The teaching crosses political ideologies. Many study groups are accepting it, as are many archaeologists, historians and secretly, many politicians. It is being called "Israelite Identity" and has absolutely nothing to do with Judaism.

Those who do not understand it or those who fear it, call it Racism, Cultism, Hatred, Unbiblical, Anglo-Israelitism, White Supremacy, Heresy and New Anti-Semitism. Yet many are saying and teaching that it is Truth, that it can be proved historically, archaeologically and Biblically.

Identifying Heirs and Why

Picture a tramp sleeping down in a back alley. One day a solicitor finds him and asks if the tramp is the man he is looking for. The tramp can prove that he is. It turns out that the tramp is a long-lost grandson of a King that left his estate and Kingdom to him. Do you think identifying the tramp would make a difference to his life? Are other tramps entitled to the future by his birthright? Clearly the difference is very real and only this tramp receives the blessings that come from being an heir.

It is the difference between living in a cardboard box or a palace. Identifying a people correctly makes a difference in their national mental outlook that translates into national performance, not just on an economic level, but also morally.

Many trendy 'intellectuals' hate the word morality. Yet morality governs more than sexual behaviour; it's the difference between suicide or living to live and even procreate on a personal as well as a national level.

So, let's begin to identify who we are...

At school we are taught we come from a bunch of barbarians who came into Europe as part of a mass folk migration from the east, moving West and Northwest. Keep the following in mind. Barbarian, despite modern ideas, does not mean a slob or crude fellow. It was a term that meant, 'one who does not speak Greek or Latin.' The barbarians were often descendants of refugees or people migrating. Refugees or migrants can be seen to lack sophistication because they are in transit, just like a back packer. Our forefathers in Roman times were in transit, they were pioneers carrying out their culture in a wilderness. But their forefathers were very civilised and cultured from whence they migrated. Like the American pioneers who came from cultured lands, they had to start afresh in a wilderness with very little means.

To the British they were 'barbarians'. They lived rough and ready. Yet their bloodline, (like the British) was European. The American 'barbarism' was not due to the people being crude, but rather, the sophisticated and culturally rich pioneers had to live crudely because they were in the wilderness. It is therefore not a case that pioneers are uncultured, rather they have to start with nothing and try to recreate their culture.

The early Europeans who lived outside the 'world' or dominion of Rome were pioneers. The aim of a pioneer is not to become a barbarian. The aim is to recreate the culture left behind but without (what is seen by the pioneer) as intolerable decadence, corruption or a lack of morality. Indeed, most early American pioneers were made up of Christian sects that opted to live a higher moral standard than they felt was possible in their land of birth.

America was settled by Puritans, Mennonites, Quakers, Huguenots, Amish and so on. Can we then liken these folk to the early Europeans, who lived outside the empire of Rome? Certainly, Roman culture was highly decadent and thrived on fleshly passions ranging from gluttony to all manner of sexual activity to ultimate fleshly pursuits ending in spectator viewed deaths.

The Romans were keen to write gruesome accounts of the Celts and Germanics, yet much of this was propaganda or exaggeration, even perverted romanticism to suit various aims. By and large the Celts and Germanics had strong moral codes. They were highly religious. An ancient text proves the origin of their religion to be founded in the Old Testament and that the reason for migrating in the first place was to leave a morally corrupt civilisation, (more on that later)

The Secret

In this book we will introduce you to an archaeological fact that is kept secret by the establishment. The fact is that the German people are Semitic. Indeed, they are descended from the lost tribes of Israel. No, I did not say the Germans are Jewish. I will give a short history to prove these claims. Before reading on, you must clear your mind and understand that when you read the words: Israelite, Semite, or Hebrews; you are not reading the word Jew.

The establishment has programmed us to think that 'Israelite' means 'Jew', yet it does not and nowhere in the Bible does it mean such.

We cannot understand our ethnic beginnings if we cloud out terms by traditional dogma. Judaism is a religion, just as Catholicism is. When we say Catholic, do we mean Italian? No because we also have German, Irish, Mexican and Filipino Catholics.

So it is with Jews, they are not a race but a religious cult.

The First Tribes

Our schools teach us there were 'Stone age' or 'Cave men' in Europe such as Neanderthal and Cro-Magnon man. Our historians and school teachers are either misinformed or dishonest.

No, I am not arguing whether or not such species existed. I am against these 'learned' people's method of teaching. They tell us of these cave men and then teach us evolution followed by telling us of the Celts and Germanic tribes. They allow (even encourage) us to assume that that the Europeans evolved from these cave men.

Yet, the Celts and Saxons did not evolve from cave men. The 'cave men' died out, they came to an end and did not leave offspring to enable an ongoing population. The Celts, Germanics and Goths migrated into Europe from the East in various waves, not having a link whatsoever with the cave men. The bulk of the cave men died out tens of thousands of years

before the arrival of the Celts, Germanics and Goths. Neander-thal men lived between 100,000 to 40,000 BC, the Celts migrated into Europe after approximately 2000 BC, resulting of a gap of at least 38, 000 years!

The most well-known group of Celts lived in middle Europe around 800 BC and has been named by archaeologists as the Hallstatt culture. When the Germanics-Saxons or Goths moved into Europe we are wrongly taught to believe the Celts were totally driven out of Europe. We are also wrongly taught that Celts and Germanics are two different races. I will show the two peoples are one and the same.

The reason why the Celts seem to have disappeared is because they were ethnically indistinguishable from the incoming Saxons. The Celtic tongue disappeared because Germanic became the overriding speech. In the same way Latin (in the form of French) replaced the Germanic of the Germanic-Franks in France. Even though the French, who descend from Germanic and Celtic people and now speak a form of Latin, still live on today. The Celts did not die out in Europe. After many battles they simply were 'grafted' into the Kin stock of Germanic tribes.

It is time to trace the Celts back to their "cradle". More and more "authorities" recognise that the Celts came from the Middle East, as pointed out in a lengthy BBC documentary on these people. The word Celt (pronounced Kelt) is found in many forms as in Gelderland (Holland), Galatia (in middle Turkey), Cheltenham (in England), Galia (France), Galicie (Southern Poland), Gallia (a former Roman Province in Northern Italy), Wael (the 'W' in this case once pronounced gutturally) and Wallonia. Early forms of the word are "Cald' or 'Chald' as found in 'Chaldea' the land of Mesopotamia. Early Chaldeans migrated from the delta region, near what is now Kuwait, up the fertile strip of land along the Euphrates River to the regions along the Mediterranean Coast to found the ancient civilisations such as Egypt.

When we think of the Middle Eastern people today, we tend to picture a brown skinned folk with dark brown eyes. Yet in those early days it was not so. The Arabs, Turks and other darker people moved into the Middle East much later. The Turks for instance do not come from Turkey but rather east from middle Asia. Originally Turkey was populated by descendants of the Chaldeans and related people, who were fair skinned and blond. Basically, the Turks ethnically cleansed these fair skinned people from Asia Minor. The original Egyptians too, being Kin to the Chaldeans were what we describe as Nordic in appearance. Our earliest records show that the 'Chalds' came from a high land region north of Mesopotamia. Great numbers of these 'Chalds' migrated northwesterly from the highland region of Eastern Turkey and West Iran into Europe to become the proto-Celts.

Those that migrated south into Mesopotamia became known as Chaldeans. Chald literally means 'highlander'. The word Celt is derived from Chald. One of the most famous Chaldeans (or proto-Celts) is Abraham of the Bible. Note, Abraham was not a Jew, he was not even an Israelite, he was however a Chaldean of the city of Ur. He was related to the Celts. His blood was Celtic. We know the Celts were on the whole blond. The Bible tells us that Abraham's wife Sarai was very fair.

The French word for fair is 'Blond'. The Hebrew word used is Yophiy from the root word Yaphah, meaning blond, beautiful or to be bright, or light. Seeing that Abraham loved all of God's laws, including those that forbade marrying those of another nation, it stands to reason that he too would have been of 'Nordic' appearance. Indeed, the Celts were tall about 6 feet or 1.8 m, ruddy and on the whole fair and blond. Abraham and his family left Ur at the time the ethnic make-up of Chaldea was shifting from predominantly fair (blond) Chaldean to the new incoming darker skinned people who changed the entire make up of Chaldea.

Abraham followed the route taken by so many of his kind over the centuries before, to settle in a land where he would live amidst people that the 'Law' approved of. He could have gone into Europe, but he did not need to go that far. In those days, Palestine and Lebanon were populated not by Jews or Arabs, but by Hebrew-Celts, once from the Highland north of Chaldea, a blond folk, his Kin.

From Abraham came Isaac. Isaac was ethically thus Celtic, not Jewish. From Isaac came Jacob, who was renamed Israel. He too, was ethnically a Celt, not Jewish. This means that all Jacob's' children were Celts or Chalds, not Jewish. From this lineage comes King David. In **Samuel 17:42**, we read that David was ruddy and fair. Ruddy means his skin was light with a pink complexion and again we see the same word fair meaning Blond. This means Jacob-Israel was also fair. This means all Israelites were ruddy and blondish. This gives a totally different picture than the Hollywood stereotype that the Israelites were swarthy with black hair. But then remember, 50% of what comes from Hollywood is nonsense. The other 50% is fiction. Jacob-Israel, (the Celt) had 12 sons who in turn gave 12 tribes. The tribes took on the name of their respective patriarchs. They are: Reuben, Simeon, Judah, Dan, Naphtali, Gad, Asher, Issachar, Zebulun, Manasseh, Ephraim and Benjamin. All are logically, Celts, not Jewish.

True Meanings

Let's get our terms straight. The word Jew is a corruption of the word 'Yehuwdiy,' from 'Yehuwdah'. Yehuwdah means Judah or of Judah (the person). Therefore, it is ethnically and etymologically wrong to say that descendants of the other 11 sons are of Judah; it is simply impossible. It is equally impossible to say that Jacob, Isaac and Abraham are children of Judah, which the churches do by implication, by calling them Jews. To call any of them Jews is of course utter nonsense, yet all the churches do and most school teachers. Even dictionaries are guilty of this stupidity. Only descendants of Judah can be called Yehuwdiy, which can be corrupted to Jews.

There is a second category of Jews that are not even descended of Judah. After the 12 tribes settled in what became known as the land of Israel, around 930 BC, infighting lead to a rift between the Israelites. The land was split in two, the Northern half became the land of Israel, the Southern half became the land of Judah.

The Assyrians began to invade both rival Israelite lands around 730 BC First the northern land fell, then the southern.

The British-Israelites teach the Assyrians only took the Northern land of 10 tribes. This is not true! The Assyrians took all 12 as outlined in II Kings 18. The Assyrians repopulated the land with non-Israelites after the Israelites were deported. However, the City of Jerusalem was not taken.

The only Israelites left in the land were the remnant (i.e. not all) of Judah and Benjamin. Because Jerusalem became the administrative capital of this now Assyrian province, the territory became known as Judea (being also a historical reference to the main tribe of the capital). This meant that dwellers in the Assyrian province became known as Judeans, even though most were non-Judahites. All the non-Israelite people in the land took on the new geographic term, Judeans, as well as the remnant of Judah and Benjamin.

Only the remnant of Judah could rightfully claim racial blood lines to the person of Judah, but the rest (the majority) of the mixed multitude of non-Israelites laid claim by geographic means. Both groups are translated as Jews in all modem Bibles. It therefore takes a trained reader to spot the difference.

Jesus was a Judahite, but he was not a Judean; he was a Galilean. The term 'King of the Jews' is not a reference to being a king of the Geographic Judeans but rather a reference to his Royal descent from Judah. The term 'King of the Jews' does not mean King of religious Jews. Jesus was in essence of Chald or Celtic blood, he was not a religious Jew, even though he was from the tribe of Judah.

Jewish author Alfred M. Lilienthal wrote this, "Here's a paradox, a paradox, a most ingenious paradox: an anthropological fact, many Chris-tians may have much more Hebrew-Israelite blood in their veins than most of their Jewish neighbours." (From the book 'What Price Israel', Chicago Henry Regency Company 1953). Could there be any truth to this? If so, this would mean the greater number of German society and its neighbouring countries have misidentified the people most prominent in the Bible. The 1980 Jewish Almanac's first Chapter, entitled "Identity Crisis," begins with the following admission:

"Strictly speaking, it is incorrect to call an ancient Israelite a 'Jew' or to call a contemporary Jew an 'Israelite' or a 'Hebrew." (by Richard Siegel and Carl Rheins, New York, Bantam Books 1980). The 1978 Summer edition of the Jewish Newspaper "*United Israel Bulletin*" (Vol. XXXXV, 507 Fifth Avenue, New York) admits the following which contradicts

Church teachings, "to get to the root of matter ... it is important we clear up one basic misconception held by so many in our society ... to the true definition of the terms Hebrew', 'Israel', and the 'Jew'. Abraham was not a Jew! Don't let this statement shock you. Historically and ethnologically, he was not a Jew. Neither was Joshua nor Joseph".



Today's Jews come under 2 catego-ries, Ashkenazim and Sephardim. The Ashkenazim make up some 90% of all modem Ashkenaz Jews. was the grandson of Japheth. Japheth was a brother of Shem. This means that 90% of all Jews are not Semitic! Semitic means a de-scendant of Shem. Jacob-Israel de-scended from Shem. Seeing that the Askenazim are not Shem, this means, this group (90% of today's Jews) are not Israelites. This group is the thrust

behind the Zionist

movement and are the main occupiers of the modem Jewish state in Palestine. It does not take much to see that this group has taken Palestine under false pretences as they are not Israelites in any shape or form.

The second largest group of Jews are Shepardic. These do have some claim to say their forbearers lived in Judea. BUT, not as Judahites, let alone Israelites. The Sephardim take their name from Sepharvaim or Sephardaim. The Sephardaim were Assyrian people who were placed into the depopulated lands of Israel and Judah after the Assyrian invasion, (see 2 Kings 17:24, 31; 18:34, 19:13; Isaiah 36:19; 37:13) This means only one thing, Today's Jews Are Not Israelites.

Although most may believe they are Israelites, the truth is they are not. I am not being nasty but truthful.

That is why Jesus said in Revelation 2:9 and 3:9 that, "*there are those that call themselves Jews, but they are not*". In other words, there are those that call themselves Israelites by claiming lineage through the tribe of Judah but they are imposters. When the Bible says the Kingdom was taken away from the Jews, it did not mean taken away from the Israelites but from those that wrongly claim to be Israelites by calling themselves Jews.

The True Heirs

Now that we know that today's' Jews are not Israelites, who then are the true Israelites for whom Christ was sent? "*I was sent to the lost sheep (tribes) of the house of Israel, and to Them Alone.*" (*Matthew 15:24*).

To find the Israelites, we can see that we need to be looking at a Celtic or at least a Celtic type of people. One of the forefathers of the Celto-Israelites was a person called Eber, from whence we got the term Hebrew. In Phoenician Hebrew, Eber means Coloniser. The Europeans are renown as a colonising people.

The name Heber or its variations appear through-out Europe as in Ebro River (in Spain), Iberia (old name for Spain) and Iverni, (the old name for Ireland, Latinised later by the Romans to Hibernai, then Hibernia). Many Israelites teamed up with the Canaanites and formed the trading Empire called Phoenicia. This fits the two distinct ethnic elements that made up the Phoenicians: the red haired being the Israelite element while the darker swarthy type being Canaanites. The word Canaanite means merchant or peddler.

The Hebrew-Celtic element did the colonising while the Canaanite ele-ment did the trading. Indeed, the Merchant class of Phoenicia called themselves the "Chanai", meaning Canaanite in their dialect.

The Hebrew-Celtic group often called themselves the Barat Phoenicians. According to the Bible. God made special Covenants with Abraham and his folk. They were 'Covenant folk'. Barat comes from the Hebrew B'r't or Berith, meaning 'Covenant'. This word or variations appear in the form of Parth or Parthia (near Afghanistan), Brittany in France, Britain (from Barat-ana: land of the Covenant) and Bruttium (a former southern province of Italy).

The study of the above names seems to suggest a historical path of migrations made by the early Hebrew-Celtics, who are blood Kin of Abraham and his descendants, the Israelites.

We stated earlier that the Assyrians took almost all the Israelites away, other than those in the stronghold town of Jerusalem.

For hundreds of years our most renowned seats of learning, colleges, universities, and theological institutions, have been at a loss to solve the issue as to what became of the so-called "Lost tribes of Israel". The overriding theory held by modem theologians (without proof), is that they simply integrated with the people of the lands of their captivity.

Yet such a theory contradicts the everlasting covenants outlined in Scripture. These writings also tell of both the northern and southern Israelite Kingdoms being taken by the Assyrians with only those of Jerusalem being spared (740-721 BC); the latter being taken in a later Babylonian captivity. These however represented only a small remnant. When the Babylonian banishment ended, less than 50,000 souls returned. An estimated 3 to 6 million Israelites, therefore, were elsewhere.

During the last hundred years, archaeologists have unearthed and published the original records kept by the Assyrians who took the bulk of Israelites captive. These records, housed in the British Museum, reveal vital clues. Assyrian wall reliefs give pictorial details showing the casting asunder of Israelites, their towns and the deportations of those captured, while the Assyrian scribes wrote of the Israelites' stay during captivity. These clay tablets were found in the diggings of the Assyrian Royal Library at Nineveh in 1850 AD. They were translated and published in 1930 by Professor Leroy Waterman of the University of Michigan.

The tablets were in total disorder, hundreds of which were of miscellaneous texts dealing with matters of state. Because of this and the fact that the Assyrians called the Israelites by other names during their captivity, the relevance to the Israelites has been overlooked. Yet a number of these tablets, dated around 707 BC, uncover the hidden lot of the Israelites as they fled from the land of their captivity. These are the "missing links" vital to pinpoint the modern-day descendants of the "lost tribes of Israel"

As outlined above, the forebears of the Israelites were Chaldeans, or we could say proto-Celts. In due course I will demonstrate that a branch of these Celto-Israelites became the Goths and Saxons. If this be so, then it stands to reason that the Saxon invasions into Celtic Britain and Europe did not bring a new race into the area. Instead, it would be more accurate to see the influx as the coming together of tribes of the same ethnicity.

Before translating the clay tablets, it pays to briefly look again at the birth of Chaldea. The Sumerians were an Asiatic people whose tongue was neither Semitic nor Indo-European. Its spoken form ended about 3500 BC to 2050 BC with the influx of Semitic (proto-Celtic) tribes. These Semitic, proto-Celts at that time had no written characters. They simply took the Sumerian script and adapted it to their Semitic tongue.

The proto-Celts came in a number of waves, one of the earliest being the Akkadians. Nearby in Kurdistan lived the Semitic Guti. About 2800 BC there arose in Akkad a Semitic chieftain named Shargani-shar-ali, better known as Sargon I, who some believe to be Nimrod of Scripture. (Nimrod's death and rebirth festival is marked by felling and decorating trees at the shortest day in December.

Sargon formed a central government and administration, complete with record keeping. It was during his reign that the Semitic tongue was first written (using Sumerian characters; see above). Soon thereafter the land fell prey to roving tribes, both Semitic and non-Semitic.

Under Semitic law, mixed marriages were forbidden, yet despite this, many Chaldeans wed with Sumerians and with other non-Semitic newcomers. The culture and laws of the region began to shift. During this period of change the Biblical Abram (later Abraham) and other proto-Celts set off on migratory treks presumably to be able to worship and live as they had before the changes. Certainly, the scriptural account tells how Abram set off on a divine mission to be the patriarch of many nations. In time, some of Abraham's descendants formed the bedrock of the tribes of Israel. All the while power struggles in the land of Chaldea spawned a number of empires, most notably those of Assyria and later, Babylon. Every spring, the kings of Assyria gathered troops and moved against a neighbouring area. Often they were held at bay; other times they'd overrun their neighbours. The dead were beheaded and prisoners chained as slaves. Towns would be looted, then set ablaze. A policy to deport a rebellious overrun nation and resettling the vacated area with more yielding foreign underlings in their stead, was brought in by the Assyrian king Tiglath-Pileser III.

It was during his reign that large numbers of the Israelites were taken deep into Assyrian territory. When he died in 725 BC his son Ulula took over as 'Shalmaneser V, who in turn died during the siege of Samaria. His successor, Sargon II, relates in his writings that he took the northern Israelite capital of Samaria. "*I surrounded and deported as prisoners 27,290 of its inhabitants*—"

In time, the social standing of the Israelites within Assyria (providing they paid their taxes) was reasonable and they enjoyed a degree of freedom to travel. Nevertheless, they were captives and according to the account of Josephus, the overthrow "*proved wholly destructive of the kingdom of Israel, Hoshea being made prisoner and his subjects being transported to Media in Persia...*" (*Antiquities* IX. 13, 14)

After Sargon II's assassination, Sennacherib took the throne. His campaigns against the Israelite southern kingdom ensured that the bulk of the Israelites were thence 'lost' to the eyes of orthodox historians and theologians. Sennacherib's account, recorded on the Taylor Prism (British Museum), is that of a boastful over-runner, referring to the Israelite king Hezekiah "—-*Like a caged bird*" In time, Assyria would fall to the Babylonians. It was during the reign of the Babylonian king Nebuchadnezzar that those remnant Israelites, not taken by the Assyrians, were deported to Babylon. When Babylon was overthrown by Cyrus king of Persia, the exiled remnant was allowed to return to Palestine, yet only 50,000 accepted the invitation. In order to find out what became of all the Israelites (who were not part of the remnant) we must seek them under other names. One of the earliest Assyrian references to Israel is found on a monolith of Shalmaneser III, uncovered in 1861 at Kurkh, southwestern Turkey. It tells of the defeat over armies of 2,000 chariots and 10,000 foot soldiers from Ahab the Israelite, "Ahabbu- mat Sir'ilaia". It is also the last time the Assyrians referred to Israelites by that name. Ahab's successor, Jehu, is shown yielding to Shalmaneser upon the "Jehu Stele" or the "Black Obelisk". In the text, Jehu is called "Son of Omri" (Note 'son' here means lineage, for Jehu was Omri's grandson). During this time, the Assyrians referred to the northern Israelite Kingdom as the "House of Omri".

The Hebrew name "Omri" begins with the letter "Y" which is spoken as a guttural "H", translated into Assyrian with "Gh," "Kh" or "Ch". Thus, even before the various captivities, the Assyrians called the Israelites "Beth-Khumri" (House of Omri). Sargon II called himself the overthrower of "Bit-Khumri". The clay tablets or "letters" covering the sweep of the Assyrian Empire in the 7th year hundred BC, held many references to the captive Israelites. Most of these letters were border reports made by spies sent by the Assyrian rulers to oversee movements of nations within and without their empire. Variations of the name "Ghumri" used by the Assyrians are Khumri, Khomri, Gimira, Gamera and Gimir.

Letter 197-Sennacherib to king Sargon states: "...When the king of the people of Urartu went to the land of Gimir, his army met with a debacle..." The battle between the Urartians and the Gimir took place south of Lake Urmia next to Media. Assyrian policy of using relocated captured peoples as buffer zones paid off. The 'Gimir' had withstood the Urartians out of self-preservation. The location ties in with the Biblical identification which places the captured tribes being placed near Habor and Halah between Lake Urmia and the Caspian Sea, as well as with the writings of Josephus.

From the tablets it becomes clear that the Gimir or Captive Israelites were kept as a homogenous enclave. This is backed by a series of tables in which the king of Assyria Esarhaddon (681-669 BC) is asking divine guidance about the operation of his troops sent to gather taxes from territory of the Medes (British Museum KK195, 83-1-28; 697, 82-5-22,175). The tablets show that the Gimirian warriors were teaming up

with those of the Medes and the Mannai to revolt. Of Esarhaddon's battle with the Gimiri (697 BC), he wrote "*Teushpa* [Tushpa, east of Lake Van], *the Gimira, a barbarian whose home was afar off, I cut down with the sword... together with all his troops.*" We see here that the captive Israelites had chieftains: and troops with their original home stated to be afar off. This confirms them to be a folk in exile. Indeed letter 1237 refers to the Gimira as exiles.

"Let the Cavalry and the Dakku invade the Gimmerians. They are the offspring of outcasts, they recognise neither the oath of a god (Assyrian God) nor an agreement."

We stated earlier, like the American pioneers, the earlier Europeans came from far off lands in search of religious freedom. The Apocryphal book of 2 Esdras in 13:40 tells of the Israelite tribes surviving in captivity but planning to leave the land of their "heathen" captives and to "go forth into a farther land, where never mankind dwelt,—" "That they may keep their laws (of God) which they never kept in their own land".

The Israelites called themselves the Nation; Folk; Sons, and/or House of Isaac; Beth-Isaaca or Beth-Sak, Gamira was not a name the Israelites chose for themselves; it was strictly an Assyrian application. The Persians, however, who had closer social contact with the Israelites, called them by the name Sakka or Saka from Isaaca. Because of this, later tablets began to use the term Iskuza.

Again, one of Esarhaddon's prayers (keep the above text from 2 Esdras in mind where Israelites go into new lands), "*Will the I-sk-u-za warriors who live in the district of the Mannai, and have moved to the frontiers of the Mannai, succeed in their plan? Will they march out from the pass of Hubushkia* —*and take much booty, and heavy spoil from the borders of Assyria?*" The Isaaca or Iskuza began to overrun lands belonging to the Medes, competing with Assyrian troops to gather tribute as they went.

Referring to his tax gatherers, Esarhaddon, king of Assyria, asks "—*and* which have gone into the land of the Medes in order to collect the tribute of horses, (will they be attacked) by the hand of the Iskuza warriors?" These are clear archaeological references back to the Apocryphal account

that the Israelite tribes were not only leaving the Middle East, but they were a homogeneous force to be reckoned with. At this point it is also crucial to note that Strabo identifies part of Armenia having been named Sak-sina. The term is a variation of Saakai-suna, it literally means, "sons of the Sakai", or "Beth-sak". That the Assyrians turned Isaaca into Iskusa must be understood in the way the name must have sounded to their ears, for in Hebrew, Isaaca sounds as yits-khawk(a). In time Sakaisuna became Sachsen, Sac-son or Saxon. Sacson literally means Beth-Sak. According to Herodotus, the Isaaca, (Iskuza, Sakka, Saka) were also called the "Scythians" by the Persians. Ptolemy states that a Scythian folk sprung from the Sakai, by the name of Saxons. The Jewish Encyclopaedia Vol. 12 page 250, "—the Sacae, or Scythians who again, were the Lost Ten Tribes..." So, the Jews knew all along that we are Semitic!

For those who have a problem linking Gimiri with Sakka, the Behistun Rock is proof positive. The old caravan road from Babylon to Ecbatana (old capital of Median) runs by a limestone mountain rising out of the plain to 1,700 feet. About 300 feet above the base is a rock face holding inscriptions made by the order of Darius the Great, about 515 BC. The memorial is 150 feet long by 100 feet high. The inscriptions are in 3 tongues, Babylonian (Accadian), Elamite (Susian) and Persian. The inscriptions refer to Kana, or Canaanland from whence the lost tribes came, and Armenia, the area of captivity.

Of the 23 nations over whom Darius ruled and named, among these is the Sakka. In both the Persian and Elamite accounts, the name is Sakka, but in the Babylonian version the same people are called "Gimri". What is more, the monument shows a branch of the Gimiri or Sakka had by this time (517 BC) trekked a long way beyond Bactria (north of Afghanistan). Many of the lost tribes of Israel had made their way to the steppes of Russia, never to return.

From this point orthodox history takes over telling how these tribes trekked into Europe. Of the Cimmeri (Gimir) the Encyclopaedia Britan-nica states "An ancient people., one body of whom is called in Assyrian sources Gimirrai and is represented as coming through the Caucasus—later writers identify them with the Cimbri of Jutland who were probably *Teutonized Celts.*" From Scriptures we see that these Israelites will have new names and new lands (Isaiah 62:2) and their naming will be after Isaac (Romans 9:7; Gen. 21:12).

The Saxons or Sachsen are Isaac's Sons, therefore they are Israelites. The corrupted forms of the term Isaacsons such as Saxons is found in England as Wessex (Western Saxony), Sussex (South Saxony), Essex (East Saxony), Middlesex (Middle Saxony).

To establish a fact, the Law of God needs a double witness. And the Second witness is in our Germany. Just as in England four areas are named after Isaac, so too four are named after Isaac in Germany and Holland (three in Germany, one in Holland, once part of Germania). The areas stretch from the north east of our land to the south west in an unbroken land, they are Niedersachsen (Lower Saxony), Sachsen-Anhalt, Sachsen (Saxony) and Saksenheim (Isaac-son-home in Holland). As the Isaac-Sons migrated from the middle East into Europe they took names as cultural memory with them and gave these places, towns, regions, and rivers where they dwelt.

The Israelite tribe of Dan gave its name to many rivers in Europe such as the Danube (Donau) or D'niester, D'nieper and Don. Also, to town names such as Danzig but most notable to DANMARK.

One of the most notable of Germanic tribes were the Jutes, whose name is still found in Jutland, literally Juda and Judaland!

The very name 'Deutsch' for Deutschland comes from 'Deut-ish. 'Ish' in Hebrew means Man or Folk, i.e., the folk of the 'Deut' (Teut, Teutonic). Ish in Germanic means the same. The 'sch' is the modem German version of the old 'iysh', another Hebrew (not Jewish link).

'Deut' or 'Diut' comes from the Saxson 'theod' which in turn comes from the Gothic, 'thiuda' which means a 'nation' or 'troop of one ethnic makeup'. The word 'Goth' comes from 'Guda' or 'Gutthiuda' meaning the 'troops' (or folk) of the 'Gud'. 'Gud' in turn comes from the name of the Israelite tribe of 'Gad'. Goth literally means "Gad's folk". Many towns today still bare Gad's name, such as Gades in Spain but closer to home, (i.e. Germany and nearby) Göta, Göteborg, Gotha, Gotland and so forth.

Whereas England is mostly the tribe of Manasseh and Ephraim and Southern Holland mostly of Zebulun; Northern Holland and Germany are mostly Issachar. The tribe of Judah and Dan are mostly in Northern Germany and Denmark whereas the Hinterland or Heartland of Germany is mostly the tribe of Gad. And with that in mind, let us look at the Biblical blessings, prophesies and idiosyncrasies of 'Gad'.

In Deuteronomy, Chapter 33:21 we read that Moses blessed Gad (as he did all the tribes) before taking their share in the promised land. But because the Bible teaches the Israelites will inherit new promised lands much later (2 Samuel 7:10; 1 Chron. 17:9) the blessings would have repeat performance.

And he (Gad - later Goth) provided (chose) the first (or prime i.e., the finest) part (of land) for himself (i.e., his folk)". Just as in Canaanland, the Gadites chose the finest land, a hinterland; the Goths (their offspring) settled in a European hinterland, a choice land in Europe.

After having been to 26 countries and lived in 4 of them, I am, (as are many tourists), struck by the sheer beauty of Germany. Of all the lands in Europe, Germany and their German speaking areas of Austria and Switzerland are without doubt the most beautiful in the World. This is not chauvinism. This is an honest observation of prime, choice land.

Indeed, the last two wars have been fought over control of Europe's finest 'Real Estate', Germany.

East Germany (Middle Germany) was the Jewel in the crown of the Soviet block, and true East Germany (occupied now by Poland) is to this day occupied (by Poland) with no hint of giving it back.

The prophecy of choice land is indeed true, but what of our future and current lot. What plan has God in store for us?

God's Plan For Germany - By Adam De Witt

Genesis 49:19, "*Gad, a troop shall overcome him; but he shall overcome at the last.*" This shows a relationship with a troop or a people. Although most of the other tribes remained relatively distinct throughout history, they tended to separate themselves from the Goths, often banding together against them. The tribe of Judah settled largely north of the Goths. Traditional tribal jealously between Ephraim and Judah to this day never died and reached its peak at the turn of this century. It took very little to ignite a war in 1914, just as it did many times between 930 BC to 730 BC. In Europe, Judah is strongly allied with its nearest tribe, a tribe that has the distinctive trait of being seen as a people in their own sight, a troop.

The world views the Germans (those of Gad and Judah) as a distinct group, yet in reality they are Israelites as part of the larger family of Israelites found elsewhere in the world. The Germans therefore fit this prophetic character trait perfectly. The main thrust of the prophecy is being carried out right now and the last part has yet to be fulfilled. It states that Gad will be overcome.

This century is the only century in which Germany as a unified state has been overcome. Up until the last years of the 18-hundreds, there was no German state. There were many German lands, all with their own Kings and Princes, but a united states of Germany is very recent. Since the end of WWI, the German state has been overcome in some form or another. Even today, Germany is occupied by winners of the 2nd World War (and no peace treaty exists to this day between her and her over runners). Germany also has the unique and sad distinction of being the only land on the earth (to this day) that has lost much of its territory and any talk of wanting these back can lead to criminal proceedings.

Germany is the only land to lose more civilians after the surrender to its over runners (conquerors) than during the war. At least 9.3 million Germans died in the first 5 years after the war due to deliberate policy of starvation. Eisenhower stated in 1944 that he would like to "*see things made good and hard for them*" (the Germans).

The Morgenthau plan was to systematically starve the Germans, and although officially dropped by the American, Roosevelt said in secret "that the plan would be 'implemented'" The allies slowed oil production to a trickle, closed what factories were left, kept the work force imprisoned and confiscated or destroyed factories and machinery.

In Berlin September 1945, an official estimated that half the children aged three and under would not survive the next year, with a baby death rate of 100%! In February 1946 US senator Kenneth Wherry stated, "the American people should know once and for all that as a result of this Government's policy they are being made accomplices of mass starvation. Germany is the only nation subjected to Deliberate starvation policy".

Red Cross food trams were sent back to Switzerland, foreign governments were denied permission to send food to German civilians, the fishing fleet was kept in port and one fishing boat was blown up by the British soldiers to make the point. The official ration in the French zone in January 1947 was 450 calories per day. Ethnic cleansing of Germans from Eastern Europe, tepidly called "Expulsion" was authorised under the Potsdam agreement signed by Stalin, Churchill and Truman. More than 16 million Germans were uprooted from ancestral lands after a string of gruesome events.

In a Sudetenland thorp, all the German women were seized and their Achilles tendons cut. As they lay screaming, the Czech men raped them repeatedly, Hermine Muckusch, a grandmother from Jagerndorf in Sudetenland was force marched out of her homeland with 27 children. Within 14 days, all but one were dead. Her story was a typical act of genocide of the time, during peace time!

Thousands of German Mennonites were beaten and shot at by British troops who, tried to force them into cattle wagons bound for the Soviet Gulag such as Liezein in Austria, June 1945.

Bones discovered in mass graves in 1976 and 1981 at Kaltwasser / Bromberg were returned to the ground without marker when it was discovered they were Germans. The Genocide against the Germans goes on today. Although now well fed, the folk are morally starving, having no love for themselves. Hybridisation of species is simply genocide by way of destroying the original stocks. Germans are brainwashed daily by the media and schools (controlled by the occupying forces) to accept, love, help and wed the non-Israelites flooding into the land. This time the aliens overcome the land by sheer numbers with Germany taking in more than all of Europe. Germans have no homeland and her culture is being replaced by an alien culture of recreational sex, recreational drugs and brain destroying rock'n'roll. Even the pro-German skinheads partake in anti-German behaviour, sex before marriage, listening to music with rock'n'roll beat and drink too much. Neither the far right, the far left, nor the churchgoers, ever obey God's Saxon Laws.

How far can people go if they have 1, 2 children (how many of these are hybrids)? Germany has been well and truly overcome. Any wealth Germans enjoy is for selfish gain so as to not see or feel what is happening. But even that wealth cannot stand.

What, then, my beloved Kin, my brothers and sisters of true Israel? The last part of the prophecy gives hope "*but he shall overcome at the last.*"

This century was the one that all Western lands looked forward to with great hope. Technology would save the poor and relieve drudgery (normally reserved for the masses). Sadly, technology was not seen as a blessing from God. Instead of bringing the individual nations of the true Israelites together, each instead boasted of their technological gifts in mad rivalry aimed against their Saxon Kin in other Saxon lands reaching unprecedented rivalry. Jealousy soared between the two greatest Celtic-Saxon-Israelite nations: Great Britain and Germany.

Canaanite Jews saw an opening that would allow themselves to rule over the two rivals, reversing the curse of a long-lost birthright that dates back to the time of Jacob. For now, space does not allow us to go into this in great detail, but, in short, the Biblical patriarch of the Jews, Esau, lost his birthright that could otherwise have seen his people become leaders of nations. The Canaanite (Ashkenazim - Shephardic) Jews recognise an ancestral link to Esau. The Saxons and Celts are from Jacob.

Because Jacob instead took the birthright, his descendants in the 18hundreds, (Saxon-Israelites) were at the point of leading the Earth. One third was in British hands, not much less was in French hands, large parts in Dutch hands, middle Europe and parts of Africa in German hands and

from middle Europe to the far side of Asia was in Russian hands. The world was 90% controlled by Saxon-Israelites, descendants from Jacob.

The 20th Century saw an end to that because of petty infighting. We preferred to love non-Israelites instead of Israelites, our own Kin folk.

A house (or a people) divided against itself cannot stand, and indeed, the Israelite-Saxons were divided and fell. After the two Saxon-Israelite World Wars, Britain lost its empire and was drained of all its wealth. America's debt increased from 1940 to 1945 by 500%. Russians of (Scandinavian) Israelite stock were subjected to systematic starvation since 1917 and by 1945 Germany lay in ruins. After the "Wars between the Saxon-Israelites" our rivalry carried on.

Instead of coming together, Saxons preferred to make treaties, pacts and friendships with non-Israelites and even passed laws to punish Israelites who did not want to join with non-Israelites. Israelites that want to unite Israelites are branded racists while it perfectly OK. for Israelites of Britain to hate South African Israelites, or Australian Israelites to hate English Israelites or Dutch Israelites to hate German Israelites and so forth. And, so, the Bible tells us that after all the curses God brings against us to make us obey, we still refuse to love our own and serve Christ; more will befall us. God says that if you love non-Israelites so much, he will give them to you until you are sick of them.

Speaking of the latter days, Ezekiel chapter 7 (Verse 15) tells us of famines for our people. (The great depression in the Americas killed many. 7 million starved to death in the Ukraine and millions in middle Europe after 1945). Those that overcome shall be weakened as the West was. We lost our culture and the World was de-colonised from the 1950's onwards; Indonesia, Vietnam, Kenya, India, Malaysia, Ceylon, Rhodesia, Southwest Africa, Congo, Algeria, French West Africa, Southwest Africa, The Sudan and many more. And still our folk did not repent.

Verse 21 tells us that strangers (non-Israelites) will take much of our inheritance and pollute it. All the beauty of our colonial times has been burnt, pulled down, bombed, stripped and left to fall to ruin. We have been ethnically cleansed from all these lands and no one cared.

Verse 22 tells how God's protection will turn away from us. And in Verse 23, if all that fails to change our ways, those homelands we traditionally have called ours will also be taken by strangers; lands such as Australia, USA, Canada, Britain, France, Spain, Denmark, Germany, Holland, Belgium and so on. "...for the land is full of bloody crimes, and the city is full of violence (often meaning violence to God's Law by saying it is not applicable to today's living). Wherefore I will bring the worst of the heathen and the shall possess their houses..." Do you see it? Our streets and houses are taken over by the "worst of the heathen".

In Verse 27, at last our folk will know that God is boss. His Laws will replace that of parliament. Away with Communism, Socialism, Nazism, Facism, Greenism and Democracy. Only God's theocracy for us. Then and only then will our people overcome. We will overcome when we separate ourselves from non-Israelites and their laws and customs. Then too will Gad overcome, and Germany like the rest of the true Israelites, will rise to glory. Not because we are so good, but because our true President/King is so good. We are to fully become God's Servant folk. Not to serve non-Israelites, but to serve God first and then each other (Israelite kin) in God's ways.

John the Baptist was an Elijah type that made ready the way for Christ's first work, to buy back his Israelites and cover their sins. This is an Elijah ministry, again to proclaim to the true Israelites to obey the Laws of Moses and hold fast to the testimony of Jesus to prepare the way to Christ's second work, the removal of sin (sin means the breaking of **THE** Kings Laws). Our folk have been bought by the blood of Christ (redeemed) now true the Israelites (Saxons) are to be restored to Christ and inherit the earth.

Some years ago, the Canadian British Israel Association put out a book on heraldry called, Symbols of Our Celto-Saxon Heritage. It showed the bond between European heraldic symbols and those of the Israelite tribal banners as a means to strengthen the weight of proof to our Israelite roots. He also forgets that Germany did likewise but earlier and the authorizer in Germany was one of the world's greatest Christian reformers. In the above list, under the heading 'Primary Emblems', we see the official emblems of the Twelve Tribes as displayed on their ensigns in accordance with the command: '*Every man of the children of Israel shall pitch—with the ensign of their father's house.*'

Those listed under the heading 'Secondary Emblems' are the additional likenesses mentioned in connection with some of the tribes in the bless-ings given by Jacob and later by Moses or, as in the case of Simeon, they were adopted to commemorate some historic event. These were not the official emblems of the tribes and, so far as we have been able to discover, were not used during the early years of Israel's history.

Nevertheless, these secondary emblems would not be forgotten. Later, in some cases, they were used by a section of a tribe to distinguish it from the rest and, in one or two cases, secondary emblems of one tribe became the recognized emblem of a group of tribes.

The book also gives 'Camp' emblems. These were given to groups of tribes, three tribes a group, so four Camp groups—four emblems. Thus, each tribe had selfhood (individual) emblems as well as camp symbols.

While the Bible does not actually state what the emblems on the standards of the four Brigades or Camps were, nevertheless, it does offer evidence which clearly indicates that they were a **Lion**, a **Man**, an **Ox** and an **Eagle**.

We learn from this that the camp symbols, a lion, an ox, a man and an eagle, were taken on by a number of tribes. Seeing that the book is pitifully lacking in giving our German kinsfolk any coverage, I will give some even weight (balance) to it all by putting before you a few German heraldic symbols. Bid thee (please) keep in mind that these are only a thin slice of the many Israelite symbols in Germany.

The March (land area like, say, a shire, state or land) of Brandenburg has as its symbol the eagle of Dan. This also the symbol of the Unified German Marches or the Bound States of Deut-ish-land-- otherwise known as Germany.

The emblem for Dresden is the lion of Judah. Dresden was one of the finest Israelite towns on earth and the envy of many, more so of the English- speaking world, who's unholy bond with Edom saw to Dresden's cold blooded bombing. Judah's lion is also in the shields of the states of Hesse, Rhineland-Palatinate, Saarland. Schleswig-Holstein and Thuringia.

The gate of Simeon is in the shield of Hamburg.

The horse of Dan is found in the state shields of Nether Saxony and North Rhine-Westphalia.



Judah's secondary emblem, three stretched lions, is that of Baden-Wurttemberg. We see the selfsame emblem for England and Denmark, another link to prove kinship between Britain and Germany, yet the BI'ers would rather foster the unholy bond between Britain and Edom (Jewry).

The Berlin 'rimtown' (suburb) of Tiergarten, has as its emblem the leaping 'tier' or 'deer' of Naphtali. We find the Ox of Ephraim in the shield of Mecklenburg.

As a double witness we see Gad's tribal emblem twice, that being a trooper on horseback, within a shield set upon the 'Great Bridge' in Grimma. This Gaddite emblem is quite lacking in other Israelite lands. This linked with the name Goth and Deut or Teutonic is proof of Gad's settling in Europe's finest bit of 'real estate', Germany.

Indeed, we find Israelite signs in all the German lands or Marches, even in the swallowed-up lands such as Pomerania.

In a hopeless try to shrug this off, many in BI have said that the German eagle is a cropped version of the Holy Roman Empire's double-headed eagle and say, thus Germany is not Israel. Yet that does not explain away the countless Israelite symbols in Germany, nor the fact that many of the single-headed ones were used before the reign of Charles the Great, or for that matter that double-headed eagles are found in other lands such as in England.
