Christianity And Pharmaceuticals William Finck

he Greek words *pharmakon*, *pharmakos*, and *pharmakeia* are usually rendered "sorcerer" or "sorcery" in the King James Version of the Bible. That version was translated by 1611, and ever since then most theologians have followed in its footsteps, and have kept the interpretations of the medieval Englishmen of that time, while the rest of the world has become "modern", and has updated its language. Or have we?

Here are the definitions of those words, from Liddell & Scott's An Intermediate *Greek-English Lexicon*, Oxford University Press, Impression of 1999, First edition 1889. I will supply English transliterations in place of all of the original Greek words:

pharmakon: "a drug, medicine, Homer etc.: the pharmaka applied outwardly were christa, egchrista, epichrista (ointments), and pasta, epipasta, kataplasta (plasters), Theocritus, Aristophanes; those taken inwardly brosima, and potima, pota, pista, Aeschylus, Euripides, etc...

2. In bad sense, an enchanted potion ... so a charm, spell, enchantment ... also a drug, poison ... II. a remedy, cure, Hesiod"

pharmakeia: "the use of drugs, potions, spells, Plato. 2. poisoning, witchcraft ... Demosthenes. II. remedy, cure, Aristotle."

pharmakos: "a poisoner, sorcerer, magician, N.T."

Note that Liddell & Scott gave only the New Testament as a source for their definitions for this use of the word *pharmakos*. And why did they not give secular Greek definitions? Because they would have had to put "apothecary", "pharmacist" and "druggist", yet perhaps that was already not politically acceptable by 1889, and so instead they put nothing! The large and scholarly Ninth Edition of the Liddell & Scott *Greek-English Lexicon* does likewise, defining the word in this sense identically, and citing only the *Septuagint* and the N.T., even though it cites the secular Greek writer Herodianus (2nd c.

A.D.) on the pronunciation of the word. This is the only time that I have seen Liddell & Scott limit their definition of a word to the manner in which Bible translators have treated it, when the word appears also in Greek writers outside of the Bible. There is another sense in which the word *pharmakos* is used, and that will be discussed below.

Here is a lengthy citation concerning physicians from Strabo's *Geography*, Book 15:1:60: "As for the Garmanes, he says that the most honourable of them are named Hylobii and that they live in forests, subsisting on leaves and wild fruits, clothed with the bark of trees, and abstaining from wine and the delights of love; and that they communicate with the kings, who through messengers inquire about the causes of things and through the Hylobii worship and supplicate



the Divinity; and that, after the Hylobii, the physicians are second in honour, and that they are, as it were, humanitariphilosophers, men who are of frugal habits but do not live out of doors, and subsist upon rice and barley-groats, which are given to them by everyone of whom they beg or

who offers them hospitality; and that through sorcery they can cause people to have numerous offspring, and to have either male or female children; and that they cure diseases mostly through means of cereals, and not through means of medicaments; and that, among their medicaments, their ointments and their poultices are most esteemed, but that the rest of their remedies have much in them that is bad; and that both this class and the other practice such endurance, both in toils and in perseverance, that they stay in one posture all day long without moving; and that there are also diviners and enchanters, who are skilled both in the rites and in the customs pertaining to the deceased, and go about begging alms from village to village and from city to city; and that there are others more accomplished and refined than these, but that even

It may be argued that a pharmaceutical is a drug, and not a potion, and that the Bible is talking only about potions. That argument is entirely subjective. The Bible makes no such distinction, but talks of pharmakeia in general. For the purposes of this paper, I am only going There is absolutely no proof supporting any such distinction between drugs and potions or sorceries: the distinction did not exist at all until the foundation of the modern pharmaceutical industry and the money of the international bankers who created it!

Here are all of the Scripture references where those words appear in the New Testament, from the Christogenea New Testament:

"20 And the rest of the men, those who had not been killed by these plagues, did not even repent from the works of their hands, that they do not worship demons and idols, things of gold and things of silver and things of copper and things of stone and things of wood, things which are able neither to see nor to hear nor to walk. 21 And they did not repent from their murders nor from their drugs [pharmakon] nor from their fornication nor from thefts." (Revelation 9:20-21, *CNT*)

"23 And the light of a lamp shall not shine in you hereafter! And the voice of the bridegroom and a bride shall not be heard in you hereafter! Because your merchants were the great men of

> to cite here one Old Testament reference for the use of the word pharmakeia, Isaiah 47:9 from the KJV: "But these two things shall come to thee in a moment in one day, the loss of children, and widowhood: they shall come upon thee in their perfection for the multitude of thy sorceries, and for the great abundance of thine enchantments." How can "sorceries" be connected to the loss of children, and to widowhood? Think about birth-control pills. Think about the declining birthrates which many tie to the modern chemical and pharmaceutical industries. Think about the premature deaths of so many people who have substituted fast food and prescription drugs in place of sound nutrition and exercise. Do we see a problem today with wizards and sorcerers deceiving all of the nations, as we have just read in Isaiah and the Revelation? Or do we see the whole world captivated by a need for drugs? Read all of Isaiah chapter 47, and one should realize with certainty that it is much the same language as Revelation chapter 18, where pharmakeia is also condemned, and that both chapters are talking about the same thing: the condemnation of the great whore and mystery Babylon!

The Christian should look to Yahweh his God for healing, protection or deliverance from evils and enemies, and a long and healthy life. Those very things are promised to those who keep His laws, for instance the commandment at Exodus 20:12 states "Honour thy father and thy mother: that thy days may be long upon the land which the LORD thy God giveth thee." And the law also states, as Paul quotes Lev. 18:5 at Romans 10:5: "Moses writes of the justice which is from of the law, 'That a man who practices these things shall have life by them." It is no mistake, that our English-speaking forebears used the word *crises* to describe what evils befell a man. For the word is directly from the Greek *krisis*, meaning *judgment*.

When men circumvent the laws of their God and Creator, they are forced to seek their own remedies for the resultant evils which befall them. Hence the search for pharmakeia in order to solve our troubles. This has opened a veritable Pandora's Box, and our society's dependence upon pharmaceuticals grows larger and larger with each passing day. We have become so alienated from our God, and have strayed so far from His laws, that even our infant children are pumped with all sorts of unnatural substances almost as soon as they are born, and we as a people have become drug-dependent at every stage of our lives! Drugs have become our escape both from the realities of life, and from the natural punishments resulting from our deviant behavior. But that escape is only a temporary illusion. For we know not what greater damage we have brought upon ourselves as a result of our turn away from God and towards our own devices.

When man was created, he was told that every green herb was for him for food. There are thousands of natural remedies that are useful for alleviating various ailments or which act as preventatives for those ailments. Very little capital is put into the development of the knowledge of these remedies. The reasons for this are solely economic: investment bankers cannot control what grows out of the ground, and once the studies are done and the results published, the prospects for financial profit are quite dim the people will simply grow their own product! Instead, pharmaceutical companies scour the globe looking for naturally-occurring substances, especially in the plant world, and examine what those substances may be good for. Once a

And the law discovery is made, the drug companies strive to guard the information, and then they synthesize the substance, hoping to then profit from it once they patent it. Christians, in turning away from and their lives into the hands of the anti-Christ jews: and what good will ever come from that? None whatsoever!

Pharmaceuticals and the laws of clean and unclean foods.

Whatever you ingest into your body in any man-



ner is, in essence, a food. Even the ancients knew that the blood contained digested foods which then circulated throughout the body, nourishing its members (see Livy, History

of Rome, 2.32.9-12). Injecting pharmaceuticals into your bloodstream is the same as injecting them into your cellular food supply: you are eating them. These pharmaceuticals, and especially vaccines, contain agents which you may otherwise never eat. Mercury, for instance, or cultures from the dead body parts of unclean animals, are regularly used in vaccine production. These all violate the laws handed down to Christians by Yahweh their God, and these laws should still be governing Christians unto this By receiving injections, one is eating unclean foods, even though he is bypassing the usual digestive process. And to consider the very nature of these unclean foods used in the production of vaccines and other medications, any normal person would grow ill at even the thought of eating such things!

Very strangely, the word *pharmakos* also had another use in ancient Greek, and Liddell & Scott offer another definition for that other sense of the word: "II. *one who is sacrificed as an atonement for others, a scape-goat, Aristo-phanes; and, since worthless fellows were reserved for this fate, <i>pharmakos* became a general name of reproach, Iliad, Demosthenes." When are Christians going to learn, that Yahshua Christ is their only true *pharmakon*? All pharmaceuticals are therefore unChristian, and contrary to the laws and the will of Yahweh our God. Born Under Contract Clifton A. Emahiser

magine yourself being born, and when you took your first breath, you found yourself under a Lbinding legal obligation emanating from your ancestors which you cannot, in any way, annul. As a matter of fact, if you are a member of a certain group of people, you have several contracts by which you must abide which will affect every major phase and all the decisions of your life. There is only one group of people in the entire world who are born with this obligation on their physical, mental and spiritual beings. And, as much as anyone might want to find a way to disengage himself from the provisions of these contracts, he finds himself entirely helpless to do so. He cannot decide he doesn't want to be under the terms of these contracts, nor can others who are not under them decide they want to be included therein. If you have been designated a party under the terms, you really have no choice in the matter but to comply. It is not open for invitation, and you don't have an option. If one does not comply with the terms of the accord, every means will be applied to bring him back into compliance with that Covenant. One cannot plead ignorance to the existence of these contracts as ignorance is no excuse. Because these binding contracts play such an important role in our lives, it will be the object here to explain them and the penalties incurred for not keeping the terms as prescribed. But, with this passage, we are getting much too far ahead of our story, for we must go back to the beginning to get the concept of what all of this is about.

Preamble To The Contract

While it was not the contract or Covenant in itself, the "9 And he (Yahweh) said unto him (Abram), Take The recipients of this proposed covenant were to be EXCLUSIVELY Abram (Abraham) and his descendants:

"And I will make thy seed as the dust of the earth: so that if a man can number the dust of the earth, then shall thy seed be also numbered.'

It is paramount we should observe, in Yahweh calling Abraham, He dealt with one individual and his family. (I will be using the Tetragrammaton throughout, including quotes.) In other words, Yahweh was the party of the first part, and Abraham and his family were the party of the second part. In this passage, the parties of the Covenant contract were established. Nowhere are we told Yahweh ever made a covenant with any other people. It should be noted that Yahweh chose Abraham, not the other way around. It was Yahweh who was calling the terms of the contract. In subsequent covenants, the definition of Abraham's immediate family seed would be narrowed down and clarified. When we examine Scripture, this Covenant is definitely speaking of Abraham's descendants through Isaac and

> Jacob; not Hagar, Ishmael, Keturah or Esau.

> Before receiving this promise from Yahweh, Abraham asked how this thing could be, for his only legal heir was his servant Eliezer of Damascus. Whereupon, Yahweh declared that Eliezer would not be Abraham's heir, rather his own flesh and blood. As with all contracts, there are two or more parties involved; but the conditions set forth in this one are quite unusual. At this point, all that was left was to finalize the agreement as described in Genesis 15:9-10:

> This legal process is described in the *Believer's Bible* Commentary by William MacDonald, page 53,

where he quotes a footnote from David Baron's *The New Order of the Priesthood*, pages 9-10:

"According to the ancient Eastern manner of making a covenant, both the contracting parties passed through the divided pieces of the slain animals, thus symbolically attesting that they pledged their very lives to the fulfilment of the engagement they made (see Jeremiah 34:18, 19). Now in Genesis 15, Yahweh alone, whose presence was symbolized by the smoking furnace and lamp of fire, passed through the midst of the pieces of the slain animals, while Abram was simply a spectator of this wonderful exhibition of Yahweh's free grace."

There is a very similar comment in *The Wycliffe* Bible Commentary, page 21, comparable to David Baron's quotation above and essentially says the same thing. Again, Jamieson, Fausset & Brown make a very similar observation concerning this passage in their Commentary On The Whole Bible, page 27, of which I will quote only one sentence: "The patriarch did not pass between the sacrifice and the reason was that in this transaction he was bound to nothing."

When Yahweh made this Covenant with Abram, Yahweh put Abram into a half-conscious trance so he could witness the event, but not be an active partic- and thee and thy seed after thee in their generaipant. Normally, each party in the contract was required by law to walk between the divided carcasses. It was saying, in effect: "So let it be done to me as these divided animals if I keep not the terms of this contract." In this particular contract, Yahweh walked alone between the slain animals, thus making it a one-way (unilateral) compact; Yahweh promising everything, with nothing being required of Abram. Thus, all the obligations of the agreement were placed solely upon Yahweh. This signified that it was an unconditional Covenant dependent for fulfilment upon Yahweh alone. Rousas John Rushdoony, in his book The Institutes of Biblical Law, couldn't be more mistaken when he said, page 44: "Abraham was required to pass between the divided
"This is just the apposite" 15 And the angel of Yahweh called unto Abraof what really happened, for Yahweh walked this path by Himself. We have to consider: if Yahweh hasn't literally fulfilled this promise of "many seed" by this time, He is not faithful to His Word. If He has kept His Word, then somewhere in the world today there must be a people so numerous they would be impossible to count.

We can know for a certainty this unconditional Covenant by Yahweh was directed only toward the descendants Isaac and Jacob-Israel, for it is recorded in verses 13-14, where it refers to Israel's sojourn in Egypt. None of Abraham's other chil- Primo-genesis, page 82: which he substituted for

dren fit this criteria, so, we are assured beyond all doubt, this Covenant was for Israel, and Israel only. Therefore, all of Abraham's full-blooded descendants through Isaac and Jacob fall under this contract, which is a covenant in perpetuity. This Covenant Yahweh signed, sealed and witnessed with Abram, his friend. Once ratified, it could not be abrogated; it was to be in effect forever.

COVENANT REAFFIRMED (Genesis 17:4-7)

Thirteen years later, Yahweh reappeared to Abram with a reassurance, a challenge and a richer promise. This restatement, like the first promise, was to his seed through Isaac and Jacob; not to the Ishmaelites or Edomites or some kind of spiritual church or a process of spiritual adoption.

"4 As for me, behold, my covenant is with thee, and thou shall be a father of many nations. 5 Neither shall thy name any more be called Abram, but thy name shall be Abraham; for a father of many nations have I made thee. 6 And I will make thee exceeding fruitful, and I will make nations of thee, and kings shall come out of thee. 7 And I will establish my covenant between me tions for an everlasting covenant, to be an Elohim unto thee, and to thy seed after thee.'

At that very moment, Isaac and his offspring became the personal property of Yahweh. By the act of placing Isaac on the altar, Yahweh was now in a legal position to bless or chastise Isaac and his progeny (less Esau) in any manner necessary in order to keep them under the terms of the Covenant. Not only this, but Isaac's offspring would inherit the strategic sea-gates of the world; Suez, Gibraltar, Aden, Singapore, Malacca, Cape of Good Hope, Falklands, Dover and Panama. Though some gates may be lost for a while, they will be returned to Isaac's sons. (Genesis 22:17)

A RACE DEDICATED

Again, for more comment on this second ratification of this contract, I will quote from Howard B. Rand's *Primo-genesis*, page 82:

"Through Isaac an entire race was dedicated to Yahweh's service, for from that day forward Isaac's seed became Yahweh's. In the utterances of the prophets and throughout the whole Bible, in the story it tells, this fact is fully set forth. Failure to recognize the fact that a race has been dedicated to serve has prevented thousands from understanding the statements concerning a servant people who would become witnesses to Yahweh's glory throughout the ages. As the story unfolds, the significance of the history of this race - today represented in the Anglo--Saxon-Celtic peoples — will become more apparent. The knowledge of their activities, as they fulfil ancient prophecies, will further establish the accuracy of the Bible story.

Jacob then vowed a vow: (1) If Yahweh would be with him and keep him in the way he went, (2) If Yahweh would provide bread to eat and raiment to wear, (3) If Yahweh would bring him back home in peace, (4) Then shall Yahweh be his El, (5) This pillar which he set up shall be the House of El, and (6) In all his increase he would give Yahweh a tenth. Question: Was Jacob just speaking for himself on the six items above, or speaking for all of his progeny?

COVENANT REAFFIRMATION TO JACOB

After spending many years in the land of Haran, Jacob collected all the numerous possessions he had acquired, along with his wives and children, and quietly left the house of Laban. On his return to the land of his fathers, the angels of Yahweh came to meet him. And, he called the place Mahanaim, templating meeting Esau, who years before had threatened to kill him, Jacob separated himself from his family by sending them across the brook Jabbok, Isaiah 43:10: "Ye are my witnesses, saith Yahwhere he stayed alone and prayed for Yahweh's help. weh, and my servant whom I have chosen ... ' Jacob, being alone, perceived being touched by a man, actually an angel messenger, with whom he wrestled all night until morning. Being frightened to face Esau, Jacob would not let go of the angel of Yahweh until he blessed him. Not being able to overcome Jacob, the angel touched him on his thigh, which in turn came out of joint. Jacob admitting his name meant supplanter, the angel said: ("Thy name shall be called no more Jacob, but Israel: for as a prince hast thou power with Yahweh and prevailed"), Genesis 32:12, 28:

"12 And thou saidst, I will surely do thee good, and make thy seed as the sand of the sea, which "born again" cannot be found in Scripture. I am cannot be numbered for multitude ... 28 And he said, Thy name shall be called no more Jacob, but Israel: for as a prince hast thou power with Yahweh and with men, and hast prevailed."

Following this, Jacob and Esau made a precarious, short-lived reconciliation. Upon Jacob journeying on to Bethel, Yahweh renewed His Covenant with him. It was not a new covenant, but the same Covenant He had made with Abraham and Isaac before him, Genesis 35:11:

"And Yahweh said unto him (Jacob), I am Yahweh Almighty: be fruitful and multiply; a nation and a company of nations shall be of thee, and kings shall come out of thy loins.

YAHWEH'S CHOSEN PEOPLE

From the foregoing, it should be quite obvious Yahweh does have a "chosen people." As a matter of fact, Yahweh chose his people, and in no way can one choose Him. They may choose to serve Him, but cannot choose Him personally. For, He has already made the choice of choosing us, and we have no say in the matter. To back up this statement, I will quote Deuteronomy 7:6:

"For thou art an holy [set apart] people unto Yahweh thy El: Yahweh thy El hath chosen thee to be a special people unto himself, above all the people that are upon the face of the earth."

For more witnesses that this is speaking of Israel only, let's consider the following passag-

Isaiah 44:1-2: "Yet now hear, O Jacob my servant; and Israel whom I have chosen: 2 Thus saith Yahweh that made thee, and formed thee from the womb, which will help thee; Fear not O Jacob my servant; and thou Jesurun whom I have chosen."

FALSE DOCTRINE OF BEING BORN **AGAIN**

While it is not our desire to ridicule anyone's prayer to Yahweh for repentance such as found in 2 Chronicles 7:14, or any effort one might put forth to amend one's ways, but the doctrine of being



sure many might be quick to quote John 3:3 where it says: 'Verily, verily, I say unto thee, Except a man be born again, he cannot see the kingdom of Yahweh." Actually, this passage does not say "born again", but "born from above." You'll have to admit there is a world of difference between being born again and being

born from above. Being born from above simply does not imply being born again. You can check almost any Bible commentary and it will confirm 'born from above' is a correct rendering. It may also be rendered "from the beginning." It was Nicodemus only who didn't understand this, and churches, as a whole, have taken the same position he did. While the churches do not go to the extent of saying one must reenter one's mother's womb, they take another erroneous position. Nominal churchianity takes the position: if a person, (and he can be from any race) chooses Jesus Christ as his personal Savior and believes on Him, he can enter the Kingdom, and somehow this new candidate is regenerated or "born again" of the Spirit. That this passage should have been translated "born from above" is illustrated in Matthew Pool's A Commentary On The Holy Bible, volume 3, page 290:

"The word translated <u>'again'</u> is "anothen" which often signified 'from above' ... "

Comparing verse 3 to 31, we can plainly see it should have been translated "from above" as it uses the same Greek word #509:

John 3:31: "He that cometh from above is above all: he that is of the earth is earthy, and speaketh



of the earth: he that cometh from heaven is above all."

Now that we can understand that the expression "born again" is a mistranslation, let's take a better look at this passage found in John 3:1-21. What we have here is a man of the Pharisee sect by the

name of Nicodemus coming to the Messiah by night to inquire more concerning the kingdom of Yahweh. No doubt, Nicodemus was a good man and a true Israelite, for he defended Yahshua at his trial, John 7:50-51, and attended, with Joseph of Arimathaea at His burial, John 19:38-40. This was part of the conversation our Anointed One had with him, John 3:3-7:

"3 Yahshua answered and said unto him, Verily, verily, I say unto thee, Except a man be born from above, he cannot see the kingdom of Yahweh. 4 Nicodemus saith unto him, How can a man be born when he is old? can he enter the second time into his mother's womb, and be born? 5 Yahshua answered, Verily, verily, I say unto thee, "But the natural man receiveth not the things of the cannot enter into the kingdom of Yahweh. 6 That which is born of the flesh is flesh; and that which is born of the Spirit is spirit. 7 Marvel not that I said unto thee, Ye must be born from above."

What we have in this passage is a paraphrase, which is defined in the dictionary as a restatement of the meaning of a passage in different words. In other words, the secondary statement is a restatement us-"Art thou a master of Israel, and knowest not ing different words to help define the meaning of the primary statement. A paraphrase is two parallel statements saying the same thing, but in different words. Actually, what we have in this passage are three statements in parallel. Now that we know what a paraphrase is, let's examine the (1) primary, (2) secondary, and (3) the third-parallel statements of this passage. In verse 3, the expression "Except a man be born from above" implies an additional birth other than a physical birth. So the first statement suggests a natural birth, plus a birth "from above." Being a paraphrase, the secondary statement must repeat the same message, but with different words. fore, the physical birth implied in verse 3 is the same as the water and flesh of verses 5 and 6, and the "born from above" of verse 3 is the same as the Spirit and spirit of verses 5 and 6. The parallel is: (1) natural birth, water, flesh (2) born from above. Spirit, in other words, the natural birth of verse 3 is the same as water and flesh, and the "born from above" of verse 3 is the same as Spirit and spirit. Once we understand the parallel of the natural birth, we soon understand the water surrounding the child breaking and producing a body of flesh. When we further understand the "born from above", we then comprehend a birth of the Spirit by the Spirit [of Yahweh]. The "water" in this passage has nothing to do with baptism!

Some say the Spirit-birth happened in preexistence, which may have some merit. Whether or not such a thing is true, we can be sure the Spiritbirth happened when Yahweh breathed the breath of life into Adam. Therefore, Adam became a spiritman (living soul), and the father of a race of spirit-men and spirit-women. Throughout the Bible, it differentiates between earth-men and spiritmen. The Adam-man was the only race born with the Spirit of Yahweh. The other races are born of the flesh, but not the Spirit. Once we understand this, we can comprehend such verses as 1 Corinthians 2:14, which reads:

Spirit of Yahweh: for they are foolishness unto him: neither can he know them because they are spiritually discerned."

The next important statement made by the Messiah to Nicodemus is recorded in John 3:10 when He said to him:

these things?"

This should give us a pretty good idea that what Yahshua told Nicodemus he ought to have known, can be found somewhere in the Old Testament. It is also possible the "Spirit" spoken of in John 3:2-8 may have significance overlooked by many. While we know it is true concerning Adam being a spiritman, this passage may be speaking of something beyond this in scope. Let's take a look at Ezekiel 36:26-27:

It should be noted in the passage just quoted, that it is directed only to Israelites, for they alone received the statutes and judgments. With all of this, it should become quite clear what is meant by being "born from above." It should be quite obvious, when it is speaking of the "water", it is speaking of the natural birth process and not baptism. It should also be quite evident, that the being "born again" doctrine taught in the mainstream churches is not at all the

Spirit-birth taught in Scripture.



Nicodemus, hearing word rumored about concerning the Messiah's teaching of the Kingdom, decided to investigate the matter with Yahshua Himself. We have to imagine poor, old Nicodemus when he misunderstood he might have to reenter

his mother's womb to gain entrance thereto. What a strange way to enter the Kingdom of Yahweh he must have thought. He was probably familiar with the usual civil laws for entering a country by the right of birth in an earthly kingdom. But, to enter the Kingdom of Yahweh, he finds he must enter by the right of the Spirit-birth breathed by Yahweh. He was informed: "... the natural man receiveth not the things of the Spirit of Yahweh" (1 Corinthians. 2:14). In Nicodemus' eyes, the Messiah introduced a whole new (but really old) concept of the Kingdom of Yahweh (John 3:6) of flesh and spirit. Every Adamite has two births: one from earth, one from above; one of his body and one of his spirit. Without the first, he cannot enjoy the earth; without the last, he cannot see or enjoy the Kingdom of Yahweh. The one is visible; the second is invisible. [Gal. 4:28-31]

THE INVISIBLE KINGDOM

After Messiah explained to Nicodemus both the physical and spirit dimensions of the Kingdom, in John 3:8, He goes on to compare the Spirit to the phenomena of the wind:

"The wind bloweth where it listeth, and thou hearest the sound thereof, but canst not tell whence it cometh, and whither it goeth: so is every one that is born of the Spirit."

While the wind blows in a variety of directions, and we can hear its sound, perceive its operation in the motion of the trees and even feel its touch, we cannot discern the air itself. The motion of the wind is imperceptible, but we can gauge it by its risings, fallings and changes of directions. We can only know that it exists by the effects which it produces. Like natural birth, the Spirit reproduces, by the law "after its kind." Miscegenation, therefore, brings death to the Spirit. In Scripture, both in Greek and Hebrew, the words "spirit" and "breathed" are constantly brought together. Therefore, inasmuch as Yahweh breathed into Adam His breath of life, they are both of the same Spirit.

As the Kingdom's coming is imperceptible, Yahshua said, Luke 17:20:

'The kingdom of Yahweh cometh not with observation." Truly, the Kingdom must be reconciled with the Covenant, for we are legally His from

astor V. S. Herrell recently posted an article, "A Kraut of Krauts", which not only condones, but even promotes the consumption of swine, using poor translations and interpretations of several New Testament passages in order to do so. In the article he also slanders all those who may disagree with him, by labeling them with the "Judaizer", "mongrel' or "jew" epithets as a cunning device in order to somehow discredit his adversaries before they could even reply. Now Herrell may be full of



tough talk, but if he called me a "mongrel" or a "jew" to my face I'd be willing to go out into a back lot with him at any time to settle the matter man to man.

I'm not attempting threats of violence or a display of boasting or zealous bravado here, but would only like to get one thing straight up front: I will not be intimidated by Herrell's arrogance. And my ancestors having come from a small village in the Rhineland, I am just as much of a "kraut" as he is. Herrell's article makes many other mistakes concerning the history of the White race, and also ridiculously associates the issue of swine with race and aesthetics, as if insinuating that all beautiful White people must eat pork, or one cannot possibly be beautiful or White! However those other errors shall not be addressed here.

Isaiah Chapter 66 contains a prophecy that most reasonable men agree is an end-times prophecy. In the middle of this prophecy, at verse 17, we

find the following: "They that sanctify themselves, and purify themselves in the gardens behind one tree in the midst, eating swine's flesh, and the abomination, and the mouse, shall be consumed together, saith the LORD." Isaiah's prophecy concerns the dispersed children of Israel, who are those same Germanic pagans eating swine's flesh in pagan idolgroves which he is describing! Yet it must be known that Herrell is a Preterist: one who believes that all Biblical prophecy was fulfilled by 70 AD and the destruction of Jerusalem. 

In the verses quoted above, it is clear that Jesus is comparing the future tribulation with the days of Noah just before the Flood "took them all away." So, let's look at those verses and see what they say:

"And Yahweh said unto Noah, Come thou and all thy house into the ark; for in thee have I seen righteousness before me in this generation." -Gen: 7-Verse 1

"And every living substance was destroyed which was upon the face of the ground, both man and cattle, and the creeping things, and the fowl of heaven; and they were destroyed from the earth: and only Noah remained alive, and they that were with him in the ark. – Gen: 7-Verse 23.

Now, note very carefully the use of the word "remained." Unless I do not understand the English language, "remained" and "left behind" are synonymous. I can hear the wailing and the grinding of teeth when the rapturists find out how wrong they have been.

"That the trial of your faith, being much more precious than gold that perisheth, though it be tried with fire, might be found unto praise and honor and glory at the appearing of Jesus Christ." -- I Peter 1: 7.

What greater delusion could there be than believing that mere faith, as opposed to practicing the righteousness of Yahweh's Law, is all that is required for salvation! Did any of the prophets say that it would that easy?? The dispensational-

Of these modern, fair weather Christians, I would ask: How does your "faith" compare with Job's? Are you absolutely, one hundred per cent positive that the Old Testament is irrelevant?

They have unwittingly obviated the need for the Tribulation because they have replaced God's Law with antinomian "faith," thus removing the Scriptural basis (righteousness versus unrighteousness) for the Judgment Day and the very tribulation from which they falsely expect to be spared. 3.) They have fallen into a delusion of self-flattery, claiming that their vague, emotion-

laden concept of "faith," even though it denies the validity of the Law, is sufficient for salvation. 4.) They have opted for the easy way out, contrary to the clear pronunciations of Scripture which tell us that we must be "tried by fire" and that we must "endure to the end."

In short, they have become Christian couch potatoes whose heads are so far up in the clouds that they are no earthly good. Amen.

There will indeed be a rapture of the saints; but the "rapture" will be the joy they experience after they have endured to the end. Frankly, I wouldn't miss it for the world. I want to savour the victory. Being "chastened," "tried," and effectively removed themselves from the scene "made pure as gold" should be considered an honour, not something to be avoided. Gird your loins and buckle your seatbelts, the roller coaster leaves in five minutes! Maybe sooner!





Was Mary A Levite Or A Judahite? By Pastor Eli James

Many Christian Identity believers have written tribe of Levi. to me expressing the opinion that Mary, mother of Jesus Christ, was not of the tribe of Judah but was a descendant of the Tribe of Levi. In this paper, I am going to do my best to counter this opinion and show the Biblical reasons why it is unsound. Although most of those who have expressed this opinion are concerned Christian Identity adherents, there are also those who wish to throw a monkey wrench into the works of Christianity by suggesting the idea that Jesus was NOT of the House of David, and therefore, not a Judahite.

The Sycamore Of The Bible Extract From

Scripture Natural History - The Trees And Plants William H. Groser BSc.(Lon) 1888

Editor's Note: This extract is interesting from the point of view that the sycamore tree that Zaccheus climbed was in fact a fig tree whose scientific name is *Ficus sycomorus* and possibly the reason for it being mistranslated as a sycamore tree. This tree is not the edible fig, but the bad fig of Scripture, so therefore when Christ called Zaccheus down, this was symbolic of him being called out of the Edomite Jewish world order.

Sycamine Sycamore (Heb. shihmah). 'Ye might say unto this sycamine tree, Be thou plucked up.'—Luke xvii. 6. The sycamore trees that are in the vale.'—1 Kings x. 27.

In giving almost identical names to the mulberry and the sycamore-fig, the old Greeks were not led into any serious botanical error; for both the figs and the mulberries are classed by most bota-

nists in the same order of plants. Both terms were derived from, a fig, and the sycamore is the 'fig-mulberry,' so called from its resemblance to the fig in its fruit and to the mulberry in its leaf. The 'Morea' derives its name from its similarity to the latter in form. But the two names were often used inter-changeably, the sycamore-fig being called the 'Egyptian sycamine.' By Latin writers the two kinds were distinguished by different names.

Modern Biblical critics have contended that their predecessors were in error in supposing the 'sycamine' of Luke xvii. 6 to be identical with the 'sycamore' of Luke xi. 4, and of the half-dozen references thereto in the Old Testament. But although, as we have seen, translators of former days fell into many excusable mistakes in matters of scientific identification, two points may fairly be urged in their favour in the present instance. The first is, that in the Septuagint Ver-

sion of the Old Testament every instance in which the Hebrew has shikmin the Greek has, 'sycamine,' and not 'sycomore,' though the fig, and not the mulberry, is certainly intended. St. Luke, therefore, may easily have used the two names interchangeably. The second argument is forcibly put by Dr. Thomson: 'As to the mulberry, it has yet to be shown that it was then known in Palestine; ...and further, the mulberry is more easily plucked up by the roots than any other tree of the same size in the country, and the thing is oftener done. Hundreds of them are plucked up every year in the vicinity and brought to the city for firewood.'

We conclude then that the word sycamine, instead of being used in its strictly classical sense in the passage above cited, is employed, as in the Old Testament, to denote the **SYCO-MORE-FIG**, and as synonymous with the Sycomore of Luke xix. 4.

The tree thus alluded to is a true fig, and has no natural alliance with the maple sycamores of Europe and North America, which belong to an order not represented in Palestine. It is the Ficus sycomorus of botanists, and is still common in warm and sheltered localities in that country. In Egypt 'Pharaoh's fig trees,' as they are called, are less abundant than formerly, leading some modern travellers to doubt, but quite unnecessarily, whether this was the true 'Egyptian sycamore' of Theophrastus and Dioscorides. Dr. Thomson has given a full description of this noble tree of wayside, valley, and plain. He says it is easily reared, grows rapidly, and becomes a giant in girth, with wide-spreading branches and enormous roots. It bears several crops of figs during the year; but they are small and insipid, compared with those of the better-known F. carica. Still, they are gathered, as by the prophet Amos of old, and sent into the markets for food, chiefly among the poorer classes; among whom alone 'gatherers of sycamore fruit 'are to be found (see Amos vii. 14). Children, like Zaccheus, often climb into the branches. In flowers and foliage it closely resembles the common fig, but grows to a greater size, sometimes reaching

a height of thirty or forty feet, and a diameter of twenty.

The wood is soft, but durable, and therefore useful; and this fact will serve to explain several Biblical allusions. David, and Solomon after him, had special plantations of sycamores and olives under the care of

crown officials, in the 'Shephelah' or low hills near the coast, where the climate is mild and equable (1 Chron. xxvii. 28; 1 Kings x. 27). Solomon in his years of wealth and prosperity made cedar timber as common as sycamore wood. In later times, when national apostasy had brought divine judgments on the land, Ephraim and Samaria are represented as saying, 'in their pride and stoutness of heart, the bricks are fallen down, but we will build with hewn stones: the sycamores are cut down, but we will change them into cedars' (Isaiah ix. 9, 10).

With cedars, pine trees, and oaks, the Hebrews might well regard the wood of the sycamore-fig as an inferior material; just as the fruit was not to be compared to that of the allied species. But in Egypt it was far from otherwise. The sycamore yielded the largest planks; it was extensively cultivated for coffins, tables, doors, boxes, tablets, and idols; while as a fruit-tree its figs were valued much more highly than in Palestine, being included in the sacred offerings to the gods, and even selected as the heavenly fruit to be given to the righteous on their admission to eternal happiness. Hence we can well understand the severity and significance of the visitation mentioned by the Psalmist (lxxviii. 47): 'He destroyed their vines with hail, and their sycamore trees with frost.' Like the statelier palm, the sycamore has almost disappeared from the city of Zaccheus the publican. An aged specimen grows near the Pool of Siloam at Jerusalem, and is said to mark the site of Isaiah's







Why Jubilees?



Why did Yahweh have Moses write the book of Jubilees? The simple answer to this question is that the Jubilee, like Yahweh's Sabbaths and Feast Days, is an ordinance that were are to keep and memorialise forever. The problem is that we haven't been obeying this

ordinance. Few Christians pay any attention to this, which is Yahweh's most important economic law. And, certainly the Jews, who claim to keep the laws of Moses, fail even more, because they publicly proclaim to be the observers of these laws. We in Identity know that this is Judaism's greatest lie. We know that Judiasm is the DENIAL of Moses, not the affirmation of Moses. Jesus Himself confirms this, when He tells those lying, thieving Pharisees: "Do not think that I will accuse you to the Father: there is one that accuses you, even Moses, in whom you hope. 49 or 50 Years?

Many people are under the false assumption that a Jubilee is a period of fifty years. That is incorrect. A Jubilee period is exactly 49 years,

Here is the definition given to us at Leviticus 25:8: And thou shalt number seven sabbaths of years unto thee, seven times seven years; and the space of the seven sabbaths of years shall be unto thee forty and nine years.

Why then the common error of counting 50 years instead of 49? The reason is that the Jubilee is to be proclaimed on the Day of Atonement in the 49th year, but it lasts into the following year, which is actually the first year of the next 49-year Jubilee period. The Jubilee is a celebration that occurs WITHIN those two years, but it is not a chronological year. It is actually a year-long celebration, which commences on the Day of Atonement in year 49 and ends on the Day of Atonement in year 1 of the next set of 49 years.

In other words, Year 49 is a typical Sabbath year until the Day of Atonement. When the Day of Atonement arrives in that year, the Jubilee must be proclaimed.

We have completed plans for our 9/9/09 (the follow-up to last year's 8/8/08 event) internet radio marathon for this year. During last year's event, I announced that we will be repeating these internet marathons every year until the year 2012, but each year the date would be moved up, from 8/8/8 to 9/9/9 to 10/10/10, 11/11/11, and finally, 12/12/12. This year, the theme is Yahweh's Jubilee! At that time, I felt moved to make the Jubilee the theme for this year's event; but I then had no idea that 2009 was the 70th Jubilee year from Joshua! Dr. Pratt has filled us in on the details.

I will quote extensively from John Pratt's article, so you can get his reasoning:

> Now we come to a date that has eluded me until now. The story of the falling of the walls of Jericho at the blast of the trump is one of the strangest stories in the entire Bible, and seems loaded with calendrical significance. Let's review this unusual story and then determine the date.

> Shortly after passing over Jordan, Joshua was commanded to conquer the city of Jericho in a very peculiar manner. Afterwards, the taking of the other cities of Canaan was much more routine. But in the case of Jericho, Joshua was commanded to have his army encircle the city once per day for six days. Accompanying the army were to be seven priests, each bearing a trumpet, and carrying the sacred ark of the covenant.



On the seventh day, the group was to encircle the city seven times, after which the priests were to give a long, loud blast on their trumpets. At that time, the entire army was to shout, and the walls would fall to the ground, rendering the city an easy mark to conquer (Joshua 6:3-6).




As this article was in preparation, the search was again made for the date of the fall of the walls of Jericho and now the answer seems so obvious that it is amazing that it was not discovered earlier. The Feast of First fruits occurs seven

Note that the Day of Pentecost, which always occurs on Sunday on the Perpetual Hebrew Calendar, is counted as the fiftieth day from Easter Sunday, even though they are separated by seven weeks (49 days), because Easter is counted as the first day.



With all of that in mind, let us now consider the Feast of First fruits (Pentecost) as a possible date for the Fall of Jericho. Passover that year was celebrated on evening preceding Sat 17 Apr 1422 BC. The manna ceased to appear in its weekly cycle the following Sunday morning

(Joshua 5:12), which was Easter Sunday, 18 Apr 1422 BC. The disappearing of the manna from the earth clearly represented the return of Jesus Christ to heaven, he being the true manna from heaven (John 6:31-35, 48-51). Note the wonderful significance that the manna returned to heaven on Easter Sunday, the same day on which the Savior resurrected. That Easter morning had two other things in common with the morning of the Savior's resurrection: it was also Easter on the Jubilee calendar and the day of the Priest cycle representing resurrection.

Counting seven weeks from that Easter brings us to Sun, 6 Jun 1422 BC, the Feast of Firstfruits, as the proposed day for the Fall of Jericho. That turns out to have been a holy day on at least five sacred calendars. In addition to being Pentecost, it was 13 Serpent on the Sacred Round (as was "Brazen Serpent Day"), Firstfruits (of Wine) on the Jubilee calendar, 0 Prime (Mercury), and 1 Summer on the Enoch Fixed calendar. With all of those testimonies that the day was special, there is no doubt in my mind that finally the date of the Fall of Jericho has been found.

Upcoming Celebration Dates

There will be an anniversary date of each of the above events coming up in the seventieth jubilee year. The fact that the year is not just any jubilee, but marks exactly seventy jubilees from

Most of these dates are not outstanding on their own, but only in commemoration of great events of the past. On the other hand, one of these dates is amazing by itself: the anniversary of the Crossing of the Jordan River.

Dr. Pratt concludes his calendar analysis with these words:

According to the proposed dates from my research, the year from about Sep 2008 through Sep 2009 will mark the seventieth jubilee year from the events of the last year of Moses leading the children of Israel through the wilderness and of Joshua crossing the Jordan River into the promised land of Canaan. It would be a good time to commemorate the raising of the Brazen Serpent, the giving of the Book of Deuteronomy, and even the Easter Sunday on which the manna ceased to come from heaven. But of all of the days to celebrate, the most outstanding will be the anniversary of Joshua's miraculous crossing of the River Jordan. The quarter-day beginning at 6 p.m. on Sun 5 Apr 2009 is a once-in-history repetition of the date of the birth of Isaac on four sacred calendars.





As the late Will Rogers used to say, "It ain't so much what a man doesn't know that causes him so many problems, but what he knows that just ain't so."
