

ETER CONFIRMS THIS LAN-GUAGE WHEN HE SAYS, "Judgment must begin at the House of God," (I Peter 4:17) which can only be the whole House of Israel. All of Scripture confirms this. It is only because of the poor translations, deceptive definitions, Jewish "tradition," and Judeo-apostasy that anything different is taught today.

Israel is Yahweh's Servant **People**

We are Yahweh's Servant People. Neither the Jews, nor any other people, have ever sereved Him. They have always served their own gods.

Isa. 4:21: "Remember these O Jacob and Israel; for thou art my servant: I have formed thee; thou art my servant: O Israel, THOU SHALT NOT BE FORGOTTEN OF ME."

Verse 22 is a prophecy of the coming of the Kinsman Redeemer of Israel: "I have blotted out, as a thick cloud, thy transgressions, and, as a cloud, thy sins: return unto me; for I have redeemed thee." These words were spoken only to Israel, and no one else. Acts 7:31 confirms that this forgiveness only applies to Israel.

Isa. 42:1 tells us this: "Behold MY SERVANT (Israel), whom I uphold; MINE ELECT, in whom my soul delighteth; I have put my spirit upon him: he shall bring forth judgment to the nations."

Isaiah does NOT say that Israel will become the nations. He tells us that we will bring judgment TO the nations.

PROMISE

The Promises were made exclusively to Abraham, Isaac and Jacob...and their descendants.

Gen. 16:6-12. Hagar's son is Ishmael, the progenitor of today's Arabs.

Paul confirms Ishmael's exclusion in Gal. 4:22-31. We Anglo-Saxons are the children of the free woman, Sarah. The Ishmaelites (today's Arabs) are the children of the bondwoman, Hagar.

Gen. 17:1-16, 19-21. "Perfect" is *Tamiym*, without blemish, without spot. This is the same word that is used of all sacrificial animals. This word cannot be equated with good, upright, or blameless. This is a reference to genetic purity.

Yahweh's specific promise is given to Sarah (Gen. 17:15-16). She will be the mother of a bloodline. Her direct descendants will be kings and nations.

Again, Paul confirms the exclusivity of these promises. Gal. 3:13-19. This covenant cannot be disannulled. "Abraham's seed will be a blessing to all nations." Paul confirms the exact terms of Gen. 12:3 at Gal. 4:14. Nothing has been altered, nor can it be altered.

The whole of Chapter 3 is devoted to explaining that the forgiveness of Israel was not dependent upon the Law of Moses. It was promised independently of the Law, even BEFORE the Law, through Abraham. That's why the Law cannot annul this promise.

"Now to ABRAHAM AND HIS SEED [posterity] were the promises made. He said not "and to posterities [such as those genealogies which have been decidedly excluded from the promises], as of many [posterities]; but as of ONE [posterity], to your seed [posterity], which is anointed. – Gal. 3:16.



The KJV translation of "which is Christ" is absurd, as the promises were NOT made to Jesus Christ. The verse begins by recounting the direct genealogy to which the promises were applied. These promises were made to all of Abraham's direct descendants, through Isaac and Jacob's descendants. The specific promise that the Messiah [Christ] would come to Israel is being

affirmed here. Christ did not come to redeem Himself, as this horrible translation implies. Nor were the promises made to Him. He is the Redeemer who was promised to Israel. Gal. 3:16 is speaking of the ANOINTED PEOPLE, ISRA-EL.

"I come not but unto the exiled sheep of the House of Israel." – Matt. 15:24.

He did not come to redeem himself. He was sinless. These nonsensical translations in the KJV have made absolute mincemeat of the True Gospel.

Also, Gal. 3:28-29 is horribly translated. It should read, "There is neither Judean nor Greek, there is neither bond nor free, there is neither male nor female: for you [ISRAEL] are all one in Christ Jesus. [This confirms that the anointed people, Israel – all twelve tribes, including those of the Dispersion, male or female, free or bond, Judahite or Hellenized Israelites – were redeemed at the Cross.] And if you be anointed, then are you Abraham's seed [direct posterity] and heirs according to the PROMISE."

Paul is confirming that only the **anointed peo- ple**, those to whom the promises were made, are the recipients of the promise that was delivered. Sarah specifically disinherited Ishmael at Gen. 21:10.

Esau disinherited his own descendants by selling his birthright, and Paul has no authority to change the terms of the covenants and promises. Nor does he claim to have such authority.

He specifically states that no one has the authority to **give our inheritance to anyone else**; but the KJV and the Dispensationalists claim otherwise! This is GRAND THEFT, by mistranslation! But these promises can be fulfilled only by ensuring that they are delivered to their intended recipients. The KJV has butchered these verses so badly that they make no sense whatsoever.

However, the universalists just love to preach nonsensical sermons about how ALL PEOPLE – even the Ishmaelites and Edomites who were specifically excluded - can become "Abraham's seed" by "having faith." Can you believe this? Believe it, because they have pulled off this tremendous scam by mistranslating a few words! Paul said no such thing.

Galatians 4:1-7 carries the radical word stretching further by falsely translating the Greek huiothesia as ADOPTION in verse 5. Strong's tells us that this word means the "PLACING, as a son."

The word, ADOPTION, is added as an example, but it is a bad example, because only sons and daughters can be put into the place of INHERIT-ANCE. Now, a son or daughter can be placed into the position of inheritance when they come of age. But, only those directly named in the LAST WILL AND TESTAMENT count as heirs. This is how the promises to Abraham, Isaac and Jacob have been fulfilled TO THE LETTER.

Paul is saying that the heirs have "grown up" and now qualify for the inheritance. No other human beings can possibly qualify as heirs. In this verse, Paul first makes it clear that Christ came to redeem them that were under the law [of sacrifices], which had been delivered to and practiced exclusively by Israelites and no other people!!!! So, how can the people of other nations be adopted? These two concepts are in direct contradiction to each other.

Verse 6 confirms that he is talking about true Source: sons, not those adopted from other nations.

Verse 7: "Wherefore you [the direct descedants of Abraham, Isaac and Jacob] are no longer a servant, but a son; and if a son, then an heir of God through Christ." Remember that only Israel was considered by Yahweh to His Servant People. We are to serve Him by bringing the world order back under His Law. As the City on the Hill, we are to set the example for other nations to follow. If we mix with them, we become like them. If we become like them, then there is no city on the hill.

As Paul stated twice already (Gal. 3:15, 17), these covenants CANNOT BE ANNULLED, but the translation committee of King James have these covenants mean what they say, and declare that the promises have been annulled, by King James. CHANGING THE TERMS OF THE PROMIS-ES AND COVENANTS and adding the rest of creation to the redemption. This doctrine is in total violation of the terms of the covenants, promises, and inheritance. But false priests have no problems with contradictions.



Arnold Kennedy (above) has done the best analysis of the KJV's poor translation of the book of Galatians. His article, "The book of Galatians and an Israel Exclusive" is must reading. First, a quotation regarding Gal 3:26 and 3:29:

In these two critical verses we have something else [not Jesus Christ] which is anointed! What can it be? What is the subject? Is it not the seed of Abraham, in their generations, according to the original promise? Hence, Gal. 3:16 reads 'and TO THY SEED which is anointed' and Gal. 3:29 reads 'and if ye be an anointed (people) then ye are Abraham's seed. The churches try to spiritualize the matter of Abraham's seed." -

How would you like it if someone mistranslated your epistles and then interpreted them in such a way as to deprive you of your inheritance? Would that not make you slightly upset with the translators?

Then, because of this type of subterfuge, many in Christian Israel accuse Paul of being the guilty one, not realizing that the KJV translators were doing the devil's work in contradicting the clear, unambiguous, exclusive Covenants between Yahweh and Israel.

How would you like to be accused of this false charge? This is what the Paul distorters have done to his epistles. The lousy KJV translation done their utmost to rewrite history, deny that is responsible for this massive confusion. Paul cannot be blamed for the imperialistic agenda of

KINDRED

Gen. 24:1-7, 36-38: "My kindred" refers to the Shemitic nation of Abraham. No Canaanite wife is permitted for Isaac. Rebekah is the pure White

Shemite that Yahweh has selected for Isaac. She is blessed by Yahweh at Gen. 24:58-60

Gen. 25:1-6: The sons of Keturah are sent away so as not to interfere with Isaac's inheritance. These are the Indo-Aryans. They are still a kindred people to the Shemitic Caucasians, but they are not Israelites.

HOLY, SEPARATE, SEVERED

"Holy" means "called out." It is only in modern times that the word 'holy' has developed the strictly RELIGIOUS meaning of 'saintly" or "non-sinful." Even so, these modern meanings are derived from "called out."

Obviously, the Israelites were hardly ever a non-sinful people, so that definition makes no sense at all. Yahweh has constantly struggled with us because of our sinfulness. Only the Elect, or Remnant, ever achieves righteousness to the degree acceptable to Yahweh for governance of the Kingdom. We are the elect, in spite of our faults, because Yahweh intends to purge the sin out of us.

Ex. 19:5-6: "Now, therefore, if ye will obey my voice indeed, and keep my <u>covenant</u>, then ye shall <u>be a peculiar treasure unto me above all people</u>: for all the earth is mine. And ye shall be unto me a kingdom of priests, <u>and an holy nation</u>.

Isa. 6:12-13: "And Yahweh has removed men [#120, AWDAWM] far away [into the wilderness of Europe, which became the regathering place for all White Israelites], and a great forsaking [of His laws, way back in Palestine and the Great Apostasy today] in the midst of the land. But yet in it shall be a tenth [a remnant], and it [the remnant] shall return [to Me, Yahweh], and shall be eaten: as a teil tree, and as an oak, whose substance is in them, when they cast their leaves: so the HOLY SEED shall be the substance thereof."

The Israelites will yet bear fruit, which can be "eaten" when the harvest is ripe. The other 90% are so rotten that they cannot be "eaten." This is also confirmed by the prophetic Church of Laodecia, the End Time Apostasy which so foul that it literally nauseates Yahshua! (Rev. 3:16.) Only the Israelites are spoken of in this manner. None of the historical escapades undergone by Israel apply to any other race. The exclusivity

of the Bible is unmistakable, once the fog of universalism is removed from one's eyes. Segregation is not an option. It is mandatory.

"For I am Yahweh your Elohim, the HOLY ONE OF ISRAEL, your Savior: I gave Egypt for your ransom, Ethiopia are for you. Since you (Israel) were precious in My sight, you have been [somewhat] honorable, and I have loved you: therefore will I give men for you, and people for your life.

Fear not: for I am with you: I will bring your seed from the east, and gather you from the west. I will say to the north, Give up; and to the south, Keep not back: bring My sons from afar, and My daughters from the ends of the earth; Even every one that is called by my name: for I have created him for my glory, I have formed hmi; yea, I have made him." - Isa. 43:3-5.

These words are spoken exclusively to Israel and to no other people. In fact, these words are part of the dominion Mandate given to the Adamic race way back in Gen. 1:26-31. Yahweh will present the other races and nations to us, once the Remnant has mastered righteousness.

The Hebrew word for 'holy' is qadash. More than anything else, it means "appointed, dedicated, consecrated." The dedication ceremony was the placing of Isaac on the sacrificial altar by Abraham. Only by virtue of this ceremony are Isaac's descendants intended to be "sacred," or "non-sinful."

Certainly a priest and God's people Israel should be non-sinful; but that is not what the word means.

It means that Yahweh has dedicated us exclusively, setting us apart from the heathen, in order that we might refrain from sin, so that we could provide the world with a holy example, so that we might be the City on the Hill.

Peter confirms this dedicated state for Israel. I Peter 2:9-10: "Ye are a chosen [selected out of many races] Race, a royal [kingly, above all others] priesthood, a holy [dedicated exclusively to Yahweh] nation, a peculiar [different from all other peoples] people, that ye should show the praises of him [to the rest of the world, as in Gen. 12:3] who hath called you out of darkness in to his marvellous light. Such in time past were not a people, but now are the people of God."

Because the Israelites had been already scattered throughout the Greco-Roman world, Peter is simply stating that the New Covenant has again made us One People, via the common forgiveness. Because Israel was broken up into **two houses** after the death of Solomon, we were no longer ONE PEOPLE.

And because we had forgotten His Covenants with us, we were no longer a cohesive culture. But Christ's forgiveness of our past sins made us one people again.

Yahweh is speaking to His people through the apostle Peter, referring to us, using the exact same exclusive language that is contained in the Old Testament, declaring that we are a "chosen" or elect" race, as a "holy nation" and as a "people for God's own possession." By God's grace we occupy a very favoured position in His universe. This is what it means to be CHOSEN. If every group, race and nation were likewise "chosen," the word would lose its meaning.

Now, True Israel, what are you going to achieve with this very favoured status? Are you going to do as the Judeo-Christians do and destroy your own talents by wasting them on this evil world; or are you going to use your peculiar talents to bring in the Kingdom?

More exclusivity, if you can handle it: "When Yahweh, thy Elohim, shall bring thee (Israel) into the land whither thou goest to possess it,

and hath cast out many nations before thee, the Hittites, and the Girgashites, and the Amorites, and the Canaanites, and the Perizzites, and the Hivites, and the Jebusites,, seven nations greater and mightier than thou; And when Yahweh thy Elohim shall deliver them before thee; thou shalt smite them, AND UTTERLY DESTORY THEM; THOUSHALT MAKE NO COVENANT WITH THEM, NOR SHOW MERCY UNTO THEM." - Deut. 7: 1-2.

Why would God say such a seemingly horrible thing? The Christian Apostasy teaches that those days are over; and that it is water under the bridge. Let's continue to read, and we'll find out what the Christian Apostasy does not want you to know.

"NEITHER SHALT THOU MAKE MAR-RIAGES WITH THEM; thy daughter thou shalt not give unto his son, nor his daughter shalt thou take unto thy son." – Verse 3.

At Deut. 14:1-2, speaking specifically to the children of Israel, we are told, "Ye are the children of Yahweh your God: ye shall not cut yourselves, nor make any baldness between your eyes for the dead. For thou art an holy people unto Yahweh thy Elohim; and Yahweh hath chosen thee to be a peculiar people unto Himself, above all the nations that are on the face of the earth."



This dedication of one particular people, which Paul refers to as "predestination," as being "above all other nations," is repeated at Deut. 26:18-19, which tells us "And Yahweh hath avouched thee this day to be His peculiar people, as he hath promised thee, and that thou shouldest keep all His Commandments; And to make thee high above all nations which He hath made, in praise, and in name, and in honour; and that thou mayest be an holy people unto Yahweh thy God, as He hath spoken."

I Kings, 8:51-53, states: "For they be THY PEOPLE, and THINE INHERITANCE, for

which thou broughtest forth out of Egypt, from make with the house of Israel; After those days, the midst of the furnace of iron: That thine eyes may be open to the supplication of THY SERV-ANT, and unto the supplication of Thy People **Israel**, to hearken unto them in all that they call for unto Thee. For thou didst SEPARATE THEM FROM AMONG ALL THE PEOPLE OF THE EARTH, TO BE THINE INHERITthy servant, when thou broughtest our fathers ber their sin no more. out of Egypt, O Yahweh God."

At Isa. 44:3, God tells Jacob/Israel: "I will pour my Spirit **upon thy seed, and my blessing upon** thine offspring. (Not to all people, but Israel's offspring only. The other nations get blessed according to Gen. 12:3.)

Isa. 51: 1-4: His laws are to be promulgated to the other nations by us, True Israel, that we may be a blessing to the nations, as we have done, as history proves. But we succeed in instructing the nations ONLY AS A SEPARATE SPE-CIES, for when we mix with them, we become like them, and we lose our genetic ability to be that special people, Israel.


The New Covenant Prophesied in the **Old Testament**

Old Testament "Word for Word" Deuteronomy Part 21 Translation by Stephen Howard Anderson



Chapter 28

[Blessings For Obedience]

- 1. And it shall be, if you shall listen diligently to the voice of Yahweh Eloheycha, to observe and do all His commandments that I command you today, that will set 5414 you Yahweh Eloheycha on high 5945 over all the nations of the land.
- **2.** And shall come upon you all these blessings *1293*, and overtake *5381* you, because you listen to the voice of Yahweh Eloheycha:
- **3.** Blessed *1288* shall you be in the city *5892*, and blessed shall you be in the field *7704*.
- **4.** Blessed shall be the fruit 6529 of your womb 990, and the fruit of your ground 127, and the fruit of your beasts 929, the increase 7698 of your oxen 504, and the flocks 6251 of your sheep 6629.
- **5.** Blessed shall be your basket *2935* and your kneading trough *4863*.
- **6.** Blessed shall you be when you come in, and blessed when you go forth.
- 7. Shall give Yahweh your hated enemies that rise up against you to be smitten 5062 before you: by one way they will go forth against you, and seven ways they shall flee 5127 before you.
- **8.** Shall command Yahweh upon you the blessing in your storehouses *618*, and in all the works of your hands. Blessed shall be the land that Yahweh Eloheycha gives to you.

- **9.** Shall establish 6965 you Yahweh as a people Holy to Him, as He has sworn 7650 to you, because you shall keep the commandments of Yahweh Eloheycha, and walk 1980 in His ways 1870.
- **10.** And shall see all the peoples of the land that by the Name of Yahweh you are called; and they shall be afraid *3372* of you.
- 11. And shall make abundant 3498 Yahweh prosperity 2896, in the fruit of your womb, in the fruit of your beasts, in the fruit of the ground, on the ground that swore Yahweh to your forefathers to give you.
- **12.** Shall open 6605 Yahweh to you His good 2896 storehouse 214, the sky 8064, to give rain 4306 to the land in its proper time 6256, and to bless all the work of your hands: and you shall lend 3867 to many nations, and you shall not borrow 3867.
- 13. And shall make you Yahweh the head 7218, and not the tail 2180; and you shall be above 4605 only 7535, and you shall not be beneath 4295; because you listen to the commandments of Yahweh Eloheycha that I command you today to keep and do.
- **14.** And you shall not turn aside *5493* from any of the words that I command you today, to the right hand *3225*, or the left *8040*, to walk after other elohiym to serve them.
- **15.** But it shall be, if *518* you will not listen to the voice of Yahweh Eloheycha, to observe and do all the commandments and statutes that I command you today; then shall come upon you all these curses *7045*, and overtake *5381* you:
- **16.** Cursed 779 shall you be in the city, and cursed shall you be in the field.
- **17.** Cursed shall be your basket and kneading trough.
- **18.** Cursed shall be the fruit of your womb, and the fruit of your ground, the increase of



your cattle, and the flocks of your sheep.

- **19.** Cursed shall you be when you come in, and cursed shall you be when you go forth.
- **20.** Shall send Yahweh upon you cursing *3994*, discomfiture *4103*, and rebuke *4045*, in all you put your hand to do, until you are destroyed *8045*, and until you perish *6* quickly *4118*; from the presence of your wicked *7455* deeds *4611* by which you have forsaken *5800* Me.
- **21**. Shall make to cleave *1692* Yahweh to you the pestilence *1698*, until you are consumed *3615* from upon the ground that you went there to possess.
- **22.** Shall smite you Yahweh with a consumption 7829, and with a fever 6920, and with an inflammation 1816, and with a violent fever 2746, and with the sword 2719, and with blight 7711, and with mildew 3420; and they shall pursue 7291, you until you perish 6.
- **23.** And shall become the sky that is over your head as bronze 5178, and the land that is underneath as iron 1270.
- **24.** And shall make Yahweh the rain 4306 of your land powder 80 and dust 6083: from the sky it shall come down upon you, until you are destroyed 8045.
- **25.** Shall give you Yahweh to be smitten *5062* before your hated enemies: one way you shall go forth against them, and seven ways you shall flee *5127* before them, and shall become a terror *2189* to all the kingdoms of the land.

- **26**. And shall be your carcasses *5038* food *3978* for all the birds *5775* of the sky, and the beasts of the land, and none shall terrify *2729* them.
- **27.** Will smite you Yahweh with the boils 7822 of Mits'rayim, and with the hemorrhoids 2914, and with scabs 1618, and with the itch 2775, of which you are not able 3201 to be healed 7495.
- **28.** Will smite you Yahweh with madness 7697, and blindness 5788, and confusion 8541 of mind 3824:
- **29.** and you shall be groping 4959 at noonday 6672, as grope the blind 5787 in darkness 653, and shall not prosper 6743 in your ways: and shall be oppressed 6231 and robbed 1497 all your days, and none 369 shall save 3467 you.
- **30**. A wife you shall betroth 781, and another man shall ravish 7693/7902 her: a house you shall build, and not dwell in it: a vineyard you shall plant 5193, and not eat the grapes of it 2490.
- **31.** Your ox 7794 shall be slaughtered 2873 before your eyes, and you shall not eat of it: your ass 2543 shall be violently taken away 1497 from before you, and shall not be returned to you: your sheep 6629 given to your hated enemies, and none to save them.
- **32.** Your sons and your daughters shall be given to another *312* people, and your eyes shall look, and long *3616* for them all the day: and no might *410* shall be in your hand.
- **33.** The fruit of your ground and all your labors shall be eaten by a people that you do not know; and you shall only 7535 be oppressed 6231 and crushed 7533 all the days,
- **34.** so you will become insane 7696 from the sights 4758 that your eyes shall see.
- **35.** Shall smite you Yahweh in the knees *1290*, and in the legs *7785*, with harmful *7451* boils *7822*, that are not able to be healed, from the sole *3709* of your feet to the top of your head *6936*.
- **36**. Shall bring Yahweh you, and your king that you shall set 6965 over you, to a nation

1471 that you have not known, you, nor your forefathers; and you shall serve 5647 there other 312 elohiym 430, of wood 6086 and stone 68.



- **37.** And you shall become an astonishment 8047, a proverb 4912, and a taunt 8148, among all the peoples where shall lead 5090 you Yahweh there.
- **38.** Much seed shall go forth to your fields, but little 4592 shall you gather 622; for the locust 697 shall consume 2628 it.
- **39.** Vineyards *3754* you shall plant *5193*, and tend *5647* them, but the wine *3196* you shall not drink *8354*, nor gather grapes *103*; because the vine weevils *8438* shall eat them.

Verse **69** is 29:1 in the KJV.
- **69.** And these are the Words of the Covenant, which commanded Yahweh to Mosheh to make with the children of Yis'rael in the land of Moab, besides the Covenant that He made with them in Choreb 2722.

Chapter 8 Why the Old White Empires Fell

The Greeks and The Hebrews (3) By Cyrus Gordon

HAISTOS DISK is inscribed on both faces with a spiral text written in pictographs. The lines separating groups of pictographs presumably mark off individual words. Although not the same as Egyptian hieroglyphs, the symbols appear to have originated in the Nile delta. Several of them can be recognized in simplified form among the symbols of Crete's two scripts: Linear A and Linear B.

We now know enough Minoan to read the Semitic nouns for four different kinds of pots, for "wine" and "wheat," for "town" and "city," for "people," "man" and "mother." We can decipher the verbs "to be," "to give" and "to set up as an offering," the pronouns "he," "his" and "all," the numbers "seven," "nine" and "10," the conjunction "and" and the preposition "to." We can translate synonymous phrases, such as "fellow citizens" and "people of his city," in which all the elements are West Semitic.



The Phaistos Disk - Obverse and Reverse

It has taken eight years to achieve these modest gains. It came as a blow to me to discover recently in the writings of a fourth-century Latin author, L. Septimius that the dissolute Emperor Nero (who ruled from A.D. 54 to 68) recognized ancient texts discovered on Crete during his reign as being Phoenician. In effect, the decipherment of Linear A amounts to the rediscovery of what was still known in Rome during at least the first four centuries of the Christian era. How much time and labour might

have been saved had more credence been given to L. Septimius!

Minoan script employs the principle of acrophony; this means that the phonetic value of each symbol is the opening sound of the word it depicts. How acrophony works can be demonstrated by applying it to some of the pictographs on the Phaistos disk, which is the most noteworthy pictographic text discovered on Crete [see illustrations on this page]. For example, the pictograph of a man on the disk is equated with the Ugaritic word for "man," bwiushu; thus the pictograph stands for the syllable "bu." This is the phonetic value established by Ventris for the Linear B form of the same sign, the pictographic origin of which he did not surmise.

ACROPHONIC PRINCIPLE provides that the phonetic value of a symbol consist of the opening sound of the word depicted by the symbol. In the three cases illustrated the phonetic values for the symbols in linear script were determined independently by the late Michael Ventris. The author has related two of these script symbols to pictographs appearing on the Phaistos disk and has also demonstrated, in all three cases, that commonplace Ugaritic words for the objects portrayed yield the correct acrophonic sounds.


One of the two commonest "words" on the Phaistos disk—it occurs five times —is a pictograph of a horn plus one of a bird. The Semitic word for "horn" is k(a)rn, and in this case we assign the syllable kr (with the vocalic r, as in the English word "butter") to the horn pictograph. The Ugaritic and Syriac word for a bird of prey is kudr, and we assign the syllable ku to the bird pictograph. This is the same value determined by Ventris for the pictograph's Linear B equivalent on the basis of quite different—and purely cryptanalytic—reasons. "Horn" plus "bird" is thus pronounced kr-ku, which probably means "town." (In the Eteocretan texts "town" is spelled kark in unmistakable Greek letters.) A number of additional readings from the disk are possible. My colleagues and I interpret one sequence of nine signs, divided into two word groups, as declaring "I have eaten in the house of Haddu." (Haddu, a variant of Addu, is another name for Baal.) Although we are a long way from achieving a complete and consistent decipherment of

the Phaistos disk, I suggest that it bears a ritual text associated with a shrine to Baal in the palace at Phaistos.

The bird pictograph on the Phaistos disk also appears, in a modified but recognizable form, on a bowl found near Apodulu. Another pictograph on the bowl is evidently an apple—tuppüh in Ugaritic and tuffäh (plural) in Arabic. Ventris established the value tu for the equivalent of this sign in Linear B; perhaps we now know why. 'In learning English the pupil says "a is for apple"; in learning early Minoan he may have said "tu is for tuppüh."

What do these text decipherments and parallels between early Greek and early Hebrew literature suggest? In my opinion the conclusion is inescapable that both the Greek and the Hebrew heritage are rooted in a single cosmopolitan culture that flourished throughout the eastern Mediterranean during the second millennium B.C. with Crete as its major centre. From this viewpoint the still unreconstructed history of the region before, during and somewhat after this era must in general have unfolded along the following lines.

Starting in the fourth millennium B.C., before writing was widespread, Sumerian civilization had already arisen in Mesopotamia and Egyptian civilization in the Nile valley. Both cultures required contact with the outside world. Sumerian life demanded a supply of stone and metal, and the native soil yielded neither.

There we learn that God created the world by the melodious threefold utterance of His Holy Name—and that the form or figure of that Name was /1\, being the rays of the rising sun at the equinoxes and the solstices converging into a focus—"the eye of light." These rays, we are informed, according to the influence which the sun has upon the earth at the different seasons which they represent, show God in His various characters as a Creator, a Preserver, and a Destroyer.

The Divine Name may not be uttered (*Ed. This* is what the Edomites pretending to be "God's Chosen" say! True Hebrews know, the Scriptures tell them to call on His Name.), because no mortal man can individually articulate the harmony of the sound; re-echoed, indeed, by the universe in concert at its primeval birth, "when the morning stars sang together, and all the sons of God shouted for joy," (Job xxxviii. 7.) but not to be heard again until the renovation of all things at the last day.

Again; the bardic or is a combination of V or /I\ and \I/ or V, and primarily denotes the same idea as "Alpha and Omega, the beginning, and the ending," (Rev. i. 8.) which is one of the titles of our Saviour. It is remarkable that there is a natural tendency in the Cymric tongue to pronounce the separate letters AW like O at the end of words; as gwrandaw, gwrando; taraw, taro, &c.

According to "Cyfrinach y Beirdd," there were only three languages of Divine origin. The first was that of Adam in Paradise, which, however, he lost on his expulsion;—this is the language of heaven. The second language was that which Moses acquired, and which was used by the prophets for 3000 years subsequently, and is still the language of Holy Scripture. The third is the Cymraeg, which was obtained by Enos, the first man after the banishment of Adam from Eden, who praised God and goodness in a vocal song. It was carried over the Deluge by Japheth, and his posterity conveyed it to the extremity of the earth, and it is spoken at this day in its perfect kind and character by us the Cymry in the Isle of Britain, (pp. 28, 29.)

In accordance with this view of the subject our British forefathers bestowed great pains upon the cultivation of the language. And as it was considered to be peculiarly the language of song, the production of the sacred A, which was formed by the musical utterance of the Divine Name, "when the morning stars sang together," the improvements, which have been from time to time introduced into its structure, have always more or less been of a prosodial character.

We have briefly marked its progress and gradual development from the earliest period to the era of Edeyrn Davod Aur in the notes which we have incorporated with that portion of the Grammar entitled— "The origin and progress of letters."

The grammar which formed the basis of "Dosparth Edeyrn Davod Aur," is said to have been compiled by Geraint Vardd Glas, in the tenth century. This was preserved among the MSS. in Raglan Castle, before it was destroyed in the wars of the Commonwealth, but no copy is now to be found. This is the Book, no doubt, referred to in the following extract which occurs at p. 623 of the Iolo MSS.

"The oldest system on record of memorials and recollections, is that of Geraint Yardd Glas, upon the poetic metres; and of all that is extant from before his time, there is nothing remaining excepting what may be discerned by the learned by means of books.

This Geraint was brother to Morgan Hen, king of Glamorgan, and he collected ancient records of poetry and bardism, and arranged them in a book of his own composition, and established them by the laws of the chair and the gorsedd, in every country and dominion in Wales; and Geraint excelled in knowledge and judgment, and every chair in Wales and England was given him; from which he was called the Bardd Glas of the Chair—He who understands will see, that it was from the system of Geraint Yardd Glas that the one of Brittany was taken, and also a great portion of that of Gruffydd the son of Cynan was taken, called the system of Glen Achled, and that of Aberfraw, under emendation, amplification, extension, and adornment: and therefore Lewys Morganwg, in his book upon poetry, called the system of Geraint the old original system; and he says that the system of the Round Table is the one of Brittany, called also that of Caermarthen, as it existed under King Arthur in Caerlleon upon

What were the particular changes or additions which were introduced by Einion Offeiriad, are not known, nor may they be ascertained from Dosparth Edeyrn; for from certain extracts, which are preserved in Dr. John David Rhys's Grammar relative to the article, we clearly learn that his views and those of Edeyrn are not altogether identical, or at least are not couched in the same language.

It must be remarked, however, that the paragraph, which is there attributed to Edeyrn, does not occur in the copy which forms the text of the present volume. Einion is said to have flourished in the middle of the twelfth century.

Edeyrn compiled his grammar about a.d. 1270. It appears to have been much valued by the literati of Wales, even to a comparatively late period of our history. Thus, Sion Brwynog, addressing Elissau ab William Llwyd of Rhiwaedog, AD 1500, compliments him upon the fact that his father was conversant with the system and grammar of Edeyrn Davod Aur.

The Political Influence of the British-Israel **Movement in the Nineteenth Century (Part 6) Richard Simpson**



HE **GATES** WERE VERY **IMPORTANT** TO **BRITISH-ISRAEL** and Constantinople was the most important gate. Possession of the gates Philo-Judaism was a strong element of meant power to the British Empire. In 1919, British-Israelite Admiral Lord Fisher said 'Do you know that there are five keys to the world the Straits of Dover, the Straits of Gibraltar (Above), the Suez Canal, the Straits of Malacca, and the Cape of Good Hope? And every one of these keys we hold '.145

The Channel Islands kept a check on the French. Gibraltar seized from the Spanish in 1704 guarded the entrance to the Mediterranean. Malta captured from Napoleon in 1800 stood halfway between Gibraltar and Port Said. The gates to the Red Sea - Aden and Perim - were acquired in 1856 and 1839 respectively. Cyprus was rented from the Turkish and was the Gate to Suez, Port Said and Palestine.

Possession of the gate of Constantinople would prevent the Russian Black Sea fleet entering the Mediterranean. 'Ask of Me, and I shall give thee the heathen for thine inheritance, and the uttermost parts of the earth for thy possession' (Psalm ii.8). Hence, in 1839, Britain extended diplomatic protection to all 10,000 Jews living in the Turkish province of Syria.

On the Jewish side, Sir Moses Montefiore was also taking a great interest in Palestine. 146 Montefiore believed that Palestine was underexploited making it a rich opportunity for a Jewish homeland. He agreed with the new

British Consul William Young to introduce gradual assistance to the Jews so as not to arouse the suspicion of the Turks and Egyptians.

He received the backing of the British government but was only able to obtain vague promises from Mehmet Ali. Unfortunately, in 1839, war broke out between the Egyptians and Turks with the French backed Turks capturing Beirut. 147 Lord Shaftesbury had put events in motion with the establishment of a British Consulate in Jerusalem, in 1838, reflecting the concern of restorationists with development of their doctrine and its application to political realities. 148

Evangelicalism with its desire to assist Jewish return to Palestine, convert them to Christianity and bring about the second coming of Christ following the conversion of Jews to Christianity. Coincidently, Shaftsbury's mother-in-law was the wife of Lord Palmerston and on assuming the Premiership, Palmerston asked Shaftesbury to select appropriate clerics for Bishoprics.

This was the perfect opportunity for Shaftesbury to establish his Evangelical master plan and duly recorded in his 1838 diaries that he had persuaded Palmerston to appoint Britain's first diplomat to Palestine. 149 Shaftesbury reasoned that if Britain established herself in Palestine, as the Jew's political and military protector, immigration would begin eventually spawning the Second Coming but first he had to sell his plan politically to Palmerston.

An alliance of Britain, Russia, Prussia and Austria demanded the withdrawal of Mehmet Ali from Syria or they would back the Turks. The French king sacked Thiers and Egypt withdrew. In return for Britain's assistance in retaining Syria, the Turkish government lifted its restriction on Jewish immigration to Palestine. Unfortunately Palmerston fell at the 1841 General Election and it appeared that Shaftsbury's plans were stalled. However, his successor Peel agreed to a new Anglican Episcopal seat in Jerusalem.




The first Anglican Bishop of Jerusalem was Michael Solomon Alexander (left), a converted Jew but unfortunately, in 1842, Peel forbade British Consul Young from assisting Bishop Alexander with any

of his Jewish schemes and significantly, for the Evangelical Shaftesbury, British Diplomatic protection would only be extended to Jews but excluded those that converted to Christianity. 151

Contemporaneously, the removal of the French threat led to a lapse in the Turkish immigration policy and the expected mass emigration did not take place except for a few people to the Montefiore colonies and mass emigration, when it did take place was directed toward Europe and America.

Disraeli's acquisition of the Suez Canal and Cyprus between 1874-78 made physical conquest of Palestine inevitable. British-Israel applauded the government's bold stroke in acquiring half the shares in the Suez canal proclaiming it as the beginning of the restoration movement and an Act of God. 152 The Suez

Canal shortened the sea trip to India by 5000 miles and part fulfilled biblical prophecy 'in the same day the Lord made a Covenant with Abraham, saying, Unto thy seed have I given this Land, from the River of Egypt into the great river, the river Euphrates'.



Disraeli (left) was also worshipped by British-Israel as a God in that his surname 'Of Israel' was seen fulfilment of 'One shall say, I [am] the LORD'S: and another shall call [himself] by the name of Jacob: and another subscribe [with] his

hand unto the LORD, and surname [himself] by the name of Israel'.153 In 1875, Lionel de Rothschild supplied Disraeli with the £4 million to purchase the Khedive of Egypt's controlling shares in the Suez Canal Company. 154

However, there was one problem here in that Biblical prophecy maintained of Ephraim 'He shall not return to Egypt.'; a fact I only found one reference to in British-Israel literature .155 Hine remarked on the coincidence that at a time, national identity with Israel, Benjamin Disraeli was selected as Prime Minister and 'I have faith to look upon this man as one specially raised by God as a deliverer for our nation' and 'under the auspices of a Premier, of Jewish or Israelitish origin, and raised, we cannot but believe, to his high and influential position by Divine Providence to exert a prominent influence on the coming events.' 156 &157

His prophetic feelings were backed up by staff writer Harrison Oxley in 'We identify Benjamin Disraeli, Esq., as one called in a most distinguished manner to lead the Nation to glory, and by the Identity, we see clearly how Judah and Israel became united, how Palestine comes into the possession of the British Nation.' 158

However, Disraeli did not seem to agree with this and embarrassingly declared the American nation 'to be more like that of ancient Israel under the judges than any other of history.' In 1875, in preparation for the formation of a Palestine Colonization Fund, members of the Alliance. This sub-organisation drew up plans society met the Turkish Ambassador. The gravitas of this fund was reflected in the delegation that approached the Turkish Ambassador, at it's inception.

The more prominent members included Colonel Gawler, Jacob Montefiore, Bishop Titcomb, Lord Shaftsbury, The Lord Mayor of London and two MPs A. Kinnaird & F. Walpole. 159 One offshoot of The Anglo-Israel Association was The International Universal Alliance whose purpose was 'to secure the neutralisation of Palestine under the guarantee of the great Powers, with the view of assuring the security of Christian and Israelitish populations'. 160

This was a significant link with the Jewish community in that a prominent member was Sir Moses Montefiore, occasional president of the Board of Deputies, who initiated the subordinate Palestine Committee of the Universal

emigration schemes promoting the colonization of Palestine, Syria and neighbouring countries and with the support of the German Colony of the Society of the Temple channelled funds through a Palestine Colonization Fund to a society established at Premisle, Galicia.161

Although not a member of British-Israel, to their regret, in his obituary it was said 'He was a Prince of the House of Judah, but he belonged properly to the House of Israel'. 162 In the 1870's, Rishon le Zion and other colonies were set up near Lake Tiberias at the initiative of the French branch of the Rothschilds. 163 In 1875, Sir Moses Montefiore travelled to Palestine to arrange for additional purchases of land after Palestine Exploration Fund maps showed large areas of economically unexploited fertile land. 164

Pastor Sheldon Emry on Vaccines

Sir The following is a statement on the teachings of Lord's Covenant Church, America's Promise Ministries in relation to immunizations, inoculations, vaccines, and related so-called cures, preventatives, or medicines given by injection into the body.

We believe Christians are not to demand or accept any such injections for the following reasons as gleaned from God's Holy Bible. The church is to be holy. Ephesians 5:27, That he might present it to Himself a glorious church, not having spot, or wrinkle, or any such thing;

but that it should be holy and without blemish. Individuals are to be holy. Romans 12:1, I beseech you therefore, brethren, by the mercies of God, that ye present your bodies a living sacrifice, holy, acceptable unto God, which is your reasonable service.

Also, 1 Peter 1:15-16, But as He which hath called you is holy, so be ye holy in all manner of conversation [life]; because it is written, Be ye holy; for I am holy. Holy means not only to be in service to God, but to be "clean". We have a saying, "Cleanliness is next to godliness." That this is true is verified in the Old Testament passage Peter was referring to in his quote in the preceding paragraph. It was from Leviticus 11:44-45:

For I am the Lord your God: ye shall therefore sanctify yourselves, and ye shall be holy; for I am holy: neither shall ye defile yourselves with any manner of creeping thing that creepeth upon the earthy. For I am the Lord that bringeth you up out of the land of Egypt, to be your God: ye shall therefore be holy, for I am holy.

These verses are at the end of the list of clean and unclean beasts in the chapter which

God's people are commanded NOT to eat the unclean. The implication here is obvious --- that if they were to eat that which is unclean, they would not be holy.

The same doctrine in Deuteronomy 14. It begins, Ye are the children of the LORD your God; ye shall not cut yourselves, nor make any baldness between your eyes for the dead [these were common heathen religious practices in that day], for thou art an holy people unto the LORD thy God, and the LORD hath chosen thee to be a peculiar people unto Himself, above all the nations (people) that are upon the earth.



Thou shalt not eat any abominable thing, [and then follows the command NOT to eat things God calls unclean. Also in verse 21, we read, Ye shall not eat anything that dieth of itself ... for thou art an holy people unto the LORD thy God.... There are two other things in that passage quoted above that are further reasons for refusing vaccines.

Firstly, we are not to cut ourselves. Inoculations, vaccinations, etc., include puncture or cutting of the body. (See Leviticus 19:28 and 21:5). Secondly, we are not to eat, i.e., partake of, anything that dieth of itself. Vaccines are often made, or in, bodies; foetuses, or, the eggs of creatures that are unclean according to the plain Word of God. Moreover, the process of producing the so-called "vaccine" often causes the body, foetus, or egg to die in the process. Therefore, it is further forbidden us.

We are also commanded not to eat the blood of animals. But flesh with the life thereof, which is the blood thereof, shall ye not eat. Genesis 9:4. This was made a statute at Mt. A Doctor's Letter to Her MP Regarding Compulsory Vaccination



Sir__, I came across a copy of a letter from a Doctor to her local MP appertaining to the government's plans for compulsory vaccination recently hinted at by Matt Hancock recently. I see this as another attack by the enemy on true Israel! Letter below.

Dear Sir Graham,

I refer to my earlier correspondence dated March 2nd and April 26th regarding the concerns I have about the COVID-19 vaccination program.

I am grateful to you for raising these concerns with the Minister for covid-19 Vaccine Deployment. Sadly Mr Zahawi seems to be either unwilling or unable to respond to my questions. Perhaps he is just delaying until the vaccine rollout has reached the whole adult population as it is due to imminently.

Mr Zahawi said in his letter to you that "the UK currently operates a system of informed consent for vaccinations". Clearly the current proposals to make vaccinations compulsory for care home workers and possibly frontline NHS workers is completely counter to this. If a medical intervention is mandated for one group in society why not others? What about visitors to care

homes? Delivery drivers? Shop workers? The list will go on and on.

I would like to draw your attention again to Article 6 of the Universal Declaration on Bioethics and Human Rights. It states that "any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information.

The consent should, where appropriate, be express and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice". If an individual is being coerced into undergoing vaccination, through fear of losing their livelihood, then they are not giving "free and informed consent".

In effect, the person administering the vaccine in such circumstances is committing the criminal offence of Assault and Battery. We know that the pharmaceutical companies have been granted legal indemnity by the Government but what indemnity does the vaccinator have in this situation?

In my opinion to ask anyone to undergo a medical intervention for the benefit of others is profoundly unethical. Population immunity, achieved through high vaccine take-up, is a by-product rather than the primary reason for immunising an individual.

This ethical problem is particularly pertinent to the arguments given for rolling the program out to children, but is also relevant to the majority of healthy working-age adults. The mortality risk from covid-19 in this cohort is lower than that for seasonal influenza.

People are being persuaded to have these vaccines to protect society at large. Why is nobody in Government paying attention to the significant morbidity and mortality being reported on the Yellow Card system in relation to the administration of the vaccines?

Young healthy people are being exposed to risks, both known and unknown, in taking these vaccines yet have little to gain in terms of personal benefit. Dr Tess Lawrie wrote an open letter to MHRA Chief Executive Dr June Raine saying that "the MHRA now has more than

enough evidence on the Yellow Card system to declare the covid-19 vaccines unsafe for use in humans". At the very least we should be pausing to review the data before coercing young care home workers into having this vaccine when the results of the phase 3 trials are not yet known or understood.



In my discussions with patients who have undergone vaccination I have come to realise that many are unaware that these vaccines do not yet have full marketing authorisation. Sadly, the vaccine trials have now been compromised by being un-blinded and control arm participants being offered the active drug.

Given that these vaccines are still in their experimental phase, surely point 1 of the Nuremberg code applies: the voluntary consent of the human subject is absolutely essential. How is this in any way compatible with mandatory vaccination?

According to Dominic Cummings, the Prime Minister referred to Matt Hancock as "f***ing hopeless". Having heard the Health Secretary say that there is a "material difference" in the duty of care owed by the state to those who have not yet been offered the vaccine compared to those that have not taken up the offer of vaccination, I would go as far as to say he is dangerous and a menace.

He is not fit for public office and needs to be removed from his post before he inflicts further harm on the people of this country. The GMC's Good Medical Practice guidance states that Doctors must "treat patients and colleagues fairly and without discrimination".

I do not think there is an exception to this based on vaccination status. Similarly the NHS constitution says that "the NHS provides a comprehensive service, available to all" and that staff has a "duty not to discriminate against patients or staff and to adhere to...human rights legislation". With regard to patients it says "you have the right to accept or refuse treatment that is offered to you, and not to be given any...treatment unless you have given valid consent". Perhaps the Health Secretary ought to familiarise himself with these documents.

Having read my comments you will not be surprised to learn that I still do not intend to take this vaccine currently. I refuse to be bullied into undergoing a medical intervention against my will. It is against everything I would advocate for my patients. With record waiting lists in the NHS it would seem to me to be unwise to risk losing a proportion of the workforce by forging ahead with plans for making Covid-19 vaccination compulsory. Your CEO has passed my notice to the legal department who in turn has passed the arrangement


of the so called court to you. I believe that this is because the CEO and Marie Barnes do not want to admit that the council is holding a kangaroo court.

Churchyard of St Brynachs at Nevern 'Bleeding' Yew trees



Influenza Is an Electrical Disease



UDDENLY AND INEXPLICABLY, influenza, whose descriptions had remained consistent for thousands of years, changed its character in 1889. Flu had last seized most of England in November 1847, over half a century earlier. The last flu epidemic in the United States had raged in the winter of 1874–1875.

Since ancient times, influenza had been known as a capricious, unpredictable disease, a wild animal that came from nowhere, terrorized whole populations at once without warning and without a schedule, and disappeared as suddenly and mysteriously as it had arrived, not to be seen again for years or decades.

It behaved unlike any other illness, was thought not to be contagious, and received its name because its comings and goings were said to be governed by the "influence" of the stars.

But in 1889 influenza was tamed. From that year forward it would be present always, in every part of the world. It would vanish mysteriously as before, but it could be counted on to return, at more or less the same time, the following year. And it has never been absent since.

Like "anxiety disorder," influenza is so common and so seemingly familiar that a thorough review of its history is necessary to unmask this stranger and convey the enormity of the public health disaster that occurred one hundred and thirty years ago. It's not that we don't know enough about the influenza virus.

We know more than enough. The microscopic virus associated with this disease has been so

exhaustively studied that scientists know more about its tiny life cycle than about any other single microorganism. But this has been a reason to ignore many unusual facts about this disease, including the fact that it is not contagious.

In 2001, Canadian astronomer Ken Tapping, together with two British Columbia physicians, were the latest scientists to confirm, yet again, that for at least the last three centuries influenza pandemics have been most likely to occur during peaks of solar magnetic activity—that is, at the height of each eleven year sun cycle. Such a trend is not the only aspect of this disease that has long puzzled virologists.

In 1992, one of the world's authorities on the epidemiology of influenza, R. Edgar Hope-Simpson, published a book in which he reviewed the essential known facts and pointed out that they did not support a mode of transmission by direct human-to-human contact.

Hope-Simpson had been perplexed by influenza for a long time, in fact ever since he had treated its victims as a young general practitioner in Dorset, England, during the 1932–1933 epidemic—the very epidemic during which the virus that is associated with the disease in humans was first isolated. But during his 71-year career Hope Simpson's questions were never answered. "The sudden explosion of information about the nature of the virus and its antigenic reactions in the human host," he wrote in 1992, had only "added to the features calling for explanation."


Why is influenza seasonal? he still wondered. Why is influenza almost completely absent except during the few weeks or months of an epidemic? Why do flu epidemics end? Why don't out-of-season epidemics spread? How do epidemics explode over whole countries at once, and disappear just as miraculously, as if suddenly prohibited?

He could not figure out how a virus could possibly behave like this. Why does flu so often target young adults and spare infants and the elderly? How is it possible that flu epidemics travelled at the same blinding speed in past centuries as they do today? How does the virus accomplish its so-called "vanishing trick"? This refers to the fact that when a new strain of the virus appears, the old strain, between one season and the next, has vanished completely, all over the world at once. Hope-Simpson listed twenty-one separate facts about influenza that puzzled him and that seemed to defy explanation if one assumed that it was spread by direct contact.

He finally revived a theory that was first put forward by Richard Shope, the researcher who isolated the first flu virus in pigs in 1931, and who also did not believe that the explosive nature of many outbreaks could be explained by direct Contagion.

Shope, and later Hope-Simpson, proposed that the flu is not in fact spread from person to person, or pig to pig, in the normal way, but that it instead remains latent in human or swine carriers, who are scattered in large numbers throughout their communities until the virus is reactivated by an environmental trigger of some sort.

Hope-Simpson further proposed that the trigger is connected to seasonal variations in solar radiation, and that it may be electromagnetic in nature, as a good many of his predecessors during the previous two centuries had suggested.



When Hope-Simpson was young and beginning his practice in Dorset, a Danish physician named Johannes Mygge, at the end of a long and distinguished career, had just published a monograph in which he too showed that influenza pandemics tended to occur during years of maximum solar activity, and further that the yearly number of cases of flu in Denmark rose and fell with the number of sunspots.

In an era in which epidemiology was becoming nothing more than a search for microbes, Mygge admitted, and knew already from hard experience, that "he who dances out of line risks having his feet stomped on."4

But he was certain that influenza had something to do with electricity, and he had come to this conviction in the same way I did: from personal experience.

In 1904 and 1905, Mygge had kept a careful diary of his health for nine months, and he later compared it to records of the electrical potential of the atmosphere, which he had recorded three times a day for ten years as part of another project.

It turned out that his incapacitating migraine-like headaches, which he had always known were connected to changes in the weather, almost always fell on the day of, or one day before, a sudden severe rise or drop in the value of the atmospheric voltage.

But headaches were not the only effects. On the days of such electrical turmoil, almost without exception, his sleep was broken and unrestful and he was bothered with dizziness, irritable mood, a feeling of confusion, buzzing sensations in his head, pressure in his chest, and an irregular heartbeat, and sometimes, he wrote, "my condition had the character of a threatening influenza attack, which in every case was not essentially different from the onset of an actual attack of that illness."5

Others who have connected influenza with sunspots or atmospheric electricity include John Yeung (2006), Fred Hoyle (1990), J. H. Douglas Webster (1940), Aleksandr Chizhevskiy (1936), C. Conyers Morrell (1936), W. M. Hewetson (1936), Sir William Hamer (1936), Gunnar Edström (1935), Clifford Gill (1928), C. M. Richter (1921), Willy Hellpach (1911), Weir Mitchell (1893), Charles Dana (1890), Louise Fiske Bryson (1890), Ludwig Buzorini (1841), Johann Schönlein (1841), and Noah Webster (1799).

In 1836, Heinrich Schweich observed that all physiological processes produce electricity, and proposed that an electrical disturbance of the atmosphere may prevent the body from discharging it. He repeated the then-common

belief that the accumulation of electricity within the body causes the symptoms of influenza.

No one has yet disproved this. It is of interest that between 1645 and 1715, a period astronomers call the Maunder Minimum, when the sun was so quiet that virtually no sunspots were to be seen and no auroras graced polar nights—during which, according to native Canadian tradition, "the people were deserted by the lights from the sky,"6—there were also no worldwide pandemics of flu.

In 1715, sunspots reappeared suddenly after a lifetime's absence. In 1716, the famous English astronomer Sir Edmund Halley, at sixty years of age, published a dramatic description of the northern lights. It was the first time he had ever seen them. But the sun was still not fully active. As though it had woken up after a long sleep, it stretched its legs, yawned, and lay down again after displaying only half the number of sunspots that it shows us today at the peak of each eleven-year solar cycle.

It wasn't until 1727 that the sunspot number surpassed 100 for the first time in over a century. And in 1728 influenza arrived in waves over the surface of the earth, the first flu pandemic in almost a hundred and fifty years. More universal and enduring than any in previously recorded history, that epidemic appeared on every continent, became more violent in 1732, and by some reports lasted until 1738, the peak of the next solar cycle. 7 John Huxham, who practiced medicine in Plymouth, England, wrote in 1733 that "scarce any one had escaped it."

He added that there was "a madness among dogs; the horses were seized with the catarrh before mankind; and a gentleman averred to me, that some birds, particularly the sparrows, left the place where he was during the sickness."8

An observer in Edinburgh reported that some people had fevers for sixty continuous days, and that others, not sick, "died suddenly." 9 By one estimate, some two million people worldwide perished in that pandemic. 10

If influenza is primarily an electrical disease, a response to an electrical disturbance of the atmosphere, then it is not contagious in the ordinary sense. The patterns of its epidemics should prove this, and they do.

For example, the deadly 1889 pandemic began in a number of widely scattered parts of the world. Severe outbreaks were reported in May of that year simultaneously in Bukhara, Uzbekistan; Greenland; and northern Alberta. 11 Flu was reported in July in Philadelphia 12 and in Hillston, a remote town in Australia,13 and in August in the Balkans. 14

This pattern being at odds with prevailing theories, many historians have pretended that the 1889 pandemic didn't "really" start until it had seized the western steppes of Siberia at the end of September and that it then spread in an orderly fashion from there outward throughout the rest of the world, person to person by contagion. But the trouble is that the disease still would have had to travel faster than the trains and ships of the time.



It reached Moscow and St. Petersburg during the third or fourth week of October, but by then, influenza had already been reported Durban, South Africa 15 and Edinburgh, Scotland. 16 New Brunswick, Canada, 17 Cairo, 18 Paris, 19 Berlin, 20 and Jamaica were reporting 21

epidemics in November; London, Ontario on December 4;22 Stockholm on December 9;23 New York on December 11;24 Rome on December 12;25 Madrid on December 13;26 and Belgrade on December 15.27 Influenza struck explosively and unpredictably, over and over in waves until early 1894.

It was as if something fundamental had changed in the atmosphere, as if brush fires were being ignited by some unknown vandal randomly, everywhere in the world.


One observer in East Central Africa, which was struck in September 1890, asserted that influenza had never before appeared in that part of Africa at all, notwithin the memory of the oldest living inhabitants. 28

"Influenza," said Dr. Benjamin Lee of the Pennsylvania State Board of Health, "spreads like a flood, inundating whole sections in an hour... It is scarcely conceivable that a disease which spreads with such astonishing rapidity, goes through the process of re-development in each person infected, and is only communicated from person to person or by infected articles."29 Influenza works its caprice not only on land, but at sea.

With today's speed of travel this is no longer obvious, but in previous centuries, when sailors were attacked with influenza weeks, or even months, out of their last port of call, it was something to remember.

In 1894, Charles Creighton described fifteen separate historical instances where entire ships or even many ships in a naval fleet were seized by the illness far from landfall, as if they had sailed into an influenzal fog, only to discover, in some cases, upon arriving at their next port that influenza had broken out on land at the same time.

Creighton added one report from the contemporary pandemic: the merchant ship "Wellington" had sailed with its small crew from London on December 19, 1891, bound for Lyttelton, New Zealand. On the 26th of March, after over three months at sea, the captain was suddenly shaken by intense febrile illness. Upon arriving at Lyttelton on April 2, "the pilot, coming on board found the captain ill in his berth, and on being told the symptoms at once said, 'It is the influenza: I have just had it myself." 30



An 1857 report was so compelling that William Beveridge (left) included it in his 1975 textbook on influenza: "The English warship Arachne was cruising off the coast of Cuba 'without any contact with land.' No less than 114 men out of a crew of 149 fell ill with influenza and only later was it learnt that there

had been outbreaks in Cuba at the same time."31

The speed at which influenza travels, and its random and simultaneous pattern of spread, has perplexed scientists for centuries, and has been the most compelling reason for some to continue to suspect atmospheric electricity as the cause, despite the known presence of an extensively studied virus.

Here is a sampling of opinion, old and modern: Perhaps no disease has ever been observed to affect so many people in so short a time, as the Influenza, almost a whole city, town, or neighbourhood becoming affected in a few days, indeed much sooner than could be supposed to spread from contagion.

Mercatus relates, that when it prevailed in Spain, in 1557, the greatest part of the people were seized in one day.

Dr. Glass says, when it was rife in Exeter, in 1729, two thousand were attacked in one night. Shadrach Ricketson, M.D. (1808), *A Brief History of the Influenza* 32

The simple fact is to be recollected that this epidemic affects a whole region in the space of a week; nay, a whole continent as large as North America, together with all the West Indies, in the course of a few weeks, where the inhabitants over such vast extent of country, could not, within so short a lapse of a time, have had the least communication or intercourse whatever. This fact alone is sufficient to put all idea of its being propagated by contagion from one individual to another out of the question.

Unlike cholera, it outstrips in its course the speed of human intercourse.



Contagion alone is inadequate to explain the sudden outbreak of the disease in widely distant countries at the same time, and the curious way in which it has been known to attack the crews of ships at sea, where communication with infected places or persons was out of the question.

The Sussex Zodiac By Mike Collier



The terrestrial zodiac is one of the places where earth mysteries and strange phenomena meet and wink at each other. Those whose personalities are dominated by cynicism will sneer at the concept/phenomena out of hand. But such unconsidered criticism should be ignored. Reality is relative and so strange in places that to dismiss things without consideration is to live in ignorance and illusion. The earth mysteries strange phenomena - paranormal fields lie at the edge of reality. Those who familiarise themselves with their contents may well gain a better grasp on reality, in total.

Ed. The Zodiac and its signs is Scriptural, His story written in the sky and reflected on earth.

Mr. Collier has spent several years researching this zodiac on the map and in the field with the dowsing rods. His research so far is not definitive but is probably the beginning of a life time's work. It is published here for the first time.

The Zodiac

"The secret source of Avalon's mystique, the bubbling fount of all its legends, the magnet that drew so many saints, kings and pilgrims, is all the more mysterious for being invisible". This is the Glastonbury Zodiac, claimed by it's discoverer, Katherine Maltwood, as at once the oldest and biggest of Britain's antiquities. This great goemantic circle of giant effigies, ten miles across and thirty miles round, has so far been

totally ignored by cautious Establishment archaeologists. It is Too Big to be Seen, Too Good to be True:

Modelled in relief by hills and lesser contours, outlined in part by streams which follow these round, the effigies are essentially natural - yet the outlines have been completed by man through the ages, by roads, paths and canals and embellished by tumuli, ramparts and lynchets at the nodal points. Preposterous! Maybe, but there on the map are the twelve signs of the zodiac in correct order in a circle....

I can think of no better introduction to a piece on these rather elusive signs than the above, written by Mary Caine in "The Glastonbury Giants or Zodiac" (An Arthurian Reflection) -((Glastonbury - edited by Anthony Roberts)).

When Mrs Maltwood discovered it half a century ago, she equated the figures with the Arthurian legends and suggested that the circle was the original Round Table. Since then other zodiacs have been found, at Pumpsaint in Wales, Nuthampstead in Hertfordshire and Kingston in Surrey. There is literature available on these by Lewis Edwards, Nigel Peninck and Mary Caine respectively. There are also others that have been written about, albeit some of them rather tentatively.

It appears that we have one in Sussex, overflowing into Kent and not far from the Surrey border; roughly twice the size of the Glastonbury circle.

It is twenty miles across and virtually on the same latitude, centred around the village of Stonegate. (A pin was put into the map at Stonegate and another at Glastonbury and a line between them actually went through Stonehenge.


However, do not regard this as too accurate, it is merely a point of interest). The zodiac stretches from Danehill in the west to Bodiam in the east and from Hellingly in the south to Tunbridge Wells in the north.

It should be noted that there are some very significant place names, a real phenomenon that


does occur in this and associated 'earth mysteries', for want of a better phrase.




AQUARIUS: As at Glastonbury, the phoenix. Flightshott farm nearby.




PISCES: A whale with the lovely Bayham Abbey at its mouth and Jews Wood in its belly. There is another fish attached.




TAURUS: At Mayfield an outline of just head and hoof. This is common amongst some zodiacs instead of the whole animal.




CANCER: Here is a superb outline of a crab; this is very significant as so far not one has emerged on any other zodiac.




CAPRICORN: The figure associated with Pan and the earthy side of Nature is the goat-unicorn and has a satyr-like look and position with a virile appearance. Nearby is Mount Easy. This extraordinary figure has a shortage of churches and contains an H. M. Detention Centre and the incredibly named Worms Hill, Folly Hill and Nevergood.



SAGITTARIUS: The front of the figure is incomplete owing to lack of research; after all, someone once said that a zodiac contained a lifetime's work. It appears to be a Centaur, or mounted Archer, firing an arrow. Right on the head is the name The Horns which may put this in the sphere of Cernunnos but in Glastonbury it is the Arthur Figure. If the arrow is fired it hits a chapel where the map says Great Butts. Surely like Ramslye and Lions Green these place names must be beyond coincidence.




GEMINI: A giant sitting in a boat. The boat in these cases is usually named the Argo Navis, certainly there is Argos Hill nearby. In the body of the boat is Skippers (of the boat) Hill, Sleeves Wood on the arm and the aptly named Cross-in-Hand where the hand is holding a cross of some description.




SCORPIO: An outline of the Scorpion; a water sign with the watery Bodiam Castle adjacent. As befits the death sign, it is near to the site of the Battle of Hastings.



Lions Green Where there used to be Stone Lions




LEO: Lion's Green is in this figure with two stone lions outside a large house and lion named houses nearby. In spite of this it really looks like a hound rather than a lion; in a Babylonian zodiac this would have been so. It is worth remarking here that some of the Leo signs in the other zodiacs do not look very leonine either.




ARIES: A sitting ram with the head looking southwards towards the sea. It's tail is formed by

an ancient site at Ramslye where there is the rocky formation High Rocks, well worth a visit. The horns are marked by circular paths in a wood called, of all things, Hornshurst Wood.



LIBRA: Usually represented by a dove in the middle of the circle instead of the scales but here appears to be absent. This sign was, after all, a late arrival, in Caesar's time by the Romans, and grew from one of the claws of the Scorpio. Perhaps the crow below Scorpio is something to do with this.



VIRGO: The same as in most other zodiacs, the goddess is holding a sheaf. She has been associated with a hare and here, nearby, is Harebeating. The lower part of her outline appears to be near the top of a crow's head between her and Scorpio, note the nearby town of Crowhurst. There is a precedent for this as there is a crow in the Hebden Bridge Zodiac. What is the significance of the name on her sheaf, Three Cups Corner?


Dr. Anthony Fauci – Facing early retirement at 80 years of age, due to his crimes against humanity, Who writes this stuff? And how do some people who are






