Gulf War Illness By Willie Martin

VERY MONDAY NIGHT MICHAEL ELLIS AND ALFRED ADASK CO-HOST A DALLAS RADIO TALK show called the "Christian-Patriot-Connection" (8-10 p.m., KPBC-770 a.m.). The following is an edited transcript of their interview with Doctors Garth and Nancy Nicholson (husband and wife) on May 15, 1995.

To save space, questions posed by Michael or Alfred are simply identified as "CPC" (Christian-Patriot-Connection), and the responses of both Doctors are generally identified as "Dr." Further, the italicized text is their emphasis and the [bracketed comments] are the hosts insertions. Also, note that this is not a "professional" transcript; it's based on an audio tape and therefore its technical terms and personal names are only phonetically approximated and can be assumed to be misspelled. Nevertheless, you will soon get the idea.

The Nicholsons' credentials are impressive and lend weight to their allegations: Dr. Nancy Nicholson: Undergraduate degree from Johns Hopkins University; Ph.D. in Molecular Biophysics from Florida State University; post-doctoral training at M.D. Anderson Cancer Center at Houston; Baylor University faculty in the Pharmacology, Microbiology, and Immunology Departments; President of the Rhoden Foundation for Medical Rhoden Foundation for Medical Research.

Dr. Garth Nicholson: Professor of Laboratory Medicine and Pathology, Professor of Internal Medicine, and Chairman of the Department of Tumor Biology at the University of Texas, M.D. Anderson Cancer Center at Houston; 25 years experience; published over 400 papers and scientific and medical journals; member of the editorial boards of 13 scientific and medical journals; nominated for the Nobel Prize. CPC: Last Winter, I was channel surfing at two in the morning, and caught a Houston press conference where a lady in a laboratory smock explained

that "mycoplasmas" are natural components found in all living cells. She continued that she and her husband were doctors who had discovered that the cause of the "Gulf War Illness" was a man-made, artificial mycoplasma that had somehow been implanted in the cells of Desert Storm veterans. The next day, I expected to read explosive "Germ warfare!" newspaper headlines. Instead, I heard nothing more about these "artificial mycoplasmas." The story stuck in my mind for several months, but I heard no more until a friend recently introduced me to tonight's guests: Dr. Nancy Nicholson (the lady in the press conference) and her husband, Dr. Garth Nicholson.

Dr.: First, the mycoplasmas that seem to cause Gulf War Illness are not exactly "artificial," but we have some scientific evidence that they have been "modified." However, there's a "federal gag order" out on this so you won't hear about it in the normal news. It's frustrating because people need to know they can be helped - but if they don't know, they are at risk.

CPC: How did you get involved with the Desert Storm syndrome?

Dr.: Our daughter served in the 101st Airborne Division in Iraq on the deep insertions. Like many other vets, she came home very sick with Chronic Fatigue Syndrome and a number of associated ailments including arthritis-like problems with her joints.

She had problems with her hearing, vision, memory, headaches, skin rashes, muscle spasms, gastrointestinal problems, and cardiac erythema. All of these and a variety of other problems collectively fall under the category of "Desert Storm Syndrome" or "Gulf War Illness."

Urinary and reproductive cycle problems are also common in women with "Gulf War Illness." Severe pregnancy problems, many still births, birth defects, and many of the babies born to Desert Storm Syndrome patients die within a couple of years, tremendous problems in this category.

CPC: This is an amazing array of symptoms. How many people are infected?

Dr.: Between "50 and 100 thousand." That only includes those registered at the Veterans Hospitals, not their family members. There may be more.

CPC: Wow! Are these the soldiers that were in the "deep insertions" in Iraq?

Dr.: Some were on "deep insertions" and some were behind the lines. For example, some air force soldiers decontaminated aircraft that bombed Iraqi chemical and biological weapon storage facilities. Many of those "decontamination soldiers are dead and those still alive are very, very ill; some are paralysed." We worked with a sixteen-member graves registration until; there's only one member left alive and she's in a wheelchair now and doing very poorly.

CPC: The other fifteen dead?

Dr.: They're all dead! They were handling thousands of bodies but [the government] has covered this up and "only reported 148 combat deaths - but there were ten times more than that" due to infectious diseases and other problems associated with the Gulf War. Worse, the number is "going to grow" because of the "contagion" - mycoplasmas can be transmitted "through the air." Every place I look, somebody's showing symptoms.

We have detected the micro-organism, it's very evasive and "very infective, very contagious" in these Gulf War veterans. The evidence [indicates these mycoplasmas] have been tampered with by man.

The mycoplasma penetrates the cell, proliferates. It takes pieces of the host's membrane with it so the body is set up for rheumatoid response or thyroiditis and it's a very confounding illness, "perfect germ warfare," the last thing you'd expect, very difficult to diagnose. The general medical community is unaware of the - so the more it's kept under wraps, the greater the problem becomes.

The mycoplasmas are "deep" in each cell's nucleus and have certain DNA sequences that are "extremely" unusual and it is "highly" unlikely that these genetic sequences could have gotten into this organism in anyway except by man putting them there. One of the DNA sequences includes part of the HIV AIDS virus that was inserted in this micro-organism to make it more dangerous and more pathogenic - but that doesn't mean that

the people with Gulf War Illness have HIV--it's treatable— people hear "AIDS" and they get really upset.

CPC: Did you study AIDS and the hanta virus? Doesn't their transfer into humans seem so unnatural, that something almost had to be chemically engineered?

Dr.: Absolutely. You only expect a naturally occurring virus to have "homology" [similarities] to several other viruses. We look at the DNA sequence of HIV 1 and there's homology to so many different natural occurring viruses (more than 50), that it doesn't appear to be a naturally occurring event.

The Gulf War mycoplasma also give "AIDS-like" symptoms because it can also cause immuno-suppression. When a patient is immunesuppressed, he's left wide open for a variety of other opportunistic infections and diseases. Patients become more susceptible because they have this underlying [mycoplasma] infection which I call the "great imposter" and "great masquerader."

It hides and it manifests itself in so many different ways that most people just treat the symptoms if they don't know that this particular organism is present. And it is difficult to detect; we had to go to forensic techniques - but it "is" detectable and it is treatable.

Some people think the mycoplasma is a co-factor to the HIV virus. A person who had HIV and contracts these mycoplasma infections probably won't survive unless God intervenes directly. But other people who have "only" the mycoplasma can live - "if they're given the proper treatment."

We have a publication in the "Journal of the American Medical Association" on a small study of seventy-three soldiers who had Gulf War Illness. Fifty-five of those soldiers recovered after multiple treatments with the antibiotic Doxycycline. So we know that there are probably two antibiotics, (Doxycycline and Sibrofloxin) which seems fairly effective against the mirco-organism. But it requires several cycles, sometimes years.

We are told the Iraqis operated under the Soviet War Doctrine. If so, they probably used "several" infectious and chemical agents. As a result, many of the Gulf War soldiers were heavily exposed to indigenous chemicals and a variety of other agents in the air and clothing. This caused a "multiple chemical sensitivity" problem. Unfortunately, because of these chemical sensitivities many veterans can't take the powerful antibiotics because they react against them like they're foreign chemicals - so we have a double problem with those soldiers.

CPC: Do Doxycycline or Sibrofloxin actually kill the mycoplasma or do they just "put it to sleep?"

Dr.: "You will carry the mycoplasma for the rest of your life" but whether you relapse depends on your own immune system. The earlier you get the antibiotics the better chance you have of not relapsing. The longer you possess the illness, the harder it is to get rid of it...

CPC: Another guest on our program is Randall Pharr, a minister and former Navy Chaplin who's had personal contract with some of the victims of Gulf War Illness.

Rev. Pharr: Several of my colleagues served during Desert Shield and Desert Storm as Chaplains on the lines with the troops. These Chaplains have been medically "boarded out" of the service because of this malady and our endorsing agency is absolutely convinced that "biological or chemical warfare was used." However, to maintain whatever political advantage there may be, "we have soldiers, sailors, marines and airmen that are dying."

Dr.: It's absolutely pathetic. As a Chaplain you would be a number-one target to be "boarded out" if you got ill because they don't want anyone who is religious and willing to stand up against this unbelievable assault on America.

But it's also international. Scientists were imprisoned in the Middle East for not going along with the germ warfare. I've experienced a 10-year character assassination, professional assassination in work; anybody who has any belief in God is attacked - particularly in the science community. But I cannot justify any of this with science. It's evil, that's all I can tell you. It's a spiritual battle.

CPC: If this disease "is communicable through the air," it may be potentially more dangerous than AIDS.

Dr.: I don't see how anyone can avoid that conclusion. It's latency period depends on the individual's immune system; some people might carry it for years—it can also be transferred to unborn babies. That's why it's so important that we tell people what to do.

I've detected the sequences deep in the nucleus, "very" deep in the nucleus—I don't know what that's going to do for generations - it's in the hands of God now. But, it's hard to sleep at night wondering who's going to be a victim when they can be easily treated if the gag order and media blackout were stopped.

CPC: Who issued the gag order?

Dr.: Most likely, the Defenfe Department or the Pentagon itself. We know that the White House has this information and they haven't done anything with it. Our own hospital's administrators admitted receiving pressure from the Defence Intelligence Agency and the CIA because we were "ordered to stop our work" on these problems. We were "ordered" not to talk to the media or the press. But we can't do that because it's too serious. There has to be something that we leave for future generations. The children must be considered but it almost sounds like people thinking in terms of "eugenics" [2] where they don't care...they don't care about who is victimized.

One of my close friends (a Director of Special Investigations in the Justice Department) "has confirmed that there have been secret eugenics directives in prominent East coast laboratories since the late 19402." I've had corroboration from scientists who were on some of these projects, so it's a horrifying thought. But, I can't explain it any other way, that people should be so callous with our soldiers.

Every other experiment that's been done since the late 1940s involved soldiers. For some reason, the people who give these orders think they're immune to the disease and can escape it. But, someone might carry the infection and not feel anything or not have any symptoms and then pass it on to the next generation, or come down with it 10 years later. "Probably nobody is immune."

Today you don't have to be a soldier to get sick. [Because the mycoplasmas are contagious] we are talking about "civilians."

We've even heard that "some of these micro-organisms were probably illegally tested within the Texas prison system." We're working with some prison personnel at the Huntsville group headed by Sally Meadly. They had an array of symptoms similar to those that we're seeing in the Desert Storm vets.

In Huntsville prison, there's several hundred people that were affected and diagnosed with anything from multiplesclerosis to Lou Gehrig's disease.

When I'd done their profile, using our genetic tracking, the profile was very similar. (A couple of years ago, there was an unusual outbreak of an illness in Palestine, Texas where there's also a prison facility. They hushed that up, but we were able to talk to the physician and he did use Doxycycline). [3]

That connection [between Desert Storm and prison illnesses] helped us start to piece together duplicities and the spider web of connections between politics and science. High level people got sick, so they started leaking information to us.

We put it together, because after we helped many people who were high level and military intelligence and Delta Force - and my own experience of most likely having been in the department where the work was initiated - we were able to piece the information together.

CPC: Could the "Ebola" flesh-eating bacteria in Africa be a biological warfare agent? Dr.: All the sudden, all these illnesses are cropping up. I

can't prove it, but it's highly suspicious that there was an outbreak of Ebola in West Virginia. That's what the movie "Outbreak" is about.

Knowing what I know from people who worked at Ft. Detrick (Maryland) and who are high up in the agencies, nothing would surprise me in the amount of genetic tampering. I strongly suspect there's been tampering with the Leprosy bacteria and with Anthrax gene sequences. So, although we can only speculate, you have to assume there may be tampering with anything that's deadly.

None of this has been exposed in the media because there's practically a news blackout on this. Both my wife and I have given interviews for major news networks but they've been pulled. It's very frustrating because we wanted to help everyone. You have to draw the line at political agendas - the welfare of the people should be primary, particularly our soldiers...it's a tremendous betrayal.

CPC: Why would government suppress this information? Is the cover-up to help make these "world police actions" seem more palatable to the American people?

Dr.: It's probably more serious than that. We can only speculate, but in the late 1960's we passed federal laws banning the development and deployment of biological weapons. We ratified international treaties in the early 1970's essentially banning the use of biological weapons. Unfortunately our biological weapons development has probably gone on unimpeded even after signing those treaties. [4]

But we didn't know enough about the cells to begin with, that's why these experiments are completely ill-advised. Dr. Paul Burg won the Nobel Prize and advised against these experiments in the early 70s. They literally excluded him from the loop and went full speed ahead on the recommendations of Dr. Joshua Letterburg and Dr. James Watson - who had very unusual agendas in relation to the Human Genome Project. We believe the Human Genome Project funnelled a bunch of money - that should have gone to basic research for medical benefits - into making destructive weapons and biological warfare research.

It's contemptible. We don't know enough about how our cells work and these people should never have played God. It's completely immoral. It goes against everything that we, as a people, stand for. But there's also the question of financial liability. If people that were exposed to these biological weapons can "prove" they were exposed, there's a certain amount of civil liability.

Remember the Agent Orange problem of Viet Nam? Every veteran exposed to Agent Orange had one heck of a time trying to convince government that they were ill. Because of that, court battles were dragged out for 20 years or more.

CPC: There's a serious difference, though - Agent Orange was not "communicable."

Dr.: That's right - the mycoplasma is much more serious.

CPC: so government generally ignored the Agent Orange veterans until many had died and the problem was essentially stilled by time. Today, however, we're dealing with a "contagious" disease and official silence will cause "more people to suffer or die." So, by keeping this disease under wraps, government virtually guarantees that the contagion will spread...?

Dr.: That's true - they're still handling it just like they handled Agent Orange.

CPC: If Iraq used biological weapons in the Gulf War, where did Iraq get the necessary research data?

Dr.: I made a little survey and it seems that "most of the mycoplasma laboratories in this country have Iraqi technicians," which was quite an interesting fact. I can't speak for other countries.

However, it seems that everybody was involved. Mirza Bachoff is Moscow's Administrator for the Human Genome Project so you have what was the Soviet Union involved; "the United States is involved" leading the west; you have Iraq; the United Kingdom; "Israel was involved" - everybody, everybody. However, not too many people worked on mycoplasmas for the last 20 years so it's easy to trace who was doing the research.

CPC: Then how did Iraq get that biological weapon? Is it possible that the U.S. or a close ally is responsible for unleashing this disease?

Dr.: OK, let's speculate. We strongly suspect that the "the mycoplasmas that we've detected in Gulf War veterans were 'modified' in this country" (in fact right here in Houston) and sold illegally to the Iraqis.

CPC: That's why the government's not going to talk?

Dr.: Correct. It's very interesting that two weeks "before" Desert Storm, the U.S. Commerce Department put a hold on all mycoplasmas or genetically-modified mycoplasmas for shipment to the Iraqi Atomic Energy Commission - which tells us "they had already shipped it." [5]

CPC: Has this disease affected people living in the Middle East?

Dr.: They're very sick. We had an emissary from Iraq itself, from Sadam Hussein. We have his blood, he was positive. He told us there were 250,000 dead and at least a million infected including members of his own family.

We've been contacted by just about every Middle East country. For example, in Jordan there are high rates of spontaneous miscarriage and stillborn.

CPC: Those who live by the sword will die by the sword...?

Dr.: We told the Iraqi emissary that he poisoned his own seed; the germs don't care what you are. They don't know terrorists from counter-terrorists, from Iraqis, Israelis, Islamic, Christians and Jews - they attack everyone. However, the French help their soldiers exposed to the Gulf War Illness. They wrote to us and said they knew about the antibiotics but they were "diplomatically tied." We've helped the British; both Nancy and I were o BBC. The story is not being covered up in Britain. In Australia we were on television. We've been on TV in Italy because the Vatican is very concerned about this, particularly the Pope, who in his splendour of truth wrote that certain acts are inherently evil and this is one of them. He spoke out on our "death oriented" society, so germ warfare will be very high on their priority. But [because of the gag order and press blackout], America is the last place to be helped.

You know, we wish we could stay totally away from the politics but it impacts on everything.

CPC: What kind of "political agenda" are you facing right now?

Dr.: We can only hypothesize, but it appears that although "American soldiers were victims of biological and chemical warfare." The official government line is that no chemical or biologicals were used against our soldiers. Unfortunately it doesn't look that way and to keep that official line going, they have to deny that our soldiers are sick - and that's just what they're doing.

CPC: we've watched movies since we were kids about scientists creating monsters that had five eyes and were ten feet tall. In real life, however, it appears we may have created a more devastating monster - one so small that it's virtually invisible.

Dr.: Not if you know what to look for. And "recognized early, it's easily treatable."

We developed our gene tracking test over a fifteen year period to study the spread of cancer. We modified it for infectious disease and that enables us to know how the DNAs are put together and precisely where they are. As a result, "we have a test for this disease that we will run free of charge." But we need a blood sample to run the test.

We'd been mostly testing soldiers and their families but we've opened it up to other people because we now realize that many people have come in contact whether they've known it or not, with people from the Middle East, with soldiers, with a variety of other individuals, and they are at risk. Many people have chronic fatigue syndrome and the associated Gulf War Syndrome, but don't know it.

CPC: One last question: if we know someone who was in the Gulf War, should we check to see if they have any of these symptoms?

Dr. Garth Nicholson: Yes! If they want help, the can contact my office at the University of Texas, M.D. Anderson Cancer Center in Houston and I'll give you the number. They can contact Jean at my office (713) 792-7477. They can also contact us by fax at (713) 794-0209.

CPC: Blessings to you all. God bless you in your work.

About seven weeks after this radio interview, the July 3, 1995 "Spotlight" also carried an article about the Nicholsons ("Government Lying to Vets About Gulf War Syndrome").

This article quoted Dr. Garth Nicholson on the apparent U.S. coverup of biological warfare in the Gulf War: "The reason for such highly unusual events, is probably due to the fact that former President Bush and former Sec. of State James Baker, as well as the president of the M.D. Anderson Cancer Center, have financial interest in the local biotechnology companies that we strongly suspect were selling illegal biological weapons to Iraq that were subsequently used against our soldiers in Desert Storm." There's a bombshell. If one hundred thousand American veterans have been exposed to a life-threatening bio-warfare agent that was sold illegally to Iraq and generated a profit and to destroy large numbers of people in the world, for those who would control the world.

On July 6, 1995, the "Dallas Morning News" published a front page article entitled, "Iraq Tells U.N. It Produced Warfare Germs." According to the article: "Iraq has admitted for the first time that it secretly produced deadly bacteria before the 1991 Persian Gulf War in sufficient quantity to kill millions of people...[A] remote desert factory produced an immense quantity of the bacteria that cause botulism poisoning and anthrax infections...[However] both germ stockpiles were destroyed before the Gulf War to prevent contamination of the Iraqi countryside during the enemy bombing raids. They also said Iraq never had bombs or other weapons that could be filled with either of the agents."

Point: Iraq denies using botulism or anthrax as germ warfare agents in the Gulf War, but finally admits they were at least preparing to use germ warfare prior to the Gulf War. Although there is no mention of the "mycoplasma incognitos," the truth is seeping out, nonetheless.

In reference to **Aids** being a man-made virus there is no longer any doubt about that, which is abundantly clear from the following:

The Planted Aids Virus

The **Aids** Virus was planted in Vaccine at the U.N. World Health Organization to weaken and conquer the U.S. Most Americans know by now that there is no known cure for AIDS. Some of our medical men frankly state that there will never be a cure, except by isolation.

They have found that the AIDS virus is so small - It Can Pass through a Condom. And so strong - it can live six hours on a kitchen table!

But the most amazing news is that doctors have discovered that the Aids' virus Was Prepared Especially for - the African Black Man by Communist agents working as scientists for the World Health Organization [They are trough with the Blacks, as they have served their purpose in destroying Civil Rights and other laws they did not like in America.

The Blacks never suspecting their role as they worked tirelessly for equality, they never, and still do not, realize; that instead of getting what they most wanted, the Blacks were instead losing ground until, today their condition in life has not become better - **but Has Steadily Grown Worse**.

Therefore the so-called Black leaders like Jessie Jackson and the Rev. Sharp will lead them to total destruction like a Judas Goat, for it is now time to remove them because they are becoming increasingly harder to handle]. They decided that our conquest by AIDS would be easier and more effective than a nuclear holocaust.

Dr. William Campbell Douglass, an M.D. wrote an article for the September issue of "Health Freedom News," the journal of the National Health Federation entitled:

"Who Murdered Africa"

This is not a question. It's a statement. WHO, the World Health Organization, murdered Africa with the AIDS virus. Dr. Doubtless continues: Other suspects, the homosexuals, the green monkey and the Haiti and, Were Only Pawns in This Viricidal Attack on the Non-communist World.

Many viruses grow in animals and many grow in humans, but most of the viruses that affect animals don't affect humans. There Are Exceptions, Such as Yellow Fever and Smallpox.

The World Health Organization, in published articles, called for scientists to work with these deadly agents and Attempt to Make a Hybrid Virus That Would Be Deadly to the Black Man. [6] In the bulletin of the World Health Organization (WHO), Volume 47, pp. 251, 1972, they said, "an Attempt Should Be Made to See If Viruses Can in Fact Exert Selective Effects on Immune Function.

The possibility should be looked into that the immune response to the virus itself may be impaired **If the Infecting Virus Damages**, more or less selectively, **the Cell Responding to the Virus**."

That's **Aids**. What the **WHO** is saying in plain English is, "Let's cook up a virus that selectively destroys the T-cell system of man, an **Acquired Immune Deficiency**."

Why would anyone wish to do this? If you destroy the T-cell System of man, you destroy man. Is it even remotely possible that the World Health

Organization would want to develop a virus that **Would Wipe Out the Black Race?**

If their new virus creation worked, the WHO stated, then many terrible and fatal infectious viruses could be made even MORE terrible and **More Malignant.** Does this strike you as being a peculiar goal for a **Health** organization?

What about the green monkey? Some of the best virologists in the world and many of those directly involved in AIDS research, such as Robert Gallo and Luc Montagnier, have said that the green monkey may be the culprit. You know the story: A green monkey bit a native on the rump and, bam; AIDS all over Central Africa.

There is a fatal flaw here. Gallo, Montagnier and these other virologists know that the AIDS virus doesn't occur naturally in monkeys.

In Fact, It Does Not Occur Naturally in Any Animal! Aids Started practically **Simultaneously** in the United States, Haiti, Brazil, and Central Africa. One would wonder - was the green monkey a jet pilot?

Examination of the gene structure of the green monkey cells proves that **It Is Not Genetically Possible** to transfer **Aids** virus from monkeys to man by natural means.

Dr. Theodore Strecker's research indicates that the National Cancer Institute in collaboration with the World Health Organization made the **AIDS** virus in their laboratories at Ft. Detrick (now NCI).

They combined the deadly retroviruses, bovine leukemia virus and sheep visna virus, and injected them into human tissue cultures. The result was the AIDS virus, the first human retrovirus known to man AND NOW BELIEVED TO BE 100% FATAL TO THOSE INFECTED.

The momentous plague that the world now faces was anticipated by the National Academy of Sciences (NAS) in 1974 when they recommended that, "Scientists throughout the world join with the members of this

committee in voluntarily deferring experiments (linking) animal viruses." What the NAS is saying in carefully-guarded English is: "for God's Sake, Stop This Madness!"

Now that we've let the green monkey off the hook. How about the Communists? Well the Communists are saying **AIDS** is a "capitalist plot." This should make you suspicious because, as any student of the Jewish conspiracy knows, **They Always Blame Others for What They Are in the Process of Doing**. And what they are doing is **Conducting Germ Warfare from Fort Detrick, Maryland, against the Free World, Especially the United States, Even using foreign Communist agents within the United States Army's germ warfare unit euphemistically called the Army Infectious Disease Unit.**

Carlton Gajdusek, an NIH executive at Fort Detrick, admits it: "In the facility I have a building **Where More Communist Scientists from the U.S.S.R.** and **Mainland China Work** (with full passkeys to all the laboratories) than there are **Americans**. Even the Army's Infectious Disease Unit is loaded with foreign workers, not always friendly nationals." Can you imagine that? A United Nations - **WHO** Communist Trojan horse in **Our** biological warfare centre. There is absolutely no doubt that the creations of the **Aids** virus by the **Who** was not just a scientific exercise that got out of hand.

It was a cold-blooded, diabolical, successful attempt to create a killer virus that was then used in a successful experiment in Africa. so Successful That Most of Central Africa May Be Wiped Out, 75,000,000 Dead within the next 5-10 years.

It was Not an Accident. It Was Deliberate. In the Federation Proceedings of the United States in 1972, WHO said: "In the relation to the immune response a Number of Useful Experimental Approaches Can Be Visualized."

They suggested that a neat way to do this would be to put their new killer virus (AIDS) into a vaccination program, sit back and observe the results. "This Would Be Particularly Informative in Sibships," they said. That

is, **GIVE THE AIDS Virus TO BROTHERS** and **SISTERS** and see if they die, who dies first and of what, just like using rats in a laboratory.

They Used Smallpox Vaccine for Their Vehicle and the geographical sites chosen in 1972 were Uganda and other African states, Haiti, Brazil and Japan.

Dr. Strecker pointed out that even if the African green monkey could transmit **Aids** to humans, the present known amount of infection in Africa makes it **Statistically Impossible** for a single episode, such as a monkey biting someone on the butt, to have brought this epidemic to the point it currently is. **the Doubling Time of the Number of People Infected**, about every 14 months, when correlated with the first known case, and the present known number of cases, prove beyond a doubt that a large **Number of People Had to Have Been Infected at the Same Time.**

From 1972 to 1987 is 15 years. In 15 years, **from a Single Source of Infection** there would be about 8,000 cases in Africa, not 75-million.

Because of the trillions of possible genetic combinations, there will never be a vaccine.
