### FOREWORD

HEN I WAS VERY YOUNG, as were many other students, was fond of airing my views at the Speakers Corner which is in Hyde Park, London. I had been brought up to believe the Bible to be the Inspired word of God. It was an assumption that I accepted as being no less certain than that the world was round and that night followed day!

Quite naturally, armed with such an authority, I quoted the Bible copiously and, providing I could find a Bible text to fit the occasion, was convinced that that was the end of any argument!

It was a few days before Christmas, when I was about twenty years of age —and I'm not going to let on how long ago that was—when I got my comeuppance! A very pleasant man, not looking nearly as wicked as he should have looked, parried every assertion I made with the simple but profound words `Yes that IS what the Bible says but how do you KNOW that the Bible is the Word of God?'

Well **I DID** know, as every Christian knows, that the Bible is the Word of God because the Holy Spirit had revealed it to me and nobody who has had that revelation can ever doubt the fact. I could sing with the hymn-writer of old `I need no other argument, I need no other plea, it is enough that Jesus died and that He died for me!' There are millions of people in the world of all nations, of every social strata and of all levels of education who have had that experience! We, I can assure the doubter, need no other argument, for we have received the knowledge from God Himself by direct revelation.

It is not easy however to conduct a discussion on the basis of one having an inner-feeling which obviously no-one else can comprehend! The pleasant man did not destroy my faith in the Bible being the Word of God but he did cause me to wonder how I could prove **TO DOUBTERS** that the Bible is the Inspired Word of God. How, I wondered, could it be proved from evidence **EXTERNAL** to the Bible that the Bible is the Word of God?

That great Evangelist/Revivalist my good friend the late Principal George Jeffreys used to say `Bible prophecy is the test of Bible inspiration.' He was right! ## **CHAPTER ONE** Astounding Mathematical Discoveries!

**T IS ALTOGETHER REASONABLE** to expect that if there is a supreme being somewhere `up there' he would attempt to contact his creation. My intention in this book is to prove conclusively that God has indeed contacted His creation through **THE BOOK GOD SIGNED** and that the Bible is nothing less than His divine revelation to the world.

The newly discovered scientific facts which form the basis of this book are highly significant and of supreme importance! They show beyond doubt that the Bible could not have been written by human beings alone but that it is a supernatural, God inspired and God given book!

This book is a scientific, numerological demonstration of the divine, verbal inspiration of the Bible. The discoveries of Russian scientist and mathematician Dr. Ivan Panin can be rightly described as `Astounding!'

I will show in the following pages that a divine mathematical imprint has been discovered beneath the surface of the original Bible text, an imprint that has been mysteriously hidden for many thousands of years. The occurance of this divine mathematical imprint is so consistent and persistent that it has been detected, not in two or three but in tens of thousands of occurrences!

Needless to say, these mathematical discoveries are baffling and confounding atheists and agnostics alike for no living expert has been able to refute them. They are causing skeptics and modernist thinkers to think again and accept the Bible as being the supernatural, God inspired book it claims to be. The facts given in this book undoubtedly constitute one of the greatest discoveries of all time.

- What I have said so far will no doubt cause the reader to ask a number of questions:
- What is this amazing mathematical `signature' which exists beneath the surface of the Bible text?
- How does this `signature' prove scientifically that the Bible could not have been conceived in the human mind?
- Who made these discoveries and when?
- Why were they not discovered before?
- How do they affect each one of us personally?

Before an attempt is made to answer these and other questions, it is necessary to remind the reader of:-

#### THE GREAT BIBLE `CLAIM' CONCERNING ITSELF

There can be no doubt that the Bible `claims' to be a supernatural, God inspired, God given book. The Bible declares that `All scripture is given by inspiration of God.' II Timothy 3:16. The expression, `given by inspiration of God' is the translation of one Greek word `*theopneustos*,' which means literally `God-breathed.' The great Bible claim then, is that `all scripture,' the entire Bible, `is God-breathed.'

The Bible claims that the writers of Scripture wrote, not of their own will, but only as they were `moved' or `controlled' by the Holy Spirit of God. 11 Peter 1:21 declares that the Scripture came `not ...by the will of man, but holy men of God spake as they were moved by the Holy Spirit.' Another translation of this same passage declares that no Scripture `was ever borne by man's will; but men spake from God, being borne on by the Holy Spirit.'

The Bible claims that the words which the prophets wrote were not their own words but that they were the very words of God Himself. The Person speaking was God, not man. God was speaking merely 'by' or 'through' man. 'God ... spake in time past unto the fathers by the prophets.' Hebrews 1:1.'He (the Lord God) spake by the mouth of His holy prophets.' Luke 1:70. `The Spirit of the Lord spake by me, and His word (not the writer's own word) was in my tongue.' II Samuel 23:1,2.'Behold I (God) have put my words in thy mouth.' Jeremiah 1:9. 'Thou shalt speak my words (God's words) unto them.' Ezekiel 2:7. A death penalty was pronounced upon the prophet who should add any of his own words to God's words. God declared, 'the prophet, which shall presume to speak a word in my name, which I have not commanded him to speak, ... even that prophet shall die.' Deuteronomy 18:20. God said to Moses, 'Ye shall not add unto the word which I command you, neither shall ye diminish out from it.' Deuteronomy 4:2. Thus the Bible clearly distinguishes itself from the word of men. It claims that its words are the very words of God Himself and that men were merely the instruments or mouthpieces 'by' or 'through' which God 'breathed' His Word. The prophets merely recorded the words they received from God. They did not always understand the full significance of what they wrote, for they 'diligently "searched' their own writings so that they might understand more perfectly. I Peter 1:10, 12.

The Apostle Paul declares, `the things that I write unto you are the commandments. I Corinthians 14:37. `We speak, not in the words which man's wisdom teacheth, but which the Holy Ghost teacheth.' I Corinthians 2;13. `Ye heard of us ... not the word of men, but ... the word of God.' I Thessalonians 2:13. The phrase, `Word of God' occurs frequently and is always especially significant. Statements such as `Thus saith the Lord, "God said,' and similar expressions, occur more than 2,500 times in the entire Bible. The Scripture is to be received `not as the word of men, but as it is in truth, the word of God.' Thus, the Bible makes startling claims for itself- it actually claims to be a supernatural, God breathed, God given book - the very Word of God Himself. This is the unmistakable language of the Bible. Numerous other Biblical statements could be given in support of this claim. However, those already presented are sufficient for the present purpose.

There can be no doubt about what the Bible `claims' concerning itself. However, many have raised the question—`Is that claim actually true?' Is the Bible actually the very Word of God?'

The facts which have been recently discovered beneath the surface of the original Bible text now scientifically prove and demonstrate that the Bible actually is a supernatural, God inspired book! Various questions concerning the newly discovered facts were mentioned in a preceding paragraph. The first of these questions can now be discussed and answered.

## CHAPTER TWO The Newly Discovered Numerological Imprint

HAT IS THIS `imprint' that has been discovered to be existing beneath the wording of the original Bible text? Obviously, over the years, there have been various translations of the Bible and so the question will naturally be asked `Which translation has this imprint?'.

In order to understand what these `imprints' are it will be necessary to define —

#### THE MEANING OF THE TERM 'ORIGINAL BIBLE TEXT'

Most persons are acquainted with the fact that the Bible contains two main divisions — the Old Testament, and the New Testament. Strange as it may seem, these two main divisions of the Bible were originally written in different languages. The Old Testament was originally written in Hebrew while the New Testament was written in Greek. By the term `original Bible text' is meant the Hebrew and Greek text of the Bible—the words of the writers in the original languages, not their words translated into some other language. The facts, then, have been discovered beneath the surface of the Hebrew Old Testament text and the Greek New Testament text of the Bible.

Before the reader can understand what the facts are (the facts which have been mysteriously concealed in the Hebrew and Greek Bible text) it is necessary to carefully observe:-

#### A PECULIAR CHARACTERISTIC OF THE HEBREW AND GREEK LANGUAGES

Many of the newly discovered facts have a direct bearing on the unusual characteristic of these languages. The following comparison is made with the English in order that the peculiarity of the Hebrew and Greek might be clearly understood.

In English there are twenty-six letters in the alphabet, a, b, c, d, e, f, g, h, etc. In addition to these twenty-six letters we use the numbers 1,2, 3, 4, 5, 6, 7, 8, 9, 0. These figures are the Arabic symbols used for the purpose of expressing `numbers.'

The Hebrew and Greek languages do not have a system like this. These languages have only the letters of their alphabets, but do not have additional symbols or figures such as 1,2,3,4, etc. which express numbers. Instead of using special figures, the Hebrew and Greek languages use the letters of their alphabets to express or represent numbers. Thus the letters of their alphabets serve a twofold purpose—they are used to represent or express numbers as well as to write words. Every letter of the Hebrew and Greek alphabets represents a certain 'number.' In other words, each letter is assigned a 'numeric value.' This is the peculiar characteristic of these languages.

The Hebrew alphabet has 22 letters and the Greek alphabet 24.

The Hebrew and Greek letters then, in addition to expressing sounds, also express the numbers 1,2,3,4,5, etc. Each letter represents a certain `number'— it has a definite `numeric value.' For example, in Greek the number one hundred forty-four is written p Á ä for these letters have the following numeric values a -100 i - 40  $\ddot{a}$  – 4

The reader can easily understand that since each Greek and Hebrew letter has a numeric value, each word likewise has a numeric value, for each word of course is made up of one or more letters. For example, the Greek word 'Içóïýò which means `Jesus' has a numeric value of '888. Why? Because the numeric values of the six Greek letters in the word 'Içóïýò Jesus, when added, total 888.

Thus the numeric value of this Greek word 'Içóïýò Jesus, is 888. In connection with this it is interesting to note that Satan's number or the number of the anti-Christ is 666—a strange comparison indeed. Revelation 13:18.

Every Greek and Hebrew word, then, in addition to expressing some idea, also has a numeric value which is obtained by adding the numeric values of the special letters in each particular word.

The reader can easily understand that since every word in the Hebrew and Greek has a numeric

value, as shown in the above example, each sentence likewise has a definite arithmetical sum or numeric value, for each sentence of course is composed of a number of words. The numeric value of a sentence is obtained by adding the numeric value of each word contained therein. The following Greek sentence, "'Å Üêñvóåí 6 'Éçóaéi is given as an example.

If this were translated word for word into English it would read, `Wept the Jesus.' In the King James or Authorized Version of the Bible, it is translated `Jesus wept.' John 11:35.

The total of the numeric values of the three words is 1743. Thus the numeric value of the sentence is 1743.

Just as each sentence has a numeric value, so each paragraph and each passage has a numeric value. In precisely the same way, each of the sixty-six books of the Bible has a numeric value.

Thus the peculiar characteristic of both the Hebrew and Greek languages is that the letters, words, sentences, paragraphs, passages, etc., have `numeric values.'

Now there is one number in particular to which the reader's attention is called. It is a number which occurs in Scripture more times than any other. It is the number `seven.' From the first book of the Bible through the last book, `seven' is by far the outstanding number. For example, the Sabbath was the seventh day. In Egypt there were seven years of plenty and seven years of famine. When the city of Jericho was captured, the people and seven priests who had seven trumpets marched around the city seven times. Every seventh year the land of the Israelites was not to be cultivated or planted. Solomon was seven years building the temple. After its completion he held the feast for seven days. Naaman washed seven times in the river.

In the book of Revelation, the last book of the Bible, this number is especially outstanding. Seven churches, seven lamp stands, seven seals, seven trumpets, seven vials, seven stars, seven spirits, etc., are mentioned. In all, the number seven occurs in the book of Revelation more than fifty times.

It has long been known that the number seven occurs in the Bible in this particular manner more frequently than any other number. However, only recently it has been discovered that this same number also occurs in a mysterious and peculiar manner beneath the very surface of the Hebrew Old Testament text and the Greek New Testament text of the Bible.

When it is stated that the sevens occur in a peculiar manner `beneath the surface' of the original Bible text, we mean that they occur in such a way that they are not noticed or discovered by merely `reading' the surface, or words. The sevens are strangely out of the sight of ordinary Hebrew and Greek readers. They are mysteriously hidden. Thousands who have read and studied the original Hebrew and Greek text of the Bible have passed by these strange occurrences of the number seven without even noticing or knowing of their presence. These sevens are so deeply concealed that special searching and investigation and special counting are necessary in order to find them. Thus they are said to occur `beneath the surface' or `in the structure' of the text because they are beyond the observation and view of ordinary Hebrew and Greek readers.

It has been discovered that thousands of these sevens are mysteriously hidden in the structure of the text. Some of the sevens are strangely concealed in the unusual system of numbers—in the `numeric values' of the Hebrew and Greek letters, words, sentences, paragraphs and passages of the text, while other sevens are hidden in other remarkable and peculiar ways.

These sevens beneath the surface of the original Hebrew and Greek Bible text are the amazing newly discovered facts. The astounding new discoveries are numerical discoveries—discoveries having to do with numbers. The recently revealed numerical facts or sevens, in a most extraor-dinary way, enable us to see an actual scientific demonstration of the divine verbal inspiration of the Bible.

The reader is given examples of these newly discovered numerical facts before he learns how they scientifically prove that the Bible is a supernatural, God breathed book.

## CHAPTER THREE. Examples Of The Numerological Imprint Discovered Beneath The Surface Of Ancient Manuscripts

The following are examples of the newly discovered facts or `sevens' which occur in a peculiar manner beneath the surface of the Hebrew text of the first verse in the Old Testament—the very first verse in the Bible.

#### **BOOK OF GENESIS, CHAPTER ONE, VERSE 1**

'In the beginning God created the heavens and the earth.'

The first `sevens' pointed out occur in a strange manner in the `numeric values' of various words and letters of the verse. It has already been stated and explained that each Hebrew and Greek word has a `numeric value.' The Greek word ' $Iç \acute{lis}$  Jesus, was given as an example, and its numeric value was seen to be 888.

Below are the Hebrew words of the very first verse in the Bible. The words are taken from their line position and placed in a column so that the `numeric value' of each word may be more easily shown.

## (The Hebrew reads from right to left instead of left to right as we are accustomed to reading. Thus the first letter of each Hebrew word is on the right, not on the left.)

There are three important nouns in this first verse—'God', 'heaven' and 'earth.' The numeric values of these three nouns are 86, 395, 296, respectively. When these three numeric values are added, the total value is found to be a number which divides perfectly by 7—a number which is a multiple of 7. The total numeric value of the three words, strange as it may seem, is exactly 777, which of course is 111 7's.

Is it not strange that the numeric value of these words is a value which divides perfectly by seven—a value which is an exact multiple of seven? Notice that the numeric value of the words is not 776 or 778, but exactly 777. If the numeric value were 776 or 778 it would not divide evenly by 7.

Here the number seven occurs in a strange manner beneath the surface, beyond the view of those who merely `read' the words or surface of the Hebrew text. It is mysteriously hidden in the

numeric value of the three words and is passed by unnoticed unless it is discovered by special investigation and special counting.

Each numerical `fact' or `seven' discovered in the structure of the text is called a `feature'—a `numeric feature.' This, then, is feature one. It is repeated below to place it in a list with other numeric features which have been discovered beneath the surface of the first verse in the Old Testament.

#### FEATURE ONE

#### FEATURE TWO

#### FEATURE THREE

#### FEATURE FOUR

#### FEATURE FIVE

The numeric value of the first and last letters of the words remaining between the first and last words also divides perfectly by 7. Their numeric value is:-

#### FEATURE SIX

The Hebrew participle 'ETH' which is not translatable into English, occurs twice in the sentence of seven words. The article `the' also occurs twice. The numeric value of these two words which occur twice also divides by 7. Their numeric value is exactly

#### FEATURE SEVEN

The last letters of the first and last words have a numeric value of exactly

These numeric facts or sevens are indeed beyond the view of mere `readers' of the Hebrew text. They are truly mysteriously hidden beneath the surface and can be discovered only by special searching and calculations.

The above features were discovered in the `numeric values' of the Hebrew letters and words. However, the number seven is also concealed in various other ways in the structure of this first Bible verse. Examples are given below.

These sevens—these numeric features or facts—are indeed strangely hidden `beneath the surface. 'They are truly beyond the view of ordinary readers of the Hebrew text and are discovered only by special investigation and counting.

The above are only a few examples of the many amazing numeric facts which have been discovered in the structure of this first verse of only seven Hebrew words. Literally dozens of other phenomenal numeric features strangely underlie the structure of this verse.

Examples of these newly discovered facts or numerical features should be pointed out from other passages before the reader learns how they scientifically prove that the Bible could not possibly have been written by human beings alone, but that it is a supernatural, God inspired, God given book.

The following are examples of the newly discovered facts or `sevens' which occur in a peculiar manner beneath the surface of the Greek text of the first verses in the New Testament.

## BOOK OF MATTHEW, CHAPTER ONE, VERSES 1-17 The Account of Christ's Genealogy

**THE FIRST SEVENTEEN VERSES** in the book of Matthew form a natural, logical division by themselves, for they deal with one particular subject, namely, the genealogy of Christ. There are seventy-two Greek vocabulary words in these first seventeen verses. The first fact or `seven' pointed out is strangely hidden in the total `numeric value' of these seventy-two Greek vocabulary words.

It must be remembered that the number of vocabulary words in a passage is usually different from the total number of words in a passage. The vocabulary words are the different words used. For instance, the word `and' is one word in the vocabulary, but it may be repeated many times in the passage itself. Á man may have a vocabulary of only five hundred words. With these five hundred different words he may write an essay of four thousand words. Some of the words, such as `and,' `for,' 'by' etc., may be used over and over again. The number of vocabulary words, or the number of different words used in a passage, is thus not the same as the total number of words used.

It has already been stated that there are seventy-two Greek vocabulary words in these first seventeen verses of Matthew, and the first fact or `seven' is strangely concealed in the `numeric value' of these words.

#### FEATURE ONE

It is amazing to note that the total numeric value of these 72 words is also a number which divides perfectly by 7—a number which is an exact multiple of 7. The numeric value of these words is:-

Notice the number is not 42,363, or 42,365, but exactly 42,364. Neither of the first two numbers divides evenly by 7. If even **one** Greek letter were taken out or exchanged for another letter, the numeric value would be changed.

The 72 Greek vocabulary words in the first seventeen verses of Matthew occur in 90 forms. (Greek words are written in various forms to give slightly different meanings. For example, the word ' $\dot{E}c\dot{o}i$  Jesus, is sometimes written ' $lc\dot{o}0$  which means `of Jesus.' This then is a different form of the word `Jesus.') The 72 vocabulary words mentioned above occur in 90 forms. It is astonishing to note that the numeric value of the 90 forms is also a number which is a multiple of 7. The numeric value of these forms is:-

These particular features of 7's occur beneath the surface of the passage in the `numeric values. 'The number 7 also underlies the text in many other remarkable ways.

The above nineteen features are merely a few examples of the many phenomenal numeric facts which have been discovered beneath the surface of this one passage, Matthew, Chapter One, verses 18-25. The number seven strangely underlies the very structure of the text in every conceivable manner. The Greek letters and words are literally permeated with amazing occurrences of the number seven.

Following are examples of numerical facts which are strangely hidden in the second chapter of Matthew.

These are certainly remarkable and startling occurrences of the number seven in the very structure of the text. They are so deeply and peculiarly hidden that the reader can well understand how thousands of Greek and Hebrew readers could pass them by without noticing them.

The preceding numerical features from the second chapter of Matthew do not form a complete list by any means. They are merely a few examples of the interesting features which permeate and underlie the structure of this passage.

In the preceding pages of this book the reader has been given a small conception of the thousands of amazing facts which have been found in the very structure of Bible passages.

## THE EXTENT OF THESE NUMERICAL FEATURES

It has been discovered that amazing numerical facts occur beneath the surface of the original Bible text from the very first verse in Genesis through the very last verse in Revelation. Phenomenal mathematical features, similar to the examples already presented, underlie and pervade the text of everyone of the sixty-six Bible books. They occur in the very structure of every paragraph in the entire Bible, not in the paragraphs only, but often in the many sub-divisions of paragraphs. Often single verses are literally teeming and saturated with astounding numerical facts. These features extend to all parts of the text, vocabulary, grammatical forms, parts of speech, etc. Often as many as a hundred or more numeric features are strangely hidden beneath the surface of passages which consist of no more than 175 words. Actually thousands of the numerical facts have been discovered—they are so abundant that more than 40,000 pages have been required to contain the calculations used in discovering and enumerating the features of the New Testament alone.

The examples in the preceding pages—examples from the first verse in Genesis and the first passages in the New Testament—have shown how the numerical fact of sevens underlie the structure of single **Bible passages**. However, this is only one particular manner in which the sevens occur. It has been discovered that they occur beneath the surface of the text in dozens of other ways.

The next chapter is devoted to one other particular manner in which the sevens are found in the structure of the Bible text. Then the reader will be prepared to learn the significance of these newly discovered facts—how they scientifically prove the Bible could not possibly have been written by human beings alone, but it is a supernatural, God inspired, God given book.

In the addenda there are additional abbreviated examples of the same type of numeric discoveries as are presented in this chapter—discoveries of facts which occur beneath the surface of single Bible passages. The examples in the addenda are facts discovered in the structure of passages from the Book of Mark, and are very interesting indeed. The reader may find it helpful if he refers to them before beginning the new chapter which discusses another manner in which the facts underlie the original Bible text.

## CHAPTER FOUR Further Examples Of A Complex Mathematical Pattern Discovered Beneath The Surface Of The Original Bible Text.

**HE EXAMPLES** in the preceding two chapters are examples of numerical facts which occur beneath the surface of single passages. The following are examples of features which occur in a different manner. They are features which are not confined to single passages, but are features which occur in the structure of special words—words which are separated by great distances, appearing in many different books of the Bible.

#### EXAMPLES OF NUMERICAL FEATURES IN THE NAMES OF THE BIBLE WRITERS

The Bible writers' names are widely separated throughout the Scripture. It is remarkable to note that the number seven is found even in the scattered occurrences of these names.

Twenty-six writers are named in the Bible. There were others who wrote books of the Bible. However, only twenty-six of the writers are actually named in the Bible itself.

Of course, each of these twenty-six names, like all other Hebrew and Greek words, has a

numeric value. In the following list the numeric value is placed beside each name.

All this seems so amazing—and so exhaustive—yet the truth of the matter is, these are merely a few examples of the many astounding numerical features which occur in the structure of these Bible writers' names.

The above are examples of features which are not confined to single passages but are examples of features which occur in the structure of special words — words which are separated by great distances, appearing in many different parts and many different books of the Bible. The reader can well understand that the discovery of numerical features such as these requires careful searching throughout the entire Scripture. Following is another illustration of numerical features which occur in this same manner.

#### WORDS WHICH BEGIN AND END THE NEW TESTAMENT BOOKS

There are twenty-seven books in the New Testament. Thus there are twenty-seven words which begin these books and twenty-seven words which end them, a total of fifty four words.

This again is only one of the dozens of amazing numerical features which occur in the structure of these words. The reader will agree that features such as this one are indeed deeply and peculiarly hidden beneath the surface, and would not be discovered by superficial readers of the Greek text, unless special investigation and calculations were made.

The following are other examples of features which underlie the surface of special words—words which are separated by great distances, appearing in many different books of the Bible.

The features enumerated above by no means form the complete list of numerical features which are strangely hidden in the occurrences of these words.

Similar features underlie the occurrences of thousands of other words. For example, the word `year' is distributed throughout the book of Genesis in such a marvellous manner that more than 20 amazing numeric features occur.

Thus far the reader has seen two distinct ways in which the number seven has been discovered in the structure of the original Bible text. Numerical features occur beneath the surface of single passages and also beneath the surface of special words which are separated by great distances appearing throughout the Bible.

Numerical features are peculiarly hidden in the structure of the original Bible text in dozens of other interesting and amazing manners. One other way in which the number seven occurs is briefly pointed out, then it will be explained how these amazing newly discovered numerical facts scientifically prove that the Bible is a supernatural, God inspired, God given book.

It is interesting to note that even the Bible as a whole divides perfectly into exactly seven great divisions.

- 1. The Law
- 2. The Prophets
- 3. The Writings (Hagiographa)
- 4. The Gospels
- 5. The Acts
- 6. The Epistles
- 7. Revelation

The two larger divisions, the Prophets and the Epistles, are each composed of a number of books which divides perfectly by seven. The number of books in each of these divisions is exactly 21, or 3 7's. There are dozens of other amazing numeric features hidden beneath the surface of these seven Bible divisions.

## CHAPTER FIVE. Does This Mathematical Pattern Prove That The Bible Is Of Supernatural Origin?

**THE PRESENCE** of the amazing numerical features or facts beneath the surface of the original Bible text cannot be denied by anyone. There are actually thousands of phenomenal, numerical facts in the very structure of the Bible. One can ignore them and turn his eyes from them but the astounding numeric facts continue to be there. Our own opinions, likes or dislikes do not alter the facts in the least. Welcome or unwelcome, acknowledged or unacknowledged, the facts continue to be there. Their presence is one truth which every person must accept.

Now then, since these facts are actually found in the very structure of the Bible text, a certain logical question arises.

#### HOW CAN ONE ACCOUNT FOR THE PRESENCE OF THESE FACTS?

How did these features occur or come to be in the very structure of the Bible text? Their presence must be explained in some satisfactory way.

The reader will agree that there are only two possible ways in which these amazing facts could have occurred. They could have occurred either by accident, that is, by sheer chance, or by design. They could have occurred accidentally, or they could have been purposely designed or arranged—their occurrence in such a marvellous manner could have been planned and intended.

No doubt some are of the opinion that these features occurred accidentally—that they occurred in this peculiar manner merely by chance. Now then:-

#### WHAT ARE THE CHANCES FOR TWENTY FOUR FEATURES TO OCCUR ACCIDENTALLY?

Suppose there are twenty-four numerical features or facts in the structure of a certain passage. What chances are there that these features would occur together in one passage accidentally? This is easily calculated, for there is a standard, recognized, scientific method of calculating chances—there is an established law of chances.

Only one number in seven is a multiple of seven. The other six numbers which are not multiples of seven have as good a chance to occur accidentally as the one that is a multiple of seven. Therefore,

Thus, according to the law of chances, for 24 features to occur in a passage accidentally, there is only one chance in 191,581,231,380,566,414,401—only one chance in one hundred ninety-one quintillion, five hundred eighty-one quadrillion, two hundred thirty-one trillion, three hundred eighty billion, five hundred sixty-six million, four hundred fourteen thousand, four hundred one.\*

Many brief Bible passages have as many as seventy or a hundred or more amazing numeric features in the very structure of their text. If there is only one chance in quintillions that 24 features could occur together accidentally, what would the chance be for 70 features to occur together accidentally?

When there is only one chance in thousands for something to happen accidentally, it is already considered highly improbable that it will occur at all. When there is only one chance in hundreds of thousands, it is considered practically impossible. But here there is one chance in not only millions, but billions, and trillions, and quadrillions, and quadrillions, that merely 24 features could occur together in a passage accidentally.

The argument and demonstration is convincing enough. The amazing numerical features of even one small passage, to say nothing of the thousands in the entire Bible, could not possibly have

occurred by accident—by sheer chance. All this evidence simply cannot be explained by the doctrine of chances. If these features did not occur accidentally, then there is only one conclusion, one alternative. They were purposely designed or arranged—their occurrence in such a marvellous and mysterious manner was intended or planned.

The point can be illustrated in the following way:

Suppose for example, someone were carrying a bag which contained 24 oranges. Suppose that suddenly the bag broke and the 24 oranges fell to the floor. What chance would there be that, the oranges would fall into four perfect rows with six in each row, each orange being exactly opposite the other? Such self arrangement would be considered impossible!

Suppose on the other hand you came into the room and found the oranges arranged in the manner described. You would come to only one conclusion, namely, that they were purposely designed or arranged in that unusual manner. No one would risk being called insane by insisting that such a thing occurred accidentally!

Likewise, these profound numeric features found in the very structure of the original Bible text are not there by chance or accident, but by design. They are arranged according to definite plan; they form thousands of perfect and uniform designs.

It has been conclusively shown that there are amazing numerical features in the structure of the Bible—their presence cannot be denied, but is a truth which everyone must accept. It has been proved that these features could not possibly have occurred by chance or accident, but that they were arranged or designed. This is a second truth which everyone must accept.

Since the discovery of a design is proof of a designer, the next logical question arises

#### WHO PLANNED AND CARRIED OUT THESE AMAZING NUMERIC DESIGNS?

Who caused them to occur in the very structure of the Bible text?

The thousands of perfect patterns and designs came into the Scripture through some intelligence. The reader will agree that there are only two possible intelligences that could have planned and brought about these profound designs. They could have come into the Scripture either by human intelligence or by superhuman, namely, divine intelligence.

## Were these amazing numeric designs planned by the men who wrote the books of the Bible?

(1) The profound numeric patterns in the structure of the Bible passages could not possibly have been planned and worked out by mere human beings alone.

If anyone could write an intelligible passage of 300 words, constructing it in such a way that the same designs and schemes of sevens occur in the structure of its text as those found in the first seventeen verses of Matthew, indeed he would prove himself a wonder if he could accomplish it in six months. (Chapter 3.)

If anyone could write an intelligible passage of 161 words, constructing it in such a manner that the same designs and arrangements of sevens occur in the structure of its text as those which are found in verses 18-25 of the first chapter of Matthew, he would accomplish a still greater wonder if he were able to do it in three years.(Chapter 3)

If anyone in an entire lifetime of continuous work could write an intelligible passage of some 500 words, containing in its structure as many intertwined yet harmonious numeric features as are found in the second chapter of Matthew, it would be a miracle of miracles. (Chapter 3.)

No mortal in the lifetime of a hundred years could possibly have carried out the design which is found in even a single book of the Bible, if he devoted the entire hundred years to the task. It would require some centuries to write a book designed and constructed in the manner in which the book of Matthew is constructed.

It must be remembered that with each additional sentence the difficulty of constructing these numerical features increases not only in arithmetical progression, but in geometrical progression, for each paragraph is designed so as to develop constantly fixed numeric relations to the material which precedes and follows it. Every additional letter, word, and sentence makes the matter tremendously more complicated and comprehensive.

The reader must also observe that many of the Scripture writers were men chosen from very ordinary walks of life—men who had little or no schooling at all. If Matthew, Mark, Luke or John, for instance, had attempted to construct and produce the harmonious numeric features and designs which are found in their books as a whole, and had attempted to produce separate numeric schemes and designs which occur in each division, and in each sub-division, and in the words, forms, vocabularies, letters, etc., how long would it have taken them to construct their books? Centuries upon centuries!

Dr. D. B. Turney tells how he attempted to construct a passage that would show some numeric features. He declares, 'I gave numeric values to the English alphabet, and tried to prepare a passage which would adhere to the numerics, and make every section a multiple of seven, and present all the other features of Biblical arithmography, without letting the meaning of the passage descend to nonsense. After working thereon for days, I could get no satisfaction. Yet this feature is accomplished in every one of the thousands of Bible paragraphs without the slightest visible effort.'

(2) The marvellous numeric designs which extend over many books of the Bible could not possibly have been planned and carried out by the writers themselves.

Not only are the phenomenal designs confined to the text of single Bible passages, but widely separated portions of the Bible are woven into intricate and perfect patterns. Special words which are scattered through many different books of the Bible form amazing chain-designs that literally teem with numerical features. The numeric designs in the structure of the Bible writers' names were given as examples of these word-chains which extend throughout the entire Scriptures. (Chapter Four) The discovery of such designs requires careful searching in all parts of the 66 books of the Bible.

The double design of sevens in the name `Moses,' for example, could not have been planned and carried out by the Bible writers themselves. It must be remembered that the writers did not live at the same time—they lived many years apart. In fact there was a period of about 1600 years between the writing of the first book of the Bible and the last. It must be remembered also that the 66 books were written by 33 different persons. And it must be remembered that they were men of widely different backgrounds. Many of the writers had little or no schooling. How could these men have planned the distribution of the name `Moses' throughout the entire Bible so as to form marvellous numeric designs?

How could each one of the 33 writers who lived in various countries, the last writer separated by 1600 years from the first, insert the name 'Moses' just enough times to keep the numeric design in suspense until it came to John, the last writer who used it in the book of Revelation

just once to complete the design? How could each writer have known that he should use a particular word a certain number of times so that when all would be finished after 1600 years the total would divide perfectly by seven and would show numeric design? Certainly such design could not possibly have been planned by the writers themselves. The case of Moses is only one example of a chain design which extends throughout the entire Bible. Literally hundreds of other cases as convincing as this can be pointed out.

Each word of the whole Scripture is linked and connected in one marvellous pattern. All the intricacies and beauties of the separate and smaller patterns when put together form one great design. Thus the entire Bible is tied together by a continuous pattern from Genesis to Revelation.

The designs interlock paragraph with paragraph, book with book, and the Old Testament with the New Testament. The numerics of the Old Testament and those of the New together form harmonious schemes which could not be made possible or solved without either of the Testaments. The Old Testament was concluded 400 years before the New Testament was begun, yet the two when taken together form one complete revelation. Both accord perfectly—both are parts of one homogeneous whole.

The fact that the Bible was written by a number of different persons in various countries of the world over a period of hundreds of years makes it impossible for the writers to have planned these patterns. Designs which cover some 1600 years could never have been planned and carried out by man, for many of the words were penned without any knowledge of what would be written by other writers many years later. Even if it were possible for the 33 different writers to meet and confer about the use of their vocabularies, etc., it would require thousands of years to carry out such profound numeric schemes.

The minds of the cleverest men who have ever lived would not be capable of devising such sublime mathematical problems. No human minds could possibly have devised such a means of binding the whole of the Word together.

(3) The special elaborate numeric designs in each book of the Bible could not possibly have been planned and carried out by the writers unaided.

The number of words found in Matthew, not found in any of the other 26 New Testament books, shows elaborate designs. How did Matthew know that he should use certain words which would not be used in any of the other 26 books of the New Testament? In order for him to have done this it would have been necessary for him to have had all these other books before him as he wrote his book. If he had all these other 26 books before him as he wrote, it would mean that he wrote his Gospel last.

It so happens, however, that each of the other books has a certain number of words which are not found in any other New Testament book. These words show phenomenal numeric designs. How did each writer know that he should use a certain number of words which would not be used in any other book? In order for each writer to have done this it would have been necessary for each one to have had all the other 26 books before him as he wrote. If each had the other 26 books before him as he wrote it would mean that each particular Gospel was written last. But such a thing is an utter impossibility! How could each Gospel writer have the other 26 books before him as he wrote? Such a thing is unthinkable!

These are only a few of the many problems which confront a person who tries to figure out how mere men could have designed and arranged the phenomenal numeric features in the structure of the original Bible text. Certainly these amazing numerical designs could not possibly have been planned and carried out by human beings.

It is interesting to note that as far as is known,

#### THE BIBLE IS THE ONLY BOOK IN EXISTENCE WHICH IS CONSTRUCTED ON AN AMAZING NUMERIC DESIGN

At first glance the most obvious objection to the numeric features of the Bible is that such or similar numerics could be extracted from any other writings in any language if sufficient time and ingenuity were expended. However, this is not the case. The Bible is different from all other books. No other piece of literature anywhere in the entire world is known to contain amazing numerical features such as are found in the structure of the Bible text. The Apocrypha shows no evidence of such numeric design. Various persons have devoted much time to the examination of the Greek classics in an effort to find the same mathematical structure, but no such phenomena have yet been found anywhere.

Various professors of Greek have been requested to submit Greek prose classics to the numeric test to ascertain if this same amazing numerical phenomena could be found. No one has reported any success in finding such numeric designs.

No human beings could have written the Bible in the way it is demonstrated to have been written. No human foresight or arrangement could have secured such results beforehand; no human powers could have carried them out to such perfection. Man by his own attainments could not perform such unthinkable feats. It is simply impossible to account for these designs of numeric features if the mere human authorship of the Bible is assumed.

If human logic is worth anything at all we are simply driven to the conclusion that the thousands of amazing numeric designs in the very structure of the original Bible text could not possibly have been planned by the men who wrote the books of the Bible—they could never have been produced by human minds.

It is evident that the Bible is not the work of many minds, but the work of One Mind. The designs furnish clear proof that the whole Bible has but one Author. All the books of both the Old and New Testaments were planned and produced by the same Mind.

Every candid, logical minded individual is simply compelled to admit that the intelligence which planned and designed the Bible must have been Superhuman, Divine. That One Designer was a Supernatural, Master Designer. Only the Supreme, Omniscient, Omnipotent God could have caused such phenomenal numeric designs to occur beneath the surface of the Bible text. Only God could have constructed the Bible in the amazing manner in which it is constructed. The Eternal, Omnipotent Author designed, super-intended, worked, and carried out His Own infinite plans. There is no escape from this conclusion.

## CHAPTER SIX Two Supremely Important Questions Settled By The Newly Discovered Numerological signature:

**HE AMAZING NEWLY DISCOVERED FACTS** forever settle the following two important questions regarding the Bible.

Throughout the years there has been great controversy over the question whether the Bible is actually a supernatural God inspired book as it claims it is, or whether it is a book purely of human origin—the writings of men without any divine influence whatsoever. This question has now been definitely settled beyond all speculation, for the profound facts discovered beneath the surface of the original Bible text scientifically prove that the Bible could not possibly have been written by human beings alone, but that it is a supernatural, God given book. Any unbiased,

open-minded person who is willing to face the facts will agree to this. Thus the facts definitely settle this first question.

There is, however, another great question which has arisen in regard to the Bible. The newly discovered facts in an amazing and marvellous manner also definitely settle this question. Before it can be discussed, it is first necessary to inform or remind the reader of the following subject matter which has a direct bearing on the question to be considered.

#### THE ORIGINAL MANUSCRIPTS WHICH THE PROPHETS AND APOSTLES THEMSELVES WROTE, HAVE BEEN LOST

So far as is known, none of the original manuscripts are now in existence. It is certain, however, that God could have caused them to have been preserved if it were His will to do so. There seems to be a reason why these original manuscripts were not preserved.

### Why Did God Allow the Original Manuscripts To Disappear?

If the original manuscripts were available they might have been worshiped. Many human beings are ready to worship anything which lays any claim to sanctity. Bones and ashes of saints, splinters said to be from the cross upon which Christ hung, bits of linen cloth said to have been worn by Jesus, by the Virgin Mary, or by some venerated saint, nails from the crosses upon which martyrs hung, clothing, furniture, all these and more have been worshiped by many. In the book of II Kings 18:4 Hezekiah was commanded to destroy the brazen serpent made by Moses because it was worshiped. If the original handwriting of Moses, David, Paul, or other Bible writers should now exist, there would no doubt be many who would worship it, and thus detract from the worship of the invisible God.

Furthermore, the preservation of the original manuscripts was quite unnecessary for there exists such an abundance of good manuscript copies, ancient versions or translations, paraphrases, quotations, commentaries, harmonies, accounts, lists, etc.

Thus the Old Testament and New Testament manuscripts which are available today are ancient copies of the originals.

There are a number of important Hebrew manuscript copies which contain the complete Old Testament. In addition to these, there are partially complete, and fragmentary manuscripts which make a total of about 1,700. There are also about 350 copies of the ancient Septuagint version or translation, besides copies of many other translations of the Hebrew Old Testament.

There are more than 4,000 Greek manuscript copies of the New Testament. In addition to these there are about 8,000 manuscripts of the Latin Vulgate translation and at least 1,000 manuscripts of other ancient translations. Thus there are more than 13,000 manuscript copies of the whole or parts of the New Testament.

If every ancient manuscript copy and every modern printed copy of the New Testament were destroyed, the entire New Testament, with the exception of eleven verses could be reproduced from the thousands of quotations which are clearly found in the writings of the early Christians. During the first centuries, Christians in their writings quoted New Testament verses and passages so frequently that practically the entire Testament could be reproduced by merely referring to these writings.

The reader's attention is called to the fact that there are a number of passages in the New Testament which have been seriously disputed by scholars. An example of such a passage is the last twelve verses in the Gospel of Mark—Mark 16:9-20. The reader may be surprised to learn that this passage is not found in some of the ancient manuscript copies of the New Testament.

However, it is found in many of the other manuscript copies.

When preparing editions of the Greek New Testament and translations of it, scholars have had to decide which set of copies they would follow. Should they follow the ancient New Testament manuscript copies which include this particular passage or the copies which do not include it? Which set of copies is correct on this particular issue? A question of this kind naturally has caused great controversy. Some insist that the passage should be included while others contend the opposite. Those who reject the passage maintain that it is merely a passage which someone has written of his own initiative and has inserted or added to the God inspired manuscript. They naturally declare that such passages if they are foreign or new material should not be included in the inspired Bible as the very word of God, but should be marked or designated in some way as the writings of human origin, or eliminated altogether. Such passages are said to be `interpolations'-foreign or new material inserted into the original words of the Author.

There are twelve such passages in the New Testament which are said by some to be interpolations. The passages are found in some manuscripts, but not found in others. Which copies should translators follow? Which copies give the true and original text? Are the passages genuine portions of God's Word or are they man's addition to it?

If the original parchments upon which the apostles wrote their books were available, a question of this kind would not arise, for New Testament translators would have before them the apostles' original handwritten text. However, as it is, scholars can refer only to ancient copies of the original parchments—copies which disagree in regard to 12 passages in particular. They have had to decide which manuscripts give the true original text—the copies which contain certain passages, or the copies which do not contain them.

The newly discovered facts, in a marvelous and amazing manner, definitely settle the question over a disputed passage. This is the second great question which the newly discovered facts definitely settle—the question whether certain passages actually belong in the divinely inspired Bible or whether they are passages of human origin which someone has inserted into the inspired text.

An example is the passage which has already been mentioned, namely:

## THE BOOK OF MARK, CHAPTER SIXTEEN VERSES 9-20 The Last Twelve Verses Of Mark

Are the last twelve verses of Mark's Gospel a genuine portion of the divinely inspired Bible, or are they an `interpolation?'

This question has been disputed by many scholars throughout the years. Some of the best editors of the Greek New Testament consider that this passage of twelve verses is an `interpolation.' They honestly believe that it is foreign or new material which someone has added to the original, inspired Bible. Perhaps no other passage in the entire Bible has been disputed more than this one.

Some of the foremost editors of the Greek New Testament have treated the passage as follows: Weiss places these verses in the margin. Tregelles and Alford retain them, but not as a genuine portion of Mark. Tischendorff omits them altogether. The revisers of 1881 separate them from the rest of the Gospel by an unusual space.

Westcott and Hort, perhaps by far the best equipped and most nearly correct editors of the Greek New Testament, mark these verses in double brackets, designating that in their honest judgment the verses do not belong in the New Testament and are an `interpolation.'

This passage not only shows an amazing design as a whole but it shows designs within the design, and further designs within those. The separate paragraphs have designs of their own within the design. The vocabulary has its design, and the forms have theirs. It is marvellous indeed!

The above 23 amazing numeric facts or features are merely examples of those which occur beneath the surface of the 175 words in the last twelve verses of Mark. There are a hundred or more astounding features in the very structure of this passage. It is needless to weary the reader with further enumeration of the numeric phenomena.

According to the law of chances (calculation chart in the preceding chapter) there is only one chance in 27,368,747,340,080,916,343 that these 23 features of sevens could occur together in one passage accidentally. If the number is this high for merely 23 features, what chance would there be for 70 or 100 features to occur together accidentally?

Not only is there an abundance of numerical facts and designs hidden beneath the surface of the passage itself, but certain words in the passage are parts of elaborate designs which extend to many other books of the New Testament. For example, the word 'baptizo' (baptize) which occurs in these last twelve verses of Mark is part of a numeric design that runs through all the New Testament passages in which this word occurs. There are some 20 amazing features in the design through the word 'baptizo'—a design which is composed of widely separated occurrences of the word in different books of the Bible. If this particular passage were to be torn from the Scripture, there would be one less occurrence of this word 'baptizo,' and the entire New Testament design through this word would be utterly destroyed. Many other words in these last twelve verses of Mark are links in chains of features parts of designs which include other New Testament books. Without this passage the many elaborate numeric designs would be destroyed.

The demonstration is convincing enough. These numeric features did not occur in this passage by chance. They were designed to occur the way they do. Certainly the designs and features are beyond the ability of mere man to construct—they can only be attributed to God Himself. Thus the numerical facts discovered in the very structure of the passage definitely prove that it is not an `interpolation' of man, but that it is God's passage, and that it is entitled to its place in the divinely inspired Bible.

Thus, the numerical facts forever settle the question whether or not the passage is an interpolation.

It is true that these verses strangely disappeared from the two oldest manuscripts. How or why they disappeared we do not know. Some of the words are a strong condemnation of Satan. Could it be that he inspired someone to remove them—could it be that he sought to permanently banish them from the Scriptures? If such were the case it was merely an 'attempt' which failed, for it is now definitely known that these verses are a genuine portion of God's Word.

Various scholars have declared that the following passage is an interpolation.

#### THE ACCOUNT OF THE WOMAN TAKEN IN ADULTERY—John 7:53 to 8:11

This passage is not found in some of the ancient manuscript copies of the New Testament. Scholars, when preparing their Greek editions and translations of the New Testament, have had to decide which manuscripts to follow. Should they follow copies which include the verses, or copies which do not include them? Which of the many manuscript copies give the true original text?

If the original parchment upon which John wrote his Gospel were available, a question of this kind would not arise because scholars would have before them John's own handwritten text. However, as it is, there are only copies of the original parchments available—copies which vary or differ in that some contain the verses while others do not contain them.

Westcott and Hort had no doubt in their minds whatever that this story was not part of the original text. They and many other able scholars have believed that when we read this passage in our Bibles, we are not reading the Word of God, but a passage which someone has added to it.

Editors have rejected this passage from the New Testament with even greater assurance than the last twelve verses of Mark. Tregelles, who was a strictly orthodox editor of the New Testament, and who believed as firmly in the divine inspiration of the Scriptures as anyone, honestly confessed that the account of the woman taken in adultery was not part of the Word of God. Various other scholars, on the contrary, have earnestly contended that the passage is entitled to its place in the Bible.

Is this a genuine God inspired passage or is it a passage of human origin which someone has added to the inspired Bible?

Does the passage contain the divine numerical designs beneath the surface of its text? Yes-the passage is permeated with the same phenomenal numeric designs and features as are found in the structure of genuine God inspired passages. The profound numeric features and schemes found therein could not possibly have originated with man. We definitely know that this passage is divinely inspired and that it is not to be erased or excluded from the Bible, or even disfigured by brackets.

It is true these verses strangely disappeared from the oldest manuscripts. However, various other manuscripts contain them. How or why they disappeared we do not know.

The following passage, which is very brief, yet very important, has been disputed by scholars.

#### **CHRIST'S FIRST PRAYER FROM THE CROSS**

`Father, forgive them; for they know not what they do.'-Luke 23 :34.

Some manuscript copies of the New Testament contain the verse while others do not. Which manuscript copies are correct on this point? Does this prayer rightfully belong in the God inspired Bible, or is it an interpolation by man?

Certainly we would like to know whether or not Christ actually uttered that prayer. Matters and questions of this nature are of vital importance to all true Christians. How could an earnest and sincere Christian rest in peace until he knew for certain whether passages such as these are genuine portions of God's Word or whether they are interpolations which should be torn out of

the Bible?

Various editors consider that this brief prayer is an interpolation. However, it has now been discovered that the prayer is permeated with the same amazing numeric features found throughout genuinely inspired Bible passages. Thus, we have conclusive proof that this prayer is actually part of the inspired Bible—not an addition to it.

Christ uttered six other statements or cries from the cross. When this prayer is included, there are then exactly seven statements which Christ uttered from the cross.

#### CHRIST'S AGONY IN THE GARDEN Luke 22:44

This account, which tells that Christ agonized in the garden to such an extent that he sweat great drops of blood, has also been disputed. Is it a God inspired passage, or is it an interpolation?

The amazing numeric features contained in the very structure of the passage give sufficient and conclusive proof that the account did not originate with man, but that it is a divinely inspired passage, which rightfully belongs in the Bible.

In all, there are twelve such disputed passages in the New Testament which are definitely settled by these newly discovered facts.

## CHAPTER SEVEN. Other Important Questions Settled By The Numerological Pattern.

**T HAS BEEN SHOWN** in the preceding chapters that the newly discovered facts definitely settle two important questions-(1) the question whether the Bible is actually a God inspired book as it claims, or whether it is a mere human production, and (2) the question whether certain passages are genuine God inspired passages or whether they are mere human interpolations or additions to the inspired Bible.

But the amazing newly discovered numerical features do more than this—there are four other important questions which they definitely settle. Number (3) is:-

#### THE QUESTION CONCERNING THE TRUE READING OF CERTAIN PASSAGES

There are two reasons in particular why it has been difficult at times to determine the correct reading of some passages. One reason is that the words in the oldest Hebrew and Greek manuscripts have no spaces between them, and there is very little punctuation. The separation of Hebrew and Greek words in some cases is a matter of mere editorial opinion. Thus at times editors differ as to which is the correct reading or interpretation of a passage.

As an illustration, consider the following English words written without any spaces between them.

#### Otherwise men would do it. This could be read in either of two ways. Other wise men would do it. Otherwise, men would do it.

If the Bible had originally been written in English, and this sentence had been included in it without any spaces or punctuation, there might have been some lengthy theological discussions
#### The Book God Signed - Karl Sabiers

over the insertion or omission of a space between the words 'other' and 'wise.'

The following words written without spaces is another illustration.

#### God is nowhere This also could be read in either of two ways. God is nowhere. or God is now here.

If the Bible had originally been written in English and this sentence were to occur, some atheist would probably foolishly insist that the true reading should be `God is nowhere,' while the theologian would contend that the correct reading should be `God is now here.'

These illustrations in English help emphasize the fact that rendering the correct reading of a passage is indeed quite an important matter.

Thus one reason why it has been difficult at times to determine the correct reading of certain Bible passages is that there are no spaces between the words in the oldest Hebrew and Greek manuscripts. However, a far greater reason than this is that

#### THE MANUSCRIPT COPIES VARY OR DIFFER SLIGHTLY

It has been stated that the original parchments or manuscripts upon which the Prophets and Apostles wrote are not available, but that there is an abundance of good manuscript copies. The reader's attention is called to the fact that these copies give slightly different readings in some cases. These variations or different readings include such matters as differences in spelling, transposition of letters, words, and clauses, order of words, etc., which are the fault of the scribes or copyists. However, it must be remembered that **the doctrine of the Bible or the article of faith s not affected in the least by these slight variations and only in a very few places is the actual sense of passages affected.** 

Why do the manuscript copies differ slightly in wording, spelling, etc.?

When the reader considers the laborious task of copying manuscripts by hand—especially manuscripts as large as the Old or New Testament—he will agree that it would be very easy to make errors in copying. A letter, a syllable, or a word could easily be omitted. Likewise, they could easily be transposed. One word could be mistaken for a similar word—for example, `proelthon' for `proselthon.' Some letters are so similar they could be mistaken for another. Sometimes a change in a letter would mean a change in a word, especially in Hebrew. If the manuscripts were dictated, variations might be traced to the inaccurate or unalert hearing of the scribe, or to the poor pronunciation of the reader. Variations could also easily occur if the scribes carried long sentences or thoughts in their minds without referring to the manuscript from which they were copying.

Suppose someone should make a hand-written manuscript of say 100 pages. Suppose 100 people should make copies by hand. How many errors or variations would there be? It is not easy to get copying done these days without variations. Suppose the work were done in the uncial or capital Greek letters without any spaces between the words, even by one who was familiar with that language. How many variations would occur?

It is worth while to note the pronounced contrast between the manner in which the Old Testament was copied and manner in which the New Testament was copied.

The Hebrew Old Testament was copied by official and professional scribes who worked under strict and stringent rules regarding pen, ink, parchment, length of page, line, etc. The copyists zealously watched over every detail of their work and the manuscripts were handled with great care. The divisions, words, and letters were carefully counted and recorded. If even one slight error were discovered in their work the entire scroll was discarded and a new one was made. Prayer was offered and pens were wiped after a certain number of words. Thus the work of copying was ceremoniously and religiously done and it conformed to a definite high standard of quality. Because of this extreme care on the part of expert scribes, the many Hebrew Old Testament manuscript copies do not vary or differ greatly regarding the reading of certain verses. The Hebrew Old Testament copies have come down to us with comparatively few variant or different readings.

The books of the Greek New Testament were frequently copied without such care. A person in the early Christian church who desired a copy of the New Testament books or letter could hire a professional scribe to do the work if he could afford to do so. This would insure a high degree of accuracy. If he could not afford to do so he could employ a cheaper and less capable copyist, or else he could do the work himself. This would mean work poorly done, and a copy containing variant readings. Often he would be a poor copyist and would not be interested in small details. He would be after the substance of the salvation message, not necessarily the exact words and forms. Thus the many New Testament Greek manuscript copies differ or vary in regard to the exact wording of certain verses more frequently than the Hebrew Old Testament manuscript copies do.

Thus the manuscripts through careless copying are defective in some passages—they differ more or less one from another. These differences however, as already stated, are for the most part very slight and in no case affect a single doctrine of the Bible.

When scholars and translators have prepared editions of the Bible in its original languages or translations of it, they have not always followed one particular manuscript copy, but they have had before them many copies of the text which they followed at times. Hundreds of manuscripts have been carefully compared and examined—their testimony has been carefully ascertained and duly weighed. The comparison of these manuscripts shows a uniformity and proves a common source.

The King James or Authorized version of the Bible, which is the most popular and best loved edition, was translated in the year 1611 .At that time there were only about 2000 Greek copies of the New Testament text available for comparison, and they were not early copies, but were comparatively late in date. The 1611 translation was thus made from the Hebrew and Greek texts which were then available. However, since 1611 when this translation was made, scholars have found several thousand more manuscripts—some of which are better and are of earlier dates. Since the discovery of these better and earlier manuscripts, scholars saw that the wording of certain passages could be slightly changed. Thus in 1885 the well known Revised version was published. (The New Testament was completed and published in 1881. However it was not until 1885 that the revision of the Old Testament was completed.) Slight changes were made as to the wording of certain verses, etc. However, the meaning, the sense, and the doctrine of the Bible remained exactly the same.

In 1881 Dr. Westcott and Dr. Hort, two devout Christian men, published an edition of the Greek New Testament after they had spent 28 years carefully examining and comparing thousands of Greek New Testament manuscript copies, which as already stated differ or vary slightly in matters of spelling, order of words, transposition of words, clauses, etc. From all these Greek manuscript copies they gathered a text which scholars have considered to be one of the finest Greek New Testament texts ever printed. However, in their text they left numerous alternative readings. Each time they were not certain which one of two readings to follow, they placed one reading in the text and left the other in the margin as an alternative. The alternative reading could

be substituted for the one in the text.

Thus the many scholars who have devoted years to editing particularly the New Testament have found it difficult at times to determine the exact reading of passages where ancient manuscripts differ. They have had to decide which of the many manuscripts they would follow on certain readings. Some have insisted that a verse should read as it appears in one certain manuscript and others have contended that it should read as it is found in a different manuscript. Questions concerning the correct reading of passages have naturally caused a great deal of controversy and dispute.

It has been pointed out that at times it has been difficult to determine the true reading of passages for two reasons—because there are no spaces between the words in the oldest Hebrew and Greek manuscripts and because of the variant or different readings in the many manuscripts.

The newly discovered facts, in an amazing and marvellous manner, definitely settle the dispute and question concerning the true reading of any Bible passage. They provide a positive test whereby the true and original text of Scripture may be ascertained beyond the possibility of doubt. The following is an example of a disputed reading from the Old Testament.

#### BOOK OF ISAIAH, CHAPTER NINE, VERSE THREE

The American Revised Version follows certain manuscripts and gives the translation of the verse as follows:

'Thou hast multiplied the nations; thou hast increased their joy.'

The Authorized or King James Version follows other manuscripts and translates the verse in the following manner:

'Thou hast multiplied the nations, and not increased their joy.'

The American Revised Version tells that God **has** increased their joy, while the King James Version says that God **has not** increased their joy—a difference between yes and no. Which reading is correct?

In the Hebrew manuscript copies this is the difference of only one letter.

The newly discovered facts definitely settle the question. The Hebrew text of this passage which the Revised Version uses shows an elaborate design of numeric features. If even one letter of the verse is changed to another the entire numeric design fails. The Hebrew text of the passage from which the King James Version is translated shows no numerical design. Thus the newly discovered facts in the very structure of the passage definitely settle the question of the correct reading. They prove that the Revised Version gives the correct reading.

Some may think a question of this nature does not make much difference any way. They may feel that it is not a matter of great importance. But, suppose the question had been about the statement `He that believeth on the Son bath life' or `He that believeth on the Son bath not life.' This would have been a question of the utmost importance.

The following is an example of a disputed reading from the New Testament.

#### I CORINTHIANS, CHAPTER 13, VERSE 3

The amazing numerical design in the structure of the text also settles the correct reading of this

disputed passage.

The Revised Version follows certain Greek Manuscript copies and gives the translation of one particular phrase of the verse as follows:

#### 'If I give my body to be burned'

Westcott and Hort, in their Greek New Testament, follow other manuscripts and render the disputed portion differently. Instead of `if I give my body to be burned,' they use `**if I give my body so that I may glory.'** 

In the Greek this is a difference of only one letter. Which is the correct reading?

The newly discovered facts in a marvellous manner settle this question. The Greek text of the passage rendered by Westcott and Hort shows a beautiful and elaborate design of amazing numerical features. If even one letter is changed to another, the entire numeric scheme fails. But the Greek text of the passage from which the Revised Version is translated shows no numeric design. The newly discovered facts thus prove that Westcott and Hort give the correct reading of the passage.

#### WHAT IS THE LAST WORD OF THE BIBLE?

The Authorized or King James Version follows certain Greek manuscripts and gives the word `Amen' as the last word in the Bible. The Revised Version likewise concludes the Bible with this word. The Revisers do not even intimate that some authorities omit the word. Westcott and Hort in their Greek New Testament follow other Greek manuscripts and conclude the Testament with the word `saints.' Tischendorff, Alford, and other editors differ.

The amazing design of numeric features or facts discovered in the structure of the Greek text used by Westcott and Hort definitely settle the question concerning the correct reading of the last verse in the Bible. The numerical facts prove that they are right in ending the New Testament with the word `saints.'

#### THE TRUE READING OF BIBLE PASSAGES IS DETERMINED WITH REMARKABLE PRECISION AND ACCURACY

Readers will be amazed to learn that the perfect numeric designs which underlie the very structure of the original Bible text make it possible to detect any letter or word that may have been added, omitted, or transposed through the error of a copyist. The extraordinary mathematical designs in a profound manner determine the exact order of words, spelling, etc. Every question concerning the true reading of a passage—every single disputed matter, even to the slightest variation of text between manuscripts—is conclusively settled by the elaborate design of numerical features.

Just as an astronomer, who knows definite astronomical calculations and the position of various planets, can determine where and when certain other planets will appear, so one who knows definite numerical calculations of the Bible and the position of various letters, words, or books, can immediately determine where certain other letters, words, or books should occur.

#### **Place Values And Order Numbers**

The proper order of Bible words is determined by the numeric designs in the `place values' and `order numbers' of the words. It must be remembered that the `numeric values' of words are not affected or changed by their order in the text. Regardless of the order of the words the numeric values remain the same. Therefore the proper order of the words cannot be determined merely

by the designs in the numeric values. The separate numeric designs, however, in the place values and order numbers furnish methods of determining the correct order of words.

For example, various manuscripts differ as to the order of the names of our Lord. Some manuscript copies give the order as Jesus Christ' in certain passages, while other copies in the same particular passages give the order as 'Christ Jesus.' Which is correct? The proper order for each particular passage is definitely established by the numeric designs in the place values and order numbers of the words. The amazing numeric designs always give a definite and clear answer—the true order shows numeric designs and the false order does not. A change in order invariably destroys perfect designs in the place values and order numbers.

The correct spelling of words is determined by the designs in the order numbers. For example in a certain passage in some manuscripts the following words are spelled `Mariam' and `Daveid.' In the same passage in other manuscripts the words are spelled `Mary' and `David.' Which is the correct spelling? The elaborate numeric designs in the place values conclusively prove that `Mary' and `David' are the proper spellings of the words. It is also possible to determine whether a certain number of letters should form one large word or two smaller words.

Since there is no punctuation in the ancient manuscripts, it is sometimes difficult to determine whether certain sentences are intended to be in the form of commands or questions. Numeric designs in the place values even settle issues of this nature. They definitely settle the dispute as to the correct `interpretation' of any passage, and even long debated questions concerning the true authorship of certain books of the Bible. For example, numeric designs unquestionably prove that the Apostle Paul was the writer of the Epistle to the Hebrews.

It is remarkable also to note that a profound `cross-section' method—a system of multiplication—makes it possible to promptly detect and check on any errors which may have been made when determining the place and order of words in the vocabulary.

It is indeed marvellous to think of the many separate systems of designs which run through each letter and word. Not only is there a definite numeric scheme in the `numeric values' of each letter and word, but there are also separate designs in. the place values, values, and other numbers, of each letter and word. Each pattern or design serves its own particular purpose. In addition to these separate systems of designs there is the amazing `cross section' check on the vocabulary, and there are the many other numeric features and designs which permeate the text in every conceivable manner. It is marvellous indeed! All these systems together conclusively settle any question concerning the true reading of a passage.

One separate scheme or numeric design is convincing enough to demonstrate the divine inspiration of any passage, but when all these many separate systems of designs which run through each letter and word of a passage are combined, the argument is simply unshakeable. Every letter and word is so intricately intertwined and interlocked by these different systems of designs that it is simply impossible to move a letter or word either to the right or to the left without destroying the perfect patterns. The very order of every letter and word is definitely designed. Each letter and word has its own special place. Such perfect order—such complex systems of designs with their astonishing precision and accuracy, indeed could not have occurred accidentally. As an illustration, suppose that the sixty or sixty-five pieces of an alarm clock were placed in a box. One could shake that box year in and year out and those pieces would never go in their proper places accidentally. The perfect order and the complex numeric systems of the Bible cannot be attributed to chance, or even to human design—they can only be divine.

The Bible itself claims that divine inspiration extends not only to every sentence and every word, but even to the smallest letter and the smallest mark. In Matthew 5 :17, 18, when Jesus said that not one `jot' or one `title' would pass from the law till all be fulfilled, He referred to the

smallest letter (jot) and the smallest mark or point (title), thus indicating that even they were inspired.

The numerical facts demonstrate that the words, syllables, letters, and even every jot and title are numbered and have their own special, divinely appointed place in the text. God controlled the writers and placed every jot and title just where He wanted it. He controlled the spelling of every word and the number of its occurrences in the various Bible books. The Bible is scientifically proved to be divinely inspired, not in a loose or general way—not only in `thought,' but in actual word and letter. The Great Designer precisely planned the exact order of every word and letter, and every jot and title. Christ's significant statement `The Scripture cannot be broken' is proved to be true.

Numerical designs definitely settle the true reading of every Bible passage where the various manuscript copies differ slightly in the order of words, spelling, etc. The exact text which was originally written by the Prophets and Apostles has been reproduced and ascertained with absolute certainty. Every word, syllable; letter, and mark of God's Word has been restored to its original perfection and purity. The exact wording of every disputed passage is definitely settled by the mathematical designs, and by them alone—by designs which are strangely concealed beneath the very surface of the Bible text. Indeed God has protected and preserved His Word in a wonderful manner. It has come down to us with amazing perfection and purity—without a tinge or speck of corruption within or without.

When one considers the similarity of various letters and the difficulty of copying large manuscripts by hand, he will agree that the manuscript copies, irrespective of their slight variations, have been transmitted to us with marvellous accuracy.

In the Hebrew there are certain letters which appear very much alike. For example, the first letter in the Hebrew alphabet denotes one, and with two little points above it, it denotes a thousand. The twenty-second or last letter of the Hebrew alphabet denotes four hundred, but the fifth letter, which looks very much like it and could be easily mistaken for it, denotes five. A very slight error of the copyist would therefore make an utter change in meaning. The following letters could be easily confounded:

л — л	400 and 5
п — л	8 and 5
2 — 2	2 and 20
r — 1	3 and 50
ר — ד	4 and 200

Deuteronomy 6:4, if the Hebrew letter which has a value of 4 were changed to the very similar letter which has a numeric value of 200, the verse would read 'the Lord our God is a false Lord,' instead of the Lord our God is one Lord.' A change in these same letters in Exodus 34:14 would make that passage read, 'Thou shalt not worship the one true God.'

Since each letter stands for a number, it is clear that a change in even a single letter changes the numeric value of the entire

passage. The omission of or a change in a single letter, to say nothing of a whole word, at once destroys many features of a perfect numeric design. In fact the design as a whole is destroyed by the addition of one word. In one case all is harmony, and the elaborate scheme of sevens is seen at once, while in the other case, all is confusion if something foreign is introduced into the delicate numerical system mysteriously recorded in the Bible by the Holy Spirit.

The following is a striking illustration of the remarkable precision and accuracy made possible by the presence of the numerical facts in the very structure of the Bible text.

A certain Bible concordance prepared by C. F. Hudson, supervised by H. L. Hastings, and checked by Ezra Abbot, lists what were evidently thought to be all of the Bible references in which the word `Moses' occurs. According to the concordance the name appears in exactly 846 Bible references. This number of course is out of harmony with various numeric designs which run through the Bible. According to certain numeric designs the name would be expected to

occur a number of times which divides perfectly by seven. Of course 846 does not divide evenly by seven, but 847 does—it is 121 sevens. What is the trouble? Was one of the references omitted from the concordance?

Yes, a reference to Moses which that certain edition of the concordance does not list is found in the book of Hebrews. The scholarly gentlemen who prepared this concordance apparently overlooked this verse, but the error is detected by the designs of numerical facts which occur in the very structure of the Bible text.

It has been stated that the newly discovered facts definitely settle various important questions in regard to the Bible. Three of these questions have already been discussed. They are restated below and are included with an additional three.

#### SIX SUPREMELY IMPORTANT QUESTIONS NOW DEFINITELY SETTLED BY THE NEWLY DISCOVERED FACTS

It has been scientifically demonstrated in preceding chapters that the amazing numerical facts definitely settle the question whether the Bible is actually a God inspired book as it claims or whether it is a mere human production. It was shown that the amazing numerical structure of the Bible could not possibly have occurred accidentally but that it was designed, and the phenomenal design could not possibly have been planned and carried out by man, but is the word of God Himself. (Chapters 1-5)

The newly discovered facts definitely settle the question whether certain passages are genuine God inspired passages or whether they are mere human interpolations or additions to the inspired Bible. The disputes over passages such as Mark 16:9-20, John 7:53 to 8:11, are not forever settled. (Chapter 6)

The amazing numerical facts also definitely settle the question concerning the true reading of passages. The slightest variation of text between manuscript copies is detected by the design of numerical facts, and thus the correct reading is easily determined. The numerical facts not only make the Bible sure regarding its supernatural divine inspiration, but they settle the text and its meaning, such as Isaiah 9:5, I Cor. 13:3. They settle all disputes concerning matters of spelling, punctuation, order of letters, words, etc. (Chapter 7)

The newly discovered numerical facts definitely settle the question regarding the correct number of books the Bible should contain. The Roman and Greek Catholic Churches include in the Old Testament of their Bibles, 14 books known as the Apocrypha, which Protestants do not include. The books of the Apocrypha date from 300 B. C. to 100 A. D. With the exception of these books, the Roman and Greek Catholic Bibles are practically identical with the Protestant Bible. What is the correct number of Bible books?

There are many marvelous numeric designs which run through all of the 66 books of the Protestant Bible as a whole—patterns which bind these books into one great unit. If a single book is added or removed, certain elaborate numeric designs or chains which tie these books together are completely destroyed. Furthermore, there is no evidence of numerical features and designs in the very text of the Apocrypha. Thus the Bibles of the Roman and Greek Catholic Church, so far as the number of books is concerned, is proved to be incorrect against tampering with the divinely planned number of books.

The newly discovered facts also definitely settle the question concerning the correct order of the Bible books. The books of the English Bible are arranged in different order from that in which they are found in the Hebrew Received Text and the Greek Text. The order of the books as given in the original Hebrew and Greek is not accidental but divinely designed. A phenomenal numeric design runs through the order numbers of the books in such a peculiar and marvellous

manner that if the books are taken out of their proper order the particular numeric scheme fails. The numeric facts thus act as an automatic check against tampering with the divinely designed order of the 66 Bible books. This is a large and marvellous subject.

The amazing newly discovered facts even settle the long disputed question concerning the correct Chronology of the Bible. The exact dates of Bible events from the time of Adam are determined and definitely established, and are arranged in their proper sequence by the profound numeric designs in the structure of the text. The designs furnish data for an exact system of chronology in which the outstanding dates of Bible history divide perfectly by seven. This also is a great subject in itself. Volumes could be devoted to the relation of the numeric facts to Bible Chronology. The subject is so vast and comprehensive that no attempt is made to discuss it in this publication.

The writer, naturally, has not attempted to give a full or detailed account of the science of Bible Numerics, but has merely endeavoured to present a systematic account of the nature and scope of this newly discovered science. Many departments and phases of it, such as, place values, values, order numbers, higher numerics, number of books, order of books, chronology, and other comprehensive systems of designs, have been barely mentioned. Nevertheless, the reader may grasp the general idea.

The amazing numeric facts and designs in the structure of the original Bible text are indelible. They are impressed upon and interwoven in the text in such a peculiar and marvellous manner that no power on earth can blot them out. They are woven into God's Word as a thread is woven in a dollar bill to assure its genuineness. They are imprinted on the pages of Scripture as watermarks are imprinted in paper for verification and identification. They guard the Bible against errors and interpolations as the intricate designs on a bank note or check guard against counterfeits and interpolations. Indeed, God has stamped or marked His Word in a marvellous manner!

The many profound numeric designs in the structure of the Bible text are not only beyond the attainment of the Bible writers themselves, but no doubt the writers did not even know of the formation and presence of these elaborate patterns in the text. No doubt these men were so completely controlled by God's power and wisdom in writing His exact words that they were wholly unaware of the fact that every letter and word was being arranged according to a definite mathematical plan. No doubt the writers were unconscious of the fact that the Spirit was introducing, weaving, and mysteriously concealing beautiful patterns and intricately intertwined designs in the very structure of their writings. Even the Bible passages themselves appear to be wholly innocent of the slightest attempt at design—they read beautifully and naturally.

It has been demonstrated that the vast numerical structure of the Bible is a supernatural divine work. While it is utterly impossible for human beings to construct a book on such a marvellous mathematical design, it is only the normal work of God, the great Creator, Who has carefully placed

#### NUMBERS IN ALL OF NATURE

The number system of God is stamped upon all His works. All departments of nature are based on a system of mathematics—great mathematical laws govern the activities of the entire universe.

For instance, in the sphere of light, there are exactly seven colours. The seven colours merged together form light. In the sphere of music there are exactly seven whole tones in the scale, while every eighth note begins a new octave and is merely a repetition of the first note. The seven colours correspond to the seven notes in music, and sounds that harmonize correspond with colours that harmonize, while discords in colour correspond with discords in music.

The human body is completely renewed or changed every seven years. Every part of the body

is constantly throwing off old effete matter, and constantly receiving deposits of new and living matter. In seven years the whole structure is altered down to the minutest particles and becomes essentially a new body. In certain diseases, the seventh, fourteenth, and twenty-first are the critical days. Man's pulse beats slower every seventh day whether he is sick or well. In diseases resulting from physical exhaustion, the pulse changes every seventh day. With the human being the period of gestation is 280 days (7 x 40). Indeed, seven is stamped upon physiology. Is it not significant that God ordained every seventh day to be a day of rest, and that He declared man's years to be `Three score and ten.' (7 x 10)?

With animals, the period of gestation of the mouse is  $21(7 \times 3)$  days. The hare and rat 28 (7 x 4) days. The cat 56 (7 x 8) days. The dog 63 (7 x 9) days. The lion 98 (7 x 14) days. The sheep 147 (7 x 21) days. With birds, the incubation of the common hen is  $21(7 \times 3)$  days. The duck 28 (7 x 4) days.

God's mathematical laws are at work in all departments of nature. Sometimes one certain number is the dominant factor, then again another is the basic number.

The Creator's law of design for the snow flakes is the number six. All snowflakes are different, yet they are all alike with either six points or six sides.

The number eleven as well as seven is stamped on music. The number of vibrations in a second for each note is a multiple of eleven, and the difference in the number of vibrations between each note is also a multiple of eleven. For example, the difference between Do and Re is 33, between Fa and Sol 44, always a multiple of eleven.

The Science of Botany reveals that the different sections of flowers are arranged according to particular numbers and their multiples. For example the basic number of the buttercup is five. There are 5 sepals in the calyx, 5 petals in the corolla, 5 carpels in the pistil, 15, 20, 25, or some other number which is exactly so many fives of stamens in the androecium. Similarly, the basic number of the daffodil is 3, that of the mignonette 4, the wild rose 5. etc. Thus God stamps His creation with a mathematical pattern.

In Chemistry no two substances can unite without observing definite mathematical proportions. The planets of the heavens are governed according to mathematical laws. Indeed, nature does not operate by chance, but by design. God's number system is found throughout the universe much more extensively than is commonly supposed. Volumes could be devoted to showing design in nature. God is the Great Numberer and Mathematician of all creation. Every department of nature bears His mathematical signature.

#### *`He made the stars ... And God set them in the firmament of the heaven.'Gen. 1:16-17 `He counteth the number of the stars' Ps, 147.4 R. V. He `bringeth out their host by number' Isa. 40:26*

God `hath measured the waters in the hollow of His hand, and meted out the heaven with a span, and comprehended the dust of the earth in a measure, and weighed the mountains in scales, and the hills in a balance.' Isaiah 40:12

If God placed the stars in their proper order, and numbered them and measured the waters and weighed the mountains, is it surprising or incredible that He has placed the words and letters of His book in exact order, and numbered them, and guided them into combinations of numbers?

The same God Who created the universe and was careful to weave designs and intricate patterns into the smallest detail of creation, has taken the same care with His Word. He has placed the same peculiarity in both.

`The very hairs of your head are all numbered' (counted) Matthew 10:30.

The word `numbered' in Greek is `arithmeo' the very word from which our English word `Arithmetic' is derived. If God counts the very hairs of our heads, is it strange that He has counted the words and letters of His Scripture?

### CHAPTER EIGHT. Why Was This Numerological `Code' Not Discovered Until Recently?

**HE DISCOVERY** of thousands of numerical facts beneath the surface of the original Bible text has been the lifetime task of a single Individual—Dr. Ivan Panin,\* a famous Russian Scientist.

Among the thousands who have read the Hebrew and Greek text of the Bible, Ivan Panin was the very first to discover the amazing numerical facts which lie beneath the surface of the Scripture—the facts which scientifically prove that the Bible could not possibly have been written by human beings alone, but that it is a supernatural, God inspired, God given book.

## \*Ivan Panin died at Aldershot, Ontario, Canada, on October 30, 1942, shortly after this book was first published.

Today, after more than a half century if diligent and tedious labour on his phenomenal numerical discoveries, Mr. Panin, in his eighty-sixth year, presents an array of facts which astound the world. The original manuscripts of his work consist of approximately 40,000 pages. Upon these pages, many of which are now yellow with age, Mr. Panin has carefully and thoughtfully written millions of figures. The completion of his work has required persistent labour from 12 to 18 hours daily throughout the past fifty years.

Mr. Panin is of the same calibre as the famous Simon Newcomb and is without doubt the greatest mathematical genius since Newcomb's time. In discovering these thousands of numerical facts Mr. Panin has fulfilled a ministry and has accomplished a life work utterly different from that of any other human being who has ever lived. Indeed he has a place among the greatest and most famous men in the history of the world.

An individual whose life-work has been so outstanding as Mr. Panin's deserves an entire book devoted to his biography. However here in a few pages the writer has attempted to present some of the more important facts concerning this distinguished person and his work.

Mr. Panin was born in Russia, December 12, 1855. As a young man he was an active Nihilist and participated in plots against the Czar and his government. At an early age he was exiled from Russia. After spending a number of years in Germany furthering his education, he came to the United States. Soon after his arrival, Mr. Panin entered Harvard University. He was a personal friend of the famous Professor William James, and President Eliot of Harvard.

Mr. Panin is a brilliant scholar and a Master of Literary Criticism. After his college days he became an outstanding lecturer on the subject of literary criticism. He lectured on Carlyle, Emerson, Tolstoy, and on Russian literature, etc., being paid as high as \$200.00 for each address. His lectures were delivered in colleges and before exclusive literary clubs in many cities of the United States and Canada. During this time Mr. Panin became well known as a firm agnostic—so well known that when he discarded his agnosticism, and accepted the Christian faith the newspapers carried headlines telling of his conversion. Professor James, who was reputed to be the greatest Metaphysician of his time, remarked, 'What a pity that Mr. Panin is cracked on religion. A great philosopher was spoiled in him.' Prior to his conversion Mr. Panin wrote some three thousand aphorisms and many remarkable essays, which are indeed a memorial to his days as a Master of Literary Criticism. Mr. Panin was also an editor of two daily

newspapers. He is a gifted writer and a brilliant and eloquent speaker.

#### HOW AND WHEN DID MR. PANIN DISCOVER THE FIRST OF THESE NUMERICAL FACTS?

It has already been stated that Mr. Panin has devoted more than a half century to the discovery of these amazing numerical facts. To be exact, it was in the year 1890 that Mr. Panin made the discovery that a phenomenal mathematical structure underlay the text and vocabulary of the Greek New Testament.

Mr. Panin was casually reading the first verse of the Gospel of John in the Greek—`In the beginning was the Word, and the Word was with (the) God, and the Word was God.' The question came to his mind, `Why does the Greek word for 'the' precede the word `God' in one case, but not in the other?'

Therefore in one column he made a list of all the New Testament passages in which the word `God' occur with the article `the,' and in another column he made a list of all the passages in which the word `God' occurs without the article. On comparing the two sums he was struck with the numeric relation between them. He then followed the same procedure on the word `Christ' and on other words, and found amazing numeric facts. This was the beginning of the profound numerical discoveries which are now called the Science of Bible Numerics. Mr. Panin has used the Greek text of Westcott and Hort as a basis for most of his work. However, he has not wholly confined himself to that text.

Since discovering the first features in 1890 Mr. Panin has earnestly devoted his entire life to one definite and specific purpose. For the past half century he has toiled faithfully and tirelessly with undaunted perseverance. He has devoted himself so persistently to counting letters and words, figuring numeric values, making concordances, and working out mathematical problems, that on several occasions his health completely failed. Regardless of the tremendous mental and physical strain he has laboured faithfully and diligently for the past fifty years.

Mr. Panin has permitted nothing to hinder him from fulfilling his life work. At one time he was offered a very tempting position as president of a college. However, he rejected the offer. He chose rather to devote his life to discovering numerical facts and demonstrating the divine inspiration of the Bible. Since 1890 Mr. Panin has trusted God to provide for him. Some think it strange he should have discontinued his seemingly profitable lecture work as a Master of Literary Criticism at \$200.00 a night, for the purpose of counting Bible numbers, letters, syllables, words, etc.

This distinguished person is a man of extraordinary resources in scholarship. He is keen-minded and alert and possesses amazing analytical and dissecting ability. He is eminently open and scientific. He assumes nothing, but bases all on observed facts—facts of a positive, irrefutable, unparalleled sort. He pursues his way with calmness and is positive of the ground he covers. He is a complete master of himself and of the facts at his command.

Mr. Panin is an ardent and devout Christian—a 'born again' child of God. His pleasing personality radiates the abiding presence of the Christ within. This refined gentleman and his lovely wife live quiet, humble lives on a small Canadian farm, far removed from the busy city activities. Mr. Panin is very modest and conservative. He prefers to be called Mr. Panin rather than Dr. Panin, and is reluctant about publicizing facts concerning his own life story. He points out that the Apostles left little or no life stories of themselves, but exalted Christ instead. Incidentally Mr. Panin is a citizen of the United States.

#### THE EXTENT OF MR. PANIN'S OUTSTANDING LIFE WORK

It was necessary for Mr. Panin to prepare and construct special `tools' before he could begin the actual work of discovering the thousands of numerical facts in the structure of the Bible. He has had to construct concordances, vocabularies and other analyses of the Bible which require the utmost accuracy to the slightest detail.

His specially prepared concordance of the Greek New Testament words consists of a thousand pages and contains every one of the 137,903 occurrences of the New Testament Greek words. The words are arranged in alphabetical order and all the references of the chapters and verses are neatly listed directly under each word. Of course certain words occur hundreds of times throughout the New Testament, yet each occurrence is listed in the concordance. The best Greek concordances in print were not complete enough or accurate enough for Mr. Panin's work, therefore it was necessary for him to construct a concordance of his own.

Mr. Panin's specially prepared concordance for the forms of the New Testament Greek words is a manuscript which contains more than 2,000 pages. It is constructed on the same plan as the first concordance, and contains about twice as much material.

The construction of these two manuscripts, needless to say, was no small task. More than six years of tedious and continuous labour were required to complete them. But this is not all—Mr. Panin has prepared special books for the vocabulary words of the Greek New Testament. It is strictly a scientific vocabulary. Each New Testament word is listed and there are sixteen columns of numeric data for each word. Four columns containing the order number, place value, numeric value, value, precede each word. Behind each word there are twelve columns containing the number of occurrences, number of forms, syllables, letters, writers, books, diphthongs, etc. The completion of the vocabulary required more than two years of strenuous labour. In some of his work Mr. Panin has marked certain words in green, red, blue, and purple ink. Each colour bears some particular significance.

All this work was merely the preparation of some `tools' which were necessary before Mr. Panin could begin the actual work of discovering countless thousands of numerical facts. Since the work was begun, Mr. Panin has accumulated some 40,000 pages of material on which he has made calculations, worked out mathematical problems, and recorded numerical facts. Upon these pages he has thoughtfully and prayerfully written millions of small and neat appearing figures. His work constitutes volumes and his discoveries are seemingly without end. Throughout the past fifty years Mr. Panin has been earnestly devoting from twelve to eighteen hours daily exploring the vast numerical structure of the Bible. The mental and physical toil involved has been tremendous.

It is noteworthy that Mr. Panin has not done his work for `pay' neither has he `paid' anyone to assist him. During these years he has needed a capable secretary and persons to assist him in other departments of his enterprise. However he has felt that this type of work could not be truly done for a `salary'. He has needed volunteers—persons with a God-given devotion to the work—dozens of vigorous, resourceful young men with enthusiasm for the cause, not persons who require salaries. For many years when Mr. Panin first began his work he hoped and prayed for even a small number of persons who would stand by him and assist him in his God given work but it seems many had no time, others were not interested, etc., so he had to go on alone. For many years he toiled, sometimes cheerlessly and sadly, but his labour was not in vain. Finally he triumphed over every obstacle and hardship. After more than a half century of continuous labour and undaunted perseverance he was able to see the task completed, and today as a result of his faithfulness and courage, he presents an array of facts which astound the world.

The fact that Mr. Panin has been able to accomplish this immense task single handed is indeed

a testimony to his diligence. The writer knows of no other example of perseverance and diligence anywhere in history which equals or even compares to the fifty years continuous labour of this one man. Indeed Mr. Panin is an intellectual giant and a prodigious worker.

Mr. Panin's specially prepared concordances, vocabularies, and many of the pages of other numeric data are now turning yellow with age.

prehensive accomplishment. To say that it is extraordinary indeed is not sufficient!

Two outstanding results of Mr. Panin's lifetime labour are his

#### NUMERIC GREEK NEW TESTAMENT and NUMERIC ENGLISH NEW TESTA-MENT

Both volumes are commendable and scholarly pieces of work. The 'Numeric Greek New Testament' is a complete Greek Testament without any alternative readings. The text was established by means of the newly discovered numeric designs which pervade the Scripture. Mr. Panin has settled every one of the alternative readings left by Wescott and Hort in their Greek text of the New Testament. He presents a pure and accurate Greek text—an indisputable text which is exactly the same as that of the original manuscripts which the Apostles wrote by the inspiration of God. It is the first Greek New Testament published which has its text based upon the newly discovered numerical structure of the Bible—a remarkable piece of work indeed! It is a volume of 514 pages, printed at the Oxford University Press.

The 'Numeric English New Testament' is Mr. Panin's translation of his Greek New Testament. The chief aim of his English translation, next to that of furnishing a pure text, is to place the reader, as far as possible, on the same footing with the Greek. It is indeed a superb piece of English, yet it follows the Greek text very closely and gives as literal a rendering of the original as possible. Mr. Panin's many years of study and careful examination of every jot and tittle of the original Bible text, and his ability as an outstanding literary man, make him a fit and well equipped editor. His New Testament is unquestionably the finest and most accurate translation into English. It is one of the latest translations published, and is the only one which has its text based upon the newly discovered numerical structure of the Scripture. Students of the Bible are not doing their work justice unless they study this splendid edition. It is truly a beautiful translation, a volume of 610 pages in clear and readable type, printed at the Oxford University Press and published by The Book Society of Canada.

Some have thoughtlessly attempted to verify Mr. Panin's work by counting letters and words in their English King James translation or in some other translation of the Bible. The same features which Mr. Panin has discovered in the Hebrew and Greek text of the Bible could not be expected to be found in translations of that text. This is easily understood. For example, the Greek sentence 'Edakrusen 'o lesous' is a sentence of three Greek words, but translated into English it is a sentence of only two words—'Jesus wept.' There are sixteen letters in the Greek word' lçóïýò but only five letters in its English translation—'Jesus.' Furthermore, the letters of the English alphabet do not have numeric values as the Hebrew and Greek letters have. Also words of one language are not simply transliterated in other languages. An example is the word 'Venice.' This is the English spelling. But the French is 'Venise; 'the German is 'Venedig;'while the Italian is 'Venezia.'

The numeric features which Mr. Panin has discovered are not based on the letters and words of any English translation or any other translation of the Bible. They are based entirely on the letters and words of the Hebrew and Greek in which the Bible was originally written. Thus it is easily understood that it is difficult for many readers to verify a great number of Mr. Panin's statements.

For the benefit of scholarly readers Mr. Panin has printed special monographs in which he has given the Greek texts of numerous Bible passages. In the monographs he has included the vocabularies and many other details of original numeric data which pertain to the various texts. These charts and tables of calculations were made available so no one could say it was impossible to check Mr Panin's findings. The original numeric data has enabled any scholar to easily verify for himself every statement Mr. Panin has made in the monographs. Throughout

the years, Mr. Panin has sent these printed copies of numeric data to scholars whom the material especially concerns. To the best of his ability he has seen to it that none remain in ignorance of his discoveries.

At one time, a number of years ago, Mr. Panin sent some of his numeric material with vocabularies and other details to nine rationalists, whom he respectfully and publicly invited to refute him. He challenged Dr. Charles W. Eliot, President of Harvard University; Professor J. Henry Thayer, also of Harvard; Dr. W. R. Harper, President of the University of Chicago; Dr. Minot J. Savage, and others, saying in print, 'Gentlemen, will you kindly refute my facts; will you refute the conclusions?'

Mr. Panin received several replies. One was not `interested' in his `arithmetical' facts, two `regretted' that they `had no time' to give heed thereto. Another `did not mean to be unkind, but ...' The others were silent.

A number of years ago some of Mr. Panin's numeric material appeared in a Sunday edition of the 'New York Sun. 'The following is a quotation:

'Now there are three ways, but three ways only, in which to refute my argument:

(1) By showing that it is possible for two books to be written each after the other; that it is possible for eight men (the eight New Testament Writers) to write in turn each after the other seven; that it is possible for 27 books (of the New Testament) to be written each in its turn last; that it is possible for some 537 pages (of the Westcott and Hort Greek New Testament Text) to be written each in its turn last! (Chapter 5, number 3.)

(2) My argument can also be refuted by showing that the facts I present are not facts; that the Greek Alpha does not stand for one, Beta for two, Gamma for three, and so on; that the additions I make are not additions; in short, that the numerics I presented to the readers of the Sun are delusions, figments, fabrications, frauds—miserable cheats, in short.

(3) Lastly, my argument can also be refuted by showing that even though my facts be true, my arithmetic faultless, and my collocation of numerics honest, that men could have written thus without inspiration from above.

'No sane man will try to refute me by the first method. To refute me by the second method I herewith respectfully invite any or all of the following to prove that my facts are not facts: namely Messrs. Lyman Abbott, Washington Gladden, Herber Newton, Minot J. Savage, Presidents Eliot of Harvard, White of Cornell, and Harper of the University of Chicago, Professor J. Henry Thayer of Harvard, and Dr. Briggs, and any other prominent higher critic so called. They may associate with themselves, if they choose, all the contributors to the ninth edition of the Encyclopaedia Britannica who wrote its articles on Biblical subjects, together with a dozen mathematicians of the calibre of Professor Simon Newcomb. The heavier the calibre of either scholar or mathematician, the more satisfactory to me.

`They will find that my facts are facts. And since they are facts, I am ready to take them to any three prominent lawyers, or, better still, to any judge of the superior or supreme court, and abide by his decision as to whether the conclusion is not necessary that Inspiration alone can account for the facts, if they are facts.

`All I should ask would be that the judge treat the case as he would any other case that comes before him: declining to admit matters for discussion as irrelevant when they are irrelevant; and listening patiently to both sides, as he does in any trial.'

No attempt has been made to deal with Mr. Panin's undeniable facts or with the unavoidable

conclusion. A destructive critic can do nothing in the way of refuting these facts—all he can do is ignore them. Are Mr. Panin's figures wrong? If so, where are they wrong? If they are not, then the inferences are indisputable. One cannot argue with mathematics.

#### WHY WERE THE NUMERICAL FACTS NOT DISCOVERED UNTIL RECENTLY?

There seems to be a reason why the thousands of mysteriously hidden numeric facts remained concealed for so many centuries before they were finally revealed. The discovery of these facts was no doubt withheld until this very day and age, because the Holy Spirit of God, Who caused these features to be so arranged in the structure of the Bible, foresaw that the greatest attacks ever waged against the Bible would occur in the age in which we live.

The fiercest attacks ever made against the Bible were begun a number of years ago when the forces of modernism and destructive higher criticism began their cunning internal attacks. Never before in the history of the church has the Bible been torn to pieces by those who profess to be ministers and teachers and lovers of it. Previous to these latter days, only atheists and sceptics boldly denounced and ridiculed the Bible, but recently modernists who stand behind sacred pulpits denounce and ridicule the very book they are being well paid to teach. Today so called 'Christians' are attacking the Bible, whereas it ought to be defended by everyone who calls himself a Christian. If people were as inconsistent as that in business, they would be dismissed from their positions immediately. Higher critics and so called scientific thinkers in supposed 'Christian' colleges and seminaries disgracefully attempt to reduce the Bible to nothing more than a collection of human writings which are filled with inaccuracies and contradictions and the vagaries of the human imagination. This attack against the Bible has come from within the Church itself, and as a result many mere `church members' have been deceived into substituting modernism for godly old-fashioned fundamentalism. The present Bible-attack is against the entire foundation of the Christian faith-the divine inspiration of the Scriptures-and is indeed the most cunning and severe attack in the history of the Church.

It is marvellous to know that the Bible is gloriously withstanding this latest attempt to destroy it, as it has withstood all other attempts on the part of its enemies in the past.

The amazing scientific facts in the very structure of the Bible itself were no doubt intended to be revealed as a surprise weapon of combat for the final crisis. The Holy Spirit, Who caused these numerical features to be so arranged in the under structure of the Bible, evidently foresaw that there would come a day when destructive critics and modernists would tamper with His book, and would attempt to discredit it. He no doubt foresaw that there would come a day when organized Atheism and other `isms' would do their utmost to overthrow the Bible. Therefore He placed these series of divine marks in the very structure of the text to provide indisputable proof of its divine origin, and to insure its purity. He hid them in a mysterious way, and caused them to remain concealed until a set time—this particular time in the history of the Church when among many, respect for the Bible is gone—the very time when such evidence is most needed.

Modernists and higher critics began their destructive work many years ago. However, it has been only during the past fifty years that their work has progressed rapidly and has been seriously felt. Is it not strange that at that very time—50 years ago—the divine numeric structure of the Bible was discovered? Is it not strange that the Science of Bible Numerics appears in an age of Science?

Is it not strange that at the very time when organized Atheism was first making its plans to overthrow and control Russia, God was preparing a Russian to discover thousands of numerical facts—facts which would scientifically prove the supernatural origin and character of the Bible—facts which would shatter all the arguments of Atheists, Modernists and Higher Critics? Perhaps no country has been so anti-God, anti-Christian, and anti-Bible as modern day Russia.

Is it not remarkable to think that God saw fit to send a man out of that very country, and convert him, and equip him with the ability to discover the divine numerical structure of the Bible? Certainly these newly discovered irrefutable facts are God's answer to Atheism, Higher Criticism, and Modernism.

Indeed, 'God moves in mysterious ways His wonders to perform.'

#### TWO THINGS FOR EVERY READER TO REMEMBER

(1) The scientific demonstration is convincing to all those who are willing to see.

(2) The demonstration will be opposed by some—by those who deliberately refuse to see.

(1) Mr. Panin's extraordinary Bible proof is not based on mere theories and convincing phraseology, but upon positive facts—facts which are presented according to the inexorable laws of logic. If a person will but open his eyes and acquaint himself with the facts—if he is willing to listen to reason—he is simply compelled to admit that Mr. Panin's facts prove that the Bible is not a human book, but a supernatural God breathed book. Mr. Panin presents an amazing proof—an actual demonstration according to the law of design, so simple that any school boy can easily understand it. The supernatural origin and character of the Bible are now convincingly and scientifically demonstrated to the complete satisfaction of any unbiased, open minded person.

(2) However, the fact that such an amazing scientific proof is available does not necessarily mean that all the atheists and infidels and higher critics of the world will now accept the Bible as a God given book—verbally inspired or breathed of God.

`The god of this world (Satan) hath blinded the minds of them that believe not, lest the light of the glorious gospel of Christ, who is the image of God, should shine unto them.'—II Cor. 4:4.

`The natural man receiveth not the things of the Spirit of God: for they are foolishness unto him; neither can he know them, because they are spiritually discerned.'—I Cor. 2:14.

`This is the condemnation, that light is come into the world, and men love darkness rather than light, because their deeds are evil.'—John 3:19.

Readers should not be unduly alarmed or surprised when they find some who oppose this scientific demonstration. The Bible does not teach that all will accept the Scriptures and that all will be saved. The actual demonstration is convincing to every candid, open minded person—to everyone who is willing to `see' and believe. However, there are always some who deliberately refuse to see and believe regardless of how much convincing evidence is presented. Mr. Panin has given the facts to unbelievers, but the eyes for seeing them, only God can give. The scientific demonstration can never convince those who deliberately close their eyes to the truth and simply refuse to look. The fact that some do not want to be convinced is no argument against this amazing proof, for the irrefutable facts remain unaltered in the structure of the Scripture regardless of the opinion or attitude of unbelievers. Those who accept this demonstration are utterly helpless when they come to those who are not willing to listen. Persons who deliberately ignore the facts are in a pitiful state of affairs. Reason and logic mean nothing to them—they commit `intellectual suicide.'

Readers should not be surprised or alarmed to find the amazing scientific demonstration subject to criticism and attack. Disbelievers in this proof of divine inspiration may not be satisfied with merely refusing to see for themselves, but they may even go so far as to attempt to influence others against it. The proof is supremely important—and is bold and positive—it has vital

bearing and effect upon every human being. Naturally open opposition to such proof can be expected. It must be remembered that it is Satan's business to foster doubt and unbelief. He has been busy causing mankind to question God's word since the beginning when he said, 'Yea, hath God said?' Genesis 3:1. Satan always has fought and opposed every truth, every plan, and every action of God. We must be prepared to recognize the devil's work when it appears, and then say 'Amen' to God's true Word. 'All Scripture is given by inspiration of God.'—II Timothy 3:16. 'Yea, let God be true, but every man a liar.'—Romans 3:4.

If the Bible itself is hated, misquoted, misrepresented, falsely accused, criticized and attacked, is it surprising that any proof of the Bible should escape false accusation and criticism? Throughout the centuries the Bible has been misrepresented and falsely accused, yet this has not affected the character of the Bible itself. The Scripture stands as pure and as spotless as ever. No one has discovered a single contradiction in it, or established a case against it. However, the false accusations have deceived some, and have caused some to reject the Bible. Any proof of the Bible is subject to the same misrepresentation and false accusation. The proof itself remains untouched, its truth remains unaltered. However the false accusations may deceive some, and may cause some to reject the proof.

Those who disbelieve this demonstration may openly `call' it a fraud, a lie, or a fake. It must be remembered, however, that these words have never yet established a single fact. Such words are not mentioned in books on logic as powerful and convincing `methods' of demonstration and proof. Masters of thought throughout the ages have considered such terms as non-essentials in logical argument. Merely 'calling' something a fake or a fraud proves nothing. Likewise, mere opinions or theories of men expressed in apparently convincing phraseology prove nothing. Opinions are opinions and facts are facts. If the so-called facts are not facts they can be disproved without difficulty. If they are facts we must answer to God for ignoring them.

Some critics may propound and rely on `irrelevant' answers—answers which appear to have a vital bearing on the subject, but in reality are only beside the point. Such a `non-sequitur' is not sufficient to prove anything. Persons may originate irrelevant answers through their own misunderstanding, unfamiliarity or ignorance of the subject. One can easily blunder by basing his arguments on false premises.

If one were to find a few features of sevens scattered here and there in the text of some writing outside the Bible, this would not be sufficient to disprove the scientific demonstration of the Bible. A feature may occur accidentally here and there in some other writing but the phenomena of the hundreds of features in a single Bible text, and the phenomena of the seemingly endless chains of intricate features which run through all of the sixty-six Bible books (like that of the word `Moses' for example, Chapter 4), could never be reproduced in any human writing. The phenomena of the order numbers of the words, and the phenomena of the cross-section-check on the vocabulary and the hundreds of other systems of features which intertwine all of the sixty-six books could never be reproduced in any human writing.

Any who might feel inclined to criticize or condemn Mr. Panin's results should realize that his work was not hurriedly or lightly done in a few months' time, but was accomplished in a period which extended over 50 years. He is an expert and is the pioneer in his particular field of work. He is acquainted with the voluminous facts of his discoveries as no other person is. Therefore a thoughtful person will `think twice' and will carefully consider the matter before he seeks to hastily criticize or to quickly pass judgment upon the result of the 50 years' diligent painstaking labour of an expert.

What man, after spending merely days or weeks or months of investigation, is capable of criticizing Mr. Panin's fifty years' labour? If great scholars have not attempted to disprove Mr. Panin's accuracy, should anyone with lack of evidence feel justified in attempting to condemn his lifetime discoveries?

Because in proving the great truth of the divine inspiration of the Bible they place upon each of us a certain responsibility—a responsibility which cannot be avoided.

If we gain knowledge that the Bible is a supernatural, God inspired book—the very Word of God Himself—a strange thing happens. Knowledge of this great truth never leaves us where it finds us—we never remain as we were before. Such knowledge **bestows a privilege, it opens an opportunity, it creates a responsibility to examine and heed the instructions God has given us in His Word.** 

Once we know that the Bible is God's Word the issue can never end at that point. Merely acknowledging that the Bible is divine is not sufficient. If we are to be consistent and honest with ourselves we must continue one step farther—we must learn and accept what God has to say concerning us in His Word. If the Bible were a mere human production we would be under no obligation to give any special attention to it. However, inasmuch as it is divine we cannot justly disregard its contents and we cannot casually lay it aside saying that it has no special relationship to us.

It is our duty to know, believe, and obey the instructions God has given in His Word.

The Bible gives God's message to all humanity. It tells us the purpose for which the Scriptures were written. It tells us why some cannot understand the Bible. It tells why some do not think as the Bible teaches. It tells why some dislike the Bible and why some condemn its teaching. Most important of all is the fact that it gives a perfect picture and description of ourselves—it enables us to see ourselves as we really are and it enables us to know of our future.

When the Bible makes a statement, every word of that statement can be relied upon as true. Being of divine origin, it speaks with sovereign authority. It speaks without apology. The teachings of the Bible are not complicated and difficult to understand, for the Author of the Book, the Holy Spirit of God, promises that all who humbly come to its pages will be guided and enlightened in understanding its teachings.

There are various Bible statements which vitally concern our eternal well-being. Let us examine these statements in a spirit of honesty and truth.

#### Many have asked the question. - Why Was The Bible Written?

God clearly states His purpose in giving the Bible to mankind. 'Written that ye might believe that Jesus is the Christ, the Son of God; and that believing ye might have life through his name.' John 20:31.

From this verse of Scripture we learn that `life' is obtained through believing in Jesus Christ. `that believing (in Jesus Christ) ye might have life through his name.'

We shall learn that the `life' mentioned in this passage is not `physical life, 'but` spiritual life. 'The fact that we have physical life does not necessarily mean that we also have spiritual life for the Scripture bears out the strange truth that individuals maybe alive physically and yet be `dead' spiritually.

#### `dead in your sins'—Col. 2:13 `dead in trespasses and sins'—Eph. 2:1 `dead in sins,'—Eph. 2:5 `dead while she liveth'—1 Tim. 5:6

#### By nature we are `dead' spiritually

'Wherefore, as by one man sin entered into the world, and death by sin; and so death passed upon all men'—Rom. 5:12; II Cor. 5:14

#### By nature we are 'sinners.'

`all have sinned'—Rom. 5 :12

`all (are) under sin'—Rom. 3:9

`all have sinned and come short of the glory of God.'—Rom. 3:23 `the scripture hath concluded all under sin'—Gal. 3:22

`there is no man that sinneth not'—I Kings 8:46

`there is not a just man upon the earth, that doeth good, and sinneth not.'-Ecc. 7:20

`There is none righteous, no, not one.'—Rom. 3:10

'If we say we have no sin we deceive ourselves.'-I John 1:8

'If we say we have not sinned, we make him (Christ) a liar.'—I John 1:10

Sin is a sad and terrible reality. This fact is proved not only by the teaching of Scripture but also by the testimony of all mankind. All have been hounded by remorse of conscience for wrongdoing.

#### By nature we are `lost'

We are `guilty before God.'—Rom. 3:19 We are `condemned already.'—John 3:18 As sinners we are `unjust' in God's sight—I Peter 3:18 ('There is not a just man upon the earth'—Ecc. 7:20. `There is none righteous, no not one.'—Rom. 3:10) Our hearts are `not right in the sight of God.'—Acts 8:21; Ps. 78:37 Our hearts are `deceitful ... and desperately wicked'—Mt. 15:19 By nature we are `sold under sin'—Rom.7:14; Is. 52:3 We are the `servants of sin'—Rom. 6:17; Jn. 8:34 We are `holden (bound or held captive) by the cords of sin.'—Prov. 5 :22 As sinners we are abiding in `darkness'—I Pet. 2:9; Eph. 5:8 Sins `have separated' us from God. There is no communion or fellowship with Him.—Is. 59:2 By nature we are `far off from God—Eph. 2:13 and are `lost'—Lu. 19:10 We are `without Christ,... having no hope.' We are `without God in the world.'—Eph. 2:12

By nature we are helpless and hopeless sinners. We are dead spiritually and are guilty and unjust before God. We are separated or alienated from God and have no communion or fellowship with Him. We are lost `having no hope.'

It is a precious truth to know that irrespective of our state and condition by nature

#### God loves us.

`God commendeth his love toward us,...while we were yet sinners.'—Rom. 5:8 `Herein is love, not that we loved God, but that **He loved us.**'—I John 4:10

`In this was manifest **the love of God toward us**, because that God sent His only begotten Son into the world that we might live through him.'—I John 4:9

`**For God so loved the world**, that he gave his only begotten Son, that whosoever believeth in him should not perish, but have everlasting life.'—John 3:16

'Behold, what **manner of love** the Father hath bestowed **upon us**, that we should be called the sons of God.'—I John 3:1

#### For What Purpose Did The Son Of God Come To This Earth?

Christ came to accomplish a definite work. He came to provide `salvation' for sinners.

'Jesus Christ came into the world to **save sinners.**' I Tim. 1:15 Christ `is come to **seek and to save** that which is lost.'—Lu.19:10; Mt. 11:18

'God sent ... his Son into the world ... that the world through him might be **saved.**' Jn. 3:17; Jn. 12:47

The Father sent the Son to be the **Saviour** of the world.'—I Jn. 4:14

Christ came `to make **reconciliation for the sins** of the people.'—Heb.2:17

`God ... sent his Son to be the **propitiation** for our sins.'—I Jn. 4:10 `He was manifested to take away our sins.'—I Jn. 3:5

'I am come that they might have **life.'**—Jn. 10:10

'God sent his only begotten Son into the world that we might live through him.'—I Jn. 4:9

#### By Coming To This Earth How Did Christ Make It Possible For Sinners To Be `Saved?'

How did He accomplish the work which He came to do?

The Son of God did not accomplish this great work by coming to this earth to be a `good example' or a `great religious teacher.' Neither did He accomplish this work by giving the world `noble philosophical principles.' There is a far deeper meaning involved than this.

Christ, the sinless Son of God, as `a lamb without spot or blemish' gave Himself on the cross as a sacrifice for sin. He, the innocent party, became the sin bearer for the guilty.

#### (I) By Hs Death on the Cross Christ became our Saviour

'His own self bare our sins in his own body on the tree (cross)'—I Peter 2:24

'He (God) hath made Him (Christ) **to be sin for us**.'—I Cor. 5:21 '**The Lord (God) hath laid on Him (Christ)** the iniquity of us all.'—Is 53:6 'Christ **died for the ungodly**.'—Rom. 5 :6 'While we were yet **sinners** Christ **died for us**.' Rom. 5:8

Christ hath once suffered for sins, the **just (Christ)** for the **unjust (sinners)**'—I Pet. 3:18. Also Tit. 2:14, Gal. 1:4, 1 Cor 15:3, I Cor. 5:21, I John 3:16

#### (II) By Hs Death on the Cross Christ Shed His Blood For Us

(a) Through the shed blood of Christ —We are `redeemed'

'Thou (Christ) was slain and thou hast redeemed us to God by thy **blood.**'—Rev. 5:9 'We have **redemption** through His **blood.**'—Col. 1:14; Eph. 1:7 'Ye were not **redeemed** with corruptible things such as **silver or gold**, but (ye were redeemed) with the **precious blood of Christ** as of a lamb without spot and without blemish.'—I Pet. 1:13 'Ye have sold yourselves for nought and ye shall be **redeemed** without money.'—Is. 52 :3 'By His own **blood** He ... obtained eternal **redemption** for us.'—Heb. 9:11

Notice the following important truth in regard to `redemption.'

'Ye are not your own, For ye are **bought** with a **price**.'—I Cor. 6:19-20 The Church of God Christ `hath **purchased** with His own **blood**.'—Acts 20:28 Christ `gave His life a **ransom**'— Mt. 20:28 He `gave Himself a **ransom**'—I Tit. 2:6

These Scripture references using the words redeemed, ransomed, bought, purchased, are particularly significant.

Redeemed means bought back. Sinners are sold under sin (Rom. 6:17 Isa. 52:3) but are redeemed by Christ's blood. Sinners could be redeemed or purchased from their guilty, sinful, lost and condemned condition, only by some Person paying the price. Christ paid the **price** to redeem sinners. The price which He paid was not silver or gold (I Pet. 1:13) or money (Isa. 52:3) but was His **own shed** blood—His own **life**.

Through the shed blood of Christ - We have the `forgiveness' or `remission' of our sins

**My blood** of the new testament (covenant) **is shed** for many **for the remission of sins.**'—Mt. 26:28

'In whom we have redemption through **His (Christ's) blood,** the forgiveness of sins.'—Eph. 1:7; Col. 1:14

(c) Through the shed blood of Christ - We are cleansed from sin

'Jesus Christ ... loved us, and **washed us** from **our sins in Hs own blood.'**— Rev. 1:5 'The **blood** of Jesus Christ His (God's) Son **cleanseth** us from **all sin**.'—II Jn. 1:7

(d) Through the shed blood of Christ - We are `justified' (made `just') before God and are `reconciled' to God.

'Being now justified by His blood.'—Rom. 5:9 'When we were yet enemies, we were reconciled to God by the death of Hs Son.'—Rom. 5:10

(e) Through the shed blood of Christ - We are made `nigh' to God

'But now in Christ Jesus ye who sometimes were far off are made **nigh (brought close to God)** by the **blood** of Christ.'—Eph. 2:13

(f) Through the shed blood of Christ - We make peace with God

**`Having made peace** through the **blood** of His Cross.'—Col. 1:20 We have seen what Christ has done to provide for our salvation, now **what must we do to be saved?** 

The Bible teaches that this salvation cannot be earned or merited by good works or deeds.

Not by works of righteousness which we have done, but according to His mercy He saved us.'—Titus 3:5 `saved ... not of works, lest any many should boast.'—Eph. 2:8 `Who hath saved us ... not according to works.' II Tim. 1:8 Our good works or our righteousness will not obtain salvation for us, for our `righteousness is as filthy rags in His sight.'—Isa.64:6 Salvation is the `gift of God' therefore it cannot be earned or merited. If we could earn our own salvation it would not have been necessary for Christ to have died.

Alas, how many depend upon their own self-righteousness for salvation. Many depend upon their church membership. Others depend upon their good living—in being respectable citizens of the community—in supporting their families, and in contributing to the poor and to the up-keep of the church.

A way of salvation which a person devises for himself, even though there is much good about it, will never bring the soul to God. Man's way of salvation by `works' is not God's way.`There is a way that seemeth right unto a man, but the end thereof are the ways of death.'—Prov. 14:12

`My thoughts are not your thoughts, neither are your ways my ways, saith the Lord. For as the heavens are higher than the earth, so are my ways higher than your ways, and my thoughts than your thoughts.'—Isa. 55 :8-9

#### We Are Saved By Faith—By Believing In Christ's Finshed Work of Redemption, And By Receiving Him As Our Personal Saviour

#### (a) We must believe in the work of Christ

**`Believe** on the Lord Jesus Christ, and thou shalt be **saved**,'—Act 16:31 `Through his name whosoever **believeth in him** shall receive **the remission of sins**.' `And by him all that **believeth** are **justified** from all things.'—Acts 13:36 `Without faith it is impossible to please God.'

Genuine faith in the work of Christ will be accompanied by repentance.

`God commandeth all men everywhere to repent.'—Acts 17:30 `Godly sorrow worketh repentance to salvation.'—II Cor.7:9-10 The words of the publican express the thought. `God be merciful to me a sinner.'—Lu. 18:13 `If we confess our sins, he is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness.'—I Jn. 1:9 `Repent ... for the remission of sins.'—Acts 2:38 `Repent ... that your sins may be blïtted out.'—Acts 3:19 `Except ye repent ye shall all likewise perish.'—Lu. 13:3

#### (b) We must receive Christ as our personal Saviour.

By nature we are `dead' spiritually. To become alive spiritually we must be born of God. We must be `born again.' As we can enter this world only by the process of a natural birth, so we can enter the Kingdom of God only by the process of a spiritual birth. Spiritual life is received only by the spiritual birth.

`That which is born of the flesh is flesh and that which is born of the Spirit is spirit.'—John 3:6. To be saved—to be a child of God—we must be `born of God.'—John 1:13

Christ said, `Verily, verily I say unto thee except a man be born again he cannot see the kingdom of God.'—John 3:3

Regeneration or the `new birth' is not baptism, or confirmation, neither is it reformation. Regeneration is not the old nature altered, reformed or re-invigorated. It is not a reforming process on the part of man, and it is not a natural forward step in man's development. Regeneration is a new birth from **above**, and is a supernatural creative act on the part of God. The sinner receives a new nature—God's nature, and he is a new creature, and puts on the new man which God creates after holiness and righteousness.

`A new heart will I give you, and a new spirit will I put within you;' Eze. 36:26. `If any man be in Christ, he is a new creature; old things pass away and behold all things become new.' II Cor. 5:17. Eph. 4:24.

By regeneration, or new birth, we are admitted into the kingdom of God. There is no other way of becoming a Christian but by being born from above. Too often we find other things, such as good works, reformation or baptism, substituted by man for God's appointed way of becoming a child of God. To be a child of God one must be born of the Spirit of God.

Jesus said, 'Except a man be born again he cannot see the kingdom of God.' No age, sex, position, condition, exempts anyone from this necessity. Not to be born again is to be lost. There is no substitute for the new birth. Paul said, 'Neither circumcision availeth, anything nor un-circumcision, **but a new creature.**' That is the all important thing, being a new creature in

Christ. Christ did not say that ye ought to be born again, or it would be good for you to be born again. He said `**ye must** be born again.' Jn. 3:7.

We can experience this new birth by receiving Christ as our personal Saviour.

John 1:12 tells us, 'As many as received Him (Christ) to them gave He power to become the sons (children) of God, even to them that believe on his name.'

We cannot receive eternal life without receiving Christ. `God hath given to us eternal life, and **this life is in His Son**, He that hath the Son hath life, and he that hath not the Son of God hath not life.' I John 5:11-12.

`Verily, verily, I say unto you, He that believeth on me hath everlasting life.'—Jn. 6:47

We will experience this new birth—we will be born of God—if we receive Christ as our Saviour. We will be new creatures in Christ Jesus, `and old things will pass away and behold all things will become new.' I I Cor. 5:17. Christ will dwell in us. Gal. 2:20. And we `shall not come into condemnation (judgment) but are passed from **death** unto **life**.' Jn.5:24.

One of the most wonderful facts about this salvation is that it is for everyone. 'God is no respecter of persons. 'Acts 10:34.'Who so ever shall call upon the name of the Lord shall be saved.' Acts 2:21. Christ encouragingly calls, 'Come unto me all ye that labour and are heavy laden and I will give you rest.' Mt. 11:28. 'Him that cometh unto me I will in no wise cast out.' Jn. 6:37. Rev. 3 :20; 22:17.

We can **know** that we are saved, and we can know Christ as our personal Saviour. I Jn. 5:10, 'He that believeth on the Son of God hath the **witness** within himself.' Rom. 7:1—16, 'The Spirit itself beareth witness with our spirit that we are the children of God.'

Dear reader, there is no middle territory, you are either saved or you are not saved. The Bible says, 'No servant can serve two masters; ...ye cannot serve God and mammon.' Lu.16:13. Christ said, 'He that is not with me is against me.' Lu.11:23. 'Know ye not, that to whom ye yield yourselves servants to obey, his servants ye are to whom ye obey: whether of sin unto death, or of obedience unto righteousness?' Rom. 6:16.

The Bible also says, 'Choose ye this day whom ye shall serve.' Joshua 24:15. 'Now is the accepted time, now is the day of salvation. "Today if ye hear His voice, harden not your hearts.' Heb. 3 :7. Do not postpone accepting Christ. 'Seek ye the Lord while He may be found, call upon Him while He is near.' Isa. 55:6. 'Ye know not what shall be on the morrow. Jas. 4:14.

`For what shall it profit a man, if he shall gain the whole world, and lose his own soul? Or what shall a man give in exchange for his soul?'

`Come now, and let us reason together, saith the Lord: though your sins be as scarlet, they shall be as white as snow; though they be red like crimson, they shall be as wool.' Isa.1:18. `This is a faithful saying, and worthy of all acceptation, that Christ Jesus came into the world to save sinners; of whom I am chief.' I Tim. 1:15.
