It’s time for you to start listening to the dissenting voices. Your life and the lives of your loved ones are literally at stake.



In The Name of Yahweh Part 27

A.D. 30 – A.D. 100:


Acts 11:25 – *Then departed Barnabas to Tarsus, for to seek Saul:*

Acts 11:26 – *And when he had found him, he brought him unto Antioch. And it came to pass, that a whole year they assembled themselves with the church, and taught much people. And*

the disciples were called Christians first in Antioch.

This is the first time that Israel are given the name, “Christian,” prophecy of course states they are to be known under a new name.

Here we can see the new name for Israel is Christian, or, “Christ-Son,” meaning of that racial lineage directly descended from Yahweh as recorded in Luke 3:23-38 and this should be the racial name for all those of Israel today. It has nothing to do with religion.

Acts 13:9 – *Then Saul, (who also [is called] Paul,) filled with the Holy Ghost, set his eyes on him,*

Acts 13:10 – *And said, O full of all subtlety and all mischief, [thou] child of the devil, [thou] enemy of all righteousness, wilt thou not cease to pervert the right ways of the Lord?*

Here is another example of a Jew trying to deceive Israel, in perverting the works of Yahweh, and subsequently having his ethnic

lineage correctly called out as, “child of the devil.”

Galatians 3:22 – *But the scripture hath concluded all under sin, that the promise by faith of Jesus Christ might be given to them that believe.*

Galatians 3:23 – *But before faith came, we were kept under the law, shut up unto the faith which should afterwards be revealed.*

Galatians 3:24 – *Wherefore the law was our schoolmaster [to bring us] unto Christ, that we might be justified by faith.*

Galatians 3:25 – *But after that faith is come, we are no longer under a schoolmaster.*

Galatians 3:26 – *For ye are all the children of Yahweh (God) by faith in Christ Jesus.*

Galatians 3:27 – *For as many of you as have been baptized into Christ have put on Christ.*

Galatians 3:28 – *There is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female: for ye are all one in Christ Jesus.*

Galatians 3:29 – *And if ye [be] Christ's, then are ye Abraham's seed, and heirs according to the promise.*

Galatians 3:22 refers to all under sin, but who were under sin? Only Israel were under sin, because sin is defined in 1 John 3:4 as the transgression of the law, and as we have seen throughout Exodus, Leviticus, Numbers and Deuteronomy, the law was given by Yahweh to His children Israel only.

The verse then goes onto make Jesus Christ available to, “them that believe.” How would you show that you believe in Jesus Christ? By not sinning, i.e. following the laws.

We have seen what happened to Israel when they disregarded Yahweh's laws - they lost their identity. Indeed how could they be called, Sons (Ish) Ruling (Ra) With Yahweh (El),” as if they did not follow Yahweh's laws they were no longer fit to rule with him.


Certainly other races were expected to abide by Yahweh's laws when they were in lands under the control of His people Israel, but the law was not given to them.

Galatians 3:23 states, "we were kept under the law," again who was it who were under the law – Israel.

Galatians 3:24 and 3:25 continues in this vein stating that the law of Israel was the schoolmaster of Israel.

Remember Deuteronomy 31:10 and 31:11 which states Yahweh's law is to be read to His people Israel every seven years? Can you see it's relevance here? Also Jeremiah 31:33 where Yahweh's people Israel are to have the law written on their hearts.



Moving onto Galatians 3:26,

"For ye are all the children of Yahweh (God) by faith in Christ Jesus."

Galatians 3:26 is preached as a mantra by the, "Jesus loves everybody," crowd. They deliberately isolate this verse in order to teach that any race can become Christ's Israel bloodline by faith only. However when read in conjunction with the book of Galatians (which incidentally is a letter from apostle Paul to his racial brothers in the churches of Galatia), you can see their interpretation is incorrect. This is proven at the start of Galatians below:

Galatians 1:1 – Paul, an apostle, (God) the Father, who raised him from the dead;)

Galatians 1:2 – And all the brethren which are with me, unto the churches of Galatia:

Notice that Paul uses the term brethren, i.e. brother, he does not say, "All believers in Jesus Christ, step right up." Paul defines what he means by, "brethren," in Romans:

Romans 9:3 – For I could wish that myself were accursed from Christ for my brethren, my kinsmen according to the flesh:

Romans 9:4 – Who are Israelites; to whom [pertaineth] the adoption, and the glory, and the covenants, and the giving of the law, and the service [of Yahweh (God)], and the promises; "

Paul's definition of brethren - as kinsmen – as Israelites proves the book of Galatians is to his racial brothers, maintaining the consistency of Christ's mission on earth which was also only to the race of Israel, a fact He clearly stated in:

Matthew 15:24 - But he answered and said, I am not sent but unto the lost sheep of the house of Israel.

Therefore when we correctly interpret Galatians 3:26 and move onto Galatians 3:27 where Paul states, "For as many of you as have been baptized into Christ have put on Christ," we can see what he is saying is that there are no lost sheep of Israel in Galatia who have just discovered they are racially of Israel, that have not rejoiced at that fact by obeying Israel's laws.

Interestingly these same people who isolate Galatians 3:26 and 3:27 to justify their communist ungodly teachings, do not choose to isolate the verse of Luke where Christ states,

Old Testament

“Word for Word” Part 12

Translation by Stephen Howard Anderson



Chapter 21

1. Yahweh visited 6485 Sarah as that He had said, and did Yahweh to Sarah as that He had spoken.

2. Conceived 2029, and bore Sarah to Ab'raham a son in his old age 2208 at the appointed time that spoke of to him Elohiym.

3. Called Ab'raham the name of his son born to him, that bore to him Sarah, Yits'chaq 3327.

4. Circumcised 4135 Ab'raham Yits'chaq his son , a son of eight days, as that which commanded him Elohiym.

5. And Ab'raham was a hundred years of age when was born to him Yits'chaq his son.

6. And said Sarah, "Made me to laugh did Elohiym, so all that hear will laugh 6711 with me."

7. She said, "Who would have said 4448 to Ab'raham, that would give suck 3243 to children Sarah? For I have born him a son in his old age."

8. And grew 1431 the child, and was weaned 1580, and made Ab'raham a great feast 4960 on the day that was weaned Yits'chaq.

9. Saw Sarah the son of Hagar the Mits'riyth, that she bore to Ab'raham, mocking 6711.

10. And *she* said to Ab'raham, "Cast out 1644 this slave woman 519 and her son, for shall not be heir 3243 the son of this slave woman with my son, with Yits'chaq!"

11. Displeasing 7489 was the matter 1697 muchly 3966 in the eyes of Ab'raham upon account of 182 his son.

12. Said Elohiym to Ab'raham, "**Do not let this be displeasing in your eyes over the boy 5288, and over your slave woman; all that says to you Sarah listen you to her voice because of Yits'chaq shall be called 7121 your seedline,**

13. and also of the son of the slave woman a nation 1471 I shall make because of your seed is he."

14. Rose up early Ab'raham in the morning, and took bread, and a bottle 2573 of water, and gave it to Hagar, putting it upon her shoulder 7926, and the child, and sent her away, and she walked and wandered 8582 in the wilderness 4057 of B'er-Sheba 884.

16. She walked, and sat opposite 5048 him, a distance 7368 of a shot 2909 from a bow 7198, for she said, "Let me not see the death 4194 of the child." She sat opposite him, and lifted up her voice, and wept 1058.

17. Heard Elohiym the voice of the boy: and called the messenger 4397 of Elohiym to Hagar from the sky, saying to her, "**What ails you Hagar? Do not fear, for has listened Elohiym to the voice of the boy where he is.**

18. Rise up, and lift up the boy, and hold 2388 him in your hand: because a great nation I will make of him."

19. Opened Elohiym her eyes, and she saw a well 875 of water, and she walked, and filled the bottle with water, and gave drink to the boy.

20. And was Elohiym with the boy; and he grew 1431, and dwelt in the wilderness, and became a great 7235 bowman 7199.

21. He lived in the wilderness of Paran 6290; and took for him his mother a wife of the land of Mits'rayim 4714.

The Covenant Between Abiymelek and Ab'raham



22. And it was at that time, that said Abiymelek and Piykol 6369, the captain 8269 of his armies 6635 to Ab'raham, saying, "Elohiym is with you in all that you do;

23. now swear 7650 to me by Elohiym here 2008 to not 518 deal falsely 8266 with me, or my son 5209, nor with his posterity 5220; as the kindness 2617 that I have done with you, you will do with me, and with the land where you have sojourned 1481."

24. Said Ab'raham, "I shall swear."

25. Chastened 3198 Ab'raham Abiymelek over the cause 182 of a well of water, that took away by force 1497 the servants of Abiymelek.

26. Said Abiymelek, "I do not know who has done this thing: also you did not tell 5046 me, and also I have not heard of it, until 1115 this day."

27. Took Ab'raham sheep and oxen, and gave them to Abiymelek; and made 3772 them both 8147 a covenant.

28. Set aside 5324 Ab'raham seven ewe-lambs 3535 of the flock by themselves 905,

29. and said Abiymelek to Ab'raham, "What means these seven ewe-lambs that you set aside by themselves?"

30. And he said, "Because these seven ewe-lambs you shall take from my hand, in order that

they be to me a witness, that I have digged 2658 this well."

31. Upon this he called that place B'er-Sheba 884, because there they both swore.

32. They made a covenant at B'er-Sheba, then rose up Abiymelek and Piykol captain of the army and returned to the land of the P'lish'tiyim 6430.

33. And *Ab'raham* planted 5193 a tamarisk tree 815 in B'er-Sheba, and **called on The Name of Yahweh**, El 410 Olam 5769.

34. And sojourned Ab'raham in the land of the P'lishtiyim many days.

Chapter 21 Notes

Verse 2 - Gen. 18:14; Heb. 1:11;

Verse 4 - Gen. 17:12; Acts 7:8; Yashar 21:3;

Verse 6 - 6711 and 6712 both mean laugh here. In verse 9 6711 means "mock".

Verse 9 - 6711 here means "mocking". In the Book of Yashar (Jasher), (which by the way means Book of the Upright), Yish'mael is shooting arrows at ,or near, Yitschaq. This is the reason Sarah wants Hagar gone. Later on, it is recounted how Yish'mael became a great archer, and this lends credence to the story of him "mocking" Yits'chaq with his bow. Jasher is available through Artisan Sales, and I strongly suggest you obtain a copy.

Verse 10 - 1644 garash, means to drive out. Sarah wanted Hagar and her son GONE! Gal. 4:29,30.

Verse 12 - Rom. 9:7; Heb. 11:18 - Elohiym has big plans for Yits'chaq. In English his name is Isaac, thus "Isaac's sons", thus Saac's sons, thus Saxons. This is how his seedline shall be called. Yits'chaq fathered Yaacob, who would then become Yis'rael, so the Saxons were the Yis'raelites that migrated into Europe, and then to America. WE are Yis'rael, and not the hook-nosed usurers that follow the Babylonian Talmud.

Verse 13 - Elohiym will not forget Yish'mael either, as he is Ab'raham's son. He will father

many sons, who will later mix-race, and become the "dusky people" – ereb/Arabs.

Verse 20 - Here Yish'mael becomes the great archer, which ties in with verse 9, and the Book of Yashar 21:15.

Verse 21 - Hagar obtains a wife from her people for Yish'mael. She was an adamitess, but his seedline will not remain pure. Yashar 21:17;

Verse 22 - Gen. 26:26 - 6369 Piykol means "mouth of all" – piy = mouth, kol = all. Verse **25** - Yashar 22:6

Verse 31 - Yashar 22:9 884 means "well of an oath".

Verse 33 - Ab'raham called (invoked) The Name of Yahweh. They DID know The Name back then. The account in "Exodus" (Shemoth) was just a reminder to Mosheh to give to the people, as to Who was speaking to them.

Is Israel A Chosen Servant Race To "Save The World"? (Part 3) By Arnold Kennedy



Deut. 28:9-10

THE LORD
S H A L L
E S T A B L I S H

thee an holy people
unto himself, as he
hath sworn unto thee,
if thou shalt keep the
commandments of the

LORD thy God, and walk in his ways. And all people of the earth shall see that thou art called by the name of the LORD; and they shall be afraid of thee.

God says He will not be glorified in other than Jacob/Israel. Here the word "establish" is in the imperfect mood showing that it will yet come to pass fully. The "holy people" can never become anything else, such as "the Church" in the popular sense. "All the people of the earth...shall be afraid of you", in this verse makes a clear separation between God's people and all others. It also shows that there are two groups, with Israel not being included in "all the people of the earth". This further is an example of how "all" is not inclusive of two groups. The expression of God's purpose is found in the phrase, "an holy people unto himself".

Deut 14:2 *For thou art an holy people unto the LORD thy God, and the LORD hath chosen thee to be a peculiar people unto himself, above all the nations that are upon the earth.*

The term 'holy people' and 'peculiar people' are free translations of the biblical terms 'am qadosh ("set-apart people") and 'am clegullah ("treasure people") who were designed to be different than all other races. This parallel about Israel being a "peculiar people" carries in into the New Testament, without change.

1 Peter 2:9 But ye are a chosen generation, a royal priesthood, an holy nation, a peculiar people; that ye should shew forth the praises of him who hath called you out of darkness into his marvellous light.

1. These people are a chosen (elect) 'generation'. -[genos =race, or descent from a particular people].

2. They are a 'nation'. -[ethnos = racial group].

3. They are 'holy'. -[hagios = sacred and set apart].

4. They are 'peculiar'. -[periousios = "beyond the usual, or "a people selected by God from the other nations for his own possession", according to Strongs 4041].

Denominations will not accept this because it does not support their "to save the world" doctrine. From this latter verse we can see that God's purpose for Israel in the New Testament is still "to show forth the praises of God". Israel


is the 'chosen' or 'elect' [eklektos]. Peter goes on to quote the prophecy of Hosea about this same people, thus showing God's purpose is for one and the same people, for all time.

Isaiah 51:2 Look unto Abraham your father, and unto Sarah that bare you: for I called him alone, and blessed him, and increased him.

Here "alone" ['echad] means "one in number". There is no record of any change to include others, through Scripture. Here "called" means making a proclamation; this is in the perfect mood, which means it is a completed action. It cannot be added to in order to include any other peoples. The "blessed" and the 'increased" are in the imperfect mood, showing that this will yet fully come to pass.

THE WORD "PURPOSE".

The Greek word for "purpose" (prothesis) is used for God purposing. It is also translated as "shewbread" in Hebrews 9:2. This is about the twelve loaves of wheaten bread, corresponding to the number of the tribes of Israel, which twelve loaves were offered to God every Sabbath. The New Covenant nowhere changes the purpose of God concerning the twelve tribes of Israel. No one else is possibly included. Israel (racially) is the only people Scripture associates with the New Covenant—[Hebrews 8:8-9].



Romans 8:28-29 *And we know that all things work together for good to them that love God, to them who are the called according to his purpose. For whom he did foreknow, he also did predestinate to be conformed to the image of his son, that he might be the firstborn among many brethren.*

Examination of the use of this word "purpose" (prothesis) shows clearly that it is impossible for it to have any meaning that would suggest that non-Israel peoples could be included in the manner that Jews, Roman Catholics, denominations and most others allege. Firstly, "purpose" is connected with those that God foreknew, that is Israel in the Old Testament. Secondly it concerns "brethren" (adelphos = from the same womb, stock or family). The words, "the called" are also definitive. God's purpose still is about Israel only. These are the ones predestined to "be conformed to the image of his son". This is active on God's part and passive on His people's part.

Romans 9:10-11 And not only this; but when Rebecca also had conceived by one, even by our father Isaac; (For the children being not yet born, neither having done any good or evil, that the purpose of God according to election might stand, not of works, but of him that calleth;)

Again, the New Testament relates this back to the Old Testament unchanged. Thus the idea about anyone of any race coming into the fold by "believing in Jesus" is invalid. God's purpose has nothing to do with having done good or evil, and thus nothing to do with belief. The ability to believe in Jesus is confined to the elect. It can be seen this has nothing to do with "works" in the phrase, "neither having done good or evil. With any form of multi-racism, there could be no such thing as "election". There could be no "elect", neither having done any good or evil.

Ephesians 1:11 In whom also we have obtained an inheritance, being predestinated according to the purpose of him who worketh all things after the counsel of his own will:—

This verse is national in character, and accordingly we have to note that in the Greek, "obtained an inheritance" and "predestinated" in the verse above are in the passive voice, so the inheritance has nothing to do with anyone of any race making his or her own choice. God does the choosing as to who can believe. God has a purpose. People of other races cannot "choose God" or "choose Jesus" in the way popular evangelism insists. As Jesus confirms, "You have not chosen me, but I have chosen you"—[John 15:16-19].

Ephesians 3:11 According to the eternal purpose which he purposed in Christ Jesus our Lord:—

God's eternal purpose is not something that came to pass in the so-called "Gospel Age". Strong's 165 gives "eternal" as, "for ever, an unbroken age, perpetuity of time, eternity". "Purposed" here is, aorist in tense and active in voice. It concerns what God is always doing, without change, so the alleged change the religionists have made, to now try to incorporate other non-Israelites, is wrong.

Another verse, which clarifies this matter of "His own purpose" further, is:

2 Timothy 1:9-10 *Who hath saved us, and called us with an holy calling, not according to our works, but according to his own purpose and grace, which was given us in Christ Jesus before the world began, But is now made manifest by the appearing of our Saviour Jesus Christ, who hath abolished death, and hath brought life and immortality to light through the gospel.*

Again, His purpose is not a matter of our choice or works. It is passive. God's purpose was established "before the world [ages] began". What "is now made manifest by the appearing of our Saviour Jesus Christ", in no way defines any different purpose.

Both "Jesus Christ" and "Christ Jesus" appears in 2 Tim. 1:9 above. "Jesus Christ" means "Jesus the Christ", whereas "Christ Jesus" refers to an anointed people belong to Jesus. The "hath saved us" cannot have the meaning of "save the world", "us" being a limited to the party being addressed.

THE LORD GLORIFIED IN ISRAEL.


We have looked at and considered the word "glory" as in "Israel My Glory", and it will be helpful to look further into the word "glorified". The word is highlighted in the verses below.

Isaiah 26:15 *Thou hast increased the nation, O LORD, thou hast increased the nation: thou art glorified: thou hadst removed it far unto all the ends of the earth.*

Isaiah 44:23 *Sing, O ye heavens; for the LORD hath done it: shout, ye lower parts of the earth: break forth into singing, ye mountains, O forest,*

and every tree therein: for the LORD hath redeemed Jacob, and glorified himself in Israel.

Yes, God glorifies Himself by increase in Israel! At this prophesied time of the re-gathering and restoration of the Kingdom to Israel, the 'Israel' limitation remains. Israel (only) is the people in whom God is glorified. It is only Israel that is redeemed. This could not be otherwise, since only Israel could be redeemed (purchased back). No other race was originally spoken of as being God's possession, so they could never be "bought back".



Isaiah 60:21 *Thy people also shall be all righteous: they shall inherit the land for ever, the branch of my planting, the work of my hands, that I may be glorified.*

This again has to do with Israel's inheritance, and again it only concerns Israel. There are 206 references to Israelites as "thy people", and 231 as "my people". God has a purpose for Israel to "inherit the land", not to "go to heaven".

GOD'S "GLORIOUS" NAME.

We have considered, "glory" and "glorified" in connection with God's purpose for Israel, but what about the word "glorious"? There are Old Testament references to God's "Glorious Name" we could refer to. There is enough in the next verse to silence all those who would "give God's

glory to another". There is enough to slay the "save the world" dragon. Here God tells us something important about His Name.

Exodus 3:15 *And God said moreover unto Moses, Thus shalt thou say unto the children of Israel, The LORD God of your fathers, the God of Abraham, the God of Isaac, and the God of Jacob, hath sent me unto you: this is my name for ever, and this is my memorial unto all generations.*

God has purposed something here! His name is "the God of Abraham, the God of Isaac, and the God of Jacob". This is "for ever"! It is unto "all generations". Dare any change this into "the God of Jews and Gentiles"? We have seen that God is jealous about His Name. In books about the names of God, this is the name they leave out!

Isaiah 63:12 *That led them by the right hand of Moses with his glorious arm, dividing the water before them, to make himself an everlasting name?*


Could this connect with other than Israel as the verses give "forever" and "everlasting"?

THE PLACE OF OTHER RACES IN ASSOCIATION WITH ISRAEL.

Israel was to dwell separately and not to associate with other races in such as in the worship sense, but they had communication with other races. The next passage from Isaiah is lengthier, but it tells us about who (only) are of God's planting (as seeds). Jesus also tells us in Matthew 15:13-14, "Every plant, which my heavenly Father hath not planted, shall be rooted up. Let them alone: they be blind leaders of the blind. And if the blind lead the blind, both shall fall into the ditch".

Obviously there must be those others in the garden (and the denominations) who are not of God's planting. Those who do not believe what Jesus tells us about this must of necessity be blind leaders of the blind. The "let them alone" of Jesus is given in the imperative mood! It is a command. "Alone" means "go from them". It is futile to attempt to change those who want to insist on including "all the world", i.e. the rest of humanity, as being part of God's purpose in redeeming Israel.

What is presented in the next passage may upset some people, as they may have heard of the first part about "beauty for ashes", but they will never have heard a sermon upon the subject matter of verse 5.



Isaiah 61:3-9 *To appoint unto them that mourn in Zion, to give unto them beauty for ashes, the oil of joy for mourning, the garment of praise for the spirit of heaviness; that they might be called trees of righteousness, the planting of the LORD, that he might be glorified.*

And they shall build the old wastes, they shall raise up the former desolations, and they shall repair the waste cities, the desolations of many generations.

Verse 5. And strangers [zuwr] shall stand and feed your flocks, and the sons of the alien [nekar] shall be your ploughmen and your vine dressers. But ye shall be named the Priests of the LORD: men shall call you the Ministers of our God: ye shall eat the riches of the Gentiles, and in their glory shall ye boast yourselves.

For your shame ye shall have double; and for confusion they shall rejoice in their portion: therefore in their land they shall possess the double: everlasting joy shall be unto them. For I the LORD love judgment, I hate robbery for burnt offering; and I will direct their work in truth, and I will make an everlasting covenant with them.

And their seed shall be known among the Gentiles, and their offspring among the people: all that see them shall acknowledge them, that they are the seed which the LORD hath blessed.

We can see that "the seed which the LORD hath blessed" is singular. [It is singular in the

Hebrew]. The separation between Israel and aliens is still in place, even at the late time this prophecy refers to. Israel and foreigners have not been "made one", even then. It may not be 'politically correct' (or religiously acceptable) to suggest that foreigners (zuwr) and aliens (nekar) are designed to be labourers for God's people. Verse 5 says, "And strangers shall stand and feed your flocks, and the sons of the alien shall be your plowmen and your vine dressers". This one verse, and others like it, is never the subject of a Sunday sermon in our humanistic denominations. So God does have a different purpose for foreigners. This purpose obviously is not to make aliens one with Israel.

Isaiah 60:10 agrees, "*And the sons of strangers shall build up thy walls, and their kings shall minister unto thee*". Here again the foreigners (nekar) are ministers (servants) to Israel. Servant-hood was exactly the status of the Gibeonites who were within the camp of Israel - (See Joshua 9:21-27, "*And Joshua made them that day hewers of wood and drawers of water*

for the congregation, and for the altar of the LORD").

But, in their association with Israel, as foreigners they had a requirement to keep the Law of God in order to survive. This is somewhat different from the present-day English attitude of, "It might offend the Muslims". Even if, as foreigners, the Gibeonites had benefits from associating with the Israelites in the camp, they never could have equal status with Israelites.

The position of "Priests of the Lord" and "Ministers of our God" in Isaiah 61:6 has not changed in the New Testament, as we see in 2 Peter 1:9. "But ye are a chosen generation, a royal priesthood, an holy nation, a peculiar people". "Peculiar" is also translated as "purchased possession". The Word "generation" (genos) has the meaning of "stock" and "race", and cannot be dismissed in any way, or changed to be a matter of belief only. Seed only reproduces 'after its own kind'!

Hart and The Genealogies of The Irish and The Egyptian Connection

In his Irish Pedigrees, O'Hart presents the legendary origins of the Irish people, from the Biblical Adam and Eve through the kings of ancient Ireland. From (1) Adam, his son (2) Seth, his son (3) Enos, his son (4) Cainan, his son (5) Mahalaleel, his son (6) Jared, his son (7) Enoch, his son (8) Methuselah, his son (9) Lamech, his son (10) Noah, his son (11) Japhet, his son (12) Magog, his son (13) Baoth "to whom Scythia came has his lot," his son (14) Phoeniusa Farsaidh (Fenius Farsa) King of Scythia, his son (15) Gaodhal (Gathelus), his son (16) Asruth, his son (17)

Sruth (who fled Egypt to Creta), his son (18) Heber Scut (returned to Scythia), his son (19) Beouman, King of Scythia, his son (20) Ogaman King of Scythia, his son (21) Tait King of Scythia, his son (22) Agnon (who fled Scythia by sea with the majority of his people), his son (23) Lamhfionn (who led his people to Gothia or Getulia, where Carthage was afterwards built), his son (24) Heber Glunfionn King of Gothia, his son (25) Agnan Fionn King of Gothia, his son (26) Febric Glas King of Gothia, his son (27) Nenuall King of Gothia, his son (28) Nuadh King of Gothia, his son (29) Alladh King of Gothia, his son (30) Arcadh King of Gothia, his son (31) Deag King of Gothia, his son (32) Brath King of Gothia (who left Gothia with a large band of his people and settled in Galicia, Spain), his son (33) Breoghan King of Galicia, Andalusia, Murcia, Castile, and Portugal, his son (34) Bile King of Galicia, Andalusia, Murcia,

Castile, and Portugal, and his son (35) Galamh (also known as Milesius of Spain) King of Galicia, Andalusia, Murcia, Castile, and Portugal.

Ireland and Pharaoh

In Irish Gaelic language *fear rua* (pharaoh) the Irish people, while *an fear rua* means the red haired man which is pronounced as pharaoh

"Heber is both an Irish masculine given name and an etymologically unrelated Biblical name. The Irish name is an Anglicisation of the Irish Gaelic *Éibhear*. The Biblical name means "enclave" in Hebrew; and was used by several minor characters in the Bible."

Who Is A Jew? By Biblicism Institute From Our Northern Ireland Correspondent

The word Jew is nowhere to be found in the good book.

The word "Jew" did not come into existence until the year 1775.

ITS MODERN CONNOTATION points to someone who follows and adheres to a faith similar to that of the Pharisees of Judah, but is not of the tribe and stock of Judah. In other words, Jews are people from nations

other than the 12 Hebrew tribes who practice a religion known as [Judaism/Pharisaism](#), the doctrine of the Pharisees.

It is much like those who believe in Christ and are called Christians in honour of the One whom they follow and their religion is known as Christianity, the doctrine of Christ. If one were to say that all Christians are Judahites because Christ was of the tribe of Judah, it would be a fallacy. In much the same way, Jews are not Judahites (or Judeans).

In fact, the religion that is known as Judaism is actually Pharisaism. Judaism – as it pertains to [Pharisaism](#) – is a misnomer since it is neither the doctrine of Judah nor the doctrine that Christ practiced.

It is the doctrine of the Pharisees of old, an evil doctrine they brought back from their Babylonian captivity. It does not follow the truth of the Bible, neither of the Old Testament nor of the New. Its central tenets are found in a book

called the Talmud, a book full of worldly traditions, lies, and superstitions.

“The Babylonian Talmud is based on the mystical religious practices of the Babylonians which were assimilated by the Judahite Rabbis during their Babylonian captivity around 600 B.C. The Rabbis then used these occult traditions in place of the word of God,” wrote Edward Hendrie in Solving the Mystery of Babylon the Great.

And that is why Jesus was constantly rebuking the Pharisees:—



“You belong to your father, the devil, and you want to carry out your father’s desires. He was a murderer from the beginning, not holding to the truth, for there is no truth in him. When he lies, he speaks his native language, for he is a liar and the father of lies.” **John 8:44**

“You have let go of the commands of God and are holding on to human traditions.” **Mark 7:8**

“You serpents, you brood of vipers, how will you escape the sentence of hell?” **Matthew 23:33**

WHAT IS THE WORD IN THE NON-TRANSLATED BIBLE?

In both the Old Testament Hebrew and the New Testament Greek the translated word is always meant to be Judah or Judahite(s), of the physical tribe and stock of Judah. And Jews today are not of the tribe of Judah.

Hebrew Words in the Old Testament Bible: Yehuwdah: Jehudah or Judah Yehuwdiy: Jehudite or Judahite or belonging to Jehudah / Judah.

Greek Words in the New Testament Bible: Iouda: Jehudah or Judah—Ioudaios: belonging to Jehudah or belonging to Judah.

According to Jewish-born Historian Benjamin H. Freedman, author of [Facts Are Facts:-](#)

The best known 18th century editions of the New Testament in English are the Rheims (Douai) Edition and the King James Authorized Edition. The Rheims (Douai) translation of the New Testament into English was first printed in 1582 but the word ‘Jew’ did not appear in it.

The King James Authorized translation of the New Testament into English was begun in 1604 and first published in 1611. The word ‘Jew’ did not appear in it either. The word ‘Jew’ appeared in both these well known editions in their 18th century revised versions for the first times.

When the word ‘Jew’ was first introduced into the English language in the 18th century its one and only implication, inference and innuendo was ‘Judean’. However, during the 18th, 19th, and 20th centuries a well-organized and well-financed international “pressure group” created a so-called ‘secondary meaning’ for the word ‘Jew’ among the English-speaking peoples of the world. This so-called ‘secondary meaning’ for the word ‘Jew’ bears no relation whatsoever to the 18th century original connotation of the word ‘Jew’. It is a misrepresentation.

“The present generally accepted secondary meaning of the word ‘Jew’ is fundamentally responsible for the confusion in the minds of Christians regarding elementary tenets of the Christian faith. It is likewise responsible today to a very great extent for the dilution of the devotion of countless Christians for their Christian faith.

“Christians today are becoming more and more alerted day by day why the so-called or self-styled ‘Jews’ throughout the world for three centuries have spent uncounted sums of money to manufacture the fiction that the ‘Judeans’ in the time of Jesus were ‘Jews’ rather than ‘Judeans’, and that ‘Jesus was a Jew’.” See [How the Ashkenazi Jews conquered the West](#).

The forced evolution of the word “Jew” is similar to the evolution that befell the word “gay”. Gay=Merry became Gay=Homosexual. Try telling someone who’s happy (and who’s not a homosexual) that you’re glad he’s so “gay” and see what happens.

Another example is when many Christians today interact with a Jew they just met, their immediate reaction is to say: “Oh, Jesus was a Jew, too.” What they’re unwittingly saying is that “Oh, Jesus was a Pharisee, too.” Oh, the blasphemy!

The word “Jew” is so entrenched in describing one who follows Pharisaism (or Judaism) that it’s been completely emptied of its original meaning. Hence it no longer describes a Judahite or Judean.

That is why it needs to be struck from the translated bible.

JEWS TODAY ARE NOT THE HEBREWS OF THE BIBLE



Today the majority of those who are known as Jews are in fact the non-Semitic and non-Israelite Ashkenazim, Sephardim, and Samaritans who in later times joined small numbers of different races that converted to Judaism/Pharisaism: Polish, Russians, Ukrainians, Germans, etc. These latter ones form a minority known as European Jews who when coupled with the Ashkenazim constitute a majority against the darker-skinned Samaritan, Sephardic, and African Jews. And resurrecting the dead Hebrew tongue after centuries in the dustbin of oblivion in order to make it modern Israel’s official language won’t change those facts much like parking a Subaru in a Lamborghini dealership won’t turn it into a Veneno Roadster.

Here’s an example of how changing Jews to Judah changes the whole meaning of a passage: “*Salvation is of Judah.*” **John 4:22**

In every bible that verse is translated as “Salvation is of the Jews.” Let’s go to the original Greek word: Ioudaios which literally translated means “Belonging to Judah – Of the tribe of Judah.” However, Jews today do not belong to the tribe of Judah.

And that’s extremely important because Jesus knew why He said Judah and not Levi or Ephraim or any of the other tribes, not even Jacob or Israel. He was announcing the fulfillment of every Old Testament prophecy concerning Himself, including Micah’s prophecy which was proclaimed some time during 737-696 BC:

And thou, Bethlehem Ephrata, art a little one among the thousands of Judah: out of thee shall he come forth unto me that is to be the ruler in Israel: and his going forth is from the beginning, from the days of eternity.” **Micah 5:2**

Jesus was born of the Virgin Mary in Bethlehem, Judah (and was crucified in Jerusalem, Judah). And only Jesus’s going forth could have been from the beginning, from the days of eternity because He was conceived by the Holy Spirit and was Emmanuel, God with us (God made flesh).

“Behold, a virgin shall be with child, and shall bring forth a son, and they shall call his name Emmanuel, which being interpreted is God with us.” **Matthew 1:23**

Furthermore, the Judahites kept God’s covenant with Moses by slaughtering and eating a lamb for Passover.

Jesus did it with his disciples. The lamb was killed and eaten in a private home. The sacrifice

of the Passover Lamb in the Hebrew home was God's very contract with each individual ancient Hebrew, and that's why Jesus repeated it with his disciples in order to introduce the new covenant.

"Tell the whole community of Israel that on the tenth day of this month each man is to take a lamb for his family, one for each household." Exodus 12:3.


Only God knows for sure the nature of any man's heart and we must admit that there are wildly varying degrees of "good" and "evil" among individuals.



Brain Washing, Social Control and Programming – Why You Should Kill Your Television From Our West Midlands Correspondent



Media Control

Schooling plays a big role in programming the population, but the most potent and prevalent educational tools are the mass media. These are devised to reach a large audience via the broadcasting of information through natural means (spoken or

written language, posters) or technological ones (radio, television, cinema, the Internet). With time, the elite has come to control all the important mass media outlets and are now able to dictate their contents.

The trick is easy. All the elite need to do is repeat the same simplistic lies in all the media and the population will believe them without a doubt. This is how lies acquire an irresistible aura of credibility. A specialist of mass brainwashing, L. Wolfe, explains it further:

“As Tavistock’s researchers showed, it was important that the victims of mass brainwashing not be aware that their environment was being controlled; there should thus be a vast number of sources for information, whose messages could be varied slightly, so as to mask the sense of external control.”

Wolfe specified that the contents had to be entertaining and leave the impression that the person always had the choice between various messages and sources. Therefore, the same repetitive information remains hidden behind different and appealing guises.

Tavistock

Around 1920, the Tavistock Institute became the center for the study of human behaviour, mind control, propaganda, and social manipulation. Created in London, it spread overseas with the financial help of the Rockefeller Foundation. Its influence increased when it combined the study of anthropology, economy, organizations, politics, psychology, psychoanalysis, psychiatry, and sociology.



For example, Tavistock organized social phenomena such as the hippie counterculture and the use of mind-altering drugs. Its primary objectives were and still remain the organization of cultural changes through the imposition of chaos and the occult manipulation of special groups. With a 2012 budget of

around 6 billion USD, it is now made up of 10 institutions, 400 subsidiary companies, and 3,000 study groups.

In secret, Tavistock guides powerful multinationals such as the Rand Corp. (media, politics, commerce, health, education, defence), the Mitre Corp. (defence, revenue, national security), the Stanford and Hudson Institutes.

After 90 years of research, Tavistock's main discovery concerns child sexuality. This has a great influence on the development of personality. Early sex stimulation produces adults whose emotional development is similar to that of a neurotic child.

Their second discovery is related to stress. Tavistock researchers found out that people

under controlled stress became more infantile and gave up strongly held beliefs under group pressure to conform to popular opinion. That explains why the mass media insist so much on sex, violence, and fear-inducing messages. We are being turned into scared, submissive children who try to evade the stress of daily life through emotional masturbation – television, radio, CDs, DVDs, movies, and video games.

Television

Westerners spend four plus hours a day, the equivalent of two months a year, or nine years in a lifetime, being hypnotized by a television screen without being conscious of the effects this activity has on them. They have nearly stopped interacting with friends, neighbours, community, and even family. Their free time is spent in imaginary relationships with fictitious characters on the screen.

A few US statistics will show us the extent of the phenomenon: 99 % of households own at least one TV; there are 2.24 TVs per family; the television remains open 7 hours a day; 66 % eat in front of their television sets. The addiction starts right after birth, since 30% of kids who are 0 to 1 year old and 47 % of the 5 to 8 year-olds have televisions in their rooms.

A typical US child spends 3.5 minutes per week in meaningful conversation with a parent, but 1680 minutes per week in front of TV. Is this why television is called the “one-eyed babysitter”? By the time they are 65, most people have seen 2,000,000 TV ads. This phenomenon is becoming global.

The entire population of earth has become addicted to television. If one decides to quit the TV habit, they experience psychological withdrawal symptoms that can be as severe as those related to drug or alcohol abuse. There is a direct relationship between child obesity – which is severe for 11% of 6 to 17 year olds in US – and advertisements, since the most popular types of commercials are related to junk food. A study counted more than 200 junk food ads during four hours of cartoons on Saturday morning television in the US. When compared with radio listening, television is more impactful because there are pictures. The more there are to accompany a special news report, the more tangible it will seem and the lesser the chance of

people questioning its accuracy. Media expert Hal Becker once said:

“I know the secret of making the average American believe anything I want him to. Just let me control television... You put something on the television and it becomes reality. If the world outside the TV set contradicts the images, people start trying to change the world to make it like the TV set images.”

How is it that the elite have been so successful in achieving full control of television programming? Through the assistance of government. Politicians vote and impose laws that favour large TV stations over smaller ones and make it difficult for independent ideas to reach the airwaves. Better yet, most countries have their own sanitized State television stations. Mass Hypnosis and Mass Violence

Tavistock hastened to study the effects of television on human behaviour as early as the 1940's. Its researchers discovered that 30 seconds after one starts watching TV, the brain automatically begins to produce alpha waves, a modified state of consciousness. The viewer goes into a trance-like mode, a type of light hypnosis.

All their attention becomes concentrated on the screen, while the rest of their environment is ignored. In this semi-conscious state, they become highly susceptible to the messages contained in the programs, especially the commercials, which are created especially for that purpose.



Television started becoming popular in the fifties, and the elite have now accumulated more than 60 years of experience spread over three generations of viewers. The results are staggering. People are no longer logical, as their opinions and ideas come directly from television.

The images validate what they hear. This filter of tele-opinions gets automatically superimposed over their daily reality, and have become passive members of a plugged-in society, and can no longer think, talk, or write logically. For them, images and knowledge are synonymous.

In Europe, violence on television is as critical as in America. Specialized stations such as Baby TV and Baby First broadcast programs for babies 24/7. When toddlers are one year old, they are already watching at least one hour of television a day. Statistics from 1988 showed that during one week of TV watching, viewers witness 670 murders, 15 rapes, 848 fights, 419 shootings or explosions, 11 armed robberies, 8 suicides, 32 hostage takings, 27 torture scenes, 9 demonstrations, 13 strangulations, and 11 war scenes. Nowadays, these types of events are not reserved to late hours. For example, Quebec's popular TQS station presented the movie Terminator at 6:30 pm – just in time for kids.

And it's Getting Worse!

Ever heard of Silent Sound Spread Spectrum or SSSS? It is a secret Pentagon psychotronic technology that has been operational since 1990. In 1991, it was used during the first Gulf War to manipulate Iraqi troops into surrendering en masse. Like compliant children, 200,000 men came out of their desert bunkers and fell to their knees before approaching US troops.

The SSSS is now available in your neighbourhood – free of charge. It is carried to your brain with the use of several technologies, including chemtrails, cell towers and high definition digital television (HD-TV). In this way, the elite is aiming for total mind control to insure the compliance of its sheeple. Now you know why the government was so enthusiastic about letting us get digital converter boxes for a cheap price, because they want us to have access to high-quality television images.

Big Brother goes even further with digital streaming video that allows any person with a personal computer linked to the Internet to access and watch popular television programs. This is available for free through companies such as Hulu. In this way, computer monitors and HD-TV screens broadcast SSSS and combine it with subliminally-pulsed images to bring about specific emotions and physical responses to all

listeners or a selected type of DNA (Blacks, Orientals, women, etc.). If the elite has a sample of a person's DNA, it can even target selected individuals. Experimentation has shown that it is effective – with varying levels of efficiency – with about 85% of the population, while the remaining 15% seem to be immune to such mind control attempts.

What Should We Do?

What should we do now that we know? Well, truth is useless if we do not change our actions. Number one: throw out the television. Even without this new mind-control technology, the television has always been a “box of lies.” Watching TV lowers one's intelligence, and many statistics are there to prove it. Forget the “good educational shows” that are simply there to misinform you.

Number two: limit the time you spend in front of the computer and on the internet, and never watch TV shows from the Internet.

Number three: avoid other sources of do not use cell phones (whether ‘smart’ or not). Basically, it is like putting your head in the microwave oven and pushing the ‘ON’ button. It is difficult to avoid chemtrails, but living a TV-free and cellphone-free life is possible – you get so much more time to read, think (for yourself), meditate, exercise, cook, and keep good company.

The elite have hijacked our brains with their technology, but we still have our free will. We can choose to use it or not to use it. Which one will you choose?



I have been thinking about this Scripture and I have to say that I struggle with its meaning.



Imagine how a computer might describe its maker:—


Why did he design me to be so unreliable, annoying, badly programmed, easy to hack, etc, etc - why couldn't he make me perfect?

The Right To Bear Arms

Copy of a letter to Mr Justice Superstone from Albert Burgess

17th July 2017



My Lord—, I understand you have been given the job of hearing a judicial review on the right of Her Majesty's natural born subjects to bear arms. Whilst not being directly involved in the case before you, I should however appreciate it if you will please consider my opinion and together with any other of Her Majesty's Judges hearing or having an interest in the case.

That eminent Judge Lord Denning said, "If a man comes into your house without the correct paperwork, knock him spark out". But what if that man has a butchers knife or a gun? What if he is not on his own? How then, do we knock him spark out? Very few of us are trained in the martial arts or have been trained by the SAS. Most of us are just not capable of defending our homes or families. We need our ancient right and duty to bear arms.

There are five types of law in this ancient Kingdom. The first is custom, the second charters, third are those made by the Estates of England, fourth statute. The fifth is common law.

Custom is that law which has been in use and approved by the people from before time of memory. Sir Edward Coke ruled that this included any law which predated King Richard I coming to the Throne, a little over four hundred years before Sir Edward Coke. So before time of memory can be set at any law over four hundred years old.

Charters are things like the Charter of Liberties 1100 or Magna Carta 1215. These are contracts between the King and his subjects. Parliament is not included. The City of London has a Royal Charter as do a number of other places like the Cinque Ports. These are legally enforceable contracts solely between the King and his subjects.

The Estates of England are the highest law giving body in this Kingdom. They have the ability to hire and fire Kings which they did when they effectively fired James II and hired William and Mary with the Declaration of Rights 1689 and in May 1366 they advised King Edward III that he had to refuse tribute to the Pope. It was the Estates of England meeting at Runnymede that forced King John to sign Magna Carta 1215 demanding that he govern us according to our law.

Forth, statutes are acts of Parliament. Statues cannot be used to alter, amend or repeal any of the above and are quite simply laws dealing with the day to day running of the Kingdom. Put it like this I go to work to earn money. I give that money to my wife and she administers it buying food clothing and paying the bills.

The taxpayer equates to the husband earning the money and Parliament equate to the housewife. They buy what we need, pay the nation's bills and lay down rules for the day to day running of the Kingdom. Constitutionally, Parliament is a tri-partite agreement where the House of Commons originates legislation, the House of Lords give it approval, send it back with amendment or they reject it outright strictly in accordance with their collective conscience. If it is approved, it goes to the King who strictly in accordance with his own conscience in the best interests of his subjects, will grant or refuse the Royal Assent. If the King refuses the Assent, he cannot be asked or told to give his reasons.

Common Law is made by the courts adapting a statute to the case before them. The Judges interpret the law in such a way that justice can be achieved when it might not be if the statute were applied as written. Common Law is also that law which was common to the entire Kingdom.

Such a law states quite clearly that if the French or Turks come into this Kingdom even if the King says he wants them and they are his friends, each of us can become an officer and form a force/militia to throw them out. So English law and custom state that we must hold weapons and be prepared to use them for the defence of ourselves and of the Kingdom.

Custom it has long been the custom not only to permit the carrying of weapons by the King's

subjects, but it was in fact from earliest times a requirement that all freemen must by law equip himself with weapons suitable to his station. The minimum was a broadsword and a long bow. Indeed it is still a legal requirement to this day, that all men between the ages of twelve and sixty do an hour's practice with the long bow every day.

Like many laws it is current legislation that is not enforced. For hundreds of years since the introduction of purely English law by King Alfred, every man over twelve years of age must possess weapons to be used in locally formed militias for the defence of his local town and/or the Kingdom.

In later years, this required the larger land owners to supply one or more fully equipped and mounted Knights ready to be sent into battle for the defence of the Kingdom. This was called the Knights fee. Along with Knights, land owners would supply archers and men at arms fully equipped to defend the Kingdom.

Over hundreds of years the longbow was largely replaced with cannon, pistols and rifles. It was the custom for Englishmen to possess and carry swords, daggers and hand held guns - the pistol being the most convenient.

The 1689 Bill of Rights which incorporates the Declaration of Rights, states that a Protestant may carry weapons suitable for his defence as allowed by law. Catholics were already carrying them, a clear statement by the Estates of England that the law and custom of England was to have an armed population ready and able to defend both themselves and the Kingdom.

Even today, you cannot be arrested for carrying a longbow, a purely English and Welsh weapon. But if you walk down the street with any part of a crossbow, you will be subject to arrest. The first firearms legislation appeared in 1903 and required people to hold a permit to buy ammunition and carry a loaded weapon in public. In 1919 after the Great War, Government fearing anarchists started to restrict the carrying of firearms. With such ridiculous knee jerk reaction, Government failed to consider that an armed population prepared to resist anarchists would have prevented any anarchists attempting anything and will very effectively have shut them down. Later statutes

imposing strict gun control are unlawful. This is because they attempt to repeal the custom and practice of England to have an armed population ready to defend the Kingdom. In 1588 on the approach of the Spanish Armada, Queen Elizabeth I ordered the release of all prisoners because England was their country too and they must be allowed to defend it from invasion.



The present Government are allowing unlimited immigration. This has resulted in very many child rapes and acid attacks, a particularly vile form of assault. It has resulted in no go areas where we understand police officers ask permission to patrol. We are being invaded contrary to the will of Her Majesty's natural born subjects. As the result, we not only have the right but a clear duty to consider ourselves officers according to our ancient laws and the custom and practice of England to call out militias to defend our children and this ancient Kingdom which we see being overrun by barbarian hordes. And we demand our ancient right to bear arms in the defence of this Kingdom.

No Parliament since 1911 has been a lawfully constituted Parliament. This is because the 1911 Parliament Act breached section 3 of the 1848 Treason Felony Act and overawed the House of Lords common law cognizance to conduct its own business its own way. It was a clear act of treason contrary to the above Act. The 1949 Parliament Act made the situation worse and the 1999 House of Lords Act overawed the House of Lords common law cognizance to decide who does and does not sit in the Upper House. As a result all firearms Acts passed since 1911 are void as they were not made by a properly constituted Parliament as laid down in our constitutional and common law.

Sir Edward Coke CJ ruled that "Parliament may sometimes pass a law which is repugnant, against common right and reason or impossible

to perform in which case the Common Law will intercede and strike it down". I respectfully submit that it is against common right and reason to disarm the Queen's loyal subjects so they are no longer able to defend the Realm. It is repugnant that such disarmament should occur and if Her Majesty's loyal subjects decided to arm themselves in defence of Her Majesty and this Kingdom, it would be impossible to disarm them. Stonor CJ said that, "Law is that which is right". It is not right to have a population disarmed so that they are unable to defend the Kingdom. Beresford CJ said, "There is no such thing as a bad law, because if it is bad it is not law" It is bad law to expose the Kingdom to risk by having an unarmed population.



I most respectfully submit that to disarm and keep Her Majesty's natural born subjects disarmed breaches our common law right in conformation with the custom and practice of England. To bear arms suitable to defend ourselves and this ancient Kingdom. I further submit that every firearms act since 1903 has no lawful validity because they all breach our common law right to bear arms suitable to our station and the custom and practice of England.

Government have so reduced the Kingdom's armed forces that they are unable to defend the Kingdom they serve, from invasion. Government's reduction of the number of police officers has left our police forces in every part of the country vulnerable to riot, riot of such size and violence that the police on their own will be entirely overwhelmed. Several riots occurring across the nation would stretch our police to breaking point and far beyond. The Armed Forces, the natural back up for the civilian

police, are so depleted and already overstretched with peace keeping and overseas operations fighting terrorists that there is every prospect that an armed attacking force going to war against Her Majesty's natural born subjects will see our police and armed forces totally overwhelmed by sheer weight of numbers.

We have in Britain a rapidly growing and volatile group of Muslim Judaists determined to cause death and destruction on our streets. We know from experience in mainland Europe that they are not frightened to attack police as they destroy large parts of the cities across Europe and Scandinavia. Greek customs officials opened containers purportedly containing furniture donated to Muslim refugees. Instead of furniture, they found containers of military grade weapons and ammunition. Police raids on Mosques in France and Germany have exposed considerable quantities of military grade weapons.

Our own police have already conspired to cover up the rape and prostitution of our young school girls as young as 11 years of age. Until retiring, I held the office of constable and to my eternal shame, I watched a video of Metropolitan police officers running away from a mob of Muslims. I cringe with the shame of it. I always ran toward the problem, no matter how many there were causing it.

My Lord, you have the opportunity to restore what is right and to allow Her Majesty's natural born subjects with a clean criminal record and of sound mental health, the right to possess weapons suitable for our defence and the defence of the Realm. I would suggest a rifle not capable of fully automatic fire and a handgun such as a semi automatic pistol. A requirement for owning these weapons should be attendance at a police or military range to be taught how to safely handle the chosen weapon and to ensure accuracy in its use. This would provide an easily assembled militia who would operate under the orders of a military officer in support of the police. If the weapon of choice used the same calibre of ammunition used by the military and police - for rifles 7.62 or point 22/ 5.56 calibre round and 9 mm for all hand guns so that the militia can be supplied with ammunition easily from military or police stocks.

We see marches through our towns of many thousands of Muslims complete with banners and with cars blaring out the dirge they shout. It is my fear based upon what is happening across Europe that it is only a matter of time before marches become riots. Police officers present will be killed before further police backup can arrive and the Muslims will set out on a rape and murder binge where every man is murdered and every woman and child is brutally beaten and raped. If British natural born subjects were armed, the police would receive instant support and the militia acting under police instruction could contain the situation until armed police and or military units arrive to deal effectively with such major breach to the Queen's peace.

My Lord, the United States (US) are like us. They are a common law country that took our law. Those parts of the US which have strict gun control also have the highest rates of serious crime and murder. Those parts of the US where

people are allowed to carry firearms, concealed or openly, have significantly lower rates of crime and very few murders. When crime does occur, armed citizens are able to take the criminals into custody and hold them until police arrive. If you check these facts as being one of Her Majesty's impartial Judges I hope you will, you will find the argument for armed subjects is compelling. Please remember, criminals do not respect the law which is why they are criminals and more and more of them carry guns, even fully automatic machine pistols. They 'need' fully automatic weapons because they are not trained in the use of firearms. Her Majesty's natural born subjects armed and trained with the weapons they have, they can effectively save lives, take down the criminal element and contain the situation until the police arrive.



In the article, shown below, Dr. Ehrlich (left) laments the fact that biologists believe, “compulsory family regulation will be necessary to retard population growth.” In essence, he is arguing that the government

To achieve the sterilization goals, he “urged establishing a Federal Population Commission ‘with a large budget for propaganda,’” reports the New York Times. He also called for, “the addition of a temporary sterilant to staple food, or to the water supply” in order to cause mandatory infertility.

Dr. Barry Commoner of Washington University in St. Louis added to the discussion:—

Can we not invent a way to reduce our population growth rate to zero? Every human institution – school, university, church, family, government and international agencies such as Unesco – should set this as its prime task.

A STERILITY DRUG IN FOOD IS HINTED Biologist Stresses Need to Curb Population Growth

SAN FRANCISCO, Nov. 24 —A possibility that the Government might have to put sterility drugs in reservoirs and in food shipped to foreign countries to limit human multiplication was envisioned today by a leading crusader on the population problem.

The crusader, Dr. Paul Ehrlich of Stanford University, among a number of commentators who called attention to the "population crisis" as the United States Commission for Unesco opened its 13th national conference here today.



Unesco is the United Nations Educational, Scientific and Cultural Organization. The 100-member commission, appointed by the Secretary of State, included representatives of Gov-

ernment, outside organizations and the public. Some 500 conservationists and others are attending the two-day meeting at the St. Francis Hotel, devoted this year to environmental problems.

President Nixon's chief science adviser, Dr. Lee Du Bridge, brought up the population question in his keynote speech last night, calling the reduction of the earth's population growth rate to zero "the first great challenge of our time.

Godfrey a Speaker

His comments went beyond recent statements of President Nixon, who in a message to Congress stressed the provision of birth control information to underprivileged women.

But the Federal Government's willingness to come to grips with population limitation was questioned by another speaker, Arthur Godfrey, radio-television star and a conservation campaigner.

"Dr. Du Bridge rightly said that population control should be the prime task of every government," he said. "But is there anyone here — anyone — who thinks that this Administration, or the next of the next, will act with the kind of force that's necessary?"

Dr. Erlich, who is a biologist said:—

"Our first move must be to convince all those we can that the planet Earth must be viewed as a spaceship of limited carrying capacity.

"I think that 150 million people (50 million fewer than there are now) would be an optimum number to live comfortably in the United States. 'Alternative to Armageddon'

"Some biologists feel that compulsory family regulation will be necessary to retard population growth. It is a dismal prospect — except when viewed as an alternative to Armageddon."

He urged establishing a Federal Population Commission "with a large budget for propaganda," changing tax laws to discourage reproduction and instituting mandatory birth control instruction in public schools.

He also urged “changing the pattern of Federal support of biomedical research so that the majority of it goes into the broad areas of population regulation, environment sciences, behaviour sciences and related areas rather than into short-sighted programs on death control.”

If such steps are unavailing, he continued, the nation might resort to “the addition of a temporary sterilant to staple food, or to the water supply,” with limited distribution of antidote chemicals, perhaps by lottery.

Although it might seem that such a program could be started by doctoring foods sent to underdeveloped countries, he said, “the solution does not lie in that direction” because “other people already are suspicious of our motives.”

Economic Pressure Urged

Rather, he suggested, the United States should stop economic aid to countries that do not try to limit their populations.

Dr. Barry Commoner of St. Louis, Washington University ecologist, in an ensuing discussion period differed with Dr. Ehrlich.

He said that he thought the urge to multiply was rooted in the sense of insecurity. And that the better way to reduce reproduction was by “increasing the well-being of peoples.”

He also opposed chemical stratagems on the ground that “every technological trick like that we’ve tried has caused disaster.”

Recapitulating the environmental problems stemming from population, Dr. Dubridge said: “Do we need more people on the earth? We all know the answer to that is no. Do we have to have more people? Also no.

“Can we reverse the urges of a billion years of evolving life? We can. We know techniques for reducing fertility. We are not fully utilizing them.”

Citing a widespread attitude, he said: ‘We have the right to have as many children as we can afford,’ we say. Do we, today? No.

“Can we not invent a way to reduce our population growth rate to zero? Every human institution – school, university, church, family, government and international agencies such as Unesco – should set this as its prime task.”

THE ROTHSCHILD-CONTROLLED Economist magazine published an article 30 years ago that highlighted the probability of a world currency by the year 2018.

The Free Thought Project reports: One must also keep in mind that the controlling interest of The Economist is held by the powerful Rothschild family, who regard themselves as the “custodians of The Economist magazine’s legacy.

”In essence, the magazine operates as a quasi-propaganda arm for the Rothschild banking empire and related businesses and, in many ways, meant to prime the pump of public opinion for the globalist agenda to be implemented.

The excerpt below appeared in the print magazine on January 9, 1988, in Vol. 306, pp 9-10.

Ready for the Phoenix



THIRTY years from now, Americans, Japanese, Europeans, and people in many other rich countries, and some relatively poor ones will probably be paying for their shopping with the same currency. Prices will be quoted not in dollars, yen or D-marks but in, let's say, the phoenix. The phoenix will be favoured by companies and shoppers because it will be more convenient than today's national currencies, which by then will seem a quaint cause of much disruption to economic life in the last twentieth century.

At the beginning of 1988 this appears an outlandish prediction. Proposals for eventual monetary union proliferated five and ten years ago, but they hardly envisaged the setbacks of 1987. The governments of the big economies tried to move an inch or two towards a more managed system of exchange rates – a logical preliminary, it might seem, to radical monetary reform.

For lack of co-operation in their underlying economic policies they bungled it horribly, and provoked the rise in interest rates that brought on the stock market crash of October. These events have chastened exchange-rate reformers. The market crash taught them that the pretence of policy co-operation can be worse than nothing, and that until real co-operation is feasible (i.e., until governments surrender some economic sovereignty) further attempts to peg currencies will flounder.

The New World Economy

The biggest change in the world economy since the early 1970's is that flows of money have replaced trade in goods as the force that drives exchange rates. as a result of the relentless integration of the world's financial markets, differences in national economic policies can disturb interest rates (or expectations of future

interest rates) only slightly, yet still call forth huge transfers of financial assets from one country to another. These transfers swamp the flow of trade revenues in their effect on the demand and supply for different currencies, and hence in their effect on exchange rates. As telecommunications technology continues to advance, these transactions will be cheaper and faster still. With uncoordinated economic policies, currencies can get only more volatile.

In all these ways national economic boundaries are slowly dissolving. As the trend continues, the appeal of a currency union across at least the main industrial countries will seem irresistible to everybody except foreign-exchange traders and governments.

In the phoenix zone, economic adjustment to shifts in relative prices would happen smoothly and automatically, rather as it does today between different regions within large economies (a brief on pages 74-75 explains how.) The absence of all currency risk would spur trade, investment and employment.

The phoenix zone would impose tight constraints on national governments. There would be no such thing, for instance, as a national monetary policy. The world phoenix supply would be fixed by a new central bank, descended perhaps from the IMF.

The world inflation rate – and hence, within narrow margins, each national inflation rate – would be in its charge. Each country could use taxes and public spending to offset temporary falls in demand, but it would have to borrow rather than print money to finance its budget deficit.

With no recourse to the inflation tax, governments and their creditors would be forced to judge their borrowing and lending plans more carefully than they do today. This means a big loss of economic sovereignty, but the trends that make the phoenix so appealing are taking that sovereignty away in any case. Even in a world of more-or-less floating exchange rates, individual governments have seen their policy independence checked by an unfriendly outside world.

There Are Nine Toxic Ingredients In Your Toothpaste

But accomplishing that can be difficult when a good number of commercial toothpastes are made with questionable ingredients. 2. Carrageenan – This particular ingredient is derived from red seaweed, or Irish moss, and is used to thicken and stabilize “natural” toothpastes. Repeated consumption of carrageenan has been linked to skin rashes and gastrointestinal problems.

3. Diethanolamine – A common ingredient in foaming products, diethanolamine (DEA) is at best a mild eye and skin irritant, and at worst a hormone disrupter that can potentially form carcinogenic nitrates. Exposing your skin to DEA has even been linked to heightened risk of kidney and liver cancer.

4. FD&C Blue #1 and #2 – The brilliant blue colour of toothpaste can be attributed to these ingredients. Their benefits to toothpaste are purely cosmetic, however. Swallowing these dyes can irritate your respiratory and digestive systems. FD&C Blue #1 has been linked to learning and behavioural problems in children.

5. Fluoride – Once touted as a solution to building strong teeth, fluoride has since been exposed as a downright unsafe toothpaste ingredient with a shocking number of negative health effects. From disrupting your immune system, to decreasing adrenal and thyroid gland function, there’s almost nothing to be gained from fluoride. In addition, ingesting too much fluoride can result in fluoride toxicity, which includes such symptoms as vomiting, skin rashes and headaches.

6. Propylene glycol – This surfactant and wetting agent has a variety of uses outside of being a toothpaste ingredient, most famous of which is as a component of antifreeze. Not exactly a substance you want to put near your mouth, even if you don’t take into account its potential toxicity to the liver, kidneys and brain.

7. Sodium lauryl sulphate – This chemical is added as a detergent, a cleansing agent, and as a surfactant or foaming agent. Sodium lauryl sulfate (SLS) is supposed to get rid of plaque, when in reality it just worsens your oral health. Besides raising the chances of developing sensitive teeth, SLS has also been linked to increased frequency and longer outbreaks of canker sores, as well as irritating already-existing allergies.

8. Sorbitol – To prevent toothpaste from drying out and hardening, sorbitol is often added as a key ingredient. Unfortunately, sorbitol has a laxative effect and can lead to chronic diarrhoea.



chapter house was built during these renovations. During the Wars of Independence the cathedral remained for the most part undamaged until it was burned in an attack in 1390 by the brother of King Robert III.

After the fire the main tower and the western gable between the towers as well as the main west doorway and chapter house had to be rebuilt. The building was attacked and burned again in 1402.

The remodeling after this fire included a large pointed arch with a series of windows. The uppermost window is a rose window that dates from 1422-1435.


After the Reformation, ownership of the property was in the hands of the Crown. In 1560, parliament legislated that Scottish churches would be Protestant and Catholic mass was illegal. Cathedrals only survived at this time if they were used as parish churches. Elgin was already served by a parish church so the cathedral was abandoned.

In 1595, King James VI gave ownership of the grounds to the burgh of Elgin to be used for educational purposes and to help the poor. By act of Parliament in 1567, the lead was removed from the roof of the cathedral to be used for the army.

The ruins were in a great stage of decay in 1637 when the roof of the eastern limb collapsed in a gale. The destruction of the great west window may have been caused by the troops of Oliver Cromwell during the Protectorate between 1650 and 1660.

The grounds of the cathedral began to be used for burials. The central tower collapsed in 1711

destroying the nave and the stone began to be quarried for other buildings. Repair and restoration work has continued on the ruins from the 19th Century onwards.

Elgin's Pictish Stone

Just outside the chapter house is another of Elgin's treasures, a carved Pictish stone. One side of the stone is overtly Christian, with a carved cross, but the other side is covered with a hunting scene and deliciously pagan Pictish symbols including a crescent and z-rod. The stone was found at St Giles parish church in 1823 and moved to the cathedral grounds.

The imposing west front of the cathedral is still largely intact. You can climb the spiral stairs within the 4-storey towers and get wonderful views over the cathedral grounds from the roof. There are numerous tombs of bishops, including Bishop John of Winchester in the south choir chapel, with a beautifully carved effigy beneath a cusped canopy. In the same chapel are memorials to several Dukes of Gordon and their families. One of the finest is the tomb chest of Alexander Gordon, 1st Earl of Huntly (d. 1470).
