Declaration Of Independence From Zionism

WHEN, in the course of human events, a tyranny of one special interest becomes so grievous that the people can no longer tolerate its presence, then the people must voice opposition against it. This tyranny seeks to silence its critics with claims of “anti-Semitism.”

It seeks to deprive the American people of their Constitutional right to freedom of expression. It seeks to redirect the destiny of America away from what the Founding Fathers had intended toward that of a foreign, theocratic state, in obvious violation of the American principle that the State should not favour any particular religion or denomination. (Article 1 of the Bill of Rights.).

In direct conflict with the Constitution of the United States, this tyranny exploits its vast global economic resources, including the world’s largest banking, media and industrial corporations, by pressuring the Congress, the Court System, and the Office of the President into supporting wars of aggression toward non-Jewish nations.

It owns instruments of oppression, such as the Anti-Defamation League (which is an exclusively Jewish agency that spies upon American civilians in defiance of the laws against such spying), the World Jewish Congress, the American Israel Public Affairs Committee, and dozens of other such lobbying organizations, which use all of their economic and political influence to keep America’s domestic and foreign policies tied to the State of Israel, which is an imperialistic presence in the Middle East.

Through their ownership of various media, such as television, radio, magazines, newspapers, book publishing and entertainment, these Zionist organizations never fail to demonise their perceived enemies while pretending to be the world’s watchdogs for international “terrorism.”

At the same time, the state-sponsored terrorism of the Israeli State is never mentioned by this “free” press. This one-sided perspective concerning the politics of the Israeli State is an outrage. Rarely does this biased “Press” permit the opposition to voice its disapproval of the policies of Zionism and the Israeli State.

Zionism is an international fraud, perpetuating its existence on money extorted from the taxpayers of various nations, including its exploitation of the holocaust, which they will not allow us to forget, while never mentioning the horrible crimes of the Zionists against the Palestinian, Lebanese, Christian and Muslim people who live near the Israeli State.

Since the Presidency of Woodrow Wilson, Zionist operatives have quietly influenced successive administrations through such agents as Col. Edward Mandel House, Bernard Baruch, Henry Morgenthau, Henry Kissinger, Richard Perle, Paul Wolfowitz and numerous other unelected officials. Without any public debate, thereby freezing the American people out of any involvement in these decisions, our government has, for nearly one hundred years, served the interests of International Zionism first and America last.

These operatives, who have exploited America’s resources in the interest of the World Zionist Movement, have never been the friends of America. Instead, they constitute a Fifth Column, which has steered America into one international conflict after another, allowing America to take the blame for their warmongering and bloodlust. Zionism has thoroughly corrupted America, changing our nation from a peace-loving people to a World Police State.

Following the advice and direction of these Zionist warmongers, America has become a shameful imperialistic nation, a bully that throws its weight around, declaring itself the world’s foremost promoter of “democracy,” which is a word that pro-Zionist politicians use as a cover for their Zionist-sponsored imperialism.

How many more Americans have to die for International Zionism before the American people cry foul and put an end to this tyranny?



Also during the Wilson (above) Presidency, the Zionists pushed the Federal Reserve Act through Congress, giving the House of Rothschild banking family and other international Jewish banking families the exclusive monopoly to issue America's money, in direct violation of the U.S. Constitution (Article I, Section 8).

This system, based on usury, is also in violation of God's Commandment against usury (lending money at interest). As long as America tolerates this parasitic institution, which is a legalized monopoly of private money issuance, there will be no peace in this country or in this world. The Federal Reserve System is organized crime masquerading as a governmental office, pretending to be "America's Bank," while, in fact, its stockholders run this organization purely for private gain and for economic control of our nation.

Zionism is international imperialism dressed up as Jewish survivalism. It is supremacism masquerading as liberalism. It is the proverbial "wolf in sheep's clothing," speaking in the name of "freedom" but denying freedom of speech to its critics. Its international campaign to suppress historical revisionism is tantamount to oppression, for it smears all of its critics with the word 'hate' or 'anti-Semite' while denying these same critics a voice in the public square.

They have intimidated or imprisoned such champions of free speech as Ernst Zundel, David Irving, Christopher Bollyn, and Germar Rudolf for the *thought crime* of "questioning the holocaust." For this crime against the Freedom of Speech, International Zionism, and all of its supporters, should be thoroughly ashamed, for these are the tactics, not of those who claim to

be "God's chosen people," but the tactics of an Orwellian Police State.

The brutal and blatant occupation of Palestine by the Zionists is a completely unjustified aggression, not just against the Palestinian people, but against the whole world, for when one person is deprived of his or her human rights, no one is safe. Zionism seeks to justify its occupation of Palestine based on the premise that "the Nazis persecuted the Jewish people."

However, two wrongs do not make a right. The Palestinian people never persecuted or wronged the Jewish people in any way or at any time in history. Consequently, Zionism is, by definition, a terrorist state, imposing its imperialistic will upon a completely innocent people. This occupation, in reality, places "Jewish rights" above the rights other people; and this is unacceptable.

Zionism is an offence to everything that Americans hold dear: liberty (including freedom of religion and freedom of expression), justice, and equality before the law. In defiance of these American principles, The Zionist Israeli State is an exclusively Jewish state, which denies full rights to non-Jews, making the Israeli State a de facto system of Apartheid.

Thus, to equate Zionism with "Americanism" is hypocrisy on a massive scale. Justifying their aggression by reason of their own past oppression, they have become what they claim to be against: Bigotry and Oppression.

Their chief propaganda device, the Israeli State, was conceived by fraud (the Balfour Declaration), instituted by Terror (the Stern Gang, the Irgun Gang, and other terrorist groups financed by the Rothschild banking family), and maintained by Extortion, using pressure groups within other nations to compel government funds (taxpayer's money) for their illegitimate cause.

All American aid to the State of Israel should end immediately and our connection with the Israeli State should be severed completely, for that State is a Jewish Apartheid State. If Apartheid was evil in South Africa, why is it acceptable in Israeli? Instead of giving our financial resources to this Terrorist State, we should sever all ties and use these funds to rebuild our own economy, which is in serious jeopardy. It is scandalous

that we should be giving so much aid to an Oppressor when our returning veterans, who are, in reality, fighting in Iraq to make the Middle East safe for the Israeli State, are receiving very poor health care and financial support.

The time has come for America to end its de facto occupation by Zionist bankers, corporations, warmongers and political insiders, who have exploited America for so many decades. The time has come for America to declare its Independence from Zionism, just as we declared our Independence from the British Crown in 1776. “ Word for Word” Genesis Part 18

Translation by Stephen Howard Anderson



Chapter 28

1. And called Yits'chaq to Yaaqob, and blessed him, and commanded 6680, saying to him, "You shall not take to wife of the daughters of K'naan.

2. Arise, and walk to Padenah-Aram 6307, to the house of B'thuel 1328, the father of your mother, and take for you from there a wife of the daughters of Laban 3837 the brother of your mother.

3. El 410 Shadday 7706 bless you, and make you fruitful, and multiply you, that you become an assembly 6951 of peoples 5971;

4. and give to you the blessings 1293 of Ab'raham, to you and your seedline with you; to

inherit 3423 the land where you sojourn 4033 that gave Elohiym to Ab'raham."

5. And sent away Yits'chaq Yaaqob; and he walked to Padenah-Aram to Laban son of B'thuel the Arammiy 761, brother of Rib'qah, mother of Yaaqob and Esaw.

6. When saw Esaw that blessed Yits'chaq Yaaqob, and sent him to Padenah-Aram to take him from there a wife; and blessed him, and commanded to him, saying, "You shall not take to wife from the daughters of K'naan,"

7. and listened Yaaqob to his father and to his mother and walked to Padenah-Aram;

8. and seeing Esaw that displeasing were te daughters of K'naan in the eyes of Yits'chaq his father;

9. went Esaw to Yish'mael, and took Machalath 4258 daughter of Yish'mael son of Ab'raham, the sister of N'bayoth 5032 besides his *other* wives as a wife.

Yahweh Appears to Yaaqob at B'er-Sheba

10. Went forth Yaaqob from B'er-Sheba, and walked to Charanah.

11. He camped 6293 at a place, and stayed all night 3885 there, because had gone *down* the

sun, and he took *one* of the stones of that place and put it as his head place 4763, and lay down to sleep in that place.

12. He dreamed 2492, and beheld a ladder 5551 standing up 5324 on the ground, and the top of it reached 5060 the sky; and he beheld the messengers 4397 of Elohiym ascending 5927 and descending 3381 it;

13. and behold, Yahweh was standing up upon it, and He said, "I am Yahweh, Elohey Ab'raham your forefather, and Elohey Yits'chaq. The land that you lay down upon, to you I give it, and to your seedline.

14. And shall be your seedline as the dust of the ground, and you shall spread abroad 6555 seaward, and to the east, and to the north, and to the south, and shall be blessed by you all your clans 4940 of the soil of your seedline.

15. And behold, I am with you, and will keep 8104 you everywhere that you walk, and will return you to this soil: for I will not leave 5800 you, until that I have done that which I spoke to you."

16. And awakened 3364 Yaaqob from his sleep 8142, and said, "Surely 403 is 3426 Yahweh in this place; and I did not know it!"

17. He was afraid 3372, and said, "How awesome 3372 is this place! Is not this the House 1004 of Elohiym, and this the gate 8179 of the sky?"

18. And rose up early Yaaqob in the morning, and took the stone that he had put for his head-place, and put it up for a pillar 4676, and poured 3332 oil upon the top of it.


19. He called the name of that place Beyth-El 1008; but 199 Luz 3870 was the name of that city at the first 7223.

20. And vowed 5087 Yaaqob a vow 5088, saying, "If shall be Elohiym with me, and will guard 8104 me in this way that I walk, and give me bread to eat, and clothes 899 to wear 3847,

21. so I return in peace to the house of my father; then shall be Yahweh to me Elohiym;

22. and this stone, which I have placed for a pillar, shall be the House of Elohiym, and of all that You give to me I will surely give the tenth 6237/6237 to You."

Chapter 28 Notes



Verse 1 - Yashar (Jasher) 29:24 Here is the strict command to Yaaqob not to take a Canaanite wife.

Verse 4 - Gen. 17:4-8; Verses 6-8 - Yashar 29:42,43;

Verses 6-9 - Esaw is further angered by Yits'chaq's additional blessing of Yaaqob. When he hears that marrying foreign wives displeases his father, he reacts by taking another wife from Yish'mael's lineage.

Verse 12 - John 1:51; 5551 describes a freestanding ladder, with no visible support. This is a vision, so the physics required for this incredible thing are rendered inconsequential. He sees it, and that is enough.

Verse 13 - Gen. 13:14,15; Yashar 30:1 Yahweh repeats the Promise of the land to Yaaqob and HIS SEEDLINE.

Verse 14 - Gen. 12:3 Yaaqob's seedline shall spread all over, to the British Isles, America, South Africa, and all nations where the Caucasian race resides. This Promise is extended ONLY to his seedline. No other racial group is included. The seed of Qayin cannot farm the soil 127, so this is further proof of the exclusivity of Yahweh's Covenant.

Verse 18 - Here is "The Stone of Destiny" that Yaaqob used for a headrest, and then made into the top of a pillar (monument) to Yahweh. It was used during the coronation of Yis'rael's kings, and later removed to the British Isles and used for the same purpose. The British royals were of

Chapter 29

1. Lifted up 5375 Yaaqob his feet 7272 and walked to the land of the sons of the east 6924.

2. And he looked, and beheld a well in the field, and beheld there three flocks 5739 of sheep 6629 lying down 7257 upon it, because from that well they gave water 8248 to the flocks; and a great stone was upon the mouth 6310 of the well.

3. And gathered 622 there were all the flocks; and they rolled 1556 the stone from upon the mouth of the well and gave water to the sheep and returned the stone upon the mouth of the well in its place.

4. Said to them Yaaqob, "My kinsmen, from where are you?" And they said, "From Charan are we."

5. And said he to them, "Know you Laban son of Nachor?" And they said, "We know him."

6. And said he to them, "Is he well 7965?" And they said, "He is well 7965: behold, Rachel 7354 his daughter comes with the sheep."

7. And he said, "Lo 2005, it is yet 5750 high 1419 day 3117, and not time 6256 to gather the livestock 4735. water the sheep, and go feed them."

8. They said, "We are not able until that gathered are all the flocks, and the y roll 1556 the stone from upon the mouth of the well; then we water the sheep."

9. While he yet spoke with them, Rachel came with the sheep that were her father's, for she shepherded 7462 them.

10. And it was, that when saw Yaaqob Rachel daughter of Laban the brother of his mother, and the sheep of Laban brother of his mother, that went near 5066 Yaaqob, and rolled the stone from upon the mouth of the well, and watered the sheep of Laban brother of his mother.

11. And kissed 5401 Yaaqob Rachel, and lifted up his voice and wept 1058.

12. Told Yaaqob Rachel that he was kindred 251 to her father, and that he was son to Rib'qah; and she ran and told her father.

13. And it was when heard Laban the news 8088 of Yaaqob the son of his sister, that he ran to meet him, and embraced 2263 him, and kissed him, and brought him to his house, and he told Laban all these things.

14. And said to him Laban, "Surely 389 my bone 6106 and my flesh 1320 are you." And he dwelt with him a month 2320 of days 3117.

15. Said Laban to Yaaqob, "Because you are my kin, should you serve me for nothing 2600? Tell me, what should your wages 4909 be?"

16. And had Laban two daughters; the name of the elder was Leah 3812, and the name of the younger 6996 was Rachel 7354.

17. And the eyes 5869 of Leah were tender 7390; but Rachel was beautiful 3303 of form 8389, and beautiful of appearance 4758.

18. Loved 157 Yaaqob Rachel; and he said, "I will serve you seven years for Rachel your younger Daughter."

19. Said Laban, "Better that I give her to you, than give her to another man. Abide with me."

20. Served Yaaqob for Rachel seven years, and it was in his eyes as a few 259 days, because of his love 160 for her.

21. Said Yaaqob to Laban, "Give 3051 me my wife, because fulfilled 4390 is my time 3117, that I may go in unto 935 her."

22. Gathered 622 Laban all the men of the place, and made 6213 a feast 4960.

23. And it was in the evening, that he took Leah his daughter, and brought her to him, and *Yaaqob* went in unto her.

24. Gave Laban to her Zil'pah 2153 his maidservant 8198 to Leah his daughter as a maidservant.

25. And it was in the morning, behold, it was Leah! Said he to Laban, "What is this that you have done to me? Did I not for Rachel serve with you? So why have you deceived 7411 me?"

26. Said Laban, "It must not be done in this place, to give the younger 6810 before the firstborn 1067.

27. Fulfill 4390 her week 7620, and this I will give to you , also this, for service 5656 that you serve 5647 with me yet 5750 seven years afterward 312."

28. And did *Yaaqob* so, and fulfilled her week, and he gave him Rachel his daughter as a wife.

29. Gave Laban to Rachel his daughter Bil'hah 1090 his maidservant as her maidservant.

30. *Yaaqob* went in also unto Rachel, and loved he also Rachel more than Leah, and he served with him yet seven years afterwards.

31. And saw Yahweh that was hated 8130 Leah, He opened 6605 her womb 7358; and Rachel was barren 6135.

32. And conceived 2029 Leah, and bore a son, and called his name R'uben 7205: for she said, "For has seen 7200 Yahweh my affliction 6040; for now I will be loved 157 by my husband."

33. She conceived yet again, and bore a son, and said, "For had heard Yahweh that I was hated, and has given me also this 2088:" and called she his name Shim'on 8095.

34. And she conceived yet again, and bore a son, and said, "Now 6258 this time 6451 will be joined 3867 my husband to me, for I have borne him three sons." Upon this called she his name Lewiy 3878.

35. Yet again she conceived, and bore a son, and said, "Now 6471 I will praise 3034 Yahweh," and upon this called she his name **Yahudah** 3063; and ceased 5975 from bearing.

Chapter 29 Notes



Rachel - Jacob's Beloved Wife

Verse 6 - 7354 Rachel, is pronounced as "Ra-kel" (ch is like a "k" sound);

Verse 15 - *Yashar* (Jasher) 30:12, Laban "sets up" *Yaaqob* by bringing up wages. Later we will see that Laban is not honest in his dealings, and is punished for it.

Verse 17 - Leah looked tenderly upon *Yaaqob*, but he was in love with her beautiful younger sister. Leah's story is a tragic one, as *Yaaqob* was not really sexually attracted to her. He did his "duty", and fathered children by her, but his heart was Rachel's.

Verse 21 - *Yashar* 31:1 , "go in unto" means to consummate the marriage, or to have sex with. It is used this way throughout Scripture.

Verses 23-26 - Laban was a sneaky fellow, and tricked *Yaaqob* with Leah. She was veiled, the tent was dark, and *Yaaqob* probably had a little wine at the party. What a surprise for *Yaaqob* in the morning.

Verse 27 - The term "fulfilling her week" meant to have "relations" with her all week, hoping to impregnate the new bride. He gets Rachel as well, for another seven years of service.

Verse 31 - "hated" here does not mean personal hatred, just lack of attraction, and probably resentment as well. Rachel's beauty, and

Yaaqob's obvious attraction led to jealousy between the sisters later. Leah was seriously in love with Yaaqob, and it showed in the names of the children she bore to him. Poor Leah.

Verse 32 - R'uben means "see a son", from Yahweh "seeing" her affliction.

Verse 33 - Shim'on means "hearing", because Yahweh "heard" that she was hated.

Verse 34 - Lewiy means "attached", as she hoped to be "joined" to her husband.

Verse 35 - Yasher 31:15; Yahudah means "Yahweh is praised", because she praised Yahweh. The ones that follow the Talmud changed both spelling, and pronunciation to hide the Holy Name contained in Yahudah. It will be spelled correctly throughout all my translations.

British Israel Doctrine Problems

Part 3

THE "SHEEP" WHO HAD GONE ASTRAY are the ones whom the Good Shepherd came to seek and to save.

Isaiah 59:20,21 "*And the Redeemer shall come to Zion, and unto them that turn from transgression in Jacob saith the Lord. As for me, this is my covenant with them, saith the Lord; My spirit that is upon thee, and my words which I have put in thy mouth, shall not depart out of thy mouth, nor out of the mouth of thy seed, nor out of the mouth of thy seed's seed, saith the Lord, from henceforth and for ever.*"

It is impossible to spiritualise seed or "seed's seed"; they are genetic terms which are on-going.

There does not appear to be a single reference to any other nation than Israel to whom the Redeemer would come. He is always The Redeemer of Israel and it is, as stated, to be forever. Jesus came to "visit and redeem His People" - [Luke 1:68]. Jesus is the Kinsman-Redeemer of Israel.

There is never any suggestion of any others than Israel being redeemed. From which broken Law-covenant would the other races need redeeming? Recall again how only Israel was given the statutes and judgements and only Israel needed redemption from that Law which they had broken.

We see that the covenant is for all generations to seed's seed of Jacob, and it is to those who turn from transgression in JACOB whom the Redeemer saves. Here again we have the Spirit that is of the anointed race. Israel has, "My Spirit which IS upon thee". This is not commonly taught today. We will see that this is the same presentation as that in the New Testament, believe it or not. This Scripture is not acceptable to tradition. Guess why? It is because racial Israel stays exclusive as being "Jacob's seed".

Of the end of this age we read:—

Jer 50:4 In those days, and in that time, saith the Lord, the Children of Israel shall come, they and the children of Judah together, going and weeping: they shall go, and seek the Lord their God.

A much talked about subject is the re-gathering of Israel which is supposed to be presently taking place in Palestine, but "and at that time" is not the present activity in the Israeli state. What is being established is just who is to be re-gathered. Is it a multi-racial church or is it only the House of Israel and the House of Judah [that is, the Twelve Tribes of Israel]?

The latter is the consistent and frequent Biblical presentation, as it is in the verse above [see also Ezekiel 37:15-28 in particular]. The picture painted is always of a still very exclusive Israel. The House of Israel and the House of Judah are exclusive from the heathen races all around. This shows that at the end of the New Testament age they are still exclusive. So they must be exclusive through the New Testament age, even

until the re-gathering. Note that there is no pattern of prophecy that presents any non-Israel content in the re-gathering, so something must be wrong with the traditional teachings.

Jer 51:19 The portion of Jacob is not like them [that is, Babylon]; for he is the former of all things: and Israel is the rod of His inheritance: the Lord of Hosts is his name.

This completely excludes “Babylon” from God’s inheritance. The timing of this event is at the end of the New Testament age. Again, national Israel must go through the age. Israel is to be the rod over the other races to rule with God. If Israel means “Ruling with God”, we need to ask how all races could be Israelites, if all races are the same!

Ezek 37:26-28; *Moreover I will make a covenant of peace with them it shall be an everlasting covenant with them —and the heathen shall know that I the Lord do sanctify Israel, when my sanctuary shall be in the midst of them for evermore.*

This shows that God’s covenant is with Israel alone, and that the other races will be aware of this when God comes to dwell with His People Israel. The timing, again, is the end of the age at Jesus’ return and when God’s sanctuary is in the midst of Israel and nowhere else.

Daniel 12:1 *And at that time shall Michael stand up— which standeth for the children of thy [Daniel’s] people:—*

At the end of the age it is still only “thy people” who are delivered. Israel is still in existence as a people at the time of the end and through the New Testament age. Michael does not stand up for other races.

Hosea 1:11; Then shall the children of Judah and the children of Israel be gathered together,—

This and other quotations from the Minor Prophets are included to show the “unity of the Scriptures” that always presents the exclusive nature of Israel.

Hosea again defines who is re-gathered, and also the timing. We will see that the children of Judah and the children of Israel are not united until this time. There is no suggestion of there being any

other race, or of a multi-racial “Church” comprising of “Jews and Gentiles”, as being part of the re-gathering of the remnant of Israel in these minor prophets. It is always the two Houses who are re-gathered and come together.



Hosea 14:1-5; *O Israel, return unto the Lord thy God— I will be as the dew unto Israel: —This is at the time of the re-gathering when Israel as a nation returns to The Lord Thy God. [v9, Who is wise —he shall understand these things]. No other race is being asked to return to Israel’s God. Joel 2:27 And ye shall know that I am in the midst of Israel ..*

Joel 3:2; *I will also gather all nations, and will bring them down into the valley of Jehoshaphet, and will plead with them there for my people and for my heritage Israel, whom they have scattered among the nations, and parted my land.*

Again, there is no change prophetically about which nation God is in the midst of or which nation He will be in the midst of at this future time.

Amos 3:2 *You only have I known of all the families of the earth:—*

The word used for “known” cannot be treated fully here, but it does not mean to acknowledge. It is used more as “to recognise as a fact, revelation knowledge” or “to discern” in an intimate and chosen way. Here there is the complete isolation of Israel from the other races.

Note: This is important when we come to the New Testament where it refers to those who were foreknown of God. This identifies the people as being the same nation in both Testaments; those who were foreknown in the New Testament are those who were known in the Old Testament.

Micah 2:12; *I will surely assemble, O Jacob, all of thee; I will surely gather the remnant of Israel: —Are there still any lingering doubts that no other races are ever mentioned at this time of re-gathering?*

Habakkuk 3:13; Thou wentest forth for the salvation of thy People,—

Zephaniah 3:13; *The remnant of Israel shall not do iniquity, —There are a host of other Old Testament Scriptures that could have been quoted. **GOD PLACES HIS NAME ON THE ONE PEOPLE.***

Numerous references refer to “My name” as being placed upon the Children of Israel. For example:

Deut 28:10; *And all the people of the earth shall see that thou art called by the name of the Lord; and they shall be afraid of thee.*



Numbers 6:27; *And they shall put my name upon the children of Israel; and I will bless them.*

Deut 26:19; *And to make thee [that is, Israel] high above all nations which he hath made, in praise, and in name, and in honour; and that thou mayest be an holy [separate] people unto the Lord thy God, as he hath spoken.*

The name of Jehovah [AV The Lord] is exclusive upon Israel as a race. “All the people of the earth” then does not include the Children of Israel, in this case. The name placed upon the Children of Israel who obey God is that of Jehovah Himself. God Himself decides just where He will place His Name, whether it be on a people or a place [Deut 26:2: “which the Lord **THY** God shall choose to place His Name there”].

This separation of Israel from all the other races is always distinct, but their blessing is conditional upon their obedience. We can now look at the New Testament in the light of what we have seen in the Old Testament.

The New Testament Scriptures show no disharmony or change of position from that which is written in the Law, the Psalms and the Prophets. In view of what has been written and shown from the Old Testament, this might be seen for the first time with new eyes.

It will come as a shock for some people to realise that exclusiveness of Israel continues throughout the New Testament, because this cuts across the traditional doctrine that Israel is now “The Church” and that this Church is multi-racial. Redemption from the broken Law-covenant can never be multi-racial or universal, since only Israel was given the Law as a covenant. That is why this foundation has to be shown in detail in the last chapter.

In the quotations made from the New Testament you will note many references to “the fathers” referring to Abraham, Isaac and Jacob. The people addressed in the Acts and the epistles are the children [descendants] of these fathers, the fathers of Israel. It is not just to Abraham in isolation in the way most use this to try to say Abraham’s seed is a spiritual seed.

The harmony mentioned concerning the law being given to Israel is amply confirmed in the New Testament.

Rom 9:4; Who are Israelites, to whom pertaineth the adoption, and the glory, and the covenants, and the giving of the law, and the service of God, and the promises;

So, the promises, covenants and the adoption do not apply to any but Israelites!



Cinderella

Israel in Disguise

CINDERELLA is that old, old Saxon folk tale about the poor little girl in rags and ashes who married the Prince of the realm and lived happily ever after. It has come down to us generation after generation, and it is still cherished and enjoyed.

The story of the little girl with the glass slipper has been printed in numerous books in uncounted versions of the original story. It has been made into plays, movies, cartoons, and television productions; and still the magic of Cinderella lives on. Perhaps it is the hand of God because, you know, there really is a Cinderella, there really is a Prince, there really will be a wedding, and they really will live happily ever after!

Cinderella Story — A Parable

The story of Cinderella is a magnificent, prophetic parable of the Prince of Peace and Israel. As we go along through the story, we shall attempt to explain the real-life characters that fit

in this ancient, yet still unfinished, story, which has survived so long in Anglo-Saxon folklore.

According to the original story, the pretty little girl's mother died and her father remarried. Soon after the stepmother and her two grown daughters moved in, the father left on a long trip. All three of the women were very hard and cruel to the little girl.

She was treated as a servant girl in her own house. Whenever anything went wrong, she was blamed for it and accused of being lazy.

When something she made or did deserved praise, the stepsisters took the credit and the praise for it. She was not even given a bed to sleep in and slept near the open hearth to keep warm.

As a result, she was covered with ashes and the mocking sisters called her "**Cinder-Ella**," or cinder girl. In her trouble and sorrow she wanted to reach her father, but she did not know how to find him to tell him of her degraded and cruel situation.

Before we go further in the old story, I would like to suggest the real-life players in this drama, so that seeing you will see, and hearing you will hear and understand the Bible story so cleverly hidden, yet so simply revealed, in this ancient tale.

The Women Are Identified A clue is given to the identity of the women in the first part of the story. As the father took his leave, he asked the two stepdaughters and Cinderella what they wanted him to bring them from the fair. The eldest asked for beautiful dresses, the younger for pearls and jewels. Cinderella asked only for the branch of a tree.

If we put Cinderella in the role of castoff Israel, literally beyond the visible protection of her Father, we see the eldest daughter as the corrupt, false church of the middle ages with all its pomp and ceremony. Its beautiful dresses, and its desire to keep all under its sway in poverty and rags, mark it as the Roman church.

The other daughter, desirous of riches, is the evil, gold and debt-money system, which has so cruelly ruled mist of the nations of the civilized world for so long. It brings poverty, strife, and tears yet proclaims itself as the source of prosperity and good times, just as the stepsister demands all praise to herself.

That leaves the old mother, and we find her in Revelation 17. She has the identity of both daughters, they being her offspring, and she is described thus: And the woman was arrayed in purple and gold and precious stones and pearls (the younger daughter's request), having a golden cup in her hand (the gold debt-money system— see Jeremiah 51:7) full of abominations and filthiness of her fornication (Revelation 17:\$. Then Revelation 17:4 names her — **MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH.**

She works her evil on Cinderella Israel through her two corrupt daughters, religion and finance. All three combine to rule over Israel.

John writes of her, "And I saw the woman drunken with the blood of saints, and with the blood of the martyrs of Jesus (verse 6). And the Angel answered. The woman which than seest is that great city, which reigneth over the kings of the earth," (verse 18)



The "Branch" Comes To Cinderella

But perhaps you are not satisfied with my identification of Cinderella as Christian Israel. Let's follow her a little more closely. Her father brought home the branch of a tree and Cinderella

thanked him, and went to her mother's grave and planted the branch on it.

The Saxon sage who wrote the tale of Cinderella, said the cruel stepsisters laughed at her because of the branch, but that she wept so much that her tears fell down on it and watered it. It grew and became a handsome tree.

How does this fit Israel? In prophetic Scripture Jesus Christ, who was the Word made flesh, is called The Branch.

Isaiah 11:1 reads, "And there shall come forth a rod out of the stem of Jesse, and a Branch shall grow out of his roots."

Zechariah prophesied, "Thus speaketh the **LORD** of hosts, saying, Behold the man whose name is the **BRANCH**: and he shall grow up out of His place, and He shall build the temple of the **LORD**" (**Zechariah 6:12**)

What happened when the Father sent Jesus, the **BRANCH**, here in the flesh? Hardly a ripple on the pages of then current history! Only a few score thousand of the tens of millions who lived at that time saw Him or even heard of Him.

And when He was to be arrested and put to death He was so little known that His enemies had to have a Judas to identify Him. And what happened to this Branch when it was planted?

Well, the true believers, Christian-Israel, wept, while the religious priests and Jewish rulers scoffed and derided, knowing not what they had done. The immediate persecutions that followed (see *Book of ACTS*) began the tears that watered the **BRANCH** of Israel.

Acts 8 says, "And at that time there was a great persecution against the church— and they were all scattered abroad— (and) went everywhere preaching the Word!"

The "Comforter" Comes To Cinderella

The inspired writer of Cinderella, also, tells us that a white bird lived in the tree that grew from the branch on her mother's grave; and the bird talked to her and comforted her when she was tired from work or weak from the beatings at the hands of her cruel taskmasters.

This white bird is, of course, a symbolic portrayal of the Holy Ghost that came upon Israel after the death and resurrection of Jesus Christ, the Branch. Jesus, in speaking of His leaving, said to His Israelite Disciples in John 14:16:—

“And I will pray the Father, and He shall give you another Comforter, that he may abide with you for ever.”

Then in verse 26,

“But the Comforter, which is the Holy Ghost, whom the Father will send in My Name, He shall teach you all things, and bring all things to your remembrance, whatsoever I have said unto you.”

In all four Gospels, the Spirit of God descending on Jesus is described as a dove descending out of heaven.

The Book of Acts then tells how the Holy Spirit of God was given to the multitudes of Israelites as they believed on Jesus. As the white bird was the comforter of Cinderella, so was the Holy Spirit the comforter of Israel!

Theologians, Please Read

Spirit Came To Israel 1900 Years Ago Many modern theologians do not realize that the Holy Spirit actually did come to Israel long ago. They see that the Jews, whom they believe to be Israel, have rejected both Christ

and the Spirit, and so they think the Holy Spirit instead came to a non-Israel gentile people, the Caucasians. Let us see what the Scriptures say. Turn to Acts 2 — that great chapter about the Holy Ghost at Pentecost.

After the Holy Ghost came on these men, some standing nearby thought they were drunk, as we read in Verse 13:—


“Others mocking said, These men are full of new wine.”

And then in verses 14-16:—

“But Peter, standing up with the eleven, lifted up his voice, and said unto them, Ye men of Judea, and all ye that dwell at Jerusalem, be this known unto you, and hearken to my words: For these are not drunken, as ye suppose, seeing it is but the third hour of the day. But this is that which was spoken by the prophet Joel.”

And then Peter quotes the prophet:—

“And it shall come to pass in the last days, (the time after Christ) saith God, I will pour out of My Spirit upon all flesh: and your sons and your daughters shall prophesy and your young men shall see visions, and your old men shall dream dreams: And on My servants and on My handmaidens I will pour out in those days of My Spirit.”



He was quoting Joel 2:28, and Joel prophesied to whom? To Israel, of course! Both Joel and Peter knew the Spirit was to be poured out on Israel, yet most modern preachers preach that the Jews of today (who do **NOT** have the Spirit) are Israel! (We'll show from this story why they preach that falsehood).

They say that when Christ returns, the Jews will recognize Him as their Messiah and He will pour out His Spirit on them, and then they quote Joel 2:28 as proof. George The Third's Funeral Sermon

GEORGE THE THIRD A True Israelite

2 SAM. III. 38
**KNOW YE NOT THAT THERE IS
A PRINCE AND HAN FALLEN
THIS DAY IN ISRAEL GREAT**

THE ALMIGHTY HAS, of late, in his visitations, given us such lessons on mortality, as our nation has not, for some considerable time, been accustomed to receive. It is within your recollection, how the whole nation, about two years ago, was appalled by the intelligence, that he, with one stroke, cut off two generations of the Royal Family, You, no doubt, now have some sensations similar to those, which you felt on occasion of the funeral of the late Princess Charlotte.

Little more than a year has elapsed since we assembled to contemplate the decease of the late Queen; when we were instructed, that death spares not even Royalty, whether the time of departure out of this life, be desired or not.

The demise of our beloved King has now called us together; and, while we reflect on his death, and the interment of his esteemed remains, we should not forget, that another branch of his illustrious family, has, since the commencement of this year, been called out of time, after an illness of a very short duration.



The particular hour of our assembling, was fixed on with a view, that our minds might be directed to the spot and the circumstances, on which are centred the thoughts of the whole nation; and, that they might be imbued with the profitable instructions, which that place and those circumstances afford. It is true we have not within the observation of our bodily eye, the awful pomp of the funeral procession, the sepulchre opened to receive the Royal remains, the tearful sorrow of the Royal relatives and dependants; nor can we hear the low sounding organ, and the almost faltering voices of the singers, in the performance of the funeral dirge: but the recollection of the accounts that have reached us of the late Royal, interments, will aid our contemplations, and I hope, assist to render our present meeting, truly impressive and profitable.

It is my intention, as much as possible, to let the circumstances and character of our beloved Sovereign preach to you; and, as the variety of incidents relative to our departed, Monarch, and, of his observations, which I shall present to your view, is greater than I could well charge my

memory with, I shall request, on this occasion, to be indulged with the use of notes.

Our text is taken from the remarks of David on the death of Abner, not so much because the circumstances of Saul's relative were parallel to those of our deceased King, as that they will afford me an opportunity to shew:—

- I. That our late King was, in the best sense of the word, in Israel.
- II. That he was a great man in Israel.
- III. That he has fallen in Israel, and now sleeps in Jesus. I am to shew:—



I. That our late King was, in the best sense of the word, in Israel. The Apostle Paul, in writing to the Romans, says, They are not all Israel, which are of Israel; and I believe it possible for a man to talk nicely on religious subjects, hold distinguished offices in an outward and visible church, and even preach the gospel in purity, and yet not be A true Israelite. You will perhaps then ask, "How are we, if this be the real state of the case, to know them that really belong to Israel?" There are infallible tokens of a true Israelite,—tokens necessary, in every instance, to the character of a real child of God, which is what I consider a true Israelite to mean. I will briefly notice these tokens, and endeavour to illustrate our late revered Sovereign's possession of them.

A conscious sense of guilty a sorrow for sin, and a longing desire for pardon, are, I conceive, the incipient experience of all God's children. The degree of consciousness of guilt and sorrow for sin, is not alike in alls this may depend much on the peculiar course, character, and disposition of

the individual, that is the subject of these dawns of spiritual life. But a sense of guilt, and a consequent sorrow for sin, are the unfailing effects of the Holy Spirit's operations; and wherever these really exist, there will accompany them an ardent desire for pardon.

Our late King had these tokens of a child of God; for, when, some years ago, in conversation with a person from whom he had reason to expect, he might derive some spiritual instruction, he lamented the guilty state of his soul, and spoke of his sins with deep contrition, inquiring how he might get rid of the burden, he felt, on being reminded of the regularity of his conduct, and the large sums he expended in charity, he replied, "That is not what I want to hear; I want to hear more of a Saviour." A true Israelite is distinguished:—

2. By, faith in Christ, as able to save to the uttermost all that come unto God by him. With a scriptural idea of the nature of sin, and the holy character of God, we see that there can be no possibility of our performing any expiation of our guilt, which shall be satisfactory to divine justice. And that no mere man can do it for us, is decisively declared in holy writ, in the words of the Psalmist, None of them can by any means redeem his brother, or give to God a ransom for him.

Yet a Redeemer if spoken of, and described in the Old Testament in such a manner, as, with the writings of the Evangelists and Apostles in our hands, to lead us to Christ, God manifest in the flesh; and to his blood and righteousness, the sure foundation of a sinner's acceptance with God. He was wounded, bruised, and slain, after having, by a spotless life, magnified the law, and made it honourable. Thus he loved his people unto death; and when his dying is spoken of, it is recorded as a condescending act of wonderful humiliation, in these words:—

He humbled himself and became obedient unto death, even the death of the cross.

It is also recorded as an act of his power:—

No man taketh my life from me; but I lay it down of myself I have power to lay it down, and I have potter to take it again.

Faith beholds in his death an almighty efficacy, rendering the harmony of the attributes of God

apparent, and the sinner acceptable in his sight. It sees a virtue in his blood, fully suited to the cleansing and healing of the sinner's soul.

Upon this point, I will quote, in reference to our deceased Monarch, the remarks of a gentleman, who was in the habit of close and official attendance on the late Princess Amelia, during her whole illness. "His Majesty speaks to his daughter on the only hope of a sinner being in the blood and righteousness of Jesus Christ! He examines her as to the integrity and strength of that hope in her soul with calmness and delight to the conversation of her venerable parent, and replies to his questions in a very affectionate and serious manner.

If you were present at one of those interviews, you would acknowledge with joy, that the gospel is preached in a palace, and that under highly affecting circumstance. Nothing can be more striking than the sight of the King; aged and nearly blind, bending over the couch, on which

the Princess lies, and speaking to her about salvation through Christ, as a matter far more interesting to them both, than the highest privileges and most magnificent pomp of Royalty, A true Israelite is known,


3. By a due reverence for God, and ardent prayer to him for every blessing calculated to aid his spiritual growth. Who is there that has become acquainted with his sins and guilt, and has perceived an almighty efficacy in the atonement of Christ, that can think lightly, or irreverently, of God; or does not, with ardour of soul, beseech him for his blessing. Attracted by the love of God, displayed in the gift of his Son, and the bestowment of his grace, in the influence of the Holy Spirit and faith in Jesus, the believer humbly adores the Lord, and delights in communion with him. And when the heart is a line to its true interests, nothing will be permitted to interfere with the seasons of this sweet employment.

When Was The Beginning? (Part 2)

Returning to our Genesis Scripture:



GEN 1:2 (Cont.) through verse 5 [Verse 2(b) Cont.] –And the Spirit of God moved upon the face of the waters. (Vs.3) And God said, Let there be light: and there was light. (Vs. 4) And God saw the light, that it was good: and God divided the light from the darkness. (Vs.5) And God called the light Day, and the darkness he called Night. And the evening and the morning were the first day . . . (KJV)

It is not written how much time transpired between the destruction of the first earth age and the rejuvenation of the earth for the second earth age. God was very angry, we will learn why

later in this study. And this flooding of the waters should not be confused with Noah's flood. As we will learn further on in this study, this particular destruction and subsequent overflowing of the waters, was complete and total, and **nothing** or **no-one** survived it! In the flood of Noah, we know that Noah, his family, and at least two of every flesh that were brought aboard survived.

The first earth age was inhabited by us, by our souls in a different form, there were no flesh human bodies then (animals yes). In that first earth age we all had spiritual bodies, in this earth age we have flesh bodies because we were created and formed from the dust of the earth.

When God destroyed that first earth age, the souls, the spiritual bodies returned to the Father (God), just as we do when we die in this earth age. But spiritual bodies leave no organic remains. When we die today, only our organic remains (flesh and bone) remain to be buried. Our soul, our spiritual being or spiritual body so to speak, returns instantly to the Father whom gave it.

In this present second earth age we have two bodies, one within the other, and they can only be separated by death. In the first earth age we only had the spiritual bodies.

You know that when someone dies today we bury their body, but their soul goes back to God that gave it. It is this soul that will be judged either to Heaven or "Hell". But the deceased flesh that we bury simply rots back to the dirt and minerals that they are formed of.

Your spirit (your intellect) and your soul will either live forever or will be consumed in the lake of fire (Hell). Just as you will never find or see any physical remains of someone's soul, or spiritual body; neither will you find physical remains of those spiritual bodies that inhabited the earth in the first earth age.

You will however, find the remains of their existence; the markings, tools, and the residue of settlements. But the spiritual bodies went back to the Father, and are now in the process of going through this second earth age, in flesh bodies. There is a reason for this (*explained further on in this study*).

Every soul goes through each earth age **only one time**, but it is the same one soul! Use this as an analogy: At one time we were all infants, then children, and eventually adults, but it was always us, the same one person.


OK, now that we can see that there was an earth age before this one, chronologically transpiring between *Genesis 1:1 and 1:2*, let's examine why there had to be the second (our present one).

There is very little written of that first earth age, but we will examine a couple of places where it is spoken of. The key to understanding that there was an earth age before this one is in understanding why God destroyed that first earth age and Created this one.

God does not do anything without a reason and in understanding why He destroyed that first earth age we can know with a surety that it did in fact once exist.

There are to be three earth ages altogether. We know that we live in one and that "Heaven" is another one, so it should not be surprising that there was one before our present one. All Souls, all of us, were present in that first earth age but God does not allow us to retain knowledge of it.

He places a veil between that age and this one so that none of us could recollect it. That may have something to do with the fact that Scientists tells us that we only use approximately 9% of our brains (exact percentage disputed). In the eternity (Heaven) we will have full recall of all three earth ages, and full use of our intellect. There is no mental retardation in a spiritual body, nor is there disease and malformation, the spiritual body does not even age.



In that first earth age in which all our souls lived, Satan rebelled against God and led one third of God's children to fight against him - *Rev 12:4 "And his tail drew the third part of the stars of heaven, and did cast them to the earth"*.

As stated, in this first earth age we were all in spiritual bodies. We were not born of woman like we are in this earth age, in fact there are no female forms with spiritual bodies, nor do they age, which is why whenever there is a report in the Bible of an Angel it is always described as a young male.

That doesn't mean that the females that are in this earth age didn't exist then, it just means that in spiritual bodies there is no need for pregnancy and physical birth, thus we were all in the same form, having no female gender. See *Luke 20:28-38*, Specifically:

Luke 20:34-36; 34 And Jesus answering said unto them, The children **of this world** marry, and are given in marriage:

35 But they which shall be accounted worthy to obtain **that world** and the resurrection from the dead, **neither marry, nor are given in marriage**:

36 Neither can they die any more: for they are **equal unto the angels**; and are the children of God, being the children of the resurrection. KJV

Today we are *children of men*, born of women, but in Heaven (the third age) we shall be *children of God*, not born of any woman. We shall be "*equal unto the angels*" which means *the same as the angels*.

Angels have no female gender, and neither shall we in the angel's realm, which is the realm of God, which is eternal; no death, no birth in heaven, thus, no need for the female form (gender). Today we are perishable, liable to die, going to die someday; flesh dies, spirit does not (unless God blots it out in the Lake of Fire after Judgment Day).

That brings to mind the absurdity of the *feminist's* rendition of Almighty God as a female with breasts. The only female *gods* are the false nonexistent goddesses of pagan idolatry, I hope for the feminist's sake that God winks at their ignorance.

This is no knock on the female gender either, females are great, it is just that being *male* carries no significance if there is no *female*; just like being *single* would mean absolutely nothing if no one were *married*. This also condemns, as errant, the *Marian Worship* of the Catholics. And the so-called *Marian Apparitions* are merely demons in disguise.

To understand this you cannot think in the flesh of this present male and female gendered *second earth age*, you have to look at it spiritually. For in Heaven (the third age) we will all be in spiritual bodies and not flesh bodies; and likewise we were all in spiritual bodies in the *first*

earth age. Do not confuse this with reincarnation, reincarnation does not exist, it is just a lie from Satan to make the heathen believe that they are not accountable to Almighty God on judgment day for their actions. There 'gonna' *reincarnate* alright, right into the Lake Of Fire if their not careful! The Reincarnationist New-Age Religionists would do well to absorb *2 Cor 5:10 & 11* (below). Let's learn from Apostle Paul of the flesh body and the Spiritual body:

1 Cor 15:44 It is sown a natural body; it is raised a spiritual body. There is a natural body, **and there is a spiritual body.** (KJV)

2 Cor 5:6-11 Therefore we are always confident, knowing that, **whilst we are at home in the body, we are absent from the Lord:**



7 (For we walk by faith, not by sight:)


8 We are confident, I say, and willing rather to be **absent from the body, and to be present with the Lord.**

9 Wherefore we labour, that, whether present or absent, we may be accepted of him.

10 For we must all appear before the judgment seat of Christ; that every one may receive the things done in his body, according to that he hath done, whether it be good or bad.

11 Knowing therefore the terror of the Lord, we persuade men; but we are made manifest unto God; and I trust also are made manifest in your consciences. (KJV)

In this great war in Heaven which brought about the destruction of the first earth age, Satan and his misguided bunch of blasphemers of course lost. God destroyed that first earth age. Your best documentation of that first earth age would be in the best account of it's destruction, found in the book of Jeremiah:



Jer 4:22-27 For my people is foolish, they have not known me; they are sottish children, and they have none understanding: they are wise to do evil, but to do good they have no knowledge.

23 I beheld the earth, and, lo, **it was without form, and void; and the heavens, and they had no light.**

Here you see a second Scriptural witness to *Genesis 1:2*, this lets you know that we are talking about the destruction of the first earth age. This destruction was brought about by water, just as with Noah's flood, but should not be confused by Noah's flood; they were two different events.

24 I beheld the **mountains, and, lo, they trembled, and all the hills moved lightly.**

This is thought by some (including us) to be the cause of the earth being *off-kilter*. It is a fact that the earth spins on an axis that is 23½ degrees of centre, and also that True North and Magnetic North are several degrees apart; the number of degrees varies depending where on earth you take the measurement.

25 I beheld, and, lo, **there was no man**, and all the **birds of the heavens were fled**.

We see in verse 25 above: "*there was no man*" and "*all the birds of the heavens were fled*", that we are not talking about Noah's flood here. For

Noah, his family, as well as sets of every flesh animal, including birds, passed through the flood!

26 I beheld, and, lo, the fruitful place was a wilderness, and **all the cities thereof were broken down** at the presence of the LORD, and by his fierce anger.

We also see that the first earth age was inhabited, and even had cities: "*all the cities thereof were broken down*". Are there any remains of these cities left today? Well there is some work being done on the ocean floor, but the results are not in.

There seem to be city grids well beneath the ocean surface in one place. This is possible as with the destruction of the first earth age in *Genesis 1:2(a)* (i.e., the first half of verse) "*And the earth was without form, and void; and darkness was upon the face of the deep*", and the subsequent rejuvenating of it in *Gen 1:2(b)* "*And the Spirit of God moved upon the face of the waters*" there may well have been a massive shift of the land masses.

27 For thus hath the LORD said, the whole land shall be desolate; **yet will I not make a full end.**

God said that the ruin of that first earth age wasn't the end; thus we have this second earth age in which we live now.

So when you understand that God wholly destroyed the earth with water *before* Noah's Flood, then much difficulty is removed from many Scriptures.

The destruction from Noah's Flood was nowhere as complete as the first destruction, as we seen. After Noah's Flood God promised to never destroy the earth with water again "*...neither shall there any more be a flood to destroy the earth.*" (*Gen 9:11*). (Next time he shall use fire).

Our Jeremiah Scripture above was the destruction of the first earth age in God's own words through the Prophet Jeremiah. God was very

angry at his creation because they had tried to overthrow Him. But he would have had to destroy one third of his children that had joined Satan and rebelled against him *Rev 12:4*, and He did not want to do that. If you had three kids, no matter how much they betrayed you, could you bring yourself to kill one of them?

So this second earth age, this flesh earth age, became necessary so as to allow every soul to come through it and make a choice between following God or following Satan. Those are the only two choices, and if you do not make a conscious choice to love and follow God through Jesus Christ, then you have made an unconscious choice to follow Satan with the ways of this world.

God placed a veil between this earth age and the first so that we cannot know what side we were on in that revolt, nor do we possess any memory of it. Once again, I must stress that this is not saying there is any reincarnations; the very concept of re-incarnation is blasphemy to God and Jesus Christ!

Where else in God's word do we see mention of the three separate earth ages?



This was the first earth age. The one God had to destroy because of revolt.

7 But the heavens and the earth, which are now, by the same word are kept in store, reserved unto fire against the day of judgment and perdition of ungodly men. (This is this present earth age (second) that we live in now).



8 But, beloved, be not ignorant of this one thing, that one day is with the Lord as a thousand years, and a thousand years as one day.

9 The Lord is not slack concerning his promise, as some men count slackness; but is long-suffering to us-ward, not willing that any should perish, but that all should come to repentance.

10 But the day of the Lord will come as a thief in the night; in the which the heavens shall pass away with a great noise, and the elements shall melt with fervent heat, the earth also and the works that are therein shall be burned up.

11 Seeing then that all these things shall be dissolved, what manner of persons ought ye to be in all holy conversation and godliness,

12 Looking for and hasting unto the **coming of the day of God**, wherein the heavens being on fire shall be dissolved, and the elements shall melt with fervent heat?

13 Nevertheless we, according to his promise, look for new heavens and a new earth, wherein dwelleth righteousness. (KJV)

This is the third age yet to come (commonly referred to as Heaven).

But if we go to war with Russia because Mrs May is a complete bloody idiot just trying to look big in front of the EU who have been pushing against Russia for a long time now.





A Letter Sent to Jack Straw in 2009, But Still Relevant Today



The Rt. Hon. Jack Straw MP Lord Chancellor, Justice Minister and Secretary of State for Justice

Sir __, In view of your comments on BBC Radio 4 concerning the “Peers for hire” debacle, which included measures to expel and punish any member of either the House of Lords or the Commons for law breaking, may I ask what you intend to do about lawyers and bankers placing false affidavits into court, forging documentary evidence, falsifying accounts, making fraudulent claims in pleadings and general dishonesty in proceedings?

Concern has oft been expressed by members of “the executive” and the general public at large about a declining confidence in the legal system both criminal and civil, the latter in particular, where the public perception is one of unreliability, careless attitude and downright dishonesty.

I am in contact with many people who have experienced such things as false statements, false affidavits, forged and altered documents, false accounting and general perjury being used by lawyers in the courts of law, and such false instruments being accepted by the judges to obtain illegal orders.

When such matters are brought to the attention of the judges one is met with outright hostility, “I prefer the other sides version of events!”

To continue in ones efforts to attain a just outcome is to risk having a Section 42 order imposed upon further litigation, or, perhaps being sectioned under the Mental Health Act; perhaps a false bankruptcy is needed to stop further litigation which would otherwise expose the criminal connivances between lawyers, bankers and judges.

The 1968 Theft Act is specific in the punishment permitted for destroying documents lodged in court files, yet courts are deliberately destroying files and records in order to cover up wrong doings such as that described above. Such destruction of files is indeed done before a matter is fully settled.

The principle judge in the Leicester court distributed a memorandum to court staff instructing them that under no circumstances must court records be shown to anyone including lawyers. This is contrary to the Rules of the Supreme court Order 63 and contrary to the perception of transparency.

The excuse used against a complainant is that a judge can do whatever he likes in his own court, and, judges are independent of the executive.

I will greatly appreciate your comments upon such matters as I have outlined in this letter. I can confirm that we have all documentary evidence to prove criminality by leading solicitors, one in particular acting for a once leading high street bank, and one acting upon the instructions of the Law Society to ditch a case against an errant solicitor by whatever means available.

Those means resulted in illegally obtaining a bankruptcy order against the client. While those who administer justice are abusing the trust placed in them by the citizen then justice is compromised and ceases to be a key component of a civilised society.

It is my earnest hope, that as Justice Minister you will give these matters urgent consideration.

Reply

Dear Mr Talbot-Jenkins, Thank you for your letter of 8 February addressed to the Rt. Hon. Jack Straw MP outlining your concerns about

solicitors and court officials. Your letter has been forwarded to the Legal Services Regulation and Redress Division at the Ministry of Justice, as we are responsible for the policy in this area.

I should explain that the legal profession is independent from the Government and self-regulating, and therefore neither Ministers nor their officials are able to comment on or intervene in individual cases. However, I hope it will be useful if I provide some background information on the matters you raise.



Solicitors must govern their practice and conduct in accordance with the Solicitor's Code of Conduct 2007 and the Solicitors Regulation Authority (SRA) is the professional body responsible for ensuring action is taken against solicitors who do not comply with the rules of conduct. Under the Code of Conduct, solicitors not only have duties in relation to their clients, but also to the court.

Under Rule 1.01, it is a core duty of a solicitor to uphold the rule of law and the proper administration of justice. In addition, solicitors must act with integrity. Furthermore, a solicitor must never knowingly or recklessly mislead the court (Rule 11.01). The SRA's guidance on the rules relating to litigation and advocacy, give examples of deceiving or misleading the court as:-

- A)** submitting inaccurate information or allowing another person to do so;
- B)** indicating agreement with information that another person puts forward which you know is false;
- C)** calling a witness whose evidence you know is untrue;
- D)** not immediately disclosing a document you have become aware of during the

course of a case, which should have been, but was not disclosed;

E) attempting to influence a witness, when taking a statement from that witness, with regard to the contents of their statement and

F) tampering with evidence or seeking to persuade a witness to change their evidence.

If a solicitor fails to observe the professional rules of conduct, the SRA is empowered with a range of disciplinary, including reprimanding the solicitor and putting restrictions in place as to how the solicitor can work.

In the most serious or persistent cases of a solicitor's misconduct, such as suspected dishonesty, a criminal conviction, or mishandling clients' money, the SRA can refer these matters to the Solicitors Disciplinary Tribunal (SDT).

The SDT has the power to strike solicitor's names off the roll. The SDT is wholly independent from the Law Society and its principal function is to hear and determine applications in respect of allegations against solicitors of inappropriate conduct, or breaches of the rules relating to professional practice, conduct and discipline. The SRA refers the majority of applications to the SDT.

In relation to your complaints about the conduct of the judiciary, I should explain that the Lord Chancellor has joint responsibility with the Lord Chief Justice for judicial conduct and discipline and are assisted in this role by the Office-for Judicial Complaints (OJC).

Their responsibilities cover matters relating to allegations of personal misconduct in the way that a judicial office holder has behaved, whether inside or outside of the courtroom. I should point out that the Lord Chief Justice, the Lord Chancellor and officials in the OJC are not able to consider or intervene in complaints about judicial decisions or judicial case management.

The only way in which a judicial decision can be challenged is by appeal to a higher court. Judicial decisions include, but are not limited to, the way in which proceedings are handled, which

matters should be considered, which evidence should be heard, and decisions taken in relation to costs.

Whilst not meant to be an exhaustive list, examples of potential misconduct would be rudeness, aggressive behaviour and the use of insulting, profane, racist or sexist language.

It is part of a judge's role to decide which evidence they prefer. The Lord Chancellor and Lord Chief Justice are unable to approach a judge on decisions that they have made on the outcome of a case or how it should progress. Similarly, neither the Lord Chancellor or Lord Chief Justice can initiate investigations into allegations of criminal behaviour and neither can a judge presiding over a case. Criminal allegations can only, and must, be directed to the police in the first instance. If a judicial office holder were subject to a criminal charge or criminal conviction, the Lord Chancellor and Lord Chief Justice would then consider the impact of that on their judicial office.

It will be of interest to you to know that the Government has acknowledged the present state of affairs with regards to regulation of the legal profession could conceivably be seen as not being in the best interests of the consumer. As such the regulation of legal services was overhauled in England and Wales through the introduction of the Legal Services Act 2007.

The Legal Services Act 2007 provides for the creation of the Legal Services Board, a single oversight body, independent of both Government and the legal professions. It will be a publicly accountable body with the power to enforce high standards in the legal sector,

replacing the current maze of regulators with overlapping responsibilities. Its chair and the majority of its members will be lay persons. The overall aim of the LSB is to improve the delivery of

legal services to the general public, and to businesses, by providing consistent oversight regulation to the legal services sector, and improving performance by ensuring that the Approved Regulators carry out their functions to the required standards. Importantly, the Act introduces regulatory objectives that will guide the newly established Legal Services Board (LSB), Office for Legal Complaints (OLC) and approved regulators in exercising their functions. This includes protecting and promoting the interests of consumers, and promoting and maintaining adherence to the professional principles.

The Act will also establish a single and fully independent Office for Legal Complaints (OLC). Its chair and the majority of its members will also be lay. The OLC will administer an ombudsman scheme providing a single point of entry for consistent handling of all consumer complaints about providers of regulated legal services. This will replace the current system whereby complaints against the different types of legal professionals are handled by their own representative bodies. Irving's nemesis, Deborah Lipstadt meanwhile, has taken it upon herself to deny the holocaust casualty figure of 100,000 for Dresden, but God help any one of us who would have the temerity to doubt the Six Million casualty figure of Holocaustianity, or even to apply the word "holocaust" to what happened in Dresden.

We challenge any reader to collect the legacy media's descriptions of the bombing of Dresden from the 1990's onward and count how many term it a holocaust.

The extent to which we are imprisoned in an Orwellian dystopia of our own making is revealed when we consider the fact that it is regarded as highly insensitive or indeed "anti-Semitic" to violate the self-appointed Newspeak holocaust trademark appropriated by the Holy People, and apply it to the German cities that were incinerated, or to Hiroshima and Nagasaki, even though those war crimes were genuine holocausts by dictionary definition: "Destruction or slaughter on a mass scale, especially caused by fire. This writer is sometimes accused, as a researcher in the field of the Babylonian Talmud, of seeing the Talmud where it is not. It is not so much the Talmudic texts themselves that we observe in our society, but the results of their influence. The single most remarkable dimension of Talmudic *halacha* is its narcissistic exceptionalism, born of the self-worship it inculcates.

Prof. Lipstadt, who has made an career out of stigmatising anyone who doubts any aspect of the "Holocaust" narrative, as a diabolic "Holocaust denier," is free to deny, without negative consequences, the holocaust in Dresden, because of her exceptional status as one of the Holy People. She may do as she likes with history, in ways that the rest of us may not.

For that reason alone we cannot respect the religion of Holocaustianity. It is not history. It is a product of Talmudic megalomania. Few of us tolerate fanatical egoism from Catholics, Protestants or Muslims.

Franklin Roosevelt directed against the cultural treasure houses of western civilization, in cities like Dresden. They tossed a match into Dresden as casually as a drooling meth addict would torch an apartment building for revenge on the landlord who had evicted him.

Yet “conservative Christian” American university professors and administrators in institutions of higher learning such as Michigan’s esteemed Hillsdale College, which is the recipient of millions of dollars in donations from “Conservatives” seeking to preserve western civilization, have hallowed Churchill into a paragon of decency, courage and western leadership. 

The Real Holocaust: The 1915 Armenian Genocide and its Russophobic Origins From Our West Midlands Correspondent

J. von Bernstorff (German ambassador); "The way the Armenian problem was solved was hair-raising. I can still see in front of me Talaat's cynical expression, when he emphasized that the

Armenian question was solved." **Einar af Wirsén (Swedish Diplomat)** "When I kept on pestering him about the Armenian question, he once said with a smile: 'What on earth do you want? The question is settled, there are no more Armenians'".

Henry Morgenthau (American Ambassador (He was Jewish)); "Whatever crimes the most perverted instincts of the human mind can devise, and whatever refinements of persecution and injustice the most debased imagination can conceive, became the daily misfortunes of this devoted people. I am confident that the whole history of the human race contains no such horrible episode as this. The great massacres and persecutions of the past seem almost insignificant when compared with the sufferings of the Armenian race in 1915."

On May 30th 1915 Talaat Pasha issued the Tehcir Act, which on paper was a security measure the Turks put forth to prevent a Russian-Armenian revolt by forcibly relocating the nationals of

Armenia to Mesopotamia and Syria. This was the story the Young Turks told the world to avoid and minimize any public disapproval or foreign resistance. The relocations involved disarmed Armenians being forcibly marched to camps in the inner deserts of Anatolia and Syria, and these camps were not stocked with necessary supplies for survival.

The properties of these people were confiscated and sold to new arrivals, the men were often singled out to be killed first, and the women were often enslaved and raped en masse.

The accusation of Russian-aligned rebellion was used as justification and cover. American Ambassador Henry Morgenthau frantically remarked;

"Have you received my 841? Deportation of and excesses against peaceful Armenians is increasing and from harrowing reports of eye witnesses it appears that a campaign of race extermination is in progress under a pretext of reprisal against rebellion.


Protests as well as threats are unavailing and probably incite the Ottoman government to more drastic measures as they are determined to disclaim responsibility for their absolute disregard of capitulations and I believe nothing short of actual force which obviously United States are not in a position to exert would adequately meet the situation."

A confession is considered as valuable only if it contains some true and verifiable details of the crime the investigator did not know of. This rule of criminal investigation was observed in the controversial telegram transcriptions written in The memoirs of Naim Bey.

On March 25, 1915, Talaat states: "It is the duty of all of us to effect on the broadest lines the realisation of the noble project of wiping out the existence of the Armenians who have for centuries been constituting a barrier to the Empire's progress in civilization."

What events led to these horrific genocide and near destruction of the Armenian people, and why are the Armenian people important for European history?

Did it happen, or didn't it, and who was behind it? Armenians are an ethno-linguistic-religious



group distinct from their surrounding neighbours. They have their own church, the Armenian Apostolic Church, which was founded in the 1st century AD, and became in 301 AD the first branch of Christianity to become a state religion.

They have also their own alphabet and language which is classified as an independent branch of the Indo-European language family. The historical homeland of the Armenians sits north of the Fertile Crescent, a region of substantial importance to modern human evolution. Genetic and archaeological data suggest farmers expanding from this region during the Neolithic populated Europe and interacted/admixed with pre-existing hunter-gatherer populations.

Furthermore, Armenia's location may have been important for the spread of Indo-European languages, since it is believed to encompass or be close to the Proto-Indo-European homeland (Anatolia or Pontic Steppe) from which the Indo-Europeans and their culture spread to Western Europe, Central Asia and India.

The Holocaust of the Armenian people wasn't simply stopped at the borders of Turkey; Ottoman troops by the Young Turks insistence had also invaded Persia. During this invasion Christian Armenians and Assyrians alike were slaughtered.

In fact, approximately half of Persia's Christian Assyrians alongside about four-fifths of the Christian Assyrian leadership were killed during this time by Turkish and Kurdish invaders.

Two months after the (largely Jewish led) Bolshevik revolution the new Russian government began withdrawing Russian troops from the Caucasus. This withdrew the only ally the Armenians had and put their remaining people at risk of extinction. At this time the last refuge for these people was the small remaining

unconquered land of historic Armenia centred around Mount Ararat.



Mount Ararat is traditionally the Christian-accepted location of Noah's Ark in the Book of Genesis. Armenia was the first Christian country in the world.

The Armenian language is the most ancestral, oldest Indo-European Language left since the extinctions of its Indo-European predecessors Anatolian and Tocharian. It's hard to overstate the ethno-cultural significance in this event threatening complete extermination of the most ancestral Indo-European speakers and also the most ancestral Christians.

Much of the Armenian highlands were lost; Western Armenia was renamed "Eastern Anatolia" by the invaders. With the survivors and refugees concentrated in Caucasia the impending invasion threatened complete annihilation.

The Christian leader Catholicos Gevorg V ordered Church Bells to peal for six days as all classes of Armenian people were called to take up arms with the women and children readying supplies and the entire survivors of the nation prepared for total war. The President of the Armenian assembly stated "If we are to perish, let us perish with honour."

In the battles of Sardarabad, alongside Abaran and Karakilisa, the outnumbered Armenians managed to defy the odds and fight off the Turkish invaders. Historian Christopher Walker remarked that with a loss at Sardarabad "it is perfectly possible that the word Armenia would have henceforth denoted only an antique geographical term."

The Destruction of Armenians in the Ottoman Empire resulted by most estimates with 1.5

million of the 2 million Ottoman Armenians being exterminated.

The history of Armenia is intertwined with that of Europe and Russia especially. Russia had generally had an Armenian presence through its history but after the Russo-Persian wars in 1828 Russia annexed parts of the historical Armenian nation. Since that time Russia has generally defended the rights of Christian minorities in the Ottoman lands.

Russian foreign minister Sergey Lavrov is perhaps the most visible example of a Russian Armenian given that he was born to an Armenian father.

But the Armenians had, for the most part, been very well integrated in the empire as well. Armenians were formerly dubbed the "loyal millet".

The Armenians opportunities in the region arguably increased with the transition from Greek Byzantine rule to Ottoman rule. Armenian villages traditionally had a high degree of autonomy as well. Any sort of separatist nationalism would seem unviable, and the main Armenian conflicts with the Ottoman Muslims were based about regional autonomy and protection from bandits.

The primary Armenian political organizations with public protests were advocates pushing for autonomy such as the 1890's Kum Kapu demonstration. These requests were quite reasonable as the Armenians had suffered various attacks and murders from Muslim Kurds and other bandits who, by the Ottoman empires laws, held legal superiority in court.

During this time the Sultan Abdul Hamid II attempted to shed the "sick man of Europe" label his failing Ottoman Empire had by encouraging a modernization of the Empire, which required a stronger and more centralized government role in citizens affairs.

Abdul Hamid II was attacked in the British press as the "Red Sultan" for various atrocities committed against minorities such as Armenians and for all intents and purposes was the perfect archetype of a Tyrant.

The Young Turks who sought to overthrow him by contrast were revolutionaries. They shouted

their slogans of “Hürriyet, Musavat , Uhuvvet” inspired from the French “Liberté, égalité, fraternité” meaning “Liberty, Equality, Fraternity”.

Turkish ethnicity is often described as a "melting pot" of all Anatolian people ranging from the gene pools of the Balkans, Anatolia, and parts of Asia."



The Young Turks were also rationalists (above) following a materialist ideologies like positivism which they prioritised over religion; The Islamic authorities the Ulama even denounced them as "trying to change Islam into another form and create a new religion while calling it Islam".

The Ottoman Empire was historically a place where Jews could live without fear of persecution according to one of the Erdogan aligned newspaper the Daily Sabah.

Indeed this tolerance extended into the post-Sultan era of the Young Turks, as the Encyclopaedia Judaica noted that various Zionist groups were hopeful in 1908 for opportunities to press their interests; “the absence of anti-semitism in Turkey made the idea [Jewish settlement in Palestine] possible”.

Talaat specifically was very open to these ideas; "Four years later Talaat even propagated the fantastic idea of a ‘Muslim-Jewish Alliance.’ The Balkan wars had plunged the Ottoman Empire into financial ruin and Talaat, who became a key member of the CUP's ruling triumvirate following the military coup of January 1913, expected the Zionists to link the empire with the fabulous wealth of ‘world Jewry.'"

Knowing this background of the states historical pluralism, alongside the progressive and secular motto of the new government and its noted tolerance of Jewish minorities, one has to ask

how a genocide could have even been possible. How could such a progressive government proceed to horrifically genocide many of the states indigenous Christian populations?

If we take a closer look at the killings we come across many disturbing disparities in the treatment of these minority groups. After all in the Great fire of Smyrna catastrophe of 1922 the Christian Armenian and Christian Greek sections of the city were destroyed while the Jewish and Turkish sections were not.

In 1918, three years after the passing of the Tehcir law, Talaat Pasha made a Turkish Balfour declaration equivalent expressing support for the establishment of Jewish Palestine. Clearly it is a strange sort of nationalism the Western world is unfamiliar with when the Jewish minorities are spared.

The Armenian Holocaust was not only unexpected by the victims but in fact it is still to this day denied by the perpetrator state Turkey. And until recently, the execution of the genocide itself was only known by third party observers, with the state of Turkey claiming the genocide was really just a civil war.

The only direct evidence of intentional genocide were in translated telegrams written in the 1921 published The Memoirs of Naim Bey which lost much of the source material telegrams.

In October 2016 however Prof. Taner Akçam found archived Ottoman telegrams confirming the legitimacy of various events from The Memoirs of Naim Bey and confirming that they were not mere fabrications for propaganda.

This legitimacy was confirmed further when the “smoking gun” of April 2017 was discovered, an original telegram directly inquiring over the murder of Armenians. The official Young Turks government telegram asks directly if the deported Armenians are being killed or “merely sent off and deported”.

“Are the Armenians who were deported from there being liquidated? Are the troublesome individuals whom you have reported as having been exiled and expelled been eliminated or merely sent off and deported? Please report honestly.”

This is a telegram with an Ottoman letterhead and with the Ottoman coding system acquired by an Armenian Catholic priest, Krikor Guerguerian.

He held the evidence in a private archive wherein it was secured by his nephew. The issue being re-raised has re-opened conflicts between Turkey and the international community. During the Western progressive-leftist worlds drama over President Donald Trumps Holocaust remembrance statement of “11 million”, an angry and emotional response from the Jewish Telegraph Agency made some very interesting admissions on the Jewish Holocausts history.

The “5 million” has driven Holocaust historians to distraction ever since Wiesenthal started to peddle it in the 1970’s. Wiesenthal told the Washington Post in 1979, “I have sought with Jewish leaders not to talk about 6 million Jewish dead, but rather about 11 million civilians dead, including 6 million Jews...”

“I said to him, ‘Simon, you are telling a lie,’” Bauer recalled in an interview Tuesday. “He said, ‘Sometimes you need to do that to get the results for things you think are essential.’”

Bauer and other historians who knew Wiesenthal said the Nazi hunter told them that he chose the 5 million number carefully: He wanted a number large enough to attract the attention of non-Jews who might not otherwise care about Jewish suffering, but not larger than the actual number of Jews who were murdered in the Holocaust, 6 million.

With the newly opened international drama of the Armenian Holocaust denying Turkish government, we can find some interesting admissions of the origins of the Young Turks revolution. The Young Turks Revolution broke out in Salonica.

Salonica was the largest Jewish city in the world at this time with Jewish people constituting over half the population. According to a prominent Turkish Newspaper in a very recent article on October 13th 2017;

“The most prominent financier and mentor of the Committee of Union and Progress (CUP), which seized the government in 1908, was a Jewish banker of Italian origin from

Salonica, Emmanuel Carasso. When Greeks, who had held a privileged status up until then, fell into disfavor after the Constantinople massacre of 1821 targeting Greeks, Jews were hoping for a second chance.

However, with their art facilities scattered around Anatolia, Armenians came in first thanks to their capital surplus. As a result of the Jewish lobby's recommendations, the Young Turks government removed Armenians from Anatolia in 1915. Hence, the economy of the country was left in the hands of Jewish capital.



Carasso, who was a part of the committee that informed Abdülhamid II (left) of his dethronement, was the closest confidant of Talat Pasha, the figure responsible for the deportation law. In fact, when Talat Pasha

escaped abroad in 1918, he entrusted his entire estate to Carasso. To take an active role in the foundation of the Ankara government, Carasso returned to his homeland before his death.”

The allegations of the Armenian Holocaust denying Erdogan-aligned newspaper are very important and need to be explored in depth, as these allegations may help to uncover background historical interactions between Jewish groups and European/Christian groups in a multicultural environment.

In his book Banality of Indifference, Yair Auron alleges that the Jewish citizens of Turkey during this time were apathetic to the murdered Armenians. Regarding the attitude of the Jews towards the Armenians, he wrote:

"A slight grimace on their lips, a short heartfelt sigh, and nothing more. The Armenians are not Jews, and according to folk tradition the Armenians are nothing more than Amaleks! Amaleks? We would give them help? To whom? To Amaleks? Heaven forbid!"

During the 1922 great fire of Smyrna, in which the Greek and Armenian portions of the city were burned down while the Turkish and Jewish sections were spared, the accounts of Jewish teachers alleged that either the Greeks or Armenians started the fire themselves.

This apathetic and dismissive attitude has even been shown in the Jewish “Anti-defamation league” which as recently as 2007 campaigned against the American governments recognition of the Armenian Holocaust.

“Foxman finally acknowledged the Armenian Genocide in his remarks. It was an encouraging development given that ADL’s only formal statement on the genocide is worded in such a way as to actually circumvent the intent required for a finding of genocide by the UN Genocide Convention.”

“That statement, issued in 2007, said that the “consequences” of the Turkish massacres of Armenians were “tantamount” to genocide, implying it was not a planned extermination. This statement was widely censured, but calls for an unambiguous confirmation were rebuffed by ADL”

It needs to be noted here that the American ambassador to Turkey Henry Morgenthau was himself a Jew, and quickly became of the fiercest advocates for recognition of this genocide, and even demanded American intervention to protect

the Armenian victims. But of course exceptions don’t break the rule.

The post-WW2 world has served to served to centre all discussions of prejudice on nomadic minority ethnic groups. The topic is very well studied with any and all possible ethnic and political roots examined. By contrast, prejudice and oppression of Indo-European nationalities and their culture or religious practices are not widely discussed.

While these events are minimized in the social/academic spheres of the Western world, Christophobia and Europhobia have not only happened historically but continue to happen today.



Frightening Frequencies: The Dangers Of 5G

UNTIL NOW, mobile broadband networks have been designed to meet the needs of people. But 5G has been created with machines’ needs in mind, offering low-latency, high-efficiency data transfer. It achieves this by breaking data down into smaller packages, allowing for faster transmission times. Whereas 4G has a fifty-millisecond delay, 5G data transfer will offer a mere one-millisecond delay—we humans won’t notice the difference, but it will permit machines to achieve near-

seamless communication. Which in itself may open a whole Pandora’s box of trouble for us – and our planet.

More Bandwidth – More Dangers of 5G

Let’s start with some basic background on 5G technology. Faster processing speeds require more bandwidth, yet our current frequency bandwidths are quickly becoming saturated. The idea behind 5G is to use untapped bandwidth of the extremely high-frequency millimetre wave (MMW), between 30GHz and 300 GHz, in addition to some lower and mid-range frequencies.

High-frequency MMWs travel a short distance. Furthermore, they don’t travel well through buildings and tend to be absorbed by rain and

plants, leading to signal interference. Thus, the necessary infrastructure would require many smaller, barely noticeable cell towers situated closer together, with more input and output ports than there are on the much larger, easier to see 4G towers. This would likely result in wireless antennas every few feet, on every lamp post and utility pole in your neighbourhood.

Here are some numbers to put things into perspective: as of 2015, there were 308,000 wireless antennas on cell towers and buildings. That's double the 2002 number. Yet 5G would require exponentially more, smaller ones, placed much closer together, with each emitting bursts of radio frequency radiation (RFR)—granted, at levels much lower than that of today's 4G cell towers—that will be much harder to avoid because these towers will be ubiquitous. If we could see the RFR, it would look like a smog that's everywhere, all the time.

Serious Health Concerns

First, it's important to know that in 2011, the World Health Organization's International Agency for Research on Cancer classified RFR as a potential 2B carcinogen and specified that the use of mobile phones could lead to specific forms of brain tumours.

Many studies have associated low-level RFR exposure with a litany of health effects, including:
DNA single and double-strand breaks (which leads to cancer)
oxidative damage (which leads to tissue deterioration and premature ageing) also:—

- disruption of cell metabolism
- increased blood-brain barrier permeability
- melatonin reduction (leading to insomnia and increasing cancer risks)
- disruption of brain glucose metabolism
- generation of stress proteins (leading to myriad diseases)

As mentioned, the new 5G technology utilizes higher-frequency MMW bands, which give off the same dose of radiation as airport scanners. The effects of this radiation on public health have yet to undergo the rigours of long-term testing. Adoption of 5G will mean more signals

carrying more energy through the high-frequency spectrum, with more transmitters located closer to people's homes and workplaces—basically a lot more (and more potent) RFR flying around us. It's no wonder that apprehension exists over potential risks, to both human and environmental health.

Perhaps the strongest concern involves adverse effects of MMWs on human skin. This letter to the Federal Communications Commission, from Dr Yael Stein of Jerusalem's Hebrew University, outlines the main points.

Over ninety percent of microwave radiation is absorbed by the epidermis and dermis layers, so human skin basically acts as an absorbing sponge for microwave radiation. Disquieting as this may sound, it's generally considered acceptable so long as the violating wavelengths are greater than the skin layer's dimensions. But MMW's violate this condition.

Furthermore, the sweat ducts in the skin's upper layer act like helical antennas, which are specialized antennas constructed specifically to respond to electromagnetic fields. With millions of sweat ducts, and 5G's increased RFR needs, it stands to reason that our bodies will become far more conductive to this radiation. The full ramifications of this fact are presently unclear, especially for more vulnerable members of the public (e.g., babies, pregnant women, the elderly), but this technology may cause our pain receptors to flare up in recognition of the waves as damaging stimuli.

Consider that the US Department of Defence already uses a crowd-dispersal method called the Active Denial System, in which MMWs are directed at crowds to make their skin feel like it's burning, and also has the ability to basically microwave populations to death from afar with this technology if they choose to do so. And the telecommunications industry wants to fill our atmosphere with MMWs?

Other Distressing Research

Unfortunately, innocent animals have already been the victims of testing to see MMW's effects on living cells. Extrapolating the results from animal testing to humans isn't straightforward,



but the results nonetheless raise some serious red flags. Perhaps most significantly, a US National Toxicology Program study noted that male rats exposed to RFR for nine hours a day over two years developed rare forms of tumours in the brain and heart, and rats of both sexes developed DNA damage.



The researchers noted that the increased risk to the rats was relatively small; but if these findings translate to humans, the widespread increase in cell phone use could have a significant impact on populations. Thus the NTP study served to renew the debate about the potential harmful effects of cell phones on human health.

Not only that, it caused a significant shift in the American Cancer Society's understanding of radiation and cancer, and sparked them to state that our ignorance of RFR's impact on human health could be compared to our previous obliviousness to the connection between smoking and lung cancer.

Other animal research worldwide illustrates how microwave radiation in general and MMW's in particular can damage the eyes and immune system, cell growth rate, even bacterial resistance. An experiment at the Medical Research Institute of Kanazawa Medical University showed that 60GHz millimetre-wave antennas produce thermal injuries in rabbit eyes, with thermal effects reaching below the eye's surface. This study, meanwhile, suggests low-level MMW's caused lens opacity—a precursor to cataracts—in rats' eyes.

A Chinese study demonstrated that eight hours' of microwave radiation damaged rabbits' lens epithelial cells. A Pakistani study concluded that exposure to mobile phone EMF prevented chicken embryo retinal cells from properly differentiating.

This Russian study revealed that exposing healthy mice to low-intensity, extremely high-frequency electromagnetic radiation severely compromised their immune systems. And a 2016

Armenian study concluded that low-intensity MMW's not only depressed the growth of E. coli and other bacteria, but also changed certain properties and activity levels of the cells. The same Armenian study noted that MMW interaction with bacteria could lead to antibiotic resistance—distressing news, considering immunity to bacteria is already compromised due to the overuse of antibiotics.

Again, if these findings translate to humans, our rampant cell phone use would likely cause profound, adverse health effects; an increase in MMW's as more bandwidth is introduced could further complicate the matter. But what's also important to note here is that 5G technologies will not only have a profound impact on human health, but on the health of all living organisms it touches, including plants, as we shall see.

5G Harms The Planet, Too

Equally disturbing, 5G technology puts environmental health at risk in a number of ways. First, MMW's may pose a serious threat to plant health. This 2010 study showed that the leaves of aspen seedlings exposed to RFR exhibited symptoms of necrosis, while another Armenian study suggested low-intensity MMW's cause “peroxidase isoenzyme spectrum changes”—basically a stress response that damages cells—in wheat shoots. Plant irradiation is bad news for the planet's flora, but it's bad news for us, too: it could contaminate our food supply.

5G Planned Decades Ago

The more elderly of us will remember that back in the late 1950's, lead paint was banned, because of its carcinogenic effects. However, leaded petrol, was not banned until 15 years later. It is patently obvious that lead in paint was not a real danger, for in order to harm to oneself, it would have to be scraped off and eaten, nobody has been known to do that. The lead expelled from exhaust fumes is far more dangerous! It can be seen now in hindsight why lead was banned, that is, because it would block radiation from entering our homes, especially 5G. 5G is also hindered by foliage of trees. Was this the reason of the great trees slaughter in Sheffield on the pretext that the trees were diseased in order to facilitate the penetration of 5G radiation?
