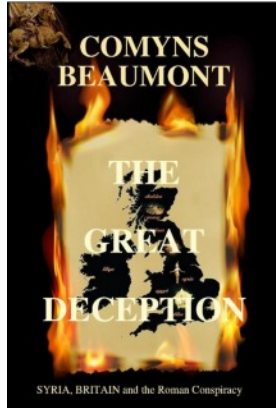

The Old Jerusalem is Not the New Jerusalem Pastor Eli James Comments on Sheldon Emery's Classic (3)



Israel the Harlot

In verse 16, Jesus said to her, "Go, call thy husband, and come hither. The woman answered and said, I have no husband." Jesus said

unto her, "Thou hast well said, I have no husband: For thou hast had five husbands; and he whom thou now hast is not thy husband."

She had no husband and she had many husbands. Who, in the Bible, had no husband, and had many husbands? Israel, of course, who left her first husband, her God, and as Scripture says, "they have gone whoring from under their God" (Hosea 4), and "thou has played the harlot with many lovers" (Jer. 3:1).

Worship to Cease at Jerusalem

Then she went on to ask Him to explain something. "Our fathers worshipped in this mountain; and ye say, that in Jerusalem is the place where men ought to worship (?)" He answered, "Woman, believe Me, the hour cometh, when ye shall neither in this mountain nor yet at Jerusalem, worship the Father." This is testimony by Christ Himself that worship of God was to cease in old Jerusalem and old Palestine!

Then Jesus explained how worship would be from that time on. "But the hour cometh, and now is, when the true worshippers shall worship the Father in spirit and in truth: for the Father seeketh such to worship Him. God is a Spirit: and they that worship Him must worship Him in spirit and in truth."

Jesus said to her that this old Jerusalem was not to be a place of worship. As we read these Scriptures and look over at old Jerusalem, we can see that that has come to pass. In fact, in the Jewish state of Israeli a person cannot even

become a citizen if he is a professing Christian! It is written in their laws. It was tested by a "racial" Jew a few years ago. He went to Israeli and applied for citizenship. He proved his racial lineage, but stated he believed in Jesus Christ as the son of God. His case went through the courts, and his request for citizenship was denied. Only atheists or followers of Judaism are granted Israeli citizenship. Recently, additional laws and regulations have been passed in Israeli restricting or ending most Christian missionary work there. Jesus said worship of God would cease in old Jerusalem and in Samaria, and it has.

Jerusalem A Burdensome Stone

Let's turn to Zechariah 12:1, "The burden of the Word of the Lord for Israel, saith the Lord, which stretcheth forth the heavens and layeth the foundation of the earth, and formeth the spirit of man within him. Behold, I will make Jerusalem a cup of trembling unto all the people round about, when they shall be in the siege both against Judah and against Jerusalem." This is Jerusalem in prophecy, yet future, as we can see by the next verse. "And in that day will I make Jerusalem a burdensome stone for all people: all that burden themselves with it shall be cut in pieces, though all the people of the earth be gathered together against it." God calls Jerusalem a "stone" and indicates it will destroy its enemies.

In Matthew 21:43-44 Jesus Christ speaks to the chief priests and Pharisees, and He says, "Therefore say I unto you, The kingdom of God shall be taken from you, and given to a nation (yes, a nation) bringing forth the fruits thereof. And whosoever shall fall on this stone shall be broken: but on whomsoever it shall fall, it will grind him to powder." The same terminology - the same thing is going to happen to the people who gather against prophetic Jerusalem as will happen to those who fight the nation to which Christ will give the Kingdom. And both the nation and Jerusalem are called a stone, God's Stone Kingdom! Prophetic Jerusalem is the same as the Kingdom.

People are Gathering Against New Jerusalem



In Zechariah we read that "all the people of the earth be gathered against it." What are the people of the earth being gathered against? Why prophetic Jerusalem, of

course! That huge Jerusalem that is so big it takes an angel to measure it, that has a multitude of people and cattle (Zechariah 2), the one God dwells in, the one He calls "Zion." That is what they are gathered together to destroy. [Is it not obvious that it is we, True Israel, Prophetic Jerusalem, against whom the world's wrath is being orchestrated by the Jews?

It is America that is being blamed by the rest of the world for the evils being done by the scheming Zionists, who use our military to promote their version of "peace," the so-called "war on terror." The Jews have, except for the powerless Muslim world, have everyone else on their side, thanks to their control of the press and Judeo-Christianity!

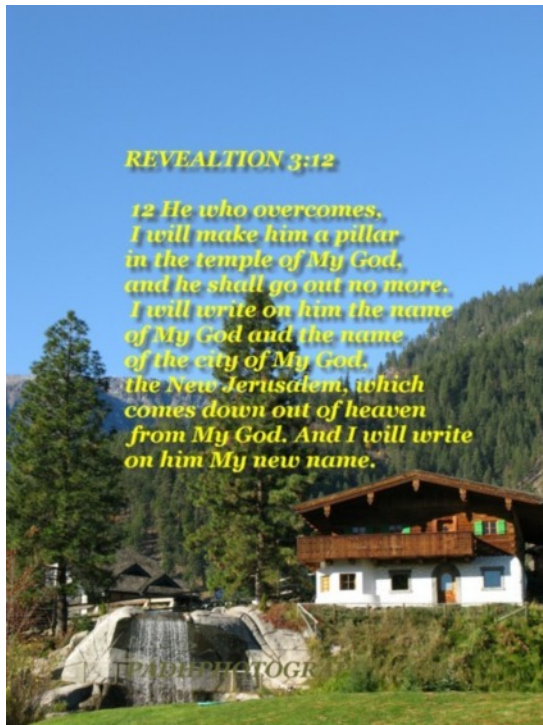

Yet deluded Christian ministers look at old Jerusalem and erroneously call its Jewish occupants "Israel." No, my friends, "all the people of the earth" are gathered against the New Jerusalem, the United States of America, God's Country, the land of the regathering of the true descendants of the twelve tribes of Israel.

New Jerusalem - In Palestine? In Heaven? On Earth?

We have seen that Zechariah indicated that "all the people of the earth" would be gathered against prophetic Jerusalem. And we also read that Christ told the Jews, "The Kingdom of God shall be taken from you and given to a nation--..

"As we read some specific descriptions of New Jerusalem, let us keep in mind that Jesus taught "the Gospel of the Kingdom," not just a gospel of personal salvation, as some think. All four Gospels make that plain in the beginning of His ministry. Read Matthew 4:17, Mark 1:15, Luke 4:43, John 3:3 and others.

In John 3:3 Christ explains the connection between personal salvation and the kingdom, "Except a man be born again, he cannot see the kingdom of God." The ultimate purpose of Christ's finished work on the Cross was to provide man with the means to enter the kingdom. Jesus Christ said, "But I say unto you, Swear not at all; neither by Heaven; for it is God's throne: Nor by the earth; for it is His footstool: neither by Jerusalem; for it is the city of the great King" (Matt. 5:34-35). The city of the great King!



Turn to Revelation 3:12, which links the born again believer with the city of God, New Jerusalem. "Him that overcometh will I make a pillar in the temple of my God, and he shall go no more out: and I will write upon him the Name of my God, and the name of the city of my God, which is New Jerusalem, which cometh down out of heaven from my God: and I will write upon him my new name."

God's new Name is Jesus Christ. The name to be written on the inhabitant of New Jerusalem is His new name, "Christ man," or "Christian!" The "city of my God," New Jerusalem, will be a Christian place, a place of born again believers, where the Saviour Jesus Christ is believed on and praised, not an old city that has the same name, where Christ is hated and denied.

New Jerusalem the Bride

Revelation 21: "And I saw a new heaven and a new earth: for the first heaven and the first earth were passed away; and there was no more sea ["sea" in prophecy signifies human turmoil]. And I John saw the holy city, new Jerusalem, coming down from God out of heaven ..." This is the same as Rev. 3:12. It is very clear that New Jerusalem is not in heaven, but that it "comes from" heaven! As can be seen, these Scriptures do not fit the teaching that the New Jerusalem or the Kingdom is somewhere other than on earth.

Let us read on . . . "prepared as a bride adorned for her husband." The "bride" of prophecy! These are the first 2 verses, but my Christian reader should continue through verse 8 for the beautiful description of the kingdom.

Then in verse 9 and 10 John says, "And there came unto me one of the seven angels which had the seven vials full of the seven last plagues, and talked with me, saying, Come up hither, I will shew thee the Bride, the Lamb's wife, And he carried me away in the spirit to a great and high mountain, and shewed me that great city, the holy Jerusalem, descending out of heaven from God." The angel showed John the bride. And what was the bride? "The holy Jerusalem."

The Church is never called "New Jerusalem" in the Bible, yet ministers teach the church is the bride. If you have been taught the bride of Christ is some sort of "gentile church," you should read Revelation 21 over until you see the truth.

Israel The Bride

John goes on to describe this New Jerusalem, the bride of the Lamb, "Having the glory of God: and her light was like unto a stone [here is that stone again] most precious, even like a jasper stone, clear as crystal; and had a wall great and high, and had twelve gates, and at the gates twelve angels, and names written thereon . . ." And what were the names that were written on the gates to this New Jerusalem? "Which are the names of the twelve tribes of the children of Israel!"

Yes, Israel is the Bride, and she will be purified of sin and corruption, for she is washed in the blood of her Redeemer, the Lord Jesus Christ. Israel shall no longer be a harlot, the divorced wife of the great Jehovah. Israel was made a widow indeed with the death of her Husband, who took her punishment upon Himself on the Cross of Calvary (Isa. 53, 54).

Then she, upon receiving the Holy Spirit and being baptized for remission of her sins, becomes the new, cleansed, and made ready virgin Bride of Christ. This is the Israel with the law written in her heart, "For this is the covenant that I will make with the house of Israel after those days, saith the Lord; I will put My laws into their minds, and write them in their hearts; and I will be to them a God, and they shall be to

Me a people" (**Heb. 8 and Jer. 31:31**). Yes, Israel is the Bride!

and ye shall be My sons and daughters, saith the Lord Almighty."

We will read a few more verses of Revelation 21 before we turn to one of God's prophets to complete this study of the New Jerusalem. Verse 15, "And he that talked with me had a golden reed to measure the city and the gates thereof, and the wall thereof." This is obviously the same angel referred to in Zechariah 2 who was measuring Jerusalem.



The Scriptures are always consistent; there is no discrepancy when the Word is used to interpret the Word. And that the New Jerusalem is on earth is verified by many Scripture verses including verse 24 of Revelation 21, "And the nations of them which are saved shall walk in the light of it: and the kings of the earth do bring their glory and honour into it."

There Will Be a New Temple in New JerUSAlem

At the same time Christians must understand the nature of the temple that will be built in New Jerusalem (and which God will bless!). Every Christian should know this (but they do not), so that they will not be deceived by ministers who preach "lying divinations" about old Jerusalem and the Jews. The Holy Word makes it plain of what substance this new habitation of Christ will be built. "Know ye not that ye are the temple of God, and the Spirit of God dwelleth in you? . . . for the temple of God is holy, which temple ye are." (1 Cor. 3:16-17). "Know ye not that your body is the temple of the Holy Ghost, which is in you . . . for ye are bought with a price" (1 Cor. 6:19-20).

That the temple (Christians) is not to be defiled by associations with unbelievers is made abundantly clear in 2 Corinthians 6:14-18, including the oft-quoted "be ye separate," and God's promise, "And I will be a father unto you,

That God's new habitation is to be made up of all believers is disclosed by Paul in Ephesians 2:19-22 "now therefore ye are no more strangers and foreigners, but fellow citizens with the saints, and of the household (see "sons and daughters" above) of God; And are built upon the foundation of the apostles and prophets ("New Testament Christians," please note the inclusion of the "prophets," or Old Scriptures!), Jesus Christ Himself being the chief corner stone; in whom all the building fitly framed together growth unto an holy temple in the Lord: in whom ye also are builded together for an habitation of God through the Spirit." Is the new temple to be one of stone built in old Jerusalem? Hardly.

Jesus Christ verified the substance of the new temple and its new location. "Him that overcometh will I make a pillar in the temple of my God, and he shall go no more out: and I will write upon him the name of my God [Christian Identity is restoring the correct Name of God, Yahweh. Although Pastor Emry did not use the name of Yahweh, it is becoming more accepted within Identity today. Please see my treatise on the subject at this [link](#) -- Eli], and the name of the city of my God, which is New Jerusalem, which cometh down out of heaven [not in heaven - but Coming down from heaven], and I will write upon him My new Name [Christ]" (Rev. 3:12).

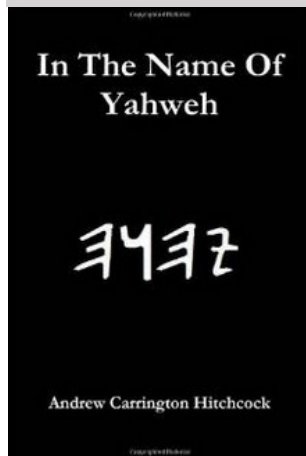

In The Name of Yahweh

The Israel laws concerning sexual morality.

The Jews who claim they are the Israel of the Bible have a rather different take on sexual morality. In the section of their Talmud entitled Sanhedrin 74b Tosephoth, it states,

“The sexual intercourse of a Goi (non-Jew) is like to that of a beast.”

They go on to state in section Kethuboth 3b, “The seed of a Goi is worth the same as that of a beast.”

And in their Zohar, Section II, 64b, “If only idolaters alone had sexual intercourse, the world would not continue to exist. Hence we are taught that a Jew should not give way to those infamous robbers. For if these propagate in greater numbers, it will be impossible for us to continue to exist because of them. For they give birth to sucklings the same as dogs.”

The Jews who claim to be the Israel of the Bible also have different sexual laws to those we have just seen in the Bible.

In the section of their Talmud entitled Sanhedrin 55a, it states of sodomy,

“Rab makes nine years the minimum; but if one committed sodomy with a child of lesser age, no guilt is incurred. Samuel makes three the minimum. At nine years a male attains sexual matureness.”

Sanhedrin 69a clarifies this with the statement, “Such a minor can produce semen, but cannot beget therewith; for it is like the seed of cereals less than a third grown.”

Going back to Sanhedrin 55a, “Thus the point of comparison is the sexual matureness of woman which is reached at the age of three.”

This point is re-affirmed in Sanhedrin 55b, where it states, “A maiden aged three years and a day may be acquired in marriage by coition.”

However there is a caveat for those Jews who consider three year old girls are a little too old for them, and they can seek solace in the section of their Talmud entitled Kethuboth 10b-11a, where it states in footnote 17,

“If they had sexual intercourse before they were three years and one day old the hymen would grow again, and they would be virgins.”

This is clarified by footnote 7 of Kethuboth 11b where it states, “tears come to the eye again and again, so does virginity come back to the little girl under three years.”

Moving up to the page text of Kethuboth 11b, “When a grown up man has intercourse with a little girl it is nothing, for when the girl is less than this, it is as if one puts the finger into the eye; but when a small boy has intercourse with a grown-up woman he makes her as a girl who is injured by a piece of wood.”

The Jewish Talmud, Section Kethuboth 61b also instructs Jews on the frequency they can enjoy sex, based upon their occupations,

“The times for conjugal duty prescribed in the Torah are: for men of independence, every day; for labourers, twice a week; for ass-drivers, once a week; for camel-drivers, once in thirty days; for sailors, once in six months.”

The Jews claim their Torah is the first five books of Moses: Genesis; Exodus; Leviticus; Numbers; and Deuteronomy. I have read these books on numerous occasions in order to write this one, and I can assure the readers, this Jewish sanctioned child-rape, is absolutely nowhere to be found in any of those books.

Going back to the Jewish Talmud, section Yebamoth 59b demonstrates a far more politically correct attitude to the celibacy of the priesthood.

It states, “A woman who had intercourse with a beast is eligible to marry a priest...It once happened at Haitalu that while a young woman was sweeping the floor a village dog covered her from the rear and Rabbi permitted her to marry a priest.”

This sentiment is echoed in Jewish Talmud, section Sotah 26b, “there is not adultery in connection with an animal.”

The Jewish Talmud, Section Yebamoth 60b, provides advice on how to assess if a woman is still a virgin, “They made them sit upon the mouth of a wine-cask. [Through anyone who had] had previous intercourse, the odour penetrated; through a virgin, its odour did not penetrate.”

Leviticus 19:13 – *“Thou shalt not defraud thy neighbour, neither rob [him]: the wages of him that is hired shall not abide with thee all night until the morning.”*

Leviticus 19:14 – *“Thou shalt not curse the deaf, nor put a stumbling block before the blind, but shalt fear thy God: I [am] Yahweh (the LORD).”*

Leviticus 19:15 – *“Ye shall do no unrighteousness in judgment: thou shalt not respect the person of the poor, nor honour the person of the mighty: [but] in righteousness shalt thou judge thy neighbour”.*

Leviticus 19:16 – *“Thou shalt not go up and down [as] a talebearer among thy people: neither shalt thou stand against the blood of thy neighbour: I [am] Yahweh (the LORD).”*

Leviticus 19:17 – *“Thou shalt not hate thy brother in thine heart: thou shalt in any wise rebuke thy neighbour, and not suffer sin upon him.”*

Leviticus 19:18 – *Thou shalt not avenge, nor bear any grudge against the children of thy people, but thou shalt love thy neighbour as thyself: I [am] Yahweh (the LORD).*

Leviticus 19:19 – *“Ye shall keep my statutes. Thou shalt not let thy cattle gender with a diverse kind: thou shalt not sow thy field with mingled seed: neither shall a garment mingled of linen and woollen come upon thee.”*

Be honest with your neighbour. Do not look down on the poor nor up to the rich, earthly wealth is not an indication of a person’s character.

You shall not take a stand against the life of your neighbour, however if your neighbour has broken the law, you are expected to witness to that, as it says in Leviticus 19:17 regarding, “rebuking,” your neighbour.

You shall not hate your brother and if you have a problem with another member of the family of Israel, you must tell them directly. Don’t gossip about them, don’t bear a grudge against them, and don’t be dishonest with them by omission by failing to tell them of a resentment you have against them and thus denying them the opportunity to rectify their standing in your mind.

We finish off with more laws regarding the duty of maintaining purity. We have seen the purity regarding race, but here Israel are instructed not to even wear clothes of mixed fibres.



Leviticus 19:28 – *“Ye shall not make any cuttings in your flesh for the dead, nor print any marks upon you: I [am] Yahweh (the LORD).”*

Leviticus 19:29 – *“Do not prostitute thy daughter, to cause her to be a whore; lest the land fall to whoredom, and the land become full of wickedness.”*

Leviticus 19:30 – *“Ye shall keep my sabbaths, and reverence my sanctuary: I [am] (Yahweh) the LORD”.*

Leviticus 19:31 – *“Regard not them that have familiar spirits, neither seek after wizards, to be*

defiled by them: I [am] Yahweh (the LORD) your God.”



Leviticus 19:32 – *“Thou shalt rise up before the hoary head, and honour the face of the old man, and fear thy God: I [am] Yahweh (the LORD).”*

Leviticus 19:33 – *“And if a stranger sojourn with thee in your land, ye shall not vex him.”*

Leviticus 19:34 – *“[But] the stranger that dwelleth with you shall be unto you as one born among you, and thou shalt love him as thyself; for ye were strangers in the land of Egypt: I [am] Yahweh (the LORD) your God.”*

Leviticus 19:35 – *“Ye shall do no unrighteousness in judgment, in meteyard, in weight, or in measure.”*

Leviticus 19:36 – *“Just balances, just weights, a just ephah, and a just hin, shall ye have: I [am] Yahweh (the LORD) your God, which brought you out of the land of Egypt.”*

You shall not print any marks on you, and there I was wondering why tattoos are so promoted by the fashion industry, the sports industry, the music industry, and the media as an obligatory fashion accessory in these recent times.

Spiritualism is out as is chasing after wizards, which the majority of parents teach their children to do today as evidenced by the success of the, Harry Potter,” book and movie franchise.

You must not allow Israel women to be of loose morals as this could cause other Israel women to follow their example.

You should respect your elders and strangers that live amongst you. Hang on, does that not go against the principle of Israel separating from other nations?

Although, if you recall, one of the key Biblical points that we are told to use that would identify and distinguish just Who and Where Israel would be found in the End time or in “*That Day*”, is the predicted international opposition to and antipathy toward, that nation! Which attitude is becoming apparent, but also now slowly beginning to awaken Israel and its People to the recognition of America as being that Land that God held in abeyance, as the future site for Israel’s final gathering.

How blind is the world to the Divine grants made to Christian Israel of America, giving it such monumental blessings and gift. How most others refuse to see the gifts and grants that America has made to the world, while it suffers as well, insidiously, with massive internal opposition to its basic Christian standards and blessings. Good and evil seemingly always running in parallel.

But such antipathy does seem to come even from friends, although current events not withstanding, most would seem to warrant such concern, for I too, consider that what is going on in the Middle East today, unwarranted and a waste...yet, in the great scheme of things, in His Great plan for the ages, is this not His punishment on Israel, does it not also, contribute to the continued debasement of His Chosen, to the demise of the Power of the Holy people and its being “*scattered*”, just as Daniel noted was a key end time distinction, and that then “...*all these things shall be finished.*”? (See Dan.12:7)

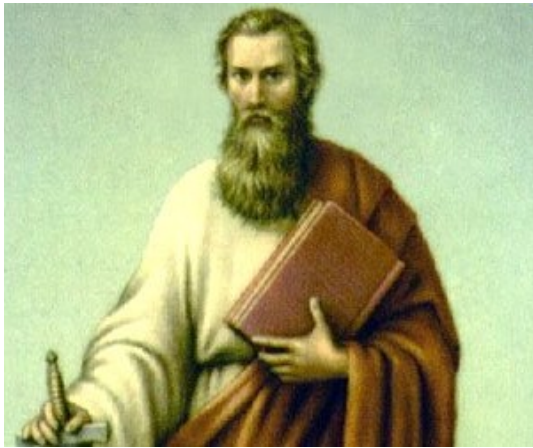
So, in reflection, your antipathy to this issue of USA - Zion, might just be antithetical to His Great Plan of the Ages, and yet, proving to all, that you are not unique, that your antipathy fits within the prediction that a future Israel/Jerusalem would be hated and reviled, as noted in Zechariah 12:3: “*And in that day will I make Jerusalem a burdensome stone for all people: all that burden themselves with it shall be cut to pieces, though all people of the earth be gathered together against it.*”

Subsequent commentary that follows this verse, speaks to what happens, for it is then, when Christian Israel is overcome, its power scattered, that the prophetic Divine Intervention* appears, as in verse 9, God states: “*And it shall come to pass in that day that I will seek to destroy all the nations that come up against Jerusalem.*”

* (This Intervention (an International Demonstration Effect?), is the Divine action or event that awakens Israel to its origins, and when it begins, in such a sudden and dramatic way, true Israel finally realizes that God’s Promises for them as Israel, are real!)

Further, as to what does happen in *That Day*, we can see similar commentary in Haggai 2 where God is speaking about shaking the heavens and the earth. Then in verse 22, He states: “*And I will overthrow the throne of kingdoms, and I will destroy the strength of the kingdoms of the heathen; and I will overthrow the chariots, and*

those that ride in them; and the horses and their riders shall come down, every one by the sword of his brother."



Paul speaks to this as well, noting in 1 Cor.15:24: *"Then cometh the end, when He shall have delivered up the kingdom of God, even the Father; when He shall have put down all rule and all authority and power."*

Daniel 2:44 also provides similar commentary: *"And in the days of these kings shall the God of heaven set up a kingdom which shall never be destroyed: and the kingdom shall not be left to other people, but it shall break in pieces and consume all these kingdoms, and it shall stand forever."* While this revelation was made to Nebuchadnezzar, its future application refers to a far distant period.

But, since you refer to Zechariah in opposition to the thesis that USA is Zion, lets go back there for more confirmation that opposes your view. In Ch. 2, where you use the expression *towns without walls*, (v.4), I suggest that this series of verses proves the point about USA-Zion...So, lets investigate these verses.

Chapter 2, begins with instructions to two angels to *"measure Jerusalem"* to determine its size.. A seemingly odd approach, until we realize that God is planning to reshape that region where Israel has gathered. For the next verses explain what is to come; that Jerusalem is to be inhabited without walls for the anticipated multitude of men and animals. God promises to set a wall of fire around this region and to become the Glory in its midst.

Then in v.6 He instructs all Israel to come forth, and flee out of lands of the north, saying, *"I have*

spread you abroad as the four winds of the heaven..."

But, the next verse, 7, offers a valid point that certainly has to allude to America as Zion. God states therein: *"Deliver thyself, O Zion, that dwellest with the daughter of Babylon."*

Who is it that now *"dwells"* with this *"daughter of Babylon"*? Where is the principle nation or region that Esau/Edom dominates and uses to control the world under the aegis of Esau, the Jew? For certain, it is America, although London fits into this Babylonian matrix of today, but it is America, the real *"battle ax"* that is being used, and abused.

Note as well, that God instructs Zion to *"deliver thyself"* in verse 7, in other words, to recognize your captors and begin to resolve your problems with them—an event which Jesus also may have alluded to in a most unusual comment found in Luke 12:4. *"I am come to send fire on the earth; and what will I, if it be already kindled?"*

When He does step in to intervene in the lives of Israel, He identifies the enemies as Edom. *"And I will lay My vengeance upon Edom by the hand of My people Israel: and they shall do in Edom according to mine anger and according to My fury; and they shall know my vengeance, saith the Lord God."* (Ezek.25:14)

But, that point of *dwelling* with the *daughter of Babylon* is not unique to Zechariah alone. In Micah 4, is a similar depiction for *"That Day"*, or the end times. Chapter 4 speaks to both the *daughter of Zion* and the *daughter of Jerusalem*, but, speaks as well to the *"daughter of Babylon"*...In other words, what we find gathered in America in the *"last days"* as v.1, alludes to, are the principle opponents that have co-existed over the ages, only here, as depicted as the *"daughters"*! From these comments we must recognize them as future, the subsequent progeny of the earlier *"kingdoms"* or nations. Micah 4 does address quite a bit about those coming events that are applicable to the daughters of Zion and Jerusalem, but in verses 9-10, we find the confirmation that they suffer under the dominion of Babylon. (as we do today).

Here is that verse 9: *"Now why dost thou cry out aloud? Is there no king in thee? Is thy counselor perished? For pangs have taken thee as a woman*

in travail.” Does not that verse speak to that nation which has no real king? Few dedicated “counselors” to advise this “daughter” of the truth of its origins? Does America have a true Christian King?

Now, in verse 10, God speaks to these events. *“Be in pain and labor to bring forth, O daughter of Zion, like a woman in travail: for now shalt thou go forth out of the city, and thou shalt dwell in the field, and thou shalt go even to Babylon; there shalt thou be delivered; there the Lord shall redeem thee from the hand of thine enemies.”*

Again, has America *gone even to Babylon*? Are we suffering under the Babylonian leadership that governs events today? For certain, and what came out of the Babylonian experience of the Jews that has ever been their hallmark, but the ability to use Fiat Funding and Usury and deceit to control the lives of those within whom they were merged or existed...But then, was it an inherent ability of theirs, or, was it a grant from the Lord, using them to force His chosen Israel to return to His Laws and lifestyle.

Now we also are informed that it is during this current Babylonian captivity of the daughters of Zion/Jerusalem that the Lord steps in with that Divine interdiction or intervention, for in v.10 we can see God saying that “there”, during that captivity by the daughter of Babylon, that *“there Lord shall redeem thee.”*

Redeemed from those acting and playing the part that God stated they would be found doing as noted in Jeremiah 24 as the “evil figs”. In verse 9, God says, *“And I will deliver them to be removed into all nations for their hurt, to be a reproach and a proverb, a taunt and a curse, in all places whither I shall drive them.”*

Such captivity is well outlined as being the 2nd captivity of Israel. Isaiah 11:11 speaks to it, as does Jeremiah 30:3, 7-8, 18. Several other verses, (especially Exek. 39:25), also allude to this 2nd or final captivity of Israel, and its resolution by Divine intervention. Jeremiah 30:8 is the most vivid and clear as to God’s intentions and intervention, which is preceded with His comment in v.7, that speaks to how serious are the end time events. Saying: *“Alas! For that day is great. So that none is like it: it is even the time*

of Jacob’s trouble; but he shall be saved out of it.”



Ezekiel 39:25 speaks clearly of this 2nd captivity, but in the two preceding verses, 23-24, we can see that Israel’s enemies, the heathen also discover that Israel is His Chosen, for it begins with this statement: *“And the heathen shall know that the house of Israel went into captivity for their iniquity...”*

Further along in Ezek. 39 is another reference that speaks to this final gathering of Israel where the Lord will redeem them. In verses 27-28, God states: *“When I have brought them again from the people, and gathered them out of their enemies lands, and am sanctified in them in the sight of many nations; then shall they know that I am the Lord their God, which caused them to be led into captivity among the heathen; but I have gathered them into their own land, and have left none of them any more there.”*

There we see another reference to their *Own Land* -- of Israel. If this reference was to Old Jerusalem, it would not be identified as uniquely their “own land”, for it would have been understood if true. Thus it has to be a far different “own land” which follows along with God’s prophetic words about Lands for Israel in the Future as He stated in II Samuel 7:10 and I Chron. 17:9.

Despite the emergence and promotion of appropriate verses that might appear to justify your main thesis that decrees America as being the final focus for Israel’s tribes, there are three important facts or themes found within the Bible that reject your views.

One, the rejection, disassociation and abandonment of Old Jerusalem by God, **Two** the historical proofs that affirm how the “lost”

Tribes of Israel made their way to the West, to the “wilderness areas” to the “isles of the sea” and where they concluded this historic trek in a wilderness area held in abeyance for them. The third point to consider is the duality found in the references to a “return” to Jerusalem. Such return was manifest when the Good and Bad figs did return from Babylon to Old Jerusalem – an event which some tend to ignore and to then transpose the biblical references that apply, shifting them into a distant future.

The many verses that allude to Divine abandonment such as II Kings 23:27, Jeremiah 19:10-12, 26:18, affirm this to be true. Certainly God’s words in Jeremiah 19 that give us a lesson via broken pottery confirms His intentions as regards Old Jerusalem. His statement after instructing Jeremiah to break the bottle in sight of men, and to say to them: “...*Thus saith the Lord of hosts; Even so I will break this people and this city, as one breaketh a potters vessel, that cannot be made whole again, and they shall bury them in Tophet.*”

Then in an even more strident announcement about this issue, He goes on to say, “*This will I do with this place, saith the Lord, and to the inhabitants thereof, and even make this city as Tophet.*”*

*(Tophet, by the way, was a site in the valley of Hinnom, infamous for its human sacrifices and which became a dumping ground for refuse.”

Now why would the Lord choose such a site for where His chosen were to return and gather? Such Holy gathering would certainly preclude such a site for the final restoration of Israel with their Holy Redeemer..

If we go to 1 Kings 9:3-9, it is also pointed out that God had a caveat attached to the promises being made to Solomon (And Israel). Verse 6 contains these words: “*But if ye shall at all turn from following Me, ye or your children, and will not keep My commandments and My statutes which I have set before you, ...*” etc.etc.

There it is apparent that neither Solomon or the Israelites benefited from these original promises made to them by God, (due to their apostasy) so having failed these responsibilities, God then says of Old Jerusalem that it would be a place of hissing. It was and remains so.

As to comparing several words in Zechariah 2:4 – a reference to “*towns without walls,*” words which you consider to be similar to the term, “*the land of unwalled villages*” which is traditionally used to distinguish America, there does not appear to me, to be any real correlation to support your thesis, rather both would appear to be intended for a future Jerusalem since it makes reference to the *daughter of Zion.*

The Trojan Origins Of European Royalty! (Part 6)

The Later Odin

W^E have seen so far that there were two **Odins** -- Nimrod and Dan I. There is also a **Third Odin** to be found in the sagas and traditions of the Scandinavian people who, like

his namesake **Dan I**, was descended from the **Kings of Troy!** The details are to be found in Olson's *The Incredible Nordic Origins:*

Odin [the third] was king of the Asgardians or the Aesir, located **between the black and Caspian Seas.** The "Historian's History of the World," Volume XVI, tells us that he was a mortal man and was **King of the Hellespont.** He had great possessions in Turkland, and his followers were called by the Gothic writers Asae, Asiani, and Asiotae. Their principal city was **Asgard.**

"**The Anglo-Saxons** had their base in **Troy**, as the Asa-Sveas had theirs in Asagard" (Syd-Skandinavernas Forstfodsloratt, pp. 47, 48).

It is believed that **Asgard** lay near today's **Asov**, which is situated on the Sea of Asov, north of the Black Sea, at the mouth of the **Don River**. This is where **Odin** and the Asar, according to a saga, originally lived (*Sveriges kulturhistoria*, p. 43)....

After committing his kingdom to his two brothers **Ve** and **Velier**, **Odin** made vast conquests as he and his hordes marched toward Northwestern Europe.

First he entered Riisland (Russia), and after having successfully taken over that nations inhabitants, appointed his son BO to reign over them.

From there he went by sea to Northern Germany, reducing Saxony and dividing it among his children. **Horsa and Hengist** -- the chiefs of the **Saxons** who conquered Britain in the fifth century-- **considered Odin as one of their ancestors**.

Following the conquest of Saxony, he proceeded to **Jutland [Judah's Land]** and Funen (now parts of Denmark) and subdued them. this he gave to his son **Skiod**, from whom the kings of Denmark are descended. The city of **Odense** was built by him.

Thereafter he advanced to Suithoid (Sweden), where he was kindly received by Gylfus or Gylso, king of the country, with whom, according to Dalin, he was acquainted. He and his followers were allowed to settle there. He built the city of Sigtuna....

The desire of **Odin** to spread his religion and to dominate caused him to undertake a conquest of Norway. His son **Saeming** became ruler over this kingdom.

After these many feats, he finally returned to Sweden, where he perceived he was about to die

from a lingering disease. Unwilling to suffer the ignominy of not dying in battle, he gave himself nine wounds and other cuts. When he died, his body was carried to Sigtuna where it was burnt with much pomp. -- Pp. 70-72.

The reason **Odin** left the Hellespont region in the first place was because of the vengeance of the Romans. At this time (first century B.C.) the Roman Commonwealth was at its strongest; and the then king of **Pontus** attempted to arm all the people in his territory against the power of Rome. After some initial successes, this king and his ill-united people were forced to retreat from the advancing Romans.

As a result **Odin** was also forced to flee from the Roman wrath. "Mallet says his [**Odin's**] true name was **Sigge**, the son of Fridulph. **Fridulph can be traced back to Priam, King of Troy.**"

After arriving in the Northwest of Europe **Odin** sought revenge against the Romans. "Dalin writes that the entire North became aroused by him against Rome. It is said that his resentment, as a result of being driven from his country by the Romans caused him to be all the more violent. This desire for revenge he left fermenting in the bosom of Northern Europe. When the time came, they all by common consent and after successive attacks toppled Rome!" (*The Incredible Nordic Origins*, p. 72).

M. Paul du Chaillu, quoting old Norse sagas, summarizes the life of **ODIN**: "At this time the Asia men came from the east. Their **Leader** was called **Odin**, who was a mighty warrior. In every battle he gained victory. He owned a great deal of land in **Swithiod the Great (Scythia)**, whose capital was **Asgard (Kiev)!**"

Sharon Turner, who compiled a *History of the Anglo-Saxons*, wrote: "The human existence of **Odin** appears to be satisfactorily proved. The **Founders of the Anglo-Saxon octarchy** [in Britain] deduced their descent FROM **ODIN** by genealogies, in which their ancestors are distinctly mentioned up to him!" (Quoted from *Wake Up!* August, 1980). The line of the third **Odin**, from his ancestor **Dan I**, is as follows:

Instead of being unrelated and unconnected, the royal houses of Europe and Britain stem from a common origin in the Troy of Homer! Whatever Is “Satan”? Part 2

ORIGINS.

SCRIP TURE does not anywhere present a supernatural being known as Satan which is often conjured up as a being having horns, cloven hoofs and a tail, among other things.

Although there is reference to a great red dragon having a tail in Rev. 12:4, this is the concept of Judaism we see in, *“He hath Beelzebub, and, by the prince of the demons casteth he out the demons— [Mark 3:19].*

This is where the idea comes from that “Satan” is the ruler of the devils. Most churches are Judeo-Christian and this is their popular belief. “Judeo-Christian” does not mean “Christian” or “Biblical”. The word “Judeo” refers to the belief structure Judah adopted when in captivity in Babylon. This was the popular belief in Judea in Bible times. Jesus always condemned these traditional beliefs. **But the churches accept them.**

The Gnostic, Cabalistic (Jewish), Saducee and Christian Scientist idea is that evil is nonexistent -[Acts 23:8]. The Jewish Encyclopaedia says, *“As the Divine has true being, evil is that which had no being”*. The consequence of this belief can be seen in the immorality advocated in the Jewish Talmud. What these all deny is what the Bible says about the nature of the human heart as the source of evil.

It is popular to say that God created the world out of nothing but we are not told that is so. God simply created. This act transcends the ability of the human mind to comprehend. What we can understand is that part God tells us about, namely that God made laws to which there would be good consequences for keeping them and “evil” consequences for not keeping them. He gave His people a choice and let them choose the consequences. But God did not leave His people ‘lost’ under His judgement. He provided redemption for those who believed what He said.

We are told, *“For in him we live, and move, and have our being”*[Acts 17:27]. This means that the only kind of interaction God can have with the creation is that of personal relationship and personal action. There is no room for impersonal mysticism. God is totally personal, and the only relationship He has with men is personal. God communicates with men by means of language (word) and actions (deeds).

Now, in regard to the eternal Law of God, this could be something that could either be rightly related to Him, or wrongly related. We see this in common life. We can rightly relate to our friends, or we can make enemies of them by wrongly relating to them. We can rightly relate to the creation by shepherding it properly, or we can relate to it wrongly by polluting and destroying it. We can rightly relate to God by believing and agreeing with God in our actions, or we can wrongly relate with God by being adversaries to God. Thus the Christian world view is exhaustingly relational in character. We call this relationship by the Biblical word *“covenant”* or *“covenant relationship”*.

What does this mean for the so-called "problem of evil"? Evil is not a substance but rather a wrong relationship with God. “Evil” and “satan”, in the moral sense, are just other words connected with *sin* which is Law transgression. Sin makes a person an adversary to God. But “Satan” is a word preferred by pagans and religionists since it seems to connote personality and thus moves responsibility away from human accountability. The word “satan” is conveniently used to disguise the corruption of the human heart. The question is often asked, "How could a good God permit evil to exist?" The answer is, “Evil does not exist as a singular identity”. Evil is the consequence of wrong choices and bad deeds. The consequence is always condemnation.

John 3: 19 And this is the condemnation, that light is come into the world, and men

loved darkness rather than light, because their deeds were evil. From this we see again exactly what the source of evil is.

Again it is not “Satan”!

In fact, the possibility of "evil" or sin is implicit in the very act of creation itself. God set the rules and gave man free choice, God established the possibility that man as captain of creation might choose to become wrongly related to Him; man might choose to break the covenant and rebel against the Covenant. In the Covenant sense this applies only to Israel, although the laws of God apply to every person on earth-[e.g. the laws of science].

The Israel Man was not confronted with a choice between God and "Satan" as two separate entities. Rather, he was confronted with a choice whether to relate to God rightly (faithful obedience) or wrongly (faithless rebellion). We know which choice Israel made, and the consequence.

When we read in Isaiah 54:16 of God saying "I have created the waster to destroy"; this sounds as if "the waster" is a personality, but the "waster" is what God caused to take effect as a pledge or consequence for making a wrong choice. The word "created" is *bara'* as in Genesis One.

REDEMPTION

The purpose of redemption was not to rescue man from an evil external influence. Nor was it to defeat "evil." Rather, the purpose of redemption is to restore man to a right relationship with God, to remove Israel from God's covenant wrath and restore him to God's covenant blessings. "For this purpose the Son of God was manifested, that he might destroy the works of the devil" [i.e. adversary works and God's wrath-1 John 3:8].

When Christian Israelites do not keep this matter firmly in mind, they fall into one of two errors. The first is to view man's problem as "Satan," and God's work as rescuing man from "Satan." The second is a more subtle error. It is to view "evil" as "non-being" and an illusion, and to say that redemption comes when people realise that "evil" does not exist. This is the viewpoint of Judaism, Eastern Mysticism and of Christian Science. While it is true that "evil" does not exist as a "being", the "problem of evil", or what that "problem" is, is still very real. Man exists, and so does God. When Man is estranged from God, Man must come to grips with his rebellion and seek salvation in the Person and work of Jesus

Christ. There is no salvation in ignoring the issue! The Bible presents "salvation" as being a present deliverance in this life, not "heaven" at our death as churches teach. Yes, we are told that God creates [brings about] evil as a consequence of disobedience. Again, God does it, not "Satan".

What we describe as being "evil" is the manifestation of estrangement from God. Anything in this estrangement position is an adversary to God. This adversary position is what the Bible terms "satan". This illustrates the Biblical use of the word "satan". We are told in the blessings and curses under the law in Deut. 28, that obedience and disobedience would each have a different eternal consequence.

Psalm 119:160 Thy word is true from the beginning: and every one of thy righteous judgments endureth for ever.

OCCULT MANIFESTATIONS.



People who are deliberate adversaries to God manifest mental states which cause them to have a whole range of occult manifestations. These mental states lead on to what the Bible terms "enchanters", "charmners", and involves "witches", "wizards" and "necromancers" [familiar spirits-Deut.8:1 1], and "astrologers"; things which God terms "abominations". God says, "I try the reins, even to give every man according to his ways".

Romans 1 :24-25 Wherefore God also gave them up to uncleanness through the lusts of their own hearts, to dishonour their own bodies between themselves: Who changed the truth of God into a lie, and worshipped and served the creature more than the Creator, who is blessed for ever. Amen.

Note that God "gives to every man" and "gave them up", **not "Satan"**.

The occult is a reality. When we begin to take a close look at the occult, it becomes necessary to define terms. There is a great difference between cults and the occult. The term *cult* refers to a group of people polarised around one individual

who is often a magnetic personality. This individual has his or her own understanding of truth, who God is, man's relationship to God, the existence of heaven and hell, as well as a number of other issues of faith. In most cases such individuals incorporate some degree of biblical truth into their teachings in order to gain a certain amount of credibility in order to deceive the unwary.

From dictionary definitions, the term *occult* means "hidden" or those things or teachings that are "unknown" "covered over" or "secret". So, the occult is the seeking after knowledge of unknown information, knowledge that is gained beyond normal human experiences. Therefore, knowledge is said to be received by some supernatural involvement or connection. This they call "Satan" with a capitalised "S". Satanists admit or insist that their god is "satan", that is, they have become total adversaries to God.

Satanism challenges the biblical teaching regarding man's relationship to others. Each of God's people are to esteem others better than themselves, and are to be team players. In 1 Corinthians we read about God's people being a part of the body of Christ, whereas Satanism esteems the "self" over others.

Young Satanists believe that the strong will rule with what they see as "Satan". Once they are sufficiently involved, they often make a pact with the supposed Satan. They commit themselves to a future date when they will take their own lives by suicide. They believe that if they submit themselves to Satan in death, they will come back in another life as a stronger being and rule with him forever. This reincarnation idea is the nature of deception from hearts that are "*deceitful above all things*".

Power has become an obsession with young Satanists. It is sought after on the physical, mental, and spiritual levels. According to one former occultist, the greatest lure into the occult is "power" and "knowledge." Not just corporate power but personal power. Gaining knowledge that others do not possess is another aspect of the occult. When individuals have more knowledge it affords them a degree of power over those who do not have access to that knowledge. Satanism leads one into bondage through mind control and fear, whereas Christianity allows the individual the freedom

of choice to escape that bondage through the redemption that is in Christ Jesus.

THE CASTING OUT OF "DEVILS".



In dealing with the subject of "Satan" we have words which appear to be associated with that word, such as "unclean spirits" and "devils". These have to be touched upon, but these are not the prime subject of this paper, and so will not be enlarged upon.

We witness in the Gospels the parade of ailments Jesus cast out of people. These ailments were curses. People were healed when their curse was removed. This does not mean that these ailments have a leader called "satan" in the way popular religion is wont to say. What it means is that there is a parade of consequences of wrong belief, although this is not necessarily found in those personally healed. We know that the sin of Achan affected a whole nation-[Joshua 7] - although this sin may have reference only to the "Babylonian garment" and what that actually was.

Literal translations of "devil" are "spoiler", "hairy", "false accuser", or "slanderer". The phrase "the devil" is not found in the Old Testament. We see the plural word 'devils', twice meaning "spoiler" or "destroyer", and twice again meaning "hairy" or "shaggy". Otherwise it is translated as "goat", "kid" or "hairy" 54 times.

In the New Testament "the **devil**" is also translated "accuser", "false accuser" and "slanderer". "The slanderer" is the word used which tells us that Jesus was, "*tempted of the devil*", and as "*satan which deceiveth the whole world*". The other 78 renditions of "devil" or "devils" are from a word which means, "*to distribute fortunes*", or "*one who disburses or dispenses riches*". The Greek *daimonion* [Strong

1140] is a derivative of *diamon* [Strong 1142] is used in James 3:15 as “devilish” which clearly shows that it is an earthly heart-desire for mammon, or wealth, which is “devilish”. Scripture does not teach the popular “Satan” doctrine”. Nowhere in Scripture is there basis to regard “Satan” as a supernatural being.

“UNCLEAN” SPIRITS

Just as *spirit* means 'breath,' so does "unclean spirit" signify "foul breath", which are words in opposition to those of God. The casting out of “unclean spirits” is symbolic of the removal of belief in false doctrines which opinions 'tear' or torment the person who clings to them. It is false doctrine that drives men mad, as opposed to the peace which acting upon God's Word brings. This “madness” can be sensed; it “entered into” swine and drove them into the sea.

The fact that Legion and others were "possessed" (owned) by the deceitful principles of antichrist beliefs indicates the power of counterfeit words to bring us into submission to men who are “adversaries” in high places rather than to God. These “unclean spirits” include men in high authority in the earth, and our war is against them. That which defiles is that which comes out of the mouth of man, not of “satan”. As Jesus confirms:

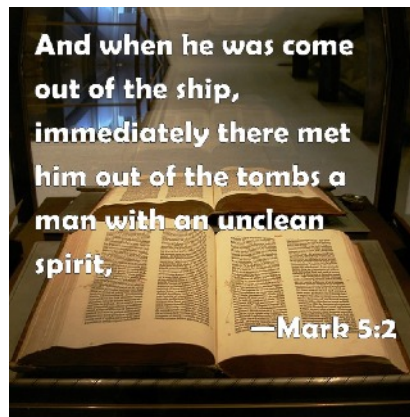
Mark 7:20 *And he said, That which cometh out of the man, that defileth the man.*

Only by hearing (understanding) His Word can we be rid of these erroneous beliefs which we have been taught, and of the effect these have on us. Only then can we have what the Bible calls a “sound mind” or “the mind of Christ”.

In the symbolism of the unclean spirits' speech, we see that these false doctrines debate with God Himself as to the truth of His Word, just as today those who are in error resist His Truth. We can see this in the following verses.

*Zechariah 13:2 And it shall come to pass in that day, saith the LORD of hosts, that I will cut off the names of the idols out of the land, and they shall no more be remembered: and also I will cause the prophets and the **unclean spirit** to pass out of the land.*

*Matthew 10:1 And when he had called unto him his twelve disciples, he gave them power against **unclean spirits**, to cast them out, and to heal all manner of sickness and all manner of disease.*



*Mark 5:2 And when he was come out of the ship, immediately there met him out of the tombs a man with an **unclean spirit**.*

*Luke 9:42 And as he was yet a coming, the devil threw him down, and tare him. And Jesus rebuked the **unclean spirit**, and healed the child, and delivered him again to his father.*

*Revelation 16:13 And I saw three **unclean spirits** like frogs come out of the mouth of the dragon, and out of the mouth of the beast, and out of the mouth of the false prophet.*

Obviously here we have good examples of symbols in vision form, having not happened physically. There were no literal frogs or dragons, were there?

Clothing a symbol with a personality is where the churches and tradition manufacture a person they regard as an identity they call “Satan”.

This is what they have done with the word “Lucifer”. Again, like the word “Satan”, **it is not a proper name**. The word simply has not been translated in the KJV. Many other translations use words like “*day star*”, “*shining one*”, “*star of the morning*”, etc. Isaiah 14 is **symbolic** of the restoration of Israel and the fall of Babylon, the adversary city which had risen as if it were a “day star”.

When Jesus said in Luke 10:18, “*I beheld Satan as lightning fall from heaven*” He was talking about adversary deception falling before the disciples. “Fall” = *pipto* = “to descend from an erect to a prostrate position”. What appeared to

be the light of a lamp (*astrape* = lightning) could not stand before the disciples and had to bow down.

THE TITLE of this article is one of many sayings that are often repeated in all forms of the media or even as a print on clothing. We are continually being stimulated to search for the reason for our existence. Luck and good fortune, which is the basis of being happy is continually sought after. In the end, materialism and selfish desires take over and the real purpose for life is drowned in a sea of froth and bubble. The whole matter is summed up in one word, "vanity" as expressed in **Ecclesiastes 12 : 8** "all is vanity".

Some time ago I sat with a very elderly lady and we talked about her younger years when she lived on a country farm. After commenting about her youth and the hardships of not having a father figure and the fact that her mother had to

improvise in so many ways, I asked her "Could she sum up in one sentence her approach in dealing with such difficult times?". This lady provided just one word and that was "contentment". Because simplicity in today's world is considered archaic, society has replaced it with the pursuit of happiness which has become an emotional state of mind that floats like an ether from one form of excitement to the next. The human mind becomes so over stimulated that it is often difficult to please and therefore be content with the simple aspects of life.

Whilst the words from the Presbyterian Larger Catechism of the Westminster Confession of Faith, might be an over simplification concerning the question, "What is the chief and highest end of man?", it is at least a starting point. The answer given in the Catechism is, "Man's chief and highest end is to Glorify God and fully to enjoy him for ever". It is through the word "enjoy" that we reach happiness.

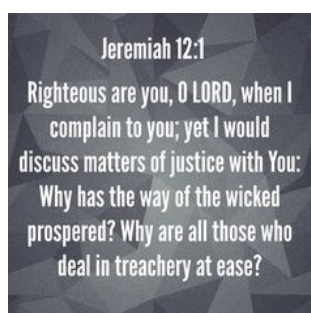
The words, "Don't Worry, Be Happy" by Bobby McFerrin, even though a catchy tune, lends to the accepted collective view that happiness is the prime aim in life. It is true that to worry should not be part of our personality, especially when we are to put all our cares into the hands of Christ. Worry often shows our lack of faith or belief. To worry can also show that we do not have enough confidence in a God who knows all things.

It is true that the cares of this world can choke how we approach the word of God and we become unfruitful. In **Matthew 6 : 34** we read, "Do not therefore fret about tomorrow, for the morrow has its own trouble. The care of each day by itself is quite enough" (Fenton translation). In light of the above it is natural to worry, especially in a world of curses resulting from disobedience to God's Laws. It is by studying the Word, that God will grant us the peace of mind to deal with our emotions of

concern. But God did not promise an easy way to the understanding of Truth and the path of life. But what does the Bible say about being happy. Before I proceed with Biblical happiness, it is interesting that the dictionary says of happiness that is associated with the word "hap", which means good fortune or luck, to come by chance. One dictionary says, "Being in the enjoyment of agreeable sensations from the possession of good, contented in mind, satisfied, highly pleased with oneself, fortunate; attended with good fortune; prosperous".

I will leave these definitions without comment. The underlying aspect of what the Bible says about happiness is in conjunction with being blessed. When you refer to Strong's Concordance it becomes obvious that being happy and blessed are associated. Other study aids also show the connection, namely Expository Dictionary of Bible Words by Stephen Renn and Expository Dictionary of New Testament Words by W. Vine. Being blessed is to do with God's providence. Refer to Genesis 28:14 where it states that the seed of Jacob shall bring forth blessings to the families of the earth.

The following list of verses with the word happy is not complete but when taken in their context it would become obvious that the meaning of being happy has a very different purpose than what the world expects. The word blessed should also be taken into consideration but I will leave that up to you for your own study. It is my view that because the word blessed has a more Biblical connotation it is not used often in association with the word happy.



and they prosper and those who deal treacherously and are happy. As for the verse from Malachi the proud are happy, those that work wickedness are set up and they that tempt the Lord are delivered. How easy it is to look around you and see the truth of the above, for many who aspire to such ends use happiness to cover their tracks.

There are a number of other verses that tell how the aspirations of the worldly are so often achieved by cunning and immoral methods. As for the verses in Peter we have been assured, "But and if ye suffer for righteousness' sake, happy are ye: and be not afraid of their terror, neither be troubled", and "If ye be reproached for the name of Christ, happy are ye; for the spirit of glory and of God resteth upon you: on their part he is evil spoken of, but on your part he is glorified". John 5:17 says, "If ye know these things, happy are ye if ye do them".

The few verses chosen are as follows: Psalms 127 and 128 refers to those who have their quivers full of arrows. They shall not be ashamed. Psalm 127:1 shows the context of happiness when the city is built by the Lord. In Psalm we have the fruitfulness of the people and how happy they shall be. Psalm 137 refers to the destruction of Babylon and how happy shall the people be when it is gone. Refer to Revelation 18 for the context of this Psalm. Psalm 144:15 refers to those who are happy and has God as their Lord. This Psalm refers to the providence of God when the people obey. Psalm 146:5 says Happy is he that hath the God of Jacob for his help, whose hope is in the Lord his God. Proverbs 3:13 refers to the finding of wisdom and understanding. Proverbs 14:21 refers to those who have mercy on the poor. Proverbs 16:21 refers to those who trust in the Lord. Proverbs 29:18 refers to those who keep the law, happy is he. James 5:11 refers to those who endure will be happy and the outcome will be realising God's pity and mercy. The ultimate understanding of the word happiness is to be seen in the Beatitudes of Matthew 5 and the references to Blessed as used in Revelation. The greatest blessings or happiness will be poured out to those who "are called unto the marriage supper of the Lamb" (Revelation 19:9).

It is in the context of the above verses that we begin to understand the question, "What is the chief and highest end of man?" So in conclusion I will not mention the usual end of year greeting but rather say, "May the God of Abraham, Isaac and Jacob grant you happiness that has been blessed". John T. of Winmalee.

New Heavens And A New Earth

(For A Lecture At Orange St. Church London)

Here then we have the answer to the question whether Israel ever really entertained a resurrection hope, and we find the answer by discovering the place that the People of God had in God's plan for his whole creation.

We are to remember that throughout the whole OT period Israel's corporate relationship to God remains a vital factor in the thought of her prophets and historians ('Thou art my God' Hos.2.23). Although composed of many individual men and women, each of whom God had made, in some sense, in his own image, yet Israel, the People of God as a whole, was in reality one great corporate 'nephesh'. It was the people as a whole who had been called to be the Son, so that in the last analysis it was they, who were made in the image of God as a corporate entity. But as Son of God (Ex.4.22) Israel was also Son of Man.

The people of the saints of the most High are thus finally become the man of God's' right hand, or, in other words, they are now sitting at the right hand of God. It is the zeal of the Lord of hosts alone which has performed this.

It is at its peril then, that the Church in its pride arrogates to itself alone the place and function of Israel. The Church has been engrafted into the stock of Israel from without by the grace of God alone.

The modern view, which is sometimes presented in the name of biblical religion, that, for example, a husband may be invited by God to enter 'heaven', and yet be willing to separate himself from the wife whom he loved on earth, and with whom he has been one flesh, and let 'her go' to 'hell' because of her unbelief, would be wholly inconceivable according to OT thought.

That is to say the fundamentally selfish conception that an individual man could cut himself off from his brethren and seek salvation

for himself in an after life was quite foreign to Israel's understanding of her relationship to God. On the other hand, it was the very logic of the Hebrews in this matter which finally led certain of the Psalmists and the author of Job to approach nearer to the hope of a life beyond death more satisfying than the current doctrine of Sheol with its pit.

This logic of theirs was paradoxically no less than the logic of faith. 'Whither I shall go from thy spirit' sang one Psalmist (139.7) 'or whither shall I flee from thy presence? If I ascend up into heaven thou art there; if I make my bed in Sheol, behold, thou art there'... Surely the darkness shall cover me; even the light shall be light about me'. Had not the God of Israel made the whole earth? Then had he not created Sheol as well?

Did his power not stretch down to the realm of the departed? (Num.16.30). Had not Enoch who had walked with God in this life, been taken; and was he not therefore still walking with God? (Gen.5.22). 'But God will redeem my 'nephesh' from the Power of Sheol: for he shall receive re'. Ps.49;15) is therefore one answer of faith to the problem of Sheol. Whom have I in heaven but thee? and there .is none upon earth that I desire beside thee.

My flesh and my heart will fail; but God is the strength of my heart and my portion for ever 'le-olam' (Ps.73.25-26) (See p.102) Therefore my heart is glad, and my glory (or perhaps 'liver' - the consonants are the same) rejoiceth; my flesh also shall rest in hope. For wilt leave my flesh in Sheol; neither wilt thou suffer thine holy one to see the pit' (P.16.9-10).

Central to God's choice of action then, we observe once again the ultimate paradox of omnipotent humility. God who is 'shaddai', Almighty, and 'bore', Creator, who declares the end from the beginning (Isa.46.10), and who could recreate his universe with the same ease with which he first created it, chooses to go another road. What he chooses to do, for no understandable reason except that of love

(Deut.4.37) is to humble himself, nay, to empty himself, to become one flesh with the empirical people of Israel, his own creation, a people that lay under the curse of God himself! It is through his union, then, with this accursed people dwelling upon this accursed earth that God is revealed to us in the OT to be working out his

pan for the redemption, not only of the Israel whom he loves, not even only of all mankind, but also of his whole fallen and rebellious universe. **God's choice of Israel exemplifies the mystery of love.**

Joshua And The Israelites In Britain and Ireland

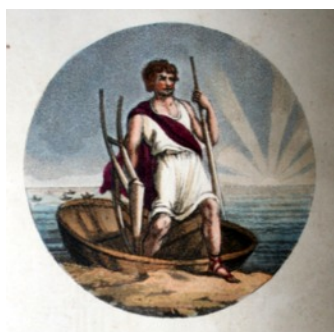

"Every place that the sole of your foot will tread upon I have given you, as I said to Moses."
Joshua 1:3

What do the names: Joshua , Jesus , Hesus , Hu Gadarn, Hu the Mighty, Yeshua, have in common? They are all the names given to the same biblical Joshua who took the Israelites into the Promised Land. The eradicating of the knowledge of Joshua and the Israelite colonization of the British Isles has led to the longest enduring Holocaust, throughout Europe, which has not been properly recorded in history. More Israelite blood has been shed over the identity issue than Jewish blood shed during the Second World War. The knowledge of who the druids were is a major key to solving a historic puzzle. 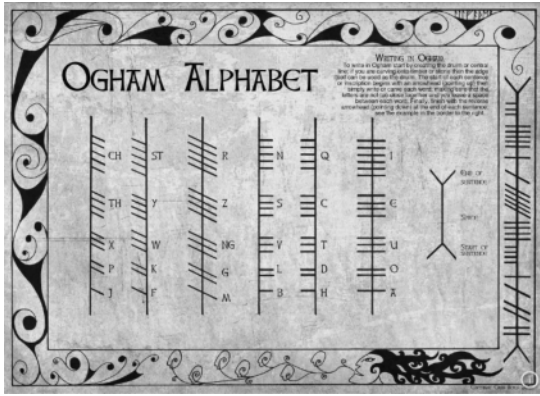

Jesus was merely the Greek form of the Hebrew name Joshua. Hu or Hesus the Mighty was Joshua the Mighty, the great general who led Israel into Palestine. And the Welsh Triad records that in his later years he also settled Israel peaceably in the British Isle. From there, for trading purposes, they spread to the coasts of the continent..." (*Compendium of World History*, by Herman L. Hoeh, Vol. II, page 49-50, 1969, printed in the U.S.A.)

"The educational system adopted by the Druids is traced to about 1800 B.C. [editors note: should be mid 1300's B.C.] when Hu Gadarn Hysicion (Isaacson), or Hu the Mighty, led the first colony of Cymri into Britain from Defrobane, where Constantinople now stands. In the justly celebrated Welsh Triads, Hu Gadarn is said to have methodically systematized the wisdom of the ancients of these people whom he led west from the Summerland.

He was regarded as the personification of intellectual culture and is commemorated in Welsh archaeology for having made poetry the vehicle of memory, and to have been the inventor of the Triads. To him is attributed the founding of Stonehenge, and introduction of several arts including glass-making and writing in Ogham characters.

On Hu Gadarn's standard was depicted the Ox; in this possibly may be discovered the origin of the sobriquet, 'John Bull'. Hu established, among other regulations, that a Gorsedd or Assembly of Druids and Bards must be held on an open, uncovered grass space, in a conspicuous place, in full view and hearing of all the people." (Celt, Druid and Culdee, by Isabel Hill Elder, page 53, The Covenant Publishing Company, London, 1973.)

The Great Holocaust of Europe



A migration of Israel Identity believers took place during the Middle Ages, through Europe to escape the Holocaust. The history of the British Isles can now be rewritten to re-establish the national inheritance of the Celtic and Anglo-Saxon peoples who are the chosen people of the Bible.

Conclusion



The fact that Joshua was in Britain, is the missing link between the Identity Movement and the British peoples. Wherever Joshua placed his feet became the soil of the Hebrews, known as Israel. The British Isles are the inherited lands of the Tribe of Ephraim, and a refuge for the Houses of Israel and Judah. Who can deny it? It comes from the mouth of the Almighty God of Israel.

The Man Who Preached After He Was Dead

LUTTERWORTH CHURCH. 11

Doctor John Wickliffe has been dead these forty years, and his bones have been lying the while in Lutterworth Church-yard; but it has been decreed by the great Council of Constance that they shall lie there no longer.

A party of monks, with pick and spade, have dug them up, and now they kindle a fire, burn them to powder, and shovel the ashes into a brook which sweeps past the church-yard; and the brook bears them on to the Avon, which, after winding through Stratford meadows, falls into the Severn, and the Severn bears them to the sea. But why are the monks so intent upon annihilating the doctor's bones?

Because the doctor, who was a preacher, though he has been dead so long, still continues to preach! The monks will have no more of it; and they think that by getting rid of his bones they will put an end to his preaching. They forget that there are some things which the fire will not burn—such as liberty, truth, justice.

Little do they think that the doctor will keep on preaching; that his parish will be the world, his followers citizens of every land; that his preaching, together with that parchment and the great piece of beeswax attached to it, which the barons obtained from John Lackland, will bring about a new order of things in human affairs; that thrones will be overturned; that sovereigns will become subjects, and subjects sovereigns.

LUTTERWORTH CHURCH.

A century has passed since the Magna Charta was obtained, but not much liberty has come from that document as yet. The people are still villains. The king and the barons plunder them; the monks, friars, bishops, and archbishops—a swarm of men live upon them. They must pay taxes to the king, to the barons, and to the priests; and they have no voice in saying what or how much the taxes shall be. They are ignorant. They have no books. Not one man in a thousand can read. The priests and the parish clerks, the bishops, rich men, and their children are the only ones who have an opportunity of obtaining an education. There are no schools for the poor.

STRATFORD

The priests look sharply after their dues. Be it a wedding, a funeral, the saying of mass for the dead, baptizing a child, granting absolution for sin, or any other service, the priest must have his fee. The country is overrun with monks and friars—Carmelites, who wear white gowns; Franciscans, dressed in grey; Augustinians and Dominicans, who wear black. They live in monasteries and abbeys, shave their crowns, and go barefoot.

They have taken solemn vows to have nothing to do with the world, to spend their time in fasting and praying; but, notwithstanding their vows, none of the people—none but the rich men—can spread such bountiful tables as they, for the monasteries, abbeys, nunneries, convents, and bishoprics hold half the land in England, and their revenues are greater than the king's. In the monastery larders are shoulders of fat mutton, quarters of juicy beef, haunches of choice venison. In the cellars are casks of good old wine from the vineyards of Spain and the banks of the Rhine, and yet the friars are the greatest beggars in the country.

They go from house to house, leading a donkey, with panniers lashed to the animal's sides, or else carry a sack on their backs, begging money,

butter, eggs, cheeses, receiving anything which the people may give; and in return invoking the blessings of the saints upon their benefactors, and cursing those who refuse to give. They have relics for sale: shreds of clothing which they declare was worn by the Virgin Mary; pieces of the true cross; bones of saints—all very holy.

GOOD OLD WINE



They have a marvellous story to relate, of St. Dunstan, who was a blacksmith, and very wicked, but afterward became a good man, and was made Archbishop of Canterbury. One day the devil came and looked into the window where the saint was at work, trying to tempt him, whereupon St. Dunstan seized his red-hot tongs and clapped them upon the devil's nose, which made the fiend roar with pain; but the saint held him fast till he promised to tempt him no more.

THE WAY ST. DUNSTAN SERVED THE DEVIL

The people are very ignorant. There are no schools; there are none to teach them except the priests, monks, and friars, who have no desire to see the people gaining knowledge, for knowledge is power, and ignorance weakness. The people are superstitious, as ignorant people generally are. They believe in hobgoblins and ghosts. They have startling stories to relate of battles between brave knights and dragons that spit fire, and are terrible to behold.



St. George, the patron saint of England, had a fierce encounter with a dragon, and came off victorious. The peasants relate the stories by their kitchen fires; the nobles narrate them in their castles; the poets rehearse the exploits of the brave knights in verses, which the minstrels sing from door to door. Although no one ever has seen a dragon, yet everybody believes that such

creatures exist, and may make their appearance at any moment.

A KNIGHT FIGHTING A DRAGON.

The people believe in witches. Old women who are wrinkled and bent with age are supposed to sell themselves to the devil, and he gives them power to come and go through the air at will, riding a broomstick, at night, bent on mischief; with power to fly into people's houses through the keyholes, to bewitch men, women, children, horses, dogs, cattle, and everything. If a horse is contrary, the people say old Goody So-and-so has bewitched it; if the butter will not come in the churn, the cream is bewitched; if anything happens out of the usual course, the witches are the mischief.

"There is mischief in the air."

King, priest, nor people will not suffer witches to live, for the Bible commands their destruction, say the prelates of the Church, who alone have the Bible; and many a poor, innocent woman is put to death.

MISCHIEF IN THE AIR

The monks and friars having been recognized by the Pope, and holding their authority directly from him, assert their right to preach in the churches, crowding out the parish priests.

Little good does their preaching do. It is mostly marvellous stories about the saints, and what happened to people who did not feed them; or about the wonderful miracles performed by relics. They sell pardons for sins committed or to be committed; and they have indulgences absolving men from all penalties in this life, as well as after death.

The monks drive a thrifty trade in the sale of relics. The good people who believe all the stories of their wonderful power to cure diseases, to preserve them from harm, bow down before the bits of bone, and pieces of wood, and rusty nails, and rags which they exhibit; but there are so many relics that some of the people begin to see the tricks which the monks are playing upon them, for it is discovered that John the Baptist had four shoulder-blades, eight arms, eleven fingers, besides twelve complete hands, thirteen skulls, and seven whole bodies—enough almost

for a regiment! It is discovered that some of St. Andrew's bones once belonged to a cow; that St. Patrick had two heads—one small, preserved when he was a boy, and the other large, the one he wore when he became a man!

THE MONKS



Some of the monks spend their time in writing books—printing the letters with a pen; but many of them are lazy. The abbots and bishops are fond of hunting foxes, and ride with the country gentlemen after the hounds, and sit down to good dinners in the barons' halls. The parish priests, for the most part, are ignorant. Their sermons on Sunday are narratives of monkish traditions, stories of the saints, with commands to attend mass. They get up spectacles called "miracle plays," acting them as dramas. They ask the women and girls indecent questions when they come to confession, and their lives are very far

from being pure. They are so debased that they drink themselves drunk in the village ale-house. If the monks, or priests, or bishops commit a crime, even though it be murder, the king cannot arrest them, for the bishops have their court, and a man who enters the priesthood is not amenable to civil law. They are let off with a light penance, and then may go on saying mass, and absolving the people from their sins. But if one of the people commits murder, he will have his head chopped off by one of the king's executioners.

The priests, however, are not all of them wicked. There are some who, instead of spending their time in the ale-houses, or in plundering their parishioners, look kindly after their welfare. Some are learned men, educated at Oxford or Cambridge, who exhort the people to lead honest lives. The man whose bones the monks are burning was a good priest, a learned man. We may think of him as attending school, when a boy, at Oxford, graduating from one of the colleges; and, after graduating, he studies theology, and becomes a priest, and preaches in the Oxford churches. He is so learned and eloquent that the people come in crowds to hear him. There are students at Oxford from all over Europe—from France, Holland, Switzerland, Germany, and Bohemia—thirty thousand or more—who listen to his preaching. His fame reaches London; the king (Edward III.) sends for him, and he preaches to the court.

He uses a camera and tripod to photograph the lights, and advises snapping in the dark away from city light pollution and never using a flash.

God's Word

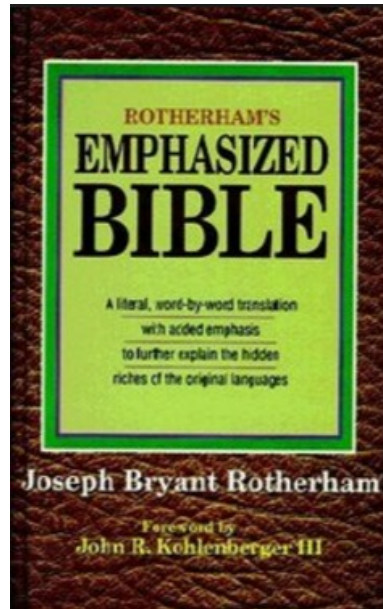
Sir--, I make no apology for writing again concerning "GOD's WORD" as contained in The Holy Bible. This e-mail is forwarded to many of my friends throughout the world. All of whom would describe themselves, in matters concerning "GOD", as one or more of the following - Christian, Churchgoer, Identity Christian, British Israelite or even Biblicist.

For the sake of clarity, I shall use the word "GOD" in this e-mail although I am well aware that many prefer to use the word, Yahweh, or Jehovah, or simply God.

Over many years I have advised many of my friends to consider reading and studying GOD's word by the use of a "literal" Bible translation. Of course, many have ceased reading the Authorised/KJV Bible as they have been told that "modern scholarship" has rendered this particular translation of the Bible as obsolete. Have we really studied this subject before deciding to cast away the Bible that literally changed the world? Do we study to establish for ourselves, that which are the true texts from which the Bible was produced? GOD promised to preserve His Word FOR ALL TIME. Do we believe Him? 1] I have often recommended the Emphasised Bible by J B Rotherham. I still regard this as a fine "literal" translation HOWEVER do those of you that use Rotherham's Bible know from which texts your Rotherham Bible is translated? Do you think this question is

important? Does it make any difference? The original Rotherham Bible was published in 1872. This Bible was translated from the TRUE Majority Text that had been used in ALL of the GREAT ENGLISH LANGUAGE BIBLES UP TO THAT TIME – AND ALSO ALL GERMAN BIBLES. However, we should know that the devil never rests in his aim to destroy the TRUE Word of GOD. Just six years later, in 1878 and again in 1879 Rotherham decided (or was he persuaded ?) that he should make a new translation, including translating from the (spurious) texts that were then coming on stream via the "scholarly textual critics", notably Westcott and Hort.

2] In addition, the truly great Literal Translation of the Bible by Robert Young, also from the true Majority Text published in 1862, was also "amended". In 1887, Young produced a new translation based on the spurious 1881 Westcott and Hort eclectic text. (How can any "eclectic" test be considered worthwhile?) However, by GOD's good grace, the publishers of the original Young's Literal Bible of 1862 "smelled a rat". In 1898, these publishers REPRODUCED the original 1862 Literal Translation!! Well done those men!!

Do we not smell a rat – or perhaps a snake or devil?

I humbly ask that you all check out which Bible(s) you read. The devil creeps in and many are unaware – as shown in the way GOD’s Word in the Rotherham Bible has been altered without many noticing the fact. So what do we do to ensure we are reading and studying the Preserved word of GOD? May I suggest:-

1] Before we proclaim GOD’s Word, we should ensure that which we are proclaiming is indeed The Word of GOD and not words translated from a spurious text – no matter what “modern scholarship” says!

No matter how proficient a translator may be, any translation made from the Minority Text or the Westcott and Hort, so called, 1881 eclectic text, will never guide one to The Truth of Scripture.

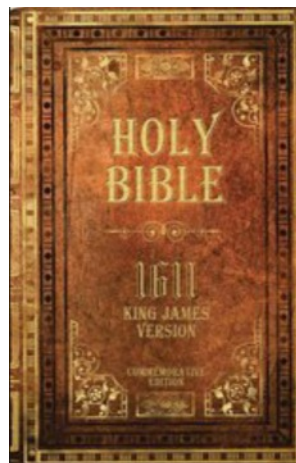
6] I suggest that a good choice of “Literal Bibles” may be made from, Young’s Literal Bible 1898 edition, J P Green’s Interlinear Bible and of course, Rotherham’s Bible as long as it is the 1872 translation.

7] Please compare the readings of Old English Bibles with any spurious “modern Bible”. By “modern Bible” I refer to the (English) Revised Version, The American Standard Version and all subsequent versions translated since 1881 from the spurious minority text.

8] Please check in the Bible you use, as to how the translators’ explain why their version is

superior. Such explanations make interesting reading

9] Can the hundreds of “modern bibles” currently being sold, ALL be The Word of GOD? If all of these, or any of these Bibles are the Word of GOD, just where was GOD’s Word BEFORE 1881?



10] I realise that many words in the Authorised / KJV are badly translated. That is why I suggest checking out such “errors” via a Literal Translation. I cannot “read” Hebrew or Greek texts. However, today, with very good lexicons available, anyone can easily understand the real meaning of any

Hebrew or Greek word written in the Majority Text. (A point to remember here is of course, that Strong’s is a Concordance NOT a Lexicon.) Many say they need their Bibles to be in “modern English” – whatever that term may mean. REALLY?? Are we unable to read Shakespeare’s works? Well, the 1769 edition of the Authorised Version is not difficult to read unless we also say that we can’t understand any of the words of the great hymns of that period. Margate Shell Grotto

The American Flag Is The Flag Of The East India Company

Following is an excerpt from the book **Critical Path** by Buckminster Fuller



Ross, after which came the thirteen white, five-pointed stars in the blue field with the thirteen red and white horizontal stripes. While the British government lost the 1776 war, the East India Company's owners who constituted the invisible power structure behind the British government not only did not lose but moved right into the new U.S.A. economy along with the latter's most powerful landowners.

IT IS IMPORTANT TO NOTE that, while the British Empire as a world government lost the American Revolution, the power structure behind it did not lose the war. The most visible of the power-structure identities was the East India Company, an entirely private enterprise whose flag as adopted by Queen Elizabeth in 1600 happened to have thirteen red and white horizontal stripes with a blue rectangle in its upper left hand corner. The blue rectangle bore in red and white the superimposed crosses of St. Andrew and St. George.

When the Boston Tea Party occurred, the colonists dressed as Indians boarded the East India Company's three ships and threw overboard their entire cargoes of high-tax tea. They also took the flag from the masthead of the largest of the "East Indiamen"—the Dartmouth. George Washington took command of the U.S. Continental Army under an elm tree in Cambridge, Massachusetts. The flag used for that occasion was the East India Company's flag, which by pure coincidence had the thirteen red and white stripes.

Though it was only coincidence, most of those present thought the thirteen red and white stripes did represent the thirteen American colonies—ergo, was very appropriate—but they complained about the included British flag's superimposed crosses in the blue rectangle in the top corner. George Washington conferred with Betsy

By pure chance I happened to uncover this popularly unknown episode of American history. Commissioned in 1970 by the Indian government to design new airports in Bombay, New Delhi, and Madras, I was visiting the grand palace of the British fortress in Madras, where the English first established themselves in India in 1600. There I saw a picture of Queen Elizabeth I and the flag of the East India Company of 1600 AD, with its thirteen red and white horizontal stripes and its superimposed crosses in the upper corner. What astonished me was that this flag (which seemed to be the American flag) was apparently being used in 1600 AD., 175 years before the American Revolution.

Displayed on the stairway landing wall together with the portrait of Queen Elizabeth I painted on canvas, the flag was painted on the wall itself, as was the seal of the East India Company. The supreme leaders of the American Revolution were of the southern type—George Washington and Thomas Jefferson. Both were great landowners with direct royal grants for their lands, in contradistinction to the relatively meagre individual landholdings of the individual northern Puritan colonists.

Top Herbs For Vision And Eye Health Tony Isaacs (Health Secrets)



WHAT YOU CONSUME has a tremendous affect on the health of your eyes, and lost vision can be restored by giving the body what it needs. A plant based diets that provide ample amounts of vitamins, minerals and carotenoids is the first step in maintaining and restoring your eyesight. When that is in place, the next phase is adding herbs and remedies that support and heal the eyes. Here is a list of the top herbs for vision and eye health.

Herbs that keep eyes healthy

Pycnogenol is a powerful antioxidant derived from French maritime pine tree bark and the

subject of more than 180 studies. Of particular note is its ability to reduce leakage into the retina by repairing capillaries in the eyes. While still largely unknown to American doctors, *Pycnogenol* is the leading prescription for diabetic retinopathy in France.

Coleus forskohlii, *Pilocarpus jaborandi*, and *Triphala* have all been used to lower intra-ocular pressure via parasympathetic relaxation of the body. *Triphala* has long been used in Ayurvedic medicine for the treatment of glaucoma.

Saffron is better known as the kitchen spice that gives curry its yellow color; however, it can have wonderful results for eye problems, including cataracts. In a recent trial, every participant who took saffron had vision improvements and the researchers said the aromatic herb “may hold the key to preventing the loss of sight in the elderly”.

[No, very few curries contain saffron because it is extremely expensive (the most expensive spice on earth); plus, while saffron has an in-

credible rich and warm flavor, it is easily overpowered by other spices and herbs, as contained in curries. I have only found one curry that has saffron in it (the name eludes me but I can find it if anyone is interested). Turmeric (another excellent spice) gives the yellow color to curry, as it is in most all curries... Turmeric is even used for color in saffron rice (my favorite, though the saffron does give it yellow color too) and in mustard. I stock Turmeric bulk if anyone is interested. It is incredible for inflammation. 1 heaping service teaspoon in about 4 oz of warm water twice a day or more, in a day or two will clear up severe inflammation. 5.50 / lb. + P&H. It stains powerfully, so rinse mouth well after drinking; also, wash any cookware/dishes immediately if cooking with it.

Also, I can offer 1 oz. (or 28 grams) tins of saffron threads for 84.00 + P&H. One ounce is huge and will take you years to use it all; but it should not be stored in the decorative tin but in a small glass mason jar. It is excellent in soups, rice, even chicken salad or egg salad. It takes about 5,000 flowers (or 15,000 stigmas/stamens) to make an ounce of saffron threads; which are the center filaments of one species of fall-blooming crocus flower.]

Silymarin, the primary component of milk thistle, is a major liver support compound. The liver is the key organ for the eye, since all the fat soluble vitamins and glutathione are stored there, and B vitamins are activated in the liver. The eye is subjected to bright light throughout the day and important ingredients for repair are stored in the liver.

[This thistles produces a beautiful plant and it is not cold hardy so it will not take over, it will die out.]

Bilberry is high in a type of bioflavonoid that speeds the regeneration of rhodopsin, the purple pigment used by the eyes' rods. British air force pilots in World War II ate bilberry jam to improve their night vision during evening sorties.

Ginkgo biloba has been used for many centuries for eye and central nervous system problems. It is a selective cerebro-vascular dilator and seems to increase circulation to the back of the eye as well as increasing blood flow to the eye. It is also becoming an increasingly popular adjunct in the treatment of macular degeneration and glaucoma.

[Gingko is also excellent for the brain; it is the leaves of a slow-growing tree (mine is quite small after over a decade). However, don't take too close to bed-time or it will keep you awake.]



Eyebright (above) has flowers that resemble eyes and has been used for centuries to treat eye irritation. The name is also thought to have been given the plant because of its valuable properties as an eye medicine that preserved eyesight and so brought gladness into the life of the sufferer.

[The old herbal doctrine of "signatures" indicates that often a plant will be shaped like the bodily organ that it helps; God kind of knew what He was doing.]

Remedies for the Eyes

Bentonite clay poultices have been used successfully by many people with eye problems. **Bentonite** clay pulls out toxins that cause many different eye issues and is especially good for infections and eye strain. It has been reported to help restore vision in the instance of cataracts

Mix one-half to one liter of a combination of carrot, celery, and parsley, and chicory juice to help nourish the optic nerve and muscular system. Amazing results have been reported using this formula.

[I believe unless specifically indicated, any formulas mentioned are meant to be drank, not washed in the eye.]

Use *fennel* eaten raw, made into tea or used as an eyewash to help with vision problems, including cataracts.

*Endive juice is considered to be an effective remedy for myopia. It can also be mixed with other beneficial juices such as carrot, parsley, and celery.



Cayenne is an anti-inflammatory for the mucus membranes and it increases blood flow to the eye when taken internally.

[Cayenne can also be added in small amounts to tinctures and washes for the eye, yes, it does burn, but it subsides. Dr. Shultz uses it in his eyebright formula. Cayenne also stops bleeding, whether used internally or externally, even though it increases blood flow. 1/4 teaspoon drank in 4 oz of warm water can stop a heart attack / stroke and will also stop bleeding anywhere in about 30 seconds. It will stop bleeding externally or internally. It can also be applied externally to a wound to stop bleeding. You can mix it in a specially labeled nose-spray bottle and it will stop nose bleeds; yes, it will burn, but the burning subsides and is better than dripping blood all over the place. Cayenne can also be applied in small amounts to stop bleeding after shaving if you don't have one of those blood stop pencils; which also work for nosebleeds; and the pencils burn too.]

Use **Coleus** dropped directly into the eye to increase blood flow to the eye and decrease intraocular pressure.

[the juice from the decorative plant known as dusty miller (which I think is in the artemisia/wormwood family) is also reported to dissolve cataracts, when used as an eye drop]

Jaborandi is an herb that grows in the rainforest. It's been used for well over 100 years in patients with glaucoma and it contains pilocarpine, an alkaloid compound which causes constriction of the pupils and reduces pressure within the eye.

Remedies Especially for Cataracts

The use of carrots is considered beneficial in the treatment of cataracts. Take plenty of raw

carrots daily or else drink two glasses of fresh carrot juice, one each in the morning and evening.

*Eat two or three cloves of raw garlic daily to clean the crystalline lens of the eye. The cloves should be chewed slowly.

*Mix an equal quantity of aniseed and coriander powder together with one teaspoon of brown sugar, and take the mixture in doses of 12 grams in the morning and evening.

*Place a few drops of raw organic honey in the eyes twice or more each day. This is an ancient Egyptian remedy which is reported to have been beneficial to many people with cataracts.

*Finely grind seven kernels of raw almonds together with half a gram of black pepper and place in a half cup of water. Sweeten with raw honey and drink the mixture to help the eyes regain vigor and clarity.

*Twice daily, close your eyes and bathe them with hot (but not scalding) water containing Epsom salts. In addition, take an Epsom salts bath at least twice a week. Remain in the bath from twenty-five to thirty-five minutes till you perspire freely. After the bath, cool off gradually.

[Epsom salts contain magnesium. Magnesium is the most important mineral in the body and most everyone is deficient in it and it is hard to get enough because your body does not assimilate it that well; epsom salts baths are intended to absorb through the skin as much as possible, so long hot baths can be helpful; and the notion of putting it directly on eyelids is for the same reason.] Maybe wet a warm wash cloth with the epsom salt water and lay down and place over eyes, and place heating pad on top and rest.]

When it comes to eye remedies, the best results may well come from combining one or more of the suggested remedies.

Two final ingredients essential to improving vision and maintaining eye health are patience and perseverance. Most vision problems do not develop overnight and are unlikely to correct overnight. However, with patience and perseverance vision problems can often be improved and perhaps even corrected entirely. And with a good diet and other items such as those described in this article, you may be able to maintain good eyesight for a long, long time.
