

# Daniel's Seventy Weeks Fulfilled in Yahshua Messiah

**O**WN to the Crucifixion. From the following analysis of the way in which the Passover week was practiced, there is

an important detail that most of us have missed.

Passover: [Ex. 12:1-14 & Lev. 23:4,5] On the 10th day of the first month, Nisan, [roughly equivalent to April on our calendar], every family of Israel was to take a lamb, without blemish, and separate it from the flock. On the evening of the 14th the Passover lamb was killed, cooked, and eaten during the night. The blood was applied on the door posts and lintel. This feast celebrates the Exodus from Egypt. But, like all of the feasts, it also has a prophetic meaning. It looked forward to the sacrifice of the "Lamb of God who taketh away the sin of the world." This was clearly demonstrated by Paul when he wrote, "For even Christ our Passover is sacrificed for us." [1 Cor. 5:7]. Not only did Jesus fulfil this feast symbolically, but also quite literally. On the 10th of Nisan, Palm Sunday, Jesus rode down the mount of Olives on a colt. He was crucified four days later on Passover. [Source](#).

On reading this passage, I realized that the 10th of Nisan was one of the important days of Holy Week, the day on which the "lamb without blemish" is selected. This "selection" was actually accomplished by the anointing ritual performed by Mary Magdalene, the day before He rode into Jerusalem. Yahshua Messiah was **Selected** as the "sacrifice without blemish" on this day. Yahshua would be anointed as heir-apparent to the throne of Israel later that week!

[Note: John Pratt, the Mormon chronicler of the Hebrew and other calendars, has stated that Monday, April 6, 2009, marks the 70th Jubilee from the day that the Israelites entered the Promised Land. This date obviously falls within our Holy Week this year (2009). For this fascinating info, [click here](#):

Incidentally, we have already planned our 9/9/09 (the follow-up to last year's 8/8/08 event) Internet radio marathon for this year; and the theme is Yahweh's Jubilee! In addition, according to the Solar Calendar, which I have deduced from the Bible, the Book of Enoch and the Book of Jubilees, Passover falls on Friday, April 3 in 2009, which happens to be the same date as the Crucifixion in 33 AD.

I believe that these anniversaries demand that we start paying real close attention to the meaning of the Hebrew Feast Days, for they have a prophetic meaning, giving us the pattern of the events that lead up to the Second Coming.]

The Hebrew word for "week" can mean any period of seven days, regardless of what its first day is. It does not necessarily mean from Sabbath to Sabbath, as in the usual 7-day Sabbath rest. That comes from the Hebrew word, Shabbath (#7676). We still have the same general usage of the word week today, as in "I'll see you in a week." It is not necessarily a reference to the first day of the Monday-Sunday week that most of us follow. Nor is it a reference to the Sunday-Saturday "Sabbath" of the Old Testament.

The shabua of Dan. 9:24-27 is a reference to any set of seven days, but the "one week" is a very specific week in the life/death of Jesus Christ!

There are many articles that discuss the chronology of Yahshua's final week. I found this one to be one of the best. It is entitled, "[The Last Week of Christ's Life](#)," by John Schoenheit.

I will be taking quotes from this article to help document the events of the Holy Week. If you will go back and reread Isaiah 53, referenced above, you will see how many of those prophecies are fulfilled during Holy Week!!! Isaiah 53 is actually a capsule summary of Christ's mission as the Lamb of God!

### Day 7: Announcement Day

Jesus announces that the time has come for His Passion and He collects the Apostles to

accompany Him as He travels from Galilee into Judea:

**Matthew 19:1:** “And it came to pass that when Jesus had finished these sayings, He parted from Galilee and came into the coasts of Judaea beyond Jordan; and great multitudes followed Him; and He healed them there.”

As the Apostles question Him about the meaning of their following Him, He responds,

“Verily I say unto you, that you which have followed Me, in the regeneration when the Son of Man shall sit on the throne of His glory, **You Also Shall Sit Upon Twelve Thrones**, judging the twelve tribes of Israel.” (Mat. 19:28.)

Thus, He is telling them that these events will have their ultimate effect when the Kingdom has been restored to the Twelve Tribes of Israel. This is clearly an eschatological prophecy, verifying Rev. 21:12. Now, this gets tough:

“And everyone that has forsaken houses, or brethren, or sisters, or father, or mother, or wife, or children, or lands, for my Name’s sake, shall receive a hundredfold, and shall inherit everlasting life.” (Verse 29.)

Christian Identity teaches that we must follow Yahshua, not the Judeo-Christian ministers, who teach the broad path to “salvation.” They want to “save the world” by “converting” the unbelievers. Even Paul says, “Do not be unequally yoked with unbelievers.” (II Cor. 6:14.) Jesus teaches that the world will **hate** the real followers of Jesus Christ! (Psalm 109:5, Matt. 24:9, Mark 13:13, Luke 6:22.)

How different this is from the prevailing, modern teaching that all you have to do is believe in His name and you will be saved! The Christian couch potato, since his “faith” lacks substance, has little to offer and risks nothing! He just waits to be “raptured.” True Christianity **Separates us from the evil world**, in order to prepare us for the world to come!!

These blind leaders of the blind simply refuse to acknowledge the hundreds of prophecies that tell us that this world order will be judged by a scorching heat, a purification by a literal, moral and spiritual fire. They have utterly abandoned the “fire and brimstone” message in favour of

the “God loves everybody,” “We are all saved” nonsense of Judeo-Christianity. With all of their efforts focused on “saving” the heathen, they will not even be able to save themselves!!!

Continuing on their way to Jerusalem, Jesus stopped and said to the Twelve:

“Behold, we go up to Jerusalem; and the son of man shall be betrayed to the chief priests and to the scribes, and they shall condemn Him to death. And shall deliver Him to the nations to mock, and to scourge, and to crucify Him: and the third day He shall rise again.” (Mat. 20:17-19; Luke 18:31-32.)


The Gospel of John sets up Holy Week with these words:

“And the Jews’ Passover was near at hand: and many went out of the country up to Jerusalem before the Passover, to purify themselves. Then sought they for Jesus, and spoke among themselves, as they stood in the temple, What think you, that He will not come to the feast?” (John 11:55-56.)

Jesus, being an Israelite of the Tribe of Judah, the Seed of David (Matt. 1:1), would surely come to the Feast, but there was a problem:

“Now both the chief priests and the Pharisees had given a commandment, that, if any man knew where He were, he should show it, that they might take [arrest] Him.” (Verse 57.)

The ultimate confrontation between the Messiah and the Jews was at hand.



After passing through Jericho, Jesus and the Twelve finally ascend into Jerusalem, where Jesus steered toward the house of Zacchaeus, saying to him, “Zacchaeus, make haste, and come down; for today I must abide at your house.” (Luke 19:5.)

Although the account does not say so, it is clear that Jesus meant that He would stay the night at the home of Zacchaeus, for the trip from Jericho was a long and eventful one.

Here is a description of the terrain and travel time required in the days of Jesus:



Although the road between Jerusalem and Jericho may have changed since ancient times, archaeologists have helped us understand the landscape of the road at the time of Jesus. The road that joined the two cities was a direct horizontal climb from Jericho. It crossed rugged, rough terrain along side cliffs and embankments. The distance from Jericho to Jerusalem may have been about twelve miles and could have taken eight to ten hours to travel on foot. [Source](#).

Given the distance and the events depicted, at least two-thirds of the daylight hours were required just to walk the distance, especially with a mob of people tagging along, with Jesus performing numerous miracles along the way! So, it seems reasonable to conclude that Jesus stayed overnight with Zacchaeus.

### **Day 6. The Anointing and First Supper**

This is the evening of the First Anointing, “six days before the Passover.” (John 12:1.) The anointing of His feet establishes His qualifications as the Lamb of God. This would be the equivalent of Nisan 10, the day on which the sacrifice is selected. After Judas protested that the money for such expensive oil should not be wasted on a trivial ritual, Jesus rebukes him and says,

“Let her alone, against the day of My burying has she kept this.” (Verse 7.)

Here is the beginning of the fulfilment of Daniel 9:27, “And He shall confirm the covenant with

many for one week.” This is the “week” we are here documenting, the only week in which He went 7 days in a row into Jerusalem. This is the week, during which Yahshua confirms, with many, various terms of the Old Covenant, in which our Kinsman Redeemer was promised to us. Jesus is announcing that He is now preparing Himself to perform the promise of redemption.

(Let me interject here that the basis of my new interpretation of the italicised sentence in the previous paragraph is that it **does not** refer to the “weeks of years,” as the other “weeks” in Daniel do. Rather, the “one week” in the sentence quoted in the previous paragraph refers to a **literal Week**, namely, **Holy Week**, a week of seven literal days, which I am recalling here.)

John adds the comment that the real reason Judas objected to the expenditure was that this money would no longer be available for him to steal!!! (Verse 6.)

[Here, Pastor Schoenheit interjects that this information about Judas explains an apparent contradiction cited by skeptics against the veracity of the Scriptures. As he explains it:

By the way, this helps us explain an apparent contradiction in God’s Word because the Bible in Acts says that Judas bought a field with the reward of iniquity, yet we know that the money that Judas got for selling Christ out he threw down in the Temple and walked away from it. How could he buy a field with the reward of iniquity if the money that he got for selling Christ was thrown down at the Temple, and the Scribes and Pharisees gathered it up and kept it? The answer is in this verse. Judas was constantly stealing stuff from the ministry of Christ for his own needs and desires. **Comprende?**

As the Jewish author, Samuel Roth (Jews Must Live), has explained to us, the motto of the Jewish people is “Always take.” Judas was behaving according to the then unwritten Talmudic code, which permits Jews to steal from non-Jews, if they can get away with it!! (Talmudic references: Baba Mezia 24a, Baba Kamma 113b.) Moral: Never hire a Jew to be your treasurer! America has already made this mistake, with the Federal Reserve Bank!!!!]

### **Day 5: Palm Day. Triumphal Entry Into Jerusalem.**

Although this is traditionally referred to as “Palm Sunday,” this is just a Catholic invention. (The fact is that the Hebrew Israelites did not have named days of the week, such as “Sunday,” “Monday,” “Tuesday,” etc. I will continue this narrative without regard to named days of the week.) Yahshua rides into Jerusalem on an ass, being proclaimed “King of Israel.” Of course, all of this is in fulfilment of various Old Testament prophecies concerning the Messiah.

The triumphal entry into Jerusalem, from the account in John, was a spontaneous event, precipitated by the news that Jesus would be coming into Jerusalem. (John 12:12.) Jerusalem was already overflowing with people, who had arrived early for the upcoming Feast of Unleavened Bread.


Jesus declares, “The hour is come that the Son of Man should be glorified— Now shall the prince of this world be cast out.” (John 12:23-31.) This is the beginning of the end for Satan. Again, I would ask the futurists, who believe that the “prince that shall come” is the antichrist, shall Satan cast out Satan?

## In The Name of Yahweh Part 20

#### The house of Israel and the house of Judah.

**A**S WE KNOW Jacob’s race was given the name Israel which is Hebrew for, “sons ruling with God.”

This is why the Israel people of today cannot help but see the tenets of political-correctness as wrong, because it is in direct contravention to the law which is written in their hearts.

**Ezekiel 18:19** – *Yet say ye, Why? doth not the son bear the iniquity of the father? When the son hath done that which is lawful and right, [and] hath kept all my statutes, and hath done them, he shall surely live.*

**Ezekiel 18:20** – *The soul that sinneth, it shall die. The son shall not bear the iniquity of the father, neither shall the father bear the iniquity of the son: the righteousness of the righteous shall be upon him, and the wickedness of the wicked shall be upon him.*

**Ezekiel 18:21** – *But if the wicked will turn from all his sins that he hath committed, and keep all my statutes, and do that which is lawful and right, he shall surely live, he shall not die.*

**Ezekiel 18:22** – *All his transgressions that he hath committed, they shall not be mentioned unto him: in his righteousness that he hath done he shall live.*

**Ezekiel 18:23** – *Have I any pleasure at all that the wicked should die? saith Yahweh (the Lord*

This was naturally carried on by his twelve sons: Reuben; Simeon; Levi; Judah; Dan; Naphtali; Gad, Asher; Issachar; Zebulun; Joseph; and Benjamin.

Due to Solomon’s (Israel’s third king, the son of David) repeated breaking of Yahweh’s laws, ten tribes of Israel were split off from his rule. He was left with the tribe of Judah which comprised of some of the tribe of Benjamin. **Ezekiel 18:24** – *But when the righteous turneth away from his righteousness, and committeth iniquity, [and] doeth according to all the abominations that the wicked [man] doeth, shall he live? All his righteousness that he hath done shall not be mentioned: in his trespass that he hath trespassed, and in his sin that he hath sinned, in them shall he die.*

**Ezekiel 18:25** – *Yet ye say, The way of Yahweh (the Lord) is not equal. Hear now, O house of Israel; Is not my way equal? are not your ways unequal?*

**Ezekiel 18:26** – *When a righteous [man] turneth away from his righteousness, and committeth iniquity, and dieth in them; for his iniquity that he hath done shall he die.*

**Ezekiel 18:27** – *Again, when the wicked [man] turneth away from his wickedness that he hath committed, and doeth that which is lawful and right, he shall save his soul alive.*

**Ezekiel 18:28** – *Because he considereth, and turneth away from all his transgressions that he hath committed, he shall surely live, he shall not die.*

**Ezekiel 18:29** – *Yet saith the house of Israel, The way of Yahweh (the Lord) is not equal. O house of Israel, are not my ways equal? are not your ways unequal?*

**Ezekiel 18:30** – *Therefore I will judge you, O house of Israel, every one according to his ways, saith the Yahweh (Lord GOD). Repent, and turn [yourselves] from all your transgressions; so iniquity shall not be your ruin.*

**Ezekiel 18:31** – *Cast away from you all your transgressions, whereby ye have transgressed; and make you a new heart and a new spirit: for why will ye die, O house of Israel?*

**Ezekiel 18:32** – *For I have no pleasure in the death of him that dieth, saith Yahweh (the Lord GOD): wherefore turn [yourselves], and live ye.*

Yet again, Yahweh is literally forced to beg His children, Israel, to follow His laws and ways.

He stresses equality, but within Israel, not across each and every race as per the doctrine of mainstream churches.

He reasons with Israel, listening to what they say, but re-iterates that it is His ways which are right.

**Ezekiel 21:25** – *And thou, profane wicked prince of Israel, whose day is come, when iniquity [shall have] an end,*

**Ezekiel 21:26** – *Thus saith Yahweh (the Lord GOD); Remove the diadem, and take off the crown: this [shall] not [be] the same: exalt [him that is] low, and abase [him that is] high.*

**Ezekiel 21:27** – *I will overturn, overturn, overturn, it: and it shall be no [more], until he come whose right it is; and I will give it [him].*



The story behind these verses is that Israel do not follow Yahweh's ways and therefore the current descendant of King David, King Zedekiah, is captured by the armies of Nebuchadnezzar and transported to Babylon.

**Ezekiel 21:27** in which Yahweh states, "I will overturn, overturn, overturn, it" refers to the physical throne of David which is transported at this time by Jeremiah and King Zedekiah's daughters to Ireland, as all of his sons had been

killed, and they were the only surviving royal line of David.



It

remained in Ireland for over 1,000 years until it was transported to Scotland around A.D. 500 by Fergus Mór. It is now more commonly known as the Stone of Scone or Jacob's Pillar.

It remained in Scotland until A.D. 1296 when King Edward I removed it to Westminster Abbey, where it remained until 1996 when the government of John Major sent it back up to Scotland to appease the Scottish nationalists (something I found out earlier in the year after I made a special trip to Westminster Abbey to see it!), however it is still the property of England and the arrangement is it will be transported back to Westminster Abbey for future coronations.

Reference to the throne's removal to the British Isles is made in Jeremiah where it is stated that Yahweh will look after his people in these nations:

Jeremiah 31:10 – Hear the word of Yahweh (the LORD), O ye nations, and declare [it] in the isles afar off, and say, He that scattered Israel will gather him, and keep him, as a shepherd [doth] his flock.

Going back to Ezekiel, Ezekiel 21:27 goes on to say, “and it shall be no [more],” which is an accurate statement, as kings and queens in England have not governed England for many years, having had an, “elected democracy,” take their place.

It is also indicative of the last days that the current queen, whilst directly descended from

King David, has African blood from Queen Charlotte and appears to have mongrelized her seed with Prince Philip, who as previously mentioned, is widely believed to be Jewish through his great-grandmother Julia Hauke.

On that basis should any of her descendants inherit the throne, it would further breach the Davidic Covenant as promised to David and his seed.

See 2 Samuel in which Yahweh says to David:

2 Samuel 7:12 – And when thy days be fulfilled, and thou shalt sleep with thy fathers, I will set up thy seed after thee, which shall proceed out of thy bowels, and I will establish his kingdom.

2 Samuel 7:13 – He shall build an house for my name, and I will stablish the throne of his kingdom for ever.

Going back to Ezekiel 21:27, Yahweh's promise that the throne will change ownership three times (I will overturn, overturn, overturn, it): to Ireland; then to Scotland; then to England, is fulfilled where it awaits Jesus Christ, whose possession we can see it will become in the closing of Ezekiel 21:27 – “until he come whose right it is; and I will give it [him].”

See also: Luke 1:32 – He shall be great, and shall be called the Son of the Highest: and Yahweh (the Lord God) shall give unto him the throne of his father David:

Luke 1:33 – And he shall reign over the house of Jacob for ever; and of his kingdom there shall be no end.

Finally, and for the avoidance of doubt that there will be any break in the royal line, we can see in Psalms 89 that this covenant was made to every subsequent generation of David, although adherence by them to Yahweh's laws is of course also required.

Psalm 89:3 – I have made a covenant with my chosen, I have sworn unto David my servant,

Psalm 89:4 – Thy seed will I establish for ever, and build up thy throne to all generations. Selah.

# Old Testament

## “Word for Word” Part 5

### Translation by Stephen Howard Anderson



#### 7 The Deluge

1. And said Yahweh to Noach, "Come you and all your household into the ark, for you are righteous 6662 before Me in this age 1755.

2. Of all beasts 929 that are clean 2889 you shall take to you by sevens 7651/7651, males 376 and

females 802: and from the beasts that are not clean, by two 8147, the male and the female.

3. Also of the birds of the sky by sevens, the male 2145 and the female 5347, to keep alive seed upon the face of all the land.

4. For after yet seven days I will cause it to rain 4305 upon the land forty 705 days and forty nights; and will destroy 4229 all that subsists 3351 that I made upon the face of the soil."

5. And did Noach that which commanded Yahweh.

6. Noach was six hundred years of age when the deluge 3999 of water was upon the land.

7. And went Noach, and his sons, and his wife, and his sons' wives with them, into the ark, because of the presence 6440 of the waters of the deluge.

8. From the beasts that were clean, and from the beasts that were not clean, and from the birds and all that creeps upon the soil,

9. two by two they went to Noach into the ark, male and female, as commanded Elohiym to Noach.

10. And it was, after seven days, the waters of the deluge were upon the land.

11. In the six hundredth year of the life of Noach, in the second 8145 month 2320, the seventeenth

7651/6240 day of the month, the same day, broke open 1234 all the fountains 4599 of the subterranean water supply 8415 abundantly 7227, and the sluices 699 of the sky were opened 6605.

12. And was the rain 1653 upon the land forty days and forty nights.

13. In the same day 6106/3117/2088 went Noach, and Shem, and Cham, and Yepheth, the sons of

Noach, the wife of Noach, and the three wives of his sons with him into the ark;

14. they, and all living by their species, and all beasts by their species, and all creeping things that creep upon the land by their species, and all the birds 5775 by their species, all birds 6833, all with wings 3671.

15. And they went to Noach in the ark, two from all flesh that had the breath 7307 of life 2416.

16. And they went, male and female from all flesh, and came as that commanded them of Elohiym: and shut the door 5462 Yahweh behind 1157 them.

17. And was the deluge forty days upon the land; and increased 7235 the waters, and bore up 5375 the ark and lifted 7311 it above the land.

18. And prevailed 1396 the waters, and were increased greatly 3966 upon the land, and went 1980 the ark upon the surface 6440 of the waters.

19. And the waters prevailed exceedingly 3966/3966 upon the land, and covered 3680 over 5921 the high 1364 hills 2022 that were beneath 8478 the whole 3605 sky 8064.

20. Fifteen 2568/6240 cubits 520 [22.5 feet] upward prevailed the waters, and covered were the hills.

21. And died 1478 all flesh that creeps upon the land, and the birds, and the beasts, and the living creatures, and all swarming things 8318 that swarm 8317 upon the land, and all the adams 120.

22. All that had the breath 5397 of the spirit 7307 of life 2416 in their nostrils 639, and all on the dry land 2724 died 4191.

23. And destroyed 4229 was every living thing 3351 that was upon the surface of the soil. from adam unto beast, unto creeping things, unto birds of the sky, destroyed from the land: and only 389 Noach and that with him in the ark survived .

24. And prevailed the waters upon the land one hundred and fifty days.

## Chapter 7 Notes

**Verse 2** - As 2889 is used here, and means ceremonially clean for sacrifice, 376 and 802 do not refer to non-adamic men, but actual animals. These forms are common in Hebrew, and are gender indicators.



**Verse 6** - 776 means the known inhabited area, ground, and country. It is not used for the whole planet. The area described was almost certainly the Tarim Basin, with its hill country. Great underground water sources broke open, possibly from an earthquake, and with the huge rainfall, all within the Basin area would have drowned. The rain was so intense that it beat the birds from the sky, and they drowned also.

**Verse 11** - The Nephiliym were in that area doing their evil, and the local adamics followed their ways, as they must have impressed them greatly. They drowned. This was not a "flood",

but an overwhelming outpouring of Yahweh's wrath.

**Verse 20** - Fifteen cubits, with a cubit at 18", would be 22.5 feet of water. In a concentrated basin area it would have covered all the hills. Mount Everest is 6.5 MILES high, and the Rocky Mountains, Appalachians, etc. would NOT have been covered. The deluge was local, NOT worldwide. The animals in the ark were for repopulation of the local area when all the bad-guys were dead. Some of the clean animals would be sacrificed to Yahweh. The unclean ones, as "beasts", were work animals, or just wild creatures not fit for sacrifice.

No more fairytales from "churchianity". The Scripture does not need "enhancement" from them.

## Chapter 8

1. Remembered 2142 Elohiym 430 Noach, and all the living things, and all the beasts that were with him in the ark: and passed over 5674 Elohiym a wind 7307 over the land, and abated 7918 the waters.

2. Shut up 5534 were the springs of the subterranean water sources and the sluices 699 of the sky, and restrained 3607 was the rain from the sky.

3. Turned back 7725 were the waters from upon the land going 1980 back 7725 continually: and diminished 2637 were the waters at the end 7097 of a hundred and fifty days.

4. Settled 5117 the ark in month seven, on the seventeenth day of the month, upon the mountains 2042 of Ararat 7801.

5. And the waters went and decreased 2637 until the tenth 6218 month: in the tenth month on the first of the month were seen the tops 7218 of the hills 2022.

6. And it was, at the end of forty days, opened Noach the window 2474 of the ark that he had made.

7. And he sent forth 7971 a raven 6158, which went forth 3318 continually 3318 and returned 7725, until dried up 3001 were the waters from upon the land.

8. Then he sent forth a dove 3123 from him, to see if abated 7043 were the waters from upon the surface of the soil.

9. But did not find the dove rest 4494 for the sole 3709 of her foot 7272, and she returned to him to the ark; for the waters were upon the surface of the whole land. He sent forth his hand, and took her, and brought her to him in the ark.

10. He anxiously awaited 2342 another seven days afterward, and again 3254 he sent forth the dove from the ark.

11. And came to him the dove in the evening 6153, and behold, a leaf 5929 of an olive tree 2132 was plucked off 2965 in her mouth 6310: and knew Noah that abated were the waters from upon the land.

12. And he waited 3176 another seven days afterward, and sent forth the dove, and she did not again return to him anymore.

13. And it was, in his six hundredth and first year, in the first 7223 month on the first 259 of the month, dried up 2717 were the waters from upon the land; and removed 5493 Noah the covering 4372 of the ark, and looked, and behold, drying up was the surface of the soil.

14. And in the second month, on the twenty seventh day of the month, dried was the land.

15. And spoke Elohiym to Noah, saying,

16. "Go forth from the ark, you, and your wife, your sons, the wives of your sons with you.

17. All the living that are with you, with all flesh, the birds and the beasts, and all the creeping things that creep upon the land; go forth with you, and swarm 8317 the land, and be fruitful 6509 and multiply in the land."

18. And went forth Noah, and his sons, and his wife, and the wives of his sons with him.

19. All living things, all creeping things, and all the birds, all that creeps upon the land, by their species, went forth from the ark.

20. And built Noah an altar 4196 to Yahweh; and took from all the beasts that were clean, and

from all the birds that were clean, and sent up 5927 burnt sacrifices 5930 on the altar.

21. And smelled 7306 Yahweh a savour 7381 of sweetness 5207, and said Yahweh in His heart, "I will not again 3254 curse 7043 anymore 5750 the soil 127 on account of 5668 the adams; for

the devisings 3336 of the mind 3820 of the adams is evil 7451 from their youth 5271: and I will not again smite 5221 all living as I have done.

22. Yet all the days of the land, seedtime 2233 and harvest 7105, and cold 7120 and heat 2527, summer 7019 and winter 2779, and day 3117 and night 3915 shall not cease 7673."

## Chapter 8 Notes

**Verses 1-3** - Basically, Yahweh reverses the process of the deluge, and "turns off the tap". Yashar 6:34



**Verse 4** - Ararat is modern day Armenia. The ark settled on one of the many low mountains there. The exact location is yet unknown.

**Verse 11** - The water drained off somewhere downstream, and back into the crevices that it came from. If the "world" were flooded, there would be nowhere for the water to drain into. The deluge was local, not worldwide.

**Verse 17** - Yashar 6:42

**Verse 20** - Noah built an altar, and made a burnt offering of one of each of the clean for sacrifice species. The term "sent up", 5927, is as the smoke "ascending", with the accompanying odor, pleasing to Yahweh.

**Verse 21** - The word "mind" 3820 is literally "heart". In Hebrew idiom, the heart was the centre of thought, opposite the Greek idiom, where it was the centre of emotion, as in English.

## 9 The Covenant With Noah

1. Blessed Elohiym Noah and his sons, and said to them, "Be fruitful and multiply, and fill the land.

2. And the fear of you 4172 and the terror of you 2844 shall be upon every living creature of the land, and upon every bird of the sky, and upon all that creeps on the soil, and upon all fish of the sea; into your hand they are given.

3. Every creeping thing that lives to you shall be food 402; even as the green 3418 herbs 6212 have I given you all things.

4. But 389 flesh with its life 5315, the blood 1818 you shall not eat.

5. Surely 389 the blood of your lives 5315 will require 1875; at the hand 3027 of all living will I require it, and at the hand of the adam, by the hand of the brother I will require the life of the adam.

6. Whoso sheds 8210 the blood of the adam, by adam shall be shed his blood, because in the image 6754 of Elohiym was made the adam.

7. And you, be fruitful, and multiply; breed abundantly 8317 in the land, and multiply there."

8. Said Elohiym to Noah, and his sons with him, saying,

9. I, behold, establish 6965 My covenant 1285 with you, and with your seedline 2233 afterward;

10. and with all creatures that live that are with you, the birds, the beasts, and of all the living creatures of the land with you; from all that go forth from the ark, to all living creatures of the land.

11. And I will establish My covenant with you; neither shall be cut off 3772 all flesh 1320 any more from waters of the deluge, and shall not be another deluge to destroy 7843 the land."

12. And said Elohiym, "This is the sign 226 of the covenant that I give between Me and between you, and between all creatures that live that are with you for generations 1755 perpetually 5769:

13. My bow 7198 I set 5414 in the clouds 6051, and it shall be for a sign of the covenant between Me and between the land.

14. And it shall be, when I bring 6049 a cloud 6051 over the land, that is seen 7200 the bow in the cloud,

15. I will remember My covenant that is between Me and between you, and between all creatures that live of all flesh; and shall not become any more the waters a deluge to destroy all flesh.

16. And shall be the bow in the cloud; and I will look on it, and remember the covenant perpetually between Elohiym and between all creatures that live, and all flesh that is upon the land."

17. And said Elohiym to Noah, "This is the sign of the covenant that I establish between Me and between all flesh that is upon the land."

## Noach's Drunkenness



18. And it was the sons of Noah that went forth from the ark were Shem, and Cham, and Yapheth: and Cham, he is the father 1 of K'naan 3667.

19. The three of these are the sons of Noah: and these were dispersed 5310 in all the land.

20. Began 2490 Noah to be a man 376 of the soil 127, and he planted 5193 a vineyard 3754:

21. and he drank 8354 from the wine 3196, and was drunken 7937; and was uncovered 1540 within his tent 168.

22. And saw Cham, the father of K'naan, the pudenda 6172 of his father, and told 5046 his two brothers outside 2351.

23. And took Shem and Yepheth a garment 8071 and put it upon both their shoulders 7926, and walked backwards 322, and covered the nakedness of their father; and they faced 6440 away 322 and the nakedness of their father they did not see.

24. And awoke 3364 Noach from his wine, and knew that which did to him his younger 6996 son.

25. And said he, "Cursed 779 be K'naan 3667; a servant 5650 of servants shall he be to his brothers!"

Verse 4 - Lev.7:26,27; 17:10-14; 19:26; Deut.12:16,23; 15:23 - Here is the prohibition against the eating of blood.

Verse 5 - Here we have beasts with hands. Non-adamic hominids.

Verse 6 - Gen.1:26; Ex.20:13

Verse 7 -Gen.1:28

Verse 14 - 6049 is only used this way here. It normally means to pervert, use magic. This is an idiom.

Verse 19 - The sons were dispersed in their original area. Outside of this area adamic and non-adamic people still existed. The ancient Chinese records tell of the waters reaching the base of their mountains.. If everyone was killed, who kept those records? No more "churchianity" fairytales. If the truth hurts, it does not make it less of the truth.


Verse 20 - 2490 here is in the causative form.

## The Misuse Of The Words, "All", "Every", "Whosoever", etc. (Part 3)

Quoting Lloyd Palmer of the USA on these words:

**W**HOSOEVER is an objective pronoun. According to the *Oxford English Dictionary*, "objective"

means: "dealing with outward things or

*exhibiting facts un-coloured by feelings or opinions; not subjective.*" As an adjective, "whosoever" is used to modify and convey a, "fair, impartial, equitable, neutral, open-minded and unprejudiced" meaning to a noun.

In contrast, a subjective pronoun, according to Oxford, means: (of art, literature, written history, a person's view, etc) "*proceeding from personal idiosyncrasy or individuality; not impartial or literal.*" Now that we have examined the

differences in “objective” and “subjective,” which one of the two is in harmony with Scripture?

Jesus told His disciples, “*Ye have not chosen Me, but I have chosen you and ordained you...*” (John 15:16). This is a subjective statement, and not an objective one. This becomes a matter of doctrine. Do you follow the “*people choosing God*” notion, or do you surrender to the scriptural “*people chosen of God*” doctrine? Your answer will determine whether you think the word “*whosoever*” applies to anyone who confesses Christ (the people choosing God notion), or whether you embrace the revealed, “*people chosen of God* doctrine.”

Allow me to ask this question: If all that a person has to do is “confess” Jesus as his personal Saviour, which is the doctrine of most Judeo-Christian churches, then why did Jesus say these words:



*“Not every one that saith unto me, Lord, Lord, shall enter into the kingdom of heaven; but he that doeth the will of my Father which is in heaven. Many will say to me in that day, Lord, Lord, have we not prophesied in thy name? And in thy name have cast out devils? And in thy name done many wonderful works? And then I will profess unto them, I never knew you: depart from me, ye that work iniquity.”* (Matt.7:21-23)

These words are strong ones, but they reveal that not every one who “confesses” Christ will be saved!

Universalists love to quote John 3:15-16 to claim that “*whosoever*” as it is used in these verses, applies to all ethnic groups. When we look up the Greek word that “*whosoever*” was translated from, we discover something unusual. The word is No. 3588 in *Strong’s Greek Dictionary*. It is actually three words in Greek: “*ho, he, to, in all*

*their inflection; the definite article; the (sometimes to be supplied, at others, omitted in English idiom): the, this, that, one, he, she, it, etc.”* The list is all subjective words. None of the words could be considered as objective.

In other words, “*he*”, “*she*”, and “*it*”, etc, are subjective pronouns. Subjective pronouns are exclusive. Therefore, the catch-all word “*whosoever*” is a misleading word to use, because it totally changes the inflection.

I suggest that a corrected phrase be used in place of the word “*whosoever*.” The phrase “*those who*” doesn’t destroy the “*people chosen of God*” doctrine of the Bible. For example, lets delete “*whosoever*” and apply “*those who*” in those two verses of John 3:15-16:

*“That those who believe in him should not perish, but have eternal life. For God so loved the world, that He gave His only begotten Son, that those who believe in Him should not perish, but have everlasting life.”*

Now it becomes far less inclusive when properly translated and removes the concept that Jesus was speaking generally as many are inclined to see. So the next time you read Scripture and come upon the word “*whosoever*,” try substituting “*those who*” and see if it doesn’t make for better Bible exegesis. When you understand the “*people chosen of God*” doctrine, you will also comprehend that our English translators chose of “*whosoever*” was a bad choice that led to the Universalist’s mistaken assumption that Jesus was speaking to all groups on an equal basis”. (End Quote).

#### **EXAMPLES WHERE WE FIND THE WORD “ALL” THAT ARE NOT ALL INCLUSIVE.**

Matt. 2:3 *When Herod the king had heard these things, he was troubled, and **ALL** Jerusalem with him. And when he had gathered **ALL** the chief priests and scribes of the people together, he demanded of them where Christ should be born.*

The word “*all*” is found twice in this passage, and “*all Jerusalem*” has the context of “*all the chief priests and scribes*”. King Herod would not be demanding where the Christ would be born of a woman giving birth, neither would

such a woman be troubled. Thus it does not include “all” of the other people in the city, and to say that every person in every situation was troubled would obviously be not true.

Matt. 3:5 *Then went out to him Jerusalem, and ALL Judaea, and ALL the region round about Jordan, And were baptized of him in Jordan, confessing their sins.*

Again the word “all” appears twice. Very obviously John the Baptist could not have baptised every person in Jerusalem, or indeed every person in “all Judea”. Thus “all” refers to that part who came from those locations, and not anyone else who stayed home. Also, it did not include the High Priest and the Roman garrison.

Matt. 27:24 *When Pilate saw that he could prevail nothing, but that rather a tumult was made, he took water, and washed his hands before the multitude, saying, I am innocent of the blood of this just person: see ye to it. Then answered ALL the people, and said, His blood be on us, and on our children.*

Perceptibly, “all the people” means that part of the people who were present before Pilate, and does not include anyone else.

Mark 7:14 *And when he had called all the people unto him, he said unto them, Harken unto me EVERY ONE of you, and understand:*

Here, “all the people” does not include the Scribes and Pharisees Jesus had been talking to immediately before this, and “all” has the meaning of all those others then present, as does “every one of you”.

Acts 3:9, *And ALL THE PEOPLE saw him walking and praising God: And they knew that it was he which sat for alms at the Beautiful gate of the temple: and they were filled with wonder and amazement at that which had happened unto him. And as the lame man which was healed held Peter and John, ALL THE PEOPLE ran together unto them in the porch that is called Solomon's, greatly wondering.*

Again, “all the people” that occurs twice in this passage can only refer to that part of “all the people” who were present.

There is a Scripture in Rev. 13:7, which is taken

totally out of context, and used by many preachers to deceive mankind, and bring great fear upon them. That verse says (speaking of the anti-christ), *"And it was given unto him to make war with the saints, and to overcome them: and power was given him over ALL KINDREDS AND TONGUES, AND NATIONS."*

And the next verse says, *"And ALL that dwell upon the earth shall worship him, whose names are not written in the Book of Life of the Lamb slain from the foundation of the world".*

Thus “all kindreds” does not include those whose names are written in the Book of Life. False preachers point to the word “all” in verse 7, and again in verse 8, without giving consideration to the context itself. There are many, many times throughout the Bible when the word “all” is put for “a part”, even in the same way that we use the word in our every day life. Often we use terms such as *“everybody in town was at the meeting”, or “the water was all over the place”,* and so forth.



In Genesis. 6, when God was talking about bringing a flood upon the Earth in verse 13, God said, *"The end of ALL FLESH is come before Me."* Then in verse 17, God said, *"In Genesis 6:17, "And, behold, I, even I, do bring a flood of waters upon the earth, to destroy ALL FLESH, wherein is the breath of life, from under heaven; and EVERYTHING that is in the earth shall die",* we know that Noah did not die as part of “all flesh”. Again, “all” is being used with the meaning of “a part” or “the greater part.

In Joshua 6:21, *"And they utterly destroyed ALL THAT WAS IN THE CITY, both man and woman, young and old, and ox, and sheep, and ass, with the edge of the sword",* we know that Rahab was not part of “all” that was destroyed in that city.

In 1 Kings 11:16, "For six months did Joab remain there with all Israel, until he had cut off **EVERY MALE** in Edom:) That Hadad fled, he and certain Edomites of his father's servants with him, to go into Egypt; Hadad being yet a little child", did "every male" include male children? Did "every male" include those Edomites who fled? If the entire Edomite male population on earth had been slain, how could Edomites be found after this?

In Luke 2:1, "And it came to pass in those days, that there went out a decree from Caesar Augustus, that **ALL THE WORLD** should be taxed. (And this taxing was first made when Cyrenius was governor of Syria.) And **ALL** went to be taxed, every one into his own city", we can see that "all the world" has the meaning of "all that world". This is how "all the world" is used in "Go ye into all the (that) world and preach the Gospel".

In Romans 1:8, "First, I thank my God through Jesus Christ for you all, that your faith is spoken of throughout **THE WHOLE WORLD**", do we believe that "the whole world" included the Chinese, the Maoris and the Aztecs?


In Rom. 10:18, "I say, Have they not heard? Yes verily, their sound went into **ALL THE EARTH**, and their words unto **THE ENDS OF THE WORLD**. But I say, Did not Israel know"?, again did "all the earth" and "the ends of the world" include say Australia, or was it confined to all "that world" of the context, Israel?

In Col. 1:23, "If ye continue in the faith grounded and settled, and be not moved away from the hope of the gospel, which ye have heard, and which was preached **TO EVERY CREATURE WHICH IS UNDER HEAVEN**", could "every creature under heaven" be extended beyond those to whom Paul preached?

These are just a sample of verses that show how Scripture uses phrases, and if we use them otherwise, we must come to wrong conclusions. These wrong conclusions then lead on wrong evangelism and also to the interpretation of prophecy. Let us consider some of these.

If those preachers who are telling us that the antichrist will rule all nations, and kindreds upon the face of the Earth, if they are not fear-

mongering, then why do they not put the same emphasis on Dan. 11:41, where it is speaking of the antichrist at the height of his power and glory. There it says that antichrist will overthrow many countries, then it says, "But these shall escape out of his hand, even Edom, and Moab, and chief of the children of Ammon." If the same people were occupying the same territory, this would be modern day Jordan, and some territory close by. So we must ask, if the antichrist at the time is going to have his throne in Jerusalem, and will not be able to get control of Jordan, which is just next door, and the area around about, why should we believe that he will rule the whole Earth? But if this is not the present application, "all nations" does not include those that escape.



Also, in Matthew 24, in answer to one of the three questions Jesus was asked, He spoke of that future time when the antichrist will be at the height of his glory, and ruling all that he will be able to rule. And if there is not going to be any place on Earth that the anti-christ will not rule, then why did Jesus say, "Let them which be in Judea flee into the mountains", verse 16? Why flee if there is no place to go to? And why would Jesus bother to tell the people to flee, if the antichrist is going to be ruling every foot of land? In that case, there would be no place to go.

Also, the prophet, Isaiah, gets in on this subject, and confirms the scripture in Dan. 11:41. In Isaiah 16:1-4, we are told that those fleeing Israelites, mentioned in Matthew 24:16, will go to Moab, and will be hidden in Moab until the end of the age when Jesus Christ will come, and the antichrist will be consumed out of the land. Is it not a fair question to ask, that since the

fleeing Israelis will be protected in Moab from the forces of the antichrist, is it not then a fair assumption that the antichrist will not be in charge in Moab, and especially since the scripture says that he will not be?

In the book of Dan. 2, that prophet was talking to Nebuchadnezzar, who was the king of Babylon at that time, and Daniel said to him in verse 38, *"And wheresoever the children of men dwell, the beasts of the field, and the fowls of the Heaven hath He given unto thy hand, and hath made thee ruler over them all."* So it must be asked if Nebuchadnezzar ruled America? Did he rule Japan? And the rest of the world? The answer of course is that he did not. He ruled only in the Middle East, and yet he was spoken of as *"ruler over them all"*.

Then Dan. 2:39, it speaks of the third kingdom of brass (which was the Grecian Empire), and it says, *"that it would bear rule over all the earth"*. So again, did the Grecian Empire cover the whole earth, as we know it today, or just the Middle East? If your answer is the Middle East, you are right. Yet, the same term was used of that kingdom in Dan. 2:39, as is used of the antichrist in Rev. 13:7&8. So, neither one did, nor will, rule every nation on earth.

If a person would read these prophetic passages, and try to apply the same rule as some do on Rev. 13:7-8, we would have a big, big mess, and we would have contradiction after contradiction in the Bible.

### The Validity Of Mark 16:9-20 J. Hudson Ballard

**T**HE weightiest name against Mark's authorship of the disputed passage is Eusebius, the great Palestinian critic of the 4th century. He is also the earliest witness against these verses. He states that some Mss. contained the passage in dispute, but that the more numerous and best Mss. omitted it.

While not a few Fathers questioned this, yet the influence of Eusebius so commanding that many contemporaneous and succeeding Fathers accepted his statement.

After Eusebius not one independent witness against the verse. All traced to him. On the other hand, before the time of Eusebius and as early as Irenaeus of the 2nd Century, the witness of the Fathers is uniformly in favour of the verses—among the great names being Justin martyr, Hippolytus Chrysostom, Jerome, Ambrose, Augustine, and Victor of Antioch.

While the Sinaitic and Vatican, the two oldest and best Mss. and many others omit but many others contain it. These two were among 50 Mss. of the N.T. which Constantine commissioned Eusebius to prepare for his new capital. They

were thus compiled under his supervision and reflected his views.



The passage was objectionable to him which explains their position. Count Tischendorf, who discovered the Sinaitic Mss. noticed that both it and the Vatican Mss. the Gospel of Mark was transcribed by the same hand, a fact pointing to an earlier Mss. as a common source of both.


Both the spacing and embellishment indicate if not proven otherwise that the common parent - from which both Mss. were taken must have contained the verses. Eusebius (above) was an ancient higher critic.

# The Great Pyramid, Khafre & Menkaure Pyramid Geometry Encoded Into The New Zealand Landscape (5) By Martin Doutré

## ADDITIONAL PYRAMID CODING

**T**HERE ARE YET OTHER clearly marked geometric representations of the Great Pyramid in the Waitapu Valley and several additional lengths and angles that relate to the pyramid. Let's look at some of these.



**Figure 9: This depiction of the Great Pyramid is at 10 X scale once again and hits very positively onto markers within the Waitapu Valley.**

A giant obelisk discovered near the Bushline Observatory in September 2002 marks the corner of the pyramid to the western sector. From there the pyramid baseline extends for 7560 feet to the centre of the tor mound on the southern ridge of Maunganui Bluff where it resolves upon a boulder marker. The line then turns and runs for 6117 feet to a peninsula tor mound on the northern side of the valley before returning to the obelisk.

Digger operator/ surveyor, Ian Pyke in company with dairy farmer, Michael Griffith, first discovered the impressive peninsula tor structure in April 2002. As an experienced earth moving contractor, Ian has a trained eye for detecting unnatural earth-mound formations or other types of ancient, surveying related structures on the landscape. He has been instrumental in locating many cairn, tor mound or sighting pit surveying markers around the valley and outlying districts. To add yet more credence to the fact that the above, exact pyramid geometry is definitely encoded into the Waitapu Valley one can consider the azimuth angle that the left face diagonal lies on. There are two ways to calculate

the coded length of the Great Pyramid's side. One is the face diagonal length based upon an angle of 51.84-degrees, giving a length of 611.7894615 feet. The other method is to simply multiply half the base length (378 feet) by PHI (1.6180339) to get 611.6168142 feet (a shortfall difference of about 2 inches).

In the above picture the azimuth angle up the left face side sits at 61.16-degrees east of true north. It will be remembered that Menkaure Pyramid geometry mentioned earlier was set to an azimuth angle of 17.82-degrees when half the base length of Menkaure was intended by its architects to convey 178.2 feet. In the methodology of the early surveyors both a length and angle would carry a code where possible.



**Figure 10: The large, broken obelisk stone, dappled in shadow and lying in front of the platform upon which it once stood.**

A rimu tree now grows out of the former pedestal platform. This giant stone, which would once have stood in excess of 6 feet tall when housed into the ground, was located by Stacey Pyke and Sid while they were doing a forest sweep looking for ancient, purpose erected markers near the Bushline Observatory. Several boulder cairn and obelisk positions were found during the search and, thankfully, the forest canopy was thin enough to allow GPS fixes to be taken. Careful AutoCAD analysis is slowly revealing the design purpose behind the placement of each marker. This obelisk sits on an equivalent level to the southern ridge tor mound and the peninsula tor of the northern side of the valley...the 3 station points of Great Pyramid geometry encoded within the confines of the Waitapu Valley.

## YET MORE PYRAMID CODES.

Throughout the Waitapu Valley there are several lengths and angles that are suggestive of Great Pyramid geometry being encoded. Here are some samples of this occurrence.



**Figure 11: The blue line runs accurately for 12235 feet from the Benchmark Cleft to a boulder cairn on the hill above the Kerr Road Observatory site.**

This distance is the length up the side of the Great Pyramid (including symbolic apex) X 20. The line proceeds from the Benchmark Cleft at an azimuth angle of 20.16-degrees. Calculations undertaken to see how the top altar section of the Great Pyramid carried codes indicated that one square of 44 feet (extremity limits of the floor) and another of 42 feet (1 foot border all around) were primarily important. The 4-side inch total of a square 42 feet per side is 2016 and this number features prominently in ancient navigation.

The red line runs from the benchmark Cleft to the main northern ridge tor mound plateau sighting pit at an azimuth angle of 51.84-degrees, which was the intended design slope angle of the Great and Menkaure Pyramids. The distance to the western face approach of the tor mound would comply very favourably to 12235 feet. Unfortunately, some minor quarrying near that side of the tor mound (about 20-years ago) has eradicated traces of any former markers situated there.

The yellow line runs for 6117 feet (the Great Pyramid's face diagonal length if it had a capstone X 10) from a boulder cairn near the Telecom Road to the apex of a modified, inner valley hill dotted with boulder markers. The azimuth angle of this alignment is 308.16-degrees, which is 360-degrees minus 51.84-degrees (the pyramid's slope angle).

The positive recurrence of vivid pyramid geometry, based upon the dimensions and angles of Giza Plateau pyramids helps to refine our knowledge of who New Zealand's ancient core population was.

Ancient New Zealanders left clear-cut expressions of their measurement standard, astronomical, calendar and navigational numbers, sexagesimal degree angle system, etc., consistent with what was left throughout Great Britain, Continental Europe and the Mediterranean Basin.

This ancient stock of cousin peoples were highly migratory and general structural styles (domestic and scientific), found upon the New Zealand landscape, look more like those of Megalithic Great Britain and France than any other single location. From this it can be surmised that ancient people of Western Europe were the most successfully established and widespread population to colonise New Zealand in the BC era.

Branches of the Mediterranean/ European family tree settled en mass in the Americas in remote antiquity, with latter offshoot branches joining long lost cousins at the base of the South Pacific. If we were permitted to do DNA sampling on the tall red headed skeletons that repose in ancient burial caves or sand dunes around New Zealand (often in a trussed or sitting position) then lingering questions of just who the early occupants were would be quickly answered.

As long as the authorities continue to deny scientists access to those suppressed DNA samples, we can do no more than mathematically assess the residual structures that dot New Zealand's very ancient landscape.

God told Israel they would speak in another language one day. Isaiah 28:11 announced, "For with stammering lips and another tongue will he speak to this people." The word translated "stammering" is listed in Strong's Concordance as "Gael" and is listed in Young's Analytical

Concordance as "leag". This apparent contradiction is explained by the fact that the Phoenician reads from left to right, while the Hebrew reads from right to left. Therefore, "gael" and "leag" are the same word read in two ways. One name for the ancient Irish language is Leagael. The

reverse reading is Gaeleag, known today as Gaelic. This is the language still spoken by some in Ireland; it is as well, the native language of the Highland Scotch. The Gaelic language is indicative of the Celtic people. In the narrower sense the term Celtic is often applied today to the Irish, the Manx, the Highland Scotch, the Welsh, the Cornish and the Bretons of northern France.

In the broader sense, the term Celtic speaks of entire range of Nordic people of various subgroups who dominated central and northern Europe from 600 B.C. to about 100 A.D.

The same chapter of Isaiah quoted in the previous paragraph establishes that the Gaelic language would be associated with Ephraim, the British Isles. Thus does God always do what He says He will do. We are held in His hands, though Satan has blinded the true Israel to its identity these last days.

Isaiah 66:8 foretells that a new nation will be born in a day. What day was that?

**Leviticus 26:21** warned that Israel would be punished "seven times" if the nation persisted in sin. Israel did continue to sin. About 747 B.C., the house of Israel was required to pay heavy tribute to Assyria. After this additional setbacks occurred. The nation collapsed and was taken into captivity.

The term "seven times" in the Bible means 2,520 years (seven times three hundred sixty--a day meaning a year). That brings us roughly to 1773 A.D. Calendar corrections can bring us to 1776 A.D. On July 4, 1776, a nation was born in a day with the Declaration of Independence.

(Actually, the correct year is 745 BC, according to *Putnam's Dictionary Of Events*, copyright 1927, page 6, which states, "745, Accession of Tiglath-pileser III of Assyria, who wages war against Chaldea, Syria, and the kingdom of Israel." This was the historical date when the eastern half of the tribe of Manasseh was deported by Tiglath-Pileser. 2520 years later is **Exactly 1776**. (Since there is no year 0, the correct answer is 1775 + 1.) – Eli}

Isaiah 60:5 promises that much of the wealth of the world will one day flow to the nations of Israel. The King James Version says, "—the forces of the Gentiles {sic, nations – Eli} shall come unto thee." The word translated "forces" means "wealth" and the word "Gentiles" means simply "nations" so that the verse should read, "...the wealth of the nations shall come unto thee."

America produces much of the wealth of the world, which benefits (blesses) all mankind. It is natural that wealth should flow into this dynamic society. Much of the world is jealous of our creativity, inventiveness, and willingness to take risks to make possible advancement. # The Welsh Eisteddfod Its Original And Etymological Meaning

## From Our USA Correspondent



The eisteddfod is one of the most ancient institutions of the Welsh nation. It may have received its inspiration from a more remote nation than the Celtic Cymri, Greece, Rome or Syracuse, possibly, but in its present form, from though Welsh only.

As early as the time of the tyrant Dionysius of Syracuse, great assemblies of International contestants met to vie with one another in public sports and contests. At times they were exalted in nature, and of a distinctively literary character. It was one of the redeeming traits, if it had any, of that strange monarch, that he loved to excel in literature.

The Stuarts of England devoted much time to literary attainments. Indeed there have been many instances of literary monarchs, and many princes have given their aid and encouragement to the eisteddfods held in the once proud Celtic kingdom. The literary festivals in which monarchs have participated in the contests have been frequent; and, either the Welsh nation has been the progenitor of the exalted custom, or it may have been simply imitator of the ancient game and literary contests of primitive times.

However this may be it has survived the ravages of time, the rise and fall of nations, the disintegrating force of revolutions, and has been a nucleus around which have gathered the morally good, the intellectually great, and the religiously devout of the sons and daughters of Gwalia and others.

Time has rather brightened the ancient and holy custom of the fathers and Tuesday next in the metropolis of the anthracite coal regions of Pennsylvania, once the beautiful home of the red man, the Welsh national convention is to be held. The Damascus of the Plains is to crystallise the custom with a celebration full of ancient and aesthetic accomplishments. It has required labour and expenditure of money to keep alive this most ennobling national institution.

### ETYMOLOGICAL MEANING

The etymological meaning of the word eisteddfod is "a sitting", a "session," a "synod," a "convention;" and the more modern significant definition "a literary and musical festival." The word, so difficult to most persons of pronunciation, is a compound word, composed of two words, "*eistedd*," to sit, and "*fod*," to be; which rendered in the compound meaning mean "a sitting to be." Its primitive meaning was a sitting or synod composed of bards and minstrels.

The so-called Gorsedd of the Bards is usually regarded as one of the relics of the Druidic period, and is mentioned in the Welsh Triads as the highest assembly of the Isle of Britain. This is a strange ceremony, yet not more so than what may be seen within the halls of any secret order.

At the "Logan Stone" (*Maen I.log*), the arch Druid stands. Twelve stones and twelve bards at stations in a circle first chant the Gorsedd prayer, which is feebly expressed in the English as follows;

**"Grant O God, thy protection;  
And in protection, strength;  
And in strength, understanding;  
And; in understanding, knowledge;  
And in knowledge, knowledge of the just;  
And in knowledge of the just, the love or it  
And In that love, the love of all existence;  
And in the love of all existence, the love of  
God.  
God and all Goodness."**

## SACRED CIRCLE

There is a sacredness about it that is with the religious pathos of the Welsh life and habits. The ritual is completed in the hour devoted to this mystic rite, and then the "Sacred Circle" is broken.

This language, that has surprised linguists, and served to connect the remote ages to this, by its strange construction, has, unlike its immediate sister tongue, survived in its primitive purity. It is the language of song and poetry; and the institutions of the Welsh will survive so long as their wonderful speech exists.

The institutions of any nation are known much in traditions, more or less correct and quite the greater weight of good things come from the remote East. Then come chronicles more certain' yet fallible.

Tradition gives the Welsh nation four great Eisteddfods; one in the sixth century, one in the seventh century, one in the ninth century and one in the eleventh century. It is quite certain that they were more frequent than tradition has recorded, else time must have crated them forever, as they could not have survived two centuries apart.



**The Bardic Chair**

The eisteddfod was given its Welsh characteristics and name from the assemblage of bards for competition in national assemblies. Synods or convening of bards was known to the Romans 200 years BC, by which name the Gauls and other Celtic people designated their minstrels. Prior to the 1281 AD in the reign of Edward I, it was the custom for the Welsh Princes to appoint the judges, or adjudicators of the national eisteddfods, thus proving the great interest taken by the national rulers in the festival.

Subsequently to the reign of the first Edward, eisteddfods were repeatedly held under royal commission down to the reign of Elizabeth, which celebrated monarch contributed largely to the great festival, by giving her presence and patronage at the great National festival at Caerwys, Wales, in A. D 1568.

Once in the reign of Henry IV, a restriction was placed upon this wholesome- amusement. This is the only time in recorded History wherein a ruler has ventured to molest the pure Celtic Institution. It was, perhaps, the result of a condition of unrest - the year 1403. But there could be no lasting prejudice, and in due time the most jealous monarch saw that nothing but good could come of this happy assemblage.

### FIRST HELD IN 1166 AD

Popular opinion has encouraged the eisteddfod. Authentic history gives its origin in the year 1168 AD when a convention was held in Cardigan Castle. This event was held under the patronage of the Prince of South Wales; and it was reported as an event worthy of the attention of the chronologer. It is difficult to tell when and where the first eisteddfod was held. It has made itself a history of a thousand years and more. Its aims have been elevating, and its purposes good.

Language has, perhaps, more effect on a people than religion; and the strong perfect speech of the Welsh has given the people characteristics akin to the philological contour. The motto: "*Dan Nawdd Duw n'l Dangnef.*" (under the protection of God und His peace) the Central Wales bardic eisteddfod motto, is a sample of linguistic perfection and combined devotional conception.

The purpose, largely, of the eisteddfods in the United States, and other countries foreign to

Wales, has been to preserve a perfect mother tongue, and to encourage literature and art among all nationalities without reference to tongue or creed. The pride of a Welshman in his language is remarkable.

A celebrated philologist has said of it: "The language or, rather, the structure, of sentences, and the phraseology exhibits a certain stateliness, or even grand eloquence, characteristic, indeed. The language, while national supremacy is virtually gone, still survives, the oldest spoken language now used in literature and business.

There is a triune relation in the eisteddfod, in the Triads, in the language, and in the sacred sign each suggestive of the three letters of the bardic alphabet (Coelbren y Deirdd), which forms the name, God.

Another of the motto of the five chairs of the bardic provinces, "*Duw a phob Dafont.*" (God and all that is good), again, like most of the proverbs and mottos of the people, accord to virtue and Supreme Sovereignty the mastery of men and things.

### THE CYMRIC LANGUAGE LIVES.

National physical strength may be subdued, but it is impossible to tarnish the pure institutions of a devoted people. The language of Cambria lives, though something history records, has suppressed her autonomy of government, for the time being.

Sophocles, the second of the great of Greek tragic artists, says;

**"No ordinance of man shall override  
The settled laws of Nature and of God;  
Not written these in the pages of a book,  
Nor were they framed today, nor yesterday;  
We know not whence they are; but this we  
know,  
That they from all eternity have been,  
And shall to all eternity endure."**

### POET LAUREATE

The picture below is that of the Rev. De Pugh Griffiths of Binghampton, N. Y. Mr. Griffiths won the chair and three hundred dollars for the

best original poem at the Denver eisteddfod of 1897.

He will be at the Robert Morris eisteddfod at the Frothingham next Tuesday and will act in the dual capacity of president of the sessions and adjudicator of the poetical compositions. He is a poet of decided abilities and a gentleman of superior culture and education.

The musical features of the eisteddfod will be unusually interesting and the competitions more than ever excellent and spirited. The chief choral prize, "*Teyrnasoedd y Ddaear,*" which is the composition of the immortal John Ambrose Lloyd, is, and will always be, considered the most musical glee that was ever written by a Welshman. It is always new, and its rendition never fails to warm the Welsh heart. We anticipate an elegant and spirited contest.

The male voice competition will probably be the best from a musical standpoint. Greater attention is paid to correct reading, interpretation and shading. The voices are better, as a rule, and the tempo more strictly adhered to. This, undoubtedly, will be a great contest, as some of the finest male voices will participate in the affair. The quartets, trios and duets and solos will be hotly contested by some of the best singers of Wyoming and Lackawanna valleys. Many will enter on the Piano solo.

## From Our Glasgow Correspondent





the human and animal food chains with many more GMOs.


EcoWatch produced the article "15 Health Problems Linked to Monsanto's Roundup," which include: ADHD, Alzheimer's disease, Anencephaly (birth defects), Autism, Brain cancer, Cancer, Celiac disease and gluten intolerance, chronic Kidney disease, Colitis, Depression, Diabetes, Heart disease, Hypothyroidism, Inflammatory Bowel Disease (IBS) and "Leaky Gut Syndrome", Liver disease, Lou Gehrig's disease (ALS), Multiple Sclerosis (MS), Non-Hodgkin lymphoma, Parkinson disease, Pregnancy problems (infertility, miscarriages, stillbirths), Obesity, Reproductive problems, and Respiratory illnesses.

However, there are photographs of two-year-old rats from GMO feed studies that resulted in massive tumors. Monsanto's studies presented for GMO approvals stopped at 90 DAYS, not the normal two-year-life-cycle of rats! - Picture on next page.



**Relative to Monsanto’s 90-day study, EFSA (European Food Safety Authority) stated.**

“With respect to the detection of potential unintended effects in whole GM food and feed, it is unlikely that substances present in small amounts and with a low toxic potential will result in any observable (unintended) effects in a 90-day rodent feeding study, as they would be below the no observed effect level and thus of unlikely impact to human health at normal intake levels.

Laboratory animal feeding studies of 90-days duration appear to be sufficient to pick up adverse effects of diverse compounds that would also give adverse effects after [chronic exposure](#).”

However, “Seralini’s long-term study linking glyphosate to rat tumours was unfortunately retracted from the journal Food and Chemical Toxicology due to pressure from Monsanto lobbyists. The results of the study have since been republished in Environmental Sciences Europe.” [1]

Look what’s happened to food in Europe, which previously was relatively clean of GMOs!

In June 2015, EFSA issued a new guidance document on the information that companies need to provide when applying for renewed authorisation to import GM plants for food and feed into the European Union. The European Commission grants authorisations to place GM food and feed on the European market for a period of ten years. [3]

Could that impact your food shopping and buying practices regarding foods produced in Europe? It certainly ought to affect what previously was considered GMO-free foods coming from European countries.

What do you think?

Aren’t consumers entitled to know what’s in the food we are eating, e.g., GMOs and how that food was grown or produced/manufactured?

Shouldn’t there be “reverse advertising” on all food labels, e.g., no GMOs or GMO-free?

Shouldn’t the PLU identity number “8” be mandatory for all foods containing GMOs or grown as GMOs? [2]

Currently, the PLU identity number “9” identifies organically-grown food.

Won’t you please tell the EPA what you think about GMOs and sign the petition? Thanks!

**T**HE HIEROGLYPHS tell the tale of early Egyptian explorers, injured and stranded, in ancient Australia.

The discovery centres around a most unusual set of rock carvings found in the National Park forest of the Hunter Valley, 100 km north of Sydney.

The enigmatic carvings have been part of the local folklore of the area for nearly a century with reports of people who sighted them as far back as the early 1900's. The site was secretly visited by families "in the know" in the 1950's and fell back into local mythology for a couple of decades until it was accidentally rediscovered by a man looking for his lost dog.

The carvings are in a rock cleft, a large block of split sandstone on a cliff-face that has created a small chasm or "chamber" of two flat stone walls facing each other that widens out from two to four meters and is covered in by a huge flat rock as a "roof" at the narrow end. The cleft is most cave-like and only accessible by a small rock chute from above or below, well disguised from the average bush-walker.

When you first come up the rock chute and climb into the stone hallway you are immediately confronted by a number of

worn carvings that are obviously ancient Egyptian symbols. These are certainly not your average Aboriginal animal carvings, but something clearly alien in the Australian bush setting.

There are at least 250 hieroglyphs. At the end of the chamber, protected by the remaining section of stone roof, is a remarkable third-life sized carving of the ancient Egyptian god "Anubis".

The hieroglyphs were extremely ancient, in the archaic style of the early dynasties.

This archaic style is very little known and untranslatable by most Egyptologists who are all trained to read Middle Egyptian upward. The classic Egyptian dictionaries only handle Middle Egyptian, and there are few people in the world who can read and translate the early formative style.

Because the old style contains early forms of glyphs that correlate with archaic Phoenician and Sumerian sources one can see how the university researchers who saw them could so easily have thought them to be bizarre and ill-conceived forgeries.

The ageing Egyptologist Ray Johnson, who had translated extremely ancient texts for the Museum of Antiquities in Cairo eventually was successful in documenting and translating the two facing walls of Egyptian characters - which stemmed from the Third Dynasty.

The rock walls chronicle a tragic saga of ancient explorers shipwrecked in a strange and hostile

land, and the untimely death of their royal leader, "Lord Djes-eb". A group of three cartouches (framed clusters of glyphs) record the name of "RA-JEDEF" as reigning King of the Upper and Lower Nile, and son of "KHUFU" who, in turn, is son of the King "SNEFERU".

This dates the expedition just after the reign of King Khufu (known in the Greek as "Cheops" reputed builder of the Great Pyramid) somewhere between 1779 and 2748 BC. Lord Djes-eb may have actually been one of the sons of the *Pharaoh Ra Djedef*, who reigned after Khufu.



### Sketches of the Rock Art

The hieroglyphic text was apparently written under the instruction of a ship's captain or similar, with the corner glyph on the wall displaying the title of a high official or chief priest.

The scribe is "speaking for his Highness, the Prince, from this wretched place where we were carried by ship." The expedition's leader, as mentioned before is described in the inscriptions as the King's son, "Lord Djeseb", who came to grief a long way from home.

The hieroglyphics sketch his journey and his tragic demise: "For two seasons he made his way westward, weary, but strong to the end. Always praying, joyful, and smiting insects. He, the servant of God, said God brought the insects.

Have gone around hills and deserts, in wind and rain, with no lakes at hand. He was killed while carrying the Golden Falcon Standard up front in a foreign land, crossing mountains, desert and water along the way.

He, who died before, is here laid to rest. May he have life everlasting. He is never again to stand beside the waters of the Sacred Mer". (MER meaning "love")


There was a moat around the pyramid called the "waters of Mer". The second facing wall, which

was much more seriously eroded, details the tragedy further.

This wall begins with the badly eroded glyph of a snake (Heft), with a glyph of jaws (to bite) and the symbol for 'twice'.

"The snake bit twice. Those followers of the diving Lord "KHUFU", mighty one of Lower Egypt, Lord of the Two Adzes, not all shall return. We must go forward and not look back. All the creek and river beds are dry. Our boat is damaged and tied up with rope.

Death was caused by snake. We gave egg-yolk from the medicine-chest and prayed to AMEN, the Hidden One, for he was struck twice."



### Burial rituals, prayers and preparations are described

"We walled in the side entrance to the chamber with stones from all around. We aligned the chamber with the Western Heavens."

The three doors of eternity were connected to the rear end of the royal tomb and sealed in. We placed beside it a vessel, the holy offering, should he awaken from the tomb. Separated from home is the Royal body and all others.

The extraordinary 5,000 year-old story of the death and burial of "Lord Djes-eb" one of the sons of the Pharaoh Ra Djedef. Visual observation of the site makes it obvious that the very worn carvings exposed to the coastal weather would have to be several centuries to a thousand years old at least. When first found the site was completely overgrown with thick vegetation and filled in with smashed rock and a much higher soil line.

A number of excavation attempts by interested parties have not turned up any artefacts or bodies but sophisticated and expensive laser scanning techniques have not been applied.

There is significant evidence that the ancients were well aware of the Great South land. There were both Sumerian and Mayan traditions of a "lost motherland" in the Pacific. Australia appears under the name of "Antoecie" on the famous spherical world map of **Crates of Mallos**, even appearing on the Greek map of **Eratosthenese** in 239 BC.

It seems fairly certain that the maritime civilizations of antiquity were quite capable of extensive ocean voyages. Particularly the early Egyptians, as evidenced by Giza's remarkable "Tomb of the Boat".

In the 1950's, a streamlined 4,500 year old hundred foot, ocean going vessel was excavated from right next to the Great Pyramid. In 1991 an entire fleet of even older boats was found buried in the desert at Abydos in Upper Egypt. According to Cairo Times, in 1982, archaeologists working at Fayum, near the Siwa Oasis uncovered fossils of kangaroos and other Australian marsupials.

And there's also the strange set of golded boomerangs discovered by Prof. **Carter** in the tomb of Tutankhamen in 1922.



### The Gympie Ape

A stone ape statue possibility 3000 years old.

The statue was unearthed in 1966 on Mr **Dal K. Berrys Wolvi** road property. The ape is made of conglomerate iron stone and shows a squatting ape figure. It is believed to represent the Egyptian God Thoth in ape form.

A smaller stone idol unearthed near the Gympie Pyramid is also believed to represent the Egyptian God Thoth in ape form clutching the Tau or the Cross of Life.

This statuette is badly weathered with age. Thoth was the god of writing & wisdom, depicted as an ape by the Egyptians until about 1000 BC when he became an Ibis-headed human bodied deity who recorded the judgment of the souls of Amenti, the after world. Thoth's symbol was the papyrus flower.

An ancient Terraced Hill at least 6000 years old has been found on the outskirts of Gympie off Tin Can Bay Road. The Pyramidal structure is 100 foot high and consists of a series of terraces up to 4 feet tall and eight feet across constructed of small and larger lumps of stone. It was recorded by the first white man into the area in the 1850's.

A very small statuette of a squatting ape was found by Widgee Shire workman Mr Doug George from near Traveston crossing. Mr George picked up the rock while working near the bridge.

This is also believed to be Thoth in ape form. Unearthed at Noosaville on the Sunshine Coast, was an ancient Egyptian Jade Ankh or 'Cross of Life'.

### Toowoomba

A group of seventeen granite stones were found with Phoenician inscriptions.

One had been translated to read "Guard the shrine of Yahweh's message" and "Gods of Gods". Another inscription reads, "This is a place of worship or Ra" and "Assemble here to worship the sun." Ra was the Egyptian sun god.



### The carving featured the outline of a chariot, showing one of its wheels

**Rex Gilroy** in 1978 identified ancient Masonic Egyptian symbols among aboriginal cave art several miles from the 1910 Ptolomy IV coin discovery site. An Egyptian sun disc was discovered in 1950 carved into a cliff.

# The Plague of Justinian

### Apocalypse in VI century: Volcanic winter and and Plague of Justinian

**I**N Byzantine chronicles from 536-540 AD, scientists found the description of an unusually long solar eclipse. According to chronicler Procopius of Caesarea, a black cloud covered the sun for several months. The celestial phenomenon was linked to many disasters that occurred during that time, such as crop failures, famine, political unrest and epidemic of Justinian plague.

So-called Plague of Justinian was the world's first-ever recorded pandemic of plague. The pandemic was named so as it started during the reign of Byzantine Emperor Justinian I. The pandemic affected almost the entire civilized world. Other plague epidemic would break out during hundreds of years afterwards - from year 541 to 750.



Researchers believe that the source of plague appeared in Ethiopia or Egypt, from where the disease, together with grain cargoes, as well as infected rats and fleas, arrived in Constantinople via trade channels of the time. From Constantinople, the epidemic spread across the Byzantine Empire before it reached neighbouring countries. By the end of year 654, plague had reached North Africa, all of Europe, Central and South Asia and Arabia.

In Byzantium, the pandemic had reached its peak by the year 544. According to chronicles, plague was killing up to 5,000 people daily in Constantinople. At times, the disease would claim 10,000 lives a day. Plague destroyed 40 percent of the population of the city. In the East, plague killed about 100 million people; the death toll in Europe was about 25 million.

In Irish sources, one may come across the term of '*crom conaill*' ("Red Death"), which became the cause of death for many saints and monarchs in 549-550. It was "Red Death" that killed Welsh King Gwynedd Maelgun and Saint Finnian of Clonard.

A prophecy about these events can be found in the Bible. Here is what one reads in Chapter 9 of Revelation: "And he opened the bottomless pit; and there arose a smoke out of the pit, as the smoke of a great furnace; and the sun and the air were darkened by reason of the smoke of the pit." Verse 9:17: "And thus I saw the horses in the vision, and them that sat on them, having breastplates of fire, and of jacinth, and brimstone: and the heads of the horses [were] as the heads of lions; and out of their mouths issued fire and smoke and brimstone." Verse 9:18: "By these three was the third part of men killed, by the fire, and by the smoke, and by the brimstone, which issued out of their mouths."

What happened during that time? Scientists believe that the cause for the long-lasting solar eclipse was multiple volcano eruptions, traces of which were discovered in the ice of Greenland and Antarctica. Each of these eruptions that occurred in years 536 and 540 affected the lives of civilizations at the time. Scientists do not know which volcanoes exactly were to blame for the eruptions, but they were most likely the ones in Central and North Americas, as well as in Indonesia.

Supposedly, it was large amounts of volcanic ash in the atmosphere that caused the so-called "volcanic winter" effect. A similar phenomenon, albeit of a local scale, occurred in 1815 after the explosion of Mount Tambora in Indonesia.

Scientists found support for the "volcanic" hypothesis in manuscripts from the VI century. They also studied samples of the Greenland and Antarctic ice that was formed during that era.

It turned out that fragments of the ice contained sulphur and other compounds that are normally found in volcanic ash and gases. The scientists thus could create a climate model, to reconstruct the events that took place in late 530's.

It was found that the power of the two volcanic eruptions combined was the strongest in the past 1,200 years. As a result of those eruptions, average temperatures on the Earth dropped by two degrees Celsius. Above all, the climate changes affected the northern hemisphere - Scandinavia, the Mediterranean Sea, the Middle East and North Africa. The researchers concluded that it was volcanoes that triggered "apocalypse" of the sixth century, and no one can guarantee that it will not happen again.

Did these plagues come about consequential to The Justineian Code which changed Yahweh's Law?



The Corpus Juris (or Iuris) Civilis ("Body of Civil Law") is the modern name for a collection of fundamental works in jurisprudence, issued from 529 to 534 by order of Justinian I, Eastern Roman Emperor.

It is also sometimes referred to as the Code of Justinian, although this name belongs more properly to the part titled Codex Justinianus.

This Code, like the Theodosian, enacted orthodox Christianity into law. It began by declaring for the Trinity, and anathematised (solemn curse)

Nestorius, Eutyches, and Apollinaris. It acknowledged the ecclesiastical leadership of the Roman Church, and ordered all Christian groups to submit to her authority. But ensuing chapters proclaimed the dominion of the emperor over the Church: all ecclesiastical, like all civil law, was to emanate from the throne.

The Code proceeded to make laws for metropolitans, bishops, abbots, and monks, and specified penalties for clerics who gambled, or attended the theatre or the games. Manicheans or relapsed heretics were to be put to death; Donatists, Montanists, Monophysites, and other dissenters were to suffer confiscation of their goods, and were declared incompetent to buy or sell, to inherit or bequeath; they were excluded from public office, forbidden to meet, and disqualified from suing orthodox Christians for debt. A gentler enactment empowered bishops to visit prisons, and to protect prisoners from abuse of the law."

This last quotation should hit you like a bombshell, for it reveals that Justinian did just what was prophesied of him by Daniel. Justinian did, in fact, think to change laws. Justinian had the greatest opportunity to do this as the law was being translated from the Latin to Greek. It was an opportunity for him to change the law to his own religious convictions.

to buy or sell without it) is in the past, not in the future. It was the number of a man, and that man was the Pope.

## **Catholic Scholar, James E. Bulger Was The Murder of James From Kirkby, Merseyside From Our Newcastle Correspondent**
