## The Israelite Phoenicians And Glastonbury Bv **Pastor Eli James**



Britain, Phoenicia's Secret Treasure, and its Conversion to **Christianity - The** Legendary Tin Mines of Cornwall

British Isles through their own exploring and seeking out of new products and markets for them. They kept the knowledge of the Cornish tin mines a closely guarded secret so they could control trade in the metal and charge a high price for it. After the Punic wars, Carthage, the one remaining city of the Phoenicians, became less and less an important economic power.

HEN ROME WAS STILL A TINY VILLAGE on the Palatine Hill, Phoenician traders were sailing their the length and breadth of the Mediterranean and beyond in search of goods to be sold or traded for a handsome profit. There were great risks in making a long sea voyage and bringing home a valuable cargo, but the enormous profit that could be made from selling the goods made the risks worthwhile.

The key was to trade a product that was unique, very desirable, hard to get, or desperately needed for other products that were common in the land of the people with whom you were trading. These products may be rare and desirable someplace else, and the trader now had something with which he could once again make a profit.

Tin was just such a product in the ancient world. Tin was vital to the ancients because it was needed in the making of bronze. Bronze was an alloy, or a mixture of two or more metals. To make bronze, the metal smith mixed copper with the proper amount of tin. Copper tools and weapons by themselves were too soft and did not long remain sharp.

Tin made the copper harder and also made the molten metal fill the mould more completely when it was cast into useful objects like axe heads, hammers, and jewellery. So many useful articles were made of bronze in ancient times that no civilization could thrive very long without a supply of it or the copper and tin needed to make it.

With their well - known efficiency and thoroughness, the Romans counted access to the British tin mines as one of the advantages of conquering the island. Julius Caesar knew of the importance of British tin when he invaded the island in 55 to 54 B.C. After the conquest of Britain during the reign of Claudius, the Romans were in control of most of the world's supply of the metal. Hence, the closely guarded treasure secret of Britain's tin passed hands from the Phoenicians to the Romans.



The fact that tin trade existed is too well attested to need proof. Herodotus as early as 445 BC speaks of the British Isles as the Tin Islands or Cassiterides (above). Pytheas (352-323 BC) mentions the tin trade, as does also Polybius (circa 160). Diodorus Siculus gives a detailed description of the trade. He tells us that the tin was mined, beaten into squares, and carried to an island called Ictis, joined to the mainland at low tide, which is generally held to be Mount St. Michael in Cornwall, although some have identified it with Falmouth.

Thence it was shipped to Morlais, and transported across France on pack horses to Marseilles. From Marseilles it was again shipped The deposits of tin in the ancient world were to Phoenicia. Innumerable ancient workings in usually small and not very plentiful. The Cornwall still attest the trade, and tin is still Phoenicians discovered the tin deposits of the mined there today. Lord Avebury and Sir John Evans held the opinion that the trade existed as early as 1500 BC, and Sir Edward Creasy writes: "The British mines mainly supplied the glorious adornment of Solomon's Temple". This matter ties in very well with the involvement of Phoenician builders with construction of Solomon's Temple.

## Travel Between The Eastern Mediterranean And Britain

Before going into the controversial question of Glastonbury, Joseph of Arimathea and the stories or legends which surround it, one needs to stop at a few points to determine some basic givens. Glastonbury is traditionally the first Christian sanctuary in Great Britain, visited, so legend has it, by Joseph of Arimathea and Saints David & Patrick. It has a strong tradition in British history dating back to the time of King Arthur who is said to have been buried at the Abbey beside his lovely wife Queen Guinevere.

His body was moved at a later date. Further, at Glastonbury Joseph of Arimathea is said to have planted the Holy Thorn tree which is still growing there today. Also, a holy well is supposed to be still found there.

The strong tradition tying Joseph of Arimathea with Glastonbury and the Phoenician tin trade with Cornwall may have strong thread of truth that ties them together. The only known sailors who came from the Eastern Mediterranean to Britain were Phoenician. Hence, the elementary conclusion is that Joseph of Arimathea, if he really made the trip(s), must have done it on Phoenician ships.

If this hypothesis is accepted, further reading on the subject could be accommodated. However, some claims and details seem far fetched but are presented herewith for your consideration despite their implausibility.

Below, the account is presented as is even though the author does not necessarily agree with this presentation in its totality.

However, for historical reference presents this some what irrefutable point of evidence:

Historians William of Malmesbury, Maelgwyn of Llandaff and Polydore Vergil all place Joseph of Arimathea at Glastonbury. Even the four

Church councils of Pisa 1409, Constance 1417, Sienna 1424 and Basle 1434, mention that "the Churches of France and Spain must yield in points of antiquity and precedence to that of Britain as the latter Church was founded by Joseph of Arimathea immediately after the passion of Christ."

## Joseph Of Arimathea, Tin Merchant



According to the Talmud, Joseph of Arimathea was said to have been an uncle of the Virgin Mary, being a younger brother of her father. He gained his wealth as an importer in the tin trade, which existed between Cornwall and Phoenicia.

Joseph along with St. John buried Jesus after the crucifixion. Joseph, in the tin trade, made a lot of trips to Britain, where being a rich merchant made close contact with royalty; namely Kings Beli, Lud, Llyr and Arviragus, who gave Joseph and his companions some 2000 acres of land, tax free. Arviragus would become God's "Protectorate" for the Cradle of Christianity, Glastonbury. Caradoc, Pendragon of 'Britain', would become God's "Protectorate" of the fledgling British Church.

Joseph of Arimathea was a man of refinement, well educated, and one who possessed many talents, had extraordinary political and business ability. He has been called one of the richest men in the world. He learned about that tin trade from the Phoenicians, which then was akin in importance to that of steel today. They had been bringing ore from Britain for centuries.

Joseph was well educated, a member of the ruling political body of the whole country. In St. Jerome's translation, Joseph's official title is given as 'Nobilis Decurio', a minister of mines for the Roman Empire, with direct access to Pilate himself. He was no slouch. How better to protect Jesus, after Joseph the carpenter died, and insure the seeding and growth of the Gospel in Britain.

The basic story of Joseph's trip to Britain varies in some details from account to account. But the bare facts are that Joseph, with many disciples travelled from the holy land by Phoenician boat and landed at Marseilles (a Phoenician trading post), in the Vienoise province of the Gauls (France). From there he went on to Britain established seminaries and sent out missionaries. In his "Ecclesiastical Annals", Cardinal Baronius, Curator of the Vatican library, gives this account. "In that year the party mentioned was exposed to the sea in a vessel without sails or oars.



The vessel drifted finally to Marseilles and they were saved. From Marseilles Joseph and his company passed into Britain and after preaching the Gospel there..."

How many of the disciples were with Joseph of Arimathea during his short stay in Gaul, before going on to Britain, is hard to say. Various existing records agree in part with the Cardinal Baronius record, naming among the occupants of the castaway boat Mary Magdalene, Martha, the hand-maiden Marcella, Lazarus whom Jesus raised from the dead, and Maximin the man whose sight Jesus restored.

Other records state that Philip and James accompanied Joseph. Others report that Mary, the wife of Cleopas, and Mary, the mother of Jesus, were also in the boat. Here's Cardinal Baronius' complete list of passengers: St. Mary, wife of Cleopas, St. Martha, St. Lazarus, St. Eutropius, St. Salome, St. Cleon, St. Saturninus, St. Mary Magdalene Marcella, the Bethany

sisters' maid, St. Maximin, St. Martial, St. Trophimus, St. Sidonius (Restitutus) and St. Joseph of Arimathea.

Philip was waiting for the travellers in France. There is testimony asserting his commission in Gaul, all of which alike state that he received and consecrated Joseph, preparatory to his embarkation and appointment as the Apostle to Britain.

Although there are some who would argue for France being first, most records agree that Britain, at Glastonbury was the Root of the Christian movement.

One would expect that history would show that the missionary activities would flow out of the well-spring of Christianity. And well does history record this. The Gaulic records state that for centuries the Archbishops of Treves and Rheims were all Britons supplied by the mother church at Glastonbury- Avalon. St. Cadval, a famed British missionary, going out from Glastonbury, founded the church of Tarentum, Italy, A.D. 170 four hundred years before the time of St. Augustine and at least fourteen years after King Lucius Christianized all of Britain in A.D. 156!

Converts literally flooded into Glastonbury for conversion, baptism, instruction and missionary assignment. Philip sent, from Gaul alone, one hundred sixty disciples to assist Joseph and his team with the crowds. And it is surely known that helpers were sent from other places beside France.


One of the first to go out from Glastonbury was Mary and Martha's brother Lazarus. He headed straight back to Marseilles where he held the Bishopric for seven years. But that was only natural. France was a Family Thing for the Bethany household.

Mary and Martha both lived out their lives, preaching and teaching in the south of France. "The Coming of The Saints," by Taylor is a good book on the subject.

Many famous names are recorded as having been associated with Glastonbury- Avalon:

Sidonis, Saturninus, and Cleon taught and Iltigius, in "De Patribus Apostolicis", quotes St. supported other missionaries in Gaul, then returned to Britain. Martial's parents, Marcellus and Elizabeth were there along with St Zacchaeus. Parmena, disciple of Joseph, was appointed the first Bishop of Avignon. Drennalus, helped Joseph found the church at Morlaix. He was then appointed to Treguier as its first Bishop.

Beatus founded the church in Helvetia, after receiving his baptism and education at Avalon.

Beatus was baptised by St. Barnabas, the brother of Aristobulus, sent in advance by St. Paul to Britain. He is referred to in scripture as Joses, the Levite.

Mansuetus was consecrated the first Bishop of the Lotharingians A.D. 49, with his See at Toul. He also founded the church at Lorraine.

## **Historical Note:**

Mansuetus was a constant visitor to Rome after Claudia had married Pudens. He was a friend of Linus, the Bishop of Rome, and brother of Claudia. After the death of St. Clement, Mansuetus became the third official Bishop of the British Church at Rome. Thus we have three disciples of Avalon, instructed by St. Joseph, to become, in succession, Bishops of Rome.

Peter as saying; "Concerning the Bishops who have been ordained in our lifetime, we make known to you that they are these. Of Antioch, Eudoius, ordained by me, Peter. Of the Church of Rome, Linus, son of Claudia, was first ordained by Paul, and after Linus's death, Clemens the second, ordained by me, Peter."

If all of this is true, was Glastonbury The First Christian Church thanks Phoenician to Christians (more history on Joseph)

In Lionel Smithett Lewis' St. Joseph of Arimathea at Glastonbury indicates "It is certain that Britain received the Faith in the first age from the first sowers of the Word. Of all the churches whose origin I have investigated in Britain, the church of Glastonbury is the most ancient.": wrote sir Henry Spelman in his Concilia, and again he wrote in the same work: "We have abundant evidence that this Britain of ours received the Faith, and that from the disciple of Christ Himself, soon after the Crucifixion of Christ."

Robert Parsons, the Jesuit, in his Three Conversions admits that: "The Christian religion began in Britain within fifty years of Christ's ascension." His co-religionist, the very learned Alford, in his Regia Fides says: "It is perfectly certain that, before St. Paul had come to Rome, Aristobulus was absent in Britain."

The discreet Fuller goes so far as to say: "If credit be given to these ancient authors, this Church without competition was senior to all Christian churches in the world." "Britain," wrote the erudite Polydore Vergil, "partly through Joseph of Arimathea, partly through Fugatus and Damianus, was of all kingdoms the first that received the Gospel." It is a matter of distinct interest that Cardinal Pole, twice over, when solemnly reconciling Britain to the Pope and the Church of Rome, at the beginning of Queen Mary's reign, claimed that Britain was the first country to be converted to Christianity.

The Venerable Bede, writing about AD 740, says: "The Britons preserved the Faith which they had received under King Lucius uncorrupted, and continued in peace and tranquility until the time of the Emperor Diocletian."

It will be noticed that two distinct events are spoken of above: (1) The foundation of the Church in Britain by the Disciples of Christ. (2) The acceptance of Christianity by the British Nation under Good King Lucius about AD 170. Britain was the first of all nations to accept Christianity as its national religion. Few people realize that this is why the British King is called "our Most Religious King".

Not many realize that the superior dignity and antiquity of our national Church has been decided by Church Councils. The Councils of Pisa in 1409, Constance in 1417, Sienna in 1424, and Basle in 1434. It was there contended that the Churches of France and Spain must yield in points of antiquity and precedence to that of Britain, as the latter Church was founded by Joseph of Arimathea immediately after the Passion of Christ.

Gildas the Wise, the earliest Christian historian (AD 425-512) distinctly says that the Light of Christ shone here in the last year of the reign of Tiberius Caesar, that is AD 37. This falls in with the claim recorded above, which gave precedence to British Bishops at the Church Councils on the ground that Britain was converted "immediately after the Passion of Jesus Christ".



It fits in also with the statements of Fuller and Polydore Virgil already recorded that the Church of Glastonbury was the Senior Church of the world; with Sir Henry Spelman's words that Britain received the Faith soon after the Crucifixion; with Alford's statement that Aristobulus (Above) was in Britain before St. Paul went to Rome; with the observance by the Greek Church of the martyrdom in Britain of Our Lord's disciple, St. Simon Zelotes, on May 10, AD 44 (a date supported by Cardinal Baronius; and with Hippolytus' (born about AD 160) inclusion of that Apostle in his lists as

"Bishop of the Britons". All these are testimony to the year AD 37 as marking the coming of the first Mission.

Joseph of Arimathea was the protector of that valorous little band of disciples during the perilous years following the crucifixion, the indefatigable head of the Christian underground in Judea, and the guardian of Christ's only earthly treasure, - His mother.

According to the Talmud, Joseph was the younger brother of the father of the Virgin Mary. He was her uncle, and therefore a great uncle to Jesus. Chiefly from the secular reports we learn that Joseph was a married man and his son, Josephus.

It is quite obvious that the husband of the Blessed Virgin Mary died while Jesus was young. Under Jewish law such a circumstance automatically appointed the next male kin of the husband, in this case Joseph, legal guardian of the family. We know that Joseph never forsook his nephew.

He stood by Him as a bold, fearless defender at the notorious trial, and defied the Sanhedrin by going to Pilate and boldly claiming the body when all others feared to do so. It is commonly taught that Jesus was poor and of obscure relatives.

His relationship with the affluent Joseph of Arimathea proves otherwise. In his own right he was a property owner but long before he took up His mission He forsook all material wealth.

Leading authorities identify Arimathea with Ramah, or Ramallah as it is called today. It was the birthplace of the prophet Samuel, and is called in the Septuagint Arimathaim. Josephus calls it Amartha.

The identity seems clear. Now Ramah lay about eight miles due North of Jerusalem on the Jerusalem-Nazareth road. It was the first stopping place of caravans travelling North from Jerusalem. It would be the stopping place of the Holy family, both to and from the city.

Joseph is always spoken of as belonging to Arimathea, which implies that it was his existing place of residence. He was a wealthy man, and his duties as a chancellor would bring him frequently to Jerusalem, where he had also a The Origin and Early History of Christianity in town residence.

He would certainly be in Jerusalem at the time Did the Apostle Paul Visit Britain?, by R.W. of the feast. [of Passover] The whole story now becomes clear. As the uncle of the Virgin Mary he probably knew all about the wondrous story of Our Lord's birth. Year by year, when Joseph and Mary attended the feast, he would enquire about the mysterious child. He would eagerly look forward to His first visit.



## Is Israel A Chosen Servant Race To "Save The World"? By Arnold Kennedy



## Introduction

HERE IS an almost universal view amongst those generally called "Christian", together with Jews, that God's purpose in selecting the chosen race of Israel was

that this race was chosen, "to save the world". The same idea is held both by many of those who say that "Israel" refers to a people as a racial

lineage, and also by all those who declare that Israel is now a spiritual "church" made up of those of any race who "believe in Jesus". Looking at this literally, we would have to accept that if only one race was the "chosen race", then all other all races would have to be 'un-chosen' in regard to God's purpose for Israel. To see one application under the New Covenant, of what God's purpose is, we read:

Hebrews 8:8-10, Behold, the days come, saith the Lord, when I will make a new covenant with the house of Israel and with the house of Judah: Not according to the covenant that I made with their fathers in the day when I took them by the hand to lead them out of the land of Egypt; because they continued not in my covenant, and I regarded them not, saith the Lord. For this is the covenant that I will make with the house of Israel after those days, saith the Lord; I will put my laws into their mind, and write them in their hearts: and I will be to them a God, and they shall be to me a people.

Here one purpose is expressed as being that "the Lord" was to be "a God" (singular) of "a people" (singular). This is exactly the same purpose as that expressed in the Old Testament. No one can honestly escape the singular nature of Israel as "a people", in the New Testament, expressed here as being the House of Israel and the House of Judah. These are the same people whom God led out of Egypt in the Exodus, that is, they are Israelites. This passage points out that these only two parties concerned in the New Covenant.


This understanding about these two Houses is very different to what the denominations teach. They teach that somehow one of these Houses has become a multi-racial "church" and that the other House has become "The Jews". Denominations teach that Jesus was sent to "everyone", whereas Jesus says, "I was not sent but to the lost sheep of the House of Israel"-[Matt.15:24].

To try to get over this difficulty, the denominations have invented the phrases, "spiritual Israel" (as "the Church") and "natural Israel" (as "the Nation") which they wrongly term 'The Jews'). Actually, this is nothing new; reference to this can be found as far back as AD 116 where there was suggestion made that the two parties were "The Church" and "The Jews". This later developed into the idea that there is a "Church" comprised of "Gentiles" [supposedly non-Israelites] and "The Jews" [supposedly "Israelites"]. How the House of Israel could become non-Israelites is never explained.

Most commentaries and modern Bible footnotes are 'factories of confusion'; they will say in one place that "Israel" now means "the Church" in which everyone of any race can be 'saved', whilst also pointing out elsewhere that Israel as a race will yet be restored to the land promised to Abraham. To make this more confusing they also say in other places "Israel" means "The

There is no way anyone could rightly force-fit the House of Israel and the House of Judah into the concept of "Jews and Gentiles".



The "Jews and Gentiles" are not the two parties of Hebrews 8:8-10 as above, nor of Old Testament prophecy–[See Jer.31:31]. In the expression, "The Jew and the Greek"-[Rom. 1:16, 10:12, Col. 3:11] - "The fake Jew" is the Judean part of Israel and "The Greek" refers to those Israelites dispersed in parts of the old Greek empire.

If we make the two parties different in identity from these two Houses, (as Scripture states so clearly they are), we must come to a wrong conclusion when we come to look at God's purpose for electing Israel to be a chosen race.

Nowhere do the denominations explain how their multi-racial concept of "the Church", as they like to call it, could be partakers of the New Covenant, especially in the terms of Hebrews 8:8-9, as above. We can easily see that a "new" Covenant could not be made with any race, which had not first had an "old" Covenant, as it would not be "new" to any race but Israel.

might be a member of the House of Israel and which might be in the House of Judah is never stated, and indeed, never could be. Denominations offer, "That they might be one" (John 17, 11+21+22), out of its "Israel" context, in support of their claim.

This conflict is added to by a misinterpretation of a handful of much-misused verses, wrong word meanings and phrases. These will not be discussed here because they, and objections raised so far, are all well covered and answered in the book, "The Exclusiveness of Israel" by 'Eliel', which is obtainable through the address inside the front cover of this booklet.

Before we explore some of the things Scripture says about God's purpose in making Israel a "chosen people", we will look at published statements, which typify the popular denominational teachings about God's purpose for making Israel a chosen people. These teachings are based upon the Jewish and denominational claims that the two parties are "Jews and Gentiles" rather than the two parties of both Testaments, namely the House of Israel and the House of Judah (House of Judah - not Jews).



There is no prophecy in the Old Testament books that says "Israel" would become "The Church" in the popular concept, and there is no statement showing this as fulfilment of such prophecy in the New Testament books.

## A viewpoint expressed by the Jews.

From the 1994-2000 Encyclopaedia Britannica Inc., we can read the following extracts, which come from Jewish assertions. Please note what is emphasized below, because they show the viewpoint, not only of most Jews, but also of virtually everyone else who wears the tag "Christian". Please note the emphasised words.

- 1. "The idea that they have been chosen by God as his special people implies that the Jewish people have been chosen by God to worship only him and to fulfil the mission of proclaiming his truth among all the nations of the world.
- **2.** Those whom God had selected to preserve and transmit his revelation to all the world.
- 3. The destinies of all nations were shaped toward the fulfilment of God's purpose and that this purpose was to ultimately unite all humanity as one people in their acknowledgement of him as God. Israel was to be God's instrument to accomplish this great revelation and would serve as the messenger and witness of God's reality and law to all the other nations of the earth. The people of Israel would exemplify and teach God's statutes to the rest of humanity and would thus help bring the entire human race to salvation. Israel would be the saviour of humanity and the national embodiment of the messiah.
- **4.** Israel was to be God's instrument to accomplish this great revelation and would serve as the messenger and witness of God's reality and law to all the other nations of the earth.
- **5**. Abraham and his descendants are singled out not merely as the object of the divine blessing but also as its channel to all mankind.
- **6.** In Isa. 43-44, Israel is declared to be God's witness and servant who is to bring the knowledge of God to the nations. In chapter 42 of the same book Israel is declared to be a "covenant of the people, a light to the nations, to open the blind eyes, to bring out the prisoners from the prisons, and them that sit in darkness out of the prison house" (42:6-7).

Note carefully how they wrongly call Israel "the Jewish people", to fit in with their "Jews and Gentiles" belief, and note also that Israel is supposed to be, "The national embodiment of the Messiah". In both Isaiah 42:6-7 and 44:6 which are quoted, the Servant who is to "raise up the tribes of Jacob, and to restore the

preserved of Israel", and to be "a light to the nations", is Jesus who is, "A light to lighten the Gentiles [ethnos = people], and the glory of thy people Israel-[Luke 4:32]. Israel thus is not the corporate Messiah to "bring the entire human race to salvation" as is claimed. Denominations, which say Israel's purpose is "to save the world", are agreeing that Israel is a corporate Saviour of all races.

In this they are denying the personal Jesus as the Saviour and Redeemer of Israel. By claiming that "Israel" and "The Jews" are the same identity, and that Israel's purpose is to "save the world", the Jews are able to suggest that they are the world's corporate saviour.

They openly claim they are this corporate Messiah, and within themselves say they are destined to rule nations of the world. Instead of majoring on the redemption of Israel by a personal Redeemer, they (and the churches) major on bringing all the races together by social action, bringing in their Humanistic and Talmudic teachings such as "Human Rights", pro-Homosexuality and "non-Discrimination". Neither the "Jews" nor the churches get these values from the Bible.

The Bible does not teach that God's purpose is to turn non-Israelites into Israelites, or to make all races one. It is the House of Israel and the House of Judah that God purposes should become one. The "middle wall of partition" [Eph. 2:14] divides one thing, that is, "all Israel"-[See also Zech. 11.14]. The unconverted of the Houses of Israel and Judah have enmity between them until the time given in Isaiah chapter 11. So, the parties could not have become "Jews and Gentiles", even up until this time in the future!

There are variations upon this "Jews and Gentiles" and "save the world" theme held by the Roman Catholic Church, Conservative Denominations, Pentecostals, Jehovah Witnesses, Mormons, Seventh Day Adventists and so-called "Holy Ghost" denominations. It could broadly be said, "This is what everyone believes".

## THE "BRITISH-ISRAEL" GROUP's VIEW.

Their creed, or the "we believe" statements, is analysed in the writer's paper, "British-Israel Creed Contradictions", together with doctrinal expositions. This passage goes on to tell us that there are also other vessels "fitted for destruction" and not for glory. The basis is race and God made the choice before his Chosen has done good or evil-[Rom. 9-11].

Not believing these things is one reason why British Israel/Identity groups are so divided in their expression as to God's purpose in choosing one race. Their persistent setback is that they inconsistency in what they give as their beliefs. present the word "Gentiles" as always meaning and Greek, the words translated as "Gentiles" are also used of the peoples of Israel.

> "Our fathers" shows the whole context concerns only Israel. Likewise all the New Testament books can be shown to be written only to Israel, just as the letters to the Corinthians are, as above. Because they have a fixation about "Gentiles" being always non-Israelites, churches have to invent a belief about getting the message out to Israel first before going to what they think of as being Gentiles. In Acts 13:43, where Paul says, "Lo, we turn to the Gentiles, For so hath the Lord commanded us, saying, I have set thee to be a light of the Gentiles, that thou shouldest be for salvation unto the ends of the earth", it does not take much working out that Paul was turning from the Judean Israelites to the "other sheep" Israelites which were the scattered House of Israel. This is the sequence pre-determined in prophecy.

A female kinswoman of Jesus and Joseph called Anna is said by some to have married into the royal line of Britain, becoming an ancestor of King Arthur [see Arthur]; the first royal convert to Christianity was Bran the Blessed, father of leader of the resistance to Roman imperialism in the mid years of the first century AD, Caractacus [see Caractacus]; Britain's King

world's first Christian ruler and Britain became the world's first Christian realm [see Lucius & More 1]; Lucius had a famous correspondence with Pope Eleutherius and appointed bishops and archbishops.

The Archbishops of Treves and Rheims in Gaul were for many years from Britain; St Cadval was a famous British missionary to Italy, founding the church at Tarentum in AD 170; the British royal descriptor 'Court of St James' probably should really refer to 'St Joseph', the confusing nomenclature resulting from the Council of Basle in 1434. The Roman Catholic version of Christianity was brought to England by Augustine in AD 596 [see below, St Augustine of Canterbury], more than half a millennium after the actual arrival of 'primitive Christianity', which had been favourably received because of a perceived congruence with Druidism [see Druidism & More 14]; receptivity was also built by a curious prophecy, delivered in the early first century AD:

'There was in Great Britain in the time of this King Cambelinus [see Cymbeline], a soothsayer, whom they called Thezelinus, and who was said to be a prophet; so it happened, once upon a time, that the king was holding a great feast at his court, and he commanded that they should bring him this Thezelinus, of whom, when he came, the king required, in presence of his barons, that he would be pleased to prophecy something concerning the time to come; at which request.


Thezelinus replied to the king, telling him not to be astonished to hear that the Saviour and Redeemer of the whole world was born of a virgin, without human corruption. The king and the other barons caused this prophecy to be written down, and often afterwards they recollected it; and for this reason the Britons believed in our Lord as soon as they heard him spoken of or preached, because they remembered the prophecy of Thezelinus.' ## What Race Were The Greeks and Romans? Part 2 **John Harrison Sims**

## The Roman Patricians

ELL PAINTER, AUTHOR of the above-mentioned History of White People, finds it "astonishing" that the American Nordicist Madison Grant (1865-1937) argued in The Passing of the Great Race(1916) that the Roman nobility was of Nordic origin, yet there is good evidence for this view. There are many lavishly illustrated books about ancient Rome with examples of death masks, busts, and statues that clearly depict the Roman patricians not simply as Europeans but as northern European.

Dr. Peterson explains that the Romans painted their death masks to preserve the color, as well as the shape, of their ancestors' faces. Blue eyes, fair hair, and light complexions are common. A good example of racial type is the famous portrait bust of Lucius Junius Brutus, the founder of the Roman Republic, which dates from the fourth century BC. Brutus' face is identifiably Germanic, and so is the colour of his eyes. T

he sculptor used ivory for the whites and blue glass for the pupils. Or take the famous marble head of a patrician woman from the late first century AD, which is often included in illustrated surveys of imperial Rome to demonstrate the fashion for curled hair. Her features are typically northern European: a delicate, aquiline nose, high cheekbones, and a face angular and long rather than round. Another classic example is the famous fresco from the Villa of the Mysteries in Pompeii, which shows four women undergoing ritual flagellation. They are tall, light-skinned, and brown-haired.

There also evidence from Roman is names. Rutilus means "red, gold, auburn" and stems from the verb rutilo, which means "to shine with a reddish gleam." Rufus, meaning red, was a common Roman cognomen or nickname used for a personal characteristic, such as red hair.

The Flavians were an aristocratic clan whose family name was derived from flavus, meaning golden-yellow. The Flaminians were another family whose clan name fromflamma, meaning flame, suggesting red hair. According to Plutarch, Marcus Porcius Cato had "red hair and grey eyes," Lucius Cornelius Sulla, the general and dictator, had "blue-grey eyes and blond hair," and Gaius Octavius (Augustus), the first Roman emperor, had "bright eyes and vellow hair."

Recent analysis of an ancient marble bust of the emperor Caligula found particles of the original pigment trapped in the stone. Experts have restored the colors to show that the demented ruler had ruddy skin and red hair.

The love poetry of Publius Ovidius Naso, better known as Ovid, (43 BC to AD 17) offers much evidence of the color of upper-class Roman women during the early years of the empire. That Ovid ascribes blond hair to many goddesses — Aurora, Minerva, Ceres, Diana, and Venus tells us something about the Roman ideal of beauty; that he describes many of his lovers the same way tells us that the Nordic type was still found in imperial Rome. "I'm crazy for girls who are fair-haired and pale-complexioned," he writes in his Amores of 15 BC, but "brunettes make marvellous lovers too."

He admires the contrast of "dark-tresses against a snow-white neck," and adores young girls who blush. One of his favourite lovers is "tall" with a "peaches-and-cream complexion," "ivory "smart Greek blonde."

So where did the Romans come from? They were a Latin people, although according to legend that may have some basis in fact, there were also Greek colonists and Trojan refugees among the founding races. The Latins were one of eight Nordic Italic tribes — Apulii, Bruttii, Lucanians, Sabines, Samnites, Umbrians/Oscians and the Veneti — who migrated into the Italian peninsula around 1000 BC. Of course, Italy was not vacant.

The Etruscans lived to the north of Rome in what is now Tuscany, and there were other darkercomplexioned whites living in the peninsula. The Etruscans are likely to have been Carians from Asia Minor.

What became of the Nordic Greeks and Romans? Their numbers were reduced and thinned through war, imperialism, immigration, and slavery. Protracted internecine war was devastating.

The Hellenes lost relatively few men in their two wars with the Persian Empire (490, 480-479 BC), but they were decimated by the ruinous series of inter-Hellenic wars that followed. The Peloponnesian War (431-404 BC) pitted Athens and her subject Ionian cities against the Spartan Dorian confederacy.

That was followed by 35 years of intermittent warfare between Sparta and Thebes (396-362 BC), which pitted Nordics against Nordics. These wars so weakened the Greek republics that they fell under Macedonian rule about 20 years later (338 BC), bringing to an end the classical age of Greece.

Money was, as always, a racial solvent. Theognis, a noble poet from the Dorian city of Megara wrote in the sixth century BC: "The noblest man will marry the lowest daughter of a base family, if only she brings in money. And a lady will share her bed with a foul rich man, preferring gold to pedigree. Money is all. Good breeds with bad and race is lost."

The Roman experience was similarly tragic. All of her later historians agreed that the terrible losses inflicted by Hannibal during the Second Punic War (218-201 BC) were minor compared to the horrendous losses Rome inflicted on

cheeks," and "bright eyes." Another was a herself during the nearly 100 years of civil war that followed the murder of the reforming Tribune Tiberius Gracchus in 133 BC.

> Immigration was the inevitable backwash of imperialism as slaves, adventurers, and traders swarmed into Rome. Over time, slaves were freed, foreigners gave birth to natives, non-Romans gained citizenship, and legal and social sanctions against intermarriage fell away. By the early empire, all that was left of the original Roman stock were a few patrician families.



The historian Appian (left) lamented that "the city masses are thoroughly now mixed with foreign blood, the freed slave has the same rights as a native-born citizen, and those who are still slaves look no different from their masters." Scipio Aemilianus (185–129 BC), a statesman and

general of the famed clan of the Aemilii, called these heterogeneous subjects "step-children of Rome."

One hundred and fifty years later, Horace (65-8 BC) wrote in Book III of the Odes: Our grandfathers sired feeble children; theirs Were weaker still — ourselves; and now our curse Must be to breed even more degenerate heirs.

The last Roman writers therefore came to see their own people as both morally and physically degenerate. The subtext of Tacitus' (56-117 AD) ethnological treatise Germania is a longing for the northern vigour and purity the Romans had lost.

He saw the Gauls and Germans as superior to the Romans in morals and physique, and Roman women shared this admiration. Blond hair became the rage, and German and Gaulic slave women were shorn of their blond or reddishbrown hair to make wigs for wealthy women. By the time of Tertullian (160-225 AD), so many Roman women were dying their hair that he complained, "they are even ashamed of their country, sorry that they were not born in Germany or Gaul."


Juvenal complained of the dwindling stock of "the bluest patrician blood," which is a figurative through their light skin.

## The Pagan "Star of David" Part 2 By Hoim



## The Real David and Solomon!

N THE OTHER HAND, it has been discovered by some researchers that this "Star of David" (also called "Shield of David" and "Seal of Solomon") was NOT a symbol relating to either the Biblical King David or Solomon, but to Solomon ben Duji the Khazar, and his son, David al-Roy. While some sources do not identify them as Khazars, evidence indicates that they clearly were. Notice what Arthur Koestler has to say:

"David al-Roy was assassinated -- apparently in his sleep, allegedly by his own father-in-law -But the cult did not stop there. According to one theory, the six-pointed 'shield of David,' which adorns the modern Israeli flag, started to become a national symbol with David al-Roy's crusade.

'Ever since,' writes Baron, 'it has been suggested, the six-cornered "shield of David", theretofore mainly a decorative motif or a magical emblem, began its career toward becoming the chief national-religious symbol of Judaism— it was attributed to David in mystic and ethical German writings from the thirteenth

century on, and appeared on the Jewish flag in Prague in 1527.' Baron appends a qualifying note to this passage, pointing out that the connection between al-Roy and the six-pointed star still awaits further elucidation and proof" (The Thirteenth Tribe).

Research indicates that in the twelfth-century an Ashkenazim, a Khazar Jew, called Solomon ben Duji (or Ruhi or Roy) claimed he was Elijah and his son Menahem ben Duji was the Messiah. They wrote letters to all the Jews in the lands about them proclaiming the coming of the Messianic Kingdom. It appeared to have had little effect, for, twenty years later Menahem had assumed the name "David al-Roy," and the title of "Messiah" and that the movement shifted from Khazaria to Kurdistan.

After vain attempts to rouse the Diaspora to action and to invade the Holy Land, Menahem, or David al-Roy, was assassinated in his sleep, allegedly by his own father-in-law, whom someone had bribed to do the deed.

## According to one source –

"---In the early 12th century Russia produced an attempt at a Jewish Crusade, aimed at conquering the Holy Land by force of arms. This was started by a Khazar Jew named Solomon ben Duji (Ruhi or Roy in some translations), with the help of his son Menahem and a Palestinian Jewish scribe. They wrote letters to the Jewish communities of the Middle East. announcing that the time had come when God would bring His people back to Jerusalem, that Solomon ben Duji was Elijah, and that his son was the Messiah. However, those appeals seem

to have had little effect, for we hear nothing until twenty years later; at this time Menahem moved from Russia to northern Iraq, changed his name to David al-Roy, and proclaimed himself the Messiah. Then he assembled a substantial armed force of Khazars and local Jews, and took possession of Amadie, a strategic fortress northeast of Mosul.



"It seems that from here the plan was to lead the army to Edessa, and fight through Syria to the Holy Land. Because of the constant feuds between Crusaders, Sunni and Shiite Moslems, the enterprise did not seem as hopeless as it does now. Besides, some Moslem commanders might have welcomed the prospect of a Jewish Crusade against those Christian castles.

"One of David al-Roy's messengers went to Baghdad and boldly told the Iraqi Jews to assemble on a certain night on their flat roofs, and from there they would be flown on clouds to the Messiah's camp. Many Jews spent that night on their roofs, awaiting a flight that never came for them. Not long after that, David al-Roy was assassinated in his sleep, allegedly by his own father-in-law, whom some interested party had bribed to do the deed.

That ended the Crusade, but as with Abu Isa, David al-Roy continued to have followers for many years afterward. He also existed for centuries in Jewish literature as an example of the all-conquering king the Messiah was expected to be; Benjamin Disraeli, the famous 19th-century British Prime Minister, even wrote a historical romance about his career, called *The Wondrous Tale of Alroy*."

Solomon ben Duji and his son Menahem had used the magical symbol of two equilateral triangles having a common center, the six-

pointed star, or Hexagram, or *Magen David*, that then became known as the Seal of Solomon.

Magen David in Jewish liturgy signifies "God as the protector" (shield) of David, and in this context, the symbol gained currency among medieval Jewish mystics who attached magical powers to King David's shield. Especially following the influence of the Kabbalist Isaac Luria (1533-72), the hexagram became accepted by "the Jews" as "the Shield of David," before this time, there was no general usage of the six-pointed star in Jewish culture.

## **Archaeological Evidence**

Almost every researcher of the Star of David mentions the "seal from Sidon", but although the seal was purchased in Sidon It belonged, according to the inscription on it, to a man named Joshua son of Asayahu, who lived in Israel during the later kingdom -- the sixth century B.C. In this finding of the Star of David it appears partially and blurred, if it is a Star of David at all. Scholem declared this finding as the oldest appearance of the Star of David in Judaism.

However, the Librarian Shlomo Zucker noted (on the margin of Scholem's book) that the identification of this shape as the Star of David is uncertain, since it is "by a certain interpretation", and referred the reader to a book where the author, Diringer, claims that the Magen David that appears in the seal of Sidon was a decorative motif, and that we can understand from it that the Magen David was a sign used by the Jews already in this early period.

In the courtyard of the Museum of Tarentum (Italy) there's a tombstone bearing the Hebrew inscription: "Here rests the wife of Leon son of David \$\phi\$ of Milo". This tombstone is no earlier than the sixth century A.D. From the inscription on the tombstone researchers concluded that in the sixth century A.D. there was already a connection between the name and the shape of the Star of David. This is the first Jewish tombstone bearing the Star of David. Later it appeared here and there on other tombstones, until it became one of the most popular motifs that mark the graves of Jews.

In the Tarentum tombstone and in the seal from Sidon the Star of David does not appear alone -- it appears along with Hebrew words, and is understandable in the light of the context that these words create for it.

The "Seal from Sidon" comes from, apparently, the land of Israel, and the Tarentum tombstone was found out of Israel, in exile, in Italy. Discovering the Star of David in Israel is particularly important because it may verify the legend (which **first appeared in the Middle Ages**) about the shield that protected King David in his wars. It has been assumed that if the Star of David is discovered in excavations within the State of Israel, then it must be Jewish, but out of all the findings of the Stars of David in Israel, a majority of them are actually Christian hexagrams discovered in a church or a monastery or near a Cross.

This includes findings from Acre, from Khirbeter-Ribba, from Khirbet Carmel near Hebron, from Roglit in the Negev, from Shilo. In the Euthymius monastery mosaic appears a crescent in the inner hexagon and it indicates a Muslim influence or a Muslim design of the mosaic.

Three reliefs, carved in stone and containing the Star of David, were discovered by German archaeologists Kohl and Watzinger Capernaum, on the shore of the Sea of Galilee in Israel. Alongside them were also discovered, among other things, reliefs of a Menorah, an Ark on wheels, a Pentagram, a Pelta ("Amazons' Shield") and a swastika. Kohl and Watzinger noted in their book on ancient synagogues in the Galilee that the origin of the Star of David is indeed pagan, and its meaning for pagans was magical, but its amazing appearance among the decorations of synagogues in Israel shows that the Jews have adopted it as an emblem, although their spiritual leadership ignored it as part of the fight against idolatry. Gershom Scholem, however, concluded from these findings the opposite conclusion. He says:

"—in the synagogue of Capernaum (second or third century C.E.) it is found side by side with the pentagram and the swastika on a frieze. There is no reason to assume that it was used for any

In the Tarentum tombstone and in the seal from purposes other than decorative" (*On the* Sidon the Star of David does not appear alone -- *Kabbalah and Its Symbolism*).

Recently, however, archaeologist Professor Jodi Magness, from the University of North Carolina, dated the construction of the synagogue in Capernaum to the first half of the sixth century A.D.

A relief of the Star of David framing a Rosetta engraved in stone was discovered in a synagogue in the excavations (sixth century A.D.) at the ruins of Shura in the Upper Galilee. This star is probably the only archaeological find, from the first centuries A.D., discovered in Israel, whose Jewishness is not controversial.

Engravings resembling the Jewish Star of David were unearthed at two Khazar sites -- one along the Donets River in eastern Ukraine and the other along the Don River in southern Russia. This one is a circular metal disc, interpreted by Professor Bozena Werbart of Umea University as Jewish but seen by others as **shamanistic or pagan**.

The circular nature of the disc may represent the sun, and the six points may represent rays of the sun. Scholars lean towards assigning the disc to Tengri shamanism due to the fact that there are also known examples of Khazarian sun discs with five or seven points, rather than consistently six. Some of the Jewish-Turkic graves at Chelarevo in what used to be Hungary contain engravings of the Star of David and are believed by some to belong to **Khazar Kabar migrants**.

## The Bible And Swearing of Oaths (Part 2) From Our West Midlands Correspondent



ID THE CROWN ORDER EVERYONE TO PAY THE INCOME TAX?

No, that wasn't possible. There really was "no jurisdiction." And that would have done nothing to cure the lack of respect. The crown went one better. It ordered that every man shall swear an oath of allegiance to the crown! Damned Christian thing to do, eh? Literally!

A small handful of the tax objectors obeyed. MOST REFUSED.

It was a simple matter of black and white. Jesus said "swear not at all." They opted to obey Him over the crown. That quickly brought them into court, facing the charge of high treason. An official would take the witness stand, swearing that he had no record of the defendant's oath of allegiance.

Then the defendant was called to testify, there being no right to refuse to witness against one's self. He refused to accept the administered oath. That refusal on the record, the court instantly judged him guilty. Took all of 10 minutes.

That expedience was essential, for there were another couple hundred defendants waiting to be tried that day for their own treasons against the crown. In short order the jails reached their capacity, plus. But they weren't filled as you'd envision them. The men who'd refused the oaths weren't there. Their children were. There was a "Stand-in" law allowing for that. There was no

social welfare system. The wife and children of a married man in prison existed on the charity of church and neighbours, or they ceased to exist, starving to death.

It was typical for a man convicted of a petty crime to have one of his kid's stand in for him for 30 or 90 days. That way he could continue to earn a living, keeping bread on the table, without the family having to rely on charity. However, a man convicted of more heinous crimes would usually find it impossible to convince his wife to allow his children to serve his time.

The family would prefer to exist on charity rather than see him back in society. But in this case the family had no option. The family was churchless. The neighbours were all in the same situation. Charity was non-existent for them. The family was destined to quick starvation unless one of the children stood- in for the breadwinner. Unfortunately, the rational choice of which child should serve the time was predicated on which child was the least productive to the family earnings.

That meant nearly the youngest, usually a daughter.

Thus, the prisons of England filled with adolescent females, serving the life sentences for their dads. Those lives would be short. There was no heat in the jails. They were rife with tuberculosis and other deadly diseases. A strong man might last several years.

A small girl measured her remaining time on earth in months. It was Christian holocaust, a true sacrifice of the unblemished lambs. (And, we must note, completely ignored in virtually every history text covering this era, lest the crown, government and church be duly embarrassed.)

Despite high mortality rates jails still overflowed. There was little fear that the daughters would be raped or die at the brutality of other prisoners. The other prisoners, the real felons, had all been released to make room. Early release was premised on the severity of the crime. High

treason was the highest crime. The murderers, result of the refusal to swear oaths, but as the thieves, arsonists, rapists, etc., had all been set free.

That had a very profound effect on commerce. It stopped. There were highwaymen afoot on every road. Thugs and muggers ruled the city streets. The sworn subjects of the crown sat behind bolted doors, in cold, dark homes, wondering how they'd exist when the food and water ran out.

They finally dared to venture out to attend meetings to address the situation. At those meetings they discussed methods to overthrow the crown to which they were sworn! Call that perjury. Call that sedition. Call it by any name, they were going to put their words into actions, and soon, or die from starvation or the blade of a thug.

Here we should note that chaos (and nearly anarchy: "no crown") came to be, not as the direct result of the governmental demand that people swear them! The followers of Jesus' words didn't bring that chaos, those who ignored that command of Christ brought it.

The crown soon saw the revolutionary handwriting on the wall and ordered the release of the children and the recapture of the real felons, before the government was removed from office under force of arms. The courts came up with the odd concept of an "affirmation in lieu of oath."

## **Book About Killing Gentile Children Becomes Bestseller In Israel**

Sir , I came across this disturbing item which I think will be of interest to your readers:

"JERUSALEM – A Jewish rabbi has issued a book giving Jews permission to murder non-Jews, including babies and children, who may pose an actual or potential threat to Jews or Israel. "It is permissible to kill the Righteous among non-Jews even if they are not responsible

for the threatening situation," Rabbi Yitzhak Shapiro, who heads the Od Yosef Chai Yeshiva in the Yitzhar settlement in the occupied West Bank, wrote in his book "The King's Torah."

He argues that govem (a derogatory epithet for non-Jews) may be killed if they threaten Israel.

"If we kill a Gentile who has sinned or has violated one of the seven commandments – because we care about the commandments there is nothing wrong with the murder."

Rabbi Yitzhak Shapiro – co-author of the book

Shapiro, who heads a small Talmudic school at the settlement of Yitzhar near Nablus, claims his edict "is fully justified by the Torah and the Talmud."

The anti-govern edict seems to come in response to the arrest by Israeli police of a Jewish terrorist who has confessed to having murdered two Palestinian shepherds in the West Bank.

The terrorist, an American-born immigrant named Yaakov Teitel, also confessed to have tried to assassinate leftist Jewish figures.

Police considered the arrest an important According to Israel Shahak, author of "Jewish achievement in combating Jewish terrorism, which experts contend thrives on religious edicts issued by rabbis affiliated with the religious-Zionist camp.

Nearly 16 years ago, a Jewish terrorist named Yigal Amir assassinated then Israeli Premier Yitzhak Rabin.

The controversial edict is backed by numerous rabbis affiliated with the so-called national-religious camp as well as the Talmudic seminary in West Jerusalem, known as Merkaz Ha'rav.

Among the rabbis who have publicly supported the edict are Yitzhak Ginsburg and Ya'akov Yosef.

Ginsburg had written a leaflet glorifying murderer Goldstein and called him a "saintly figure."

Shapiro's views on how Palestinians and non-Jews in general ought to be treated according to Jewish religious law (halacha) are widely looked at as representing the mainstream not the exception in Israel.

During the Israeli onslaught against Gaza earlier this year, Mordecahi Elyahu, one of the leading rabbinic figures in Israel, urged the army not to refrain from killing enemy children in order to save the lives of Israeli soldiers.

He had even petitioned the Israeli government to carry out a series of carpet bombing of Palestinian population centres in Gaza.

## A Remarkable Sermon

As we see Archbishop Justin Welby preached about peace. In the Treaty of Paris 1856, civilians are not to be involved in war. Merchant shipping was forbidden to have cannons and armed civilians and such were to be shot if captured.

The carpet bombing of Dresden was contrary to international law, as it involved civilians. The bombing of German civilians had interesting results. In the words of an RAF officer who was shot down and escaped, the rest of the aircrew were killed by German civilians as police officers watched. Would every male reader put themselves in the position of a German civilian in these circumstances? Your wife and children have been killed, following the carpet bombing of an undefended city. And the aircrew of a damaged plane lands before your eyes. Would you offer these murderers a cup of tea or would you kill them? Brutality breeds brutality!

Winston Churchill became Prime Minister with the higher direction of the war on 9 May 1940. He started bombing civilians on the night of 10<sup>th</sup> /11th May. Hitler did not reply kind until September when the blitz began. It appears he wished sanity to prevail.

Besides the enormous loss of German civilians, our four engined bombers were deathtraps for and a dorsal turret on the top, but no ventral turret underneath.

The Germans had 2 engined bombers designed to be used against military targets only, as the figures prove. I was there in 1953 where I estimated that 30 square miles of the city were destroyed) our losses from the German raids was 60,000 killed.

The only winners in the war are the beneficiaries, who are armament the manufacturers and banksters. The latter write imaginary numbers in their ledgers, not representing any cash issued lawfully by the head of state in Parliament and lend this lie to the politicians of all belligerents. Sermon of The Archbishop of Caterbury, at the Frauenkirche, Dresden, Germany as Referred to by The Ancient Marriner



Sunday 15th February 2015

Sermon preached by Archbishop Justin Welby at the Frauenkirche today, during a visit to Dresden to commemorate the 70th anniversary of the allied bombing of the city.

### Isaiah 62: 6-12; Mark 8: 31-37

Unlike my wonderful predecessor I do not speak German, a fact of which I am both ashamed and disappointed. I therefore have to ask you to listen to my English when standing in this extraordinary church, preaching in which is one of the great privileges of my life.

During my five years in charge of the work at Coventry Cathedral on the Community of the Cross of Nails the story of Dresden, the terrible events of seventy years ago, the appalling

suffering of the Europe of those days, all were part of the story which has so shaped my own priority on reconciliation in so many parts of the world.

Until recent years, central and western Europe could feel confident that reconciliation was well established and that never again would any of us either go ourselves or send our children or grandchildren to fight other Europeans in the field of battle.

How tragic it is that this glorious church, speaking of liberty, of hope, of the faithfulness of God and witnessing to the good news of Jesus Christ now and in the centuries past, should be set once again in Europe where the sound of battle is maybe but a rumour, but a rumour growing in strength.

It is a deep reminder that reconciliation is a gift of God which is to be taken, made part of our very selves, and then nurtured and tended as one would a tropical plant in a cold climate, knowing that carelessness will lead to chill and ice killing the plant.

We find this urge to continual renewal of the living out of our vocation as Christian disciples set out clearly in the New Testament reading through the words of Jesus.

Who can doubt his frustration? He has just heard the declaration from Peter that he is the Son of the Living God, that he is the one for whom Israel has been waiting. And in a swift moment, in another sentence, Peter not only demonstrates his own failure to recognise the history-changing, life-transforming, world-reversing nature of this revelation, but also touches Jesus at the point of greatest vulnerability.

We are to take the humanity of Christ seriously. Above my mantelpiece in my office is a drawing by Sutherland of the face of Christ on the Cross, the same artist Sutherland who created the great tapestry at the east end of Coventry Cathedral.

It is a face in which the reality of humanity is shown at the deepest level. Underneath it is a reproduction of the twisted wood of the cross scarred by war that stands on the high altar at Coventry. Near it is a picture called "Victim, No Resurrection" by Terry Duffy. Again it is an image of deepest suffering. Should we not

not need to go through the cross was immensely we ourselves not prefer to avoid the cross?

That is why he turns to say that not only must he do, but so must also all those who call themselves Christians. We are to take up our cross and in imitation of Christ, walk after Him. The cross weighs on us in so many forms.

Above all though, it is the cross that bruises and presses on us as events press upon us and fears gather around us. Yet the call of the Christian is not to put it down, to turn away and pretend that the world is other than it is, but like Jesus to bear the full weight of the sin of the world moving onward proclaiming the good news of salvation and of hope for all.

Yet, like the cross which God lays upon our shoulders so that we may be true disciples of Christ, so also is the gift of hope and redemption, the certainty of joy and deliverance. Look at Isaiah. The people of Israel, returned from exile, found not the easy path of new empire and new Davidic kingdom which they expected, but rather the everyday struggles exacerbated by local war lords and bandits, by fear and danger on every side. For its reality read, the book of Nehemiah.

The prophet does not pretend that things are other than they are. He is utterly realistic as we Christians must also be. He recognises evil both threatening Jerusalem and within the community of faith. We must be equally real and equally humble about our own failings as well as the dangers of the world around. We cannot demonise the other without remembering that the other often has legitimate cause to say much about our own sin.

Yet Isaiah does not lose sight of the fact that God is faithful and will redeem. And therefore he calls the sentries to pray, like the importunate

understand that for Jesus the idea that He might widow in Luke's Gospel, to pray so much that God cannot help but answer. The church is to attractive at every level of His humanity. Would cry out to God in protest and lament at the tragedy of the world, to say as in Mark's Gospel "I will take the cross", like Isaiah earlier in his life to say "here am I, send me".

> The reality of the world in which we live, the reality in which this great Frauenkirche stands is of a world in which the lust for power and the hunger for dominance, the desire to hold on to what we have even when it has not been justly gained, is as dominant now as it has ever been in history.

> We look to the east and see the Ukraine threatened with invasion. We look to the south and find immense poverty and struggle as a result of governments that have taken on debt, the slavery of which must now be borne by those who are mere observers in the error. We look further south-east and south-west and find a cruelty that is beyond description in Isis and Boko Haram, masquerading as religion revealed by God.

> On all sides we hear the cry of the oppressed, and yet in our part of the world and many others there is more peace, more prosperity, better medicine, healthier living and better community relations than has ever been.

> What are we to do as Christians? First we are to remember that the Jesus we serve, who reveals the very nature of God, bore a cross and would not tolerate for one second the idea that anything less than bearing it to the full extent was essential to His vocation, and thus to ours.

> Secondly, we are to be a people who amidst the changes and chances of this life hold utterly to the reality of a God to whom we cry with every emotion from praise and thanksgiving, through lament and sorrow, to anger and resentment.

> We are to be the sentries that do not cease to pray, knowing that the God to whom we call is the one who will transform our society, who will enable the kingdom of heaven to come. We may carry the cross, but it is only in bearing it to its fullest extent that there is the transforming joy that fills us as we walk within the footsteps of Jesus.





It was a subject which might fill many books; he had himself written one such.\* Most of his illustrations were from the counties of Herefordshire, Shropshire, and Radnorshire. He first of all drew attention to the startling manner in which prehistoric works of various descriptions tended to follow one another in straight lines across the country. He indicated this by means of points connected by lines on large ordnance maps.

This held good in the neighbourhood of the Malvern Hills and elsewhere. The churches also, the sites of which, of course, had a significance previous to the Christian era, tended to line up in straight lines. Such straight lines must necessarily be artificial; the straight line did not occur in natural geography. The various sighting points were in the nature of earth-mounds of various descriptions, barrows, burys, tumuli, knaps, or cairns; also cuttings on ridges, moats or moat-like ponds, and mark stones. The line, he believed, was called the "ley" (pronounced "lay"), and people still spoke of the "lay of the land," not the lie of the land.

He dealt in detail with these various sightingpoints, but his main purpose was to show how they were connected, and he called special attention to the sighting notches—clean-cut little notches in the sky-line, often quite obscured if the observer did not stand in a given position, that is to say, on the line of the sunk track on the breast of the hill of which they were part. These notches were exceedingly well worth investigating, and indicated the possession of more brains than had often been attributed to early man.

Causeway {392} Into the question of names he dived interestingly, but far too briefly. He pointed out that two English words, "halo" light round the moon) had

the same significance, while "moat" or "mote" got into the language as meaning a speck of light in the eye.

The origin of these words was the moated mound, called "hlaew" and "beorh" in Beourilf. The primary purpose of the moat was for sighting from a distance. The words "beacon" and beckon," again, came from the same Anglo-Saxon word "beacen," meaning a sign or {393} signal-standard. The poet of the beacon was not Macaulay, but Newman, in "Lead, kindly light," and he got his inspiration from the Old Testament, in the prophecy of Nehemiah: "Moreover, thou leddest them in the day by a cloudy pillar, and in the night by a pillar of fire, to give them light in the way wherein they should go."

He reminded the audience how the word "beacon" had helped to form placenames, instancing Beaconsfield, and also the new village of Becontree

in Essex. The words indicated, not a hill, but something on the track to the beacon. "White," again, as a place-name, generally indicated something on those salt ways which were indispensable to the early Briton, salt being one commodity which he had to fetch from a distance. Similarly the prefix "red" applied to pottery.

His logical deductions were that the alignments he had shown were sighted, and as fragments of tracks remained on alignments, the sighting was evidently done in order to make trackways. As many such alignments included prehistoric tumuli, all such alignments must be

pre-Roman. The position of these immovable tumuli must have been fixed by sight. He

some illustrations of those remaining, and it. remarked that these stones often became objects superstitious mystery and religious observance.

Finally, he mentioned how frequently old churches were oriented to the line of the earthworks. Often the lanes leading up to churches to be found in old cities showed what must have been originally a sighting arrangement if one looked carefully. He instanced this from one lane in Hereford, with the cathedral tavern appearing to fill the opening at one end of it, and at the other end the tower of another church. He finished his lecture on a note of interrogation.

These indications of early life in country were wonderful, and yet we knew very little as to what they signified. > The theories which he had propounded with regard to these sighting marks had been corroborated by other observers in different parts of the country, notably in Norfolk and Suffolk, and again in Dorset. In reply to further questions, he agreed that it was not absolute proof of design unless there were four sighting points in a direct line; two, of course, meant nothing, and three might be accidental. Churches were often built on pagan sites. At the beginning of the seventh century a letter was written by Pope Gregory, giving instructions that churches should be planted on the sites of heathen temples.






