Disillusionment And Discovery

MY introduction to priestly hypocrisy came during the Second Vatican Council. As a mere lad of 17, I was a very idealistic Catholic, believing very strongly in the principles of morality as historically taught by the Catholic Church.

That all changed in 1963, when Vatican II swept the "eternal truths" of the Catholic Faith aside. In the place of the old, long-established "eternal truths" was a new set of "eternal truths," many of which contradicted the old "eternal truths." Unable to stomach the hypocrisy of it all, I left the Catholic Church and never looked back. It wasn't until 1978 that I discovered a worthy replacement: Christian Identity.

That limbo of 15 years took place during the Swinging Sixties and the Indulgent Seventies, an era of liberal changes with which I was not comfortable, even though I may have indulged in some of its guilty pleasures. As I was looking for Truth, not Entertainment, the "sex, drugs, and rock & roll" culture that I grew up in never appealed to me, despite its ubiquity.

Giving credit where it is due, my Catholic upbringing did stress the Ten Commandments, although the Catholic version deletes the Commandment against idolatry!

My assessment of the Catholic Church proved to be correct, as the Church did little or nothing, aside from lip service, to stem the tide of liberalism. In fact, after Vatican II, the Church was instrumental in institutionalising liberalism against conservative values. Although maintaining a consistent stance on the subject of abortion, the Church abandoned its anti-communist position and its ages-old stance against Judaism and Freemasonry.

The homosexual / paedophile crisis in today's church is but one symptom of Catholicism's inner

sickness and turmoil. Far too many Catholics look the other way or make excuses, rather than demand truth and accountability from their so-called "spiritual leaders." Such sheep get the pastors they deserve.

In the middle of my personal limbo period, I did a tour in Vietnam, surviving a year of hell, fighting against a largely unseen enemy, in a war that was not designed to be won. Instead, I saw very clearly that this war was making **BIG BUCKS** for **BIG CORPORATIONS** while **BIG GOVERNMENT** was taking control over what was previously the private sector.


It was painfully obvious to me then – and also to most other true conservatives – that the Government, under Lyndon Baines Johnson, was using the Vietnam War as a cover / subterfuge / distraction for the direct implementation of far-reaching socialistic intrusions into our private lives. While we were supposedly fighting communism on the battlefield, the Welfare State and liberalism were the big winners of the Vietnam War. Do you see the irony?

Our military strategy was to capture objectives in the field, only to abandon them shortly thereafter and allow the Viet Cong to retake those objectives without a fight.

When I confronted my commanding officer about this stupid policy, I became ostracized within my own outfit. I told him, the company, and the battalion that I refuse to fight with an organization that is not committed to winning. At no point during the Vietnam War was there any attempt to establish a front and secure the territory behind this front. (As I was to find out later, General MacArthur had the same problem during the Korean War.) Instead, the enemy was allowed constant inroads into whatever territory we possessed. How many times should a soldier be asked to recapture the same hill?

The expression, "no-win war," was commonly used by those of us who saw that the war effort was not sincere. I had developed the opinion that the War was being deliberately prolonged by corporate interests in order to reap maximum profits from supplying the War; and the federal government enabled this policy.

Even before returning from Vietnam in 1970, I promised myself that I would find out just who the war profiteers were. This path took me, first, to the hard money school of economics, starting with Harry Browne, Peter Cook, Frederic Bastiat, Ludwig von Mises, and other "rogue" economists, who taught that fiat money was the bane of civilization, the true cause of inflation and the true cause of most wars, and that bankers were the true war profiteers and the most influential warmongers.



Few people see war in this light. I am not aware of any college course entitled, Economics of War, 101. For a real education, everyone should read General Smedley Butler's War Is a Racket. This book should be the main college t e x t b o o k ,

demonstrating how wars are arranged by international financiers and fought for the specific purpose of making profits for international corporations.

But you will never see such a course offered in any university curriculum. Since many of these "institutions of higher learning" depend on corporate handouts (i.e., "philanthropy") and state funds, both of which are controlled by Jewish agents, the funding of these institutions would quickly be cut off if they ever taught the truth about the financing of war. Academia rigorously pursues the theme that wars are fought over conflicting ideologies or over clashing religions, while the economic facts of warfare are systematically minimized or excluded.

In this way, college students are given "facts" while they remain ignorant of true history!

Most people believe that wars are fought over conflicting ideologies. I would point out that an ideology never financed a war. Bankers finance wars.

In particular, the Rothschild banking family has financed more wars than any other. From this understanding, the forbidden subject of secret societies and clandestine operations drew me ever deeper into the fact that rich and powerful men rule from behind the scenes and that most politicians in the limelight are nothing more than puppets and actors being manipulated by the "hidden hand." I could see very clearly that the main business of modern politics is disguising treason as patriotism. It was a very depressing realization.

A major revelation for me was Joe McCarthy's book, America's Retreat From Victory, which vividly demonstrated the ruthless pursuit of treason for profit undertaken by our so-called leaders. This suppressed book thoroughly documents how Franklin D. Roosevelt, General "Vinegar" Joe Stilwell, and General George C. Marshall sabotaged Chiang Kai-Shek's Free China by diverting resources, including military supplies, to Mao Tse Tung.

The inescapable conclusion of McCarthy's book is that Red China was deliberately created by the Roosevelt Administration. As incredible as this statement sounds, anyone with a brain understands that the real victor of WWII was communism, as Roosevelt and Churchill inexplicably, without any military necessity, and without consulting their respective legislatures, handed whole nations over to Stalin, even though Stalin's army could not function without the Lend-Lease program. Such treachery is mind-boggling. Who would conceive of such treachery? For daring to expose this Zionist treachery, "Tailgunner Joe" is still demonised to this day.

General Patton, realizing that High Treason was at work, exclaimed, "We slaughtered the wrong pig!" Instead of destroying Germany, we should have destroyed the Soviet Union; but powerful men, otherwise known as "capitalists," were working feverishly behind the scenes to ensure that communism would command the world stage. Thus, the so-called "Cold War" was nothing but a facade behind which Treason worked to expend America's resources until

America could be debauched by Zionism. “Word for Word” Genesis Part 28

Chapter 42

1. Now when Yaaqob saw that there was corn in Mitsrayim, Yaaqob said to his sons, "Why do you look at each other?"

2. Said he, "Behold, I have heard that there is corn in Mitsrayim, go down, and buy for us from there; so that we may live, and not die."

3. Yoseph's ten brothers went)down to buy corn in Mitsrayim.

4. But Binyamiyn, Yoseph's brother, was not sent by Yaaqob with his brothers, because perhaps some harm 611 might befall him.

5. The sons of Yisrael came to buy among those that came; because the famine was in the land of Kenaan.

6. Yoseph was the governor over the land, and it was he that sold to all the people of the land. Yoseph's brothers came, and bowed down before him with their faces toward the ground.

7. Yoseph saw his brothers, and he recognized 5234 them, but was unrecognized 5234 by them, and spoke roughly to them; and said to them, "Where have you come from?" And they said, "From the land of K'naan to buy food."

8. Yoseph recognized his brothers, but they did not know 3045 him.

9. And remembered Yoseph the dreams which he dreamed of them, and said to them, "You are spies 7270, and have come to see the nakedness 6172 of the land."

10. And they said to him, "No, my lord, your servants are come to buy 7666 food.

11. We are all one man's sons; we are upright 3651 men; are not your servants spies!"

12. Said he to them, "No, you are come to see the nakedness of the land!"

13. And they said, "Your servants are twelve brothers, the sons of one man in the land of Kenaan; and behold, the youngest is still with our father, and one is no longer."

14. Yoseph said to them, "It is as I said to you, saying, 'You are spies!'"

15. This is the way you shall prove yourselves; by the life of Par'oh you shall not leave here, unless your youngest brother comes here.

16. Send one of you, and let him bring your brother, and you shall be kept in prison 631, so that your words may be proved, whether there be any truth in you; or else by the life of Par'oh you are surely spies!"

17. And he put them all together under guard 4929 for three days.

18. Said Yoseph to them the third day, "Do this, and live; I revere 3373 Elohiym;



19. if you are honest men, let one of your brothers be bound 631 in the house of your prison 4929; and you go, and carry corn for the famine of your household;

20. but bring your youngest brother to me, so shall your words be verified, and you shall not die. And they did so.

21. They said to one another, "Of a certainty 61 we are guilty 818 concerning our brother, in that we saw the anguish of his being 5315, and he implored 2603 us, and we would not listen to him; and that is why this trouble 6869 has come upon us."

22. Reuben answered them, saying, "Did I not speak to you saying, Do not sin against the

child'; and you would not listen? So his blood is required of you."

23. They did not realize that Yoseph understood them; because he spoke to them through an interpreter.

24. And he turned himself away from them and wept; and returned to them again, and communed with them, and took Shimeon from them, and bound 631 him before their eyes.

25. Then Yoseph ordered that their sacks be filled with corn, and to return every man's money into his sack, and to give them provisions for the way home; and this is how he treated them.

26. And they loaded their asses with corn, and left from there.

27. And as one of them opened his sack to give his ass provender 4554 in the inn, he saw his money, for behold, it was in the mouth 6310 of his sack.

28. And he said to his brothers, "My money has been returned; and it was in the mouth of my sack!" And their hearts left 3318 them, and they were afraid 2729, saying one man; to his brother, "What is this that Elohiym has done to us?"

29. And they came to Yaaqob their father in the land of Kenaan, and told him all that had happened to them, saying,

30. The man, the lord of the land, spoke roughly to us, and thought we were spies in the land.

31. And we said to him, 'We are honest men; we are not spies;

32. we are twelve brothers, sons of our father; one is no longer, and the youngest is still with our father in the land of Kenaan.'

33. And the man, the lord of the land, said to us, "This is how I will know that you are honest men; leave one of your brothers here with me, and take food for the famine of your households, and be gone;

34. and bring your youngest brother to me. Then I shall know that you are not spies, but you are honest men; so then I will give you your brother, and you shall do business 5503 in the land."

35. It came to be, as they emptied their sacks, that behold, each man's bundle 6872 of money was in his sack; and when both they and their father saw the bundles of money, they were afraid 3372.

36. Yaaqob their father said to them, "You have bereaved me; Yoseph is no longer, and Shimeon is no longer, and you will take Binyamiyn; all these things are against me!"

37. Reuben spoke to his father, saying, "Put to death my two sons, if I do not bring him back to you. Put him in my care, and I will bring him back to you again."

38. He said, "My son will not go with you; for his brother is dead, and he is left alone. If harm 611 befalls him by the way that you will go, then will you bring down my hoary head 7872 in grief 3015 to Sheolah 7585!"

Chapter 42 Notes

All of 42 is the account of the brothers of Yoseph going to Mitsrayim to purchase grain, as the result of the seven year famine. Yoseph will show that he is the most mature and responsible of all the brothers, and will

eventually be given the blessing of the birthright.

Verses 6-9 - Yoseph's brothers finally bow down before him, as he saw in his dreams.

Verses 10-20 - Yoseph plays a "mind game" with his brothers, in order to get them to bring Binyamiyn to him.

Verses 21,22 - The brothers realize their guilt concerning Yoseph.

Verse 25 - Yoseph secretly puts the brothers' money into their grain sacks, knowing full well the pressure this will put on them, with their brother Shimeon as a "hostage".

Verses 27-35 - When they find the money, in front of Yaaqob, Yaaqob has the expected reaction.

Verse 27 -Yashar (Jasher) 51:48;

Verse 35 - Yashar 52:1


Verses 36-38 - Yaaqob is already grieving, and Reuben does his best to calm him, promising to bring back both Binyamiyn and Shimeon.

Verse 38 - 7585 Sheol(ah) is the land of the dead, and its inhabitants.

The Bible, Race And Culture - Part 6

PS A L M 147,19-20 "He hath showed His word unto JACOB, and His statutes unto ISRAEL, HE HATH NOT DEALT SO WITH ANY NATION, and as for

his judgements, they [the other nations] have not known them". This verse is both limiting and specific and relates exclusively to Israel as a

race. Churches in our land that believe this are very few. The "word" here is "dabar", or the spoken word in the sense of a specific direction, charge, instruction or covenant. "Statutes" here is "choq" and Judgements is again "mishpat", as pointed out in the Deut. 4:7 reference above.

This is a very clear statement, and note this spoken word is NOT given to other races! This is not a popular concept or popular teaching, but it is confirmed in both Testaments. Acts 10:36 says, "The Word which God sent to the Children of Israel" so we can see that the Apostle Paul

agrees about this. But if God declares "He hath not dealt so with any nation" we dare not question this, even if denominations ignore it. Israel is unique! The judgements are "mishpat"—or God's verdict or decree.

THE WHOLE BIBLE IS ABOUT ISRAEL AND ISRAELITES.

Non-Israel races are mentioned in the Bible two ways, firstly as they impinge upon Israel and secondly in connection to world empires. It is not difficult to conclude that the Bible is a book primarily about God's purposes for Israel [as a people] because Jehovah is consistently declared to be the God of this one people. Because we do not find this expression of purpose for other races, we cannot presume anything that is not said about them.

Then we find expressions like, Israel's God, the Light of, the Rock of, the Redeemer of, the Stone of, the Shepherd of, the Portion of, the God of; all of which refer expressly to Israel. In the KJV we find the words: "of Israel" occur 1,692 times!

"to Israel" occur 23 times! "for Israel" occur 24 times!

Then there are expressions like the "The God of your fathers" and "fathers of Israel" ["fathers" is mentioned 549 times including 56 through the New Testament], so there is no doubt about the sole race concerned because "pater" is a genetic term in context.

There is the intimate word "Jeshurun" for Israel. There are at least 5,000 direct references isolating Israel as a people. This personal God OF ISRAEL, Jehovah, ["Yehovah"] is mentioned 6,528 times by this name and 21 times as "Yahh".

From here on in this paper, we will look very briefly at a number of topics that connect in a doctrinal way with what has been pointed out thus far. Each paragraph below is a portion, or summary, of chapters from the author's book, "The Exclusiveness of Israel".

WHO ARE GATHERED TO GOD IN THE END?



Jer 50:6 says, "My people hath been lost sheep". It was the "sheep" that Jesus says He came to give His life for-[John 10:15]. Jesus said, "I lay down my life for the sheep". He goes on to say these sheep are from both the Judean and the Dispersion folds. Sheep are born sheep. Goats are conceived as goats according to God's Law "after their kind".

Tares come from tare seed. The tares are to be burned and the goats are to be separated. They cannot ever change how they were created. Paraphrasing Paul's contention, "Who are we to argue with God as to how the potter makes any vessel"-[Rom.9:21]. The "election" is made before "having done good or evil"-[Rom.9:11]. Election is not because of God's fore-knowledge of what a person was going to do in the future;

this is what many try to say to get around Scripture.

The 'gathering', or the 're-gathering' as it is often called is always presented in the Bible as being that of Israel. Jesus mourned over Jerusalem - [Matt. 23:37] and His people whom He came to save—not over any non-Israel race. Jesus gathers only His Elect nation-[Matt. 24:29]. Jesus gathers "together in one the children of God that are scattered abroad"-[John 11:49-52].

Note that they are "God's children" before they are gathered. In Ezekiel 37 the Dry Bones are stated to be those of both Houses making up the whole of Israel, and in the parable of the two sticks, that which is joined together are Ephraim and Judah. Right through the prophets, the story is the same; none but Israelites are gathered and the two parties remain Ephraim and Judah, that is, all Israel.

WHO WILL JESUS ULTIMATELY RULE OVER?

Matthew 2:6 "Out of thee shalt come a Governor, that shall rule my people ISRAEL.



Luke 1:32-33 "And the Lord God shall give unto Him the throne of His father David, and He shall reign over **THE HOUSE OF JACOB** for ever".

Here we are told the ultimate rule is stated to be over Israel. No one can make the "House of Jacob" or "Israel" mean all races. Denominations do not like these restrictions, and so ignore them.

Acts 1:6 "Lord, will you at this time restore again the Kingdom TO ISRAEL"? Jesus agrees about the Kingdom being over Israel, but does not disclose the time factors.

WHO IS BEING ADDRESSED IN THE BOOK OF ACTS?

The genetic fathers of Israel are mentioned in at least 20 verses through the book of Acts. These are the genetic/racial 'fathers' of those being addressed. God as being the "God of OUR fathers" and "the God of Jacob" is mentioned five times in the Book of Acts. In addition, consider the additional racially specific verses:

Acts 2:22 "Ye men of Israel, hear these words"

Acts 2:36 "Let all the House of Israel know assuredly...."

Acts 3:12 "Ye men of Israel why marvel ye at this..."

Acts 3:22-24 "For Moses truly said unto the fathers, a prophet shall the Lord God raise up unto you, of your brethren, like unto me"

The limitation to Israel is specific. "Unto you" and "the fathers" confirms the limitation to the Israelites being addressed. That denominations like to extend this to include all races does not make it valid. Note that this is post-Pentecost, and in this church age; so it is not in this age that anything changed, even if most say it did according to popular teachings. The "fathers" and "your brethren" are again racially selective and are definitive.

Acts 3:25 "Ye are the children of the prophets—and of the covenant which God made with our fathers."

This is a **RACIAL** statement! It concerns only one race. Scripture is not supposed to be racist according to popular doctrine, is it? So when could this covenant to "our fathers" have changed after the Book of Acts?

Acts 10:36 "The word which God sent unto the Children of Israel..."

This confirms the Old Testament in Psalm 147:19 where we read, "He sheweth His word unto Jacob, and His statutes unto Israel. He hath not dealt so with any nation..." Note the clear "not" in this verse. This also is racist, but it is Biblical!

Acts 13:17 "The God of this people Israel chose our fathers".

There are a multitude of Old Testament scriptures confirming this racial selection. We cannot ignore the relationship between Israel, "our fathers" and the people being addressed. They are the same race!

Acts 13:23-24 "According to His promise raised up UNTO ISRAEL, a Saviour, Jesus..." "To give repentance to all the people **OF ISRAEL**".

This verse is one of many that say Jesus was raised up unto Israel. The original promise was made to Israel only. There are no statements at all extending this beyond "all men" of Israel in context. Again this is racial in purpose.

Acts 13:26 "Men and brethren, of the stock of Abraham—is this word of salvation sent..."

We do not find any stream of references about the word of salvation being sent to any but Israel. This is yet another racial statement; we cannot change the meaning of "stock" and its 'kin' connection.

Acts 13: 32 "And we declare unto you the glad tidings, how that the promise which was made unto the fathers, God has fulfilled the same unto us their children....".

This is a straight genetic statement. The prophetic promise was made only to Israel. Who can really continue to pretend that Paul was speaking to non-Israelites [so-called Gentiles]. Paul goes on to tell about justification through Jesus "by which ye could not be justified by the Law of Moses", showing that he was speaking only to Israelites.

Acts 28:20 "For the hope OF ISRAEL I am bound with this chain."

Paul does not say it is the hope of all races. Note that nothing has changed at the end of the Book of Acts.

THE CHOICE is between:

[a]. The Bible which does not ever state explicitly that God is other than:—

- the "God of Israel" [203 times].
- the "God of Abraham" [17 times].
- the "God of Jacob" [20 times].

- the "God of our fathers" [7 times and still used at the end of the Book of Acts, chapter 22:14].

[b] The universalist doctrine of the "fatherhood of God" or "the brotherhood of man" where God is supposed to be the God of every race. "God" here is not Jehovah, the God of Israel. This is commonly believed even if there are no direct statements.



This is the belief of the Roman Catholic Church, the United Nations, most cults and other anti-Christ organisations, so this point is worth weighing up. The belief of most Christians comes from the misuse of "all", "every", "whosoever" and such words which we will look at shortly.

ASK THE BIG QUESTIONS

Which option is right?

[b] If the first option changed, when was this? [We will look at Acts 28:28 and Dispensational Theory].

Where are all the references to God being the God of all the other races?

Where are all the specific direct references to God being the "Saviour" of other races?

[c] Where are all the statements about Jesus being the Redeemer of other than the "all men" and "whosoever" of Israel, according to each context?

Those who want to declare that there has been a change have to be able to deny the unity of the scriptures which Jesus says cannot be broken. The prophets did not prophesy of any change, so there is no change in what was prophesied.

There are many scriptures that state that those to be saved were already Jesus' people before He came, but who were in an unsaved state.

Look at the scriptures below and consider if people become God's people after they are saved or if they are God's people already before they are saved and redeemed. In reading these verses, see that what is being talked about is the

fulfilment of Old Testament prophecy. Then ask again, "did this ever change, and if so exactly when"? The emphasised words below will help identify the subject people specifically in each verse.

5 THE BABYLONIAN EMPIRE CONQUERED

THE BABYLONIA EMPIRE was conquered by the Medes and the Persians and Cyrus or Khurosh of the Manda issues a proclamation stating that the Lord God of heaven had charged him to rebuild the temple in Jerusalem (2 Chron 36:22-25 and Ezra 1:1-2), In B.C. 557, under Zerubbabel, a prince of Judah, more than 400000 of the tribe of Judah and Benjamin left Babylonia to return to promised land. They were accompanied by a high Persian official to ensure that the instructions of one of the Persian kings were carried out.

It is thought that Cyrus may have been of Israel descent since he came from one of the areas to which the Israelites had been dispersed by the Assyrians (Ghiralman, “Iran” chapter 3, page 132). Ezra in chapter 2, verse 64 states that the number returning was 42,360, as well as maids and servants.

The Davidites, the legitimist party, felt that the time was ripe for placing on the throne of the new kingdom a descendent of king David, perhaps Zerubbabel and they began to intrigue, The high Persian official in charge of the country stopped the work on the temple.

An embassy was sent to the new king Darius asking that the edict of Cyrus be carried out. Darius took severe measures against the Davidites but at the same time ordered the edict

of Cyrus to be carried out. He also installed a high priest of the order of Aaron in a hereditary office thus creating a theocratic state (Ghiralman, “Iran” chapter 5 page 141). The work of restoring the temple was completed in B.C. 515.

Continuing the policy of Darius and Cyrus Artaxerxes gave Ezra permission to return to Jerusalem with 1,500 families of Judah, but they quarreled with their co-religionists who had never left Palestine, and the king sent his cup bearer and confidential adviser Nehemiah to settle the differences.

Ezra was the great founder of Judaism. He gave the community a code of laws and had proposed to the ten tribes living to the North West that they join in setting up the new Israel State the plans of which are found in Chapters 40, to 48 of Ezekiel. The ten tribes however did not seem to want to co-operate and began moving out of the areas in which they had been settled by the Assyrians after the conquest of Babylon by the Medes and Persians (2 Esdras 13:40).

They entered the Euphrates by the narrow passages of the river and journeyed to Arsareth a tributary of the Danube. Evidence of this move is to be seen on graves and monuments they left in the Crimea. A Hebrew-Phoenician inscription on the tombstone reads “This is the tombstone of Buki, the son of Itchak the priest may his rest be in Eden, at the time of the salvation of Israel. In the year 702 of our Exile. This tombstone would have been placed there in

15 B.C. Josephus, the Judahite Historian states that they were in great numbers beyond the Euphrates and outside the confines of the Roman Empire, (Antiquities of the Jews Book XI, Chapter V, Sections 2 3).

6 THE NAME JEW

The name Jew is first used in 2. Kings 16:6 to apply to the residents of Elath to distinguish them from the Israelites who were with their leader Pekah and Resin, king of Syria had attacked Jerusalem.

The term now can only be applied to those members of the tribes of Judah and Benjamin who returned from the captivity in Babylon to the Holy land. With those who returned were the princes of the Royal Blood of David who only married within their own family and kept their genealogical tree with great care (The Davidites); and the descendants of Zadock, the high priest of the line of Aaron (The Sadducees) (Ezra 1:8 and 2:36)

Jerusalem had always been a city with a mixed population,(Ezekiel 16:3) "Thus saith the Lord unto Jerusalem ; thy birth; and thy nativity is of the land of Canaan, thy father was an Amorite and thy mother was an Hittite."


In the fourth century B.C. the Persian Empire was conquered and destroyed by Alexander of Macedon and Greek influence and culture spread. The Sadducees were cultured men of letters and accepted the new philosophy: the Pharisees and the scribes were responsible for copying out the law and the prophets and this they did to the letter and thus became the interpreters of the law. They had brought with them from Babylon a Babylonian book, The Talmud and this book became more and more important as a key for interpreting the scriptures.

7 THE DEATH OF ALEXANDER THE GREAT

On the death of Alexander of Macedon the Macedonian empire broke into pieces, each section being governed by one of Alexander's

Satrap (governors) who became hereditary rulers. The Jewish nation was in the sphere of influence of the Syrian King Antiochus Epiphanes. Antiochus wished to have complete control and attempted to subvert the Jewish religion. He sacrificed a cow on the altar of the Temple and ordered the High Priest Mattathias, to offer a sacrifice on a heathen altar to the Gods of the Syrians.

This he refused to do and killed the priest in his place. Mattathias with his sons fled into the desert and there formed the "Mi Kamoka Be Elim", Jehovah (Who is like unto thee Jehovah) the Maccabees.



Mattathias was the great grandson of the High Priest Hashmon (Asmonaeus) and so the family were also called the Asmoneans. (Antiquities of The Jews, Book VII, Chap IV, and V.) All the Asmonean brothers died in

battle, but John Hyrcanos, the son of the younger brother Jonathan became the leader of the Maccabees.

John Hyrcanos halted further Syrian aggression and defeated the Samaritans, but he sowed the seeds of the final ruin of his nation by the compulsory incorporation into Jewry of the arch enemies of Israel, the descendents of Esau, in B.C. 116. During his leadership there was constant friction between his own high priestly circle, the Sadducees and the traditionalists the Pharisees.

The Sadducees were the intellectual elite of the Jews; they had adopted the new Hellenic philosophies and wished for the, secularisation of the state. They denied the immortality of the soul and the dependence of the soul of man on the will of God and they denied the future coming of the Messiah.

The Pharisees on the other hand were the traditionalist party and more inclined to follow the influence of the Persians. They had collected

the sacred books of the law and the prophets and were responsible for making copies which they did with exactitude leaving out neither yot nor tittle. They studied the law and the prophets and were responsible for its interpretation.

They had brought back with them another book the Babylonian Talmud and this, with oral tradition soon gained superiority over the ancient writings as affording a key as to how they were to be read and understood.

Aristobulus, the son of John Hyrcanos elevated himself to the kingship of the Jews. He killed his mother and a brother and he himself died a painful death. He was followed in the kingly office by his brother Alexander Jannaeus an unprincipled monster. Jannaeus, like his father was a Sadducee and a modernist. He enraged the people when, acting as High Priest he poured the water of the holy oblation on the ground instead of on the altar and was pelted with oranges and soft fruit by the assembled congregation.

In his anger, Jannaeus called in his mercenary troops and six thousand worshippers were sabred to death. He also crucified eight hundred Pharisees who had fled for protection to the fortress of Bethorne. On his death he was succeeded by his queen, Salome Alexander in B.C. 79. When she died the kingdom was disturbed by the quarrelling of her two sons Hyrcanos and Aristobulus.


Aristobulus was supported by the priestly aristocracy but the common people supported Hyrcanos. They did not wish to see the High Priesthood and the Office of King combined in one person. Civil War broke out.

8 THE ROMAN EMPIRE

In B.C. 66 The General of the Roman Republic, Gnaeus Pompious, had conquered the Pontic King in Asia. In 65 B.C. Pompey's lieutenant, Scaurus came to Damascus and both Jewish parties tried to buy his support. In 63 B.C. Pompey himself came to Jerusalem and their representatives of the Jewish people begged him to abolish the Hashmonean kingship and establish the rule under a High Priest. The Hashmonean Kingdom was abolished and Aristobulus was taken to Rome and Hyrcanos was left as High Priest and ruler.

9 HEROD - EDMITE - PROCLAIMED KING OF THE JEWS

Ever since John Hyrcanos had forced the Idumeans to accept Judaism at the point of the sword these people had infiltrated themselves into every sector of Jewish life. They were loyal to their own interests and intent on destroying and subduing the House of Jacob. Antipater, a duke of Edom raised himself to be a power behind the throne by clever intrigue. He had married Cypros a member of an influential Jewish family.



The influence of the Idumeans now became supreme in the Jewish State. There was still a strong following among the Jews for Aristobulus, and Antipater gave full support to the Romans and leant on them. He supported Hyrcanos, the High Priest, who also had Roman support. For support rendered, Caesar recognized Antipater as ruler of Palestine, his two sons Phasael and Herod (Above) were given commands. Herod was given Galilee where he met resistance.

The Zealots led by a guerrilla leader Hezekiah caused him some trouble. Herod exterminated the followers of Hezekiah and killed this Leader with his own hand. This caused him to be hated by the Jewish people, and they sent an embassy to Mark Anthony entreating that the House of Antipater be deprived of its power. This was of no avail and Mark Anthony made the brothers Phasael and Herod tetrarchs.

Herod was proclaimed King of the Jews by the Roman Senate, but Herod was very unsure of his throne and terrified of further insurrections, the old priestly caste still clung to the House of Hashmon. In an attempt to gain support among the Jews, Herod took as one of his wives Mariamne, a princess of the House of Hashmon. He then assumed the right to appoint the High Priesthood.

Mariamne influenced him to appoint their younger son Aristobulus as High Priest. The delight and clamour of the Jewish Population at

this act unnerved Herod and he had Aristobulus drowned. Herod now appointed a new high priest from the Egyptian House of Boethus. This line was of Legitimate Aaronic stock but from that time onward the high priest became the creature of Herod and held office during his pleasure.

For services rendered Octavius when he became Caesar Augustus confirmed Herod in his appointment and increased his territories to include the whole Palestinian coast.

Herod became a supporter of the philosophies of the Hellenes and of the Roman power. He built pagan temples and new Greek style cities and advocated emperor worship; but he was careful to ensure that the law should not be offended in the Jewish territories and set about rebuilding the temple, Herod put to death all members of the House of Hashmon until there were none left except Mariamne and his two sons and some distant Cousins the sons of Barbas.



Antipater, Herod's son (Above) by another woman began an intrigue against Mariamne accusing her of being a traitor, Herod had her murdered together with her other son. He then slaughtered the sons of Barbas. Herod was very fond of Mariamne and when he found that Antipater was responsible for lying rumours Herod had him put to death as well. The only people now left with Hashmonian blood were the grandchildren of Mariamne. Herod who became Agrippa 1 (The Herod of Acts 12) and the notorious Herodias.

10 THE ROYAL LINE OF DAVID PROTECTED

Throughout all these years the Royal House of David was protected in poverty and obscurity. It was an offence to mention the title "Son of David" such was a title given only to the true Royal House.

When the wise elders came from the Israelite communities living in the East in Elam and Media to which they had been taken by the Assyrians, they stopped and made a courtesy call on Herod, the King of the Jews. Herod was alarmed at their news and requested them to return back by the same route and give him further news.

These elders were well versed in the prophecies of Israel and in the divine time system. Herod called for his advisers and was told that the Messiah would be born in Bethlehem Ephrata as was prophesied by the prophet Micah, Chapter five, verse two. Herod now realized that here was a greater threat to his throne than any that had gone before.

Here was a royal prince of the House of David, of the tribe of Judah and the line of Jacob who had stolen the birthright and the blessing from his ancestor Esau. Should this royal prince live he would be acclaimed as King by the whole Jewish community.

The Davidites had metriculously kept the hereditary register of the House of David and these members of the royal family never married outside the family. Herod was determined to act. He sent soldiers to Bethlehem to kill all male children of two years and under in the area about the town. But Joseph had been warned to take the Lord Christ away to Egypt, Herod died in the same year, B.C. 4.

On the death of Herod his kingdom was divided between his three sons. The Jewish people sent an embassy to Augustus seeking to be delivered from the House of the Idumean Herods to no avail. Augustus decreed that one son, Archelaus should rule Judaea, amaria and Idumea with the title of Ethnarch; Antipas should rule Galilee and Peraea with the title of Tetrarch and Phillip, also with the title of Tetrarch should rule the districts of Batanaea, Trachonitis and Hauran.

There was continual disorder in Palestine, numerous persons came forward claiming to be

the legitimate rulers of the Jews. The people were hostile to the Herodians and wished to have an internal self governing community under the imperial legate of Syria. In A.D. 6 Quirinius, the Legate of Syria, appointed Annas as High Priest. This man Annas was enabled to ensure that members of his family held the high priesthood, and in A.D. 18 an Idumean, Joseph Ben ha-Quy-yafa (Caiphas) who had married the daughter of Annas, was made high priest.

Herod Antipas, the son of Herod the Great, governed Galilee and Peraea from his strong hold of Masada. He had married Herodias a daughter of Aristobulus the son of Mariamne murdered by Herod the Great, but Herodias was the wife of Herod the son of Herod the Great by another Mariamne, daughter of the high priest of the Egyptian House of Boethus. Herod Antipas had enticed Herodias away from her husband and she had brought her daughter Salome with her. John the Baptist earned her enmity for condemning this act for which he was murdered. Our Lord referred to Herod as that fox; (Luke 13 : 32), "Go ye and tell that fox, behold I cast out devils and I do cures today and tomorrow and the third day I shall be perfected. Nevertheless I must walk today and tomorrow, and the day following, for it cannot be that a prophet perish out of Jerusalem. O Jerusalem, Jerusalem, which killest the prophets and stonest them that are sent unto thee: how often would I have gathered thy children together, as a hen doth gather her brood under her wings, and ye would: behold your house is left unto you desolate and verily I say unto you, ye shall not see me until the time come when ye shall say blessed is he, that cometh in the name of the Lord." (Luke 13 :32-35).

Jesus told the scribes and the Pharisees, "If ye continue as my disciples ye shall know the truth and the truth shall make you free." They answered, "We be Abraham's seed and were never in bondage to any man." The Israelites had been slaves in Egypt and had been taken into captivity in Babylon. The Idumeans, the descendents of Esau had never been in bondage Jesus said to them, "I know that ye are

Abraham's seed (the Idumeans were also descended from Abraham through Esau) but ye seek to kill me because my word hath no place in you." "I speak what I have seen with my father and ye do which ye have seen with your father". They answered "Abraham is our father". Jesus said "If ye were Abraham's seed (spiritual) ye would do the works of Abraham, but now ye seek to kill me, a man that hath told you the truth, which I have heard of God.

This did not Abraham, ye do the deeds of your father (Esau, who sought to kill Israel Jacob). Then they said to him "We be not born of fornication; we have one Father, even God." Jesus replied, "If God were your father, ye would love me a for I proceeded forth and came from God; neither came I of myself, but He sent me." "Ye are of your father the devil, and the lusts of your father ye will do, he was a murderer from the beginning and abode not in truth because there is no truth in him. When he speaketh a lie, he speaketh of his own, for he is a liar, and the father of it. Your father Abraham rejoiced to see my day: and he saw it and was glad. "Before Abraham was I AM." and they attempted to stone him.

The experts have started the largest geophysics survey to date on Rousay, a hilly island off Orkney mainland.




Rousay Island Orkney

Scythians. The LXX Contains Some Apparent References To The Scythians.



Sir—, From an extract in the Bible Dictionary, it states:—

In 2 Macc. Antiochus IV. Epiphanes is charged with such injustice as would not be found in a Scythian court and in 3 Macc. the servants of Ptolemy IV. Philopator are accused of cruelties after the fashion of Scythians. The city of BETH-SHEAN is called Scythopolis in Judges. 12: 7; Judith 3:10; 2 Macc. 12: 29; I Symmachus translated (Elam) in Gen. 14:19, Moreover

'Scythian' is mentioned with barbarian in TR of Col. 3:11.

It is not certain that in any of these instances the reference is to the historic Scythians.

Jason of Cyrene in the days of Cesar, and the author of 3 Macc. at the time of Caligula, may indeed have had in mind such descriptions as those in Herod or some proverbial sayings based on them.

It is also possible, however; that they used the term Scythians only as a synonym for 'barbarians.' According to Georgios Syncellus the origin of the name Scythopolis, also known to Josephus, Eusebius, and others, was the presence in that city of a body of Scythians remaining from the invasion in the time of Psammetichus. The name, however, does not occur on an inscription before 218 BC. Pliny states that Scythopolis formerly had the name of Nysa.

Whilst it is not in itself improbable that some Scythians in 625 BC remained as an enclave in Beth-Shean and played as important a part there as the exiles from Cutha seem to have done in Samaria. It is also possible that the name is due to the settlement of some people deported by Assurbanipal, such as the Parthian Dahae (Ezra 4: 9), where Hoffmann's conjecture is more ingenious than convincing. Symmachus may have used Scythian for Parthian.

In Col. 3: 11, the text is clearly not in order. It probably read originally 'Jew and Gentile', circumcision and un-circumcision, Greek and barbarian. 'Scythian' seems to be a gloss to 'barbarian.'

It is exceedingly probable that in MT the Scythians are referred to as Ashkenazi in Gen. 10:3; Ch. 1: 6 Jer. 51:27.

The question of the origin and meaning of the name Ashkenazi and the related names needs to be re-examined in connection with the Jerahmeelite theory.' See Crit. Bib. on Gen. 10 2-4.

Explanation only in the political relations between Scythians and Assyrians. The editor of Jer. 1-20 (see Jeremiah [book], had an important landmark to go by. and rightly put the beginning

of his prophet's ministry in the memorable thirteenth year of Josiah.

Winckler assumes that the defence of Nineveh by Madyas occurred at the time when the city was finally destroyed, and that the Scythians. He correctly observes that a parenthesis begins after the statement of the appearance of Madyas, and concludes that only the beginning of Herodotus' account and the end of it were drawn from an older source, the remainder being the historian's own work



But the parenthesis only tells how the Scythians happened to be in Asia, and the narrative manifestly continues with--- 'Then the Medes fought with the Scythians' in the end. The rest presents only one difficulty, which, however, may be satisfactorily met. If the twenty-eight years of Scythian rule fell within Cyaxares reign (625-585), as distinctly affirms, they must have extended from 625 to 597: yet the capture of Nineveh in 606 is mentioned after the recovery of the nations ruled before 625.

But the restoration of Media's former territory is not unnaturally mentioned first, even though it had not been fully accomplished before 597. and the important addition of Assyria only afterwards with emphasis, though occurring already in 606.

There is no evidence that Scythia lost anything but an ally by the fall of Assyria. If the king of the Umman Manda in the Nabuna'id inscription is Cyaxares, there is no hint in that document of a Scythian army appearing for the defence of Nineveh in 606. Had the Scythian power in Asia Minor been crushed in that year, it is not likely that hostilities between Media and Lydia would have been so long deferred. In 597 the two allies.

Media and Chaldea, seem to have made a great attack upon Media destroying the Scythian power in Armenia and Cappadocia. Chaldea

Not many people know that there are no poisonous seaweeds. I collect what to others might seem inedible seaweeds, but treated correctly they make good additions to meals. I dry them so that they crumble in my hands if I squeeze them. I then add them to stews or food I cook in a slow cooker.

A real advantage in using seaweed is that all the micro nutrients often depleted from our soils end up in the sea and are absorbed by the seaweeds—far cheaper than mineral supplements and our bodies have evolved to use them if presented in this way. Perhaps now I have aroused your interest so read on.

In the UK, the media is controlled by people that you are unaware of. About the only wildlife safe from the proposed upgrade from 3 and 4G mobile 'phone transmissions to 5G is sea life.

Australia and the Dutch have discussed the dangers of 5G in their parliaments. Our parliament cannot because they are effectively controlled. Anti-Semitism Is a Cover for



Censorship

Sir ___, Whether against the Yellow Vests, or US congressmen or UK politicians, the accusation is meant to stop thought.

Let's get this straight. Anti-Zionism is not anti-Semitism, or anti-Jewishness. But the deliberate confusion of the terms allows the Israeli state and its supporters to carry out huge crimes with impunity.

The cynical confusion is also being used as a smear to undermine critical politicians and protest groups in Western states.

We have seen a rash of this false ambiguity recently with the labelling of the Yellow Vest protest movement in France as "anti-Semitic" as well as the same smear being levelled at British Labour party leader Jeremy Corbyn and US congresswoman Ilhan Omar.

Omar, a newly elected Democrat member of the House of Representatives, got into hot water after she criticized Israeli lobby groups and their outsized political donations for having an undue detrimental influence on US foreign policy in the Middle East.

The congresswoman was castigated by President Donald Trump for her "anti-Semitic hate speech" as well as by her own party leader in the House of Representatives, Nanci Pelosi.

But what Omar said was a simple incontestable truth; a factual statement that Israeli financial blandishments have ended up buying American government bias in propping up Israeli state interests over the rights of Palestinians.

Trump is a prime example of the questionable transaction. During his 2016 presidential bid, Trump received millions of dollars in political donations from Sheldon Adelson, an American-Israeli property magnate who is fervently pro-Israel. Trump's policies since becoming president clearly demonstrate an Israeli bias in White House policy, in particular his controversial declaration of Jerusalem as the capital of the state, thus preempting a historic negotiated settlement with Palestinians.

The Israeli state continues to bulldoze Palestinian homes in illegally occupied territories and to use excessive lethal force against unarmed Palestinian protesters. Since last year, the UN estimates that nearly 200 Palestinians, including children, have been shot dead by Israeli soldiers and snipers while attending demonstrations against the cruel Israeli siege on Gaza.

US and European governments routinely keep silent on these grave crimes perpetrated by the Israeli state. A major factor is the powerful and well-financed Israeli lobby in America and the European Union.

Anti-Zionism is a specific term for political opposition to violations committed by the Israeli state against historic rights of indigenous Palestinian peoples who have seen their ancestral lands gradually annexed since the Israeli state was founded in 1948.

To stand against these systematic crimes is not anti-Semitic. Indeed, many honourable Jewish people around the world are among the most vehement critics of Israeli state crimes. Writers and activists such as Norman Finkelstein and Ralph Schoenman.

Britain's Labour leader Jeremy Corbyn has a long personal history of advocating for Palestinian rights. He describes himself as being "anti-Zionist", that is, opposed to the relentless illegal annexation of Palestinian lands for the self-declared purpose of building a religious Jewish state.

This week a group of Labour MPs resigned from the party to set up a new independent group in the British parliament. The group of seven MPs claim that the Labour party under Corbyn is institutionally "anti-semitic".

That is a unwarranted smear on their former leader and the rest of the party. It seems significant that the breakaway splinter group is refusing to reveal where its funding is coming from. The Israeli lobby?

Likewise in France, the Yellow Vest protest movement is this week being slated "anti-semitic". This follows an upsurge in vandalism on Jewish cemeteries, where dozens of graves have been daubed with Nazi swastikas. Such attacks in France have been on the rise long before the Yellow Vest movement against French government economic policies began in November. Coincidentally, however, there was an incident last weekend when a prominent French philosopher Alain Finkelkraut was verbally accosted on a Parisienne street by some Yellow Vest members.

Video footage showed Finkelkraut's assailants calling him a "dirty Zionist" and mocking him to go back to Israel. They did not refer to his Jewish heritage, yet several media reports implicated the Yellow Vest movement as being "anti-semitic".

It is a fact that Finkelkraut in his writings and public comments is an ardent supporter of the Israeli state. Arguably, anyone who presents themselves in public as an apologist for this state and its criminal policies is therefore liable for public opprobrium by those who call themselves anti-Zionists.

The deliberate and dubious conflation of "anti-Zionism" with being "anti-Jewish" and thereby by extension being a sympathizer of the Nazi holocaust is a cynical attempt at covering up the horrific crimes committed by the Israeli state. It is an abject form of censorship against truth-telling on behalf of Palestinian rights, so that we are browbeaten into accepting crimes against humanity by the Israeli state and its American military sponsorship.

Worse than this, it is not just about intimidating people into silence in the face of iniquitous oppression in the Middle East. The anti-Zionist/anti-semitic fraud is also being used to smear and undermine any potential political opposition within Western states. **Yours truly, K H, West Midlands, UK.**

Second Case of Leprosy Reported in Ireland



A second case of leprosy has been confirmed in Ireland in the Dublin North East region.

The case was notified to the Health Protection Surveillance Centre (HPSC) by the HSE NE in June.

According to the HSE, no cases were officially reported in Ireland between 1981 and 2012 when leprosy was on the list of notifiable diseases .

The first case of leprosy was notified to the HSE in January and involved a Brazilian man in his 30's who attended a GP clinic in Co Meath. He

contracted the disease in his home country a decade earlier.

Both cases involved a recurrence of leprosy. Neither was contracted in Ireland.

Leprosy is a curable chronic infectious disease. When left untreated, it can cause permanent damage to the skin nerves limbs and eyes, however disability can be avoided when treatment is provided during early stages of the disease. It is transmitted via droplets, from the nose and mouth, during close and frequent contacts with untreated cases.

The incubation period of the disease is about five years and symptoms can take up to 20 years to appear after the initial infection because the bacteria multiply very slowly. Despite its reputation, leprosy is not highly infectious and is curable. **Yours truly D. J., UK**


Forasmuch as the King hath seen that divers Evils, and the disinheriting of the good Men of his Land have happened by the Usuries which the Jews have made in Time past, and that divers sins have followed thereupon; albeit he and his Ancestors have received much benefit from the Jewish People in all Time past; nevertheless for the Honour of God and the common benefit of the People, the King hath ordained and established, That from henceforth no Jew shall lend any Thing at Usury, either upon Land, or upon Rent, or upon other Thing:

And that no Usuries shall run in Time coming from the Feast of Saint Edward last past.

Notwithstanding, the Covenants before made shall be observed, saving that the Usuries shall cease. But all those who owe Debts to Jews upon Pledges of Moveables, shall acquit them between this and Easter; if not they shall be forfeited.

And if any Jew shall lend at Usury contrary to this Ordinance, the King will not lend his Aid, neither by himself nor his Officers, for the recovery of his Loan; but will punish him at his discretion for the Offence, and will do justice to the Christian that he may obtain his Pledge again. TODAY, EVERYBODY KNOWS somebody who was healthy, got vaccinated and was never healthy again. The people whose lives are being impacted by business deals between governments, Big Pharma and Big Philanthropy increasingly are being marginalized in the top-down public policymaking process by wealthy and powerful institutions in society financing the global multibillion-dollar vaccine industry.

This is evident when the people raise their voices to ask for better vaccine science and more humane public health policies and are demonised, discriminated against and punished by those in control of those wealthy and powerful institutions.

The World Health Organization (WHO) has ranked “vaccine hesitancy” as one of the top 10 Threats to Global Health in 2019

A joint investigation by the British Medical Journal and the Bureau of Investigative Journalism revealed that three key scientists who influenced WHO’s decision to declare a swine flu influenza pandemic in 2009 and recommend all countries use and stockpile vaccines and pandemic flu drugs had financial ties to pharmaceutical companies profiting from the WHO recommendations.

The Gates Foundation has donated more than \$3 billion to Gavi. Between 2000 and 2013, only 10 percent of total funding provided by Gavi was used to strengthen health systems in developing countries, while nearly 80 percent was used to purchase, deliver and promote vaccines.

The National Institutes of Health and other U.S. federal health agencies give millions of dollars in taxpayer dollars to academic institutions and vaccine manufacturers to improve vaccine technology, find new lucrative vaccine markets and boost vaccine marketability. The U.S. government also partners with the Gates Foundation to develop and promote vaccine use By Barbara Loe Fisher

The World Health Organization (WHO) issued a report on January 16, 2019 ranking “vaccine hesitancy” as one of the top “10 Threats to Global Health in 2019,” alongside air pollution and climate change, non communicable diseases, global influenza pandemic, anti-microbial resistance and infectious diseases such as ebola, dengue fever and HIV.

Throughout history, the greatest contributors to disease and early death in human populations have been poverty, poor sanitation and poor nutrition,^{2,3,4} but infectious diseases with pharmaceutical solutions dominated this list.

And, there was no mention of the major opioid addiction crisis crippling and killing tens of thousands of people in the U.S. and Europe,^{5,6} or the iatrogenic medical error epidemic that every year claims more than

750,000 lives in Europe and 250,000 lives in the U.S., where it is the third leading cause of death.

The immediate mainstream media response to the WHO's announcement was to focus on "vaccine hesitancy," with The Editorial Board of The New York Times declaring January 19 that "anti-vaxxers" are "the enemy" and calling on the U.S. government to "get tough" by waging a "bold and aggressive" pro-vaccine campaign that includes "tightening restrictions around how much leeway states can grant families that want to skip essential vaccines."



By January 23, The Hill announced Washington state had declared a state of emergency because of 23 cases of measles reported in an "anti-vaccination community" near Portland, Oregon,¹⁰ and there was a public call in the UK for social media platforms to "clamp down on fake news" and censor "misleading information and negative messaging around vaccination."

The New York Times' editorial headline, "How to Inoculate Against Anti-Vaxxers," was a theme repeated in articles reacting to the WHO's suggestion that people wanting to make informed, voluntary decisions about vaccination are a global menace. One doctor suggested that parents who don't vaccinate their children are selfish: "[I]t's a matter of 'I don't care about other people in the community, I only care about the health and welfare of my own child.'"

There was no discussion about institutionally acknowledged gaps in vaccine safety science, or the fact that most parents dutifully follow the advice of paediatricians and public

health officials and only became vaccine safety critics after the risks of vaccination for their children turned out to be 100 percent.

There was no discussion about the fact that since 2011, pharmaceutical companies have no liability for injuries and deaths caused by the vaccines they sell in the U.S. that are government recommended and mandated.

Instead, parents of vaccine injured children and others concerned about vaccine safety, who for decades have been asking government and industry to produce better quality vaccine science and more humane vaccine policies that respect genetic and biological diversity, were stereotyped as "anti-vaxxers" and demonised as a "threat" to public health.

The Editorial Board of The New York Times explained, "It's no mystery how we got here. On the Internet, anti-vaccine propaganda has outpaced pro-vaccine public health information."

Authoritatively, "the Board, its editor and the publisher" of The New York Times stated that, "Scientists, especially, are uncomfortable with black and white statements, because science is all about nuance. But, in the case of vaccines, there are some hard truths that deserve to be trumpeted. Vaccines are not toxic, and they do not cause autism. Full stop."

There was no discussion about why people are legitimately concerned about vaccine ingredients and Pharma paying the Food and Drug Administration (FDA) to fast track new vaccines to licensure without adequate testing.

There was no discussion about the fact that doctors giving children 69 doses of 16 vaccines starting on the day of birth — three times as many vaccinations as they got in 1983²² — cannot explain why so many highly vaccinated children in the U.S. today are sicker, not healthier today: 1 child in 6 is learning disabled and 1 in 40 has autism.

Millions more suffer with asthma, diabetes, severe allergies, epilepsy, cancer, schizophrenia, depression and other chronic disease marked by chronic inflammation in the body.

The CDC states that “90 percent of the \$3.3 trillion in annual health care expenditures are for people with chronic and mental health conditions.”²⁵ The largely unexplained chronic disease and disability epidemic in the U.S. is bankrupting the U.S. health care system and there is no research being funded to investigate the role that ever-increasing numbers of vaccines given to infants, children and adults may be playing.

Multinational pharmaceutical corporations in command of a global \$34 billion vaccine market are holding billion-dollar contracts with mass communication companies and public-private partnerships with governments to purchase vaccines and create vaccine marketing campaigns that dwarf the relatively small number of websites and blogs labelled “anti-vax” simply for criticizing vaccine science and government policy.

Yet, there is no recognition by mainstream media articles of the fact that wealthy corporations and philanthropic foundations with political agendas,^{36,37} well-paid medical doctors and government health officials in charge of operating the vaccine system are in privileged positions of power with a distinct advantage over ordinary people subjected to vaccine laws that place an unequal risk burden on individuals with genetic and biological susceptibility to suffering harm from vaccination.

Bio-Populism’ Blamed for Vaccine Hesitancy in Europe

In the UK, The Economist published an article entitled, “The Campaign Against Vaccination,” in which an anonymous author declared, “Across Europe, the rise of populism is damaging public health. A common feature is skepticism of vaccines.”

Pointing to Italy, Austria and France as hotbeds of political support for “parental choice” about vaccination, the author attempted to politically tie growing public support for vaccine choice to a fear of migrants and coined a new term: “bio-populism,” saying:

“It is increasingly clear that Europe’s populists want for the body what they want for the

nation: purity, unity and self-governance. Populist health policies mean citizens being free from outside influences — whether vaccines devised by doctors, regulations invented by politicians or diseases supposedly carried by migrants — and in control of their own epidemiology.”

He (or she?) went on to explain that bio-populism is a “combination of me-first libertarianism and anti-expertise herd mentality.” Quoting Italian medical professor Dr. Roberto Burioni, who has stated authoritatively that “Vaccines are not an opinion” and offered an explanation for “Why science can’t be democratic,” The Economist article ended with a warning that, “At least one pandemic will probably sweep the interconnected world in the next decade. Viruses, after all, know no borders.”

There was no discussion of the fact that most parents and physicians calling for better quality vaccine science and informed consent protections in vaccine laws are ideologically diverse and do not all identify with one particular political party. In fact, a 2015 Pew Research Centre survey revealed that age and parenthood had more to do with vaccine hesitancy, with young adults and parents with children under age 18 being less supportive of mandatory vaccination.

Vaccines, Autism, Erosion of Trust in Drug Companies and Doctors



In the U.S., Live Science trumpeted: “Anti-Vaccine Movement Joins Ebola, Drug Resistance on List of Top Global Threats.”⁴⁶ A doctor at Johns Hopkins Centre for Health Security was quoted as saying the reason that non-communicable diseases and not infectious diseases made the WHO’s top 10 global threat list is “a testament to how powerful vaccines are.”

Pointing to the jubilant public response to the release of polio vaccine in the 1950's, he commented, "We need to get back to that era when vaccines were celebrated the way a new iPhone [is]."

The headline People Magazine chose was "World Health Organization Names Anti-Vaxxers As a Top Threat to Global Health in 2019." At the beginning of the article, the following statement appeared: "There is no scientific link between vaccines and autism, according to the Centres for Disease Control." It ended with the statement, "To tackle the rising levels of vaccine hesitancy, WHO plans to push forward with the goal of eliminating cervical cancer with greater application of HPV vaccines—"

U.S. News & World Report ran this headline: "WHO: Anti-Vaccine Movement a Top Threat in 2019." That author stated, "So-called anti-vaxxers refuse the required shots for their children on religious or philosophical grounds. An increase in unvaccinated children has, in part, been tied to the medically discredited belief that vaccines cause autism spectrum disorder."

Pointing out that a recent U.S. survey found that public trust in vaccination is on the decline, she added, "The heightened mistrust, researchers said, was especially prevalent in small pockets of people in insular communities or like-minded communities online."

Pacific Standard asked, "Are Anti-Vaxxers a Major Health Threat? The World Health Organization Says Yes." This article included a quote from a paediatrician:

"The ongoing erosion of trust in the medical establishment as a whole is also to blame, as frequent reports of dubious financial relationships between physicians, professional medical societies, and the pharmaceutical industry leave many questioning whether or not physicians can be trusted. Unsure of what to do and whom to listen to, many seek answers to their questions elsewhere, or simply rely on their gut feeling—"

Salon created the most sensational headline that asked the foreboding question, "The Anti-vaxxocalypse: What Happens to Humanity if

Vaccine Hesitancy Continues?" The author explained to readers, "In other words, the anti-vaccination movement, which has inspired many in first-world countries to refuse or hesitate vaccination for easily-preventable diseases, is now a threat to global health and, ergo, stability."

The exaggerated response to the WHO announcement by corporations owning mainstream media outlets has been curiously uniform. Often using identical talking points, perspective from parents and physicians in the U.S. and Europe rationally calling for reform of the vaccine policies and laws is left out.

The politics of vaccination are in full swing, but where is the money coming from to fund these vaccine marketing campaigns using name calling, threats, shaming and misinformation to demonise and call for discrimination against those who criticize vaccine science and government policy?



The WHO Markets Vaccines

Immediately after World War II in 1945, the United Nations (U.N.) voted to establish a new international health organization. In 1948, WHO was founded by the U.N. after ratification by 26 member states and given a budget of \$5 million.

WHO is a specialized agency of the U.N. headquartered in Geneva, Switzerland, and is composed of six regional offices operating in different parts of the world, including the Pan American Health Organization (PAHO) in Washington, D.C.

Today, 194 member states of the U.N. are impacted by the activities of the WHO, which has a broad mandate to "act as the directing

and coordinating authority on international health work.”

The WHO Constitution, revised in 2006, states that its objective “is the attainment by all peoples of the highest possible level of health,” and health is defined as “a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity.”

The WHO Constitution also states that “Informed opinion and active co-operation on the part of the public are of the utmost importance in the improvement of the health of the people.” The top priorities of the WHO when it was founded 70 years ago were malaria, tuberculosis, venereal diseases, maternal and child health, sanitary engineering and nutrition.

During the first 30 years of WHO’s operation, the U.N. agency spearheaded a global smallpox eradication campaign (1958 to 1980); prevention and control of yaws, endemic syphilis, leprosy, trachoma, cholera and yellow fever (1960’s); fertility regulation and birth control (1970’s); childhood vaccination programs (initiated 1974); and the institution of primary health care of all national health systems (initiated 1978).

Today, the WHO is the world’s largest and most influential public health agency with an annual budget for 2018 to 2019 of \$4.4 billion. Slightly more than 21.6 percent (\$956.9 million) of the WHO budget is funded by assessments on member states and the remaining is funded by “voluntary contributions.”

The biggest individual programs funded by WHO are for polio eradication vaccine campaigns (\$903 million); vaccine campaigns for other communicable diseases (\$805 million); and corporate services/enabling functions (\$715.5 million).

Currently, the top 10 U.N. member state annual funders of WHO are the governments of the U.S. (\$125 million); Japan (\$49 million); China (\$40 million); Germany (\$33 million); France (\$27 million); United Kingdom of Great Britain and Northern Ireland (\$23 million); Brazil (\$19.5 million); Italy (\$19

million); Canada (\$15 million) and Australia (\$12 million).

The Bill & Melinda Gates Foundation is the largest non-state funder of the WHO, having donated more than \$2 billion in earmarked grants to the international health agency since 1998, and is the second largest WHO funder overall (after the U.S. government). Because Gates Foundation grant money is earmarked for specific programs, such as vaccine purchase, delivery and promotion, the Gates Foundation significantly influences the setting of WHO’s program priorities.



In

2010, after a joint investigation by the British Medical Journal (BMJ) in collaboration with the London-based Bureau of Investigative Journalism, an article was published in the BMJ revealing that three key scientists — who influenced the WHO’s decision to declare a swine flu (H1N1) influenza pandemic in 2009 and recommend that all countries use and stockpile vaccines and pandemic flu drugs — had financial ties to pharmaceutical companies profiting from the WHO recommendations (GlaxoSmithKline and Roche).

WHO was also criticized for lack of transparency for refusing to release the identities of the 16 members of an emergency committee formed in 2009 to guide pandemic policy.

The 2009 pandemic H1N1 vaccine, which was rushed to market to address a WHO declared pandemic that did not happen, triggered an autoimmune reaction in more than 1,300 people in Europe who got GSK’s Pandemrix vaccine and left them with narcolepsy, an incurable immune mediated neurological disorder.

Gavi, the Vaccine Alliance Marketing Vaccines The WHO and the U.S. government are founding partners of Gavi, the Vaccine Alliance. In 2000, the Bill and Melinda Gates Foundation provided \$750 million in seed money to spearhead the creation of Gavi, a public-private partnership and multilateral funding mechanism involving the WHO, governments, the vaccine industry, the World Bank, philanthropic foundations and civil society groups to “improve access to new and underused vaccines for children living in the world’s poorest countries.”

Of the more than \$15 billion raised by Gavi since 2000 to vaccinate the world’s children, U.S. government contributions have totaled \$1.9 billion or 12 percent of all contributions received by Gavi. The United Kingdom has contributed \$2.2 billion or 14 percent of Gavi’s total contributions.

The single biggest funding source for Gavi is the Gates Foundation, which has donated more than \$3 billion or 20 percent of Gavi’s total income. Between 2000 and 2013, only about 10 percent of total funding provided by Gavi (\$862 million) was used to strengthen health systems in developing countries, such as improving sanitation and nutrition, while nearly 80 percent was used to purchase, deliver and promote vaccines.

Gavi is headquartered in Geneva with an office in Washington, D.C. that carries out day-to-day operations, and one of Gavi’s core goals is to “shape markets for vaccines and other immunization products.”

In 2008, Gavi announced that five countries — Italy, Norway, Canada, the UK and Russia — had joined the Gates Foundation to pledge \$1.5 billion in Advance Market Commitments (AMC) to accelerate access to pneumococcal vaccines with donors providing up-front funding commitments to support vaccine purchase and speed the introduction and use of vaccines in countries partnering with Gavi.

Currently, the AMC incentivizes vaccine manufacturers to sign contracts to provide pneumococcal vaccine to developing countries at lower per dose prices and be reimbursed by Gavi funds. By March 2015, Pfizer and

GlaxoSmithKline had received more than \$1 billion from Gavi’s AMC funds.

CDC officials provide Gavi with technical support and guidance. In 2015, the U.S. Congress pledged to appropriate \$1 billion to Gavi that was spread over four years (2015 to 2018).

At the World Health Summit in Berlin on October 16, 2018, Gavi CEO Dr. Seth Berkley announced that 11 heads of the world’s leading health and development organizations had signed a “landmark commitment” to find new ways to accelerate achieving goals of the United Nation’s Sustainable Development Goals created in 2015.



The new Global Action Plan vaccine marketing initiative is being coordinated by the WHO. Relating Sustainable Development Goals to vaccination of all the people in the world, Gavi states that:–

Immunization protects people from being forced into poverty by high out-of-pocket expenses.

Vaccines protect child health and support cognitive development, allowing children to perform better at school and have more opportunities.

Vaccinated healthy children grow into a productive workforce and become strong contributors to the economy, and healthy children free up parents’ time so they are able to work

Vaccines are critical to building people’s resilience to and mitigating the risk of disease outbreaks tied to climate change.

Good health is a critical determinant of peace and well-being in a society. People-centred health systems are core social institutions in every country, and immunization is often the first point of contact between these systems and the population

In 2016, Berkley and other Gavi executives came under criticism in the UK for taking excessively high salary packages. According to an investigative news report:

“Seth Berkley has taken home more than £2 million over the past four years as chief executive officer of Global Alliance for Vaccines and Immunisation (Gavi), which has been given £1.5 billion by Britain.

Another official at the Geneva-based group collects a pay package of more than £500,000 a year. Incredibly, Dr. Berkley was given a housing allowance on top of his £623,370 pay package.”

In December 2018, Berkley told CNN that “while measles is one of the few diseases we could potentially eradicate, that will never happen if wealthy countries like the United States can’t maintain herd immunity. Because a measles case anywhere is a threat everywhere.”

He said parents in the U.S. are delaying their children’s vaccinations “perhaps because they believe in immunization but are worried by some of the anti-vaccine scare mongering. This needs to stop.”

Echoing the idea that parents who don’t go along with the vaccine program are selfish, he added, “In countries like the United States we need to stop thinking about vaccination as something you only do to protect the ones you love, and instead view it also as a goodwill act for the benefit of others.”

According to the CDC, in 2017 to 2018 “vaccination coverage among kindergartners remained high,” with 94 percent of children having received two doses of measles, mumps and rubella (MMR) vaccine; four or five doses of diphtheria, tetanus and pertussis (DTaP) vaccine; and two doses of varicella zoster (chickenpox) vaccine (among many other

vaccines required by states for school attendance). Only 2 percent of kindergartners had an exemption from one or more state required vaccines.

The Bill and Melinda Gates Foundation’s Marketing of Vaccines



The Gates Foundation was established in 2000 by Microsoft Corporation founder Bill Gates and his wife, Melinda (above).

Headquartered in Seattle, Washington, the Gates Foundation is the largest philanthropic foundation in the world with a \$43.5 billion trust that makes grant payments of more than \$3 billion annually to advance the foundation’s goals for reforming education systems, such as the institution of Common Core curriculum in all U.S. schools, and funding public health initiatives, primarily global vaccination programs.

A major goal of the Gates Foundation is to make sure every child in the world is vaccinated. Investor businessman Warren Buffet, who took control of textile manufacturer Berkshire Hathaway, Inc. in 1965 and went on to amass a personal fortune of more than \$60 billion, pledged \$31 billion and became a co-director of Gates Foundation in 2006.

In 1998, the same year that the U.S. Department of Justice filed an antitrust lawsuit against Microsoft Corporation,⁷⁵ Bill and Melinda Gates committed \$100 million to create the Bill & Melinda Gates Children’s Vaccine Program. One purpose of that program

was to establish an international consensus on vaccine use recommendations:

“Efforts will be made to support international conferences and the development and dissemination of strong international consensus statements and recommendations for the use of the new vaccines.”

The homepage of the Gates Foundation proclaims ALL LIVES HAVE EQUAL VALUE and states

“We believe we can save lives by delivering the latest in science and technology to those with the greatest needs. We work with partners to provide effective vaccines, drugs and diagnostics and to develop innovative approaches to deliver health services to those who need it most. And we invest heavily in developing new vaccines to prevent infectious diseases that impose the greatest burden.”

In 2016, Global Justice Now published an investigative report, “Gated Development: Is the Gates Foundation always a force for good?” Authors were critical of the unchecked political power and influence on global health programs and agricultural policies of Bill Gates and the Bill and Melinda Gates Foundation (BMGF):

“To say that the BMGF has become an important actor in international development would be an understatement. When it comes to global health and agriculture policies, two of its key grant areas, the BMGF has become probably the most influential actor in the world.



It is also likely that Bill Gates (above), who has regular access to world leaders and is in effect personally bankrolling hundreds of universities, international organizations, NGOs and media outlets, has become the single most influential voice in international development.

But the BMGF’s increasing global influence is not being subjected to democratic scrutiny. Unlike governments, which are formally accountable to their electorates, the BMGF is a private U.S. foundation, and remains unaccountable to public bodies (except for tax reporting purposes).

Even worse, the BMGF appears to have bought the silence of academics, NGOs and the media who might otherwise be expected to criticize aspects of the foundation’s work.”

Money Makes the World Go Around

Congress appropriated nearly \$90 billion to the U.S. Department of Health and Human Services in 2018, and the biggest line item in the CDC’s \$11 billion budget was the Vaccines for Children program (VFC) (\$4.5 billion), which was created by Congress in 1993.

Under the VFC program, the federal government purchases CDC recommended vaccines from vaccine manufacturers to administer to children who are on Medicaid, are uninsured or whose health insurance plans do not fully cover CDC recommended vaccines. Hundreds of millions of dollars are additionally allocated in the HHS budget for vaccination programs, including \$700 million for the National Centre for Immunization and Respiratory Diseases.

One of the most politically powerful public-private partnerships in the world today is the lucrative one that has been forged by the pharmaceutical industry with the government, mainstream media and wealthy philanthropic foundations with political agendas.

In the past decade, these public-private partnerships have come under scrutiny by public policy analysts. In 2015, authors of a special report published by the Global Policy Forum observed:

“However, it is not only ‘big business’ but also ‘big philanthropy’ that has an increasing influence in global development policy, particularly large philanthropic foundations. The scope of their influence in both past and present discourse and decision-making

processes is fully equal, and in some cases goes beyond that of other private actors.

Through the sheer size of their grant-making, personal networking and active advocacy, large global foundations, most notably the Rockefeller Foundation and the Bill & Melinda Gates Foundation have played an increasingly active role in shaping the agenda-setting and funding priorities of international organizations and governments.”



For example, the Gates Foundation has given Johns Hopkins more than \$100 million in research grants since 2015, including for vaccine development and promotion. At the same time, Johns Hopkins University receives more than \$2 billion per year in funding from U.S. government agencies, such as the National Institutes of Health (NIH) and the National Science Foundation (NSF), to conduct research, including for vaccine development and vaccine use promotion.

The National Institutes of Health (NIH) and other federal health agencies give millions of dollars in taxpayer dollars to academic institutions and vaccine manufacturers to improve vaccine technology, find new lucrative vaccine markets and boost vaccine marketability. The U.S. government also partners with the Gates Foundation to develop and promote vaccine use.

For example, in 2013, the CDC Foundation received three grants totaling \$13.5 million from the Gates Foundation to globally “advance the implementation” of meningitis and rotavirus vaccine programs.

The Centres for Disease Control and the CDC Foundation have received more than \$167 million from the Gates Foundation. Vaccine manufacturers have also received millions of dollars in grants from the Gates Foundation,

including GlaxoSmithKline (over \$50 million);⁹⁶ Merck (\$1.4 million);⁹⁷ Pfizer (\$16.5 million);⁹⁸ and Sanofi Pasteur (\$3.6 million).

Big Media: Under the Influence

Mass media corporations also are under the influence of Big Pharma and Big Philanthropy money. For example, National Public Radio has received \$20 million in grants and Solutions Journalism Network has received \$4 million in grants from the Gates Foundation. Recently, Gates’ Microsoft Corporation partnered with News Guard Technologies Inc.,^{102,103} a new corporation that is rating websites and online publications to “fight false news, misinformation and disinformation.”

The News Guard corporation is also collaborating with other corporations, such as Google,^{107,108} which owns over 90 percent of the Internet search market. One of the biggest investors in News Guard is Publicis, the oldest advertising company in the world and the third largest mass communications company today.

Publicis is paid billions of dollars by pharmaceutical companies to market vaccines. including a \$1.5 billion media contract with GlaxoSmithKline. PDI, a Publicis health company, states:

“Vaccination coverage in the United State is high, but in the face of the resurgence of vaccine-preventable diseases such as pertussis and measles, the existing gaps in the vaccination coverage of the U.S. population have become worrisome.

Gaps exist because not every patient who needs a vaccination gets it at the recommended age. Moreover, the recommendations for new vaccines, including vaccines for influenza and human papillomavirus (HPV), have been expanded--

PDI’s field-based medical sales representatives and inside medical sales representatives from our health care contact centre can increase adoption of vaccines by responding to questions and concerns—— To increase immunization rates, we must build sustainable

systems for vaccination within the context of a changing health care system.

Here [are] some recommended steps toward achieving this goal: assessment of the actual vaccination rate in a provider's practice; consistently making recommendations for timely vaccinations to both the parents of paediatric patients and adult patients; standing orders for non-physician personnel to carry out vaccinations at the scheduled time without physician involvement; educating physicians on emerging research of vaccine risks and on how to interact with parents who are concerned about the detrimental effects of the MMR and HPV vaccines; and educating physicians about state-sponsored and other programs that can help patients overcome financial barriers to vaccination."

It is clear that mass media communication today is being controlled by corporations financially tied to pharmaceutical companies and influenced by powerful political institutions in society. It goes a long way to explaining why mainstream media outlets have been nearly united in attacking parents and physicians who defend the ethical principle of informed consent, including informed consent to vaccination, and are calling for vaccine exemptions to be severely restricted or eliminated.

The five largest companies in the world today are Apple, Google, Microsoft, Amazon and Facebook.

These and other technology corporations dominate online communications and sales and are positioned to join together to aggressively market vaccines and promote "no exceptions" vaccine use policies endorsed by the WHO and governments.

The threat to autonomy and freedom of thought and speech posed by these companies, especially in censoring online public conversations about vaccination and health, is considerable.

The People Are Not Represented

Today, everybody knows somebody who was healthy, got vaccinated and was never healthy

again. The people whose lives are being impacted by business deals between governments, Big Pharma and Big Philanthropy increasingly are being marginalized in the top-down public policy making process by wealthy and powerful institutions in society financing the global multibillion-dollar vaccine industry.

This is evident when the people raise their voices to ask for better vaccine science and more humane public health policies and are demonised, discriminated against and punished by those in control of those wealthy and powerful institutions.

A system that will not bend will break. The responsibility for the crisis of trust in the global vaccination system lies squarely at the feet of those who operate the system and refuse to acknowledge the suffering of the people harmed by vaccines.

ARTICLE 2. As it cannot be doubted that the liberty of the press is the most powerful means used by the pretended supporters of the rights of nations to the detriment of those of princes, the high contracting parties promise reciprocally to

adopt all proper measures to suppress it, not only in their own state but also in the rest of Europe.

ARTICLE 3. Convinced that the principles of religion contribute most powerfully to keep nations in the state of passive obedience which they owe to their princes, the high contracting parties declare it to be their intention to sustain in their respective states, those measures which the clergy may adopt with the aim of ameliorating their own interests, so intimately connected with the preservation of the authority of the princes; and the contracting powers join in offering their thanks to the Pope for what he has already done for them, and solicit his constant cooperation in their views of submitting the nations."

Do we have a false God before us and worship him and his church instead of the real Lord, Jesus and his government. The divine right of kings exists in Clinton and every Governor of the states in corporate Union. Prehistoric London Its Mounds And Circles **By E. O. Gordon (Published 1946)** **Part 3**



Stone Hammers Found at Stonehenge

IN 1901 a thorough investigation of Stonehenge took place in order to raise the Great Trilithon that had fallen on the last night of the last century. On excavating the base to re-fix it in cement, stone chippings and some flint hammers were found (now in Devises Museum) with which it was supposed the tenons of the Sarsens had been shaped, verifying the tradition that the Druids used only instruments of flint in the cuttings for religious purposes to guard against the making of Idols (**Deut. xxvii. 5-6; 1 Kings vi. 7; Joshua viii. 31**).

The first Colonizers arrived, on our shores "When England no longer formed part of the -Continent, but had assumed its present physical aspect, its present fauna and flora." This fact we learn from labels in the cases containing the weapons, pottery, and personal ornaments of the

people who lived in the Stone, Bronze and Iron Ages, in the British Antiquities Department of the British Museum.

The route of the Kymry may be traced by the names of the countries through which they passed, the Crimea and the Chersonese; according to Dr. Lightfoot, the Galatians retained many traits in common with the Kymric branch of the Keltic race, and though the population of Galatia was very mixed, the characteristic vitality of the Kelts maintained the prominence of the race. Though Greek became eventually the language of the towns, the dialect of the country-people was almost identical with that of the Treveri—the people of Trier or Trêves, founded in the time of Abraham by Trebeta, the son of Ninus, King of Assyria, 1300 years before Rome.

But before inquiring into the history of the coming of the Kymry in the Neolithic or new stone age, it will add to the interest of our story, first to glance at the remains of the still older civilization of the Palæolithic or most ancient stone age, when Britain formed part of the continent of Europe, and elephants, lions, hyenas and bears, roamed the vast forests which then covered it.



In his *Early Man in Britain* Boyd Dawkins (above) states that the civilization of these River drift and Cavemen may be compared to that of the Bushmen of Australia. The great “Ice Age” swept away all traces of the existence of these Aborigines, except those rude remains that have been brought to light by the Geologist. Some interesting specimens of human remains,

together with those of wild animals, found in caves in England and on the Continent, may be seen in the Geological Gallery of the Natural History Museum in the wall-case on the right as you enter.

Professor Woodward has kindly allowed a photograph to be taken of a specimen of a human skull discovered embedded in the stalagmite floor of a cave. In the centre of the gallery should be noticed the head of a mammoth with tusks 7 feet in length, found at Ilford, a district at one time covered with vast forest, but now a suburb, within half an hour’s journey of the city. In pier-case No. 8, near to this old inhabitant of the neighbourhood, is the skull of a British lion, possibly a contemporary of the mammoth.

A map in the British Antiquities Department in the British Museum shows where the footprints of the primitive race have been discovered on the banks of the Thames and other rivers. In the gallery are to be seen specimens of their rough unpolished stone implements, and standing between models of the Druidic circles of Arbor Low, and Stonehenge, is a portion of the floor of a cave-dwelling showing human remains mingled with those of wild animals.

No greater contrast could well have been devised that would enable us to realise the low-grade of the conditions of life without any religion (so far as we know) and the elevating influence of a knowledge of the True God, the Light and Life of the world. This knowledge inspired the first Colonists to erect their “Bethels” wherever they settled, a consecrated “place of assembly,” having no enclosing walls or overarching roof, but a spot set apart for the worship of the Most High, whose Presence the Ancients believed permeated all natural objects.

The footprints of these first settlers have been traced by the remains of their religious monuments (circles and mounds), from the district north of the Persian Gulf, along the trade route of the Phoenicians, to the shores of the Mediterranean. These material remains, when taken in connection with a remarkable affinity in language, the discoveries of modern travellers and the testimony of national traditions, proof that the original colonists came from Accad[4], or Accadia, the Southern Province of Babylonia. They brought with them their primitive religion,—“the first wave of the Aryan family to

overspread Europe before Greeks or Romans were heard of.”

The earliest recorded history of the British race takes us to Central Asia, the fertile district watered by the Tigris and Euphrates, lying between Mount Ararat on the north and the Persian Gulf on the south. To this country of the ancient Chaldees the earliest settlers in Britain trace their origin.

The Kymry or Kimbri are the Welsh branch of the ancient Keltic people.

National traditions maintain that the Kymry possessed from the earliest period of their existence a knowledge of the true God, and embodied it into their theological code as one of the fundamental doctrines of Druidism. This Keltic literature consists of “The Historic Triads of the Island of Britain,” three hundred in number (of which only one hundred and sixty are extant), Bardic Poems, and various fragments of Druidic Philosophy.

Like the Sacred Vedas of India the Triads were handed down by oral tradition. Not until the sixth century were they written down by the Bards of King Arthur’s Court, Taliesin and Llywarch Hen, when the British king re-organized the “Old Order” on Christian lines and drew up his rules of the Round Table on the Druidic principles of patriotism and self-sacrifice in the cause of King and Country.

In the national Triads of Wales, which are, according to Matthew Arnold and Max Müller, the “oldest literature in the oldest living language in Europe,” the eastern origin of the British race is stated:—

**“A numerous race, fierce they were called,
First colonized thee, Britain, chief of Islea,
Men of the country of Asia, the country of
Gafis.**

**Said to have been a skilful people, but the
district Is unknown**

**Which was mother to these warlike
adventurers on the sea.**

**Clad in their long dross, who could equal
them?**

**Their skill is celebrated, they were the dread
of Europe.”**

It is not known exactly where Gafis is, but from Layard’s discoveries, and Sayce’s reading of the clay tablets from the Babylonian Library where he finds a similar form of Monarchical and Constitutional Government to that in early Britain, there seems every reason for thinking it was in this part of the world.

As we have already mentioned, Sayce points out yet one other bond of union between ancient Chaldea and Britain, in the fact that in Babylonia and Persia, as in Britain, no ruins of palaces or dwellings are found; magnificent remains of Temples, only, testify to the importance the people of these countries attached to their religious worship. It is only in the later civilization of Assyria that we find the grandeur of the palaces far exceeds that of the Temples.



At Nineveh the Royal Library was kept in the Palace, and not, as at Babylon, in the Temple. It is of no little interest that the ancient Libraries of the Kings of Babylon and Nineveh are now preserved in the British Museum. From these imperishable records inscribed on clay tablets Sayce has discovered that the “Accadian Law did not differ much from our own.” He finds here an ancient form of Monarchical and Constitutional Government similar to that which existed in Britain for many centuries before the Christian Era, an organized rule which in primitive times was shared by no other European country.

Precedents and previous decisions seem to have been held in as high esteem as among our own lawyers. The king was the supreme court of appeal, and copies exist of private petitions

preferred to him on a variety of matters. Judges were appointed under the king and prisons were established in the towns. An old Babylonian code of moral precepts addressed to princes denounced the ruler “who listens to the evil advice of his courtiers and does not deliver judgment according to the law-book.”

Another Code which goes back to the Accadian epoch, 3800 B.C., contains an express enactment for protecting the slave against his master. May not this be the seed of imperishable human thought which, lying dormant for centuries, lived again in the spiritual activities of Wilberforce, Livingstone and Gordon, the three saintly men to whom the world owes the suppression of the slave trade.

The status of women is another link between Accad and our own country. Britain has always been a country where the Salic law is not in force, and the exceptional reverence and honour shown to women in all classes of society in all periods of our history, Sayce traces back to the ancient Accadian law which assigned a position to woman that made her the equal of man: in fact, he tells us, she ranked before her husband in matters relative to the family.

An interesting article by Hall Caine appeared in the Daily Chronicle (March 14, 1910) on the subject of the “Women’s Charter,” introduced into Parliament by Sir Charles Maclaren, now Lord Aberconway.

In this article he states that by Manx law the woman is to all intents and purposes the equal of the man. “The rights of the family in a man’s property are most powerfully expressed in the person of his wife, without whose sanction his estate may not be disposed of by will or deed, and may not be encumbered save subject to her widow rights should she survive him— “Thus the co-ownership of the wife with the husband is implied in Manx law down to the present day.” Here appears a veritable survival in the Isle of Man of the Ancient British and Accadian Law.

Other signs of kinship between Central Asia and these Islands of the West may be observed on the Nineveh sculptures, now within reach of the humblest student in the British Museum. On one of these marbles from Sennacherib’s Palace a triumphal procession is depicted in honour of a victory (not a religious procession). The

minstrels carry small harps; these, Sir Henry Layard used to take pleasure in pointing out, were the original of the small Welsh harps used by the Keltic bards from the time that they were first established (1000 B.C.) to the present day.

A form of the Scottish bagpipes may also be seen on these Assyrian marbles, together with the original of the British war-chariots peculiar to our island. With 4,000 war-chariots Cassivellaunus repulsed the Romans, 55 B.C. In one of the finest monuments in London on Westminster Bridge, Thorneycroft has represented Boadicea in her war-chariot, which only differs from the Assyrian model by the blades fixed in the wheels.

It has been a wonder to many how the gigantic un-hewn rocks, weighing 70 or 80 tons, employed in the construction of the Circles of Avebury and Stonehenge, were moved and fixed in their respective positions. The method is made clear when we see here depicted the removal of one of the winged bulls of Sennacherib’s palace-gate, by the simple process of rollers, ropes, unlimited amount of human labour, and a lever. But there is a most important and significant difference to be noticed between Assyrian marbles and the stones which form the British circles. Whereas the former are covered with carving and inscriptions, the megalithic remains in Britain are un-inscribed and unwrought (**Exod. xx. 25**).

Another link with Assyria is mentioned by the late Dr. Collins, Bishop of Gibraltar, which tends to confirm the Eastern origin of our prehistoric forefathers. In October, 1907, when on his long and difficult journey as the bearer of a letter from the Archbishop of Canterbury to the Catholicus or Patriarch of the Assyrian Church, he came

across a Kurdish village in the district of Ararat which reminded him of the numerous hut-circles still existing in all parts of Britain, but more especially in Cornwall. With the latter the Bishop was evidently acquainted, otherwise he would hardly have made the following entry in his diary:—

The village is like a large burrow or warren, consisting of a series of earthen mounds of large size, some with solid roofs that can be walked on, others that the owners anxiously warn one off. The whole thing strongly suggests the underground dwellings at Chysauster or Treryn in the Land's End district.

It is, however, only within the last century, that fresh light has been thrown upon the religion and civilization of Ancient Britain, from the affinity that has been found to exist between our own and Eastern languages.

Dean Alford and Max Müller point out that the majority of our words are of Celtic, Phoenician, Hebrew, Arabic and Persian origin, and that many place-names, rivers more especially, are derived from the Sanskrit. The name of the river "Avon," for instance, that forms the eastern boundary of the vast prehistoric cemetery on the Wiltshire Downs, comes from the Sanskrit root "Av," which signifies "water," "on" being expressive of distinct unity, so "Avon" means literally "a river."

In South Wiltshire we find three rivers, the Wyly, the Nadder and the Ebel, whose names, derived from the Sanskrit, are further convincing proofs of the early Eastern occupation. From the name "Wyly" we have "Wilton," the ancient capital of the County itself.

The Welsh word "gwili" means "full of turns—winding," and the root of the word is to be found in "gwy," which signifies a flow or flood. Between Wilton and Salisbury, the Wyly receives the waters of the river Nadder. A natural derivation of the word Nadder would seem to be from the Welsh "Neidr," which means a snake or adder. Philologists derive this word from the Welsh "Nad," a shrill noise, or from "Nad-er," to utter a shrill cry.

There is in Sanskrit a remarkable confirmation of the probability of such an etymology, for whilst "Nad" means "to sound," "Nada," its derivation, means "a river." The Ebbe or Ebel is a small river in the south-west part of Wilts.

The word would seem probably to be derived from the same Sanskrit root ap, or ab, which is found in the Gothic as "Alwa," and in the obsolete Gaelic as "Abh"; the termination of the second form is probably a diminutive, for El has this force in Welsh. Crib means "a summit," "Crib-el" a "Cock's comb," "Coq" means "a short piece of wood," and "Coq-yl," a short, stout piece of wood, i.e. Cudgel. Hence "A-bel" or "Eb-cl" would mean a little river.
