In Memoriam: Pastor George Udvary

GEORGE UDVARY was born in Budapest, Hungary, in 1932. As a result of WWII, the communists, under Stalin, occupied Hungary. A communist campaign of rape, pillage, murder and confiscation of all private property taught the Hungarian people what communism really is.

As a young man, George became a Hungarian freedom fighter. He, like many other young Hungarians, was led to believe that America would come to the aid of the anti-communists, should they rise up against their oppressors. Although Radio Free Europe promised this help, President Eisenhower never delivered, leaving the anti-communists feeling betrayed.

After the Hungarian freedom fighters had gained a temporary victory over their Soviet oppressors, Eisenhower had this message sent to Tito, the communist dictator of Yugoslavia, on Friday November 2, 1956:

“The government of the United States does not look with favour upon governments unfriendly to the Soviet Union on the borders of the Soviet Union.” Thus assured that the Americans would not interfere with the Soviet military, the Soviets re-invaded on Nov. 4 and put an end to Hungary’s brief liberation.

Eisenhower’s betrayal of Hungary left George Udvary no choice. He had to flee across the

border into Austria. From there he came to America, where he spent a few years as a speaker on the anti-communist lecture circuit. In the mid 1960’s he made the acquaintance of Dr. Wesley Swift and Bertrand Comparet. From these two men, Udvary learned that communism is Jewish and that the Jews are an impostor people who have no connection to the Israel of the Bible.

In 1967 he renounced Roman Catholicism and became a Christian Identian. He was ordained as a CI minister in 1975.

As a CI Pastor, George Udvary taught two-seedline; the sacred names, Yahweh and Yahshua; a literal Satan that exists in the spirit but who also has earthly followers; the distinction between Jews and Judahites; the separate creation of the White race (Adam) by Yahweh; racial segregation; and many other doctrines known to Identians today.

In 2008, he published a book, **Christian Israel Biblical Reference Manual**, which is available at www.anglo-saxonisrael.com. Pastor Udvary was a frequent guest on my radio shows after he published his book. He was dedicated, honest and courageous in teaching Christian Identity.



Strangers, Pilgrims And Israel

IN the Old Testament there are Scriptures that certainly look as if they are saying that non-Israelite strangers could become circumcised, keep the Passover, the Laws of Moses and thus become

as *one born in the land*. This is the matter which is being questioned. The immediate necessity is to look at the word *stranger* and similar words like *foreigner*, *sojourner* and *alien*. In both the Hebrew of the Old Testament and the Greek of the New Testament there are many different words loosely translated as *strangers*, *foreigners* and *servants*, etc and this is the problem. Our translators [this includes the NIV] have had no system of consistent rendering of any of these words. **That there are strangers who are Israelites and strangers who are not Israelites, is very obvious.**

IN THE OLD TESTAMENT there are eight words which are translated as *stranger*, *strangers*, *foreigner*, *sojourners* or *aliens* and some clarification is necessary. Without this clarification we have translations which make the Bible appear contradictory and inconsistent.

IN THE NEW TESTAMENT there are ten words which are variously translated, so that it is clear that each word in the original has a different meaning. Some of the New Testament quotations are from Old Testament origins and therefore they show a close alliance between the two languages.

WHAT ARE THE DIFFERENT KINDS OF STRANGERS?

The most commonly misunderstood word is *ger*, which is translated as “stranger(s)” 86 times out of the 92 times it occurs in the Old Testament. The meaning of this word might be

summarised as being an Israelite who lives apart from the main body of Israel. That is, living among, or in the land, of other races. The important fact is that this stranger is an Israelite by race.

It is not hard to find instances where the translators have translated the same Hebrew word, in the same context, into two different English words. This makes immediate nonsense of those verses when taken as translated.

Following are the main Hebrew words translated *stranger*, *foreigner*, *sojourner*, etc. The comments include a summation of the meaning of the key terms and the status of the people covered by those terms in the eyes of the Law. The summations are based on usage of the word in Scripture, as shown throughout this chapter. The words are:

H4033 *maguwr* (noun) from 1481 in the sense of lodging; a temporary abode; by extens. a permanent residence: - dwelling, pilgrimage, where sojourn, be a stranger. For example: Gen 17:8, *the land wherein thou art a stranger*. It is used of the places where Abraham, Isaac and Jacob dwelled in their travels or pilgrimage. We can use the term *dweller*.

H1616 *ger* (noun) a guest; by implication a foreigner: alien, sojourner. For example, Gen 15:13, *Know of a surety that thy seed shall be a stranger in a land that is not theirs*. A person of one's own blood or race who is visiting in the district and is not known to the residents of the area. Israelites who were not present at the covenant sanctification ceremony in Mount Sinai (such as the descendants of Judah's son, Zerah). Moses named his son, Gershom, because he was visiting from Egypt and Canaan (as opposed to being an exile). The *gerim* have equal rights before the law and can accumulate wealth in Israel. We can use the term *kinsman-visitor* (to show the genetic connection).

H2114 *zuwr* (verb - used as a participle with the force of a noun) to turn aside (espec for lodging); hence to be a foreigner, strange, profane;

spec. to commit adultery: (come from) another (man, place), fanner, go away, strange (-r, thing, woman). , *land*).

H8453 towshab (noun) from 3427 For example, Num 16:40, ... *no stranger which is not of the seed of Israel*. The basic thought is of non-acquaintance and non-relatedness. A complete alien; **no racial connection**. In our context, one who is not an Israelite, Shemite or Hebrew. This person has no rights or protection under the Law and be killed on sight if found near the Temple. We can use the term *alien*.

H5236 nekar (noun) from 5234. Foreign, or (concr) a foreigner, or (abstr.) heathendom: - alien, strange, stranger. For example, Gen 17:12, *And he that is eight days old shall be circumcised among you, every man child in your generations, he that is born in the house, or bought with money of any stranger, which is not of thy seed (not of your own immediate family). Refers to what is foreign to a family, tribe, nation.* Hence the son of a stranger refers to the son of a foreigner and these are half-caste Israelite (see Isa 56:3, *Neither let the son of the stranger, that hath joined himself to the LORD, speak, saying, The LORD hath utterly separated me from his people: neither let the eunuch say, Behold, I am a dry tree*). In this context, we can use the term *foreigner*. (Compare Gen 35:2 which reads ... *put away gods, the foreigners which are in the midst of you ...*)

H5237 nokriy (adjective) from 5235. Strange, in a variety of degrees and applications (foreign, non-relative, adulterous, different, wonderful): alien, foreigner, outlandish, stranger. For example, Judges 19:12, *And his master said unto him, We will not turn aside hither into the city of a stranger, that is not of the children of Israel; we will pass over to Gibeah*. Compare with Ruth 2:10, *Then she fell on her face, and bowed herself to the ground, and said unto him, Why have I found grace in thine eyes, that thou shouldest take knowledge of me, seeing I am a stranger?* - a foreign person with respect to Boaz and his people because Ruth had come from a different Israelite tribe.

Similarly, a strange woman as opposed to one's wife referred to an adulteress. In our context it describes one who is not of Israel but is a Shemite or Hebrew versus an alien (*zuwr*). Harlots, in Israelite times, were typically not



Israelite women, but were quite similar in appearance because they were in a broadly related genetic line. Thus it refers to Hebrew people with whom marriage is forbidden - Canaanites, Moabites, Ammonites, etc and with whom Israelites were always led away to other gods. These people had no rights or privileges in Israel. In this context, we can use the term *foreign (one, person. A dweller, (but no outlandish); espec. (as distinguished from a native citizen and a temporary inmate or mere lodger) resident alien, foreigner, inhabitant, sojourner, stranger*. For example, Lev 25:6, *And the sabbath of the land shall be meat for you; for thee, and for thy servant, and for thy maid, and for thy hired servant, and for thy stranger that sojourneth with thee*. Compare 1 Ki 17:1 *And Elijah the Tishbite, who was of the inhabitants (towshab) of Gilead, ...* The majority of the references are to a temporary, landless, wage earner, hence, not naturalised. In our context, the lowest order and, basically, had no rights other than access to the cities of refuge. The children of the towshab could be bought as perpetual servants, without prospect of redemption, and could not hold any position of authority. In this context we can use the expression *temporary resident*.

Each of these terms apply their meanings according to their context and hence can be used of Israelites as well as other people. For example, Abraham described himself as a sojourner to the sons of Heth [Gen 23:4]. However, our interest is the use of these terms with reference to the status of non-Israelites within Israel. By way of example, let us look at one of the standard Scriptures used by universalists:


Exodus 12:19 Seven days shall there be no leaven found in your houses: for whosoever eateth that which is leavened, even that soul shall be cut off from the congregation of Israel, whether he be a stranger [kinsman-visitor], or born in the land.

This verse makes perfect sense when we realise the stranger in this case is, in fact, an Israelite but not one who was present in Mount Sinai at the time of the formal covenant ceremonies. Compare this with:

*Ex 12:43-49. And the Lord said to Moses and Aaron, This is the order of the passover. There shall be no **stranger** [the AV text is deficient here; the Hebrew reads: no son of a stranger - ben nekar - son of a foreigner; a half-caste] eat thereof: But **every man's servant** [bondservant] that is bought for money, when thou hast circumcised him, then he shall eat thereof. A **foreigner** [a foreign person] or a **hired servant** [H7916: a man at wages by the day or the year - Not the same as the bond servant, above] shall not eat thereof. In one house shall it be eaten; thou shalt not carry forth ought of the flesh abroad out of the house, neither shall ye break a bone thereof. All the congregation of Israel shall keep it. And when a **stranger** [kinsman-visitor] shall sojourn with thee, and will keep the passover to the Lord, let all his males be circumcised, and then let him come near and keep it, and he shall be as one born in the land: for no uncircumcised person shall eat thereof. One law shall be to him that is homeborn, and unto the **stranger** [kinsman-visitor] that sojourneth among you.*

In the AV version of this quotation there are four categories of people mentioned in regard to the ordinance of the Passover and it looks as if the stranger mentioned as forbidden at the beginning of the verses is suddenly allowed to partake at the end of the verses. However, the translations do not reveal that there is a fifth category, the kinsman-visitor, who is the one is allowed to partake if the males of his family are circumcised.

Let us look at some of the variations in the English translations of these verses:



The NIV calls the first stranger an alien, and the second one a temporary resident which is not correct – the half-caste is not an alien and the kinsman-visitor is not the same as an alien who is temporarily living in the country.

The RSV calls the first a foreigner and the second a stranger – the first one is wrong and the second one is only partly right; the kinsman-visitor is a stranger, but it does not reveal the

racial connection that is present in the Hebrew word.

The Living Bible actually calls the second pair of strangers “foreigners” which is so far off the mark that it is completely mis-leading.

The sincerity of the translators is not the issue here, but there are important implications for how we view the New Testament verses on similar subjects. In the New Testament we still have pilgrims and strangers, aliens and foreigners. We have been taught or have presumed certain things about these words, but the right teachings are, in fact, the same as are presented in the Old Testament. The New Testament is based on the Old Testament and it is written [in the Old Testament].

If certain of the “strangers” in the Old Testament were Israelites by race, might not certain of these strangers still be Israelites by race in the New Testament?

STRANGERS IN THE NEW TESTAMENT.

In the New Testament we also find a variety of words translated as “strangers”, “foreigners” “aliens” and “pilgrims”. As the translators did not understand the differences between the different terms for strangers in the Old Testament, it should not surprise us to find the same confusion in the New Testament. There Greek words translated stranger, pilgrim or sojourner are allogenes, allotrios, apallotrioo, epidemeo, xenodocheo, xenos, parepidemos, paroikeo, paroikia, paroikos and philonexia. With reference to Strong, Thayer and Vine, the words that are relevant to this chapter are:

G245 allotrios (adjective) from G243; another's, that is, not one's own: by extens. foreign, not akin, hostile - alien, (an-) other (man's men's) strange(-r). Belonging to another (opposite of idios - one's own); foreign, strange; hence not of one's own group, family, nation, kingdom; an alien, an enemy. Matt 17:25, Heb 11:34. This is the equivalent of the Hebrew nekar. We can use the term foreigner.

G526 apallotrioo (verb) apo (from) plus allotrios. to estrange away, that is (pass. and fig.) to be non-participant: alienate, be alien. To alienate, estrange; to be shut out from one's fellowship

and intimacy. To be rendered alien, to be alienated; the condition of unbelievers is presented in a threefold state of alienation (a) from the commonwealth of Israel (b) from the love of God (c) from God Himself. Hence, to be shut out from one's group. Eph 2:12. There is no obvious equivalent for this word in the Hebrew terms above. We can use the term *estranged*.

G1927 *epidemeo* (verb - used only twice; participle) to make oneself at home, that is, (by extens.) to reside (in a foreign country): - [be] dwelling (which were) there, stranger. To be present among one's people, in one's city or one's native land; to be a sojourner; of a foreign resident, among any people, in any country. Acts 2:10. This is the participle equivalent of the Hebrew *ger*. We can use the term *visiting*.


G3581 *xenos* (adjective) foreign (lit. alien, or fig. novel); by impl. a guest or (vice-versa) entertainer: - host, strange(r). A foreigner, a stranger; alien (from a person or a thing); without the knowledge of, without a share in; new, unheard of; one who receives and entertains another hospitably; with whom he stays or lodges, a host. Strange; denotes a stranger in the sense of an unknown person of the same group (such as people of the same race). Matt 27:7, Acts 2:10, 17:21, Eph 2:19, Heb 11:13. There is no equivalent for this word in the Hebrew terms above. We can use the term *stranger*.

G3927 *parepidemos* (adjective used as noun - *para*: from; expressing a contrary condition; *epidemeo*: to sojourn and *demos*: a people) from 8344 and the base of 1927. An alien alongside, that is, a resident foreigner: - pilgrim, stranger. One who comes from a foreign country into a city or land to reside there by the side of the natives; a stranger; sojourning in a strange place, a foreigner; in the NT metaph. in reference to heaven as the native country, one who sojourns on earth. Sojourning in a strange place away from one's own people. Used of those to whom Heaven is their own country and who are sojourners on Earth. Denotes a sojourner, an exile; used of OT saints. 1 Peter 1:1. As this term is related to *epidemeo* above, it is the equivalent of the Hebrew *ger*. We will use the term *visitor*.

G3940 *paroikia* (noun) See *paroikos*. Foreign residence: -- sojourning, as strangers. A dwelling near or with one; a sojourning, dwelling in a strange land; metaph. the life of a man here on

earth is likened to a sojourning. This is the equivalent of the Hebrew *towshab*. We will use the term *temporary resident*.

G3941 *paroikos* (adjective) having a home near, that is, (as noun) a by-dweller (alien resident): foreigner, sojourn, stranger. Dwelling near, neighbouring; in the NT, a stranger, a foreigner, one who lives in a place without the right of citizenship; metaph. without citizenship in God's kingdom; one who lives on earth as a stranger, a sojourner on the earth; of Christians whose home is in heaven. One who dwells in a place. 1 Peter 2:11 - as sojourners (*paroikous*) and aliens (*parepidemous*). This is the equivalent of the Hebrew *towshab*. We can use the term *temporary resident*.



The New Testament, therefore, has a similar variety of words as has the Old Testament in this area, so we can no longer presume that all strangers and foreigners [as translated] are non-Israelites. Comparisons must be made from the Old Testament foundation in the Law, the Psalms and the Prophets.

There is a certain relationship conveyed by one pair of words used in the Old Testament which always compares with the same sentiment conveyed by a similar pairing of words in the New Testament. These New Testament phrases are derived from the Old Testament, so there is a link between them.

Ps 39:12 Hear my prayer, O Lord, and give ear to my cry, hold not Thy peace at my tears, for I am a STRANGER [ger: kinsman-visitor] with thee, and a SOJOURNER [towshab: temporary resident], as all my fathers were.

Gen 23:4I am a STRANGER [ger: kinsman-visitor] and a SOJOURNER [towshab: temporary resident] with you.

Lev 25:23 For ye [are] STRANGERS [ger: kinsman-visitor] and SOJOURNERS [towshab:

temporary resident] *with me*.

1 Chron 29:15 We are STRANGERS [ger: kinsman-visitor] before thee and SOJOURNERS [towshab: temporary resident]


1 Peter 2:11 Dearly beloved, I beseech, as STRANGERS [paroikos: temporary resident] and PILGRIMS [parepidemos: visitors].

Heb 11:13 These all died in faith ... and confessed that they were PILGRIMS [xenos: stranger] and STRANGERS [parepidemos: visitors] on the earth.

Eph 2:12 Being ALIENS [apallotrioo: estranged] from the Commonwealth of Israel, and STRANGERS [xenos: stranger] from the covenants of promises.

Eph 2:19 Now therefore, ye are no more STRANGERS [xenos: strangers] and FOREIGNERS [paroikas: temporary residents] but fellow citizens with the saints and of the household of God.

Here we have a selection of Scriptures from both Testaments in which there are parallel words. In the Old Testament references, the paired words are *ger* and *towshab* in each case. While both terms are used to define race, it is essential to determine the context in which they are used to verify which race is under discussion.



In Hebrews 11:13 the pilgrims and strangers are Israelites because the

book is written to the Hebrews;

those whose Fathers had been given the Law of Moses. In the other New Testament verses, it is not clear, at first glance, that they are Israelites. But, when we examine the Greek, we find similar terms - ones that identify Israelites in each context. And it is easy to verify that each reference is, indeed, to Israelites. These paired words do not teach that there are two groups of people, but rather that they all are Israelites in two different situations. When David said that he was *a stranger and a sojourner* [Ps 39:12], he was one person who was two things. *Strangers and aliens* are not necessarily two completely dissimilar groups of people in Ephesians 2:12 and Ephesians 2:19. In this case they are one group of people who are two things. This follows exactly the same pattern as presented in the

Old Testament.

When we compare what David is saying in Psalm 39:12 with what Peter is saying in 1 Peter 2:11, we find a common distinction. David refers to *all my Fathers* who were, of course, Israelites. Peter is addressing *the Elect* and not others. This book of Peter is written to *strangers* [parepidemos: visitors] *scattered*. Note this well; there is no way around it! This cannot be spiritualised to make it refer to some non-Israelite multi-racial church! Both David and Peter are saying they have no kinship with the races among whom they (Israel) are temporarily living (that is, for the duration of their lives). We find a remarkable affinity and agreement between both Testaments. In both, Israel is totally exclusive. It is now even more difficult to insist that these so-called “gentiles” are non-Israelites!

Before we leave this subject of strangers, let us consider another very significant Scripture. *John 7:35... will he go unto the dispersed among the Gentiles* [Hellenes: Greeks] *Greeks and teach the Gentiles* [Hellenes: Greeks].

As we know, the *dispersed among the Greeks* relates to the *Lost sheep of the House of Israel* whom Jesus says He came for only [Matt 10:6 and 15:24]. Those *lost sheep* were the only ones the disciples were instructed to visit. Come now and let us reason together. Could the disciples go to proclaim the Gospel of the Kingdom to a race they could not find because they were *lost*? They were not so lost that they could not be found, were they? [*Lost*, in this context, has to do with Israelites put aside for punishment].

To read the parables of Jesus in the light that these *lost sheep* are the House of Israel is enlightening! The lost sheep are never non-Israelites! When we come to the regathering of those “strangers” who are scattered, how could it ever be a regathering of any other than that exclusive race of Israel who were scattered in the first place?

When we look again at the 1 Peter 2:9 we find these particular strangers [of 1 Peter 1:1] were:

[a] Chosen ... [Isaiah 41:8 ... *Jacob whom I have chosen*]

[b] A Royal Priesthood ... [Isaiah 61:1 , Hosea 4:6 etc.]

[c] An Holy Nation ... [Deut 14:2]

Please note that “nation” is singular in this context. Some may still wish to deny these “holy” (set-apart) people still exist as being different from all other nations. But Peter knew they still existed when he wrote to them.

[a] A peculiar people [Exodus 19:5 , Deut 26:18 , Psalm 135:4].



Israel and Judah were taken into their respective captivities because of their continued

disobedience under the Law. Following the captivities these people moved away from Palestine because God had cast them out of that land. On top of being scattered, they also

lost all knowledge of their law, which means they lost the rituals for reconciliation with God. They were lost as members of the eternal Kingdom of God. However, as a nation of people they did not cease to exist (Jer 31:36,37 and Jer 33:17). Jesus came for these people because, by making the ultimate sacrifice, they no longer needed the Levitical Law as the means of reconciliation with God. They could “go direct” by prayer in Jesus name, because He is now the Mediator for the individual Israelite. It was still limited to Israelites because:

[a] Only they had broken the Law.

[b] Only they had the indwelling spirit that needed to save from eternal death.

The physical location of the Dispersed Tribes was well known up to the time of the destruction of the Temple in 70 AD. After that, with no Temple in Jerusalem as a focus for ceremony for those who wished to make the journey, the whereabouts of these people was forgotten over time. Nevertheless, the existence of the sun, the moon and the stars says the nation of people still exists today. The words of Jeremiah’s prophecy are quite definite and cannot possibly apply to a

“church”.

As a separate matter of prophecy, the nation of Israel would always have a monarchy ruling over them, from the site of the official throne. This is sometimes confused with 1 Peter 2:13 which refers to the people respecting the authority of the King. This is a different matter – the teaching throughout the New Testament, even for the Judeans, is to obey the civilian authorities of the day, (render unto Caesar, etc), and not to foment social upheaval. This directs us to stand up for what is right when formal opportunities and mechanisms are available, but not to incite social unrest by going outside the formal system.

When we go to the book of Hebrews and consider these *pilgrims and strangers*, the *Fathers* and the “Patriarchs” are prominent. God who spoke to these Fathers by the Prophets, *hath in these last days spoken unto us by His Son*. We can pretend all we like that the children are now spiritual children, but the Bible still insists that the New Testament is only made with the House of Israel and the House of Judah [Heb 8:8]. How would these Houses be spiritualised? The quoted prophecies are those made to Israel! Israel is still just as exclusive, today!!

Misconceptions About Josephus, The Judean (2) Or, How To Tell the Difference Between a Jew and an Israelite!

The buzzword is designed to make you react in an **EMOTIONAL** manner, preventing you from hearing the rest of the "extremist's" rhetoric! Of course,

once you know what the buzzwords are, your knee is less likely to jerk!

But, be careful, if you keep reading, you might become an "anti-Semite" – even though the Jewish people have less Shemitic blood in them than the Palestinians! Those who escape the hammerlock are often thrown out of the ring and taken to jail for daring to refute their enormous edifice of lies. That's what the ADL is for. Those who persist in challenging Jewish fables and Jewish tactics often wind up dead. That's what the Mossad is for. Censorship and murder in the name of G-d!

Most Judeo-Christians will view my definition of Judaism as excessively harsh. On the contrary, my view of Judaism is in perfect accord with that of Jesus Christ, who was neither a Jew nor a rabbi. Christians who think that Jesus was either of these have not read the Scriptures with a clear mind (nor have most of these "Christians" even read the Scriptures, period, clear-minded or not, superficially or not), having left the reading and interpreting to the pulpit masters of the false denominations, who, by the way, get their instructions from the very same rabbis who invented Judaism. Since the world's academics are likewise either deceived or intimidated by the Jewish Thought Police, they also have absorbed the sloppy thinking promoted by these very same deceivers, as if they were the final authority on Scripture.

Or, to put it bluntly, **modern Judeo-Christianity has allowed the Devil to interpret Scripture for them.** Even the most erudite scholars have fallen for these deceptions because they do not understand the true nature of Judaism, nor do they understand the history of the period between the Return from Babylon until the time of Christ.

The rabbis teach that Judaism was brought back from Babylon by Judahites. The reason they teach this lie is to create the impression that their tradition is of Judah. **But the people of Judah never practiced Judaism. They practiced the Mosaic Law.** Read these last two

sentences again, for in them is the historical fact. The rest of this article will be devoted to explaining the significance of these two facts. By juxtaposing Judaism and Mosaism together in a false rendition of history, the rabbis have equated opposites.

Some Historical Perspective



When Judah was subjugated and carried away captive to Babylon, they were a multitude. During this 70 years of captivity, some Judahites became Babylonians. **Most of those who returned to Judea did not.** The books of Ezra and Nehemiah clearly tell us that the Return was a very powerful REVIVAL of the Mosaic Law, not a departure from it. This is a point that virtually all scholars have wrong, thanks to Jewish deception. The Prophet Daniel was one of those captives. By refusing to eat the cuisine of the Babylonians, he incurred the wrath of the king, Nebuchadnezzar. But Yahweh saved Daniel for his adherence to Yahweh's Law, and Daniel became Nebuchadnezzar's most trusted advisor!!! Thank you very much! Contrary to what many believe, Daniel, Jeremiah, Ezra and Nehemiah NEVER adopted ANY BABYLONIAN CUSTOMS. They stayed faithful to Yahweh and Moses.

The handful that returned to the land of Judah from Babylon were clearly those who honoured their Judahite/Israelite/Mosaic heritage the most. This is contrary to what the Jews teach, for they teach that these Judahites brought the Babylonian Talmud with them. That is a diabolical lie, a lie which is designed to fool us into thinking that the Judahites of Judea accepted Babylonianism when, in fact, Babylonianism did not creep into the priesthood until the Pharisees arrived on the scene much later (around 150 B.C.). The point of this deception is to give the Jews credibility for their Talmudic doctrine, which they attribute to True Judah, so therefore they must be True Judah also, since the two groups practiced the same doctrine. NO, they

DID NOT! Talmudism has always been an EXCLUSIVELY JEWISH AFFAIR. True Judah never followed the rabbis because there were no rabbis in those days.

The rabbis' main purpose is to cast confusion and obfuscation upon True History, so that they can claim Judahite heritage as their own.

As will be shown in this discussion, Talmudism did not rear its ugly head until the last days of the Hasmonean Dynasty, a Dynasty which was targeted by the Talmudists for a coup. Or, to use a Jewish slogan, "When your enemy is down, kick him harder."

Here is the significant point: By claiming that Judaism existed among the Judahites of Judea, they deflect our attention away from the fact that Judaism was begun by the Edomites who surrounded Herod, the Idumean. They want you to believe that Judaism is equivalent to Mosaism. And they want you to believe that Judaism is a continuation of Mosaism. **The only way you can believe that is if you know nothing about Judaism.**

The crucial period between the Return of the Judahites from Babylon to the time of Christ is referred to by scholars as the "Intertestamental Period," so-called because the events of the time are not recorded in either the Old Testament or the New Testament. But if you count the Apocrypha, **which were originally a part of the King James Bible of 1611**, this designation is seen to be clearly deficient, because the Books of Maccabees, Tobit, Judith, and Baruch give us many details of what happened after the book of Malachi and before the Gospel of Matthew. It was not until 1885 that the Apocrypha were deleted from the King James Bible. These books provide us with a wealth of information that prove that the Judahites of Judea were endeavouring to remain true to their Race and to their Religion, modern interpretations notwithstanding. Do you think that some particular group might have had an agenda in deleting these books?

Why were these Books deleted? Whose decision was it to delete them?

The total number of references to the Apocrypha in the margins of the original King James as printed in 1611 is 113. Of this number, 102 are in the Old Testament. The New Testament passages with references to the Apocrypha are as follows:

If Matthew, Luke, John and Paul saw fit to quote from the Apocrypha, shouldn't you know about it?

Only when we have an accurate view of our own history can we see through the historical deceptions of the rabbis and their patsies, the Catholics (the first Universalists), Mainstream Protestants, the Fundamentalists and the Christian Zionists, all led by their goat-herders, the televangelists, the aptly misnamed "God Squad" of deception. This Devil's Advocacy Team has infected Christianity to the point of near oblivion, distorting both our history and our religion to where modern Christianity and the Christianity of the Apostles have become diametric opposites. Of course, this opposition is the point that I hope to prove in this article. I will let you decide whether I am "rightly dividing the Word."

The Exclusive Covenants

There is NO POSSIBLE WAY that what is today called "Judeo-Christianity" can be resolved with Biblical Christianity. Biblical Christianity is based on the EXCLUSIVE COVENANTS that Yahweh, Our Elohim, made with the **Children of Israel**. There is NO OTHER ENTITY or persons involved in these contracts between Yahweh and His Chosen People (the linear descendants of Abraham, Isaac and Jacob). No third parties, such as the "Evangelical Church" or "the Jews" or "Spiritual Israel" or "Judeo-Christianity" has any right to claim any legal or moral interest, whatsoever, in these EXCLUSIVE CONTRACTS. Gen. 5:1, a verse which tells us whom the Bible is about, says "THIS IS THE BOOK OF THE GENERATIONS OF ADAM," meaning Adam and his descendants. Abraham, Isaac and Jacob are Adam's direct descendants through Noah. The word translated as "generations" comes from the Hebrew toledaw, meaning "descent," or "family."

The Bible is the history book of Our Adamic Family. It is the story of our Family Tree. The

reason why Matthew and Luke recorded the genealogy of Jesus Christ is to prove his genetic descent from Adam and Yahweh. No Judeo-Christian minister will tell you this. They will tell you that this genealogy is irrelevant. If it is irrelevant, why did they bother to record it? The reason is very simple. Yahshua Messiah came to redeem Israel. It was Israel that was "put away in punishment," so only Israel needed to be redeemed. This is why He said, "I come not but unto the Lost Sheep of the House of Israel."

This is what the famous pastor W.G. Finlay of South Africa called the COVENANT MESSAGE. Since this doctrine also emphasizes the fact that True Israel is here to reestablish the Kingdom of God through the operation of the covenants and promises, it is also referred to as the KINGDOM IDENTITY MESSAGE. This is an exclusively Racial Covenant between Yahweh and His literal offspring, the Adamic / Hebrew / Israelite / Caucasian seedline. From this perspective, any doctrine which violates or denies the expressly stated purpose of these Covenants is HERESY, plain and simple. The claim that the WHOLE WORLD or that all the people of this planet were redeemed is a fabrication. On the contrary, only True Israel was redeemed because we are the people who were "lost." That word 'lost' is translated from the Greek apollumi, meaning, very specifically, "put away in punishment." Only the House of Israel was put away in punishment. And only the children of Israel are the subject of this Scripture anyway!



Judaism and JudeoChristianity both qualify as outright heresy because neither is mentioned in the Bible as being a party to the Covenants. Morally, BOTH violate Yahweh's Laws by inventing and teaching doctrines that cannot be found in Scripture, either in the Old Testament or in the New Testament. Thus they both violate the terms of the conditions of the PROMISES that Yahweh gave EXCLUSIVELY to the Children of Israel, and NO ONE ELSE. You might be astonished to learn that Judaism is, in fact, NEVER MENTIONED by name or found in any page of the Holy Scriptures! This is yet another devastating example of the

venting and teaching doctrines that cannot be found in Scripture, either in the Old Testament or in the New Testament. Thus they both violate the terms of the conditions of the PROMISES that Yahweh gave EXCLUSIVELY to the Children of Israel, and NO ONE ELSE. **You might be astonished to learn that Judaism is, in fact, NEVER MENTIONED by name or found in any page of the Holy Scriptures!** This is yet another devastating example of the

historical charade Judaism has perpetuated for the last 2,000 years.

Yahshua HIMSELF refers to the religion of the Old Testament as "the Law and the Prophets." Indeed, **Judaism originated outside of the Old Testament in pagan Babylon**; and it is still today being palmed off to the public as the religion practiced by the Israelites of Scripture. The fact that today's religious world equates the Mosaic Law with Judaism is one of the most astounding feats of advertising the world has ever seen. Although Judaism is not mentioned by name ANYWHERE IN THE BIBLE (if you don't believe me, start looking!!), it is first referred to in the New Testament at Matthew 15:2. Here, Jesus Christ (Yahshua Messiah) is passionately confronting the scribes and Pharisees, who have developed a NEW, ANTI-MOSAIC TRADITION, as Yahshua tells them:

"Why do you also transgress the commandment of God by your tradition? For God commanded, saying, Honour your father and mother: and, He that curses father and mother, let him die the death. But you say, whosoever shall say to his father or his mother, it is a gift, by whatsoever you might be profited by me; and honour not his father or his mother, **he shall be free. Thus have you made the commandment of God of none effect by your tradition.** You hypocrites, well did Isaiah prophesy of you, saying, This people draweth nigh unto Me with their lips; but their heart is far from Me. **But in vain do they worship Me, teaching for doctrines the commandments of men.**" (Matt. 15: 1-9). This episode is repeated for us at Mark 7:3-13.

Those Christians who have bothered to actually read the New Testament are aware of the fact that Jesus Christ denounced the scribes and Pharisees as hypocrites on EVERY SINGLE OCCASION that He confronted them. Likewise, He NEVER failed to denounce their CORRUPT teachings, so there is no possible way that Yahshua considered these scribes and Pharisees as teachers of God's commandments. On the contrary, He denounced them as teachers of false doctrine that contradicted the clear teachings of the Law of Moses. Has your "pastor" ever explained this fact to you? I'll bet he has not ever bothered to mention this very important fact!

Pharisaism Became Known As Judaism

It is these same Pharisees who contrived to put OUR BELOVED LORD JESUS to death. Now,

the 1942 **Universal Jewish Encyclopaedia, Volume VIII**, p. 474, tells us this:

"The Jewish religion as it is today traces its descent, without a break, through all the centuries, from the Pharisees. Their leading ideas and methods found expression in a literature of enormous extent, of which a very great deal is still in existence. The Talmud is the largest and most important single member of that literature."

Stop now, dear Christian, and consider the fact that Yahshua's worst enemies were the inventors of the religion of Judaism. I find it to be quite incredible that so few Christians understand the significance this conflict. To the average Judeo-Christian, Yahshua's confrontations with the scribes and Pharisees are little more than a curiosity, if they know anything about them at all.

I would venture to say that the Gospel message contains equal parts of His performed miracles and of the enmity between Yahshua and the Pharisees, yet few Christians can give you any indication of latter. The black marking, to coin a term, of this message has been so thorough that you might as well take a black magic marker and black out every reference to the scribes and Pharisees.



Scriptural documentation of Pharisaic HYPOCRISY is like a big fat T-Bone steak on your plate, but the Scripturally-challenged prefer to dine on Kosher Ham instead.

Please ask your "pastor" why he has never preached a sermon about this hypocrisy of the Pharisees, especially since this subject occupies about one-fourth or more of the Gospels narrative.

Now, any rational person who has read the New Testament will see very clearly that Judaism is one and the same with the "leaven of the Pharisees" of Luke 12:1. And the rabbis of Judaism have never renounced their traditions. Therefore, there is only one possible conclusion. The religion of the Pharisees is the religion of hypocrisy; and the epitome of that hypocrisy and the epicentre of the historical deception is the

pretence that Pharisaism is based on the Old Testament. The New Testament is ample witness of the fact that Judaism is the religion of the Pharisees; but, paradoxically, modern Christians are blinded to this fact and are seemingly unable to put two and two together to come up with four. The deluded Christian world has eyes that cannot see and ears that cannot hear.

Let's see if this formula gets it right:

Pharisees + Deception = Judaism.

Or, perhaps even better:

**The Mosaic Law + Pharisaic Deception =
Judaism.**


The rabbis of Judaism know full well that they are one and the same with the practitioners of the "tradition of the elders" that Yahshua Messiah so thoroughly condemned. This is why Jews hate the New Testament and want to outlaw it! This is why there was a world-wide outcry by Jews against Mel Gibson's movie, "The Passion of the Christ," for a full year before it was even released. But, of course, they are not going to admit publicly the intimate connection between the Pharisees and Judaism, for no hypocrite ever publicly admits his hypocrisy. No thief wants to go to jail. No traitor wants to be exposed. No whoremonger wants to give up his sex toy. No practiced deceiver ever wants to give up his CON GAME. The liar and his family have become pathological. He just keeps on lying until he is caught in his lies, or until the victims have had enough of his evil machinations. And as long as the academics cooperate by remaining silent about these discrepancies, the Jews don't worry much. They also control the public schools, the curriculum (including "holocaust" studies), our sexual preferences, our entertainment choices and our reading habits, not to mention our choice of Bibles.

The False Shepherds of Christendom

Christianity's problem is that there are no Christian ministers who have the guts to call the rabbinical bluff. Only those of us in Christian Identity are exposing this historical origin of Judaism. All others play the game of equating Judaism with Mosaism.

The Twentieth Century has witnessed an astounding about-face on the part of Christianity vis-à-vis Judaism. For nearly 2,000 years, it was axiomatic that Judaism and Christianity were diametric opposites. Simply put, Judaism was

the religion of the rabbis. Christianity was the religion of Jesus Christ. Both sides never even bothered to question this arrangement, realizing that this was indeed the case, with these two diverse societies having almost nothing in common except commerce, with the Jews doing the money lending and the Christians doing the borrowing. Religiously, socially and historically, Jews and Christians were as far apart as their respective doctrines, like dogs and cats in the same neighbourhood. However, in the mid 1800's, the Jewish House of Rothschild began to mount a subtle, covert and quietly relentless propaganda campaign, based on deceptive advertising and the ongoing purchases of publishing houses. In the 1800's, the Rothschilds even tried to obtain a monopoly control of the paper industry, so as to prevent a Free Press from operating.



That pro-Zionist advertising campaign began with the hiring of one CI Scofield (left), a family deserter, convicted forger and con artist, who issued the Scofield Reference Bible. The purpose of that "Bible," and the ongoing brainwashing that his "Bible" represents,

was to gradually and systematically superimpose Talmudic doctrine over the anti-Judaic teachings of the Christian Bible.

Today, over 150 years later, this persistent and relentless brainwashing campaign has resulted in another new tradition – another bastard child, if you will. Its name is "Judeo-Christianity." This new religion, just like its predecessor, the "tradition of the elders," is diabolically clever in that it Satanically commingles Pharisaic and Scriptural teaching, not one Christian in a million being aware of the deception. Thus, Judeo-Christianity today has become the modern version of Pharisaism; and these Christians have become the complete and willing dupes of the Judaic tradition. Christians have been conditioned to give Judaism credit for composing the Old Testament, when the exact opposite is true. Hiding behind a false tradition, Judaism extorts nothing short of worship from deceived Christians who falsely believe that Judaism is the

same religion from which Jesus and the Prophets taught.

They believe the damnable lie that "Christianity owes its origins to Judaism." On the contrary, Christianity owes its origins to the Old Testament. Judaism owes its origins to Babylon and Idumea.

A Thumbnail Sketch, Hollywood Style



If this were a plot for a movie, it would go something like this: In Scene One, the Hero returns home after a long absence to redeem His family (Christian Israel) from their present state of subjection to an evil landlord. Prior to the Hero's appearance, a secret agent of the landlord had knocked on the family door, insisting that the Hero had long since died. This agent, claiming to be a forgotten relative, was contriving to steal the inheritance of the Hero's family by impersonating a family member.

Scene Two: The Hero discovers the plot and learns of the agent's impersonation. Before He is able to warn the family about what is going on (the Bible prior to Talmudic and Masoretic tampering), the villain ruthlessly murders the Hero, leaving the family ignorant of their predicament. But the elders of the family sense that there is something wrong, so the villain wisely extricates himself and goes into hiding until the family forgets all about him.

Scene Three: Patiently biding his time, he waits until he thinks the family is sufficiently distracted by their ever-growing problems. With the elders grown old and feeble and many dead, the villain returns once again when the family has totally forgotten about him. Subtly, he once again claims kinship as a long, lost heir. The compassionate family members take pity on him, although some members only begrudgingly accept his story. When he mentions the inheritance that the family is due, wanting only to claim his "share," he is told, "We'll wait until

the day the Will is read, and then we'll sort it all out."

Scene Four: The villain, realizing what must be done, contrives to kill the real heirs while building up a false resume of his own family relationship. He presents the family with an elaborate family tree with himself prominently figured. With the elders gone, the family has no way of verifying or disputing his claim. Thus, when it is time for the Will to be read, he hopes to be the only, or the eldest, "heir" remaining, thus claiming the entire inheritance. His act is so convincing that the surviving family members are set at odds against each other (Judeo-Christianity versus Christian Identity), even killing each other in the name of the Hero, while the villain rubs his hands in gleeful anticipation of inheriting the estate (Kingdom).

Sound far-fetched? Hollywood has had blockbuster hits with lousier plots!!

The question is: How will this thriller end? The answer is contained in the Parable of the Wheat and the Tares in Matthew 13.

Yahshua Messiah foresaw this confusion of the heirs and predicted it when He said: "They shall put you out of the synagogues: yea, the time comes, that whosoever kills you will think that he doeth God service." (John 16:2) Ultimately, the Jews took control of the synagogues and put the True Judahites out of them. They have been impersonating Judah ever since.

Indeed, the rabbis of Judaism took over the synagogues and threw the Apostles, who were True Judahites of the House of Judah, and their true Christian followers out of them. Even today, the Jews reserve the right to call their temples "synagogues." Given this prophecy, it should be obvious who they are: the synagogue of Satan. Despite all this contrary evidence, the world's Judeo-Christians, continue to labour under the false assumption that they are doing God service by paying obeisance to the rabbis. They are filled with the bloodlust of Zionism, donating their time and money and even their very lives in military campaigns, to a completely delusional cause.

No greater catastrophe could have ever befallen mankind. Christianity has been brainwashed into becoming anti-Christianity (Judeo-Christianity), and this anti-Christianity is being shouted from the pulpits, with bells ringing and choirs singing, from every denomination in the Name of Christ. The ONLY denomination

which stands as a rock against this deception is Christian Identity.

"Beware of false prophets, which come to you in sheep's clothing, but inwardly they are ravening wolves." (Matt. 7:15) The sheep do not have the discernment to see the wolf hiding behind the disguise because they have not read the Scriptures for themselves, thus they are blind sheep unable to see the truth. They blithely accept the modernistic interpretations coming from the Rothschild/Scofield seminaries of falsified theology, from which the Gospel of Jesus Christ, the COVENANT MESSAGE of redemption and repentance, has been perverted back into the "traditions of men."

(Isa. 60:1) Shake the sleep out of your eyes, stop grumbling about having to leave your warm, cosy bed, and prepare for the fight of your lives. Armageddon has arrived.

"Even so every good tree brings forth good fruit (peace and justice); but a corrupt tree brings forth evil fruit", i.e., corruption, violence and war, especially the phony "God is on our side" type of war that is crucifying the Palestinian people at this very moment, while the Judeo-Christians yawn and partake of Jewish animus served with flowery "Christian" rhetoric, plus a huge helping of hypocrisy and a collection plate full of the Devil's currency.

The Fairy Tale **By Dr. Oren F. Potito**



IMEDIATELY after the end of World War II, the Jews began circulating the report that Hitler had killed 12 million Jews, but there never were more than 16 million Jews in the entire world, even if it seems like that many in your own city! And there

were never more than 6 million Jews in all of Europe. It was certain that someone would "get wise" and point out the absurd nonsense of this

twelve million "fairy tale", so they finally changed the BIG LIE and reduced the "Jewish fable" from twelve million killed to six million killed. But even this is a complete lie! Kurios, Theos: Greek Substitutes for Name

Recent discoveries of Greek manuscripts of the Old Testaments reveal that the sacred Name was preserved in Hebrew or Aramaic letters in the first and second centuries B.C.E.

observes, "From these findings we can now say with almost absolute certainty that the divine name hwhy was not rendered by Kurios [*Kurios*] in the pre-Christian Greek Bible, as so often has been thought. Usually the Tetragram was written out in Aramaic or in paleo-Hebrew letters or was transliterated into Greek letters" (Vol. 96, 1977, p. 65).

Writings in the **Journal of Biblical Literature**, professor George Howard

The Greek translators later entirely eliminated the Hebrew Tetragram, a Greek word meaning

“four letters,” substituting the Greek *Kurios* [Lord] or *Theos* [God] for the Hebrew Tetragrammaton, as they believed that the Greek text was as sacred as the Hebrew. However, neither *Kurios* nor *Theos* is a transliteration of the Hebrew hwhy. *Kurios* and *Theos* are not names. They do not represent the Tetragrammaton, nor do they have the same meaning.

Howard writes, “Toward the end of the first Christian century, when the church had become predominately Gentile, the motive for retaining the Hebrew name Yahweh was lost and the words kyrios and theos were substituted for it in Christian copies of Old Testament Septuagint’s ..Before long the divine name was lost to the Gentile church except insofar as it was reflected in the contracted surrogates or remembered by scholar,” *Biblical Archaeology Review*, March 1978.

Thus, the sacred Name not only was obscured by zealous Jews, but also the Greek substitutes soon found their way into both the Old and New Testament translations.

Why the Terms ‘God’ and ‘Lord’?

It can readily be seen that if the Greek text was considered as sacred as the Hebrew, then the Greek replacements for the Tetragrammaton were thought to be on an equal footing with the Hebrew Name. When the Bible was translated into other languages, the Greek texts were used because translators had a better understanding of the Greek than they did the Hebrew.


Being that *Kurios* and *Theos* are Greek terms, a more familiar substitute was customarily used in each language in which the Scriptures were translated. Thus, “Kurios” was rendered “Lord” in English texts and “Theos” was replaced with “God.” These designations, however, should never have been used as surrogates for the sacred Name. Their connotations tell why.

Lord comes from the Old English *hlaford*, meaning “keeper of the loaf.” It refers to a person who feeds dependents, as in the head of a feudal estate (**Webster’s New World Dictionary**). The meaning of Lord corresponds almost precisely with the heathen deity Baal. “God” derives from the Old Teutonic root *gheu*, meaning to invoke and to pour, as in a molten image (“God,”

Oxford English Dictionary). (See further explanations below.)

This base root for god, *gheu*, has another derivative – giddy—from the Old English *gydig*, and *gidig*, meaning “possessed, insane, from the Germanic *gud-igaz*, “possessed by a god” (**American Heritage Dictionary** under *gheu*). This source makes the remarkable statement, “Giddy can be traced back to the same Germanic root *gud*-that has given us the word God.”

Ancient Roots of ‘God’ and ‘Lord’




Many Bible references reveal that the Hebrew word “Baal” has the same meanings as our English word “Lord.” See the footnotes and center column references on Hosea 2:16 in various Bibles (for example: “Baali = My Lord” – **Companion Bible** note). Throughout the Book of Judges we find that Israel continually fell back into the worship of the Baalim (Lords). In 1Kings 16:29-17:1, Ahab became a king and plunged Israel into full-scale Baal worship. An interlinear version will show that in 1Kings 18:19 and 21 the word is “ha Baal,” meaning “the Lord.” For an apostate Israel, Yahweh had become the “ha Baal” (the Lord) of Israel. (See top of page 37, “Baal – Lord”.)

Rather than having a special, close relationship with Israel through His Name, Yahweh now found Israel worshiping in a common title used for the idols of the nations around them.

The prophet Isaiah excoriated Israel for their abominations in serving pagan idols. One of the most prominent was the Syrian god of fate or luck, otherwise known as Gad: “*But you are they that forsake Yahweh, that forget my holy mountain, that prepare a table for that troop, and that furnish the drink offering unto that number*” (Isa. 65:11). “Troop” is translated from the Hebrew Gad, pronounced “God” (see **Strong’s Hebrew and Chaldee Dictionary**, No.

1409, and note the phonetic *Gawd* in this reference.).



Our word “God” and its Germanic roots “Gott” and “Gut” are connected to the ancient Syrian idol “Baal Gad,” which Yahweh judged Israel for worshiping. The **New Bible Dictionary** says of Gad, “A pagan deity worshiped by the Canaanites as the God of Fortune for whom they ‘prepare a table’”

(Isa. 65:11)

Read what The **Anchor Bible Dictionary** says about “Gad”: “A Deity (or spirit) of fortune mentioned in Isa. 65:11 as being worshiped, along with Meni (a god of fate or destiny), by apostate Jews, probably in postexilic Judah,” Vol. II, p. 863. Further, this resource tells us, “The place name Baal-gad (Josh. 11:17) could be interpreted as ‘Lord Gad’ or as involving an epithet (gad) joined to the divine name Baal” (ibid.)

Do you grasp the significance of what you just read? The heathen nations that Joshua was directed to destroy had a place called Baal-gad, which is none other than “Lord-God,” a reference to Isaiah 65:11 and the worship of this “deity” by those who forsake Yahweh! As the Anchor Bible Dictionary affirms: “The apostates of Isa. 65:11 were looking to Gad [God], not Yahweh, as the source of well-being and prosperity” (Vol. II, p. 864).

In Hastings’ **A Dictionary of the Bible**, we find that the word Gad or God was “originally an appellative” and used as a divine name in pagan worship (see *Gad*, p. 76).

Lips Speaking Guile

A few who would contest the truth of the sacred Name will counter with an argument like, “You are saying that I need the exact Hebrew pronunciation of the Savior’s Name or I have no salvation. So anyone with a lisp and unable to form the exact Name as in Hebrew is lost.”

With this argument they summarily reject the ONLY NAME under heaven given to mankind

for salvation by Yahweh Himself. Acts 4:12 says there is only ONE Name by which we are saved. “*Neither is there salvation in any other: for there is none other name under heaven given among men, whereby we must be saved.*”

Rest assured that He Who has created man’s tongue would not give us a Name we cannot pronounce! If a physical disability makes the Name difficult to pronounce, Yahweh would surely look with favor on one’s willingness to do so regardless of the success. Yahweh seeks a ready and compliant heart (2Cor. 9:7); that is what matters. We are to walk joyfully in all truth as Yahweh reveals it to us, growing in grace and knowledge, Ephesians 4:13.

Some may also ask whether those who never knew or called on His saving Name in their lifetimes would be relegated to the lake of fire. The teaching of Scripture is that we are judged by what we know, not by what we don’t know. If we don’t know something is wrong, we must first be taught that it is wrong before we can be held accountable. This is clear from Acts 17:30, in what Paul told the ignorant Athenians who were worshiping idols on Mars Hill:

“And the times of this ignorance Yahweh winked at; but now commands all men everywhere to repent” (Acts 17:30). “Winked at” means overlooked. What constitutes sin for which we are held accountable is when we know the truth but reject it (James 4:17). (See Yahshua’s comment in Matt. 11:21-23.)

His People Will Revere His Name

Posing arguments to circumvent the Name is nothing but a futile attempt to spurn deeper truth. It amounts to sheer rebellion—a stubborn effort to absolve oneself of any responsibility to call upon the one and only revealed, saving Name.

The real test is whether one seeks to follow ALL truth without argument or polemics, and to do so as closely as one is able. As we demonstrate our complete desire to rid our worship of every error, Yahweh sees our dedication and adds His blessings to our obedience.

Yahshua said that the mark of His true Assembly is that it would not reject His true Name. He tells the true Philadelphia Assembly, “*I know your works: behold, I have set before you an open door, and no man can shut it: for you have a little*

strength, and have kept my word, and HAVE NOT DENIED MY NAME” (Rev. 3:8).

We must revere and call upon His rightful Name with the deepest respect and reverence, because it belongs to our soon-coming King. We may choose to deny His Name now, but we will not DARE deny it as we prostrate ourselves before the King of the universe when He comes in His full, majestic glory and in His royal Name Yahshua!

For those who reject the Name and scorn those who hallow it, Yahweh issues some stern warnings. *“Hear the word of Yahweh, you that tremble at his word; Your brethren that hated you, that cast you out for MY NAME’S SAKE, said, Let Yahweh be glorified: but he shall appear to your joy, and they shall be ashamed”* (Isa. 66:5).

Do YOU Break the Third Commandment?

To those who consider themselves sincere Bible students striving to please our Heavenly Father by keeping His Commandments, the following should prove most interesting. Many verses in the Bible teach that the truly converted who love Yahweh will keep His Commandments dealing with proper worship of the Heavenly Father (Deut. 6:5-6; John 14:15, 21; 1 John 2:5; Rev. 22:14).

“For this is the love of Yahweh, that we keep His Commandments: and His Commandments are not grievous” (1 John 5:3).


Sabbath-keeping groups, especially, strive to keep the Commandments, contending that they properly keep every one of the Ten. But the Third Commandment is the most overlooked or ignored of all the Ten! It is broken virtually every day.

The Third Commandment expressly deals with the holiness of Yahweh’s Name. *“You shall not make wrong use of the name of Yahweh your Elohim: for Yahweh will not leave unpunished the man that misuses His name,”* TSS. Ridiculing, disregarding, ignoring or denying His Name and using a substitute is certainly the wrong use of His Name, and is breaking the Third Commandment.

Many Called By His Name – Yesterday and Today

The short form “Yah” in the Name “Yahweh” is found in the King James Version in Psalm 68:4, where modern translators mistakenly rendered it “Jah.” As we know by now, the **J** should be a **Y**.

The poetic form “YAH” is found as the suffix in many Hebrew names such as IsaYAH, JeremiYAH, ZachariYAH, ZephaniYAH, HezekiYAH, and NehemiYAH. His Name is also found in the prefix of a number of Hebrew names such as YAHchobed (Jochobed, mother of Moses), YAHed (Joed), YAHel (Joel), YAHezer (Joezer), YAHha (Joha), and YAHnadab, (Jonadab). Most of these have also been disguised with the mistaken letter J.



Many of the Psalms command and encourage all to call upon Yahweh’s Name. Notice these examples, taken from **The Sacred Scriptures**, which instead of the title “L-rd,” has the proper names restored:

“I will give thanks to Yahweh according to His righteousness: and I will sing praise to the NAME of Yahweh most high.” (Psalm 7:17) *“O, Yahweh, our Sovereign, how excellent is your NAME in all the earth. Who have set your glory above the heavens.”* (Psalm 8:1)

“O Yahweh, our Sovereign, how excellent is your NAME in all the earth.” (Psalm 8:9)

“I will sing praise to your NAME, O you Most High,” (Psalm 9:2)

“And they that know your NAME will put their trust in you: For you, Yahweh, have not forsaken them that seek you,” (Psalm 9:10)

“Therefore I will give thanks to you, O Yahweh, among the nations and will sing praises to your Name.” (Psalm 18:49)

“Some trust in chariots, and some in horses; But we will make mention of the NAME of Yahweh our Elohim.” (Psalm 20:7)

“I will declare your NAME to my brethren; in the middle of the assembly I will praise you.” (Psalm 22:22)

“Save me, O Elohim, by your NAME, and judge me in your might.” (Psalm 54:1)

“Sing unto Elohim, sing praises to His NAME: cast a highway for Him that rides through the deserts; His NAME is Yah; and exult before Him.” (Psalm 68:4)

The Psalms are for everyone to read, as both the Savior and the New Testament writers frequently quoted from them. The Psalms are filled with admonitions calling our attention to the importance of Yahweh’s awesome and powerful name. They cannot be ignored.

The title of the Bible book following Deuteronomy properly should be “Yahshua,” not Joshua. It is the same Hebrew name as our Savior Yahshua. The question naturally arises, why do we not find Yahweh’s and Yahshua’s name in our Bibles? Certainly if the sacred Names are

that important, then we should find the name of the Heavenly Father and His Son on almost every page. The Bible lays the blame at the feet of the scribes and translators:

“How do you say, we are wise, and the law of Yahweh is with us? But behold, the false pen of the scribes has worked falsely,” Jeremiah 8:8,


“Which think to cause My people to forget My NAME by their dreams which they tell every man to his neighbor, as their fathers have forgotten My NAME for Baal.” (Jeremiah 23:27)

Through ignorance or by design the translators of the Bible were negligent in rendering the Mighty One of the Hebrews as Yahweh (His true Name) and that of His Son Yahshua and not Jesus. This will be very apparent in the field of education for our children. Yet the basic truths have not changed. As technology progresses and the genius of the human mind makes life more answerable to science we will see more and more science being turned into a religion. The new world motto will be "In Science we Trust". Just the other day the media was referring to a drug that will soon reverse the ageing process. The more I read the more I realise that the conversation between Satan and Eve is becoming the aim of modern science. This new science or knowledge is going to be used to not only answer all our problems but will present us with a whole new set of ethical values. The masses will be expected to trust the plans that have been set down for us.

It is no wonder that Christ said that those who teach that the Law is not to be considered will be least in the Kingdom of Heaven (Matthew 5:19).

It is obvious that man has failed in bringing about a society where there is genuine hope for

the future. Just recently I read a book by W. Harman entitled, "Global Mind Change - the Promise of the C21st". In this book the author highlights the issues that need to be rectified. On page 158 he says, "The fundamental question as we look ahead is not how we can stimulate more demand for goods and services and information, nor is it how we can create more jobs in mainstream economy ...The question is fundamentally spiritual, not economic". I can assure you the author is not suggesting the same spiritual answers as given in the Bible. In fact his spiritual solution is the spiritual wickedness in high places (Ephesians 6:12, 1 Timothy 4:1).

Like so many of the world's leaders they are highly intelligent, well educated in the wisdom of this world, articulate, and possess other qualities that not only attract great crowds but position of power and money. The interesting point about the book is that every issue he raises, can be solved if we only obeyed the Laws that God gave to Israel. It is also true that our biggest problem is spiritual and not economic. The Bible is very clear that faith is followed by works, not the other way around.

Satan and his legion know that the final battle will be over the issue of who controls the mind of man. There is not one political party that would present to the people a platform based on the view that the minds of man have to decide between Satan's system or God's system of governing. As I said at the outset of this article, there are still too many "Christians" who support the Democratic process of electing politicians. 

Monopoly - I did not know this!!!

You'll never look at the game the same way again!

STARTING IN 1941, an increasing number of British Airmen found themselves as the involuntary guests of the Third Reich, and the Crown was casting about for ways and means to facilitate their escape...

Now obviously, one of the most helpful aids to that end is a useful and accurate map, one showing not only where stuff was, but also showing the locations of 'safe houses' where a POW on-the-run could go for food and shelter.

Paper maps had some real drawbacks -- they make a lot of noise when you open and fold them, they wear out rapidly, and if they get wet, they turn into mush.

Someone in MI-5 got the idea of printing escape maps on silk. It's durable, can be scrunched-up into tiny wads and unfolded as many times as needed, and makes no noise whatsoever.

At that time, there was only one manufacturer in Great Britain that had perfected the technology of printing on silk, and that was John Waddington, Ltd. When approached by the government, the firm was only too happy to do its bit for the war effort.

By pure coincidence, Waddington was also the U.K. Licensee for the popular American board game, Monopoly. As it happened, 'games and pastimes' was a category of item qualified for insertion into 'CARE packages', dispatched by the International Red Cross to prisoners of war.

Under the strictest of secrecy, in a securely guarded and inaccessible old workshop on the grounds of Waddington's, a group of sworn-to-secrecy employees began mass-producing escape maps, keyed to each region of Germany or Italy where Allied POW camps were regional system). When processed, these maps could be folded into such tiny dots that they would actually fit inside a Monopoly playing piece.

As long as they were at it, the clever workmen at Waddington's also managed to add: 1. A playing token, containing a small magnetic compass

2. A two-part metal file that could easily be screwed together.

3. Useful amounts of genuine high-denomination German, Italian, and French currency, hidden within the piles of Monopoly money!

British and American air crews were advised, before taking off on their first mission, how to identify a 'rigged' Monopoly set -- by means of a tiny red dot, one cleverly rigged to look like an ordinary printing glitch, located in the corner of the Free Parking square.

Of the estimated 35,000 Allied POWS who successfully escaped, an estimated one-third was aided in their flight by the rigged Monopoly sets. Everyone who did so was sworn to secrecy

indefinitely, since the British Government might want to use this highly successful ruse in still another, future war.

The story wasn't declassified until 2007, when the surviving craftsmen from Waddington's, as well as the firm itself, were finally honored in a public ceremony.

It's always nice when you can play that 'Get out of Jail' Free' card!

I realize most of you are (probably) too young to have any personal connection to WWII (Dec. '41 to Aug. '45), but this is still interesting.



Sir,—herewith a copy of a letter sent to the FCO

Dear Mr. Sandars,

I was sent a copy of a letter that you sent, via email, to Mr. Rex Poulton dated today. I have his permission to respond to you.

The issue is very simple and that UK membership of the EEC, later to become the EU, was totally illegal. Edward Heath committed treason with the signing of the European Communities Act 1972. This violated the Act of Supremacy which was reissued by Elizabeth I in 1559. This Act along with all Constitutional Laws are the highest laws in the land. The Pirates of Finance

TWA 800 and Swiss Air 111 Similarities

On the evening of July 17, 1996, TWA 800 fell into the ocean 7 miles from the Long Island town of East Moriches. The plane had taken off from New York's JFK Airport and had been bound for Paris, France. All 230 people on board died.

Swissair 111 - September 2 (9+2), 1998. All 229 people on board died.

During the first year and a half of the inquiry, investigators from the National Transportation Safety Board and from the FBI concentrated on three matters: the possibility of a mechanical cause, the possibility of a bomb, and the possibility of a missile.

Like TWA 800, Swissair 111 is believed to have suffered an electrical catastrophe. In the case of Swissair 111 as in the case of TWA 800, the originating event remains mysterious: TWA 800's catastrophe involved the wiring in the central fuel tank and Swissair 111's catastrophe involved the wiring in the entertainment system located near the cockpit, but in neither case do investigators believe they have yet found the originating cause.

Timing Connection

Both planes started out on a route that took them east along the southern coast of Long Island.



TWA 800 began to fall at 8:31 PM, 12 minutes into the flight.

Swissair 111 flew for an hour longer than did TWA 800; it crashed off the coast of Nova Scotia at 9:31 PM Eastern Daylight Time (72 minutes from take off ($7+2 = 9$)).

The record of the difficulty, as widely reported in the press, begins at 9:14 PM (exactly 55 minutes since take off), when Swissair 111's pilot requests permission to make an unscheduled landing at Boston;

The two flights could have taken off on any two days of the week and at any two minutes of the day.

But as it happens, both took off on a Wednesday at 8:19 PM (3rd day of the week

MH370 took off on March 8 ($3 + 8 = 11$), Saturday (7th day of the week) at 12:21 am.

Last contact: 1:19 am (119 like Sep 11)


A friend asked me to figure out the number of weeks between two "accidents": the flights TWA 800 and Swiss Air 111.

Well, TWA 800 took off from JFK Airport on Wednesday evening, July 17, 1996, and exploded a few minutes later over the Atlantic Ocean, near Long Island. Swiss Air 111 took off from the same airport on Wednesday evening, September 2, 1998, and went down in flames into the Atlantic Ocean off the province of Nova Scotia, Canada. The number of weeks between these two accidents is exactly 111 (777 days), the same as the Swiss Air flight number. This is a very clear hoof print of the clandestine Luciferian Masons (CLuMs) who had sabotaged both airliners.

Conspiracy investigators have long realized that another such sabotaged flight was Pan Am 103. This third doomed flight was brought down over Scotland on December 21, 1988. December 21 is the Winter Solstice, a very important CLuM holiday. Notice also that Pan Am 103 was destroyed over Scotland, whereas Swiss Air 111 met its end near Nova Scotia, i.e., "New Scotland". Scotland is very important to CLuMs, since the Masonic Scottish Rite is the pre-eminent public Masonic body throughout the world.

The Scottish Rite (degrees 4 to 33) is also known as Red Masonry, as opposed to Blue Masonry, i.e., the lowest three Masonic degrees. Red Masonry has been associated with many blood-red conspiracies, such as the French Revolution of 1789 and the spread of Red Socialism and Communism throughout the world. Notice also that Pan Am 103's flight number contains the digits of 13, the most Masonically correct number. What is even stranger is that the time between Pan Am 103 in December 1988 and TWA 800 in July 1996 is 7 years and 7 months: here we have an occurrence of the number 77, the mark of the revenge of Lamech. Lamech was a descendant of Cain, the first murderer, and

father of Tubal-Cain, an important hero of the CLuMs. The Bible says the following about the mark of the revenge of Lamech:



“And Lamech said unto his wives, Adah and Zillah, ‘Hear my voice: ye wives of Lamech, hearken unto my speech: for I have slain a man to my wounding, and a young man to my hurt. If Cain shall be avenged sevenfold, truly Lamech seventy and sevenfold.’” (Genesis 4: 23-24)

Coming back to TWA 800 and Swiss Air 111: the time between them is 111 weeks, or 777 days. The number 777 contains the mark of the revenge of Cain (7) and the mark of the revenge of Lamech (77).

For those who would like to see more hoof prints, consider this: On Saturday, September 5, 1998, three days after the Swiss Air 111 disaster off the coast of Canada, the Swiss Ambassador to Canada was killed in an “accident” involving a train. His name was Daniel Dayer and he was killed in his own hometown, Sion, Switzerland. Sion, of course, means Zion. As CLuM luck would have it, Daniel Dayer had started his diplomatic career for Switzerland at his first posting in Tel Aviv, Israel, in 1968.

How biblical! A Daniel (a reminder of the apocalyptic Prophet Daniel), born in Sion (Zion), having started his career in Israel, meets his death back in Sion (Zion) in a transportation “accident”, right after another transportation “accident” of a Swiss carrier in Dayer’s service post, Canada.

This is a typical pattern of CLuM ritual human sacrifices: the “main event” is surrounded by other sacrifices of lesser importance to reinforce the message.

These three doomed flights, Pan Am 103, TWA 800, and Swiss Air 111, were sacrificed in

proximity to the Atlantic Ocean, burial ground of the legendary Atlantis, as a reminder of the New Atlantis Plot, the Great Work of CLuMs. The first sacrifice took place in Scotland and the last one off Nova Scotia, “New Scotland”. themselves who were instrumental in bringing forth the charges. And if that isn't the norm then they're undoubtedly there to make sure that the complainant (usually an agent in one form or another) gets the maximum support of their power and influence in the courts and the media.



The foundation for all of this pretence and deceit was laid at the end of the last world war when the Zionist-controlled U.K. and USA began cranking up their

deliberately orchestrated accusations that Hitler and the German military were guilty of having attempted to wipe out the Jews in Europe by gassing millions of them and then cremating the innocent souls in ovens to cover up their horrendously heinous crime. The Nuremberg Trials at the war's end were the focus of these fantastic claims of wilful genocide by gas and fire and the West, still mesmerized by the massive amounts of anti-German hate propaganda which they had been saturated with for the past six years, as well as being shell-shocked from all the fighting, killing, bombing and destruction, fell prey to this massive deception and was unwilling or unable to garner the moral fortitude or financial resources necessary to counter these outrageous lies of the powerful Zionist lobby.

Little did it matter that every confession by the captured German military commanders had been gained by torture. Little did it matter that the majority of those running the trials were of Jewish ethnicity. Little did it matter that laws which had been followed by nations for decades were suddenly revised in secrecy just prior to the war's end and the former International Geneva protocols cast aside and new standards of jurisprudence abruptly introduced into the equation by Jewish judges and the Zionist forces who had gained firm control of the whole charade. This was the hour that they'd planned for and were waiting since first declaring war on Germany in 1933 when Hitler and the National Socialist Party gained power through legal, democratic means.

Now that the Allies had gained their victory the Zionists, via subterfuge, deception, political pressure and the willing assistance of their

controlled media and Hollywood, were finally in a position to have their long sought "6 Million Jewish Holocaust" footings poured, so that the foundation of their fabricated "6 Million" phantasy was now firmly in place thus allowing for the rest of the monkey business of taking over national and international laws, all of which would be based upon the cunningly crafted pretext for tyranny known as the "Holocaust".

After that landmark lie was accomplished it was merely a matter of time, patient plodding and endless, inordinate propaganda and pressure placed upon the rest of the population of the world who had still to accept the "Holocaust" hoax and be subsequently convinced of the dire and urgent necessity for enacting legislation that would make it illegal to promote either "genocide" or "hatred" toward any identifiable group.

In principle (and of course based upon the lie of the "6 Million") these proposals might have appeared laudable and worthy had the mythical "Holocaust" actually occurred and in that context they would most definitely have been noble pursuits to accomplish but that, unfortunately, wasn't the reality. Only now that the real history of the last eighty years is finally coming to light, thanks to the free and open Internet, are we finally getting to see the original, unadulterated script as it was so cleverly designed by the Zionist forces of the day; a program of diabolic, Machiavellian political pragmatism designed to destroy democratic institutions and replace them with a Zionist-based illuminist, occult vision of a macabre New World Order where they, and only they, would hold all the power and control over the people of the world along with all the resources of the planet.

Such was the set and setting here in Canada when the Jewish lobbies started their underhanded campaign to create "Hate Propaganda" laws that would be and are being used against Canadian citizens today.

One might legitimately say that these deceptive measures to control freedom of speech actually began even before the commencement of WW2. After Hitler and the National Socialist Party came to power in 1933 the Jews in Canada were already growing fearful that Canadians might begin to believe what Germany was saying about the International financiers and the Jewish

control of their own beleaguered nation and so in the province of Manitoba, (of all places) the government passed a statute to combat what was apparently perceived to be a "rise in the dissemination of Nazi propaganda". The premise of which (The Libel Act, R.S.M. 1913, c. 113, s. 13A (added S.M. 1934, c. 23, s. 1) was later to become The Defamation Act, R.S.M. 1987, c. D20, s. 19(1) and was in all likelihood the first volley launched against freedom of expression.

Up until 1970 Section 181 of the Criminal Code, which reads: "Every one who wilfully publishes a statement, tale or news that he knows is false and that causes or is likely to cause injury or mischief to a public interest is guilty of an indictable offence and liable to imprisonment for a term not exceeding two years." was the only provision in the Code even remotely connected to the offence of group defamation but it didn't, then, specifically make mention of "hate propaganda".

As stated above, when WW2 ended the work of the Zionist lobbyists began in earnest when their "Holocaust" card began appearing as the foundational pretext to any and all discussions surrounding "human rights" and "discrimination". The first step in the direction of censorship was the United Nations' Universal Declaration of Human Rights in 1948 with its references to "hate propaganda" and by 1953 we find that the Canadian Jewish Congress was already diligently pursuing efforts toward this end with their attempt to insert anti-hate propaganda provisions into the Criminal Code which was being revised in that same year.



Their labours eventually bore the fruit of deception when they were finally able to convince Canada's federal Justice Minister Guy Favreau in 1965 to appoint a special (interest) committee to look into the purported "problems" connected with the dissemination of "hate propaganda" in Canada.

Surprisingly (not) what became known as "The Special Committee on Hate Propaganda in Canada" and later abbreviated (for propaganda purposes) to the "Cohen Committee" was headed by a Jewish lawyer, Dean Maxwell Cohen, Q.C., Dean of the Faculty of Law, McGill University. While not all members of the committee were Jewish there was one other notable lawyer instrumental in aiding the Jewish lobby in their relentless quest for censorship laws. This was none other than Professor Pierre E. Trudeau, Associate Professor of Law, University of Montreal.






