

"GENTILES" (Part 2)

POPULAR THEOLOGY ABOUT "GENTILES" ... IS IT RIGHT?

WE have already seen on the origin of the word "Gentile". There appears to be no evidence that the Apostles could properly distinguish between Israelites and non-Israelites in the nations, to which they went. Hence the message had to be taken to the nations in order for the message to reach "all men" of the descendants of the outcast Israelites. These men had the capacity to believe God and so could accept the 'good news' and become reinstated as God's people. But the Roman error was picked up and it has come to prevail. Of course, the originator, the arch-cult-type, the Roman Catholic Church keeps on its unchanging false doctrine and false identification. But she is the one with whom the kings of the earth have committed fornication and by whom they have been deceived through her sorceries [Rev 17:2 and Rev 18:23]. It was Rome who originated the error in doctrine about the "Gentiles".

But we are told to come out of her my people [Rev 18:4]. God's chosen people Israel are warned to come out of all of Rome's doctrines, including Rome's universalism! Multitudes today are going Rome's way. But the great whore will be cast down; God has so decreed, and none need be partakers of her plagues. Who rejoices when Babylon is cast down? Is it not the holy [set-apart] apostles and prophets? [Rev 18:20]. One has to come out to be set-apart! The Faithful and True will come to judge and make war on that whore Rome [Rev 19:11]. The "wife" must get ready. It is the saints [Israel by Bible definition - see Psalm 148:1] who wear the white linen [Rev 19:8]. The voice from out of the Throne addresses His servants. They are the ones who have the right to enter the city through those twelve gates. Would there be much point in

mentioning this if every race went through those gates?

Rev 21:12 And a wall great and high, and had twelve gates, and at the gates twelve angels, and names written thereon, which are the names of the twelve tribes the children of Israel.

Rev 21:27 And there shall in no wise enter into it anything that defileth, neither whatsoever worketh abomination, or maketh a lie: but they which are written in the Lamb's book of life.

A comment here might well be helpful because Rev. 21:12 is confirmed in the Book of Zachariah where we find Israelites only within the New Jerusalem, with the other races outside the City of God. This being so shows that there is no scope for the popular "grafting in" and "adoption" doctrines. "The Twelve Tribes" is rather definitive and cannot possibly be moulded into the popular concept of the "Church". To do that it would be necessary for a switch in identity to be made, but this cannot be done because we are told, "The promises made to the fathers (of Israel) are fulfilled in us their children (offspring)"-(Acts 13:32).

Who works the abomination in doctrine? Is it not the mother of harlots and abominations? Who spreads the doctrine of universalism? Who originated it? The meaning of Catholicism is universalism! Search the Scriptures and see which race is the only race written in the Book of Life, and when this was done!

THE KINSMAN-REDEEMER

JESUS IS THE REDEEMER OF KINSMEN! If anyone believes the "go ye into all the world" and "Jesus died to save the world" doctrine in the way Rome (and most churches) interprets the world, then that person cannot believe that Jesus is our [that is, Israel's] Kinsman-Redeemer. At the Second Advent Jesus will ignore those who are not His kinsmen.

TO WHOM DID THE APOSTLE PAUL WRITE?


In the second chapter of the author's book, The Exclusive Nature of Israel in the New Testament, many New Testament Scriptures were quoted to

show that the Apostle Paul wrote to Israelites and that he could not have been writing to anyone else.

Gal 2:7 "The gospel of the uncircumcision was committed unto me, as the gospel of the circumcision was unto Peter".

Rom 11:13 "For I speak unto you Gentiles, inasmuch as I am the apostle of the Gentiles".

These verses are commonly used to support the "Jews and Gentiles" doctrine in the popular concept. In this view, the "uncircumcision" are the supposed "Gentiles" and the "circumcision" are supposed to be "The Jews". Whatever would a circumcised "Gentile" be?



It is important to remember that the word translated as "Gentiles" in these verses is "ethnos" in Romans and "hellen" in Galatians. "Ethnos" refers to Israelites by the same term that applied to them in the Old Testament. "Hellen" is discussed in the author's paper "Galatians and Israel Exclusive". Everyone who has been taught that the Gentiles are always non-Israel does experience difficulty in "unlearning". This is understandable, because this doctrine is what theology has taught; this is written into translations in a way that makes unlearning difficult.

Now we can look at some other Scriptures from the New Testament that show Israel as being the only people being addressed.

Acts 10:36 The word which God sent unto the children of Israel, preaching (proclaiming) peace by Jesus Christ.

Acts 10:43 To Him give all the prophets witness, that through his name, whosoever believeth in Him shall receive remission of sins.

Acts 13:23 Of this man's seed hath God, according to his promise raised up unto Israel a Saviour, Jesus.

Acts 13:32,33 How the promise which was made unto the fathers, God hath fulfilled the same unto us their children - Here we see direct Scriptures that are particular and exclusive. We also have a whosoever to which all the prophets of Israel give witness. Now, in the Old Testament books, to what "whosoever" does the Redeemer of Israel come? Is it whosoever of Israel as the prophets say, or is it the "whosoever" of every race as translators think it should say? A positive decision has to be made! The word "whosoever" is an objective pronoun that gives a specific meaning to a noun or subject. Thus it means, "whosoever of Israel". For this reason, "whosoever" cannot mean "anyone of all races" when Israel is the context.

Someone might be thinking, Yes, but there are still two parties. This problem completely disappears when we take note of:

Matt 4:12 Now when Jesus had heard that John was cast into prison, he departed into Galilee [from Judea].

Acts 9:31 Then had the churches rest throughout all Judea and Galilee ...

The highlighted words show clearly that the two territories are treated differently. There was a clear barrier between the two. But both were Israelites of differing Houses.

Matt 4:23 And Jesus went about all Galilee, teaching in their synagogues, and preaching the gospel of the Kingdom ...

Matt 4:15,16 The land of Zabulon and the land of Nephthalim, by the way of the sea, beyond Jordan, Galilee of the Gentiles, the people which sat in darkness saw great light ...

The latter verse identifies these Israelites in Galilee and calls them "Gentiles"! It is historical fact that Israel separated into two Kingdoms and became known in prophecy as:

The House of Israel [10 tribes].....also known as Ephraim and "the uncircumcision".

The House of Judah [2 tribes].....also known as Judah and "the circumcision".

Subsequently, both Kingdoms went into captivity in Assyria or Babylon. Following the captivities, all of the 12 tribes (except for a small remnant) went North and were dispersed among the nations. These became known as the Dispersion or Uncircumcision. A small remnant of the Babylonian captivity of the Southern Kingdom returned to Palestine and formed the Judean nation. The ruling classes of the Judean nation were dominated by Edomites (Jews), and their subversion of the Scriptures, the Traditions of the Elders, became the religion of the land. The Judean nation practised circumcision and hence in the Scriptures, are referred to as the Circumcision. Consequently, the New Testament refers to two groups - the Uncircumcision (the Israelites outside the Judean nation) and the Circumcision (the Israelites inside the Judean nation).

The other uncircumcised races are not included in the uncircumcision, because the sum of the two groups addressed is "all Israel" in Romans 9.

But this is ignored by Churches that claim the "The Jews" means Israelites and that "Gentiles" means everyone else.

JESUS' MINISTRY WAS NOT PRIMARILY TO THE JEWS OR IN JUDEA


Most people would question this statement without even thinking about it! But let us look at this matter more closely. In the gospels, Jesus makes a clear distinction between Galilee and Judea, the latter being the territory of "The Jews" = The Judeans or Jewry.

John 7:1 After these things Jesus walked in Galilee: for he would not walk in Jewry, because the Jews sought to kill him.

John 11:53,54 Then from that day forth they took counsel together for to put him to death. Jesus therefore walked no more openly among the Jews; but went thence unto a country near to the wilderness, into a city called Ephraim.

Matt 19:1. And it came to pass, that when Jesus had finished these sayings, he departed from Galilee, and came into the coasts of Judea, beyond Jordan.,

Matt 4:13 And leaving Nazareth, he came and dwelt in Capernaum ...



In the Thompson Chain Reference Bible, the footprints of Jesus are presented graphically on Pages 274 and 275 showing that Galilee was the major area of Jesus' ministry.

Most Christians seem to think that Jesus dwelt among "The Jews" in Jerusalem, but this is not so. Christians seem to think that Jerusalem was the centre-point of Jesus' teaching ministry. Jesus went to Jerusalem at particular times for particular purposes. His disciples did not appreciate these times about going up to Jerusalem, as Jesus once told them, "Your time is always now, but My time is not yet" [John 7:6]. Jesus fulfilled the Old Testament times exactly regarding the Sabbaths and the feasts of Israel. Jesus said He knew the exact day of His crucifixion at Jerusalem [Matt 26:2]. He went to Jerusalem on exactly the right day [Nisan 10th] to be chosen by the Israelite people among the population as their King, and He was delivered to become the all-sufficient sacrifice for the redemption of His people. Jerusalem was the centre-point where Jesus would fulfil His mission and His Father's Will to be the Passover Lamb for Israel. The institution of the Passover Lamb was only to Israel.

Across the border from Judea, mention is made of Ephraimites and Galileans [Benjamites]. Jesus was safe amongst the Israelites in Galilee whereas He was not safe amongst the Judeans. This fulfilled the prophecy made by Moses:

Deut 33:12 And of Benjamin he said, the beloved of the Lord shall dwell safely by him; and the Lord shall cover him all the day long, and he shall dwell between his shoulders.

We have seen from Matthew 4:15,16 above that these Israelites in Galilee are called "Gentiles". It was Galilee from whence Jesus picked out eleven of His disciples. Judas, the Judean, was the one who betrayed Jesus! Eleven of the disciples were not of "The Jews" and were not of Judah either.

When Jesus ascended, the witnesses are described as Men of Galilee in Acts 1:11 and Acts 2:7. In Acts 2:22 those addressed were Men of Israel, but not "Jews". But whilst addressing the Men of Israel, the disciples soon came up against "The Jews" in the national leadership. The more we look into this matter, the more impossible it becomes to say The Jews and the Men of Israel refer to the same people.

Today most denominations are "Christian Zionists" who insist that "The Jews" and "Israel" are one and the same! We read that some of the priesthood believed in Jesus; all were not Edomites or other proselytes. Nicodemus was a "ruler of the Jews" and so was among the leaders. But his counsel was somewhat different as an Israelite non-Edomite! Jesus was speaking primarily of the leadership in general when referring to "The Jews". Jesus described these leaders as "hiredlings", and not "the shepherd, whose own the sheep are not". Each such person in the religious leadership was "climbing up some other way" and each was a thief and robber [John 10:1]. In Verse 5 Jesus calls them strangers and they are identifiable because of the what they were doing as making them different.

The Exclusive Covenants Of Covenant (Part 9) Documenting The Bible's Commandment of Racial Segregation By Pastor Eli James



(THE TWELVE TRIBES OF ISRAEL)

THE Twelve Tribes of Israel are the final exclusionary group. We are the heirs of the Promises. The pattern of exclusion demonstrates that the Covenants, Promises, Dominion and Inheritance devolved from Adam and Eve down to Jacob and his twelve sons. All other ethnicities, including the other tribes of the White Race, are excluded from these Covenants. The Bible makes all of this explicit and clear, as this record has demonstrated. However, it is also clear that tribal membership is based on the father. Intermarriage between Israelites and Adamic Aryans was always permitted. However, the posterity was always reckoned through the father.

So, if the Bible goes to extremes in order to sever even the close Adamic kinsmen of Israel, how in the world are "all races" going to be included?

The pattern of exclusion proves that universalism is a crock.

Abraham, Isaac, Jacob and his twelve sons all married Shemitic women. Once these women were selected, the posterity of Israel continued through the patriarchs. Intermarriage between men and women of the different tribes meant that, for example, the offspring of an Asherite woman and Simeonite male would be reckoned as Simeonites. Although it is impossible for us to keep track of all of this genealogy, Yahweh knows all; and He has His reckoning all set for the New Jerusalem of Rev. 21, which consists exclusively of the 144,000 of the TWELVE TRIBES OF ISRAEL. This prophecy cannot be spiritualised. It is genetic reality, according to Yahweh's own laws, will and testaments.

Finally, if an Israelite man marries a White woman of a non-Israelite nation, such as a Slavic woman of Japheth or a Shemitic woman of Armenian, Scythian or Parthian extraction, those offspring will be reckoned as Israelites. However, if an Israelite woman marries a non-Israelite White man, her offspring will not be counted as Israelites. Therefore, her children

will not be Heirs of the Covenants. Nevertheless, all White non-Israelites, who call upon His Name and obey His commandments, will have a share in the Kingdom, but rulership of the Kingdom will devolve exclusively upon the Israelite patriarchate.

“Japheth shall dwell in the tents of Shem.” This prophecy came exactly true as the Davidic Throne, through both Zarah and Pharez, continued through the Emperors of Rome (First Reich) and then through the Kings and Queens of Europe (Second Reich). The royal Houses of Europe were all cousins to each other; and they are all descendants of the Shemitic House of David, whether their subjects were Celts, Iberians (Hebrews), Cimmerians, Scythians, Israelites, Saxons or Slavs. Hitler’s “Third Reich” was premature. It was not based on Scripture. It is yet to come.



What the world knows as Western Civilization was organized by the Caucasian Israelites, who are the direct descendants of Abraham, Isaac and Jacob. Under our leadership, the other branches of the White race were unified into one great culture, based on honour, honesty, inventiveness, hard work and common law. All of these qualities were grafted into Caucasian Israel as a result of the promise of Jer. 31, the New Covenant, being fulfilled in True Israel. Christian Jurisprudence, with all of its stress on justice and fair play, was brought to the world by the Anglo-Saxon, Caucasian people. The Jews had nothing to do with it. In fact, the Jews have been a subversive force since Gen. 4:1, where Cain was cursed with the inability to farm. The Jew wanders the landscape until he finds a nice, cosy Saxon state to feast off. We are the builders. The Jews are the destroyers. It can be stated as a plain fact of history that the primary pastime of the Jewish people is to subvert and destroy Adamic/Saxon nations. The fact that He was an Adamite and a descendant of David gave him the qualifications for this dual deliverance. The Enmity declared at 3:15 does not get resolved until the Second Coming, when He will return with His holy angels to smite the Edomites and anyone who has allied himself or herself with them (Mystery Babylon).

Conclusion

“Yet I planted you a choice vine, wholly of pure seed. How then have you turned DEGENERATE and become a wild vine?” Yes, this verse is in the Bible, but it is not the KJV translation. It is the Revised Standard Version, which gets the context right, as Jeremiah is enumerating the sins of Israel. In Jer. 3:1, He says, “You have played the harlot with many lovers.” Since Yahweh is speaking to the whole nation of Israel, the “many lovers” can only be the other nations that Israel is forbidden to intermarry with!

When it is time for the children of Israel to be punished for their sins, He says, "I will appoint over them four kinds of destroyers, says Yahweh: the sword to slay, the dogs to tear, and the birds of the air and the beasts of the earth to devour and destroy." – Jer. 15:3. (RSV)

Yahweh punishes our national fornication by using those very nations to kill us, by turning them into destroyers of Israel. How many times has this happened to our once glorious, Whites-only societies?

Nevertheless, He will not totally abandon us. He will bring us back to our senses, breaking the matrix of deceit, the bonds of delusion and apostasy! Not only that, the rest of "humankind" will acknowledge that WE are HIS CHOSEN PEOPLE. Observe:

"And their seed shall be known among the nations, and their offspring among the people: all that see them shall acknowledge them, that they are the seed which Yahweh hath blessed." – Isa. 61:9.

Amos 3:2 puts it this way: "YOU ONLY HAVE I KNOWN OF ALL THE FAMILIES OF THE EARTH."

Isa. 43:21: "This people have I formed for Myself; they shall show forth My praise."

Numbers 23:9 – "Behold it is a people that shall DWELL ALONE."

What part of the expression "dwell alone" don't you understand? We are to segregate ourselves from all the other races.


Deut. 32:9: "For Yahweh's portion is His people. Jacob is the lot of His inheritance."

Deut. 33:28-29: Israel then shall dwell in safety ALONE: the fountain of Jacob [shall be] upon a land of corn and wine; also his heavens shall drop down dew. Happy art thou, O Israel: who is like unto thee, O people saved by the LORD, the shield of thy help, and who is the sword of thy excellency! and thine enemies shall be found liars unto thee; and thou shalt tread upon their high places.

Instead of treading down the heathen idolaters, today's Judeo churches are inviting them into

their homes and churches, just like the reprobate Israelites of Palestine! The Great Apostasy will be judged along with the Synagogue of Satan.

I Kings 8:53: For you did SEPARATE THEM from among all the people of the earth, to be Your inheritance."



Despite all of this segregationist language, the world believes that the mongrelised Jews are "Israel." But, because Yahweh's servant people, Israel, have been blinded to their true Identity, many of us, thanks to Jewish propaganda, remain in the dark. Paul tells us at Romans 11:25, "...that blindness in part is happened to Israel, until the fullness of the nations be come in." Now that the New World Order has done away with sovereign nations, our blindness is finally beginning to lift. Do you see how easy it is to discern Paul's true meaning, once the blinders of mistranslation are removed?

In Matt. 13, Jesus is asked by the Apostles why he speaks in parables. His answer is exclusivist. At verse 11, He answers, "Because it is given to YOU to know the mysteries of the kingdom of heaven, but to THEM it is not given." Clearly, the gospel is not for everybody. It is only for a few, even within Israel. "Many are called but few are chosen." Yet, today's apostate churches unanimously teach that we are all "saved" by mere belief in Jesus Christ. The exclusivity of the covenants has been replaced by the heathenism of the churches, who profit by having more butts in the pews and more shekels in the basket. At verse 14, regarding those people for whom this Gospel is not intended, He says that He has no intention of preaching to them, "lest at any time they should see with their eyes, and hear with their ears, and should understand with their heart, and should be converted, and I should heal them."

Why would Jesus say such a thing? The obvious reason is that there were always Pharisees in the audience, seeking to entrap Him with His words. Yahshua never minced words with these Pharisees. He condemned them at every turn. He did not even TRY to convert them. At John 10:26, he tells them, "But you believe Me not, because YOU ARE NOT OF MY SHEEP." So much for everyone being "one in Christ." Also, there were various non-Israelites in the crowds, to whom the gospel does not pertain.



In Matt. 15, the Canaanite woman asks to be given the "bread of life," but Jesus tells her, in Covenant language, "It is not fitting to take the children's bread and give it to the dogs." Yahshua is telling her, in no uncertain terms, that the inheritance stored up for the children of Israel cannot be given to anyone else but those exact children. Her answer is just as revealing. She says, "Truth, Lord, yet the dogs eat of the crumbs which fall from their masters' table." Note the location of the apostrophe in the word masters. It is plural! For once, the KJV translators got it right!!! She is acknowledging that the Israelites, not merely Jesus Christ, are her masters. The Canaanite woman understands that the children of Israel are to inherit the Kingdom; and no one else has any claim to it. Because she acknowledged Him as the Son of David and because she acknowledged the Israelites as her masters, Yahshua granted her wish and even praised her for her "great faith." But He refused to give her what belongs only to the children of Israel.

Even the Edomite and Khazar Jews will ultimately acknowledge that we Anglo-Saxons are their Israelite masters. Just read Rev. 3:9.

Deut. 4:23-32 declares, through Moses the prophet, that at the Day of Judgment, He will regard Israel as a separate people, to be redeemed

out of the nations among which they have been scattered:

I call heaven and earth to witness against you this day, that ye shall soon utterly perish from off the land whereunto ye go over Jordan to possess it; ye shall not prolong your days upon it, but shall utterly be destroyed. And the LORD shall scatter you among the nations, and ye shall be left few in number among the heathen, whither the LORD shall lead you. And there ye shall serve gods, the work of men's hands, wood and stone, which neither see, nor hear, nor eat, nor smell. But if from thence thou shalt seek the LORD thy God, thou shalt find him, if thou seek him with all thy heart and with all thy soul. When thou art in tribulation, and all these things are come upon thee, even in the latter days, if thou turn to the LORD thy God, and shalt be obedient unto his voice; (For the LORD thy God is a merciful God;) he will not forsake thee, neither destroy thee, nor forget the covenant of thy fathers which he sware unto them. For ask now of the days that are past, which were before thee, since the day that God created man upon the earth, and ask from the one side of heaven unto the other, whether there hath been any such thing as this great thing is, or hath been heard like it?

At Matt. 7:6, Jesus says, "Give not that which is holy unto the dogs, neither cast your pearls before swine, lest they trample them under their feet, and turn again and rend you."

What does this mean?

- 1.) We are not to give our Inheritance to non-Israelites. They have no part in the Covenants.
- 2.) When we intermarry with non-Whites, we give our inheritance to those who will abuse the covenants, thinking themselves better than us; and they will turn against us and kill us. This is what is happening in South Africa today, as the Judeo-Christians have tried mightily to convert the Blacks away from voodoo and their pagan, tribal beliefs, but it has not worked. This is also happening in all of the formerly White nations on planet earth, where the Jews have systematically disenfranchised White people and empowered non-Whites against us. Now, these same non-Whites, especially Blacks, Arabs, and Mexicans, pretend to be superior to Whites, even to the point of committing genocide against their White benefactors. Matt. 7:6 is a prophecy of

what happens when we Israelites give our inheritance away to those who are not meant to have it. They are turning against us and rending us! We are not to mingle our seed with the non-White races. Whenever we do, Yahweh punishes us for disobeying His Law of Segregation.



The doctrine of racial integration is coming from the ENEMIES of God's People, Israel. These enemies are the Canaanite, Edomite, Khazar Jews, the Great Pretenders to the Inheritance of True Israel. This is what the Bible calls the GREAT HATRED (Psalm 139:22; Ezek. 36:5; Hos. 9:7), that was announced in Gen. 3:15 and is still the most powerful religious and political force operative in the world. Contrary to the Word of God, the doctrine being preached from today's pulpits is racial integration!!!

Today this doctrine is being pushed by their descendants in modern day Talmudic Jewry, Free Masonry, Catholicism, Cabala-ism, and centralized in the United Nations.

The UN policy is ‘The International Brown Man.’

These enemies of Christ and the Adam/Israel people are carrying the grudge of Esau and Cain. They both lost their rights to the blessing and the scepter. Now they do not want Jacob/Israel Adam to have it. They know from experience with torture in their new world orders of

He has collected thy flocks, and all the possessions HE ROBS FROM BEFORE THY FACE, and when we entreated and asked for what was ours, HE DID AS A MAN THAT PRACTICES USURY ON US.’” – Jubilees, XXXV, 12-14.

Which ethnic group is most well-known, having no equal, for practicing USURY? Only we in Christian Israel know exactly who and what the Jews really are. The rest of the world still gropes through the murky matrix of Mystery Babylon, having made common cause with the Jews in making merchandise of True Israel. (John 2:16; 2 Peter 3.) Commerce by day, fornication by night, just as Esau, their mackdaddy, did ages ago. Barack Obama is nothing but the latest puppet of the Edomites. The Jews make merchandise of White Israelites, while the “Amen Corner” of Judeo-Christians cheer, “More! The Two Seeds Of Genesis 3:15 (11)

THE BIBLICAL VIEW OF SATAN

The Biblical View of Satan is clearly laid out in the Holy

Scriptures. From Genesis to Revelation the narrative of the sacred scriptures presents one unified picture of a personage called Satan, the Devil, that “old” serpent, the Dragon and this being is presented in the Holy Bible as a Created, Defeated Rebel who has been Defeated, Judged, and placed within well defined boundaries by an All powerful, omnipotent, omnipresent, omniscient GOD who holds all power and all authority both in Heaven and in Earth. The Biblical view of Satan is that while he still stands as the great adversary against Almighty God, seeking to impede and intimidate the purposes and plan of God, he is a defeated rebel who has already lost the battle. First and foremost, the Bible presents Satan as a created being. The Bible sets forth Satan as the creation of Almighty God The Creator. Secondly, the Holy Scripture sets forth Satan as a defeated rebel, one who has been found guilty of lawless rebellion against God, and a Fallen Creature who stands under indictment from God and absolutely chained within the perimeter established by God’s Sovereignty. Thirdly, the Bible does establish Satan as a person. There is one Satan and many Demons presented in Scripture.

The Bible does not present Satan as any type of supernatural, omnipresent, omniscient being with all power and authority, but, on the contrary, the Bible presents Satan as a created rebel, who engaged in lawless rebellion against Almighty God, who was openly defeated, and judged, and now knowing that his days are short in the earth. Satan seeks to lead forth the forces of darkness as their captain. While the Bible teaches that Jesus Christ is the embodiment of all light and truth, Satan is the captain of darkness and unrighteousness. They are not coequals for Satan has already been defeated, his time for opposing God has been regulated by God, His sentence of Death has been handed

down, and Satan knowing that his days are numbered, seeks to lead the forces of darkness in opposition to God in these final days of history.

The Biblical view of Satan is clearly outlined in Scripture. First Satan is presented as an anointed Cherub, as a leading Arch-Angel of Light. He is a created being of God who sought to become his own God (Isaiah 14:12-21) and through open lawless rebellion he was, along with a third of the Angelic Forces (Rev. 12:4) cast out of the heavens and defeated by Michael. (Rev. 12:7-9). This was Satan’s first defeat. Again Satan suffered mortal wounds in that every generation of history since the advent of Adam, has witnessed the survival of a righteous and holy remnant of the Abrahamic Seedline in this earth. Satan has never achieved a total victory over God’s Family in this Earth. Every generation of Saints has overcome his wiles. Today after nearly six thousand years of testing, the Saints of Almighty God, the Seed of Isaac remain undaunted from the attack of Satan and his Demons. Satan has been defeated but he continues to work his work of darkness in this earth. His absolute defeat came when Jesus Christ rose from the tomb to conquer death, sin, and the grave. Now, Satan has been deposed of his greatest weapon, “death”, and he stands as a totally defeated rebel of darkness, awaiting his final judgment here at the ending of this age.

Greg L. Bahnsen in his essay on The Person, Work, and Present Status of Satan as recorded in the Journal of Christian Reconstruction, Vol. 1, No. 2, Winter, 1974, a Chalecedon Ministry, has done a most commendable job of presenting the Biblical Viewpoint of Satan. Bahnsen writes on Satan as follows: “Satan is a person. He cannot be rationalized away as a pre-scientific myth of literary personification. He moves (I Pet. 5:8), works (Eph. 2:2) knows (Rev. 12:12), speaks (Matt. 4:3), plots (II Cor. 2:11), desires (Luke 22:31), disputes (Jude 9), deceives (II Cor. 11:3), feels emotion (Rev. 12:12; I Tim. 3:6; James 2:19), tempts (I Thess. 3:5), makes promises (Matt. 4:9), sins (I John 3:8), and engages in many other activities of a personal nature...The disapprobation felt towards Satan by the inspired writers is manifest from their

designation of him as the evil one (Matt. 6:13, 13:19,38; John 17:15; Eph. 6:16, I John 2:13-14; 3:12; 5:18-19), slanderer (Matt. 4:1, 11; Luke 4:2, 6; I Tim. 3:6-7; II To, 2:26; I Pet. 5:8; Rev. 12:9; 20:2), adversary (I Pet. 5:8), enemy (Matt. 13:28-29), accuser (rev. 12:10), destroyer (I Cor. 10:10), and a world-ruler of darkness (Eph. 6:12); the recoil from him as a liar and a murderer (John 8:44), angel of the bottomless pit (Rev. 9:11), roaring lion (I Pet. 5:8), red dragon (Rev. 12:3-17, 20:2), and the old serpent (Rev. 12:9, 20:2; II Cor. 11:3).



In the Holy Bible Satan is presented as the prince of the Demons. The Bible presents one devil (diabolos) but many demons (daimonia). The Bible clearly portrays Satan as leading the demonic forces and these demons are, according to scripture, the spirits of the created angels, that left their first estate (Jude 6, II Pet. 2:4, and Rev. 12:4) and who now seek to inhabit bodies. In Matt. 9:34, Satan is called “the prince of demons”. The Word of God declares in Matthew 12:43-45 and Mark 5:12 that demons need to occupy physical bodies and their primary modus operandi is this earth is to inhabit the physical bodies of people. The gospels alone record fifty-two cases of demon possession with the word “demonic” occurring fifty-five times and the phrase “unclean” or “evil spirit (s)” appearing twenty-eight times. For classic cases of demon possession read Matthew 8:28-34, Matt. 9:32-33, Matt. 12:22, Matt. 15:22-29, Matt. 17:14-18, Mark 1:23-26 and Mark 16:9. The Word of God makes a very clear distinction between demon possession and sickness or


disease. Demon possession is presented in Scripture as an actual occurrence, not merely as a metaphorical description. St. Luke, a physician himself, makes this distinction between demon possession and sickness very clear and separated them in (Luke 4:33-36, 40-41, 6: 17-18; 9:1-2). For a thorough reading on Satan and demons refer to the excellent article written by Greg L. Bahnsen in the Journal of Christian Reconstruction, pages 11-17, previously discussed.

The Bible view of Satan presents him to be first of all, a created Angelic personage who is graphically described in Ezekiel 28:11-19 as being “...perfect in thy ways from the day thou wast created, till iniquity was found in thee.” The Holy Scriptures thus present Satan as a created angel of the Living God. Ezekiel in describing Satan, had called him King of Tyrus Ezekiel 28:12 and declared that he had been in Eden, the garden of God. The King of Tyrus representing Satan is not to be confused with the Prince of Tyrus discussed earlier. The Prince of Tyrus was a type of Satan. The real message of Ezekiel is clearly discussed in Ezekiel 28:11-19. He was the anointed cherub (Ezekiel 28:14), he was perfect in his ways from the day of his creation until iniquity was found in him, (Ezekiel 28:15), his heart was lifted up because of his apparent beauty (Ezekiel 28:17), his wisdom was corrupted by reason of his brightness and he was to be cast down to the ground (Ezekiel 28:17). All of these conditions describe the fall of Satan as the created angel of the living God.

Apparently, according to numerous scriptures in the Bible, Satan held a position of great authority and may have even been in charge of this earth before the formation of the Adam man. In any event the Bible presents him as the “anointed cherub that covereth”, (Ezekiel 28:14) and he had been in the Garden of Eden (Ezekiel 28:13) something that the prince of Tyrus had never done by any stretch of the imagination. Ezekiel 31:16 describes his great fall from his position of high rank and authority. All of Ezekiel 31:1-18 lends itself to the study of Satan and his fall from high rank and authority. Ezekiel 31:16-18 is absolute evidence that the Bible is talking about the fall of Satan from a very exalted position as a created angel of God. In Isaiah 14:12-21 we have laid before us some very dynamic verses of scripture regarding the nature of Satan’s sin before God. Again Isaiah 14:12

addresses itself to “Lucifer” not to the King of Babylon as depicted in Isaiah 14:4. The King of Babylon was only a type of “Lucifer”. Satan was the primary objective of this Scriptural utterance. Lucifer, the Day Star, the anointed Cherub, had involved himself in Lawless Rebellion against Almighty God. The creature (Lucifer) sought to be his own god. He sought to exalt his throne above the stars of God, to ascend above the heights of the clouds, and do all the other acts and sins outlined in Isaiah 14:12-14. Isaiah 14:17 clearly points to Satan who refused to open the house of his prisoners. The “pit” in verse 19 is that bottomless pit of Rev. 20, which is reserved for Satan. Almighty God in Isaiah 14:21 declared that slaughter be for his (Satan’s children) that they not fill the face of the world with cities. (Isa. 14:21). Note that Cain was the first builder of cities.

In Revelation 12:7-9 we have recorded where Satan, that “old” serpent, the Devil, waged war against Michael and his angels and there he was, along with the angels who left their first estate (Jude 6 and II Peter 2:4) cast out of heaven. The Dragon, who was that old serpent, the Devil and Satan (Rev. 12:9 and 20:2) had taken a third of the angelic host with him in his rebellion against God (Rev. 12:4). These angels had left their first estate and had followed Lucifer, that



“old serpent” the Dragon in his rebellion against God. Satan’s fall from heaven described in Revelation 12:9 was also described in Ezekiel 31:16-18. Revelation 9:1 depicts Satan as a “...Star fall from heaven unto the earth: and to him was given the key to the bottomless pit.” Satan was the star that fell. Jesus Christ himself stated that “I beheld Satan as lightning fall from heaven”. Luke 10:18. Here we have Ezekiel, Isaiah, John and Jesus Christ all talking about Satan’s fall from a position of grandeur. Jeremiah 4:23-26 discusses the conditions that befell the earth when Lucifer, the Day Star, was cast out of the heavens and into the earth following his assault against the Throne of God. When reading Jeremiah 4:23-26 also read Isaiah 14:15-16. Keep in mind that Isaiah 14:15 declares the final end of Satan: “Yet thou shalt be brought down to hell, to the sides of the pit.”

The Biblical View of Satan is therefore one of a created angel, an angel of high rank and authority who led a lawless rebellion against God, was soundly defeated and cast down to earth to work his works of darkness in the earth for he knows that he has only a short time left. (Revelation 12:12).

Satan is clearly defined under many different titles in the Holy Bible. He is called Lucifer in Isaiah 14:12 which in Hebrew is translated heylel from halal meaning to shine, to make a show, the morning star. His name Satan is from #7854 sawtawn from #7853 an opponent, a prim. root to attack, accuse (be an) adversary. Satan, the arch-enemy of good, adversary, Satan, withstand. The word Satan in the Greek as used in the New Testament comes from #4567 Satanas of chald. or corresp. to #4566 (with the def. Affix.) the accuser, i.e. the devil, Satan, #4566...Satan the Devil. Satan is called the Devil which in the Greek New Testament #1228 means diabolos, from 1225; a traducer; spec. Satan, false accuser, devil, slanderer. He is called Serpent as in Genesis 3:1-14 which in the original Hebrew comes from #5172 (nachash) a prim. root, to hiss, whisper, certainly divine, enchanter, enchantment, learn by experience, indeed, diligently observe. Satan is called a Dragon as in Revelation 12:9 which comes from the original Greek #1404 drakon, a

fabulous kind of serpent (perh. as supposed to fascinate): dragon. Satan is called Beelzebub as in Matthew 12:24 which comes from an original Greek word #955 Belial, beeleeal; worthlessness; Belial, as an epithet of Satan. Satan is called Abaddon as in Rev. 9:11 which comes from the Hebrew means destruction. Again in Revelation 9:11 Satan is called Appollyon which in the Greek means Destroyer. Satan is thus known by these and many other titles in the Holy Scripture of Truth. Note: All numbers come from the Strong’s Exhaustive Concordance to the Holy Bible.

The Bible makes its first introduction to Satan in Genesis 3:1-14 when he appeared as a fallen Angel (of light) II Cor. 11:1-15, under the title of Serpent. The Serpent in the Garden of Eden as Satan. This is why Satan is called that “old

serpent” in Rev. 12:9 and 20:2. Remember the word Serpent used in Genesis 3:1-14 comes from the Hebrew #5175 (Nachash)...a prim. root, to hiss, whisper, certainly divine, enchanter, enchantment, learn by experience, indeed, diligently observe. Satan appeared as St. Paul declares, as an angel of light in the Garden of Eden. He was the first cause of Original Sin. Satan sought to tell and convince Adam and Eve that they could be their own god. Satan’s original fall from God was that he wanted to be his own god. Now in the Garden of Eden he sought to convince Eve that she, too, could be her own idiot god and engage in rebellion. The Original Sin, in the Garden of Eden, was lawless rebellion against Almighty God, it was Adam Man, under the influence of the Serpent, seeking to become his own god. For a very thorough discussion of the Serpent in the Garden of Eden see Appendix #19 in the Companion Bible, Samuel Bagster and Son Limited, 4 New Bridge Street, London, England EC4. You must read this Appendix #19 on the Serpent. Your education of the Serpent will not be complete until you thoroughly read the digest Appendix #19 on the Serpent. I wish to quote one paragraph from this lengthy article on the serpent as follows: “But for the figurative language of verses 14 and 15 no one would have thought of referring the third chapter of Genesis to a snake: no more than he does when reading the third chapter from the end of Revelation (ch. 20:2). Indeed, the explanation added there, that the “old Serpent” is the Devil and Satan, would immediately lead one to connect the word “old” with the earlier and formed mention of the serpent in Gen. 3: and the fact that it was Satan himself who tempted “the second man”. ”the last Adam”, would force the conclusion that no other than the personal Satan could have been the tempter of the “first man, Adam”.

Today the modern church world, with tens of thousands of ministers, teaches that the Serpent in the Garden of Eden was a literal snake. They deny that the serpent was Satan even when the Holy Scriptures declare the serpent to be Satan as is evidenced in Revelations 12:7-9 and 20:2. The doctrine that the serpent in the modern church world. This is not what the Bible teaches. The Word of God declares that the serpent in the Garden of Eden was Satan. He appeared to Eve as an Angel of light. II Cor. 11:1-15. Satan was the tempter of Adam and Eve. The serpent, appearing as an angel of light was the first cause of original sin. He beguiled the first Adam man

into believing that (EVE) could be her own god. Original sin must be imputed to Satan, the father of lies. He appeared as a fallen angel, clothed in false light, he appeared to Eve as if he were GOD, in fact Eve apparently thought that the Serpent was God, for she thought that Cain was from God. (Genesis 4:1). According to St. Paul (II Cor. 11:15) Satan’s ministers, those flesh beings who follow him, are all transformed as though they were ministers of light. Today the lie of the Serpent, that Man can be His own idiot God, now covers the earth. For Humanism, the religion of the “Old Serpent” is now the religion of this world. The god of Humanism is sex, and it was through this medium that the “old serpent” caused our parents to fall. Today the sex of humanism is worshipped throughout the world as though it were god. The lie of the Old Serpent goes on unabated and only those with sterile minds can fail to see that Satan is a real person, still telling the lie of ancient history, in the Garden of Eden, that Man can be his own god. The sin of lawlessness and rebellion still permeates the earth and a group of flesh beings that Jesus Christ called serpent (Matthew 23:33) stand in the earth to continue the will and work of that “old serpent” of Genesis 3:1-14.



In order to clearly understand the Biblical View of Satan, acting out the role of that “old serpent” in the Garden of Eden, it is necessary to examine the first cause of sin, that is original sin. The Original Sin, the first cause, must be separated from “sin” the result of the first cause. When Adam Man was driven out of the Garden of Eden he left with a fallen nature. He had lost his spiritual dimension in Jesus Christ. This fallen nature, this root of sinful lust and passion which the “Old Serpent” planted in our Race has caused every child of Almighty God to fight the warfare of two natures...fighting for supremacy. One nature, that of the inner man, the spirit man, the celestial man, is at war with the fallen man, the

sensual fallen nature of man. Because the Old Serpent through Original Sin, the first cause, instituted this propensity to sin, the fallen nature of Adam man, it was not necessary for Satan to make a personal confrontation with each member of Adam's Race following the original sin. Satan, like a General commanding a war, operates a command post and directs the warfare against the purposes and plan of God, including the Children of God. Although he can become personally involved if he so chooses (as he did the case of Job and then in the personal temptation of Jesus Christ, as well as in the life of David in getting him to number Israel) Satan now has an army of flesh and blood beings who are dedicated to his work in this earth. These satanic children of Satan are clearly labeled by Jesus Christ in Matthew 23, Mark 7, in Luke 11, and in John 8. The Jews of Revelation 2:9 and 3:9 constitute that serpent race who today comprise Satan's army in the earth. Satan commands this army of evil doers in the earth today and they seek to prevent the Kingdom of God from coming into the earth. Again, you must make a distinction between "sin" and "original sin". Original Sin is now abiding in every seed of Adam and only Jesus Christ, His shed Blood and the Office and Work of the Holy Spirit can expunge that sin from Adam man and make him a new creature. It is imperative that we remember that it was the "old serpent" the Devil and Satan who was the first cause of all sin.

Again, the Biblical View of Satan is that he was a created, but defeated rebel against Almighty God. Satan is now limited by the Sovereignty of Jesus Christ. He is on a stake. The limitations of Satan are placed there by God. Satan could only operate within circumscribed limits imposed by God's Sovereignty. Satan has been defeated at every point. He was defeated when he attempted his assault against the authority of God. (Rev. 12: 7-9). He was defeated when he sought to tempt the First Adam for Jesus Christ (the Second Adam) rose from the dead and brought life and resurrection and conquered death...again bringing defeat to Satan. Satan also lost when he sought to tempt the Second Adam (Jesus Christ), was defeated. Satan has been judged and found guilty. His sentence, like all

lawless rebellion against Almighty God, is one of eternal death. His doom is sure. His end is sealed by the Sovereignty of Jesus Christ. Satan's time is now very short (Rev. 12:12). He now works and leads as the captain of the forces of darkness to oppose and impede the progress of God's Kingdom into this earth.

In final summation the Biblical View of Satan is that doom is sure. This Anointed cherub, this highest among the Arch-Angels, is now defeated, judged, and awaits the day of his binding in the bottomless pit. (Rev. 20:1-2). Church Of St Mary And St Alkelda

DATING from 1280, this is one of only two churches dedicated to St Alkeda (Alkelda, Athilda, Alcelda) (the other being in Giggleswick) and is said to be her final resting place. St Alkeda was a chaste Saxon maiden, sometimes described as a princess and a nun. On 28th March 800AD, somewhere close to the site of the church, she was strangled to death for her faith by two Danish women involved in a Viking raid. It has been suggested that they killed her by twisting a napkin around her neck. This scene was recreated in a stain

glass window in the church in the 15th century, fragments of which can be seen in the North aisle west window. When the church was renovated in 1878 a stone coffin was discovered that contained the remains of a woman, who is thought to be the martyred St Alkeda. A plaque near the location reads "Near this pillar, on the spot indicated by tradition, were found, during the work of restoration, the remains of St. Alkelda, patron saint of this church, Anno Domini 1878. F. Barker, rector; T. E. Swale and S. Croft, churchwardens."



William Grainge who wrote in the 1800's suggested her name could have been linked to a holy woman connected to a holy spring. Keld is the Old English name for well or spring and haeligkeld is holy well. St al-kelda could have been saint of the holy well.

St Alkelda's feast day is 28th March which is the anniversary of her death. In 1388 King Richard II gave permission for a fair to held on the Feast of St Alkelda.

Middleham Jewel


According to Edmund Bogg in "From Eden Vale to the plains of York or A Thousand Miles in the Valleys of the Nidd and Yore" (1894) 'Certain fee farm rents in Middleham were required to be paid upon St. Alkeda's tomb, and these were laid on a stone table or altar in the middle of the nave, as were also some annual doles of bread.'

The church displays a replica of what is known as the Middleham Jewel. This 15th century reliquary is a diamond-shaped pendant with a long oblong sapphire. It is engraved with the Trinity on the front and of the Nativity on the reverse. The jewel was found in a field close to Middleham Castle in 1985

Contamination Of The Food Chain

THE National Academy of Sciences recently estimated that 15% of the American people are presently afflicted with allergies to one or more chemical products. The study pointed out that we are exposed to more toxic chemicals while inside our homes than when we go out. The chemicals which are found in every home include benzene, which causes leukemia; the common moth spray and mothballs containing para-dichlo-robenzene, whose use forms an invisibly but damaging gas in some thirty million American homes; lindane, a common pesticide; chlordane, used for termite control (chlordane has been much in the news lately

because of some families who became deathly ill after their homes has been treated by professional termite exterminators; one couple had to move out and totally abandon their home, after inspectors informed them there was no way it could be sufficiently cleansed of the chlordane residues to be habitable). Chloroform compounds are much more common in homes than is popularly realized. The EPA has found that chloroform levels inside of homes was five times greater than outside. Persons taking hot shower baths inside a closed shower curtain are unaware that they are inhaling substantial amounts of chloroform from the steam. Heating the water releases the chlorine in the heavily chlorinated water, which then emerges as a gas while the hot water comes from the nozzle. A daily shower is guaranteed to give you a chloroform high. Formaldehyde is also present in many homes in a number of commonly used compounds.

The daily ingestion of minute portions of any or all of these household chemicals contributes to the development of cancers, as they are sufficiently toxic to become


carcinogenic in daily contact. However, Dr. A. Samuel Epstein, a noted cancer authority from the University of Illinois, states that "Food is the single most important route of exposure for humans to synthetic chemicals." Jim Sibbinson estimated that the average American ingests some nine pounds of chemicals in foodstuffs each year, meaning chemicals so toxic that a fraction of an ounce can cause serious illness or death. These chemicals are put into our food chain as additives, preservatives, dyes, bleaches, emulsifiers, antioxidants, flavours, buffers, noxious sprays, acidifiers, alkalizers, deodorants, moisteners, anti-caking and anti-foaming agents, conditioners, curers, hydrolizers, hydrogenators, drying agents, gases, extenders, thickeners, sweeteners, maturers fortifiers, and other agents.

Most Americans are not aware that of the more than five thousand chemical additives in the foods which they eat every day, about one-third are known to be harmless, another third are described by the Food and Drug Administration as "gras," an acronym for "generally recognized as safe," and the other third, almost 2,000 chemicals, are being used in large amounts, even though they have never been adequately tested for possible harmful results. An effort was made to control the use of these chemicals by Rep. James J. Delaney of New York, in 1958. He introduced the Delaney clause, which was enacted into law. It stated that if any food additive is found to induce cancer when ingested by man or animal, it is to be designated unsafe and cannot be used.

The Delaney Committee, which conducted Hearings from 1950 to 1952, listed 704 chemical additives, of which only 428 were known to be safe. The other 276, which continued to be used without any proof that they were safe, meant that the food processors were playing Russian roulette with the American consumer. Even so, it was another six years before the Delaney Amendment became law, requiring testing of these additives. In the ensuing years, some of these chemicals have been dropped in favour of other substances, while others continue to be used without any positive tests to indicate whether they are safe or unsafe. For more than fifty years, food colourings had been made from

such poisonous substances as lead, chromium, and arsenic. In any case, the crux of the Delaney Amendment called for the testing of food additives to find whether they caused cancer in man or animal. The catch is that most additives are only tested for toxicity, not for their propensity to cause cancer.

Coumarin, which was a key ingredient of imitation vanilla flavouring, had been in continuous use for seventy-five years before it was found to produce serious liver damage in laboratory animals. An artificial sweetening agent, dulcin, was used as a sugar substitute for fifty years before it was found to produce cancers in test animals. Butter yellow was found to cause cancer of the liver, that is, AB and OB Yellow. Mineral oil, the famous Rockefeller cancer cure of the mid-1800's, which was now used in many salad dressings, was found to prevent the absorption by the body of vitamins and other nutritional needs.



The 1938 Food and Drug Cosmetics Act certified nineteen dyes for use in foods. Since then, three have been decertified, leaving sixteen for use in foods. The label "certified" simply means that it is pure—it offers no clue as to

its possible effects on the human system. Dr. Arthur A. Nelson reported that FDA tests in 1957 reported that ten of the thirteen certified dyes then in use had produced cancers when injected under the skin of rats. Science writer, Earl Ubell (above), estimated that humans would get twice as much of these dyes by mouth as the rats had injected under their skin. The oil-soluble colours were so poisonous that the rats died before the scientist could see whether any cancer had developed. Nine of the dyes commonly used in foods in the United States are as follows:

Orange No. 1—used in fish pastes, carbonated beverages, jellies, puddings and many other foods (now decertified).

Orange No. 2—Cheese, margarine, candies, exteriors of orange fruit (now decertified).

Yellow No. 1—Confectionery, spaghetti and other pastas, baked goods, beverages.

Yellow No. 3 (Yellow AB)—Edible fats, margarine, butter, candy.

Yellow No. 4 (Yellow OB)—Margarine, butter, candy. **Green No. 1**—Cordials, candy, bakery goods, soft drinks, jellies, frozen desserts.

Green No. 2—Frozen desserts, candies, cakes, jellies, biscuits, cordials.

Green No. 3—Bakery products, candies, jellies, desserts. **Blue No. 1**—Frozen desserts, jellies, puddings, ice cream, candies, cake, icings.

Yellow AB and Yellow OB, which are known cancer hazards, have been widely used to colour margarine and butter. They are made from a dangerous chemical called beta-naphthylamine. It is notable because it has low toxicity, that is, it is not poisonous in its effect, but it is one of the most carcinogenic substances known. Orange No. 2, O-tylazo-2-naphthol, which had been used heavily in United States, the food industry using thousands of pounds of Orange No. 2 annually, was finally discontinued in 1956 when it was found to induce intestinal polyps and cancer in test animals.



White bread, which had long been known to cause brain seizures in dogs, because of the loss of critical nutritional ingredients in processing the beautiful white flour, has in recent years been enriched with a wide variety of vitamins and nutrients. However, a shot of synthetic vitamins, another shot of emulsifier to keep it soft, and the addition of other ingredients, suggests that it might well be produced from a test tube instead of a bakery.

Emanuel Kaplan and Ferdinand A. Dorff, researchers with the Health Department in Baltimore, presented a report, "Exotic

Chemicals in Food," which was presented at a meeting of FDA officials. We quote, "Let us quickly consider the chemical treatment of the various ingredients used in bakery practice. The flour is derived from seeds probably treated for plant disease protection with organic mercurials or similar agents, and the seeds are planted on soil influenced by fertilizers. Selenium (an extremely poisonous mineral substance) may be extracted from the soil. In milling, flour is treated with improvers, oxidizing agents such as persulfate, bromate, iodate and nitrogen trichloride, which affect protease activity and gluten properties.

"Bleaching agents such as oxides of nitrogen, chlorine and benzoyl peroxide convert the yellow carotenoid pigment to colorless compounds because of alleged consumer desire for white bread. Vitamins and minerals are added in compulsory 'enrichment.' Mineral salts may be added to stabilize gas-retaining properties of flour gluten. Cyanide or chlorinated organic compounds may be employed in fumigation of the resulting flour in storage

"The water used may be chemically purified by means of alum, soda ash, copper sulfate and chlorine . . . Ammonium salts and other chemicals are employed as yeast nutrients. Chemical leaveners may contain sodium bicarbonate, alum, tartrates, phosphates, starch, and cream of tartar. Fluorine is a possible natural contaminant of the phosphate . . . Oleomargarine, if used, may have added colour, vitamin A, neutralizes, interface modifiers and preservatives; or the margarine may be packed in a preservative-treated wrapper. Mineral oil is frequently used as a dough trough or pan lubricant . . . Milk or milk products may contain neutralizer and antioxidants . . . Artificial coal tar colour may be used . . . Stabilizers and thickeners such as gums and treated starches may be employed as fillers. Synthetic flavours used contain glycerine, alcohol or substitute chemicals as solvents for a variety of alcohols, esters, acids, and ketones, and may contain saccharine. (Ed. Note: This would probably be replaced today by aspartame, an artificial sweetener widely used, which is said to cause brain seizures.) Spices may be natural spices subjected to fumigants or solvent-extracted spice essences. Mould inhibitors such as calcium propionate may be employed and the

final product may be contaminated on the store shelf with insecticidal powders such as sodium fluoride."

Since this report was delivered in the 1950's, many new chemicals have come onto the market, whose properties may be either more or less dangerous than those listed by Kaplan and Dorff. The increasing use of hydrogenated oils, and their linkage to heart disease, offers an additional area for concern. More than a billion pounds of hydrogenated oils are now used annually.

It is estimated that almost half of the American population, more than 100 million citizens, now suffer from some form of chronic illness, of which 25 million are allergic disorders. These allergies are increasingly found to be caused by exposure to or ingestion of some chemical substance. 20 million Americans have nervous disorders; 10 million have stomach ulcers; 700,000 suffer from cancer, and lesser numbers suffer from such diseases as lupus and muscular dystrophy.

In 1917-18, of the draftees for World War I, 21.3% were rejected and 9.9% placed in "limited service" because of various handicaps. In the Korean War period, after World War II, from 1947-1955, 52% of the draftees were rejected for physical and mental defects, a 21% increase since World War I, despite the great "advances" which the United States had supposedly made in nutrition, medical care, meals for school children, and other marks of progress. These figures also do not take into account that standards for World War I draftees were much higher than in World War II. In 1955, 25% of all draftees from New York City, aged from 21 to 26, were turned down for heart ailments. Of some 200 Americans killed in Korea, and autopsied, 80% were found to have advanced stages of heart disease. Dr. Jolliffe reported to Congress in 1955 that, "Whereas coronary heart disease was a rarity prior to 1920, it has now become the No. One cause of death in the 45 to 64 year old age group as well as after 65." How much of this was due to the increase in the use of chlorinated water supplies after World War I, Dr. Jolliffe does not say. Although specialists know that the ingestion of chlorine is a primary factor in the formation of

arteriosclerotic plaques on the walls of arteries, no studies have been commissioned to determine the use of chlorine as a factor in the increase of deaths from heart failure. Dr. Mendelsohn has noted, fluoridation of water is one of the Four Holy Waters of the Church of Modern Medicine. Scientists dare not tamper with what is essentially a religious and emotional conviction.



Dr. Mendelsohn also points out the possible contradictions in the American Medical Association's frequent admonitions to get your daily supply of the Big Four for adequate nutrition, that is, vegetables and fruits, grains, meats and dairy products. Dr. Mendelsohn points out that many groups cannot tolerate cow's milk because of enzymatic deficiencies. Some studies show that 75% of the world's peoples are lactose intolerant, and cannot digest cow's milk.

One of the post World War II epidemics was the worldwide reaction to the extensive use of DDT, even though DDT had come into being as the supposed guardian against epidemics during the war. Its use had been advertised as the miracle pesticide which would prevent outbreaks of various diseases in the war-ravaged nations of the world. However, DDT was eventually found to be a cumulative poison in the human system, much like sodium fluoride. Not only were considerable concentrations of DDT being accumulated in man's fatty tissues, but he also was consuming additional amounts in every forkful of food that he ate. Nobel Prize winner Dr. Otto Warburg heralded the dangers of DDT when he warned that any poison which interferes with the respiration of the cells causes irreparable damage and produces degenerative diseases such as cancer. Despite such warnings, from 1947 to 1956, the annual production of DDT quadrupled to an annual total of more than five hundred million pounds. The Public Health Service analysed food in a Federal prison for DDT content, finding stewed fruit with 69 ppm content, bread with 100 ppm DDT content, while lard used in the preparation of food was estimated to have 2500 ppm DDT.

Tests also showed that it took many years to lower the amount of DDT stored in body fat. DDT is even more persistent in soil; seven years after DDT was applied to test plots 80% of it remained. Orchards and farms which used DDT in annual spraying built up enormous amounts in the soil. DDT has since been banned, but the residues remain. Even after the ban, Monsanto continued to make huge profits from the sale of DDT by exporting it to other countries. Another commonly used pesticide, chloridane, was found to be four times as toxic as DDT. Another substance which was later banned was aramite, an acknowledged carcinogen used as a pesticide.

Produced by the chemical conglomerate, U.S. Rubber, in 1951, aramite came under a barrage of criticism. Despite the widespread publication of FDA tests proving its dangers, it remained in use until the spring of 1958, when it was finally withdrawn.

Some substances containing arsenic are still found in foodstuffs as pesticide residue and as a food additive for poultry and livestock.

Selocide, a pesticide based on selenium, was found to produce cirrhosis of the liver in persons ingesting food which had been treated with this chemical. After two hundred children became ill from eating dyed popcorn at a Christmas party, the FDA announced de-certification of the three dyes involved, Red No. 32, Orange 1 and Orange 2. A government report stated that, "When FD&C Red No. 32 was fed to rats at a level of 2.0 per cent of the diet, all the rats died within a week. At a 1.0 per cent level, death occurred within 12 days. At 0.5 per cent, most of the rats died within 26 days. At 0.25 per cent approximately half of the rats died within 3 months. All of the rats showed marked growth retardation and anaemia. Autopsy revealed moderate to marked liver damage. Similar but less severe results were obtained with rats on a diet containing 0.1 per cent of FD&C Red No. 32 ... Dogs taking 100 milligrams per kilogram of body weight per day showed moderate weight loss ... A single dose gave diarrhoea in the majority of the dogs tested."

Light As Darkness **Isaiah 5:20, 42:16, 59:9-10 , Matthew 6:23, Luke 11:35** **John Trotter - Winmalee Australia**



YOU cannot from a physical point of view have darkness and light in the same room, for darkness is the absence of light. But by giving a figurative sense to the two words, light and darkness, we can understand how these can be seen as interchangeable terms. The analogy given in the Bible, "that the light of the body, is the eye" is

akin to another saying "knowledge is to the mind, what light is to the eye".


Ferrar Fenton says of this verse: "The eye is the lamp of the body". The words light and lamp are very different Greek words. I would suggest that the eye is an analogy of the light that comes from the lamp. The lamp had oil in it to provide light. This oil is symbolic of the Word of God which is to lighten our way through darkness and lack of understanding (Psalm 119:105).

In Matthew 6:22 there is reference to the single aspect of the eye. This word "single" (Strong's 573) means clear. Fenton used the word "sound". James 1:8 says "a double minded man is unstable in all his ways". One commentary expresses the view that if we try to focus on more than one thing at a time our view or understanding can be distorted. See Matthew 6:24 for reference to God and mammon which is the deification of money. Our conscience or the eye must be very sure in our deciding as to which side of the fence we are

on. As Christ says in Matthew 12:30 “he that is not with me is against me”. In reality Christ is the dividing line. In short if our conscience is single minded then the soul of man (the body) will not be evil.

But it is Matthew 6:23 that raises an issue that needs some explaining. Matthew says here that light can be darkness. How can this be?

Fenton expresses Matthew 6:23 in the following way: “But if your eye is diseased, your whole body will be in darkness. Consequently, if your sight is defective, all your body will be darkness”. From previous thoughts this verse can also be written as follows: But if your conscience is distorted, then your soul (the body) can be deceived by false teaching. I am not inferring here that any one person has all the truth. We are told in the Bible that the Holy Spirit will guide you into all truth (John 16:13). In other words the search for truth is on-going, even into the everlasting.



Again Thayer's commentary comes to the rescue for he shows that the light here refers to “reason, mind, and the power of understanding”. This reference to light in this context is very different to the Truth that Christ speaks about, for us to follow. It is this light

that is the darkness in the mind of those who cast Christ aside. This is the light of the “evil eye”. As John 3:19 says, “And this is the condemnation that light is come into the world, and men loved darkness rather than light, because their deeds were evil”. The light that is evil comes from a heart that is deceitful, and desperately wicked (Jeremiah 17:9).

This darkness is but a shade or shadow or a faint resemblance of the truth. The outline is very obscure to the point that one can only have relative opinions or a point of view. So much of what is taught today does have a little truth and also it is presented in such a scientific or analytical way that for most it is difficult to understand the facts of the matter. As Job 15:16

says, “How much more abominable and filthy is man, which drinketh iniquity like water?”

One of the platforms of the Humanist Manifesto is that man is basically good. Any evil in man is largely due to environmental issues or what level of society you were born into. Any other reasons for misbehaviour can be dealt with by pharmaceutical drugs. Whilst the above might be an over simplification of how the problems of society are dealt with, the humanist will not accept the Biblical view that man is sinful. If man is not sinful we therefore do not need the Law of the Bible. In the Bible we are told that sin “is the transgression of the Law” (1 John 3:4). It is therefore the conclusion of the Humanist that he must write his own laws for society. The heart or soul of man is evil and it is the heart that defiles man (Mark 7:21-23). It is for this reason that man needs a Saviour and Israel needs a Redeemer.

In Isaiah 5:20 we read , “Woe unto them that call evil good, and good evil; and put darkness for light and light for darkness; that put bitter for sweet and sweet for bitter”. The end result is that the wicked are justified or acquitted and the just are condemned (Proverbs 17:15). Malachi 2:17 and 3:15 adds another dimension of confusing darkness and light. These verses say in Ferrar Fenton: “You have wearied the Lord by your speeches: But you may ask , “In what have we wearied Him?” By your saying of all who do wrong, “They are right in the sight of the Lord and He will be satisfied with them, or where is the justice of God?” and 3:15, “So now we congratulate the cruel, for they prosper. The practices of vice are prosperous. The despisers of God also are safe.”

Please consider the above verses and you will quickly realise just what a mess this nation is in and that includes all the Western Nations who once had Godly men and women who were respected by the people. The beginnings of our Christian Heritage has been cast aside. It is no wonder the people are confused and have found themselves more content in their requests like those uttered in Isaiah 30:9-11 which say: “That this is a rebellious people , lying children, children that will not hear the Law of the Lord. Which say to the seers, “See not”; and to the prophets, “Prophecy not unto us right things, speak unto us smooth things, prophecy deceits: Get you out of the way, turn aside out of the path,

cause the Holy One of Israel to cease from before us”.

Ezekiel 22:27 has an interesting reference to these wolves who destroy souls to obtain dishonest gain. The underlying meaning of the word “wolf” in this verse is “yellow”. It is quite possible that these wolves were not only violent but cowards or despicable dogs as the word yellow implies (World Book dictionary).

In the New Testament the word “wolf” refers to the colour white. But Strong's shows that this word can be traced back to the word “light”. By applying a figurative sense to the word light it is understandable how these wolves are also associated with those who are translating “light into darkness”. Also as white is the combination of the 7 colours of the rainbow I can see how these wolves are mixing up the religions of the world into the confused religion of Babylon. Also as the number 7 means spiritual perfection



Racial Theory Evolved into “Racism”

According to the Oxford English Dictionary, the term “*racism*” emerged in the early 1930’s, as distinct from the many controversial, “*theories of race*” which had existed for hundreds of years before the term “racism” was formulated and adopted as a noun. Historically, ones pride in racial origin and respective culture have always been worthy of support and the promotion and adoption of their values was always considered justifiable and worthy – mandatory as well, in some historic instances.

The expression, “*Racists*” is a modern one: its collective counterparts, *racism* and *racialism*, emerged out of the turbulent 1930’s in parallel with the growth of control and influence of Talmudic Judaism within the international financial world and in the international Media, which Jews either owned or otherwise controlled. *Racism* as an expression, is perpetuated by this increasingly noisy and influential minority but it also has become symbolically associated with a perceived persecution of “all” minorities and it is used in similar context as another equally touted “nullification” word -- “*anti-Semitism*”- used effectively to stifle concern over criticism of Jewish incursions into the political, religious, and economic life of other peoples, especially Christians: affairs in which Jews seek dominion. A dictate that stems from within the pages of their Babylonian Talmud.

The use of the word *Anti-Semitism* obliquely infers and seeks to affirm a validity in its claimants geographic origins, but its proponents are not Semitic in origin, instead, are admittedly Turkic-Mongol, the progeny of the biblical, Ashkenaz; Grandson of Noah’s son Japheth, not of Shem – therefore, they cannot be “Semitic” (See Gen.10:1-3)

The claims about *anti-Semitism* can thus be easily disposed of, but the collective term *Racism*, is applied across a broader, national scale when it becomes inclusive, being used to bring ‘other’ minorities aboard so to speak, thereby adding support and strength to

Modern “racism” refers to “*beliefs and practices that assume inherent and significant differences exist between the genetics of various groups of humans*” – a natural and plausible outlook -- since the historic views of most peoples have always been considered as favouring personal exploitation and attitudes of pride in, and for, one’s own race. History is replete with wars, writings and demonstrations by races and nationalities who strove to perceive and present and defend the uniqueness and the character and nationalism of their own people. And rightly so! The Bible and Christianity do express the need for, and demand for racial separation, for discrimination and the defence and retention of national characteristics – especially the biblically promoted exclusivity of Israelites and the Divine relationship which is so often noted in the Bible.

This stems from Divine guidance from God Himself, who erected barriers of separation between the various races. The following verse from Deuteronomy 32:8 speaks to this point:

“When the Most High divided to the nations their inheritance, when He separated the sons of Adam, He set the bounds of the people according to the children of Israel.”

There we can see that God not only established a geographic separation, of the world’s people, but also we find an indication of Divine discrimination; the Divine favoring of the children of Israel in expressions affirming their Exclusivity, their unique relationship with Him.

Because the Christian Bibles' 'creationism' does express elements of racism, non-Christians insist that such historic doctrines of racism defame the values of Christianity -- that in adopting Old Testament "racism," some Christians are "racist" in their doctrines. Thus, many Fundamental and Evangelical Christians who (through Talmudic influence) mistakenly adopt only New Testament values, and detach themselves from any biblical proof of their historic origins – rightly seen by some, as the Chosen people, defined in both the OT and New Testament and designated as the Lost sheep of the House of Israel,



Such a mistaken and confused view of Who is who, is found among most Fundamentalists and Evangelical Christians!

The "blinded" or those who insist that proper interpretation of Old Testament guidance falls solely within the purview of Jews and Judaism while asserting that OT edicts do not necessarily apply within Christianity. Many Fundamental and Evangelical churches have chosen to adopt this view, but they also have abandoned the original, "Historicist" view of Biblical prophecy and the recognition of just Who God's Chosen people really were and are today.

Yet, since the 1930's and the increasing rise to political and financial influence of Talmudic Judaism, expressions of xenophobic attitudes have been countered by a "nullification" process, induced by those who had achieved dominion over newsprint, publishing houses and the media – hoping thereby, to change national and international racial concepts and tribal values by deriding historic exhibitions of national pride and sovereignty as being adverse to human dignity and a violation of 'human rights'. The establishing of the United Nations under these biblically adverse qualities affirms this talmudic program to disestablish national pride and Divine favour.

Out of these recent pronouncements has developed a controversial opinion that


expressions of national pride is "racism," adopted also, by other internal minorities, defining it rather as a system of "oppression" – which view, when properly evaluated, ignores the facts that affirm that races *do* have considerable differences; both in physical and sociological aspects; in religious differences as well, Further, the different genetic characteristics that modern technology has unveiled, confirm that genes among the races are varied, and that such distinguishing differences may have been Divinely intended, but these views are ignored or twisted to accommodate the use of 'racism' to stifle dissent and agitation toward and against minorities—all the while, reducing the power and influence of white Christianity—confirming, as noted by the prophet Daniel, that "when he shall have accomplished to scatter the power of the holy people, all these things shall be finished." (See Dan.12:7)

Yet, if a historic evaluation of the expression "racism" is done, it should become apparent to any discerning reader that the term has evolved as noted earlier, into a tactical weapon of sorts, targeting the Christian world and their racial attitudes that were adopted from long before the time of the American Civil War and as further reinforced from events associated with many other international wars of sovereignty, whose origins can be traced to how and when that 'influential minority' used and abused Christian principles and twisted them into justification for other wars; even WW I and WW II. Here, is a modern Encyclopaedia definition of this issue:

"Now, racism is seen as something entirely to be opposed by almost all mainstream voices, though there is little agreement over what is "racism." It is well worth remembering this, when looking at current concepts of "racism." In hindsight, many eminent scientists, philosophers and statesmen appear "racist" by late-20th century standards; although the recognition of the historical nature of these judgments is deemed by many to exonerate these figures or governments for their ideas or actions." (Wikipedia-The Free Encyclopaedia-"Racism")

What this Wikipedia statement reveals, speaks to facts of history: that pride in race and nationality were and always had been, legally and morally authorized, but the Wikipedia authors failed to note that the basis behind these

historic voices must be attributable in most cases, to their well-grounded Biblical faith of the participants, as the doctrines then taught that followed biblical instructive views on a Biblical people's exclusivity that are so vehemently castigated and reviled by today's media and blinded 'Christian' Israelites as well.



One author, S.E.D. Brown, writing for The CDL Report in an article titled: "The Total Zionist Onslaught On The West" identified the use of the terms "racism" and "anti-Semitism" as words used to stifle any rational, open discussion of the relationship of Jews to others.

"The problem of race today must always be referred to as a legal, constitutional, moral or psychological problem. Never can the problem be referred to in its real terms, namely as a biological and political problem. For that, it is uniformly argued by all the "experts" and the "leading thinkers" in the world, is "racism." And is not the racism of the White man—but that of the black man and the Jew—the very hall mark of the "anti-Semite" and "genocide"?"

Indeed, so intimidated has the West become by the smears of "racism" and "anti-Semitism" that the people of the West are today, cowered into complete silence. These terms are never defined so that the victim may disagree or defend himself, but are spat out everywhere as the accusation of some vicious crime, placing the defendant beyond the pale and bringing automatic condemnation without trial."

History clearly shows that there have been periods when one race, nation or empire developed its "civilization" before other peoples/nations, and it was these developing national 'civil' qualities that enabled them to either dominate or assist other races and nationalities - until they peaked at decadent levels of success and power and then devolved into becoming dictatorial and confrontational with other nations - and then this "empire" dissolved. Then, these distorted elements of "civilization" shifted to other more successful,

more powerful or "civilized" races and again, the history of the world changed accordingly.

A period that began in the 1500's can be considered as the time biblically defined as being just past the half-way point of a time that St. Paul expressed as the biblical period when "*the fullness of the Gentiles be come in.*" (Rom.11:25). A time when the European Nations, or the "Western World" experienced its Reformation and then rose to international dominion and prominence: when European exploration, conquest and colonization rose to overshadow so of much of the rest of the world. Thereby *Fulfilling the Covenant promises made to Abraham/Isaac/Jacob-Israel, manifest in Europe's Christian Israelite nations.*

Further, when it is understood that the Latin word "*Gentilis*" or "Gentile" used by Paul, rightfully refers to these self-same Europeans, as Israelites and not to *pagans* or *heathens*, it should be apparent that these European nations had a "**kinsman**" relationship amongst themselves, derived from a common basis, a common heritage, biblically defined by the persistent use by Paul, of the term "Brethren", meaning, *from a common womb* - Sarah's. "*...she shall be a mother of nations; kings of people shall be of her.*" (Gen.17:16)

In Romans 9, the Apostle Paul, of the tribe of Benjamin, even advises these "Romans", telling them who they were, and how they were related:

"For I could wish that myself were accursed from Christ for my brethren, my kinsmen according to the flesh: Who are Israelites; to whom pertaineth the adoption, and the glory, and the covenants, and the giving of the law, and the service of God and the promises."(Rom. 9:3-5)

From such recognition of Israelite origins and their purpose, no one can change what has been so historically well established, but, these historic Truths still remain obfuscated and cloaked. First by God for His purposes originally, in a Divinely stated time period (2520 years) but today by organized Churches and Talmudic Judaism, fearful that the truths of the identity of the People of the Book found within the pages of the Word do speak of a coming Restoration of Israel, of its "lost sheep" as is now finally emerging. A Restoration of 'Jacob' to the status

enjoyed at Mt. Sinai when in unison, all tribes agreed to the stipulations of the Law.



Theirs is a heritage that was and yet is, very distinct from the “non-western” world, a heritage of Divine biblical qualities seen today, revealed and adopted in the historic grants of largess, of inventions, and the dramatic rise and successes of the Western world – especially in pertinent Biblical prophetic views related to the Divine Abrahamic Promises which are also recognized as having been manifest *only* in those *lost sheep of the house of Israel* which does not include Ashkenazic Jews.

As was noted earlier, civilizations rise and fall, and periods of national and racial prominence and control wax and wane as well. St. Paul understood these historic events as fact, for when he alludes to the ending to that time of predominant power of “Gentile” dominion, his words infer that it concludes: as has happened throughout history, for his words, “*be come in,*” indicates an end to that time of the “Gentiles, or “Nations,” the “Israelite Nations” (See Romans 11:25)

(In verse 11, the Hebrew word “Goyim” has been mistranslated into the Latin word, “Gentiles” rather than into its proper definition “Nations”)*

These words of Paul apply as well to that Divinely ordained period of “dominion” of the “*holy people*”, a time that concludes when this power of the holy people is “*scattered*”, as noted above what the prophet Daniel was shown in his time (Dan.12:7) and as addressed by Jesus: Luke recording His words that made

reference to the same historic time period as being when; “...*the time of the Gentiles(nations/tribes) be fulfilled.*” (Luke 21:24)

This prophetic event terminates the generations of man and his ‘civilizations’ and what eventually emerges from this scattering of the power of the “*holy people*” has ever been the hopeful theme of the Christian Bible -- the Restoration of His chosen people, a people whom the Bible identifies throughout, as *Israel* or *Jacob* and *Judah* – members of a rejoined and restored Kingdom, originally designed and planned in mutual covenant at Mt. Sinai – but disrupted by the failures of these self-same “*holy people*” until history ran its course and an eventual Divine interdiction of the *adversaries* of the Holy People, defined as the *Tares* occurs (Matt.13:38-43), and closes this final period of Adam man’s worldly dominion - the *time of the Gentiles be come in*, or concludes—after a rather brief, promised, (Gen.27:40), 2nd captivity of Jacob/Israel by Esau/Edom – that is terminated by Divine intervention.

***Note: The Hebrew word “*goi*”, or the plural, “*goyim*” is a collective noun meaning ‘*nation*’ or sometimes a collective body of people. But it has been translated into English many different ways. The word occurs 557 times in the Old Testament. It is translated as ‘*gentile*’, 30 times, ‘*heathen*’, 142 times; ‘*nation(s)*’ 373 times, ‘*people*’ 11 times, ‘*another*’, 1 time. The same thing is true of the Greek word “*ethnos*”. It occurs 164 times in the New Testament. It is translated as ‘*gentile*’, 93 times, as ‘*heathen*’, 5 times, ‘*nation(s)*’, 64 times and ‘*people*’ 2 times. These word ‘*options*’ were available to the translators or editors and account for potential errors in definition and translation by translators. This also led to skewed doctrinal issues that produced confusion and dissention in the Christian world. Was there and is there, a purposeful intent found in such deviations?**

Rudolf Hess Anonymous August 17, 2012 Deputy Führer: a Courageous Hero for Peace



— "My coming to England in this way is, as I realize, so unusual that nobody will easily understand it. I was confronted by a very hard decision. I do not think I could have arrived at my final choice unless I had continually kept before my eyes the vision of an endless line of children's

coffins with weeping mothers behind them, both English and German, and another line of coffins of mothers with mourning children" (**Rudolf Hess, June 10, 1941**).

I do not propose to argue about charges that are concerned with the internal affairs of Germany, with which foreigners have no right to interfere. I make no complaints about statements, the aim of which is to discredit and dishonour myself and the entire German people. I regard such statements coming from enemies as confirmations of our honor. It has been my privilege to serve for many years under the greatest son to whom my people have given birth in its thousand years of history. Even if it were possible for me to do so, I would never wish to wipe this period of service out of my life. It fills me with happiness to know that I did my duty toward my people. I regret nothing. Whatever men may do to me, the day will come when I will stand before the judgment seat of the Eternal: to Him I will give an account of my actions, and I know that He will pronounce me innocent" (Rudolf Hess' last statement before the International Military Tribunal in Nüremberg, August 31, 1946).

When World War II ended, Germany was in total ruin. But it was to get even worse. Within a few years 15,000,000+ Germans and ethnic German civilians were cleansed, with 9,000,000+ murdered by starvation and disease. This was

The Queen Attends A Cabinet Meeting

Sir,—The *Daily Mail* reported the Queen's attendance at the Cabinet meeting on 19 December 2012 which comprising Her Majesty, the Cabinet Secretary and 31 ministers.

And the numbers in the Cabinet? The essential information is found in that superb quote; Parkinson's law. In it professor Parkinson tells us that the maximum is a handful of five people. This recalls the supreme Council in our written constitution – the four Great Offices of State upholding the throne. These are hereditary positions, for a Jack in office cannot be trusted. The first is the Lord High Steward. His task is to read all acts of parliament and make sure they are lawful before the King signs them into law. A check and balance on King and Parliament. But, contrary to our written constitution he has been set aside, being a great inconvenience to Parliamentarians with foul designs.

This happened in the so-called "restoration" in 1660. The engraving of the procession to the crowning at the Abbey shows three High Officers on horses directly behind Charles the very second. But there is a riderless horse labelled "The horse of an High Officer of State." The Lord High Steward had been set aside!!

By doing this Charles had done the most kingly thing, quite the worst act of any Stuart monarchs, from which we are still suffering.

Why, oh why, did the Saxons make the Stuarts King of England? When this genetic line landed from Ireland they brought their troubles with them and with their Empire building turned the mountains of Caledon into a bloodbath for over 1000 years. Defeated clan chiefs, petty kings in their own right, had to go to Dunedin and to have their arms matriculated by the Lord Lyon King of Arms. Only two clans avoided this fate. The Macquires and the Gunns. The two witnesses!

The present dynasty are on the throne because of the faint connection with the Stuarts. I have just learned that when Queen Anne died, those in power went through the seniority list of the Stuarts. None were acceptable as they were all Roman Catholics until they came to number 50 and George became George 1st.

This seems rather curious as we are a Royal nation seated on - "*This Royal Throne of Kings, this sceptred isle*"

Prof Parkinson tells us that the maximum size of the Cabinet is 22. And every time the Cabinet increases its numbers it becomes less efficient and loses power. Now of course everybody wishes to be a Cabinet member (*will to power*) and persons acting as prime minister wish to reward all their chief supporters. So they have every motive to invent new ministries and enlarge their Cabinet. His successor has the same motives and the Cabinet will get ever larger, less powerful and less efficient. Now we have 31 so-called ministers. Which explains why our nation is so sick today, for the real decisions are made for it elsewhere and the 31 objects are only rubber stamps.

I might mention that the Lord High Steward, with the assistance of Hugh Thornton tried to get recognition of this post as the Coronation approached of Queen Elizabeth. But Parliamentarians do not want any check or balance imposed on them for they are not democratic or responsible. So this noble attempt failed. And they still make unlawful acts of parliament.

The second High Officer of State: the Lord High Constable, who is in command of the King's Horse and Foot, has also been set aside. He is an important check and balance on the power of the king, for it is he who declares war, for the King is not allowed to. Sometimes this job is very easy

such as the outbreak of the hundred years war. The King of the French sent King of England a very obvious insult – some tennis balls. Very shortly thereafter the French ambassador was packing to return to the fair land of France! France paid dearly for the folly of their King – Crecy, Poitiers, etc. Their generals appear to have been incompetent, for they only got rid of us by following a woman. Joan of Arc was judicially murdered by the Roman Catholics but then made her Saint in the 20th century!!

Politics is a specialised form of crime. A typical criminal is Chamberlain who in 1939, knew perfectly well that he was not allowed to declare war by our written constitution, so he used the weasel words, "*A state of war now exists.*" It is high time that the army learned not to march when these weasel words are said by a Prime Minister attempting to start a war. SCHOOLS AS THE HUB OF THE COMMUNITY

A **NOTHER** angle was that the schools would become more important in people's overall life. Kids in addition to their academics would have to get into school activities unless they wanted to feel completely out of it. But spontaneous activities among kids; the thing that came to my mind when I heard this was - sand lot football and sand lot baseball teams that we worked up as kids growing up. I said the kids wanting any activities outside of school would be almost forced to get them through the school. There would be few opportunities outside.

Now the pressures of the accelerated academic program, the accelerated demands where kids would feel they had to be part of something - one or another athletic club or some school activity - these pressures he recognized would cause some students to burn out. He said. "The

smartest ones will learn how to cope with pressures and to survive. There will be some help available to students in handling stress, but the unfit won't be able to make it. They will then move on to other things." In this connection and later on with drug abuse and alcohol abuse he indicated that psychiatric services to help would be increased dramatically. In all the pushing for achievement, it was recognized that many people would need help, and the people worth keeping around would be able to accept and benefit from that help, and still be super achievers. Those who could not would fall by the wayside and therefore were sort of dispensable - 'expendable' I guess is the word I want. Education would be lifelong and adults would be going to school. There'll always be new information that adults must have to keep up. When you can't keep up anymore, you're too old. This was another way of letting older people know that the time had come for them to move on and take the demise pill. If you got too tired to keep up with your education, or you got too old to

learn new information, then this was a signal - you begin to prepare to get ready to step aside.

SOME BOOKS WOULD JUST DISAPPEAR FROM THE LIBRARIES

IN addition to revising the classics, which I alluded to awhile ago and with revising the Bible, he said, "Some books would just disappear from the libraries." This was in the vein that some books contain information or contain ideas that should not be kept around. Therefore, those books would disappear. I don't remember exactly if he said how this was to be accomplished. But I seem to recall carrying away this idea that this would include thefts. That certain people would be designated to go to certain libraries and pick up certain books and just get rid of them. Not necessarily as a matter of policy - just simply steal it. Further down the line, not everybody will be allowed to own books. And some books nobody will be allowed to own.

CHANGING LAWS

ANOTHER area of discussion was laws that would be changed. At that time a lot of States had blue laws about Sunday sales, certain Sunday activities. He said the blue laws [Sunday laws] would all be repealed. Gambling laws would be repealed or relaxed, so that gambling would be increased. He indicated then that governments would get into gambling. We've had a lot of state lotteries pop up around the country since then. And, at the time, we were already being told that would be the case. "Why should all that gambling money be kept in private hands when the State would benefit from it?" was the rationale behind it. But people should be able to gamble if they want to. So it would become a civil activity, rather than a private, or illegal activity. Bankruptcy laws would be changed.

I don't remember the details, but just that they would be. And I know subsequent to that time they have been. Antitrust laws would be changed, or be interpreted differently, or both. In connection with the changing anti-trust laws, there was some statement that in a sense competition would be increased. But this would be increased competition within otherwise controlled circumstances. So it's not a free competition. I recall of having the impression

that it was like competition but within members of a club. There would be nobody outside the club who would be able to compete. Like teams competing within a professional sports league; if you're the NFL or the American or National Baseball Leagues - you compete within the league but the league is all in agreement on what the rules of competition are - not a really free competition.

THE ENCOURAGEMENT OF DRUG ABUSE TO CREATE A JUNGLE ATMOSPHERE

DRUG use would be increased. Alcohol use would be increased. Law enforcement efforts against drugs would be increased. On first hearing that it sounded like a contradiction. Why increase drug abuse and simultaneously increase law enforcement against drug abuse? But the idea is that, in part, the increased availability of drugs would provide a sort of law of the jungle whereby the weak and the unfit would be selected out. There was a statement made at the time: "Before the earth was overpopulated, there was a law of the jungle where only the fittest survived. You had to be able to protect yourself against the elements and wild animals and disease, but if you were fit you survived. But now we've become so civilised - we're over civilised - and the unfit are enabled to survive only at the expense of those who are more fit." The abuse of drugs would restore, in a certain sense, the law of the jungle and selection of the fittest for survival. News about drug abuse and law enforcement efforts would tend to keep drugs in the public consciousness. And would also tend to reduce this unwarranted American complacency that the world is a safe place, and a nice place.

ALCOHOL ABUSE

THE same thing would happen with alcohol. Alcohol abuse would be both promoted and demoted at the same time. The vulnerable and the weak would respond to the promotions and therefore use and abuse more alcohol. Drunk driving would become more of a problem; and stricter rules about driving under the influence would be established so that more and more people would lose their privilege to drive. Again, much more in the way of psychological services would be made available to help those who got hooked on drugs and alcohol. The idea

being, that in order to promote this \neg drug and alcohol are used to screen out some of the unfit - people who otherwise are pretty good would also be subject to getting hooked. And if they were really worth their salt they would have enough sense to seek psychological counseling and to benefit from it. So this was presented as sort of a redeeming value on the part of the planners. It was as if he was saying, "You think we're bad in promoting these evil things - but look how nice we are - we're also providing a way out!"

RESTRICTIONS ON TRAVEL

THIS also had connection with something we'll get to later about overall restrictions on travel. Not everybody should be free to travel the way they do now in the United States. People don't have a need to travel that way. It's a privilege! It was kind of the high-handed the way it was put.

THE NEED FOR MORE JAILS, AND USING HOSPITALS AS JAILS

MORE jails would be needed. Hospitals could serve as jails. Some new hospital construction would be designed so as to make them adaptable to jail-like use.

NO MORE SECURITY

NOTHING is permanent. Streets would be re-routed and renamed. Areas you had not seen in a while would become unfamiliar. Among other things, this would contribute to older people feeling that it was time to move on, they feel they couldn't even keep up with the changes in areas that were once familiar. Buildings would be allowed to stand empty and deteriorate, and streets would be allowed to deteriorate in certain localities. The purpose of this was to provide the jungle, the depressed atmosphere for the unfit. Somewhere in this same connection he mentioned that buildings and bridges would be made so that they would collapse after a while, there would be more accidents involving aeroplanes and railroads and automobiles. All of this to contribute to the feeling of insecurity, that nothing was safe. Not too long after this presentation, and I think one or two even before in the area where I live, we had a newly constructed bridge break. Another newly constructed bridge defect was discov-

ered before it too broke. I remember reading just scattered incidents around the country where shopping malls would fall in right where they were filled with shoppers. I also remember that one of the shopping malls in our area, the first building I'd ever been in where you could feel this vibration throughout the entire building when there were a lot of people in there. I remember wondering at that time whether this shopping mall was one of the buildings he was talking about. Talking to construction people and architects about it they would say, "Oh no, that's good when the building vibrates like that, that means it's flexible not rigid." Well, maybe so, we'll wait and see. Other areas there would be well maintained. Not every part of the city would be slums.

CRIME USED TO MANAGE SOCIETY

THERE would be the created slums and other areas well maintained. Those people able to leave the slums for better areas then would learn to better appreciate the importance of human accomplishment. This meant that if they left the jungle and came to civilisation, so to speak, they could be proud of their own accomplishments that they made it. There was no related sympathy for those who were left behind in the jungle of drugs and deteriorating neighbourhoods. Then a statement that was kind of surprising, "We think we can effectively limit crime to the slum areas, so it won't be spread heavily into better areas". I should maybe point out here that these are obviously not word for word quotations after 20 years, but where I say that I am quoting, I am giving the general drift of what was said close to word for word, perhaps not precisely so.

I remember wondering, how can he be so confident that the criminal element is going to stay where he wants it to stay? But he went on to say that increased security would be needed in the better areas. That would mean more police, better coordinated police efforts. He did not say so, but I wondered at that time about the moves that were afoot to consolidate all the police departments of suburbs around the major cities. I think the John Birch Society was one that was saying "Support your local police, don't let them be consolidated." I remember wondering if that was one of the things he had in mind about security. It was not explicitly stated. Anyhow he went on to say there would be a whole new

industry of residential security systems to develop with alarms and locks and alarms going into the police department so that people could protect their wealth and their wellbeing. Because some of the criminal activity would spill out of the slums into better, more affluent looking areas that looked like they would be worth burglarising. And again it was stated like it was a redeeming quality: See we're generating all this more crime but look how good we are – we're also generating the means for you to protect yourself against the crime. A sort of repeated thing throughout this presentation was the recognised evil and then the self-forgiveness thing, "See we've given you a way out."

Russia Records Largest (White) Birthrate For January 2013

Since the implementation of the demographic policy

IT is the highest monthly level of birth rate in January for all the time of implementation of the demographic program (as a rule, birth rate indicators in January – the lowest), the Ministry of Labour and Social Protection of the Russian Federation is told in the message on a site.


Growth of birth rate is noted in 78 regions. So, in 18 regions birth rate increased more than by 15%: these are the Novgorod, Kursk, Ulyanovsk, Kaliningrad, Vologda, Lipetsk, Ryazan, Astrakhan and Chelyabinsk areas, the Karachay-Cherkess Republic, the Republics Northern Ossetia-Alania, Adygea, Ingushetia, Tatarstan, Sakha-Yakutia, Stavropol Krai, Yamal-Nenets autonomous area, the Jewish autonomous region. In 23 subjects of the Russian Federation growth of number of births by 10–15% is registered. Among them Rostov, Kirov, Saratov, Oryol, Tyumen, Magadan areas, Krasnoyarsk and Seaside edges, St. Petersburg. Growth of number of births by 5–10% is noted in 27 regions of Russia.

In January, 2013 180,7 thousand people died that on 15,1 thousand people it is more (for 9,1%), than in January, 2012. In January, 2013 decrease in number of the dead is registered in 7 regions – the Sakhalin, Amur, Magadan areas, the Republics of Kalmykia, Ingushetia, Buryatia, Sakha (Yakutia).

Natural losses of the population made in January, 2013 21,8 thousand people, or practically as much, how many in January, 2012.

Also in the first month 2013 the natural increase of the population is registered in 21 regions and as a whole – on North Caucasian and Ural to federal districts.


