The Exclusive Covenants (Part 2)

Of Covenant Theology: Documenting the Bible's Commandment of Racial Segregation

The Racial Exclusivity of the Bible Documented: The Abrahamic Covenants

The reader is encouraged to go to all of the verses cited, to see the undeniably exclusive nature of the language.

THE BIBLE FAITHFULLY RECORDS THE GENEALOGIES OF TWO DISTINCT GROUPS: THE DESCENDANTS OF CAIN AND THE DESCENDANTS OF ADAM. Gen. 4:11-24 records the genealogy of the Kenites, the descendants of Cain. These Kenites are, very clearly, a non-Adamic people.

Gen. 4:25 – Gen. 5:25 records the genealogy of the Sethites, the descendants of Adam and Eve through Seth. The Bible is the historical record of the conflicts, wars and enmity between these two groups of people; but both Judaism and Judeo-Christianity have whitewashed and obfuscated this history.

The Bible is the story of the separate and distinct genealogies of these two seedlines and how the conflict of the ages, the racial war between the Adamites and the Kenites, will be resolved at the battle of Armageddon, when Jesus returns with His mighty angels to vanquish the Edomites, the people of God's curse. Throughout Scripture, Israel's most vicious enemies always derive from the seedline of Cain. This singular, indisputable fact is totally ignored by the Jewish perversion and the Judeo-Christian distortion of the Bible.

Gen. 6:1-4; 7-12. The Flood was NOT global. The Kenites most certainly survived the Flood. [Good web article debunking the [global flood myth](#):]

Gen. 9:8-11. The Noahic Covenant is established with Noah and his direct descendants, "with you and your seed," exclusively. The other

races of the world, which had already existed for thousands of years in their specific habitats, are not a party to this covenant. The idea that all species stem from the few that were on the Ark is pure mythology. The Bible says no such thing. It is an idea that is a holdover from the flat earth society that prevailed during the translation of the KJV.

The Rainbow Covenant of Verse 13 is the only one made with the entire earth. This is not an exclusive covenant. All of the other covenants are made exclusively to, for and with the specific posterity of Jesus Christ's genealogy. These people are today known as Caucasian Israel.

With regard to Yahweh's punishment of the Adamites in Noah's time, Michael A. Clark has this to say:

"Prior to the Great Deluge of the Patriarch Noah's day, the whole known world was in an uproar to the extent that the survival of the people that God had brought forth to serve Him in righteousness was being put in jeopardy. What was taking place was far more than a spiritual or religious threat to the cultural integrity of the People of God. It was a threat to disrupt the genetic destiny of their families for all time. Almighty God looked upon world society and saw that 'all flesh had been corrupted.'

*Miscegenation, or the interbreeding of racial types, was taking place on a scale and in a way that the Almighty had to intervene by a direct act of global judgment. In all this, it should be noted, Noah was 'perfect in his generations,' or in his family of marriage unions." –"Coming Events Cast Their Shadow," p. 268, **Crown and Commonwealth**, Winter 2006.*

Gen. 12:1-3 declares the exclusive Covenants made with Abraham and his direct descendants (posterity). **No other group, outside of this specific genealogy can be included in these covenants.** Note that Abraham was not a Jew, so these Covenants do not apply to the Jews. Since Ishmael was the father of the so-called

Arabs, these people are also descendants of the Abrahamic Shemites. Thus, the Arabs have just as much claim to Semitic heritage as the Jews do. In both cases, however, there is very little Adamic genetic material in the modern Arabs and Jews. Both Jews and Arabs are very miscegenated people.

Verse 3 specifically states that all nations, which are not a part of this specific posterity, will be blessed or cursed depending upon whether they bless or curse us, the true posterity of Abraham.

Note that the word ‘*Jew*’ is not used in this passage, nor does this passage apply to Jews, since they are the descendants of Cain and Esau, who are NOT of the posterity of Abraham, Isaac and Jacob. Despite Jewish claims to the identity of Israel, the covenants do not apply to them, because they are not Israelites, Hebrews, Shemites, or Judahites. Nor are they the TOLEDAW (descendants) of Adam. They have always belonged to the genealogy of Cain. (Matt. 23:33-36.)

Gen. 13:14-17: Abraham’s direct descendants will be an immense multitude. Caucasian Israel has fulfilled this promise. The Jews have not. The Jews have always been a minority on the world’s stage. This minority status is a fulfillment of a specific prophecy of Esau, whose numbers will be small. (Obadiah 2, 3.)

Gen. 15:18-21: declares how Abraham’s descendants will displace the sons of Cain, but only in the land of Canaan. Yahweh’s intention in the land of Canaan is very specific: to exterminate the hybridized offspring of the fallen angels, who cohabited with the daughters of Adamkind in Gen. 6. In the days of the Israelites, these giants and other forbidden hybrid creatures were still walking the earth in the land of Canaan.

Gen. 16: There is a common misconception that, because Hagar was an Egyptian woman, that she was non-White. This is a false idea. Since Yahweh specified that only race-specific animals were allowed aboard the Ark, no hybrids were allowed. Noah’s three sons, Shem, Ham and Japheth were as white as Noah and his wife, Naamah.


Gen. 17:1-14: The Covenant is renewed between Abraham and his direct descendants,

exclusively (Verse 7) in their racial descent (*toledaw*), for an everlasting covenant. The many nations prophesied here are the White nations of Europe, America, South Africa, Canada, Australia, etc., which were founded by the direct descendants of Abraham, Caucasian Israel.

The word ‘*stranger*,’ in verse 12, is anyone not of **Abraham’s Direct Lineage**. Such people can be made slaves. Israelites cannot be made slaves, except for those who willingly sell themselves into indentured servitude in order to pay off their debts. But even these are to be set free every seventh year. In addition, all debts are to be cancelled and the property of the Israelites is to be returned to them every 49th year, the Year of Jubilee.


Although slavery will eventually be abolished (“Israel will set the slaves free.”), the time is not yet. Even though people of other nations can be the servants of True Israel, this does not give Israelites the right to mistreat them. The Covenant Nations of the Anglo-Saxons had to be established before any slaves could be set free. As per the promise of Gen. 12:3, the Anglo-Saxons have been a blessing to the world, providing agriculture, science, medicine, high art, music, hygiene, roads, railroads and all manner of spiritual and physical blessings to the world wherever we have gone. All of these blessings are the direct fulfilment of the blessings provided to Abraham’s direct posterity.

The Covenants Renewed and Continued with the Exclusive Descendants of Isaac.



Gen. 17:15-22: Verse 19 continues the Covenant with Isaac, who is the direct descendant of Abraham through Sarah, **but Ishmael is excluded from the Covenant**, because Ishmael’s mother is Hagar, not Sarah. Instead, Ishmael is given a blessing (Verse 20).

Gen. 18: 9-15: The circumstances of Sarah's conception by Abraham.



Gen. 21:1-14: Sarah demands that Hagar and her son, Ishmael, be cast out of her presence, so that Ishmael could not interfere with Isaac's inheritance. The Book of Jasher provides additional details about Sarah's displeasure with Ishmael.

Jash. XXI:14-15 tell us that Sarah witnessed Ishmael drawing his bow, with intent to kill Isaac. This made her fear for Isaac's life. She therefore demanded that Abraham send Ishmael and his mother away.

Gen. 21:12: *"In Isaac shall thy posterity be called."* The future Anglo-Saxon nation is here prophesied. Verse 13: Ishmael blessed, *"because he is thy seed,"* but not covenanted.

Gen. 22:1-19: Isaac is dedicated to Yahweh on the altar. All of Isaac's direct descendants are thus a party to Isaac's chosenness. Question for the universalists: If Ishmael is excluded from the Covenant by Yahweh Himself, why are you trying to bring them back in with your "spiritual Israel" doctrine? In arguing for the equality of all "in Christ Jesus," you are violating the terms of the Covenants. You have no right to do this!

Gen. 24:62-67: Abraham is very insistent that Isaac's wife-to-be must be of a particular race. She must be a Shemite of the house of Aram. Aram was the fifth and youngest son of Shem (Gen. 10:22). The Shemites are White, as even the universalists agree! This chapter is very racially exclusive. Verse 61: Yahweh chooses Rebecca (Rebekah), arguably the most racially exclusive woman in the Bible, to be Isaac's wife.

Moana Finch, commenting on Abraham's selection of a Pure White wife for Isaac, says, *"So the*

race would be kept pure and of the one type of blood, a wife was chosen for Isaac of the family of Nahor. It was to Rebekah, Isaac's wife, that the Gate of Israel's enemies was promised. Genesis 24:60. Strictly speaking, Isaac cannot be termed an Israelite, for they were a later generation. Isaac was the FIRST SAXON, and being a descendant of Abraham, a Hebrew. He can also be called a Semite or Shemite, as he was descended from Shem." – p. 22, **Thy Kingdom Come**, December 2002.

[Strictly speaking, Abraham was not a Jew, for the same reason. Nor was Isaac. Nor was Jacob. Even Judah was not a Jew. He was the first **Judahite. All of these men – and their wives - were of pure Adamic descent, without any admixture of non-Adamic blood.** The Jews, contrariwise, are the most miscegenated breed on the face of the earth.]

Gen. 25:1-6: Abraham marries Keturah after Sarah dies. She bears him six sons, but Isaac was the exclusive son of the Covenant (verse 5). He sends Keturah's sons away to the east, so that they cannot interfere with Isaac's inheritance (Verse 6). These sons of Keturah became known as the Indo-Aryans, as many of them travelled as far as India, setting up Brahmanic (Abrahamic) culture there.

The exclusivity of the Covenant is drastically illustrated by how frequently family members are **Excluded** from the inheritance. Yahweh is consciously excluding those He knows are not qualified – even those of the same race! - for the promises made to the specific seedline.

The Story of Esau and Jacob

Gen. 25:19: Isaac marries Rebecca. Rebecca conceives twins, but one of them will be a traitor to the genealogical seedline. *"Two nations are in thy womb."*

Gen. 25:33-34: Esau sells his birthright to Jacob. Esau despises his birthright. Thus, Jacob becomes the elder son.

Gen. 26:33-35: The Hittite (Canaanite) wives of Esau condemned.

Gen. 27:41: Esau hates Jacob because He blames Jacob for stealing his blessing. He intends to slay Jacob as well. Esau is a greedy,

nasty person. It is no wonder that Yahweh Himself hates Esau. *“Esau I have hated. Jacob I have loved.”*

Gen. 27:46-28:1: Isaac and Rebekah make Jacob swear not to marry outside of their race.

Gen. 28:13-15: The Covenant Seedline promised to Jacob.

Gen. 35:9-12: The Covenant promises repeated.

Gen. 36: The descendants of Esau/Edom. This is a completely separate genealogy from that of Jacob/Israel.

Gen. 49: The prophecies of the 12 sons. None of these prophecies have ever been fulfilled by the Edomite or Khazar Jews. All have been fulfilled exclusively by the Anglo-Saxon nations.

More Proof of Yahweh’s Laws Against Miscegenation

Gen. 38: Judah and Tamar. The story of Judah and Tamar proves that half-breeds cannot inherit the Kingdom of Israel. Even though Shelah was the older half-brother of Zarah and Pharez, Shelah never even gets consideration as the eldest son - for the same reason that Cain did not get eldest son consideration, because both Cain and Shelah were half-breeds. Only pure-blooded Israelites, descended from the father, get consideration for inheritance. This episode also proves that “adultery” has nothing to do with marriage. This is another modern interpolation of Scripture.

Even though Judah was married to the Canaanite woman (against Yahweh’s law), their surviving son was not even considered as a patriarch of Judah. Tamar’s eldest son, Pharez, was given this honor. Because both Pharez and Zarah were both pure-blooded Adamites (Tamar was a descendant of Shem), only they could get consideration as patriarchs of Israel. Even though Tamar “played the harlot” and never married Judah, only Pharez and Zarah could inherit the Adamic bloodline. This parable clearly tells us that Yahweh is more concerned about bloodlines than marital status.

Deut. 7: This entire chapter concerns the law that Israel must remain separate from all Canaanites. *“Thou shalt make no covenant with them*

nor show mercy to them. Neither shalt thou make marriages with them.” Any Israelite who marries a Jew (Canaanite, Edomite or Khazar) is violating Deut. 7.

Furthermore, if we Israelites remain separate from the Edomites and Canaanites, we will have his love, blessings, bounty, good health, good children. *“Thou shalt be blessed above all people.”* All we have to do is stay away from Jews. Whenever we allow Jews to flourish in our nations, we suffer the degradations of second-class citizens, as the Jews are masters of subversion and usurpation. No lamb can live among wolves.



Deut. 9: The wickedness of the Canaanites is stressed. They are so wicked that Yahweh wants them destroyed. But soft-hearted Israel fails to appreciate the threat of the offspring of the fallen angels. The Anakim (descendants of the Nephilim) are still in the land of Canaan, since the flood of Noah; and the rest of the evil Canaanites flourish there. Yahweh is using the Israelites to judge the Canaanites.

Exo. 23:31-33: The Philistines excluded from association with True Israel.

Deut 17. Evildoers are to be punished, not coddled. Those who are worthy of death must be executed. *“So shalt thou put the evil away from among you.”* Nowhere in Scripture does it say, *“Love the sinner, hate the sin.”* That’s Judeo-Christian hogwash. **Yahweh hates sinners. He does not even hear the prayer of a sinner.** (John 9:31.)

Verse 14 and 15 tell us how to choose a king from amongst ourselves. We are not to choose anyone who is not of our race!! *“One from among thy brethren shalt thou set king over thee: thou mayest not set a stranger over thee, which is not thy brother (kinsman).”* Can you imagine how upset Yahweh is with those silly Whites who voted for Obama?

Deut. 23:2-3. *A mongrel [Heb. ‘mamzer’] shall not enter into the congregation of Yahweh; even to his tenth generation shall he not enter into the congregation of Yahweh. An Ammonite or Moabite shall not enter into the congregation of Yahweh; even to their tenth generation shall they not enter into the congregation of Yahweh forever.*

Strong’s Concordance provides us with a very simple definition of *mamzer*: “mongrel.” This word has nothing to do with marriage. It is a prohibition against race-mixing. These passages are totally consistent with the story of Judah and Tamar. Even though Judah had a “legitimate” child **by marriage** with the Canaanite woman, Shelah was never considered to have the right of inheritance. Only Pharez and Zarah had that right, even though they were born out of wedlock, because they were pure-blooded Shemites.

What was the sin of Solomon, that caused Yahweh to condemn him in his old age? *“But King Solomon Loved Many Strange Women, together with the daughter of Pharaoh, women of the Moabites, Ammonites, Edomites, Zidonians, and Hittites: of the nations concerning which Yahweh said unto the children of Israel, Ye Shall Not Go into Them, Neither Shall They Come in Unto You.* – I Kings, 11:1-2.

Can it be any clearer what Solomon’s sin was?


Ezra 4: The Judahites, observing Yahweh’s laws of separation, reject the company of the Samaritans. Today, this is called “discrimination” or “racism.”

Ezra 9: Ezra is astounded at the loose morals of those Judahites who have taken foreign wives. The sin of race-mixing is thoroughly condemned.

Neh. 10:28; 13:23. Ditto.

Psalm 106:34-45. Because the Israelites did not destroy the Canaanite nations, Yahweh punished them by handing the Israelites over to the heathen for punishment. *“But they mingled with the nations, so...He gave them into the hand of the heathen.”* This happens whenever we Israelites mingle with non-Whites. **Yahweh uses those nations with whom we race-mix to punish us.** This clearly is happening to the White Race today. The only way to end this form of Divine Punishment is to eject these non-Whites from

our nations, as Abraham Lincoln and the Whigs were doing.

“Word for Word” Deuteronomy Part 19

Chapter 25

1. If there is a controversy 7379 between men, and they come to the place of judgement 4941, and are judged 8199; they shall justify 6663 the righteous 6662, and condemn 7561 the wicked 7563.

2. And it shall be, if the wicked is a son 1121 of smiting 5221, the judge shall cause him to fall down 5307, and to be smitten before him, sufficient 1767 for his fault 7564, by the number 4557 of blows.

3. Forty 705 smittings 5221, no more 3254, lest 6435 if more, and smite upon him many 7227 stripes 4347, then your kinsman might seem vile 7034 in your sight

4. You shall not muzzle 2629 the ox 7794 when it treads out 1758 grain.

5. If brothers live together, and one dies, and has no children, it shall not be that the wife of the dead shall go outside 2351 the family to a foreign 2114 man: the brother-in-law 2993 shall go in unto her, and take her as a wife, and perform the duty of a brother-in-law 2992 to her.

6. And it shall be, the firstborn that she bears shall be raised 6965 upon the name of the dead brother, that his name not be wiped out 4229 from Yis'rael.

7. If the man does not desire 2654 to take his brother's wife 2654, then let his brother's wife go up to the gate to the elders 2205, and say, "My brother-in-law refuses 3985 to raise up his brother's name in Yis'rael, he will not perform the duty of a brother-in-law. "

8. Then shall call him the elders of the city, and speak to him: and if he stands, and says, "I do not desire to take her; "

9. then shall approach 5066 him his sister-in-law 2994 in the sight of the elders, and draw off 2502 his shoe 5275 from upon his foot, and spit 3417 in his face, and shall answer and say, "So shall it be done to a man that will not build up 1129 his brother's house."

10. And his name shall be called in Yis'rael, "The house of the one of the drawn-off shoe."

11. When men struggle 5327 together one man with a kinsman, and the wife of the one draws near 7126 to rescue 5337 her husband from the hand of he that smites him, and she puts forth her hand and seizes 2388 him by the pudenda 4016:

12. then you shall cut off 7112 the palm of her hand 3709. Your eye shall not pity 2347.

13. There shall not be in your bag 3599 multiple stones 68/68, a great 1419 and a small 6996.

14. There shall not be in your house multiple ephas 374/374, a great and a small.

15. A stone perfect 8003 and just 6664 there shall be, an ephah perfect and just there shall be, so that long 748 shall be your days upon the land that Yahweh Eloheycha gives you.

16. For an abomination 8441 to Yahweh Eloheycha are all that do these things, all that do

unrighteously 5766.

17. Remember what did to you Amaleq 6002 on the way, when you came forth from Mits'rayim;

18. how they met you by the way, and attacked the rear 2179 of you, all that were feeble 2826 behind you, and you were faint 5889 and weary 3023; and they did not fear 3372 Elohiym.

19. It shall be, when gives you rest 5117 Yahweh Eloheycha from all your hated enemies around you, in the land that Yahweh Eloheycha gives you as an inheritance of possession, you shall wipe out 4229 the remembrance 2143 of Amaleq from under the sky. Do not forget 7911!

5. And you shall speak and say before Yahweh Eloheycha, "An Arammiy 761 ready to perish 6 was my forefather. He went down to Mits'rayim, and sojourned 1481 there with a few 4962/4592, and became there a nation 1471, great, mighty, and populous 7227:

6. and did evil to 7489 us the Mits'riym 4713, and afflicted 6031 us, and put 5414 upon us harsh 7186 bondage 5656.

7. We cried 6817 to Yahweh Elohey of our forefathers, heard Yahweh our voice, and saw our affliction 6040, our misery 5999, and oppression 3906:

8. and brought us forth Yahweh from Mits'rayim with a mighty hand, and with an outstretched arm, and with great terrors 4172, and with signs, and with wonders:

9. and He has brought us to this place, and given us this land, a land that flows with milk and honey.

10. And now, behold, I have brought the firstfruits of the ground 127, which You have given me Yahweh. And you shall set it before Yahweh Eloheycha, and prostrate 7812 yourself before Yahweh Eloheycha.



Chapter 3 The Fall of Celtic India

BACTRIA WAS THEN A WHITE NATION. SO TOO WAS ITS WESTERN NEIGHBOR PARTHIA (NORTHERN IRAN AND TURKMENISTAN TODAY) and its southern neighbor Gedrosia (Pakistan today). East of Gedrosia was Aryan (or white) controlled India. In India, by 1000 BC intermarriage between white Aryans and black Dravidians was wide spread. This multicultural zeal was beginning to ethnically cleanse the whites from India through rampant hybridization. To stem the ethnic doom, the Aryan system of a divided society (in order of highest rank: priest, master of ceremonies, warrior- hunters, farmer, slave artisan) was trans-

ferred to include degrees of ethnic purity or degrees of admixture. This became known as the Caste system.



The Caste system mirrored the Aryan system: Brahmins (priesthood), Kshatriyas (Soldiers), Vaishyas (farmers and traders), Shudras (Serfs) and lastly the Unclean or Untouchables (the darkest of human types). Thus whites were able to stave off the inevitable for a while by way of 'tiered-apartheid'. God's Word however demands the removal of the heathen - the removal did not happen. The Caste system was a compromise, the white man always favoring cheap labor.

During this time around 450 BC, Hadassah or Esther lived in the land of exile (Esther means star; E-star). Most Bibles call these Israelites, Jews by way of poor translating. To overcome confusion the word 'Jew' should have been rendered as Judean, i.e.. Israelites from the kingdom of Judea.

The empire in which Esther and her captive Israelites lived was white. It stretched from Africa to India (Esther 1:1). The Persian king was also white and the virgins he gathered into his palace are outlined as 'fair'. The Hebrew word used here means 'fair'. Fair is from the French tongue, it means 'blond'.

The verse for fear of the Jews they became Jews' is sadly taken out of context by most Identity preachers. It simply means that for fear of the Judean-Israelites those in this empire converted to Israelite Law.

For further study I urge you to get his book "*The Beginning*". Asoka was a convert to Buddhism. Buddhism was soaked up into Hinduism. Buddhism was against the caste system. Asoka was a multicultural supremacist, a sort of free-mason of his day. The nation being multiracial therefore being multicultural was divided against itself. It is hard to work out if Asoka was an Aryan or a Mamzer (Mixed Blood), but he showed all the shrewdness of a wolf. He only became a pacifist after he had overrun all of India.

Then he set about promoting the 'soft' genocide of all whites by way of international multiculturalist (or international socialism of the day). He sent 'missionaries' of this faith of "Universal Reconciliation" to Kashmir, Ceylon, Burma, Egypt and Greece.

Those whites who carried on living in India gave their creative skills to the nation, being the thrust behind its great architectural monuments. But their numbers were dwindling under the weight of multiracial, universal reconciliation. Race mixing had taken its toll. Greatly weakened, in time, they no longer were able to yield their strength to India. The land became weaker by its melting pot decadence.



Muslim armies were on the move over-running one white land in Asia after another. By the 8th year hundred, India's melting pot could not withstand the tide. In 1526 the very Asians that drove out the Tokharians were now able, under their leader Babar, to take India thereby founding

the Mongol Empire. White India became a memory. Asoka's melting pot ideal reduced this greatest white power house to become what today would be called a 3rd world nation.

The Greeks and The Hebrews

archaeological and linguistic: in the past few years it has become increasingly apparent that the oldest inscriptions found on the island of Crete are written in a Semitic tongue. My own familiarity with both kinds of evidence arises from the study of the ancient texts, monuments and history of the Mediterranean; it is coincidence rather than intention that has brought me to this dual examination.

THE RELATION BETWEEN THESE TWO PEOPLES (Greeks and Hebrews) of the ancient Mediterranean is seldom mentioned. Evidence that the oldest language of Crete is Semitic, however, suggests that the two cultures have common roots.

One profound but not always recognized result of the overthrow of the medieval age of faith by the modern age of skepticism was a suspension of belief in the historical validity of both Holy Scripture and pagan legend. On the one hand, the narratives of the Old Testament were often viewed exclusively as sacred writings with no relation to reality; on the other, the Creek legends that reflect the history of another area of the eastern Mediterranean in a period roughly contemporaneous with the Old Testament were often downgraded to a status only a little superior to nursery tales.

The classical civilizations of Greece and Judea have traditionally been regarded as entirely distinct cultures, yet today two lines of evidence are combining to support the hypothesis that they have a common background. One line of evidence falls within the realm of historical and literary scholarship; the strength of its case lies in vivid parallels between early Greek and early Hebrew literature. The other is essentially


Greek thought and Hebrew religion, however, continued to command general respect. One consequence of this view is that "rational" Greece and "spiritual" Israel have been kept

poles apart in Western thought, as though the ancient Greeks had never known religious inspiration and their Semitic neighbours had been devoid of reason.

The rise of skepticism undoubtedly played an invaluable role in freeing men's minds from the fetters of superstition. It is significant, however, that it required an almost childlike faith in the validity of ancient literature to open the modern era of archaeological discovery. The great 19th-century archaeologist Heinrich Schliemann loved and believed in Homer.

If Schliemann had not trusted the Iliad, he would never have sought, let alone uncovered, Troy and Mycenae (after which the earliest Greek civilization is named). Arthur Evans, who believed in the historical reality of the legendary King Minos, dug at Knossos on Crete and revealed Minoan civilization. Scholars who believed in the historical veracity of Scripture similarly uncovered the buried cities not only of the Holy Land but also of the entire Old Testament world from Iran to Egypt.

Until quite recently biblical archaeologists have had an advantage over their colleagues who study ancient Europe. Before the 19th century there were no intelligible texts older than Homer and the Bible; everything earlier was therefore "prehistoric." Old Testament studies were radically changed by the decipherment in the 19th century of Egyptian hieroglyphics and Babylonian cuneiform.



The parallel Greek and Egyptian inscriptions on the Rosetta stone (above) and Darius' trilingual cuneiform texts at Behistun in Iran were keys

that eventually helped the decipherers to extend the span of recorded history back to about 3000 B.C. At the turn of the century Evans found a number of Cretan gem stones and other objects engraved with either realistic or stylized pictographs. He also found many clay tablets inscribed in the related Cretan scripts called Linear A and Linear B, but since no one could decipher them classical archaeologists continued to call Minoan and Mycenaean civilization "prehistoric."

In 1928 a Mycenaean tomb was uncovered by a ploughman at the ancient site of Ras Shamra in Syria. Archaeologists were quick to react to this evidence of Greek connections with an ancient Semitic region.

Beginning in 1929, French expeditions under Claude F. A. Schaeffer have worked steadily at Ras Shamra. Among the many treasures that have been uncovered are inscribed tablets, dating from the early 14th century B.C. to the early 12th century, that record a rich, epic literature in a northwest Semitic dialect akin to Phoenician and biblical Hebrew.

The city at Ras Shamra was soon identified as ancient Ugarit. Its narratives not only acknowledge a debt to Minoan Crete but also contain many parallels bridging the gap between Homer and the Bible. Ugarit's god of arts and crafts is described in the texts as having his workshop on Crete and as having come originally from Egypt. The hero of one major epic poem, King Kret (whose name is reminiscent of Crete), is involved in the loss and recovery of a destined bride paralleling King Menelaus' classic difficulties over Helen in the Iliad.

In reading Homer most of us are inclined, consciously or unconsciously, to impose the cool virtues of Western medieval chivalry on the actions of the Greek heroes; King Kret, in contrast, is unabashedly Oriental. Deprived of his betrothed, his first action is to summon up El, the head of the Ugaritic pantheon, in hysterical fashion:

*He enters his chamber and cries
While repeating words he weeps
His tears are shed like shekels earthward
Like fifth-shekels on the bed.
As he cries he falls asleep*

*As he weeps deep sleep overcomes hint
Yea he lies down in deep sleep.
Then he is startled!
For in his dream El descends
In his vision the Father of Man.
He draws near, asking Kret:
"Who is Kret that he should cry?
E'en the Good One, Lad of El, that
he should weep?"*

The friendly El lends a helping hand; he instructs Kret in the ritual necessary to win the aid of the redoubtable deity Baal and advises him to march with an army to the city of Udum, whose king, Pebel, is holding Kret's destined bride. Kret is warned that Pebel will try to buy him off with rich gifts; he is to reject the bribe and to demand the maiden as follows:

*"What need have I of silver and yellow gold
A share of her estate
And eternal slaves
Three horses and a chariot
From the yard of a handmaid's son?
Nay, what is not in my house you shall give.
Give me the Lady Hurrai
The well-bred Your firstborn
Whose charm is like Anath's charm
Whose beauty is like Astarte's beauty."*

In considerably less time than it took the Greek armies to capture Troy, Kret gets the girl; later El blesses the marriage:

*El takes a cup in the hand
A goblet in the right hand .
"The wife that you take, O Kret,
The wife you take to your house
The girl you bring into your court
Shall bear you seven sons
And an eighth (a daughter), Octavia."*

At this time in the eastern Mediterranean, on the eve of the emergence of the Greeks and the Hebrews as historical peoples conquering their own "promised lands," it is not surprising that epic literature should concern itself with the heroic adventures of royalty. In both Ugaritic and Homeric literature the aristocrats alone are worthy of attention.

Nonetheless, when one finds such a basic theme of the Iliad—a royal quarrel over an abducted woman, conducted with the assistance of the gods—foreshadowed in the literature of a

Semitic city in the 14th century B.C., familiar literary material appears in a fresh light and old faces take on a new cast. The narrative of Abraham in Genesis, for example, shows a similar colouring of royal epic.

Of Abraham and Sarah it is said respectively, "Kings shall stem from you" and "Kings of peoples shall issue from her" (Genesis 17). Abraham commands his own troops; he heads a coalition with three other chieftains to vanquish a coalition of invading kings (Genesis 14). Twice Sarah is taken away from him— into the harem of Pharaoh and later into the harem of the Philistine king Abimelech. Both times Abraham recovers her unsullied (as Achilles did Briseis, although Menelaus was less fortunate in the case of Helen). Thanks to the bridge provided by the Ugaritic epic, the sense of these familiar biblical texts is enriched.

The reader may well ask why the discovery of a Ugaritic epic was required in order to evoke the hypothesis that both the Semitic and the Greek classics have a common eastern Mediterranean background. The answer lies not in any lack of ancient parallels but rather in the artificial boundary between the two cultures that is built into our education. Both ancient Greece and ancient Israel recognized the strong bonds that had united them from remote times. The Hebrews included the Ionian Greeks in the Table

of Nations; Noah's son Japheth (whose name is equated with Iapetos, one of the Titans of Greek myth) numbered Javan (Yawan, the ancestor of the Ionians) among his sons (Genesis 10). If it is assumed that the Japheth of the Table of Nations is the same as the Japheth of Noah's blessing (Genesis 9:27), a particularly close relation between the ancestors of the Greeks and the Hebrews can be inferred from the text: "May God make room for Japheth, that he dwell

among the tents of Shem." Nor is tented pastoralism the sole Semitic way of life recorded in the Old Testament. The Israelite tribes of Zebulun, Dan and Asher are described as seafaring peoples: "Zebulun shall dwell by the sea coast, yea he is by the coast of ships with his flank by Sidon."

communist murderer of millions of Europeans. Boris Johnson is a Zionist, descended from Turkish/Lithuanian Jews, including a Rabbi.



The Political Influence of the British-Israel Movement in the Nineteenth Century (Part 4)

PALESTINIAN JEWISH FEELING, towards Britain was again reflected in a prayer drawn up by leading Jewish Rabbis in Jerusalem at the Synagogue of Beth Jacob, in that 'the English nation who protect and shield thy people Israel from oppression - O Lord, this great people have sent their chosen mighty men to fight a just war and to promote equality and equity to all her people alike.'

Some British-Israel, such as Rev. Thomas Howlett, were against the Palestine answer maintaining that the Scriptures were against both colonisation and assimilation. In his view,

the Jews and Anglo-Saxons had a racial affinity, whilst most nations regarded them as aliens.

His objections to re-settlement in Palestine as a nation were that Palestine was part of Turkey and coveted by Russia; both of which were anti-Jewish, and the days of the small independent nation were over.

He maintained that intelligent, wealthy and influential Jews were opposed to colonisation schemes as they preferred existing world business centres hence the British Empire and the USA were the Promised Land. Assimilation was unworkable as separation was the speciality of the Jew[93] Citizenship with the Anglo-Saxon was the destiny of the Jew and this would be accomplished by the restoration of the Israelitish nation[94].

British-Israel brought attention to the poor treatment of Jews outside Britain, especially Russia, reasoning that those outside Britain did not identify with the house of Israel[95]. An anti-Semitic petition was circulated in Germany, in 1880, claiming 'the fruits of Christian labour are harvested by the Jews.' It was claimed in the Romanian Parliament 'that the true difficulty in the way of allowing the Jews the equal rights, which were stipulated in the treaty of Berlin, was the certainty entertained by the Romanians and Serbians that if the Jews were thus given an equal chance they would gradually oust the peasantry till they possessed the whole land[96].

The Examiner, on 4th June 1891, declared of the Russian pogroms 'This persecution is known to spring from a purely commercial source - from the jealousy with which the native Russians have seen the many interests of the Empire slowly centring themselves about the banking houses of certain wealthy and industrious Jews[97].'

James Blaine, Secretary of State of the United States echoed this opinion in a state paper to the Court of St James 'No student of history

need be reminded of the lesson taught by the persecution of the Jews in Central Europe and in the Spanish peninsula. There, as in Russia to-day, the Hebrew fared better in business than his neighbour; then as now, his economy and patient industry bred capital, bred envy, and envy persecution, and persecution disaffection and social separation[98].

Bishop Titcomb (centre page) had no trouble in applying British-Israel to this situation remarking on the influx of Jews from Germany, Romania and Russia '*Is not Great Britain marked out among the nations as the most interested in promoting the temporal and spiritual welfare of the Jews*[99]. Further noting that a British Church occupied Mount Zion, the Palestine Exploration Society had mapped out the Holy Land and Britain was the only country taking an active interest in a Jewish homeland. According to Titcomb Britain was the only country in Christendom with missions for the conversion of the Jews[100].



This sympathy with the troubles of the Jews was, however, at odds with the British-Israel stance on Jewish Disability. John Wilson, surprisingly, objected to the removal of Jewish disabilities maintaining that foreign unbelieving pauper Jews, who were migratory by nature, would be encouraged to come to England[101].

Let us use all kind and honest hospitality to the homeless wanderer; but let us not without due consideration; throw into his hand the keys of the citadel[102].'

Wilson maintained that such was the history of the Jews that they could not be depended on to put the nation's interests before their own and although Britain had placed the worldwide Jewish race under it's protection, the country did not want to be responsible for the mischief Jews occasioned when they achieved political power.

Wilson stated 'It would be quite unfair on the Jew to expect to be treated with the same confidence and esteem as the Christian[103]' and consequently there were no good grounds to suggest they were fit to legislate for the most

important empire on the earth. Credit was given for producing and transmitting the Scriptures in the past, but currently Jews did neither hence 'we are willing to do what we can for the true good of the Jew, but we earnestly deprecate the sacrificing, for even his sake, the honour and welfare of the State, the interests of the whole human race[104].'

Wilson even went as far as putting them in the same class as Catholics insisting that 'the Jewish Rabbi and the Romish Priest virtually conspire to crush the Evangelical Christian[105].' noting that the two races who put Jesus to death were the Jews and Romans.



The British-Israel position on Jewish Disability mirrored the reaction of the Protestant community in general. Sir Robert Inglis (left), an influential figure in the Anglican Church, opposed the admission of Jews to Parliament as he had earlier with Roman

Catholics and Non-Conformists and was supported by Shaftesbury who whilst supporting Jewish emigration to Palestine to fuel his Evangelical ambitions did not champion their political rights.

It is ironic that in 1902, British-Israel claimed of the Queen 'Under her the Jews have emerged from obscurity and repression into the full enjoyment of all the rights and privileges of British citizenship.' It was Disraeli, icon of British-Israel who was the most prominent political figure in the fight for Jewish equality and despite the the Jewish Disabilities Bill being passed in 1847, it was consistently thrown out until 1858, when he saw his friend Lionel de Rothschild take his seat[106].

Domestic Politics

British-Israel was not ostensibly a political movement but it was inevitable that any association that interpreted Biblical prophecy against the background of actual historic, real-time and future events would attempt to influence, take credit or comment on the relevance of those events.

Primarily an Anglican organisation, it was inevitable that British-Israel would contribute to political issues concerning the Jews, Catholics and Palestine. In essence, the character of movement was pro-Conservative, Imperialist and anti-Home Rule divided only by the Teutonic theory[107]. British-Israel did have followers in both legislative houses, however, limited by significant elected representation it promoted, through various publications, those influential public figures who blindly reflected it's own theologically driven policies and prophecies. It is only in from the 1870's that the British-Israel press really started to roll enabling commentary on their domestic political stance.

Prior to the 1874 General Election, Edward Hine asserted, that the British-Israel movement had 'no motive to endeavour to operate any influence, in a political sense', however, in the same year, Hine appealed for representatives in Parliament and stressed the importance of selecting MPs indoctrinated by British-Israel philosophy[108].

There was is no record of how successful his campaign was but in the event the Conservatives, under Disraeli, won with a majority of 52 seats which pleased the British-Israel pundits.



Hine was not alone and **Viscount Folkestone (left)**, president of the Metropolitan Anglo-Israel Association and MP, asserted, in 1880, 'I am sure that this association, in the course of time—will assume a very prominent position in the history of the nation. I have no doubt but that it will exercise a great influence on the policy, both home and foreign of our future governments[109].'

This 1880 election did, however, indicate the low influence of British-Israel in the hustings. Despite pleading it's non-political stance, British-Israel backed Disraeli British-Israel encouraged the nation (Israel) to support the party that would achieve God's destiny for the nation asking if Britain wanted to see the achievements of Disraeli - the Eastern question, Berlin Treaty - and the proposed protectorate of Asiatic Turkey, acquisition of Cyprus and the Holy Land reversed[110]?

The Liberals, under Gladstone, won by a majority of 176 seats but true to form they found biblical prophecy to cover the non-Imperial policies of

Gladstone ‘Come, My people, enter those into thy chambers, and shut thy doors about thee; hide thyself as it were for a little moment, until the indignation be over past.’ (Isa. 16:20) to mark

Britain’s withdrawal from expansion. It followed that British-Israel did not expect Liberals to have long enough in power to affect foreign policies.

Post 1880 election, British-Israel were gladdened to hear the Liberals intended maintaining the empire but deplored its repudiation of further colonial annexations therefore not fulfilling Britain’s destiny to rule the world[111]. Sure enough the appropriate biblical prophecy was found ‘And the kingdom and dominion, and the greatness of the kingdom under the whole heaven, shall be given to the people of the saints of the most High, whose kingdom is an everlasting kingdom, and all dominions shall serve and obey him’ (Daniel 7:27).

The subject of the federation of the empire was becoming increasingly the subject of national concern and British-Israel believed this was the aim of Disraeli’s future policy gleefully quoting on the subject from arch-enemy the ultra-radical quarterly *The Westminster Review* ‘the organ of Bentham, of Charles Buller and of John Stuart Mill; the organ pre-eminently of pure philosophic Radicalism’ article *Imperium et Libertus* opposing Gladstone[112].

However, again British-Israel were at pains to point out that their politics were not party politics but Israelite and Bible politics seeking

enlargement of the Empire with England at the centre intimating cheekily *The Westminster Review* had copied British-Israel articles[113].

Unfortunately, Gladstone was of the opinion that Saville (editor of *The Banner of Israel*) was labouring under ‘almost a delusion’[114].

The judgement of the national mood appeared to be correct and pre-General Election, in 1885, British-Israel was worried that Gladstone had been going ‘to scuttle out’ of Egypt and yield to French pressure ‘We hardly imagine the people of this country will give up and allow all their interests to be bartered away and ruined because Mr Gladstone is the Prime Minister of their choice; for being without policy, that statesman seems content to let Israel’s blood flow in torrents[115].’

Sarcastically, they referred to Gladstone’s plan to as an attempt to restore Britain, in Europe, to ‘perfect independence’ classing it as a contest between ‘the iron will of the Liberal leader and that of the God of Israel’ and asked for the electorate to vote for God fearing men[116].

In fact the French had expected the British monarchy to collapse with the Sudan fiasco and threatened invasion of India by Russia but a comment in *Revue Politique et Litteraire* credited the British Empire as being more solid than was generally suppose a point taken up by British-Israel as proof of God’s guarantee[117].

a land grabber. AND no Crimea voted almost 100% to leave and REJOIN their native people of Russia. Even alt media, doesn't seem to get this straight.



Chronic Electrical Illness (Part 3)

THE DETAILS, WRITTEN DOWN OVER TIME in her Autobiography of a Neurasthene, describe the classic syndrome presented nearly half a century earlier by Beard. "I knew neither peace nor comfort night

nor day," she wrote. "There remained all the usual pain of nerve trunks or peripheral nerve endings, the exquisite sensitiveness of the body, the inability to bear a touch heavier than the brush of a butterfly's wing, the insomnia, lack of strength, the recurrence of depression of spirits, the inability to use my brain at my study and writing as I wished."

"It was with the greatest difficulty," she wrote on another occasion, "to even use knife and fork at the table, while the routine carving was an impossibility."

Cleaves had chronic fatigue, poor digestion, headaches, heart palpitations and tinnitus. She found the sounds of the city unbearable. She smelled and tasted "phosphorus." She became so sensitive to the sun that she lived in darkened rooms, able to go outdoors only at night. She gradually lost her hearing in one ear. She became so affected by atmospheric electricity that, by her sciatica, her facial pain, her intense restlessness, her feeling of dread, and her sensation "of a crushing weight bowing me to the earth," she could predict with certainty 24 to 72 hours in advance that the weather was going to change. "Under the influence of oncoming electrical

storms,” she wrote, “my brain does not function.”¹¹

And yet through it all, suffering until the end of her life, she was dedicated to her profession, exposing herself day in and day out to electricity and radiation in their various forms. She was a founding and very active officer of the American Electro-Therapeutic Association. Her textbook on Light Energy taught the therapeutic uses of sunlight, arc light, incandescent light, fluorescent light, X-rays, and radioactive elements. She was the first physician to use radium to treat cancer. How could she not have known?

And yet it was easy. In her day as in ours, electricity did not cause disease, and neurasthenia—it had finally been decided—resided in the mind and emotions.

Other related illnesses were described in the late nineteenth and early twentieth centuries, occupational diseases suffered by those who worked in proximity to electricity. “Telegrapher’s cramp,” for example, called by the French, more accurately, “mal télégraphique” (“telegraphic sickness”) because its effects were not confined to the muscles of the operator’s hand. Ernest Onimus described the affliction in Paris in the 1870’s. These patients suffered from heart palpitations, dizziness, insomnia, weakened eyesight, and a feeling “as though a vice were gripping the back of their head.”

They suffered from exhaustion, depression, and memory loss, and after some years of work a few descended into insanity. In 1903, Dr. E. Cronbach in Berlin gave case histories for seventeen of his telegraphist patients. Six had either excessive perspiration or extreme dryness of hands, feet, or body. Five had insomnia. Five had

deteriorating eyesight. Five had tremors of the tongue. Four had lost a degree of their hearing. Three had irregular heartbeats.

Ten were nervous and irritable both at work and at home. “Our nerves are shattered,” wrote an anonymous telegraph worker in 1905, “and the feeling of vigorous health has given way to a morbid weakness, a mental depression, a leaden exhaustion... Hanging always between sickness and health, we are no longer whole, but only half men; as youths we are already worn out old men, for whom life has become a burden... our strength prematurely sapped, our senses, our memory dulled, our impressionability curtailed.” These people knew the cause of their illness. “Has the release of electrical power from its slumber,” asked the anonymous worker, “created a danger for the health of the human race?”¹²

In 1882, Edmund Robinson encountered similar awareness among his telegraphist patients from the General Post Office at Leeds. For when he suggested treating them with electricity, they “declined trying anything of the kind.”

Long before that, an anecdote from Dickens could have served as a warning. He had toured St. Luke’s Hospital for Lunatics. “We passed a deaf and dumb man,” he wrote, “now afflicted with incurable madness.” Dickens asked what employment the man had been in. “‘Aye,’ says Dr. Sutherland, ‘that is the most remarkable thing of all, Mr. Dickens. He was employed in the transmission of electric-telegraph messages.’” The date was January 15, 1858.¹³


Telephone operators, too, often suffered permanent injury to their health. Ernst Beyer wrote that out of 35 telephone operators that he had treated during a five-year period, not a single one had been able to return to work. Hermann Engel had 119 such patients. P. Bernhardt had over 200. German physicians routinely attributed this illness to electricity.

And after reviewing dozens of such publications, Karl Schilling, in 1915, published a clinical description of the diagnosis, prognosis, and treatment of illness caused by chronic exposure to electricity. These patients typically had headaches and dizziness, tinnitus and floaters in the eyes, racing pulse, pains in the region of the heart, and palpitations. They felt weak and exhausted and were unable to concentrate. They could not sleep.

They were depressed and had anxiety attacks. They had tremors. Their reflexes were elevated, and their senses were hyperacute. Sometimes their thyroid was hyperactive. Occasionally, after long illness, their heart was enlarged. Similar descriptions would come throughout the twentieth century from doctors in the Netherlands, Belgium, Denmark, Austria, Italy, Switzerland, the United States, and Canada.¹⁴ In 1956, Louis Le Guillant and his colleagues reported that in Paris “there is not a single telephone operator who doesn’t experience this nervous fatigue to one degree or another.”

They described patients with holes in their memory, who couldn’t carry on a conversation or read a book, who fought with their husbands for no reason and screamed at their children, who had abdominal pains, headaches, vertigo, pressure in their chest, ringing in their ears, visual disturbances, and weight loss. A third of their patients were depressed or suicidal, almost all had anxiety attacks, and over half had disturbed sleep.

As late as 1989, Annalee Yassi reported widespread “psychogenic illness” among telephone operators in Winnipeg, Manitoba and St. Catharines, Ontario, and in Montreal, Bell Canada reported that 47 percent of its operators complained of headaches, fatigue, and muscular aches related to their work.



Then there was “railway spine,” a misnamed illness that was investigated as early as 1862 by a commission appointed by the British medical journal Lancet. The commissioners blamed it on vibrations, noise, speed of travel, bad air, and

sheer anxiety. All those factors were present, and no doubt contributed their share. But there was also one more that they did not consider. Because by 1862, every rail line was sandwiched between one or more telegraph wires running overhead and the return currents from those lines coursing beneath, a portion of which flowed along the metal rails themselves, upon which the passenger cars rode.

Passengers and train personnel commonly suffered from the same complaints later reported by telegraph and telephone operators: fatigue, irritability, headaches, chronic dizziness and nausea, insomnia, tinnitus, weakness, and numbness.

They had rapid heart beat, bounding pulse, facial flushing, chest pains, depression, and sexual dysfunction. Some became grossly overweight. Some bled from the nose, or spat blood. Their eyes hurt, with a “dragging” sensation, as if they were being pulled into their sockets. Their vision and their hearing deteriorated, and a few became gradually paralysed. A decade later they would have been diagnosed with neurasthenia—as many railroad employees later were.

The most salient observations made by Beard and the late nineteenth century medical community about neurasthenia are these:

It spread along the routes of the railroads and telegraph lines.

It affected both men and women, rich and poor, intellectuals and farmers.

Its sufferers were often weather sensitive.

It sometimes resembled the common cold or influenza.


It ran in families.

It seized most commonly people in the prime of their life, ages 15 to 45 according to Beard, 15 to 50 according to Cleaves, 20 to 40 according to H. E. Desrosiers, 15 to 50 according to Charles Dana.

It lowered one’s tolerance for alcohol and drugs. It made people more prone to allergies and diabetes.

Neurasthenes tended to live longer than average.

And sometimes—a sign whose significance will be discussed in chapter 10—neurasthenes passed reddish or dark brown urine.



It was the German physician Rudolf Arndt who finally made the connection between neurasthenia and electricity. His patients who could not tolerate electricity intrigued him. “Even the weakest galvanic current,” he wrote, “so weak that it scarcely deflected the needle of a galvanometer, and was not perceived in the slightest by other people, bothered them in the extreme.” He proposed in 1885 that “electrosensitivity is characteristic of high-grade neurasthenia.” And he prophesied that electrosensitivity “may contribute not insubstantially to the elucidation of phenomena that now seem puzzling and inexplicable.”

He wrote this in the middle of an intense, unrelenting haste to wire the whole world, driven by an unquestioning embrace of electricity, even an adoration, and he wrote it as though he knew he was risking his reputation. A large obstacle to the proper study of neurasthenia, he suggested, was that people who were less sensitive to electricity did not take its effects at all seriously: instead, they placed them in the realm of superstition, “lumped together with clairvoyance, mind reading and mediumship.”¹⁶

That obstacle to progress confronts us still today.

The Renaming

In December 1894, an up-and-coming Viennese psychiatrist wrote a paper whose influence was enormous and whose consequences for those who came after have been profound and unfortunate. Because of him, neurasthenia, which is still the most common illness of our day, is accepted as a normal element of the human condition, for which no external cause need be sought. Because of him, environmental illness, that is, illness caused by a toxic environment, is widely thought not to exist, its symptoms auto-

matically blamed on disordered thoughts and out-of-control emotions.

Because of him, we are today putting millions of people on Xanax, Prozac, and Zoloft instead of cleaning up their environment. For over a century ago, at the dawn of an era that blessed the use of electricity full throttle not just for communication but for light, power, and traction, Sigmund Freud renamed neurasthenia “anxiety neurosis” and its crises “anxiety attacks.” Today we call them also “panic attacks.”

The symptoms listed by Freud, in addition to anxiety, will be familiar to every doctor, every “anxiety” patient, and every person with electrical sensitivity:

Irritability

Heart palpitations, arrhythmias, and chest pain
Shortness of breath and asthma attacks.

Perspiration

Tremor and shivering

Ravenous hunger
Diarrhea

Vertigo

Vasomotor disturbances (flushing, cold extremities, etc.)

Numbness and tingling Insomnia

Nausea and vomiting Frequent urination Rheumatic pains
Weakness Exhaustion


Freud ended the search for a physical cause of neurasthenia by reclassifying it as a mental disease. And then, by designating almost all cases of it as “anxiety neurosis,” he signed its death warrant. Although he pretended to leave neurasthenia as a separate neurosis, he didn’t leave it many symptoms, and in Western countries it has been all but forgotten. In some circles it persists as “chronic fatigue syndrome,” a disease without a cause that many doctors believe is also psychological and that most don’t take seriously. Neurasthenia survives in the United States only in the common expression, “nervous breakdown,” whose origin few people remember.

In the International Classification of Diseases (ICD-10), there is a unique code for neurasthenia, F48.0, but in the version used in the United States (ICD- 10-CM), F48.0 has been removed. In the American version, neurasthenia is only one among a list of “other nonpsychotic mental disorders” and is almost never diagnosed. Even in the Diagnostic and Statistical Manual (DSM-V), the official system for assigning codes to mental diseases in American hospitals, there is no code for neurasthenia.

It was a death warrant only in North America and Western Europe, however. Half the world still uses neurasthenia as a diagnosis in the sense intended by Beard. In all of Asia, Eastern Europe, Russia and the former Soviet Republics, neurasthenia is today the most common of all psychiatric diagnoses as well as one of the most frequently diagnosed diseases in general medical practice.¹⁷ It is often considered a sign of chronic toxicity.¹⁸

In the 1920’s, just as the term was being abandoned in the West, it was first coming into use in China.¹⁹ The reason: China was just beginning to industrialize. The epidemic that had begun in Europe and America in the late nineteenth century had not yet reached China at that time.

In Russia, which began to industrialize along with the rest of Europe, neurasthenia became epidemic in the 1880s.²⁰ But nineteenth century Russian medicine and psychology were heavily influenced by neurophysiologist Ivan Sechenov, who emphasized external stimuli and environmental factors in the workings of the mind and body.



Because of Sechenov’s influence, and that of his pupil Ivan Pavlov after him, the Russians rejected Freud’s (left) re- definition of neurasthenia as anxiety neurosis, and in the twentieth century Russian doctors found a number of environmental

causes for neurasthenia, prominent among which are electricity and electromagnetic radiation in their various forms. And as early as the 1930’s, because they were looking for it and we weren’t, a new clinical entity was discovered in Russia called “radio wave sickness,” which is included today, in updated terms, in medical textbooks throughout the former Soviet Union and ignored to this day in Western countries, and to which I will return in later chapters. In its early stages the symptoms of radio wave sickness are those of neurasthenia.

As living beings, not only do we possess a mind and a body, but we also have nerves that join the two. Our nerves are not just conduits for the ebb and flow of electric fluid from the universe, as was once believed, nor are they just an elaborate messenger service to deliver chemicals to muscles, as is currently thought. Rather, as we will see, they are both.

As a messenger service, the nervous system can be poisoned by toxic chemicals. As a network of fine transmission wires, it can easily be damaged or unbalanced by a great or unfamiliar electric load. This has effects on both mind and body that we know today as anxiety disorder.

The Banker, The Model and The Jewish Spy Role Model on Trial (Part 3) From Our Hastings Correspondent



**Robi Mendelssohn
– Jewish banker
and British spy at

WE CAN NOW REVEAL – and would have revealed in court – that the key promoter of Hermann Abs in 1946 was not some undercover SS man straight out of Frederick

Forsyth’s *The Odessa File*, nor some reactionary British aristocrat. In fact the British occupation authorities were lobbied to press ahead with Abs’s rehabilitation by Robi Mendelssohn, a partner in the long-established Jewish banking firm Mendelssohn & Co. Reading the accounts by Tom Bower, Adam LeBor, and Michael Pinto-Duschinsky, one would assume that the Mendelssohn family were victims of brutal Nazi rapacity, facilitated by Abs, and that Robi Mendelssohn should have been first in the queue to demand Abs’s prosecution as a ‘war criminal’.

Yet in fact Mendelssohn was the prime mover insisting that Abs was the man the British should immediately get onside in a key role to rebuild postwar Germany.



Who was Robi Mendelssohn (Above)? Why was he in a position to give high-level advice to the postwar British authorities? And why has his role

remained secret until now, more than 75 years after the war?

Robert von Mendelssohn (known to friends, family and MI6/MI5 officers as Robi) was born in 1902 at a palatial residence in the Grunewald district of western Berlin, built for his father Franz, head of the family bank Mendelssohn & Co. The German Kaiser Wilhelm II had fourteen years earlier granted the family the noble prefix ‘von’ in recognition of their importance to the Reich’s economy.

The Mendelssohn bank was founded in 1795 by Joseph Mendelssohn, eldest son of the philosopher Moses Mendelssohn, and until the 1920’s all of its partners (including the composer’s father Abraham) were family members. The firm came to specialise in government debt and overseas trade.

Franz von Mendelssohn died in June 1935 aged 69. As his *Financial Times* obituary emphasised, he remained senior partner of the bank and died at his home:

“Rumours that he was interned in a concentration camp are entirely erroneous, neither he nor any member of his family ever having been in such a camp.”

His 34-year-old son Robi was now in principle head of the family and already a partner in the bank, but was regarded as more of a playboy entertainer: his role was to amuse visiting VIPs in Berlin theatres and nightclubs. Adolf Hitler had by this time been Chancellor of Germany

for two and a half years, but it was three years after Franz's death that moves were made to "Aryanise" the bank. The initial problem in 1935 came not from the National Socialist government but within the family. Both Franz and his cousin Paul von Mendelssohn-Bartholdy, a fellow partner in the bank, died during 1935. In the ensuing family reshuffle Franz's widow Marie was registered as a 'managing partner' but Paul's widow Elsa was not.

In the meantime Robi cemented his credentials with the government by volunteering in 1936 for four months basic training in the German Army, and in 1938 he married the architect Liselotte von Bonin. It was during that summer – five years into National Socialism – that Mendelssohn's bank began to reach the end of its almost 150-year history. Even then, records show that the government's preferred solution was to transfer Jewish-owned shares to Robi, who classed as a *mischling*, or half-Jew.

A major issue here was that the bank held about 27 million Reichsmarks in "lines of credit" for overseas trade. During the financial crisis of 1931 these lines of credit had been frozen and were subject to renegotiation every year under the terms of the 'Standstill Agreement'. Hermann Abs was one of the main German negotiators. In principle the bank's proprietors were responsible and were any of the proprietors to withdraw, foreign creditors could demand immediate payment in foreign currency, which would mean seizure of assets.

By taking over Mendelssohn's, any German bank would be doing the Jewish partners a favour not robbing them, as these Jewish

partners would then be freed from the threat of having their foreign assets seized. A further issue during the takeover was that non-Jewish employees of the bank were concerned that the partners were getting a good deal while leaving the employees vulnerable to pay cuts, redundancy or threats to their pensions (a situation familiar to every reader whose employers have been taken over). Jewish employees as opposed to the partners and owners were of course in a much worse position: they were dismissed at the end of 1938 when the bank went into liquidation. It became clear during 1938 that the preferred solution was for Deutsche Bank to take over Mendelssohn's, and Abs handled the negotiations. Among the 'crimes' commonly attributed to Hermann Abs was this Deutsche Bank takeover of Mendelssohn & Co., the largest private bank in Germany, as well as its Amsterdam branch in 1940. As is standard in such cases, the tale is of innocent Jewish businessmen having their property confiscated, their art collections seized by the state. However the truth is that the Amsterdam branch of Mendelssohn's, which had become a separate entity under the control of Jewish crook Fritz Mannheimer, had already become insolvent in August 1939 – eight months before the German invasion of the Netherlands.

As noted above, the position of Mendelssohn's Bank in Germany was far more complicated, mainly due to its international debt obligations. From 1938 to 1943 it continued to operate as "Mendelssohn in Liquidation", with Robi as the most important family partner – indeed by 1942 the sole partner – and by 1943 the liquidation

was almost completed, with Deutsche Bank having absorbed almost all its assets and liabilities.

Meanwhile several other family members were given financial compensation for the value of their shareholdings in the liquidated bank, and very importantly were freed from their obligations regarding its debts.

These included Robi's brother-in-law Paul Kempner, a former partner in the bank who emigrated to the USA in 1939. Kempner worked postwar as treasurer of an association formed to provide financial assistance for relatives of anti-Hitler conspirators – the American Committee to Aid Survivors of the German Resistance of July 20. Kempner had been an official of the liberal German Democratic Party during the Weimar Republic, and at the end of the Weimar years was Germany's representative on the Finance Committee of the League of Nations.

Unlike his brother-in-law Kempner, however, Robi was not overtly involved in politics.

Germany's largest private bank, especially in regard to international trade (limited of course after 1939 to neutral and German-allied countries).

The German government evidently felt that Robi Mendelssohn was one half-Jew who could be trusted. They were wrong. In the summer of 1943 senior MI6 officer John Cordeaux reported to the Foreign Office (in a document revealed here for the first time) that during a trip to Stockholm, Mendelssohn had made contact with the MI6 representative in the Swedish capital, Harry Carr.

Carr was a veteran MI6 officer who first worked for British intelligence in Russia soon after the Bolshevik revolution. From 1928 to 1941 he had been in charge of the important MI6 station in Helsinki, mainly focused on anti-Soviet operations, then relocated to Sweden after Finland joined the German side in 1941.



This sensational contact from a high-level Berlin source had to be handled at top level within MI6 and the Foreign Office, whose head Sir Alexander Cadogan had written to MI6 chief Sir Stewart Menzies only a few weeks earlier about the extreme sensitivity of such operations:

"The danger grows in proportion as the enemy national concerned is a person of standing in his own country, and I would say that no direct contact whatever should be made (without prior reference to myself) with any really prominent enemy national, such as a Cabinet Minister, a General or a senior official.

These last are precisely the sort of contacts that are likely to become known and that are most likely to arouse Russian suspicions; and even if it ever seemed desirable to authorise a contact of this kind, it would, I think, simultaneously be necessary to inform the Russians of it and probably the Americans as well."

THE FIRST ALARM in Sweden about Mad Cow Disease has just sounded. A farm in Halland (a coastal county in Sweden) first became associated with this “incredibly unlikely event, which has not really happened”, to speak in Tage Danielsson's (one of the most famous comedians, writers, filmmakers, actors, and much more, ever in Sweden; the quote is from a brilliant monologue about the dangers and risks of nuclear power plants, after the incident in Harrisburg, 1979) words. And, fortunately, this time the analysis seems to have been false. But is this the first also the last alarm?



Minister of Agriculture Margareta Winberg (above) has declared that there is no danger. I think she's very wrong. I think there is a huge danger just around the corner and it is not Winberg who should say that I am wrong in my suspicion; I want the Ministers of Trade and Industry Sahlin and Rosengren (who are responsible for the expansion of wireless communication) and the Minister of Social Affairs Engqvist (who is responsible for public health) to reassure us.

No, better than that! I want an absolute guarantee for safety and an absolute responsibility declared for any future danger!

What danger am I talking about? We all know today that Mad Cow Disease (BSE) is due to cattle being fed with ground animal carcasses. In these are infectious agents, prions (special

proteins), which transfer to the cattle. Under these unfortunate circumstances the infectious agent can be transported from the gastrointestinal channel to the blood and from blood, or via nerves, through the blood-brain barrier to the nerve cells in the brain. The result: a massive destruction of the brain tissue - the animal loses of control, behaves inappropriately and eventually dies. These infectious agents can be transmitted to humans, which in a corresponding way takes the human form of “Mad Cow Disease” (Creutzfeldt-Jacob’s Disease).

The Swedish researchers Arne Brun, Bertil Persson and Leif Salford, from Lund University and Hospital, have recently made a sensational discovery. They found, and this confirmed the results of other researchers, that very weak mobile phone-type microwave signals break down the blood-brain barrier in rats, whereby toxic proteins can penetrate and damage the brain. The resemblance to Mad Cow Disease is striking. Against this background, it must be considered most likely that Mad Cow Disease is simply due to the microwave radiation from mobile phones and other devices!

More and more people are pointing to mobile phones and base stations as causes of ill health. There is talk of burnout, sleep disorders, cancer, asthma and allergies, disorders of reproduction ... This week, a court in Geneva demanded the dismantling of a mobile phone mast precisely with reference to the perceived ill-health of the surrounding residents. The residents also received financial compensation for their suffering.

The other day you could read in Swedish newspapers that the most common mobile phones on the Swedish market have a radiation value between 1.7 watts per kilo body weight (Ericsson T28s) and 0.17 watts / kilo (Panasonic EB-GD 92). Brun, Persson and Salford used 500-5,000 times weaker radiation (0.4 milliwatts / kilograms) to open up the blood-brain barrier!

We are part of a full-scale trial sanctioned by the Swedish government where we are all whole-body irradiated around the clock, regardless of where we are. Then it doesn’t feel safe to know that the Lund researchers were able to break through the blood-brain barrier

with a radiation dose that is 5,000 times weaker than the Swedish (non-statutory) recommended value of 2 watts / kilo body weight! Nor does it feel reassuring to constantly read that “mobile phones are harmless”. Who, I ask, who can guarantee this !?

Very Uncomfortable is that researchers have recently shown that prions can migrate from mother to foetus. The foetus is normally protected by a membrane between its blood and the uterine tissue, the blood-placenta barrier.

We must assume that this barrier can also be damaged by very weak mobile phone radiation, just like the blood-brain barrier! Will Mad Cow Disease break out in Sweden? Yes, I definitely think so. We will soon have 30,000 new base stations for mobile telephony's new 3G / UMTS, we will have millions of local transmitters / receivers in the form of Bluetooth

systems. Does this feel safe? Is it really enough for companies or authorities to stubbornly repeat: "... there are hundreds of reports that show no biological effect"? Would you feel safe with hundreds of harmless snakes in the woods - while you have a poisonous cobra around your neck?

What does the Swedish Radiation Protection Institute do? I do not know. What exactly are our other authorities doing to find out the seriousness of the above? I do not know. What is the government doing? I do not know.

The only thing I know is that there is a risk that there is a risk. If I'm wrong in my fears, well, then you can laugh at me. But if I'm right, can I then laugh ...?

Waco Siege

Its massive location is now used by a Judeo-Christian church. Others are "downsizing". Many manufacturing plants are vacant. Even big supermarkets are closing. Those that can't meet discount and offshore pricing close down and their customers go to the Wal-Mart types who can.

Offshore

For the last 20 years or so, America's Corporations have quietly been moving operations offshore. We know that jobs and production have been exported to Mexico and Korea, but even Mexico is now complaining about China's and India's competition. These lands have billions of potential customers, a virtual slave population willing to work for pennies an hour, and the potential to reduce manufacturing costs tremendously. This translates into tremendous corporate profits.

Few Cartel politicians criticize "globalisation" and none advocate high tariffs to ban the return of alien-made goods to America. After all, the cartel media didn't put their politician- puppets in office to cause them trouble. And, corporations have no feelings. They are programmed for one thing - profit. 
China Trade -1994

China trade profits began to kick in in the late 1970's. They exploded in 1994. The stock markets reacted - big!

The Cartel financed conquest of China by their agent Mao following WWII, allowed American corporations to quietly begin buying cheap Chinese products and setting up their own manufacturing plants in China to take advantage of cheap Chinese labour. The products were sold for high prices in America. Products costing \$1 were sold for \$15 in America and corporate profits went out the roof.

NASDAQ

The chart below is the NASDAQ. It is an indicator of stock movements of over-the-counter stocks.



Advance/Decline

The declining line below the NASDAQ average is the Advance Decline line. It is a moving average of the difference between stocks moving up and those moving down. If the NASDAQ average moves up—

—so should the Advance Decline line. If the NASDAQ moves down - so should the A/D line. It isn't good if the NASDAQ moves higher while the A/D line moves lower.

Notice that the divergence between stock prices and their A/D line started as far back as 1995 and continued on through 2003. A massive divergence. Stock averages moved up and most stocks traded down. American companies are being devastated - a result of the China poison.

Observation

Again - a Corporation has no mind, no compassion, no sense of right or wrong. It is programmed for profit - nothing else - and will do anything to obtain its goal. We are told that American business moving off-shore is bad because unemployed workers of downsized

businesses will have less money to spend. Corporations don't think so. They don't think that they won't suffer at all. Why? They are counting on the economies in the far east growing and replacing Western economies. To put it another way, they believe that the rising standard of living and increased income in these untapped oriental markets will fuel corporate operations far into the future. Backlash
