# Old Testament

## “Word for Word” Exodus Part 8

### Translation by Stephen Howard Anderson



## Chapter 10

1. And said Yahweh to Mosheh, **“Go in to Par’oh: because I have made heavy his heart, and the hearts of his servants, so that I might show these signs in his presence:**

2. **and so that you may tell in the ears of your son, and of your son’s son, what things I have done in Mits’rayim, and My signs which I have done among them; that you may know that I am Yahweh.”**

3. And came in Mosheh and Aharon to Par’oh, and said to him, **“Thus says Yahweh Elohey the Ibriym, ‘How long will you refuse to humble yourself before Me? Let My people go, so that they may serve Me.**

4. **Else, if you refuse to let My people go, behold, tomorrow I will bring the locusts <sup>697</sup> into your territories <sup>1366</sup>:**

5. **and they shall cover the surface of the ground, so that one cannot be able to see the ground: and they shall eat the remainder of that which escaped <sup>6413</sup>, which remains to you after the hail, and shall eat every tree which grows for you out of the field:**

6. **and they shall fill your houses, and the houses of all your servants, and the houses of all the Mits’rayim which neither your fathers nor your fathers’ fathers have seen, since the day they were on the land unto this day.”** And he turned himself, and went out from Pa’roh.

7. And said the servants of Par’oh to him, **“How long shall this man be a snare to us? Let the men go, so that they may serve Yahweh Eloheyhem <sup>430</sup>: do you not yet know that Mits’rayim is destroyed?”**

8. And were brought again Mosheh and Aharon to Par’oh: and said he to them, **“Go, serve Yahweh Eloheychem <sup>430</sup> but who are they that shall go?”**

9. And said Mosheh, **“We will go with our young and with our old, with our sons and with our daughters, with our flocks and with our herds will we go; because we must hold a feast to Yahweh.”**

10. And said he to them, **“Let Yahweh be so with you, as I will let you go with your little ones! See to it; because evil is before <sup>5048</sup> your presence.**

11. Not so! Go now you men, and serve Yahweh, because that you did desire.” And they were driven out from before Par’oh.

12. And said Yahweh to Mosheh, **“Stretch out your hand over the land of Mits’rayim for the locusts, so that they may come up upon the land of Mits’rayim, and eat every herb of the land, all that the hail has left.”**

13. And stretched forth Mosheh the rod over the land of Mits’rayim, and brought Yahweh an east wind upon the land all that day, and all that night; and when it was morning, the east wind brought the locusts.

14. And went up the locusts over all the land of Mits’rayim, and rested in all the territories of Mits’rayim: very grievous were they; before them there were no such locusts as they, neither after them shall there be such,

15. because they covered the surface <sup>5869</sup> of the whole land, so that the land was darkened <sup>2821</sup>; and they ate every plant of the land, and all the fruit of the trees which the hail had left: and there remained no green thing in the trees, or in


the plants of the field, through all the land of Mits'rayim.

16. Then called Par'oh for Mosheh and Aharon in haste; and said he, "I have sinned against Yahweh Eloheychem, and against you.

17. Now therefore forgive 5375, please, my sin only this once, and entreat Yahweh Eloheychem so that He may take away from me this death only!"

18. And he went out from Par'oh, and entreated Yahweh.

19. And turned Yahweh a mighty strong west wind, which took away the locusts, and cast them into the Sea 3220 of Reeds 5488, and there remained not one locust in all the territories of Mits'rayim.



20. But strengthened Yahweh the heart of Par'oh, so that he would not let go the children of Yis'rael.

21. And said Yahweh to Mosheh, "**Stretch out your hand toward the sky, so that there may be darkness 2822 over the land of Mits'rayim, darkness which may even be felt 4959.**"

22. And stretched forth Mosheh his hand toward the sky, and there was thick 653 darkness in all the land of Mits'rayim three days:

23. Saw they not one another, and rose none from his place for three days: but all the children of Yis'rael had light in their dwellings.

24. And called Par'oh to Mosheh, and said, "Go you, serve Yahweh; only let your flocks and herds remain; let your little ones also go with you."

25. And said Mosheh, "You must give us also sacrifices for burnt offerings, so that we may do this for Yahweh Eloheynu 430;

26. Our livestock also shall go with us; there shall not a hoof be left behind; because of these must we take to serve Yahweh Eloheynu; and we know not with what we must serve Yahweh until we come there."

27. But strengthened Yahweh the heart of Par'oh, and he would not let them go.

28. And said Par'oh to him, "Get you away from me, guard 8104 yourself, see my face no more; because in that day you see my face you shall die!"

29. And said Mosheh, "You have spoken well, I will see your face again no more."

## Chapter 10 Notes

Yahweh is setting up Par'oh for the final fall. Par'oh keeps sinning, and when Yahweh sends Mosheh to him to warn of a new plague, he ignores him. When the plague comes, Par'oh calls for Mosheh to entreat Yahweh, and makes promises he will not keep.

This brings more punishment, and by now, the entire land of Mits'rayim is devastated. Paroh's own people warn him of this, but he is a mighty king of a mighty land, and he will not let slaves dictate to him, no matter who their God is. In the future, all this will be known among all the nations where Yis'rael will finally settle.

The very Name of Yahweh will inspire fear among the pagans because of what is going on with Mits'rayim. Par'oh tries to limit who may go in stages, but finally Mosheh just tells him that all of Yis'rael will go, period. Par'oh drives him out from him, with a threat of death if he sees him again.

This sets the stage for the final blow of the last plague in Chapter 11.

## Chapter 11

1. And said Yahweh to Mosheh, “Yet I will bring one more plague upon Par’oh, and upon Mits’rayim; afterward he will let you go from here: when he shall let you go, he shall surely thrust you out from here altogether.

2. Speak now in the ears of the people, and let every man ask 7592 from another person, and every woman from her associate 7268, jewels of silver, and jewels of gold.”

3. And gave Yahweh the people favour 2580 in the eyes of the Mits’rayim. Moreover the man Mosheh was very great in the eyes of the servants of Par’oh, and in the eyes of the people.

4. And said Mosheh, “Thus says Yahweh, ‘About midnight I will go out into the land of Mits’rayim:

5. and all the firstborn in the land of Mits’rayim shall die, from the firstborn of Par’oh that sits on the throne, even unto the firstborn of the maidservant that is behind the mill 7347; and all firstborn of beasts 929.

6. And there shall be a great cry 6818 throughout all the land of Mits’rayim, such as there was none like it nor shall be like it anymore.

7. But against the children of Yis’rael shall not a dog move his tongue, from man or beast: so that you may know that Yahweh puts a

distinction 6395 between the Mits’rayim and Yis’rael.’

8. And all these your servants shall come down to me, and bow themselves down 7812 to me, saying, ‘Get you out, and all the people that follow you!’ : and after that I will go out.” And he went out from Par’oh in a burning anger.

9. And said Yahweh to Mosheh, “Par’oh shall not listen to you; so that My wonders may increase in the land of Mits’rayim.”

10. And did Mosheh and Aharon all these wonders in the presence of Par’oh: and strengthened Yahweh the heart of Par’oh, so that he would not let the children of Yis’rael go forth from his land.

## Chapter 11 Notes

Par’oh is warned of the final plague by Mosheh, before he leaves his presence, in a continuation from the last chapter. Par’oh again will not listen, as arranged by Yahweh, so that His power will be in evidence for all to see. “Beasts” and “dogs” are derogatory terms for non-adamic “men”. Yahshua called them “dogs” in the New Testament. The “dog” moving his tongue is a metaphor for speaking against Yis’rael. Even a non-adamic slave would not speak against them.

### Chapter 15 (Continued)

#### TO WHOM DOES GRACE ABOUND

Obedying the Law and trusting (faith) the giver is how you show grace or kindness to the giver. Your obedience is meant to be your response to the gift. You can do nothing to get salvation, it is given. But in order to have less painful correction, it pays to be kind to the giver by obeying Him, King Jesus. Furthermore, some say Identity Christians have a less than gracious stance towards non-Israelites.

It is true that all things and creatures are God’s creation, but the grace Jesus gave was to Israelites only; Read Romans 5:8-12. Paul tells us that by one man, death (spiritual death)

came to many (all Adamic types), likewise by the wholesome lawfulness of Jesus the gift of grace was given to many of Adam's seed through Abraham. This grace or kindness is what saves, but only Israelites.

Thus grace is only to us as a gift, a pearl not to be cast to the swine. Do not give the grace (given to you) to these whom it was not meant for. You do not confess Jesus to be saved, but rather you confess Him because you are saved. Romans 10:9-10 has always been misquoted by the churchy-types who treat God as a genie in a bottle; say the right words and you'll be saved.

That sort of nonsense was designed to "Christianise" non-Saxons. The point is, non-Saxons were never 'saved' and therefore can never confess Jesus.

This then thwarts the whole idea of claims (made by church types) that non-Saxons can be Christians. Sorry, they are not, no matter what you call them. 

And for those Judeo-Christians that help the non-Saxons, "Therefore is wrath upon thee (Israelites) from the Lord" 2 Chronicles 19:9. But kindness to many of those that obey Jesus, through the Law.

These are over-comers who work towards the **RISE** of Abraham's kin and no one else. These are Elijah types, anointed types, Jesus Christ's body, booth (Beth-house-tabernacle) types. The ones that will replace the present ruling class.

They will rule with Jesus to restore in fullness all that was lost, that which was taken from our folk, doing unto Babylon double as she has done unto us. Taking back all the lands we lost under church rule, unbinding the melting-pot and all the paganism that goes with it, from daft fashions to Rock 'n' Roll to modern art, architecture to man's laws, parliaments, central governments and so forth.



There will be a united nations, but not the melting-pot version of Esau, rather a oneness (united) of Jacob, Abraham's kin, one no matter where they live. 'I have a dream', to see my folk obeying Jesus, as one cry and as one song. **AMEN!**

### **To Be Added "To Spue or Not To Spue"**

Spewing is a tasteless subject, yet very Biblical. Its too tasteless for today's effeminate dainty church leaders, and never understood by churches throughout history, but they are responsible for kicking in the laws of spewing. The Law (of God) states that punishment must befit the crime.

Too often our folk have looked back at calamities that have befallen them and asked: "what have we done to deserve this?" Case in point: A "White-Indonesian" (that is, an Indonesian born white - an Israelite) who was

forced into a concentration camp with some 10,000 other white Indonesians during WWII (run by the Japs) wondered, 'Why us? When will God help us?'



### A Japanese Concentration Camp

The Japs ran many concentration camps, each holding as many as 10,000 white people, cramped into the most unclean conditions in which starvation was a daily punishment whilst the guards ate the Red Cross food parcels, or fed fresh fruit to pet apes while dying whites looked on. Beatings and other abuses were daily happenings for petty things such as not bowing to a Jap guard properly, serving no purpose other than to make camp masters feel superior.

Boys ten years and over were taken to boys camp where many were worked to death in slave labour extermination camps. These folks were rounded up, taken and locked away and tortured to rid the land of them, based on one criteria only—they were white!

If it were any other folks than white victims, we'd speak of ethnic cleansing, or the Final Solution. The Dutch (Israelites) or (white-Indonesians if you like) were subject to this slow genocide. On average, the death rate per camp per month was between 75 to 100 whites a day. Too often we ask the question "if there is a God why would He allow this?" Better phrasing would be, "because there is a God **WHY** did He bring this on?"

It's to do with the law of spewing. As I have shown in this book, we never drove the heathen out. We always felt we knew better than God, that we understand the heathen better than He. And —also the fact that Israelites have always

wanted cheap labour to do things for them. So what happens - we (Israelites) become their 'cheap or slave labour'! Even in the Church Age, or Pentecostal age in which we were meant to have the Law (of God) written on our hearts, we made our own laws and wrote these instead on our hearts. Such a move then required that we choose kings and priests to represent those laws; they represented our heart idols, or heart nature, a return to the wickedness of Gilgal.

Because we did not drive out the heathen when God gave us the chance and ordered us when He gave us the 'Key of David' (Rev 3:7, Isa 22:15-25) we became subject to corrective laws that had to deal with our disobedience. The punishment had to fit that crime. Thus, if we would not drive out the heathen, the punishment is that they drive us out! The 'Key of David' is written in the account relating to the 6th church age in which the churches started the missionary societies and their kings/governments were in the throes of colonization zeal.

But when our folk (with the Key of David, i.e. taking dominion in Jesus' name), the Spanish took land in South America, they never drove out the heathen. When the Portuguese took land in South America, Africa and elsewhere, they never drove out the heathen.

When the Dutch took land in South and North America, Africa and Indonesia, they never drove out the heathen. When the French took land in North America, Africa and South East Asia, they never drove out the heathen. When the English took land in North America, Africa, Asia, Australia and New Zealand, they never drove out the heathen. All the above were our kin of Israelite stock, all rebelled against God's orders.

As I have pointed out before, instead they teamed up with the heathen to drive out other Israelite kin who they saw not as brothers but as rival foes! Thus, God's children fought God's children to death and despised the good lands God gave them by not allowing God's inheritance (namely Israelite children) to inherit those lands. British (Israelites) would join Jews (Canaanites) to drive out French (Israelites) or Dutch (Israelites) and the other way around.

All the while the heathen whom God promised to drive out (spew out) benefited by this, for in time God would give these the authority to spew

our disobedient folk out. What else could/can the Sovereign Land- Lord do?

When we don't drive out the heathen, we begin to take on their ways, (even to Christians painting Aboriginal artefacts, to be sold to tourists as authentic). Christians may poo-poo this but it's true. Where does Jazz,

Rock-'N-Roll, Ramba Samba come from? Or today's art and architecture, or pagan festivals? We even import their words and make them our own (kangaroo, dugon, satay, tsunami, and so on), our fashions take on their influence and even our entire system of government (namely, man-kings).

Thus the whole nation is won over to heathenism because central government with its system of man-kings is heathen. Churches love to talk of spiritual Israelites, the truth is, we become spiritual Canaanites ('gay' mardi-gras, etc).

As pointed out earlier, we said "Give us a king like all the other nations (or heathen)." And therefore our Parliaments (towers of Babel) have non-Israelites in them, despite the Law that "Thou mayest not set a stranger (zuwr - racial alien) over thee which is not thy brother (kin)." Deut 17:15. In Netherlands Indies, as in so many other Israelite held lands, we let the zuwr rule over us and we even did 'wed and bed' them.

"Defile not ye yourselves in any of these things: for in all these the nations are defiled which I sent out before you " Lev 18:24. Yet we defiled our selves with the zuwr— "Neither shall thou lie with any beast to defile thyself therewith."

Elsewhere (Lev 20:15) the Law states that both Israelite and 'beast' are to be put to death for this misdeed. But think, the beast would have to have the mental means to give approval to the sexual misdeed, otherwise it is deemed rape. And if the deed is rape, the Law states that a rape victim is to go free.

Yet in this case there is mutual consent. Can an animal give consent? This "beast" means a 'created-being' in the sense of "beast of the field," which is a Hebrew idiom for 'hunters and gatherers.' You can not ask approval, or a date, let alone wed and bed a horse, cow, camel or Giraffe; but you can physically do all the above with a hunter and gatherer, or Beast of the Field.

That law in Leviticus 18 clearly deals with race-mixing. Race-mixing and therefore lying with the 'Beast of the Field' was common in Netherlands Indonesia as it was in all Saxon (Israelite) lands. Those that didn't wed and bed them, thought nothing of those that did.

The greater the 'defilement' the swifter God's wrath. Lev 18:25-28 "and the land is defiled; therefore / do visit the iniquity thereof upon it, and the land itself vomiteth out her inhabitants; Ye shall therefore keep my statutes and my judgments (namely do not make your own laws or constitutions) and shall not carry out all these revolting deeds —that the land spew you not out also—"

This very theme carries on into Jesus' rule as of AD 33, for in the account of the 7 churches (during the 7th and last church age, the Laodicean outpouring) we read, "I know thy works, that thou art neither cold nor hot " (they couldn't care less about God's Laws as they claimed such to be 'done away with' including the law of being Holy or separate, apart; the forbidding of racial assimilation and integration). "So because thou art lukewarm-- I will SPEW thee out of my mouth." **Rev 2:14-16.**

Those are the words of Jesus, mirroring the words of his Father, for he can do nothing but what he sees his Father do.

The Western world was and is the Church world. So when Jesus spews out a 'church' he spews out the nation that goes to that church. However painful that is, we need to say, "Yea Lord all thy judgments are righteous." (**Psalms 19:9**).

In the light of the Holy Writ, history becomes clear and makes logical sense, however painful. True, not everyone partook of certain crimes, but

the effect of tolerating and approving those that race mix, even defending them brings you under the law that teaches that those that 'take delight in those that do them' are just as guilty (Rom 1:22).

Indeed, they did not save the criminals (race mixers) from their crime (sin). And if some one did say something then no doubt that person would be labelled a hater, racist, white supremacist and so on.

Because the nation would not hearken unto the Lord, the Lord punishes the nation, if they would still not listen, He'd punish them 7 times more for their crimes (sins) Lev 26:18.

"I will even appoint over you terror; consumption and the burning ague, that shall consume the eyes, and cause sorrow of heart; and ye shall sow your seed in vain for your enemies shall eat it. And I will set my face against you, and ye shall be slain before your enemies, they that hate you shall reign over you—"

"Turn you from your evil ways (ie living by man's laws) for why will you die, O house of Israel?" (Eze 33:11). "He that turneth away his ear from hearing the law (God's Law, that is, so that would be nearly all Saxons), even his prayer shall be abomination." (Prov 28:9) Churches and church leaders should take particular note of that. "My folk are destroyed for lack of knowledge (which knowledge? about who runs the banks? NO! Rather lack of knowledge of God's Laws!)

**I Will Also Reject You**—seeing you have forgotten the law of your God (that's the crux of it) —I will also **Forget Your Children.**" (Hos 4:6) **Ouch!** That's where the rubber meets the road folks - do you now understand the suffering of our folk, our children, our loved ones? 
speak against it and in turn God's wrath upon the 'know-it-all' nation in which even one's children die.


And many people were gathered together from the towns and villages, and the hill country; for they had heard of the conversion of the apostle, and his many miracles.

## The Invisible Rainbow (Part 3) Porphyrins and The Basis of Life

**T**HE LAWS OF CHEMISTRY HAD EXPLAINED A LOT about metabolic processes, and electron transport now explained even more, but there was not yet an organizing principle. Elephants grow from tiny embryos, which grow from single brainless cells. Salamanders regenerate perfect limbs. When we are cut, or break a bone, cells and organs throughout our body mobilize and coordinate their activities to repair the damage.

How does the information travel? How, borrowing Szent-Györgyi's words, do protein molecules "live"?

Despite Szent-Györgyi's sin, his predictions have proven correct. Molecules in cells do not drift at random to collide with one another. Most are firmly anchored to membranes.

The water inside cells is highly structured and does not resemble the free-flowing liquid that sloshes around in a glass before you drink it. Piezoelectricity, a property of crystals that makes them useful in electronic products, that transforms mechanical stress into electrical voltages and vice versa, has been found in cellulose, collagen, horn, bone, wool, wood,

tendon, blood vessel walls, muscle, nerve, fibrin, DNA, and every type of protein examined. In other words—something most biologists have been denying for two centuries—electricity is essential to biology.

Szent-Györgyi was not the first to challenge conventional thinking. It was Otto Lehmann, already in 1908, who, noticing the close resemblance between the shapes of known liquid crystals and many biological structures, proposed that the very basis of life was the liquid crystalline state.

Liquid crystals, like organisms, had the ability to grow from seeds; to heal wounds; to consume other substances, or other crystals; to be poisoned; to form membranes, spheres, rods, filaments and helical structures; to divide; to "mate" with other forms, resulting in offspring that had characteristics of both parents; to transform chemical energy into mechanical motion.

After Szent-Györgyi's daring Budapest lecture, others pursued his ideas. In 1949, Dutch researcher E. Katz explained how electrons could move through a semi-conducting chlorophyll crystal during photosynthesis.

In 1955, James Bassham and Melvin Calvin, working for the U.S. Atomic Energy Commission, elaborated on this theory. In 1956, William Arnold, at Oak Ridge National Laboratory, confirmed experimentally that dried chloroplasts—the particles in green plants that contain chlorophyll—have many of the properties of semiconductors. In 1959, Daniel Eley, at Nottingham University, proved that dried proteins, amino acids, and porphyrins are indeed semiconductors. In 1962, Roderick Clayton, also at Oak Ridge, found that photosynthetic tissues in living plants behave like semiconductors.

In 1970, Alan Adler, at the New England Institute, showed that thin films of porphyrins



do also. In the 1970's, biochemist Freeman Cope (Left), at the United States Naval Air Development Center in Warminster, Pennsylvania, emphasized the importance of solid state physics for a true understanding of biology, as did biologist Allan Frey, the most

active American researcher into the effects of microwave radiation on the nervous system at that time.

Ling Wei, professor of electrical engineering at the University of Waterloo in Ontario, stated baldly that a nerve axon is an electrical transmission line and that its membrane is an ionic transistor.

He said that the equivalent circuitry "can be found in any electronics book today," and that "one can easily derive the nerve behaviour from semiconductor physics." When he did so, his equations predicted some of the properties of nerves that were, and still are, puzzling to physiologists.

In 1979, a young professor of bio-electronics at the University of Edinburgh published a book titled *Dielectric and Electronic Properties of Biological Materials*. The earlier work of Eley and Arnold had been criticized because the activation energies they had measured—the amount of energy necessary to make proteins conduct electricity—seemed to be too large. Supposedly there was not enough energy available in living organisms to lift electrons into the conduction band.

Proteins might be made to conduct electricity in the laboratory, said the critics, but this could not happen in the real world. Eley and Arnold, however, had done all their work on dried proteins, not living ones.

The young professor, Ronald Pethig, pointed out the obvious: water is essential to life, and proteins become more conductive if you added water to them. In fact, studies had shown that adding only 7.5 percent water increased the conductivity of many proteins ten thousandfold or more!

Water, he proposed, is an electron donor that "dopes" proteins and turns them into good semiconductors.

The electronic role of living water had already been noted by others. Physiologist Gilbert Ling, realizing that cell water is a gel and not a liquid, developed his theory of the electronic nature of cells in 1962. More recently, Gerald Pollack, professor of bioengineering at the University of Washington, has taken up this line of investigation.

He was inspired by Ling when they met at a conference in the mid-1980's. Pollack's most recent book, *The Fourth Phase of Water: Beyond Solid, Liquid, and Vapor*, was published in 2011.



The late geneticist Mae-Wan Ho, in London, has clothed Szent-Györgyi's ideas in garments that all can see. She developed a technique using a polarizing microscope that displayed, in vivid colour, the

interference patterns generated by the liquid crystalline structures that make up living creatures.

The first animal she put under her microscope was a tiny worm—a fruit fly larva. "As it crawls along, it weaves its head from side to side flashing jaw muscles in blue and orange stripes on a magenta background," she wrote in 1993 in her book, *The Rainbow and the Worm:*

*The Physics of Organisms*. She and many others have urged that the liquid crystalline properties of our cells and tissues not only teach us about our chemistry, but have something special to tell us about life itself.

Włodzimierz Sedlak, pursuing Szent-Györgyi's ideas in Poland, developed the discipline of bio-electronics within the Catholic University of Lublin during the 1960's. Life, he said, is not only a collection of organic compounds undergoing chemical reactions, but those chemical reactions are coordinated with electronic processes that take place in an environment of protein semiconductors.

Other scientists working at the same university are continuing to develop this discipline

theoretically and experimentally today. Marian Wnuk has focused on porphyrins as key to the evolution of life. He states that the principal function of porphyrin systems is an electronic one.

Józef Zon, head of the Department of Theoretical Biology at the University, has focused on the electronic properties of biological membranes. Oddly enough, the use of porphyrins in electronic products instructs us about biology. Adding thin films of porphyrins to commercially available photovoltaic cells increases the voltage, current, and total power output.

Prototype solar cells based on porphyrins have been produced, as have organic transistors based on porphyrins.

The properties that make porphyrins suitable in electronics are the same properties that make us alive. As everyone knows, playing with fire is dangerous; oxidation releases tremendous energy quickly and violently.

How, then, do living organisms make use of oxygen? How do we manage to breathe and metabolise our food without being destroyed in a conflagration?

The secret lies in the highly pigmented, fluorescent molecule called porphyrin. Strong pigments are always efficient energy absorbers, and if they are also fluorescent, they are also good energy transmitters.

As Szent Györgyi taught us in his 1957 book, *Bio-energetics*, “fluorescence thus tells us that the molecule is capable of accepting energy and does not dissipate it. These are two qualities any molecule must have to be able to act as an energy transmitter.”

Porphyrins are more efficient energy transmitters than any other of life’s components. In technical terms, their ionisation potential is low, and their electron affinity high. They are therefore capable of transmitting large amounts of energy rapidly in small steps, one low-energy electron at a time.

They can even transmit energy electronically from oxygen to other molecules, instead of dissipating that energy as heat and burning up. That’s why breathing is possible. On the other side of the great cycle of life, porphyrins in plants absorb the energy of sunlight and transport

electrons that change carbon dioxide and water into carbohydrates and oxygen.

Porphyrins, the Nervous System, and the Environment There is one more place these surprising molecules are found: in the nervous system, the organ where electrons flow. In fact, in mammals, the central nervous system is the only organ that shines with the red fluorescent glow of porphyrins when examined under ultraviolet light.

These porphyrins, too, perform a function that is basic to life. They occur, however, in a location where one might least expect to find them—not in the neurons themselves, the cells that carry messages from our five senses to our brain, but in the myelin sheaths that envelop them—the sheaths whose role has been almost totally neglected by researchers and whose breakdown causes one of the most common and least understood neurological diseases of our time: multiple sclerosis.



It was orthopaedic surgeon Robert O. Becker (above) who, in the 1970’s, discovered that myelin sheaths are really electrical transmission lines.

In a state of health the myelin sheaths contain primarily two types of porphyrins—coproporphyrin III and protoporphyrin—in a ratio of two to one, complexed with zinc. The exact composition is crucial. When environmental chemicals poison the porphyrin pathway, excess porphyrins, bound to heavy metals, build up in the nervous system as in the rest of the body.

This disrupts the myelin sheaths and changes their conductivity which, in turn, alters the excitability of the nerves they surround. The entire nervous system becomes hyper-reactive to stimuli of all kinds, including electromagnetic fields.

The cells surrounding our nerves were hardly even studied until recently. In the nineteenth century, anatomists, finding no apparent function for them, supposed that they must have only a “nutritive” and “supportive” role, protecting the “real” nerves that they surrounded.

They named them glial cells after the Greek word for “glue.” The discovery of the action potential, which transmits signals along each neuron, and of neurotransmitters, the chemicals that carry signals from one neuron to the next, had ended the discussion. From then on, glial cells were thought to be little more than packing material.

Most biologists ignored the fact, discovered by German physician Rudolf Virchow in 1854, that myelin is a liquid crystal. They did not think it was relevant. However, working from the 1960’s to the early 1980’s and author, in 1985, of *The Body Electric*, Becker found quite another function for the myelin-containing cells and took another step toward restoring electricity to its proper role in the functioning of living things.

When he began his research in 1958, Becker was simply looking for a solution to orthopaedics’ greatest unsolved problem: nonunion of fractures. Occasionally, despite the best medical care, a bone would refuse to heal. Surgeons, believing that only chemical processes were at work, simply scraped the fracture surfaces, devised complicated plates and screws to hold the bone ends rigidly together, and hoped for the best.

Where this did not work, limbs had to be amputated. “These approaches seemed superficial to me,” Becker recalled. “I doubted that we would ever understand the failure to heal unless we truly understood healing itself.”


Becker began to pursue the ideas of Albert Szent-Györgyi, thinking that if proteins were semiconductors, maybe bones were too, and maybe electron flow was the secret to the healing of fractures.

Ultimately he proved that this was correct. Bones were not just made of collagen and apatite, as he was taught in medical school; they were also doped with tiny amounts of copper, much as silicon wafers in computers are doped with tiny amounts of boron or aluminium.

The presence of greater or lesser amounts of metal atoms regulates the electrical conductivity of the circuitry—in bones as in computers. With this understanding, Becker designed machines that delivered miniscule electric currents—as small as 100 trillionths of an ampere—to fractured bones to stimulate the healing process, with great success: his devices were the forerunners of machines that are used today by orthopedic surgeons in hospitals throughout the world.

Becker’s work on the nervous system is less well known. As already mentioned, the functioning of neurons had been worked out, up to a point, in the nineteenth century. They transmit enormous amounts of information to and from the brain at high speed, including data about one’s environment, and instructions to one’s muscles.

They do this via the familiar action potential and neurotransmitters. And since the action potential is an all-or-nothing event, neuron signalling is an on-off digital system like today’s computers.



But Becker thought that this could not explain the most important properties of life; there had to be a slower, more primitive, and more sensitive analogue system that regulates growth and healing, that we inherited from lower forms of life—a system that might be related to the acupuncture meridians of Chinese medicine, (above) which western medicine also made no attempt to understand.

A number of researchers before Becker, among them Harold Saxton Burr at Yale, Lester Barth at Columbia, Elmer Lund at the University of Texas, Ralph Gerard and Benjamin Libet at the University of Chicago, Theodore Bullock at U.C.L.A., and William Burge at the University of Illinois, had measured DC voltages on the

surfaces of living organisms, both plants and animals, and embryos. Most biologists paid no attention. After all, certain DC currents, called “currents of injury,” were well known, and were thought to be well understood.

They had been discovered by Carlo Matteucci as long ago as the 1830’s. Biologists had assumed, for a century, that these currents were meaningless artefacts, caused simply by ions leaking out of wounds. But when, in the 1930’s and 1940’s, a growing number of scientists, using better techniques, began to find DC voltages on all surfaces of all living things, and not just on the surfaces of wounds, a few began to wonder whether those “currents of injury” just might be a bit more important than they had learned in school.

The accumulated work of these scientists showed that trees, and probably all plants, are polarized electrically, positive to negative, from leaves to roots, and that animals are similarly polarized from head to feet. In humans potential differences of up to 150 millivolts or more could sometimes be measured between one part of the body and another.

Becker was the first to map the charge distribution in an animal in some detail, accomplishing this with salamanders in 1960.

The places of greatest positive voltage, he found, as measured from the back of the animal, were the centre of the head, the upper spine over the heart, and the lumbosacral plexus at the lower end of the spine, while the places of greatest negative voltage were the four feet and the end of the tail.

In addition, the head of an alert animal was polarized from back to front, as though an electric current were always flowing in one direction through the middle of its brain. However, when an animal was anaesthetised the voltage diminished as the anaesthetic took effect, and then the head reversed polarity when the animal lost consciousness.

This suggested to him a novel method of inducing anaesthesia, and when Becker tried it, it worked like a charm. In the salamander, at least, passing an electric current of only 30 millionths of an ampere from front to back through the centre of its head caused the animal

to become immediately unconscious and unresponsive to pain.

When the current was turned off, the animal promptly woke up. He observed the same back-to-front polarity in alert humans, and the same reversal during sleep and anaesthesia.

While Becker did not try it himself, even tinier electric currents have been used in psychiatry to put humans to sleep since about 1950 in Russia, Eastern Europe, and Asian countries that were once part of the Soviet Union.

In these treatments, current is sent from front to back through the midline of the head, reversing the normal polarity of the brain, just as Becker did with his salamanders. The first publications describing this procedure specified short pulses of 10 to 15 micro-amperes each, 5 to 25 times per second, which gave an average current of only about 30 billionths of an ampere.



Although larger currents will cause immediate unconsciousness in a human, just like in a salamander, those tiny currents are all that is necessary to put a person to sleep. This technique, called “electrosleep,” has been used for over half a century to treat mental disorders, including manic-depressive illness and schizophrenia, in that part of the world.

The normal electrical potentials of the body are also necessary for the perception of pain. The abolition of pain in a person’s arm, for example, whether caused by a chemical anaesthetic, hypnosis, or acupuncture, is accompanied by a reversal of electrical polarity in that arm.

By the 1970’s it had become clear to the researchers who were looking into such things that the DC potentials they were measuring played a key role in organizing living structures. They were necessary for growth and development. They were also needed for regeneration and healing.

Tweedy John Todd demonstrated as long ago as 1823 that a salamander cannot regenerate a severed leg if you destroy that leg's nerve supply. So for a century and a half, scientists searched for the chemical signal that must be transmitted by nerves to trigger growth. No one ever found one.

Finally, embryologist Sylvan Meryl Rose, in the mid-1970's at Tulane University, proposed that maybe there was no such chemical, and that the long-sought signal was purely electrical. Could the currents of injury, he asked, that had previously been considered mere artefacts, themselves play a central role in healing?



**Salamanders**

Rose found that they did. He recorded the patterns of the currents in the wound stumps of salamanders as they regenerated their severed limbs. The end of the stump, he found, was always strongly positive during the first few days after injury, then reversed polarity to become strongly negative for the next couple of weeks, finally reestablishing the weakly negative voltage found on all healthy salamander legs.

Rose then found that salamanders would regenerate their legs normally, even without a nerve supply, provided he carefully duplicated, with an artificial source of current, the electrical patterns of healing that he had observed. Regeneration would not take place if the polarity, magnitude, or sequence of currents were not correct.

Once having established that the signals that trigger regeneration are electrical and not chemical in nature, these scientists were in for yet another surprise. For the DC potentials of the body that, as we have seen, are necessary not just for regeneration but for growth, healing, pain perception, and even consciousness, seemed to be generated not in the "real" nerves but in the

myelin-containing cells that surround them—the cells that also contain porphyrins.

Proof came by accident while Becker was again working on the problem of why some bone fractures fail to mend. Since he had already learned that nerves were essential to healing, he tried, in the early 1970's, to create an animal model for fractures that do not heal by severing the nerve supply to a series of rats' legs before breaking them.


To his surprise, the leg bones still healed normally—with a six-day delay. Yet six days was not nearly enough time for a rat to regenerate a severed nerve. Could bones be an exception, he wondered, to the rule that nerves are needed for healing? "Then we took a more detailed look at the specimens," wrote Becker. "We found that the Schwann cell sheaths were growing across the gap during the six-day delay.

As soon as the perineural sleeve was mended, the bones began to heal normally, indicating that at least the healing, or output, signal, was being carried by the sheath rather than the nerve itself.

The cells that biologists had considered merely insulation turned out to be the real wires."22 It was the Schwann cells, Becker concluded—the myelin-containing glial cells—and not the neurons they surrounded, that carried the currents that determined growth and healing.

And in a much earlier study Becker had already shown that the DC currents that flow along salamander legs, and presumably along the limbs and bodies of all higher animals, are of semi-conducting type.


To others, however, it's known as the middle of July, or summer.





# Obituary Ian Verner Macdonald (January 19, 1925 - June 28, 2022) R. I. P. Posted By Daniel Johns



## Ian Verner Macdonald Receiving a Presentation

**CANADA LOST AN OUTSTANDING FREE SPEECH WARRIOR, HISTORICAL REVISIONIST AND FREE THINKER,** June 28 with the death of Ian Verner Macdonald, well into his 99th year. Ian was the son of the late John A. and Katherine Macdonald.

He was one of the first to be born in the newly-built Ottawa Civic Hospital on January 1925 and grew up in Old Ottawa South with summers spent in Sherbrooke, Nova Scotia where both of his parents were born.

A true patriot all of his life, he served in the RCAF and RN Fleet Air Arm during WWII and had a lifelong love of aviation. With degrees in economics from Queen's University and University of Toronto, he wrote the Foreign Service Exam, placing second nationwide, and then went on to a career as a trade diplomat that took him officially to over 50 countries.

His numerous unprecedented accomplishments in this career made him arguably the most productive trade official then in Canadian history. Always a Canada Firster, in the mid-60's he urged taking advantage of trade opportunities with the increasingly wealthy Arab world.

After six foreign postings, on five continents, he was appointed Chief of Planning and Policy for

export development from which position he was able to propose programmes and policies based on practical experience that would greatly improve the efficacy of government assistance to Canadians seeking to do business abroad.

In the mid-sixties, he strongly recommended cultivation of the lucrative and receptive Arab markets where he had been assured by top-level officials and businessmen that Canada, because of its perceived independent, non-partisan foreign policy, was their trading partner of choice.

Much to his dismay, Canadair reported that the sale he had negotiated for supply of jet trainers to the Sultan of Oman's Air Force (SOAF) had been vetoed by Foreign Affairs, an affront to Sultan Said bin Taimur that cost Canada heavily in prospective earnings.

More importantly, his high-level discussions to train and equip the embryo Saudi Air Force, for which a \$400 million down payment was offered, failed to receive support in Ottawa and was never consummated.

To add to the folly, his Middle East and North African trade policy proposals, no matter how astute and prescient, were opposed furiously by an influential foreign-affiliated lobby (with several moles in the Department and the ear of the Minister) who intervened to have the policy advisor summarily dismissed from the Foreign Service for his audacious devotion to duty.

He was tricked out of an easily-won appeal of his "wrongful dismissal" by a false promise of reinstatement "as soon as the heat from the Jewish Lobby dies down" –on condition he not appeal nor seek outside assistance. Because of his well-founded suspicion of foreign intrigue, he contacted RCMP Security (and subsequently the Canadian Security Intelligence Service), only to find that they were "not interested". So ended his chosen career.

Betrayed, deceived and rebuffed, deserted by intimidated colleagues, but undaunted, he

searched for alternative opportunities in government and soon landed a job, in overseas project marketing, that suited his talents.

He brokered Canadian construction of a major luxury resort project at Cayo Sabinal, Cuba, by raising \$171 million in Canadian financing for the American sponsors but the project was stalled by the imposition of U.S. Sanctions.

After a decade of forming Canadian consortia and globe-trotting on their behalf in search of project opportunities, he again ran afoul of the Lobby and again was fired – this time for successfully negotiating major concessions and joint ventures agreements in Libya worth billions of dollars and a \$700 million agricultural project in Saudi Arabia, unprecedented accomplishments that were condemned and vetoed by his furious titular superiors as “contrary to instructions”.

Meanwhile, in his spare time, he founded different ventures including manufacturing vinyl-based dental plastics, opening a feldspar mine, establishing a downtown gallery in Ottawa, building Marrakesh, a lavish-decor Hollywood-theme restaurant, etc.

As a WWII veteran with rich diplomatic experiences and advanced news writing training at Wayne State University in Detroit and as an amateur historian, he was drawn to study the history of the war. He produced hundreds of iconoclastic treatises on WWII and Middle Eastern issues.

He wrote numerous published articles and was the subject of articles written by others on his outspoken patriotism and unflagging efforts to expose subversion and corruption in government.



In the spring of 1987, on behalf of the Government of Libya with which he had kept contact



since 1972 through Libya’s UN Ambassador, he recruited a 96 member Canadian delegation to an International Peace Gathering called by Col. Muammar Ghaddafi to commemorate the previous year’s U.S. attack on Tripoli and Bengazi, (above) in which the President’s two year daughter was killed.

The conference was infiltrated by Libya’s enemies intending to stage an “ugly incident” to discredit the proceedings, the main feature of the proposed incident to be the high-profile organizer of the Canadian delegation.

When Ian was able to evade the planned assassination thanks to a tip, the only journalist on the mission (the perceptive, insightful young Christoph Halens from the Ottawa Citizen, a graduate of the Carleton University School of Journalism eager to make his mark by covering the Conference) tragically became the alternative victim.

With the Libyan outrage in mind, the Ian vigorously petitioned the Commissioner of the RCMP, the Foreign Affairs Department and the Belgian Embassy to investigate the subsequent murder by Israel of Canadian scientist and inventor Dr Gerald Bull (who had contracted his services to the Government of Iraq) but without effect, despite the availability of the prime witness (Victor Ostrovsky, former Mossad agent) in Ottawa.

He continued to be the victim of attempts to impoverish him and otherwise dampen his spirit including death threats, none of which campaigns has been wholly successful, however disconcerting. Two of his houses were destroyed by arson, and a third seriously damaged.

He felt Canada had been betrayed again as cabalistic power-brokers and venal politicians trash our priceless British-French heritage and

compete to sacrifice the country's birthright and sovereignty for sordid political advantage and personal gain.

He feared that Canada today is no longer a respected, confident, homogeneous, independent, Christian union but is becoming increasingly a dispossessed, demoralized, turbulent, unstable, lobby-driven, multicultural, multiracial, Godless, leaderless, confused, disintegrating, Americanised polyglot, essentially without national character, without cohesion, without historical integrity, without pride and without common purpose.

He was an avid musician leading a dance band while at Queen's University, forming his own Swing band while living in South Africa, and playing trombone with various bands up until he was 92. He strived to make every minute count in all his varied endeavours, and he excelled at everything he did - as the Manager of the Queen's Brass and Pipe Bands, as the top-performance trade diplomat, as an ardent Ottawa heritage promoter, as an ambitious entrepreneur, as an insatiable writer and reader.

As an undaunted truth defender and great Canadian patriot, he remained true to his integrity and principles to the very end of his life.

Ian Macdonald wrote thousands of crisp, well documented letters-to-the-editor on forbidden topics like Zionist influence in public policy,

Canada's failed immigration policies and a reconsideration of Canada's role in WWII.

Almost none appeared in Canada's "free" press. They have been circulated on the Internet and many will appear as part of a book about to go to press just before Ian died. On January 14, 2010, the Canadian Association for Free Expression gave him a freedom award at a luncheon in Toronto, citing his "lifetime of dedication to freedom of speech and the preservation of our people."


Intellectually active to the end, Ian Macdonald practised Rudyard Kipling's advice to his son "to fill the unforgiving minute with sixty seconds worth of distance run."

Tributes have begun to pour in as people around the world learned of Ian's death. Among the first to arrive was from Mark Weber, Director of the Institute for Historical Review in Orange County, California: "I'm grateful to have known this extraordinarily curious, productive and compassionate man. I remember Ian most vividly from the unforgettable days in May 2012 when he and Lydia welcomed me, my wife and step-son as guests at his rambling, museum-like home in Ottawa. I remember well our wide-ranging conversations, and how much I appreciated what he told me about his tumultuous life."

## **The Race of Genesis 10 - 1**

**I**N THIS STUDY WE ARE GOING TO TRAVEL THE HISTORY OF THE PLANET ONCE. There are no second chances; one history; one Bible; one trek from the garden of Eden to the gathering of the Wheat.

If we do not find the foundations of our race in Genesis chapter 10, then our history, along with our Bible, is absolutely unreliable and we are mired in futility. We will begin oral explanations of Genesis 10 by quoting

Epictetus, copied from the opening pages of Thayer's Greek-English Lexicon of the New Testament:

**"the beginning of learning is the investigation of names."**

The chronology of the Greek Septuagint translation of the Bible may be more reliable than the Masoretic Text, and according to many (e.g. Adam Rutherford) from that source the date of the flood of Noah may be fixed around 345 B.C.



So Genesis 10 is a snapshot, a profile of those tribes from which our race (the White Race); the family of Noah (above), first blossomed in the first few centuries after the Deluge.

The cries of those ignorant ones that says race does not make a difference only show how profound that ignorance is with such a statement. For the Bible is about one race of people **Only** the White Race and not any of the other races or people on earth.



**1:** Now these are the generations of the sons of Noah, Shem, Ham, and Japheth: and unto them were sons born after the flood. Genesis 10:2-3


**2:** The sons of Japheth; Gomer, and Magog, and Madai, and Javan, and Tubal, and Meshech, and Tiras.

**3:** And the sons of Gomer; **Ashkenaz**, and Riphath, and Togarmah.

The historian Josephus made the mistake of associating Gomer with the Kelts, an error probably derived from an early Greek name for them, and many of his copyists have followed this same mistake, which is based solely upon this weak phonetic similarity.

That the Kelts sprang from a portion of the Children of Israel deported by the Assyrians (see *Missing Links Discovered in Assyrian Tablets*, by E. Raymond Capt) is evident from many factors, including their late (7th century B.C.) Appearance in history, their location today, and their role in early history in fulfilment of many of the prophecies concerning Israel.

However that discussion is beyond the scope of our purpose here. Simply note that the "Galatians" of Paul's epistle are Kelts, and Paul was writing to Israelites.

At this point, we will interrupt William (we are using many of his notes and are not using quotation marks because they are not necessary) for an interesting item found in *The Ancient World of the Celts*, by Peter Berresford Ellis. While Ellis is a profound researcher and author of many books on the subject, he is blind to the truth that the Celts were Israelites. On page 5 he states:

"I find that it is not stretching the imagination to suggest that when the Greek merchants first started to encounter the Celtic peoples and asked them who they were, the Celts simply replied. 'The hidden people;' that is, to Greek ears, Keltol."

That should immediately set off a signal in our minds, as Psalm 83:3 should instantly be recalled which says:

"They have taken crafty counsel against thy people, and consulted against thy **Hidden Ones.**"

While the Kelts had the veil of darkness over them by Yahweh, at least they understood they were "hidden," and informed the Greeks in an allegorical statement to that fact. This comment by the Kelts is simply amazing we think.

Now, back to Bill: By contrast, in Ezekiel 38,

Gomer is allied with those in opposition to the Children of Israel, which makes it easy to accept the statement which A. Koestler, on page 72 of his book *The Thirteenth Tribe* (bear in mind that Koestler, a "Jew," writes from a "Jewish" perspective) claims that Togarmah, Gomer's son, is the common ancestor of the Uigur, Dursu, Avars, Huns, Basili, Tarniakh, Khazars, Zagora, Bulgars and Sabir.

Surely the Biblical prophecies indicate that Gomer's descendants are to be found among the Asiatic hordes of this age.

### **The Race of Genesis 10 - 2**



### **In The History of The Jewish Khazars:**

"...Our first question here is, when did the Khazars and the Khazar name appear?"

There has been considerable discussion as to the relation of the Khazars to the Huns on the one hand and to the West Turks on the other. The prevalent opinion has for some time been that the Khazars emerged from the West Turkish empire.

"Early references to the Khazars appear about the time when the West Turks cease to be mentioned. Thus they are reported to have joined forces with the Greek Emperor Heraclius against the Persians in A.D. 627 and to have materially assisted him in the siege of Tiflis. it is a question whether the Khazars were at this time under West Turk supremacy.

"A similar discussion on the merits of the different races is reported from the days before Muhammad, in which the speakers are the Arab Nu'man ibn-al-Mudhir of al-Hirah and Khusraw

Anushirwan.

The Persian gives his opinion that the Greeks, Indians, and Chinese are superior to the Arabs and so also, in spite of their low material standards of life, the Turks and the Khazars, who at least possess an organization under their kings. Here again the Khazars are juxtaposed with the great nations of the east.

"It is consonant with this that tales were told of how ambassadors from the Chinese, the Turks, and the Khazars were constantly at Khusraw's gate, Tabari, i, 899.

According to ibn-Khurdadhbih, persons wishing access to the Persian court from the country of the Khazars and the Alans were detained at Bab al-Abwab (B.G.A. vi, 135) and even that he kept three thrones of gold in his palace, which were never removed and on which none sat, reserved for the kings of Byzantium, China and the Khazars.



### The Byzantium Empire

"In general, the material in the Arabic and Persian writers with regard to the Khazars in early times falls roughly into three groups, centring respectively round the names of (a) one or other of the Hebrew patriarchs, (b) Alexander the Great, and (c) certain of the Sassanid kings, especially, Anushirwan and his immediate successors.

"A typical story of the first group is given by Ya'qubi in his History. After the confusion of tongues at Babel (Genesis 10:18; 11:19); the descendants of Noah came to Peleg (Genesis 10:25; 11:16-19; 1 Chronicles 1:19; 1:25), son of Eber (Genesis 10:21; 10:24-25; 11:14-17; Numbers 24:24; 1 Chronicles 1:18-19; 1:25; 8:12; Nehemiah 12:20), and asked him to divide (Genesis 10:5; 10:25; 10:32; Exodus 14:21; Deuteronomy 4:19;

32:8; 1 Chronicles 1:19) the earth among them.

"He apportioned to the descendants of Japheth (Genesis 5:32; 6:10; 7:13; 9:18; 9:23; 9:27; 10:1-2; 10:21; 1 Chronicles 1:4-5) - China, Hind, Sind, the country of the Turks and that of the Khazars, as well as Tibet, the country of the (Volga) Bulgars, Daylam, and the country neighbouring on Khurasan. In another passage Ya'qubi gives a kind of sequel to this.

"Peleg (Genesis 10:25; 11:16-19; 1 Chronicles 1:19; 1:25) having divided the earth in this fashion (Deuteronomy 32:8), the descendants of 'Amur ibn-Tubal (Genesis 10:2; 1 Chronicles 1:5; Isaiah 66:19; Ezekiel 27:13; 32:26; 38:2-3; 39:1), a son of Japheth, went out to the northeast.

"One group, the descendants of Togarmah (Genesis 10:2; 1 Chronicles 1:5; Isaiah 66:19; Ezekiel 27:13; 32:26; 38:2-3; 39:1, proceeding farther north, were scattered in different countries and became a number of kingdoms, among them the Burjan (Bulgars), Alans, Khazars (Genesis 10:3; 1 Chronicles 1:6; Ezekiel 27:14; 38:6), and Armenians.

"Similarly, according to Tabari, there were born to Japheth Jim-r the Biblical Gomer (Genesis 10:2-3; 1 Chronicles 1:5-6; Ezekiel 38:6; Hosea 1:3), Maw'-' (read Mawgh-gh), Magog (Genesis 10:2; 1 Chronicles 1:5; Ezekiel 38:2; 39:6; Revelation 20:8), Mawday Madai (Genesis 10:2; 1 Chronicles 1:5), Yawan (Javan) (Genesis 10:2; 10:4; 1 Chronicles 1:5; 1:7; Isaiah 66:19; Ezekiel 27:13; 27:19), Thubal (Tubal), Mash-j (read Mash-kh), Meshech (Genesis 10:2; 1 Chronicles 1:15; 1:17; Ezekiel 27:13; 32:26; 38:2-3; 39:1) and Tir-sh (Tiras).

(Genesis 10:2; 1 Chronicles 1:5) Of the descendants of the last were the Turks and the Khazars (Ashkenaz).

"There is possibly an association here with the Turgesh, survivors of the West Turks, who were defeated by the Arabs in 119/737, (H.A.R. Gibb, Arab Conquests in Central Asia, London 1923, 83ff. Cf. Chapter IV, n. 96) and disappeared as a ruling group in the same century.

Tabari says curiously that of the descendants of Mawgh-gh (Magog) were Yajuj and Majuj, adding that these are to the east of the Turks and Khazars. This information would invalidate Zeki Validi's attempt to identify Gog and Magog in the Arabic writers with the Norwegians.

"The name Mash-kh (Meshech) is regarded by him as probably a singular to the classical Massagetai (Massag-et). A Bashmakov emphasizes the connection of 'Meshech' with the Khazars, to establish his theory of the Khazars, not as Turks from inner Asia, but what he calls a Jephetic or Alarodian group from south of the Caucasus.



"Evidently there is no stereotyped form of this legendary relationship of the Khazars to Japheth. The Taj-al-Artis says that according to some they are the descendants of Kash-h (? Mash-h or Mash-kh, for Meshech), son of Japheth, and according to others both the Khazars and the Saqalibah are sprung from Thubal (Tubal).

Further, we read of Balanjar ibn-Japheth in ibn-al-Faqih and abu-al-Fida' as the founder of the town of Balanjar. Usage leads one to suppose that this is equivalent to giving Balanjar a separate racial identity. In historical times Balanjar was a well-known Khazar centre, which is even mentioned by Masudi as their capital.

"It is hardly necessary to cite more of these Japheth stories. Their Jewish origin is priori obvious, and Poliak has drawn attention to one version of the division of the earth, where the Hebrew words for 'north' and 'south' actually appear in the Arabic text.

The Iranian cycle of legend had a similar tradition, according to which the hero Afridun divided the earth among his sons, Tuj (sometimes Tur, the eponym of Turan), Salm, and Iraj.

"Here the Khazars appear with the Turks and the Chinese in the portion assigned to Tuj, the eldest son. Some of the stories connect the Khazars with Abraham. The tale of a meeting in Khurasan between the sons of Keturah (Genesis 25:1; 25:4; 1 Chronicles 1:32-33) and the Khazars

journey to the Uigurs, but it goes back to Hishim al-Kalbi. Zeki Validi is inclined to lay some stress on it as a real indication of the presence of the Khazars in this region at an early date.

"Al-Jahiz similarly refers to the legend of the sons of Abraham and Keturah settling in Khurasan but does not mention the Khazars.

Al-Di-mashqi says that according to one tradition the Turks were the children of Abraham by Keturah, whose father belonged to the original Arab stock. Descendants of other sons of Abraham, namely the Soghdians and the Kirgiz, were also said to live beyond the Oxus..."

## And the Sky Fell, and No One Listened, and All Was Still Arthur Firstenberg



Texel Island, Early June 2022

**A**ND THE SKY FELL, and no one listened, and all was still.

A scholarly literature search for “electromagnetic” plus “biological effects” produces the astonishing number of 76,400 studies, more studies than for most other environmental threats, yet the world continues on, looking yet blind, listening yet deaf, mistaking silence for comfort, the advancing flames for a bright future.

On the Dutch island of Texel, being the south end of a line of islands separating the Wadden Sea from the North Sea, a large breeding colony of seabirds called Sandwich terns (“great terns” in Dutch) made headline news last month by dying. Of the 7,000 birds nesting in the De Petten nature reserve until the end of May, none were left by the middle of June. 3,000 avian corpses were collected, and the rest either died or abandoned their nests.

The correspondent who sent me this news, Antonia in the Netherlands, also sent me to a Dutch website that monitors all cell towers and

antennas throughout the country. The tern catastrophe was being blamed on “bird flu” and she suspected something else might be going on. When I looked at the website I was floored. The first 35 dead terns at De Petten were found on May 29, 2022.

There are three cell towers on the edge of the reserve, and actually in the territory which the terns inhabit. According to the website, 18 new 4G antennas had just been added to those towers — 6 by Vodafone to its 83-foot tower on May 25, 2022, and 12 by KPN to its 108-foot tower on May 29, 2022. The number of frequencies emitted by those two towers had increased overnight from 5 to 11.

In addition to having all those antennas right at the reserve, De Petten is located on the northern edge of a waterway that separates the North Sea from the Wadden Sea, and a large number of antennas on both sides of that waterway — the antennas in Den Helden to the south and the antennas on Texel to the north — are aimed at that busy waterway, which is intensely used by the ships that continually pass through it.

Consequently, according to my research, there are a total of 105 4G antennas within 7 miles of De Petten that are aimed directly at it. Were Texel’s Sandwich terns already in bad shape from all the radiation they had been exposed to in the last few years? And did the sudden increase in both the number of antennas and the number of frequencies finally kill them?

I decided to investigate further. What I have discovered, both in the Netherlands and elsewhere, is consistent but not simple. Here are some rough rules:

(a) A sudden dramatic increase in the number of antennas and frequencies whose source is within a breeding colony or on its border is lethal. Nesting birds cannot avoid the radiation; they must either abandon their nests or die.

(b) The effect of antennas aimed at a breeding colony from a distance depends on the human population. In a sparsely populated region, the antennas emit little radiation and few frequencies because few people are using them. By contrast, cell towers located in major ports are heavily used, both by residents and ships, and emit maximal radiation. The same is true of antennas aimed at heavily used shipping lanes.

(c) Distance does not matter as much as terrain and tower height. The radiation from a taller tower travels further. And when there is nothing but water between the tower and the bird colony, the water reflects and amplifies the signal and distance matters very little.

(d) 4G towers are generally worse than 5G towers. This is because 4G towers broadcast their radiation in all directions while 5G towers emit most of their radiation in focused beams, aimed directly at people holding 5G phones in their hands.

With these rules in mind, let us look at a few other breeding colonies of Sandwich terns and see what has happened to them this year:

Another large breeding colony of Sandwich terns made headlines a bit later, and for the same reason: the one at Waterdunen, at the opposite end of the Netherlands, in Zeeland province.

Like De Petten, the Waterdunen nature reserve is located on a busy shipping lane at the entrance to a busy port. The largest colony of these birds in the Netherlands, Waterdunen hosted 7,000 pairs of terns that flew up from Africa to breed there this spring. But on June 24, 2022, it was reported that 4,600 dead adult and young Sandwich terns had been collected there during the previous two weeks.

By the end of June, this colony no longer existed either. The nature reserve at Waterdunen has 318

heavily-used 4G antennas aimed in its direction from distances of from 0.5 to 8 miles. Most of these emit between 1,000 and 2,000 watts of radiation each. 46 of these antennas are new, having been added to existing towers in April, May and June 2022.



### Waterdunen

One 55-foot tower less than 2 miles down the beach from Waterdunen was upgraded on May 18, 2022 from 6 antennas to 12 and from 2 frequencies to 4. Another, 40-foot tower in the same location was upgraded on June 22, 2022 from 6 antennas to 18 and from 2 frequencies to 6. As Sandwich terns live on fish, that tower is within the foraging area for that colony.

Did the same thing happen to all nesting Sandwich terns in the Netherlands? No. Just 20 miles from Waterdunen was a small, healthy colony of terns at a nature reserve called Yerseke Moer. And from April to July, i.e. throughout the 2022 nesting season, this colony thrived and no dead birds were found there. Unlike De Petten and Waterdunen, this reserve is located in a relatively isolated place, is not near a major port and is not on a shipping lane. A total of 35 4G antennas are aimed at this reserve from distances of up to 8 miles. Only two of those antennas have been added since April.

Likewise in France, two very large colonies of terns had two completely different experiences. At the Platier d'Oye nature reserve near the port of Calais, a colony of 3,000 Sandwich terns began nesting in April.

The first 100 dead birds were discovered on May 20, and within a few weeks the colony was almost completely wiped out. The situation at Platier d'Oye is similar to that further north in

Texel: dozens of new 4G and 5G antennas were added near the reserve during the months of May and June. 3 new 4G antennas and 6 new 5G antennas were added to an existing 90-foot cell tower bordering the reserve.

Another 6 new 4G antennas and 6 new 5G antennas were added to an existing 140-foot tower about two miles to the southeast. Another 6 new 4G antennas and 6 new 5G antennas were added to an existing 95-foot tower about two miles to the east. At this writing there are the astounding number of 355 antennas of all kinds on 26 towers at 13 locations ranging from 10 feet tall to 255 feet tall within about 4 miles of this nature reserve.

An even larger colony — the largest breeding colony of Sandwich terns in France — had no disease during the 2022 breeding season. It is called the Polder de Sébastopol and was host to several thousand pairs of nesting birds. But like Yerseke Moer, it is on an isolated island with few human residents. The island's land area is largely devoted to parks, nature reserves and visitor accommodations.

None of the antennas on the two cell towers a half mile west of the Polder are aimed at it. And even though there are a large number of antennas between one and four miles away that are aimed directly at the Polder, no ships pass by offshore and those antennas are little used except by visitors to the reserve walking its trails.

Looking at the details and different experiences at particular breeding colonies of these birds, the official story breaks down. How can one make sense of the extermination of so many of these birds in a matter of a few weeks in such widely scattered places?

According to the bird conservation organizations, bird flu is so contagious that it spreads among Sandwich terns all over Europe in a matter of days, yet it is so non-contagious that a small colony of terns 20 miles away escapes scot-free. Bird flu travels from one end of the Netherlands to the other in a few days, but not between two Dutch colonies 20 miles apart, and not between the two largest colonies in France?

Apparently the conservation organizations also do not think it strange that suddenly and for the

first time ever, in 2022, bird flu is (a) killing Sandwich terns and (b) is occurring during their breeding season.



In decades of monitoring them, bird flu has never affected Sandwich terns (above) before anywhere in the world. And it has always been a seasonal disease, occurring only in autumn and winter, and has never before affected any types of wild birds in spring and summer until 2022.

It has also never affected so many different kinds of wild birds at once terns, seagulls, avocets, gannets, skuas, guillemots, puffins, oyster catchers, ducks, geese, godwits, pheasants, magpies, sanderlings, storks, cranes, pelicans, herons, swans, loons, sparrows, pigeons, red-winged blackbirds, owls, cormorants, grebes, dunlins, crows, ravens, bald eagles, hawks, falcons, vultures.

Both the bird organizations and the authorities are reacting reflexively by wearing masks and hazmat suits when they visit these colonies and handle dead birds. But they should begin questioning the cause of such an unprecedented catastrophe.

There is no doubt that sick birds have tested positive for a virus called H5N1. But when every testing laboratory is constantly amplifying fragments of that virus in untold numbers of PCR tests, one has to suspect that the walls, floors, air, equipment, and personnel in the testing laboratories are contaminated with this virus.

When one remembers that samples from a goat, a quail and a papaya, sent to the National Health Laboratory of Tanzania, all came back positive for COVID-19, the results of PCR tests, whether for people, birds, or fruit, should be regarded with caution. Yes, both birds and people are getting sick and dying, but there is another

obvious factor that is being ignored. The tendency to blame all illness on microorganisms is destroying our world.

It is the uncontrolled irradiation of our world that is killing us and wiping out all the birds. Both 4G and 5G antennas are being erected more quickly and in greater numbers than ever before, not only on land but even on the surface of the sea.



Wherever there are offshore wind farms, the cell phone companies are placing cell towers on those platforms. Seabirds will soon not only have no place to lay their eggs and raise their young, but they will not even be able to hunt for their food and feed their young without being irradiated. The largest company building cell towers on the surface of the sea is called Tampnet. [Here](#) is a map of all their towers and their coverage areas in the North Sea and the Gulf of Mexico:

In 1918, at the very height of the Spanish influenza, attempts by medical teams in Boston and San Francisco to demonstrate the contagious nature of the flu met with complete and resounding failure.

They collected mucous secretions from the mouths, noses, throats, and bronchi of sick flu patients in various stages of the disease and transferred these secretions to the noses, throats, and eyes of hundreds of healthy volunteers.

They injected blood from sick flu patients into healthy volunteers. The had healthy volunteers sit nose to nose with severely ill flu patients while they spoke to each other and then the patient coughed five times directly in the face of the volunteer. None of the volunteers got sick in any way. These experiments were published in the Journal of the American Medical

Association, the Boston Medical and Surgical Journal, and Public Health Reports.


Horses also came down with influenza, and similar failure attended attempts to transfer influenza from one horse to another. As a result of these experiments, Lieutenant Colonel Herbert Watkins-Pitchford wrote that he could find no evidence that influenza was ever spread directly from one horse to another.

Many are the scientists, over the years, who have observed that influenza, whether in humans, horses, birds, or pigs, is an exceedingly strange disease. No one has ever explained why the flu is seasonal, for example. Or why flu epidemics end. Or why out-of-season epidemics do not spread. Or why flu epidemics explode over whole countries at once, and disappear just as miraculously, as if suddenly prohibited.

Or how human influenza can spread around the world in days, and has always done so, even centuries ago when neither air-planes, automobiles, railroads, nor steamships existed. At least 23 scientists over the years, including Richard Shope, the scientist who first identified the flu virus in 1931, have published papers questioning the contagious nature of the flu and/or suggesting an electrical cause for it.

Chapters 7, 8 and 9 of my critically important book, *The Invisible Rainbow: A History of Electricity and Life*, are devoted to a complete, detailed examination of the history and science of influenza. Chapter 16, the longest chapter in the book, is devoted in part to the effects of electromagnetic radiation on birds. ## The Venetian Conspiracy (Part 2)

**M**OST TYPICAL OF THE VENETIAN SYSTEM IS THE COUNCIL OF TEN, established in 1310 as the coordinating body for foreign and domestic political intelligence operations. Meeting in secret session together with the doge and his six advisors, the Ten had the power to issue a bill of capital attainder against any person inside Venetian jurisdiction, or abroad. If in Venice, that person was generally strangled the same night and the body thrown into the Canale degli Orfani.

The Ten had at their disposal a very extensive foreign intelligence network, but it was inside Venetian territory that their surveillance powers became pervasive: the contents of any discussion among oligarchs or citizens was routinely known to the Ten within twenty- four hours or less, thanks to the ubiquity of its informers and spies.

Visitors to the Doge's Palace today can see mail slots around the outside of the building in the shape of lion's mouths marked Per Denontie Segrete ("For Secret Denunciations") for those who wished to call to the attention of the Ten and their monstrous bureaucracy individuals stealing from the state or otherwise violating the law.

Death sentences from the Ten were without appeal, and their proceedings were never made public. Offenders simply disappeared from view.

The Venetian regime is a perverse example of the "checks and balances" theory of statecraft, and there were indeed a myriad of such feedback mechanisms.

The Savii Grandi balanced the powers of the doge, who was also checked by his six advisors, while more and more power passed to the state inquisitors and the chiefs of the Ten.

The state attorneys acted as watchdogs on most matters, as did the Senate, and in times of crises the Gran Consiglio would also assert its powers. The Ten were constantly lurking in the background.

Almost all officials except the doge were elected for terms averaging between six months and one year, with stringent provision against being reelected to an office until a number of months had passed equal to the oligarch's previous tenure in that post. This meant that leading oligarchs were constantly being rotated and shunted from one stop on the Cursus Honorum to another: to Savio Grande to ducal advisor to state inquisitor and so forth.

There was no continuity of the population of Venice; the continuity was located only in the oligarchy. In fact, the population of the city seemed unable to reproduce itself. Venice suffered astronomical rates of mortality from malaria and the plague – its canals, it must be remembered, were first and foremost its sewer system.

The decimated natives were continually replenished by waves of immigration, so much so that the Frenchman Philippe de Comynes, an adversary of Machiavelli, could report that the population was mostly foreigners.

Internal order was entrusted to an intricate system of local control in each of the city's sixty parishes, meshing with an elaborate apparatus of corporatist guilds called the Scuole. This was supplemented by an unending parade of festivals, spectacles, and carnivals. Very few troops were usually stationed in the city.

So much for the phenomena. Reality was located in the fact that an elite of ten to fifteen families out of the one hundred fifty effectively ruled with an iron hand.

Various Venetian diarists let the cat out of the bag in their descriptions of corruption and vote-buying, especially the bribery of the impoverished decadent nobility, called Barnabotti, who were increasingly numerous in the Gran Consiglio. The regime ran everything, and offices of all types were routinely sold.

This reality of graft was also known to Dante. The poetical geometry of Canto 21 of the Inferno, the canto of the grafters or Barattieri, is established by a reference to the Venetian Arsenal and the pitch used to caulk the hulls of the galleys:

**As in the Arsenal of the Venetians  
Boils in the winter the tenacious pitch  
To smear their leaky vessels over again,  
For sail they cannot.**

The souls of the grafters are immersed in the boiling pitch, where they are guarded by the Malebranche, grotesque winged monsters armed with spears and hooks: a fitting allegory for the souls of the Venetians.

Dante visited Venice in 1321, acting in his capacity as diplomatic representative of the nearby city of Ravenna, whose overlord was for a time his protector. He died shortly after leaving Venice.

The two explanations of his death converge on murder: one version state that he was denied a boat in which to travel south across the lagoon. He was forced to follow a path through the swamps, caught malaria, and died.

Another version says that a boat was available, but that to board it would have meant certain assassination. Venetian records regarding this matter have conveniently disappeared.

### **Petrarch Versus Aristotle**

The Venetian method of statecraft is based on Aristotle – the deepest Aristotelian tradition in the West. Long before the era of Albertus Magnus (1193-1280) and St. Thomas Aquinas (1225-1274), Venice had established itself as

the chief centre for the translation and teaching of Aristotle's works.

In the year 1135, the Senate sent Giacomo da Venezia to Byzantium, where he was trained in post-Justinian Aristotelian orthodoxy, returning to Venice after two years to begin lectures on Aristotle and to prepare Latin versions of the Greek texts he had brought back with him.



### **Padua Italy**

A school of Aristotelian doctrine was set up at the Rialto market, the heart of the business and commercial activity of the city. When Venice conquered Padua at the beginning of the fifteenth century, Aristotelian hegemony was imposed on the University of Padua, which became the only one where Venetian nobility were allowed international clientele, especially from Germany.

The inveterate Aristotelianism of Venice is the starting point for a major literary attack on that city by Francesco Petrararch, son of Dante's personal secretary, who took up the responsibility of servicing Dante's humanist networks during the disastrous years around the middle of the fourteenth century.

Although these were the years of the Black Death, Petrararch ("Fraunces Petrak the laureate poet" as Chaucer knew him) was the soul of a tenacious humanist rearguard action, with spirited counterattacks at every opportunity, that made the later Italian Renaissance possible.

Petrarch was a contemporary of the Ciompi revolt against oligarchical rule in Florence; he was certainly involved in Cola di Rienzo's seizure of power in Rome in May, 1347. The real story of Petrararch's literary and political

achievements has yet to be told. Nonetheless, the fact that he was a determined foe of Venice and its ideology is abundantly clear.

In 1355 Venice had just passed through one of its infrequent internal crises, usually explained as the attempt of the Doge Marin Faliero to overthrow the regime and establish a Signoria, or personal dictatorship, of the type common in Italy at the time. Marin Faliero was publicly decapitated by the Council of Ten.


Petrarch might have had a hand in this operation; during this period he was a frequent guest at the court of the Da Carrara rulers of Padua, about thirty kilometres from the Venetian lagoon.

Petrarch may have developed plans for injecting a dose of Platonism into the intellectual life of the Serenissima. Petrarch proposed that he be allowed to take up residence in Venice and locate his library there; the books would remain as a bequest to the city after his death, forming the nucleus of what would have been the first public library in Europe. The Venice authorities accepted, and Petrarch, the most celebrated intellectual of his times, took up his residence on the Riva degli Schiavoni.

Soon he began to receive the visits of four Venetian Aristotelians, whom he later referred to as “my four famous friends.” These four oligarchs were Tommaso Talenti, Guido da Bagnolo, Leonardo Dandolo, and Zaccaria Conatarini, the latter two of the most exalted lineage. After several discussions with Petrarch, these four began to circulate the slander that Petrarch was “a good man, but without any education.”

Petrarch shortly abandoned the library project and soon thereafter left Venice permanently. His answer to the slanderers is contained in his treatise “De Sui Ipsius et Multorum Ignorantia” (1367) (with a swipe at Aristotle in the title), his most powerful piece of invective- polemical writing.

Petrarch scored Aristotelian scholastic philosophy as “a prostitute who delights to worry about vain questions of words.” Real philosophy, with the clear purpose of advancing morality, he said, is to be found in St. Augustine. All that Aristotle is capable of doing is providing a delphic description of what the external at




tributes of morality might look like. To the authority of Aristotle, (left) Petrarch counter posed the Platonism of the New Testament, saying

that Christ, not Aristotle, was for him the decisive guide. His “four friends,” he asserted, were not Christian, but preferred to follow their favourite philosopher in their sophistry, blasphemy, and impiety. They mocked Christ, and were so pretentious that they could not even understand their own arguments.

Petrarch pointed out that Aristotle provided his followers with all sorts of strange and curious lore, like the number of hairs on a lion’s head or of feathers in a hawk’s tail, how elephants copulate backwards, how the phoenix arises out of his own ashes, how the only animal that can move its upper jaw is the crocodile.

But these facts are not only useless, he said, they are false. “How could Aristotle know such facts, since neither reason nor experience reveal them? Concerning the ultimate objects of philosophy, Aristotle is more ignorant than an old peasant woman.






