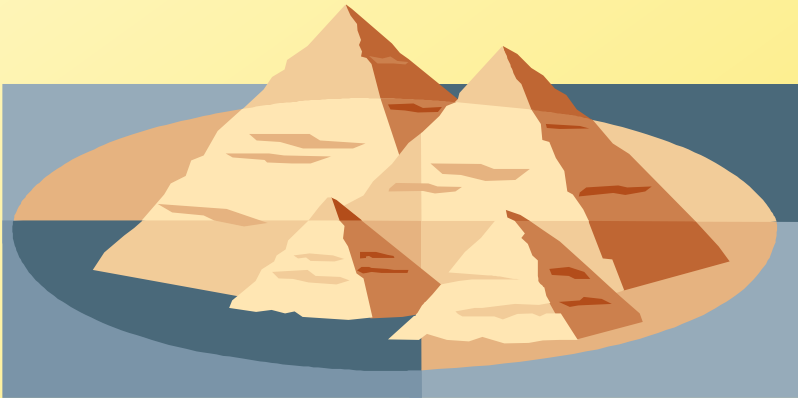

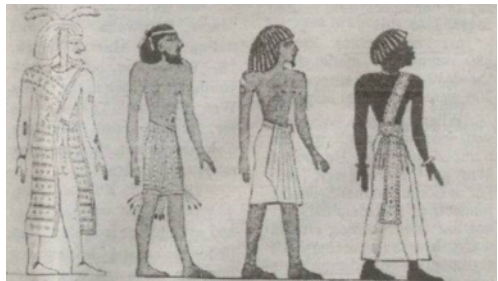

Whites built the Great Pyramid in 2,600BC. It was 481 feet high, as tall as a 40 story skyscraper covering 13 acres of land. It took 20 years to construct and consists of 2.3 million blocks of stone weighing 2.5 tons each. The mongrelized people of Egypt today

could not build such a monument.

The Egyptians were very race conscious as seen here from this depiction of an ancient monument. From left, the blonde leader, next the Semitic Arab, then the mulatto with Semitic and Negro features and finally the pure Negro. Note that they knew that the Negro cannot grow a beard!



Egypt was the world's greatest civilization and it lasted for 4,000 years - longer than any other. It came into existence in 4,500 B.C. It developed along the fertile Nile river delta and was bounded by the Mediterranean Sea, on the East by the Red Sea and on the West and South by the Sahara Desert. It was isolated and made up of Whites who had migrated down from Phoenicia, in central Iraq, where the first civilization began. This safe-guarded them for many centuries from Negro and Asiatic infiltration. They were able to develop the sciences of writing, mathematics, archaeology, astronomy, etc.

This is attested to by the famous anthropologist, Dr. A.L. Kroeber, who stated:

***"The laying of the foundation of modern civilization along the Nile and the Euphrates some 7,000 years ago belongs to the credit of the White race."***

Those original White Egyptians maintained their racial purity to a very high degree for an amazing 27 centuries. This was due to their lack of any direct contact with the Negro Nubians immediately to their South. Their civilization reached its peak between 1,800 BC and 3,400 BC when they built their world famous pyramids and temples. To this very day these amazing examples of architecture are evidence of a very high order of mathematical and engineering skills and craftsmanship which reached a perfection surpassing many such instances down through this day and age. They also developed their medial science to an amazing degree. Their knowledge of law was extensive and their administrative capacity enabled them to govern themselves and their empire. Their methods employed to administer provinces very closely resemble those established to govern our individual states today.

It was during the latter centuries of progress, creative accomplishments and enlightenment that the Egyptians were making disastrous basic errors. They would one day accumulate into a single great factor which was directly responsible for their decay and eventual destruction. That single great factor came with the intermingling of the black and White

racess. This is the very same basic error which has been occurring in America since the end of the Civil War.

### **How Racial Integration Came To Egypt**

It was approximately 3,400 BC when the Egyptian civilization began to spread slowly southward up the Nile River. This was their only connection with inner Africa. The Negro tribes on the northern fringe of Nubia began to launch raids into Egyptian territory and had to be conquered by the Egyptian army. As a result of these conquests Nubian, (Negroes), were brought back to Egypt as slaves. As time passed and the need for additional soldiers grew, some Negro slaves were accepted into the army.

The Egyptians called them "Mercenaries" and that word is used today for hired fighters whose loyalty is only to money. They were widely used during the reign of Pepi I about 2,325 BC.

Amenhotep III, (Pharaoh), went to war with Ethiopia, not for land acquisition, but to capture docile slaves who were considered highly valuable. Historian Rawlinson writes:

***"The black races have always been especially sought after for this purpose and were in great demand in the Egyptian slave markets."***

**Egyptian historian, Samuel Sharpe states:**

***"There are carvings and paintings on the wall of Memmonium at Abydos that record the victories of Ramesis 17 over Negroes and Ethiopians and how they were brought back to Egypt."***

In time, the Negro slaves became emancipated and interbreeding began to take its toll on the White population. The color of the general population began to change. The Egyptians had no segregation or miscegenation laws and were taken by surprise as interracial sex produced a new kind of Egyptian. At the same time intermarriage, while not outlawed, was strongly discouraged among the upper classes. By keeping their blood

lines relatively pure the Egyptian civilization was able to continue under their enlightened rule.

### **One Pharaoh Tried To Save Egypt**

Pharaoh Sesostrie III, (1878 - 1840 BC), ordered the importation of Negro slaves halted during his reign. He built fortresses on both sides of the Nile at the Second Cataract, on the Southern boundary of Egypt. To this day one can still see an inscription on a stone slab with his command:

***"By will of his majesty the King of upper and lower Egypt, Sesostrie III, this is an order to prevent any Negro from crossing by water or by land, except a Negro who shall come to do trading in Ikan, or with a commission. Every good thing shall be done with and for them, but without allowing a ship of Negroes to pass by Heh, the Southern boundary, going down stream forever!"***

Several similar proclamations were inscribed at several other points along the Nile emphasizing his stand banning any further African immigration. After the death of Sesostrie III, the Egyptian state began to collapse from within. Historian, John A. Wilson, in his book, "The Burden of Egypt," writes:

***"There is evidence that restless movements were penetrating Egypt upsetting the orderly prosperity of the past. In Africa there was the slow and filtered northern pressure of the Negroes."***

As interracial mating reduced the White population to mulattoes, quadroons, and octoroons, all progress, law and order, the building of structures of any kind, exploration, conquests, etc., came to a halt. A record has been found of the Hyksos King, Kamose, who in a discussion with his nobles is recorded as stating:

***"Let me understand what this strength of ours is for. One prince is in Avaris, another is in Ethiopia, and here I sit in association with an Asiatic and a Negro."***

**When the Romans proceeded against Egypt to capture Anthony and Cleopatra, her army fled. The pair were left to their own fate.**

**To this very day the non-White nation of Egypt has no power and receives the second highest amount of foreign aid from the U.S. - after Israel!**

**How Mongrelisation Came To South America

**South America's Decline**

"South America's original civilization was built by the Spanish and Portuguese. However, they interbred with Indians to create a Mestizo mixed race. Today, they constitute 90% of the population. To exist, they are dependent upon foreign investment and management.

Senor Pezet, Foreign Minister of Peru, stated in 1913, "You Americans form an unmixed mass. Your ancestors came to pioneer and brought their families with them.

The Spaniards took upon themselves Indian women creating a mixed race. This was not frowned upon by the haughty Spanish monarchy. On the contrary, they considered it the best possible means of establishing a uniform race."

### **Influx of Negro Slaves**

"The coming of the Negro slaves to South America were next incorporated into this new "*uniform race*."

"Some 642,000 Negro slaves were brought to Brazil before 1903 and several hundred thousands to Mexico. They have interbred to the point that pure Negroes no longer exist in South America. History shows a steady rise of the mixed-breed to political power.

**"As the White influence becomes less and less their society decays and will eventually collapse."**
