The Origin of Talmudism (Part 3)

THE HISTORY of the House of Judah from 430 B.C. down to the time of Christ is divided into four periods:

translator is a good example of not keeping distinctions clear. The English word 'Jew' did not come into existence until a much later time in history (1600's) when the confusion of the terms 'Judean' and 'Judahite' by various historians had become commonplace.

The Persian Period, 430 to 332.

The Greek Period, 331 to 167.

The Maccabean Period, 166 to 63.

The Roman Period, 63 to Christ and after.

Continuing now with Josephus:

The German word 'Jude' is subject to the same problems. The Samaritans, as pretend Judahites, were simply perceived by outsiders to be Judeans. These outsiders did not make any distinctions between Edomites, Judahites and their mixed offspring.

Chapter 8 relates how the Syrians were defeated by Alexander the Great and how the Judahites concluded an alliance with him. Relevant to our documentation of the genealogical history of these Judahites is a statement concerning the Samaritans, a group of Syrians who lived just north of Judea: "the Samaritans —seeing that Alexander had greatly honoured the Jews [sic], determined to profess themselves Jews; for such is the disposition of the Samaritans, as we have already elsewhere declared, that when the Jews [Judahites] are in adversity they deny that they are of kin to them, and then they confess the truth; but when they perceive that some good fortune hath befallen them they immediately pretend to have communion with them, saying, that they belong to them, and derive their genealogy from the posterity of Joseph, Ephraim, and Manasseh ."

Nor did they understand the differences between the Mosaic Law and Pharisaic "law." Josephus is telling us that the Samaritans claimed to be Judahites when and if there was political gain to be made therefrom. Many of these same Samaritans eventually were absorbed into Jewry, although their origin is most likely that of half-breed Israelites of the tribe of Joseph.

Note that Josephus is declaring that the Samaritans were prone to impersonating Judah when it was politically expedient to do so. This type of Jewish duplicity is evident to us today as well, for in America they fervently praise the "separation of church and state" while in Israel, they are Jewish despots practicing a Jewish theocracy.

Even at this point in time, the Judahites referred to themselves as "Judah", not as Judeans. A good modern parallel is the word 'German' which is used exclusively by outsiders to refer to the German people, who refer to themselves as 'Deutsch,' a word derived from 'Teuton.' The Greek word 'Ioudaios', meaning Judean, is incorrectly translated as meaning Jew, for the word 'Jew' implies a different meaning than would either 'Judean' or 'Judahite.'

Here in the story of the Samaritans we get another clue as to how the impostor group is coming into being. Again, the use of the word 'Jew' for both 'Judahite' and 'Judean' by the

W. G. Finlay, late editor of the periodical, The Covenant Message, has this to say regarding this great impersonation: "According to Josephus Antiquities of the Jews the name 'Jew' first came into existence with what is generally called 'the return from the Babylonian captivity (actually, Josephus doesn't say that; his translators do!)— I find it very significant that prior to this time, the word 'Jew' was unknown.

Why, in the Masoretic text which is a Jewish work is there no reference to 'Abraham the Jew' or 'Moses the Jew'? This surely tells us something but so few are prepared to open their eyes and see the depth of the masquerade which

is having such a disastrous effect on the TRUE Israel people."

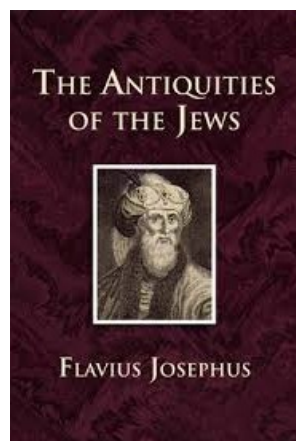
W. N. Saxon, in his booklet, "*The Mask of Edom*", says, "Judaism's masquerade as Biblical Judah and, moreover, as all Israel which is the basis of Jewish Nationalism becomes patently counterfeit when placed in juxtaposition with the historical record of the true Houses of Israel and Judah.

Even a brief summary will show the contrast between the descendants of Biblical Jacob-Israel as opposed to the alien posterity of the cabal which claims for itself not only the Promised Land but the very name and inheritance of Israel ." p. 8.

Envy by the Canaanites over the Israelites and their heritage is recorded in the Book of Psalms: " For, lo, thine enemies make a tumult: and they that hate thee have lifted up the head. They have taken crafty counsel against thy people, and consulted against thy hidden ones . They have said, Come, and let us cut them off from being a nation; that the name of Israel may be no more in remembrance.

For they have consulted together with one consent: they are confederate against thee. " 83:5. The "hidden ones" are the lost tribes and those who have forgotten their true heritage. This envy is nothing more than the lust Esau has for recovering the inheritance which he so foolishly and steadfastly rejected. The Edomites are confederate against true Israel because Esau, who is still in rebellion against God's Law, is the forefather and the animating spirit behind Edom and Judaism.

In addition to Josephus (below), I and II Maccabees tell us of the struggles of the Judahite leadership to liberate themselves from Greek domination. They should be read in conjunction with Josephus in order to get a full appreciation of the difficulties, in terms of internal squabbling, Canaanite intrigues and external military threats that the Judahites faced. (The reader should understand that what is



being retold here is a mere sketch of this period of history, and only the most salient points are being discussed. Reading Josephus and Maccabees is highly encouraged.)

Upon the death of Alexander the Great, the fortunes of Judah changed for the worse. Alexander's empire was divided among his generals, and two of them, in turn, fought over Judea. In response to the invasion of Antiochus the Great, the Maccabeans revolted and gained independence from the Greeks at the cost of ongoing warfare.

Due to the pressures and intrigues of war, it was at this time that infighting among the Judahites for the High Priesthood, and much intrigue resulted with one faction allying themselves with Antiochus while the other faction allied themselves with Ptolemy of Egypt.

It was shortly after that the sects known as the Sadducees, Pharisees, and Essenes arose; and the story of the House of Judah cannot be appreciated without understanding the power struggle that was going on among them.

Very briefly, the Sadducees can be said to be pro-Greek. The Sadducees usually consisted of the Judahite upper class and the reigning High Priest. These were influential people holding positions of political power.

More than likely, they favoured the cosmopolitan life style of the Greeks, with its games and spectacles and sophistication, to the rigid doctrines of the Mosaic Law a striking parallel to our "modern" Christian "leadership," which has become very secular!

The Pharisees, on the other hand, as the favourites of the Herodian kings, held authority, if not respect, over the common people of Judah; and it seems that their power was not to be denied. (The modern parallel here is Christian Zionism! Compare the power of the Jewish Neo-Cons in today's Bush administration.

The Bush family might as well be the reincarnation of Herodian dynasty!) Several Judahite leaders, such as John Hyrcanus and Alexander Jannaeus, had their lives made difficult by opposing the Pharisees. The Essenes seemed to be a more monastic group which included a branch of Cenobites who took vows of celibacy.

All of the available evidence suggests that it was the Essenes who took most seriously their Israelite heritage and obeyed the racial law against intermarriage. (Christian Identity today, thank you!) The Essenes, therefore, diametrically opposed the Pharisees, seeing them as hypocrites and usurpers.

Judas Maccabeus (a Judahite, not a Jew!) arose as a great spiritual and military leader and successfully fought off Antiochus and even subdued the Idumeans and Ammonites to the south. Judas was so successful that he nearly regained all the territory which belonged to the Twelve Tribes before the captivity!



After the Maccabees (above) successfully evicted the Greeks, the Samaritans, seeing the difficulties of the Judahites somewhat abated, for the time being, renewed their claim of kinship to Judah. While the nation of Judah was fiercely defending itself against Greece, the Idumeans were already forming an alliance with Rome, plotting their move against Judah when the inevitable defeat of Greece came at the hands of the Romans.

Judah, being fully occupied defending herself against Greece, and not given to making deceptive deals behind the scenes, was not prepared for the Roman juggernaut.

With the Roman occupation, behind-the-scenes intrigue by both Judahite and non-Judahite candidates increased, and the priesthood fell more and more into corruption. Josephus relates that "Alcimus, who was not of the high priest stock," became High Priest.

The continuous warfare was taking its toll on Judah's spiritual life. The situation grew worse and worse until, finally, Antipater, an Idumean, gained influence with John Hyrcanus, a Maccabean. Antipater talked Hyrcanus into

conquering Idumea and making Judea and Idumea one kingdom, thus tending to mingle the populations.

It was at this point that the Idumeans became Judeans, for a purely Judahite priesthood would never have accepted Idumeans as fellow citizens.

By this time, the Babylonian influence on the scribes and Pharisees had already allowed them to accept non-Israelite members, otherwise, Alcimus would never have become high priest. Consequently, Hyrcanus permitted them to stay in the combined new country if they submitted to circumcision and subjected themselves to the religious rules and regulations of the high priests.

This was, of course, a disastrous development in terms of distinguishing Judahites from Canaanites. In a footnote to Josephus, translator Whiston says "This account of the Idumeans admitting circumcision, and the entire Jewish [Pharisaic] law, from this time, or from the days of Hyrcanus, is confirmed by their entire history afterwards— Ammonius, a grammarian, says:—

The Jews [Judahites] are such by nature, and from the beginning, whilst Idumeans were not Jews [Judahites] from the beginning, but Phoenicians and Syrians; but being afterwards subdued by the Jews [sic] and compelled to be circumcised, and to unite into one nation, and be subject to the same laws, they were called Jews [Judeans —EJ].'

Dio also says: 'That country is also called Judea, and the people Jews [sic]; and this name is given also to as many as embrace their religion, though of other nations.' " Antiquities, Chap. 9.

The racial confusion bred linguistic confusion, and the rabbis have exploited this linguistic confusion in their historical pretence as Israel and Judah. The above quotes demonstrate why we should always distinguish between Jews and Judahites.

The Jews have done everything possible to influence Christian and secular historians into equating Jews with Judahites; but as can be plainly seen, the history of Jewry and Judaism begins with this edict of John Hyrcanus.

Thus, properly understood, this is an excellent commentary and verification of our main

argument: that a non-Israelite people called Jews adopted, by virtue of their half-breed relationship to Israel, some Israelite customs and kept the name for themselves! Also clearly expressed here is how the distinction between Judahites (Israelites) and Judeans became blurred, eventually to be forgotten, with the word 'Jew' substituting for both!

Indeed, had these developments not taken place, the prophecy concerning Israel's lost identity would never have been fulfilled. (See Psalm 83:3; Isa. 29:10-12; 42:16,19-20; 49:2; Hos. 1:9,10; 2:6; Matt. 13:44; Romans 11:7,8,25.)

While the modern Jews, the inheritors of the "Traditions of the Elders", have claimed continuity with Israel from that day forward, true Israel, the Anglo-Saxons plus the remnant of Judah, eventually forgot who they were and lost their identity!

It is one of the most important marks of Israel that God foretells true Israel's forgetfulness. The Anglo-Saxons have indeed forgotten their true heritage. In contradistinction, the Jews have always claimed to be the Chosen People! So, who is True Israel, those who fulfil the prophecy or those who do not?

John Hyrcanus was succeeded by Aristobulus I and then by Alexander Jannaeus, who was a most cruel and corrupt monarch. He made a habit of killing many of his own people and is reported to have crucified eight hundred Judahites at one time and slit the throats of their wives and children while they watched from their crosses kind of like George W. Bush sending True Israelites out to Iraq to be slaughtered by the Zionist war machine!



Alexander was succeeded by his wife, Alexandra, who made a league with the Pharisees. She did this because Alexander, on his death bed told her that all his troubles were due

to having opposed the Pharisees and joining ranks with the Sadducees. He thus advised her to cease hostilities with the Pharisees if she did not wish to fall into the same tragedy.

Alexandra was succeeded by her son, Hyrcanus III. But, Hyrcanus III and his brother, Aristobulus II, fought with each other over the throne, Aristobulus II realizing that the nation was being taken over by non-Israelites. But then the Romans entered the scene and concluded a pact with Hyrcanus III and Antipater, the Idumean, thus defeating Aristobulus II.

Upon Hyrcanus III's death, his sons, in turn, struggled to regain the leadership, but Antipater murdered two of them and finally installed his own son, Herod, as monarch of Judea. Judah was at its ebb. Around 60 B.C., Herod the Great, a half-breed Idumean Jew (and now the word is correctly applied), became petrarch of Judea, a collector of tribute money for the Romans.

Thus ended the valiant struggle of the Judahites to remain a distinct people and culture under their own rule. It is important for us to realize that the struggle to maintain the genealogical purity of Israel continued even down to the time of Christ.

In spite of all the corruption and seed-mixing at the upper echelons, there were still numerous pockets of pure-bred Israelites in and around Judea, especially of the tribe of Benjamin in Galilee. One of these settlements, known as Nazareth, was to be the home of Jesus, the Messiah. In fact, the Galilean Benjamites rarely entered Jerusalem; and, remember, Peter was found out because he had a Galilean accent!

Absolutely crucial to our understanding of this history is this most salient fact: After the return from captivity, the remnant of the House of Judah had to perform its function of bringing the Messiah into the world.

Christ could not have been born except through pure-bred Judahite stock! That is why Matthew, Chapter 1 and Luke Chapter 3 so meticulously record Yahshua's genealogy. Judah's leadership down to the time of Christ was accepted by a succession of prophets, priests, kings, priest-kings, and national heroes. For the record, the succession of pure-bred Judahites that ruled the House of Judah during this period is given here:

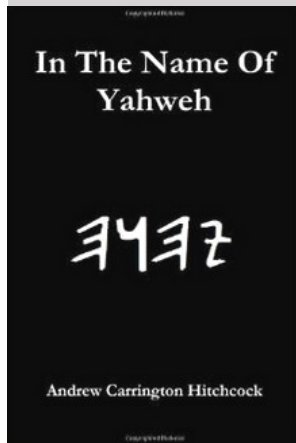

The Last Days

ZEPHANIAH
 1:18 – Neither their silver nor their gold shall be able to deliver them in the day of Yahweh’s (the LORD’S) wrath; but the whole land shall be devoured by the fire of his jealousy: for he shall

make even a speedy riddance of all them that dwell in the land.

Those who Yahweh hates, that dwell in the lands of His people, will be exterminated in the last days, and all the riches they have accumulated by intrigue against Israel will be for naught.

We only need look at today’s banking system to see that those that accumulate silver and gold are the Jews.

However the scriptures tell us other interesting things about gold and silver with regard to Israel in the last days.

2 Timothy 3:1 – *This know also, that in the last days perilous times shall come.*

2 Timothy 3:2 – *For men shall be lovers of their own selves, covetous, boasters, proud, blasphemers, disobedient to parents, unthankful, unholy,*

2 Timothy 3:3 – *Without natural affection, truce breakers, false accusers, incontinent, fierce, despisers of those that are good,*

2 Timothy 3:4 – *Traitors, heady, high minded, lovers of pleasures more than lovers of Yahweh (God);*

2 Timothy 3:5 – *Having a form of godliness, but denying the power thereof: from such turn away.*

2 Timothy 3:6 – *For of this sort are they which creep into houses, and lead captive silly women laden with sins, led away with divers lusts,*

2 Timothy 3:7 – *Ever learning, and never able to come to the knowledge of the truth.*

Looks like life today doesn’t it. What is particularly apt is the line, “ever learning and never able to come to the knowledge of the truth.”

I don’t think we’ve ever had such an abundance of college courses, training, re-training, liberalism, etc, all things that have to be indoctrinated, I mean learned, to ensure that those born with the law written in their hearts quickly disregard it.

In fact will someone tell me why every college degree lasts for three years in the UK? Does it make sense that every subject takes exactly three years to learn? It doesn’t does it. What does make sense however is that in order to undertake these degrees the students have to get in to debt to pay their tuition fees and living costs. According to the UK Push University Guide, the

projected average total debt (on course completion) for students entering university in 2012 (when tuition fees rise to £9,000 a year), is £53,000.

In other words, before you have even taken home your first ever pay packet, you will owe an average of over £50,000. What better way to indoctrinate the masses into believing that debt slavery is a normal way of life. And I wonder who these students will be in debt to, it wouldn't be banks by any chance would it...

Isaiah 1:7 – *Your country [is] desolate, your cities [are] burned with fire: your land, strangers devour it in your presence, and [it is] desolate, as overthrown by strangers.*

Doesn't this sound like the inner cities of the nations of Israel today...

Jeremiah 10:20 – *My tabernacle is spoiled, and all my cords are broken: my children are gone forth of me, and they [are] not: [there is] none to stretch forth my tent any more, and to set up my curtains.*

Jeremiah 10:21 – *For the pastors are become brutish, and have not sought Yahweh (the LORD): therefore they shall not prosper, and all their flocks shall be scattered.*

Here we can see Yahweh refer to the state of his churches today, and see who he blames for their current state: the pastors, whose heretical teaching has caused Yahweh's children to turn from him.



Church attendances are falling off exponentially, as predicted by Yahweh, because the pastors/vicars/clergymen/ministers/preachers/priests are not teaching Yahweh's laws or ways.

Rather than teach Yahweh's laws and ways to Israel, they are too busy promoting globalisation, running their churches under the communist pretext of equality, teaching that god (notice the small, "g") loves everybody, or sodomising children.

One only needs to look at the 501c3 tax exempt status offered to churches in America, which is provided on the condition that churches don't, "speak out or oppose anything the government considers is legal."

In other words, so long as the churches don't speak out against: same-sex marriages; homosexuality; abortion; usury; pandering to Jewish interests - such as their counterfeit nation of Israel (who a great percentage of the US government officials share dual nationality with); etc, they won't have to pay any taxes.

This was introduced by the Jewish senator, Lyndon Baines Johnson, in 1954, and today almost all churches in America put filthy lucre before truth by operating under this tax exempt status.

Interestingly the New King James translators changed the word, "pastors," from Jeremiah 10:21, to, "shepherds." Could it be they were worried that if they did not they may offend the pastors and not sell as many Bibles?

Whatever the reason Yahweh will have the last word against the pastors, so I hope they consider their earthly riches fair exchange for their forthcoming damnation. See:

Jeremiah 23:2 – *Therefore thus saith Yahweh (the LORD God of Israel) against the pastors that feed my people; Ye have scattered my flock, and driven them away, and have not visited them: behold, I will visit upon you the evil of your doings, saith Yahweh (the LORD).*

Some readers will notice that the laws given to the priests/pastors are not included in this book. This is for the same reason as the law of sacrifice, they have been done away with, as Israel are now commanded to pray directly to Yahweh, in Jesus' name, and not through an intermediary as promoted by the Catholic churches with their priests or the Jewish synagogues with their rabbis.

The pastors' job is simply to teach, a job they clearly do not care about as they have cursed themselves already for failing to teach Yahweh's true name, see:

Malachi 2:1 – *And now, O ye priests, this commandment [is] for you.*

Malachi 2:2 – *If ye will not hear, and if ye will not lay [it] to heart, to give glory unto my name, saith Yahweh (the LORD of hosts), I will even send a curse upon you, and I will curse your blessings: yea, I have cursed them already, because ye do not lay [it] to heart.*

Revelation 2:9 – *I know thy works, and tribulation, and poverty, (but thou art rich) and [I know] the blasphemy of them which say they are Jews, and are not, but [are] the synagogue of Satan.*

Here we have an example of a mistranslation of Jew.

In both this verse and Revelation 3:9 that follows, replace the word Jew with Israel, and it will make sense. Jesus Christ is of course addressing the Jews in both of these verses.

Revelation 3:9 – Behold, I will make them of the synagogue of Satan, which say they are Jews, and are not, but do lie; behold, I will make them to come and worship before thy feet, and to know that I have loved thee.

This describes the modern Jewish race today. They have developed the name, "Jews," as a trademark to appeal to both religious and non-religious people.

Its appeal to religious people is the lie promoted by Jews that they are the Israel of the Bible, and as a result they can do what they want to whoever they want as they are, "god's chosen people."

Not only do we know that this is not the case, but we see this delusion was predicted by Jesus Christ. We can also see that the Jews are destined to find out who they truly are (if they didn't already know) and who Israel is.

Its appeal to non-religious people is in showing the Jews as a long-suffering persecuted people,

which again allows them to do what they want to whoever they want, in this case because they allege they have suffered so much throughout history.



This is what the promotion of, "political-correctness," has been about since day one, making anyone who questions their actions out as, "racist," so people look the other way when they see Jewish power at work, through banking, politics and the media.

Unfortunately as a result these non-religious people do not bother to investigate even one aspect of the alleged persecution of the Jews.

For example, if the persecution of the Jews is such an unquestionable fact, why is any investigation of their last alleged persecution during World War II, prohibited by law in 16 countries, with the penalty for the breaking of that law being prison terms of several years.

Why also, is this the only alleged event in history that can result in a prison sentence for people who choose to investigate it?

Revelation 3:9 and 2:9 both have a double meaning showing the prophetic wisdom of the scriptures. This meaning can be obtained if you leave the word, "Jew," as, "Jew," and not change it to "Israel."

On that basis it can be argued that both verses also apply to the Ashkenazic/Khazarian Jews who represent 90% of the Jews on the planet today.

The Ashkenazi/Khazarian Jews originally descended from an area in Eastern Europe which converted to Judaism in 740 A.D.

As they were a mixed mongrel people they may have contained mixtures of Israel, Jewish, and other racial blood, but whatever the case they cursed themselves by grafting themselves onto the anti-Christ Jewish religion and have served Satan well ever since.

Remember, although Yahweh's people Israel have to be racially pure, Satan will take anybody who is prepared to turn from Yahweh, indeed he even tried to tempt Yahweh's son, Jesus Christ!

On that basis, when considering the Ashkenazi/Khazarian Jews who say they are Jews, but are not (they are a people converted to Judaism), Revelation 2:9 and Revelation 3:9 can be read unchanged.

Furthermore, the word synagogue comes from the Greek language and means, "assembly" or, "to bring together." This would change, "synagogue of Satan," to read, "the bringing together of Satan's children." Now read Revelation 2:9 and Revelation 3:9 again with that in mind.

Chapter 25

1. Again 3254 Ab'raham took a wife, and her name was Q'turah 6989.

2. And she bore him Zim'ran 2175, and Yoq'shan 3370, and M'dan 4091, and Mid'yan 4080 and Yish'baq 3435, and Shuach 7744.

3. And Yoq'shan begat Sh'ba 7614, and D'dan 1719. And the children of D'dan are the Ashshuriym 805, and the L'tushiym 3912, and the L'umiym 3817.

4. The sons of Mid'yan; Eyphah 5891, and Epher 6081, and Chanoch 2585, and Abiyda 28. All these were sons of Q'turah .

5. Gave Ab'raham all he had to Yits'chaq.

6. But to the sons of the concubines 6370, that had Ab'raham, gave Ab'raham gifts 4979, and sent them from near Yits'chaq his son, while he yet lived, eastward 6924, into the land of the east 6924.

7. These are the days of the years of the life of Ab'raham that he lived; a hundred and seventy five years.

8. Then breathed his last 1478 and died 4191 Ab'raham in a good 2896 old age 7872, old 2205, and full 7649 of years; and was gathered 622 to his people.

9. Buried 6912 him Yits'chaq and Yish'mael his sons, in the cave of Mach'pelah, in the field of Ephron son of Tsochar the Chittiy, that is before Mam're;

10. the field which purchased Ab'raham from the children of Cheth: there was buried Ab'raham, and Sarah his wife.

11. And it was after the death of Ab'raham, that blessed Elohiym Yits'chaq his son, and dwelt Yits'chaq by B'er-Lachay-Roiy.

(The descendants of Yish'mael - See 1 Chron. 1:28 - 31)

12. This is the family lineage 8435 of Yish'mael, son of Ab'raham, that was born of Hagar the Mits'riyth, maidservant of Sarah to Ab'raham;

13. and these are the named of the sons of Yish'mael, by their names, and their family lineage: the firstborn 1060 of Yish'mael, N'bayoth 5032, and Qedar 6938, and Ad'b'el 5655, and Mib'sam 4017,

14. Mish'ma 4927, Dumah 1746, Massa 4854,

15. Hadad 2301, Theyma 8485, Yetur 3195, Naphiysh 5305, and Qedema 6929:

16. these are the sons of Yish'mael, and these are their names, by their settlements 2691, and by their encampments 2918; twelve chiefs 5387 according to their tribes 523.

17. These are the years of the life of Yish'mael, a hundred and thirty seven years; and he expired and died, and was gathered to his people.

18. They dwelt 7931 from Chawiylah 2431 unto Shur 7793 that is before Mits'rayim 4714, as you go to Ashshurah 804: and before all his kinsmen 251 he fell 5307.

The Birth of Esaw and Yaaqob



19. This is the family lineage of Yits'chaq, son of Ab'raham: Ab'raham begat Yits'chaq:

20. Was Yits'chaq forty years of age when he took Rib'qah daughter of B'thuel the Arammiy 761 of Padan-Aram 6307, sister of Laban the Arammiy to wife.

21. Entreated 6279 Yits'chaq to Yahweh on behalf of 5227 his wife, because barren 6135 was she: and entreated was Yahweh, and conceived 2029 Rib'qah his wife.

22. Struggled 6279 the children within 7130 her; and she said, "Surely why is this with me?" And she went to inquire 1875 of Yahweh.

23. Said Yahweh to her, "**Two nations are in your womb 990, and the two peoples 3816 from your womb 4578 shall be divided 6504; and one people from the other people will be stronger 553, and the elder 7227 shall serve 5647 the younger 6810.**"

25. Came forth the first 7223 red 132 all over like a cloak 155 of hair 8181; and they called his name Esaw 6215.

26. And after that came forth his brother, and his hand 3027 took hold 270 of the heel 6119 of Esaw; and they called his name Yaaqob 3290: and Yits'chaq was sixty years of age when she bore them.

27. And grew 1431 the boys 5288: and was Esaw a skilled 3045 hunter 6718, a man of the field 7704; and Yaaqob was a wholesome 8535 man, dwelling in tents 168.

28. And loved 157 Yits'chaq Esaw, because of venison 6718 for his mouth 6310: and Rib'qah loved Yaaqob.

29. And boiled 2102 Yaaqob pottage 5138: and came Esaw from the field, and he was weary 5889:

30. and said Esaw to Yaaqob, "Let me swallow 3938 now 4994 from that same red 122/122 soup, because weary 5889 am I 595." Therefore was called his name Edom 123.

31. Said Yaaqob, "Sell 4376 this day your birthright 1062 to me."

32. Said Esaw, "Behold, I walk 1980 to death 4191: and what 4100 is this 2088 birthright 1062 to me?"

33. Said Yaaqob, "Swear 7650 to me this day," and he swore to him: and he sold 4376 his birthright 1062 to Yaaqob.

34. And Yaaqob gave to Esaw bread 3899, and pottage 5138 of lentils 5742; and he ate and drank, and rose up and walked away. Despised 959 Esaw his birthright 1062.

Chapter 25 Notes

Verse 1 - Yashar (Jasher) 25:1;

Verse 5 - The son of the actual first wife gets it all. Concubines don't count.

Verse 6 - Ab'raham loved his other sons also, but they could not be left there to challenge the firstborn legitimate son.

Verse 10 – Gen. 23:3-16;

Verses 12-18 - Here is the beginning of the Yish'maeliy (Ishmaelites), who were then adamic, but later mixed-race and became "dusky" (6150 arab).

Verse 16 -Yashar (Jasher) 25:19;

Verse 21 - Yashar 26:8;

Verse 23 - This is a key verse, as Yahweh Himself tells Rib'qah that Esaw and Yaaqob

would be [6504 divided, having the connotation of enmity] at birth. Esaw always hated Yaaqob/Yis'rael, and his Edomite seedline still do. They follow the Babylonian Talmud, and not the Scripture of Yahweh. They are "mamzers" (mongrels) of mixed seedlines, and hate the purebred white Israelites. Romans 9:12; Yashar 26:12;

Verse 25 - Yashar 26:17 ; Here the doubled "red" word gives Esaw his "nickname" of Edom.

Verse 26 - 270 is to seize, or take hold of. Heel is 6119 aqeb, thus Yaaqob 3290, from 6117 aqab, to restrain by the heel. All these names have a meaning associated with events, or descriptions.

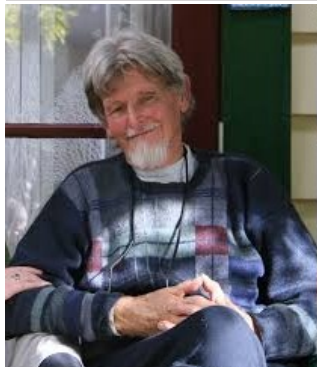
Verse 27 - Yashar 26:17;

Verse 29 - Read Yashar (Jasher) 27:7-12, which tells of the fight between Esaw and Nimrod, in which Nimrod is slain. This is why Esaw was exhausted when he returned to their camp.

Verses 31-34 - Here is shown the foolishness of Esaw. He was never intended by Yahweh to have the birthright, as Yahweh knew what he would do, and what his seedline would become. 959 "despised" here means "held in contempt".

Clean And Unclean Food (Part 2) Arnold Kennedy



SOME RELATIVE NOTES FROM THE SAME COMMENTARY.

IN ISAIAH 66 we find this statement, which in context, is concerned with God's people.

Isaiah 66:17 They that sanctify themselves, and purify themselves in the gardens behind one tree in the midst, eating swine's flesh, and the abomination, and the mouse, shall be consumed together, saith the LORD.

Being consumed by God for eating swine's flesh is a heavy statement! The abomination is *shequets* = "an unclean thing, an abomination". Yes, it is heavy for Isaiah to say that God will consume eaters of pork, rodents and other things. But the same commentary (as quoted earlier in this paper) contradicts itself as it agrees that eating unclean animals as being unlawful, stands until Judgment Day, saying:

When God restores His people to Jerusalem (vv. 10-13) in the Millennium, they will rejoice and prosper, but on His and her enemies He will swoop down in judgment like a fire (cf. 2 Thes. 1:7-9) and a whirlwind to slay them. This judgment will be fair because of their abominations: worshiping in idolatrous gardens

(cf. Isa. 1:29; 65:3) and eating ceremonially unclean animals such as pigs (cf. 65:4; 66:3; Lev. 11:7) and rats (cf. Lev. 11:29).

Where did they get the word “ceremonially”? It is from tradition. God’s commandment not to eat unclean food has nothing to do with any ceremony. It has nothing to do with food offered to idols either. The word “enemies” refers to those of God’s people who are eating pigs and mice, etc. Here this commentary is contradicting what they say in their quotation found in the first page of this paper. They confirm this concerning the verse below, which again is about eating swine’s flesh:

Is 65:2-7 Which remain among the graves, and lodge in the monuments, which eat swine’s flesh, and broth of abominable things is in their vessels; Which say, Stand by thyself, come not near to me; for I am holier than thou. These are a smoke in my nose, a fire that burneth all the day. Behold, it is written before me: I will not keep silence, but will recompense, even recompense into their bosom, Your iniquities, and the iniquities of your fathers together, saith the LORD, which have burned incense upon the mountains, and blasphemed me upon the hills: therefore will I measure their former work into their bosom.

The commentary says, as follows:

Isaiah 65:1-7. Constantly reaching out to Israel, God revealed Himself to those who did not even ask for that revelation. Only because of His grace did He do so, even calling out to them, Here am I. Yet they did not respond. He was always ready to help them (holding out His hands; Paul quotes vv. 1-2 in Rom. 10:20-21), but they continued to be stubborn, independent, and evil.

They provoked God by (a) worshiping in pagan gardens (cf. Isa. 1:29; 66:17); (b) being involved in necromancy (supposedly consulting the dead, while sitting among the graves, 65:4; cf. 8:19); (c) disregarding His dietary laws (65:4b; cf. 66:3, 17; Lev. 11:7); and (d) being religiously arrogant till they became as repulsive and irritating to Him as smoke in a person’s nose. Because of their sins, the LORD would judge them. The Assyrian threat (Isa. 1-37) and the Babylonian Exile (chaps. 38-66) were two of the ways the Lord disciplined His people. The

consequences of sin had to be faced; God would pay them back in judgment for their idolatrous worship in high places (cf. 57:7).

Here the commentary again declares this reference to eating swine’s flesh concerns God’s people, thus showing inconsistency. Is there any wonder why church members are all so confused?

A THIRD BIBLE PASSAGE USED TO SUPPORT TRADITION



Rom. 14:14 *I know, and am persuaded by the Lord Jesus, that there is nothing unclean of itself: but to him that esteemeth any thing to be unclean, to him it is unclean. But if thy brother be grieved with thy meat, now walkest thou not charitably.*

This is another passage that is used to promote the teaching that the eating of unclean foods was set aside by Jesus. Here again, tradition, which promotes that idea, has not considered the context. The context is established in the first verse of the chapter where the issue is about being a vegetarian or not.

Rom. 14:1 For one believeth that he may eat all things: another, who is weak, eateth herbs.

The context certainly is not about eating, or not eating, unclean meats. It is about being a vegetarian or not. So, as usual and according to good Greek word usage, “all” refers to the “all” of the context only, and thus does not include anything outside of the particular context.

Likewise when we come down to the verse “All things indeed are pure” and “For the kingdom of God is not meat and drink; but righteousness, and peace, and joy in the Holy Ghost”, there has been no change in the context within this chapter, and thus there is no application outside of the limited context.

A FOURTH BIBLE PASSAGE USED TO SUPPORT TRADITION

1 Cor. 8.8 But meat commendeth us not to God: for neither, if we eat, are we the better; neither, if we eat not, are we the worse.

Again, to suggest that this means that God's people can now eat unclean foods once again means that no notice has been taken of the passage context, which is confined to eating foods offered to idols.

FINAL COMMENT.

No wonder church members are confused over this issue and every issue relating to "the Commandments of God", a phrase found often enough within the New Testament, even if churches ignore the phrase. Church trumpets, such as commentaries and teachers, are making uncertain sounds by contradicting themselves, in the way as was pointed out above!

Commentaries say that on one hand Jesus has set aside the eating of unclean animals, and on the other hand that God's people will be judged for eating swine's flesh on judgement day, (if not before). What they have set aside are the "commandments of God".

The footnotes of the "Life Application Bible" actually say, "He did not downgrade the Law, but He paved the way for the change made clear in Acts 10, 7-22 when He removed the cultural restrictions regarding food". Amazing!

Does this concept not in fact downgrade the Law of God? And where does 'culture' come into it? Do we not say our culture allows us to eat pig but not rat, so that is now our standard? On this basis we could say nothing of the "commandments of God" has any relevance in today's "culture". This is what we are seeing today in society and most churches, go along with this idea, even in the holier than thou, so-called "holy ghost works".

There may be some partial acknowledgement of the "commandments of God" (Mal. 2:9) but God says, "Therefore have I also made you contemptible and base before all the people, according as ye have not kept my ways, but have been partial in the law". This partiality causes society to view the churches as they do. It is God

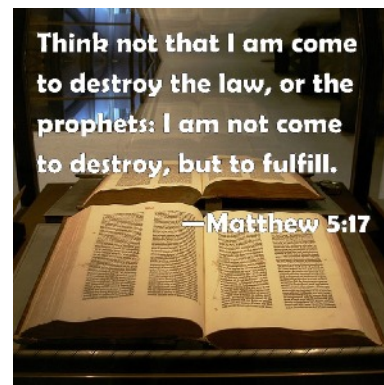
that has brought this view of churches by society to pass. The blessing and the glory have departed from the churches. Again, why?

Rev. 22:14 Blessed are they that do his commandments, that they may have right to the tree of life, and may enter in through the gates into the city.

And, as Jesus says,

John 14:21 He that hath my commandments, and keepeth them, he it is that loveth me: and he that loveth me shall be loved of my Father, and I will love him, and will manifest myself to him. Judas saith unto him, not Iscariot, Lord, how is it that thou wilt manifest thyself unto us, and not unto the world? Jesus answered and said unto him, If a man love me, he will keep my words: and my Father will love him, and we will come unto him, and make our abode with him. He that loveth me not keepeth not my sayings: and the word which ye hear is not mine, but the Father's which sent me.

Jesus has not therefore changed the Father's word, or the Father's commandments. In making obedience a matter of the heart, Jesus did not over-ride the "commandments of God". He said,



Matthew 5:17-18 *Think not that I am come to destroy the law, or the prophets: I am not come to destroy, but to fulfil. For verily I say unto you, Till heaven and earth pass, one jot or one tittle shall in no wise pass from the law, till all be fulfilled.*

But, commentaries and Bible footnotes, in general, gyrate in contradictory comments to try to establish the idea that heaven and earth has already passed away, thus giving the impression that the "Commandments of God" have been set aside. At least 90% of churches follow the conclusions of these commentators. Thus

churchgoers have been taught to think that unclean foods are now clean.

Ezekiel 22:26 Her priests have violated my law, and have profaned mine holy things: they have put no difference between the holy and profane, neither have they shewed difference between the unclean and the clean.....

Romans 6:1 *What shall we say then? Shall we continue in sin, that grace may abound? GOD FORBID:*

Galatians 3:21 *Is the law then against the promises of God? GOD FORBID:*

Paul did not agree with the commentators and neither should any of us.

Those who have been redeemed by the Blood of the Lamb, outside of any works of the Law, then come into a new relationship where the principle, "Yea rather, blessed are they that hear the word of God, and keep it" applies. **Anybody for rat pie?**

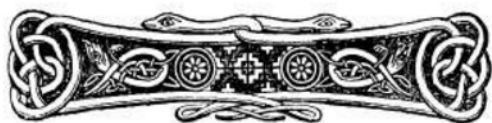

The Brehon Laws A Paper

ANCIENT LAW



AS IN LAW and all other branches of learning some knowledge of one system is useful in the study of any other system, so also one cannot well appreciate the relative proportions and importance of what belongs to one nation without taking some account of the condition in the same respect at the same period of neighbouring nations with which a comparison may be instituted.

For this reason I think our present subject should be introduced by a preliminary notice of the condition of law in early times in neighbouring nations with which we are liable to be compared. We can, however, scarcely do more than glance at one such nation; and remembering where we are, and the circumstances' of our country, the English nation seems the most appropriate for our purpose.

The first collection of Saxon laws into writing was made under Æthelbirht, king of Kent, after Saint Augustine had converted him to Christianity and baptised him. This occurred

about the beginning of the seventh century, Saint Augustine having arrived in Kent in A.D. 597. Æthelbirht's was a collection of the most meagre scraps, such as only extreme poverty in this respect could make any people consider worth collecting or preserving. After that time collections of laws continued to be made occasionally in Kent and the various little kingdoms into which England was then divided; but none of them reached respectable dimensions until that of Alfred the Great, towards the end of the ninth century.

Alfred is said to have been educated in Ireland. His is the earliest collection the English nation can show of any real value. Besides those given under Alfred's own name, it is probable that he may also be credited with the so-called Doms of Ine.

It is believed that none of the originals of the early English laws, or works relating to law, were written in the language of the English people, that the originals in Saxon times were always in Latin, and those of Norman times in Latin or Norman-French, and that the copies of the Saxon Doms now extant are transcripts from the translations made for vulgar use.

The originals of Acts of Parliament continued to be written in Norman-French down to the beginning of the sixteenth century, and the

records in legal proceedings down to the middle of the eighteenth century.

The brand of native inferiority, first impressed upon the people, continued thus long impressed upon the laws the people were bound to obey. Even in this year of grace, 1894, the royal assent is given to Acts of Parliament in words which neither the Queen nor her subjects understand, and which never were used by any generation of Englishmen.

Bearing in mind these few facts regarding the early condition and historical development of English law, we come in a proper mood to consider the most archaic system of law and jurisprudence of Western Europe, of which many records now exist, namely, what are now generally known as the Brehon Laws. This is not their real name.

Irish Laws, or Gaelic Laws, would be a better name for English speakers to use; but the thing meant has always been known to Gaelic speakers as Feineachus. A general term for all law, without special reference to that of Ireland, was Recht.

But the law of the Gaels was Feineachus. It included Cain Law, being that which was enacted or solemnly sanctioned by national assemblies, was of universal obligation, and could be administered only by professional judges; and it also included Urradhus Law, which was law relating to local matters, modified by local assemblies and by local customs, and which might be administered by the Flaiths who were not professional lawyers.

Feed My Sheep

Isaiah 40: 11, Jeremiah 3: 15, Ezekiel 34: 1 - 31. John 21: 15 - 17.

BEFORE I PROCEED with the theme of this article, there are 3 points that need to be said. To help anyone understand the relationship between the Old Testament (Covenant) and the New Testament (Covenant) you have to realise that the Bible is primarily concerned with one people, and that is Israel. Also when the same word is used in both the

above Covenants there is a good chance that they are connected. This certainly applies to the words "sheep" and "elect" which means "my chosen ". Finally when a quote is given in the New Covenant section, from the Old Covenant section, then you have to return to the "first mention" of that quote to help you understand why it is used in the New Covenant section. Other verses with that same word or phrase has to be also referred to so as you can understand the context. I hope these 3 points make sense

The following few thoughts will show why it is so important to return to the Hebrew and Greek meaning of words. The generally held view that the New Testament is mostly about the "church", has arisen due to the fallacious teaching of replacement theology which teaches that the church or body of Christ has replaced the Bride of Christ which relates to Israel. As expressed in one of my previous articles, the word "church"

should not be in the New Testament section. The correct word is "assembly, or congregation or called out". Can it be any clearer where we read in Matthew 15: 24 "I am not sent but unto the lost (wander away, to lose oneself, to throw off, to be punished) sheep of the house of Israel". In Ezekiel 34: 16 God says that He will seek that which is lost. Then in Matthew 18: 11 we read: "For the Son of Man is come to save that which was lost".

The Dark Secrets Behind The Pope's Audience Hall (It's a Giant Snake) From Our West Midland's Correspondent



WHEN I first realized the true magnitude of what the Pope's Audience Hall design reveals, I was shocked. Despite 10 years of research into the elite, occult, Illuminati, consciousness, and more, this stuck out as something I just HAD to write about.

Have you heard of the Pope's Audience Hall? Also known as the Paul VI Audience Hall or the Hall of the Pontifical Audiences, it lies partially in Vatican City and partially in Rome, Italy.

Named after Pope Paul VI and built in 1971 by Italian architect Pier Luigi Nervi, it seats 6,300 and contains a bronze statue called La Resurrezione, designed by Pericle Fazzini, within.

This all sounds pretty straightforward so far, but let's dive into what makes this building so strange. We'll start with the less weird, and get progressively weirder as we go.

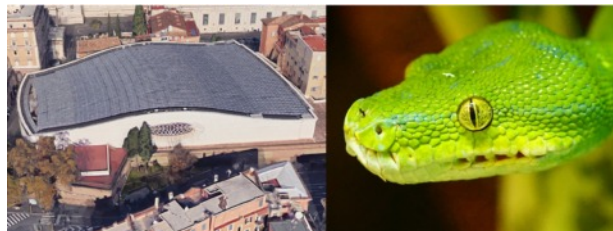
Building Method and Design

The building was designed with reinforced concrete by well-known architect Pier Luigi Nervi. Nervi is known for simple yet practical designs that are strong and made to last.

The simple curvature of the building might seem unassuming from the outside, but this is part one of what we will begin to explore about this

building, and I promise you, by the time we get to the end, you will see what I'm getting at.

Have a look at the image below and compare its shape to the image of a snake beside it. Note the overall shape — wide back, narrow, rounded front, eyes in the middle, nostril at the front, and curved top.



Windows

As you can already begin to see in the image above, there are two windows on either side of the building that resemble eyes. They are made of stained glass and sit about halfway through the building's length on either side.

In the centre of the eye shape, you begin to see a slit that could resemble a reptile eye. If you're not convinced yet, which is understandable, keep reading.

All of a sudden we begin to see things taking shape here — two reptilian eyes, staring at you as you observe the stage.



Scales and Fangs

Have a look again at the image above — what do you notice down the centre? There stands what looks to be a statue in the middle and then on either side, two sharp, pointed fangs. The building's roof and sides also resemble scales. Here are two more images to give you a sense of the scales.

Now let's pull it together a bit more so we can really see what we are looking at. In the image

below, really pay attention to the whole building and stage layout next to the image of a snake. The eyes, the shape, the scales, the fangs, the look and feel of the reptile... it's all there.



The La Resurrezione Statue

In the middle of the stage sits a statue of Christ rising from an atomic apocalypse. It was designed by Pericle Fazzini and put in place by 1977. Have a look at it below. Do you notice anything about Jesu

Left side

It's difficult to see from the front, but when you view the statue from the sides, where patrons would sit, it becomes strikingly clear from both sides that the head of Jesus is meant to look like that of a snake.

Think about it for a moment: If just one side of the statue gave the impression of a snake's head, we could brush this off as coincidence, but when it looks this way from all angles, and the entire building resembles a snake as well, it becomes much more difficult to ignore. One must begin to realize that this was purposefully designed to appear this way. The thought and planning that went into this would have to have been immense. The reality is, there is an obvious reason for this imagery.

The Big Question

You may be asking what that reason is; why was this building built in such a way that the Pope appears to be speaking from the mouth of a reptile? If you aren't asking that question, you're simply turning a blind eye. It's not that the evidence isn't present, it's that you are choosing not to see it. There are seven separate pieces that comprise the snake or reptile symbol. If it were

one or two I would understand your skepticism — even three. But when seven pieces come together so beautifully, so perfectly, you know beyond any shadow of a doubt that it was intentional.



Regardless, I know what I'm saying may be difficult to accept, but all tough truths go through phases — laughter and ridicule, partial acceptance, and then, eventually, they appear self-evident to the population. 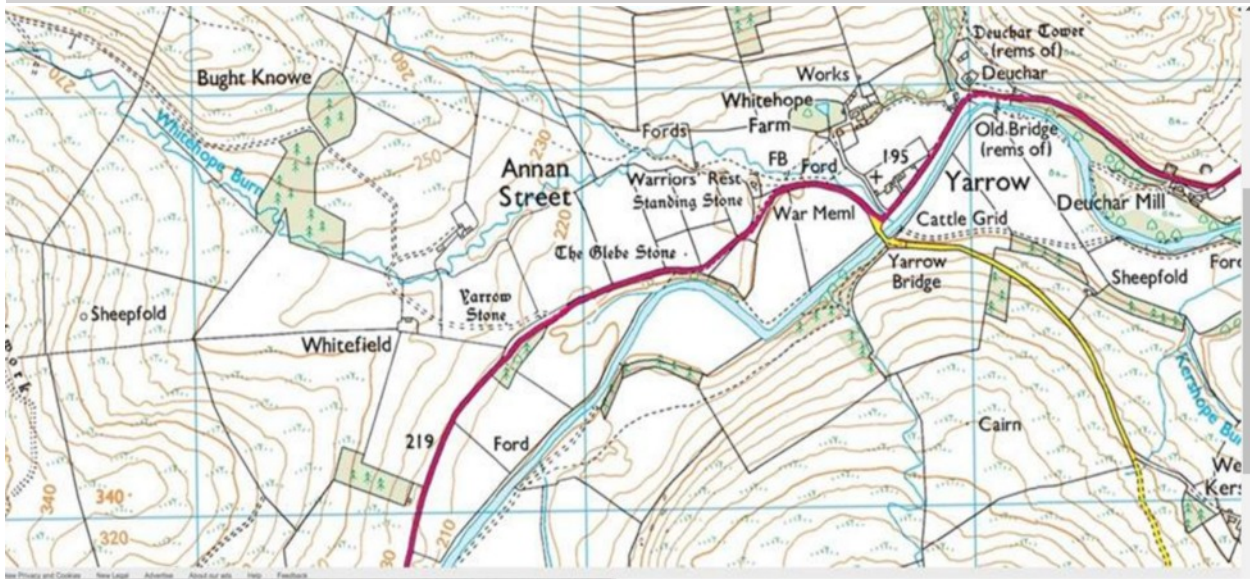

The Yarrow Stone - King Arthur's Tomb?

The Inscribed stone Found Near Yarrow Kirk. Selkirkshire. Br John Alex. Smith, M. D,

In July 1857 I brought under the notice of the Society the inscribed stone, found near Yarrow Kirk, with its ruddy cut Latin inscription, and gave details of its general appearance and the history of its discovery. (This communication is printed in the Society's Proceedings, vol. ii. p. 484.)

The Inscribed Stone (of which a drawing, from a photograph kindly taken for me by my friend Mr J. Smith, Jun., Darnick, is given in Plate XVIII.), is a large rough or un-hewn slab of grey-stone, somewhat triangular in shape, about seven feet in length, by three feet at its greatest breadth, from which it tapers downwards towards the pointed extremity; measuring two feet across at the surface of the ground, and five feet in height, from the point being now buried

to a depth of about two feet; it is about three inches in thickness at its upper part, and increases to a foot at the surface of the ground.

The stone displays a rude inscription on one side, the other showing no traces of letters, or ornamental sculpture of any kind. I may remind the Society, it was discovered upwards of fifty years ago, when the waste moor on the farm of Whitehope, known by the rather strange name of Annan Street, was first brought under tillage.

The locality had long been remarkable for the presence of two large un-hewn standing stones, near which various cists and sepulchral remains were found; a large cairn, under which the remains of bones were observed, having been formerly removed from the base of the larger standing stone; over the whole moor, indeed, sepulchral remains have been found.

Some time after reading this communication, my attention was called to the exact correspondence in the history and place of discovery of what at first sight appeared to be another stone, stated to have been covered with incised ornaments, and described as having been discovered in a similar manner, and at the same place, as the Inscribed Stone just referred to.

The object of the following notes is an attempt to show that these two apparently distinct and separate sculptured stones are in fact but one and the same. Dr Daniel Wilson designates this second stone, with its incised ornaments, the

“Annan Street Stone,” and gives a figure of it in his interesting “Prehistoric Annals,”¹ in the chapter on the “Archaic or Bronze Period.” After noticing the sculptured markings and concentric circles on various stones, he says :—

“Of the same class, also, is another slab figured here, the drawing of which was made by George Scott, the friend of Mungo Park, who accompanied him to Africa, and died there. It was forwarded to the Society of Antiquaries by Sir Walter Scott in 1828, who described the original as a rough sandstone, about six feet long by perhaps two and a half broad, which were raised by the plough at a place called Annan Street, upon the farm of Wheathope.

The drawing is designated, probably by the original draftsman,—A Druid stone found at Annan Street, figured with the sun and moon. Little doubt can be entertained that it had formed the cover of a cist, though few probably will now be inclined to attempt a solution of the enigmatic devices rudely traced on its surface.

The spot where it was found is about half a mile from the church at Yarrow, and close by there are two large stones, about 120 yards apart, which are believed to mark the scene of the memorable struggle that has given “The dowie houns of Yarrow so touching a place in the beautiful legendary poetry of Scotland.”

On examining the letters and papers of the Society, the China-ink sketch (now exhibited) was found—and is the original from which Professor Daniel Wilson’s figure was taken.

The latter, I may state, is a good copy, with a slight difference merely in the shading which gives the appearance of a fractured-like extremity to the stone, being a little darker or stronger marked, perhaps, than in the original; and an impression of it, for which I am indebted to Professor Wilson, is annexed.

A portion has been broken off at this corner since the drawing was made, but is still preserved.

Memoranda received by me from Sir Walter Scott, in regard to the drawing in Indian ink upon the other side.

Edinburgh 9(h March 1828

(Signed) “E. W. A. Drummond Hay.”

“The drawing was made by (? George) Scott, who accompanied Mungo Park to Africa, and died there.

With this drawing the following detailed MS. account was found:—



“The original is a rough sandstone about six feet long, by perhaps two and a half foot broad, which was raised by the plough at a place called Annan Street, upon the farm of Wheathope, belonging to his Grace the Duke of Baccteueh.

The place is about half a mile from the church of Yarrow, and is said at some remote period to have been the site of an ecclesiastical building. There are two large fragment« of rock at the distance of about 120 yards from each other. Here the memorable duel is said to have taken place, which gave occasion to Hamilton's ballad of “Busk ye, busk ye, my bonny, bonny bride;” and other ballads on the same subnet. The common tradition is, that both the knights, whose names are reported to have been Scott, fell in the duel.

King Edward VIII of Britain Wanted to Peace with Adolf Hitler - but Churchill Didn't

Sir __, The National Archives published more papers from the U.K. government's secret basement storeroom in the Cabinet Office where papers deemed "too difficult, too sensitive" for the regular filing system were hidden away. They include a 1953 memo from Churchill, marked "top secret," explaining the existence of a series of German telegrams carrying reports of comments by the Duke of Windsor, as Edward VIII was known after he abdicated in 1936.

"He is convinced that had he remained on throne war would have been avoided and describes himself as firm supporter of a peaceful compromise with Germany," reported a telegram from Lisbon in neutral Portugal, where the duke was staying in July 1940. "Duke believes with certainty that continued heavy bombing will make England ready for peace."

Edward abdicated so he could marry an American divorcee, Wallis Simpson. The couple set up home in France, but when World War II broke out they moved to Spain. The government in Madrid, formally neutral but sympathetic to Germany, asked for guidance from Berlin as to what should be done with them. German Foreign Minister Joachim von Ribbentrop replied, asking if they could be kept there. Then he ordered a watch on their house.

Ribbentrop's interest was piqued when he was told, a few days later, that in private "Windsor spoke strongly against Churchill and against this war." While he considered what to do, the duke

and duchess made their way to Portugal, where they made similar comments. The Nazis decided to act.

'Persuaded or Forced'

"The duke should return to Spain under all circumstances," Ribbentrop wrote, adding that they should then be "persuaded or forced" to stay there. His plan was then to offer the duke "the granting of any wish," including "the ascension of the English throne."

Churchill, meanwhile, was alive to the danger of having an alternative monarch so close to being in Nazi hands. He appointed the duke as governor of the Bahamas. When the Windsors were reluctant to leave Europe, Churchill threatened Edward, who held honorary military rank, with court-martial. Ribbentrop, anxious not to let his prize escape, launched Operation Willi to persuade the Windsors to return to Spain, kidnapping them if necessary. But despite sabotage attempts and bomb threats, the Germans failed.



Winston Churchill and Dwight Eisenhower tried to suppress captured Nazi documents that showed Britain's former King Edward VIII discussing his desire for peace with Adolf Hitler, according to files newly released in London.

The plan was "to persuade the duke to leave Lisbon in a car as if he were going on a fairly long pleasure jaunt, and then to cross the border at a specified place, where Spanish secret police will ensure a safe crossing," according to a note sent to Ribbentrop.

The telegrams describing their operation were found in 1945 as Hitler's regime collapsed. When they were passed to the British government, Clement Attlee, who had replaced Churchill as prime minister, wrote to his

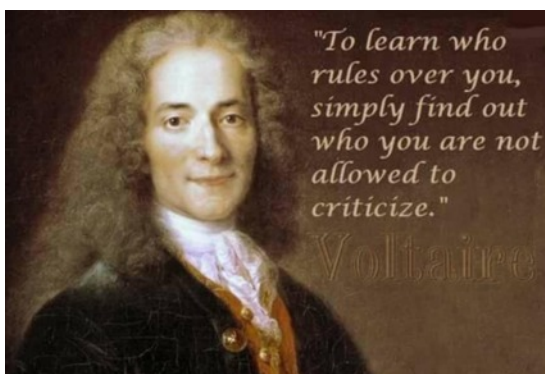
predecessor, saying that their publication “might do the greatest possible harm.” Churchill replied, agreeing and expressing the hope that it might be possible to “destroy all traces” of the files.

Publication Plan

But after Churchill returned to power in 1951, he was horrified to learn Attlee had subsequently changed his mind, apparently at the urging of Foreign Secretary Ernest Bevin. Historians in Washington now proposed to publish the Nazi telegrams.

In 1953, Churchill wrote to President Eisenhower, expressing his concern that “they might leave the impression that the duke was in close touch with German agents and was listening to suggestions that were disloyal.” Eisenhower, who had been the allies’ supreme commander, had seen the telegrams in 1945, but believed he had successfully suppressed them, arguing they were “obviously concocted with some idea of promoting German propaganda.” He was unaware a microfilm of them had been passed to the State Department.

By the 1950's, too many people had seen the messages for them to be destroyed, and the British historian in charge of preparing the documents for publication threatened to resign if they were suppressed. They were eventually published in 1957, with the duke describing them as “complete fabrications.” **Yours truly, K H, West Midlands, UK**

I am sending a copy of this letter to Teresa May and a copy to the editor of Vogue magazine so that he may publish it.

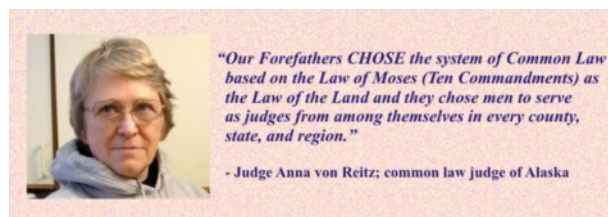

For the last several months people have been wanting to argue over the pros and cons of silver versus gold standards to base monetary values on and so far as that goes, silver is the obvious choice. It's our traditional form of money and it is the least subject to manipulation. I have said that from Day One when the whole issue of precious metals-backed forms of money came up, and I still say so.

However, as I attempted to make clear in my discussion about The Goat Standard, nearly anything that has actual value can serve as a standard for exchange: a sin, a female goat, and \$200 have the same value in the current system of things, and it doesn't much matter how you cut it.

The ridiculousness of the whole concept should be apparent given that example, but judging from some of the responses I've gotten, there are still those who just don't get the joke.

They know that the present monetary system is bogus and can cite chapter and verse for why it is bogus. The "secret" of the Federal Reserve is now well-known: check kiting is what the rest of us call it. And insurance is revealed to be nothing but legalized gambling. In fact, the entirety of the banking industry is now known to be a criminal enterprise aimed at theft of various kinds, fraud of various kinds, and enslavement of various kinds.

So--- now you think that "going back to the gold and/or silver standard" is the answer? Think again. First, there is vastly more gold already mined than the rats are admitting. Tons of it. Miles of tunnels filled with it. Huge, vast,

mindless quantities of gold. You haven't seen it, but I have.

Second, there are now means to extract endless additional quantities of gold from common materials. Gold can be extracted from sand, from crushed glass, from sea water--- you name it, and gold can be extracted from it. There is an endless supply of gold available now, just as there is an endless supply of paper money. And again, you haven't seen that, but I have.



The rats in charge are all ready to spring this new twist on gold and have you buying in at over a thousand dollars per ounce. They will try to make you believe that gold is very scarce and valuable. They won't tell you how much of it they already have stored up. They won't reveal how easily they can extract more on demand. This is all designed to make you think that gold has value because it is supposedly rare and in finite supply, when its not.

It's just a slightly different version of the same old trick. And, the same kinds of processes can be applied to producing silver. So there is no long term cure to be had from precious metals. Or from paper. Or from goats.

The take home point is that we need to totally rethink the concept of money and the way we symbolize value and what we value.

When we value external things, we make ourselves slaves of those things. We have all seen this, we have all been victimized by it, and yet hardly anyone seems able or willing to look it squarely in the face. We have been living as slaves to pieces of paper and numbers in bank ledgers. Will we now live as slaves to little pieces of metal and more numbers in bank ledgers? Ah.....duh?

The essence of idolatry is that you take something in the external world and raise it up to be a god over you, whether it is a coin, a piece

of paper, a goat, a religious relic or a dictator. It hardly matters what form the idol takes.

Somehow, we have to grow beyond this infantile condition of self-enslavement and delusion, this kink in our logic circuits. In order to do that, we must become aware of the problem and of the truth.

The problem is that we very easily lose track of the difference between the symbol of value and the value itself. The truth is that until we can come to a more sane and mature basis of symbolizing value, we will be prey to criminals who operate as middlemen controlling the perceived value of these symbols and limiting our access to them.

How many here want to spend the rest of your days bowing and scraping to criminals? Doing their bidding because they control the supply of "genuine" pieces of paper or pieces of metal, either one?

This is why I have said for a long time that we need to have a world standard coinage or currency or both, which is based on the value of all natural resources, all commodities in trade, and all labour on Earth. This is the only way to have "honest" money that is immune to hoarding and speculation and manipulation.

Imagine what would happen if we made goats the standard of value? Everyone would suddenly be raising goats and turning out goats as fast as possible, and as the market became saturated with the "value" of goats, the price of goats would go down.

It's the same with any commodity you can name including gold and silver.

The only answer that avoids all of this craziness is the answer I have given you--- base the value of your money on all goods and all services (labour) worldwide. Then the only way for such money to gain value is for us to take better care of the Earth and better care of ourselves and the plants and animals that share the Earth with us. Such money ceases to be an idol and an end unto itself, and becomes a motivation for good.

And that is what we sorely need on this planet--- motivation to do what is right and good. **From P.E., Sussex UK The End**

A common hypothesis for Stockholm syndrome is that it's the victim's response to the trauma. By identifying with the aggressor, the ego defends itself. If the victim can just adopt the same values as the aggressor, the dire threat ceases to exist. Another mental defence mechanism known as Normalcy Bias may come into play as with the two oldest generations of former Soviet subjects after collapse of the USSR. In the victim's mind, nothing can alter the conditions to which the victim is accustomed. A traveller in Europe recently posted a description of Lithuania's Grutas Park – a

chilling display of communist statues that were removed from public squares in Lithuania. "Families with young children roam the park and it is no exception to see young children posing with Lenin or Stalin while their dad is making a picture. It is also a strange experience to visit...souvenir shops where you can buy mugs or small glasses with a portrait of Stalin on it. Why would anyone buy a mug with the portrait on it of he who ordered the death of millions? ... Bizarre but true."

British Grand Jury Re-Established From Our Bristol Correspondent

ON SATURDAY, 11 OCTOBER 2014, a Grand Jury consisting of indigenous men and women from across the lands known as the Isles of Britain was convened in the city known as Nottingham.

The last Grand Jury that sat in these lands was August 29, 1933, at the London Court of Sessions.

Those Sovereign men and women came together, for and on behalf of the indigenous peoples of these lands, in order to determine whether the Administration of Justice (Miscellaneous Provisions) Act 1933, was equitable and/or lawful.

As such, the abolition was a breach of natural law as well as various international declarations on the unalienable rights of indigenous peoples.

Secondly, the Grand Jury declares that every act purporting to transfer the sovereignty of the peoples of the isles of Britain is unlawful, treasonous and void *ab initio* on the grounds that to do so is to fundamentally breach the rules of the English Constitution as well as the Common Law of the peoples of the lands of the British Isles which guarantees that sovereignty cannot be breached.

Thus it came to pass that on Saturday 11th October 2014, an ancient and fundamental right of the natural peoples was re-established: namely, the right of the peoples of these lands to form a Grand Jury as and whenever necessary to take to task any and all institutions of state and/or individuals who have attempted to usurp the Common (Natural) Law as enshrined by the Laws of Molmutius.

Sovereign Grand Jury - 1st Session 1st Unilateral Declaration

Given the absence of justice in Her Majesty's Courts & Tribunal Service, having exhausted all available remedies; and the thousands of miscarriages of justice seeking appropriate redress;

Upon the Sovereign indigenous people of the islands of Britain convening a Grand Jury, in a

secure and private location in the city of Nottingham, on Saturday the 11th of June 2014, under the protection of the Treaty of Universal Community Trust; and:

Upon hearing presentment #001GJ, alleging that no Parliament of the United Kingdom or any other form of British government can ever be said to be or have been in possession of the right to abolish or interfere with the ancient institution of justice, commonly known as the Grand Jury; The Grand Jury unanimously agree that the allegation set forth in the presentment is proven beyond question and make the following solemn declaration under oath:

It is hereby declared that the Administration of Justice (Miscellaneous Provisions) Act 1933 [the act purportedly abolishing the Grand Jury] is void *ab initio*; on the basis that the institution was formed for sole purpose of overturning miscarriages of justice by government institutions and despotic monarchs; that the Act of Parliament was therefore at best *ultra vires* [without jurisdiction]; and at worst a criminal act of treachery by the Parliamentarians responsible; the effect of which was to deny the people their unalienable ancient right of redress against the tyranny of government and injustice. The statute must therefore be regarded as a nullity from the outset and cannot be lawfully relied upon in any legal proceedings against the indigenous people of Britain.

Sealed as a Unilateral Declaration, under the protection of the Treaty of Universal Community Trust:

No government institution has the jurisdiction to challenge the substance or effectiveness of this declaration, since its terms must be unequivocally applied under long-established principles and customs of British Common Law. Certified copies may also be used in defence of any claim founded upon the void Act of Parliament concerned.

Sovereign Grand Jury - 1st Session 2nd Unilateral Declaration

Given the imminence of the completion of the purported transfer of British Sovereignty to the European Union suprapstate; Upon the Sovereign indigenous people of the islands of Britain convening a Grand Jury, in a secure and private

location in the city of Nottingham, on Saturday the 11th of October 2014, under the protection of the Treaty of Universal Community Trust; and:

Upon hearing presentment //002GJ, alleging that no Parliament of the United Kingdom or any other form of government can ever be said to be or have been in possession of the right to transfer the sovereignty of the British people:

The Grand Jury unanimously agree that the allegation set forth in the presentment is proven beyond question and make the following solemn declaration under oath:

It is hereby declared that every Act of Parliament of Her Majesty's Government purporting to transfer or cede sovereignty to unelected, unaccountable European Union Commissioners is unlawful treasonous, illegal and void ab initio; on grounds that to do so is to fatally breach British Common Law, the Constitution of the United Kingdom and the Declaration on the Rights of Indigenous Peoples, all of which affirm the unalienable rights of the people of Britain to self-governance and self-

determination. It is therefore clear that neither the reigning monarch, nor her designated plenipotentiaries, had or now possess the authority to ratify any of the treaties which purport to render the British people subjects of the unelected European Union dictatorship, as of the 1st of November 2014. These acts and any subsequent ones of a similar nature must therefore be regarded as nullities from the outset and cannot be lawfully relied upon in any legal proceedings against the indigenous people of Britain.

No government institution has the jurisdiction to challenge the substance or effectiveness of this declaration, since its terms must be unequivocally applied under long-established principles and customs of British Common Law. Certified copies may also be used in defence of any claim founded upon the void Acts of Her Majesty's Government.

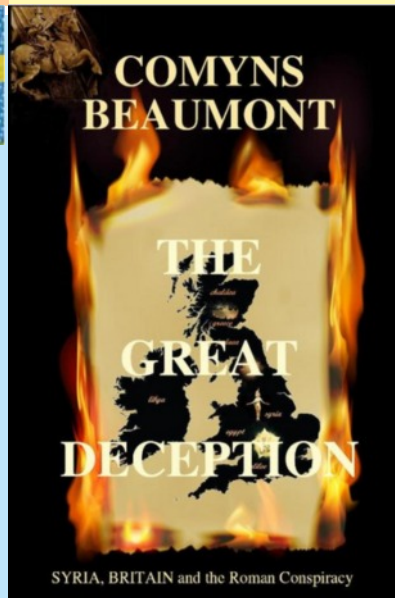

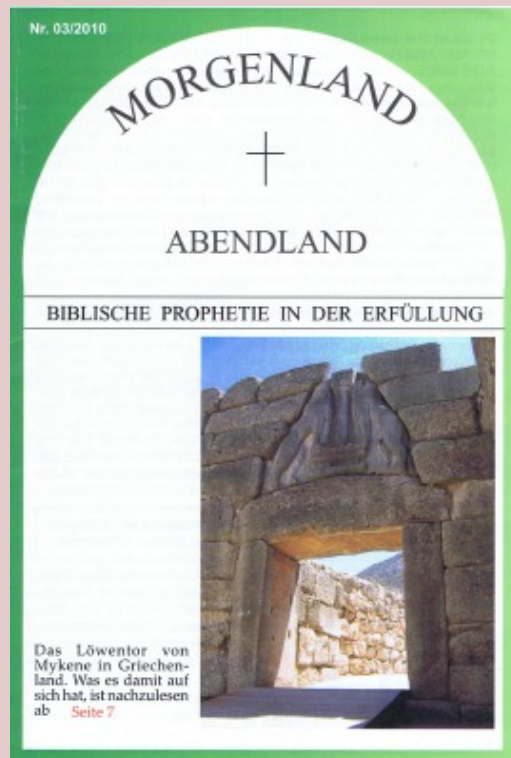
