immunity.

NIT – Natural Immunity Theory – the belief that biochemical augmentation of natural immunity does not work.

Allopathic medicine – invasive therapies, such as surgery, drugs, immunization.

ME – the Medical Establishment.

VID – Vaccine Induced Disease.

MD – Medical Doctor.

Iatrogenic – disease caused by doctors.

Spin – deliberate lies told by journalists and special interest groups.

Kept Press – news outlets owned by the monopolists.

Spinmaster – a journalist who distorts the news in order to protect the guilty.

Vaccines Are Dangerous

VACCINES ARE DANGEROUS. Vaccines are more than dangerous, they are deadly. Today, vaccines cause far more disease and death than the diseases they supposedly control.

At odds are two different models of how best to prevent disease. These two models can be labelled as the medical intervention theory and the natural immunity theory. The medical intervention theory (MIT, for short) is promoted by the Medical Establishment, which, of course, includes the pharmaceutical industry. Ever since the American Medical Association was taken

over by the Rockefellers, health care in America has advanced steadily towards monopoly. As Eustace Mullins puts it:

In 1900, there was only one doctor for every 750 Americans. They had usually served a two year apprenticeship, after which they could look forward to earning about the same salary as a good mechanic. In 1900, the AMA Journal, which was already under the editorship of Dr. George H. Simmons, sounded the call to arms. "The growth of the profession must be stemmed if individual members are to find the practice of medicine a lucrative profession." One would find difficulty in reading in the literature of any profession a more determined demand for monopoly.

But how was this goal to be achieved? The Merlin who was to wave his magic wand and bring about this dramatic development in the medical profession turned out to be none other than the richest man in the world, the insatiable monopolist, John D. Rockefeller. Fresh from his triumph of organizing his gigantic oil monopoly, a victory as well-blooded as any ancient Roman triumph, Rockefeller, the creature of the House of Rothschild and its Wall Street emissary, Jacob Schiff, realized that a medical monopoly might bring him even greater profits than his oil trust. In 1892, Rockefeller appointed Frederick T. Gates as his agent, conferring upon him the title of "head of all his philanthropic endeavours." As it turned out, each of Rockefeller's well-publicized "philanthropies" was specifically designed to increase not only his wealth and power, but also the wealth and power of the hidden figures whom he so ably represented.

Eustace Mullins, Murder by Injection

Part of the AMA's monopolistic thrust was to demonise non-allopathic therapies, such as chiropractic.

As an agency that proclaims itself to be concerned with improving the nation's health, the AMA has a duty to accept the field of chiropractic medicine as having proven medicinal value. But history shows just the opposite. Until recently, the AMA viewed

chiropractors as competition and tried to destroy the practice of chiropractic medicine in its entirety. In *When Healing Becomes a Crime*, Kenny Ausubel writes, "For over 12 years and with the full knowledge and support of their executive officers, the AMA paid the salaries and expenses for a team of more than a dozen medical doctors, lawyers and support staff for the expressed purpose of conspiring (overtly and covertly) with others in medicine to first contain, and eventually, destroy the profession of chiropractic in the [United States and elsewhere](#)."

We are further informed:

Judge Getzendanner ruled, "I conclude that an injunction is necessary in this case. There are lingering effects of this conspiracy; the AMA has never acknowledged the lawlessness of its past conduct and in fact to this day maintains that it has always been in compliance with the antitrust laws."

The AMA was forced to circulate the contrite Order of Injunction through medical journals, hospitals, and many other outlets, and to cease and desist from obstructing the professional rights of the chiropractic profession. The conviction marked the third time in the century that the AMA was found guilty of antitrust violations for conspiracy and restraint of trade.



The medical association was first convicted in 1937 under Dr. Fishbein (left) for trying to destroy an autonomous doctors' group applying cost-cutting health delivery and insurance in Washington, D.C. It was again found guilty

in 1982 by the Federal Trade Commission—a decision upheld by the Supreme Court, just as the earlier conviction was. This time the verdict confirmed the AMA's decades-long, systematic violation of antitrust statutes. - [Ibid.]

The chief architect of the AMA's assault on alternative therapies was a quack by the name of Morris Fishbein. When Fishbein was in control, the AMA and the Journal (JAMA) were located on Dearborn St. in Chicago. In his

biography of Fishbein, Bob Wallace tells us, Dr. Morris Fishbein (1889-1976) originally studied to be a clown. Realizing he could make more money as a doctor, he entered medical school (where he failed anatomy), then barely graduated. He never treated a patient in his life.

Why is he so important? Because he became head of the AMA, a position that he used to enrich himself and crush legitimate therapies out of existence. He appeared to be motivated solely by money and power.

As head of the AMA (and editor of the Journal of the American Medical Association from 1924-1949), he decided which drugs could be sold to the public based only how much advertising money he could extort from drug manufacturers, whom he required to place expensive ads in the JAMA. There were no drug-testing agencies, only Fishbein. It was irrelevant if the drugs worked.

Fishbein was a shakedown artist. Yet, today, there is a Morris Fishbein Centre for the History of Science and Medicine at the University of Chicago. - Bob Wallace, "Morris Fishbein, AMA Enemy of American Health," Lew Rockwell.com.

So, JAMA was literally run by clown pretending to be an MD. Fishbein took over the Journal of the American Medical Association and used its advertising power to promote allopathic medicine over natural therapies. His expertise was propaganda, shakedowns and accepting pay-offs from pharmaceutical companies.

Ever since the days of John D. Rockefeller, the Medical Establishment has been engaged in a long-standing marketing campaign to promote MIT (medical intervention theory) over NIT (natural immunity theory). Of course, this self-serving model of how to treat disease is good for business. Conspiring to put competitors out of business has never been beneath the dignity of the medical establishment.

Next to fractional reserve banking, the Medical Establishment is the most profitable industry on the planet. Big Pharma produces little pills at pennies per piece and sells them for dollars per piece. Since the days of Morris Fishbein, the Medical Establishment has turned ever-growing profits into a constant stream of advertising, all of which goes towards promoting the MIT.

Early successes, such as antibiotics and penicillin, plus dramatic advancements in surgical techniques, helped the ME to establish a virtual monopoly on health care.

Big Pharma and Vaccines

A major part of Big Pharma's monopolistic thrust has been the campaign to promote vaccination as a legitimate therapy. Capitalizing on poorly conducted studies and deliberately false information about the efficacy of vaccines, the ME has pursued a relentless course of vaccine promotion.

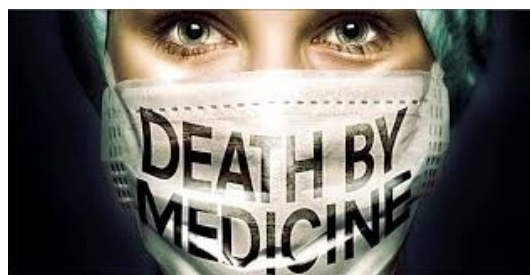
The simple fact is that vaccines have never been proven to be effective or safe. For one thing, they never give long-term immunity. This is why booster shots are required. And the chemical additives contained in vaccines can be more dangerous than the disease.

Ingredients, such as thimerosal, aluminum, squalene, etc., added as activators and preservatives, have been implicated as the causative agents for numerous chronic health conditions, especially neurological conditions, such as alzheimers, attention deficit disorder, multiple sclerosis and autism. Since the human body's nervous system is an ultra-sensitive electrical conductor, the introduction of metals, such as mercury and aluminium, will short-circuit these electrical impulses, wreaking havoc in the brain, nerves and synapses. The introduction of metallic substances through vaccination is creating a population of schizoid paraplegics.

Even if vaccines can claim success against some old maladies, which is doubtful, the fact is that we have a whole new category of neurological diseases that exist primarily in vaccinated people. Another side effect of vaccinations is blood coagulation around capillaries, the very smallest blood vessels that feed our organ tissue. This is, again, caused by the unnatural introduction of metallic compounds into our blood streams.

These metals change the electrical charge of the blood corpuscles, which causes them to coagulate in front of the capillaries, resulting in minor and major strokes. Coagulated blood cells dam up in front of capillaries, thus preventing healthy blood cells from passing through. This

prevents the organ tissue from receiving vital oxygenation and nutrients.



Big Pharma knows that this is happening, but the steamroller of vaccination has been running so fast and furious, that it is too late to turn back now. If the Medical Monopoly admits to its crimes, it will be overwhelmed with lawsuits, and the vaccine manufacturers may be forced out of business, bringing the parent pharmaceutical corporations down with them. This is why the Medical Mafia has sought to protect itself by allying itself with the Food and Drug Administration. In this way, their corporate lawyers and government lawyers can work together to keep the public behind a mysterious barricade of legalese.

Sudden Infant Death Syndrome

If we pay attention to REAL statistics – not those statistics that are proffered by Big Pharma – we find that there is a direct correlation between many modern syndromes, such as autism, asthma, multiple sclerosis, Alzheimers, etc., and vaccination. All of these diseases have sprung up DURING the modern era of government-imposed vaccination programs.

This era can be said to have begun with the polio vaccine in the 1950's. Even with polio, a detailed survey of the historical facts shows that polio was already on its way out as a health problem well before the Salk vaccine was introduced. In fact, the introduction of the Salk vaccine caused a SPIKE in the occurrence of polio, so it was not just a case of too little too late, it was a case of making things worse. In the aftermath, despite the spike, the ME claimed that it was the saviour of the children. This was another corporate lie. The industry often fudges their own statistics, by renaming and re-categorising diseases that vaccination victims acquire right after vaccine delivery.

The same is true of Sudden Infant Death Syndrome, which is most definitely caused by

vaccinations. In fact, Japanese doctors, alarmed by the sudden appearance of this previously unknown syndrome in Japan, petitioned the Japanese government to **stop** the DPT vaccine, which they felt was responsible for the SIDS epidemic. One independent researcher has this to say about that episode:

Between 1970 and 1974, 37 infant death occurred after DPT vaccination in Japan; because of this the doctors in one prefecture boycotted vaccination ... Consequently, the Japanese Government first stopped DPT vaccination for 2 months in 1975, and, when vaccination was resumed, the vaccination age was lifted to 2 years.

Interestingly, not only the entity of sudden death disappeared from vaccine injury compensation claims (only 2 deaths were subject of vaccine injury compensation claims in the 2-year olds compared with 37 in younger children), but the overall infant mortality has improved: Japan zoomed from 17th to first place in infant mortality in the world.

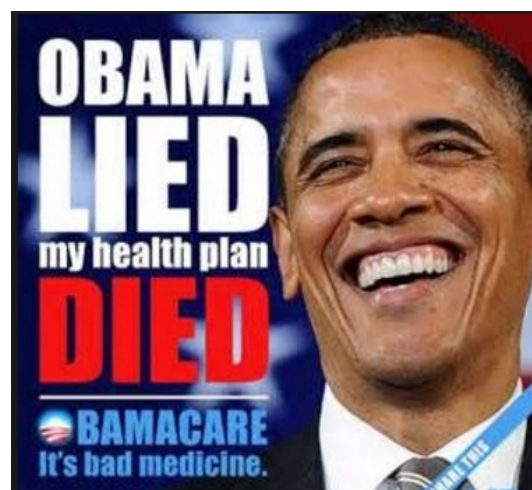
This means that Japan moved from a very high bracket to the lowest infant mortality rate in the world (Jenny Scott 1991). Interestingly, Noble et al. (1987) who spent some 2 weeks in Japan studying the a-cellular whooping vaccine there, wrote that "It is difficult to exclude pertussis vaccines as a causal factor even when other etiologies are suggested, particularly when the adverse events occur in close temporal association with vaccination". - [Scheibner](#):

This is a statistic that doesn't lie. Japan zoomed to the world's best infant mortality rate as a **DIRECT RESULT** of curtailing its infant vaccination program. In recent years, many MD's have begun to speak out about the correlations between vaccines and the new "epidemics." There IS a relationship; and the relationship is direct.

But these remonstrant MD's are demonised by Big Pharma and their corps of paid "journalists," who continue to trumpet vaccination as either safe or effective; and neither of these propositions is true. There is a voice crying in the wilderness of the drug-induced mania, that is current in modern society. Drugs are everywhere, both legal and illegal; and these drugs are becoming more and more of a health

problem, and an economic and political problem as well, because the cosy relationship between Big Pharma and Global Governance is full of corruption and is totally contrary to any and all conflict of interest stipulations that were built into our Constitution.

Suffice it to say that, when a Big Pharma executive leaves the corporate suite, he or she often winds up working in the Food and Drug Administration – er, I mean, Food and Drug Administration – pushing for more drugs to be imposed upon Americans against our will. The marriage between Big Pharma and Big Government was made in hell; and the world is paying a steep price, both in terms of rising medical costs and declining health, for this UN-sponsored monstrosity.



For this reason, Obama's health insurance bill is disingenuous, because it fails to address the fact that rising health costs are a direct result of Big Pharma's corrupt, monopolistic practices. ObamaCare will simply grease the skids for the Big Pharma State, in effect protecting their profits by having Big Government – which means the taxpayers – pay for questionable "therapies," thereby taking the risk out of the corporate market. Whatever happened to the Anti-Trust legislation that is supposed to protect us from such monopolistic scams?

All we hear from the Kept Press is that the "gun lobby is the most powerful lobby in America." I doubt that the NRA has 1/100th of the lobbying money that Big Pharma does. The medicrats are lying to us about this situation. In fact, a 2004 study concerning hospital care revealed that nearly 200,000 Americans suffered from wrongful death due to medical malpractice in our hospital system. And this is just what

happened in the hospitals. There is no way of knowing how many deaths occurred at home, due to poor supervision of drug dispensation, stupid mistakes and outright malpractice.

One survey, comparing handgun accidents with death by medical malpractice, showed that an American is 9,000 times more likely to die of medical malpractice than from a handgun wound.



Yet, all we hear about on television and from the totalitarian gun-grabbers in our government is “how evil guns are.” None of the spin-whores at ABC, NBC, CBS, Fox, etc., have ever advocated a million - mom - march against malpractice. And they never will, because 60 - 70% of TV advertising revenues come from Big Pharma, not from the NRA. Virtually every commercial break contains one or two drug ads. There is no relief from this headache.

MIT Versus NIT: How the Immune System Works and Why Vaccination Doesn't Work

When we breathe a virus or other microbe into our lungs, it gets caught in our respiratory mucosa, somewhere between our esophagus and lungs. There is an antibody in the respiratory tract mucosa called IgA which, when triggered by a virus, initiates the T cell (pac man) immune response. Bypassing this mucosal aspect of the immune system by directly injecting organisms into the bloodstream leads to a disabling in the immune system itself.

This results in the failure of our immune system to properly respond to viruses or bacteria allowing them to stay in the body where they will continue to grow, mutate and proliferate. This bypassing of the IgA immune system can

also lead to a hypersensitivity of the B cells, resulting in autoimmune diseases, in which the hypersensitized B cells errantly attack the cells of our own bodies, in addition to the invading organisms. The two poles of the immune system, the cellular (T cells activated through the mucosal system) and humoral mechanisms (B cells, activated through infections in cuts) have a reciprocal relationship. In other words, when one is stimulated, the other is inhibited. Since vaccines activate the B cells to secrete antibodies, the T cells are subsequently suppressed. The interaction between T cells and B cells is quite complex. Vaccination disrupts this interaction, causing unpredictable reactions.

To get an idea of how the T and B cells interact, consider this scientific assessment:

Helper T cells are arguably the most important cells in adaptive immunity, as they are required for almost all adaptive immune responses. They not only help activate B cells to secrete antibodies and macrophages to destroy ingested microbes, but they also help activate cytotoxic T cells to kill infected target cells. As dramatically demonstrated in AIDS patients, without helper T cells, we cannot defend ourselves even against many microbes that are normally harmless.

Helper T cells themselves, however, can only function when activated to become effector cells. They are activated on the surface of antigen-presenting cells, which mature during the innate immune responses triggered by an infection. The innate responses also dictate what kind of effector cell a helper T cell will develop into and thereby determine the nature of the adaptive immune response elicited.

Thus, the suppression of the T cell response can cause of the development of cancer and other infections. In fact, the “prevention” of a disease via vaccination is, in reality, a suppression of the T cell response, resulting in an inability to neutralize dangerous organisms. We acquire natural immunity when, after we have been through one sickness or another, our body

responds by allowing some of the antibodies produced during the illness to become "memory cells". These cells will "remember" the next time that particular antigen (virus) enters our system.

By bypassing or suppressing the T cell response, vaccination actually works against the immune system, not with it. It would not be unfair to say that vaccination triggers a host of microscopic reactions, none of which have been anticipated by the vaccine industry. Nor is the vaccination industry interested in investigating these microscopic reactions, for such study will only reveal the fallaciousness of current vaccination theory. Starting with Edward Jenner's cowpox studies, apparent past successes must now come to grips with current microbiological science. As the evidence begins to trickle in, despite Big Pharma's attempts to suppress it, the dangers and risks of vaccination are becoming evident. By

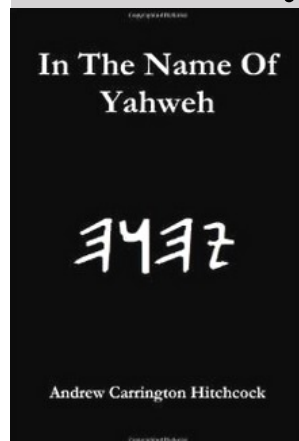

In The Name of Yahweh Part 25

JOHN 8:31 – **THEN SAID JESUS** to those Jews which believed on him, If ye continue in my word, [then] are ye my disciples indeed;

John 8:32 – *And ye shall know the truth, and the truth shall make you free.*

John 8:33 – *They answered him, We be Abraham's seed, and were never in bondage to any man: how sayest thou, Ye shall be made free?*

John 8:34 – *Jesus answered them, Verily, verily, I say unto you, Whosoever committeth sin is the servant of sin.*

John 8:35 – *And the servant abideth not in the house for ever: [but] the Son abideth ever.*

John 8:36 – *If the Son therefore shall make you free, ye shall be free indeed.*

John 8:37 – *I know that ye are Abraham's seed; but ye seek to kill me, because my word hath no place in you.*

John 8:38 – *I speak that which I have seen with my Father: and ye do that which ye have seen with your father.*

John 8:39 – *They answered and said unto him, Abraham is our father. Jesus saith unto them, If ye were Abraham's children, ye would do the works of Abraham.*

John 8:40 – *But now ye seek to kill me, a man that hath told you the truth, which I have heard of Yahweh (God): this did not Abraham.*

John 8:41 – *Ye do the deeds of your father. Then said they to him, We be not born of fornication; we have one Father, [even] Yahweh (God).*

John 8:42 – *Jesus said unto them, If Yahweh (God) were your Father, ye would love me: for I proceeded forth and came from Yahweh (God); neither came I of myself, but he sent me.*

John 8:43 – *Why do ye not understand my speech? [even] because ye cannot hear my word.*

John 8:44 – *Ye are of [your] father the devil, and the lusts of your father ye will do. He was a murderer from the beginning, and abode not in the truth, because there is no truth in him. When*

he speaketh a lie, he speaketh of his own: for he is a liar, and the father of it.

John 8:45 – *And because I tell [you] the truth, ye believe me not.*

John 8:46 – Which of you convinceth me of sin? And if I say the truth, why do ye not believe me?

John 8:47 – *He that is of Yahweh (God) heareth Yahweh's (God's) words: ye therefore hear [them] not, because ye are not of Yahweh (God).*

This is one of the most important passages of the Bible, and we can break **it down** as follows:

In John 8:31-32 Jesus talks of His disciples abiding in His word and the truth making them free.

The Jews first lie is in John 8:31 when they imply that they believe in Jesus.

Then in John 8:33 the Jews state that they have never been in bondage to anyone. If that is the case then of course they cannot be Israel, because Israel were in bondage in Egypt.

Jesus tells them he knows they are Abraham's descendants, this could be from a variety of race-mixers, here are two examples, the race-mixing Esau* (see their fate asterisked at the bottom of this section), or a branch of Simeon, see:

Genesis 46:10 – *And the sons of Simeon; Jemuel, and Jamin, and Ohad, and Jachin, and Zohar, and Shaul the son of a Canaanitish woman." i.e. Cain's Satanic race.*



We also know that King Solomon had Canaanite wives, another example of the mixture of Yahweh's Seed and Satan's seed.

When a son or daughter of Yahweh through Israel race mixes, their offspring lose their Israel heritage. Worse, if they race-mix with a seed of Satan, their offspring becomes the seed of Satan.

(Interestingly, in John 8:41, when the Jews deny they were born of fornication, fornication means race-mixing.)

Moving on to John 8:39, Jesus questions if the Jews are Abraham's children, as if so they would do the works of Abraham.

The Jews then claim Yahweh is their Father. Jesus states that if Yahweh was their Father, then they would accept Him.

Then Jesus delivers the verdict, the Jews' father is the devil.

Do note here that Jesus is referring to the Jewish race collectively, not a small group of corrupt Jewish leaders.

Also note that if Jesus was a Jew (a popular myth propagated by pastors in the, "Eve ate an apple," tradition, the tradition being that nowhere in the Bible is it stated), then His father would be the devil, whereas we already know His Father was Yahweh.

What John 8:44 does is leave us in no doubt that Cain's satanic seed are the Jews. We can find further evidence of this in the book of Ezekiel which reveals the destiny of Edom, the descendants of Esau:

Ezekiel 25:14 – *And I will lay my vengeance upon Edom by the hand of my people Israel: and they shall do in Edom according to mine anger and according to my fury; and they shall know my vengeance, saith Yahweh (the Lord GOD).*

John 10:22 – *And it was at Jerusalem the feast of the dedication, and it was winter.*

John 10:23 – *And Jesus walked in the temple in Solomon's porch.*

John 10:24 – *Then came the Jews round about him, and said unto him, How long dost thou make us to doubt? If thou be the Christ, tell us plainly.*

John 10:25 – *Jesus answered them, I told you, and ye believed not: the works that I do in my Father's name, they bear witness of me.*

John 10:26 – *But ye believe not, because ye are not of my sheep, as I said unto you.*

John 10:27 – *My sheep hear my voice, and I know them, and they follow me:*

John 10:28 – *And I give unto them eternal life; and they shall never perish, neither shall any [man] pluck them out of my hand.*

John 10:29 – *My Father, which gave [them] me, is greater than all; and no [man] is able to pluck [them] out of my Father's hand.*

John 10:30 – *I and [my] Father are one.*

John 10:31 – *Then the Jews took up stones again to stone him.*

John 10:32 – *Jesus answered them, Many good works have I shewed you from my Father; for which of those works do ye stone me?*

John 10:33 – *The Jews answered him, saying, For a good work we stone thee not; but for*

blasphemy; and because that thou, being a man, makest thyself Yahweh (God).

John 10:34 – Jesus answered them, Is it not written in your law, I said, Ye are gods?

Here we have another example of the Jews accosting Jesus, Jesus telling them that they are not of His sheep, Israel, and the Jews subsequently stoning Him again.

But John 10:34 is further evidence of who the Jews are when Jesus says that the Jewish law states that they are gods. “ Word for Word” Part 10

Translation by Stephen Howard Anderson



Chapter 18

1. Appeared to him Yahweh by the Terebinths of Mam're: as he sat in the doorway of his tent in the heat 2527 of the day.

2. He lifted up his eyes and looked, and behold, three men stood 5324 by him: and when he saw, he ran to meet them from the door of his tent, and bowed himself 7812 to the ground 776,

3. and he said, " Yahweh, if now 4994 I have found favor 2580 in Your eyes, do not 408 now pass by 5674 your servant 5650.

4. Take now a little 4592 water, and wash 7364 your feet 7272, and rest 8172 Yourselves under the tree:

5. and I will fetch 3947 a morsel 6595 of bread 3899 to sustain 5582 Your hearts 3820; and afterwards

You will pass on: for this reason You have passed over to Your servant." And they said, "So do that you have said."

6. Hastened 4116 Ab'raham into the tent to Sarah, saying, "Quickly 4116 make three measures 5429 of fine 5560 flour 7058, knead 3888 it, and make cakes 5692!"

7. And to the herd 1241 ran Ab'raham, and took a calf 1121/1241, tender 7390 and good 2896, and gave it to a lad 5288; and he quickly prepared it.

8. He took curds 2529 of milk 2461 and the calf which he had prepared, and set it before them; and he stood 5975 by under the tree, and they ate.

9. They said to him, "Where 346 is Sarah your wife?" And he said, "Behold, in the tent."

10. One said, "I will surely return 7725/7725 to you at the time 6256 of reviving 2416; and behold 2009, a son shall have Sarah your wife." And Sarah heard it in the doorway of the tent, which was behind him.

11. Now Ab'raham and Sarah were old 2205, and come 935 into days 3117, and had ceased 2308 to be 1961 Sarah of the way 734 of women 802.

12. And laughed 6711 Sarah within herself 7130, saying, "After 310 I am worn out 1086 shall there be for me delight 5730, with my lord 113 being old 2204 also?"

13. Said Yahweh to Ab'raham, "For what reason did laugh Sarah, saying "Shall I indeed 637 truly 552 bear 3205 when I 589 am old 2204?"

14. Is it too difficult 6381 for Yahweh this thing 1697? At the appointed time I will return to you, at the time of reviving shall have Sarah a son."

15. Denied 3584 Sarah, saying, "I did not laugh 6711." for she was afraid 3372. And He said, "No, for you laughed."

(Ab'raham Pleads for S'dom)

16. Rose up from there the men, and looked 8259 toward the face of S'dom: and Ab'raham walked with them to send them forth.

17. Said Yahweh, "Shall hide 3680 I from Ab'raham that which I do;

18. seeing that Ab'raham will surely become 1961/1961 a great nation and mighty 6099, and shall be blessed by him all the nations of the land?

19. For I know him, for the sake that he will command his sons and daughters and his household afterwards, and will keep 8104 the way 734 of Yahweh, and do righteousness 6666 and justice 4941, so that may bring Yahweh upon Ab'raham that which He spoke upon him."

20. Said Yahweh, "The outcry 2201 of S'dom and Amorah is great 7227, and their sin 2403 is very 3966 heavy 3513:

21. I will go down 3381 now, and see if by the outcry 6818 that has come to Me they have done completely 3617, and if not, I will know."

22. Turned 6437 from there the men, and walked towards S'dom: but Ab'raham yet stood before Yahweh.

23. And drew near 5066 Ab'raham, and said, "Will You also 637 sweep away 5595 the righteous 6662 with the wicked 7563?"

24. Perhaps 194 there are 3246 fifty righteous 6662 within the city: will You also 637 sweep away 5595 and not forgive 5375 the place 4725 for the sake 4616 of fifty of the righteous that are there 7130?

25. Far be it 2486 from You to do this thing, to put to death 4191 the righteous with the wicked 7563, and that should be the righteous as the wicked, far be it from You: shall the Judge 8199 of the land not do justice 4941?"

26. Said Yahweh, "If 518 I find 4672 in S'dom fifty righteous within the city, I will forgive 5375 all the place 4725 for their sakes 5668."

27. Answered 6030 Ab'raham and said, "Behold now, I have taken upon me 2974 to speak to Yahweh, and I am but dust 6083 and ashes 665:

28. Perhaps 194 there shall lack 2637 five of the fifty righteous: will you destroy 7843 for five the whole city?" And He said, "I will not destroy if I find there forty and five."

29. And he continued 3254 again 5750 to speak to Him, saying, "Perhaps there shall be found there forty." And He said, "I will not do it for the sake of forty."

30. And he said, "Let not now be kindled anger 2734 in Yahweh, and I shall speak: perhaps there

shall be found there thirty." And He said, "I will not do it if I find there thirty."

31. And he said, "Behold now, I have taken upon myself to speak to Yahweh: perhaps there shall be found there twenty." And He said, "I will not destroy for the sake of twenty."

32. And he said, "Let not now be kindled anger in Yahweh, and I will speak only 389 this time 6471, perhaps shall be found there ten." And He said, "I will not destroy for the sake of ten."

33. And went away Yahweh, as that He was finished 3615 with speaking to Ab'raham: and Ab'raham returned to his place.

Chapter 18 Notes

Verse 1 - Yahweh appears in the form of a man. He can be whatever He pleases, as He is the Creator of All Things. Ab'raham recognizes who He is right off, and addresses Him by His Name Yahweh. In verses 27,30,31,and 32, the Masoretes substituted 136 adonay for The Name of Yahweh. I have restored The Holy Name in those verses. Yashar 18:4



Verse 2 - 376 as "men" in this verse indicates male gender. These were not "men".

Verse 3 - No fooling Ab'raham. He knows who just arrived, and calls Him by His Name, Yahweh.

Verse 10 - "time of reviving" means "Springtime" in the idiom. Here Sarah is promised a son, despite her age. Romans 9:9; Yashar 18:9

Verse 11 - The "way of women" refers to the monthly female cycle, which had stopped for

Sarah. Yahweh will disregard that. There is nothing He cannot do.

Verse 12 - Sarah thought it was funny that as an old woman she might have a child, and laughs "to herself", ah... OOPS! Yahweh can even hear our thoughts! The word 5730 delight, refers to sexual pleasure. 1 Peter 3:6

Verse 13 , 14 - Yahweh heard Sarah's thoughts, and clearly informs her that **NOTHING** is too difficult for the Creator of All Things. She will bear a son.

Verse 15 - 3584 denied, is only a "vowel" difference from 3585 lying. Some translate it as such, as the consonants are identical. Of course Sarah was afraid, and she tried to get out of it. Sorry, but you can't fool Yahweh.

Verse 16 - Two "men" get up to leave, going towards S'dom.

Verses 22 - 33 - Yahweh stays, and Ab'raham pleads for S'dom and Amarah. I have restored The Holy Name where the Masorettes took it out.

Chapter 19

1. And came two divine messengers 4397 to S'domah 5467 at evening 6153: and Lot sat in the gate of S'dom 5467: and seeing them, Lot rose up to meet them, and bowed 7812 with his nose 639 towards the ground 776,

2. and he said, "Behold now, my lords 113, turn in 5493 now, to the house of your servant, and stay all night 3885, and wash 7364 your feet 7272, and you shall rise up early 7925, and walk on your way." And they said, "No, for in the public square 7339 we will stay the night."

3. And he urged 6484 them greatly 3966; and they turned in with him, and came into his house; and he made for them a feast 4960, and matsoth 4682 he baked 644, and they ate.

4. But before 2962 they lay down 7901, the men of the city of S'dom surrounded 5437 the house,

from young 5288 to old 2205, all the people from its entirety 7097:

5. and they called to Lot, saying, "Where 346 are the men that came to you tonight 3915? Bring them forth to us and we may know 3045 them sexually."

6. Went forth to them Lot at the doorway 6607, and the door 1817 he shut 5462 afterward 310,

7. and he said, "Do not, I beg you 4994 my brothers 251 act so wickedly 7489.

8. Behold now, I have two daughters that have not known a man; I will send them forth to you, and do to them what is good in your eyes, only 7535 to these 411 men do not do a thing: because for this they came under the shadow 6738 of my roof 6982."

9. And they said, "Stand 5066 back 1973!" And they said, "This one 259 came as a sojourner 1481, and he thinks he is a judge 8199/8199: now 6258 we will do worse 7489 to you than to them!" And pushed 6484 the men on Lot greatly 3966, and came near 5066 to break 7665 the door 1817.

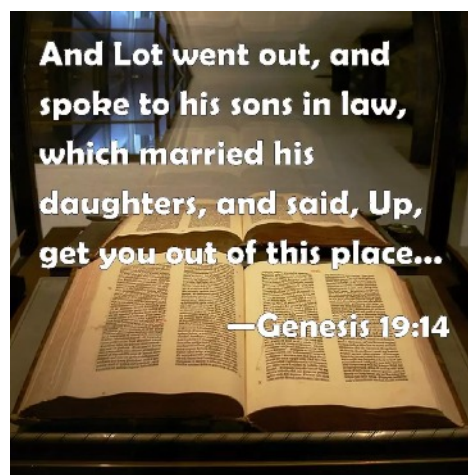
10. But sent forth the men their hand, and brought Lot to them in the house, and the door they shut.

11. And the that were at the door of the house they smote 5221 with blindness 5575, both small 6996 and great 1419: and they wearied 3811 themselves to find 4672 the doorway 6607.

12. And said the men to Lot, "Are there more 5750 who 4310 are of you here 6311? Son-in laws 2860, sons, and daughters, and all that you have in this city, bring forth from this place:

13. for we will destroy 7843 this place, because great 1431 is the outcry 6818 against them before Yahweh; and has sent us Yahweh to destroy it."

14. Went forth Lot, and spoke to his sons-in law, which had taken his daughters, and said, "Rise up and go forth from this place, for will destroy



Yahweh the city!" But it was mocking 6711 in the eyes of his sons-in-law.

15. As 3644 the morning dawn 7837 came up 5927, the messengers insisted upon 213 Lot, saying, "Rise up! Take your wife, and your two daughters, which you find here; lest 6435 you be swept away 5595 in the punishment for iniquity 5771 of the city!"

16. And he hesitated 4102, so seized 2388 the men his hand, and the hand of his wife, and the hands of his two daughters: for the mercy 2551 of Yahweh was upon him, and they brought them forth, and set 5117 them outside 2351 of the city.

17. And it was, when they brought them forth outside, they said, "Escape 4422 for your lives 5315; do not 408 look 5027 behind 310, and do not stand 5975 at all in the plain 3603; to the mountain escape, lest you be swept away!"

18. Said Lot to them, "No 408, please 4994, Yahweh!"

19. Behold now, has found your servant grace 2580 in Your eyes, and You have magnified 1431 Your mercy 2617, that You have done to me in keeping alive 2421 my being 5315; and I am not able 3201 to escape to the mountain, lest cling to me 1692 calamity 7451, and I die 4191:

20. behold now, this city is near 7138 to flee 5127 there 8033, it is a small thing 4705: let me escape there, and it is not a small thing that shall remain alive my being."

21. And they said to him, "Behold, I have lifted up 5375 your face 6440 also on this matter, and will not 1115 overthrow 2015 the city you spoke of.

22. Make haste 4116, escape there, for I am not able to do a thing until you go there!" Upon this was called the name of the city Tsoar 6820.

23. The sun 8121 had come forth upon the land when Lot came to Tsoarah 6820.

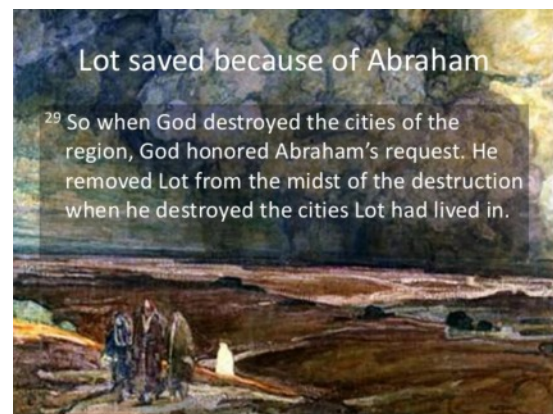
24. And Yahweh rained 4305 upon S'dom and upon Amorah brimstone 1614 and fire 784 from Yahweh from the sky.

25. He overthrew 2015 those 411 cities, and all the plain 3603, and all the dwellers of the cities, and that which grew 6780 on the soil 127.

26. And looked 5027 his wife 802 from behind 310, and she became 1961 a pillar 5333 of salt 4417.

27. And went early 7925 Ab'raham in the morning 1242 to the place where he had stood there before Yahweh:

30. Went up Lot from Tsoar, and dwelled in the hills 2022, and his two daughters with him; for he feared to dwell in Tsoar: and he dwelled in a cave 4631, he and his two daughters.

31. Said the firstborn 1067 to the younger 6810, "Our father is old, and of men are none 369 in the land to come to us in the way 1870 of all the land.

32. Come 1980, let us make to drink 8248 our father wine 3196, and we will lie 7901 with 5973 him, and keep alive 2421 from our father seed 2233."

33. And they made to drink their father wine that night, and went in the firstborn and lay 7901 with

her father; and he did not know when she lay down 7901 or rose up 6965.

34. And it was, on the morrow 4283, said the firstborn to the younger, "Behold 2005, I lay last night 570 with my father: let us make him to drink wine also tonight, and go you in and lay with him, so we keep alive from our father seed."

35. They made to drink also that night their father wine, and rose up the younger, and lay with him; and he did not know when she lay down or rose up.

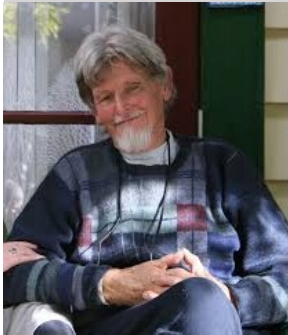
36. Were made pregnant 2029 both the daughters of Lot from their father.

Is Israel A Chosen Servant Race To "Save The World"? (Part 2) By Arnold Kennedy



**A verse they
confuse people
with is:**

ACTS 9:15 "But the Lord said unto him, Go thy way: for he is a chosen vessel unto me, to bear my name before the Gentiles, and kings, and the children of Israel".

This appears on the surface to suggest that there are Israelites and non-Israelites involved. In the phrase, "and the children of Israel", the word "and" here is translated in 62 other places as "both". Following this pattern, "the Gentiles and kings" are both of the Children of Israel, or to paraphrase this, "to bear my name before the peoples and rulers, both of whom are Children of Israel".

Further to this, many British-Israelites claim that what they call "the Church" is "by definition composed of people of all nations"-[This is a reference from "Bible Truth" -UK]. They talk about foreigners coming to join themselves to "the Lord" in Isaiah 56:3 and Zechariah 2:11 as if that made them one with Israel, but the word "join" has more the meaning of "borrow", or "attend" in the Hebrew. Although these foreigners see how God's blessing is upon Israel, these foreigners never can become equal, or "adopted" into Israel, nor "grafted in" in the way the denominations teach. A branch cannot

be grafted "in again" onto a tree unless it had previously been attached-[Rom. 11:22].

Another idea claimed is that when Peter says in 1 Peter 2:9, "But ye are a chosen generation, a royal priesthood, an holy nation, a peculiar people; that ye should shew forth the praises of him who hath called you out of darkness into his marvellous light", that the royal priesthood is to minister to all the other races. The simple response to this is to ask if a priest ministers to people, or "unto the Lord". In the fifth verse of this chapter we can see these words, "Ye also, as lively stones, are built up a spiritual house, an holy priesthood, to offer up spiritual sacrifices, acceptable to God by Jesus Christ".

All Denominational groups, including many British Israelites, express a wrong purpose in God's choosing Israel to be "above all other races, which expression brings much conflict into the Bible. As already pointed out, this is more often because of the wrong understanding of the word "Gentiles", which is also translated as "people", "nations", and "heathen". But the word is also used in the Israel context. So, what is God's expressed purpose for Israel? Let us examine the major verses they base their view upon.

**"IN THEE SHALL ALL NATIONS BE
BLESSED".**

Gal 3:7-9 Know ye therefore that they which are of faith, the same are the children of Abraham. And the scripture foreseeing that God would

justify the heathen through faith, preached (proclaimed) before the gospel unto Abraham, saying, in thee shall all nations be blessed. So then they which be of faith are blessed with faithful Abraham.

This verse together with and the verses below, are favoured by universalists because they seem to present a universal gospel for all races. "Nations" is sometimes translated emotively as "Heathen" to try to add weight to the universal argument. To understand any passage of Scripture it is necessary to look at it as a whole by going back to the prophecy behind it to see what it is fulfilling.

To Abraham:

Gen 12:2,3 *And I will make of thee a great nation, and I will bless thee, and make thy name great; and thou shalt be a blessing: and I will bless them that bless thee, and will curse him that curseth thee, and in thee shall all families of the earth be blessed.*

Gen 18:18 *Seeing that Abraham shall surely become a great and a mighty nation, and all the nations of the earth shall be blessed in him?*

Gen 22:18 *And in thy seed shall all the nations of the earth be blessed; because thou hast obeyed my voice.*

To Isaac:

Gen 26:3 *Sojourn in this land, and I will be with thee, and will bless thee; for unto thee, and unto thy seed, I will give all these countries, and I will perform the oath that I sware unto Abraham thy father.*

To Jacob:

Gen 28:14 *And thy seed shall be as the dust of the earth, and thou shalt spread abroad to the west, and to the east, and to the north, and to the south: and in thee and in thy seed shall all the families of the earth be blessed.*

To Israel:

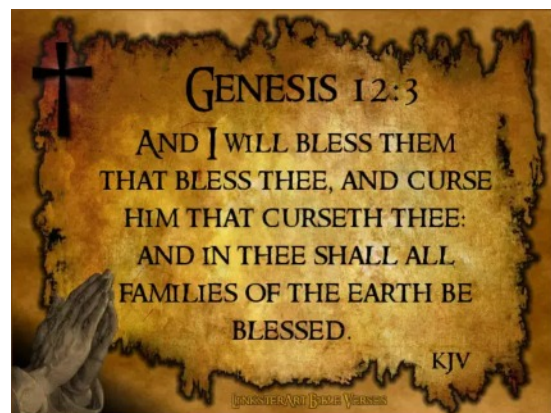
Psalms 22:27 *All the ends of the world shall remember and turn unto the Lord: and all the kindreds of the nations shall worship before thee.*

Here are six important verses that are used to support the doctrine of universal racial salvation. Indeed, they do appear to give valid support on the surface. But do they actually say what the religious translators make them say? Is this the problem here?

THE "FAMILIES OF THE EARTH" BEING BLESSED IN ABRAHAM

The major source of error in these blessing passages is what we mean by certain words. We have different words translated as earth and the ground, countries and the land, as also occurs with the words translated nations, families and kindreds. Although an extensive technical Hebrew language exposition is beyond the scope of this paper, there are things that need to be pointed out.

Originally Abraham was told to go from his father's house unto an *eretz* that God would show him. If *eretz* here is the whole Earth, then Abraham must have gone to another planet! Abraham was told all The 'Earth' which thou seest, I will give thee. He was told to arise and walk through the earth. Did he walk across the whole globe? So we have to ask if this 'earth' is the whole earth or the Promised Land. It is not all the *eretz*s of all the races on earth. Abraham was told to get himself out of his present earth and to go to THE earth. There are many references that give confirmation of the meaning. THE earth does not mean the whole globe, but rather that portion belonging to the particular area or person under consideration.



Contrary to popular presentation, we must note that in Genesis 12:3, the 'them' in I will bless them is plural, whereas the 'him' in "I will curse him" is singular. The Hebrew allows for two possible translations of be blessed, namely:

(1) may be blessed in, or by, association with thee, and

(2) may bless themselves [as the RV footnote says].

Some awkward questions could be posed here if it was to be taken that all nations had the meaning of "every race on earth":

If those who curse Abraham are cursed, how could those so cursed be part of all nations which were to be blessed?

Were the Egyptians blessed or cursed through Israel's presence during their captivity and also in the Exodus?

When the Children of Israel went into the Promised Land, they were told to exterminate all the Canaanite nations. Was not that an unusual way of blessing the Canaanites? After all, they were supposed to be part of all nations. Likewise Amalek was to be exterminated.

In Deut 23:6, God commanded Israel that they should not seek the peace or the prosperity of the Ammonites and the Moabites right up to the end of the age. Ezra 9:12 indicates similar treatment of the non-Israelites in the land. This is hardly a blessing on those nations, is it?

When The House of Judah was in captivity in Babylon, is there any evidence of Israel being a blessing to Babylon?

When the House of Israel was in captivity in Assyria, did this make the Assyrians blossom?

In prophecy why are all the forecasts concerning non-Israel nations always detailing them as being servants to Israel and for them to perish if they refuse this destiny? This is so right up to the end of the age.

The promise to Abraham was to "ALL" nations without any exceptions. "All" cannot include those who are cursed and those God says that He hates. Hence "all" means all the nations of Israel.

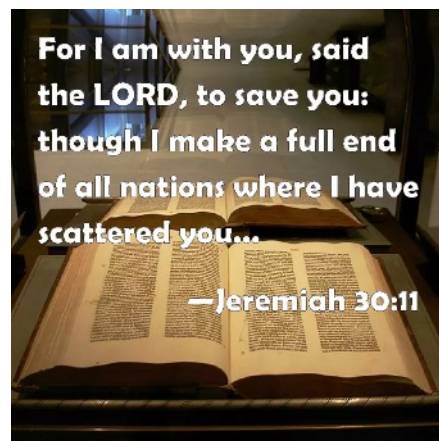
Throughout Scripture, Israel was to dwell alone and shall not be reckoned among the nations [Num 23:9]. Prophecy sustains this to the end.

Daniel 7:27 *And the kingdom and dominion, and the greatness of the kingdom under the whole heaven, shall be given to the people of the saints of the most High, whose kingdom is an everlasting kingdom, and all dominions shall serve him.*

Isaiah 60:12 *For the nation and kingdom that will not serve thee shall perish; yea, those nations shall be utterly wasted.*

Zech 14:16,17 *And it shall come to pass, that every one that is left of all the nations which came up against Jerusalem shall even go up from year to year to worship the King, the Lord of hosts, and to keep the feast of tabernacles. And it shall be that whoso will not come up of all the families of the earth unto Jerusalem to worship the King, the Lord of hosts, even upon them shall be no rain.*

Israel and Judah were scattered among all nations, but are these other nations to be blessed? Jeremiah does not agree.



Jer 30:11 ... though I make a full end of all nations whither I have scattered thee, yet I will not make a full end of thee ...

Jeremiah repeats this in Jer 46:28, addressing this to Jacob.

In all these Scriptures we can see the unique place of Israel among the other nations. This continues after Jesus returns and Israel reigns with God over the other nations. Finally there will be no more death. What a blessing! The blessing is either given by this seed, or by the Act of God.

"for I have created him [ISRAEL] for my glory!"

A full treatment showing that there is no change made in God's purpose for Israel under the New Covenant is made in "The Exclusiveness of Israel" (as referred to above). So we will consider God's purpose for Israel, continuing with the Isaiah chapters used by the Jewish claims as quoted earlier in this paper. We have ample evidence through the New Testament that the "it is written" does not change under the New Covenant. Can we surpass, or deny, God's purpose for Israel as shown in the following verses which express aspects of God's purpose?

Isaiah 46:13 "and I will place salvation in Zion for Israel my glory".

Isaiah 43:7, "for I have created him (Israel) for my glory".

Isaiah 43:21 " This people have I formed for myself; they shall shew forth my praise"?

Isaiah 49:3 "And said unto me, Thou art my servant, O Israel, in whom I will be glorified.

We can compare these verses listed above against the list of presentations listed above from Jewish and British-Israel sources. The Jewish sources mention Isaiah chapters 42-49, in which they claim that such phrases as "to the nations" represent all mankind. But when we look at each context, we can see that the phrases refer only to the peoples of Israel. Looking at all the other passages quoted from Isaiah, we can see that these are totally in the context of Israel only, and not of all mankind. For example:

Isaiah 43:3 For I am the LORD thy God, the Holy One of Israel, thy Saviour.

There is no mention in Scripture of God being the Saviour of other than the "world" of Israel.

A Miscellany of Historical Facts Mainly Relating to The British Isles 1 Religion (Part 4)

ST HELEN OF THE CROSS: AD 248-c 330; renowned British Empress and one of most important figures in Western history [see Helen]; Helen was the daughter of a British monarch, Cole II, and married the Roman Emperor Constantius Chlorus; their son was mighty Constantine the Great, who legalised Christianity in the Roman Empire; in the same year as her son convened the Council of Nicea to establish Church doctrine, AD 325, she journeyed as a widowed Empress with imperial funding and a massive Roman military escort to the Holy Land to find Christian relics.



She is said to have obtained the Holy Cross there, covering it with jewels and gold and placing it in a silver casket; the nails from the cross she had made into a bridle bit for her son's horse; the town of St Helen's in Lancashire is named after her and there are churches in Britain that preserve her name; a stained glass window in

Landaff Cathedral, South Wales, depicts King Arthur carrying St Helen's Cross on his shoulder after victory at the Battle of Baedan against the Saxons; Helen and Constantine her son were key figures in the rise of Christianity to become the religion of the West.

Linus: son of captured King Caractacus [see Caractacus]; Caractacus had led the resistance to the Emperor Claudius after the Roman invasion of Britain in AD 43; he said before the Roman Senate, "If you wish to lord it over the world, does it follow that the world is to accept slavery?"; he received clemency; Prince Linus became the first appointed Bishop of Rome in AD 58, i.e. the first Pope before the term was used; Linus was installed by St Paul in St Peter's lifetime, the latter never holding formal office in Rome; the British royal Christians in Rome are mentioned by St Paul in

his writings, in 2 Timothy 4:21 in the New Testament [see Claudia & More 11]; note though that the online Catholic Encyclopaedia dates Linus's reign as Bishop of Rome to a later time, 67-76.



Eleutherius: (Left) r 175-89; contemporary of Britain's King Lucius, the world's first Christian ruler, with whom he shared a famous correspondence [see Lucius]

Simplicius: r 468-83; contemporary of King Arthur, misnamed 'Sulpicius' by medieval

historian Geoffrey of Monmouth [see Arthur, Geoffrey of Monmouth]

Pope Joan: a woman masquerading as a man, born early AD 800's; she reputedly reigned for two years as Bishop of Rome under the name of John VIII, Anglicus, i.e. 'of England', and there is a bust of her/him at Sienna Cathedral; Pope Joan is said to have died in childbirth during a papal procession

Stating a position: in 1080 the Bishop of Rome was reminded in a letter from William the Conqueror that the King of England owed him no allegiance

Adrian IV: this was Englishman Nicholas Breakspear, who died in 1159, apparently by choking to death on a fly in his wine - a pioneering demise among Bishops of Rome, not since emulated

Coincidences: in 1981 Prince Charles married Diana, Liverpool were crowned club football champions of Europe, Australia lost the Ashes cricket contest with England and a pope died; in 2005 Prince Charles married Camilla, Liverpool were crowned club football champions of Europe, Australia lost the Ashes cricket contest with England and a pope died

Pelagius: AD c 354-c 430; a holy man of Britain who denied the Christian doctrine of original sin; he promoted the idea that salvation depends on human free will, as well as the grace of God, which was later declared a heresy

St Patrick: the patron saint of Ireland and a religious genius; he was born in the west of Britain and probably returned there to become Abbot of Glastonbury in AD 439

St Augustine of Canterbury: this personage is not to be confused with St Augustine of Hippo; St Augustine of Canterbury landed on Isle of Thanet in AD 597 on a papal mission; the west of Britain had already been Christian for hundreds of years, but not the Saxon part, which was pagan; his remit was to bring the whole of Britain under the sway of Roman Catholicism; he failed with pre-existing church of Britons in the west, but converted local Anglo-Saxon king, Ethelbert, and conducted mass baptisms; Augustine was the first Archbishop of Canterbury; he founded the Church of England, which was called as such by AD 1100's; there are 12,000 medieval-and-earlier churches still existing in Britain, 16,000 parish churches in all; the Pope's influence was finally thrown off after 900 years by Henry VIII Tudor, who was descended from ancient British stock.

St David: d 589; Wales's patron saint is the only one of the four in the British Isles to be native of the country of which he is patron saint; St David said, 'Do the little things in life'

Archbishops: there have been Christian archbishops in London since the time of King Lucius in the second century AD [see Lucius]; the first of these was Theon, starting c180, according to Holinshed & Enderbie [see Sources; for Enderbie's list, see More 1]; the unlucky 13th and last of the early era was Vodinus, who was killed by the Saxons in the 430's; prior to him was Guithelinus.

He relayed the news to the Britons in 410 that the Romans were leaving, arranged for a king, Constantine, to be shipped over from Brittany ('Less Britain') and later raised two of Constantine's children, one of whom, Uther Pendragon, was father to King Arthur - who held back heathen Saxon invaders for a generation [see Arthur];.

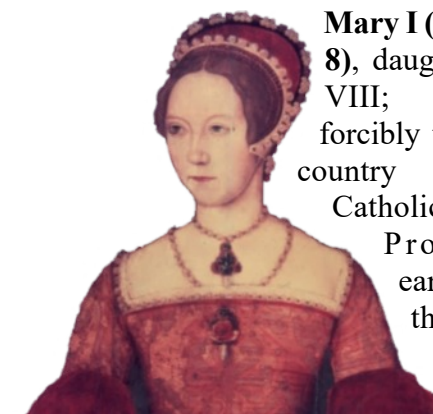
The other archbishops in this section were of Canterbury in Kent, which was a pagan site before it became a Christian one and which is a mysteriously accurate 30° west of the Great Pyramid of Giza; the first Archbishop of Canterbury was St Augustine [see above]; St

Dunstan (c 909-88) hailed from Glastonbury and was the dominant personality in Britain in the AD 900's; Dunstan devised the coronation service for the monarch which is still in use today and wrote the Coronation Oath, through which each sovereign enters a new covenant with the people to uphold law, justice and mercy [see Modern British Constitutions].

In AD 955 Dunstan dragged to his coronation teenage King Edwy, who was in bed with his mistress and her daughter; he exercised power through five reigns; St Alphege (954-1012) was captured by the Vikings and murdered by them.

St Anselm (c 1033-1012), an Italian, was the leading theologian of his day, being the founder of scholasticism and the inventor of the ontological argument for God's existence; at his insistence slavery was abolished in England in 1102; St Thomas Becket was murdered in Canterbury Cathedral by Henry II's knights in 1170; with his dying breath he invoked St Alphege's martyrdom in AD 1012.

Becket's murder was witnessed by the archbishop's cross bearer, the aptly named Edward Grim; Stephen Langton (1150-1228) divided the books of the Bible into chapters and also suggested to King John the deal with his barons that led to Magna Carta, the forerunner of all modern constitutions; in the present day, the Archbishop of Canterbury is world leader of the Anglican church, whose headquarters is Lambeth Palace, in Westminster, London; at Lambeth Palace in 1558 died peacefully.



Mary I (reigned 1553-8), daughter of Henry VIII; Mary tried forcibly to convert her country back to Catholicism from Protestantism, earning herself the sobriquet 'Bloody Mary'; Archbishop

Ussher: 1581-1656; Anglo-Irish prelate who calculated from the life spans of those in the Bible that the world had been created during the night preceding 23 October 4004 BC; the head of the church of England in the 21st century is Queen Elizabeth II.

Christian missionaries: many have been British down the aeons, including Bishop Henry of Upsala, a Briton who founded the Finnish church in the AD 1100's

Religious independence: after the Christian Reformation and the rise of Protestantism, Britain broke with Rome and Roman Catholicism in the period 1529-33, under Henry VIII; it was a freeing of the British mind for greatness [see More 5]; religious toleration was to arrive later.

Bible in English: the Lollard movement was a precursor to the Protestant Reformation; the founder of the Lollards was John Wycliffe, AD mid-1320's-84; he was the first translator of the Bible into English; as a proto-Protestant he is known as 'The Morning Star of the Reformation'; the 'Great Bible' commissioned by Henry VIII and published in 1539 was the Bible's first authorised English translation; it was translated by Myles Coverdale and partly based on the work of William Tyndale; 1609 saw the Roman Catholic Bible translated into English (complete); this was the Douai Version, English College at Douai, printed in London [Source: Robertson/Shell]; the King James Authorised Version of 1611 is one of history's most influential books.

It incorporated the work of William Tyndale, who is thus one of the founders of English literature; in 1536 Tyndale was burnt at the stake outside Brussels as a heretic; another widely influential work was the Book of Common Prayer of 1549

Westminster Abbey & St Paul's Cathedral: the Abbey was built by Edward the Confessor (reigned 1042-66) and consecrated in 1065; it had previously been the site of a Temple of Apollo destroyed by an earthquake in Roman times; Edward died eight days after building work had ceased; a palace was built nearby, with the court moving from Winchester, which had been founded by Dunvallo Molmutius as the seat of government and used thus by Canute the Great, to London; this became the site of coronations and the burial place of monarchs.

Poet's Corner is the last resting place of scribblers; many other notables are buried at nearby St Paul's Cathedral, including its architect, Christopher Wren (1632-1723), who

was the first to find snug lying there – rather than in one of his other 51 London churches – and whose tomb inscription can be translated as ‘Reader, if you seek a memorial, look around you’ [see History in the news, Press release 1]

Sun-Fire worship: Pliny the Elder, AD23-79, remarked that the ancient Persians, the most famed of the later Eastern Sun-Fire worshippers, seemed to have derived their rites from Britain [see Sources: Waddell, p184]; ‘The persons generally called “wise men from the East” were, we find, as corrected in the Revised Version of the New Testament, “Magi,” (Matt. ii I), a term solely used for the priests of the Sun and Fire-cult...’ (Waddell, p279); Magus, founder of the Magi, was an ancient king of Britain, according to Holinshed [see Celts]; during the Roman era Mithraism came back the other way, to Britain,

with a different solar-celestial viewpoint; the Tysilio Chronicle mentions the presence in London several centuries BC of a Temple of Apollo, who was a solar deity; this was on the site of what is now Westminster Abbey

Agnostic: from Greek meaning ‘without knowledge’; the word was minted by the biologist Thomas Henry Huxley, 1825-95, to describe someone who doubts whether it can be decided whether God exists or not; Huxley was a great champion of evolutionary theory and became known as ‘Darwin’s bulldog’; the great biologist Charles Darwin in fact had a brace of important ‘hounds’ in his life, the other being the Beagle [see Charles Darwin]

The Pagan “Star of David” Part 3

IN FACT, NOTES DANKENBRING, "a Jewish Orthodox internet website tells us: The Magen David (shield of David, or as it is more commonly known, the Star of David) is the symbol most commonly associated with Judaism today, but it is actually a relatively new Jewish symbol. It is supposed to represent the shape of King David’s shield (or perhaps the emblem on it), but there is really no support for that claim in any early rabbinic literature. In fact, the symbol is so rare in early Jewish literature and artwork that art dealers suspect forgery if they find the symbol in early works" (The "Star of David" is Pagan!).

The hexagram was also widely regarded as a messianic symbol, because of its legendary connection with David, ancestor of the Messiah. On Sabbath eve, German Jews would light a star-shaped brass oil lamp called a Judenstern (Jewish star), emblematic of the idea that Shabbat was a foretaste of the Messianic Age. The hexagram was also popular among the followers of Shabbatai Tzevi, the false messiah of the 17th century, because of its messianic associations.

Another use of the hexagram in medieval times was as a Jewish printer's mark or heraldic emblem, especially in Prague and among members of the Jewish Foa family, who lived in Italy and Holland. In 1354, Emperor Charles IV of Prague granted the Jews of his city the privilege of displaying their own flag on state occasions. Their flag displayed a large six-pointed star in its centre. A similar flag remains to this day in the Altneuschul, the oldest synagogue in Prague. From Prague, the "Magen David" spread to the Jewish communities of Moravia and Bohemia, and then eventually to Eastern Europe.

The Jewish community of Prague first used the Star of David as an official symbol in the 17th century and, since then, the six-pointed star, Magen David or the Star of David, became

the official seal of many Jewish communities. In 17th-century Vienna, the Jewish quarter was separated from the Christian quarter by a boundary stone inscribed with a hexagram on one side and a cross on the other, the first instance of the six-pointed star being used to represent Judaism as a whole, rather than an individual community.

With Jewish emancipation following the French Revolution, Jews began to look for a symbol to represent themselves comparable to the cross used by their Christian neighbours. They settled upon the six-pointed star, principally because of its heraldic associations.

Its geometric design and architectural features greatly appealed to synagogue architects, most of whom were non-Jews. Ironically, the religious Jews of Europe and the Orient, already accustomed to seeing hexagrams on cabalistic amulets, accepted this secularised emblem of the enlightened Jews as a legitimate Jewish symbol, even though it had no religious content or scriptural basis.

In the 19th century, Jews almost universally adopted the Star of David as a symbol of their race -- only decades after the Rothschilds adopted this symbol in 1822 as their family coat of arms. Since the Rothschilds were Cabalists, they adopted this powerful magic symbol for their coat of arms in order to claim its inherent occult power as their own.

The Modern State of Israel

"Why and how did the six-pointed star -- the pagan occult symbol -- become connected with the MODERN state of Israel?" asks Dankenbring -- "It was adopted as the family crest or shield by the Rothschild family during the 19th century. The Rothschilds bought a great deal of property in Israel, from the Turks and Arabs, and were amongst the major supporters of the Zionist movement in the early decades. The influence of the Rothschilds and their heavy financial support of Israel, led the Jewish nation to adopt the so-called 'Star of David' as their own symbol as a nation" (The "Star of David" is Pagan!).

When an Ashkenazi Jew by the name of Mayer Amschel hung a red hexagram on his door to identify his address, he was also proclaiming

himself a master Kabbalist. Moreover, it symbolized the appropriation of the Magen David by the Ashkenazi (the Khazar Jews) as the future symbol for their movement. Mayer then changed his name to "Roth Schild," meaning "Red Shield" when he became a supplier of coinage to the royal court and when his family's unexampled rise to power truly began.



The nascent Zionist Movement, led by Theodor Herzl, (left) adopted the House of Rothschild's blazonry because its ultimate source was this family and its fabulous wealth and power. Consequently, both destinies, the Rothschild and

Zionism, became intertwined with the Zionist Movement -- wholly dependent upon the goodwill and largesse of this Khazar family. In time, the hexagram appeared in the centre of the flag of the new Jewish state of Israel and has become associated with national redemption.

During the Holocaust, the Nazis chose the yellow star as an identifying badge required on the garments of all Jews. After the war, Jews turned this symbol of humiliation and death into a badge of honour.

Today, the Star of David is the most popular and universally recognized symbol of the Jewish People. In his seminal work entitled the Star of Redemption (1912), Franz Rosenzweig framed his philosophy of Judaism around the image of the Jewish star, composed of two conceptual "triads," which together form the basis of Jewish belief: Creation, Revelation, and Redemption; God, Israel, and World. On the popular level, Jews continue to use the Jewish star as it was used for centuries: as a magical amulet of good luck and as a secularised, though pagan, symbol of Jewish identity.

What Does YEHOVAH GOD Say?

The Star of David (Magen David) is a pagan symbol for a pagan, gentile people who usurped the role of YEHOVAH God's chosen people and who, as a result, have brought down YEHOVAH's condemnation upon themselves!

The Ashkenazi Jews fulfil the prophecies of the "Synagogue of Satan" found mentioned in the Book of Revelation:

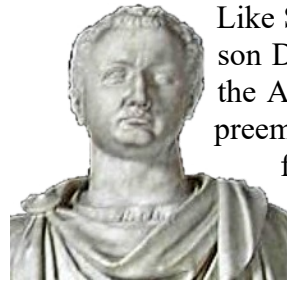

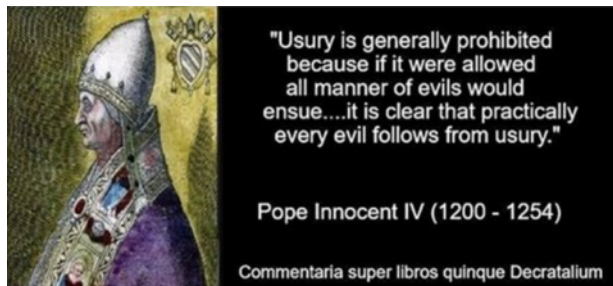
Thousands were sent to British run concentration camps during the Boer wars. Churchill summed up his time in South Africa by saying "it was great fun galloping about".

Sir ____, The translation of Sylvia Stolz's speech below might be of interest to your readers:—

Hitler and the National Socialists are considered as bad as the devil. They have done a few good things, but, in principle they are to be looked on as criminal." Many youngsters think this way and naturally many adults as well.

This question arises, how did all this begin? For many one of the starting points is Nuremberg! The Nuremberg Trials were organised by the victorious powers; i.e. the Americans, the English, the French and the Russians. The rules and regulations adopted for carrying out the war-crime proceedings had been worked out primarily by the Americans in collaboration with the Jewish World Congress under the leadership of the Robinson brothers.

This has been acknowledged; among others Nathan Goldberg wrote about it in detail, Absolutely new principles were formulated, so-called legal principles which, however, have nothing to do with jurisprudence. In these legal proceed-

ings the victors were the judges and the accusers. The defence was basically bogus only there for appearances sake.

They had virtually no rights and hardly any possibility to fulfil their task. The defence did not have, for example, access to all court documents. In the run-up to the case the prosecutors had already excluded certain subjects and facts of the case which were not even permitted to be admitted into evidence. And the defence were explicitly told this.

The submittals, which the defence wanted to introduce in the Nuremberg Trials, were rejected by the so-called judges on the grounds that the evidence had no significance. In addition, many witnesses were not admitted at all. One can therefore conclude that decisive, exonerating circumstances and witnesses were not even allowed in the Nuremberg Trials.

Accordingly, the verdict passed corresponded to this, that is as decided from the very start by the victors. The chief prosecutor, Jackson had made it known prior to the case - and this is recorded in the protocols of the Nuremberg Trials - that these trials were a continuation of the war effort. Moreover, this has also been noticed abroad: many French, Americans, and English have noticed that the Nuremberg Trials were a sham. Hard judgements were imposed. United Nations Caught Rewriting Balfour Declaration Records

The United Nations has been caught altering Balfour Declaration documents in an attempt to erase warnings made by British politicians about the devastating effect the state of Israel would have on the Palestinian people.

According to an official UN document published by the Division for Palestinian Rights of the United Nations Secretariat, a 1992 House of Lords debate on the Balfour Declaration was recently edited.

The Balfour Declaration—dated 2 November 1917 – called for the establishment in Palestine of a national home for the Jewish people—it being clearly understood that nothing would be done which might prejudice the civil and religious rights of existing non-Jewish communities in Palestine or the rights and political status enjoyed by Jews in any other country.

Balfour Declaration was subsequently written into international law

The Balfour Declaration was subsequently written into international law after being incorporated into the League of Nations Mandate for Palestine on 24 July 1922.

The upcoming centenary of the Balfour Declaration has prompted a concerted international campaign calling on the British Government to apologise for another Government’s decision taken 100 years ago.

Baroness Anelay—Minister of State (Foreign Commonwealth Office) – told the House of Lords on 3 April 2017 that no such apology would be forthcoming.

The UN’s rewriting of Parliamentary debate records actually came to light whilst I was researching the source of a quote appearing in four articles by Stuart Littlewood.

Our Digestive Tract

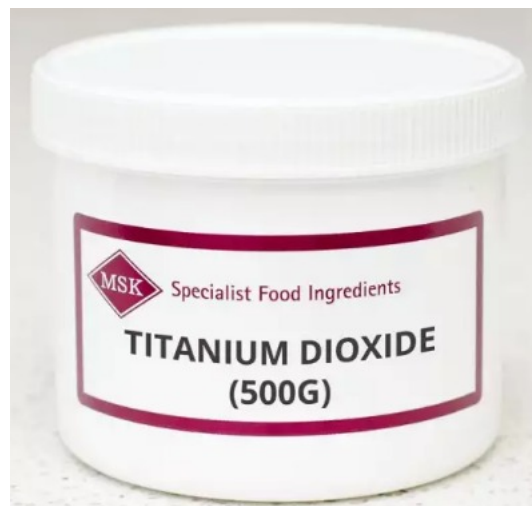
The actual process of becoming obese starts in our digestive tract, where particles of Titanium dioxide excoriate the microvilli, which line the walls of our digestive tract.

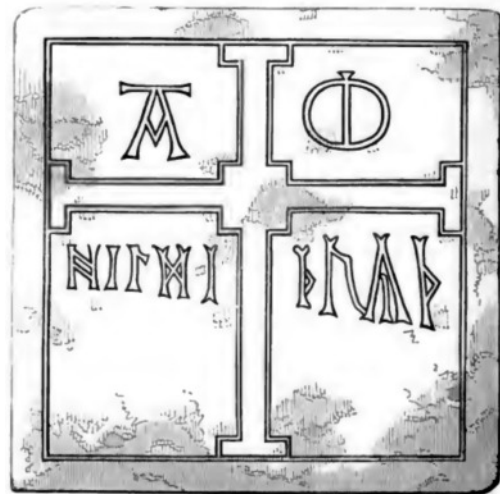

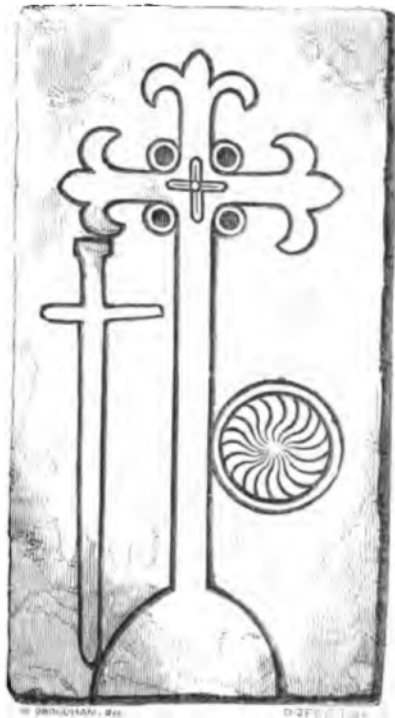

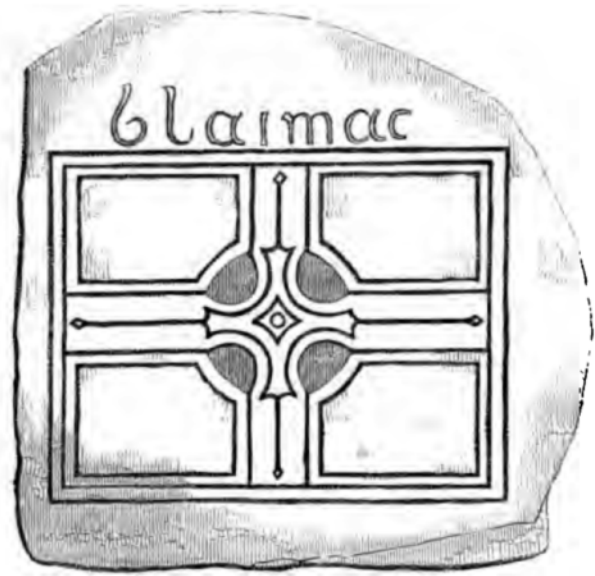

King Christian pawned his lands in the islands of Shetland to King James III of Scotland in 1469 as security in the matter of payment of a marriage dowry **AND:**

Kings of Scotland at various times, including 1549, 1550, 1558, 1560, 1585, 1589, 1660 and other intermediate years, evaded the rightful redemption of the King's lands when the money was lawfully offered **AND:**

the only powers granted to King James III in Shetland were those of trustee of the King's lands until they were redeemed, and of general administrator (but not sovereign) of Shetland as a whole **AND:**

part of his obligation was to preserve the existing language and laws **AND:**

We, the Sovereign Citizens of Shetland do hereby redeem and declare our Sovereignty, which is our birthright.

We, the Sovereign Citizens of Shetland, do declare the right to the ownership of Shetland, and to the unfettered control of Shetland destinies, to be sovereign and indefeasible.

We, the Sovereign Citizens of Shetland, being the absolute and rightful owners of the islands of Shetland, do declare and announce the formation of the Sovereign Nation of Shetland.

We, the Sovereign Citizens of Shetland, declare that we owe no allegiance to any United

Kingdom government and are not bound by any of its statutes.

We, the Sovereign Citizens of Shetland, acknowledge the rights of Her Majesty Queen Elizabeth II as being the same, and not more, than were granted to King James III in 1469. We hold Her Majesty to her oath to govern according to our laws and customs.

Further: We hereby invite all residents of Shetland to declare their Sovereignty and join with us to set up a true and just administration, based on principles of democracy ensuring that our elected representatives execute the wishes of the people.

We hereby invite all residents of Shetland to join their properties with that of The Sovereign Nation of Shetland under such new administration.

We hereby invite anyone from any country in the world, who supports these aims, namely to live in a free and just society, to become a citizen of The Sovereign Nation of Shetland.

We hereby invite other countries to recognise The Sovereign Nation of Shetland as a political entity in its own right.

Long live the Sovereign Nation of Shetland.

One by one, we must each take responsibility for our lives and our world.

Note Who has ever heard of the battle of Stennis? Few indeed. While most countries define and celebrate their history by the battles fought, this is an example of how the history of Shetland and Orkney has been suppressed. Hibbert writes:—

In the year 1530, King James V. was induced to make an hereditary grant of the estate of the Crown in Orkney and Shetland to his natural brother James, Earl of Moray. When the islanders saw that a feudal superior was intended to be interposed between them and the sovereign, they were alarmed that the ancient laws of the country were about to suffer a corresponding change.

Headed by Sir James Sinclair, the Governor of Orkney, they arose in arms, to resist the arbitrary innovation. The Earl of Caithness, and his kinsman Lord Sinclair, were sent out against them: the udallers met their opponents on the confines of Stennis, and, in a sanguinary engagement, defeated them with great slaughter.

The Earl of Caithness, and 400 of his followers, were slain; the rest were taken prisoners". This battle was in Orkney, but it involved both Orkney and Shetland udallers and is of fundamental importance to Shetland.

Crossing the Red Sea and May Day Charlotte Missouri



Overview

MAY DAY IS CELEBRATED in Europe and Canada. It was a tradition in the United States also;

however it has long been forgotten. It is said that May Day was to commemorate the Roman goddess Flora on April 27th before the time of Christ.

The traditions that are celebrated today and in the past reflect a connection to the Israelites crossing the Red Sea on the last day of the Unleavened Bread Feast.

Depending on the time of the spring equinox, the spring feast days are as follows:

- **Abib 14** is Passover on April 2nd or April 3rd. This is the date of the first Passover

in Egypt. The first born of Egypt were killed that night and the first born of Jacob-Israel's descendants were saved. (Exod 12:6)

Abib 15 is the Unleavened Bread Feast that starts on April 3rd or April 4th. This is the day the Israelites left Egypt with all their possessions and where no longer slaves. They left while the Egyptians were burying their dead.

Abib 21 is the last day of the Unleavened Bread feast which is on April 9th or April 10th. This is the day the Israelites crossed the Red Sea and entered the Wilderness of Sur.

When Rome became corrupted they no longer allowed Passover to be celebrated. Later Constantine instituted Easter which does not occur on the same day each year so the descendants of Jacob-Israel started celebrating the feast of Unleavened Bread after Easter

The Exodus

The last day of the Unleavened Bread Feast is the day the Israelites crossed over the Red Sea into the Wilderness of Sur. (Exo 12:15-16, Num 33:8, Exo 14:13-23 & 15:22) They left Egypt with their belongings since they were moving to a new place. When they crossed the red sea it must have been very noisy since there was over a million Israelites crossing in a hurry with their belongings and cattle. After they crossed the red sea, this was recorded:

“Then the princes of Edom, and the chiefs of the Moabites hasted; trembling took hold upon them, all the inhabitants of Chanaan melted away. Let trembling and fear fall upon them; by the greatness of thine arm, let them become as stone; till thy people pass over, O Lord, till this thy people pass over, whom thou hast purchased. Bring them in and plant them in the mountain of their inheritance, in thy prepared habitation, which thou, O Lord, hast prepared; the sanctuary, O Lord, which thine hands have made ready.

The Lord reigns for ever and ever and ever. For the horse of Pharaoh went in with the chariots and horsemen into the sea, and the Lord brought upon them the water of the sea, but the children

of Israel walked through dry land in the midst of the sea. And Mariam the prophetess, the sister of Aaron, having taken a timbrel in her hand-- then there went forth all the women after her with timbrels and dances. And Mariam led them, saying, Let us sing to the Lord, for he has been very greatly glorified: the horse and rider has he cast into the sea.” Sep Exod 15:15-15:21



The dance that Mariam did with the other women later became the May Pole Dance. Here is a 1919 newspaper picture of the May Day dance being performed in Philadelphia.

The tambourine dance must be very old custom if Mariam the prophetess was performing this dance after the crossing of the red sea. In the early 1800's, when May Day celebration was a big event, America was a great place to live since we were connected with our past culture. (See table on next page)

Goddess Maia

The month of May was named after the goddess Maia who was really the prophetess Mariam.

“The month May was named for the Greek Goddess Maia, who was identified with the Roman era goddess of fertility, Bona Dea, whose festival was held in May.”

Bona Dea ("The Good Goddess") was a divinity in ancient Roman religion. Men were barred from the possession of her true name. The goddess Bona Dea is also known as Terra who is also known as Maia. Terra is associated with the earth and means earth in Latin. Maia is again really the prophetess Mariam.

Goddess Flora

May Day Traditions	The Exodus & the Red Sea Crossing
In Great Britain they do the maypole dance. Some run into the North Sea at sunrise. In Oxford, it is traditional for some people to jump off the Magdalen Bridge into the River Cherwell. Some wash their face with the morning dew.	Running into the North Sea and jumping into the river are similar to crossing the sea. The Maypole dance is like the dance the prophetess Mariam did. Yahweh provided the Israelites manna bread with the morning dew
In Ireland they sometimes call it ‘Mary’s Day’	Mary’s day in honour of the prophetess Mariam. In the bible translated from Latin, Douay-Rheims, Mariam was called Mary. In the earlier Wycliffe bible she was called Marie
In Greece it is called ‘Maia Day’	Called Maia’s day also in honour of the prophetess Mariam.
In Romania some wash their face with the morning dew	Yahweh provided the Israelites manna bread with the morning dew.
Ontario, Canada some do a May day dance and the song Hal-An-Tow and Padstow.	The song mentions Mary and Moses spelt Mosyses
The United States use to celebrate by moving furniture in the morning hours and then a Maypole dance (see news here)	The Israelites moved from Egypt and took their belongings; therefore they were moving their furnishings. The Maypole dance is like the dance the prophetess Mariam did.

May Day is said to be the celebration of the goddess Flora in ancient times. This celebration last 6 days and the biblical Unleavened Bread Feast lasted seven days. Flora was the goddess of flowers:

“In ancient Roman religion, the Floralia was a festival in honour of the goddess Flora, held April 27 during the Republican era, or April 28 on the Julian calendar. In Latin, the festival was known as the Ludi Florae, the Games (ludi) of Flora. Under the Empire, the games lasted for six days.”

*“In Roman mythology, Flora (Latin: Flōra) was a Sabine-derived goddess of flowers and of the season of spring – a symbol for nature and flowers (especially the may-flower). Her name is derived from the [Latin](#) word "flos" which means "flower". In modern English, "Flora" also means the plants of a particular region or period. **Her festival, the Floralia**, was held between April 28 and May 3 and symbolized the renewal of the cycle of life, drinking, and flowers.”*

"They also set up a May-pole, drinking and dancing about it many days together, inviting the Indean women, for their consorts, dancing and

frisking together, (like so many fairies, or furies rather,) and worse practices. As if they had anew revived & **celebrated the feasts of the Roman Goddess Flora.”**

*“In ancient Rome the first day of May fell during the **festival of Floralia**, named in honor of **Flora, the goddess of springtime and flowers**. It was a time of singing, dancing, and flower-decked parades, and also to hang flowers on a loved one's door. Roman prostitutes especially enjoyed the festival, for they considered **Flora their patron goddess**.”*

Florida

In ancient myths the Israelites were celebrating the goddess Flora; which was actually a celebration of arriving in Florida. **The goddess Flora is Florida.** I believe that the early Romans hid clues like this for us because of the persecutions of the early Christians. When the Israelites were said to have arrived at the Wilderness of Sur, they actually arrived in Florida where Mariam did her dance.

It is said that Spanish explorers named Florida ‘La Florida’ because they arrived at the coast of Florida on Passover on April 2nd; However that

would have meant they [sailed over sea in the winter](#) so I'm not sure that I buy this story. I believe it was named Florida since it was the Passover season when the Israelites arrived there. It was the season of [Pascua Florida](#) "Flowery Passover". The state of Florida does celebrate Passover as a state holiday.

“Pascua Florida is a Spanish term that means flowery festival or feast of flowers. Pascua Florida Day is usually celebrated on April 2 (the day on which Ponce de León first spotted Florida) unless it falls on a weekend, in which case the governor may declare either the preceding Friday or the following Monday as the state day.”

An Extract

May Day.— if three removes are as bad as a fire, three anniversaries of moving day in New York, must be more dangerous than the great conflagration.

Monday was cold, uncomfortable day, not at all like what 1 May should be, while Sunday was as lovely as heart could wish. A stranger coming into the city, day before yesterday, would have supposed that some great prophet had foretold its immediate destruction, and that everybody was making off with their goods and chattels as fast as possible we try to get about town and see that things went on the right, but it was of no use at all, for we only got our head and shins broken, while the furniture was smashed and pilfered as bad as ever.

We therefore came home, applied a bottle of opedeldock and left the furniture, crockery, pots and kettles to shift for themselves. The streets were barricaded, carts and wagons and hand barrows and wheelbarrows, and every sort of barrows were constantly smashing together, while the drivers were swearing at their horses, the women scolding at the drivers and the children, cats, dogs, birds and pigs joined in the chorus.

From the remotest antiquity, May Day, has been a festival. The poets of every age and climb, except the cold ones, have celebrated it, and lads and lasses have fallen in love, while dancing round the Maypole since the early ages, when the royalty donned its holiday clothes, and kings and queens went into the country a Maying.

In Greece and Rome, it was anciently the grand Festival of the queen of flowers. – And Henry VIII, and the maiden Queen of England used to go into the fields on this anniversary.

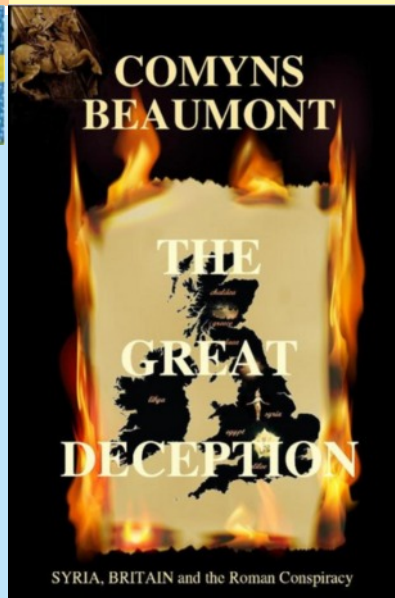

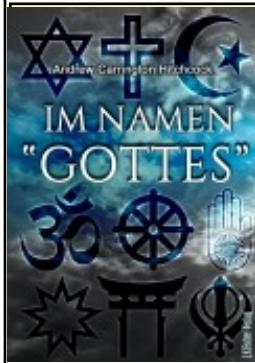

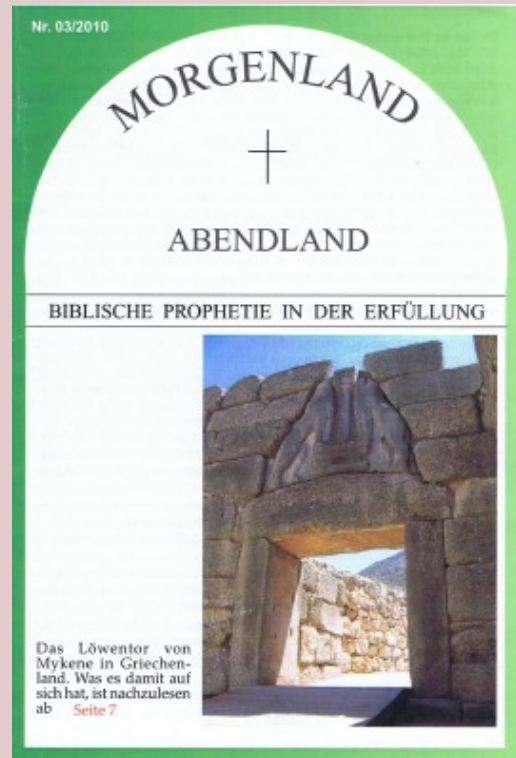
