## The Calais Immigration Crisis

## Serious Questions - Part 6

**AND MAN" AND "MEN AND WOMEN".**

**E**ARLY IN GENESIS we find the "seed of the woman" and the "seed of the serpent", so no one can claim these two co-existing seeds are the same. Prophetically this goes through to the New Covenant era-[Gen. 3:15]. Through the Old Testament, we find different words for "man, "men" and "mankind", but there are four main different words in Hebrew namely 'adam-[579 times], 'enowsh-[567 times], 'iysh-[1,713 times], and 'am-1789 times. There are places where two or three of these words for man are referred to in the one verse, thus showing comparisons, e.g.:

**Ps.8:4** *"What is man [enowsh] that thou art mindful of him, and the son of man [Adam] that thou visitest him".*

**Ps 90:3** *"Thou turnest man [Enowsh] to destruction; and sayest, return ye children of men [Adam].*

God is mindful or marks the 'Enowsh man, but He visits [paqad] the 'Adam man. We do not find 'enowsh as being God's flock. Ezek. 34:31 says, "And ye my flock, the flock of my pasture are 'Adam, and I am your God, saith the Lord". But, in Proverbs 28:5 we read "...Enowsh understand not judgement". With so many references to contrast these three words we should have enough to indicate a conclusion and to admit that there are differences.

It is not popular to divide the Word of God in the New Testament when it comes to "man", "men" and "mankind", but the distinctions remain. The majority words are aner-[212 times], tis-[969 times], *anthropos*-[560 times] and 'laos-

143 times. In John 10 we can read about Jesus saying that some there were His sheep and also that others were "not of My sheep". Jesus says, "I give My life for the sheep". He went looking for the lost sheep, but it is not recorded that He went looking for other than "sheep". Denominations do not accept this limitation by Jesus claiming that things have changed somehow later in the New Testament. Jesus says, "Every plant which my Heavenly Father hath not planted, shall be rooted up:-[Matt15:14], and so we have to admit that there are those planted by God and those not planted by God.

In the New Testament we still find there are the good seed and the bad seed. The good seed are the children of the Kingdom-[Matt.13:38]. All of Abraham's seed are not children of the Kingdom-[John 8:33-37]. Seeds are either good or bad as seeds before they have grown or done anything. The popular evangelical teaching is that it is not the nature of God to treat one racial seed differently than another, and so they claim that God plants any one of any race in the garden, making planting a matter solely one of belief, not origin as well. When did God's eternal nature change?

Who plants the Tares and what is their end? So who, is right, Jesus or the churches? There are people described and also symbolised as "beasts" in both Testaments. Looking in another direction, the word aner for "men" is never used of women, but it is not the scope here to go into all the details. People who believe that "mankind" always includes women must have difficulty with, "Thou shalt not lie with mankind as with womankind".

There are areas in both Testaments where God discriminates between women and men. Modern Christians do not think that a sovereign God should discriminate between "men" and "men" or men and women. In the creation story, we cannot remain honest if we try to say that "created" = bara' is the same as "formed" = yatsar. [The same goes for plasso and ktizo in the New Testament]. We have men and women, 'Adam in the plural, being created [bara'] in Gen.1 before the 'Adam [singular] who was formed [yatsar] in Gen.2. "Created" and "formed" have differing meanings. From the sequence alone

there is no way Genesis 2 could be a re-run of Genesis 1. On a weight of evidence basis, there is more to say that Adam [as we use the word] was the first spiritual man, but not the first biological man. In other words, God took one man from Genesis 1 and breathed into him the breath of life. Eve was the "mother of all living" with God's breath, not of the others. This indicates that there are those with the Spirit, and those "having not the Spirit"-[Jude V19]. The latter is the "natural man" who cannot receive the things of God-[1 Cor.2:14], but he may become very religious. What we believe about these issues in Genesis conditions what we believe right through the Bible.



### **Jehoshaphat's victory against the Moabites**

We will not expand racial issues such as mixed bloods, incest blood or bastards as shown for instance in Deut. 23:2-8, "A bastard shall not enter into the congregation of the Lord until THE TENTH GENERATION". With Ammonites and Moabites this ten-generation prohibition is to be maintained "for ever". Israel was told, "Thou shalt not seek their peace, nor their prosperity all thy days FOR EVER". With Shemites such as Edomites and Egyptians a regeneration period by mating back into Israelite stock takes only THREE GENERATIONS-[Deut. 23:7-8]. Up to the end of this period there is no access for them to the tabernacle.

With the Canaanite we read in Zechariah 14:21 about the end of the age, "In that day there shall NO MORE be any Canaanite in the house of the Lord of Hosts". This shows an objective and some take this to mean that no measure of Canaanite blood is ever acceptable. This then would include that section of mixed-race Jewry which descended from Judah's Canaanite wife-[Gen. 38:3], i.e. Shelah-Judah which are called Jews in 2 Kings 16:6, and who can be traced in

the New Testament. These comparisons show striking differences in treatment between some races in the Bible.

God says He has war with Amelek [one of Esau's descendants] for all generations and that Israel was to "blot out the remembrance of Amelek from under heaven"-[Ex. 17:15 and Deut.25:19]. This is about the extermination of a particular race! Edom [also known as Idumea etc.] are stated to be "The people against whom the Lord hath indignation for ever"-[Mal 1:4]. This race whom God says He hates are the enemy of Israel "for all generations" until they are destroyed at the second coming of Jesus. Beyond these few races, the Bible does not mention the balance of races by name, and so no one has any right to presume anything about their destiny. The Bible does not state that they are condemned, but there are indications that most have benefit from, and should obey, the Laws of God. At the end, in the Book of Revelation, the New Jerusalem has the names of the Twelve Tribes of Israel upon its gates. Zechariah chapter 14 presents the picture about the place of the other races.

Certain other races will bring their worship to the New Jerusalem year by year, but they are not in the city. God discriminates racially up to the end of the age, and these things demonstrate the racial differences that are in the Bible. We have to either agree or disagree with Jesus when He says that the scriptures "cannot be broken"-[John 10:35]. The Old Testament discrimination cannot be broken; we have to believe this if we are to agree with Jesus.

Reference is often heard about "God's chosen people or race" suggesting wrongly that this is "The Jews". If some are "chosen", then all the others must be "unchosen". Scripture does not indicate that "The Jews" are Israel, despite the popular suggestion. Judaism has been multi-racial since Bible days!

Three quotes from Jewish sources may personally help those who have been led to believe that the word "Jews" always relates to Israelites.

From Alfred M. Lilienthal's book "*What Price Israel!*": "Here's a paradox: an anthropological fact, many Christians have more Hebrew-Israelite blood in their veins than their Jewish neighbours".

The Jewish author Yair Davidy in his book "The Tribes-Israelite Origins of Western peoples" [Foreword by Rabbi A. Field] tells in much detail that the Saxon folks are Israel.

These Islands are shown to be North and West of Palestine, i.e.

the United Kingdom. The reader will probably be Anglo-Saxon, Celtic, or Nordic, whom can be shown to be Israelites apart from the white Japhethic and Edomic content -[Genesis 9:27 and 16:12], and obvious foreigners, who have moved in amongst them. In the Divine foreknowledge, true Israelite posterity possesses the inherent characteristics with which God purposed should be used to bring peace to the world and the casting down of demonic strongholds over the other races under the righteous rule of Jesus Christ.

**GOSPEL NUMBER ONE (False)**

This is that gospel which cannot be found throughout the Law, The Psalms, the Prophets, or through the New Testament. It says in effect:

The Law and The Ten Commandments were given to every race, as a covenant.

Jesus gave His Life so that He becomes the Redeemer of all races, to redeem them from the curse of that broken law, even if the other races did not have that covenant-law relationship.

God loves all men and every individual member of all the human races, including those God says that he hates.

The gospel is for all sinners of every race, [not "the sinners of My people"-Amos 9:10].

All are called. There are no Tares or Goats, despite what Jesus says to the contrary.

All are chosen. There are no inferior vessels, despite what Paul says to the contrary.

There are no Twelve Tribes of Israel any more -[Even if they are through the N.T.].

All men are supposed to have faith. -[The Bible says "All men have not faith"].

The Father gave Jesus to "all men", not "all men" of Israel.

All races are pre-destined -[God must have been wrong to expect Israel to destroy certain mixed races. All are the same now, it is suggested].

There are no elect people, nor any election according to grace. Everyone is the same now.

God has mercy on everyone, not just on whom He chooses or elects.

There are no scriptural differences between men of differing origins.

That "men" always includes women as well.

That non-Israel races can be "adopted" into Israel, ignoring, "Who are Israelites to whom pertaineth the adoption"-[Rom.9:4].

It is now up to all sinners of all races to embrace the love of God or to not embrace it. It is up to everyone of every race to either have eternal life, or to perish.

**THIS GOSPEL SAYS IT IS MANKIND, IN GENERAL, THAT IS SOVEREIGN, AND MAKES THE CHOICES.**

This would mean God is not sovereign in establishing a covenant relationship with Israel. About this we read in Galatians 1:9, "If any preach any other gospel unto you than you have received, let him be accursed".

**GOSPEL NUMBER TWO (True)**

This is the everlasting gospel, the true gospel in which you stand, if you continue in "The Faith". This says:

God does not say anywhere that He loves all mankind, but only His elect nation.

Jesus came for those chosen from before the "foundation of the world" -[which means the "overthrow of the order"].

Jesus is the Shepherd of the sheep only. He said, "I lay down my life for the sheep"-[John 10:15]. He did not add

**23;** And the word of the LORD came unto me, saying,

**24;** Son of man, say unto her, Thou art the land that is not cleansed, nor rained upon in the day of indignation.

## Introduction

**T**HE ABOVE QUOTATION comes from Ezekiel 22:23-31. It tells us of the day when the priesthood will become like wolves, treating their congregation as a prey instead of as their flock. False prophets abound today. They are called the Judeo-Christian priesthood. Most of them are nothing but pro-Zionist puppets, who lead their flocks into perdition, by preaching hatred of the Jews' enemies instead of the doctrine of Jesus Christ. You can hear them say, "What would Jesus do?" But if you ask them, "Would Jesus approve of the bombing of Beirut and Gaza," they turn their backs on Jesus and hide behind their paymasters. The land is full of false prophets.

One of the most persistent and problematic interpretations of Scripture is the belief that the Book of Revelation, in Chapter 20, teaches that Satan will be cast into the "bottomless pit" for a thousand years AFTER the Tribulation and Judgment. This teaching assumes that Jesus Christ will return at the Judgment Day, not to destroy Satan, but merely to bind him, thus postponing his inevitable destruction for a thousand years. Unlike many of the modern apostasies, this mistake is actually understandable. It is due to the fact that the verses dealing with the bottomless pit occur right after the verse discussing the Judgment Day. It is quite natural to assume that the events depicted at the end of Chapter 19 will be followed by the events depicted in the beginning of Chapter 20. However, as I will show, this is an ASSUMPTION, because the Millennialists ignore the critical fact that the final battle (Armageddon) between True Israel versus Gog and Magog (Verses 7-10) occurs in the verses right after Satan was let loose. In other words, the Battle of Armageddon is brought about by the very beast that was bound for a thousand years. If the post-tribulation Millennialists are correct,

then they will have to explain how the Battle of Armageddon can occur after the Judgment Day.

Assuming that the events depicted are in strict chronological order, they would occur as such:

The Tribulation and Great Battle, with the Beast and False Prophet cast into the Lake of Fire. (Rev. 19:19-21.)

The binding and casting into the Bottomless Pit of the Dragon. (Rev. 20:1-2.)

The 1,000 years confinement. (Verse 3.)

The judgment of thrones. (Verse 4.) This is a problem for the chronology, since the Beast was already cast into the Lake of Fire under item 1. Who or what is being judged here? The saints

suffering and dying for refusing to worship the Beast, which had already been cast into the Lake of Fire, living and reigning with Christ, presumably for this same 1,000-year period, while the Dragon is bound. Most interpreters assume that this reign will be peaceful. But these verses declare the contrary. Rather, the entirety of Rev. 20:4 suggests a victorious struggle, not a thousand years of peace. The

word peace does not occur in these verses. A reign can be either peaceful or tumultuous.

The "dead" in Christ "resurrected." (Verse 5.) Most interpreters believe that this resurrection will not occur until after the Judgment Day. But we already had the judgment of the Beast and False Prophet under item 1.

The release of the Dragon (Verse 7), with the attendant 1,000-year "reign" of Christ coming to an end. (Verses 5 & 6.)

The Dragon goes out to deceive the nations again and organizes the armies of Gog and Magog, which are destroyed in the Great Battle. (Verses 8 and 9.)

The devil (Dragon) is cast into the Lake of Fire. (Verse 10.)



The Judgment of the Living and the Dead. (Verses 11-15.)

The problem with this Post-Trib chronology is that it is contradicted by Ezekiel 38:8, which is very clear in stating that the invasion of Gog and Magog will occur "in the latter years." This can only mean during a time leading up to the Judgment Day. But the Great Battle had already begun in verses 11-21 of Chapter 19, with the Beast and False Prophet being judged by throwing them into the Lake of Fire. What the Post-Trib Millennialists have done is to focus on certain sentences or phrases, without paying close attention to the fact that the saints are marked by the beast, being beheaded, etc., while Satan was bound. (Verse 4.) Lifting verses out of context is a favourite tactic of naive interpreters; and this is the problem with Post-Tribulation Millennialism.

Taking the descriptions from Rev. 19:10 to Rev. 20:10 as a cohesive story, we have two possible interpretations:

There are two Judgments with a period of one thousand years intervening; or—

There is only one Judgment, with the events of Rev. 20:1-7 representing a flashback to the days before the Great Battle between the people of Israel versus Gog and Magog. (Rev. 20:8-10.)

I will argue for the latter interpretation, meaning that Rev. 19:10 through 20:10 is the story of a single Judgment, but that John's vision discusses the Beast and False Prophet first, and then focuses on the Dragon second. Rather than taking the events depicted in strict chronological order, the story is divided into two themes, the first telling the story of the judgment of the Beast and False Prophet, and the second theme concerning the judgment of the Devil, or Dragon.

In other words, there is not a 1,000-year period between two judgments. Nothing else in Scripture would indicate such a scenario, especially since the Judgment Day is major theme, mentioned hundreds of times in both the Old and New Testaments! Given this fact, it is much

more likely that we are being given two separate stories of the same events. Rev. 20:1 takes up the story of the Dragon, having dispensed with the Beast and False Prophet in Chapter 19. Viewing the story in this way eliminates the contradiction created by two judgment events: Rev. 19:20 and Rev. 20:10. The idea that Gog and Magog would be judged a thousand years after the kings and thrones of Rev. 19:19 is a major problem for the Post-Trib view. The fact is that all of the eschatological statements contained in the Bible indicate only one Judgment Day, not two separate judgment events.

### Protagonist Versus Antagonist

The Bible, in Genesis 3:15, declares a perpetual enmity (hatred, struggle and strife) between two sets of people: the seed of Eve and the seed of Nachash (the Devil). Since mainstream Bible scholarship totally ignores this prophecy (or they assume that it ended when Jesus died on the Cross), it leads to a misidentification of God's chosen people. Put quite simply: The Jews ARE NOT "God's chosen people." This is one of the foundational principles of Christian Identity. The Celto-Saxons (Caucasians) are God's chosen people. Rev. 2:9, 3:9 and 12:9 clearly tell us that there is a group of people in the world today who CLAIM to be Judeans, but are NOT, and they are the SYNAGOGUE OF SATAN. And these people are deceiving the whole world with their false ethnic claims, false religion (the Babylonian Talmud), and false history.

**Here is how one Identity author summarizes the situation:**



"Judaism's masquerade as Biblical Judah and, moreover, as all Israel -- which is the basis of Jewish Nationalism -- becomes patently counterfeit when placed in juxtaposition with the historical record of the true Houses of Israel and Judah. Even a brief summary will show the contrast between the descendants of Biblical Jacob-Israel as opposed to the alien posterity of the cabal which claims for itself not only the Promised Land but the very name and inheritance of Israel." - W.N. Saxon, "The Mask of Edom," p. 8.

The whole world has been deceived by Judaism's claim to be Israel. This is why orthodox Judeo-



Christianity is very much mystified about the ENTIRE APOCALYPSE, not just this particular episode concerning the Millennium. Since they falsely identify the Jews with/as Israel, they are incapable of understanding a single word of the Revelation concerning True Israel versus the impostor Jews!!!! (Such as Rev. 2:9 and 3:9.) Although they understand that the Dragon is Satan, they do not understand that Talmudic Judaism is the religion of Satan masquerading as the religion of Moses. Nor do they understand that the Eighth Beast is also the international Jewish mercantile Beast (the Empire of Merchants, Rev., Chapters 17-19)!!! Failing to understand such important concepts is a guarantee that they will misinterpret just about all of the Apocalypse. In short, Judeo-Christianity, operating under the delusion that the Jews are Israel, cannot possibly understand the Bible, let alone the book of Revelation.

The world has been brainwashed by the antagonist into believing that he is the protagonist. The Devil is masquerading as "God's chosen people." Therefore, most of the orthodox prophecy interpreters are in the employ of the False Prophet, and their main job is to obscure Biblical prophecy so as not to implicate their paymaster, the International Jew. With all of the money at their disposal, the Jews have the capability of hiring armies of false prophets, whose main job is to keep spreading the lie that the "Jews are God's chosen people." It is not permitted by the Kosher crowd to discuss Jewish claims openly. Critics are routinely subjected to ad hominem attacks. Is this what Jesus would do to His critics? Did He not confront them openly? Are the Jews better than Jesus that they don't have to face criticism?

In the words of another observer:

"World events, most especially the activities of the present Bush administration, demonstrate a clear agenda to implement Draconian Controls precisely as described in the prophecies of the book of Revelation. What baffles me is the almost complete silence of the Fundamentalist Christian groups who spent so many years preaching and warning everyone about the coming 'New World Order,' and 'Mark of the Beast,' and now that it is here - it's real - they don't even seem to see it. That is, of course, because they are PART of it." - Laura Knight-Jadczyk, "The Beast and His Empire."



The Scriptural and spiritual blindness of the Judeo-Christian world was, of course, prophesied by Paul at II Thessalonians 2:2. Speaking of the latter days, just before the Second Coming:

"Let no man deceive you by any means: for that day shall not come, except there come a FALLING AWAY FIRST, AND THAT MAN OF SIN BE REVEALED, THE SON OF PERDITION; even him, whose coming is after the working of Satan, with all power and signs and lying wonders; And for this cause God shall send them STRONG DELUSION, that they should believe a lie;"

Why would Yahweh cause these Christians to believe a lie? Paul answers this question himself:

"That they might all be damned who believed not the TRUTH, but had pleasure in unrighteousness."

The simple fact is this: Modern Judeo-Christianity teaches all kinds of UNTRUTH in the name of the Holy Scriptures (Dispensationalism, Antinomianism, Universalism, rejection of the Old Testament, etc.); and we in the Christian Identity movement have dedicated ourselves to exposing these lies. Without realizing it, the Judeo-Christian world has allied itself with the Devil, having been duped into following the International Jew and the blaspheming rabbis of Judaism. Using their agents, the televangelists, the Jews have successfully converted these Christians into antichrists; and these "Christians" are now totally deluded by the false teaching that the Jews are "God's chosen people." Thus putting Jewish concerns before their Lord and Savior, Jesus Christ, modern Christianity has fallen into the GREAT APOSTASY.

The absurdity of this situation is exemplified by the fact that the Christian sheeple, who sit in the

pews of the Baal-worshipping temples of Judeo-Christianity, have allowed all sorts of abominations into their churches, including homosexuals, feminists, voodoo practitioners, wiccans, and even Christ-denying blasphemers, such as John Hagee, who denies that Jesus is the Messiah and who claims that the Jews "have their own path to salvation." # Was Adam The First Man?

**M**OST KING JAMES BIBLE PREACHERS claim the Good Book says Adam was the first man. This is not true. However, the scriptures do record that **Adam was the first white man.** (There is more on this in the fifth chapter — God's People.) The Hebrew word "*Awdawm*" or Adam translates to English as: to flush or turn rosy in the face while blushing or upon anger. This characteristic is distinctive to white men only. Adam was white and so are all of his descendants.

This is Yahweh's law of genealogy (like-begets-like; after its own kind, Gen. 1:21-25), and cannot be changed, regardless whether people subscribe or reject this fact. Recently, **miscegenation** is being condoned and considered politically "correct," and this generation is unaware of Yahweh's strictest demand to keep each racial group separate. Deliberately disobeying this law is deemed an **irreversible sin** and the result of mixing bloodlines is passed on to subsequent generations. In spite of these indisputable facts, men have put forth enormous efforts to try and prove God wrong. Since this law is His law, a white couple can never produce a black baby, neither can a black couple spawn a white infant, unless somewhere in their past there is mixed blood. So neither Negroes, nor Orientals could have come from the family of Adam under any circumstances.

There are several interpretations of the creation or 'Genesis account,' which seek to explain away the dilemma of how, or from where the other non-white races could have come. Naturally, there are many theories and opinions (some worse than others), but there is only one true answer to this question. Although the Bible is not very generous with words on this subject, most of man's philosophy must be based on speculation, **including ours.** Considering that the entire creation story, which covers many

eons, is given to us in only a minimal thirty-one verses. Much caution must be used in determining what the truth may be.

Since a gross hyper-sensitivity developed in the 20th century toward non-white races and Jews, most denominational churches try to side-step the creation story in order to avoid embarrassment and/or legal problems. This has resulted in **hiding the true facts from Yahweh's children,** so they can't learn why He gave us free will, including the right to discriminate, especially when choosing our mates. This cover-up is usually accomplished by taking one of the following approaches.



The perpetrator may quickly quote Acts 17:26: "*And hath made of one blood all nations of men for to dwell on all the face of the earth, and hath determined the times before appointed, and the bounds of their habitation;*" But there is a problem with this verse in the KJV. It contradicts Yahweh's word given elsewhere, such as Gen. 1:11, 12, 21-25 and Genesis 6:20; 7:14 (after his kind, whose seed is in itself). All these scriptures regard everything reproducing "**after its own kind.**" The word **kind** means the type and color, **otherwise God would have kept them all alike to begin with.**

The other problem with Acts 17:26 is that the word **blood** is not found in the original Greek or Latin text. See notes in the Emphatic Diaglott of the Greek New Testament, pg 467, at Acts 17:26 we find "omit the word blood." It is correctly rendered in the Ferrar Fenton Bible translated from the original Greek that says: ". . . *because He (Yahweh) made by one, every race of men to dwell upon the whole face of the earth, having provided proper methods and guides for their research in seeking God.*" Again, in the Rotherham Bible, it is presented: "He (God) of one, made every nation of men to dwell upon .all

the face of the earth, marking out fitting opportunities and the bounds of their dwelling place."

Another way a church may provide answers about the differences in races is, as the Catholics claim, that all races came from Adam and Eve since "God can do anything He wants." Along with this they might use the phrase, "There are mysteries and secrets in the Bible that man is not allowed to know."

Of course, anyone with reasonable intelligence cannot accept such fallacies in avoiding the truth. These non-biblical approaches are easy to disclaim. While it is true that Yahweh is not limited in His power and nothing is impossible for Him to accomplish (See Matt. 19:26; Gen. 18:14, Job 42:2; Jer. 32:17, etc.), He doesn't break His own laws.

Biologically, it is impossible to claim that all races could have come from one source, i.e., Adam. I here are a few good reasons why:

Yahweh genetically gave every person 23 pair of chromosomes, which determines his racial, physical and mental characteristics. The only way Adam could be the father to all races is if God had made Adam with 23 pairs of chromosomes for each of the races; he would have had a minimum of 92 pairs to be able to produce black, white, red and yellow people.

The claim they make that we are not allowed to know the secrets in the Bible, is also proven false by at least a dozen scriptures. Read the following two.

**Mat 10:26** "Fear them not therefore: for there is nothing covered, that shall not be revealed; and hid, that shall not be known."

**Col 1:26** "Even the mystery which hath been hid from ages and from generations, but now is made manifest to His saints:" (Also see Matt. 11:25, 13:11; Mark 4:11, 22; Luke 8:10, 17, Luke 12:2; Rom. 16:25,26; 1 John 1:2, 2:27 and others.)

Keep in mind that there are rational answers for the creation of the non-Adamic races, which came long before the appearance of Adam or Eve. For obvious reasons, these issues have been ignored or made very controversial. They are considered a "racist" point of view by those who

are not familiar with the sound doctrine of the "Two-seedline" teaching of Israel Identity." Still that does not change the truth. This precept also known as the "**Dual-creation or the 8th day creation account**," which relies on biblical, historical and scientific evidence, along with plain common sense. Some people object by saying 'nowhere can this be found in the Bible.' Well, if five is followed by six and six by seven, why is it wrong to declare that the seventh day creation was followed by the eighth? It is sad for them to not be able to rightly divide the word of truth.

This latter-days understanding and its Bible-based theology has been derived from many decades of deep study and the research of many godly men who were inspired by the Holy Spirit. Those current-day disciples let the Bible interpret the scriptures, not special-interest or **racially-biased contortionists** who have well mastered the twisting and turning of God's word to fit their own personal schemes.



Those false prophets have been known throughout the ages as dreamers, false teachers & prophets, false witnesses, dumb dogs, liars, hypocrites and pastors/ministers of falsehood can still be found today as well. The Identity movement is no exception, where we

find 10-15 hour lectures preached by a few zealots desperately attempting to repudiate the "Two-seedline doctrine," only to end up admitting that they have nothing else to offer than their own opinion and have no proof that the concept of the "pre-Adamic" races is in error. It is not surprising that in some cases a closer observation has revealed that those adversaries of the "two seedline" message have mixed blood in their own family background.

It is a remarkable fact that other than in Genesis 1:27, there is no place in the Bible where the creation of the dark and yellow races would fit in. However, since their existence is obvious, their creation can be found in the first few chapters of Genesis— the "book of origin," or

"the book of genes." (More on this in the chapter of God's people) The Holy Bible is written explicitly to, for, and about the race of Adam. Whenever other races of people are mentioned, it is for the historical record or to display their nefarious examples. Please keep in mind, that other races, with whom Christians have nothing in common, have their own bible-like literature as well. The Jews have their Talmud-Torah and Kabala, Islam has the Koran and Hadith, Hindus have the Vedas-Samhita-Brahmans and the Negroes have Voodoo.

It is unscriptural and intellectually dishonest to advocate the fallacies of equality and world brotherhood as being the word of God. This is usually based on the forgeries in the KJV of **John 3:16** and **Acts 17:26**. (For a testimonial see John 8:23; James 4:4; 1 John 2:15, and others).

The main reason the correct understanding of the creation account is so vitally important is that this determines whether the correct interpretation is established for the rest of the Bible. If one gets the beginning wrong then the ending will also be incorrect. The following are a few more problems that play a significant role in causing confusion or misunderstanding about the origin of the non-Adamic races.

The original scriptures are no longer available for reference. We believe that this was conspiratorially-arranged throughout the ages.

Most translators and scribes of the Bible were Jewish (x this ties in closely with the first statement).

The lack of recognized and accredited non-Jewish research scholars and those that do exist may have only limited knowledge in Hebrew and Greek.

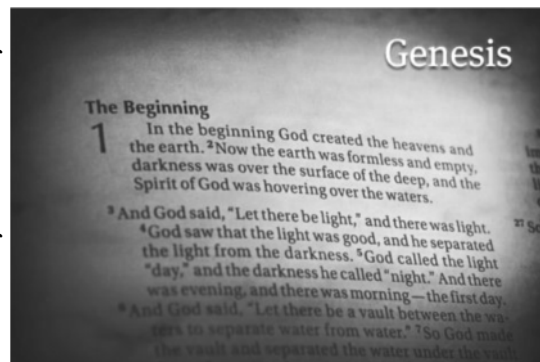
The acceptance of the KJV version as being "the inerrant word— (completely without error) of God."

The unquestioned acceptance of Strong's Concordance as the authoritative source of

choice for numbering words that are used in the KJV.

The scarcity of non-censored, non-Judeo/Christian studies, and the virtual censorship of "Israel Identity" material by the Jewish-controlled publishing industry.

The fact that most people, even some scholars, don't realize that the wrong interpretation of the first few chapters of Genesis is responsible for most atheistic, evolutionary, and agnostic beliefs in this world. In search for the truth and scholarly answers, concentration must be focused on these irrefutable facts:



The six-day creation was not six- 24 hour cycles, but six equal time periods or **ages** (Heb. *yowm*).

The laws of the Creator were established in the very beginning, that only **"like kind"** (in other words— male and female of the same race) **can beget "like kind"** (others are considered mingled)

The creation of animals and humans took place on the sixth day/age and it was a simultaneous creation of both sexes (for both animals and humans). This was an obvious need to obey God's command to be fruitful and multiply.

All sixth day creations are recorded in past tense as completed events and chronologically followed by the 7th day/age for a rest after the creation.

A grave error was made by the translators by not starting the second chapter with the fourth verse because God's seventh day of rest ended in verse 3, as a completed event for the first phase of creation.

Only after these seven ages or cycles did Yahweh continue with His work to crown His creation by putting His own seed on earth in the flesh. This was for His own purpose— to rule[1] His "antecedent" (prior) creation.' Since Yahweh is the ruler of the universe, He made His own seed the rulers of this world. This was a position He originally assigned to Lucifer until he was cast down to earth for his rebellion against God

in a power-struggle prior to Adam's appearance (see Isa. 14:12-21 and Rev. 12:7-9). This is why Yahweh formed Adam and breathed the spirit of life into him.

Adam was brought into this world in a different way than the other races, who were created in the first chapter. He was formed from the "dust of the ground," not created. He was also alone without a mate when Yahweh commissioned him to name the animals as his first work here on earth (Gen. 2:18). Then Adam found there was no suitable mate amongst the other humans for himself (verse 20).

**We must pause for a moment here to raise a few important questions that were not asked before:**

Why did God make the statement: "it is not good for a man to be alone" (Gen. 2:18) when He had already created male and female beings twenty-two verses before? The first chapter male and were already multiplying and had dominion over fowl, beasts, and every living thing.

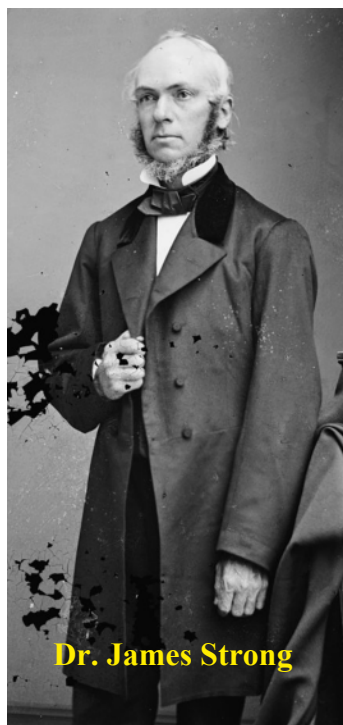
Why was Adam commissioned to name all animals and fowl **before** he had a mate? Do you suppose Yahweh wanted him to realize that although everything else had other creatures that looked alike, Adam was unable to find a suitable helpmate. Since he was in the garden alone, he was able to see females outside the perimeter, but they looked different from him. (They were of other races.)

It was only after this that Adam was put into a deep sleep by Yahweh to make the woman (**ishshah** Heb., but not the Hebrew word *neqebah*, meaning female) from Adam's flesh and bone for his mate. So Yahweh's law prevailed, she was a like-kind. A less-important note here: it is a biblical fact that neither Adam nor Eve were ever infants, in spite that all portraits picture them with a navel, suggesting an umbilical cord, a sign of separation of the infant from the mother in a normal birth.

It should be clear that the popular and widely-accepted version of the creation account is false

and in serious error. The reason for its popularity is obvious. **It advocates no difference between the creation of the different races**— the first chapter "man," and the "Adam man" or son of God, placed on earth by Yahweh in the second chapter. The reasoning behind the confusion here is based primarily on the numbering system used by Strong's Concordance. **It must be understood that his dictionary is not the word of God but only Mr. Strong's.** His problematic position and numbering arrangements are based solely on his personal conviction and understanding—period. The result of such a horrendous mistake (whether intentional or not) is responsible for the centuries-long mixing of races, now being accepted worldwide as "normal."

The mistake we refer to here that has created such colossal confusion is that Mr. Strong mistakenly assigned the same number #120 to the first chapter creation of "man," as he did to the second chapter's "Adam." — When you study the word Adam in the reference column of Strong's Concordance at Gen. 2: 23, the number #120 is present. However, going to the end of the same sentence, the word "man" also refers to Adam but shows an incorrect reference number - #376. ("And Adam said, This is now bone of my bones, and flesh of my flesh: she shall be called Woman, because she was taken out of **Man**.")

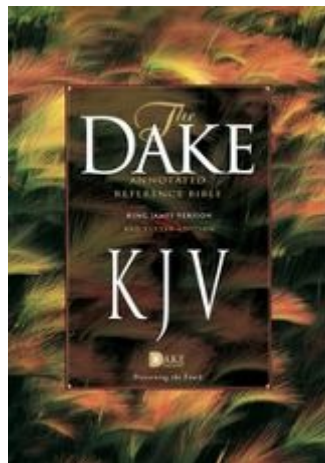
This suggests the one-seedliner's dream is correct, — that all races have the same origin and we all come from Adam. That means he and his mate Eve and their descendants have the same DNA as Blacks and, Chinese, etc... This number is used throughout the scriptures to ID the descendants of Seth, especially Enosh (#583 that refers back to #582, which says-- "**a mortal**" and thus differing from the more dignified #120). In some cases it may include the twelve sons of Jacob as in Exodus 1:1-6 and others, but not elusively to all Israelites.

But this isn't the only fact that has been ignored. Take the single English word 'man'. There are fifteen Hebrew and twelve Greek words listed

in the Strong's Concordance for "man." In dozens of scriptures we may add the English word man, but reading the Hebrew or Greek text where the word is more closely stipulated, we might find two different **kinds of man** in the same verse or even sentence, (Read Lev. 27:28; 1 Sam. 14:52 King 8:38; Job 11:12 and Psa 8:4, along with others). These examples clearly illustrate there is a difference in the application of the word **man** in the scriptures. In each of these cases, the word man can either have #376 or #582 assigned to it (i.e., Enosh man) and another may be #120 — **Adam man**.

Mr. Strong created quite a mess with his numbering system throughout the chapters of Genesis. We find that the word **Adam** is not mentioned the first time in chapter two and verse seven when he was formed by Yahweh, but verse fifteen has a **correction** note in the center column of most Bibles, replacing the word man with the word **Adam**, (although the note should have been at **verse seven**). There is no room for argument about the theological correctness of this statement, since it was chronologically the proper time recorded for Yahweh's act in forming Adam.

But this problem doesn't end here. Since the number 120 was correctly assigned to Adam, **why did Mr. Strong assign number #376 incorrectly to him in the same chapter 2:23 just 8 verses later.** If he managed to assign different numbers for Adam in the second Chapter of Genesis, why then couldn't he do it for the first chapter man?



When you study the word "Adam" in Gen. 2: 23 in the reference column of Strong's, the number #120 will be there, as it should. However, going to the word "man" in the same verse (also referring to Adam), shows the incorrect number — #376. That number #376 is used later in hundreds of places in the Bible, mostly for the descendants of Seth, namely Enosh or people in his bloodline as "enosh man", including the twelve sons of Jacob as in Exodus 1:1-6 and many more people, but not exclusively to all Israelites. So specifically, what is my point? It is that all pure blooded men in Adam's lineage, at least in the first few chapters of creation should bear the same ID number— 120.

Since this is not the case, it begs the question why in the world Mr. Strong didn't find a separate number for the "man" created in the first chapter, an eon before Adam was ever mentioned? (An eon is an age, an unspecified number of years-possibly even a million or more). For this reason, to put the appearance of Adam in the second chapter, and call it an extension to the creation of the first chapter man (separated by the Seventh rest period eon), is intellectually dishonest and untrue, arising from the above described fundamental error, negatively affecting billions of people from the inception of the first Bible.

Again, in many places where the Bible refers to the creation account (pertaining to Adam) as a continuation of the pre-adamic races in the first chapter to the formation of Adam as a spirit man that God performed in the second. There are examples in Gen. 2:5, 2:7, 8, 15, 15, 18, 23; Deut. 4:32; Job 5:7; Judges 16:7; Isa 5:15; Jer. 2:6, 49:33; Ezk 8:12 and hundreds of other places throughout the King James Bible. All these conclusively establish that the first and second chapter of the creation account does not tell the same story, but puts a difference in the origin of the respective races between the Adamic and "pre-Adamic" bloodlines (See notes in the Dake Bible on Genesis, at pg. 54 O.T.)

Those who advocate, either knowingly or in error, ignoring the plurality and simultaneous creation of both sexes in past tense, mentioned in chapter one of Genesis, are guilty of fraud. They erroneously interpret or are against the entire tenor of the Bible and are ultimately responsible for the sins of miscegenation (race mixing) by the children of Yahweh. Equating the two different creations is irresponsible and has aptly served the forces of darkness since Adam and Eve were brought to this earth.

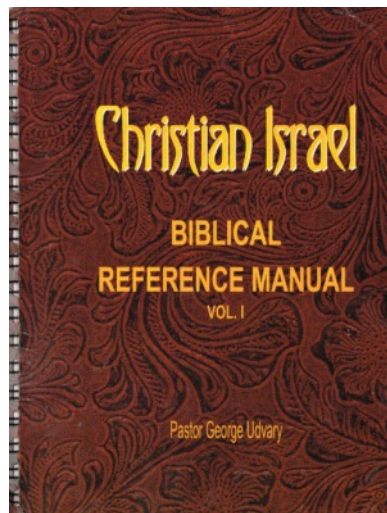
One cannot drag Adam back to the first chapter across the seventh day (of rest) to be formed. Neither can God's created races be brought across the seventh day rest into another "yowm" (age) to insinuate they are from Adam—the first human on earth. This can't be done. Logic tells us all this is unnecessary because Yahweh would have stated it if it were true. But, since a very

special event was about to happen, the birth of the "son of God," or the formation of the first Adam (Luke 3:38, 1 Cor. 15:22, 45; 1 Tim. 2:13 and fourteen verses later, his wife Eve), this topic must be resolved for the sake of Israel.

It is evident from these passages and from numerous other chapters in the Bible that not every person in this world is of Yahweh's seed. There are several different categories.

## **King Charles I - How The Jews Bought Britain (How Parliament usurped legitimate power) 1630 Ray Smyth**

**K**ING CHARLES I is presented with the Charter for the Bank of England. He refuses to sign it as he is aware that the idea comes from the Jews of Amsterdam. The Jews have been expelled from England for coin snipping, ritual murder and money lending By Edward I. Coin snipping is the act of cutting

off the outer edge of gold or silver coins. This pursuit engenders the milled edged coin we know today. Charles is aware that a Jewish run Bank of England would charge interest and that activity would ruin the country.

### **Cromwell's Contracts**

Oliver Cromwell contracts with Dutch Jews to finance an army to drive Charles I out of Britain. He agrees to allow Jews in to England and uses their money to form his new model army under the parliamentary general Thomas Fairfax.

### **JEWISH BANKERS FROM AMSTERDAM**

Led by the Jewish financier and army contractor of Cromwell's *New Model Army*, Fernandez Carvajal and assisted by Portuguese Ambassador De Souza, a Marano (secret Jew), saw an opportunity to exploit the civil unrest led by Oliver Cromwell in 1643.

A stable Christian society of ancient traditions binding the Monarchy, Church, State, nobles and people into one solemn bond was disrupted by Calvin's Protestant uprising. The Jews of Amsterdam exploited this civil unrest and made their move. They contacted Oliver Cromwell in a series of letters:

Cromwell To Ebenezer Pratt of the Mulheim Synagogue in Amsterdam, **16th June 1647:**



— “In return for financial support will advocate **admission of Jews to England**: This however impossible while Charles living. Charles cannot be executed without trial, adequate grounds for which do not at present exist. Therefore advise that Charles be assassinated, but will have nothing to do with arrangements for procuring an assassin, though willing to help in his escape.” —

**To Oliver Cromwell From Ebenezer Pratt,  
12th July 1647:**

— “Will grant financial aid as soon as Charles removed and Jews admitted. Assassination too dangerous. Charles shall be given opportunity to escape: His recapture will make trial and execution possible. The support will be liberal, but useless to discuss terms until trial commences.” —

Cromwell had carried out the orders of the Jewish financiers and beheaded King Charles I on January 30 1649.

Beginning in 1655, Cromwell, through his alliance with the Jewish bankers of

Amsterdam and specifically with Manasseh Ben Israel and his brother-in-law, David Abravanel Dormido, initiated the resettlement of the Jews in England.



**1649**

Oliver Cromwell obtains backing from the British parliament for the execution of King Charles I on a charge of treason. Afterwards, Cromwell permits the **Jews to enter England again**, but does not reverse the Edict of Expulsion issued by King Edward I in 1290, which expelled all Jews forever from England and made the provision that any who remained after November 1st 1290, were to be executed.

The results of this action and the horrors they released were much the same as those in France where the insurrectionists there became regicides also. **1 Peter 2:17** “Honour all men. Love the brotherhood. Fear God. Honour the king.”

**JEWES GET THEIR CENTRAL BANK OF ENGLAND**

**WILLIAM STADHOLDER**, a Dutch army careerist, was a handsome chap with money

problems. The Jews saw another opportunity and through their influence arranged for William’s elevation to Captain General of the Dutch Forces. The next step up the ladder for William was his elevation by the Jews to the aristocratic title of William, Prince of Orange.

The Jews then arranged a meeting between William and Mary, the eldest daughter of the Duke of York. The Duke was only one place removed from becoming King of England. In 1677 Princess Mary of England married William Prince of Orange.

To place William upon the throne of England it was necessary to get rid of both Charles II and the Duke of York who was slated to become James II of the Stuarts. It is important to note that none of the Stuarts would grant a charter for

an English national bank. That is why murder, civil war, and religious conflicts plagued their reigns by the Jewish bankers.

In 1685, King Charles II died and the Duke of York became King

James II of England. In 1688 the Jews ordered William Prince of Orange to land in England at Torbay. Because of an ongoing Campaign of L’Infamie against King James II contrived by the Jews, he abdicated and fled to France. William of Orange and Mary were proclaimed King and Queen of England.

The new King William III soon got England involved in costly wars against Catholic France which put England deep into debt. Here was the Jewish bankers’ chance to collect. So King William, under orders from the Elders of Zion in Amsterdam, persuaded the British Treasury to borrow 1.25 million pounds sterling from the Jewish bankers who had helped him to the throne.

Since the state’s debts had risen dramatically, the government had no choice but to accept. But there were conditions attached: The names of the lenders were to be kept secret and that they be granted a Charter to establish a Central Bank of England. Parliament accepted and the Jewish bankers sunk their tentacles into Great Britain.

## King Charles I's Speech at his Trial January, 1649

I would know by what power I am called hither ... I would know by what authority, I mean lawful; there are many unlawful authorities in the world; thieves and robbers by the high-ways ... Remember, I am your King, your lawful King, and what sins you bring upon your heads, and the judgement of God upon this land. Think well upon it, I say, think well upon it, before you go further from one sin to a greater ... I have a trust committed to me by God, by old and lawful descent, I will not betray it, to answer a new unlawful authority; therefore resolve me that, and you shall hear more of me.

I do stand more for the liberty of my people, than any here that come to be my pretended judges ... I do not come here as submitting to the Court. I will stand as much for the privilege of the House of Commons, rightly understood, as any man here whatsoever: I see no

House of Lords here, that may constitute a Parliament ... Let me see a legal authority warranted by the Word of God, the Scriptures, or warranted by the constitutions of the Kingdom, and I will answer.

It is not a slight thing you are about. I am sworn to keep the peace, by that duty I owe to God and my country; and I will do it to the last breath of my body. And therefore ye shall do well to satisfy, first, God, and then the country, by what authority you do it. If you do it by an usurped authority, you cannot answer it; there is a God in Heaven, that will call you, and all that give you power, to account.

If it were only my own particular case, I would have satisfied myself with the protestation I made the last time I was here, against the legality of the Court, and that a King cannot be tried by any superior jurisdiction on earth: but it is not my case alone, it is the freedom and the liberty of the people of England; and do you pretend what you will, I stand more for their liberties. For if power without law, may make laws, may alter the fundamental laws of the Kingdom, I do not know what subject he is in England that can

be sure of his life, or any thing that he calls his own.

I do not know the forms of law; I do know law and reason, though I am no lawyer professed: but I know as much law as any gentleman in England, and therefore, under favour, I do plead for the liberties of the people of England more than you do; and therefore if I should impose a belief upon any man without reasons given for it, it were unreasonable ... The Commons of England was never a Court of Judicature; I would know how they came to be so.

It was the liberty, freedom, and laws of the subject that ever I took - defended myself with arms. I never took up arms against the people,

but for the laws ... For the charge, I value it not a rush. It is the liberty of the people of England that I stand for. For me to acknowledge a new Court that I never heard of before, I that am your King, that should be an example to all the people of England, for to uphold justice, to maintain the old laws, indeed I do not know

how to do it.

This many-a-day all things have been taken away from me, but that that I call more dear to me than my life, which is my conscience, and my honour: and if I had a respect to my life more than the peace of the Kingdom, and the liberty of the subject, certainly I should have made a particular defence for my self; for by that at leastwise I might have delayed an ugly sentence, which I believe will pass upon me ... Now, sir, I conceive that an hasty sentence once passed, may sooner be repented of than recalled: and truly, the self-same desire that I have for the peace of the Kingdom, and the liberty of the subject, more than my own particular ends, makes me now at lest desire, before sentence be given, that I may be heard ... before the Lords and Commons ... If I cannot get this liberty, I do protest, that these fair shows of liberty and peace are pure shows and that you will not hear your King."

### Judge Bradshaw's Response

There is a contract and a bargain made between the King and his people, and your oath is taken: and certainly, Sir, the bond is reciprocal; for as you are the liege lord, so they liege subjects ...



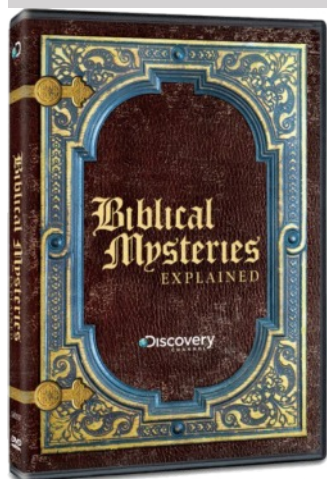
This we know, the one tie, the one bond, is the bond of protection that is due from the sovereign; the other is the bond of subjection that is due from the subject. Sir, if this bond be once broken, farewell sovereignty! ... These things may not be denied, Sir ... Whether you have been, as by your office you ought to be, a protector of England, or the destroyer of England, let all England judge, or all the world, that hath looked

upon it ... You disavow us as a Court; and therefore for you to address yourself to us, not acknowledging us as a Court to judge of what you say, it is not to be permitted. And the truth is, all along, from the first time you were pleased to disavow and disown us, the Court needed not to have heard you one word.

## Bible Mysteries

**T**o enquire into the secrets or mysteries that are mentioned in the Bible would require many pages. It is not the purpose of this article to search out the meanings of these secrets. I will be only highlighting a few thoughts on the

matter. To understand these mysteries would require of God to give us a spade to dig and eventually find the treasure in the field (Matthew 13:44). Whilst preparing this article I found near to 20 mysteries.

The first mention of a mystery refers to Nebuchadnezzar the king of Babylon and the last time that this word is used is in regards to the fall of Babylon (Revelation 17). In between we have mysteries relating to the Kingdom of God, Israel's blindness, the Deity of Christ, the elect, iniquity, the Gospel to the nations, and finally the changing of the body in the twinkling of an eye.

As seen from Strong's Concordance the word "secret" has a number of meanings. For the purpose of this article I will be only using the word "secret" as used in Daniel. The number in Strong's is 7328 and it means attenuate (to make slender) i.e. hide, a mystery or secret. It is only in Daniel that this Hebrew word is used and it is the equivalent of the Greek word for "mystery" as used in the New Testament. The Greek word is the number 3466 and there is only one meaning, the word "mystery".

It is my opinion that these mysteries primarily relate to Israel. For example the preaching of the Kingdom message was to be taken to the "lost sheep of the House of Israel". Jesus gave this instruction to the disciples in Matthew 10:5-7. It is generally overlooked that the disciples were not to go to those nations who did not make up the Israel nations.

This instruction was so specific that they were not to go to the Samaritans in the cities. Why the cities? Could they go to the Samaritans in the countryside? This would take another article. I would like to point out here that I am not referring to the generic term Gospel of Salvation which is not identical with the Gospel or, good news of the Kingdom message. The faith of the centurion and the woman from Canaan shows the good news was not just for Israel (Matthew 8 and 15. Read also Matthew 8:11-12).

Whilst it is true that God reveals the deep and secret things (Daniel 2:22), He does make known certain revelations only in accordance to those who He chooses (John 15:15-16). The underlying thought in Amos 3:7 is that the disclosed secret is to an assembly of the chosen. The following verses show that the revealing of His mysteries take place at the time that God appoints: Matthew 13:17, Romans 16:25,26, I Corinthians 2:7, 8, Ephesians 3: 4,5, 8-12, Colossians 1:26, 2 Timothy 1:10,11, Titus 1:1-3, and 1 Peter 1:10-12. In passing it is of interest that the definite article "the" appears in a number of translations of Romans 16; 26. In Strong's Concordance the number for nations is 1484 and it can mean tribes.

It is a well-established fact that there were many Israelites living in those areas where the writings of Paul were sent. These tribes had become

heathen in their beliefs and it was for this reason that the Gospel of the Kingdom was sent to them. They had to be reminded of their inheritance which came as a result of the faithfulness of Abraham. In the light of these thoughts refer to John 7:35 especially when the word gentile here means "Hellen".

It might come as a surprise to some that Christ did not assume that all those He spoke to were meant to understand the mysteries. This is clearly stated in Matthew 7:6 and 13:10-11. In Matthew 13:14-16 we have a cross reference to Isaiah 6:9-10. When you read these verses it will become obvious that they are referring to the Southern House when Uzziah was king. In Matthew 10:14 we are requested to shake the dust from off our feet under the conditions mentioned in this verse. See Acts 18:6. Who are the Gentiles or nations mentioned in this verse?

Is it possible that the Sovereignty of God has taken into consideration the fact that not all are to understand the mysteries? Both Light and Darkness play a part in God's plan for He has created both (Isaiah 45:7). The good and evil that flowed from that Tree in the Garden of Eden has also been a valuable part of God's plan for His creation. Evil people can unknowingly help carry out God's plan:

### **What a mystery!**

The Sovereignty of God and the revelation of His mysteries are not only interconnected but are also very much part of God's election plan. This is surely seen in Romans 9:11-16. Not only does God show mercy to whom He wishes but He reveals His mysteries to whom He chooses. If God finds a need in His plan to blind a nation or an individual that is His right. Read Exodus 33:19, John 12:40 and Romans 9:15-16.

Whilst all the Bible mysteries have their own relevance and importance I will conclude this article with the mystery of "His Will", as expressed in Ephesians chapter 1. In this short Epistle there are mentioned 5 mysteries. Verses 5, 9 and 11 of chapter 1 mention the Will of God. It is my view that when you cross reference words like adoption, predestination and inheritance to other verses I believe that Paul is writing this letter to none other than the "lost children of the House of Israel". This theme is continued throughout the New Testament

especially as seen in James 1:1 where it says, "to the twelve tribes which are scattered abroad greeting".

These verses in Ephesians 1 encapsulate the entire Will of God as regards His creation. Israel is at the core of this Will or intention of God. This is shown in Isaiah 2:2-4 and 11:9. There are many other verses showing the conclusive fact that true Israel is necessary in His plan to bring about "all things in Christ" (Ephesians 1:10). Even during this time of increasing decay I see God's hand preparing a people who will be chosen to rule with Him in His Kingdom on this earth. This is to do with the mystery of "election". We need not worry for all those who have not heard of the Gospel of Salvation or of the Gospel of the Kingdom for His mercy, justice and love will be the criteria by which He does the choosing.

I urge you to study word by word the Will of God as stated in the first chapter of Ephesians. (2 Timothy 2:15). For a deeper understanding please cross reference all these verses with other sections of the Bible. One of the best books I have, to help me in this regard is "The Treasury of Scripture Knowledge" by Dr. R.A. Torrey. Please obtain a copy as this book will open up the Scriptures and show that both Testaments are intertwined. The Bible will become more of a living history, for it is our history. #### 1666 CHAPTER 11 18 and 19 Cha 2

What is a "*Ces tui Qui Trust*" (pronounce set-a-kay) and why should you care?

In 1666, in London, during the black plague, and great fires of London, Parliament enacted an act, behind closed doors, called Cestui Que Vie Act 1666. ([Click HERE](#) for details)

The act being debated the Cestui Qui act was to subrogate the rights of men and women, meaning all men and women were declared dead, lost at sea/beyond the sea. (back then operating in admiralty law, the law of the sea, so lost at sea).

The rule of the use of CAPITAL LETTERS used in a NAME: when CAPITAL letters re used anywhere in a NAME this always refers to a LEGAL ENTITY/FICTION, COMPANY or CORPORATION no exceptions.

e.g. John DOE or Doe: JANE (PASSPORT, DRIVER LICENSE, MARRIAGE CERTIFICATE and BIRTH CERTIFICATE)

CEST TUI QUE TRUST: (pronounced setakay) common term in NEW ZEALAND and AUSTRALIA or STRAWMAN common term in USA or CANADA is a LEGAL ENTITY/FICTION created and owned by the

GOVERNMENT whom created it. I repeat owned by the GOVERNMENT.

Legally, we are considered to be a FICTION, a concept or idea expressed as a NAME, a symbol. That LEGAL PERSON has no consciousness; it is a juristic PERSON, ENS LEGIS, a NAME/word written on a piece of paper.

This traces back to 1666, London is a state, just like Vatican is a state, just like Washington DC is a state. The Crown is an unincorporated association. Why unincorporated, its private, the temple bar is in London, every lawyer called to the "bar" swears allegiance to the temple bar. You can't get called, without swearing this allegiance. The Crown already owns North America and everything in it.

Your only way out is to reclaim your dead entity (strawman) that the Crown created, become the trustee of the *cest tui qui* trust and remove yourself from the admiralty law that holds you in custody.

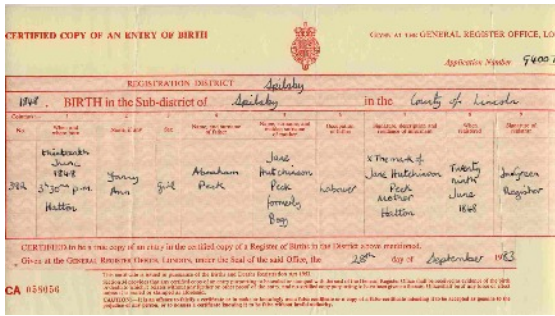
### The subrogation of your rights

When London burned the subrogation of men's and women's rights occurred.

The responsible act passed... CQV act 1666 meant all men and women of UK were declared dead and lost beyond the seas. The state took everybody and everybody's property into trust. The state takes control until a living man or woman comes back and claims their titles by proving they are alive and claims for damages can be made.

This is why you always need representation when involved in legal matters, because you're dead. The legal fiction is a construct on paper, an estate in trust. When you get a bill or summons from court it is always in capital letters, similar to tomb stones in grave yards. Capital letters signify death. They are writing to the dead legal fiction. A legal fiction was created when someone informed the government that there was a new vessel in town, based upon

your birth. Birth certificates are issued at birth, just as ships are given berth certificates.



Your mother has a birth canal, just like a ship. All this information relates to how the general public are still legally tied. Through admiralty law, through this ancient legal construct we can be easily controlled. Learning about your legal fiction helps you to unlock yourself. Otherwise you are just a vessel floating on the sea of commerce. It is possible to be free from financial stress and debt.

Parents are tricked into registering the birth of their babies. In about 1837 the Births, Deaths and Marriages act was formed in UK and the post of registrar general was established. His job was to collect all the data from the churches which held the records of birth.

Regis - from queen or crown. All people are seen to be in custody of, "The Crown". This allows people to function in commerce and to accept the benefits provided by state.

So we are in custody. Worldwide - under the IMF the majority of people are fed, sheltered and provided for, however now it is the system that is benefitting while many are suffering, are poorly fed, housed and water is contaminated. Many people are now getting sick and dying as a result - not to mention that as people evolve, they now seek to be independent of any system that seeks to control or oppress and harms the earth that this is all taking place on.

We have legally elected representatives. We have to understand who we are as men and women and how we can relate in the system.

The City of London is a centre for markets, where merchants work. Then there is mercantile law. It comes from Admiralty. Look at the symbols in the City of London that relate to Admiralty.

Our national banks are not our banks. The private shareholders from the private banks own the banks. It is all private, not public as we are led to believe. "OF" also means "without", eg. The bank without England. Private banks issue private currency.

With WWI a change happened where money was not backed by gold or silver anymore, it is now based on peoples labour. People are now pledged to the IMF as the surety to pay back the creditors in the global bankruptcy. Men and women are not bankrupt, they are the only source of credit. The public is bankrupt.

Regarding the currency that gets issued at the Bank of England, people are the gold or the treasure. The government issues bonds or treasury bills that are bought by investors. The money goes back into the economy in order to pay for the people to build things, e.g. an Olympic Stadium. However, the people are paying taxes for the privilege of using someone else's currency and paying back the principal and the interest on the original loan that was given against the treasury bonds, bills and notes. It is a private corporation that will own the Olympic stadium, be responsible for running it, be able to sell commercial rights, yet the people are actually the ones who own it and should be profiting from it. However, principal and interest is coming through the people in order to raise the money.

So where you have commerce and money, you also have "justice". You need to understand the bankruptcy before you can understand the judiciary. You need to accept the bankruptcy. We have accepted the claim to accept the summons. There is an obligation to accept any liability which has been created. All you can do is accept the bankruptcy. We are operating in admiralty. A not guilty plea dishonours the bankruptcy. The strawman, aka legal fiction is always guilty. It needs to be accepted for value. Barristers and solicitors make a living out of creating controversy. By creating a controversy you become liable for the case.

Honour and dishonour. To remain in honour you have to accept a claim and settle it. Then you add conditions. I accept on proof of claim and proof of loss. This gives the liability back to them. The legal fiction is always guilty. Only in the high courts, can the real man or woman

appear. Games are played on courts; hence the name court is a game with actors (acting on acts). It has to be treated as a game and just business.

Court room dramas are misinformation. In the public, we are operating in bankruptcy and you receive benefits. It takes a lot of time, effort and study to use these tools. You have to be prepared to go fully through the process, get the right tool out of your toolbox at the right time. People need to learn how to act as creditors.

In summary...

- **Money is backed by labour.**
- **We cannot exchange it fairly for gold or silver.**
- **Capitalisation of "name" means a dead entity, a legal fiction.**
- **Know who you are, you are not your strawman or dead fictitious entity.**
- **Learn how to become a creditor in commerce.**

My position on going to court has always been: never voluntarily go to court. Live men and women are not meant to be in any place designed solely for the business of fictional entities. When we attend court, we are deemed dead, in fact, they cannot deal with us until we admit to being dead—a legal fiction—a trust. Court is for titled persons: judge, prosecutor, defendant, bailiffs, cops, and attorneys. Live men and women are not recognized, so it makes sense to send in a dead person—an attorney—to handle our cases—except for one thing: they do not know how the system works, due to their indoctrination. If you can find one to do as you say, then you will prevail, but most of them would rather hang onto their BAR cards than behave honourably. The



only thing that dead, fictional entities want from us is our life energy, and the only way they can get it is by our agreement. Without us, they cannot function, so, they are desperate to get us into court, to have us pay the debt which they created by charging the trust.

Since common law courts no longer exist, we know that the case never has anything to do with “facts” or live men and women and so, anyone who testifies (talks about the facts of the case) is doomed. ALL courts operate in trust law, based upon ecclesiastical canon law—ritualism, superstition, satanism, etc.—which manifests as insidious, commercial law and we are in court to take the hit, if they can get us to do so. They use every trick in the book—intimidation, fear, threat, ridicule, rage, and even recesses, in order to change the jurisdiction, when they know they are losing, in order to make us admit that we are the name of the trust. When we do so, we are deemed to be the trustee—the one liable for administering the trust. Ergo, until now, it has been a waste of our time, energy, and emotion to go to a place where it is almost certain that we will be stuck with the liability.

We all know from our indoctrination, programming, and schooling that judges are impartial and have sworn an oath to this effect. This means he must not favour either plaintiff or defendant. But, our experience reveals that he does, indeed, favour the plaintiff, indicating a glaring conflict of interest—that the prosecutor, judge, and clerk all work for the state—the owner of the CQV trust. So, as the case is NOT about “justice”, it must be about the administration of a trust. They all represent the trust owned by the state and, if we are beneficiary, the only two positions left are Trustee and Executor. So, if you detect the judge’s partiality, although I doubt the case will get this far, you might just want to let them know that you know this.

If you consider court as entertainment and if you can stand the evil emanating from its officers, the fear and angst oozing from the walls, and the treacherous atmosphere, then go, knowing that

under trust law we cannot be the trustee or the executor of a trust, whilst being beneficiary, as that would be a conflict. The position of beneficiary may lack clout, but the other positions hold liability. Since state employees want to be the beneficiaries of the trust, the only way they can do so is to transfer, to us, the liability which they hold, as trustees and executors, because they also cannot be both the administrators and beneficiary of the trust. So, trusteeship and executorship, i.e.: suretyship, becomes a hot potato and everyone wants to toss it so s/he can be beneficiary of the credit from the trust.

When we were born, a trust, called a *Cestui Que Vie Trust* (“CQV”) was set-up, for our benefit. Evidence of this is the birth certificate. But what is the value which must be conveyed to the trust, in order to create it? It was our right to property (via Birth into this world), our body (via the Live Birth Record), and our souls (via Baptism). Since the state/province which registered the trust is the owner, it is also the trustee.... the one that administers the trust. Since they, also, wanted to be beneficiary of this trust, they had to come up with ways to get us, as beneficiary, to authorize their charging the trust, allegedly, for our benefit (via our signature on a document: citation, application, etc.), and then, temporarily transfer trusteeship, to us, during the brief time that they want to be the beneficiary of a particular “constructive” trust.

This means that a trust can be established anywhere, anytime, and the parties of the trust are quickly, albeit temporarily, put into place. But, since a beneficiary cannot charge a trust—only a trustee can do so—it is the state that charges the trust, but they do so for their benefit, not ours (albeit occasionally we do reap some benefit from that charge but nowhere near the value which they reap. Think bank loan..... we reap a minute percentage of what they gain from our authorization). So, the only way, under trust law, for them to be able to charge the trust is to get the authorization from the beneficiary—us, and the only way for them to benefit from their charge is to get us to switch roles—from beneficiary to trustee (the one responsible for the accounting), and for them to switch their role—from trustee to beneficiary because no party can be both, at the same time, i.e.: within the same constructive trust. They must somehow trick us into accepting the role of trustee. Why would we



do so when the trust is for our benefit? .... and how do they manage to do this?



Well, the best way is to get us into court and trick us into unwittingly doing so. But, if we know what has transpired, prior to our being there, it is easy to know what to say so that this doesn't happen. The court clerk is the hot shot, even though it appears as if the judge is. The clerk is the trustee for the CQV owned by the state/province and it is s/he who is responsible for appointing the trustee and the executor for a constructive trust—that particular court case.

So s/he appoints the judge as trustee (the one to administer the trust) and appoints the prosecutor as executor of the trust. The executor is ultimately liable for the charge because it was s/he who brought the case into court (created the constructive trust) on behalf of the state/province which charged the CQV trust. Only an executor/prosecutor can initiate/create a constructive trust and we all know the maxim of law: Whoever creates the controversy holds the liability and whoever holds the liability must provide the remedy. This is why all attorneys are mandated to bring their cheque-books to court because if it all goes wrong for them.... meaning either they fail to transfer their liability onto the alleged defendant, or the alleged defendant does not accept their offer of liability, then someone has to credit the trust account in order to off-set the debt. Since the prosecutor is the one who issues bogus paper and charges the trust, it is the Prosecutor/Executor ("PE") who is in the hot-seat.

When the Name (of the trust), e.g.: JOHN DOE, is called by the Judge aka Administrator aka Trustee ("JAT"), we can stand and ask, "Are you saying that the trust which you are now administering is the JOHN DOE trust?" This establishes that we know that the Name is a trust, not a live man. What's the JAT's first question? "What's your name?" or "State your name for the record". We must be very careful not to

identify with the name of the trust because doing so makes us the trustee. What does this tell you about the judge? If we know that the judge is the trustee, then we also know that the judge is the Name, but only for this particular, constructive trust. Now, think about all the times that JATs have become so frustrated by our refusal to admit to being the Name that they issue a warrant and then, as soon as the man leaves, he is arrested. How idiotic is that? They must feel foolish for saying, "John Doe is not in court so I'm issuing a warrant for his arrest" and then, the man whom they just admitted is NOT there is arrested because he IS there. Their desperation makes them insane. They must get us to admit to being the name, or they pay, and we must not accept their coercion, or we pay. Because the JAT is the trustee—a precarious position, the best thing to say, in that case, is "JOHN DOE is, indeed, in the court!" Point to the JAT. "It is YOU! As trustee, YOU are JOHN DOE, today, aren't you?!"

During their frustration over our not admitting to being a trust name—the trustee and/or executor of the trust, we ought to ask who they are. "Before we go any further, I need to know who YOU are." Address the clerk of the court—the trustee for the CQV trust owned by the state/province, "Are you the CQV's trustee who has appointed this judge as administrator and trustee of the constructive trust case #12345? Did you also appoint the prosecutor as executor of this constructive trust?" Then point to the JAT: "So you are the trustee", then point to the prosecutor, "and you are the executor? And I'm the beneficiary, so, now we know who's who and, as beneficiary, I authorize you to handle the accounting and dissolve this constructive trust. I now claim my body so I am collapsing the CQV trust which you have charged, as there is no value in it. You have committed fraud against all laws!" Likely, we will not get that far before the JAT will order "Case dismissed" or, even more likely, the PE, as he clings tightly to his cheque-book, will call, "We withdraw the charges".

We have exposed their fraud of the CQV trust which exists only on presumptions. The CQV has no corpus, no property, ergo, no value. Trusts are created only upon the conveyance of property and can exist only as long as there is value in the trust. But, there is no value in the CQV trust, yet, they continue to charge the trust. That is fraud!

The alleged property is we men and women whom they have deemed to be incompetent, dead, abandoned, lost, bankrupts, or minors, but that is an illusion so, if we claim our body, then we collapse the presumption that the trust has value. They are operating in fraud—something we’ve always known, but now we know how they do it. Our having exposed their fraud gives them only three options:

1. They can dissolve the CQV trust—the one for which the clerk of the court is trustee and from which s/he created a constructive trust—the case—for which s/he appointed the judge and prosecutor titles which hold temporary liability—trustee and executor, respectively. But they cannot dissolve the CQV or the entire global system will collapse because they cannot exist without our energy which they obtain via that CQV trust.

2. They can enforce the existing rules of trust law which means, as trustee, they can set-off their debt and leave us alone. Now they know that we are onto their fraud and every time they

go into court to administer a trust account, they will not know if we are the one who will send them to jail. The trustee (judge) is the liable party who will go to jail, and the executor (prosecutor) is the one who enforces this. This is why they want us to take on both titles, because then, not only do we go to jail but also, by signing their paper, we become executor and enforce our own sentence. What’s a court clerk to do!?! Pretty soon, none of these thugs will take any cases because the risk is too great. This will be the end of the court system. ‘Bout bloody time, eh?

## From Genesis To Genocide: Destiny Of The Jews By Andrew Carrington-Hitchcock



**T**HIS will come as a rather ominous title to some readers, but anyone familiar with my work will be aware I build my case first to ensure no ambiguities later.

We must first establish that there is such an antipathy to a particular race in the Bible, it is to result in the extinction of that race, and we start in the first book of the Bible, the book of Genesis. (The scripture I use is the King James, putting their use of Lord or God in brackets and replacing it with God’s true name, Yahweh.)

**Genesis 3:13** – “*And Yahweh (the LORD God) said unto the woman, What [is] this [that] thou*

*hast done? And the woman said, The serpent beguiled me, and I did eat.*”

**Genesis 3:14** – “*And Yahweh (the LORD God) said unto the serpent, Because thou hast done this, thou [art] cursed above all cattle, and above every beast of the field; upon thy belly shalt thou go, and dust shalt thou eat all the days of thy life:*”

**Genesis 3:15** – “*And I will put enmity between thee and the woman, and between thy seed and her seed; it shall bruise thy head, and thou shalt bruise his heel.*”

**Now in Genesis 3:15** “*we can see that there is enmity or hatred determined by Yahweh between two seeds, the seed of the woman and the seed of the serpent.*”

The seed (or what we would call race today) of the woman is the seed of Yahweh God, as after

He created Adam he created Eve from Adam as we can see in Genesis chapter 2 below

**Genesis 2:22** – “*And the rib, which Yahweh (the LORD God) had taken from man, made he a woman, and brought her unto the man.*”

**Genesis 2:23** – “*And Adam said, This [is] now bone of my bones, and flesh of my flesh: she shall be called Woman, because she was taken out of Man.*”

The seed (or what we would call race today) of the serpent is the seed of Satan, as we can see in Revelation 12:9 - “*And the great dragon was cast out, that old serpent, called the Devil, and Satan, which deceiveth the whole world: he was cast out into the earth, and his angels were cast out with him.*”

So what Yahweh is referring to in Genesis 3:13-15 is Satan's seduction of Eve which resulted in her falling pregnant with Cain. Eve subsequently lay with Adam which resulted in her falling pregnant with Abel. Both Cain and Abel were brothers in her womb, but with different fathers', Satan for Cain, and Adam for Abel. Cain

is referred to in 1 John 3:12 – Not as Cain, [who] was of that wicked one, and slew his brother...), in reference to Cain's descendancy from Satan and his murder of Abel. After the murder Cain is banished from Eden and goes eastward (see Genesis 4:16 – And Cain went out from the presence of Yahweh (the LORD), and dwelt in the land of Nod, on the east of Eden.), whilst Adam and Eve have another child called Seth (which in Hebrew means replacement) and who we know is Yahweh's son through Adam, by looking at Luke 3:38 – Which was [the son] of Enos, which was [the son] of Seth, which was [the son] of Adam, which was [the son] of Yahweh (God).

Now that we have the identity of the two seeds referred to in Genesis 3:15 which are going to have a permanent hatred for each other and thus be in a state of perpetual war, let us see who they are today.

Let's start off with Yahweh's seed. His first son was called Adam which is called Aw-Dawm in the original Hebrew and means of ruddy face or to show blood in the face (see *Vine's Complete Expository Dictionary of Old and New Testament Words*).

You can see Adam's genealogy all the way to Jesus Christ in Luke 3:23 to 3:38. Within this genealogy you will also find King David at the end of Luke 3:31, who in 1 Samuel 16:12 is also described as ruddy. To my knowledge the white race are the only race that are ruddy, showing blood in the face when angry or embarrassed, but if physical appearances are not enough for people to determine Adam's descendants today, how about what Yahweh said would become of Abraham's descendants (whose genealogy is recorded in Luke 3:34). From Genesis 17:4 to 17:7 Yahweh promises Abraham that he will be

a father of many nations and kings. Again this only seems to apply to the white race who still have numerous royal families throughout Europe, the nations within they created as they migrated westward, along with America, Canada, Australia, even Rhodesia (now Zimbabwe) and South Africa. Interestingly both these African nations have since

overthrown their white race founders, which have caused Zimbabwe to regress into third world status, whilst South Africa is not far behind.

Now that we have established who Yahweh's seed are today, let us identify who the seed of Satan are, and for that we jump forward to the book of John chapter 8 where the Jews are confronting Jesus Christ.

**John 8:38** – “*I speak that which I have seen with my Father: and ye do that which ye have seen with your father.*”

**John 8:39** – “*They answered and said unto him, Abraham is our father. Jesus saith unto them, If ye were Abraham's children, ye would do the works of Abraham.*”



**John 8:40** – “*But now ye seek to kill me, a man that hath told you the truth, which I have heard of Yahweh (God): this did not Abraham.*”

**John 8:41** – “*Ye do the deeds of your father. Then said they to him, We be not born of fornication; we have one Father, [even] Yahweh (God).*”

**John 8:42** – “*Jesus said unto them, If Yahweh (God) were your Father, ye would love me: for I proceeded forth and came from Yahweh (God); neither came I of myself, but he sent me.*”

**John 8:43** – “*Why do ye not understand my speech? [even] because ye cannot hear my word. John 8:44 – Ye are of [your] father the devil, and the lusts of your father ye will do. He was a murderer from the beginning, and abode not in the truth, because there is no truth in him. When he speaketh a lie, he speaketh of his own: for he is a liar, and the father of it.*”

**John 8:45** – “*And because I tell [you] the truth, ye believe me not.*”

**John 8:46** – “*Which of you convinceth me of sin? And if I say the truth, why do ye not believe me?*”

**John 8:47** – “*He that is of Yahweh (God) heareth Yahweh’s (God’s) words: ye therefore hear [them] not, because ye are not of Yahweh (God).*”

Can it be any clearer from the verses above that the Jews are Satan’s seed, Jesus Christ even says it directly in John 8:44. And just to clarify exactly who he was addressing, we simply look at the book of Mark written at the same time which in verse 7:3 states, “the Pharisees and all the Jews,” in other words the Jewish race as a whole. Also note how Christ makes a point of saying, “If Yahweh were your Father,” showing Yahweh is obviously not their father.

Can you see how even when faced with Jesus Christ the Jews try to twist history to suit their agenda, yet their claims to have come from Abraham are irrelevant because only the Jacob Israel line is Yahweh’s seed, Jacob’s brother Esau (also known as Edom) procreated with

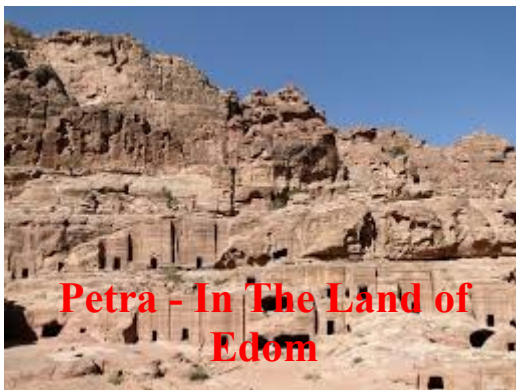
**Malachi 1:1** – “*The burden of the word of Yahweh (the Lord) to Israel by Malachi.*”

**Malachi 1:2** – “*I have loved you saith Yahweh (the Lord). Yet ye say, Wherein hast thou love us? Was not Esau Jacob’s brother? saith Yahweh (the Lord): yet I loved Jacob*”

**Malachi 1:3** – “*And I hated Esau, and laid his mountains and his heritage waste for the dragons of the wilderness.*”

Jews admit to being Esau Edom in the Jewish Encyclopaedia of 1925, where they state, “Edom is in modern Jewry.”

So to recap we have now proved that there is to be a perpetual war between the White Race and the Jews. Who will be victorious? Let’s continue with Malachi.



**Malachi 1:4** – “*Whereas Edom saith, We are impoverished, but we will return and build the desolate places; thus saith Yahweh (the Lord of hosts),*

*They shall build, but I will throw down; and they shall call them, The border of wickedness, and, The people against whom Yahweh (the Lord) hath indignation for ever.*”

To identify the genocide that is going to befall the Jews, I quote these scriptures in closing:

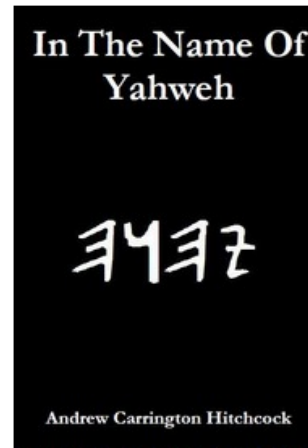

## Was Ed Miliband's Father a KGB Stooge?

The lack-lustre British general election campaign has been spiced up somewhat with the news of a link between a party leader and one of the greatest murderers of the twentieth century Genrikh Yagoda.

According to the Daily Mail, the Liberal Democrat party leader Nick Clegg — who was the Deputy Prime Minister — had an aunt in twenties Moscow who was a Mata Hari-type spy who spread her favours far and wide in the cause of whoever was paying her; entrapping and compromising various paramours including British diplomats and Soviet big wigs.

The Mail alleges that Baroness Moura Budberg worked for the genocidal Jewish Bolshevik Yagoda and may have been one of his sexual conquests. Thanks to the Toronto Globe and Mail we now know that Nick Clegg is a cousin of the Canadian Liberal Party leader — and ethnic Jew — Michael Ignatieff. The Huffington Post has described Clegg's family background as "shrouded in mystery" although it is heavily Dutch and Russian aristocratic.

This would mean that this is the first British general election where all three candidates for the prime minister's post have varying strong degrees of Jewish antecedence. The incumbent prime minister David Cameron has already boasted of his strong Jewish roots to no less than the Knesset.

But in many ways it is the Jewish roots of Cameron's closest rival Ed Miliband which are



most intriguing. Unlike the other two, Miliband is fully ethnically Jewish and boasts an impressive family pedigree with roots that go deep into Britain's Marxist world.

Was Ed Miliband's Trotskyist grandfather involved in the liquidation of White Russians who were opposed to communism? This intriguing question was asked by one of Vladimir Putin's closest advisors eight years ago and has never been satisfactorily answered. Kremlin insider Geb Pavlovsky even said that Ed Miliband may have "inherited" his hatred of Russia from his Polish-born grandfather Samuel.

The Milibands have always played down their family's Bolshevik past and instead preferred to talk about the dozens of family members from the Polish side who died in the Holocaust. Ed Miliband has always been keen to play up this part of the family history

TOO has already asked whether Ed Miliband's father Ralph himself was a KGB stooge or whether he just liked the company of KGB agents. There is no question that in the sixties, intellectual Ralph Miliband moved in the same circles as many Marxist Jews of Russian background. There is equally no question that Britain's security services were deeply concerned because of their KGB links, especially about a Russian attache called "Lev", a frequent visitor to the Miliband Hampstead home who was not slow to throw money and gifts around when it came to getting what he wanted. David Horowitz remembers a ham-fisted attempt to recruit him in the sixties.

They must be made to despise patriotism and the love of their family, to consider their faith as a humbug, their obedience to their Christ as a degrading servility, so that they become deaf to

## “City of London” Is Not Part of England It Is A Separate State From Our Kent Correspondent



**I**F EVER A COUNTRY has been referred by many names it has to be England. What is the difference between United Kingdom, England, Great Britain and moreover why is the ‘City of London’ a Corporation and not part of England, having its own laws?

First, let us run through some of the names used for UK. Before the 17th Century ”there was no such word as British, 4 separate ‘countries’ prevailed comprising people who had their own identity, language and history” English, Scottish, Welsh and Irish.

By 18th century the word British was used. Rule Britannia song was composed and Union flag created.

### British

:  
To be called British is not English only. British are Scottish, Welsh and Irish (living in Northern Ireland) Scottish and Welsh prefer to refer to themselves as Scots and Welsh instead of Brits. United Kingdom.

Formed on 1 January 1801 (2nd Union Act)

Official name of UK is ‘United Kingdom of Great Britain and Northern Ireland’

(UK = Great Britain + Northern Ireland) created in 1927

United Kingdom is made up of England, Scotland, Wales and Northern Ireland.

Comprises total land area of 244,100 square kilometres

Only Northern Ireland is part of UK

Capital of UK is England (capital of England is London)

Capital of Scotland is Edinburgh

Capital of Wales is Cardiff

Capital of Northern Ireland is Belfast (Separate since 1922)

The UNION JACK flag represents England, Scotland and Northern Ireland

### Great Britain

1st Union Act in 1701 formed Kingdom of Great Britain (England, Scotland and Wales)

2nd Union Act in 1801 formed United Kingdom of Great Britain and Ireland

1921 Anglo-Irish Treaty created Northern Ireland

Wales and England was one country under Tudors in 1543 (Scotland and Ireland ran separate kingdoms and Parliament)

GB has been ruled by UK Government since 1707 (Scotland lost its independence by force in 1652 because of Oliver Cromwell)

## England

Is a country in the United Kingdom comprising 2/3 of Great Britain

The total area of England is 130,410 sq km (50,352 sq mi).

84% of UK population live in England

English language derives from England (Scotland and Wales have their own language)

British Royal Family live in London

England and Wales was one country during Tudor Times (1543)

City of London (is a separate sovereign State located in the heart of greater London and not subject to British law) It is a Corporation.

Here's where things get complicated.

City of London and London City is not the same. In fact City of London does not belong to UK, England, Great Britain or Britain.

The City is not a part of England, just as Washington is not a part of the USA. The City of London is a privately owned corporation operating under its own flag, with its own constitution and free from the legal constraints that govern the rest of the country.

(King William III of the House of Orange in 1694 privatized the Bank of England, established the City of London, and turned control of England's money over to an elite group of international bankers. Actually a Committee comprising 12 banks headed by Bank of England (Rothschild).

England is however the financial oligarchy run by the "Crown" = City of London (Not the Queen) The Queen has to take permission to enter this private sovereign state from the Lord Mayor at the Templar Bar (4 Inns of Court – Middle Temple, Inner Temple, Lincoln's Inn and Gray's Inn " all secret societies). The Bar Attorneys of the US owe their allegiance and

pledge their oaths to the Crown (City of London). All Bar Associations throughout the world are signatories and franchises to the International Bar Association located at the Inns of Court of the Crown Temple. (Rense.com)

The City of London is 677 acres. It is a financial district " but not part of UK.

Population of the City of London is 7000 but over 300,000 commute in and out daily.

Population of Greater London is 8.1 million

The 'City' is run by the Bank of England " it is a private corporation.

Those who own the City of London are the Financial Oligarchy and are the power behind the Windsor Throne. They think they are the heirs to the Venetian oligarchy. Members of this oligarchy are mostly Jews (wealthiest of the mercantile class)



But the Bank of England dictates to the UK Parliament.

The Crown Colonies belonged to the City and were not subject to British laws though British citizens were used to conquer nations as well as pay for them. The British, Scottish, Welsh and even Irish are people simply serving the interests of the Crown or The City.

The Bankers are part of a network known as 'Club of the Isles' (informal gathering of European royalty including Queen) and has \$10 trillion in assets including – Royal Dutch Shell, Imperial Chemical Industries, Lloyds of London, Unilever, Lonrho, Rio Tinto Zinc, and Anglo American De Beers.

The Club of Isles dominates world supply of petroleum, gold, diamonds and other raw materials.

The City dominates the world's markets "raw material extraction corporations, finance, insurance, transportation and food production and thus are able to create 'chock points' as well.

The Club of Isles wishes to reduce population and bring the total world population down to 1 billion (world population is 7 billion)

The Bank of England assumed control of the US during Roosevelt's administration (1901-99) after its agent J P Morgan took control of 25% of American business.

Americans think they own the land they purchase in the US " it is far from so. they have merely purchased real estate by contract. A Warranty Deed has no value against a Land Patent.



The Crown was granted Land Patents in North America by the King of England. The US Declaration of Independence is said to have been signed to pacify the populace who objected to being taxed by the Crown (City of London).

The validity of the Declaration of Independence comes into question because the signatories on both sides were agents of the Crown.

Templar Bar Attorneys under solemn oath to the Crown signed the American Declaration of Independence" this means that when a single party signs as both first and second party it has no lawful effect.

From 1694 onwards the 'Crown' in reality were the bankers. The Crown controlled 90% of the world's trade controlled by British ships. The rest of the 10% of ships had to pay Commissions to the Crown for using the world's oceans. By 1850, Frederick Morton estimated that the Rothschilds Bank of England exceeded \$10 billion.

What is surprising is that the Bank of England is protected by its Royal Charter status and the Official Secrets Act that means no one knows who the shareholders are and who owns the company that carries out Central Banking in the UK.

What is even more surprising is that the Bank of England is entitled to issue cash, lend cash, and even charge interest to the government while remaining a private business.

This is no different to the US Federal Reserve Bank of America " it too is a privately owned bank as are all central banks of the world including the Bank for International Settlements (BIS) in Switzerland " where heads of 32 central banks shift billions of dollars at the stroke of a pen.

The world's financial crisis are moments of opportunity for those controlling these banks.

The Bank of England has played a prominent role in wars, revolutions and espionage as well as business panics.

Vatican City and Washington DC are also sovereign City States.

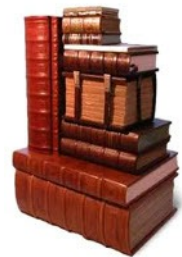

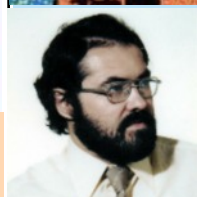

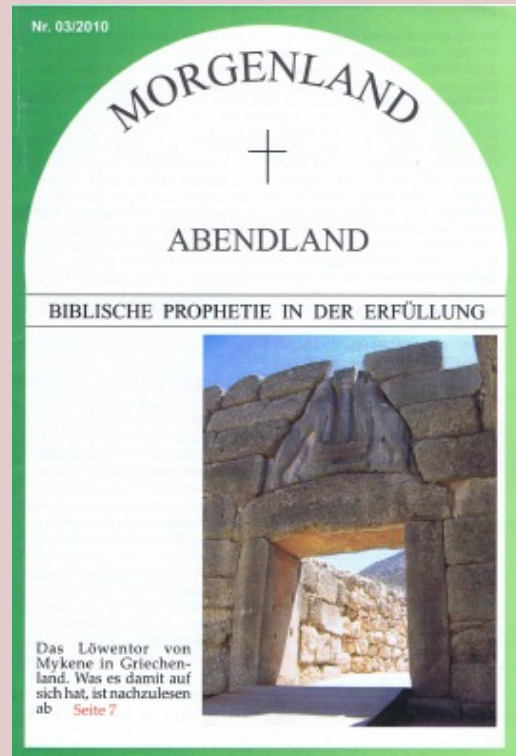
