## GOD DOES SET LAND BOUNDARIES.

**W**E see God setting land boundaries in several places, e.g.,

Although Israelites were dispersed for disobedience, the prophets declare that those of His people who are in a non-mixed state will eventually be re-gathered to this piece of defined land that they will occupy during the millennial reign of the Lord Jesus. Ezekiel defined the millennial borders in Ezekiel 47:21 and this includes much of present-day Syria, Jordan and Lebanon.

**Genesis 10:32** *These are the families of the sons of Noah, after their generations, in their nations: and by these were the nations divided in the earth after the flood.*

**Acts 17:26** *And hath determined the times before appointed, and the bounds of their habitation;*

**Genesis 17:7-8** *And I will establish my covenant between me and thee and thy seed after thee in their generations for an everlasting covenant, to be a God unto thee, and to thy seed after thee. And I will give unto thee, and to thy seed after thee, the land wherein thou art a stranger, all the land of Canaan, for an everlasting possession; and I will be their God.*

The exact area of this land promised to the lineal seed of Abraham is clearly defined in Scripture. God bound Himself with an oath about this. Within this area He defined land as an inheritance for each tribe of Israel. The land was to be held in trust for descendants of each tribe and was not to be sold to foreigners, or outside of each family. The Tribes sinned in not doing this.

We have seen that there is a land about which God says He cares for -[See also Isaiah 5:1 on about this vineyard]. It is described as "His vineyard" to which He will come again.

**Mark 12:1-9** *And he began to speak unto them by parables. A certain man planted a vineyard, and set an hedge about it, and digged a place for the winefat, and built a tower, and let it out to husbandmen, and went into a far country. And at the season he sent to the husbandmen a servant, that he might receive from the husbandmen of the fruit of the vineyard. And they caught him, and beat him, and sent him away empty. And again he sent unto them another servant; and at him they cast stones, and wounded him in the head, and sent him away shamefully handled. And again he sent another; and him they killed, and many others; beating some, and killing some. Having yet therefore one son, his well-beloved, he sent him also last unto them, saying, They will reverence my son. But those husbandmen said among themselves, This is the heir; come, let us kill him, and the inheritance shall be ours. And they took him, and killed him, and cast him out of the vineyard. What shall therefore the lord of*

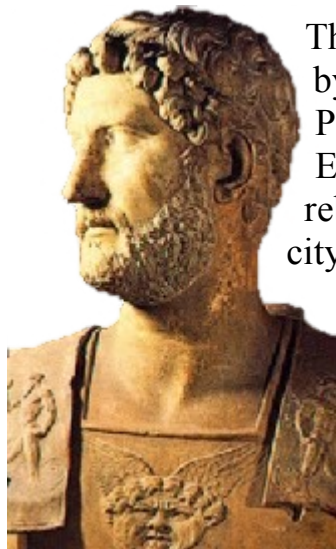
*the vineyard do? he will come and destroy the husbandmen, and will give the vineyard unto others.*

**Luke 19:26** says, *"A certain nobleman went into a far country to receive for himself a kingdom, and to return"*.

Ask yourself, would this be about returning to the same place or to a different place?

**Matt 21:39** *"And they caught him, and cast him out of the vineyard, and slew him. When the lord therefore of the vineyard cometh, what will he do unto those husbandmen?"*

So the whereabouts of the "vineyard" is given. Most churches do not accept that Jesus will destroy those occupying the "vineyard" at His return. They think that the present State of Israel is part of the prophesied re-gathering of Israel. That land of the "vineyard" will be flattened and "judged by fire" when the Husbandman returns.



The vineyard planted by God is the Promised Land. Emperor Hadrian rebuilt the present city of Jerusalem in the third century after every stone had been thrown down -[Matt 24:2 There shall not be left here one stone upon another, that

shall not be thrown down]. [Tourist beware - you will not have been told this! You will not be walking "where Jesus walked"!].

If the husbandman is going to return to the same place, this is the site of the New Jerusalem which John saw descending from above. Some claim that this is the centre of the landmass of the earth, as if this has some bearing. Jesus confined His ministry to the area of the Promised Land, saying in Matt. 15:24, *"I am not sent but unto the lost sheep of the house of Israel."* This confirms, *"He came unto His own"* –("own" with both meanings). It is those of His own people who are "lost" = "set aside for punishment" whom He came to redeem. It includes no other race at all. No other race can become "lost" = *apollumi*.. Jesus sought only "lost sheep" or Israelites.

### **SPECIFIC PLACES ARE IMPORTANT TO God.**

In the book of Deuteronomy alone there are some thirty or more references to the importance of a 'place'. We are not free to choose our place of worship or service. Note the emphasised words in the following Scriptures.

**Deuteronomy 12:5-6** *But unto the place which the LORD your God shall choose out of all your tribes to put his name there, even unto his habitation shall ye seek, and thither thou shalt come:*

**Deuteronomy 12:11-20** *Then there shall be a place which the LORD your God shall choose to cause his name to dwell there; thither shall ye bring all that I command you; your burnt offerings, and your sacrifices, your tithes, and the heave offering of your hand, and all your choice vows which ye vow unto the LORD:*

**13** *Take heed to thyself that thou offer not thy burnt offerings in every place that thou seest: But in the place which the LORD shall choose.*

**18** *But thou must eat them before the LORD thy God in the place which the LORD thy God shall choose*

**Deuteronomy 14:23** *And thou shalt eat before the LORD thy God, in the place which he shall choose to place his name there, the tithe of thy corn, of thy wine, and of thine oil, and the firstlings of thy herds and of thy flocks; that thou mayest learn to fear the LORD thy God always.*

**Matthew 12:6** *But I say unto you, That in this place is one greater than the temple.*

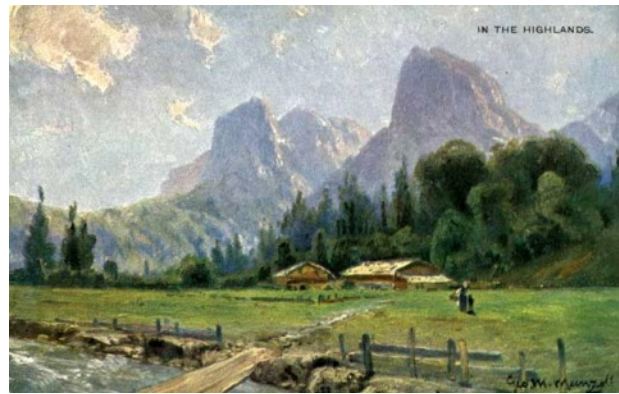
**Matthew 24:15** *When ye therefore shall see the abomination of desolation, spoken of by Daniel the prophet, stand in the holy place, (whoso readeth, let him understand:)*

**Luke 10:1** *After these things the Lord appointed other seventy also, and sent them two and two before his face into every city and place, whither he himself would come.*

**John 14:3** *And if I go and prepare a place for you, I will come again, and receive you unto myself; that where I am, there ye may be also.*

**Isaiah 62:1-4** *For Zion's sake will I not hold my peace, and for Jerusalem's sake I will not rest, until the righteousness thereof go forth as brightness, and the salvation thereof as a lamp that burneth.*

And the Gentiles [i.e. nations] shall see thy righteousness, and all kings thy glory: and thou shalt be called by a new name, which the mouth of the LORD shall name. Thou shalt also be a crown of glory in the hand of the LORD, and a royal diadem in the hand of thy God.



Thou shalt no more be termed Forsaken; neither shall thy land any more be termed Desolate: but thou shalt be called Hephzibah, and thy land Beulah: for the LORD delighteth in thee, and thy land shall be married.

When is, "Thou shalt be called by a new name"? Some people with bad imaginations say this new name is "Christians", but they have the timing wrong! What is "Thy Land" which will become a "fruitful field"?

### **ZION, A SPECIAL PLACE TO GOD.**

Let us consider a special place, namely the City of David, known in Scripture as "Zion". This city is always used in the context of Israel alone. We quickly see that it is a place that is special to God, and to Israel. We will look at a selection of passages containing the word "Zion" and then consider whether or not "Zion" refers to Jerusalem.

**Psalms 2:6** *Yet have I set my king upon my holy hill of Zion.*

**Psalms 9:11** *Sing praises to the LORD, which dwelleth in Zion: declare among the people his doings.*

**Psalms 14:7** *Oh that the salvation of Israel were come out of Zion! when the LORD bringeth back the captivity of his people,*

*Jacob shall rejoice, and Israel shall be glad. [Note the limitation to the people of Israel].*

**Psalm 48:1-7** *Great is the LORD, and greatly to be praised in the city of our God, in the mountain of his holiness. Beautiful for situation, the joy of the whole earth, is mount Zion, on the sides of the north, the city of the great King. God is known in her palaces for a refuge. For, lo, the kings were assembled, they passed by together. They saw it, and so they marvelled; they were troubled, and hasted away. Fear took hold upon them there, and pain, as of a woman in travail. Thou breakest the ships of Tarshish with an east wind.*

**Psalm 53:6** *Oh that the salvation of Israel were come out of Zion! When God bringeth back the captivity of his people, Jacob shall rejoice, and Israel shall be glad. [Note the Israel limitation again].*

**Psalm 69:35-36** *For God will save Zion, and will build the cities of Judah: that they may dwell there, and have it in possession. The seed also of his servants shall inherit it: and they that love his name shall dwell therein.*

**Psalm 76:1-2** *In Judah is God known: his name is great in Israel. In Salem also is his tabernacle, and his dwelling place in Zion.*

Psalm 78:68 *But chose the tribe of Judah, the mount Zion which he loved.*

Psalm 87:2-3 *The LORD loveth the gates of Zion more than all the dwellings of Jacob. Glorious things are spoken of thee, O city of God. Selah. [Psalm 13:1-6; 123:1-4].*

**Psalm 132:13** *For the LORD hath chosen Zion; he hath desired it for his habitation.*



**Isaiah 2:1-4** *The word that Isaiah the son of Amoz saw concerning Judah and Jerusalem. And it shall come to pass in the last days, that the mountain of the*

*LORD'S house shall be established in the top of the mountains, and shall be exalted above the hills; and all nations shall flow unto it. And many people shall go and say, Come ye, and let us go up to the mountain of the LORD, to the house of the God of Jacob; and he will teach us of his ways, and we will walk in his paths: for out of Zion shall go forth the law, and the word of the LORD from Jerusalem. And he shall judge among the nations, and shall rebuke many people: and they shall beat their swords into ploughshares, and their spears into pruning hooks: nation shall not lift up sword against nation, neither shall they learn war any more.*

**Isaiah 60:14** *The sons also of them that afflicted thee shall come bending unto thee; and all they that despised thee shall bow themselves down at the soles of thy feet; and they shall call thee, The city of the LORD, The Zion of the Holy One of Israel.*

God will indeed "Bring back the captivity of His people"! There are many passages that mention both Jerusalem and Zion, and some say this is a form of parallelism that indicates that both words have the same application. So we must examine this claim.

# Misconceptions About Josephus, The Judean (6)

## Or, How To Tell the Difference Between a Jew and an Israelite!

**NOW, PAY ATTENTION, FOLKS, BECAUSE HERE COMES THE HISTORICAL MEAT:**

**W**HEN the nation of Judah,

*which was composed exclusively of the racial descendants of the patriarch Judah, plus some Benjaminites and some Levites, was combined with the nation of Idumea, **two racially distinct people (one pure, one mixed) who practiced two diametrically opposed religions became one nation.** But the ethnic differences fully remained! This was a marriage conceived in hell by Antipater, enforced by Rome, and carried out by Herod.*

*So, when all of this world's religious commentators, theologians, historians and scholars tell you that these Edomites CONVERTED to Judaism, they are teaching falsehood, because that explanation presumes that Judaism existed in Judah before the "conversion." The reality is that the combined sects of the scribes and the Pharisees ALTERED Mosaism so as to CREATE Judaism. **There was no such thing as Judaism before this merging of two disparate nations and their separate traditions, one being Mosaic, the other pagan.** To the novice, the differences between Judaism and Mosaism may seem subtle but the reality is that **any similarity between Judaism and Mosaism has been CONTRIVED by the rabbis.** Thus, the orthodox perception gives Judaism a legitimacy which it does not deserve. By the use of carefully contrived words and slightly altered history, Judaism has thus been falsely associated with the House of Judah, when the Judahites never practiced that religion at all.*

*Now, it can be seen that these scribes and Pharisees had formed a NEW SECT that never existed among the exclusive people of Judah. **Before this sect, there was no such thing as a sect which taught that non-Judahites could become Judahites by decree or by adoption.** This anti-Mosaic, anti-Levitical conversion policy*

*began with the scribes and Pharisees; and this spelled the origin of the religion called Judaism; and this policy is still true of Judaism today; but it was NEVER true of Mosaism and it was never taught before the scribes and Pharisees came on the scene. The Law of Moses absolutely prohibits us from inviting non-Israelites to come into our congregation and practice our religion; and it absolutely prohibits our people from intermarrying with non-Israelites. **The scribes and Pharisees broke both of these laws. This is how Judaism came into being.** Thus, Judaism can only be understood as a DEVIATION from Mosaism, though it claims Mosaism as its basis. The simple reality is that the Pharisees ASSUMED Mosaism IN ORDER TO PERVERT IT to their purposes, and Yahshua Messiah understood this completely. This is why they conspired to murder Him, for fear of exposure, so that the populace would not catch on to their con game.*

*The scribes and Pharisees, with the military force of Rome backing them up, foisted THEIR OWN TRADITIONS upon the people of Judah and claimed to be the inheritors of the Mosaic Law. So, Judaism began as a VIOLATION of the Laws of Moses, **not as a continuation of those Laws.** After three or four generations of this deception, even some Judahites were unable to see the differences between the Mosaic Law and the traditions of the Pharisees, just as Saul was fooled before he became Paul.*

*The rabbis of Judaism have always made their living pretending that their tradition existed among the people of Judah throughout Judah's history. As long as people believe this lie, their charade as Israel and Judah prospers at our expense. This impersonation of Judah has deceived the Entire World. In political terms, an act of sabotage by an outsider is thus falsely perceived as a mere civil dispute. It is due to this very clever deception that every historian, theologian and commentator mistakenly calls the Judahites and Israelites of Old Testament times "Jews." As I have said elsewhere, this is the "Immaculate Deception" of Judaism. By obscuring and occluding this historical period, Jewry has been able to convince the world that they originated in Judah when they in fact originated in Idumea.

Furthermore, they claim to have been present in Egypt during the Captivity, wandering through the land of Canaan for forty years after the Exodus, present at Mt. Sinai when the Law was delivered to Moses, etc., etc., when there were, in fact, no Jews involved in any of these historical events. These people were Israelites, not Jews.



The best way of putting it is this: A Culture of Lies has been taking advantage of a Culture of Honesty for the last 2,150 years, beginning with those

turbulent years of John Hyrcanus and Herod the Great. Since that time, the Jews have been masquerading as both Israel and Judah simultaneously. Through their relentless efforts of rewriting and distorting history, they have convinced us that they are the Chosen People of Israel, when, in fact, they are Israel's WORST ENEMIES, pretending to be "kin" to Christian Israel in order to destroy us!...as related in the story plot above. This is classic parasitism!

The reality is that there were no Jews in the Egyptian Captivity. There were no Jews involved in the Exodus. There were no Jews wandering through the land of Canaan with Moses. There were no Jews present at Mt. Sinai for the reading of the Law. There were no Jewish members of either of the Two Houses (Judah or Israel) during their turbulent history. There were no Jewish people in the Captivity at Babylon. There were no Jews involved in the post-Babylonian Reconstruction of Jerusalem. There was no Jewish priesthood during any of these episodes of OUR history. These people were Israelites, not Jews.

By continuously promoting the idea that "Israel" and "Jewry" are identical or that "Judah" and "Jewry" are identical, the rabbis of Judaism have successfully created the impression that their ancestors were present at ALL of these historical events when they were, in fact, present at NONE of these events. They have

nothing whatsoever to do with OUR history; however, they are a most subtle and crafty people, taking after their father, Nachash. This is what makes them such redoubtable experts at historical pretentiousness. In this, they have no equal.

From this it follows that Abraham was not a Jew, Isaac was not a Jew, Jacob was not a Jew, Judah was not a Jew, none of his brothers were Jews, Moses was not a Jew, Aaron was not Jew, Joshua was not a Jew, David was not a Jew, Daniel was not a Jew, Jeremiah was not a Jew, and, most certainly of all, Jesus was not a Jew. Before Jacob, they were Hebrews. After Jacob, they were collectively known as Israelites. They never referred to themselves as "Jews," and their contemporaries never called them Jews, because the Jews are an entirely different ethnic group, both racially and religiously. In fact, even in New Testament times, the Judahites of Judea preferred to refer to themselves as "Israel."

In the Book of Acts, after Yahshua's Resurrection, he appeared to the Apostles, who asked Him, "Wilt thou at this time restore again the kingdom to ISRAEL?" (Acts 1:6.) Note, they DID NOT SAY "Wilt thou restore the kingdom to the Jews?" The Kingdom never belonged to the Jews. The Jews are impostors who are trying to steal the Kingdom from us.

In the parable of the Householder, Yahshua speaks of the "husbandmen," who, seeing that the Son and Heir had come to the vineyard, consulted among themselves and said, "This is the heir; come, let us kill him, and let us seize on his inheritance." (Matt. 21:38, repeated at Mark 12:7 and Luke 20:14.)

What is this inheritance? Obviously, it is the Kingdom that is yet to come. But, also, dear Christian Israelite, it is YOU. "For I will **for-sake the remnant of mine inheritance**, and deliver them into the hand of their enemies...Because they have done that which is evil in my sight." (II Kings 21:14-15.) YOU, dear Anglo-Saxon Israel, are the flesh and blood inheritance of Yahweh, redeemed by Yahshua. Don't let anyone tell you that this not Christian doctrine. It's the false priests who have invented the "spiritual Israel" doctrine and who deny the Covenants, the Promises and the Inheritance. The Jews and their cohorts have done everything in their power to make you feel ashamed of who you are. They will call you a "racist" and an "anti-Semite" or an "extremist"



for asserting your right to your own, family inheritance. Instead of rebuking Satan, we become dazed and stupefied, saying, "I'm sorry if I have offended you! Please forgive me for presuming to take that which is rightfully mine by inheritance!" Satan, smiling, says, "Off with your head!"

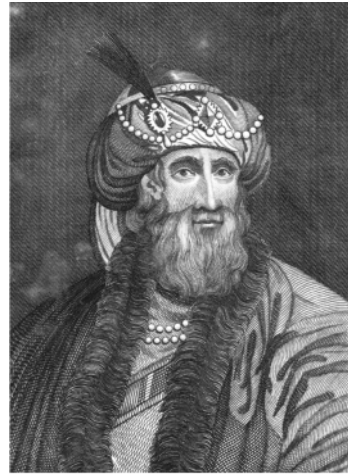
We have tolerated Jewish supremacism and injustice long enough! The time has come to reclaim our inheritance and take it away from the impostor.

The historical fact is that the rabbis of Judaism have appropriated OUR history and have claimed to be Israel and Judah since the days of the scribes and Pharisees. Now, why would they do this? Because they know that they are the children of the devil and the only hope they have of continued life is to prevent True Israel from obtaining the Kingdom...like a disease organism trying to prevent the cure from taking effect, the rabbis are doing everything they can to prevent us from claiming our inheritance. **AND THEY HAVE ALMOST SUCCEEDED!** They are trying to do to us what they did to Yahshua Messiah, because they know that Yahweh created us in order to take dominion away from them. (Psa. 8:6; Psa. 114:2; Eph. 1:11-12; Eph. Chapter 2.) Rev. 3:9: "Behold, I will make of them of the **SYNAGOGUE OF SATAN**, which say they are Judeans and are not [because they are really Edomites!], but do lie [as Jews are wont to do!]; behold, **I will make them to come and worship before thy feet, and to know that I have loved thee.**" (Rev. 3:9.)

If you think that the Jews are anything other than the Synagogue of Satan, you are thoroughly deluded and you need to throw away your blinders and start looking at their works. "By their fruits shall ye know them." This is a life and death struggle, folks, between the parasite and the host!!!!...between the children of darkness and the children of light. Shouldn't you be able to tell the difference?

By assuming Hebrew names, pantomiming Israelite rituals, creating their own version of the Hebrew language, and by writing themselves into the pages of history where they never set foot, they have convinced the world that they are the Hebrew Israelites.

Thus, when Christian scholars and secular historians talk about the "Jews" in ancient Egypt, or the "Jews" at Mt. Sinai, or the "Jews" that returned from the Babylonian Captivity, or



Josephus the "Jewish" historian, they have no idea how they have been deceived. By cleverly inserting the word 'Jew' into the modern translations of the Bible **where it was never used by the original Hebrew authors**, and by constantly re-writing history to

make themselves look like the heroes of Genesis, Exodus, Leviticus -- yes, even the Book of Esther -- etc., they have impersonated us in the most thorough fashion.

Now, mind you that, if the Jews really were Israel, perhaps one or two of the many prophecies concerning the Twelve Tribes would be true of them, but they are not. Numerous Christian Identity authors have pointed out that the Jewish people do not fit any of the Marks of Israel, namely those Israelite prophecies which have been fulfilled exclusively by Anglo-Saxon Israel, and no one else. Two of these prophecies should illustrate what I am saying:

Illustration #1: As pointed out earlier, Jeremiah 31:31-33 says that Israel would be subject to a **NEW COVENANT** in which the Law will be written in their hearts. As we all should know, this process was begun at Calvary when our original sin (by Adam and Eve in the Garden) was redeemed by Yahshua Messiah. Now, which group of people has accepted the Redeemer and the New Covenant? Jews or Anglo-Saxon Israel? Jesus Himself said that He came only for the "Lost Sheep" of the House of Israel, which brings up the second illustration:

Illustration #2: The children of Israel would fall into a state of amnesia during which they would **FORGET THEY ARE THE ISRAEL OF SCRIPTURE.** The following passages verify this: Isa. 29:1-14; 42:16, 19-20; Hosea 1:9-10; 2:7-19; Romans 11:7,8,25. Now, we Anglo-Saxons have indeed forgotten our Israelite roots. Can this be said of the Jews? Absolutely not! The fact is that the Jews have persisted in claiming to be Israel down through the centuries, so **THEY NEVER FORGOT** to claim they are Israel. In order to maintain their masquerade as Israel, they could not allow themselves to forget whom they are impersonating, otherwise the game is up!

*In the meantime, the rabbis are scrambling to prevent the Marks of Israel from seeing the light of day! But this is like trying to prevent the sun from rising. This is why these last days are turning into ABSOLUTE CHAOS, because the parasite has to pull out all the stops to prevent his own demise.*

*Please read the verses cited above. After Isa. 29:14, there is a warning to those false prophets who have turned Scripture upside down. "Surely your turning of things upside down shall be esteemed as the potter's clay: for shall the work say of him who made it, He made me not? Or shall the thing framed say of Him that framed it, He had no understanding?" (Isa. 29:14-15.) This is a reference to the Talmudic Edomite Jewish rabbis who have distorted Scripture so as to put themselves in the starring role, even above Yahweh.*

*Only Talmudic Judaism teaches that G-d consults a rabbi before making a decision and that*

*a rabbi can overrule G-d. Has not this clay disesteemed its maker? Would you expect a priesthood that honours itself above God to accept His Son as the Messiah? Recall the parable of the husbandmen. No, they would rather choose their own messiah. Before the world, these human devils posture as "pious" and "learned" men. The reality is they are the servants of Lucifer.*

*Given this knowledge that Judaism is an impostor religion, it is clear that Christianity as practiced by Israelites and Judahites is the True inheritor of the Mosaic Tradition. The New Covenant is made with exactly the same people as the Old Covenant: the Houses of Israel and Judah. **That New Covenant applies only to us and to no one else.** Furthermore, anyone who claims that the Covenants were transferred from the Jews to some universal church is just as much a deceiver as any rabbi, for the Bible says NO SUCH THING. **WHAT A QUESTION?** No doubt many Christians would be surprised by such an inquiry. However, the question is not irrelevant at all, but is very much to the point. You see all "Christians" claim to love and obey Jesus Christ, but would the Jesus they love join the mass and media frenzy to condemn Bob Jones

University and the stand they have taken against race mixing?

Liberal Christians would cry, "Don't bring Jesus into the picture." This is about the racist, bigoted attitude of Bob Jones University. Well, I beg to differ, because if a person is going to refer to themselves as a Christian (no matter what variety of Christian they may be), if they are going to condemn people, organizations, political views and so forth, as being "bad, wicked or terrible," and Jesus Christ and the Word of God proclaim this same unpopular point of view, isn't that rather hypocritical of those pseudo Christians? 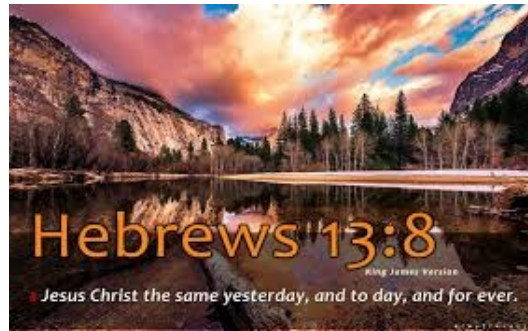
***Jesus Christ the same yesterday, and today, and forever. Heb 13:8.***

Yes, our great God and Saviour Jesus Christ is the same yesterday, today, and forever. However, fickle man continues to be tossed to and fro by the lies of the adversary, and like the politicians running for office, they call that which is evil, good, and that which is good, evil (Isaiah 5:20). How sad it is that so many lukewarm Christians today are developing their sense of right and wrong from the media, opinion polls, and movies. An even more sad reality is that most people who would refer to themselves as Christians, don't even know where Jesus Christ stands on any issue, because in their mind, Jesus is just someone who saves and blesses, and other than that, He's not really relevant to the issues of our day. There are others, of course, who think that Jesus is an ultra liberal who would walk hand in hand with Al Gore and Bill Bradley. Still others think that Jesus would join with the media, John McCain, and George W. Bush, in denouncing Bob Jones University. In their mind, Jesus Christ would certainly not side with Bob Jones University and their position against race mixing. Well, what does the Word of God have to say about the thoughts of men?

Isaiah 55:8-9, *"For my thoughts are not your thoughts, neither are your ways my ways, saith the LORD. For as the heavens are higher than the earth, so are my ways higher than your ways, and my thoughts than your thoughts."*

Worldly thought (mostly from the NAACP, Roman Catholics, and homosexual groups) have joined in one voice with the demand that all politicians challenge and rebuke the ideas and policies of Bob Jones University, or suffer being demonised by the dogs of the media. Further evidence of the wicked machinations of man is represented by a Senate resolution drafted by

Sen. Robert Torricelli (D-N.J.) denouncing Bob Jones, "decrying its segregationist policy." Even South Carolina Democratic Sen. Ernest "Fritz" Hollings voiced support for the resolution calling Bob Jones University "a national embarrassment." Now, if you are Christian, and you believe that Jesus Christ condones race-



mixing, then you probably would not have much trouble believing that this Democratic resolution against Bob Jones University is inspired of God. Well, while you're thinking about that, I want to share with you the following words by Jesus himself. You will notice

that His words speak directly to this very issue of man catering to popular opinion for popularity over principle and truth.

Luke 16:15-17, *"And he said unto them, ye are they which justify yourselves before men; but God knoweth your hearts: for that which is highly esteemed among men is abomination in the sight of God. The law and the prophets were until John: since that time the kingdom of God is preached, and every man presseth into it. And it is easier for heaven and earth to pass, than one tittle of the law to fail."*

All Christians need to carefully read and understand the importance and significance of Jesus' words: *"it is easier for heaven and earth to pass, than one tittle of the law to fail."* Remember that those are Jesus' words upholding God's Laws that I have quoted for you. Now you've got to ask yourself, either I'm trying to deceive you into believing that God's Law is still in force, or I'm telling you the truth, and God's Law is still the measure of right and wrong. It's really quite simple actually, you will either acknowledge and obey God's Laws that establish and define what sin is, or you will trust man and his laws and policies to make this determination for you. But let me give such Christians that speak against sin, but have no idea how to define sin a little hint: 1 John 3:4, ***"Whosoever committeth sin transgresseth also the law: for sin is the transgression of the law."***

You may say, OK, but you still haven't explained how Jesus is against race-mixing. Well, simply stated, Jesus is against race-mixing because it is a SIN, a violation of His Divine Law, even His creative law which establishes a 'kind after kind'

process in Genesis 1:21-26. You will notice that within these verses we are told, *"every living creature that moveth, which the waters brought forth abundantly, after their kind, and every winged fowl after his kind ... let the earth bring forth the living creature after his kind, cattle, and creeping thing, and beast of the earth after his kind"*, and so forth. Question, if the fowl have their different kinds and types, and the cattle their different kinds and types, and the fish their kind and types etc., then it should be equally obvious and true that there are also different kinds and types of man. In other words, in nature as God created them, there is a natural inbred knowledge and instinct of separation within all species of animals. There are different types and variety of eagles such as the Bald eagle, the Golden eagle, White-tailed eagle, Short-toed eagle, and Imperial eagle. All of these eagles are of the same genetic family, but they are not the same progeny or breed.

The same holds true for the different variety of bipeds. God Almighty did not make a mistake in creating the different races of people. In fact, the principle "what God hath put together, let no man put asunder" is very much applicable to the 'kind after kind' principle. Kind after kind is the creation rule and carnal minded man grossly violated this principle of Divine creation.

Again, look over these verses in Genesis 1. The Word of God repetitiously puts forth this directive that every winged fowl was to mate *"after his kind,"* and every *"living creature after his kind,"* and this principle does not exclude people. The Golden eagle is not of the Bald eagle kind, therefore the two different breeds do not mix their seed. They stay separate and the same principle holds true for people. Within humans, there are a variety of breeds or kinds, such as Indian, Asiatic, Negro, Aboriginal, and White/Anglo people, and according to God's Creation Laws, these different kinds, or breeds of mankind are not to interbreed or engage in race-mixing.

All variety of animals, fish, birds, insects, etc. are unique and distinct, and they have remained so since their creation, except where man has interfered and perverted their natural breeding habits. Again, there are a number of varieties within the bird family, but the variety of breeds do not mix their seed with other breeds. Canadian geese mate only with Canadian geese, Red-breasted geese mate only with Red-breasted geese, the Grey goose mates only with other

Grey geese and so forth. In the animal world, the Elk mates only with Elk. You won't see them mating with mule deer or a Moose. Orangutans mate only with Orangutans. They don't mate with Gorillas or other species of monkeys.

Jesus warned us in Matthew: 24:36-39, about the "days of Noah" in which there would be "marrying and giving in marriage." This is not about simple adultery as many Judeo-Christian ministers are teaching today. To prove this, let's go back to the original Bible passages, which describe the "days of Noah."



Genesis 6:1-5, *"And it came to pass, when men began to multiply on the face of the earth, and daughters were born unto them, that the sons of God saw the daughters of men that they were fair; and they took them wives of all which they chose. And the LORD said, My spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years. There were giants in the earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown. And God saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually."*

If you will notice, there are two kinds of people described in these verses, "the sons of God," (who were of one order) and the "daughters of men" (who were of another order). Furthermore we are told that from this mixing of their seed (miscegenation) a new breed or distortion was produced, which the Scriptures refer to as "giants in the earth." So, did Jesus speak against race mixing? Well, if we read what Jesus warned of from Matthew 24, in context with the example He quoted from in Genesis 6, we can come to no other conclusion but that Jesus Christ is truly the same "yesterday, today, and forever." He and His Word changes not. Man and man's carnally biased interpretation of His Word changes

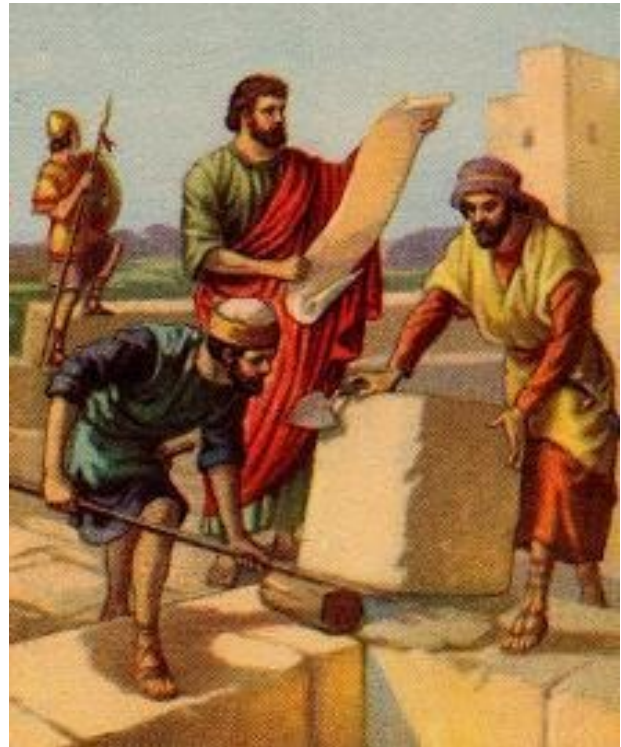
frequently according to the worldly trends of the day and what is politically correct.

Speaking of politically correct. I'm sure most of you Christians remember the great story of Nehemiah and the tremendous faith and vision he had to rebuild the wall of Jerusalem. Over the years, I have heard wonderful messages about Nehemiah and the many forms of opposition he had to overcome in order to complete the wall. Nehemiah is used as an example of a man who had a conviction of faith, not a preference of faith. A man whose heart was close to God. Well, let's read the following verses regarding race-mixing, and let's see how Nehemiah deals with the problem.

Nehemiah 13:23-30, *"In those days also saw I Jews (D.B. Note: Judeans of the Southern Kingdom of Judah) that had married wives of Ashdod, of Ammon, and of Moab; and their children spake half in the speech of Ashdod, and could not speak in the Hebrews' language, but according to the language of each people. And I contended with them, and cursed them, and smote certain of them, and plucked off their hair, and made them swear by God, saying, ye shall not give your daughters unto their sons, nor take their daughters unto your sons or for yourselves. Did not Solomon king of Israel sin by these things? Yet among many nations was there no king like him, who was beloved of his God, and God made him king over all Israel: nevertheless even him did outlandish women cause to sin. Shall we then hearken unto you to do all this great evil, to transgress against our God in marrying strange wives? And one of the sons of Joiada, the son of Eliashib the high priest, was son in law to Sanballat the Horonite: therefore I chased him from me. Remember them, O my God, because they have defiled the priesthood, and the covenant of the priesthood, and of the Levites. Thus cleansed I them from all strangers, and appointed the wards of the priests and the Levites, every one in his business."*

I have to admit, that of all the various messages I've heard from the book of Nehemiah, I have never heard one Judeo-Christian minister preach from these Bible passages. I wonder why? Could it be that these verses may be just a little too sensitive for congregations who have been taught that race-mixing is perfectly okay, or even right and proper in the eyes of God? Well, if it's so right, why do we find race-mixing condemned in the Word of God from Genesis through Revelation? Notice verse 27, *"Shall we then*

*hearken unto you to do all this great evil, to transgress against our God in marrying strange*



*wives?"* Race-mixing is referred to as a "great evil," even described as "to transgress," meaning a SIN.

Was Nehemiah some wicked racist hater, or was he a man of God? Was he on the popular world opinion side, or was he on God's side? Which side do you think Jesus Christ would have been on? You see, Nehemiah didn't just develop his righteous indignation out of some evil suppressed motive of hate, rather it was out of love from Matthew 22:37, *"Thou shalt love the LORD thy God with all thy heart, and with all thy soul, and with all thy mind."* Fellow Christians, if man's will is more important to you than God's Will, your heart is not right with Jesus Christ.

Even back in Deut. 7:1-3, God Almighty warned His people Israel against the dangers of race mixing. Whether we understand all the "ifs, ands, whys, or buts," we had better determine to obey God rather than men. If we (as Christians) do not have the love of God in our hearts, then we will develop into the type of nation America has become today, a pluralistic paganistic nation which embraces that which is pleasing in our own sight. Heed the following warning from Joshua 23:

Verses 11-23, *"Take heed therefore unto yourselves, that ye love the LORD your God. The if ye do in any wise go back, and cleave unto the*

*remnant of these nations, even these that remain among you, and shall make marriages with them, and go in unto them, and they to you: know for a certainty that the LORD your God will no more drive out any of these nations from before you; but they shall be snares and traps unto you, and scourges in your sides, and thorns in your eyes, until ye perish from off this good land which the LORD your God hath given you."*

In light of all that we have covered from the Word of God, can any true Christian truthfully believe that Bob Jones University is motivated

by hate? Can they believe that if Jesus Christ were here today, He would be walking hand in hand with the likes of Al Gore, Bill Bradley, John McCain, and, yes, even George W. Bush (who is going out of his way to distance himself from the University)?

## **Christmas In The Trenches, 1914 From Our Midland's Correspondent**

### **Christmas in the Trenches, 1914**

**B**Y the end of November 1914 the crushing German advance that had swallowed the Low Countries and threatened

France had been checked by the allies before it could reach The opposing armies stared at each other from a line of hastily built defensive trenches that began at the edge of the English Channel and continued to the border of Switzerland.

Barbed wire and parapets defended the trenches and between

stretched a "No Mans Land" that in some areas was no more than 30 yards wide.

Life in the trenches was abominable. Continuous sniping, machinegun fire and artillery shelling took a deadly toll. The misery was heightened by the ravages of Mother Nature, including rain, snow and cold. Many of the trenches, especially those in the low-lying British sector to the west, were continually flooded, exposing the troops to frost bite and "trench foot."

This treacherous monotony was briefly interrupted during an unofficial and spontaneous "Christmas Truce" that began on Christmas Eve. Both sides had received Christmas packages of food and presents. The clear skies that

ended the rain further lifted the spirits on both sides of no-mans-land.

The Germans seem to have made the first move. During the evening of December 24 they delivered a chocolate cake to the British line accompanied by a note that proposed a cease fire so that the Germans could have a concert. The British accepted the proposal and offered some tobacco as their present to the Germans. The good will soon spread along the 27-mile length of the British line. Enemy soldiers shouted to one another from the trenches, joined in singing songs and soon met one another in the middle of no-mans-land to talk, exchange gifts and in some areas to take part in impromptu soccer matches.

The high command on both sides took a dim view of the activities and orders were issued to stop the fraternizing with varying results. In some areas the truce ended Christmas Day in others the following day and in others it extended into January. One thing is for sure - it never happened again.

"We and the Germans met in the middle of no-man's-land."

Frank Richards was a British soldier who experienced the "Christmas Truce". We join his story on Christmas morning 1914:

"On Christmas morning we stuck up a board with 'A Merry Christmas' on it. The enemy had stuck up a similar one. Platoons would sometimes go out for twenty-four hours' rest - it was a day at least out of the trench and relieved the monotony a bit - and my platoon had gone out in this way the night before, but a few of us stayed behind to see what would happen. Two

of our men then threw their equipment off and jumped on the parapet with their hands above their heads. Two of the Germans done the same and commenced to walk up the river bank, our two men going to meet them. They met and shook hands and then we all got out of the trench.

Buffalo Bill [the Company Commander] rushed into the trench and endeavoured to prevent it, but he was too late: the whole of the Company were now out, and so were the Germans. He had to accept the situation, so soon he and the other company officers climbed out too. We and the Germans met in the middle of no-man's-land. Their officers was also now out. Our officers exchanged greetings with them. One of the German officers said that he wished he had a camera to take a snapshot, but they were not allowed to carry cameras. Neither were our officers.

We mucked in all day with one another. They were Saxons and some of them could speak English. By the look of them their trenches were in as bad a state as our own. One of their men, speaking in English, mentioned that he had worked in Brighton for some years and that he was fed up to the neck with this damned war and would be glad when it was all over. We told him that he wasn't the only one that was fed up with it. We did not allow them in our trench and they did not allow us in theirs.

The German Company-Commander asked Buffalo Bill if he would accept a couple of barrels of beer and assured him that they would not make his men drunk. They had plenty of it in the brewery. He accepted the offer with thanks and a couple of their men rolled the barrels over and we took them into our trench. The German officer sent one of his men back to the trench, who appeared shortly after carrying a tray with bottles and glasses on it. Officers of both sides

clinked glasses and drunk one another's health. Buffalo Bill had presented them with a plum pudding just before. The officers came to an understanding that the unofficial truce

would end at midnight. At dusk we went back to our respective trenches.

The two barrels of beer were drunk, and the German officer was right: if it was possible for a man to have drunk the two barrels himself he would have bursted before he had got drunk. French beer was rotten stuff.

Just before midnight we all made it up not to commence firing before they did. At night there was always plenty of firing by both sides if there were no working parties or patrols out. Mr Richardson, a young officer who had just joined the Battalion and was now a platoon officer in my company wrote a poem during the night about the Briton and the Bosche meeting in no-man's-land on Christmas Day, which he read out to us. A few days later it was published in *The Times* or *Morning Post*, I believe.

During the whole of Boxing Day [the day after Christmas] we never fired a shot, and they the same, each side seemed to be waiting for the other to set the ball a-rolling. One of their men shouted across in English and inquired how we had enjoyed the beer. We shouted back and told him it was very weak but that we were very grateful for it. We were conversing off and on during the whole of the day.

We were relieved that evening at dusk by a battalion of another brigade. We were mighty surprised as we had heard no whisper of any relief during the day. We told the men who relieved us how we had spent the last couple of days with the enemy, and they told us that by what they had been told the whole of the British troops in the line, with one or two exceptions, had mucked in with the enemy. They had only been out of action themselves forty-eight hours after being twenty-eight days in the front-line trenches. They also told us that the French people had heard how we had spent Christmas Day and were saying all manner of nasty things about the British Army."

## Harold Stough Notes

### Bardsey Island Or Ynys Enll (part 2)

#### Early History of the Monastery

**S**t. Cadfan was the first Abbot of Bardsey; and he was succeeded by St. Lleuddad, whose name is perpetuated by Gerddi Lleuddad (Lleuddad's Garden) in Bardsey, Ogof Lleuddad (Lleuddad's Cave) at Aberdaron and Ffynnon Lleuddad (Lleuddad's Well) at Bryn croes.

St. Dyfrig is said to have retired to Bardsey and to have died there about AD 522. In May 1120, however, his relics were transferred to Llandaff, by Bishop Urban, and installed with much ceremony in the Cathedral. Other well-known saints, who are said to have been buried in the island, are Lleuddad, David, Deiniol, Berme and Cawrdaf. We learn that Gruffydd ap Cynan, who died in 1137, bequeathed ten shillings to the Abbey.

In the "Book of Llandaff," compiled about the middle of the 12th century, occurs the Life of Elgar the Hermit. It states that Bardsey was known as "the Rome of Britain," among other reasons "for its sanctity and dignity, because there were buried therein the bodies of 20,000 holy confessors and martyrs." It is said that many of the survivors of the massacre of the Monks of Bangor Iscoed (Bangor-on-Dee) by King Aethelfrith of Bernicia in AD 613 fled to Bardsey. Apart from legends and glimpses such as these, authentic references to the Abbey of early date are very rare.

#### Medieval Abbey

Many of the early Celtic communities lost their primitive ideals with the growth of territorial endowment and the abandonment of the celibate life. Bardsey seems to have been an exception, for Giraldus Cambrensis in his "Itinerary through Wales" of 1188 tells us, "beyond Lleyn, there is a small

island inhabited by very religious monks called Caelibes or Colidei. This island, either from the healthiness of its climate, or rather from some miracle and the merits of the Saints, has this wonderful peculiarity that the oldest people die first, because diseases are uncommon, and scarcely any die except from extreme old age. Its name is Enlli, in the Welsh, and Berdesey, in the Saxon language, and very many bodies of Saints are said to be buried there, amongst them that of Daniel, Bishop of Bangor."

The safety of residents from death's grasp while an elder survived is attributed to St. Lleuddad who was granted the concession by an angel on his deathbed. The tradition was just one of many aspects of Bardsey's great reputation for sanctity: a reputation which could not fail to draw pilgrims from Wales and beyond. The Pope himself declared that three pilgrimages to the island were of equal merit with one to Rome. All roads led to Bardsey but that from the North via Clynnog Fawr was especially known as the "Pilgrims' Way" and all along its course are a number of holy wells. At Pistyll, there is a farm at which every pilgrim could demand shelter along with bread and cheese. In Aberdaron, is a farm called Cwrt which did not pay tithe but, in lieu, provided free lodging for any inhabitant of



Bardsey waiting for favourable weather to cross the Sound. The dangers of the crossing are referred to in several old Welsh poems, which also express the devout wishes of their authors to be buried in Bardsey. The pilgrims embarked at the little cove of Porth Meudwy, beneath the Abbey Court house.

Gilaldus indicated that, during his time, Bardsey was still a Celtic monastery unconnected with any particular order. Among its Abbots were two of the princely family of Owain Gwynedd: Cadwallon, c.1169, and Robert ap Meredydd.



The Abbey was dedicated to the Blessed Virgin Mary. The foundations of her Chapel are still to be seen on the mainland and her well is close by. This dedication is probably to be dated after the establishment of the Augustinian or Austin Canons in the island. The date of this is unknown, but it was clearly after the time of Giraldus. Some time between 1200 and 1240 is generally accepted. The Order had appeared in England soon after 1100 and became very popular.

The Record of Caernarfon contains a document, quoted in full in the *Archaeologia Cambrensis* for 1847, relating to the Abbot and Convent of Bardsey in 1252. It is an agreement between the Abbot on the one hand and the Secular Canons of Aberdaron on the other, settling controversies which had arisen over tithes, fines and the like. Another document, of about a century later, states that the Abbot was summoned to show by what title he claimed certain his privileges. For example, freedom from toll on the sale of cattle and the right to a Wreck by Sea.

One manuscript states that Sir John Salisbury, Knight of Lleweny, founded a religious House of Carmelites in Denbigh and gave it to the Abbey of Bardsey in 1284. From the *Taxatio* of Pope Nicholas IV, in 1291, we learn that the property of the Abbey amounted to £16 2s. 0d., including property on the mainland, 24 cows, 120 sheep, four mills and 35 shillings per annum from "selling rabbits and rabbit skins." In the *Valor Ecclesiasticus*, from the time of Henry VIII, the value of the temporalities was £28 3s. 2½d and of the spiritualities, £30 3s. 0d. The latter included the tithes of Aberdaron, Bryn croes, Tydweiliog and Llangwnadl. The total net value was £46 1s. 4½d.

The last Abbot of Bardsey was John Conway of Bodnithoedd in Meyllteyrn. Even his isolated little monastery did not escape the greedy clutches of King Henry VIII's commissioners. It was worth only £46, but was still dissolved in 1537.

#### **Post Dissolution**

There exists an interesting "survaye" of the Island made in 1547, only ten years after Bardsey Abbey's final demise. It is taken from the accounts of the "Court of Augmentations" - a tribunal set up in 1539 to deal with Monastic

properties. It would appear that the property of the Abbey was held in 1538 by one Thomas Jones of London, at a rental of £6 3s. 0d per annum.

One miscellaneous document apparently records that Sion Wyn ap Hugh, of Bodvel in Llyn, was Standard-Bearer to John, Earl of Warwick - afterwards Duke of Northumberland - at the "Battle of Norwich" in 1549. In return for his services, the Duke gave him Bardsey and the Abbot's demesne house of Cwrt near Aberdaron. The island had apparently been granted by Edward VI to his uncle, Sir Thomas Seymour, and afterwards to the Earl of Warwick. It should perhaps be mentioned that the authority for the above statement is somewhat doubtful.

According to the Rev PB Williams, around 1821, a Court of the Lord of the Manor of Bardsey was still held occasionally at Aberdaron, Bryn croes or Tydweiliog, with a Recorder, Bailiff and Constable. The Marquis of Anglesey was then the Lord of the Manor. A hundred years later it was in the hands of Colonel Vaughan Wynn of Boduan who inherited it from his uncle, the Hon. FG Wynn of Glynllivon, son of the 3rd Lord Newborough.

Today Bardsey is a designated Site of Special Scientific Interest. It is owned by the Bardsey Island Trust who maintain it as a nature reserve and seabird sanctuary. Of the old monastery, only a small ruined 13th century tower remains.

# Separation: The Greatest Sin

**Proverbs 4:2, Romans 16:17-18, 1 Corinthians 1:10, 2 Corinthians 6:14-18, Ephesians 4:14, 1 Timothy 4:6, Titus 1:9, 2 John 1:10.**

**T**HERE are many themes in the Bible. One of these themes is separation. Even the words "elect and ecclesia" (church) express this theme. 2 Corinthians 6:14-18 could not be clearer in our instruction to be not yoked together with unbelievers. Thayer's Lexicon says we are not to have any kind of discussion with idolaters.

Another theme, is that of sound and good doctrine. See Proverbs 4:2, 1 Timothy 1:10, 4:6. The words of 2 John 1:9-10 say: "Whosoever transgresseth and abideth not in the doctrine of Christ, hath not God. He that abideth in the doctrine of Christ, he hath both the Father and the Son. If there come any unto you and bring not this doctrine, receive him not into your house, neither bid him God speed". Strong words aren't they.

Many themes make up the New Age movement. One of these themes is that of bringing together all religions of the world. Doctrinal differences are to be put into the background. The belief that all religions worship the same "god" is not Biblical. Neither is the belief that man can look inwardly and realise that he is divine. This theme goes back to the Garden of Eden. The New Age interpretation of "Be still and know that I am God" (Psalm 46:10), is that the word "I" refers not to God but to us as humans.

The ecumenical movement is taking us back to the idolatry of ancient civilisations. Israel was warned that if she set up idols she would be sinning, be ensnared and finally commit apostasy. Teachers and prophets of the New Age movement believe that the greatest sin is that of separation. In 2 Peter 2:1 there is a dire warning: "But there were false prophets also among the people, even as there shall be false teachers among you, who privily shall bring in damnable heresies, even denying the Lord that bought them, and bring upon themselves swift destruction".

It is fortunate that not all "christian" leaders have fallen for the "fair speeches" that deceive the

hearts of the simple (Romans 16:17-18). The word simple means unsuspecting (Strong's 172). Such people are wise to the plans and methods of Satan who can appear as "apostles of Christ" (2 Corinthians 11: 13-15). The New Age movement use all the nice words to entice the unsuspecting enquirer into their fold. Their hope for the future is also peace and justice.



The cunning craftiness (Ephesians 4:14) of these world leaders and the thousands who blindly follow, is not something that we can put into the too hard basket. If the prophets and Apostles had taken this attitude we would not have a Bible.

One of the duties and expectations of a follower of Christ is to warn of the impending dangers. To do so we have to have an understanding of Satan's methods. Paul in all his writings showed that he had acute insight into the methods of those who hated Christ. Even though Isaiah 29:14 shows the outcome of man's wisdom this does not mean that we can sit back and enjoy a quiet peaceful Christian life.

During recent times there has been written a number of books expressing concern about how the churches have allowed the world to enter the church. This has been done, I assume, to present the Gospel to more people. It is my view that this has not happened. This attempt has resulted in the watering down of essential doctrines. The separation of the church from the world has become blurred. Whilst I am prepared to accept that we can have a difference of opinion on a number of subjects that are not essential to Salvation, it appears that too many have accepted the understanding that we can have dialogue with New Age teachings. During these final days **we must get back to basics.**

All is not lost for there are still some in the churches and outside, who are aware of the

issues raised in this short article. It is true that God has His Watchmen (Jeremiah 6:17) in the most unexpected places. Nevertheless I am saddened by the fact that there are so few who have a desire to try and understand these issues that have crippled the churches in its endeavours to be a witness to the masses. My experience is that more often, individuals outside the church have more understanding about the world's affairs.

The words of Paul in 2 timothy 4:1-4 sums up my feelings. May the words of James 1:27 provide a clear understanding of where we all must stand: "Pure religion and undefiled before God and the Father is this: **To visit the fatherless and widows in their affliction, and to keep himself unspotted from the world.** This is true separation and it is not a Sin.

## Behind the Balfour Declaration (3) Britain's Great War Pledge To Lord Rothschild By Robert John

### The Third Pledge



In 1914, the central office of the Zionist Organization and the seat of its directorate, the Zionist Executive, were in Berlin. It already had adherents in most Eastern Jewish communities, including all the countries at war, though its main strength was in Russia and Austria-Hungary.<sup>[45]</sup> Some important institutions, namely, the Jewish Colonial Trust, the Anglo-Palestine Company and the Jewish National Fund, were incorporated in England. Of the Executive, two members (Otto Warburg <sup>[M]</sup> and Arthur Hantke) were German citizens, three (Yecheiel Tschlenow, Nahum Sokolow and Victor Jacobson) were Russians and one (Shmarya Levin) had recently exchanged his Russian for Austro-Hungarian nationality. The 25 members of the General Council included 12 from Germany and Austria-Hungary, 7 from Russia...Chaim Weizmann and Leopold Kessler) from England, and one each from Belgium, France, Holland and Rumania.<sup>[46]</sup>

Some prominent German Zionists associated themselves with a newly founded organization known as the *Komitee fur den Osten*, whose aims were: "To place at the disposal of the German Government the special knowledge of the found-

ers and their relations with the Jews in Eastern Europe and in America, so as to contribute to the overthrow of Czarist Russia and to secure the national autonomy of the Jews."<sup>[47]</sup>

Influential Zionists outside the Central Powers were disturbed by the activities of the K.f.d.O. and anxious for the Zionist movement not to be compromised. Weizmann's advice was that the central office be moved from Berlin and that the conduct of Zionist affairs during the war should be entrusted to a provisional executive committee for general Zionist affairs in the United States. At a conference in New York on 30 August 1914, this committee was set up under the chairmanship of Louis D. Brandeis, with the British-born Dr. Richard Gottheil and Jacob de Haas, Rabbi Stephen Wise and Felix Frankfurter, among his principal lieutenants. For Shmarya Levin, the representative of the Zionist Executive in the United States, and Dr. Judah Magnes, to whom the alliance of England and France with Russia seemed "unholy," Russian czarism was the enemy against which their force should be pitted.<sup>[48]</sup> But on 1 October 1914 Gottheil, first President of the Zionist Organization of America, wrote from the Department of Semitic Languages, Columbia University, to Brandeis in Boston enclosing a memorandum on what the organization planned to seek from the belligerents, with respect to the Russian Jews:

We have got to be prepared to work under the Government of any one of the Powers ... shall be glad to have any suggestion from you in regard to this memorandum, and shall be glad to know if it meets with your approval. I recognize

that I ought not to have put it out without first consulting you; but the exigencies of the situation demanded immediate action. We ought to be fully prepared to take advantage of any occasion that offers itself.[\[49\]](#)



In a speech on 9 November, four days after Britain's declaration of war on Turkey, Prime Minister Asquith (left) said that the traditional eastern policy had been abandoned and the dismemberment of the Turkish Empire had become a war aim. "It is the Ottoman Government," he

declared, "and not we who have rung the death knell of Ottoman dominion not only in Europe but in Asia." [\[50\]](#) The statement followed a discussion of the subject at a Cabinet meeting earlier that day, at which we know, from Herbert Samuel's memoirs, that Lloyd George, who had been retained as legal counsel by the Zionists some years before, [\[51\]](#) "referred to the ultimate destiny of Palestine." In a talk with Samuel after the meeting, Lloyd George assured him that "he was very keen to see a Jewish state established in Palestine."

On the same day, Samuel developed the Zionist position more fully in a conversation with the Foreign Secretary, Sir Edward Grey. He spoke of Zionist aspirations for the establishment in Palestine of a Jewish state, and of the importance of its geographical position to the British Empire. Such a state, he said, "could not be large enough to defend itself." and it would therefore be essential that it should be by constitution, neutral. Grey asked whether Syria as a whole must necessarily go with Palestine, and Samuel replied that this was not only unnecessary but inadvisable, since it would bring in a large and unassimilable Arab population. "It would," he said be a great advantage if the remainder of Syria were annexed by France, as it would be far better for the state to have a European Power as a neighbor than the Turk. " [\[52\]](#)

In January 1915 Samuel produced a Zionist memorandum on Palestine after discussions with Weizmann and Lloyd George. It contained arguments in favor of combining British annexation of Palestine with British support for Zionist aspirations, and ended with objections to any

other solution.[\[53\]](#) Samuel circulated it to his colleagues in the Cabinet. Lloyd George was already a Zionist "partisan"; Lord Haldane, to whom Weizmann had had access, wrote expressing a friendly interest; [\[54\]](#) though privately expressing Zionist sympathies, the Marquess of Crewe presumably did not express any views in the Cabinet on the memorandum; [\[55\]](#) Zionism had a strong sentimental attraction for Grey[\[56\]](#) but his colleagues, including his cousin Edwin Montagu, did not give him much encouragement. Prime Minister Asquith wrote: "I confess that I am not attracted by the proposed addition to our responsibilities, but it is a curious illustration of Dissy's favorite maxim that race is everything to find this almost lyrical outburst proceeding from the well-ordered and methodical brain of H.S." [\[57\]](#)

After further conversations with Lloyd George and Grey,[\[58\]](#) Samuel circulated a revised text to the Cabinet in the middle of March 1915.

It is not known if the memorandum was formally considered by the Cabinet, but Asquith wrote in his diary on 13 March 1915 of Samuel's "dithyrambic memorandum" of which Lloyd George was "the only other partisan. " [\[59\]](#) Certainly, at this time, Zionist claims and aspirations were secondary to British policy towards Russia and the Arabs.

Britain, France and Germany attached considerable importance to the attitudes of Jewry towards them because money and credit were needed for the war. The international banking houses of Lazard Frères, Eugene Mayer, J. & W. Seligman, Speyer Brothers and M.M. Warburg, were all conducting major operations in the United States, as were the Rothschilds through the New York banking house of Kuhn, Loeb & Co.[\[N\]](#) Apart from their goodwill. the votes of America's Jewish community of 3,000,000 were important to the issue of that country's intervention or non-intervention in the war, and the provision of military supplies. The great majority represented the one-third of the Jews of Eastern Europe. including Russia, who had left their homelands and come to America between 1880 and 1914. Many detested Czarist Russia and wished to see it destroyed. Of these Jews, not more than 12,000 were enrolled members of the Zionist Organization.[\[60\]](#)

The goodwill of Jewry, and especially America's Jews, was assessed by both sides in the war as

being very important. The once-poor Eastern European Jews had achieved a dominant position in New York's garment industry, and had become a significant political force. In 1914 they sent a Russian-born socialist to the Congress of the United States. They produced dozens of Yiddish periodicals; they patronized numerous Yiddish theatres and music halls; their sons and daughters were filling the metropolitan colleges and universities. [\[61\]](#)



From the beginning of the war, the German Ambassador in Washington, Count Bernstorff, (left) was provided, by the *Komitee fuer den Osten*, with an adviser on Jewish Affairs (Isaac Straus); and when the head of the Zionist Agency in Constantinople appealed, in

the winter of 1914, to the German Embassy to do what it could to relieve the pressure on the Jews in Palestine, it was reinforced by a similar appeal to Berlin from Bernstorff. [\[62\]](#) In November 1914, therefore, the German Embassy in Constantinople received instructions to recommend that the Turks sanction the re-opening of the Anglo-Palestine Company's Bank -- a key Zionist institution. In December the Embassy made representations which prevented a projected mass deportation of Jews of Russian nationality. [\[63\]](#) In February 1915 German influence helped to save a number of Jews in Palestine from imprisonment or expulsion, and "a dozen or twenty times" the Germans intervened with the Turks at the request of the Zionist office in Turkey, "thus saving and protecting the *Yishuv*." [\[65\]](#) The German representations reinforced those of the American Ambassador in Turkey (Henry Morgenthau). [\[64\]](#) [\[66\]](#) Moreover, both the German consulates in Palestine and the head of the German military mission there frequently exerted their influence on behalf of the Jews. [\[67\]](#)

German respect for Jewish goodwill enabled the Constantinople Zionist Agency from December 1914 to use the German diplomatic courier service and telegraphic code for communicating with Berlin and Palestine. [\[68\]](#) On 5 June 1915 Victor Jacobson was received at the German Foreign Office by the Under-Secretary of State

(von Zimmerman) and regular contact commenced between the Berlin Zionist Executive (Warburg, Hantke and Jacobson) and the German Foreign Office. [\[69\]](#)

Zionist propagandists in Germany elaborated and publicized the idea that Turkey could become a German satellite and its Empire in Asia made wide open to German enterprise; support for "a revival of Jewish life in Palestine" would form a bastion of German influence in that part of the world. [\[70\]](#) This was followed by solicitation of the German Foreign Office to notify the German consuls in Palestine of the German Government's friendly interest in Zionism. Such a course was favored by von Neurath [\[71\]](#) when asked by Berlin for his views in October, and in November of 1915, the text for such a document was agreed upon and circulated after the approval of the German Chancellor (Bethmann-Hollweg). It was cautiously and vaguely worded so as not to upset Turkish susceptibilities, stating to the Palestine consuls that the German Government looked favorably on "Jewish activities designed to promote the economic and cultural progress of the Jews in Turkey, and also on the immigration and settlement of Jews from other countries." [\[71\]](#)

The Zionists felt that an important advance toward a firm German commitment to their aims had been made, but when the Berlin Zionist Executive pressed for a public assurance of sympathy and support, the Government told them to wait until the end of the war, when a victorious Germany would demonstrate its goodwill. [\[72\]](#)

When Zionist leaders in Germany met Jemal Pasha, by arrangement with the Foreign Office, during his visit to Berlin in the summer of 1917, they were told that the existing Jewish population would be treated fairly but that no further Jewish immigrants would be allowed. Jews could settle anywhere else but not in Palestine. The Turkish Government, Jemal Pasha declared, wanted no new nationality problems, nor was it prepared to antagonize the Palestinian Arabs, "who formed the majority of the population and were to a man opposed to Zionism." [\[73\]](#)

A few weeks after the interview, the Berlin Zionists' pressure was further weakened by the uncovering by Turkish Intelligence of a Zionist spy ring working for General Allenby's Intelli-

gence section under an Aaron Aaronsohn. "It is no wonder that the Germans, tempted as they may have been by its advantages, shrank from committing themselves to a pro-Zionist declaration." [74]

It was fortunate for Zionism that the American Jews as a whole showed no enthusiasm for the Allied cause, wrote Stein, political secretary of the Zionist Organization from 1920 to 1929, "If they had all along been reliable friends, there would have been no need to pay them any special attention." [75]



In 1914 the French Government had sponsored a visit to the United States by Professor Sylvain Levy (left) and the Grand Rabbi of France with the object of influencing Jewish opinion in their favor, but without success. A year later,

it tried to reply to disturbing reports from its embassy in Washington about the sympathies of American Jews [76] by sending a Jew of Hungarian origin (Professor Victor Basch) to the United States in November 1915. [77]

Ostensibly he represented the Ministry of Public Instruction, but his real mission was to influence American Jews through contact with their leaders. [78] Though armed with a message to American Jewry from Prime Minister Briand, he encountered an insuperable obstacle -- the Russian alliance. "For Russia there is universal hatred and distrust ... We are reproached with one thing only, the persecution of the Russian Jews, which we tolerate -- a toleration which makes us accomplices ... It is certain that any measures in favor of Jewish emancipation would be equivalent to a great battle lost by Germany." [79] Basch had to report to French President Poincare the failure of his mission. [80]

At the same time that Basch had been dispatched to the United States, the French Government approved the setting up of a "Comité de propagande Français auprès des Juifs neutres," and Jacques Bigart, the Secretary of the Alliance Israelite, accepted a secretaryship of the Comité. Bigart suggested to Lucien Wolf, of the Jewish Conjoint Foreign Committee in London, that a

similar committee be set up there. Wolf consulted the Foreign Office and was invited by Lord Robert Cecil to provide a full statement of his views. [81]

In December 1915 Wolf submitted a memorandum in which he analyzed the characteristics of the Jewish population of the United States and reached the conclusion that "the situation, though unsatisfactory, is far from unpromising." Though disclaiming Zionism, he wrote that "In America, the Zionist organizations have lately captured Jewish opinion." If a statement of sympathy with their aspirations were made, "I am confident they would sweep the whole of American Jewry into enthusiastic allegiance to their cause." [82]

Early in 1916 a further memorandum was submitted to the British Foreign Office as a formal communication from the Jewish Conjoint Foreign Committee. This stated that "the London (Conjoint) and Paris Committees formed to influence Jewish opinion in neutral countries in a sense favourable to the Allies" had agreed to make representations to their respective Governments. First, the Russian Government should be urged to ease the position of their Jews by immediate concessions for national-cultural autonomy secondly, "in view of the great organized strength of the Zionists in the United States," (in fact out of the three million Jews in the U.S. less than 12,000 had enrolled as Zionists in 1913), [83] the Allied Powers should give assurances to the Jews of facilities in Palestine for immigration and colonization, liberal local self-government for Jewish colonists, the establishment of a Jewish university, and for the recognition of Hebrew as one of the vernaculars of the land -- in the event of their victory. [84]

On 9 March 1916 the Zionists were informed by the Foreign Office that "your suggested formula is receiving (Sir Edward Grey's) careful and sympathetic attention, but it is necessary for H.M.G. to consult their Allies on the subject." [85] A confidential memorandum was accordingly addressed to the Russian Minister of Foreign Affairs in Petrograd, to ascertain his views, though its paternity, seeing that Asquith was still Prime Minister, "remains to be discovered." [86] No direct reply was received, but in a note addressed to the British and French ambassadors four days later, Sazonov obliquely assented, subject to guarantees for the Orthodox Church and its establishments, to raise no objec-

tion to the settlement of Jewish colonists in Palestine.[\[87\]](#)

Nothing came of these proposals. On 4 July the Foreign Office informed the Conjoint Committee that an official announcement of support was inopportune.[\[88\]](#) They must be considered alongside the Sykes-Picot Agreement being negotiated at this time, and the virtual completion of the Hussein-McMahon Correspondence by 10 March 1916, with the hope that an Arab revolt and other measures would bring victory near.

But 1916 was a disastrous year for the Allies. "In the story of the war" wrote Lloyd George, the end of 1916 found the fortunes of the Allies at their lowest ebb. In the offensives on the western front we had lost three men for every two of the Germans we had put out of action. Over 300,000 British troops were being immobilized for lack of initiative or equipment or both by the Turks in Egypt and Mesopotamia, and for the same reason nearly 400,000 Allied soldiers were for all purposes interned in the malarial plains around Salonika.[\[89\]](#)

The voluntary system of enlistment was abolished, and a mass conscript army of continental pattern was adopted, something which had never before occurred in British history.[\[9\]](#) [\[90\]](#) German submarine activity in the Atlantic was formidable; nearly 11/2 million tons of merchant shipping had been sunk in 1916 alone. As for paying for the war, the Allies at first had used the huge American debts in Europe to pay for war supplies, but by 1916 the resources of J.P. Morgan and Company, the Allies' financial and

purchasing agents in the United States, were said to be nearly exhausted by increased Allied demands for American credit.[\[91\]](#) There was rebellion in Ireland. Lord Robert Cecil stated to the British Cabinet: "France is within measurable distance of exhaustion. The political outlook of Italy is menacing. Her finance is tottering. In Russia, there is great discouragement. She has long been on the verge of revolution. Even her man-power seems coming near its limits." [\[94\]](#) Secretary of State Kitchener was gone -- drowned when the cruiser *Hampshire* sank on 5 June 1916 off the Orkneys when he was on his way to Archangel and Petrograd to nip the revolution in the bud. He had a better knowledge of the Middle East than anyone else in the Cabinet. The circumstances suggest espionage and treachery. Walter Page, the U.S. Ambassador in London, entered in his diary: "There was a hope and feeling that he (Lord Kitchener) might not come back... as I make out."

There was a stalemate on all fronts. In Britain, France and Germany, hardly a family numbered all its sons among the living. But the British public -- and the French, and the German -- were not allowed to know the numbers of the dead and wounded. By restricting war correspondents, the American people were not allowed to know the truth either.

The figures that are known are a recital of horrors.[\[R\]](#)

In these circumstances, a European tradition of negotiated peace in scores of wars, might have led to peace at the end of 1916 or early 1917.

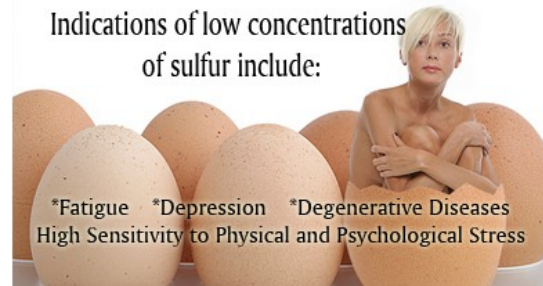

It was LEGAL TO PAY TAXES WITH HEMP in America from 1631 until the early 1800s; LA Times, Aug. 12, 1981.

REFUSING TO GROW HEMP in America during the 17th and 18th Centuries WAS AGAINST THE LAW! You could be jailed

in Virginia for refusing to grow hemp from 1763 to 1769; Hemp in Colonial Virginia, G. M. Herdon.

George Washington, Thomas Jefferson and other founding fathers GREW HEMP; Washington and Jefferson Diaries. Jefferson smuggled hemp seeds from China to France then to America.

Benjamin Franklin owned one of the first paper mills in America and it processed hemp. Also, the War of 1812 was fought over hemp. Napoleon wanted to cut off Moscow's export to England; Emperor Wears No Clothes, Jack Herer.

For thousands of years, 90% of all ships' sails and rope were made from hemp. The word 'canvas' is Dutch for cannabis; Webster's New World Dictionary.

80% of all textiles, fabrics, clothes, linen, drapes, bed sheets, etc. were made from hemp until the 1820's with the introduction of the cotton gin.

The first Bibles, maps, charts, Betsy Ross's flag, the first drafts of the Declaration of Independence and the Constitution were made from hemp; U.S. Government Archives.

The first crop grown in many states was hemp. 1850 was a peak year for Kentucky producing 40,000 tons. Hemp was the largest cash crop until the 20th Century; State Archives.

Oldest known records of hemp farming go back 5000 years in China, although hemp industrialization probably goes back to ancient Egypt.

Rembrants, Gainsboroughs, Van Goghs as well as most early canvas paintings were principally painted on hemp linen.

In 1916, the U.S. Government predicted that by the 1940's all paper would come from hemp and that no more trees need to be cut down. Government studies report that 1 acre of hemp equals 4.1 acres of trees. Plans were in the works to implement such programs; Department of Agriculture

Quality paints and varnishes were made from hemp seed oil until 1937. 58,000 tons of hemp seeds were used in America for paint products in 1935; Sherman Williams Paint Co. testimony before Congress against the 1937 Marijuana Tax Act.

Henry Ford's first Model-T was built to run on hemp gasoline and the CAR ITSELF WAS CONTRUCTED FROM HEMP! On his large estate, Ford was photographed among his hemp fields. The car, 'grown from the soil,' had hemp plastic panels whose impact strength was 10 times stronger than steel; Popular Mechanics, 1941.

Hemp called 'Billion Dollar Crop.' It was the first time a cash crop had a business potential to exceed a billion dollars; Popular Mechanics, Feb., 1938.

Mechanical Engineering Magazine (Feb. 1938) published an article entitled 'The Most Profitable and Desirable Crop that Can be Grown.' It stated that if hemp was cultivated using 20th Century technology, it would be the single largest agricultural crop in the U.S. and the rest of the world.

The following information comes directly from the United States Department of Agriculture's 1942 14-minute film encouraging and instructing 'patriotic American farmers' to grow 350,000 acres of hemp each year for the war effort:



*'...(When) Grecian temples were new, hemp was already old in the service of mankind. For thousands of years, even then, this plant had been grown for cordage and cloth in China and elsewhere in the East. For centuries prior to about 1850, all the ships that sailed the western seas were rigged with hempen rope and sails. For the sailor, no less than the hangman, hemp was indispensable...*

*...Now with Philippine and East Indian sources of hemp in the hands of the Japanese...American hemp must meet the needs of our Army and Navy as well as of our industries...*

*...the Navy's rapidly dwindling reserves. When that is gone, American hemp will go on duty*

*again; hemp for mooring ships; hemp for tow lines; hemp for tackle and gear; hemp for countless naval uses both on ship and shore. Just as in the days when Old Ironsides sailed the seas victorious with her hempen shrouds and hempen sails. Hemp for victory!*

Certified proof from the Library of Congress; found by the research of Jack Herer, refuting claims of other government agencies that the 1942 USDA film 'Hemp for Victory' did not exist.

Hemp cultivation and production do not harm the environment. The USDA Bulletin #404 concluded that hemp produces 4 times as much pulp with at least 4 to 7 times less pollution. From Popular Mechanics, Feb. 1938:

*'It has a short growing season...It can be grown in any state...The long roots penetrate and break the soil to leave it in perfect condition for the next year's crop. The dense shock of leaves, 8 to 12 feet above the ground, chokes out weeds. ...hemp, this new crop can add immeasurably to American agriculture and industry.'*

In the 1930s, innovations in farm machinery would have caused an industrial revolution when applied to hemp. This single resource could have created millions of new jobs generating thousands of quality products. Hemp, if not made illegal, would have brought America out of the Great Depression.

William Randolph Hearst (Citizen Kane) and the Hearst Paper Manufacturing Division of Kimberly Clark owned vast acreage of timberlands. The Hearst Company supplied most paper products. Patty Hearst's grandfather, a destroyer of nature for his own personal profit, stood to lose billions because of hemp.

In 1937, Dupont patented the processes to make plastics from oil and coal. Dupont's Annual Report urged stockholders to invest in its new petrochemical division. Synthetics such as plastics, cellophane, celluloid, methanol, nylon, rayon, Dacron, etc., could now be made from oil. Natural hemp industrialization would have ruined over 80% of Dupont's business.

### **The Marijuana Conspiracy**

Andrew Mellon became Hoover's Secretary of the Treasury and Dupont's primary investor. He appointed his future nephew-in-law, Harry J. Anslinger, to head the Federal Bureau of Narcotics and Dangerous Drugs.

Secret meetings were held by these financial tycoons. Hemp was declared dangerous and a threat to their billion dollar enterprises. For their dynasties to remain intact, hemp had to go. These men took an obscure Mexican slang word: 'marihuana' and pushed it into the consciousness of America.

### **Media Manipulation**



A media blitz of 'yellow journalism' raged in the late 1920s and 1930s. Hearst's newspapers ran stories emphasizing the horrors of marihuana. The menace of marihuana made headlines. Readers learned that it was responsible for everything from car accidents to loose morality.

Films like 'Reefer Madness' (1936), 'Marihuana: Assassin of Youth' (1935) and 'Marihuana: The Devil's Weed' (1936) were propaganda designed by these industrialists to create an enemy. Their purpose was to gain public support so that anti-marihuana laws could be passed.

Examine the following quotes from 'The Burning Question' aka REEFER MADNESS:

- a violent narcotic.
- acts of shocking violence.
- incurable insanity.
- soul-destroying effects.
- under the influence of the drug he killed his entire family with an ax.
- more vicious, more deadly even than these soul-destroying drugs (heroin, cocaine) is the menace of marihuana!

Reefer Madness did not end with the usual 'the end.' The film concluded with these words plastered on the screen: TELL YOUR CHILDREN.

In the 1930's, people were very naive; even to the point of ignorance. The masses were like sheep waiting to be led by the few in power.

They did not challenge authority. If the news was in print or on the radio, they believed it had to be true. They told their children and their children grew up to be the parents of the baby-boomers.

On April 14, 1937, the Prohibitive Marihuana Tax Law or the bill that outlawed hemp was directly brought to the House Ways and Means Committee. This committee is the only one that can introduce a bill to the House floor without it being debated by other committees. The Chairman of the Ways and Means, Robert Doughton, was a Dupont supporter. He insured that the bill would pass Congress.

Dr. James Woodward, a physician and attorney, testified too late on behalf of the American Medical Association. He told the committee that the reason the AMA had not denounced the Marihuana Tax Law sooner was that the Association had just discovered that marihuana was hemp.

Few people, at the time, realized that the deadly menace they had been reading about on Hearst's front pages was in fact passive hemp. The AMA understood cannabis to be a MEDICINE found

in numerous healing products sold over the last hundred years.

In September of 1937, hemp became illegal. The most useful crop known became a drug and our planet has been suffering ever since.

Congress banned hemp because it was said to be the most violence-causing drug known. Anslinger, head of the Drug Commission for 31 years, promoted the idea that marihuana made users act extremely violent. In the 1950s, under the Communist threat of McCarthyism, Anslinger now said the exact opposite. Marijuana will pacify you so much that soldiers would not want to fight.

Today, our planet is in desperate trouble. Earth is suffocating as large tracts of rain forests disappear. Pollution, poisons and chemicals are killing people. We have consumed 80% of our oil and gas reserves. We need a renewable resource. Hemp could be the solution to soaring gas prices.

### War on White English People

Sir,\_\_\_ I think your readers will be interested in this item I came across in the Express, dated Thursday, August, 9, 2007 written by Leo McKinstry:-

**England is in the middle of a profoundly disturbing social experiment. For the first time in a mature democracy, a Government is waging a campaign of aggressive discrimination against its indigenous population.**

In the name of cultural diversity, Labour attacks anything that smacks of Englishness. The mainstream public are treated with contempt, their rights ignored, their history trashed. In their own land, the English are being turned into second-class citizens.

This trend was highlighted this week by the case of Abigail Howarth, a bright teenager who applied for a training position with the Environment Agency in East Anglia but was turned down because she was too white and English. The post, which carries a £13,000 grant, was open only to ethnic minorities, including the Scots, Welsh and Irish.

Such social engineering was justified by the Agency on the grounds that minorities were under-represented in its workforce, the parrot cry used by bureaucrats throughout the public sector to justify bias against the English.

Almost every interaction with any public service now leads to a detailed analysis of one's ethnic status

Though Abigail's case rightly caused outrage, it was not unique. This kind of reverse discrimination is now rife across the state machine, underwritten by the very English taxpayers who are the targets of institutional prejudice.

Although it is technically illegal to restrict jobs to certain ethnic groups, the racially fixated commissars have found a way round that problem by developing training schemes open only to minorities. Under the 1976 Race Relations Act it is permissible to use racial considerations in recruitment to trainee positions such as the one to which Abigail applied.

Such practices are dressed up as "positive action" to widen diversity and, in the words of one Labour council, "to overcome past discrimination". So H M Revenue and Customs offers work experience jobs, worth up to £15,900 a year pro-rata, to ethnic minority graduates, while the Museums Association has two-year ethnic minority apprenticeships.

Similarly, Birmingham City Council gives £16,000 a year to "black and minority ethnic individuals" in its "Positive Action Traineeship Scheme", and a £10,000 allowance to the clerical trainees from the Bangladeshi and Pakistani communities".

Discriminatory training schemes can also be found in ITV, the civil service and the NHS, which boasts "a management development

programme specifically designed and tailored to the needs of black and minority ethnic midwives”.



It was revealed last year that Avon and Somerset Constabulary rejected 186 applications from white men on the grounds that they were already “over-represented” in the force. In the same way, London Mayor Ken Livingstone last month

refused to endorse a series of nominations for the London Fire Authority because they were dominated by whites.

And whole towns are beginning to suffer state disapproval. Eighty administrative jobs in the Prison Service have recently been transferred from Corby in Northamptonshire to Leicester because, as the Home Office admitted, Corby’s population is predominantly “white British”, a terrible sin in our multicultural society.

It is a bitter irony that the Labour Government, which works itself into such a synthetic rage over racial prejudice, should practise overt discrimination on an epic scale. The remorseless focus on supporting minorities has led to a perverted ideology of anti-white racism.

Almost every interaction with any public service now leads to a detailed analysis of one’s ethnic status. A vast race equality industry has been built up, filled with overpaid paper shufflers, consultants and advisers with little to do except invent new grievances.

There is an air of the Maoist permanent revolution about their activities. Since immigration now runs at probably one million people a year, the make-up of society is changing dramatically. So, in this climate of endless demographic upheaval, the race relations brigade will always be able to invent more work for itself.

Yet anti-English discrimination undermines the central plank of the propaganda for mass immigration. We are constantly told we need vast influxes of foreigners to boost our economy and fill vacancies but unemployment levels in immigrant communities are so high and skills so lacking that we need to reserve parts of our economy for them.

So if we have to spend a fortune on training schemes, why are we inviting hundreds of thousands of arrivals from the Third World and Eastern Europe here every year?

Economics have little to do with the issue. The Left in Britain have seized on mass immigration and multiculturalism as a battering ram to destroy the society they despise. They once sought to change our country through economic revolution. That failed with the Winter of Discontent and the downfall of communism. But demographic change through migration has proved far more damaging.

George Orwell once wrote: “England is perhaps the only great country whose intellectuals are ashamed of their own nationality. In Left-wing circles it is always felt that there is something slightly disgraceful in being an Englishman and that it is a duty to snigger at every English institution.”

That is now precisely the mentality that predominates within the machinery of the British state. And our country is dying as a result.

The castle, which should be coloured blue, is shown above and detached from the red earth, representing the castle in the sky - Heaven - God's Kingdom; the place that can **never** be taken or reached by human force, or technology, **only** by **learning** The Way of "The Force" (of God/good) and how to use it, through finding and **living** The Way/The Covenant, as was demonstrated by Jesus ("I am The Way - **THE** Example of The Way/The Covenant in action, **ONLY** by following my example and my **TRUE** teaching, thereby becoming just like me, and, when you **are** just like me, **then** you can go **back** to heaven" - and **not** before) (*please see my "Starwars - Fact not Fiction" Booklet*).

There is even an organization, the Natural Philosophy Alliance (NPA), which holds regional and national meetings devoted to critiquing modern physics, especially Einsteinian relativity. This community of dissidents and publications has been completely ignored by a self-satisfied Physics Establishment, which preserves its power and prestige, in part by mystifying veritable "scientific saints," such as Einstein and Stephen Hawking."

Einstein himself, that great egomaniac, even admitted: "No amount of experimentation can ever prove me right. A single experiment can prove me wrong."

This of course is a classic study in 'Negative Proof Fallacy'. Evidently, St. Albert has never read the Sherlock Holmes stories of Arthur Conan Doyle. The legendary sleuth warns:

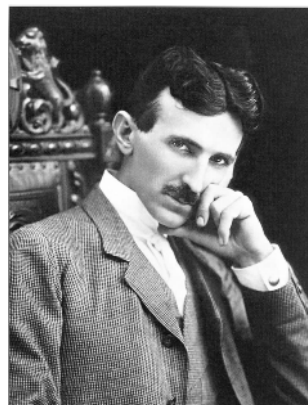
"Never theorize before you have data. Invariably, you end up twisting facts to suit theories, instead of theories to suit facts."

Einstein put the conclusion first, followed it with elegant mathematics to "prove" the premise, and then challenged his peers to disprove a negative. That's a tall order for anyone to fill.

But if there was one man could dethrone such a cleverly crafted illusion, it was the great, and I mean great, Nikola Tesla. When once asked by a sycophantic reporter how it felt to be the smartest man on Earth, Einstein replied, "I wouldn't know. Ask Nikola Tesla".

Tesla's genius can only be described as the stuff of "freak of nature". There is simply no exaggerating the depth of his scientific and creative prowess. He was the greatest electrical engineer of all time and perhaps the greatest inventor as well. Tesla is most well-known for his invention of the AC power distribution system that we still use today

A 1931 Time Magazine cover story (above left) revealed Tesla's disdain for Relativity. An excerpt:



"Nikola Tesla, the man with seven hundred basic patents to his credit, who startled the world on a number of occasions in the past by achieving what others had regarded as impossible, including the large-scale generation and distribution of

alternating current, yesterday treated the combined metropolitan press to a personally conducted tour of the labyrinthine laboratory of his fertile mind.

Just a few of his inventions include the electric motor, radio and wireless communication, electronic logic (the AND gate), the discovery of X-rays, charged particle beams, the rotating magnetic field, fluorescent lighting, and the vertical take-off and landing concept."

"And what exactly did this under-appreciated genius have to say about Relativity?"

"Since action and reaction are coexistent, it follows that the supposed curvature of space is entirely impossible ...Today's scientists have substituted mathematics for experiments, and they wander off through equation after equation, and eventually build a structure which has no relation to reality. The scientists from Franklin to Morse were clear thinkers and did not produce erroneous theories. The scientists of today think deeply instead of clearly. One must be sane to think clearly, but one can think deeply and be quite insane."

St. Albert's Mathematical Masturbation proves nothing!

At times, Tesla's criticism of Einstein was even personal in nature, suggesting that Einstein was not merely mistaken, but actually a fraud:

"Einstein is a beggar dressed in purple clothes and made king using dazzling mathematics that obscure truth"... "Relativity is a massive

deception wrapped in a beautiful mathematical cloak."

"The theory of relativity is a mass of error and deceptive ideas violently opposed to the teachings of great men of science of the past and even to common sense." "The theory, wraps all these errors and fallacies and clothes them in magnificent mathematical garb which fascinates, dazzles and makes people blind to the underlying errors. The theory is like a beggar clothed in purple, whom ignorant people take for a king. Its exponents are very brilliant men, but they are metaphysicists rather than scientists. Not a single one of the relativity propositions has been proved."

"Relativity is a beggar wrapped in purple whom ignorant people take for a King."

Tesla's most scathing condemnation of the Marxist charlatan was penned in a 1934 poem entitled 'Olympian Gossip', written to a friend. In the poem, Tesla sarcastically mocks Einstein and calls him a "long haired crank". An excerpt:

While listening on my cosmic phone  
I caught words from the Olympus blown.  
A newcomer was shown around;  
That much I could guess, aided by sound.

"There's Archimedes with his lever  
Still busy on problems as ever.

Says: matter and force are transmutable  
And wrong the laws you thought immutable."

Too bad, Sir Isaac, they dimmed your renown  
And turned your great science upside down.  
Now a long haired crank, Einstein by name,

Puts on your high teaching all the blame.

Says: matter and force are transmutable  
And wrong the laws you thought immutable."  
"I am much too ignorant, my son,  
For grasping schemes so finely spun.

My followers are of stronger mind  
And I am content to stay behind.

Einstein's fraud clearly rankled Tesla; so much so that he set out to dethrone the puffed-up hero of Jewish Marxism. The Time article also revealed that Tesla was committed to debunking Einstein:

"...My conclusions in certain respects differ from his (Einstein's) and to that extent tend to disprove the Einstein Theory. My explanations of natural phenomena are not so involved as his. They are simpler, and when I am ready to make a full announcement it will be seen that I have proved my conclusions."

It came as a surprise to your humble author that the man who was perhaps the greatest scientist in human history publicly maintained, to his dying day, that Einstein and his Relativity were cleverly masked frauds.
