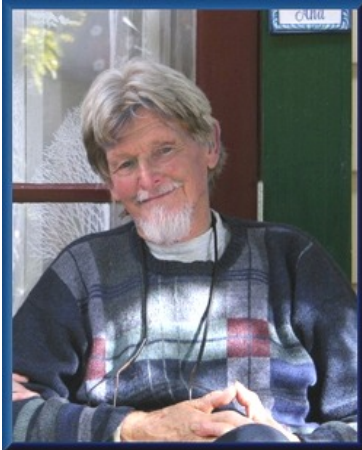

"The Earth Is The Lords"

INTRODUCTION

1 Corinthians 10:26+28 *For the earth is the Lord's, and the fullness thereof.*

THAT God is not a universalist racially, that is, Scripture does not show that God treats all races equally, has been expounded in the author's book,

Without an examination of the context and the individual words in this, it would easily be taken that "the earth" refers to the whole globe, but the world for "earth" in this Psalm is " 'erets". As each nation had its own " 'erets" or individual land, the word "earth" refers to that one particular land of the context. The context of the verses above is described as being "The Lord's". Also, the word "world" here is "tebel" and likewise this is used in a localised sense, that is, it is used of a particular places, such as where crops are grown or where lightning actually strikes. Thus these verses refer to a limited land area of the globe's surface.

"The Exclusiveness of Israel".

In this paper we will look at the question of land, to see if God treats all parts of the surface of the planet equally. This will lead us on to the Millennial Kingdom. It will be "news" to most Church people that, in the Bible, some parts of the globe's surface are, or are to be, considered as God's special property, whilst some are not.

The use of two of these words in conjunction is not uncommon.

"EARTH" – "LAND" – "GROUND," ETC.

We will make a start by considering some verses containing some of the words, such as "earth", "land", "ground", "field", "dust", "world", and "people", which unfortunately have been very well mixed up by translators. Seldom do any of these words mean the whole globe, and the latter two do not normally refer to humanity in general. Let us consider two verses to start with:

Psalm 98:7-9 *Let the sea roar, and the fulness thereof; the world, and they that dwell therein. Let the floods clap their hands: let the hills be joyful together Before the LORD; for he cometh to judge the earth: with righteousness shall he judge the world, and the people with equity.*

Again, the "earth" is 'erets and "the world" is "tebel". In, "The Lord shall judge his people" there is a limitation to "His people" (= laos) that few might expect. Certainly this limitation is not popular church teaching. Likewise the "earth" is that "earth" of His people.

Psalm 24:1-6 *The earth is the LORD'S, and the fullness thereof; the world, and they that dwell therein. For he hath founded it upon the seas, and established it upon the floods.*

Earlier in Psalm 98 we read, "He hath remembered his mercy and his truth toward the house of Israel: all the ends of the earth have seen the salvation of our God. Make a joyful noise unto the LORD, all the earth: make a loud noise, and rejoice, and sing praise". That the people concerned are isolated to, "The House of Israel" is confirmed by the context and also by the use of the Hebrew word –"am" = "people", a word which is used of a tribe or kindred people. The "ends of the earth" is limited also to this context, and the phrase has to do with boundaries of land.

Who shall ascend into the hill of the LORD? or who shall stand in his holy place? He that hath clean hands, and a pure heart; who hath not lifted up his soul unto vanity, nor sworn deceitfully. He shall receive the blessing from the LORD, and righteousness from the God of his salvation. This is the generation of them that seek him that seek thy face, O Jacob. Selah.

Obviously there is prophetic content because the passage is about seeing the salvation of the 'our

God", that is, "The God of Israel", in the future. As quoted, Psalm 24 has a tense problem. The "is" in the first verse is an added word as seen by the italics in the KJV, so it can be ignored. The second verse is future tense, "Who shall ascend into the hill of the LORD? or who shall stand in his holy place". This is amongst the millennium psalms and concerns the time when, "For the kingdom is the Lord's and he is the governor among the nations", that is, He is the governor of those nations of the context. The inclusion of the article here denotes the Israelite nations. At present we are taught to still pray, "Thy kingdom come. Thy will be done in earth, as it is in heaven", so the time of the Lord being "governor" is future. This Psalm concerns a generation of the future. "This is [added word in italics] the generation of them that seek him, that seek thy face, O God of Jacob. Selah.[verse 6]. All the kingdoms on the globe are not spoken of as belonging to God, and the word "generation" in the Greek of the LXX is a word meaning "race-stock-family-tribe".

In His temptation, Jesus confirmed that all the kingdoms of this entire globe did not belong to Him.



Matthew 4:8-10 *Again, the devil taketh him up into an exceeding high mountain, and sheweth him all the kingdoms of the world, and the glory of them; And saith unto him, All these things will I give thee, if thou wilt fall down and worship me. Then*

saith Jesus unto him, Get thee hence, Satan: for it is written, Thou shalt worship the Lord thy God, and him only shalt thou serve.

The nature of the future tense in our first verse quoted in Psalm 24 is confirmed in the verses below:

Revelation 11:15, *"And the seventh angel sounded; and there were great voices in heaven, saying, The kingdoms of this world are become the kingdoms of our Lord, and of his Christ; and he shall reign for ever and ever".*

"The Kingdoms of this world" are those kingdoms of the particular "kosmos" of the context only. To be a "kingdom", there must be

a king, the king's people, the king's territory and the king's laws. The King's laws were made a covenant only with Israel. Descriptions of the king's territory are plentiful, such as:

Gen. 13:15 *"For all the land which thou seest, to thee will I give it, and to thy seed for ever".*

There is no mention of this being swapped for another territory, even if Israel was expelled from that land for disobedience, in terms of the Covenant. Prophecy determines that a remnant of Israel would again return to that land.

Revelation 11:18 *And the nations were angry, and thy wrath is come, and the time of the dead, that they should be judged, and that thou shouldest give reward unto thy servants the prophets, and to the saints, and them that fear thy name, small and great; and shouldest destroy them which destroy the earth.*

Here we find a different word for "earth" [ge] which usually refers to the whole surface of the globe. The "nations" that are described in verse 18 as being angry is the word "ethnos" or races. Look at this question, "Are then all the races rewarded or just, "Thy servants the prophets and the saints?"

Now we are looking at a difference between people and land territory. Some of the territory on the planet is described being 'holy' or separate and as belonging to God. One part is the land promised to his "holy" = "separated" people, known as "The Promised Land". God says He cares in particular for this piece of land.

Deuteronomy 11:11-12 *But the land, whither ye go to possess it, is a land of hills and valleys, and drinketh water of the rain of heaven: A land which the LORD thy God careth for: the eyes of the LORD thy God are always upon it, from the beginning of the year even unto the end of the year.*

Here we find God separating one part of the planet from other parts, and note this is 'always'.

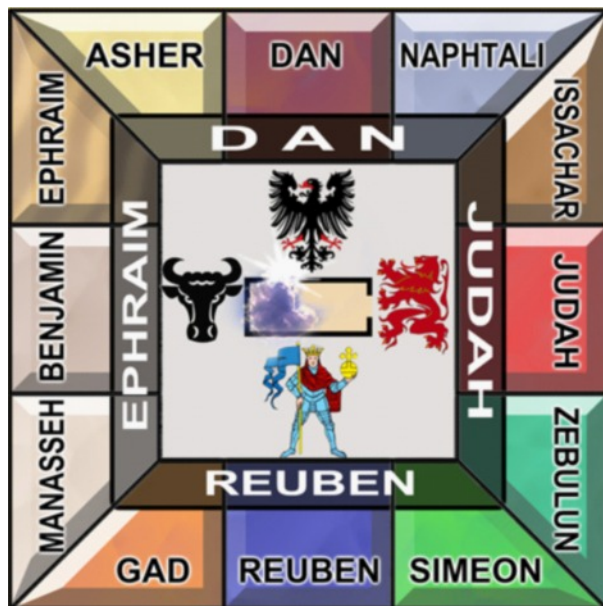
This particular piece of real estate is that promised to Abraham, and confirmed to Isaac and Jacob.

Genesis 17:7-8 *And I will establish my covenant between me and thee and thy seed after thee in*

their generations for an everlasting covenant, to be a God unto thee, and to thy seed after thee. And I will give unto thee, and to thy seed after thee, the land wherein thou art a stranger, all the land of Canaan, for an everlasting possession; and I will be their God.

Here again we find the "everlasting" or "always" confirmed. Therefore this piece of land, known as the Promised Land, is God's forever. It is the inheritance of Israel, even if Israel is expelled so that the Land can enjoy her Sabbaths whilst Israel is in exile. The time of this land becoming "an everlasting possession" will come – Israelites have had some temporary possession, as shown in Old Testament history, but the Land remains Israel's future inheritance.

"MY LAND", "THE LAND OF ISRAEL", AND "MY MOUNTAINS"



These are unique expressions that are all found in Ezekiel 38, a fact that might well upset some people with a traditional British Israel interpretation of this prophecy.

"My land" is a sanctified place, 2 Chron. 7:20, "Then will I pluck them up by the roots out of my land which I have given them; and this house, which I have sanctified for my name". That being plucked up by the roots happened does not change the 'set apart' or sanctified nature of "My Land". "My land", and "Upon My mountains", is where God says He will come to "break the Assyrian".

Isaiah 14:25, "That I will break the Assyrian in my land, and upon my mountains tread him under foot: then shall his yoke depart from off them, and his burden depart from off their shoulders. This is the purpose that is purposed upon the earth."

"MY LAND" is a select place indeed. It is where God will come to plead for His people.

Joel 3:2 "I will also gather all nations, and will bring them down into the valley of Jehoshaphat, and will plead with them there for my people and for my heritage Israel, whom they have scattered among the nations, and parted my land".

What is parted? It is "My land". Here "nations" is not "am", or God's people, but is a different word. It is where God will eliminate the Idumeans (Edomites)-Ezek. 36:5. The word "heritage" is "nachalah" that is used in the sense of land property rather than of people.

"MY MOUNTAINS" is an interesting phrase - one reference is Isaiah 65:9, "And I will bring forth a seed out of Jacob, and out of Judah an inheritor of my mountains: and mine elect shall inherit it, and my servants shall dwell there". When? It is after the slaughter of God's people who, "did evil before mine eyes, and did choose that wherein I delighted not" -V12.

"My mountains" is a particular place where a despondent and afflicted Israel becomes eventually comforted.

Isaiah 49:11 *And I will make all my mountains a way, and my highways shall be exalted. Behold, these shall come from far: and, lo, these from the north and from the west; and these from the land of Sinim.*

Sing, O heavens; and be joyful, O earth; and break forth into singing, O mountains: for the LORD hath comforted his people, and will have mercy upon his afflicted.

Those who declare that God has finished with the Promised Land should note that God's people are to be gathered from where they were scattered, to the original place where they were expelled from originally. They were expelled from the Holy Land and we will see that eventually they will return there. In the interval

Israelites are "placed" outside of the Promised Land because of their iniquity.

A PLACE FOR GOD'S PEOPLE DURING THE DIASPORA

When God dispossessed His people from "My Land", He appointed a place for His people so that "His land" might "enjoy her Sabbaths"- (Levit.26:34+43). The theory that the USA is Zion has arisen because of the failure to separate:

The placement of Israel outside of Palestine for a punishment period, and The re-gathering of Israel after this.

Before we continue, it would be well to establish that there is this difference.

Quoting **Rev. 12:14**, "*And to the woman were given two wings of a great eagle, that she might fly into the wilderness, into her place, where she is nourished for a time, and times, and half a time, from the face of the serpent*". This sums up an area of prophecy which shows that Israel was cast out to, "where she hath a place prepared of God, that they should feed her there a thousand two hundred and threescore days". The point is, the time in the "wilderness" is for a fixed limited stated time. Something else happens after that.



The Diaspora (or scattering of Israel among other nations) comes to an end when Israel is delivered or "gathered" from among the other nations. The Diaspora is not confined to Judah, as some want to claim to support a view that "Zion" equates with the USA.

This gathering principle starts to be expressed early in the piece, such as in:

1 Chron. 16:35, "*And say ye, Save us, O God of our salvation, and gather us together, and deliver us from the heathen, that we may give thanks to thy holy name, and glory in thy praise.*

Blessed be the LORD God of Israel for ever and ever. And all the people said, Amen".

Can we all not agree and say, "Amen" to this? This is not the only passage expressing this with an "Amen" at the end.

The time of the end is when, "*Behold the Lord God will come*", e.g.:

Isaiah 40:9, "*O Zion, that bringest good tidings, get thee up into the high mountain; O Jerusalem, that bringest good tidings, lift up thy voice with strength; lift it up, be not afraid; say unto the cities of Judah, Behold your God! Behold, the Lord GOD will come with strong hand, and his arm shall rule for him: behold, his reward is with him, and his work before him. He shall feed his flock like a shepherd: he shall gather the lambs with his arm, and carry them in his bosom, and shall gently lead those that are with young*".

Can we not see that the timing of the two events is different? Can we not see that different time periods are involved, with one temporary and one ongoing?

Isaiah 5:7, "*For a small moment have I forsaken thee; but with great mercies will I gather thee. In a little wrath I hid my face from thee for a moment; but with everlasting kindness will I have mercy on thee, saith the LORD thy Redeemer*".

Or as Jeremiah puts it:

Jer 35,1-12, "*At the same time, saith the LORD, will I be the God of all the families of Israel, and they shall be my people. Thus saith the LORD, The people which were left of the sword found grace in the wilderness; even Israel, when I went to cause him to rest. The LORD hath appeared of old unto me, saying, Yea, I have loved thee with an everlasting love: therefore with loving kindness have I drawn thee. Again I will build thee, and thou shalt be built, O virgin of Israel: thou shalt again be adorned with thy tabrets, and shalt go forth in the dances of them that make merry. Thou shalt yet plant vines upon the mountains of Samaria: the planters shall plant, and shall eat them as common things. For there shall be a day, that the watchmen upon the mount Ephraim shall cry, Arise ye, and let us go up to Zion unto the LORD our God. For thus saith the LORD; Sing with gladness for Jacob, and shout*

among the chief of the nations: publish ye, praise ye, and say, O LORD, save thy people, the remnant of Israel”.

8 Behold, I will bring them from the north country, and gather them from the coasts of the earth, and with them the blind and the lame, the woman with child and her that travaileth with child together: a great company shall return thither. They shall come with weeping, and with supplications will I lead them: I will cause them to walk by the rivers of waters in a straight way, wherein they shall not stumble: for I am a father to Israel, and Ephraim is my firstborn.

10 Hear the word of the LORD, O ye nations, and declare it in the isles afar off, and say, He that scattered Israel will gather him, and keep him, as a shepherd doth his flock. For the LORD hath redeemed Jacob, and ransomed him from the hand of him that was stronger than he”.

How else can we read, "Behold, I will bring them from the north country, and gather them from the coasts of the earth, and with them the blind and the lame, the woman with child and her that travaileth with child together: a great company shall return thither", and "He that scattered Israel

will gather him, and keep him, as a shepherd doth his flock".

Jer. 32:37, "Behold, I will gather them out of all countries, whither I have driven them in mine anger, and in my fury, and in great wrath; and I will bring them again unto this place".

To what place? So we can see here both the Diaspora and the "gathering" in this verse.

All this has nothing to do with, "Judeo-Christian" or Jewish doctrine as both of these give wrong identification of who is concerned, even if they may have the "this place" right.

These two passages say the diaspora is not for all time, and the verse above, and a host of others, declare Israel is to be "gathered". There are too many verses like Ezekiel 11:17, "Therefore say, Thus saith the Lord GOD; I will even gather you from the people, and assemble you out of the countries where ye have been scattered, and I will give you the land of Israel", that confirm this.

Misconceptions About Josephus, The Judean (3) **Or, How To Tell the Difference Between a Jew and an Israelite!** **By Pastor Eli James**



Judaism Is the Religion of the Anti-Christ

THE oldest deception going is the fable that Judaism is the religion of the Old Testament. In

the Nov.-Dec. issue of **Messianic Perspectives**, a magazine devoted to the fable that Jesus was a Jew, Dr. Gary Hedrick and John Kanter (a graduate of the pro-Zionist Dallas Theological Seminary) say this: "In the Jewish Bible (the Tanakh, known to Christians as the 'Old Testament'), the Hebrew term for 'gospel' is besorah..." -- from page 1, an article entitled "The Gospel of Moses."

This is an example of myth-making, for there is NO SUCH THING AS "The Jewish Bible." The Bible was written by Israelites and Judahites, none of whom were ethnic Jews. Every time someone repeats this fable, the fabric of history is distorted; and the Big Lie that the Old Testament is a "Jewish Book" is, by endless repetition, maintained as a false fact in the minds of billions. This myth-making has been going on for centuries. As long as you assume that Jews and Israelites are the same people, then you will never understand how history has been distorted.

It is quite easy to demonstrate the vast number of non-Covenantal teachings that are being purveyed in the name of the Bible. The Jews claim to speak in the name of Moses while the Judeo-Christians claim to speak in the name of Christ. Both Judaism and Judeo-Christianity are the

fulfilment of the prophecy of the Great Apostasy as spelled out by Paul in many passages. They are also the fulfilment of the STRONG DELUSION prophecy.



II Thess. 2:3: *"Let no man deceive you by any means: for that day [the coming of Christ in judgment] shall not come, except there come a falling away first, and that man of sin be revealed, the son of perdition."*

Of course, that man of sin is the Talmudic rabbi, the deceiver of the whole world, the creator of Zionism and communism, the Great Pretender to the heritage of Moses.

Regarding those deceived:

Isa. 66:4, *"I also will choose their delusions, and will bring their fears upon them; because when I called, none did answer; when I spake, they did not hear: but they did evil before mine eyes, and chose that in which I delighteth not."*

II Thess. 2:11,12: *"And for this cause God shall send them strong delusion, that they should believe a lie: That they might all be damned who believed not the truth, but had pleasure in unrighteousness."*

Here, self-righteousness and unrighteousness can be considered equivalent. The Judeo-Christian world is self-righteous in its own conceits; and Judaism, the "tradition of the elders," passes itself off as the ultimate authority on scriptural interpretation. Thus, the two worlds of Judaism and modern "Christianity" can be seen as humanistic Apostasy, par excellence, having taken Scripture and reshaped it in such a way that it has become the opposite of what the Hebrew and Greek authors wrote and taught. Yahweh's prophets have been reinterpreted to be permissive lamebrains, when the reality is that they were "fire and brimstone" critics of humanism and Judaism.

This historical animosity between Judaism and Christianity never ceased until the advent of the modern communications media, which are monopolistically controlled by Zionist Jews. No Palestinians are ever allowed to present their case against Zionism. No Identity Christians are allowed to present their case against the Great Impersonation. No revisionist historians are allowed to present their case against the Hoaxocaust...and no one breathes a word about the House of Rothschild. You know who the real dictator is by the fact that no one dares to criticize him.

These two predominant themes, Judaism and Judeo-Christianity, present us with a FALSE DICHOTOMY of the Scriptures; and I can assure you that the rabbis of Judaism are masters at conceiving and implementing false dichotomies for our people to ruminate upon, thus wasting our time, lives, fortunes and ultimately our souls on needless debate and endless conflicts, while the rabbis guffaw at our gullibility. Whole denominations have been founded upon these false dichotomies and non-Covenantal doctrines. Here is an example of one of the most basic false dichotomies:

Replacement Theology

(Explanatory Note: A Hegelian Dialectic (named after the German Philosopher, Hegel) is a philosophical argument which consists of two contradictory propositions, Thesis and Antithesis, that are mutually reconciled by a supposedly higher level of Truth, Synthesis. In political or religious terms, the Synthesis is often proposed by the very same people who have staged the two contradictory propositions, though few people are ever aware of this. Now, let us proceed.)

In the form of a Hegelian Dialectic:

Thesis: The Old Testament teaches that the Jews are "God's chosen people."

Antithesis: The New Testament teaches that the Jews were replaced by "Spiritual Israel."

Synthesis: Judeo-Christianity.

I am able to categorically refute all three of these propositions and state that the Synthesis is most definitely a false dichotomy. I can tell you right now that the Thesis is false; the Antithesis is false; and therefore the Synthesis is most definitely a false dichotomy. Only the most grandiose of deceptions could make this Synthesis possible; and that is what we have today:

Grandiose Talmudic Deception posing as Scripture.

Jesus said, "**No one comes to the Father but through me**" (John 14:6); yet we have mainstream Christian churches touting Judaism, Hinduism, Buddhism, Islam and even witchcraft as fashionable. Christianity, having become tolerant of every anti-Christian doctrine that passes before the pulpit, has become delusional. Ecumenism, also known as universalism, has become the latest fad flowing from the pulpits.

Although the rabbis of Judaism are most happy to see Christians engaging in perverted doctrine, there are many Jews and Christian dupes who refer to this false dichotomy as "replacement theology." By this, they are referring to the replacement of physical Israel with spiritual Israel, the Christian "church." We in Christian Identity know that both Jew and Judeo-Christian have it all wrong. Since the Edomite Jews were never part of either Judah or Israel in Old Testament times, the Jews cannot be the same as Israel. And since the "church" is not named in the Covenants of Yahweh, their claim is also false. Both Jew and church are false claimants. Neither deserves any recognition for their claims and neither is a party to the Covenants of Yahweh, which were/are made exclusively to **the Children of Israel**, the physical descendants of the Twelve Tribes. There is absolutely nothing in Scripture that even remotely suggests that the Covenants were transferred from True Israel to some other group. That is scriptural fantasy.

Of course, there is still the moral requirement that we obey Yah's Law in order to qualify for citizenship in the coming Kingdom. At Romans 9:3-7, Paul elaborates on this theme:

For I could wish that myself were accursed from **Christ for my brethren** [not for any other people than the Covenant People, Israel], **my kinsmen according to the flesh**: [Still have any doubt whom he is talking to or about?] **WHO ARE ISRAELITES**; to whom pertaineth the adoption, [Is it not clear that the **ADOPTION** pertains only to Israelites and not to all races or nations?] **AND THE GLORY, AND THE COVENANTS, AND THE GIVING OF THE LAW, and the service of God, and the promises.**"

How can such a statement be misconstrued as Replacement Theology? Only deliberate misinterpretation can twist these words into universalism or into replacement theology. Paul is here affirming the Covenants, the Promises, the Law, the Service, and the Adoption (which means bringing the rebellious ones of Israel back into the fold), **ALL OF WHICH WERE MADE EXCLUSIVELY TO THE CHILDREN OF ISRAEL AND NO ONE ELSE.**



Continuing with Paul:

"Whose are the fathers, and **of whom as concerning the flesh Christ came**, who is over all, God blessed forever, Amen. **NOT AS THOUGH THE WORD OF GOD HATH TAKEN NONE EFFECT** [which is exactly what the Judeo-Christian ministry

teaches when they deny that God's promises to (True) Israel have been transferred to some "church" or to "Spiritual Israel"!!!]. For they are not all Israel, which are of Israel."

What Paul is saying here is that, indeed, the promises were made to Israel as a hereditary nation ("as concerning the flesh"); but it is **NOT ENOUGH** to be an Israelite in the flesh. You also have to **ACCEPT THE NEW COVENANT, WHICH IS NOTHING ELSE THAN ALLOWING THE LAW TO BE WRITTEN UPON OUR HEARTS**, as per Jer. 31: 31-34.

You cannot be a full citizen of the Kingdom unless you have accepted Yahweh's Law within your own heart. Amazingly, those who teach that the Law has been abolished are completely ignorant of the Scriptural connection between the Old and New Testament verses just cited. The Law deniers ignore these passages because the Law is prominent in **BOTH** Covenants. I would say that these passages tend to refute their interpretation of Scripture.

If you reject His Law, it does not matter what your skin colour is. But as a fleshly Israelite, your first duty is to accept His Law and write it upon your heart. **It is patently false that Paul teaches that the Law has been abolished.** Even non-Identity scholars admit that "the law in ordinances that was nailed to the cross" was a reference **ONLY** to the blood rituals of the priesthood, the animal sacrifices for the remission of sins. The Old Testament clearly teaches

that these rituals were only a temporary manifestation permitted by Yahweh for our instruction in the Law, so that we would take it seriously. Now, we are to become a kingdom of priests, such that all of us know the law so well that any formal priesthood will be obsolete. Instead, we will return to the priesthood of the order of Melchizedek, which is a return to patriarchal rule, with the head of each family being its High Priest. Paul explains this in great detail in the first ten Chapters of Hebrews.

The teaching that the Whole Law has been replaced by mere "faith" is APOSTASY. That is not what Paul teaches; but it is what the false shepherds of Churchianity have been teaching, because they confuse the Whole Law with the sacrificial ordinances.

I know what my critics are thinking: "But, Pastor Eli, aren't the other races and nations SAVED by the Gospel? Jesus taught that the Gospel should be preached in all the world!" And, yes it has. But that does not change the fact that Yahweh has a particular people, a peculiar people, a CHOSEN PEOPLE, to whom He has given this assignment of re-establishing His Government here on planet earth. And that's who we, the Anglo-Saxon, Caucasian people are. Now, are we going to fulfil our mission or are we going to try to "save the souls" of other races and nations while we let the Kingdom slip through our fingers?

At Matt. 21:43, when Yahshua told the scribes and Pharisees, "The Kingdom shall be taken from you, and given to a nation bringing forth the fruits thereof," He was not admitting to them they had any legitimate right to it. These words imply no such thing. He was talking to Edomite Jews, not Judah. He knew that they had taken the kingdom by force. He knew that they were false husbandmen, not the legitimate ones. In Matt., Chapter 23, He also told them that they were sitting in Moses' seat. That position was also usurped by them. They had no right to it in the first place; but there they were.

This is confirmed at Matt. 21:18,19, where Yahshua cursed the whole fig tree, not just particular evil figs. From the Garden of Eden on, trees are symbolic of races and nations of people. The evil tree is the seedline of the Jews, who will be judged at the Judgment Day for the evil they have done against God's True Chosen people, Anglo-Saxon Israel.

"Behold, I will send my messenger, and he shall prepare the way before me: and the Lord, whom ye seek, shall suddenly come to his temple, **even the messenger of the Covenant**, whom ye delight in: behold, he shall come, saith Yahweh of hosts." (Mal. 3:1.)



When was the last time you heard a Jewish rabbi or a Judeo-Christian pulpit master preach a sermon on the covenants?

Instead of converting the world by our preaching, we are supposed to convert the world BY OUR NATIONAL (FAMILY)

EXAMPLE. Trying to save individual souls has been a complete failure, because a nation or people cannot be saved one person at a time. There are always too many reprobates who backslide into their old ways, once the Christian missionaries leave. Rather, other nations and races are "converted" by our national example, when we, as a society set apart for this purpose, exemplify Yah's Law in our daily lives. History has proven that every time we try to convert other races to "Christianity," we wind up changing OUR RELIGION INSTEAD!! This is patently obvious today. For nearly one hundred years, America had set the exact example of segregated, Whites Only Christianity; and as a result, we became the most blessed nation and the most powerful nation on earth; and other nations looked to our example of liberty and justice, which very consciously, was based on our religious and racial exclusivism.

The Gospel of the Kingdom has been replaced by the phoney "Gospel of Personal Salvation," when the Bible clearly teaches that the ONLY WAY THIS WORLD IS GOING TO BE SAVED IS THROUGH HIS CHOSEN PEOPLE, ISRAEL...Anglo-Saxon Israel, that is, and not the Jews, who are impostors trying to prevent us from achieving our Glory. WE are His Chosen Family, and when we disabuse ourselves of this world's Jewish materialism, then all will be blessed through us, according to the promises that were made to Abraham, Isaac and Jacob.

"Brethren, my heart's desire and prayer to God is for ISRAEL [NOT the Jews, not some church, nor some "spiritual" Israel] is that they might be saved." (Romans 10:1.)

"Even so at this present time there is a remnant [of flesh and blood Israelites] according to the election of grace. [And this concept of "grace," meaning "favour," is accorded ONLY to the Covenant People, Israel.] And if by grace, then it is no more of works: otherwise grace is no more of grace. But if it be of works, then is it no more grace: otherwise work is no more work." (Romans 11:5-6.)



This confusing language is misconstrued by the universalists to apply to non-Israelites in their so-called "church age." It has no such meaning, for the language applies only to the literal children of Israel as hav-

ing been redeemed by Yahshua at the cross. All that Paul is saying here is that we have been redeemed by Yahweh's good favour. We have not earned it by our works!!!! He is not saying that our works are meaningless or insignificant, only that the sacrificial works of the old priesthood could never be sufficient for our redemption. Indeed, even today, as sinful as we still are, how can our handful of good works count against the mountain of demerits we have built up through ages of sinfulness? To stretch Paul's words out beyond this simple concept of redemption through forgiveness is illegitimate. In the next line he proves it:

"What then? Israel [Who is he speaking of, children?] hath not obtained that which he [we] seeketh for; but the election hath obtained it, and the rest were blinded." (Verse 7.)

Now, who are the elect? The ministers of Judeo-Christianity? I don't think so!!! They, and their followers, are in fact those who are so BLINDED!!!! **The elect are those of Israel who have seen the light of their election!!!!** WE are Yahweh's servants and witnesses; **and the ignorant ministers of Judeo-Christianity are trying to take away from us what Yahweh has elected us for!!!!**

"Ye are my witnesses, saith Yahweh, and my servants whom I have chosen..." (Isa. 43:10.) Now, here is the 6 million dollar question:

Which people has WITNESSED the True Gospel before the world? Certainly not the Jews with their Talmudic abominations!! Only White Christendom has been his historical witnesses. Amen.

For the rest of the world, the choice is very simple: it's either Jacob-Israel (the Adamic/Hebrew/Israelite elect) or the Jews. It's OUR witness versus the Jewish version of Scripture. Have you had enough of the Jewish version yet?

Common Questions Asked About the Name

FOLLOWING are the questions and objections most often rise in regard to the personal Name of the Father and Son. Attempting to answer every objection the human mind may devise could prove an almost endless exercise with those who are just trying to avoid honoring their Creator as He commands us to. But for those with a genuine inquiry, we respond to the following.

Q. "There are no vowels in the Hebrew letters of the sacred Name YHWH, so how can we know how to pronounce it correctly?"

A. If the Hebrew cannot be properly deciphered because of lack of vowels, then our entire Old Testament translation – originally written in a Hebrew script without vowels – is unreliable!

Remarkably, of the 22 letters of the Hebrew alphabet, Yahweh preserved His Name with three of the four letters that in the Hebrew ARE used as vowels as well as consonants: yothe (y), hay (h), and waw (w). (The aleph, a, is also used as a vowel.) This fact can be verified in nearly any Hebrew grammar, including: **A Beginner's Handbook to Biblical Hebrew** (Horowitz), p.

7 under "Vowel Letters"; **The Berlitz Self-Teacher**, p. 73 under "The Vanishing Dots"; **Hebrew Primer and Grammar** (Fagnani and Davidson) p. 10 under "The Quiescents and Mappiq," and **How the Hebrew Language Grew** (Horowitz), p. 28. In addition, about the seventh century, Jewish scribes known as Masoretes preserved the pronunciation of the Hebrew with diacritical marks or vowel points added to Hebrew words (**Eerdman's Bible Dictionary**, p. 699).

Three of these vowel-letters form the Tetragrammaton or Yahweh's Name, why (the *hay* is repeated). But we need not rely solely on modern scholarship for this information. We can take the word of an eyewitness! The first century Jewish general, priest, and historian Flavius Josephus (37-100?) writes about the sacred Name engraved on the headpiece of the high priest: "A mitre also of fine linen encompassed his head, which was tied by a blue riband, about which there was another golden crown, in which was engraved the sacred name [of Yahweh:] it consists of FOUR VOWELS" (**Wars of the Jews**, Book 5, chapter 5, p. 556).

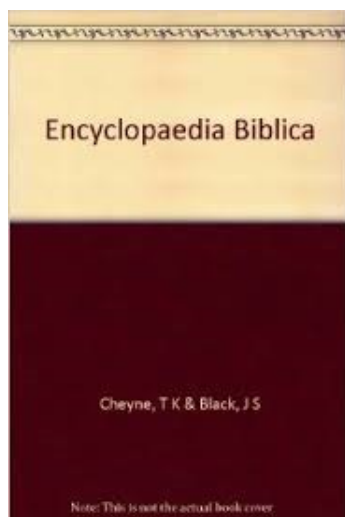
Q. "Hasn't the pronunciation of the Name been lost?"

A. It is not unusual for some who reject the Name Yahweh to argue that because of the aversion of the Jews to using the Name or even

to uttering it, that the correct pronunciation became lost. This is the same ineffectual argument put forth by those who reject the Sabbath, saying that the Sabbath has been lost so no one knows which day it is.

Would Yahweh command that all men call on His revealed, personal Name – an eternal Name that is His very memorial to all generations (Ex. 3:15), a name that is the only Name giving salvation – and then allow it to vanish in the midst of time?

Just as the Jews were given the sacred trust of preserving Yahweh's Word and statues (Rom. 3:1-2), keeping and sustaining the Sabbath in its proper weekly sequence down through history, they also have preserved the proper pronunciation of the Name through the Hebrew language. Jewish history says that the priest spoke the sacred Name 10 times annually on the Day of Atonement down through the centuries. A Name so revered would never be lost on the priesthood. Ask most any Jew in Israel today whether "Yahweh" is the true pronunciation and he or she will acknowledge that it is. Scholarship also reveals the proper pronunciation. One does not even need to go beyond a standard encyclopaedia for the facts.



The **Encyclopaedia Biblica** tells us, "The controversy as to the correct pronunciation of the Tetragrammaton, whether as Yahwe, or Yahawe, Yahwa, or Yahawa... has been gradually brought to an end by the general adoption of the view, first propounded by Ewald, that the true form is Yahwe" (*Divine Names*, p. 3311).

The eminent **Encyclopaedia Judaica** confirms this, "The true pronunciation of the name YHWH [Yahweh] was never lost. Several early Greek writers of the Christian Church testify that the name was pronounced 'Yahweh,'" Vol. 7, p.680.

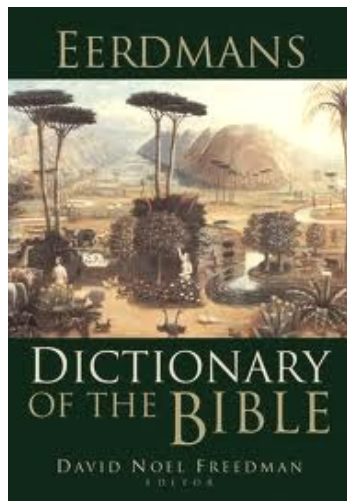
This is validated in the **Encyclopaedia Britannica**, 15th Edition: "Early Christian writers, such as Clement of Alexandria in the 2nd century, had used the form Yahweh, thus this pronunciation of the Tetragrammaton was never really lost. Greek transcriptions also indicated that YHWH should be pronounced Yahweh." Vol. X, p. 786.

Other references substantiate proper pronunciation as "Yahweh." The 15th edition of the **Encyclopaedia Britannica**, volume 12, p. 995, makes the following comment under the heading "Jehovah":

"The pronunciation 'Jehovah' is an error resulting among Christians from combining the consonants Yhwh (Jhvh) with the vowels of 'adonay, 'Lord,' which the Jews in reading the Scriptures substituted for the sacred name, commonly called the tetragrammaton as containing four consonants... The Rabbinic tradition that after the death of Simeon the Just (fl.290 B.C.) It was no longer pronounced even on these occasions, is contradicted by the well-attested statement that in the last generation before the fall of Jerusalem (A.D. 70) it was uttered so low that the sounds were lost in the chant of the priest. After that event the liturgical use of the name ceased, but the tradition was perpetuated in the Rabbinic schools; it continued also to be employed by healers, exorcists and magicians, and is found on many magical papyri. It is asserted by Philo that only priests might pronounce it and by Josephus that those who knew it were forbidden to divulge it. Finally the Samaritans shared the scruples of the Jews, except that they used it in judicial oaths.... The early Christian scholars therefore easily learnt the true pronunciation."

Another reference tells us, "The early Christian scholars therefore easily learnt the true pronunciation. Clement of Alexandria (d. 212) gives Iaove or Iaovai (or in one manuscript Iaov), Origen (d. 253-54) 'Ian, and Epiphanius (d. 404) IaBe (or Iave in one manuscript); Theodoret (d. 457) says that the Samaritans pronounced it IaBe..." (Vol. 12). Samaritan poetry employs the Tetragrammaton and then rhymes it with words having the same sound as Yah-oo-ay (**Journal of Biblical Literature**, 25, p.50 and **Jewish Encyclopaedia**, vol. 9, p. 161).

The following authorities also leave no doubt as to the proper and correct pronunciation of Yahweh's Name:



“The pronunciation Yahweh is indicated by transliteration of the name into Greek in early Christian literature, in the form *iaoue* (Clement of Alexandria) or *iabe* (Theodoret; by this time Gk. **b** had the pronunciation of **v**) ... Strictly speaking, Yahweh is

the only ‘name’ of God. In Genesis wherever the word *sem* (‘name’) is associated with the divine being that name is Yahweh,” **Eerdmans’ Bible Dictionary**, 1979 page 478.

The Latin **v** spoken of here had the same sound as the English **w**, sharing a close affinity with the **u** (**Harper’s Latin Dictionary**). That is why the **w** (“double u”) is made up of two **v**’s. The **v** was used as a vowel, only later becoming a consonant. It came from the **u**, which it follows in the alphabet.

“It is now held that the original name was IaHUe(H), i.e. *Jahve(h)*, or with the English values of the letters, *Yahweh(h)*, and one or other of these forms is now generally used by writers upon the religion of the Hebrews” (**Oxford English Dictionary** under “Jehovah”).

“The saying of God, ‘I am who I am,’ is surely connected with His name that is written in the Hebrew consonantal text as Yhwh, the original pronunciation of which is well attested as Yahweh” (**Catholic Encyclopedia**, 1967, Vol. 5, page 743).

“Such a conclusion, giving ‘Yahweh’ as the pronunciation of the name, is confirmed by the testimony of the Fathers and gentile writers, where the forms IAO, Yaho, Yaou, Yahouai, and Yahoue appear. Especially important is the statement of Theodoret in relation to Ex. lvi., when he says: ‘the Samaritans call it [the tetragrammaton] ‘Yabe,’ the Jews call it ‘Aia’...” **The New Schaff-Herzog Religious Encyclopaedia**, “Yahweh,” page 471.

Writings in **Biblical Archaeology Review**, Professor Anson F. Rainey, professor of Semitic Linguistics at Tel Aviv University, confirms that “Yahweh” is the correct pronunciation: “I mentioned the evidence from Greek papyri found in Egypt. The best of these is *laouee* (London Papyri, xlvi, 446-483). Clement of Alexandria said, “The mystic name which is called the tetragrammaton...is pronounced *laoue*, which means, “Who is, and who shall be.””

“The internal evidence from the Hebrew language is equally strong and confirms the accuracy of the Greek transcriptions. *Yahweh* is from a verbal root developed from the third person pronoun, **huwal *hiya*. In Jewish tradition, it is forbidden to pronounce the Sacred Name and its true pronunciation is supposed to remain secret. The fact is that Jewish tridents (who put the vowel points in the Hebrew text) borrowed the vowels from another word, either *adonai* ‘my lord(s),’ or *elohim* ‘God.’ They avoided the very short a vowel in this borrowing because it might have led the synagogue reader to make a mistake and pronounce the correct first syllable of the Sacred Name, namely *-ya*. The vocalized form one finds in the Hebrew Bible is usually *Yehowah*, from which we get in English the form *Jehovah*. *Yehowa/Jehovah* is nothing but an artificial ghost word; it was never used in antiquity. The synagogue reader saw *Yehowah* in his text and read it *adonai*” (**BAR**, Sept.-Oct. 1994).

Seventh-day Adventist and Hebrew scholar. Raymond F. Cottrell, writes, “The English spelling of Yahweh is now almost universally believed to reflect accurately the ancient, original pronunciation of YHWH. In keeping with the common practice today of pronouncing proper names translated from a foreign language with as nearly the original vocalization as possible, it would be altogether correct and proper for us to use the name Yahweh wherever the word YHWH (“Lord”) occurs in the Old Testament, and also whenever we are speaking of the true God in Old Testament times. This practice is becoming more and more common among Bible scholars and informed Christians,” **Review and Herald**, Feb. 9, 1967.

Q. “Yahweh’ is Hebrew but I speak English. Why shouldn’t I use the English ‘God’?”

A. To this we ask, IS “God” English? Hardly. “God” traces back to the Dutch *god*, to the Germanic *gott* and back to the Teutonic *guth*. Names are transliterated, which means the sounds are carried across unchanged into another language. They are not translated into other languages. “But what about similar forms like John, Juan, and Johann? Or Peter and Pedro?” Some may ask. True, different languages have analogous version of certain names, but that does not change the fact that your given name remains the same no matter which country you travel to. (Notice, too, how closely these name versions RESEMBLE reach other, unlike “Yahweh” and the completely dissonant and unrelated “God.”)

Names simply don’t change from language to language. If a foreign head of state visits America, we don’t attempt to come up with an English version or translation for his or her name. For example, in English news reports Boris Yeltsin is still called “Boris Yeltsin.” Hosni Mubarak remains “Hosni Mubarak.” Trying to come up with an English equivalent of names would be an exercise in futility, because there would be none. Furthermore, doing so would change the person’s name and render the new name useless as a means of identification. The same is true of Yahweh’s Name – only one Name, Yahweh, expresses Him and defines who He is. Yahweh and ONLY Yahweh Himself can change His Name, if He so desires. Yet throughout Scripture we find that “Yahweh” is what He Himself demands to be called. “This is my Name forever,” He told Moses in explaining who He was, “and this is my memorial to all generations,” Exodus 3:15.

Israel also thought that any name commonly used in worship was suitable in the worship of Yahweh. What a grievous error! Because “Baal” was so popular with their pagan neighbours, they began to use it in calling on Yahweh. So Yahweh said in His wrath against Israel, “I will also cause all her mirth to cease, her feast days, her new moons, and her Sabbaths, and all her solemn feasts...And I will visit her upon her days of Baalim, wherein she burned incense to them, and she decked herself with her earrings and her jewels, and she went after her lovers, and forgat me, says Yahweh...And it shall be that day, says Yahweh, that you shall call me Ishi; and shall call me no more Baali. For I will take away the names of Baalim out of her mouth, and they shall

no more be remembered by their name” (Hos. 2:11, 13, 16-17).

Q. “He has many names. Wouldn’t all worship go to Him anyway, no matter what name we use?”



A. This is the same logic the pagans used, which went something like this: “He is Bel-Merodach in Babylon, Baalzebub in Philistia, Zeus (left) in Greece, and we Romans will just call Him Jupiter.” Never mind that each name meant a

different way of worship. The prophet Micah brings this out in 4:5, revealing the false “walk” expressed by each different name.

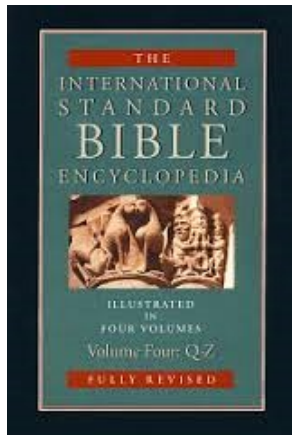
“For all people will walk every one in the name of his god, and we will walk in the name of Yahweh our Elohim for ever and ever.” His name is more than a label. It connotes a well-defined, specifically commanded way of worship that belongs only to Him who bears the Name Yahweh.

Saying Yahweh has many names is a misconception stemming from the practice of classifying Yahweh’s personal, revealed Name with generic titles, as if there were no difference. This false belief that He has “many names” traces to the Jews of the Middle Ages. In attempting to conceal the sacred Name, these Jews elevated generic terms and titles to the rank of His personal Name, then used them as substitutes for the Name.

His titles include: El, Eloah (singular, meaning mighty one) and Elohim (plural); These titles are sometimes combined with the other descriptive words: El Elyon (the most high Mighty One); El Shaddai (the all-powerful Mighty One); El Olam (“Mighty One of eternity”); El Dauth (“Mighty One of knowledge”); El Roi (“Mighty One of seeing”).

The **New Bible Dictionary** maintains, “Strictly speaking, Yahweh is the only ‘name’ of God. In Genesis wherever the word *sem* (‘name’) is associated with the divine being that name is Yahweh...Yahweh, therefore, in contrast with Elohim, is a proper noun, the name of a Person,

though that Person is divine,” p. 478. Another reference says of “Yahweh,”: “This is a personal proper name par excellence of Israel’s God...” and



“It is the personal name of God, as distinguished from such generic or essential names as ‘El, ‘Elohim, Shadday, etc.” (The International Standard Bible Encyclopaedia, pp. 1254, 1266).

Certain attributes are at times connected with His Name: Yahweh-

Yireh (“Yahweh provides”); Yahweh-Nissi (“Yahweh is my banner”); Yahweh-Shalom (“Yahweh Send Peace”); Yahweh-Zidkenu (“Yahweh our Righteousness” – the name by which Yahshua shall be known, Jer. 23:6); Yahweh-Shammah (“Yahweh Is There”); Yahweh-Rapha (“Yahweh Our Healer”); Yahweh-Mekaddishkem (“Yahweh-Elyon (“Yahweh Most High”); Yahweh-Roi (“Yahweh my Shepherd”); Yahweh-Shua (“Yahweh is salvation”).

These adjuncts used with the sacred Name are descriptive designates and must not be confused with His personal Name. Even less, the title “god” cannot possibly contain the meaning that these special titles connote, let alone be used as a personal name for the Majesty of the heavens. “Mr.” is a title, not a name, as is “Sir,” “Dr.,” and “President.” Each defines a person’s standing, position or rank, but does not identify him or her apart from any others within the same title. “There are gods many and lords many,” Paul writes in 1Corinthians 8:5. So which “deity” do we mean when we use “God” and “Lord”? Capitalizing them does not make names of these common terms.

Yahweh inspired the prophet to write, “I am Yahweh: that is my name: and my glory will I not give to another, neither my praise to graven images” (Isa. 42:8). Yahweh names Himself. This is what He expects to be called. In Exodus 23:13 He warns: “And in all things that I have said unto you be circumspect: and make no mention of the name of other gods, neither let it be heard out of your mouth.”

Psalm 83:18 tells us He has only one Name: “That men may know that you, whose name ALONE is Yahweh, are the most high over all the earth.”

In the New Testament, Acts 4:12 reads, “Neither is there salvation in any other: for there is NONE OTHER NAME under heaven given among men, whereby we must be saved.”

Q. “But doesn’t He know who I mean no matter what I call Him?”

A. Suppose your name were Michael. Would you know I meant you if I called out, “Hey, Sam”? Habitually calling you by another name would deeply offend you and cause you to wonder why I stubbornly refused to use your name. Besides, the name Sam signifies someone else entirely. Yahweh also is offended when we refuse to get serious about His Name. He warns in Malachi 2:2, “*If you will not hear, and if you will not lay it to heart, to give glory unto my name, says Yahweh of hosts, I will even send a curse upon you, and I will curse your blessings: yea, I have cursed them already, because you do not lay it to heart.*”

John 4:24 tells us, “Yahweh is Spirit: and they that worship Him MUST worship Him in spirit and in truth.” His Name is part of that necessary truth.

It’s clear and simple. Yahweh tells us what His Name is. He commands us to call Him by that Name. We don’t have the option of calling the Mighty One of the entire universe whatever we wish.

We cannot rename Yahweh. Nowhere in the Bible is man given the authority to change His Creator’s Name. Never does the worshiper tell the one he worships how He will be worshiped! Yahweh tells us...we don’t tell Him. To bestow a name is the prerogative of a superior, as when Adam exercised his dominion over the animals by giving them names, or as when a parent names his or her children. It is always the prerogative of the superior to name the inferior, never vice versa.

Mankind was given dominion or stewardship over the earth (Gen. 1:28), and to show his responsibilities, Adam was allowed by Yahweh to name all the creatures (Gen. 2:19-20). Yahweh has control of the earth, heaven and the seas, and

man has stewardship only over the creation on earth. We have no authority in heavenly things, such as calling our Creator what we wish.

Yahweh says I am “jealous for my holy Name,” Ezekiel 39:25. We must take those words to heart. If we do, He promises, “*And it shall come to pass, that whosoever shall call on the name of Yahweh shall be delivered: for in mount Zion and in Jerusalem shall be deliverance, as Yahweh has said, and in the remnant whom the Yahweh shall call*” (Joel 2:32; see Rom. 10:13).

Knowing “who you mean” makes no difference to Him if you refuse to give him the honour and glory He demands. Even IF He knew who you meant, the point is, He COMMANDS His people to call on His revealed, personal, Covenant Name (Ex. 23:13). His Name represents Him and His truths. No other name, title or designation does that. No other title or substitute name reveals Him as the One who will be whatever His people want or need Him to be. That is the essence and meaning of the Name “Yahweh.”

We cannot say we know who He is and claim to worship Him according to that knowledge if we are using titles that miss the mark completely when it comes to identifying, describing, and defining the One we honour. Through the prophet Isaiah He said, “*Therefore my people shall know my name: therefore they shall know in that day that I am he that does speak: behold it is I*” (Isaiah 52:6).



Writing in a Seventh-day Adventist publication, Associate Editor Don F. Neufeld provides this insight: “Yahweh’ is the name that identifies the God of the Hebrews. Where the Philistines worshiped Dagon, the Egyptians, Amon and the Ammonites, Milcom, the Hebrews worshiped Yahweh... When the voice said, ‘I am Yahweh,’ there was no doubt in any listener’s mind as to the identity of the speaker. He was the god of the Hebrews. So far as it is known, no other peoples called their god by this name” (*The Advent Review and Sabbath Herald*, 1971).

If you would honour another human being’s wishes by using his or her personal name, how much more should you revere your Creator’s

request by calling on Him by His Name? He’s the only One who can give salvation!

Consider: If names don’t really matter, does it matter to you whether Yahweh has YOURS right when it comes to His Book of Life? Consider what Yahshua says: “*He that overcomes, the same shall be clothed in white raiment; and I will not blot out his name out of the book of life, but I will confess his name before my Father, and before his angels... And whosoever was not found written in the book of life was cast into the lake of fire*” (Rev. 3:5, 20:15).

Q. “The sacred Name was not known before Moses, and therefore it was not a salvation Name for those who came before Moses, like Abraham, Isaac, and Jacob. This being the case, why is it necessary for us?”

A. This argument stems from a serious misunderstanding of Exodus 6:3: “*And I appeared unto Abraham, unto Isaac, and unto Jacob, by the name El Shaddai, but by my name Yahweh was I not known to them.*” As the Companion Bible explains, the word “known” means perceived and understood. “The name [Yahweh] was known as the covenant name; but was not known so as to be understood.” In other words, the patriarchs had not seen a dimension of Yahweh that Moses and those after him would see—they would soon understand fully what His Name meant by the acts of deliverance, sustenance, and love for His people that He was about to perform (Ex. 9:16; Ezek. 20:5, Amos 3:2). He would become whatever His people needed of Him, which is the intrinsic meaning of the Name Yahweh.

The following verses reveal the error of this argument and show that Yahweh’s Name was indeed known by the patriarchs and used before Moses:

Eve called on His Name – Genesis 4:1

Abraham called on the Name Yahweh – Genesis 12:8; 14:22; 15:2, 7; 21:33; 24:3;

Abimelech used Yahweh’s Name – Genesis 20:4

Isaac called upon Yahweh’s Name – Genesis 26:25

Yahweh revealed His Name to Jacob – Genesis 28:13

Anciently men “began to call on the Name Yahweh” – Genesis 4:26

Q. “Hanging on the torture stake, our Savior cried out to Yahweh, ‘Eli, Eli, lama sabachthani,’ that is to say, ‘My God, My God, why have you forsaken me?’ (Matt. 27:46). If He could use this title, what’s the problem if I use ‘God,’ too?”

A. By quoting Psalm 22:1 here, Yahshua was fulfilling the prophecy of Psalm 22:22, showing that He was the promised Messiah. It also demonstrates that our Savior spoke Hebrew, or the Aramaic dialect of Hebrew. The Savior was NOT calling His Father “My God” – an appellation from a completely different language – but “My El,” which in Hebrew means “Mighty One” or “Powerful One” (the yod or “i” on the end of El means “my”). It is one of the titles referring to Yahweh, but is not a substitute name. Yahshua also once in prayer called Him by the Hebrew *abba*, meaning father, Mark 14:36. But neither is *abba* a name.

Any time a title becomes so dominant that it is used as a replacement for the sacred Name, that designation expunges the only Name whereby we are saved, regardless as to whether that title has had a previously acceptable association with Him.

Churchianity uses the titles “God” and “Lord” in the same way Israel used “Baal” (see Jer. 23:26-27, where Yahweh says, “their fathers have forgotten my name for Baal”). These titles have become total, exclusive substitutes that are historically associated with pagan images (review the subheading, “Ancient Roots of ‘God’ and ‘Lord,’ p. 27).

Q. “Where is there any record that Yahshua ever spoke or taught His Father’s Name Yahweh, or that the Name is in the New Testament?”

A. In His prayer to Yahweh, Yahshua in John 17:26 specifically said that He had “declared unto them [the world] your name, and will declare it.” If He declared it then He spoke it.

Even though it may be somewhat hidden in our English text, we find ample examples where Yahshua called on His Father’s Name Yahweh and taught it as well. In Matthew 6:9, Yahshua opened His Model Prayer with the affirmation

of the holiness of Yahweh’s Name: “Hallowed be Thy Name.” Yahweh’s Name is the only Name that is called holy in Scripture. Man’s names are not. (Thus, it is unnecessary to change other Biblical names to their Hebrew originals.) Yahshua recognized Yahweh’s Name as sanctified, and even said He would proclaim it: “I will declare Your Name unto my brethren, in the midst of the Assembly will I sing praises unto you,” Hebrew 2:12.

In the many passages where our Savior quoted the Old Testament, He of necessity would use Yahweh’s Name. For instance, Luke 4:4, where He quoted Deuteronomy 8:3: “And Yahshua answered him, saying, It is written, That man shall not live by bread alone, but by every word of Yahweh.”

Many other examples could be shown where Yahweh’s Name appears in the Old Testament text and where Yahshua quotes these same passages word for word. A few of these include: Matthew 4:10 (from Deut. 6:13); Matthew 21:42 (from Psalm 118:23); Mark 7:6 (from Isa. 29:13); Luke 20:37 (from Ex. 3:4-6) and John 6:45 (from Isa. 54:13). In the **Hebrew Gospel of Matthew**, professor George Howard details the Hebrew text of the 14th century Jew, Sem-Tob ben-Isaac ben-Shaprut. Howard describes how the sacred Name occurs

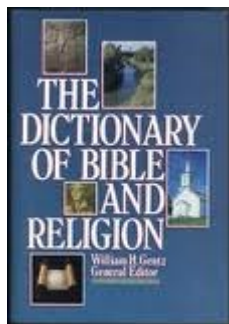
19 times in the work, mostly where Kurios and Theos appear in the Greek, but in three places where no correspondent Greek word appears. Howard observes that the Shem-Tob Matthew cannot be a translation of a Greek text, as “no pious Jew of the Middle Ages would have dignified a Christian text by inserting the Divine Name.”

Howard adds, “The conclusion that seems inescapable is that Shem-Tob found the Divine Name already in his [Hebrew] gospel text, having received it from an earlier generation of Jewish tradents. He permitted the Divine Name to remain in the text perhaps because he was unsure himself about what to do with it,” pp. 230-231.

Q. “If it is so important, why isn’t there evidence of the Name outside of the Hebrew Scriptures?”

A. Yahweh gave His Name to the Hebrew peoples because they were His chosen. Those who would take hold of the promises given first to Abraham are grafted in to the trunk of Israel, as Romans 9 and 11 explain. Naturally we would find His Name most prominent among the Israelites and their Scriptures and records. But there indeed are other places where the Name Yahweh has been found.

As we have shown, the Tetragrammaton was discovered on the Moabite stone in 1868, erected by Moabite King Mesha in 900 B.C.E. (p. 25).



Also found in the 1930’s were a number of pottery fragments on which were written personal letters at the time of the Babylonian conquest of Judah (597-587 B.C.E.). Known as the *Lachish Letters*, one letter is to the commander of a garrison at Lachish, where the

writer sends a greeting in “the name of Yahweh.” The fragments also contain about 20 proper names, most compounded with the name of Yahweh (**The Dictionary of Bible and Religion**, p. 594).

Surprisingly, extra-Biblical evidence for the Name is mounting even on this continent. Indications are that a connection existed between Native Americans and the Semitic peoples of the Middle East.

In **Adair’s History of the American Indians**, Frenchman James Adair in 1775 detailed many similarities in language, organization, and custom that the Indians of the southeast U.S. share with ancient Israelites. Having spent time among them, he noted that the Indians “frequently sing Hallelu-Yah Yo He Wah,” p. 32. He wrote on page 37, “The American Indians are so far from being Atheists, as some godless Europeans have flattered themselves, to excuse their own infidelity, that they have the great sacred name of God, that describes his divine essence, and by which he manifested himself to Moses...” On page 48 Adair continued, “They have another appellative, which with them is the mysterious, essential name of God – the

Tetragrammaton, or great four-lettered name – which they never mention in common speech...” He also noted, “...the American Indians...say YAH at the beginning of their religious dances...” p. 50.

Writing in *The Ancient American* (March-April 1994), David Allen Deal discusses artifacts discovered between 1874 and 1920 in the state of Michigan. The artifacts bear Egyptians motifs and hieroglyphics, Deal observes. Mostly religious in nature, they contain drawings of the Genesis Creation, Garden of Eden, Noah’s flood and New Testament themes. He notes that three letters in a previously unknown cuneiform style are found on nearly every piece. He writes, “I felt the letters had to stand for the name YHW,” which he notes represents the sacred Name Yahweh. In his book, **Discovery of Ancient America**, Deal also writes about paleo-Hebrew Tetragrammaton discovered in New Mexico and Tennessee.

Q. “Yahweh confused all the languages at the Tower of Babel, and because Hebrew was extant at that time, how can we be sure that the original pronunciation of Yahweh’s Name wasn’t changed?”

A. Both Shem and Noah spoke the language of Adam and Eve. We have no evidence that this language was anything other than Hebrew, the language of the oldest Biblical manuscripts. (Shem was the great-grandfather of Eber, from whom we get the name “Hebrew.” He naturally would speak the same language as his great-grandson. Eber was the great-great-great-great-grandfather of Abraham.) Certainly neither of these righteous men had anything to do with building a pagan Tower of Babel. Not having been there and involved in this rebellion, their Hebrew language would not have been affected by the confounding of languages at Babel. We can trace the lineage of the patriarchs and see how their Hebrew language continued from the beginning.

Abraham lived to see his grandchild Jacob (Israel). Abraham was alive in the days of Shem, who was born before the flood. Obviously Abraham would have spoken the same language that his family line used before and after the flood: pure Hebrew.

Q. “Doesn’t Psalm 138:2 say His Word is magnified above His Name?”

A. In the King James this passage reads, “*I will worship toward thy holy temple, and praise thy name for thy loving kindness and for thy truth: for thou hast magnified thy word above all thy name.*”

Other versions render this verse differently: “I bow down toward thy holy temple and give thanks to thy name for thy steadfast love and thy faithfulness; for thou hast exalted above everything thy name and thy Word” – **Revised Standard Version.**

”I will bow down toward your holy temple and will praise your name for your love and your faithfulness, for you have exalted above all things your Name and your Word” – **The New International Bible.**

“I prostrate myself toward thy holy temple; and give thanks to thy name for thy kindness and thy faithfulness; for thou hast magnified thy name over all” – **Smith and Goodspeed.**



“I will bow down toward thy holy temple, and give thanks to Thy name for Thy loving kindness and Thy truth; For Thou hast magnified Thy word according to all Thy name” – **New American Standard.**

None of these translations tells us that His Word is to be exalted over His Name. His Name gives weight to His Word and cannot be separated from it.

Had the translators added the right punctuation, because the Hebrew has none, the verse could just as easily have been rendered: “For You have magnified Your word, above all, Your Name.” This would give the passage the same meaning as is found in the **New American Standard** and **Smith and Goodspeed** versions, where His Name is the foundation for all other truth.

Q. “You spell the Heavenly Father’s Name ‘Yahweh,’ but I have also seen it spelled ‘Yahowah’ or ‘Yahuweh.’ Why is this?”

A. **The Cairo Geneze**, by Paul Kahle, published in London says, “Not before 1100 was an **o** added to the word hwhy and this seems to indicate the pronunciation [Adonay]” (**The Translations of the Bible**, chapter 3, pp. 172-

173, footnote 4). It was a vowel sign for the letter **o** that was put in the middle of the Tetragrammaton. This led to the erroneous “Jehovah.” The **Lexicon for the Books of the Old Testament** says: “The wrong spelling Jehovah occurs since about 1100.” It then offers arguments in favor of Yahweh as “the correct and original pronunciation” (Koehler and Baumgartner, 1951 ed., vol. 1, p. 369, col. 1).

Because early Christians were not Hebrew scholars, they did not understand that the Tetragrammaton was pointed with the vowels for **AdOnAY**. Scholars maintain that the letter **o** or **u** is a vestige of this Rabbinical practice. This technique was popular where the name why formed the beginning of a personal name, for example ucwhy (Yahshua), which was altered to Yehoshua by vowel pointing through the diacritical marks above and below the Hebrew letters (see subheading “How Did ‘Yahshua’ Become ‘Jesus?’” and request the ministudy, **Spelling the Sacred Name: V or W?**)

Q. “Doing or asking in Yahweh’s name merely means ‘by His authority.’ How can you say it means pronouncing a Hebrew Name?”

A. Attempting to sever Yahweh from His very being, nature, personality, and essence through calling on another name is nothing more than a feeble attempt to quiet one’s conscience about the importance of His revealed, personal Name. It is true to do something “in a name” can mean by the authority of that individual. But in the Bible it means so very much more.

What such reasoning cannot get around is the fact that Yahweh’s Name is definitive – it expresses the character and very personality of the Creator and Sustainer who bears it. His Name is nothing less than an extension of His being. It expresses His quintessence. Yahweh’s Name is composed of the very verb of existence – *haYa*. His Name is alive and active. It means He will be whatever His people need of Him. To call on a dead, generic term expecting the same results as calling on His dynamic Name is an insult, once we know that He has a personal, vigorous, life-giving, healing, and Covenant Name that embodies salvation itself to those who call on Him.

Lyrl Clark Van Hyning - An American Patriot

IN THE FERMENT to keep America out of the war, the largest and most active mothers' organization was We the Mothers Mobilize for America, led primarily by Lyrl Clark Van Hyning. This group did not enter the fray until the debate over Lend-Lease, when it sent women to Washington with Dilling's crusade, but it stepped up activity after Pearl Harbour.



Intelligent, versatile, and forceful, Van Hyning was an effective writer and organizer.

One journalist called her "the biggest figure in the war and postwar mothers' movement." Of Scotch-English

ancestry, Van Hyning was raised on a farm in Ohio. Her father, William Clark, a descendant of the Revolutionary War General George Rogers Clark, died when she was five years old. (Proud of her heritage, Van Hyning was an officer in the DAR.) She was a schoolteacher before marrying businessman George H. Van Hyning, and they lived in South America for more than a decade before settling in Chicago in 1933. They had three children: a son, Tom, who served in the Army Air Corps during World War II; a daughter, Parrie Ann, who ran unsuccessfully for the Illinois Senate; and a younger daughter, Georgina, who was active in her mother's antiwar work.

Vain about her appearance, the bespectacled Van Hyning dressed fashionably. A chain-smoker, she was energetic, charismatic, and a forceful speaker. Assuming a dominant role, she looked upon her followers as pawns to augment her power. "My women are not intelligent," she said. "In fact, they are rather stupid. But they are a group of women who will work hard for me and that's what is important. Later, perhaps, we will be able to attract a higher type of woman to the cause." Van Hyning demanded loyalty from her

mothers: "You have no moral right to refuse to take up this burden. It is your duty—more binding than feeding your children or being true to your husbands."⁷

Raised a Methodist, Van Hyning professed to be religious, although she attended no church. She compared herself to Jesus, a Christian martyr ("He was accused, even as I am accused, of holding the Jewish race, creed, or religion up to ridicule") and even expressed a death wish ("All my life I wished that I could have gone with him to Calvary"). She denied Jesus was a Jew and said none of the apostles, except for Judas, were Jews. In her view, Christians were in a fight against Jews, who had caused the Civil War and both world wars. Moreover, Jews repeatedly tried to destroy the United States. They plotted John Wilkes Booth's assassination of President Abraham Lincoln; planned to introduce free love so Christian families would be weakened and communists could take over; and undermined the government.

Fifty-two of FDR's advisers and eighty-six percent of all Washington officials were Jews. Woodrow Wilson was a Sephardic Jew named "Wohlson." Dwight D. Eisenhower was a Swedish Jew. Harry S. Truman, whose middle initial stood for "Solomon," also was a Jew. The New Deal and the "Rosenvelt" administration, however, were the vehicles through which Jews and communists planned to take over. "The whole gang are the offspring of the old gang that threw stones at Jesus Christ, wrapped thorns around his head, that flogged him and finally nailed him to the Cross because he spoke the truth, which upset their plans for world domination."

Nor was the government the only tool of the Jews, whose conspiracies were complex, Van Hyning argued. Sometimes they worked through the Masons. Van Hyning used to consider Freemasonry innocent because her husband, father, and grandfather were Masons. Then she learned that "[e]very password, every

explanation, every symbol, every figure in Masonry is Jewish.” It had been painful to admit that her family had been involved in a Jewish plot, but she observed, “Truth is a relentless master—once one’s hand is put to that plough, no one can quit, though it takes every earthly possession and connection.”

Nevertheless, Van Hyning insisted she did not despise Jews, she only loved Christians. “Is the scientist who seeks to find and isolate a disease germ a hater?” she asked. “Does he hate the germ, or does he love humanity?” Marx had derived his ideas for communism from the Jewish religion; his father had only pretended to convert to Christianity to mislead Gentiles. Communism was a greater threat than fascism, which was at least pro-Christian and eliminated class warfare. Fascism arose as a defence against Jewish-led communism, “the only successful means for the protection of the Gentiles from Jewish dictatorship.” Apparently, it was not an impregnable defense, for Van Hyning thought Hitler became a tool of the Jews, who financed his ascension to power and thus held a whip over him.

Still, Hitler was not a bad man; the fuhrer “probably did the best he could for the German people,” Van Hyning believed. That the United States fought him, she wrote after the war, was regrettable. “By choosing to assist Russia to victory rather than Germany, we chose the sinister powers of communism and atheism and fought to ruin the bulwark of Christianity and Germany’s great white race.” Hitler was not guilty of genocide. The Holocaust was a fabrication that Jews foisted on a gullible American public (there were more Jews after the war than before). Anyway, the fate of European Jews or the effect of Hitler’s policies was not so worrisome as Jewish immigration to the United States. Van Hyning called for the deportation of all refugees so their homes could be given to returning soldiers, and she denounced the Community Chest and United Fund because they aided Jewish refugees.

Blacks, too, were enemies of Van Hyning. During the war *Women’s Voice* reported that African troops were raping “German Christian women” and published a letter from Knowles, expressing opposition to plans for postwar resettlement of Blacks and other minority groups in Northern cities.

Van Hyning wanted women to think for themselves instead of thinking like men, particularly in politics. Women possessed talents, including experience as mothers, that could enable them to govern better than men. Writing about the mismanagement of veterans’ benefits, for instance, Van Hyning concluded, “Only after a mother stepped in was the situation adjusted.”

Before leading *We the Mothers*, Van Hyning belonged to the America First Committee and the German American Bund. Evidently she quit the committee and the Bund because she could not become a leader in either group. Then she devoted her activities to women’s groups, collaborated with Coughlin, Winrod, and Smith, and became well known among leaders of the ultra-right and the mothers’ movement (although she lacked Dilling’s congressional contacts). Van Hyning knew more women in the movement than did any other leader. She enjoyed a long career, publishing *Women’s Voice* for almost two decades after World War II.



Van Hyning wrote two or three long articles in each issue of *Women’s Voice*, which reprinted articles from the *Bulletin*, *The Cross and the Flag*, Conde McGinley’s *Common Sense*, Leon de Aryan’s *The Broom*, and other ultraright, anti-Semitic publications. In addition, the tabloid carried antiwar advertisements purchased by Viereck with money from the German government, and ads for patriotic literature. Even more blatantly anti-Semitic than the *Bulletin*, *Women’s Voice* gave less information about its

editor than Dilling's publications gave about Dilling. Unlike the *Bulletin*, it was printed professionally, but it had numerous errors in spelling, punctuation, and typography. Investigators considered *Women's Voice* one of the more damaging ultra-right publications because it was directed to the wives and mothers of servicemen. (The FBI interviewed more than one hundred members of We the Mothers, including Van Hyning, in its investigation of far-right groups for sedition, yet no indictments were issued.)



Although Van Hyning dominated We the Mothers, she had the assistance of other women and some men. One of her more active associates was Keefe, the organization's secretary. An anti-Semite who was a friend of Dilling (left) and a participant in the National

Legion of Mothers of America, Keefe attended meetings of most of the anti-Semitic groups in Chicago; wrote for their publications; campaigned for isolationist political candidates, opposed conscription, the British and the New Deal; and advocated the recall of American armed forces stationed abroad. In 1942 she founded the Women's League for Political Education, which attempted to stop the invasion of Europe by exerting pressure on Congress and inspired Sumner to introduce a resolution prohibiting the invasion. And in 1945 Keefe testified before the Senate Foreign Relations Committee against ratification of the UN Charter. She urged an immediate, negotiated peace with Japan. "When the truth about the merchants of death, the international financiers, the diplomatic schemers, and the war-gouging profiteers stands revealed, wars will end," she said.

Adelle Cox of Los Angeles led the California chapter of We the Mothers and wrote a column for *Women's Voice*. She blamed the United States, rather than the Japanese, for the attack at Pearl Harbor and denounced Is "Jew inspired" the Federal Council of Churches in America for urging the mobilization of all resources for the war. A friend of Waters, she mailed copies of *The Modern Canaanites*, an anti-Semitic diatribe, to Reverend Jonathan Ellsworth

Perkins, who attributed communism and fascism to "the Jewish brain of Karl Marx."

Palermo, the vice president of We the Mothers, was active in Chicago politics, spoke at Townsend's meetings, and attended meetings of the Constitutional Americans. She was chair of the Illinois Bataan Relief organization, an anti-Roosevelt organization created on the pretext of aiding Americans held as prisoners of war by the Japanese.

Mary Catherine Parker took part in We the Mothers as well as in the Constitutional Americans. A backer of Coughlin, she sold *America Speaks*, *Women's Voice*, *The Cross and the Flag*, Court Asher's bigoted *X-Ray*, and numerous anti-Semitic pamphlets at meetings. Parker, who served as the Chicago representative of Asher and Smith, tried to convince mothers to subscribe to their magazines. A Catholic, she was critical of the church hierarchy for supporting the war. Parker was fired from her job with a Chicago print shop because of her nationalist agitation among employees.

Pearl Bussey Phinney, a contributor to *Women's Voice*, was a friend of anti-Semites such as Homer Maertz (who proposed that Jews be sterilized), Sanctuary, and Catherine Baldwin of the Defenders of the Constitution of the U.S.A. A prominent figure in New York City nationalist circles, Phinney termed Arthur V. Terminiello, an Alabama priest who billed himself "the Father Coughlin of the South," as "one of the great patriots in American history." In one of her articles for *Women's Voice*, she wrote, "The State Department is nothing but Jews, as are the post offices and all other government positions. Let's clean them out one way or another, and out of the country for good."

Zionism and the Race War

ONLY two of these finance companies were not owned by Jews, JP Morgan (above) and the Rockefellers. All of these companies represent the Robber Barons of old. They are monopolists, international thieves and racketeers, far more powerful and far more evil than Al Capone, Bugsy Siegel, or Meyer Lansky. And these monopolists still control the Federal Reserve Bank today.

Of course, Chase National Bank is no more a national bank than is the Federal Reserve Bank; and the Federal Reserve Bank is no more federal than Federal Express. The Fed is a PRIVATE BANK run for the profit of its private stockholders.

Recently, the kept press, which is totally controlled by Zionist Jews, has been accusing the Tea Party of being racist. Well, the fact is that most taxpayers are White, middle class people; and these White taxpayers have a right to demand that their money is not wasted on bailing out bankers and on communistic entitlement transfers – which means robbing Peter to buy Tyrone’s vote. It is also a historical fact that most Blacks were sold into slavery by their own tribal chiefs, in exchange for rum and other goods. For this reason, Blacks are every bit as much to blame for slavery as the Jews and plantation owners.

Here are some quotations from the book, *The Secret Relationship Between Blacks and Jews*, published by the Nation of Islam.

Besides their important position in the sugar industry and in tax farming, they dominated the slave trade.... The buyers who appeared at the auctions were almost always Jews, and because of this lack of competitors they could buy slaves at low prices.

According to Jewish scholar Dr. Harold Brackman, during the 1600's "slave trading in Brazil became a 'Jewish' mercantile specialty in much the same way it had been in early *medieval Europe*." In fact, wrote scholar Jonathan Schorsch, "*Jewish merchants routinely possessed enormous numbers of slaves temporarily before selling them off.*" The Jewish Encyclopedia adds that "*Jewish commercial activity*" in this time included a "monopoly of the slave trade."



Dr. Marcus Arkin wrote that the Jews of Surinam used "many thousands" of Black slaves, and Rabbi Herbert I. Bloom added that the "slave trade was one of the most important Jewish activities..." In 1694,

Jews owned 9,000 Africans. They protested vehemently when the Gentile authorities decreed that the slaves should have a day off.

The prominent Jewish historian Dr. Cecil Roth wrote that the slave revolts in parts of South America "were largely directed against Jews." Sources:

Many of these Jews have Dutch and Spanish surnames, because the Jewish bankers were allowed to operate in these countries, while they were being expelled from the other European countries. The Mystery of Super Spy - Sir Anthony Blunt by T. Stokes



Anthony Blunt
1907 - 1983

Born in 1907 his School life was difficult, and he was seen as both remote and awkward; he would later claim to Guy Burgess that his first sexual experience was at age 8.

A catalogue of wartime British intelligence corruption, and incompetence at the highest levels, and a classic case of Illuminati prosecution immunity... "In such small deceits do we begin the auction of our souls".

Men, particularly when disturbed emotionally or sexually, often take refuge in "intellectualism", and Blunt was an intellectual.

Like many others Blunt, while at Trinity college in Cambridge, swore an oath to help spread communism in the west, even supporting Soviet atrocities in the Spanish civil war, as did Kim Philby.

A team of 12 Soviet sympathisers at Cambridge university, known as the "Apostles", were part of the Comintern, or communist international. The Soviets called it the Hommintern due to the drunken, promiscuous sexual behaviour of its supporters. Blunt, like many other traitors, was a total heterophobe.

Blunt later claimed as did fellow travellers Philby and Cairncross, that he only helped the Soviets because they were opposed to Hitler, but this does not wash, because Hitler only arrived on the scene in the mid thirties, and as an antidote to the Soviet threat.

All through the Nazi-Soviet pact, Germany and Russia shared their intelligence, and Blunt & co. betrayed all they could. In one instance alone Blunt had 49 Dutchmen murdered.

In the 1930's Cambridge and Oxford were traitors recruiting grounds, often done with the complicity of those in authority,

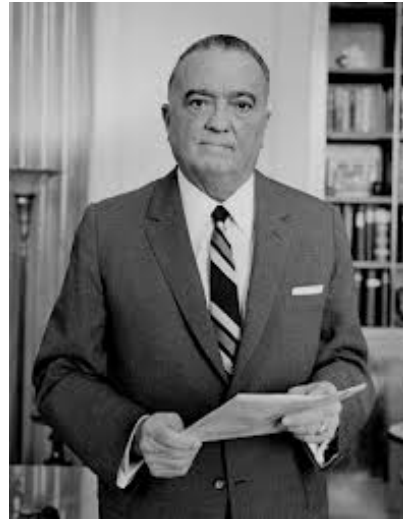
The Cambridge traitors often said, by assisting the Soviets they were only helping an ally, but they never were an ally; the Soviets worked against us the whole way through the war, up to the collapse of the Berlin wall. (This is confirmed by defector evidence, including Oleg Penkovsky, Yuri Nosenko, Igor Gouzenko, and in particular Anatoli Golitzin, and the K.G.B. archivist Vasili Mitrokhin).

After the collapse of the Soviet Union much information previously hidden from us about our own nations crimes, and hidden by our own security services has come out. This incompetence has become known from released K.G.B. files, and it makes a mockery of our history books and a lot of revered establishment figures. The American Freedom of Information act is also quite revealing. Blunt upset many contemporaries by his reference to the unnecessary fire bombing of German dormitory towns and cities, "as an act of the greatest cowardice by the R.A.F. when the third Reich was making gestures for an honourable surrender from 1942".

Blunts heavy drinking bouts show the anxiety and mental restlessness over being found out; the guilt over trying to destroy ones country must have been huge. This would be fertile grounds for deep depression, which often leads to alcoholism.

Blunt rose to the very heights of the intelligence world, and recruited many others to also betray their families and countrymen.

His friend and fellow traitor Guy Burgess was a devout keeper of daily diaries, and even today these make shocking reading.



Incidentally both Blunt and F. B. I Chief J. Edgar Hoover (above) both subscribed to the theory that the Jewish underground, the "Sanyanim", supported Russia through World War two. Blunts colleague and fellow traitor Kim Philby actually married Litzzi Friedman, a Jewish underground runner for Soviet Intelligence. Amazingly we never questioned him on this; in fact her security file actually carries a warning about this.

It was believed that the Jews would help anyone who opposed Germany, (see testimony Ethel Rosenberg, Ruth Cohen/Werner and Helen & Peter Kroger); this compounded by Churchill's decision, on Victor Rothschild's advice, to forbid any intelligence gathering on Russia. And to ship them aid as in spitfires and foodstuff etc, when our own country was so desperate, remember we shared all intelligence with the Soviets, they shared none with us, Stalin even deliberately muddying the waters, with Churchill falling over himself to appease the Russians.

In 1942, India bravely supported Britain in its war, while Churchill refused to help the Indian famine which killed four and a half million people. Churchill even remained silent over Stalin's rape squads; Russian soldiers entering Germany with orders to rape as many German women and children as possible, to disrupt the Eugenic tables.

Again defector evidence hints at the American president and his wife, Eleanor Roosevelt, having Russian socialist sympathies, but this could have been blackmail over her sexual promiscuity.

Bear in mind, to remain silent about a crime is to be complicit in it.

Churchill's attitude as an issue in itself is very strange.

Blunt had strong feelings that Germans like Klaus Barbie, who was so successful at rounding up Churchill's wartime S. O. E. thugs and bombers, Barbie then like others became agents for America in the war's aftermath, because the only people with an intelligence infrastructure to deal with the Soviets were the Germans, so they were promised immunity, the war crimes trials of Nuremberg, meant the allies went back on their word.

Churchill did not even want a trial, just a few quick murders as shown in the way the S.O.E dealt with Mussolini's cabinet.

Our Intelligence services said Britain's real enemies all along were the Soviets; anyone helping German interests were hanged or shot, Soviet agents most times were not even prosecuted. And it meant the whole truth about Stalin's Englishmen never came out.

Incidentally, Louis De-Whol, one of the British governments team of astrologers during World War two, claimed all along that certain highly placed people were at risk from blackmail. These were; alcoholics, predatory homosexuals, communists and compulsive blabber mouths. Blunt met every category, yet was allowed to continue in place. In one incident, from the Russian first chief directorate, Blunt (code named Johnson) broke down in a taxi outside Leconfield house and confessed to the driver, that he was a Soviet spy, with many deaths on his conscience.

Many taxi drivers who travelled to the Intelligence H.Q. were in the pay of the K.G.B. who reported back, and they offered Blunt the chance to defect, which interestingly, he refused. On another occasion, while undergoing a cataract operation, he blurted out to the surgeon accusations about the comedy actor Charlie Chaplin being blackmailed into being a top A.I.P (agent in place) for the Jewish underground, under threat of exposure about his tastes in underage girls, his recruitment by Lord Victor Rothschild, of his own involvement with both the Russians, and of Blunt being "turned on sexually" by the shiny boots, and fur busbies that Guardsmen wore.

Now remember you could get treatment until 1992 on the national health for sexual problems of this sort, as it was classed by the world health organisation as a mental health illness, and although he was regularly picked up by the police for hanging around public lavatories, he was never prosecuted, as he was protected from within. One of his boasts was that he often shared the same young boys with playwright Noel Coward and Intelligence chief Maurice Oldfield, and the king's own brother, these spotty adolescents they called "rough trade"; he would refer to them as his "catemites". He would also claim while drunk at whites club, that the labour leader Hugh Gaitskell was murdered by the Soviets. Years later, Gaitskells family nanny, a woman of scrupulous integrity, Maude Burton, said the family believed it also. I read her actual statement, before official alteration and signing. The family nanny was then retired to a tiny village called Brancaster Staithe, where she was born, given a cottage, and sworn to secrecy.

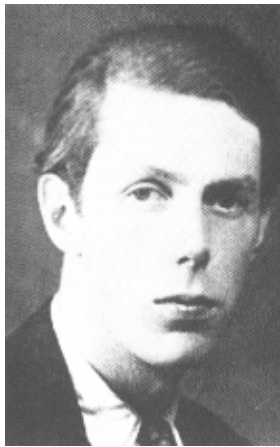

Blunt claimed the death of the patriot "Lawrence of Arabia" was also murder. After the war Blunt would jokingly claim to rent boys that he would bring back to his flat above the Courtalds Institute, that he was the illegitimate son of the king and he was sent to the remains of Germany to retrieve letters of support for the Third Reich, from our royal family and he had kept something for "insurance".

The queen mother in particular was said to be a supporter of Hitler because he was the only man alive who would stand up to the Soviet Union, and remember that in the Russian revolution her relatives, the Romanovs were murdered.

Newspaper tycoon Robert Maxwell allegedly claimed Bilderberg sources named the present queens mother, as his main protector. This meant our inept Intelligence services would never bring

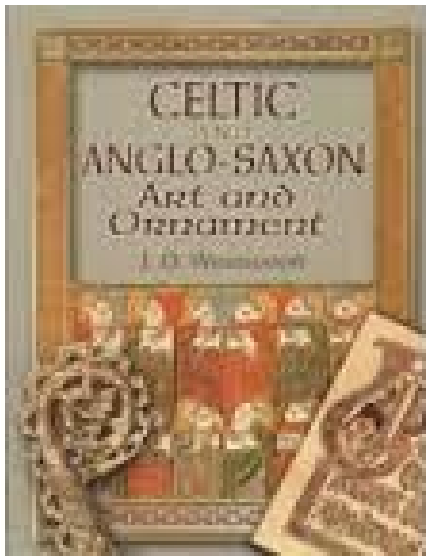

Sir,—I am required under the professional negligence pre action protocol to write to you to inform you that I intend to take action in the

Common Law Court for the suffering that you have caused me by your professional negligence.

YOUR NEGLIGENCE

You are required under common law as described by Henry de Bracton on or about the Year 1255, to record and investigate crimes that come within your knowledge.

The holder of an office of constable by refusing to record a crime is tantamount to him granting a dispensation of the penalty of that crime. Court of Common Pleas. Thomas v Sorrel 1674. You have refused to record and investigate the crimes committed by the three chief constables in the Plebgate affair where they admitted on record before the Home Affairs select committee that they altered a legal document

The Hebrew Origin Of The Brigands – Now A Derogatory Term From Our Sussex Correspondent



THE once great Bowland Forest and the dramatic fairy tale mountainous landscape of the Lake District in Cumbria, including Lancashire and Yorkshire was once known as Brigantia and is also the 'middle' territory of Britain.

The Iron Age tribe that inhabited this vast region were the Brigantes, (from whence the word brigand is derived) a distinct race of people with their own elite aristocracy who ruled over middle Britain. Ralph Ellis, author of *Scota, Egyptian Queen of the Scots* (2006), states that the race originated from a city called Brigantia in northern Spain, which from early geographical descriptions is the modern city of Betanzos in Galicia. According to old maps and literary accounts, this town up until the 17th century was referred to as 'the former city of Brigancia'. The name Betanzos is also phonetically derived from Brigantium.

In 1435, Walter Bower, Abbot of Inchcolm Abbey in Scotland, compiled a history of Scotland called the *Scotchichronicon*. In this remarkable but controversial book, Bower states that

the Irish and Scots were descended from Scota, daughter of an Egyptian Pharaoh. Ellis identifies her as the fourth daughter of the Pharaoh Akhenaten also known as Ankhnesneferibre. Her husband Gaythelos was an Amarna royal prince who Ellis believes was a vizier to Akhenaten, and later called Milesius. The *Scotchichronicon* mentions that Scota and Gaythelos left Egypt during a great exodus in 1300 BC with the help of Phoenicians and settled with their many followers in southern Spain by the River Ebro. Later they moved into Portugal and built a fortified town called Brigani their descendants eventually settling in Ireland and Scotland.

Around AD 145, a Greek geographer working in Alexandria published a map the world based upon information gathered by early Greek/Phoenician traders and the Roman expeditionary forces. His map of Britain was remarkably accurate except for Scotland north of the Tay, which stretched eastwards rather than northwards. He named the southeast region of Ireland Brigantes after the tribe who settled there.

These Irish colonists adopted the name Scotii after their Queen Scota, many of the eventually migrating to Western Scotland. The Brigantes of northern Britain with another group of these colonists making their capital at York. This popular tourist city formerly known as Eboracum took its name from the River Ebor, which is uncannily similar to Ebro, the name of the river where Scota first settled in Spain.

The Venerable Bede described the Brigantes along with the Scottish tribes off Novantae and Selgovae as the southern Picts. Other sources say they came originally from Germany or north-eastern Gaul, whilst others suggest they travelled from the Braganca region of Portugal or Bregenz in Austria, both places renowned for the worship of the goddess Brigantia, a name that literally means 'the highest'.

During the time of the Roman invasion, the Brigantes held the largest territory in Britain ruled over by Queen Cartimandua from another of their main centres Stanwick in Yorkshire. Many historians regard her as traitor, having handed over the great British war leader Carodoc or Caractacus in chains to the Romans, although many sources say she did so to protect her people.

The Romans recorded the Brigantes as a proud and war-like nation with a tradition of imperial conquest. Despite her pro-Roman stance, Cartimandua's tribe rebelled several times under the leadership of her husband Venutius, until General Ostorio finally suppressed them in AD 79. However, according to the Roman poet Juvenal, I Brigantians continued their bid for independence in the second century AD, as Roman soldiers were encouraged by their families to win glory for their country by 'destroying the forts of the Brigantes'.

Some historians now believe that the intention of Hadrian's Wall, built after AD 1 was to prevent the Brigantes and the lowland Pictish tribes from joining forces, the strength of their combined armies would have almost certainly outnumbered the Roman legions.

After the Romans departed Britain, the northwest region of Brigantia became the Kingdom of Rheged, one of the most powerful kingdoms of the post-Roman Briton ruled over by a legendary warrior called King Tjrien. Its territory stretched as far south as Manchester and the western Pennines to Galloway in the north, but its heartland in the Eden Valley and Carlisle. They successfully defended their realm against the Saxon tribes and stayed independent until the 7th century when, through a royal marriage alliance, they peacefully joined with the Angles to become part of the Kingdom Northumbria. Celtic Christian missionaries from Ireland also roamed the Kingdom Rheged during the Roman occupation, converting many pagans to the early teaching of Christ.

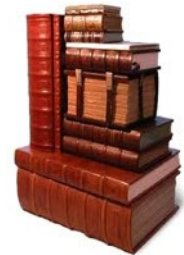

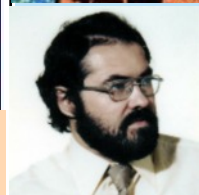

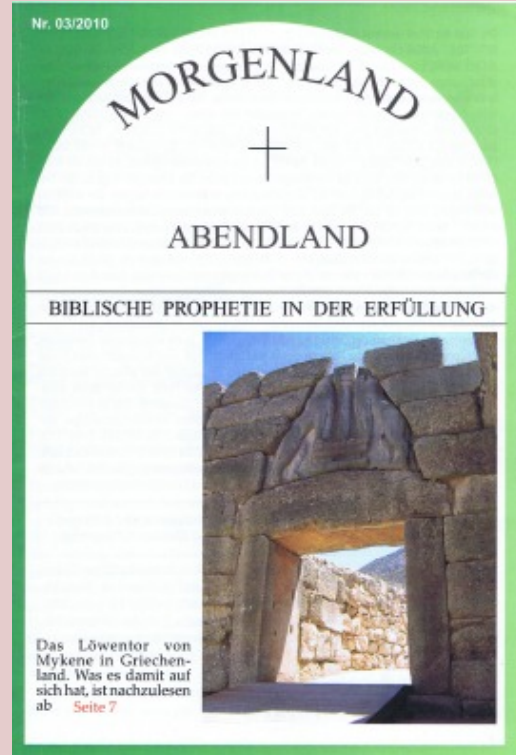
