## Refutation of Post-Tribulation Millennialism

(Continued from February edition)

### The Dragon is Tossed into the Lake of Fire

*“And I saw an angel come down from heaven, having the key of the bottomless pit and a great chain in his hand.” - Rev. 20:1.*

Verse 8 repeats the deception of the nations, but adds the fact that the Battle of Armageddon looms, under Gog and Magog. Verse 9 continues the story of this last battle.

Verse 10 describes Satan himself being cast into the lake of fire, repeating this fact, already stated in Verse 3. I point this out in order to stress the fact that the MAIN THEME of Rev. 20 is the binding and loosing of Satan. The reign of the Saints occurs within the time frame of the binding of Satan, not afterwards. **False tradition has emphasized an altogether fictitious theme, namely, the “millennial reign of Christ.”**

### The Context of Rev. 20

From our perspective, here in the year 2012, the thousand years of Rev. 20 are a FLASHBACK to the days of the persecutions of Protestants by the Catholic Church. During this period, the

Jewish persecution of Christians was held in check, even though the Popish persecutions were as bad as anything the Edomite Jews had ever done. Nevertheless, that period ended with the Protestants emerging victorious over Popery. Napoleon himself defeated the armed forces of the Papal States; and Rome’s reign as the Sixth Beast was at an end, never to return as a military power. It is important to note, however, that the Papacy still exists as a major part of the False Prophet. It has been demoted before it is ultimately destroyed.

After the Protestant victory over Popery, a new era of anti-Christian persecution began.

Since the days of the French Revolution, Christians have been persecuted **even more grievously by the Jews**, who have been holocausting Christians in a constant stream of wars and communist revolutions. Today, Jewry finances wars between and among all nations, deceptively presenting these wars as “wars of nationalism.” **The liberation of the Jews from the ghettos by Napoleon is the single most important factor in loosing Satan from the bottomless pit.** This historical fact eventually led to the re-emergence of the Jewish banking houses gaining influence in the royal courts of Europe, from which they had been banned for a thousand years.

This binding of Satan was the Holy Spirit’s doing, as Paul states in II Thes. 2:6-12. The unbinding of Satan has led to the global empire

of Zionist/communist Jewry. This last world empire is also a fulfilment of Isaac's prophecy to Esau at Gen. 27:39-40. There, Isaac told Esau that the day would come when he would break Jacob's yoke from off his neck. Esau's Zionist ascendancy over us coincides perfectly with the "little season."

### The Logical Problems of the Post-Trib Millennium

If the 1,000 years occurs **AFTER** the judgment of the Beast and False Prophet, several logical problems occur:



would have no bankers, merchants or false priests to tell us that we should worship the Jews and their monetary system. In fact, that monetary system would be gone forever. Judaism will be gone forever and Judeo-Christianity will be gone forever, because nothing gets out of the Lake of Fire. How in the world is the Dragon going to deceive us for a thousand years, if he has no bankers, war-mongers and false priests?

2.) PTM advocates teach that Christ is reigning at this time, between the judgment of the Beast and False Prophet and the judgment of the Dragon. **So, if Christ is reigning, how is Satan able to "deceive the nations" while He is reigning?** Could Satan fool Yahshua, and deceive us under His Saxon nose? Paul says that "Satan is the prince of this world." If Satan's minions have been destroyed, there won't be any Jews around to deceive us. His world will have been destroyed. Nor will there be a Judeo-Christian Apostasy to distort the Holy Scriptures. If Christ is reigning with the Saints at this time, then their reign will be absolutely ineffective if they can't restrain the Dragon for this anticipated 1,000 years of deception! The PTM advocates have no explanation of how this Great Deception can occur while both Christ and the Saints are reigning, and while the Beast and False Prophet are getting scorched in the Lake of Fire! It makes no sense at all!

1.) With the Beast and False Prophet already in the Lake of Fire, the Dragon would have no earthly minions to work through. He

3.) PTM must advocate the notion that two Judgment Days must occur. The first is the judgment of the B and FP. The second must occur one thousand years later, when the Dragon and Gog and Magog are judged. But the book of Ezekiel clearly places the judgment of Gog and Magog in the context of the one-and-only Judgment Day, just before the Second Coming. Daniel 12 asserts the same thing. PTM is essentially teaching that there will be two judgments and two second comings. For example, I Thes. 4:16 states, *For the Lord himself will come down from heaven, with a loud command, with the voice of the archangel and with the trumpet call of God, and the dead in Christ will rise first.* Then comes the judgment of the living. In these verses, there is no hint of a Second Return for a second judgment. Rather, the Kingdom will be established, then and there.

4.) PTM is the only interpretation which demands that the Battle of Armageddon be placed 1,000 years after the judgment of the Beast and False Prophet. All others declare that Gog and Magog will be destroyed **as part of the Second Coming, when He returns to vanquish His enemies.** There is no hint of a millennial delay after Gog and Magog have been destroyed.

5.) PTM ignores the context of Rev. 20, which is the confinement of the Dragon in the bottomless pit, until he can be loosed to deceive the nations for the "little season." We are IN that little season right now.

6.) PTM misidentifies the corresponding reign of the SAINTS with the non-existent "millennial reign of Christ," which is a non-Scriptural event. There is no such expression in Rev. 20. It is a false interpretation which has been reinforced by two centuries of repetition.

All of these problems are avoided when it is conceded that the thousand years in question are a FLASHBACK to the millennial binding of Satan, during which time occurred the persecutions of the Saints of European Israel, who gave their lives for Christ, **THUS REIGNING WITH HIM, in heaven, until their promised resurrection, which does not happen until Christ physically returns.** This is when the New Jerusalem comes down to the earth, and the unending rule of Christ on earth begins. They have already received their crowns of glory, **during their own millennial reign,** while Satan was bound for a thousand years; but they have

not yet received their resurrection bodies, which they will receive at the Second Coming. Verses 2 and 7 are the bookends of this flashback.

The Scriptures are replete with declarations that this present Age will end with the destruction of the Edomites (modern day Jews). There is no doubt that these Jews are the principal component of the last Beast, Mystery Babylon. **Once destroyed, they cannot rise again.** That's like saying that they can come out of the Lake of Fire. II Esdras 6:7-10 states categorically that there will be NO INTERVAL between the destruction of Esau and the eternal reign of Jacob. *"Between the heel and the hand, Ezra, do not look for any interval."* - Verse 10. Esau's destruction will be complete; and there will no more Canaanites left to afflict Jacob (Zech. 14:21).



We have to remember that chapter headings and verse numbers were added to the text by the translators. The original Greek did not contain these separations. Therefore, we cannot assume, because the Dragon is not discussed until Chapter 20, that we are dealing with an entirely new subject or

a subject that is chronologically subsequent to the immediately preceding verses of Chapter 19. Rather, John is merely dealing with the Dragon's judgment in greater detail.

A good illustration of what I mean is to consider a movie in which a traffic accident is depicted. There are three occupants in the car: two in back and one in front. The first scene focuses on what happens to the occupants in the back seat. The next scene zooms in on what happens to the driver in the front seat. The action is, in fact, simultaneous; but the story line treats the simultaneous action from two different perspectives. If there were three fatalities, the rear occupants died first, but the driver's death is shown separately and with greater detail.

The fact is that the grammatical structure of Rev. 19:19 to Rev. 20:10 is consistent with **verses 2 through 7 serving as either a flashback or an appositive** (a set of parenthetical remarks introduced for purposes of explanation or as exam-

ples). The context of verses 2-7 is what happens while Satan is bound for the thousand years. There is nothing in these verses that suggests that the action takes place **AFTER** the Judgment Day. That is simply a false conclusion that has become popular mythology.

Finally, the historical context of the events contained in Rev. 19:19 to 20:10 beautifully fits the hindering of Jewish usury for the millennium described. This Beast was let loose by the French Revolution. During the Napoleonic Wars, the banking operations of Mayer Amschel Rothschild and his five sons made them unimaginably rich and powerful, as they loaned money and sold supplies to both sides of the conflict. The subsequent emergence of the House of Rothschild as the Eighth and final Beast also fits perfectly. The Great Apostasy of the Judeo-Christian churches is a perfect fit for the False Prophet. And the "little season" corresponds to the power of the international bankers, from the demise of Napoleon at the Battle of Waterloo in 1815 to the Judgment Day. We are not quite 200 years into this little season. One thing is for sure: The Eighth Beast will not live much longer. The signs of economic collapse are everywhere; and the Battle of Armageddon also looms, as the Zionists are determined to destroy every nation which is not under their yoke. Next up: Iran.

Given all of this historical context, the best interpretation of Rev. 20 is that it describes a **Pre-Tribulation Millennium**, lasting from 800 AD to 1806 AD, during which Satan was bound. Nevertheless, while the Holy Roman Empire restrained Jewry, thousands upon the thousands of Christian martyrs earned a place in heaven, where they are already reigning with Yahshua. The next crop of overcomers will be harvested at the Judgment Day. After this event, the eternal rule of New Jerusalem will be established, without interruption. **Pastor Eli James.**

# Harlot Churches (Part 3)

## BALAAAM'S DOCTRINE

Continuing in this passage in Jeremiah chapter two:

V22, *For though thou wash thee with nitre, and take thee much soap, yet thine iniquity is marked before me, saith the Lord GOD. How canst thou say, I am not polluted, I HAVE NOT GONE AFTER BAALIM? see thy way in the valley, know what thou hast done: thou art a swift dromedary traversing her ways; A wild ass used to the wilderness, that snuffeth up the wind at her pleasure; in her occasion who can turn her away?*

Yes, they may say, “Jesus is Lord” and even love to hear the Word of God but they will not do it-(Isaiah 58). Most churches have no idea what “gone after Baalim” means. They are not taught about it. What does it mean? What did Balaam counsel Balak? It was to commit fornication with foreign women. This is the temptation that “is common to man”, that is, to the Israelite man-(1Cor. 10:13). “Not a problem”, says the Harlot. “Not a problem” say all the Harlot’s daughters. Note the phrase, “at her pleasure” in the verse above. Baalam’s doctrine is obviously pleasure in the Harlot churches. And note that it is a taught doctrine!

Is not the prophet saying that the harlot churches are like wild asses on heat in this regard? Then the Harlot says,

V25, *There is no hope: no; for I have loved strangers, and after them will I go.*

These “strangers” are foreigners! There is determination in the Harlot churches to go after strangers. Oh yes, when this is pointed out they will not accept it – no they still trust in their doctrines – their gods. This is one of their idols. So the prophet asks,

V28 *But where are thy gods that thou hast made thee? let them arise, if they can save thee in the time of thy trouble.*

Then God asks, “Wherefore will ye plead with me? ye all have transgressed against me, saith the LORD. In vain have I smitten your children; they received no correction”. But they go on teaching, their ways-(V33), saying, “I have not sinned”-(V35).

In the next chapter, the prophet Jeremiah tells the Harlot they are denied God’s blessing because they had, “played the harlot with many lovers”. Jeremiah tells the harlot, “Therefore the showers have been withholden, and there hath been no latter rain; and thou hadst a whore’s forehead, thou refusedst to be ashamed”-(V3). We will see more about the “forehead” shortly.

Hosea 2:6, confirms this, “Therefore, behold, I will hedge up thy way with thorns, and make a wall, that she shall not find her paths”. The “showers are held back; prayers remain unanswered. If they were answered and if God manifested Himself, they would all die of fright! – or of judgment.

Ezekiel tells the same story. The harlot used what God had given her to commit harlotry.

Ezekiel 16:15-17 *But thou didst trust in thine own beauty, and playedst the harlot because of thy renown, and pouredst out thy fornications on every one that passed by; his it was. And of thy garments thou didst take, and deckedst thy high places with divers colours, and playedst the harlot thereupon: the like things shall not come, neither shall it be so. Thou hast also taken thy fair jewels of my gold and of my silver, which I had given thee, and madest to thyself images of men, and didst commit whoredom with them.*

Ezekiel also names these lovers, in this case as Assyrians, being their neighbours. Assyrians were foreigners and good looking ones at that!

Ezekiel 23:5- *And Aholah played the harlot when she was mine; and she doted on her lovers, on the Assyrians her neighbours, Which were clothed with blue, captains and rulers, all of*

*them desirable young men, horsemen riding upon horses. Thus she committed her whoredoms with them, with all them that were the chosen men of Assyria, and with all on whom she doted: with all their idols she defiled herself.*

These foreigners all seemed desirable **and again, pleasing to the senses!**

But there is a sad consequence, these foreigners eventually turn against God's people. God causes this.

V9-10 *"Wherefore I have delivered her into the hand of her lovers, into the hand of the Assyrians, upon whom she doted. These discovered her nakedness: they took her sons and her daughters, and slew her with the sword: and she became famous among women; for they had executed judgment upon her.*

God's people had lost the covering their God had given them, and had become "naked". We have already seen this in Proverbs 6:26, *"Can a man take fire in his bosom, and his clothes not be burned?"* When the clothes are burned off one becomes naked. Foreigners then became God's instrument for judging His people.

How are these foreigners described?

Ezekiel 23:19-20 *She had played the harlot in the land of Egypt. For she doted upon their paramours, whose flesh is as the flesh of asses, and whose issue is like the issue of horses.*

These Egyptians were foreigners of another race. The "flesh of asses" and the "issue of horses" were (and are) unclean, but it sounds as if the flesh of foreigners is as the flesh of animals. That is, other races are like different animals; (some modern geneticists evidently agree with the Bible about this!)

This prophet gives another discourse about this in chapter 16:15-37 and this concludes by saying that the insatiable harlot's nakedness would be discovered. In the passage below, we see how the churches build their, "high and eminent" places, or church buildings in prominent positions. There they attract members of non-Israelite foreign races. There they collect money so they will give their wealth to other races, exactly as prophesied. When Paul collected money, it was only for the poor "saints" at

Jerusalem. (For a definition of who are saints, please view Psalm 148:14). This Ezekiel passage is posted below without further detailed comment, but it is worth reading carefully, because in it we can see further detail about harlotry by God's people—and the consequences!



Ez 16:15-37 *But thou didst trust in thine own beauty, and playedst the harlot because of thy renown, and pouredst out thy fornications on every one that passed by; his it was. 16 And of thy garments thou didst take, and deckedst thy high places with divers colours, and playedst the harlot thereupon: the like things shall not come, neither shall it be so. 17 Thou hast also taken thy fair jewels of my gold and of my silver, which I had given thee, and madest to thyself images of men, and didst commit whoredom with them, 18 And tookest thy brodered garments, and coveredst them: and thou hast set mine oil and mine incense before them. 19 My meat also which I gave thee, fine flour, and oil, and honey, wherewith I fed thee, thou hast even set it before them for a sweet savour: and thus it was, saith the Lord GOD. 20 Moreover thou hast taken thy sons and thy daughters, whom thou hast borne unto me, and these hast thou sacrificed unto them to be devoured. Is this of thy whoredoms a small matter, 21 That thou hast slain my children, and delivered them to cause them to pass through the fire for them? 22 And in all thine abominations and thy whoredoms thou hast not remembered the days of thy youth, when thou wast naked and bare, and wast polluted in thy blood. 23 And it came to pass after all thy wickedness, (woe, woe unto thee! saith the Lord GOD;) 24 That thou hast also built unto thee an eminent place, and hast made thee an high place in every street. 25 Thou hast built thy high place at every head of the way, and hast made thy beauty to be abhorred,*

and hast opened thy feet to every one that passed by, and multiplied thy whoredoms. **24** Thou hast also committed fornication with the Egyptians thy neighbours, great of flesh; and hast increased thy whoredoms, to provoke me to anger. **25** Behold, therefore I have stretched out my hand over thee, and have diminished thine ordinary food, and delivered thee unto the will of them that hate thee, the daughters of the Philistines, which are ashamed of thy lewd way. **28** Thou hast played the whore also with the Assyrians, because thou wast unsatiable; yea, thou hast played the harlot with them, and yet couldest not be satisfied. **29** Thou hast moreover multiplied thy fornication in the land of Canaan unto Chaldea; and yet thou wast not satisfied herewith. **30** How weak is thine heart, saith the Lord GOD, seeing thou doest all these things, the work of an imperious whorish woman; **31** In that thou buildest thine eminent place in the head of every way, and makest thine high place in every street; and hast not been as an harlot, in that thou scornest hire; **32** But as a wife that committeth adultery, which taketh strangers instead of her husband! **33** They give gifts to all whores: but thou givest thy gifts to all thy lovers, and hirest them, that they may come unto thee on every side for thy whoredom. **34** And the contrary is in thee from other women in thy whoredoms, whereas none followeth thee to commit whoredoms: and in that thou givest a reward, and no reward is given unto thee, therefore thou art contrary. **35** Wherefore, O harlot, hear the word of the LORD: **36** Thus saith the Lord GOD; Because thy filthiness was poured out, and thy nakedness discovered through thy whoredoms with thy lovers, and with all the idols of thy abominations, and by the blood of thy children, which thou didst give unto them; **37** Behold, therefore I will gather all thy lovers, with whom thou hast taken pleasure, and all them that thou hast loved, with all them that thou hast hated; I will even gather them round about against thee, and will discover thy nakedness unto them, that they may see all thy nakedness.

This “nakedness” is becoming seen today. The harlot churches are dropping in membership. Aliens are taking over our lands. We have seen how foreigners are instruments of judgment upon Israelites.

So the end of the unrepentant Harlot is not pretty. The end of the well dressed, well favoured Harlot is woe.

Nahum 3:1-6 *Woe to the bloody city! it is all full of lies and robbery; the prey departeth not; The noise of a whip, and the noise of the rattling of the wheels, and of the prancing horses, and of the jumping chariots. The horseman lifteth up both the bright sword and the glittering spear: and there is a multitude of slain, and a great number of carcases; and there is none end of their corpses; they stumble upon their corpses: BECAUSE OF THE MULTITUDE OF THE WHOREDOMS OF THE WELL-FAVoured HARLOT, the mistress of witchcrafts, that selleth nations through her whoredoms, and families through her witchcrafts. Behold, I am against thee, saith the LORD of hosts; and I will discover thy skirts upon thy face, and I will shew the nations thy nakedness, and the kingdoms thy shame. And I will cast abominable filth upon thee, and make thee vile, and will set thee as a gazingstock.*

There is no escape by rapture, is there?

### THE KEY

Jeremiah tells the same story about Jerusalem that had become described as a Harlot.



Jer. 22:8-9 *And many nations shall pass by this city, and they shall say every man to his neighbour, Wherefore hath the LORD done thus unto this great city? Then they shall answer, Because they have forsaken the covenant of the LORD their God, and*

*worshipped other gods, and served them.* The phrase, “Because they have forsaken the covenant of the LORD their God” is the real substance of what makes a Harlot. There are some 63 Bible references to “other gods”. On top this are all the references to the Gods of other peoples.

But there is more than this; a covenant is involved. God’s covenant involved commandments, statutes and judgments.

Deut 4:13-14 *And he declared unto you his covenant, which he commanded you to perform, even ten commandments; and he wrote them upon two tables of stone. And the LORD*

*commanded me at that time to teach you statutes and judgments.*

**Forgetting or forsaking this Covenant is precisely what makes a church into a harlot. The Commandments, statutes and judgments have no place in the harlot's manner of life or worship.** Few could even tell what the differences are between "commandments", "statutes" and "judgments" and how these relate to the total Law. They are taught nothing about the different components of God's Law. The Harlot seduces by her spiel that obedience is not required today.

### RACE MIXING

The church that has become a harlot has come to believe in what is termed, "The Brotherhood of Man", that is, they believe that race mixing is even desirable, and that all races are the same in God's sight. This is the belief of humanism. Churches do this because the commandments, statutes and judgments have no place in their thin



So let us consider this all from the viewpoint of not forgetting the covenant. Now, we all know about, "*Thou shalt have no other gods before me*" as found in the Ten Commandments. Further on we find:

Exodus 23:13, "*Make no mention of the name of other gods, neither let it be heard out of thy mouth*". Then a little further on we find:

Deut. 6:14 *Ye shall not go after other gods, of the gods of the people which are round about you.*

These are keys to understanding. In this verse please note the phrase, "**WHICH ARE ROUND**

**ABOUT YOU**". Israelites as God's elect people were commanded to be a separate people. They were designed to be "*a peculiar people*", described as God's "*treasure*". At that time the other races were "round about", not "amongst" them. But what happened? Through disobedience and unbelief Israel did not carry out the ethnic cleansing of the promised land, and since that time the foreigners became mixed up with them. This led (and still leads) to the worship of strange gods.

But the real doctrine of separation has not changed one iota. Israelites are still commanded to be a separated and peculiar people in the New Testament. This is exactly what the Harlot churches will not accept. This is one of the things that makes a church into a harlot church. Remember, we are not to join ourselves to a harlot. What else?

Deut. 13:12-14, "*If thou shalt hear say in one of thy cities, which the LORD thy God hath given thee to dwell there, saying, Certain men, the children of Belial, are gone out from among you, and have withdrawn the inhabitants of their city, saying, Let us go and serve other gods, which ye have not known; Then shalt thou enquire, and make search, and ask diligently; and, behold, if it be truth, and the thing certain, that such abomination is wrought among you*".

Here is that word "abomination" again. The "other gods" are the gods of other peoples. This passage goes on how to deal with harlot (Belial) churches by those Israelites who believe their God.

V!5: *Thou shalt surely smite the inhabitants of that city with the edge of the sword, destroying it utterly, and all that is therein, and the cattle thereof, with the edge of the sword. And thou shalt gather all the spoil of it into the midst of the street thereof, and shalt burn with fire the city, and all the spoil thereof every whit, for the LORD thy God:*

There is no trace of it being acceptable to have fellowship with those with "other gods". As God cuts them off, so must we.

## The Knight Of The Scarlet Thread (Part 2)

### MOTHER AND SON

Time and again, reclining at his mother's feet, had Eochaidh listened with enjoyment to her graphic way of scanning through the story of her native island. To Muiream, its tale was simply one of continued Danaan settlement and conquest. And in his earliest childhood, Eochaidh had caught from her the spirit of its romance. Nor had his broader education at the Irish Universities ever ruptured the thread which she ran backward through it; indeed continued through thereon among his books had only served to string it more thickly with new beads and fill the spaces here and there, which she in the enthusiasm of a grounded faith, had either hastened over, or else entirely neglected.

Her work was like to that of genius upon canvas which in but a few bold stokes, brings out the whole effect, but is impatient of too studied details and the quick, receptive mind of Eochaidh was facile to her brush, nor such is the power of woman as a mother, did it ever lose the master's outline. Moreover, there was ample fund of interest in this theme which Muiream loved, and which she therefore chose most frequently in converse with her son. For we must not forget that there were earlier chapters in the story of these people. These chapters stretched still further back into its remotest past, and spanning at least another 1000 years, including

the stories of the Tuatha de Danaans proper, The Fir Bolgs, The Fomorians, The Nemhedians, The Parthalonians, The Iberians, and earliest of all the Craunnogs. No wonder our historians have been long at sea since they sailed without a compass pointing unto Israel as the Pole.

Muiream's sole object was to establish the unity of the Irish race down to the Milesian (Zarah) conquest which she foresaw, and which would bring comparatively, but few newcomers to the Island. For as she firmly believed that Eochaidh would be its Ard Ri, she desired to impress upon him that the mass of his subjects would be his mother's people. And that he would be truly King of the Danaans as if he had been the son of Greame himself. She was jealous of her people's ancient prestige, and she wished her son to have good reason to be true to them, that they in turn, might give him their support without reserve.

As wave after wave, the human flotsam of successive immigration which history washed up on the Irish shores was passed in review before Muiream's gaze her own analysis of what the sea gave up bore ample evidence that all of it was but a part of one great Ship of State whose sections derelict upon the tide, had simply come in one by one instead of all at once. The wreckage all bore marks of common origin and gave ample opportunity for rude assortment when it reached the shore. Beyond this Muiream gave the subject little thought. She viewed it only from its western aspect which gave her summary its greatest value. For as already noted, it shows that God, Himself, was intimately in the case, and was disposing matters not too clearly in the west, so as to counterpart and carry on those we have already seen, HE had begun so quietly in Eastern lands. We must not forget that we view Erin's story through still later heaps of jetsam, more and more confused by those who have disturbed it ever since the Emerald Isle became an object of Anglo-Saxon contention and dispute. None of its strata have much order now, and long ago their main treasures were mined out. We do however believe that early Irish history as Muiream viewed it, was mostly broadly true. So let us return to those earlier days of Eochaidh, and sitting with him at the

feet of Muiream, take from thence a somewhat hasty survey of the previous history of Erin, for it is only thereafter that we may confidently move forward with our Hero into other scenes.

### MUIREAM'S STORY



Well, Eochaidh, thy mother must at once betray the weakness of her sex, and therefore will anticipate the end and fond conclusion of her story at its very start. I shall bring Danaan history with you, to whom it has come fully down,

and in whom, I believe, it will literally culminate. You are my son and I the Queen. If not the last, as certainly the youngest of all the Royal Danaans; hence too, you are peculiarly my people's son. For as my uncles have no children, and MacGreame's own line runs out in me, you are the only rightful heir of Erin's 'Craun.'

I am not concerned so much, my son, in your Milesian story. You have come hither to the Western Bournes, guided by the same Destiny that pioneered your predecessors. And now that the Fates have given them an equal promise in the future, for I see in the philosophy of facts, that history will soon repeat itself. It is for you to follow back the special line marked by that 'Scarlet Thread.' (Genesis 38:28)

Danaan history is without beginning. Who we were in the far off 'shadows of the rising sun,' was never clear to me. Accounts are so confusing. Although they all conspire to point unto the gods themselves. A long time ago, our ancestors came into a land which they named Dania for their father 'Dan' who was our Posie-Dan, or Father of the Sea. This land was at the very centre of the earth, and therefore always overrun with enemies. For there first, did men congregate, and there the struggle for supremacy began. There to, I think, that they had many brethren. But very early, they, that is, our own peculiar ancestors, grew weary of pursuits on shore, which so engrossed the others. So they abandoned Dania one by one, for the more daring life upon the waves where they were born. Indeed, they mostly lived upon their ships thereafter, and wandered in them everywhere. And perhaps this is the reason that we know so little of the true history of ancient Dania, for it

soon became an almost Universal name. And so in time, the men whose sons and daughters continued to be born, as at first, upon the sea, in various places, and from generation to generation, there literally was no special Dania left.

But some at last grew weary of having no fixed resting place, and hence it is that we, one branch of their descendants, have now once more become quite reconciled to life on land. Even so, we still love the sea on which this Island home floats safely even though we worship the gods beneath the groves. But enough now, of the primitive legends, for you know them all from earliest childhood.

In spite of the many names by which the successive colonists who have settled here are known, there are really but two Royal races now in Ireland, your own, and mine. That is, your father's and my father's. For as you know, I am a daughter of one whom I mis-give will be the last Danaan King, and you, your father's son, are a true Milesian. (Zarah) Yet unlike your brothers, Heremonn, you naturally so favour -the characteristics of my own people, that to me you seem as one of them, and not a true Milesian. However, to give you briefly but the skeleton of Erin's story, for you to clothe with all the incidents of flesh your education may suggest, I will commence at its earliest colonist.

### THE CRAUNNOGS:

This island had no aborigines when Danaan keels first grazed upon its shores. It was a heritage in keeping for them and quite desolate of all, but nature's loveliness, a spot of green, and peaceful that it lured to land even those whose preference had till then, been wedded to the waves. The legend says they drew near to it, at the termination of a dreadful storm which had nearly driven them over the very ocean's furious limit in the West, when turning East, they sighted from afar, its emerald diadem of leaves. And that they landed here at once, and as a sign that they came to stay, we are told that they destroyed their ships using the masts, which saved them from the tempest, as the very piers of their earliest dwellings. These Craunnogs were really Danaan's people. Of course, they were only the very rudest offshoots of a roving and adventurous people, none of whom had shaped themselves as yet so as to conform to any fixed and positive characteristics, save love of sea and freedom. They lived in lake and river

dwelling as their descendants do to today, preferring water, after all, to land.

But this very colony had been actually seeking our far off insular abode, when the tempest overtook them. This may seem strange, my son, but from remote times, it had been believed by their own ancestors that somewhere in the strong north-western angle of the earth, the seat of final empire should find a throne of permanence.

This colony had wished to be the first to seize it. And had set out for this purpose when the storm fell on them. Thus, discovering this island under the circumstances that had brought them to it, they settled here, believing it to be the very one meant by the ancient Ollams. This, I believe to be true. For Eochaidh, this same thought has been in the hearts of every set of colonists who ever landed here; even your Milesians (Zarahites) have a similar tradition. However, our earliest colonists had it as part of their very life. They called themselves 'CRAUNNOGS, OR THE 'CROWNED PEOPLE,' from this very nation that the true meaning of their name is 'TREE TOPS' and it comes from words common to all our dialects. Craun, meaning a tree, and og, meaning a tuft or termination. We use this same word for a crown as they did.

Muiream continues: You know, my son, that even now no Danaan sailor ever trusts himself upon a ship whose mast head has been trimmed, that is 'stripped' of its 'craunnog' or its top-most tufts of leaves. Our learned Druids tell us that we inherited this custom, not from these early colonists, but with them must have come from the common Eastern origin this idea. The Druids say it is the Universal sign of kinship among all the people who down to the present day, have sought the refuge of this island sanctuary, that is of all except the fierce Milesians who being the last, have conquered it at least commercially. Tradition also points to it as one of the oldest emblems of Danaan destiny, the very sign of Universal Empire. But who? The fates are still reserving for some future showing. It is also a sign of conquest and defeat. And I doubt now, Eochaidh, that some of the deeper mysteries of the Druids whom I grieve to see you do not like over well, were, in their purer origin, significant of the branch of Empire destined so they say, to be planted here in time. They say the mistletoe, which came with us from Dania, was wrested thence in token of this very promise and I would

that thou, my peerless son, might be the one to grasp the leafy sceptre from the hands of Destiny.

But the centuries have waited, and may linger still. Yet, Eochaidh, the heraldry of that blazing Sun of Gold upon a blood red field, which you, the Royal son of Scythia's race, inherit, must be indicative of something. Would that it meant that Dania's sun, which certainly set in great MacGreame, has, in his daughter's child, a still more brilliant rising yet in store.



But a final word about these earliest colonists. The pulpits upon which the Druids stand when giving judgement, are to this day called 'Craunnogs.' And they always have the mystic twig of mistletoe above them. Indeed, thy very throne will bear this ancient name, a fact which bids thee bear in constant mind that it is literally founded upon piles which drive their way through every human stratum in the land, down to this very oldest and rudest of them all, and all of this must prove to you that my argument is both just in its beginning, as well as full of moral import to a future king. 'Connaught' as you know is the very land of Dan, one of its earliest Royal Centres. And no one would deny to men from whom we have our finest seamen the plainest title to their ocean birthright. The very tufted 'Craun' they leave above each dwelling is an emblem of their race Muiream goes on to describe the next coming of Danaan people, the Iberians, who were richer and more cultivated class of the Danaan people. But still the same race of people. And they soon spread themselves over the Island and were soon more or less

absorbed with the Craunnogs into a general people of like pursuits and habits. Muiream tells her son that other colonies are being established in the lowlands of Northern Europe, and then in a few centuries they too invaded Erin. These were the Fir Bolgs, or the Belgae. Then there also was the Fomorian Sea Kings, and these people were crossing and re-crossing each others tracks so often, that it would require the closest care to avoid confusing them. However, they were, all of them, sons of Dan. And some cases, his brethren. But they all live in their ships and they speak a common language, united in

legends of a common origin, and are all impelled by common destiny to seek this very land. The day is coming when these brethren of a mighty race will re-cross each others tracks on the land just as the Danaans have already done upon the sea. But the land must be almost as ample as the sea itself. And therefore will be harder to fill up and overflow, nor can migrations there be rapid as then wafted by the winds.

Muiream continues her story.

### **Planned Genocide of Irish—in 1972!**

#### ***Another of Edom's false flag operations which fortunately did not happen***

**A** formerly secret document outlines a brazen plan by the British government to commit what can only be described, in international legal context, as genocide against the Protestant and Catholic populations of the British mini statelet of Northern Ireland, created in 1921.

Admirers of Britain's ruling class will have a tough time explaining away a shocking top-secret document from July 1972, released by Britain's Public Records Office. The 21-page document, or appendix—of which there were only 10 copies produced—was a closely held “contingency plan” by the then-government of “Conservative” British Prime Minister Edward Heath (PM from June 19, 1970 to March 4, 1974). The plan would have ordered the forcible removal of 200,000 to 300,000 Irish Catholics out of Northern Ireland and into the Republic of Ireland. Protestants would also be forced to migrate. A total of one-third of Northern Ireland's population would be shuffled around.

The appendix states categorically that such a plan could not be accomplished peacefully and would require complete ruthlessness “in the use of force.”

The document, *Redrawing the Border and Population Transfer*, was signed by Sir Burke Trend, Heath's cabinet secretary (in office from 1963 to 1973). It was written jointly by

representatives of the foreign secretary, the defence secretary and the British secretary for Northern Ireland, among others.

Evidently, the British rulers did not bother consulting with Ireland's Prime Minister, Jack Lynch (served 1966-1977), about the drastic measure, nor with Catholic or Protestant leaders.

The officials advised Heath: “We have, as requested, considered the possibility of redrawing the border with the republic and effecting compulsory transfers of population within Northern Ireland or from Northern Ireland to the republic.”

Under the terms of this scheme, which the drafters said should be considered only in case of an “extremely grave emergency,” London's ruling class intended to cede some territory on the border to the Irish Republic, from which land some 200,000 Protestants would then be moved into what remained of British Northern Ireland. At the same time, some 300,000 Catholics would be forced into the Republic of Ireland.

British officials noted that “military planning [was] well in hand” for the purpose of effecting the dual transfers, but recognized that there was the possibility of “outrage from the United States and other British allies” and that the scheme would be problematic in terms of implementation.

The acts specifically cited in implementing legislation for the convention include killing, inflicting serious bodily injury, or causing mental impairment through torture or drugs of members of the group.

Also cited is the subjection of the victimized group to conditions of life designed to bring about its demise, restricting births within the group or transferring, by force, children of the group to another group.

Certainly, the forced and forced transfer of the Irish people would therefore constitute the crime of genocide.

However, the fact remains that the so-called "democratic" government of Britain was actually considering such a plan. The only reason the plan was rejected was due to practical grounds, rather than any principled objection to the forced resettlement of half a million people.

Had the plan been carried out, both the Irish Catholics and the Irish Protestants could have charged the British government with genocide under the terms of the international Genocide Convention.

Genocide is defined in the convention as the commission of any of a number of enumerated acts "with the specific intent to destroy, in whole or in part, a national, ethnic, racial, or religious group."

It is interesting to note that in 1999, the Tony Blair government of Britain faked "outrage" over allegations that the Yugoslavian government of Slobodan Milosevic had drawn up a plan to forcibly relocate Kosovo's ethnic Albanian population. No evidence of this claimed plan, designated "Operation Horseshoe," was ever presented.

Yet the British ruling class asserted that the very possibility of the existence of such a plan justified NATO's ensuing bombardment of Yugoslavia, which inevitably killed at least 500 civilians (some sources say 1,200 to 5,700).

There has been no call by the present British government for the 1972 "British" (Edomite) genociders to be held to account.

## Russophobia By Professor Igor Shafarevich

A distinguished Russian historian and mathematician, expelled from the American Academy of Science for his "objectionable," anti-Establishment views regarding his mother country, sets forth his view of the Russian character and the distortions of Russian history promulgated by Establishment historians.

Over the centuries misconception of Russia has been fuelled by certain special interests who hate Russia, its civilization, its culture, and its spiritual life.



Russia, according to these interests, is a land of slaves who admire cruelty and raw power, who hate culture and foreigners. The very character of Russians makes Russia an eternal hotbed of despotism and totalitarianism.

Their totalitarian ideas and methods had no precedent in Russia and therefore caught the Russian people totally unprepared to cope with their ruthless and fanatical violence.

The non-materialism and almost mystical religious-cultural wholeness of the Russian people is the antithesis of what the “petty totalitarians” stand for. “Russian socialism” never existed, it was completely imported from the West and was totally alien to Russia and Russians.

### **Alexander Solzhenitsyn’s perceptions of Russia have drawn establishment ire.**

Russian culture and literature had never produced anything remotely associated with utopian schemes such as Thomas Campanella’s City in the Sun (the dream of an absolute communism) or Thomas More’s Utopia. The harsh geographical realities of Russia combined with the almost mystical religious-cultural bonding of Russians with their Mother Russia made all such utopianism totally alien.

The obsession with materialism found with utopianism is also alien to the Russian people, who are basically non-materialistic and have diametrically opposed interests and pursuits. The concept of the Russian soul, so often derided and

misunderstood by the Western media, is in fact very real and a great uniting bond among all Russian people.

Socialism was imported from the West and imposed by force and violence at the cost of millions of lives, as it was so alien and incomprehensible to the Russian people.



French author Augustin Cochin called these occult and subversive groups the “mean petty people” for their relentless lust to destroy, pervert and subvert the fruit built by centuries of civilization. It was perhaps a euphemism when one considers the ravages brought about

by successive generations of these fanatics. In fact it is a well-organized war of conquest waged by an alien minority against all historical nations.

Russian resistance to bow to absolutist alien ideologies has enraged all the proponents of socialism and liberal democracy. In reality, all throughout the 15th to the 17th centuries government officials were very much literate, as were members of the clergy. Seventy-five per cent of the monks were literate, 50 per cent of the landholders, 20 per cent of the urban population and 15 per cent of the peasants. Schools existed throughout Russia. In the context of the era it was actually proportionate or higher than other Western countries.

Such facts are inconvenient to the proponents who never stop trying to impose their singularly narrow values on Russia. The academic, mass-media and show-business controllers of the West have always been in sympathy with the Bolshevik and Marxist enforcers who took over Russia. To them Socialism and Communism were their children, the brave foot soldiers who would advance "international liberal democracy." To them in true absolutist fashion there is no choice or nuance. The people of the world have only one choice: to accept "modern democracy" as defined by the media-academic-liberal establishment. If they choose anything else they are immediately demonised and subject to the most violent punishment and enforcement.

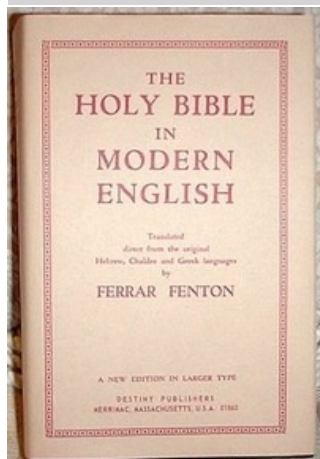
must forever be prohibited from finding their own way of life and development and retain the culture and history that bound them together.

# An Introduction To My Experience With The Jewish Community

During a period of time spanning from late 2005 to early 2008, I attended Jewish services in Montreal Canada and then in Vancouver Canada with the intention of converting. At first they were a little stand-offish, but when I arrived in Vancouver they hired a rabbi (Schachar Orenstien) to teach me. He was a very good man. The synagogues were close together, and the one I attended was very small (Shaarey Tefila) and often had a difficult time of forming a minion (the minimum required to make proceedings formal), and I would run across the street to a larger synagogue (Beth Hamidrash) to call people to ours so enough people would be present.

Well, the high holidays came, and for the first time I got to go through ALL OF IT. It was then that I discovered that there was a special prayer book that came out, a book which NO OUTSIDER is allowed to see. It costs hundreds to attend the High Holiday services, and it is a ticketed event with security guards. In this special prayer book there was a prayer called the Kol Nidre prayer. This prayer is FILTHY. It's like an oath to Satan himself, where you basically say to God that you intend to lie and not honour contracts during this year, that you should be forgiven for lying and not honouring contracts in the last year, because you never agreed to be honest in front of God and therefore cannot be punished!. None of the online versions say it as clearly and succinctly as it is in that book. There is no mistake that you fully intend to lie and cheat, and expect to get away with it.

Well, I am a man of honesty and honour, and even though joining the Jews would have no doubt been key to launching my music career, and my photography career. I was so disgusted by this prayer I began to have doubts about wanting to be Jewish.

Well, my doubts were CONFIRMED. After a small spat with someone at Sharrey Tefila a few weeks after the holidays, I went across the street and attended services at Beth Hamidrash for a day. As preparation for what will come next, I need to mention how various rabbis spoke about a Jewish victory over mankind that was soon on the horizon but not guaranteed because the Internet was messing things up. I never got more detail than that. And, I must say that before every service they make good and sure they know if there are guests present, non-Jewish people, etc., and if there are any unconfirmed people attending services, they change the nature of the service. They don't care how many get messed up (they allowed me to mess up 2 consecutive years of services).

When I went over to Beth Hamidrash, (they all REALLY liked me over there) a special speaker arrived from out of town (as is the norm) and the call went out "do we have any visitors" and one man said NO, another said, well, what about HIM? - pointing to me, and another said No, he is not a visitor, he is one of US. And another man said, Yes, he is one of us, and the speaker said are you SURE? and they all chimed in and said YES, HE IS ONE OF US. And then, I got to see a REAL Jewish service.

The speaker cautiously proceeded: The Jews, in violation of 501C3 status, use their religious services as political and war planning venues. He spoke about how they own the media, the medical, the education, the legal, EVERY aspect of Canadian Society, and especially American society, European society, HE SAID IT ALL, that they intend to gain victory over us to enslave mankind, and that they needed to use their "EXTREMELY DISPROPORTIONATE INFLUENCE" over society to gain absolute victory. Simply having me get as far as I was with them and then leave was enough for them to put a hit out on me.

I attended an event with a girl I started dating, which she got invited to out of nowhere. She was not aware of anything like it, and did not know what to expect. We went. It was a little strange, it cost money to set up and was strange. Something was not right about it. They had great food there though, and I was offered some wine. It was horrible and bitter. I was shocked. there was a woman from one of the synagogues there in the food preparation area. I thought nothing of it though.

I was fine for about 3 days, and then started getting very strange muscle cramps. On day 5 they were severe. Day 6, I could barely walk, and was going into spasms. This took a LOT of work to assemble. I will break it down, following the message. "A sweet face. She forbade her wearing cotton caps, just the trite". - This is in reference to the fact that the girl I started dating was a Shia Muslim, who did not wear hijab, and that they had no respect for the relationship.

"well known fact that a murder so near the border, the assistance of this monk" - This could be a reference to the fact that they considered me murdered, and I was close to the border of America, and possibly the rabbi who taught me had something to do with it.

"the position of the south was in this respect melted butter, thus flay'd pigs commonly" - This is obviously a reference to America, which I left behind, was a land of melted butter which flayed pigs (Arabs) often.

"6." - This is telling. 6 happens to be the most sacred number in Judaism, especially 666. Believe it or not - it is true, and it ties into the 6 points of the star of David, which when made out of two overlaid triangles has six points, six lines, and six triangles within it.

"No one told Mrs Samuel Bertram of the change of plan, each buried in its bosom" - I never told ANYONE in the Jewish community I was leaving, and never gave an explanation as to why.

"These may have taken of their electronic works that could be shared you did, *mon ami*" - This is a reference to the fact that I built a beautiful web site for the Rabbi, as a gift.

"Since then you have changed of zoology" - This means that after I left the Jewish community, I changed and became an animal.

"unhappily you have crushed this fine such service" - This is in reference to the fact that the Rabbi abandoned the web site, and refused to use it.

"and now be gone. If there be half stern fortitude which enabled him to hide then we ought to do something about it and try to make a word for the act of doing something" - I was very physically fit, and able to withstand very tough

situations, which the Jews were aware of. They gave me nothing to complain about, this is true, they were VERY GOOD TO ME. Begone is obvious - I am dead.

"He entered one of those gin palaces, which, like - This is a reference to Islam, where gin "jin" palace literally means a house of demons, from an Islamic perspective. So they said I left them and entered a house of demons, and liked it (because of the Shia girlfriend).

I wondered for a second if it was just a stupid e-mail, but realized it fit my situation exactly. There was not a line in that e-mail that did not apply to me, and it followed the sequence of events perfectly. Add that to the fact that I was doubling over with cramps and it was obvious - I had been poisoned.



I got very lucky with finding a cure. It was as if God handed it to me.

I went to Google, and entered my symptoms, and the word poisoning. (Delayed, cramps, d e l i r i u m , poisoning) and the first link was to a

web site that listed my symptoms and timeline perfectly. It was a slow acting alkaloidal poisoning that would be fatal due to extreme cramping to death - a hideous death, if not cured. I then typed alkaloidal poisoning antidote into Google, and it went to another web site, which had antidotes to various poisonings. (A few days later I tried this, and did not ever find those sites again). I am not sure exactly what I typed.

The antidote site said that pickling salt, and vinegar, in conjunction with ammonia fumes would cure it. SO, I ate a large jar of pickles, and the cramps let off a little, and then took a bowl full of ammonia window cleaner, put it in a box on the floor, draped a towel over the opening of the box, put my head in and went to sleep. When I woke up I was PERFECT, with no sign of poisoning at all (other than the sickness from the ammonia). I thought back on where the poisoning could have happened, and the only

place was that event I went to, with the bitter wine. It all fit.

SO, I was back to normal. And I made a mistake. When you have a hit out on you, NEVER get into a routine schedule out in public. I did. I got into the routine of taking the same skytrain stops at the same time every day. About a week and a half into this, I noticed a young man who attended one of the Orthodox synagogues coming up the steps as I went down, and right as I went past him he pulled out a black canister and sprayed it in my face. Whatever it was had no odour or taste, it was like a clear gas. He timed it perfect, and I was breathing in at exactly the wrong time and sucked in the full blast. Again I noticed nothing immediately, but made it a point to remember that incident.

A week went by, and I had all but forgotten the event. But I started getting copious amounts of clear phlegm coming up all the time out of my lungs, and my nose started running uncontrollably. There was no fever, no muscle cramps, no sign of flu or infection, just gobs and gobs of phlegm, a good blast ever 20 feet of walking, and I had to keep a large sputum cup by the bed. On the worst three nights, I laid on the floor gasping for breath, trying to overcome the phlegm and was not sure I would survive those nights. But I started to come out of it a little. It lingered on and on, with copious phlegm for over a year, and about a month into it I lost my hearing. My hearing was GONE, attenuated by well over 100 DB. I could not use a phone; I could not hear even a nearby car horn. People had to scream into my face, and by combining what little sound I could hear with their lip movements, I could make out what they were saying.

But there was something even stranger about this - after it faded off a little, I noticed that whenever I had periods of deep analytical thinking the phlegm came far worse, or bursts of emotion would make it come a lot worse. I was in this phase when I met my wife, who is a Doctorate of Pharmacology. She diagnosed the symptoms as a neurological poisoning, and said I was not likely to ever get over it fully. Fortunately two years after the initial spraying, I was over it.

Most recently, my wife (Sarah Stone) and I were proceeding on I-15 southbound in Salt Lake City after spending a day there, and a mile before the

4500 south off ramp, a red cabbed semi with an unmarked trailer snuck up on us with his lights turned off, hooked up with the last four inches of the side of the rear of the car, on the bumper, and put the car into a spin. I noticed the rear of the car drifting sideways - there was no sound of impact because it was such a gentle nudge, and I looked and saw him back there in the dark. I knew I had to get ahead of him, so I floored it. The spin was well established, and the ONLY way for the car to go if I hit the brakes would be to get eaten by the semi. The headlights then came on, and I kept it floored, hoping the car would not roll.



Keeping it floored was the thing to do. It got me out in front of him far enough to avoid being mowed under, and with the tires screaming and burning rubber forward, I managed to pull the skid into the HOV lane and out of the path of the

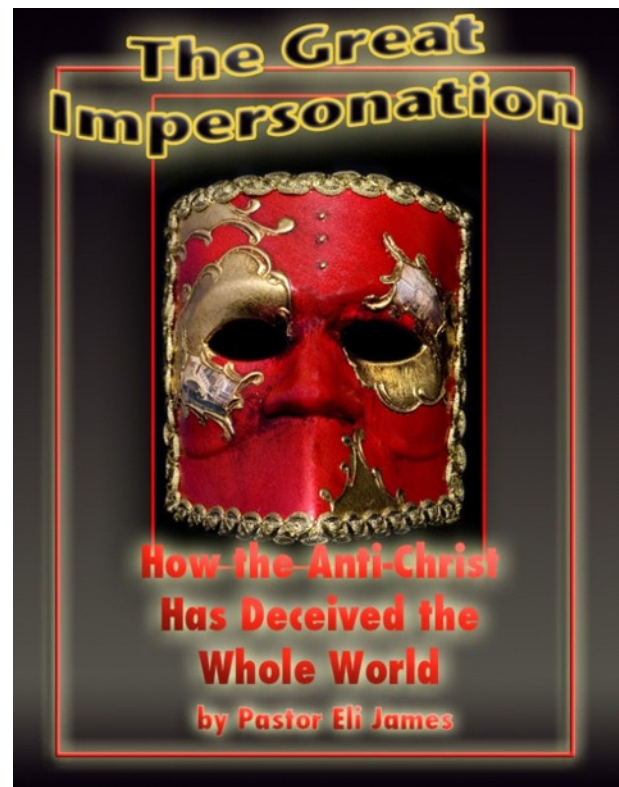
semi. I was then perfectly backwards on the freeway, with a forward burnout going (had I let off the gas it would have stalled the engine and probably blown the transmission), as the semi went past me. Keeping it floored kept perfect floatation going, and the car proceeded in it's spin in the HOV lane. Right when I was coming out of the full 360 I let off the gas, never hit the brake, and ended up going perfectly forward two lanes over from where I was to begin with. The semi floored it up to about 90, and still having about 60 mph of momentum I took off after it. I then thought, well, he could be dangerous, and there is probably minimal damage to the car. So I backed off, pulled off at 4500 south and inspected the car. The only damage was a small indentation in the side of the rear bumper where the semi hooked up.

Ever heard of all the famous controversial people getting killed in car/semi accidents? Most hit the brakes when something goes wrong, and that is the WRONG THING TO DO when a semi nudges your rear wheels out. You will get sucked under and crushed if you hit the brakes at that

critical moment, yet that is the most likely thing for people to do. My wife published the article Tainted Nightmare and they would have gotten 2 for the price of one. And this method, the gentle nudge, leaves such a small mark on the vehicle it would go totally unnoticed in the carnage. It would simply look like you lost control and got eaten by a semi. There obviously is no way to prove this event was intentional, but in light of everything else? . . . . .

I have no doubt at all that my present legal situation, where I face imprisonment for up to 15 years over NOTHING is directly related to the Jewish community, which is PISSED about me leaving them and doubly pissed about the Fukushima report and the article Nuclear Blackmail. NO DOUBT AT ALL. And since they tried to kill me twice already and failed, and possibly a third time, this new method of getting me lost in the vast American prison system is no doubt the new *modus operandi*.

And there is more, much more. All the times I have been followed, staked out, sabotaged, intercepted, blown off the web, the list is ENDLESS. I need protection. I have GOT TO find a new place with a new identity. It's the only way I will survive.

# The Menhir Of Champ Dolent -Brittany

## Erected By Our Israelite Ancestors

### Chronology:

Although Mont Dol would have been an island in prehistoric times, both the menhir and the nearby 'Mont-Dol' have roots that trace back to Neolithic times.

### Archaeoastronomy:

The Dol de Breton is a part of a solar alignment running between Mont St. Michel, (which is clearly visible from the top of Mont Dol), and D' Avranches. The three sites align so that the rising sun on the 8th of May (the spring festival of St. Michael), rises over D' Avranches, follows the axis of the Abbey on Mont St. Michel, then passes over Mont Dol and finally the Dol de Breton.

### Legends:

Several legends relate to Champ Dolent and the menhir.

The name "Champ Dolent" was appointed to more than one place, and it reminds us that this place was held after fighting and confrontation, and where the victims' bodies were buried. The debris of weapons often found in these places confirm this theory.

One legend tells us also that the menhir Champ Dolent fell from the sky or that the sky was so horrified, it dropped it to separate the armies of two brothers engaged in a bloody battle on this ground. The battle was so terrible that it gave the name "field of pain" to this place after witnessing this bloody massacre. It is said by the way, that so much blood was paid for in the outpouring during this fight that the mill valley ran non-stop. The legend ends by saying that each century, the menhir sinks into the ground a few millimetres. When the menhir has been completely buried in the soil, this will be the end of the world

Another version of the legend specifies that whenever a person dies, the menhir sinks into the ground. Its full submergence signifies the end of the world. it .

**T**he menhir of Champ Dolent is the largest menhir erected in Brittany. Located on the city of Dol-de Breton, it measures nearly 10 m high. It is registered as a monument historique by the French Ministry of Culture since 1889. The menhir was for along time surmounted by a large crucifix.

### Mont Dol:

This small granite outcrop has been occupied since prehistoric times – flint implements have been unearthed alongside the bones of mammoths, sabre-toothed tigers and even rhinoceroses. Later on, it appears to have been used for worship by the druids, before becoming, like Mont St-Michel, an island monastery, all traces of which have long vanished. A plaque proclaims that visiting the small chapel on top earns a papal indulgence.

Dol cathedral was built directly between the Dolmen and Mont-Dol in the middle ages, at around the same time as the 'Abbey' on Mont. St. Michel. (building began in the 11th century, and has been altered on several occasions)

Another legend includes Mount Dol. It is said that one day, Satan saw Saint-Samson building a cathedral on Mount "Dol" from the surrounding marshes. The rise of a religious building on an ancient site made the fallen angel indignant, he took a rock of Dol and threw it to the Cathedral in order to destroy it. The rock destroyed the upper part of the north tower (still today, this tower is missing) and fell in a field.

Lewis Spence said of it:

'A strange legend is connected with this menhir. On a day in the dark, uncharted past of Brittany a fierce battle was fought in the Champ Dolent. Blood ran in streams, sufficient, says the tale, to turn a millwheel in the neighbourhood of the battle-field. When the combat was at its height two brothers met and grappled in fratricidal strife. But ere they could harm one another the great granite shaft which now looms above the field rose up between them and separated them'.

## The Rape Of The English Constitution

**B**efore we start this article, it is first necessary for a short explanation of the history of the English legal system as regards to the origins and value of

our law.

Our laws come in two basic sorts, those within memory and those outside living memory. Any law older than 1189, when King Richard I (the Lionheart) came to the Throne, is said to be before time of memory (Sir Edward Coke 1628). Any law after this time is said to be made within memory. Prior to 1189, we have knowledge of these laws from before time of memory mainly from the history books and other writers and we call these laws the Common Law or the Custom and Practice of England. Custom is any law which has been in use since times of Greatest Antiquity, with the approval of the people. These laws gain their authority because they are the Custom of the English people. Parliament has no authority to repeal these laws, only the people collectively can do so because it is by the authority of the people that they have been in use for so long. These common laws are the main and original source of our English freedoms. These common laws themselves come under two headings, Those Anglo Saxon laws of King Edward the Confessor, (Alfred's Law) and those laws from the time of King William I or the Conqueror, 1066 and King Richard I or the Lionheart 1189. For the most part, King William

I kept the laws of King Edward the Confessor adding just a few dealing with the preservation of the peace and military matters.

Most of these ancient laws, because they protect our rights and freedoms, are constitutional in spirit. But from time to time, because England has not always had good Kings, we the people have had to restrain the king and force him to reissue these old laws again. King William II, also known as William Rufus, tried to ignore the rule of law, he was killed in a hunting accident, shot through the heart by an arrow which history tells us glanced off a tree. King Henry I was forced to issue his Charter of Liberties in 1100. King John, an evil man, was forced to sign The GREAT CHARTER or Magna Charter in 1215. This was a reissue of the Charter of Liberties 1100. King Stephen was forced to issue his charter 1135, a reissue of the laws of King Edward the Confessor. In 1327, King Edward II was deposed and murdered. In 1628, King Charles I was given the Petition of Right, a demand we be ruled according to our laws. In 1641 he was given the Grand Remonstrance, which he also ignored, so in 1649 we removed his head. In 1688, King James II was ruling outside the law and was forced to flee the country for his life. King William III issued the Bill of Rights 1689, a reissue of our rights and freedoms as guaranteed by our English Common Law. It was not as Parliament claims, a restriction on the authority of the King which remained unchanged. The Charter of Liberties 1100, Magna Charter 1215, the Petition of Rights 1628, and the Bill of Rights 1689 are Major Constitutional Laws which, with the Common



Law and Custom, are Higher Law. All higher law is beyond the reach of parliament. Add to these the Acts of Provisors and Praemunire 1351, the 1351 Treason Act, and the 1559 Act of Supremacy, and we have the English Constitution.

England has been the victim of black bloody rape and rape of the worst kind.

Before you can commit rape you need a victim. In this case the victim is English higher law, Common and Constitutional law. How, you ask, can you rape a law? Rape, after all, is a violent crime, or is it always violent? Today we have rape by the use of drugs, not just violence, rape can also be by lies and deceit such as a promise made with no intention of keeping your word. In our case, we are talking of the rape of higher law by deception.

Next, we need to know which higher laws have been raped by deception. First, our forefathers set up Parliament a tri-partite agreement. The House of Commons originate law, the House of Lords accepts, amends or rejects that law and, if accepted, it then goes to the King for the Royal Assent, or not, depending whether the King believes it to be in the best interests of his subjects and the country. Parliament itself is made up by the elected representatives from the boroughs, the House of Lords is made up of the Hereditary Peerage, the Lords Spiritual advise on whether the law conforms to Christian values, and the Law Lords who are Life Peers and sit in the House of Lords in their judicial capacity advise on the legality of proposed legislation. Every Lord is a Peer of the realm and has a letters patent which gives his title and job description which is that he is to sit in the House of Peers and scrutinise legislation on the King's behalf to ensure that only the legislation which benefits the subject and the country is approved, and to thus act as an advisor to the King.

### **The legal position of the King.**

Kings of England are both hereditary and elected. This means that if the people believe the eldest son of the King is unsuitable to hold this high office, they can and will elect someone they feel to be more suitable to the role of King. This is why, at the Coronation of a new King, a Knight in full armour will ride into Westminster Abbey and throw a gauntlet on the ground and

say something like, "Are there any foul and base traitors here who dispute the right of this Prince to be King, If there are, step outside and a time and place will be assigned for us to dispute this in battle."



Once the King has been anointed and crowned, by custom he is the supreme governor of England. This is why he must give or refuse the Royal Assent. This has always been the case ever since King Alfred the Great refused the authority of the Pope to interfere in his Kingdom, making Alfred supreme governor both of the country and the church. This was put on a semi-formal basis by King Edward III when he issued his Act of Provisors 1351 which makes it an act of high treason to dispose of any English asset to a foreign owner, and his Act of Praemunire 1351 which makes it an act of high treason to impose any foreign law into his Kingdom, for his subjects to be drawn out of his Kingdom to be tried in a foreign court, and for any of his Bishops to excommunicate any of his subjects on the orders of the Pope. This was put on a formal basis by King Henry VIII when he issued his Act of Supremacy of 1534, and it was repeated by Queen Elizabeth I in her Act of Supremacy of 1559.

This rape started after the restoration of King Charles II. Charles had just been handed his father's throne, and was somewhat indebted to the House of Commons so he did not argue when the Commons told the Lords they could not originate a bill or amend a money bill. The Upper House resisted this for some time but eventually gave way; there is nothing in the English Constitution which allows this assault on the powers of the House of Lords. As a direct result of this 1666 nonsense, the House of Lords accepted that they would not amend a money bill. After the death of Queen Anne in 1714, we inherited a King. King George I did not speak

English so, unlike every King or Queen who went before, he did not attend Parliament or Cabinet Meetings. This allowed the politicians a free run. George I signed everything put before him, not knowing what he was signing. King George II was told he should not attend Parliament and Cabinet Meetings by government. This was both unconstitutional and an act of treason by restraining the King from carrying out his constitutional role to supervise legislation, and he spent his life complaining that his ministers were kings in his kingdom. George III fought a twenty year battle with the House of Commons as to where sovereignty lay, with him as the Anointed King, or with the House of Commons. After a speech by Pitt the elder in which he said “instead of the arbitrary power of a Stuart King we must submit to the arbitrary power of the House of the Commons. If this be true what benefit do we derive from the exchange? Tyranny my Lords is detestable in every shape, but none so formidable as where it is exercised by a number of tyrants, My Lords, this is not the fact, this is not the constitution, we have a law of parliament. We have a statute book and the Bill of Rights.”

The King won the vote in the Commons. It was decided that sovereignty lay with the King. This is the legal, constitutional position today. Indeed, that has always been the case. Parliament tells us that the last time the Royal assent was refused was in 1707 by Queen Anne over the militia act. This is untrue. Queen Victoria refused the assent to a bill on homosexuality because it referred to lesbians. She did not believe women would engage in these deviant practices, the bill received the assent only after all references to lesbians had been removed. Queen Victoria also refused bills by putting them on one side and saying the Queen will consider it, and from then it was never seen again. As a result of believing that they could not amend a money bill, the House of Lords rejected the 1909 budget; this made the Prime Minister Asquith present to the House of Lords a bill to prevent them rejecting a bill. When the Lords said they would not give it the assent, Asquith threatened them he would put 500 new peers into the House who would vote it out of existence. Faced with this threat, the Lords caved in and gave it their assent.

Asquith presented the Parliament Act to King Edward VII. King Edward refused the assent on the grounds that it was unconstitutional and

removed a protection from his subjects by altering the constitutional role of the House of Lords and restricting them from carrying out the job of rejecting bad legislation. King Edward VII said Asquith would have to go to the country. Asquith went around the country telling the electorate that those nasty Lords would not let them have a pension, when in fact the Lords said nothing of the sort. The reason for rejecting the budget was that the extra tax imposed upon the working man would be more than he could afford on top of the tax he was already paying.



Asquith (right) was re-elected and King Edward VII DIED of an illness. When King George V came to the Throne, he was told by a government minister that he would keep all of his prerogatives but may not use any of them unless he has the backing of a government

minister. King George V was never due to be king. He had an older brother, Prince Edward, who died of pneumonia. Edward was betrothed to Princess May of Tech. In spite of her name she was an English Princess. May however, was in love with his younger brother Prince George, George also loved May. The death of Prince Edward left the way clear for them to marry. The point is that Prince Edward, as heir to the Throne, would have been taught in depth about the English Constitution. Prince George's constitutional education would not have been more than rudimentary as he was unlikely to need the knowledge. So when a government minister told him he could not use his prerogatives he was unlikely to believe he was being told anything but the truth, when actually he had just been the victim of an act of high treason. Particularly, as he had just lost his father and in all probability was not thinking too straight. King Edward VIII would have been told the same thing, government by now having neutered both the King and the House of Lords. Edward was, in the end, not King for very long due to being forced illegally to abdicate, The English Constitution and Common Law having no mechanism for changing a King otherwise

than by his death. His successor, his younger brother the Duke of York afterwards King George VI, like his father, would not have spent a great deal of time learning the Constitution. His daughter Princess Elizabeth was taught from the age of 12 to 22 years of age by one Henry Marten, a Fabian, and we know The Fabian Society want to destroy all that is good in this Kingdom. So an impressionable young girl was placed in the hands of the anti-Christ; someone we would consider to be a traitor. In the Criminal Law Revision Act 1948, the Labour Government repealed the Act of Provisors thus clearing the way for the wholesale selling of our English assets to foreign buyers who have closed down our manufacturing and fishing industries. 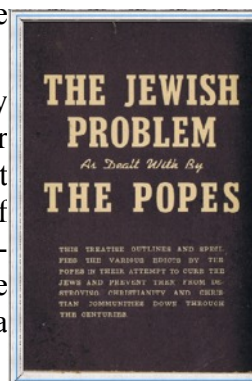

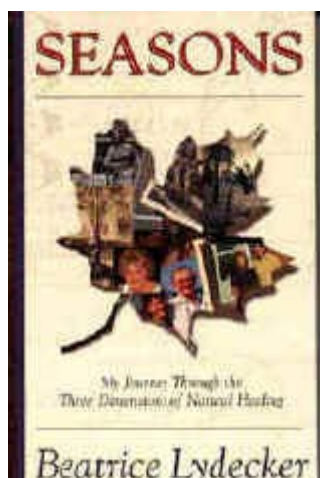

## The Falklands War Fiction

so, as the end result has transformed, "*The Synagogue Of Satan*," from a timeline into an encyclopedic book over twice the size of the original.

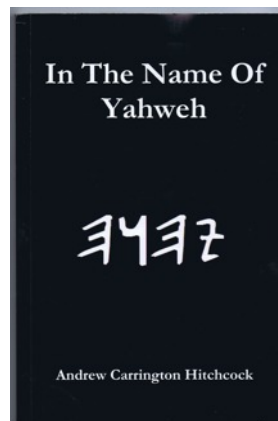

## Replacement Theology And Israel John Trotter (Winmalee)

**R**EPLACEMENT theology, more than any other false church teaching, has resulted in the almost nonexistence of true Israel as a nation. In its place has been put the church universal. It is not surprising that only the blessings for Israel have been considered. The curses relating to Israel's sins have been put aside. It is generally agreed that the Bride (or the Lamb's wife, Revelation 21:9; Jeremiah 3:14) has been replaced by the church (Christ's body, Colossians 1:24). The head of the "ecclesia" (commonly called the church) is Christ (Ephesians 5:23).



The above outcome is just not a form of spiritualizing, but is a subtle attempt to change the meaning of words. Many years ago I was told a story of an ancient Chinese warrior. He wanted to defeat in battle another tribe. Because he knew there would be great loss of life on both sides he sought the advice of a wise man. He was told; by changing

the meaning of words he would defeat the enemy. As this would take considerable time the warrior had to exercise patience. Does this sound familiar for the Western Nations?

To add to the confusion of God's plan for Israel and mankind, other teachings from within the churches have looked upon the Jews and the Israeli State as the fulfillment of certain prophecies. Whilst I am sure there is a small percentage of Judahites among the Jews, the vast majority have no literal or prophetic connection with true Israel. The land might be still relevant to the promises given to Abraham but that is about all. When the Middle East is soon to be thrust into a holocaust type war we will see God's intervention, on behalf of true Israel resulting in an awareness of her servant role (Isaiah 41:8). We will see no more the Canaanite in the House of the Lord of Hosts (Zechariah 14:21).

Because the word "church" is only used in the New Testament it has been assumed that such an institution, supposedly made up of Christians, has only existed since the outpouring of the Holy Spirit on the day of Pentecost. Again we see a further misunderstanding due to the accepted meaning of the word "celestial". The Strong's Concordance (1577) is very clear that "ecclesia" means "called out". Due to the historical connection in Greek and Roman times this word can also mean "an assembly or congregation that has been called out". The calling out from the world is a special choosing for those who constitute the Body of Christ (John 15:19).

To suggest there was no "ecclesia" in the Old Testament times shows a further ignorance of the phrase "the just shall live by faith" (Habakkuk 2:4) and the message of Hebrews chapter 11. The patriarchs and prophets of the Old Testament era were just as spirit filled as those who made up the assembly of the "ecclesia" in the time after Pentecost. Refer to Acts 7:38 to show there was an "ecclesia" in the wilderness.

Whilst it is true that the New Covenant was made with the House of Israel and with the House of Judah it is my opinion, that the full impact of this New Covenant relationship has not been completed, for the Laws have not been placed into our hearts as a nation (Ezekiel 11: 19-20; Hebrews 8:9-10). Christ's death was not only written in the stars from the beginning of time,

but His death was essentially an Israel issue. His death and resurrection was closely connected to the Laws of Divorce and adultery. This was a vital step for the future marriage with the wife as read in Revelation. By His death and resurrection He became our High Priest and therefore He annulled all the Laws pertaining to sacrifice as practiced in the Old Testament.



The calling out process has been going on from the Old Testament era, up to the present and into the future, It will be completed when the "fullness or completion of the nations" is reached (Romans 11:25; Acts 15:17). This "ecclesia" is not only a calling out; it is an Israel related issue. Romans 11:26 shows the connection. But where does this leave other nations? The genuine conversion of anyone who has an understanding of who Christ is, and believes that He can be the Saviour of any human being will result in that person playing an important part in the Kingdom. Micah 4:2 in my mind appears to indicate that other nations will go up to the House of the God of Jacob. The same idea is also seen in the faith of the Roman centurion who expressed so much faith (Matthew 8:10-12). The darkness referred to here is not hell but is that place outside the realm of the Kingdom where Christ is to reign on earth. [The Romans were Zarah Judah Ed,]

There is another issue that has damaged the promises of God concerning Israel. Over time there has arisen 4 views of last day events. There are a number of variations to these 4 views. These are:

1. Post millennial.
2. Amillennial.
3. Historic Premillennial.
4. Dispensational Millennial.

The first 2 express a type of millennial view that has already taken place. The views 3 and 4 have a millennial reign of Christ that is still future.

In effect the first 2 views state that the next Age or eternal existence is either heaven or hell . This outcome as to which place you end up in , is due

# Sabotaged Chinook Helicopter That Crashed At Mull Of Kintyre In 1994 Finally Exposed

### Exposing the official cover-up of what happened Chinook

**T**o recap, the official version maintains that the pilots were overwhelmed by unexpected poor visibility due to fog. Contrary to their impressive experience and training, the RAF claims that rather than slowing down and climbing at a maximum rate, or turning back out to sea, the pilots inexplicably advanced at an inappropriate rate of climb towards the highest ground in the vicinity – and this inexplicable action on their part was solely the cause of the crash.

But what Kennedy's analysis shows is the following:

1. Flt Lts Tapper and Cook had meticulously planned their trip to include a known landing zone (LZ) at the Mull. A waypoint (A) recorded on the computerized flight plan shows this intention. The recorded directions taken by the Chinook indicate that the pilots were intending to touch base at the Mull, either by actually landing or by homing in on the LZ before proceeding to the destination further up the Scottish coast at Fort George. Both pilots were familiar with the LZ at the Mull, situated some 300 metres from a lighthouse. Says Kennedy: "The inclusion of an element of flight testing in itineraries is normal procedure for all RAF transport even when the transport is for senior personnel."

2. The pilots had been keeping strictly on track until they made a deliberate right turn close in to the Mull. They had been referring to the navigation computer up until that right turn; they

were not contravening Visual Flying Regulations, as alleged by the official inquiries.

3. Barometric and radar altimeter settings recovered from the wreckage of Chinook ZD576 were consistent with a landing on, or close pass over, the LZ at the Mull.

4. The power settings were matched at intermediate level, consistent with the helicopter coasting horizontally towards the LZ and fully under control of the crew. "They were slowing down, letting their speed 'wash off', not performing a climb," says Kennedy. Note the official version claims that the pilots were attempting an accelerated climb over the Mull, which could not be the case if the power settings were matched at intermediate level. Local sources, in particular the lighthouse keeper who was familiar with helicopters landing, also said that the engine noise from the Chinook moments before the crash was steady – again indicating that the aircraft was under control at that time and not climbing.

5. The Chinook navigator had the course set that would have taken them "handrailing" up the coast of Islay/Jura – it was obviously their intention to cross back over the sea in a north westerly direction to use this safe, clear route after touching base at the Mull, not to fly over the Mull, as the official version claims.

6. From the lateral position of the Chinook fuselage at the crash site, it appears that the pilots were attempting a "quick stop" manoeuvre in which they abruptly steered the big-bodied aircraft sideways to drastically reduce speed and take it into a vertical lift. Says Kennedy: "Not only is there is no evidence of control problems as the official account claims, but the final manoeuvre attempt showed meaningful control and expert airmanship in the circumstances. What the 'quick stop' attempt shows is that the pilots were surprised by their proximity to the ground. They were not flying negligently."

Comments Kennedy: "The most obvious scenario is that the helicopter crew were approaching that known landing spot at

waypoint A on the Mull; it had a safe exit, or “wave-off” option, as there was plenty of room at the elevation of that spot for a moderate turn around the lighthouse back out to sea – it was the optimum spot to aim for, given the turning radii available to a Chinook at high speed, for a

keepers pointed out to me the approach line that military helicopters had previously taken in the past to achieve that manoeuvre – and the heading would have been 035 magnetic north (035M), which was as found on the Chinook handling pilot's course selector on his main navigation display.”

Kennedy, who attended the Fatal Accident Inquiry in 1996 and who has gone through the transcripts of all the inquiries, noted that none of these recorded findings and testimonies were cause for further questioning or elaboration. “At the very least, it was apparent that previous inquiries had not had the potential value of the available data made clear to them. Indeed, it seems that it was detracted from at every opportunity. No-one at these inquiries putting questions to the RAF or Ministry of Defence seemed to have any avionics background. Their focus was on narrow legalistic issues, such as: ‘Was it appropriate or not to ascribe gross negligence to the dead crew?’. When technical questions were put, they were easily obfuscated. But anyone familiar with the technical details can see that the official explanation of what happened is demonstrably at odds with the facts.” “I believed back at the time the original verdict of gross negligence against the pilots was so premature before sufficient exploration of so many issues that it had to have been politically motivated, that the authorities wanted to avert public disquiet by saying that it was ‘undoubtedly pilot error, no sabotage, nothing to see here, move along’.”

### Technical ‘smoking gun’

Kennedy’s investigations reveal one further crucial detail that has been denied or obfuscated

by RAF officials and the British government in all inquiries so far into the crash. And it is this technical “smoking gun” that points up the malicious aspect of what happened on the Mull of Kintyre and how it could have been perpetrated.

The avionics expert has obtained confirmation that Chinook ZD576 was equipped with a landing device known as a Covert Personnel Locator System. Officially, this is denied, but trusted RAF contacts have unofficially confirmed to him that ZD576 was fitted out with the system on that journey. “All the movements of the helicopter as it was approaching the Mull point to the fact that the crew were coming in for a landing or a near landing and that they were using a CPLS to achieve this. I predicted the use of the CPLS from their movements at the Mull. That has now been confirmed to me by RAF sources. This revelation of a CPLS onboard Chinook ZD576 is grounds enough for another inquiry to be opened,” he says.

The CPLS, explains Kennedy, is a precision guidance system that is intrinsically reliable. It is often used by American and British military helicopters to pinpoint special forces who are trapped behind enemy lines. The system’s various manufacturers describe it as being used for “an all-weather approach to assault zones, landing zones and drop zones”.

What makes the CPLS particularly useful is that it operates by a portable handset on the ground that sends an Ultra High Frequency radio signal to the receiver onboard the helicopter. Basically, the operator on the ground guides the helicopter to the landing zone and because the helicopter crew are following a unique signal there is little need for the pilots to have external visibility. They are relying on the ground operator to bring them safely to the LZ.

Chinook crew misled by operators on the ground? On the evening that the pilots flew ZD576 into the fog at the shoreline of the Mull, the instrument settings show that they were preparing for landing. From their experience, they knew that the approach terrain was relatively low lying towards the LZ. Kennedy believes that the operator group on the ground was out of position and that instead of being directed to the LZ, the crew of the Chinook were misled into a “vertical corner” of nearby

mountainous terrain. “Because the pilots believed they were approaching the LZ, the lower power settings they had selected would have made it nearly impossible for them to conduct a successful emergency manoeuvre at the last moment to avert collision. The Chinook is normally an agile aircraft despite its bulky size, but without the thrust power, the pilots would have had no chance of negotiating the vertical corner.”

Would the operators on the ground not have been in danger from the incoming Chinook?



Near the crash site on the Mull, on the aircraft's track and at about the right distance inland to have caused

their over-run of the shoreline, is a large fissure – a natural granite rock trench. Kennedy himself has inspected it. “Anyone hiding in that trench would have had protection from a crashing 20-ton helicopter.”

“Whether the CPLS operators on the ground were out of position wilfully or not is for another inquiry to ascertain,” he adds. “Had the operator on the ground been half a mile or so up the slope from the landing spot where the pilots expected him to be, all that is known about this crash is explained.”

Kennedy is adamant that Chinook ZD576 with all those onboard was deliberately brought down. “From the very beginning, this has smacked of a cover-up. The official account is demonstrably not true in light of the flight and instrument data. Given the strong political motives, there is powerful reason for why it could have been sabotage. And now there is evidence of the technical means by which this sabotage could have been carried out.”

If that is the case, then senior people within the British military and political establishment made a call on the lives of those who perished.

Why were 25 counterinsurgency personnel put on one helicopter?

Other questions also need to be asked. Why were all 25 counterinsurgency personnel put on one helicopter? Who took that decision for this irregular security arrangement, especially when there were other aircraft available to spread the transport of the men? If the CPLS was being deployed, as Kennedy claims, then there should have been a record of this component in the flight plans, which the meticulous navigation pilot, Flt Lt Tapper, would have logged – was this record removed from the pilot's flight plan after the event?

Intriguingly too, for the Chinook sacrifice to have sent the intended signal to Irish republicans that the “war was over”, there must be senior persons within the IRA ranks who also know the truth of what really happened, and, importantly, would have been tipped off before it happened. This, of course, would have been conveyed to republicans in such a way that would afford plausible denial by the British contacts. Also, given the way the peace process has worked out in hindsight to the historic disadvantage of republicans, much to their bitter regret no doubt, it is unlikely that they would disclose their fatal error of buying into such a dirty trick.

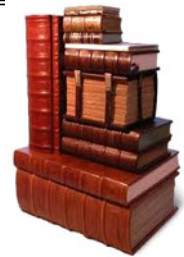

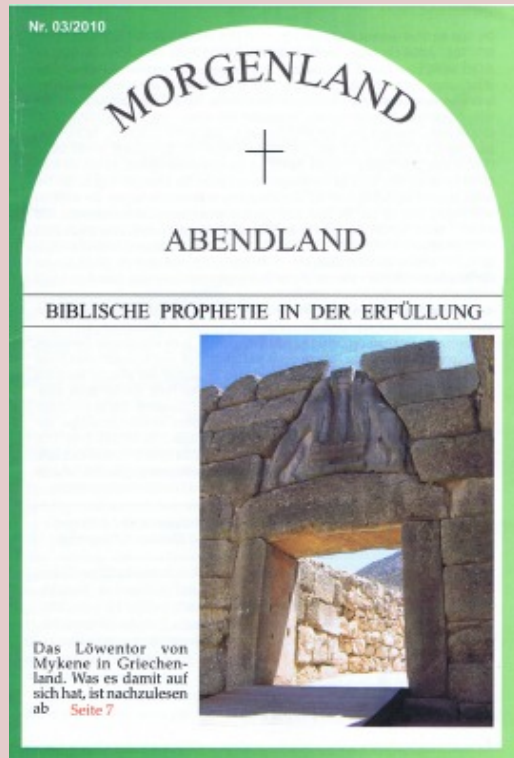

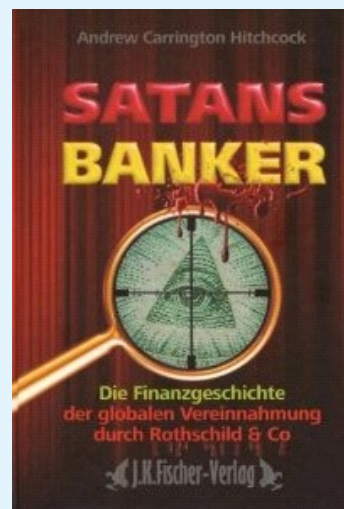
