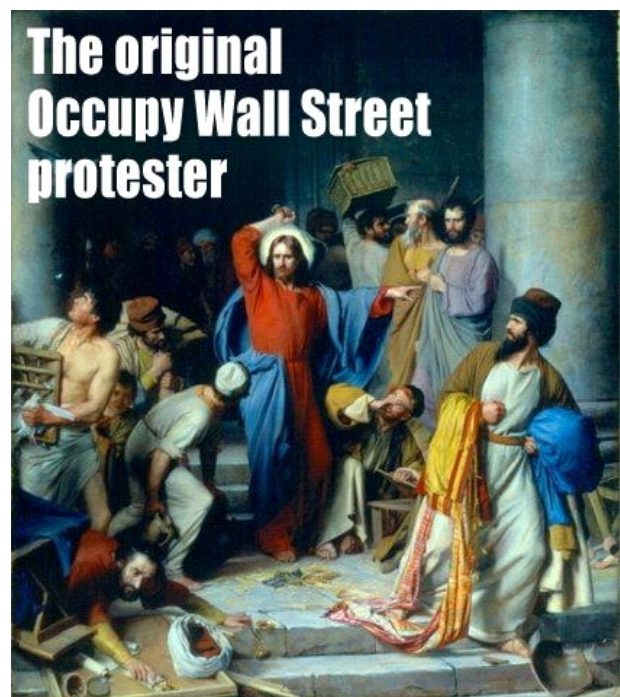

# The Numerology Of Gog And The Little Horn

## From Our South Of England Correspondent



It would probably be true to say that 99% of Protestant Christians including theologians believe that the little horn of Daniel is the Papacy. However, the scriptures would indicate otherwise, although the Papacy was and is an emanation of the “Little Horn Power”, but only in part and acting as an Aunt Sally to take the knocks from those who are not aware that the Papacy was and is a front for a far more sinister power unseen behind the scenes.

Most in Christian Identity will agree that the ten horns of the beast is Israel, representing the 12 tribes of Israel – 10 because the Levites were divided amongst the tribes while Judah was the sceptre tribe which ruled over the other tribes. Also these horns are known collectively as the whore, because Israel and Judah were put away for going after strange gods hence the term whore.

We are told each horn is a king, now a king has to have a populace over which to rule. Which of course is a very good metaphor because the beast uses the tribes as its proxy war machine to keep other nations in line and to set one tribe against another in order to keep numbers down, as it knows that it is no match numerically speaking against all the tribes.

Now it stands to reason that the little horn, must be similar to the other horns, but as its name implies, is much smaller. The only candidate to fit the description are the Edomites who now go under the name of Jews originating in the most part from Khazaria or are descendants of the

Pharisees and Sadducees of Christ’s day. Many are aware that the Jews control all western governments, but form barely 2% of the population. Hence the metaphor “little horn”. Therefore, it is not referring to one person in one place but to an alien race scattered amongst all ten tribes!

That the Jews are Gog can be demonstrated by numerology. First the scriptures need to be consulted to discover the number of Gog. We have 3 main indications in scripture:

1) Gog is mentioned exactly 11 times in the scriptures – 10 times in the Old Testament and once in the New Testament, reflecting 10 horns plus 1 little horn.

2) The little horn coming up in the midst of the 10 horns  $10+1=11$

3) The Bible refers to the eleventh hour as a time of foreboding or the latter day when Gog would come against Israel.

The Bible obeys its own rules, namely 2 or 3 witnesses. There is only one verse referring to the little horn coming up amongst the 10 horns. However, there is another verse using a different metaphor – the clue is “coming up”. Both the little horn and Gog “come up” amongst the tribes of Israel. “Coming up” is a good description of their *modus operandi* i.e. or in modern parlance worming their way in! First doing very lowly jobs and then working their way up the ladder in the various host nations.

Coming up as a cloud covereth the earth is another good metaphor, because like an autumn mist which at first is only a few inches above the ground, but then rises very high and everything is obscured, just like the Jew, who having reached high office is no longer visible as a Jew and has blended in with the indigenous population, using such tricks as pretending to convert to Christianity or marrying into the aristocracy. However, their allegiance is not to the host state, but to their Zionist satanic agenda.

**Ezekiel 38 15** *And thou shalt come from thy place out of the north parts, thou, and many people with thee, all of them riding upon horses, a great company, and a mighty army:*

*16: And thou shalt come up against my people of Israel, as a cloud to cover the land; it shall be in the latter days, and I will bring thee against my land, that the heathen may know me, when I shall be sanctified in thee, O Gog, before their eyes.*

**Daniel 7:8** *I considered the horns, and, behold, there came up among them another little horn, before whom there were three of the first horns plucked up by the roots: and, behold, in this horn were eyes like the eyes of man, and a mouth speaking great things.*

Not only that: On the basis of A = 1, B = 2, C = 3 etc,

**Khazar** = 11 + 8 + 1 + 26 + 1 + 18 = 65 = 6 + 5 = 11

**Gog** = 7 + 15 + 7 = 29 = 2 + 9 = 11

**Jew** = 10 + 5 + 23 = 38 = 3 + 8 = 11

This gives us 33 (11+11+11) = The number of Masonic degrees! Dr. Wesley Swift stated that the Edomites were known as the people with funny handshakes! Eleven (11) is a sacred number. When eleven is multiplied by the perfect number 3, the number 33 is produced, a number of tremendous occult importance.



The symbol of Amalek (an Edomite race) is a 5 pointed star, hence their military nerve centre, the pentagon, is a 5 pointed star in plan. The 5 pointed star was prominent on the hat of uncle Sam when calling the Americans to take up arms against their German cousins. The 6 pointed star of Moloch and Astarte which is an emblem of the Rothschilds and is on the flag of their large real estate area in the Middle East known as the Israeli state. Thus again we have 5 + 6 = 11 (the number of Gog)

Moreover, a number of Bible versions refer to Agag King of the Amalekites as either Agog or Gog which further associates the name with Amalek-Edom or modern day Jewry whom

Yahweh would have war with from generation to generation. Exodus 17:16

The Illuminati reconstituted itself with its occult knowledge having been acquired from ancient Egypt using the vehicle of the Knights Templar an outwardly very respectable organisation that assisted pilgrims going to Jerusalem. It was set up in 1111, but did not become officially recognised until 9 years later. Hence the importance of 9 & 11 for the orchestration of major disasters on September 11th i.e. the great fire of London, the twin towers (which



themselves form a number eleven!) and the 2009 financial collapse.

### Some Other Notable 911 Events

- 9. 11. 2007: The "Big Brother" Telecommunications Surveillance Law is passed in the German Bundestag.
- 11. 9. 1990: George H. Bush announces the coming of the New World Order (NWO)
- 9. 11. 1989: The "Fall of the Berlin Wall", with disastrous economic consequences for the citizens of the former German Democratic Republic.
- 11. 9. 1941: U.S. President Roosevelt, a High-Degree Freemason himself, states publicly that he (- without declaring war -) gave the order to fire on German military Vehicles.
- 9. 11. 1938: The "Crystal Night" or "Night of the Broken Glass"; the NSDAP attacks Jewish fellow citizens, their synagogues and property - the fruit of the anti-Semitic seeds sown by Freemason and founder of the Thule Society, Rudolf von Sebottendorf.
- 8./9. 11. 1923: "March on the Feldherrnhalle" (Field Marshal's Hall) - Hitler coup in Munich
- 9. 11. 1918: Revolution and overthrow of the Kaiser in Berlin. Prior to this there had been a Communist revolution in Munich (civil war). Rudolf von Sebottendorf gave a speech in Berlin which already contained the quintessence of

“Third Reich ideology”. (By way of explanation: “German Reich ideology”, from 1870 or so onwards, was undoubtedly wrong and gave rise to “Hitler mania”. Johann Wolfgang von Goethe warned that: “The German faces no greater danger than trying to improve himself through or with his neighbours.

London is also the premier capital of modern Israel where the Prime minister resides at No.10 (ten horns or ten tribes) Downing street, while the controlling representative of the City of London resides at No.11 again the number of Gog.

The Hebrew word for Gog is “Gowg” means "roof, covering, or mountain." Coming up as a cloud means covert or in secret. Mountain would also tie up with the other biblical name for Edom, that is mount Seir.

11 - The subversion and undoing of 10; a flawed addition to that perfect order. 11 - the Antichrist/Prince is known as the 11th Horn. Lucifer = “Light Bearer” has 11 letters! Another interesting fact is that; of the 190 nationalities within the old USSR the 11<sup>th</sup> in population size was the Jews (Gog).



Undercover aptly describes freemasons who operate in secret from their Masonic lodges under the symbol of the all seeing eye for in the little horn was full of eyes, like the eye of a man, a subliminal warning that we are under surveillance. Another point to note is that under the UK bankruptcy Act and when a firm goes into

liquidation of its assets, it is said to be under chapter 11 of that act and that is when the bank takes control, which as we know is Gog!!

Readers of previous issues of the *New Ensign* will be aware that Gog has been secretly attacking us through its scalar wave technology via HAARP and its network of microwave transmitters using ELF (extra low frequency) waves. Those readers who speak German will know that elf is German for number eleven!

We must also remember that Gog has been interfering with Scriptures. In the original KJV Bible there were 80 books, a good number (8 God x 10 ten tribes = 80). However when the Jesuit (Jewish) committee called the biblical destruction group was set up in 1776 whose

## Harold Stough Notes - Edom



### Edomites (Idumea)

Edom: (red) the name Edom was given to Esau, the first-born son of Isaac and twin brother of Jacob, when he sold his birthright to the

latter for a meal of lentil pottage. The country which the Lord subsequently gave to Esau was hence called "the country of Edom" and his descendants were called Edomites. Edom was called Mount Seir and Idumea also. Edom was wholly a mountainous country. It embraced the narrow mountainous tract (about 100 miles long by 20 broad) extending along the eastern side of the Wadi Arabah from the northern end of the Gulf of Elath to near the southern end of the Dead Sea. The ancient capital of Edom was Bozrah. Petra appears to have been the principal stronghold in the days of Amaziah (BC 838). Elath and Ezion Geber were the seaports.

Esau's bitter hatred to his brother Jacob for fraudulently obtaining his blessing appears to have been inherited by his latest posterity. The Edomites peremptorily refused to permit the Israelites to pass through their land. For a period of 400 years we hear no more of the Edomites. They were then attacked and defeated by Saul and some forty years later by David. In the reign of Jehoshaphat (BC 914) the Edomites attempted to invade Israel, but failed. They joined



Nebuchadnezzar when that king besieged Jerusalem. For their cruelty at this time they were

fearfully denounced by the later prophets. After this they settled in southern Palestine for more than four centuries continued to prosper. But during the warlike rule of the Maccabees they were again completely subdued, and even forced to conform to Hebrew laws and rites, and submit to the government of Hebrew prefects. The Edomites were now incorporated with the Israel

nation. They were idolaters. Their habits were singular. The Horites, their predecessors in Mount Seir, were, as their name implies, troglodytes, or dwellers in caves; and the Edomites seem to have adopted their dwellings as well as their country. Everywhere we meet with caves and grottos hewn in the soft sandstone strata.

The Edomites are the descendants of Edom, i.e., Esau, according to Genesis 36:1-19. And according to Numbers 20:14-21, the Israelites were refused permission to pass inviolate through Edom. This was an instance of religious aversion probably exacerbated by Satan himself.

Saul ben-Kish, anointed first king of Israel, fought against the Edomites, I Samuel 14:47; "for Yahweh so hated the Amalekites (descendants of Esau) that He commanded Saul to have no pity on them -- not even the women and children -- but to blot out the name of Amalek entirely."

And according to I Kings 11:15,16, King David defeated the Edomites; however, Hadad, one of the royal princes, escaped to Egypt and later became an enemy of Solomon's. Indeed, by David's command, Joab ben-Zeruiah, remained in Edom six months -- "until he had cut off every male organ (ZAKR) in Edom." Then, in 875 BC, the Edomites allied with Moab and Ammon to attack Judah, II Chronicles 20:22, in the Valley of Berachah. Later, Jehoram had problems with the Edomites until, finally, Amaziah killed 10,000 Edomites in the Valley of Salt, took Sela, the capital, and executed another 10,000 by pushing them from the top of the rock (II Kings 14:7, II Chronicles 25:11,12)

Subsequent to this, the Edomites became the vassals of the Assyrians, but attempted revolutions in 711 and 701 BC. And the Edomites allied themselves with Nebuchadnezzar when he destroyed Jerusalem in 586 BC, according to Psalm 137:7, which says, "Remember, O Lord, what the Edomites did on the day Jerusalem fell. 'Tear it down,' they cried, 'tear it down to its foundations!'"

Nebuchadnezzar ceded portions of Judah to the Edomites after the fall of Jerusalem. This fulfilled the prophecy of Jeremiah in Jeremiah 49; and explains why Jeremiah had been exhorting the Hebrews to destroy the Edomites. Lamentations 4:21, Amos 1:11,12, and Obadiah 8-10, all prophecy the destruction of Edom by God.

The Nabataeans were the first of God's whips against the Edomites; for the Nabataeans pushed the Edomites back up into a small parcel of land next to Judah. Then John Hyrcanus I, king-hierarch of Judea, 134-104 BC, subjugated Edom in fulfillment of the above prophecies, "that Jacob shall lay Esau by the heel." Hyrcanus "permitted the Idumeans to remain in their country as free men if they would circumcise their genitals and observe Jewish law."

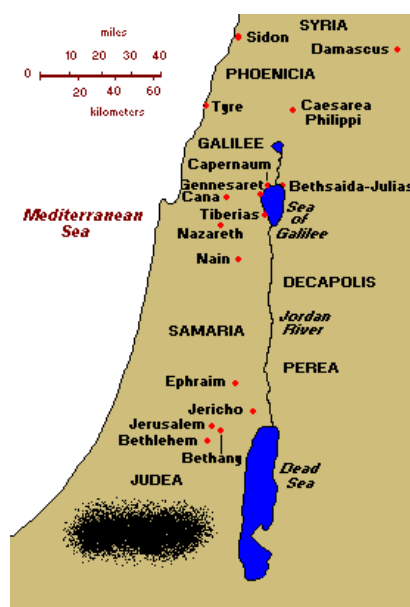
God's final whip against the Edomites was Rome. For the Romans used 20,000 of the Idumeans as allies in the siege of Jerusalem, 70AD. But afterwards, the Romans annihilated the Idumeans, stating simply that they were a lawless and despicable race.

In verses 3 and 4 of Malachi chapter 1, Malachi compares the priests to Esau and his descendants the Edomites. This was an insult of unimaginable contempt -- the ultimate slur. For the Edomites were uncircumcised. And as uncircumcised heathens the Amalekites had "made themselves particularly hateful by cutting off 'the circumcised members of the Israelites" (both prisoners and corpses), tossing them into the air and shouting with obscene curses to Yahweh: 'This is what you like, so take what you have chosen.' This tradition is deduced from Deuteronomy 25:18, alluding to Amalek's

harassment of the Hebrews at Rephidim during the Exodus."

In other words, Malachi is equating the circumcised Levitical Priests of his day with the uncircumcised Edomites. The Edomites were unbelievers who hated

Yahweh and the Hebrews, and who tried to destroy the Hebrews at every opportunity. The priests were also unbelievers who hated Yahweh, and who were trying to destroy their own country from within. Who is more to be reviled? The enemy who attempts to kill you, or traitorous compatriots who attempt to kill you?





# Britain's 9-11 Cover Up: What Will Become Of Us? - Ken Boyle



**What will become of a people too mentally lazy and stupidly trusting to take an interest in their own survival?**

Yesterday Mike Adams published an excellent article titled 'The Gullible Mind Explained'. It could have been describing the wall of uncritical and lazy reporting now hitting the airwaves regarding Lady Justice Hallett's report on the recent 7/7 Inquest.

The content of this report was easily predictable. Simply inevitable.

There are two competing narratives to explain this crime:

**1) The official story of four suicide bombers murdering 52 people and injuring hundreds by exploding four bombs on three tube trains and one bus on the morning of 7/7.**

**2) Forces embedded within the establishment carried out a false-flag attack against the British people. As with nearly all false-flag events, patsies were set up to take the blame for the crime. The four Muslims were completely innocent actors paid to participate in a concurrent anti-terror 'drill'.**

As you will have guessed, I am one of the many who subscribe to conspiracy theory number two.

## **HERE'S WHY**

After 9/11 the murderous confabulation that is modern history soared and raged all around us

under guise of a 'War on Terror', providing the necessary pretext for just about anything the western military-industrial complex felt like doing. However, in the UK we (or should I say the Labour government) had a serious problem. Although Blair and his army of stooges signed up to every invasion and participated loyally in every occupation, the one thing our 'War on Terror' was short on was... the terror. It appeared that British Muslims, peeved though they undoubtedly were at watching their co-religionists being slaughtered by the million in Iraq, just wouldn't turn their energies toward blowing up their fellow Englishmen. The 'War on Terror' was happening somewhere else.

The fact that on 7/7/05 four (or more) explosions killed fifty-two innocent people making their way to work on a Thursday morning changed all that.

Nonetheless the story, universally accepted by the British media (if not across the country), that four Islamic-terrorist suicide-bombers murdered them remains an unproven and (as I will attempt to explain) highly unlikely conspiracy theory.

Firstly it needs to be noted that the refusal of both the Labour and the new Tory/Liberal alliance to hold a public Inquiry into the events of 7/7 should ring a very loud alarm bell for every British citizen. This was the largest mass-murder ever on British soil. One might have expected the promoters of the 'War on Terror' to use a Public Inquiry to cash in on an incident that would make and massively boost their case.

In a court of law physical evidence always trumps excuses, allegations, observations or any other kind of verbal contribution to a case, so one should perhaps begin here.

## **The Explosives**

Here is a timeline for the 7/7 explosives narrative as it developed:

The first analysis came from a genuine expert. This is surely the most reliable commentary on the nature of the bombs that went off that

morning. The problem is that it would have been all-but-impossible for four young men from Leeds to get their hands on such materials.



On 12 July 2005, Superintendent Christophe Chaboud (left), chief of French anti-terrorism Coordination Unit who was in London assisting Scotland Yard with its investigation, confirmed to The Times that, ‘The nature of the explosives appears to be military, which is very worrying... the material used were not homemade but sophisticated military explosives ...’ (Nafeez Ahmed The London Bombs, p.24)

On 13th July it was stated that these were of ‘C4’ explosive... London explosives have military origin – [Science Daily. LONDON, July 13 (UPI)]: Forensic scientists told the newspaper the construction of the four devices detonated in London was very technically advanced, and unlike any instructions that can be found on the Internet.’

From The Independent on July 14th: ‘A bath filled with explosives has been found at a house in Leeds that was the “operational base” for the London suicide bombers.

17th July 2005 The Observer: ‘22 lbs TATP in the bath.’

The TATP story survived but faded away in 2007 then, when the 7/7 Kingston trial came along in the summer of 2008 all trace of the TATP story had gone.

Now the explosives were made of black pepper and hydrogen peroxide. The idea of the four heating up Hydrogen Peroxide in their kitchen to the point where it would make an explosive mix with black pepper is simply laughable. How could they test that their ‘bombs’ were going to go off. Were they going to go lurching across the country with this kind of bomb sloshing about in their rucksacks. Has anybody ever made a bomb out of this mixture? If such a bomb did explode could it possibly have caused the devastation created on 7/7?

There is much written online that mocks these materials as potential tools of mass destruction.

Do we not require a Public Inquiry on this issue alone. The changing storyline above surely makes no sense at all.

## Why Suicide?

Moving on to another very obvious question: why would terrorists who wished to wreak havoc and punish British people for the UK’s involvement in Iraq and Afghanistan choose to blow themselves up along with their victims? These were very crowded trains. They could have set a timed detonator and quietly slipped off the trains a stop or two early, leaving their bags on the floor amongst the feet of dozens of incurious passengers. Where would have been the risk in that? Surely such activists would better serve their cause by continuing and not terminating their mission?

## Drills

There were four uncannily accurate drills carried out before the 7/7 bombings:

1) **The BBC Panorama ‘management exercise’ programme of May 2004** during which a panel of ‘managers’, including Peter Power (see below) and Michael Portillo, discussed how they would deal with a terror attack on London that revealed itself to them through mock news reports as the show progressed. The scenario they had to deal with turned out to be one over-ground and 3 underground explosions taking place over a short space of time during the morning rush hour.

2) **The contemporaneous 7/7 drill:** on 7/7 itself Peter Power conducted a terror drill that shadowed the cataclysm as it happened – over the same three tube stations at more or less the same time. On the afternoon of 7/7 he was interviewed on Radio 5’s ‘Drivetime’ programme:

POWER: ...at half-past nine this morning we were actually running an exercise for, er, over, a company of over a thousand people in London based on simultaneous bombs going off precisely at the railway stations where it happened this morning, so I still have the hairs on the back of my neck standing upright!

3) **Atlantic Blue: held over 5-8 April, 2005.** All echelons of government participated in this large

terror-drill. The Independent reported after July 7th that “By an extraordinary coincidence, all the experts who formulate such plans are together in a meeting at the headquarters of the London Ambulance Service – and they are discussing an exercise they ran three months ago that involved simulating four terrorist bombs going off at once across London.”

4) **Operation Hanover:** London’s police hold a little-known yearly terror-drill. On 2005 it just happened to be held on 1-2 July. Its game-plan was threefold: three ‘simultaneous’ bomb attacks on three underground stations. The police have been reticent about discussing this astounding precursor event, mere days before 7/7. They only revealed it in 2009.

## Why No Post-Mortems?

Another astonishing fact that emerged during the 2010-11 7/7 Inquest was that no post mortems **were carried out on the bodies of the victims**. A very great deal about the nature of and distance from the explosions could have been discovered from such examinations. The effects of different explosives on flesh are well-known. Such post-mortems would have provided some definitive information that would have at least ruled out some possible explosives from consideration as the source material of the blasts. What could possibly explain such an oversight other than the desire to avoid creating conflicts with a fabricated narrative.

## Body Count Reveals No Bombers

**The First Official Body Count on Two of the Trains was One Body Short.**

At the 7/7/ Inquest in November 2010 Dr. Morgan Costello gave evidence that he was asked to attend two scenes, Edgware Road and Aldgate, for the 'purposes of certifying the extinction of life'. He counted six bodies at Edgware Road and seven bodies at Aldgate and declared these as 'life extinct'. The enormous anomaly, that passed completely unreported in the press, was that the numbers should have been seven and eight if we count the bodies of the bombers. Here is surely the clearest possible evidence that the alleged bombers were never on the trains. No similar count seems to have been carried out on the other (Russell Square ) train but we do know a little about the behaviour of

the Russell Square bomber, Germaine Lindsay, before his demise.

## Germaine Lindsay, Cool And Then Confused

Germaine Lindsay drove from Aylesbury to meet the other (let’s call them) bombers in Luton railway station. He arrived an hour before them and decided to take a little nap. He received a parking ticket while asleep in his car. Were he a terrorist he obviously would have known that he would have had only four hours left to live.

**Germaine Lindsay was one extraordinarily relaxed suicide-bomber.**



A station attendant called Mr. Patel gave testimony to the Inquest that a man he identified as Germaine Lindsay arrived on the concourse of King’s Cross station and asked to talk to “The Duty Manager”. He said it was, “Very important.” Mr Patel remarked that it was very unusual for a member of the public to know the exact name for the person in charge of the station. Normally people asked for ‘the supervisor’ or ‘the manager’. At this time there was chaos on the concourse. The metal grills had been pulled down and shut at the front of the station. Passengers were not being allowed through the barriers. A crowd had built up and people were starting to abuse staff. Numbers of ‘Community Support Officers’ who looked like police were milling around the area trying to manage the situation. No wonder Lindsay was confused. He must have decided to try to speak to someone who ‘was in on the game’ to explain to him what was going on. The most obvious explanation of his behaviour is that it would have puzzled and alarmed him that the drill had started before he, ‘the bomber’, had caught their trains. Perhaps a chilling possibility occurred to him. When Mr. Patel returned with the duty manager Lindsay had gone.

## And More

There are many, many other serious anomalies in the official narrative.



The train times presented huge problems for the official narrative causing the Home Secretary to change the story after it was realised that the 7.40 they were said to have caught had been cancelled. Then the next train arrived 23 minutes late at King's Cross giving the bombers only three minutes to buy four RETURN tickets (think about that one), cross the track by bridge and board the last possible train that makes it just feasible they could have reached the bombed trains in time.

On the 5th July 2005, Mohammed Siddique Khan took his pregnant wife to Dewsbury Hospital in West Yorkshire. She was bleeding and there was obviously something wrong. Doctors examined Hasina Patel and said that there was a 'threatened miscarriage'. They sent her home and booked her in for a scan on the 7th. Mrs Patel has never told the time they got home but afterwards Mohammed Khan said that he was 'going to see his friends'. Hasina Patel never saw or heard from her husband ever again. She miscarried on July 6th. At the 7/7 Inquest there was 'evidence' (peculiar and surely untrustworthy) presented of a mobile phone text-message exchange between Khan and Germaine Lindsay at 4.35am on the morning of the 6th July. Would Khan really have abandoned his desperate wife for a whole day while she was in that condition? Khan was a highly respected in his community and by the headmistress of the special school in which he worked as a classroom assistant. The police had used him to mediate between rival gangs in local disputes. He was trusted by all sides. Hilary Benn had taken Khan on a tour of the House of Commons. He was not known to be politically radical. Quite

the opposite. He was protective of the good name of his community and was eager to maintain good relations with the local white community. Bearing this in mind it is likely that the reason the police have film of Khan is that he was helping them 'keep an eye on' any worrisome Muslim elements in his locality. He was not a troublemaker, he was a healer and a fixer.

The most likely explanation for Khan's disappearance on the 6th is that he told his minder for the 7/7 exercise that he was not going to be able to make it. He would have been told to see that the others could make it without him. The bombings were not going to be called off but.... now he had presented his minders with a problem that had only one possible solution. His goose was cooked.

This would also explain why the attendant at the filling station where Tanweer filled his car (and argued about the change he was given) said he only saw one other person in Tanweer's car. Hasib Hussain alone (the bus-bomber) was in the car and, unknown to the pair of them, Khan was by now already dead. This would also explain why the now-suppressed BBC radio 5 news reports from the late morning of the seventh said that two men had been shot in Canary Wharf (rather than three, the supposed train bombers. Hussain had been separated from the others).

Those who have travelled to Beeston and spoken to locals report that, like Khan, Hussain and Tanweer had shown no inclination in their communities towards political or religious radicalism.

## The Evidence Against 'The Four'

Looking at the detail of latest narrative laid out before the 7/7 Inquest, it must be admitted that it is now just physically possible that the four caught the last possible train at Luton and rushed from King's Cross Thameslink to the various subway platforms before detonating their deadly cargos. However, their relaxed demeanour in the very few still photos presented as evidence militates against the probability that they were rushing about madly that morning (especially with all that liquid explosive slopping about on their backs).

Why too in the most CCTV-rich environment on earth are there only a couple of very poor pictures of the four, one at Luton, one at Thameslink, the date and time stamps on which could have easily been photo-shopped. Could the photos of Khan have been used from the 'practice run' the four carried out on 29th June 2005, just eight days earlier?

The mobile phone evidence places them all on the correct train at the right time. Three things about this though. Firstly, this is new evidence that was not released in the previous 2006 hearing. Why? Second, is it likely that these men would have been texting each other on train they had all boarded together. Finally, this is the kind of evidence easily faked. It is letters and numbers on a piece of paper.

Khan and Tanweer could easily have been talked into making the Jihadi videos that have played such a large part in aiding the public to accept their guilt. They were employees, well-paid for two days work, the practice on June 29th and for the day itself. They were told that the exercise has to be made as realistic as possible. The film would be in the hands of the station staff and other authorities giving them a possible means of intercepting the four. The on-camera 'threats' from Khan and Tanweer are vague and unspecific. When Hasina Patel first saw these videos it was reported that she said, "That's not my husband." Her brother thought it was Khan. It is most likely that she meant, "I know him. He would never say such things."

The 'bombers' all had four or more mobile phones each; one of their own private phones and at least three other (so-called) 'operational' phones that they are supposed to have used to confound anyone who might attempt to track their communications and obstruct their diabolical plan. It is most likely that these phones were supplied by their minder and that their holding them allowed their 'handlers' to track Tanweer and Lindsay down in Canary Wharf after they had panicked and gone on the run, presumably (and naively) hoping to tell their story to the British press who are mostly based there.

## **P.S. Muad'Dib**

The first person to present an alternative and more credible narrative for 7/7

was Yorkshireman Anthony John Hill, in his documentary '7/7 *The Ripple Effect*' (this is a must-see. Please watch if you don't know the film). Hill, a very unusual character in many ways, has renamed himself Muad'Dib, after a character in Frank Herbert's sci-fi epic 'Dune'. It is basically his interpretation of events that have been presented above, excepting that 'Dib did not know of the pregnancy problems of Khan's wife, nor about the 4.35 text-messages, nor Khan's failure to contact his wife after leaving her on the evening of the 5th of July at the time of making his film.



When a group of 'Islamic terrorists', allegedly associates of Khan, went on trial for offences in 2008 at Kingston Crown Court (above), Hill posted two copies of his DVD to the court. One envelope was addressed to the judge, the other to the foreman of the jury. Neither DVD reached its target but shortly afterwards a request for Hill to be extradited from Ireland (he lived in Kells, County Meath at the time) was sent to the Irish Ministry of Justice. The request was successful and Hill was collected by a British policeman, accompanied across the water and incarcerated in Wandsworth prison shortly before the start of the 7/7 Inquest.

Hill relates, amusingly, that he asked the policeman in whose charge he was placed, "Have you watched my film." The constable replied, "Yes." "What did you think of it?" asked Hill. The PC offered a look that was wide-eyed and grim. Hill asked him, "Shouldn't you be arresting Tony Blair and not me?" and the policeman sheepishly went back to reading his newspaper.

Hill made immediate applications for bail but was only released once the Inquest was finished.

His documentary has been copied and handed out at mosques to thousands of Muslims in the UK. Most Muslims now believe 'The Four' to be innocent, largely because of 'Dib's work. The authorities were obviously determined he would not upset the 7/7 Inquest operation by getting his film into the hands of family members, press and God knows who else. This man scares them and has suffered accordingly. His case is being heard in Southwark Crown Court on next Monday Morning 9th May 2011.

## What Will Become Of Us?

For me, there is only one sensible explanation to explain the facts of 7/7/05. Unfortunately this is a very unpleasant explanation.

Let us ask the hard questions of all our leaders, MP's, journalists, teachers, police, military and the rest.....

.....**What will become of us** if we continue to allow ourselves to be led by such criminals, people who are prepared to commit acts of false flag terrorism against their own people?

Think about it Constable, Sargeant, Brigadier, Headmaster, News editor, everyone.....

**There is no such thing as an innocent bystander. To stand and watch is to be complicit. Standing and watching is passive approval.**

## The Black Nobility From Our London Correspondent



**T**hese people earned the title of "**Black**" nobility from their ruthless lack of scruple. They employed murder, rape, kidnapping, assassination, robbery, and all manner of deceit on a grand scale, brooking

no opposition to attaining their objectives. These all have immense wealth. And money is power.

**The most powerful of the Black Nobility families** are located in Italy, Germany, Switzerland, Britain, Holland and Greece in that order. Their roots may be traced back to the Venetian oligarchs, who are of Khazar extraction, and married into these royal houses in the early part of the twelfth century. (Following a great Khazar victory over the Arabs, the future Emperor, Constantine V, married a Khazar princess and their son became Emperor Leo IV, also known as "Leo the Khazar". The Medici popes, and Pius XII (Eugenio Pacelli) were Khazars, as is the present Pope, John Paul II. Not all Black Nobility are royal houses, and many of the royal families no longer have kingdoms. According to researcher and author Dr. John Coleman, a "**Committee of 300**" was established early in the eighteenth century, "although it did not take on its present form until around 1897", (when the China opium trade was legalised)

Documentary proof as to the existence of the "**Committee of 300**" is not forthcoming, and it may be no more than a convenient phrase to describe certain key players. Socialist politician and financial adviser to the Rothschilds, Walter Rathenau, writing in the **Wiener Press** (24 December, 1921) said, "**Only 300 men, each of whom knows all others govern the fate of Europe. They select their successors from their own entourage. These men have the means in their hands of putting an end to the form of State which they find unreasonable.**" Exactly six months after publication, Rathenau was assassinated.

Dr. Coleman's work opens the door to further studies on named members of the ruling elite, particularly in America. Whereas the English have a long history and are very aware of their ancestry, certain families of "**blue-bloods**" in the United States that have historic ties with the British through blood and money.

These "**noble**" families are behind most if not all of the so-called pro-environmental movements that are actually intended to curb the population growth of ALL nations. **Prince Philip and Prince Charles** are the most visible symbols of this movement, and are a true part of this conspiracy to destroy industry and take the world back to a **New Dark Age**.

Most if not all the crowned and uncrowned heads of these dynasties enjoy huge incomes from ground rents. All favour Global 2000 Report to the President that's calculated to end all industrial progress, and by famine, disease and wars, eliminate the excess population industry supports. All oppose nuclear power that can produce clean cheap electricity, the key to economic development and prosperity in the Third World. They ardently desire a return to the feudal system where they will once again be absolute rulers.

**While professing Christianity, the oligarchical families, for the greater part, actually despise it in secret.** Masonry provides their religious fulfilment. And without faith, they have no belief in reward or punishment and a world to come. They live for the here and now.

Many of these oligarchies are in the drug and arms trade through well-distanced intermediaries (like so many of the large banks).



In 1815 the Jesuits and their Freemason allies among the crowned heads of Europe held the Congress of Vienna, whereby Swiss neutrality (already sanctioned by the Peace of Westphalia in 1648) was forever guaranteed; and no matter how many wars are provoked in which the common man has to do the fighting, the money of the Nobility in Switzerland should always be free from plunder. It's part of Rothschild's (above) meticulous long-range planning, and why Switzerland exists to this day. But that doesn't mean to say *your* money would be safe. Some US\$280 billion p.a. in flight capital and drug money flows into the Swiss accounts of the Black Nobility.

The place of Freemasonry in the power structure of the Elites is quite evident as they carried through Adam Weishaupt's conspiracy to avenge the Jesuits after their abolition in 1773 by

short-lived Pope Clement XIV as **"immoral and a menace to the Church and the Faith"**. By launching the French Revolution and directing Napoleon's conquest of Catholic Europe, and by revolts against the church in Mexico and Latin America, they cut-off Vatican income.

Nathan Rothschild's financing of Britain resulted in the defeat of Rome's enemy Napoleon, (as well as being the source of his wealth and influence). Since Gregory XVI conferred a Papal decoration on Kalman Rothschild for loaning the Vatican five million pounds in a period of difficulty, the Rothschilds have been the fiscal agents of the Vatican. With Vatican interests at heart, the Rothschilds extended their financial and political dominion in the United States. The Vatican's interest in the US was clearly revealed in the secret 1822 **Treaty of Verona** between Austria, France, Prussia, and Russia whereby the Jesuit Order pledged itself as the price of reinstatement to destroy "the works of Satan" it had established in setting-up, by revolution, representative governments such as the republics and "democracies" of France and the USA, replacing them with the only form of government approved by the church, rule by "divine right", as declared by the Vatican (Daniel 2:42-43; Revelation 17:12-13).

As Senator Robert Owen pointed out to the US Senate in 1916, the prime target to which the Vatican and the **"Holy Alliance"** directed the subversive and destructive activities of the Society of Jesus, is the United States, and other republics in the Western hemisphere. This plot, he claimed, was the target at which the Monroe Doctrine was directed. What the Senator did not realize is that the Monroe Doctrine protects the interests of **"The City of London"**.

The Rothschild-Vatican cabal unsuccessfully attempted to gain control over the power of the purse in the US through the First and Second Bank of the United States. They were established under emergency powers granted to the President by the Constitution, as temporary institutions to tide the country through the periods of financial stress occasioned by the Revolutionary and 1812 Wars. But the aims of the conspirators to establish a banking monopoly were thwarted by the Constitution. Until the FED.

It is said the Black Nobility promised a neutral Germany if Soviet Russia allowed East and West

Germany to reunite. And that Russia promised to see that all royal houses are restored to the rightful heirs if they decouple Europe from the American Alliance.

Imperial nobility enjoy a more elevated status than the nobilities of the German successor states and, indeed, of the Italian states. The descendants of Italian Holy Roman Empire titles have formed an Association to which all male line descendants of someone ennobled by Imperial Patent is entitled to belong. And the Principality of Liechtenstein has also claimed the ability to confirm a succession to Imperial titles, and has confirmed the right of a Spanish noble man to heir such a title for purposes of the Spanish law requiring the successor state to confirm that the claimant to a particular title is in fact the heir. Thus there is a remaining jurisdiction, even though no Imperial titles have been conferred since 1806.

In 1963, the Holy Roman Empire Association (Associazioni dei Nobili del Sacro Romano Impero) was established to unite male descendants in its membership who are invested with nobility of the Holy Roman Empire. It also includes a number of honorary members.



The Black Nobility belong to the "**Committee of 300**" that controls the UN. **Prince Bernhard** of the Netherlands has the power to veto the Vatican's choice of any pope it selects. This may explain the untimely end to Pope John Paul I's 33-day pontificate. **The Prince has veto power because his family, the Habsburgs, are descended directly from the last Roman emperor.** (The Habsburg Frederick III was the last emperor to be crowned in Rome; his great-grandson Charles V was the last to be crowned by a pope). This is the civil equivalent of the Pope's claimed "**apostolic succession**" from Saint Peter.

**Prince Bernhard is leader of the Black Families and he also claims descent from the House of David through the Merovingian dynasty, a claim that was acknowledged to be valid by the Carolingian dynasty that supplanted**

**them, by other monarchs and by the Roman Church of that time. Thus he can truly say that he is "related to Jesus".**

**Prince Bernhard's** House of Orange had its origins in France. The Habsburgs are related through marriage with the Merovingians, who are said to have descended from the Tribe of Benjamin who went into exile following war with the other eleven Tribes -- see Judges chapter 21. Exile took them to Arcadia in the central Peloponnese, Greece. Here they aligned with the Arcadian royal line and towards the advent of the Christian era, migrated up the Danube and Rhine, through marriage engendering the Sicambrian Franks -- the immediate forebears of the Merovingians, who were ultimately of Semitic origin, and descendants of King Saul.

They are identified with the Spartans, and both books of Maccabees link the Spartans with the Judah (not to be confused with the Jews). I Maccabees 12 tells of Jonathan sending a letter to the Lacedemonians (Spartan Greeks) asking for their help, since they were brethren. The Spartans replied, "It is found in writing, that the Lacedemonians and Jews are brethren and that they are of the stock of Abraham" (verse 21). It is assumed by some writers that this means the Spartans were Israelites, **but the Spartans were infiltrated by Edomites** who were descended from Bela son of Beor and brother of Baalim, and king of Edom (Genesis 36:32; I Chronicles 1:43). Edom was the son of Isaac and grandson of Abraham who sold his birthright, and bred his posterity off the Book of Life.

Early in the fifth century the Merovingians established themselves in what is now Belgium and northern France. There they adopted the **Cabalistic pseudo-Christianity of the Cathars**, a dualistic religion that holds there are **two eternal gods, the god of Good and the god of Evil**. It is revealing that **this Luciferian belief is held by Masons of high degree and those who would be Masters of this world today, and who claim that Lucifer will ultimately be victorious.**

Under Clovis I, who reigned from 481-511, the Franks converted to Roman Catholicism. Through him, Rome began to establish undisputed supremacy in Western Europe. In return for being the sword of Rome whereby the church would manifest her power and impose a spiritual



dominion, Clovis was granted the title of "**New Constantine**" and to preside over a unified "**Holy Roman Empire**" based on the church and administered on the secular level in perpetuity by the Merovingian bloodline. Like "**the sure mercies of David**", this was a pact that could be modified, but not revoked, broken or betrayed. They believe **Jesus survived the cross and married Mary Magdalene who bore His son then lived in seclusion in the south of France. During the fifth century this lineage is said to have married with the royal line of the Franks engendering the Merovingian dynasty.**

When in 496 the church pledged itself in perpetuity to the Merovingian bloodline it was presumably in full knowledge of their claimed identity. This would explain why Clovis was offered the status of Holy Roman Emperor, and why he was not created but only "**crowned**" king. In 754 the church clandestinely betrayed its pact.



The Prieur de Sion is the name of the secret order which created the Knights Templars as its military and administrative arm. (It should be remembered that the Knights Templars were the forerunners of Freemasonry). The Prieur de Sion continues to function through the centuries, acting in the shadows, and has orchestrated certain critical events in Western history.

It exists today and is still operative. Its declared objective is the restoration of the Merovingian dynasty and bloodline -- to the throne not only of France, but of other European nations as well -- a restoration that is sanctioned and justifiable, both legally and morally.

There is strong evidence to suggest that this order was the author of Freemasonry, and "**The Protocols of the Learned Elders of Sion**", as well as the Rosicrucians. There is abundant evidence to suggest that Nostradamus was one of their secret agents, and there is no question that numerous quatrains which refer to the advent of "**le Grand Monarch**" indicate that this sovereign will ultimately derive from the Merovingian dynasty. Implying a double hegemony of the Papacy and the Empire, of the Vatican and of the Habsburgs. He frequently referred quite explicitly to the Knights Templars and to the house of Lorraine which is now synonymous with the Habsburgs.

Although deposed in the eighth century, the **Merovingian bloodline** did not become extinct. On the contrary it perpetuated itself in a direct line from Dagobert II and his son Sigisbert IV. By dint of dynastic alliances and intermarriages, this line came to include Godfroi de Bouillon, who captured Jerusalem in 1099, and various other noble and royal families, past and present -- Blanchefort, Gisors, Saint-Clair (Sinclair in England), Montesquieu, Montpezat, Poher, Luisignan, Plantard and **Habsburg-Lorraine**. At present, the Merovingian bloodline enjoys a legitimate claim to its heritage.

The crown of Charlemagne -- a replica of which is now part of the imperial Habsburg regalia -- is said to have borne the inscription "Rex Salomon" (**Encyclopaedia Britannica**, 14th Ed., 1972, Crown and Regalia, Fig. 2). And the "Spear of Destiny", which is said to have pierced Christ, reside today in the Treasure House, Vienna, awaiting another Holy Roman Emperor (**The Rigby Joy of Knowledge Library. History and Culture I**, 1977:160; **The Holy Roman Empire**, Friedrich Heer, p. 284). It is clear why the "**Protocols of the Elders of Sion**" speak of a new king "**of the holy seed of David**", (**Holy Blood and the Holy Grail**, Baigent, Leigh and Lincoln). Otto von Habsburg is today the titular Duke of Lorraine and King of Jerusalem.

The Prieur de Sion claim to hold the lost treasure of the Temple of Jerusalem plundered by Titus in AD70 which would be returned to Israel "**when the time was right**". ## Did The Dimona Dozen Murder The Fukushima 50?

Overheated open fuel pools cannot produce hydrogen because in an open fuel pool the water boils off at 100 Celsius, and won't be present in pressurized form at 2,000 degrees Celsius to liberate it's hydrogen by losing it's oxygen to the zircon cladding in the fuel rods. The rods will prefer the free oxygen in the air and burn long before attempting to claim the oxygen in whatever humidity there might be. Because fuel rods only contain 20 percent fissionable material, they also cannot produce the "prompt criticality" described by "the most qualified nuclear engineer in the world," Arnie Gundersen. **I got to the bottom of the Arnie Gundersen story, and added the results of that investigation further down the page.** He has been put on a pedestal and pumped up enormously by a press that wants a misleading story, all the while he is a despised outcast of the greater engineering community. The explosion at #4 was flatly impossible absent the use of an explosive device, and as a result **the disaster at Fukushima is FAR FAR WORSE than ANYTHING Gundersen is willing to expose.** Gundersen is toeing the line and hiding the true magnitude of what happened there because if it became widely known serious questions would be asked. *When have you heard Gundersen talk about a totally missing reactor?*



[Reactor 4's dome was removed for defuelling.](#) Drone photos prove it. This dispels the rumours surrounding unit 4's explosion. Some have said this reactor was secretly in operation to enrich plutonium. This photo proves it was disassembled for shroud replacement as stated. Tepco is going out of it's way trying to explain the explosions, especially at reactor 4, because they did

indeed occur, so an explanation is needed. As a result, they are giving reasons that cannot happen, just to say something. They need to see this post and get the Arava perspective (Arava is a district surrounding Dimona).

3. That the destruction of the facility is so severe it could only have been accomplished with nuclear weapons. Hydrogen produces a non-ideal subsonic explosion. It cannot turn concrete into dust. It can produce high pressures if sealed off, but the metal roof on all the reactor containments should have provided the relief and been the only thing destroyed. It takes a high intensity explosive to strip concrete off rebar, a blast wave many times faster than supersonic. This means that whatever happened at Fukushima did not have blast characteristics that fit the "official" story. If you missed it in the high resolution photo of the destroyed facility, I took a car that was laying around in the remains and placed it on top of one of the blown away walls at reactor 3, which clearly gives the reference that the walls had support columns at least 15 feet thick. Fukushima was built with the Mark 1 containment design, but beyond Mark 1 standards which was a common upgrade (reference the included photos, it is obvious). It is true that gas explosions can be very destructive, but only in facilities that were not designed to handle them. Even the basic mark 1 containment was many times beyond capable of withstanding the worst hydrogen blast.

4. That nuclear weapon(s) were placed inside of the reactor containment(s) disguised as security cameras installed under contract this year by Arava based security firm Magna BSP (Arava is a district around Dimona, not a city). Their "security cameras" weighed over 1,000 pounds and were the size and shape of [gun type nuclear weapons](#). The reason Magna BSP gave for the odd shape, enormous weight, and giant proportions of their cameras was that they were stereoscopic. They have creatively called them bi-scopic so when you search on Google their monstrous cameras are the only thing that comes up (outside of DJ lighting and a gun scope) **Try it. Type "Biscopic camera" into Google images, (without the quotes) it's a hoot!** This helps marketing I guess. The need for such a large stereoscopic camera could be plausible at an airstrip, where the camera would need depth perception out miles, but not indoors where focal lengths are short. Other manufac-

turers have units appropriate for indoor focal lengths which are only twice the size of ordinary monocular security cameras. Depth perception going out miles could also be accomplished with two separately mounted cameras weighing only a few pounds; the giant thousand pounder is a dead giveaway. **Magna does make passive radar systems which require a large body**, but the owl could accomplish it's claimed function with two small lightweight cameras (5 or so lbs, not tiny) and the processor in a modern laptop. Why this giant thing? note—a not yet produced graphical model is what you see most on Google, the ones produced thus far are ugly boxes.

... 9/11, 4/11, 3/11? see a pattern? Let's not see a 6/11. Your time and effort in spreading the word may really make a difference.

### **The quake was not what we were told**

**In fact the quake was a bold faced lie packing a political agenda.** There is even more proof now, and it goes beyond the [linked Japanese chart](#). This original seismic data is the smoking gun, however, I have something better. I analyzed the lies told by the USGS from which I wrote this sad, sad story about how it really was, not what you will see in the video. Keep in mind that precise top speeds of flying debris cannot be determined with accuracy, but this story will at least be close to the numbers put out by the USGS.

**The people in the newsroom did not die, this story is what would have happened were USGS charts true.**

Meet Atsuo, Airi, and Akiyoshi. They were all the best and most dedicated people at the NHK newsroom, in Sendai Japan. Akiyoshi loved Airi, and Atsuo was the one who introduced them. Unfortunately, all 3 died in the quake. **Akiyoshi got a severe cut and bled to death when he hit a display screen behind him at 44 miles an hour**, and was then thrown out through a hole in a collapsed wall. Others in the newsroom died also, (at least according to the official USGS charts) but I never thought up names for them. The laser printer was never found, but the table it was on

ended up on top of the rubble, smashed to pieces, where one of the few survivors used a piece of the metal frame to splint his broken leg.

**Question: Why are none of the roads packed with people trying to flee the approaching tsunami?** Could it be that the people and government were not expecting one? Tsunami sirens blare only when it arrives, rather than 40 minutes before, which is how much warning they would have had if a real quake in the ocean had been detected. Consider that. ### **RUSH UPDATE, May 28, 2011**

When reviewing the seismic data for the supposed 9.0 I saw there were instead *three* small simultaneous inland epicentres. This made me suspicious right from the start that the quake was artificially triggered and used as seismic cover for a tsunami bomb. But I needed to find a motive for generating an artificial quake. 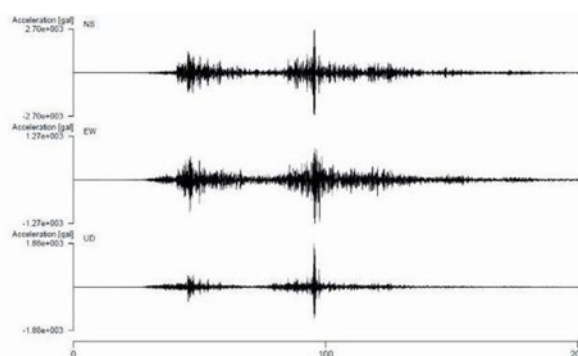
Mr. Cohen said: *"Others are engaging even in an eco-type of terrorism whereby they can alter the climate, set off earthquakes, volcanoes remotely through the use of electromagnetic waves. So there are plenty of ingenious minds out there that are at work finding ways in which they can wreak terror upon other nations. It's real, and that's the reason why we have to intensify our efforts, and that's why this is so important (April 28, 1997). Left unsaid by William Cohen is that such systems would be developed by [DARPA](#) and owned by America first!*

I would expect that after fourteen years of further development this technology can now trigger devastating earthquakes in non-seismic zones. [Benjamin Fulford](#), an experienced journalist with a long history and a paid access site, is predicting that the floods along the Mississippi are in fact caused by Haarp, which will then be followed by a manmade earthquake along the New Madrid fault, and then a subsequent attack at 15 reactors in the nation's agricultural heartland. If this is so, it will make Fukushima look like a cake walk. **I have personally verified that control systems at most American nuclear facilities (targets) have been upgraded with the Siemens SCADA system susceptible to the [Stuxnet virus](#).** It is therefore important for people to SPREAD THE WORD. They have already started with the flooding, which is phase 1. Phase 2 will be the earthquake, destroying levees to unleash the raging Mississippi. Phase 3 will be a Stuxnet virus attack at nuclear facilities. THE ELITE ARE COWARDS. IF THE WORD IS SPREAD SUFFICIENTLY, THEY WILL NOT DARE TO PROCEED TO PHASE 2 AND 3. **Mold grows best in the dark.**

The following picture is the strongest reading for this quake on any seismogram anywhere in Japan. This was before the lie machine got running smoothly. Early on there were a few sputters and this REAL chart got out. As you can see, it was a 6.67 on the Richter scale, (not Shindo scale, confirmed by PGA reference). This explains why there was NO structural damage in Sendai and the low level of shaking in the video.

This quake was initially assessed a 6.8, and the [seismic data](#) will show anyone the epicenter was *inland*, not at sea. So it started a 6.8, was upgraded to a 7.9, then upgraded to an 8.4, upgraded again to an 8.8, then upgraded to a 9.0, with the epicenter relocated in the ocean. Now many are saying it was a 9.1 which would bump up MYG011's number to 1200 from 1070, and this is all based on the impact of the tsunami, not on seismic data.

The following seismograms clearly show epicentres from *three* separate small simultaneous quakes as would be expected from an attack, rather than a natural occurrence.



It is difficult for people to grasp the magnitude of a 9.0 because the vast amount of energy being released is hidden behind confusing gradient markings on exponential charts. In order to provide clarity, I have drawn a [chart that illustrates the intensity a 9.0 earthquake on a linear scale](#). Be sure to magnify and scroll the diagram, which is 5,000 pixels high. **Owing to its extended vertical height it opens on the left side of the screen and is almost invisible until you zoom the display in your browser.** Public incomprehension of the GIANT magnitude of a 9.0 has enabled the elite scammers to propagate this latest BIG LIE. There is simply no way much of anything, even mountains, can remain standing under the impact of a 9.0, yet as the tsunami rolls in we see a picture of serene normalcy.

And now, I will bite. This is what I did not want to publish, but I know it has to be true. VLF communications are established with the bomb to penetrate the water. David in Dimona gets seismic reading from Japan. 6.67 in progress, BOOM. (New evidence shows the quake most likely was not natural).

The tsunami comes in, swamps Stuxnet infected power plant, direct video feed from legitimate cameras security company installed gets to David via totally unauthorized channel, and David knows just when to cut the generators off. Others on the team do all they can to counteract measures taken by the employees at Fukushima, who are unaware an attack is taking place and do not understand why everything is going crazy.

5. Israeli Prime Minister calls Japan, and says TAKE THAT for offering help to Iran, and ya

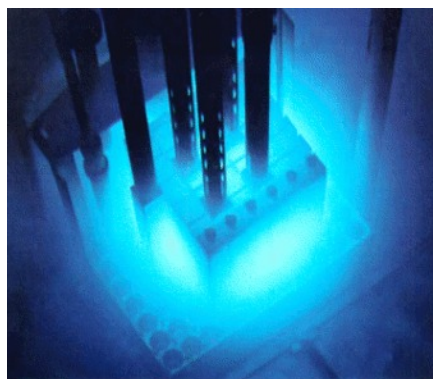
**Is it not interesting this "quake" reportedly happened at the bottom of the Japan trench, which would be perfect for hiding an atomic bomb blast?**

Furthermore, even with 100 percent pure material you need a precision trigger slamming or crushing material together to get a detonation. Even if 100 percent pure material is slammed together at high speed, if it is not done right you will get only a nuclear "sputter" that pushes the pieces apart, and no detonation. Nukes are hard to do! Why have so many of us seemed to have forgotten that nuclear detonations are hard to accomplish? The "prompt criticality" in spent fuel story is something I would have expected to hear from an Ewok praying to a gold robot. ### The Plain Truth on Fukushima

Fukushima was impossible. The swamping of the external generators by the tsunami was irrelevant, because the [real emergency backup systems](#) are driven by steam from the reactors themselves. No electricity is needed to operate three separate emergency systems at each reactor, each of which will keep a reactor safe even if only one works. Interesting it is that all nine non-electrical backup systems across the three fuelled reactors failed. This is technically impossible outside of wilful intent, and was likely the result of a Stuxnet attack.

Stuxnet was designed specifically to target Siemens SCADA controllers and is most effective at tampering with fluid control systems. The centrifuges it attacked in Iran were ideal. So are the fluid control systems at a nuclear facility. Oil refineries are equally at risk, Stuxnet is most dangerous when affecting a system which needs to control the flow of any liquid, be it hydraulic, for cooling, or combining chemicals. [Stuxnet is documented to have been produced](#) by the [Israeli Defense Forces](#), for the purpose of destroying any industrial system that can be destroyed by improper fluid flow.

Magna BSP, a Dimona based company with no history outside of IDF contracts prior to Fukushima has a [suspiciously short domain history despite a proclaimed 10 year history](#). [Magna BSP](#) had a full time Internet linked two way connection to the Fukushima reactor room(s) all the way through the disaster. They told TEPCO about that connection on March 15 (after everything blew sky high) via an article printed in the [Jerusalem Post](#). Why did Magna BSP wait until

everything was blown sky high before telling Tepco the data link existed, then not tell them face to face? I find it hard to believe that TEPCO would not have been interested in viewing a reactor that was about to explode. It seems impossible that Tepco would not have wanted to view the reactor, and probably did not ask because the link was kept a secret. It is a simple fact that Internet connections are never allowed inside a reactor's containment. The connection was mentioned in the *Jerusalem Post* AFTER the destruction was finalized.



[Stuxnet](#) has two modes, random and administrative. It can be administered to optimize the damage and can also transmit setup information and industrial system information to a remote computer. Once installed on the host system via a flash drive it causes that system to violate its normal security protocols and Internet administration becomes possible if a connection exists. Tampering is not visible on the control room readouts, because Stuxnet learns what "normal" looks like and keeps the temperature, pressure, and other readouts within normal limits so that the operators are oblivious to the destruction happening in secret. Stuxnet appeared in Japan in [June of 2010](#), shortly after Magna BSP arrived. Remote administration mode can be adjusted on demand to suit any need. No doubt the people at Fukushima sat there in idle mode thinking all was well until something screamed or went boom and at that point it would be too late to do anything other than cry.

I am a lifer in the types of control systems Fukushima and its TVA-owned Browns Ferry clone, have. BOTH have been upgraded to modern Siemens controllers running the Supervisory Control And Data Acquisition (SCADA) system Stuxnet was designed to attack; upgrades are the norm in any major facility. On many blogs people say the controls were old and therefore Stuxnet immune; they are out of touch or have no knowledge of industrial control systems. I actually ferreted it out.



*And now I will explain in detail why the problems before the explosions had to be sabotage.*

The diesel generators were not out in the open as we were led to believe, they were in fact located in the basements of the turbine buildings which were sealed off and never significantly flooded. One of them stayed running the entire time, but the electrical switch gear attached to it disconnected it for an unexplained reason which made it useless. Each of the backup generators at Fukushima were capable of running 14,000 households, which means they each had to be over ten megawatts. It is obvious then that Fukushima was set up to survive on only ONE of 13 backup generators, and ONE did keep running. One would be many times larger than needed to run last ditch backup systems at all reactors, but would not keep business as usual. But that is not the real story, which is that even others which were high and dry stopped.

I hypothesize that the ONE generator that kept running was kept as a lone reserve, never hooked up to a SCADA controller. Why did the

switch gear disconnect a working generator? That is the type of thing Stuxnet was designed to do. On top of these things, emergency generators arrived on scene within 9 hours, before anything bad happened but were unable to provide power because the switch gear would not let them. This [deceptively written report](#) from the World Nuclear Association contains all this information, but it is presented in a way which will cause you to overlook these things if you are not careful while reading it. 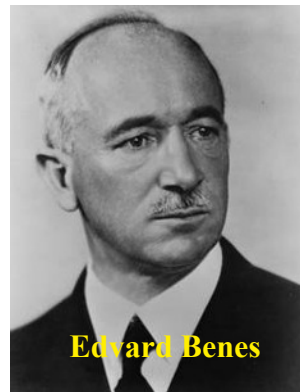
## **Gog's Plan For The Annihilation Of The German People**

**L**ong before the outbreak of the Second World War, and certainly long before the outcome of this European slaughter of brothers was foreseeable, the victors-to-be and their hangers-on had made plans for the disposition of Germany that contained fundamental violations of the Law of Nations. In addition to demilitarization and denazification projects there were plans for the destruction or expulsion of Germans from territories they have had inhabited for many centuries. For example, the expulsion of three and a half million of the Sudeten Germans was proposed in December 1938 by later Czechoslovakian president Edvard Benes, that is, nearly a year before the official outbreak of the war - and he was not the first to make the proposal.

During the Pan Slavic Congress held in Prague in 1848 the decision was taken that not only Sudeten Germans, but all ethnic Germans east of the line Triest-Stettin should be driven out. In summer 1917 Benes and later president Minister-President Kramar gave the Allies a memorandum

in which they demanded the dismemberment of Germany and the incorporation of large territories of the German Empire and Austria-Hungary in the Czechoslovakia that was to be formed.[1] After the signing of the dictate called the "Versailles Treaty," nationalistic Czech and pan Slavic statements and demands were politically prominent; unfortunately there is not space here to discuss that subject in detail.[2]

However, these demands were all more or less fanatically fixed on the expulsion of the Sudeten Germans.

These projects in violation of the Law of Nations were by no means merely the extravagant thoughts of chauvinistic, pan Slavic or Communist politicians: they were the official policy of national governments. The preamble to the Atlantic Charter expressly granted

Czechoslovakia the proviso that, on the signing of the document, the expulsion of Germans could not be hindered. In September 1942 Benes, (photo on previous page) ironically president of the National-Socialist Party, which after the war renamed itself the "People's Socialist" Party, received support for his plans from the English government. London communicated that it had no objection to the deportation of the Sudeten Germans, a population that has been dwelling in what is now Czechia as long as the Czechs themselves. In May 1943 Benes received a similar communication from Roosevelt and in June 1943 another from a Soviet liaison man in London, Alexander Bogomolov. In fact, the Czechs, and especially Benes, had never intended to subject the goal of a de-Germanized Czechoslovakia to international supervision or even to any criteria of humane conduct. In July 1944, a notice from high authority was circulated in the Czech resistance to the effect:[3]

*"We consider the possibility of the transfer of our German population. It can not be definitively stated that three millions of Germans in all can be transferred subject to some kind of international regulation. [...] It is necessary that in the first days of liberation we ourselves remove many and that as many as possible guilty Nazis fly before us out of fear of a civil revolt against them in the first days of the Revolution, and that as many as possible who resist as Nazis and defend themselves be struck down by the Revolution."*

After the military capitulation it was no longer necessary for the Czechs to operate conspiratorially and they professed their bloody intentions publicly. On 31 May 1945 the Czech National-Socialist newspaper Slovo národa stated drily:[4]

*"It will not be permitted for citizens of German descent to mingle with the Czech population."*

We should add to this remarkable announcement that it has been shown that the Czech exile government under Benes worked single-mindedly for ethnic cleansing in what was to be a newly formed Czech Republic, and that this has been carried out in a manner disregarding human rights and against the Law of Nations, as will be shown below.

Even in Poland they dreamed of expansionist plunder raids and fantasized about Polish extension to Stettin and even to Berlin, and this long before September 1, 1939. The official

program of the Polish Westmark Union contained the statement:

*"The natural boundary of Poland is west of the Oder."*

A handbill put out by the Preparation Committee for the Grunwald festival in memory of the battle of Tannenberg in 1410 stated:

*"We will take back what the Germans have taken from us on the Elbe, the Oder, and the Vistula!"*



S t a n i s l a w Mikolajczyk (left), president of the Greater Polish Agricultural Union, stated on 21 June 1939:

*"One must clearly understand that Poland will not know peace until it rests itself on the Oder."*

On August 7, 1939, the Slowo Pomorskie of Thorn said this about the Germans:

*"Therefore today we Poles say quite clearly: go back where you came from. On pushcarts drawn by dogs you came hither. You brought only a poor bedding. You can go back the same way."*

On July 20, 1939, the weekly Naród w walce proclaimed that Danzig must "remain Polish" and demanded that Germany surrender the East Prussian territory to Poland.[5]

During the war Poland received from London support similar to that received by Czechoslovakia. Churchill viewed the occupation of East Prussia by the Poles and the consequent mass expulsion of Germans with equanimity. At the conference in Tehran he admitted to Polish imperialism:[6]

*"We believe that Poland unquestionably should be satisfied at the expense of Germany."*

Some 14 months later, at the conference of Yalta, Churchill confessed that there were many people in Britain who were troubled by the thought of deportation but stated that he personally had no qualms about it. In his view, six or seven million Germans had already been killed, and at least 1 or 1.5 million more would probably be killed before the end of the war.[7] These ideas for the future were by no means propaganda blather, but were the actual views of the British Prime

Minister. At the 4th session of the Yalta Conference, on February 7, 1945, Churchill reinforced his anti-humanitarian conception by declaring "that he was not at all proposing to stop destroying the Germans." [7] A week later the genocide of Dresden was committed by British and American bombers. Churchill



It has perhaps not fallen into oblivion yet that Churchill, who prepared for or led war against Germany during more than four decades of his life, has been celebrated in the Federal Republic of Germany as a "great European." In May

1956 in Aachen he was awarded the Karl Prize, a Federal German award aiming to honor persons who "serviced the European movement." This award to Churchill can by no means be regarded as a single aberration. Several decades after Churchill's demise, leading persons in the government of the Federal Republic of Germany seem not to have learned anything from history: In 1999, German Federal Defense Minister Rudolf Scharping acquired doubtful glory, when he, during the NATO attack against Serbia in 1999, proposed to rename German Army (Bundeswehr) bases named after Wehrmacht generals, such as, for example, Field Marshall Erwin Rommel, that could possibly be changed to "Winston Churchill-Barracks."

To return to the question, what one should do with Germany: Just after the conference in Casablanca from January 14 to 25, 1943, US President Roosevelt caused a sensation when he said: [8]

*"Peace can come to the world only by the total elimination of German and Japanese war power. [...] The elimination of German, Japanese, and Italian war power means the unconditional surrender by Germany, Italy, and Japan. That means a reasonable assurance of future world peace."*

This shortsighted expression naturally contributed to the prolongation of the war, since it destroyed the possibility of a peace treaty. With this declaration of "total war for total peace" all bridges left standing were broken. The German government was made to understand

that all diplomatic possibilities for peace would be for naught. Germany stood with her back to the wall. Was there any other possibility than to fight to the bitter end with the motto, "Victory or Death," and to use all possible military means to achieve victory?

Factually, a German victory was by no means impossible. The advanced state of German technology, especially military technology, is shown by the fact that on 15 October 1942 the Army Main Command assigned to a cover group behind which operated German atomic research the task to find a way to use atomic fission and chain reactions to power rockets.

Germany had a number of "wonder" weapons in the works during the war. For example, near the end of military operations the Germans made their giant A4 rocket ready for production. It was 14 meters high, weighed nearly 11 metric tons and had a strike range of 370 kilometers. It flew 100 kilometers above the surface of the earth and reached a speed of 5,400 km/h. It had an advanced rocket motor fueled by alcohol and liquid hydrazine and it could be guided by radar or other means. Because it travelled five times faster than the speed of sound, it could not be heard and thus could not be located.

Another rocket that was nearly ready toward war's end was the winged A9. It weighed nearly 13 metric tons, had a strike range of 5,000 kilometers and could attain an amazing speed of 9,400 km/h. According to Colonel D. L. Putt, member of the US staff in the occupied territories responsible for examination of the state of German atomic weapons research, the Germans would have possessed the war-deciding weapon only a few weeks later with their V2 rockets equipped with atom bombs. In view of the immense number of inventions and patents, which the Allies searched for and confiscated in Germany immediately after the cease-fire, the Assistant Commanding General of US Air Force intelligence confessed to the Society of Aeronautical Engineers, that the Germans prepared a rocket surprise for the entire world in general and for Britain in particular, which most likely would have changed the course of the war, if the invasion would have been delayed for merely half a year. With respect to the rapid development of the German jet plane Me262 the British secret service concluded that, had Germany not been defeated by July 1945, the Germans would have

air superiority over Germany and over the armies.[10]

The overwhelming motivation of the Germans to fight for final victory was driven not least by the constantly repeated threats of the Allies to inflict certain measures on Germany and the German people when they had achieved victory. On February 23, 1944, in a debate in the House of Commons, British Foreign Minister Anthony Eden confirmed that Germany could not claim to be treated according to the Atlantic Charter, i.e. that it could not prevent the victorious powers from making territorial 'corrections' on Germany's expense. Thus, according to Eden, Germany could not claim rights based on any part of the Charter which would not be applicable for Germany.[11]



On April 22, 1944, Churchill confirmed the questionable intention that no treaty and no commitment would bind the Allies once Germany had surrendered. Churchill insisted that the Atlantic Charter would not be a legal basis for the treatment of

Germany and that territorial changes and corrections of borders could not be excluded. No arguments would be accepted, so Churchill. According to him, unconditional surrender meant that the victors had their hands free to act as they please.[12]

It demonstrates a grotesque and incomprehensible arrogance that the Allies, especially the USA and Britain, pretended to have undertaken the war against Germany expressly in the cause of justice and human rights. The cause of One World showed itself clearly then. On June 14, 1942, Roosevelt prayed (!) on the radio:[13]

*"God of the free, we pledge our hearts and lives today to the cause of all free mankind.*

*Grant us victory over the tyrants who would enslave all free men and nations. Grant us faith and understanding to cherish all those who fight for freedom as if they were our brothers. Grant us brotherhood in hope and union, not only for the space of this bitter war, but for the days to*

*come which shall and must unite all the children of the earth.*

*Our earth is but a small star in the great universe. Yet of it we can make, if we choose, a planet unvexed by war, untroubled by hunger and fear, undivided by senseless distinctions of race, color, or theory. Grant us that courage and foreseeing to begin this task today that our children and our children's children may be proud of the name of man.*

*The spirit of man has awakened and the soul of man has gone forth. Grant us the wisdom and the vision to comprehend the greatness of man's spirit, that suffers and endures so hugely for a goal beyond his own brief span. Grant us honor for our dead who died in the faith, honor for our living who work and strive for the faith, redemption and security for all captive lands and peoples. Grant us patience with the deluded and pity for the betrayed. And grant us the skill and valor that shall cleanse the world of oppression and the old base doctrine that the strong must eat the weak because they are strong.*

*Yet most of all grant us brotherhood, not only for this day but for all our years - a brotherhood, not only of words but of acts and deeds. We are all of us children of earth - grant us that simple knowledge. If our brothers are oppressed, then we are oppressed. If they hunger we hunger. If their freedom is taken away our freedom is not secure. Grant us a common faith that man shall know bread and peace - that he shall know justice and righteousness, freedom and security, an equal opportunity and an equal chance to do his best, not only in our own lands, but throughout the world. And in that faith let us march toward to the clean world our hands can make. Amen."*

This cleanness to be striven for, explained Mr. "Goodfellow" Roosevelt after the conference at Tehran, should be distinguished by the elimination of tyranny, slavery, oppression and intolerance. In the same sense as the globalists of the decade of the 1990's, he invoked a vision of a "world family of democratic states."

In paragraph 2 of the Atlantic Charter, signed 12 August 1941, it is stated that the signers did not seek territorial changes "that do not accord with the freely expressed wishes of the peoples concerned."

From November 28 to December 1, 1943, the "Big Three" met at a summit conference in the embassy of the USSR in Teheran to agree on the

policies to be applied to the German Empire after a victory. The keyword was the dismemberment of Germany, in which the three Allies agreed with. Especially during the second session on December 1, Churchill promulgated the idea of carving up Germany and pleaded for the smashing of Prussia as the "root of all evil," as well as for the separation of Bavaria and other provinces from Germany. Sniffing his opportunity, Stalin made known the demands of the Soviet Union:[14]

*"The Russians have no ice-free ports in the Baltic. That is why the Russians would need the ice-free ports of Königsberg and Memel and the corresponding part of the territory of Eastern Prussia."*

In 1945 the Soviets put the districts of Königsberg and Gumbinnen (13,200 km<sup>2</sup>) under Soviet administrative control and established the district of Kaliningrad there. In 1946 the territories of Memelland were incorporated in the newly organized Soviet republic of Lithuania.

In the course of a drinking party during this conference, Stalin proposed the following toast, which was received by Roosevelt with hearty laughter:[15]

*"The strength of the German armed forces lies in 50,000 senior officers and scientists. I raise my glass with the wish that they should be shot, as soon as we snatch them, all 50,000."*

Also the Americans were not averse to mass shootings. In Washington in August 1944 General Eisenhower told the British ambassador that all the officers of the Main Command of the German Armed Forces, as well as all the leadership of the NSDAP including town officials, and all members of the secret police, should be liquidated.[16] Just not to be misunderstood here: in this regard we are talking about some defenseless 100,000 human beings.

As the war progressed to the increasing disadvantage of Germany the intentions of the Allies with respect to the future treatment of the "German problem" became more and more audacious and specific. They reached a high point at the conference at Yalta. This summit conference of the "Big Three" took place in the former Tsar's palace Livadia near Yalta in the Crimea from 4 to 11 February 1945. Here the Allies discussed intensively the future to be imposed on the German Empire after an unconditional surrender. All three conference participants were agreed that there should be no



other way to end the war. It was only on lesser details that they were not entirely clear. For example, should they leave a German administration in office to whom the occupation zones would be assigned, or should they divide the rump of Germany into two states, north and south, with Vienna the capital of the latter? Finally they decided on another plan. Churchill stated that:[17]

*"In his opinion, there was no need to inform the Germans of the future policy to be conducted in respect of their country. The Germans should be told they would have to await further Allied demands after they surrendered. These further demands would be made on the Germans by mutual agreement between the Allies."*

This intention indicates nothing else, but a blank check with respect to the future treatment of the Germans. In this regard, Churchill declared further[18]

*"That an unconditional surrender precluded any armistice agreement. Unconditional surrender were the terms on which military operations were to be terminated. Those who signed the terms of an unconditional surrender submitted to the will of the victors."*

As the soldiers of the Red Army advanced into eastern Germany in the course of 1944/45, they were,[19] "prepared" for the occupation of Germany, above all from an official political side. In numerous frontline newspapers the rules which were to govern the behavior of the soldiers of the Red Army were promulgated. Both propagandists and writers contributed to the effort, such as Alexei Tolstoi, Mikhail Alexandrovich Sholokhov (The School of Hate), Konstantin Mikhailovich Simonov (Kill him!) and Surkov (I hate!). Most influential of all, however, were the propaganda briefs of Ilya Ehrenburg. His book *Voina* (= The War), published 1943 by the State Publications Office

for Fine Literature (!), Moscow, contains such expressions as:

*"Germans are not human. [...] If in the course of one day you have not killed at least one German, for you it was a lost day. When you have killed one German, kill another - for us there is nothing more jolly than German bodies."*

Both the soldiers of the German army and the German civilian population suffered from such behavior on the part of the soldiers of the Red Army. The outrages were not isolated incidents, but were mass crimes known to the highest authority, and collectively would later qualify as one of the greatest mass crimes of modern times.



The hate tirades and incitements of Ilya Ehrenburg and his fellow propagandists by no means represented an exceptional or singular propaganda measure of the Soviet Union. War reporter Lieutenant Günther Heysing made a collection of quotations taken from Soviet publications and

statements taken in interrogation of Red Army soldiers. This is from the soldiers' newspaper *Boyevaia Trevoga* of 20 October 1944:

*"Shudder Germany! Shudder cursed Germany! We will crisscross you with fire and sword and in your heart we will stab the last German who ever trod Russian soil."*

In a call to the Soviet Air Force at the beginning of the Soviet attack on East Prussia, we read:

*"The Red Army is on the offensive to fulfill the orders of the great Stalin and to deal the German beast its deathstroke in its hole. [...] with burning hatred in our hearts we enter the land of the hated foe. We come as judges and revengers. The foe must be destroyed without mercy."*

A deserter from the 494th G.R./174th G.D. confessed:

*"The company commander and column commander said that in German territory they could plunder without punishment and lay hands on German women."*

Nobody paid any attention to Art. 28 of the Hague Convention on Land Warfare, in which it is expressly stated, that it was forbidden to release cities or settlements to be plundered, even if they were taken in assault.

Calls for persecution of Germans were the order of the day and not only in the Soviet Union. Both in England and the USA many propaganda writings appeared calling for the persecution of Germans and Germany. In England Sir Robert Vansittart was one of the most influential inciters of Germanophobic acts. As First Diplomatic Councilor of the British Foreign Ministry he was known in diplomatic circles as the "German-hater." In his books *Black Record* (1941) and *Lessons of my Life* (1943) he put forth the idea that the German people were the eternal disturbers of world peace, the "killer bird" among the civilized nations. For this reason, it was necessary to destroy this barbaric, aggressive criminal people with a killer instinct. Vansittart's influence was enormous. He was a key figure in the British war clique that advocated draconian measures against Germany.

## The Trinity Of Global Empire

There are three cities (city-states) across this planet that share striking similarities and play a crucial role in the global governmental system we have long been living under. The three city-states (along with the role they serve) is as follows:

**City of London (finance)**

## Washington DC (military)

## Vatican City (religion)

The aforementioned city-states listed above are sovereign, corporate entities not connected to the nations they appear to be part of. In other words,



the City of London (that is the square mile within Greater London or England, just as Vatican City is not part of Rome or Italy. Likewise, Washington DC is not part of the

United States that it controls.

These sovereign, corporate entities have their own laws and their own identities. They also have their own flags. Seen below is the flag of Washington DC. Note the three stars, representing the trinity of these three city-states, also known as the Empire of the City. (There is also high esoteric significance to the number 3.)



Washington DC was established as a city-state in 1871 with the passage of the [Act of 1871](#), which officially established the United States as a corporation under the rule of Washington, which itself is subservient to the City of London. Corporations are run by presidents, which is why we call the person perceived to hold the highest

seat of power in the land "the president." The fact is the president is nothing more than a figurehead for the central bankers and transnational corporations (both of which themselves are controlled by High Ecclesiastic Freemasonry) that really control this country and ultimately call the shots.

Washington DC operates under a system of Roman Law and outside of the limitations established by the US Constitution. Therefore, it should not be a surprise that the name Capitol Hill derives from Capitoline Hill, which was the seat of government for the Roman Empire. If you look at the wall behind the podium in the House of Representatives, you will notice that on either side of the US flag is the depiction of bundles of sticks tied together with an axe. These are called fasci, hence the root word of fascism. This was the symbol of fascism in the Roman Empire, as it was under the Nazis and still is today. It is not a coincidence that these symbols are featured on the floor of Congress.

Any American who thinks they are living in a free country does not have a clue.



CORPORATION OF LONDON

The fact is that the United States corporation is controlled from the City of London, by the Crown, which is not the British Monarchy as many believe, but rather the private corporation that is the inner 'City of London' itself, also commonly known as "The City" or "The Square Mile." This square mile that makes up the centre of Greater London has its own mayor, laws, courts, flag, police force and newspaper. It is the heart of the global financial system.

Vatican City also has its own mayor (called the Governatorate), laws, flag, postal service, newspaper, radio and television stations, and even its own prison.

Another thing these three city-states have in common are their own obelisks. Obelisks are tall, four-sided shafts of stone which taper at the top in a pyramidal fashion. The obelisk is phallic in its appearance and represents the male penis. It is symbolic of the Egyptian sun god, Ra, and is an ancient symbol of male energy and generation (G) in Freemasonry.



Vatican obelisk: Located in St. Peter's Square, the Vatican obelisk was moved from Egypt to its current location in 1586. The circle at the base on the

obelisk represents the female vagina and thus male/female duality. Also notice the lines extending from the circle, forming a Union Jack as seen on the British flag.

So how are these three cities ultimately connected? We must first go back to the Knights Templar and their initial 200-year reign of power. The Knights Templar were first called "the Poor Fellow-Soldiers of Christ and the Temple of Solomon." This is a blatantly misleading title, considering the immense wealth and power of the Templars, who operated 9,000 manors across Europe and owned all the mills and markets. It was the Templars that issued the first paper money for public use in Europe, establishing the fiat banking system we know today. In England, the Templars established their headquarters at a London temple, which still exists today and is called Temple Bar.



London obelisk (aka Cleopatra's Needle): Located on the banks of the River Thames, this obelisk was transported to London and erected in 1878 under the reign of Queen Victoria. The obelisk originally stood in the Egyptian city of On, or Heliopolis (the City

of the Sun). The Knights Templars' land extended to this area of the Thames, where the Templars had their own docks. Either side of the obelisk is surrounded by a sphinx, also symbolism dating back to the ancient world.



This is located in the City of London, between Fleet Street and Victoria Embankment. The aforementioned "Crown," to be exact, is the Knights Templar church, also known as the

Crown Temple. It is the Crown Temple that controls the legal/court system of the US, Canada and many other countries. All bar associations are directly linked to the International Bar Association and the Inns of Court at Crown Temple in the City of London. Anytime you hear somebody refer to the Bar Association, they are talking about a British/Masonic system that has nothing to do with a country's sovereignty or the constitutional rights of its people. This is why, when you go to court in the US, you see the US flag with a gold fringe, denoting international rule. The government of the United States, Canada and Britain are all subsidiaries of the crown, as is the Federal Reserve in the US. The ruling Monarch in England is also subordinate to the Crown. The global financial and legal system is controlled from the City of London by the Crown. The square mile making up the centre of Greater London is the global seat of power, at least at the visible level.

Washington Obelisk (aka Washington Monument): Standing at 555 feet, the Washington Monument is the tallest obelisk in the world and also the tallest standing structure in Washington DC. The monument's cornerstone, a 12-ton slab of marble, was donated by the Grand Lodge of Freemasons. Like the Vatican obelisk, the Washington monument too is surrounded by a circle denoting the female. The reflecting pool in front of the monument signifies the ancient Masonic/Kabbalistic dictum, as above/so below.



The Temple Bar consists of what are called Inns of Court. There are four Inns of Court as follows: Inner Temple, Middle Temple, Lincoln's Inn and Gray's Inn. It is believed that the Inner Temple controls the legal system of Canada and Britain



while the Middle Temple controls the legal system of the United States, though all Inns are themselves controlled by the same few at the top.



Most Americans (and people in general) believe the US declared independence from Britain when this is simply not the

case. Of the signatories to the Declaration of Independence, at least five of them were Temple Bar attorneys, all of whom had sworn allegiance to the Crown. Alexander Hamilton was one of the Middle Crown agents during the formation of the US and was assigned to set up the American banking system on orders from the Crown, to control the United States. In fact a 'State' is a legal entity of the Crown. This is why we also have the STATE of Israel.

Furthermore, of the members of the Constitutional Convention that signed the completed US Constitution, seven were Middle Inn Templars who had also pledged allegiance to the Crown. Therefore, it is no coincidence that today copies of both the Declaration of Independence and US Constitution hang on the wall in the library of the Middle Temple in London.

To put it all in context, it is the Crown that controls the global financial system and runs the governments of all Commonwealth countries, and many non-Commonwealth 'Western' nations as well. The Crown traces back to the Vatican, which is headed by the Pope, who is the figurehead for the real powers that be behind the curtain, some of which are known but many of which are completely unknown to the general public.

James Forrestal the first US Secretary of Defence (1947-1949) quotes him as saying "Chamberlain (the British Prime Minister) stated that America and the world

heading for." (Fuller, JFC: *The Decisive Battles of the Western World* vol 3 pp 372-374.)

Hugh Wilson, the American Ambassador in Berlin until 1938, the year before the war broke out, found anti-Semitism in Germany 'understandable'. This was because before the advent of the Nazis, "the stage, the press, medicine and law [were] crowded with Jews among the few with money to splurge, a high proportion [were] Jews the leaders of the Bolshevik movement in Russia, a movement desperately feared in Germany, were Jews. One could feel the spreading resentment and hatred." (Hugh Wilson: *Diplomat between the Wars*, Longmans 1941, quoted in Leonard Mosley, Lindbergh, Hodder 1976).



Sir Nevile Henderson, British Ambassador in Berlin 'said further that the hostile attitude in Great Britain was the work of Jews and enemies of the Nazis, which was what Hitler thought himself' (Taylor, AJP: *The Origins of the Second World War* Penguin 1965, 1987 etc p 324).

Is all of this merely attributable to terrible 'anti-semitism'?

The economic background to the war is necessary for a fuller understanding, before casting judgement on the originators of these viewpoints.

At the end of the First World War, Germany was essentially tricked [see Paul Johnson *A History of the Modern World* (1983) p24 and H Nicholson *Peacemaking 1919 (1933)* pp13-16] into paying massive reparations to France and other economic competitors and former belligerent countries in terms of the so-called Treaty of Versailles, thanks to the liberal

American President Woodrow Wilson. Germany was declared to be solely responsible for the war, in spite of the fact that 'Germany did not plot a European war, did not want one, and made genuine efforts, though too belated, to avert one.' (Professor Sydney B Fay *The Origins of the World War* (vol. 2 p 552)).

As a result of these massive enforced financial reparations, by 1923 the situation in Germany became desperate and inflation on an astronomical scale became the only way out for the government. Printing presses were engaged to print money around the clock. In 1921 the exchange rate was 75 marks to the dollar. By 1924 this had become about 5 trillion marks to the dollar. This virtually destroyed the German middle class (Koestler *The God that Failed* p 28), reducing any bank savings to a virtual zero.

According to Sir Arthur Bryant the British historian (*Unfinished Victory* (1940 pp. 136-144):

'It was the Jews with their international affiliations and their hereditary flair for finance who were best able to seize such opportunities.. They did so with such effect that, even in November 1938, after five years of anti-Semitic legislation and persecution, they still owned, according to the Times correspondent in Berlin, something like a third of the real property in the Reich. Most of it came into their hands during the inflation.. But to those who had lost their all this bewildering transfer seemed a monstrous injustice. After prolonged sufferings they had now been deprived of their last possessions. They saw them pass into the hands of strangers, many of whom had not shared their sacrifices and who cared little or nothing for their national standards and traditions. The Jews obtained a wonderful ascendancy in politics, business and the learned professions (in spite of constituting) less than one percent of the population.

The banks, including the Reichsbank and the big private banks, were practically controlled by them. So were the publishing trade, the cinema, the theatres and a large part of the press all the normal means, in fact, by which public opinion in a civilized country is formed.. The largest newspaper combine in the country with a daily circulation of four millions was a Jewish monopoly.. Every year it became harder and harder for a gentile to gain or keep a foothold in

any privileged occupation.. At this time it was not the 'Aryans' who exercised racial discrimination. It was a discrimination that operated without violence. It was exercised by a minority against a majority. There was no persecution, only elimination.. It was the contrast between the wealth enjoyed and lavishly displayed by aliens of cosmopolitan tastes, and the poverty and misery of native Germans, that has made anti-Semitism so dangerous and ugly a force in the new Europe. Beggars on horseback are seldom popular, least of all with those whom they have just thrown out of the saddle."

Goodness gracious, Sir Arthur! What made you get out of the wrong side of the bed?

Strangely enough, a book unexpectedly published by Princeton University Press in 1984, Sarah Gordon (*Hitler, Germans and the "Jewish Question"*) essentially confirms what Bryant says. According to her, 'Jews were never a large percentage of the total German population; at no time did they exceed 1% of the population during the years 1871-1933.' But she adds 'Jews were over-represented in business, commerce, and public and private service.. They were especially visible in private banking in Berlin, which in 1923 had 150 private Jewish banks, as opposed to only 11 private non-Jewish banks.. They owned 41% of iron and scrap iron firms and 57% of other metal businesses.. Jews were very active in the stock market, particularly in Berlin, where in 1928 they comprised 80% of the leading members of the stock exchange. By 1933, when the Nazis began eliminating Jews from prominent positions, 85% of the brokers on the Berlin Stock exchange were dismissed because of their "race".. At least a quarter of full professors and instructors (at German universities) had Jewish origins.. In 1905-6 Jewish students comprised 25% of the law and medical students.. In 1931, 50% of the 234 theatre directors in Germany were Jewish, and in Berlin the number was 80%.. In 1929 it was estimated that the per capita income of Jews in Berlin was twice that of other Berlin residents..' etc etc.

Arthur Koestler confirms the Jewish over-involvement in German publishing. 'Ullstein's was a kind of super-trust; the largest organization of its kind in Europe, and probably In the world. They published four daily papers in Berlin alone, among these the venerable Vossische Zeitung,

founded in the eighteenth century, and the B.Z. am Mittag, an evening paper.. Apart from these, Ullstein's published more than a dozen weekly and monthly periodicals, ran their own news service, their own travel agency, etc., and were one of the leading book publishers. The firm was owned by the brothers Ullstein - they were five, like the original Rothschild brothers, and like them also, they were Jews.' (*The God that Failed* (1950) ed. RHS Crossman, p 31).



Edgar Mowrer, Berlin correspondent (above) for the Chicago Daily News, wrote an anti-German tract called *Germany Puts the Clock Back* (published as a Penguin Special and reprinted five times between December 1937 and April 1938). He nevertheless notes 'In the all-important administration of Prussia, any number of strategic positions came into the hands of Hebrews.. A telephone conversation between three Jews in Ministerial offices could result in the suspension of any periodical or newspaper in the state.. The Jews came in Germany to play in politics and administration that same considerable part that they had previously won by open competition in business, trade, banking, the Press, the arts, the sciences and the intellectual and cultural life of the country. And thereby the impression was strengthened that Germany, a country with a mission of its own, had fallen into the hands of foreigners.'

Mowrer says 'No one who lived through the period from 1919 to 1926 is likely to forget the sexual promiscuity that prevailed. Throughout a town like Berlin, hotels and pensions made vast fortunes by letting rooms by the hour or day to baggageless, unregistered guests. Hundreds of cabarets, pleasure resorts and the like served for purposes of getting acquainted and acquiring the proper mood..' (pp. 153- 4). Bryant describes throngs of child prostitutes outside the doors of the great Berlin hotels and restaurants. He adds 'Most of them (the night clubs and vice-resorts) were owned and managed by Jews. And it was the Jews.... among the promoters of this trade who were remembered in after years.' (pp. 144-5).



Douglas Reed (above), Chief Central European correspondent before WWII for the London Times, was profoundly anti-German and anti-Hitler. But nevertheless he reported: 'I watched the Brown Shirts going from shop to shop with paint pots and daubing on the window panes the word "Jew", in dripping red letters. The Kurfürstendamm was to me a revelation. I knew that Jews were prominent in business life, but I did not know that they almost monopolized important branches of it. Germany had one Jew to one hundred gentiles, said the statistics; but

the fashionable Kurfürstendamm, according to the dripping red legends, had about one gentile shop to ninety-nine Jewish ones.' (Reed *Insanity Fair* (1938) p. 152-3). In Reed's book *Disgrace Abounding* of the following year he notes 'In the Berlin (of pre-Hitler years) most of the theatres were Jewish-owned or Jewish-leased, most of the leading film and stage actors were Jews, the plays performed were often by German, Austrian or Hungarian Jews and were staged by Jewish film producers, applauded by Jewish dramatic critics in Jewish newspapers.. The Jews are not cleverer than the Gentiles, if by clever you mean good at their jobs. They ruthlessly exploit the common feeling of Jews, first to get a foothold in a particular trade or calling, then to squeeze the non-Jews out of it.. It is not true that Jews are better journalists than Gentiles. They held all the posts on those Berlin papers because the proprietors and editors were Jewish' (pp238-9).

The Jewish writer Edwin Black notes 'For example, in Berlin alone, about 75% of the attorneys and nearly as many of the doctors were Jewish.' (Black, *The Transfer Agreement* (1984) p58.

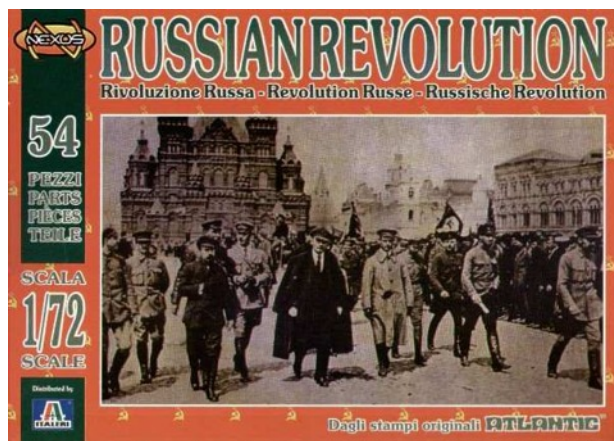
To cap it all, Jews were perceived as dangerous enemies of Germany after Samuel Untermyer, the leader of the World Jewish Economic Federation, declared war on Germany on August 6 1933. (Edwin Black *The Transfer Agreement: the Untold Story of the Secret Pact between the Third Reich and Palestine* (1984) pp272-277) According to Black, 'The one man who most embodied the potential death blow to Germany was Samuel Untermyer.' (p 369). This was the culmination of a worldwide boycott of German goods led by international Jewish organizations. The London *Daily Express* on March 24, 1933 carried the headline Judea Declares War on Germany. The boycott was particularly motivated by the German imposition of the Nuremberg Laws, which ironically were similar in intent and content to the Jewish cultural exclusivism practiced so visibly in present-day Israel (Hannah Arendt Eichmann in Jerusalem p 7).

Hitler saw the tremendous danger posed to Germany by Communism. He appreciated the desperate need to eliminate this threat, a fact that earned him the immense hatred and animosity of the Jewish organisations and the media and politicians of the west which they could

influence. After all, according to the Jewish writer Chaim Bermant, although Jews formed less than five percent of Russia's population, they formed more than fifty percent of its revolutionaries. According to the Jewish writer Chaim Bermant in his book *The Jews* (1977, chapter 8):

'It must be added that most of the leading revolutionaries who convulsed Europe in the final decades of the last century and the first decades of this one, stemmed from prosperous Jewish families.. They were perhaps typified by the father of revolution, Karl Marx.. Thus when, after the chaos of World War I, revolutions broke out all over Europe, Jews were everywhere at the helm; Trotsky, Sverdlov, Kamenev and Zinoviev in Russia, Bela Kun in Hungary, Kurt Eisner in Bavaria, and, most improbable of all, Rosa Luxemburg in Berlin.

'To many outside observers, the Russian



revolution looked like a Jewish conspiracy, especially when it was followed by Jewish-led revolutionary outbreaks in much of central Europe. The leadership of the Bolshevik Party had a preponderance of Jews. Of the seven members of the Politburo, the inner cabinet of the country, four, Trotsky (Bronstein), Zinoviev (Radomsky), Kamenev (Rosenfeld) and Sverdlov, were Jews.' Other authors agree with this:

"There has been a tendency to circumvent or simply ignore the significant role of Jewish intellectuals in the German Communist Party, and thereby seriously neglect one of the genuine and objective reasons for increased anti-Semitism during and after World War 1.... The prominence of Jews in the revolution and early Weimar Republic is indisputable, and this was a very serious contributing cause for increased anti-Semitism in post-war years.. It is clear then

that the stereotype of Jews as socialists and communists.. led many Germans to distrust the Jewish minority as a whole and to brand Jews as enemies of the German nation." (Sarah Gordon *Hitler, Germans and the 'Jewish Question'* Princeton University Press (1984) p 23).

"The second paroxysm of strong anti-Semitism came after the critical role of Jews in International Communism and the Russian Revolution and during the economic crises of the 1920's and 30's Anti-Semitism intensified throughout Europe and North America following the perceived and actual centrality of Jews in the Russian Revolution.. Such feelings were not restricted to Germany, or to vulgar extremists like the Nazis. All over Northern Europe and North America, anti-Semitism became the norm in 'nice society', and 'nice society' included the universities." (Martin Bernal, *Black Athenavol.* 1 pp. 367, 387).

"The major role Jewish leaders played in the November (Russian) revolution was probably more important than any other factor in confirming (Hitler's) anti-Semitic beliefs." (J&S Pool, *Who Financed Hitler*, p.164).

Hitler came to power in Germany with two main aims, the rectification of the unjust provisions of the Versailles Treaty, and the destruction of the Soviet/Communist threat to Germany. Strangely enough, contrary to the mythology created by those who had an opposing ethnic agenda, he had no plans or desire for a larger war of conquest. Professor AJP



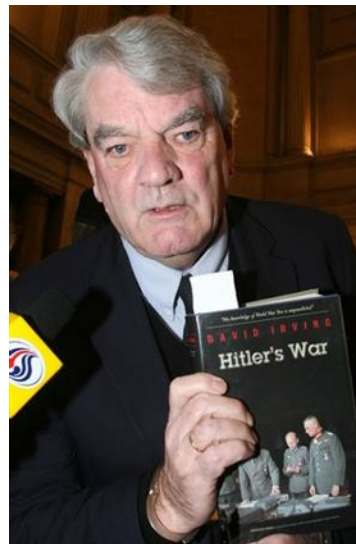
Taylor showed this in his book *The Origins of the Second World War*, to the disappointment of the professional western political establishment. Taylor says, "The state of German armament in 1939 gives the decisive proof that Hitler was not contemplating general war, and probably not intending war at all" (p.267), and "Even in 1939 the German army was not equipped for a prolonged war; and in 1940 the German land forces were inferior to the French in everything except leadership" (p104-5). What occurred in Europe in 1939-41 was the result of unforeseen weaknesses and a tipping of the balance of power, and Hitler was an

opportunist 'who took advantages whenever they offered themselves' (Taylor). Britain and France declared war on Germany, not the other way around. Hitler wanted peace with Britain, as the German generals admitted (Basil Liddell Hart, *The Other Side of the Hill* 1948, Pan Books 1983) with regard to the so-called Halt Order at Dunkirk, where Hitler had the opportunity to capture the entire British Army, but chose not to. Liddell Hart, one of Britain's most respected military historians, quotes the German General von Blumentritt with regard to this Halt Order: "He (Hitler) then astonished us by speaking with admiration of the British Empire, of the necessity for its existence, and of the civilisation that Britain had brought into the world. He remarked, with a shrug of the shoulders, that the creation of its Empire had been achieved by means that were often harsh, but 'where there is planing, there are shavings flying'. He compared the British Empire with the catholic Church saying they were both essential elements of stability in the world. He said that all he wanted from Britain was that she should acknowledge Germany's position on the Continent. The return of Germany's colonies would be desirable but not essential, and he would even offer to support Britain with troops if she should be involved in difficulties anywhere.." (p 200).

According to Liddell Hart, "At the time we believed that the repulse of the Luftwaffe in the 'Battle over Britain' had saved her. That is only part of the explanation, the last part of it. The original cause, which goes much deeper, is that Hitler did not want to conquer England. He took little interest in the invasion preparations, and for weeks did nothing to spur them on; then, after a brief impulse to invade, he veered around again and suspended the preparations. He was preparing, instead, to invade Russia" (p140).

David Irving in the foreword to his book *The Warpath* (1978) refers to "the discovery.... that at no time did this man (Hitler) pose or intend a real threat to Britain or the Empire."

This gives a completely different complexion, not only to the war, but to the successful suppression of this information during the war and afterwards. Historians today know only too well where the boundaries lie within which they can paint their pictures of the war and its aftermath, and the consequences of venturing beyond those boundaries, irrespective of the

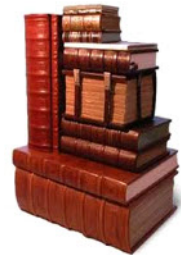

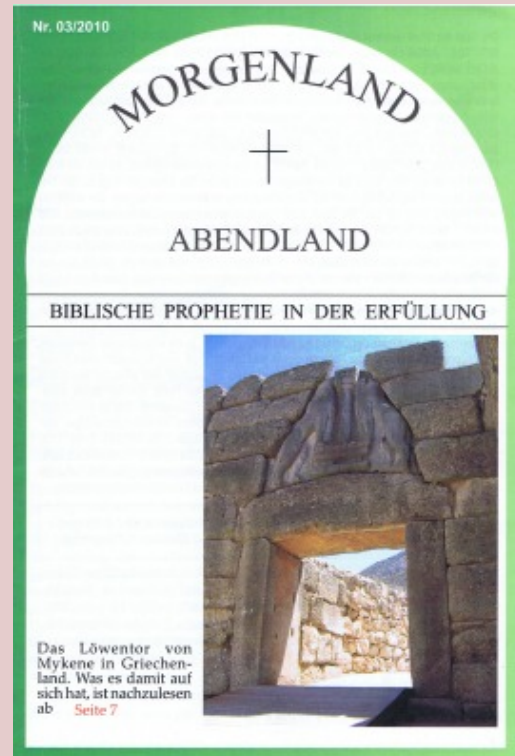
