### Genesis and Geology

(The following report is taken from a website that also tries to correlate natural history with the biblical record. The author concurs with my opinion that Cro-Magnon Whites existed before Adam and Eve. Other Identity authors who agree with this opinion are Nord Davis, Jr., Willie Martin and Jack Mohr. Two important things should be noted from the composite graphic (below) which shows the Earth's average atmospheric temperature (top part) and volcanic activity markers (bottom part) for the past 18,000 years BP. 1): There is a pronounced increase in indications of volcanic activity between the time when the megafauna

extinctions begin (about 14,000 BP) that ends just slightly before the date of the regeneration of the heavens and earth (about 6,000 years ago-Genesis 1:2). 2): The end of the extinction phase terminates in a relatively sudden and dramatic drop in global temperatures, marked by the Younger-Dryas cooling event.

Clearly, the data indicate there were rapid temperature changes, an onset of intensive geologic activity, and probably changes in the levels of solar activity at this point in Earth's history. The latter fact is supported by reported fluctuations in radiocarbon concentrations in the Younger-Dryas cold period between 12,700 and 11,500 years BP. In sum, this was anything but a normal pattern of events.

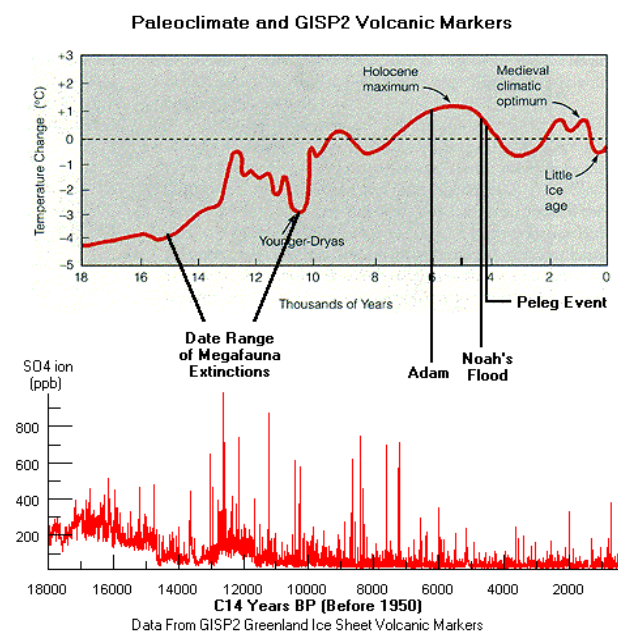
Why would so many animals perish at one time (at the END of the Ice Age, when things were warming up) after surviving several thousand years through the harsh glacial conditions in the Pleistocene epoch? The scientific community is greatly divided on the issue. Some hold that they were killed off by "man" for food, by disease, their inability to adapt to a changing post-glacial climate, or some combination of all. This form of causal reasoning precipitates from a uniformitarian paradigm that is coloured by our culture's preoccupation with political correctness and environmental issues like Global Warming.

Now a new theory on the cause of the Megafauna extinctions may hold the answer. Abundant tiny particles of diamond dust have been found in sediments dating to 12,900 years ago at six North American sites. This adds strong evidence for Earth's impact with a rare swarm of carbon-and-water-rich comets or carbonaceous chondrites, precipitating the Younger-Dryas. ([Diamonds suggest comets caused killer cold spell](#)).

Needless to say, the Biblical notion of a universal catastrophic destruction of all living things in the recent past and a Supernatural regeneration of the world by the Lord God is not something many men and women of science today would ever consider. So expect even more new theories to emerge as scientists continue to wrestle with this problem.

Would it not seem logical that a global event of this magnitude and severity, which wiped out the giant mammals, would also wipe out the humanoids that hunted them? Could a population of nomadic hunters quickly switch to an agriculturally sustained society, especially at a time when the Earth's average temperatures had plummeted sharply? I don't think so.

Keep in mind that according to the Bible, Adam and his lineage began as tillers of the soil and herdsmen after Adam's fall. The first indication of "hunting" does not appear in the Bible until after Noah's flood. (See Nimrod Genesis 10:9.) Consequently, if the Paleoclimate data are valid, and the Biblical time line of Adam and modern mankind is valid, then we must conclude it was not the descendants of Adam and Eve who hunted the now extinct mammoths. Those who did so were a race of manlike beings which were on the Earth before Adam and Eve; the Pre-Adamite race of hominids, not made in the "image of God," a fact which begs the question, in whose image were they made?



With the recent advent of the science of DNA testing, the supporting proof for this incredible hypothesis is coming to light, much to the consternation of the evolutionary uniformitarian school of human origins. For example, [DNA testing of Neanderthal](#) remains clearly shows that modern man is NOT descended from the Neanderthal. The DNA from three (3) different sets of Neanderthal remains showed that there is no genetic link between modern man and the Neanderthal. More recent studies of [Neanderthal DNA](#) and [Neanderthal Skull Characteristics](#)

further confirm this finding. This is forcing the evolutionists to start looking even further back in the fossil record for a common "ancestor" or "missing link" branch from the primates. [They won't find it](#). And guess what? They just identified [ANOTHER](#) one!

Recently the remains of an "anatomically modern human" (Cro-Magnon) found in Australia have revealed that it was at least 60,000 years old and had a mitochondria DNA generic marker which is now extinct. That is, nobody today is descended from that particular line of beings, at least on the female side. This find has raised serious debate between the "Out of Africa" and "Regional Continuity" evolutionary camps. Will future testing of other Cro-Magnon remains reveal similar DNA surprises? If the Bible is true, then the prediction is that they will.

Even more recently, and closer to our time in natural history, strands of very well preserved "human" hair were found in a Pleistocene age deposit in Oregon. These strands were dated to be between 10,000 - 12,000 years old. They present a mystery to science because DNA analysis has shown that they are not genetically related to any modern humans. Evolutionary mainline science still cannot provide a fully satisfactory answer to origins of modern man. As the tools of science improve (e.g., DNA analysis) the mysteries only become more mysterious as is demonstrated by the above cases. Reasoning from a uniformitarian paradigm, and in reference to the above-cited cases of no DNA connections to present humans, secular scientists will say that this only means those particular lines of humans must have been a branch of mankind that perished. They would have to make the claim that, as Evolutionary "theory" demands, that there was continuity of the human race. However, the link between the evidence from the past and present is still yet to be "scientifically" established. In fact, evolutionary research is finding just the opposite. Today scientists are claiming that human evolution has greatly accelerated, particularly [since about 10,000 years ago](#). The truth is there are big morphological differences between "modern man" and "primitive man," and pronouncing a sudden acceleration of evolution is their only way of explaining the findings within the accept-

ed evolutionary paradigm. The Bible has a better answer: Modern man is a new creation.

## Skeletal Evidence of Cro-Magnon and Modern Caucasians

Cro-Magnon Versus Caucasian (Please disregard the evolutionary mumbo-jumbo and the exaggerated early dates in the article here presented. It is the fossil evidence that is relevant here. At the website linked, you can compare the Cro-Magnon skull to the others, which represent different races. – Eli)

### Cro-Magnons

The Cro-Magnons were the immediate predecessors of modern Caucasians. They lived in Europe about 40,000 to about 10,000 ya. They were slightly more robust than modern Caucasians and, like Neanderthals, **they had brains that were larger (about 4%) than modern Caucasians, though their skulls were thicker and brow ridges heavier. (Howells, 1948, p. 186). With the appearance of the Cro-Magnon culture, tool kits started to become markedly more sophisticated. A wider variety of raw materials, such as bone and antler, were used and specialized tools were made for producing clothing, engraving, and sculpturing. Fine artwork, in the form of decorated tools, beads, ivory carvings of humans and animals, clay figurines, musical instruments, and spectacular cave paintings (Fig. 15-1a, 15-1b, & 25-3) appeared. (Leakey 1994).**

Figure 2-9 shows a Cro-Magnon skull. This 30,000 year old, **fully modern, Cro-Magnon skull was found in Les-Eyzies, France. The skull shows traits that are unique to modern humans, including the high rounded cranial**

**vault, and a nearly vertical forehead.** There are no large brow ridges, nor a protruding jaw. Note how the eye sockets are slightly sloped and are flattened far more than in the other fossil skulls, possibly an adaptation to protect the eyes from the cold. The flattened eye sockets that are observed in some North African skulls may be the result of Cro-Magnons migrating there during the worst of the last ice age.

There is no detectable difference between 10,000 year-old Cro-Magnon skulls and modern Caucasian skulls, except that the Cro-Magnon actually had a slightly larger brain capacity. The White Race (*Awdawm, Cro-Magnon*) was created on the sixth “day.” (Gen. 1:26-27.) The Man, Adam (*eth-ha-awdawm*), who was a member of this Race, was put into the Garden after the “day” (*yowm*, eon) of rest. This was NOT an “8th-day creation,” even though this has become popular terminology, because this event took place after the Day of Rest. Rather, the formation of the Man Adam was a molding or shaping of an individual, specifically selected by Yahweh, for the purpose of being the patriarch of a special seedline. As discussed, this type of narrowing of the seedline is a common feature of Scripture. This was an act of special selection by Yahweh Himself.

From all of the evidence at hand, I am convinced that the Chronological Account of Genesis 1 and 2 is the correct reading. Since Yahweh Elohim authored both natural history and the Bible, it is not possible that the two accounts can contradict each other. Unlike the false paradigms that currently exist in garbage science (evolutionism) and garbage theology (all races descended from Adam and Eve), I have endeavoured to eliminate these contradictions. By correctly translating the Hebrew language of Genesis and by dumping evolutionism, we find that there is no contradiction between real science and true theology.

## Harold Stough Notes Uffington White Horse and Dragon Hill



The White Horse of Uffington is one of the most impressive sites close to the ancient Ridgeway path, which traverses the steep chalk downs

brooding over the Vale of the White Horse. Other sites include Dragon Hill, The Manger and Uffington Castle, which have been the subject of legend and folklore for over a thousand years.

The White Horse of Uffington, with its elegant lines of white chalk bedrock, is thought to be the oldest hill figure in Britain. The image is a stylised representation of a horse (some would say dragon) some 374 feet in length, and is thought to date back as far as 1000BC in the late Bronze Age. Similar images have been found depicted on coins from that period, and it is thought that the figure represents a horse goddess connected with the local Belgae tribe. The goddess is generally believed to be one form of Epona, worshipped throughout the Celtic world. For paganising sacred symbols, Israel was sent into captivity.

The horse was ritually scoured every seven years under the jurisdiction of the local Lord, who had to fund the event. The festival - for that is what it became - could last for over three days and consisted of fun and games, traditional cheese rolling, wrestling and other pastimes. The focus of the games was in the enclosed earthen banks of Uffington Castle an Iron Age hill fort, which the White Horse seems to be galloping to when viewed from the air. The cheese rolling was held on the steep sided valley known as The Manger, the place where the horse was said to feed on moonlit nights. The festival, which may have had ancient origins, lapsed about a hundred years ago, and it is fortunate that the White Horse did not become completely overgrown. The horse is

now cleaned by members of English Heritage, who are responsible for the site.

Traditionally the horse is attributed to a number of famous figures, one of these is King Alfred, who is said to have had it constructed to commemorate his victory over the Danes in 871. The horse is also said to have been cut by Hengist, the leader of the Anglo Saxon horde in the 5th century AD. Another piece of folklore suggests that the figure is actually a representation of the dragon killed by St George, an event thought to have taken place on nearby



Dragon Hill.

Dragon Hill (above) is a low flat-topped mound situated in the valley below the White Horse. In legend it is the place where St George slew the dragon, its blood spilling on the hilltop and leaving forever a bare white patch where no grass can grow. Some suggest that the horse is a representation of St George's steed or even of the slain dragon itself.

## Uffington Castle

The castle is an impressive Iron Age hill fort, once protected by timber walls on top of the surviving banks and ditches, and faced with sarsen stones. It is likely that the tribe who created the White Horse once lived within this hill fort. The entrance to the hill fort was via the Northwest, protected by an earthen passageway that would have been further protected by wood. The castle was excavated in 1850 when evidence of the wooden structure was found, along with an Iron Age coin of the Dobunni tribe.

Some researchers believe that the castle marks the site of the battle of Badon, Arthur's great victory over the Saxons. This is probably due to the important strategic position of the castle close to the Ridgeway. There is little evidence to suggest this is the case.



The manger is a strangely shaped valley, which is thought to have been formed by the melting of ice in the last Ice Age. Cheese rolling was held down the side of the valley during 'The Scouring of the White Horse' every seven years. Folklore suggests that the manger is the supernatural feeding place for the White Horse, which would travel from its vantage point on the crest of the hill on moonlit nights.

# “In Thee Shall All The Nations Of The Earth Be Blessed” (Part 7)

### “JERUSALEM” IS NOT “ZION”

Jesus was born in Bethlehem that is described as “The City of David” about which we read, “For unto you is born this day in the city of David a Saviour, which is Christ the Lord” (Luke 2:11). So Bethlehem is where the “City of David” is.

**Luke 2:4**, “*And Joseph also went up from Galilee, out of the city of Nazareth, into Judaea, unto the city of David, which is called Bethlehem; (because he was of the house and lineage of David:)*”

Jerusalem is about 10-15 minutes drive by car away from Bethlehem, and is in the inheritance of Benjamin, whereas Bethlehem is in the inheritance of Judah. The fact that the two are intimately connected in history and prophecy does not mean they are the same identities. So there is this distinct difference between Jerusalem and the City of David.

The City of David has to do with the King whereas Jerusalem has to do with the Temple. This is a pattern found through the Old Testament where the High Priest was found in the Temple whereas the Monarch had his Palace. The two offices are different in function, but both Church and State are to have the same faith. This gives meaning to, “For out of Zion shall go forth the law, and the word of the LORD from Jerusalem”. A casual reading may suggest that both “Zion” and “Jerusalem” are exactly the same place, but it is not so. Parallelism suggests rather the ongoing relationship that should exist between Church and State.

This is shown in passages such as:

**1 Kings 2:11**, And the days that David reigned over Israel were forty years: seven years reigned he in Hebron, and thirty and three years reigned he in Jerusalem.

That is, King David reigned from the “City of David” (Zion) before moving to Jerusalem. King David had major problems when ruling from Jerusalem.

**1 Kings 3:1** And Solomon made affinity with Pharaoh king of Egypt, and took Pharaoh's daughter, and brought her into the city of David, until he had made an end of building his own house, and the house of the LORD, and the wall of Jerusalem round about.

Again, King David had stayed in the “City of David” (Zion) until he finished building work at Jerusalem, thus showing there is a difference between the two places.

**1 Kings 8:1** Then Solomon assembled the elders of Israel, and all the heads of the tribes, the chief of the fathers of the children of Israel, unto king Solomon in Jerusalem, that they might bring up the ark of the covenant of the LORD out of the city of David, which is Zion.

Here again the Ark of the Covenant was brought from The City of David (Zion) to Jerusalem, this again showing there is a difference between the two places.

King Solomon and those kings who followed immediately after him were all buried in the City of David rather than at Jerusalem. Note again that the “City of David” is “Zion”, not Jerusalem.

[As an aside, when visiting Jerusalem today, tourists are shown what is now known as, “The Tower of David” giving the impression that Zion is within the walls of Old Jerusalem. However, with a little digging it is found that this should be called, “The Tower of Herod the Great”].

### THE MILLENNIAL KINGDOM

What are important are the prophecies that tell us where the centre of the millennial kingdom will be? These also tell us about who racially will rule with the King there. Other races will bring their offerings, but they will not be within



the City of God. Preconceptions suggest that the “City of God” is Jerusalem, but it is Zion.

**Psalm 87:1** “The LORD loveth the gates of Zion more than all the dwellings of Jacob. Glorious things are spoken of thee, O city of God. Selah”.



The “City of God” is also described as “The New Jerusalem”

**Rev. 3:12** “Him that overcometh will I make a pillar in the temple of my God, and he shall go no more out: and I will write upon him the name of (“my” is added) God, and the name of the city of my God, which is new Jerusalem, which cometh down out of heaven from my God”.

**Isaiah 65:17.** “For, behold, I create new heavens and a new earth: and the former shall not be remembered, nor come into mind. But be ye glad and rejoice for ever in that which I create: for, behold, I create Jerusalem a rejoicing, and her people a joy. And I will rejoice in Jerusalem, and joy in my people: and the voice of weeping shall be no more heard in her, nor the voice of crying. There shall be no more thence an infant of days, nor an old man that hath not filled his days: for the child shall die an hundred years old; but the sinner being an hundred years old shall be accursed. And they shall build houses, and inhabit them; and they shall plant vineyards, and eat the fruit of them. They shall not build, and another inhabit; they shall not plant, and another eat: for as the days of a tree are the days of my people, and mine elect shall long enjoy the work of their hands”.

Some people claim that the oceans remain and that “no more sea” refers to the “sea of ungodly men”, but the word “thalassa” is about the oceans where ships sail-(Rev. 17:18). The references about people and children, planting vineyards

and trees do not suggest a spiritual interpretation of “Jerusalem” even at the time of the “New Jerusalem”. Neither do the verses below that mention boys and girls playing in the streets or about old men and old women being in Jerusalem. The earth will indeed be a “new earth” when it is “a new earth wherein dwelleth righteousness”. This vision of the New Jerusalem is what the Old Jerusalem becomes as the Lamb’s bride and is the “New Jerusalem”.

**Hosea 2:16** “And I will betroth thee unto me for ever; yea, I will betroth thee unto me in righteousness, and in judgment, and in lovingkindness, and in mercies. I will even betroth thee unto me in faithfulness: and thou shalt know the LORD”.

“Betrothal” is about marriage!

The following verses present to us a picture that is not often painted. They all confirm the multitude of Scriptures about the re-gathering of the House of Israel and the House of Jacob, that is, “all Israel”. As Paul puts it, “And so all Israel shall be saved: as it is written, There shall come out of Zion the Deliverer, and shall turn away ungodliness from Jacob” – (Romans 11:26”.

From whom? Who are cleansed? The passages all confirm that a particular “earth” is the Lord’s and that the people that dwell therein alone are described as being “The Lord’s”. These verses confirm that the “Bride of Christ” is not “The Church” [in the popular concept].

So what is yet to happen? What better than to make some quotes that are worth reading carefully to see just who is involved!

Isaiah 2:2-6 And it shall come to pass in the last days, that the mountain of the LORD'S house shall be established in the top of the mountains, and shall be exalted above the hills; and all nations shall flow unto it. And many people shall go and say, Come ye, and let us go up to the mountain of the LORD, to the house of the God of Jacob; and he will teach us of his ways, and we will walk in his paths: for out of Zion shall go forth the law, and the word of the LORD from Jerusalem. And he shall judge among the nations, and shall rebuke many people: and they shall beat their swords into ploughshares, and their spears into pruning hooks: nation shall not lift up sword against nation, neither shall they learn war any more. O house of Jacob, come ye, and let us walk in the light of the LORD.

Here again is the Law of the King from Zion and the Word of the Lord from Jerusalem.

**Isaiah 4:3-6** And it shall come to pass, that he that is left in Zion, and he that remaineth in Jerusalem, shall be called holy, even every one that is written among the living in Jerusalem: When the Lord shall have washed away the filth of the daughters of Zion, and shall have purged the blood of Jerusalem from the midst thereof by the spirit of judgment, and by the spirit of burning. And the LORD will create upon every dwelling place of mount Zion, and upon her assemblies, a cloud and smoke by day, and the shining of a flaming fire by night: for upon all the glory shall be a defence. And there shall be a tabernacle for a shadow in the daytime from the heat, and for a place of refuge, and for a covert from storm and from rain.

**Isaiah 33:20-22** Look upon Zion, the city of our solemnities: thine eyes shall see Jerusalem a quiet habitation, a tabernacle that shall not be taken down; not one of the stakes thereof shall ever be removed, neither shall any of the cords thereof be broken. But there the glorious LORD will be unto us a place of broad rivers and streams; wherein shall go no galley with oars, neither shall gallant ship pass thereby. For the LORD is our judge, the LORD is our lawgiver, the LORD is our king; he will save us.

**Revelation 3:12** Him that overcometh will I make a pillar in the temple of my God, and he shall go no more out: and I will write upon him the name of my God, and the name of the city of my God, which is new Jerusalem, which cometh down out of heaven from my God: and I will write upon him my new name.

**Revelation 21:1-3** And I saw a new heaven and a new earth: for the first heaven and the first earth were passed away; and there was no more sea. And I John saw the holy city, new Jerusalem, coming down from God out of heaven, prepared as a bride adorned for her husband. And I heard a great voice out of heaven saying, Behold, the tabernacle of God is with men, and he will dwell with them, and they shall be his people, and God himself shall be with them, and be their God.

**Zephaniah 3:14-20** Sing, O daughter of Zion; shout, O Israel; be glad and rejoice with all the heart, O daughter of Jerusalem. The LORD hath

taken away thy judgments, he hath cast out thine enemy: the king of Israel, even the LORD, is in the midst of thee: thou shalt not see evil any more. In that day it shall be said to Jerusalem, Fear thou not: and to Zion, Let not thine hands be slack. The LORD thy God in the midst of thee is mighty; he will save, he will rejoice over thee with joy; he will rest in his love, he will joy over thee with singing. I will gather them that are sorrowful for the solemn assembly, who are of thee, to whom the reproach of it was a burden. Behold, at that time I will undo all that afflict thee: and I will save her that halteth, and gather her that was driven out; and I will get them praise and fame in every land where they have been put to shame. At that time will I bring you again, even in the time that I gather you: for I will make you a name and a praise among all people of the earth, when I turn back your captivity before your eyes, saith the LORD.



**Zechariah 8:1-8** Again the word of the LORD of hosts came to me, saying, Thus saith the LORD of hosts; I was jealous for Zion with great jealousy, and I was jealous for her with great fury. Thus saith the LORD; I am returned unto Zion, and will dwell in the midst of Jerusalem: and Jerusalem shall be called a city of truth; and the mountain of the LORD of hosts the holy mountain. Thus saith the LORD of hosts; There shall yet old men and old women dwell in the streets of Jerusalem, and every man with his staff in his hand for very age. And the streets of the city shall be full of boys and girls playing in the streets thereof. Thus saith the LORD of hosts; If it be marvellous in the eyes of the remnant of this people in these days, should it also be marvellous in mine eyes? saith the LORD of hosts. Thus saith the LORD of hosts; Behold, I will save my people from the east country, and from the west country; And I will bring them, and they shall dwell in the midst of Jerusalem: and they shall be my people, and I will be their God, in truth and in righteousness.

**Hebrews 12:22-29** But ye are come unto mount Sion, and unto the city of the living God, the

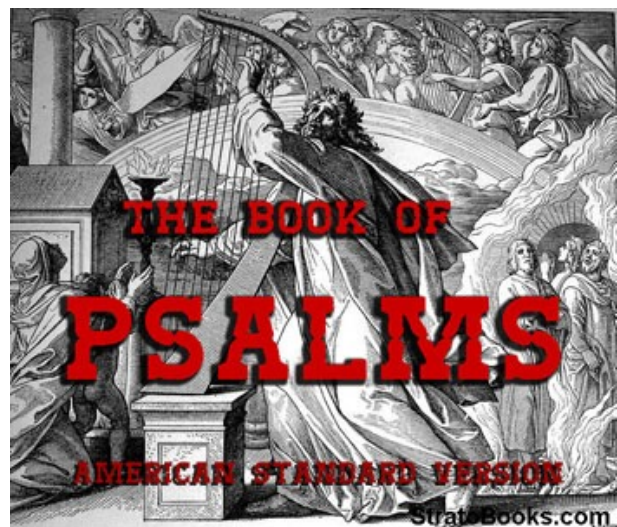
heavenly Jerusalem, and to an innumerable company of angels, To the general assembly and church of the firstborn, which are written in heaven, and to God the Judge of all, and to the spirits of just men made perfect, And to Jesus the mediator of the new covenant, and to the blood of sprinkling, that speaketh better things than that of Abel. See that ye refuse not him that speaketh. For if they escaped not who refused him that spake on earth, much more shall not we escape, if we turn away from him that speaketh from heaven: Whose voice then shook the earth: but now he hath promised, saying, Yet once more I shake not the earth only, but also heaven. And this word, Yet once more, signifieth the removing of those things that are shaken, as of things that are made, that those things which cannot be shaken may remain. Wherefore we receiving a kingdom which cannot be moved, let us have grace, whereby we may serve God acceptably with reverence and godly fear: For our God is a consuming fire.

**Micah 4:1** But in the last days it shall come to pass, that the mountain of the house of the LORD shall be established in the top of the mountains, and it shall be exalted above the hills; and people shall flow unto it. And many nations shall come, and say, Come, and let us go up to the mountain of the LORD, and to the house of the God of Jacob; and he will teach us of his ways, and we will walk in his paths: for the law shall go forth of Zion, and the word of the LORD from Jerusalem. And he shall judge among many people, and rebuke strong nations afar of; and they shall beat their swords into plowshares, and their spears into pruninghooks: nation shall not lift up a sword against nation, neither shall they learn war any more. But they shall sit every man under his vine and under his fig tree; and none shall make them afraid: for the mouth of the LORD of hosts hath spoken it. For all people will walk every one in the name of his god, and we will walk in the name of the LORD our God for ever and ever. In that day, saith the LORD, will I assemble her that halteth, and I will gather her that is driven out, and her that I have afflicted; And I will make her that halted a remnant, and her that was cast far of a strong nation: and the LORD shall reign over them in mount Zion from henceforth, even for ever.

And thou, O tower of the flock, the strong hold of the daughter of Zion, unto thee shall it come,

even the first dominion; the kingdom shall come to the daughter of Jerusalem. Now why dost thou cry out aloud? is there no king in thee? is thy counsellor perished? for pangs have taken thee as a woman in travail. Be in pain, and labour to bring forth, O daughter of Zion, like a woman in travail: for now shalt thou go forth out of the city, and thou shalt dwell in the field, and thou shalt go even to Babylon; there shalt thou be delivered; there the LORD shall redeem thee from the hand of thine enemies. Now also many nations are gathered against thee, that say, Let her be defiled, and let our eye look upon Zion. But they know not the thoughts of the LORD, neither understand they his counsel: for he shall gather them as the sheaves into the floor. Arise and thresh, O daughter of Zion: for I will make thine horn iron, and I will make thy hoofs brass: and thou shalt beat in pieces many people: and I will consecrate their gain unto the LORD, and their substance unto the Lord of the whole earth.

At the end of the last verse above, the word “whole” as in “whole earth” is not in the Masoretic Text. The word is simply “erets” and the Septuagint supplies “Israel” (genitive). Thus, this refers to the earth (land) of Israel.



**Psalm 24:1** “The earth is the LORD’S, and the fulness thereof; the world, and they that dwell therein”.

We see “the world” = “tebel” as being a localized land area and “the fullness” has reference to what Joseph’s son Ephraim would become – (Genesis 48:19 where it is translated as “multitude”). This passage goes on to say:

**V3-6** “Who shall ascend into the hill of the LORD? or who shall stand in his holy place? He

that hath clean hands, and a pure heart; who hath not lifted up his soul unto vanity, nor sworn deceitfully. He shall receive the blessing from the LORD, and righteousness from the God of his salvation. This is the generation of them that seek him, that seek thy face, O Jacob. Selah.

“The hill of the Lord” is found only here and agrees with Psalm 2:6, “Yet have I set my king upon my holy hill of Zion”. The references to this being God’s dwelling place cannot be missed, such as Psalm 76:2, “...and his dwelling place in Zion”.

“Generation” here is “dowr” and is a word approximating “the circle of life” as it applies to the one particular posterity. This posterity is described in this passage (as always) as being that of “Jacob”.

The land promised to Jacob is the “earth” that is “The Lord’s”. For ever!! Selah!

Having pointed all the above out, we can now tie up what might be seen as being loose ends to some people.

## The Incredible Story Of Lia-Fail And The Marble Chair (Part 5) By John D. Keyser

### An Early Coronation

**A**uthor E. Raymond Capt writes about an early coronation ceremony in the Abbey of Scone:

One of the **earliest** records of a **coronation** is preserved in the account of John of Fordun, the Scottish chronicler who died about A.D. 1384. He tells us that the **stone** was used in the coronation of Alexander III. in A.D. 1249:

"...and, having there placed him in the **Regal Chair**, decked with silk clothes and embroidered with gold, the Bishop of St. Andrew's, the others assisting him, consecrated his king, the king himself sitting, as was proper, **upon the Regal Chair** -that is, **The Stone** -- and the earls and other nobles placing vestments under his feet with bent knees, **before the stone**. This stone is reverently preserved in that monastery [in **Scone**] for the consecration of kings of Scotland; nor were any of the kings in want to reign anywhere in Scotland, unless they had, on receiving the name of king, first **sat upon this royal stone in Scone**, which was constituted by ancient kings the '**Sedes Superior**' or **principal seat**." -- "Jacob's Pillar," p.48.

Previously, King Kenneth II., who died in 995, had the **Coronation Stone** placed on a wooden pedestal in front of the high altar of the Abbey of Scone. "This pedestal had a wooden shaft which could be raised or lowered according to the height of the monarch to be crowned, enabling the king to sit with comfort and dignity, his kilt being arranged to **cover the Coronation Stone completely**. At the same time, the King

had an inscription engraved **on one side of the stone**:

*Ni fallat fatum, Scoti quocunque, Invenient lapidum regnare tenentur ibidem.*

### Translation:

*"If fate go right, where're this STONE is found, The SCOTS shall monarchs of that realm be crowned."*



This prophecy was certainly fulfilled when **King James VI (left) of Scotland** became **James I. of England**. It should be noted that the present **royal house of Britain** is descended from the Scottish kings, through Queen Elizabeth of Bohemia, the daughter of James VI., whose

daughter Sophia married the Elector of Hanover; their son became **Britain's King George I.**" (Ibid., P.48).

### Edward I. Seizes the Stone

Alexander III. died in 1286, leaving the throne to his infant granddaughter and only living descendant. Known as the Maid of Norway, the infant died in 1290 at the age of seven. This produced a **political crisis** in Scotland, with no less than thirteen descendants of former monarchs laying claim to the throne of Judah. The Scots asked **Edward I. of England**, noted

for his wisdom, to arbitrate. This he agreed to do -- on the terms that the Scots recognize him as "overlord"; and he intervened on behalf of John de Baliol, a grandson of David I. and chief pretender to the throne of Scotland. A certain number of the Scottish nobility formerly recognized Edward's "overlordship" in the dispute and, in 1292, after leading an English army into Scotland, Edward proclaimed John de Baliol the new king of Scotland.



The coronation of John Baliol is described by William Rishanger in his Chronicle, written about 1327: "John de Balioll, on the following feast of St. Andrew's, placed upon **the regal stone, which Jacob placed under his head** when he went from Bersabee to Haran, was solemnly crowned in the church of the canons regular at Scone...."

However many Scottish nobles, and the **overwhelming majority** of the Scottish people, bitterly resented English interference in their national affairs. Giving in to the wishes of the people for a termination of English control in the land, Baliol formed an alliance with the French in 1295. At this time the French were at war with England. Baliol then summoned the Scottish people to revolt against Edward, who summarily crushed Baliol's army at Dunbar in April, 1296. As a result, Edward decreed the annexation of Scotland to England; and John de Baliol was deposed. Scotland was immediately placed under military occupation.

In order to **thwart** the Scottish royal line, Edward then seized the **Coronation Stone** and ordered it to be transported to Westminster Abbey in London:

It is said that Edward noted the Scots reverence for the "**Stone of Scone**." He was aware of the **tradition** inspired by the ancient inscription of King Kenneth II. that wherever the **Stone** should be, a king of **gaelic blood** would reign. **seeking to defeat this tradition**, he had the **Stone** transferred to **Westminster Abbey**, where, ever since, it has been reverently cherished.

Not only was the **Stone** offered to Edward for safe-keeping but also the **Golden Scepter**, the **Crown of Scotland** and some **crown jewels**. To show his respect for the **Stone of Scone**, Edward had built a **beautiful chair of hardwood**, six feet, seven inches high, in which to **hold the stone**. Known as "Saint Edward's Chair" or the "Coronation Chair," it has ever since been kept in the chapel named for him.

It [the stone] was later claimed by the **Scots**, in connection with the Treaty of Northampton, in 1328, that **Edward II.** promised to restore the **stone** to Robert the Bruce. The **crown, scepter**, emeralds, pearls, and rubies were returned. But the **stone** was held in such respect by the people of London that **they would not allow it to be removed**. In SPITE of its location today, the **ancient tradition** that wherever the Stone should be, "a king of Gaelic blood would reign" **has not failed**. **King James VI. of Scotland** was crowned on the Stone in Westminster Abbey when he became **James I. of England**; and, today Britain's lovely Queen is **Scottish**. -- "Jacob's Pillar," p.53.

Not only is Queen Elizabeth II. Scottish, **she is of the royal line of Judah!**

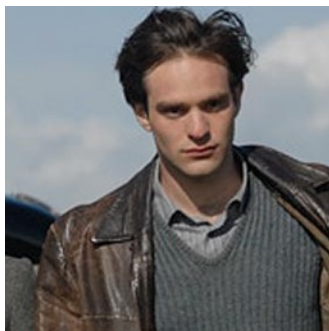
Brigadier G. Wilson, in his tract "Co-Incidences? Pointers to Our Heritage," adds a few more details:

It is not generally known that when **Edward I.** seized the **Coronation Stone** from the Scots he also carried off their highly treasured symbols and regalia of kingship and national sovereignty, as well as all the **documents** that could be found relating to Scotland's freedom and independence.

In response to the Scots earnest entreaties for their return there is reason to believe that Edward at least considered returning the '**archives**' and symbols of sovereignty, including their treasured '**White Wand or Rod**' and their '**Rood Cross**': but he **flatly refused** to return the **Coronation**

**Stone.** Nothing was done about it until the young **Edward III.** came to the throne. Younger and just beginning his reign he was more ready to compromise than his grandfather Edward I. He negotiated the **Treaty of Northampton** with The Bruce, and a **marriage** was arranged between Bruce's son and heir and Edward's sister. Edward III. agreed to return the 'Archives' and all the other national symbols which are mentioned in the Treaty, but there is (conspicuously) **no mention** of returning the **stone** -- presumably because this was 'not negotiable'! It was reported that the **citizens of London** refused to allow him to consider parting with it! -- P.6.

### The Stone Disappears!

The final chapter in the story of Lia Fail is an intriguing one-- just as exciting and full of mystery as all the previous ones! Let E. Raymond Capt recount the fascinating story:

On Christmas Eve, 1950, the recesses of St. Edward's Chapel in Westminster Abbey echoed to the sweet music of Noel in the Chapel stood Britain's Coronation Chair, under it the **Coronation Stone**, standing just as they had stood for **seven hundred years**. In the silent, eerie dimness of the early hours of Christmas morning, furtive figures stealthily entered St. Edward's Chapel, then were gone -- **and so was the Coronation Stone**.

How and by whom, this Stone, weighing over 300 pounds, was so surreptitiously spirited from its resting-place, out of the locked Abbey, was one of Britain's greatest mysteries. A splinter broken from the leg of the Coronation Chair, a short crowbar, some fingerprints, an unidentified wristwatch on the flagstones of the Abbey floor, marks on the altar step's carpet where the Stone had been dragged, and "J.F.S." carved on the chair itself were the **only evidence** of the "sacrilegious" crime which shocked all Britain. Naturally, the solving of such a crime became the first priority of Scotland Yard.

Despite the lack of evidence, it was believed that the Stone was stolen by persons having

sympathy with the **Scottish Nationalist Movement**. -- "Jacob's Pillar," p.61.

A week after the theft a Glasgow newspaper -- the Daily Record-- received a letter asking that one copy of the enclosed Petition should go to the police and the other to the press. According to the Scottish Daily Express of December 30, 1950, the Petition stated the following:

The petition of certain of his Majesty's most loyal and obedient subjects to his Majesty King George the Sixth humbly sheweth:

That his Majesty's petitioners are the persons who removed the **Stone of Destiny** from Westminster Abbey:

That, in removing the **Stone of Destiny**, they have no desire to injure his Majesty's property, nor to pay disrespect to the Church of which he is the temporal head:

That the **Stone of Destiny** is, however, the most ancient symbol of Scottish nationality and, having been **removed from Scotland by force** and retained in England in breach of the pledge of his Majesty's predecessor, King Edward III. of England, and its proper place of retention is among his Majesty's Scottish people who, above all, **hold the symbol dear**:

That therefore his Majesty's petitioners will most readily return the **Stone** to the safe keeping of his Majesty's officers if his Majesty will but graciously assure them that in all time coming the Stone will remain in Scotland in such of his Majesty's properties or otherwise as shall be deemed fitting by him:

That such an assurance will in no way preclude the use of the Stone in any coronation of any of his Majesty's successors whether in England or Scotland:

That his Majesty's humble petitioners are prepared to submit to his Majesty's Ministers or their representatives proof that they are the people able, willing, and eager to restore the **Stone of Destiny** to the keeping of his Majesty's officers:

That his Majesty's petitioners, who have served him in peril and peace, pledge again their loyalty to him, saving always their right and duty to protest against the actions of his Ministers if such actions are contrary to the wishes of the spirit of his Majesty's people:

In witness of the good faith of his Majesty's petitioners the following information concerning a **watch** left in Westminster Abbey on December

25, 1950, is appended: (1) The mainspring of the watch was recently repaired; (2) The bar holding the right-hand wrist strap to the watch had recently been broken and soldered:

This information is given in lieu of signature by his Majesty's petitioners, being in fear of apprehension.

Out of this theft of the Coronation Stone an interesting story emerged:

In pulling the Stone, by one of the **iron rings** (one embedded in each of the ends of the Stone), along the Abbey floor, an ancient **crack** in the Stone parted. The **Stone of Destiny** lay in two pieces. Its weight divided into **two parts** facilitated its removal from the Abbey.

Soon after the theft, an alarm was given and road-blocks were set up on all roads leading out of England, and everyone was asked to be on the look-out for the Stone -- to report any suspicious circumstances. The car, with the Stone concealed as a cushion in the back seat with a coat covering it made a stop near the Scottish border for gasoline. When the occupants of the car were asked by the station attendant if they had the Stone of Destiny with them, they replied, "Aye sure, its in there, its in the boot [trunk]. Letting the reward of over \$2000.00 for information leading to the recovery of the Stone slip through his fingers the attendant laughing said, "Well, the police have been around once asking me what Scotsman I've given petrol to. If they come back, I'll tell them the Stone went through this morning." -- "Jacob's Pillar," pp.62-63.

The Stone was evidently repaired by the high-jackers with doweling and cement. Before marrying the two pieces together, a copy of the **Scottish declaration of independence** was placed between them. Perhaps, then, this act satisfied Scottish patriotism which cried out for the Stone's restoration to Scone. Actually, the arguments presented in the petition to the Scottish Daily Express are invalid. The **Treaty of Northampton**, referred to in the petition, was negotiated between Edward III. of England and Robert, King of the Scots -- **not** between the countries of England and Scotland. And, since the rights of **both monarchs** later became vested in Queen Elizabeth II. (the Queen of the **United Kingdom**), no transfer of title between them can make a bit of difference today! **the ownership of the Stone of Destiny or Lia Fail is incontestable**. It belongs to the heirs and descendants of Queen Elizabeth II. who are able to trace their line from both Edward III. of England and Robert, King of the Scots.

Capt concludes by saying that "Eventually the Stone of Destiny was recovered by the English. It was wrapped up in the Scottish flag (St. Andrew's Cross) and left upon the high altar of the ruined Abbey of Arbroath in Scotland, then the British authorities were notified of where it could be found. It was at **Arbroath Abbey** that King Robert the Bruce and the Scottish Barons drew up the famous "Declaration of Independence" which included the following:

"For so long as a hundred of us are left alive we will yield in no least way to English domination. We fight not for glory, nor for wealth nor for honour, but only and alone for freedom, which no good man surrenders but with his life." (Ibid, p.63).

### A Chair or a Stone?

If you are at all observant, something in the story of the Coronation Stone should have puzzled you -- some sources call it a **Stone**, whereas others call it a **chair**! What is it then, a chair or a stone?

Hector Boece stated that Gathelus placed a **chair of marble** in the town of Brigance in Spain; while Andrew of Wyntown mentioned that a son of Gathelus took a **Stone-Throne** to Ireland. Boece mentions that when Fergus son of Ferquhard went to the aid of the colony from Scythia, he took the **Stone** of Destiny with him and was crowned on it. Yet, elsewhere, in the same work, Boece says: "Fergus, son of Ferchard...brought the **Chair** from Ireland to

Argyll, and was crowned on it." Following this -- according to Boece -- Fergus "built a town in Argyll called Beregonium, in which he placed it [**The Chair**]." However Evenus, the twelfth king from Fergus, built a town called Evonium "to which the **Stone** was removed...."

Centuries later E. Raymond Capt records that: "On Iona the 'stone Lia Fail' continued to be used as the Coronation **Stone** of the Dalriadic kings until its removal to Dunstaffnage...." Yet again, however, we have this same contradiction when James Brown claims that the "marble **Chair**, the emblem of sovereignty," was moved by Kenneth MacAlpin "from Dunstaffnage to Scone..."; while the "Encyclopaedia Britannica" states that "Kenneth [MacAlpin] is alleged to have brought the **Stone** of Destiny...from Dunstaffnage...and to have deposited it in Scone...."

In John of Fordun's account of the coronation of Alexander III. in A.D. 1249, we find that the new king was placed "upon the regal **Chair** -- that is, the **Stone**!" So I ask the question again-- was it a chair or a stone?

Finally, Edward I. of England, when he annexed Scotland to England in 1296, moved the **Stone** to Westminster Abbey in London where "he built a beautiful **Chair** of hardwood...to hold the **Stone**." Obviously, it was a stone, not a chair, that was taken to London.

Let Hector Boece, in his "Chronicles of Scotland" (1527 edition), summarize the outline I have just given:

Gathelus, a Greek, the son of either the Athenian Cecrops or the Argive Neolus [the same person], went to Egypt at the time of the Exodus, where he married Scota, the daughter of Pharaoh, and after the destruction of the Egyptian army in the Red Sea, fled with her...till he arrived in Portingall [Portugal], where he landed, and founded a kingdom at Brigantium, now Compostella. Here he reigned **in the Marble Chair**, which was the "lapis fatalis cathedrae instar," or **fatal stone like a chair**, and wherever it was found portended kingdom to the Scots. In after ages it bore the following inscription:

**Ni fallat fatum, Scoti, quocunque locutum  
Invenient lapidem, regnare tenentur ibidem.  
which Ballenden [translator of Boece's  
work] thus translates:  
The Scottis sall brwke that realme as native  
ground,  
Geif wierdis failt nocht, wherever this  
CHAIR is found.**

...a descendant of Gathelus, brought the **Chair** from Spain to Ireland, and was crowned in it as King of Ireland.

Fergus, son of Ferchard, was first King of the Scots in Scotland, and brought the **Chair** from Ireland to Argyll, and was crowned in it. He built a town in Argyll called Beregonium, in which he placed it [the **Chair**]. From him proceeded forty kings of Scotland. The twelfth king, Evenus, built a town near Beregonium, called after his name Evonium, now called Dunstaffnage, to which the **Stone** was removed, and the remainder of the forty kings are all crowned in Dunstaffnage, reign there, and are buried there. The Scots are expelled to Ireland under the last of the forty kings, but return under his nephew Fergus Mac Eric, who is crowned in the **Marble Chair**. He builds a church at Iona, and commands it to be the sepulchre of the kings in the future.



Kenneth MacAlpin (left), the last of these kings, conquers the Picts, and brings the **fatal stone** from Argyll to Gowry, and places it in Scone, because it was there that his principal victory over the Picts had taken place. Some say that he then caused the verse to

be inscribed on the **Stone** beginning "Ni fallat fatum."

#### **How, then, do we resolve the puzzle?**

Pennant, whom we have already quoted, has the answer! "In the church of the abbey (at Scone) was preserved the **famous chair, whose bottom [seat] was the fatal stone....**" (Tour in Scotland, vol. iii, p.116). This "bottom" was the **seat** or **cushion** that rested in the marble chair! An example of this can be found in the Marmorne Stuhl, or **Marble Chair**, in which Charlemagne is said to have sat, and the emperors of Germany were at one time crowned. This chair is still preserved at Aix la Chapelle. It is a plain, heavy chair of white marble on five steps, and is believed to have been covered with plates of gold during a coronation. William F. Skene says that "the Scotch stone may have been similarly raised, and the **seat alone** taken to England, and inserted in the wooden chair made by Edward I." ("The Coronation Stone," p.15).



That there was both a **Marble Chair** and a **Stone Seat** at Scone is made plain by Skene:

We find that the kings of Scotland were not only crowned at Scone, but held parliaments there. these parliaments met on the **Moot Hill of Scone**. Thus Robert II. was crowned at Scone on the 26th day of March, 1371, by the Bishop of St. Andrews, in presence of the prelates, earls, barons, and other nobles of Scotland, and of a great multitude of the people; and on the following day convened the prelates, earls, barons, and nobles before him, 'the king **sitting**, as use is, **in the royal seat, upon the Mount of Scone....**'

**In a footnote to this passage Skene states:**

Rege sedente in Sede Regia super montem de Scone ut est moris.-- Act Parl. Scot., p.181. This "Sedes Regia" must **not** be confounded with the **stone seat** which was used at the **coronation** only, and was kept in the Abbey church, to which the name of "**Cathedra**" is always applied. The **royal seat** here referred to was placed on the Moot Hill, and used when the king **presided at a parliament** or court of justice. It was on this **seat [chair] on the moot hill** that Robert Bruce was crowned in 1306, "in sede positus regali," **after the seat [cushion] called the "cathedra," or stone had been removed to England.** -- "Fordun a Hearne," vol.IV. P.997.

In other words, for a coronation the **Stone**, or Jacob's Pillar, was brought out of the Abbey church and placed **in the Marble Chair**; and then, after the ceremony, was returned to the Abbey for safekeeping! The **Marble Chair** or **Throne** was used by the king for state occasions

-- without the **seat** or cushion called the Fatal Stone.

William Skene continues: "Dr. Joseph Robertson adds, "that there appears some reason to suppose that **there were two stones at Scone** -- (1) **the stone of fate**, now at Westminster; (2) a **STONE CHAIR** in which it would seem **the stone of fate was placed** when kings were to be inaugurated...." (Ibid).

It is uncertain whether Gathelus brought the **Marble Chair** from Egypt to Spain, or whether he had the chair made in Spain as a receptacle for Jacob's stone. There is some indirect evidence in the "Cronicon Rythmicum" that states "that Gaythelus brought the stone, which it calls 'lapis Pharaonis,' or Pharaoh's stone from Egypt, and applies to it the epithet of 'anchora vite,' probably the origin of Fordun's second account that it was raised with the anchor." ("The Coronation Stone," by William F. Skene. Edmonston & Douglas, Edinburgh. MDCCCLXIX. P.16).

"Fordun's second account" referred to here is a fabulous and mythical story about how Simon Brec, the youngest son of the king of Spain, "having cast anchor on the shore of Ireland, and again weighed anchor in consequence of a storm, raised, with his anchor, a **stone of marble, cut in the shape of a chair.**"

In any event, it seems quite clear that Jacob's Pillar-stone was placed in a **Marble Chair** every time a descendant of Judah was crowned king; and between coronations it appears to have been kept in an abbey or church for safekeeping

If real, you would expect the Round Table to be situated somewhere in Manann/Manau. Not of course a table, but something to which the name Round Table became attached.

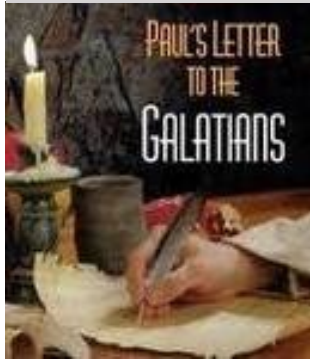

# The Book Of Galatians And An Israel Exclusive (3)

**IN THE BOOK OF ROMANS** we find that the corrected translation of Hellen as “Greeks” rather than “Gentiles” gives a whole new direction. Both “Judeans and the Dispersion” are parts of the one body. There is a common

connection with the Law which was only given to Israel as a whole. Paul tells of the work of the Law written on their hearts. This is a fulfilment of prophecy given only to and about Israel [Jer 31:31], under the new covenant. At that time only one part [the Judean side] of the whole race of Israel was acknowledging the Law. The other side of Israel was called the Uncircumcision because they were not acknowledging the Law. But both parts are concluded under sin. Throughout this Book of Romans there is much reference to the Law. The Book is written to those who were under the Law [Rom 3:19], that is, to Israel. The book is not addressed to other races.

**IN 1 CORINTHIANS 12:13**, above, is another place where Hellen is translated as “Gentile” instead of “Greeks”. The section begins with a definition in the first verse as to who these “Greeks” were.

1 Cor 10:1 ... how that our fathers ... all passed through the sea ... were all baptized unto Moses ...

This could not be said of any non-Israelite race. This whole passage tells that they were Israelites. It tells of their early history!

1 Cor 12:13 For by one spirit are we baptized into one body, whether we be Jews or Gentiles [Hellen: Greeks], ...

That is, whether from Judea or from the Dispersion. This is what has been shown earlier where the common factor connecting these two peoples was the One Spirit and the Anointing. But, why does the Apostle Paul not use the word ethnos which is often also translated as “gentile”? Why does Paul specify hellen (or

Greek) when it comes to important doctrine? Could this be in order that there might be no mistake about his meaning? Is it that there might be no mistake about who he is isolating? Paul was writing to his ‘brethren’ – fellow Israelites scattered in Asia and nearby areas, as opposed to the former nations of Israel as they were known in the Old Testament. (We do not pay sufficient attention to the use of such titles – each one is used in accordance with the subject matter and authority behind the situation.)

**IN ALL THE NEW TESTAMENT** we must register that the word Hellen (Greek) and its variations are used thirty five times. This is a lot of times! There is never one proposition that the word might mean someone who is not an Israelite. The translators seem to have thought that this should have been so because they at times switch the translation to “gentiles”, which they thought might suggest non-Israelites. There is no explanation ever presented to support the view that “Greeks” means all the “non-Jewish” races.

**FROM HISTORY** we find just where the body of the Dispersion was at that time following the captivities in Assyria and Babylon. They were about parts of the old Greek empire – in Northern Greece and Asia Minor. It is not unreasonable then that they should be called “Greeks”, because this is where they were found. We can also see this from where the Apostle Paul travelled; this is the area where they were. It does not say that they were Greeks by race or that they were non-Israelites. The concordances suggest that they were “Greek speaking”



**COMMENT:** The Apostle Paul came from the city of Tarsus in Cilicia (above); this made him one of the “Greeks”. He was a Hebrew by birth,

a Benjamite by tribe, and a Roman by citizenship. And he was a “Jew” (Judean) because he was brought up in Judea and a Pharisee, trained in Judaism. [Never forget these dual meanings of “Jew”!]. A national term does not determine racial origin in itself. Can anyone be justified in continuing to say that race and birthplace are always the same to prove a doctrine? Yet, this is what we hear as a common teaching!

### CHILDREN OF PROMISE

Gal 4:28 Now we, brethren, as Isaac was, are the children of promise.

This passage is an allegory [v24] and a comparison of relationships between those who are under the Law and those of them who have become partakers of the promise under the New Testament. The Law is the issue all the way through. The issue is not Israelites and non-Israelites, because the non-Israelites never had the Law-covenant in the first place. In verse 5 we are told Jesus came to redeem them who were under the Law that WE might receive the adoption (placing) of (as) sons. There is never a suggestion about any who were not “brethren” being redeemed or of receiving the adoption. They all have to be brothers or “brethren” of the same race. They are all adelphos or kinsmen from the same womb. Some will not like this definition so, let us consider some lexicon and dictionary sources.

### THE WORD ‘BRETHREN’

Thayer: From the same womb ... a brother ... any blood relation or kinsman ... having the same ancestor ... belonging to the same people ... a fellow-man ... one having descended from the same father.

Vine: Adelphos denotes a brother or near kinsman. In the plural, a community based on identity of origin of life.

Davidson: Adelphos [A plus delphus ... the womb] a brother, a near kinsman or relative; one of the same nation or nature.

Bullinger: Adelphos = brother, or gen, near kinsman, then in the plural, a vital community based on identity of origin.

This word is translated over 100 times as brother, for example, Peter and James his brother [Matt 4:18]; James and John, his brother [Matt 17:1]. When we read this word, brethren, as used in all the epistles, we can now see exactly what the word means. They are not spiritual brethren! They are kinsmen. They are all Israelites! In no way can they be fellow-believers from all non-kinsman races. We will be looking at this again (in the chapter Seeds, Natural and Spiritual). These are the ones who are told to look unto the rock whence ye are hewn, and to the hole of the pit whence ye are digged, look unto Abraham your father, and Sarah that bare you ... [Isaiah 51:1,2]. This limits the scope to those who came from Abraham and Sarah.

### ISAAC ... HEARING FAITH ... AND FREEBORN SONS

All that will be said here is that again we have, in Galatians 4:29, what was mentioned earlier about born of the Spirit. This is the allegorical equivalent of the anointed people being conceived containing that spirit. Those people could remain under the Law, or come under Grace. They are the same people who began under the Law [Gal 3:3]. They were able to subject themselves either to the works of the Law or to the hearing of faith [Gal 3:5] and to become righteous through hearing, believing and doing what God asked, as Abraham did. They were never justified just because they were born Israelites. The term “freeborn sons” that some use is used to suggest that somehow this can refer to other than Israelites.

Acts 13:39 And by him [that is, Jesus] all that believe are justified from all things, from which you could not be justified by the law of Moses.

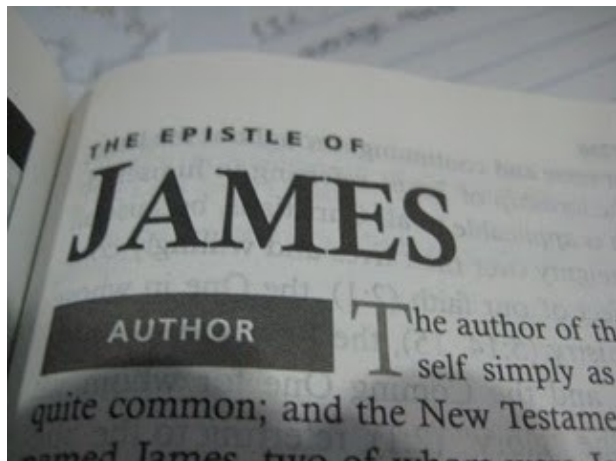


The Apostle Paul was talking again about the fulfilment of the promises that had been made to the fathers OF ISRAEL, as those people who had been given the Law of

Moses. Law and grace are an issue to Israel only.

The Edomite leaders of the Judean nation thought that physical birth gave them the right status with God when they protested that Abraham was their father, but Jesus made it clear to them they were not Abraham's children. [In John 8:37 we can see that there is a difference between Abraham's seed and Abraham's children.] Jesus said to them, ye cannot hear my words. Likewise Ishmael who was born after the flesh could not [and cannot] "hear". He is cast out. The linear descendants through Isaac could still be fools and be slow of heart to believe. They could be deceived or be bewitched. The truth is to be obeyed. Jesus had been evidently set forth crucified among you. Paul was specific as to whom he was addressing. It is these Israelites who have to choose, not other races.

James 2:21,22 Was not Abraham our father justified by works, when he offered Isaac his son upon the altar? Seest thou how faith wrought with his works, and by works was faith made perfect?



Note: In this section in the Book of James about faith and works, the our in Abraham OUR father is written unto Twelve Tribes [James 1:1]. Be fair here. Where is it declared that this is written to anyone else? He begat US with the word of Truth [James 1:18]. Where is it written that He begets any other than Israelites by the Word of Truth?

**IN THEE SHALL ALL NATIONS BE BLESSED**

Gal 3:7-9 Know ye therefore that they which are of faith, the same are the children of Abraham. And the scripture foreseeing that God would justify the heathen through faith, preached (proclaimed) before the gospel unto Abraham, saying, in thee shall all nations be blessed. So

then they which be of faith are blessed with faithful Abraham. This verse together with and the verses below, are favoured by universalists because they seem to present a universal gospel for all races. "Nations" is sometimes translated emotively as "Heathen" to try to add weight to the universal argument. To understand any passage of Scripture it is necessary to look at it as a whole by going back to the prophecy behind it to see what it is fulfilling. To Abraham:

Gen 12:2,3 And I will make of thee a great nation, and I will bless thee, and make thy name great; and thou shalt be a blessing: and I will bless them that bless thee, and will curse him that curseth thee, and in thee shall all families of the earth be blessed.

Gen 18:18 Seeing that Abraham shall surely become a great and a mighty nation, and all the nations of the earth shall be blessed in him?

Gen 22:18 And in thy seed shall all the nations of the earth be blessed; because thou hast obeyed my voice.

**To Isaac:**

Gen 26:3 Sojourn in this land, and I will be with thee, and will bless thee; for unto thee, and unto thy seed, I will give all these countries, and I will perform the oath that I sware unto Abraham thy father.

**To Jacob:**

Gen 28:14 And thy seed shall be as the dust of the earth, and thou shalt spread abroad to the west, and to the east, and to the north, and to the south: and in thee and in thy seed shall all the families of the earth be blessed.

**To Israel:**

Psalm 22:27 All the ends of the world shall remember and turn unto the Lord: and all the kindreds of the nations shall worship before thee.

Here are six important verses which are used to support the doctrine of universal racial salvation. Indeed, they do appear to give valid support on the surface. But do they actually say what the religious translators make them say? Is this the problem here?

# The Trial By Jury Justice System

### How Equal Justice for All Is Achieved;

### How Crime and Tyranny Are Precluded.

When looking into the workings of our Constitutional Justice System, simultaneously revealed is the degree to which modern governments (comprised of the executive, legislature and judiciary) together with collusive career courtroom lawyers, have strayed from the path of Justice, Equity (fairness) and the universally-applicable secular precepts of Natural Law (ethical morality), into an unmitigated criminal modus operandi. Rejecting the definitive basis of democracy and civilised human existence, modern government has judicably\* contravened The Constitution; usurped the rule of law; committed Capital Treason and Crimes against Peace and Humanity; massively engendered crime, strife, corruption and a collapse of social cohesion; and implemented the illegal coercive barbaric practices of tyranny and despotism.

\*Definition. judicable, that which can be tried by jury in a court of law.

Set out are the principal facts about civilisation's definitive, model Justice System, the Trial by Jury, with which, for their ultimate well-being, all teens and adults should be provided. Trial by Jury is also the U.S. Constitutional Justice System: the references and quotations pertaining thereto apply equally to the UK. and elsewhere.

### THE ETERNAL CRITERION OF JUSTICE.

All societies govern by their Justice System. The power to punish carries with it ALL power. It remains a universal eternal Criterion of Justice that: the validity and justice of laws and all acts

of their enforcement require to be judged not by those who make and enforce the laws (government), but by those who voluntarily agree to abide by the laws (all the adult citizens).

Those who do not uphold this tenet are then promoting unlawful rule by a tyrannical elite. Unwittingly, or for self-advantage, they serve despots, abet tyranny, and are the criminal enemies of freedom and equal justice.

Because the fairness and justice of the laws and all acts of law enforcement require to be judged by those who agree to abide by the laws, according to natural law, common law, constitutional law, and the paramount requirement for Equal Justice, the Common Law Trial by Jury of ordinary adult citizens in which the jurors judge the justice of the law and each act of enforcement is the only justice system which is just and hence legal everywhere, for all process of law, civil, criminal and fiscal.

On the aforesaid grounds, there is NO legitimate enforcement of ANY law but by the Trial by Jury. For the reasons explained above, common law applies universally: Trial by Jury is the only system which is legal for all process of law, civil, criminal and fiscal.

The (authentic) Trial by Jury prescribed and defined by *legem terræ* common law (as inscribed into the Great Charter Constitution, Magna Carta, 1215) comprises a complete constitution of itself. This is because its straightforward working mechanisms intentionally provide legal judgement and control by the People in Juries, of the modus operandi (the way of operating) of governments. (See the Juror's Duties which follow.) That is why Common Law Trial by Jury is installed by all legitimate constitutions as the sole justice system for all crimes (unimpeachable), civil, criminal and fiscal.

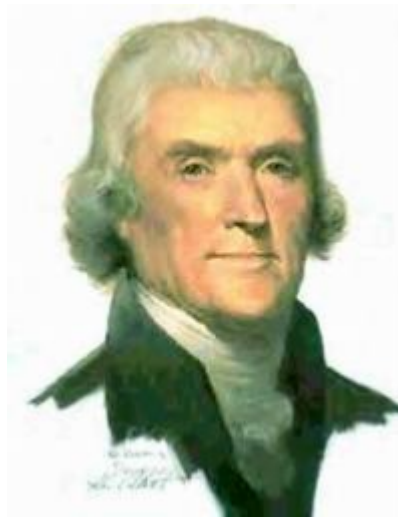
**Note:** terræ is pronounced terry, the æ as in Cæsar; seize.

The democratic Principle of our traditional Western Constitutions' Trial by Jury is that it is the Will of the People represented by indiscriminately chosen Jurors, not the will of the court or the current transient government, that must

determine what laws shall be established, maintained, and how they are enforced. In this way, Trial by Jury is the common law's Mechanism of Authority by which all the rights of all the People are protected, and on which all rights depend. Hence, Thomas Jefferson's "anchor":

"I consider Trial by Jury as the only anchor yet imagined by man, by which a government can be held to the principles of its constitution."

Lawyer Thomas Jefferson; U.S. President; Author of the Declaration of Independence; co-Founder of the Democratic Party.

The authentic Constitutional Trial by Jury operates either

(i) as a means of cost-free\* private

civil, criminal or fiscal prosecution to establish rights and punish or obtain redress for wrongs, including those committed by persons in government,

Or

(ii) as a right by which to establish a person's innocence (lack of guilt or liability) in defence from all and any fines, summary punishments, accusation or prosecution.

\* Viz. for example, *legem terræ* Article 40 inscribed into Magna Carta, the Great Charter Constitution, "To no one will we sell, to no one deny or delay right or justice." According to common law governing Constitutional Trial by Jury (which is now illegally obstructed by politicians and courts), cost-free prosecutions can be brought by private citizens to a Trial by Jury. Trial by Jury is not the 'preserve' of the government prosecution service and the legal profession. (However, vexatious and malicious litigation which waste the court's, i.e., the jury's, time can be decided upon and fined by juries.) Since its earliest inception in the mists of pre-history, common law Trial by Jury has remained

the sole civilised method of combating crime: both common crime, and crimes committed by, or in the name of, government (that is, tyranny). "It cannot be denied that the practice of submitting causes to the decision of twelve men was universal among all the northern tribes (of Europe) from the very remotest antiquity." Crabbes's *History of the English Law*, p. 32.

## UNDERSTANDING THE LAW OF THE LAND.

Understanding *Legem Terræ*, i.e., the Law of the Land which prescribes the People's all-powerful Courts of the Common Law Trial by Jury Justice System inscribed into Magna Carta, reveals how the people at large peacefully protect themselves from despotism, villainy and potential holocaust.

Through the genuine Trial by Jury, the people re-establish the due primacy of the universal, natural, common law and justice over statute law; punish and deter crime; resume their rightful responsible rôle to police their society; nurture the values of equal justice and respect for the rights of others; fulfil the purpose of Trial by Jury to eliminate crime; and they uphold the Constitution. The duplicitous legislation by which wealth and/or hegemony accrue to particular preferred people or segments of society is thus rapidly and permanently extirpated.

The consummation of the purpose of Trial by Jury (described in the preceding paragraph) constitutes the reason explaining why judges and politicians are active in denying and destroying Constitutional Trial by Jury: the criminally corrupt reveal themselves as such by their very antithesis to Trial by Jury.

## CRIME AGAINST HUMANITY

Whereas ALL injustices and wrongs from petty tyranny to genocidal holocaust may flow from denial of the genuine Trial by Jury, only from the society of Equal Justice can definitive democracy emerge. Hence, whenever Trial by Jury is denied, then the state or government which denies it commits Crime against Humanity.

If a citizen is unable to obtain Trial by Jury for either of the aforesaid purposes (i) and (ii), that fact establishes the Illegality of the Status Quo. It then becomes the principal duty of every adult to restore legality to society by campaigning for

and achieving Restoration and Universal Adoption of the Constitutional Common Law Trial by Jury Justice System.

Trial by Jury Was Constitutionally Emplaced for the Purposes of:

A.) not only ascertaining the guilt or innocence of those accused of common crimes and where necessary apportioning retribution, but also

B.) of transcendent importance, as a barrier to protect the vast mass of innocent citizenry from the crimes of arbitrary government, i.e., unjust laws, tyranny; and from the corruption, prejudices and incompetence of fallible justices (judges). Trial by Jury enables the people to judge and decide

authoritatively what their liberties and laws are, so that the people retain all the liberties which they wish to enjoy.

Naturally, people have the moral responsibility, the right and the duty to resist and suppress injustice wherever it occurs, and by whomsoever it is perpetrated, governments notwithstanding. By definition and in practice, Democracy and Justice require that the People at all times retain the Supreme Power to annul injustices and the bad laws made by fallible politicians.

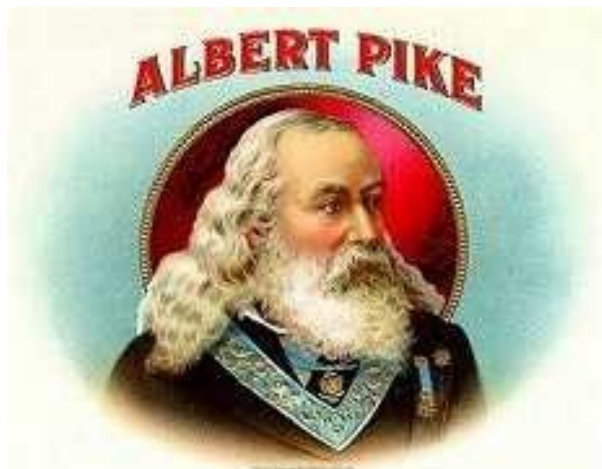
This Power backed by the full apparatus of police, prison service and Armed Services, is uniquely embodied in the Citizen-Juror's Duty in Trial by Jury: to judge the justice of every act of law enforcement, and to render the Not Guilty Verdict whenever conviction or punishment of the accused would be unfair, according to the juror's conscience.

Consider Harlan F. Stone, U.S. Chief Justice 1941-1946, on the Juror's Duty in the authentic Trial by Jury, as follows:

"If a juror feels that the statute involved in any criminal offence is unfair, or that it infringes upon the defendant's natural God-given unalienable or Constitutional rights, then it is his duty to affirm that the offending statute is really no law at all and that the violation of it is no crime at all, for no one is bound to obey an unjust law." "That juror must vote Not Guilty regardless of the pressures or abuses that may be heaped on him by any or all members of the jury with whom he may in good conscience disagree. He is voting on the justice of the law according to his own conscience and convictions and not someone else's. The law itself is on trial quite as much as the case which is to be decided."

## Albert Pike (1809-1891) From Our USA Correspondent



**A**lbert Pike also of Newbury Port moved to Arkansas where he became a prominent member of the secessionist movement. He was chosen by Mazzini to head the Illuminati operations in America and moved to

Charleston, South Carolina, in 1852. During the war he was made a brigadier general and placed in charge of raising an army of Indians. Pike's reign of terror was so despicable that foreign governments intervened to put an end to his savagery. Mazzini was not only the head of the Illuminati, he was the leading revolutionist in Europe. He was determined to establish a New World Order on the rubble of the old order and created a plan to accomplish his goal. He detailed his plan for world domination in a letter to Pike on January 22, 1870: "We must allow all the federations to continue just as they are, with their systems, their central authorities and their diverse modes of correspondence between high grades of the same rite, organized as they are at the present, but we must create a super rite, which will remain unknown, to which we will call those Masons of high degree whom we shall

select. With regard to our brothers in Masonry, these men must be pledges to the strictest secrecy. Through this supreme rite, we will govern all Freemasonry which will become the one international center, the more powerful because its direction will be unknown. Lady Queensborough, *Occult Theocracy*, pp. 208-209.

This secret rite is called "The New and Reformed Palladian Rite." It has headquarters in Charleston, S. C., Rome Italy, and Berlin Germany. Pike headed this rite in the Western Hemisphere while Mazzini headed it in the East. Pike wrote about his beliefs and goals in 1871 in "Morals and Dogma of the Ancient and Accepted Scottish Rite of Freemasonry." In this massive volume he explained that the "blind Force of the people is a Force that must be economized, and also managed. . . it must be regulated by intellect. "To attack the citadels (Institutions) built up on all sides against the human race by superstitions (religion), despotisms, and prejudices, the force must have a brain and a law (the Illuminati's). Then its (Force) deeds of daring produce permanent results, and there is real progress. Then there are sublime conquests. . . When all forces combined, and guided by the Intellect (Illuminati), and regulated by the Rule of Right, and Justice, and of combined and systematic movement and effort, the great revolution prepared for the ages will begin to march. . . It is because Force is ill regulated that revolutions prove failures" Albert Pike, *Morals and Dogma of the Ancient and Accepted Scottish Rite of Freemasonry*, 1-2 (Rev. Ed. 1950).

Even though Pike was a confederate general who committed the most heinous atrocities of the war his tomb is located just 13 blocks from the Capitol Building. He was a high ranking member of the Illuminati who is still revered by the New World Order Gang. The god of the Illuminati and the New World Order Gang is Lucifer. "The Masonic religion should be, by all of us initiates of the high degrees, maintained in the purity of the Luciferian doctrine. . . Yes, Lucifer is God, and unfortunately Adonay (Jesus) is also God. For the eternal law is that there is no light without shade, no beauty without ugliness, no white without black, for the absolute can only exist as two Gods: darkness being necessary to light to serve as its foil as the pedestal is necessary to the statue, and the brake to the locomotive. . ."The doctrine of Satanism

is a heresy; and the true and pure philosophic religion is the belief in Lucifer, the equal of Adonay (Jesus); but Lucifer, God of Light and God of Good, is struggling for humanity against Adonay, the God of darkness and evil." A.C. De La Rive, *La Femme et l'enfant dans la Franc-Maconnerie Universelle*, p. 588; Lady Queensborough, *Occult Theocracy* pp. 220-221.



Pike designed a plan for world conquest and wrote of it in a letter to Mazzini dated August 15, 1871. He said three future world wars would prepare the world for the New World Order.

Albert Pike's plan for the Illuminati was as simple as it has proved effective. He required that Communism, Naziism, Political Zionism, and other International movements be organized and used to foment the three global wars and three major revolutions. The First World War was to be fought so as to enable the Illuminati to overthrow the powers of the Tzars in Russia and turn that country into the stronghold of Atheistic-Communism. The differences stirred up by agentur of the Illuminati between the British and German Empires were to be used to foment this war. After the war ended, Communism was to be built up and used to destroy other governments and weaken religions.

World War Two, was to be fomented by using the differences between Fascists and Political Zionists. This war was to be fought so that Naziism would be destroyed and the power of Political Zionism increased so that the sovereign state of Israel could be established in Palestine. During World War Two International Communism was to be built up until it equalled in strength that of united Christendom. World War Three is to be fomented by using the differences the agentur of the Illuminati stir up between Political Zionists and the leaders of the Moslem world. # The Planned Destruction Of The White Race - Part 1

**T**he white Caucasoid race, especially that section who settled in NW Europe, are the most intelligent of all the races.

Who wrote the Charter? And who had the most to do with shaping its provisions?"

The answer is that the Russian Communists and Alger Hiss, a representative of our State Department, were the prime movers in arranging its provisions. That is the same Alger Hiss who was convicted of Perjury when he denied

sending secret material to the Soviet Union representatives. Its very beginning gave this document a bad odour."

The UN emblem was designed by a U. S. government departmental head - a secret Communist party member

David Ben Gurion in "Time" magazine, 16th August 1948 wrote: "The United Nations is a Jewish (Talmudic) ideal." James P. The only question is whether world government will be achieved by conquest or consent." 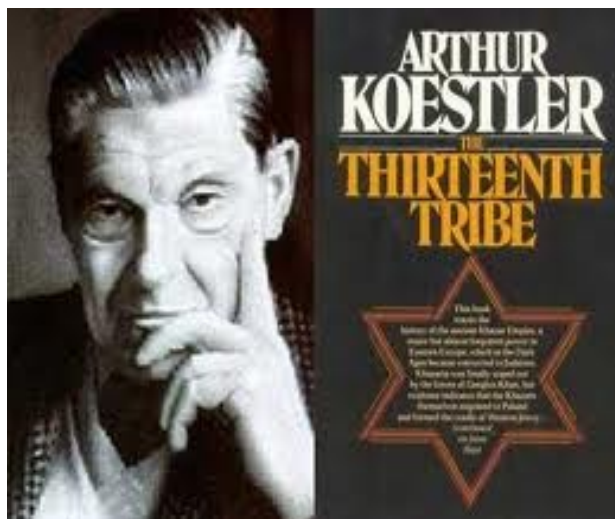

Arthur Koestler, himself a Khazar Jew, has shown in his book "The Thirteenth Tribe" that 88% of those calling themselves Jews today are not of Semite stock, not descended from Abraham, Isaac and Jacob, but are Mongolian Turks who were converted to Judaism in the 7th and 8th centuries by the decree of their ruler Bhulan. They were a race of slavers and traders with their capital Itil on the shores of the Caspian Sea near the modern city of Astrakhan.



This fact is verified in the Jewish Chronicle of the 9th of June 1978. page 21, In reviewing Koestler's book the final paragraph reads: "From the fragmentary pieces of information historians may justifiably conjecture that a substantial part, and perhaps the majority of Eastern Jews ' and hence of world Jewry ' might be of Khazar and not of Semetic origin."

In the same article an exchange of letters in Hebrew between Hasdai Ibn Shaprut, chief minister of the Sultan of Cordoba, Moorish Spain and Joseph, King of the Khazars, written about A.D. 958 is referred to. Joseph began by praising his ancestor Bhulan for converting his people to Judaism. The Khazars claimed the status of THE CHOSEN RACE by reason of their own covenant with the Almighty even though they are not descended from Abraham's seed.

Joseph then proceeds to provide the genealogy of his own people. Though a fierce "Jewish" nationalist proud of wielding the sceptre of Judah. he can not and does not claim ancestry from Shem but from Noah's son, Japheth, or more precisely from Japheth's grandsons Ashkenaz and Togarmah, the ancestor of the Turkish tribes (see 38th and 39th Chapters of Ezekiel).

Joseph writes in his letter: "We have found in the family register of our fathers that Togarmah had ten sons and the names of the offspring are as follows: ' Uigur, Dursu. Avars. Huns. Basili. Tarniakh. Khazar, Zagora, Bulgar and Sabir. We are the sons of Khazar the seventh."

These non-Hebrew people have adapted the exclusiveness of the Semite, counting themselves 'THE CHOSEN RACE' and are their own Messiah. They have adapted the Babylonian Talmud ("Rabbinical Writings" similar to chapters in the Qur'an. Don't believe me? Then check it out for yourself!) as their own and upon this book are based the 'Protocols of the Learned Elders of Zion', their plan for the overthrow and destruction of the Adamic race and the establishment of their world rule.

Dr. Joseph Klausner in The Messianic Idea in Israel, (Macmillan Company (New York 1955) wrote, "Thus the whole people Israel in the form of the elect of the nations gradually became the Messiah of the world, the redeemer of mankind."

They have got into their hands the power of the purse and issue the purchasing power of the

nations through their control of the Reserve Banks, the World Bank and the International Monetary Fund.



Theodore Hertzl (above). A founder of modern Zionism, wrote in "The Jewish State":- "When we Jews sink we become a revolutionary proletariat (communistic) and when we rise, there arises also our terrible power of the purse (capitalistic)." They have terrorized the real Semite and aim to take over the whole earth by organized revolution, indoctrinating and using the people who are their victims for this purpose.

War correspondent Douglas Reed in "Far and Wide," republished under the title "Behind the Scenes," writes: "Political Zionism and Soviet Communism both grew up side by side in Jewish areas of Czarist Russia, within Jewish families living under the same roof.... the destructive achievement, in both the Zionist and the Communist aspect came from Jews in the Russia of the Romanoffs: THAT IS THE KEY TO UNDERSTANDING THE PRESENT AND THE FUTURE.

The Khazar Jews who made those two great movements WERE NOT SEMITES: on that point all qualified authorities agree; their forebears never knew "The hills of your ancestors."

are astounding, considered as feats, like those of weight lifters, but still are less extraordinary than the submission to them of leading Gentile politicians (and clergy, teachers, union officials and newsmen) in the Christian West during the last forty years ...The way in which this overlordship has been imposed on the Christian West is wonderful and fascinating to study. It has all been done so quickly and with such skill."

The Khazar Jews began coming into Britain in numbers in the 1880's after one of their number, Hesia Helfman, had murdered the Czar Alexander II. Alexander had offended the Rothschilds by sending his fleet to aid the Americans in their civil war. The Khazar Jew William Fishman wrote in "The East End Radicals": "The religious and tribal communities, led by the rabbis and centred on the synagogues and houses of study, preserved islands of Jewish identity in a foreign sea. But the Jewish Illuminati, the descendants of the 18th century enlightenment, the radicals of various strains such as the Marxists, rationalists and secularists carried on the class war and the fight against autocracy from the heart of the East End ghetto.

They were the same breed as the Jewish idealists who helped to make the Russian Revolution before being devoured by Stalin (a national communist.) From London, Manchester, Paris and York they carried on their plotting of the overthrow of Czarist Russia and the revolution in the country which had given them sanctuary.

# Gog's Use Of Fertilisers To De-Nurture Our Food - From Murder By Injection The Late Eustace Mullins



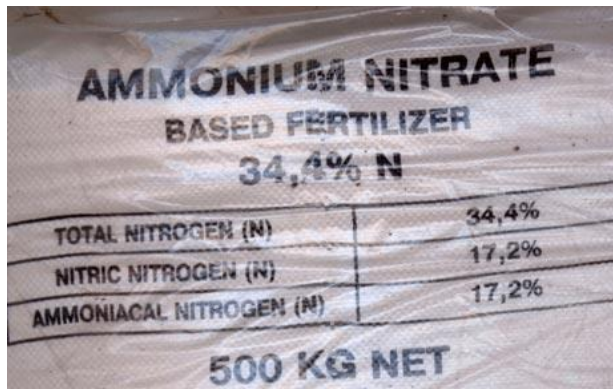
many parts of the Third World. This revolution was supposed to rapidly bring the Third World countries into the twentieth century, and allow them to compete on an equal basis with the more advanced Western nations. As the twentieth century now recedes into history, it is apparent that this objective has not been achieved. Asian and Latin American countries are offering more competition in the production of finished goods at a much cheaper labor cost, but in agriculture, despite the fact that vast new markets have been created for the Rockefeller chemical operations, the alleviation of poverty, which supposedly was the goal of the "green revolution" remains a chimera. In fact, those areas of the world which have long been marked on the maps as "undeveloped" had no notation of the fact that this was a code word for "unexploited," that is, not yet exploited by the rapacious international conspirators. The only real interest of the financiers is to develop markets for their products which can return a profit. Because most of the Third World countries are unable to pay for goods, a complex system has been developed whereby the American taxpayer sends "aid" to the Third World. He works in a factory to make a tractor; the tractor is then sent to Bolivia, and then a payment for it is extorted from the worker's wages. A further refinement is a system whereby American or international banks "lend" the money to these countries so that they can pay for the goods; the Federal Reserve System then "guarantees" these uncollectible loans with American taxpayers' funds. Once again, the worker has the money extorted from his paycheck to cover the cost of the goods he produces. The framers of the Constitution never

envisioned such a development, with the result that when the worker cites the Constitution for relief from the extortion, the judge indignantly throws him into jail for "irrelevant" and "confusing" testimony. The world is now a Gulag Archipelago, run by the ruthless minions of the Rockefeller-Rothschild conglomerate. Its gods are money and power; its only enemy is the advocate of liberty.

The current hero of the Rockefeller interests is Norman Borlaug, who was awarded the Nobel Peace Prize in 1970. An Iowa farmer, Borlaug had been sent to Mexico by the Rockefeller interests in 1944 to develop new types of grain. During his experiments there, he mated 60,000 different species of wheat, resulting in the creation of an all tropical race of dwarfs, double dwarfs and triple dwarfs by 1964. This was hailed as "the green revolution." The resulting "super wheat" produced greater yields, but this was done by "hyping" the soil with huge amounts of fertilizer per acre, the fertilizer being the product of nitrates and petroleum, commodities controlled by the Rockefellers. Huge quantities of herbicides and pesticides were also used, creating additional markets for the Rockefeller chemical empire. In effect, "the green revolution" was merely a chemical revolution. At no point could the Third World nations be expected to pay for the huge amounts of chemical fertilizers and pesticides. This was again taken care of by the system of "foreign aid" which was already in place.

The Rockefeller interests also sent Robert Chandler to the Philippines to develop a "Miracle Rice"; the result was a rice which used three times the previous amount of fertilizer. This rice matured in four months instead of the previous six months, producing three crops a year instead of two. When two Philippine groups of wealthy entrepreneurs began to contest each other for local spin offs of the profits of "Miracle Rice," the Rockefellers decided to oust one group, the Marcos combine, replacing it with the Aquino faction, which had close ties to the Chase Manhattan Bank, and which could be depended on to pay interest on loans. As usual, Rockefeller "philanthropy" was closely inter-linked with markets, profits and political

control. Modern fertilizer is a petroleum based industry.



At the conclusion of the Second World War, the munitions manufacturers found themselves faced with huge inventories of nitrates. Because of the outbreak of peace, which is always regarded with horror by the philanthropic foundations, new markets had to be found, and quickly, for these commodities. Nitrogen and nitrates were key ingredients in the manufacture of bombs and shells. A comparable peacetime market had to be developed. Following the precept which they had established after the First World War, when the monopolists, faced with a huge supply of leftover chlorine, which had been manufactured at great expense to cause intensive suffering and death, found that the only possible market was to sell it to American communities, who would then pour it into their water supplies, it was decided in 1945 that the only outlet for the huge inventory of nitrates was to put it into the food chain, as fertilizer.

The increasing rate of deaths from heart attacks in the United States for the past fifty years has been ingenuously explained by apologists for the Medical Monopoly as one more illustration of the "fact" that Americans were living longer, their advancing years making them more susceptible to "degenerative" diseases such as cancer and heart trouble. This was the usual copout from the medical establishment, which conveniently ignored important advances in the American lifestyle. For a number of years during the nineteenth century, epidemics of cholera and typhoid fever had devastated the inhabitants of large American cities, the outbreaks being due to poor sanitation and contamination of the water supply. When the monopolists poured their excess chlorine into the water supplies after the First World War, the result was widely hailed as having ended the epidemics of cholera and typhoid fever. In fact,

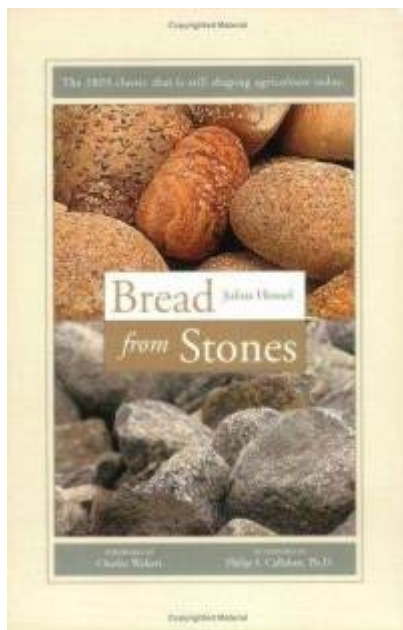
chlorination had not been responsible for this development. Typhoid fever had been largely due to the contamination of city streets by large quantities of horse droppings, which festered and drew flies. When it rained, this contamination was washed into the water supply. With the advent of the automobile, and the disappearance of horses from city streets as our main means of transportation, typhoid fever vanished almost overnight. This occurred during the 1920's, when automobiles replaced horses on the streets.

The dumping of this war material into our water supply did have one unforeseen effect. It brought on a new epidemic, an epidemic of heart attacks. The chlorine in the water combined with animal fats in the diet to form a chemical amalgam, which then formed a gummy substance in the arteries; this created a medical condition called arteriosclerosis. The buildup of this gummy substance in the arteries gradually interfered with the circulation of the blood, finally closing off the main arteries to the heart, and bringing on the attacks of angina pectoris and coronary heart attacks. Here again, a seeming "advance" in hygiene proved to be yet another boon for the Medical Monopoly, as the offices of the physicians were filled with Americans suffering from heart disease.

At the conclusion of World War II, the monopolists began a concerted effort to dump their surplus nitrates into the American food chain. County agents throughout the United States were told to advise farmers in their areas to increase their use of fertilizers, herbicides and pesticides. This advice served to make farming even more capital intensive, forcing the farmers to go to the banks to borrow more money, and paving the way for the program of forcing the individual farmers off the land, creating great agricultural monopolies, similar to the Soviet Agricultural Trust. Farmers also borrowed heavily to buy expensive tractors which ran on gasoline, greatly adding to the Rockefeller revenues, and at the same time depriving them of the fertilizer formerly available from their horses. It was hardly coincidental that the banks, which so cheerfully anted up the loans needed by the farmers who faithfully followed the instructions of their county agents, were banks who got their funds from the Federal Reserve System. This monopoly of the nation's money and credit had been planned at a secret meeting of

conspirators on Jekyll Island, Georgia in November of 1910, a meeting presided over by Senator Nelson Aldrich, whose daughter had recently married John D. Rockefeller, Jr.

The nutritional value of foods grown in heavily fertilized soil, and the fact that these foods then undergo extensive "processing" to render them more convenient for large scale warehousing, transportation and retailing, has been glossed over by the Medical Monopoly. A protesting voice was heard when Dr. H. M. Sinclair, a leading nutritionist, and head of the Laboratory of Human Nutrition, Magdalen College, Oxford, gave a 1957 World Health Day address, which was reprinted in the *British Medical Journal*, December 14, 1957. Dr. Sinclair recalled that from his earliest days as a medical student, "my clinical teachers could not answer why the expectation of life in this century of the middle-aged man is hardly different from what it was at the beginning of this century, or even a century ago. This means that despite the great advances in medicine— pneumonia almost abolished, tuberculosis comparatively rare, the magnificent advances in surgery, endocrinology, and public health—a middle-aged man cannot expect to live more than four years longer than he could a century ago—and indeed, in Scotland, the expectation of life is now actually decreasing."



In 1893, a German agricultural chemist, Dr. Julius Hensel, wrote in his book "Bread From Stones," "Agriculture has entered into the sign of cancer ... we cannot be indifferent to what kind of crops we raise for our

nourishment or with what substances our fields are fertilized. It cannot be all sufficient that great quantities are harvested, but that great quantity must also be of good quality. It is indisputable that by merely fertilizing with

marl, i.e., with carbonate of lime, such a large yield may be obtained as to make a man inclined to always content himself with marl, but with such a one-sided fertilization slowly but surely, evil effects of various kinds will develop; these have given rise to the axiom of experience: "Manuring with lime makes rich fathers but poor sons." As our present fine flour, freed from bran, furnished almost entirely devoid of nutrients, we need not wonder at the great number of modern maladies." This was written in 1893, before the Rockefeller interests flooded the world with their petroleum based fertilizers.

To counteract the growing array of inert, nutrition deficient foods, the minions of the Medical Monopoly have not been idle. While conducting wars of attrition against the leading exponents of better nutrition, the Food and Drug Administration and the American Medical Association have valiantly defended the use of chemical fertilizers. The widely circulated AMA magazine, *Today's Health*, found in every public school and library, in September 1958, stated, "Extensive research conducted by the Federal Government has shown that the nutritional value of crops is not affected by the soil of the fertilizers used . . ." This was contradicted by the Rockefeller Foundation's own Dr. Alexis Carrel, who wrote, "Chemical fertilizers, by increasing the abundance of the crops without replacing all the exhausted elements of the soil, have indirectly contributed to change the nutritive value of cereal grains and vegetables. Hens have been compelled by artificial diet and mode of living, to enter the ranks of mass producers. Has not the quality of their eggs been modified? The same question may be asked about milk, because cows are now confined to the stable all year round, and are fed with manufactured provender. Hygienists have not paid sufficient attention to the genesis of diseases. Their studies of conditions of life and diet, and of their effect on the physiological and mental state of modern man, are superficial, incomplete and of too short duration."

Despite the claims of government researchers, the importance of soil is shown by the fact that the proportion of iron in lettuce can vary from 1 mg per hundred to 50 mg per hundred,



according to conditions of the soil in which it is grown. The Middle West has long been known as "the goitre belt," because of a widespread deficiency of iodine in the soil. The British Isles, which have been heavily farmed for almost two thousand years, have such deficiencies of minerals in the soil that the British are known the world over for their bad teeth.

The present system of agricultural chemistry was fathered by Dr. Justus von Liebig, a German chemistry professor who suggested that minerals should be added to the soil and acids added to make them more available to plants. Chemistry agriculture uses soluble chemicals which are either acidic or basic, their final effect being to acidify the soil, while the use of chemical minerals renders the soil useless. It has been suggested that we are still living on the benefits conferred by the last Glacial Age, and that the only way to re-mineralise the soil is to undergo another Glacial Age, as has previously happened about every 100,000 years.

Dr. W. M. Albrecht, chairman of the Department of Soils at the University of Missouri School of Agriculture, states, "While it has long been common belief that disease is an infliction visited upon us from without, there is a growing recognition that it possibly originates from within because of deficiencies and failure to nourish ourselves completely. Fuller knowledge of nutrition is revealing mounting numbers of cases of deficiency diseases. These tend to be traced, not only to the supplies in the food and supermarket where the family budget may provide them, but a bit further, and closer to their origin, namely, the fertilization of the soil, the point at which all agricultural production takes off . . . These increasing cases classified as deficiencies are bolstering the truth of that old adage, which told us that 'to be well fed is to be healthy.' "

Many of the strange new diseases which have arisen to plague us in recent years are found to have a nutritional origin. Dr. Josephson identifies myasthenia gravis as an endocrine disorder resulting from a deficiency of manganese, which may be caused either by defective assimilation of manganese or by defective metabolism. The need for chemical fertilizers may have stemmed from a longstanding flaw in the method of farming, the use of the moldboard plow. Edward H. Faulkner,

professor at the University of Oklahoma, discovered that the moldboard plow was destroying the fertility of the soil. He counteracted this effect by disking green manure into the surface and eliminating the plow, an instrument which sandwiches virtually all green manure (decaying plant matter and vegetable residue found on the surface of the ground) some six to eight inches below the surface, where it forms a barrier to water, which should rise from the water table. The upper six inches then becomes dry, as the capillary action of water movement is blocked. Plants grown on this plow-depleted soil attract insects, while their vitamin and mineral content is depleted. The plants become sickly and die.



Seeing this result, the farmer then decides that the problem is the lack of some element in the soil, not realizing that it is the plow which has interfered with the capillary action of water in the soil. He then becomes a ready customer for large quantities of chemical fertilizers. One of the principal producers of these fertilizers was the Rockefeller-controlled American Agricultural and Chemical Company. Not surprisingly, one of its directors, John C. Traphagen, was also a director of the Federal Reserve Bank of New York and the Rockefeller Institute of Medicine. A prime mover and director of the American Cancer Society, Traphagen was president of the Bank of New York, and director of the Fifth Avenue Bank. He was also a director of Wyandotte Chemicals, Hudson Insurance, Brokers and Shippers Insurance, Caledonian American Insurance, Foreign Bondholders Protective Association,

Sun Insurance, Ltd. (one of the three principal Rothschild firms), Atlantic Mutual Insurance, Eagle Fire Insurance, Norwich Union Fire Insurance, Ltd., International Nickel, Royal Insurance Company, Royal Liverpool Insurance, and many other London insurance firms, most of whom were within the Rothschild orbit.



Also on the board of American Agricultural and Chemical was John Foster Dulles, (left) of the Wall Street law firm, Sullivan and Cromwell; he served as

Secretary of State while his brother Allen was head of the Central Intelligence Agency. Dulles was also a director of International Nickel, Bank of New York, American Banknote Company (which furnished the paper used by the Federal Reserve System to print its paper money, which was backed by paper bonds) and chairman of the Carnegie Endowment for International Peace, of which Alger Hiss was President, director of the New York Public Library, Union Theological Seminary, and the New York State Banking Board. Dulles had been secretary at the Hague Peace Conference in 1907, and served as his uncle's secretary at the Paris Peace Conference in 1918, Robert Lansing, Wilson's Secretary of State. Dulles later served on the Reparations Commission and the Supreme Economic Council with Bernard Baruch in 1919; he attended the Berlin Debt Conference in 1933, and was American delegate to the United Nations in San Francisco when Alger Hiss wrote the United Nations Charter in 1945. Both Dulles and brother Allen had attended a historic conference with Baron Kurt von Schroder and Adolf Hitler in Cologne in 1933, when the Dulles brothers assured Hitler that Wall Street bankers would advance him the money to launch his Nazi regime in Germany.

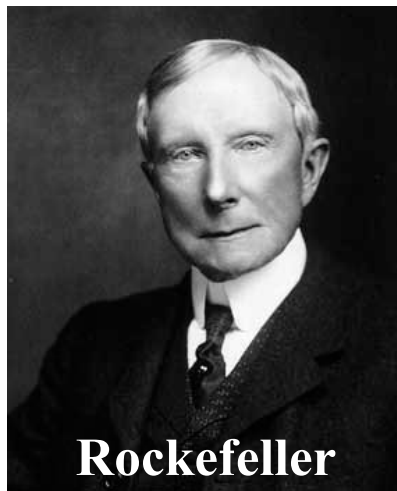
Also on the board of American Ag & Chem was George C. Clark of the investment bankers, Clark and Dodge; John R. Dillon, chairman of Unexcelled Chemical Company, Lone Start Cement, and was also a theatre tycoon, director of National Theatres, Twentieth Century Fox, Skouras Theatres, and also an aircraft tycoon, as director of Curtiss-Wright and Wright Aeronautical; also on the board was banker Robert Stone, partner of Hayden Stone, director of Rockefeller's Mesabi Iron Ore and Island Greek Coal Company, Punta Alegre Sugar Company, U.S. Envelope, John P. Chase Company, Philadelphia and Norfolk Steamship Company, Amoskeag Company and William Whitmore Company.

Another member of Ag & Chem was Elliott V. Bell, who was also director of the American Cancer Society. He had been a financial writer for the *New York Times* from 1929 to 1939, which gave him entree into the highest financial circles. He became economic adviser to Thomas Dewey in 1940, Supt. of Banks for New York State from 1947-49, director of McGraw Hill, editor of the business magazine *Business-week*, director of Rockefeller's Chase Manhattan Bank, New York Life, New York Telephone Company, Tri-continental Corporation, Revere Copper and Brass and other firms. He also was appointed to the Committee on Social Security Finance for HEW, and trustee of the John S. Guggenheim Foundation, the Roger Straus Foundation. His daughter is a leading New York socialite, Mrs. Thomas Hoving, one of the "beautiful people."

The use of chemical fertilizers caused the protein content of vegetables to drop steadily at the rate of ten per cent a year. However, the most dangerous effect, and the probable cause of much nutritionally induced disease, was the fact that chemical fertilizer reduced the amount of potassium in the soil, while increasing the amount of sodium. Potassium and sodium are the leaders of the two electrically opposite groups. Inactive potassium in the system precipitates illness, especially cancer. The increased sodium may explain the dramatic increase in the incidence of high blood pressure throughout the United States, because our population is ingesting steadily increasing

amounts of sodium from foods grown in chemically fertilized soil, while simultaneously suffering from the effects of steadily declining levels of potassium in the human system. Potassium is especially necessary for the regulation of the heart beat; its lack in the body makes the system prone to sudden heart attacks.

Nutritionists now believe that the use of chemical fertilizers in the soil causes seventy per cent of all anaemia in the citizens of the United States, because these fertilizers do not replace iron in the soil, but actually remove it.

The use of chemical fertilizers also accelerated the domination of the world's grain supply by large corporations which are closely affiliated with the Rockefeller interests. In

1919, the largest grain grower in the world was the Montana Farming Corporation. At that time, wheat was selling for a guaranteed price of \$2.20 a bushel and the combine was raking in huge profits. Montana's board of directors was headed by J. P. Morgan, whose vast interests in banking, steel and railroads had given no inkling of his desire to become a farmer; Morgan was serving on the Federal Advisory Council of the Federal Reserve Board, representing the New York central banking area. His associates on the board of Montana Farming were Rockefeller's banker, James Stillman of the National City Bank—two of his daughters married two sons of William Rockefeller; Francis Hinckley Sisson, vice-president of the Morgan controlled bank, Guaranty Trust—it is now Morgan Guaranty Trust; Charles D. Norton, whom Morgan placed as President Taft's personal secretary during the Taft presidency. Norton served as president of Morgan's First National Bank (later merged with Rockefeller's National City Bank to form the present banking giant, Citibank). Norton had been one of the original conspirators present at Jekyll Island to secretly

draft the Federal Reserve Act. He was a director of Montgomery Ward, Equitable Life, ATT, Tidewater Oil, and the Delaware and Lackawanna Railroad. He was also director of a number of Morgan's favorite charities, the American Red Cross, the Russell Sage Foundation and the Metropolitan Museum. Also on the board of Montana Farming was Charles H. Sabin, a director of Guaranty Trust, Merchants and Metals National Bank, president of the Asia Banking Corporation, American Foreign Securities Corporation, the Mackay Companies, Postal Telegraph and many other firms.

Today, the world grain trade is firmly in the hand of five firms, Cargill, Continental Grain, Louis Dreyfus, Bunge and Andre. These firms have waxed rich and powerful by riding the tide of the super grains developed by the Rockefeller Trust. They maintain close contact with these interests, and the banking interests of the Rockefellers, relying principally on the Chase Manhattan international network. These firms have also profited from the Rockefeller Foundation's development of hybrid seeds, notably corn. From a commercial standpoint, the attraction of the hybrids is that they cannot reproduce themselves. As a result, the farmer has to ante up the money to buy a new supply of the hybrid seeds each year. Hybrid seeds have another great attraction for the monopolists; they give the parent company, which owns the patent, a monopoly on that particular variety of seed. Thus we have the twin factors of commercial viability and monopoly to give the banks and the Chemical Trust a stranglehold on the American Farmer. Hybrid seeds yield an average increase of twenty to thirty per cent more per acre, which is a strong selling point to the farmer. Likewise the "miracle wheat" which was originated at the International Maize and Wheat Improvement Center at El Butan, Mexico, resulted in the development of a wheat strain which could stand up under the force of lashing rains and tropical storms. It was produced by crossing Mexican wheat with the strains of Japanese dwarfs which had short, tough stems. Norin- 10, from the island of Honshu, was hardy enough to stand up under Japanese typhoons. It became the type which made the "green revolution" a reality. After 1960, the Mexican station released a long line of wheats, Nanair 60, for the year 1960, Pitic

62, Penjamo 62, Sonora 64, Lerma Rojo 64, India 66, Siete Cerros 66, Super X 67, Yecoar 70, and Cajeme 71. Although they required intensive fertilization and irrigation, they all could thrive in tropical countries. The Big Five wield enormous political and financial power because of their enormous cash flow, and because so many governments depend on their food supply to maintain political stability. This was demonstrated during what historians now call the Great Soviet Grain Robbery in 1972. Arranged by Henry Kissinger, longtime Rockefeller stooge from the Chase Manhattan Bank, this deal bailed out the tottering Soviet government, while costing the American taxpayer many billions. In July, 1972, the Soviet Union bought wheat from the United States, in an attempt to compensate for the disastrous incompetence of the Soviet communal system of agriculture. In 1963, Russia had begun a policy of purchasing wheat from abroad by buying 6.8 million tons from Canada for \$500 million. To pay for the purchases from the United States in 1972, the Soviet Union was allowed to cover the payment in the following manner; the central bank of Hungary, acting for the Soviet Union, placed an order to sell the dollar short for \$20 billion. Secretary of the Treasury, John Connally, then devalued the dollar by ten per cent. The Soviet Union made \$4 billion on its short selling of the dollar, and paid for the grain. Michel Sidona, who had been deeply involved with the Rothschilds and the Hambro family in international financial manipulations, described the process from his prison cell, where he was later found dead. "In its fathomless naivete, the United States has provided the Soviet Union with \$4 billion, money that has since doubtless been invested in the destruction of its benefactors; I began to see then that America was the consort of its own ruin. I tell you, in all of history, no power has so blindly armed and succored its enemies as she."

The Soviet grain deal resulted in increasing the price of all food supplies in the United States by twenty per cent. Because of restrictions imposed by Congress on shipping grain in foreign vessels, a measure which had been passed to aid our dwindling maritime fleet, the Soviet grain purchases in 1972 cost the American taxpayer an additional fifty-five million dollars in subsidies to bulk carriers. The American carriers shipped the grain for sixteen

dollars a ton, although foreign vessels would have carried it for nine dollars a ton.

To this day, only a few international grain traders and Soviet officials actually know the price charged for forty million tons of grain which the Soviets bought from the United States between 1971 and 1977. Officials at the U.S. Dept. of Agriculture state that they have no records on the price paid, or whether it was ever paid. Only Henry Kissinger knows, and he is not telling.

The Big Five grain dealers are also heavily involved in currency manipulations, trading vast sums each day in currency futures, because their grain deals cause great fluctuations in the valuation of world currencies. With their inside track, they make huge profits whether the value of the currencies moves up or down. Cargill now has 25% of the world's grain trade; Bunge of Argentina has 20%; Continental Grain began operations during the Napoleonic Wars, supplying grain to both sides; it has 25% of the world grain trade—the present head of the firm, Michel Fribourg, owns 90% of the stock, with his son Rene; Michel Fribourg was a French citizen who joined the U.S. Army Intelligence during World War II; he subsequently became a U.S. citizen; Andre, a Swiss family belonging to a strict sect of Swiss Calvinists who are members of the worldwide and very militant Plymouth Brethren; and Dreyfus, which has twenty per cent of the world grain trade. Dreyfus is now headed by Nathaniel Samuels, who served on President Nixon's team as Under Secretary for Economic Affairs. The chairman of Bunge, Walter Klein, whose office is at One Chase Manhattan Plaza, New York, is a policy-making official of the U.S.-USSR Trade & Economic Council. **End OS12568**

## Belgium's Pukkelpop Festival Postponed Indefinitely After Severe Storm Leads To Deaths And Many Injuries

Five people have been confirmed dead and over one hundred injured after a severe storm hit the Pukkelpop Festival in Belgium, toppling trees and causing at least one of the stages to collapse. The Associated Press reports that many of the approximately 60,000 attendees fled the open-air festival in the face of high winds and hailstones approaching half an inch in diameter and high winds. Today was the first of the planned three-day festival (featuring Foo Fighters, 30 Seconds to Mars, Eminem, and others), which has been put on hold until further notice.

This news comes just five days after a stage collapsed at the Indiana State Fair, killing five and injuring forty prior to a Sugarland concert. The Belgian storm was by all accounts a more serious one than those that have caused collapses in Indiana, Ottawa, and Tulsa, but may point to the same concerns about outdoor stage safety that have been raised in the last few days.

Interestingly the 5 days between the 2 disasters reminds one of the 5 pointed star which was on the flag of the Amalekites whom Yahweh would have war with from generation to generation. Of course the attendees were mainly Israelites, but the purveyors of degenerate music are the amalekites/Edomites. David took 5 stones to slay Goliath - 1 for him and the others for his 4 brothers.

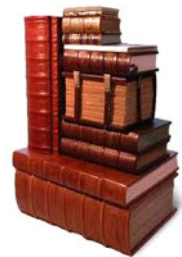

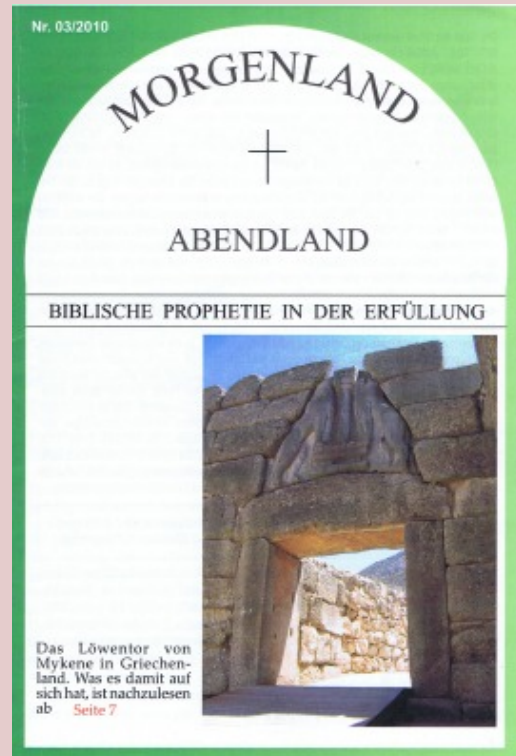
