# Arsenal Of Words (Part 15)

## A Demonstration of The Deceptive Use of Words

#### Remnant

**T**HE ENGLISH WORD remnant is derived from the Hebrew *yether* (Strong's # 3499), *shear* (#7605, pronounced she-ar), *sheeriyth* (#7611), and the Greek *kataleimma*, (#2640).

Throughout Scripture, Yahweh speaks directly of and to His Remnant, who are exclusively of the seed of Israel. In the end times, it will be only His Remnant that will do His Will. (Rev. 22:14.) We know that this cannot possibly be "Spiritual Israel," because those people refuse to keep His Commandments! They have all embraced Apostasy to one extent or another, being the victims of the anti-Christ's deceptions.

"Esias also crieth concerning Israel, **Though the Number of the Children of Israel Be as the Sand of the Sea, a Remnant Shall Be Saved.**" (Rom. 9:27.)

All contextual references to the word remnant make it abundantly clear that the Israelites are always to be distinguished from the heathen, and the separation factor remains fully in effect today, just as the original word was intended to be used in Scripture, over two thousand years ago. The Remnant can only be selected from flesh and blood Israel.

In fact, this separation between Israel and the other races will last forever, as this is the word that is used in Scripture. (Isa. 59:21.) There is no logical way for the word 'forever' to exclude the New Testament.

The folly of the "New Testament Christians" is hereby fully exposed. I would not want to be in their shoes on the Judgment Day. I can already feel their disappointment! These Israelites will then realize how badly they have let their Father down. I expect Him to be merciful, however, for

they are not doing evil deliberately. Like Eve, they have been tricked/deceived into doing evil.

#### Saints

The word saint is translated from the Hebrew *chacyid* (#2623), *qadosh* (#6918) or *qodesh* (#6944), or the Greek *hagios* (#40). It always refers to the Adamic Israelites.

{The Greek word *hagios* (#'s 39 and 40) is often translated as "holy," or when it refers to people, "saint" or "saints." The word is an adjective which properly describes something "devoted to the gods," as Liddell and Scott define it, so in the biblical context, Thayer adds to the definition in his lexicon: "set apart for God, to be, as it were, exclusively His."

In the ancient world, when an object was placed on a temple altar and dedicated to the god of the temple, the object became *hagios*, the property of the god of the temple. Now, the same is true for any sacrifice that the Hebrews offered to Yahweh. Hence, once Isaac was placed on the altar by Abraham, and dedicated to Yahweh, he and everyone who sprung from him became dedicated to the purposes of Yahweh.

Originally, these offspring would have included the children of Esau, the Edomites. But since Esau despised his birthright (Gen. 25:34) and produced forbidden mongrelised children (Deut. 23:2) with Hittite wives, the Edomites cannot be counted as heirs. Since Yahweh rejects bastards (mongrels, Gen. 36:1 ff., Deut. 23:2, Mal. 1:1-3), all of the Old Testament promises of deliverance, salvation and redemption fall to the children of Israel alone (Isa. 19:25, 29:22-23, 41:8 and 14, 43:1-7, 44:1-2 and 21, 45:17 and 19, Jer. 31:31-37, Amos 3:2, etc.), and no one else may lay claim to them.

Explaining the difference between the Edomites in Judea and the true Judahite Israelites in Judea at Romans, Chapter 9, Paul tells us that the Israelites are "vessels of mercy," but the

Edomites – although "made from the same lump" – are "vessels of wrath prepared for destruction." Such are the Jews of today. Of the children of Israel, the only ones who could properly be considered "saints" are those set apart, or separated and devoted to Yahweh their God (II Cor. 6:14-18; I Peter 2:9; Rev. 18:4; Ex. 19:5, Ezra 10:11, and Matt. 25:32). No church can make or designate a "saint." Rather, the children of Israel are given the opportunity through the Gospel to be as much, which Paul's consistent use of the word clearly demonstrates. (See Rom. 1:7; 8:27; 12:13; 16:15; I Cor. 1:2 and 6:1-2 [cf. Dan. 7:22]; 14:33; II Cor. 1:1, Eph. 1:1,4,15 and 18; 3:17-18, 4:12 and 5:3.)}

### Canaanite

The Canaanite tribes are listed first in Gen. 15:18-21, where Abram is promised by Yahweh that their land would be given to HIS SEED (zerah/sperm), meaning lineal descendants. These Canaanites have always been True Israel's foremost enemies. The Hebrew word for Canaanite means "merchant, trafficker." Think about it, isn't that the occupation the Jews are best known for? The Christian zombies have been hypnotized by the incantation, "Bless the Jews, Bless the Jews, Bless the Jews," which is the same as saying, "Your enemy is your friend. Your enemy is your friend. Your enemy is your friend."

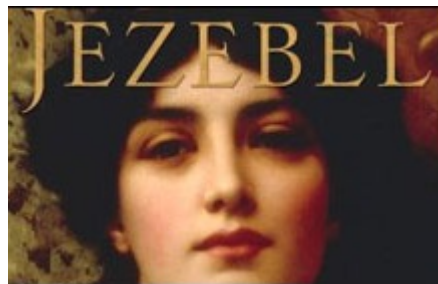
These Canaanites are the living, breathing **Evil Seed** of Gen. 3:15. They are the ancestors of the people known today as Jews. Zech. 14:21, tells us that Yahweh will make an end of this evil seed, for all of the treachery, deception, wars, disease, and suffering they have caused True Israel and the rest of the world.

Deuteronomy, Chapter 7 sets forth Yahweh's commands to the Israelites to destroy the Canaanite nations, one at a time. Verses 3 & 4 deal specifically with race-mixing: "**Neither Shalt Thou Make Marriages with Them;** thy daughter shalt thou not give unto his son, nor his daughter shalt thou take unto thy son."

But this is exactly what a modern White woman does when she marries a Jew! And the churches are chief in this trespass by encouraging forbidden relations with non-Whites. Did someone say "There is nothing new under the sun"?

"For they will turn away thy son from following me, that they may serve other gods: so will the anger of Yahweh be kindled against you, and destroy thee suddenly."

In other words, the temptation of having sex with non-White women will lure Israelite men away from Yahweh's Law. Yahweh promises us what? **sudden destruction**, if we engage in this forbidden activity!!



Now, let's take a closer look at reality. We can see that the modern churches are actually playing the role of the ancient heathen, Baal churches, which encouraged the Israelites to miscegenate! Recall Ahab and Jezebel. The "ministers" of Judeo-Christianity, IF they deal with such Scriptures at all, will only stress the "serve other gods" part of the instruction.

They will **never** mention the "Neither shalt thou make marriages with them" part of the Scriptures. The fact is that, in our historical episodes of miscegenation, we have not engaged in their heathen religious practices until after we have already started race-mixing with them. Notice the order of the causality, from verse 3 to verse 4! We do not start practicing their pagan religions until after we have started living and mating with them!

Zechariah, Chapter 14 is a prophecy concerning Jerusalem and the Day of Judgment. Most Bible interpreters think this is talking about the literal city of Jerusalem, but it is clear from many Scriptures that prophetic "Jerusalem" is a reference to the Israelite people, wherever they are. Now that you know who the modern-day Canaanites really are, read this very important prophecy, concerning the day of Judgment (comparing it with **Deut. 7:1**):

"... and in that day there shall be no more the Canaanite in the house of the Lord of hosts." (**Zech. 14:21**)

Interestingly, if we take the word Jerusalem to mean the literal city, then Deut. 7:2 speaks

prophetically of the destruction of Canaanites who TODAY live in that city. Who lives there today? The Canaanites! (Jews pretending to be Israel.) I believe that Yahweh is waiting for the Jews to re-establish the rituals of animal sacrifice in Jerusalem. This will be the **last straw!!!** This will be proof positive that their rejection of Messiah's Last Sacrifice is absolute. For this the Pharisees and their followers will have to pay the ultimate price!

"Know therefore that the LORD thy God, He is God, the faithful God, which keepeth covenant and mercy with them that love Him and keep His commandments to a thousand generations; and repayeth them that hate Him to their face, **to Destroy Them:** He will not be slack to him that hateth Him, He will repay him to his face." (Deut. 7:9-10.)

Knowing that Talmudic Judaism is LAW-BREAKING, par excellence, whom do you think is going to be repaid for their insolent disobedience, having replaced **their own tradition** for the Law of Moses, deceitfully practicing their own tradition **in the name of Moses?** The deluded Judeo-Christians make common cause with the anti-Christ Canaanites, not knowing or suspecting that they are counterfeit "Israelites"!

As yet, I have not heard of any universalists speaking of "spiritual Canaanites"! According to their theology, they must automatically become "Spiritual Israelites," along with everybody else!!! What stupidity!! They actually believe that they can convert the Devil. If Jesus couldn't do it, how can they? They have turned the Bible inside out with their blasphemous interpretations.}

What will actually happen is this: The impostors, who have weaselled their way into our company, will be booted out of our exclusive racial family; and they will cease to exist as a species. (Yes. That is what I said! I am just repeating to you what Yahweh Himself has said through His prophets, in this case, Moses). This will be their punishment for their rebellion against Yahweh and for all of the heinous crimes they have committed against True Israel. Remember that Yahweh commanded the Israelites to exterminate the evil Canaanites (Deut. 7:1-2). Zech. 14:21 is saying that, since we have failed to do the job, He will do it Himself, at the

Judgment Day. Paul confirms this judgment at Romans 9:13 and 21. The Lord giveth and the Lord taketh away; and that includes life itself. Canaanites, take heed!

However, Matt. 15:22-28, implies that individual Canaanites may obtain mercy, if they would humble themselves and recognize and accept Jesus as the Messiah, upon whose shoulders the government of the Universe rests. By this, I do not mean to imply that any Edomite, who is sincerely repentant, can be part of the government of the Kingdom.

I mean only that his soul be not be destroyed. By Yahweh's mercy, his life might be preserved, according to the offer that Yahweh made to Cain at Gen. 4:7. From the two-seedline perspective, this could only mean that He would miraculously cleanse their blood of Canaanite DNA, for that genome will be destroyed. Contrary to the blasphemous statements of John Hagee, who has stated that the Jews have their own path to salvation, this is only way that an Edomite Jew can be "saved."



"I am the Way, the Truth, and the Life. No man cometh unto the Father, but BY ME!" (John 14:6.) Apparently, John Hagee doesn't understand his own King James Version of the **New Testament!!!!** This agent of the Devil gets up in front of millions on the boob tube and blatantly contradicts the Scriptures!!! Tell me he doesn't kiss Baphomet's arse every morning!

When the Canaanite woman asked Messiah to heal her daughter, He told her, "It is not meet to take the children's bread, and cast it to the dogs." Her response was, "Yet the dogs eat of the crumbs which fall from their masters' table." Note that Jesus is jealous of the "food" that was reserved for His Kinsmen, the Adamite Israelites.

Note also the placement of the apostrophe at the END of the word masters', indicating that she is

recognizing all Israel, not just Jesus, as her masters (plural). Since most Jews, the self-proclaimed "God's chosen people," are too proud to accept Adam's children as their coequals, let alone their masters, very few Jews will be able to comply with this condition, for their very DNA is derived from the fallen angels of the Luciferian rebellion, who mixed with the daughters of Adam-kind. Never forget, they do the works of their father, the devil (John 8:44). Rebellion is in their blood. The vast majority of these rebellious souls will choose oblivion instead of obeying the Law, for they have, since they joined Lucifer in his rebellion, always defied Yahweh and wish to be a law unto themselves.

## Edomite

The Edomites were originally one of the Canaanite tribes. Through the passage of time, and because of the prominence of the Edomites, the entire Canaanite nation came to be called Edom. So, it is not incorrect to say that the Edomites are the Canaanite tribes renamed, although there were related tribes, such as the Samaritans, who maintained a separate state north of Judea. The Edomites are named after Esau/Edom, who married into their breed. It was a smooth transition.



Most of the people known as Canaanites simply became known as Edomites. Other than this change in name, there is no major difference between Canaanites and Edomites. Esau became the leader of these Canaanites, and his lieutenants became known as the Dukes of Edom. (Gen. 36:15-43.) Esau violated God's Law by marrying outside of his Race. He married two Hittite women; and the Hittites were one of the original Canaanite tribes. (Gen. 15:19-21; 26:34-35.) For this abomination, and because of his rejection of the birthright, Esau was

disowned by both Yahweh his own parents. "Esau DESPISED his birthright." (Gen. 25:34.) In short, He was a race-traitor, a defiler of his Adamic genealogy.

John Hagee is a modern-day Esau. He and his fellow pulpit masters will twist and distort the Scriptural story of Esau by telling you that all of this was Jacob's fault. By pinning the blame on Jacob, they avoid discussion of Esau's REAL SIN!!! It was not Jacob's fault that Esau broke the law of separation and refused to repent. Esau brought his disownment upon himself by violating God's law against race-mixing and disobeying his own parents (Commandments 5 and 7). In Gen. 27:46, 28:1, Isaac and Rebekah warn Jacob not to commit Esau's error. Jacob obeyed Yahweh's racial marriage laws and was blessed because of his obedience. This is the real moral of the story. In their lying sermons, these pulpit bastards will never quote the relevant passages that point to race-mixing as being Esau's crime. Instead, week after week, they present nothing but watered-down hogwash, all of it favouring the Jews, feeding the flock with sweet-tasting poison. It is quite obvious that these pulpit mongers take their orders directly from Satan's corporate headquarters.

Understanding this aspect of the Biblical narrative, you can now see today's theological, political, economic, and military struggles in their true light: It is a matter of Esau's descendants trying overthrow True Israel (Jacob's descendants) in order to prevent us from claiming the Inheritance. Esau's descendants are trying to TAKE BACK the birthright BY DECEPTION AND FORCE.

## Edom and the Seed of the Annunaki

One of the ancient Canaanite tribes was the Anakim. Both secular and religious ancient history speak of the Anunnaki (a combination of Anu and naki), the fallen angels, also known as the Nephilim. You can see that the root word, Naki is the basis of the Hebrew word Nachash, the name of the Serpent in the Garden. Naki appears also to have been retained as the root word for naked, in several current languages, undoubtedly because Eve was naked in the Garden when she was seduced by Nachash.

The Bible tells us that Esau settled among the Canaanites near Mt. Seir. (Deut. 2:4.) Mt. Seir

was also called Mt. Hor (Gen. 14:6; Num. 20:14-22), and in Roman times unto today has been known as Petra. Among these Canaanites were the Anakim, the descendants of Anak, who were the literal giants of Canaanland. Deut. 2:12 and 22 tell us that the children of Esau succeeded these various Canaanites, after a period of internecine warfare. Dishon, Son of Seir, was the founder of the Idumean tribes.

He was the uncle of one of Esau's Canaanite wives, Aholibamah (Gen. 36:18). Dishon was a son of Seir, the Horite, (Gen. 36:20) and Aholibamah was a daughter of Anah, Dishon's brother (Gen. 36:21). So, filially, Dishon was Aholibamah's uncle.

We know that the giants survived as late as the time of King David, for Goliath was a Son of Gath (I Sam. 17:4); and Gath was the land of the giants. (II Sam. 21:22) From these scattered references, we have Scriptural evidence of a direct, hereditary link between the Anu-naki (half-breed offspring of the fallen angels), the Canaanites, Esau/Edom, the Dukes of Edom, and the Idumeans.

So, the Edomites and the Idumeans are the same people. This should erase any doubts or confusion about their genealogy. As Edomites, the Idumeans are definitely NOT Israelites. The Idumeans are, in fact, the continuation of the Satanic Seedline.

Thus, we see that the Edomites mingled their seed with that of BOTH the descendants of the fallen angels, of Noah's day, and the descendants of Cain, of Adam's day. As the saying goes, "birds of a feather flock together," and it was only a matter time before these two groups of fallen angel seed found each other and formed the confederation of Canaanites, many of which later became known as the Edomites.

There are more of their family ties recorded in I Chron. 1:13-16, 35-42 and Gen. 36:18-30. Given this information, it should now be clear to you as to why Yahweh commanded the Israelites to destroy this particular seedline.

This is the Anunaki / Kenite /Canaanite / Edomite / Shelahite / Idumean/Jewish family tree. They were / are the devil's seed. This is exactly why Jesus, speaking to their Idumean descendants, told the Pharisees, "Ye are of your

father, the devil." (John 8:44.) Both organized Judaism and organized Judeo-Christianity are doing everything in their power, making up fable after fable after fable, to prevent you from having this understanding of the Scriptures.

Without reference to these genealogies, you cannot possibly tell the good guys from the bad guys. And, if you haven't figured it out yet, one of the favourite tactics of the bad guys is to impersonate the good guys. This is how they weasel their way into your confidence.

The Cain/Satanic Seedline: Nachash (Anunaki) – Cain – Kenites (sons of Cain) – Canaanites (including the Anakim /Anunaki and Nephilim) – Edomites – Idumeans – Shelahites -- Pharisees – Jews. Given this direct, genetic connection to the fallen angels, it should come as no surprise to you that, after their dispersion from Judea by the Roman army's destruction of Jerusalem, this seedline has been known as "the Perfidious Jew."

How quickly we forget that the Jews have always had this reputation. But the Jews never forget. That's why they always take control of the major organs of information, so that new generations of sheeple will believe the same old lies and be fleeced in the same old manner. The impostor can never let his act slip, otherwise he exposes himself. He will never tell us that he is an impostor. We have to put our thinking caps on, and figure it out.

### “Word for Word” Deuteronomy Part 8

## Chapter 10

1. At that time said Yahweh to me, "**Carve 6458 you two tablets of stone, like the first, and come up to Me in the mountain, and make you an ark 727 of wood.**

2. **And I will write 3789 upon the tablets the Words that were upon the first tablets that you broke 7665, and you shall put them in the ark."**

3. And I made an ark of the wood of Shittiyim 7848, and carved two tablets of stone like the first, and went up the mountain, with the two tablets in my hands.

4. And He wrote upon the tablets, as the writing upon the first, the Ten Words, which spoke Yahweh to you in the mountain from the midst of the fire in the day of the assembly: and gave Yahweh them to me.

5. And I turned myself 6437 and came down from the mountain, and put the tablets in the Ark which I had made; and they are there as that which commanded Yahweh.

6. And the children of Yisrael set forth 5265 from B'eroth-B'ney-Yaaqan 885 to Mosera 4149: and there died Aharon, and was buried there; and ministered in the priest's office 3547 El'azar 499 his son in his stead 8478.

7. From there they set forth to Gud'godah 1412; and from Gud'godah to Yot'bathah 3193, a land of streams 5158 of waters 4325.

8. At that time set apart 914 Yahweh the tribe 7626 of Lewiy 3878 to carry 5375 the Ark of the Covenant of Yahweh, to stand 5975 before Yahweh to minister 8334 to Him, and to bless 1288 in His Name 8034 unto this day.

9. Wherefore it shall not be for the Lewiy to have a portion 2506 or inheritance 5159 with their kinsmen 251; Yahweh, He is their inheritance, as that which spoke Yahweh Eloheycha.

10. And I stood upon the mountain as the first days, forty days and forty nights; and listened Yahweh to me also at that time, and would 14 not 3808 Yahweh destroy you 7843.

11. And said Yahweh to me, "**Arise 6965, walk 1980 to your station 4550 before the people, so they may go in and possess the land that I swore to their forefathers to give them."**

12. And now, Yis'rael, what does Yahweh Eloheycha require 7592 of you, but to revere 3372 Yahweh Eloheycha, and walk in all His ways, and to love 157 Him, and serve 5647 Yahweh Eloheycha with all your heart and all your being 5315,

13. to observe 8104 the commandments 4687 of Yahweh, and the statutes 2708 that I command this day for your good 2896?

14. Behold, of Yahweh Eloheycha is the sky 8064, and the sky of skies, and the land, and all that is in it!

15. Only 7535 upon your forefathers delighted 2836 Yahweh to love 157 them, and He chose



977 their seedline 2233 after them, you of all peoples, as this day.

**16.** Circumcise 4135 the foreskins 6190 of your hearts 3824, and your neck 6203 be not stiff 7185 any more 5750.

**17.** Because Yahweh Eloheycha, He 1931 is Elohey 430 of Elohiym 430, and Lord 113 of lords 113, the Great El 410, mighty 1368 and awesome 3372, that does not lift up 5375 faces 6440, nor take 3947 bribes 7810,

**18.** but makes 6213 justice 4941 for the fatherless children 3490 and widows 490, and loves 157 the sojourner 1616, giving food 3899 and clothing 8071.

**19.** Therefore love the sojourner, because sojourners you were in the land of Mits'rayim.

**20.** Yahweh Eloheycha you shall hold in awe 3372; and you shall serve Him, and cleave 1692 to Him, and by His Name you shall swear 7650.

**21.** He is your praise 8416, and He is Eloheycha, that has done for you these great and awesome things, that saw you with your eyes.

**22.** With seventy 7657 people went down your forefathers to Mits'ray'mah 4714, and now has made you 7760 Yahweh Eloheycha as the stars 3556 of the skies 8064 in multitude 7230.

## CHAPTER 10 NOTES

**Chapter 10** is a further accounting of prior occurrences, along with additional exhortations for righteousness. Verse **16** speaks of circumcision of the heart (or mind), and the entire being 5315. What this means is "total commitment" to Yahweh. The heart 3824 in Hebrew is the center of thought, not emotion, as in the Greek. Your thoughts and actions are to be centered on Yahweh's Torah.

**Verse 6** - Num. 20:28; 33:38; 885 "Wells of the children of Yaaqan";

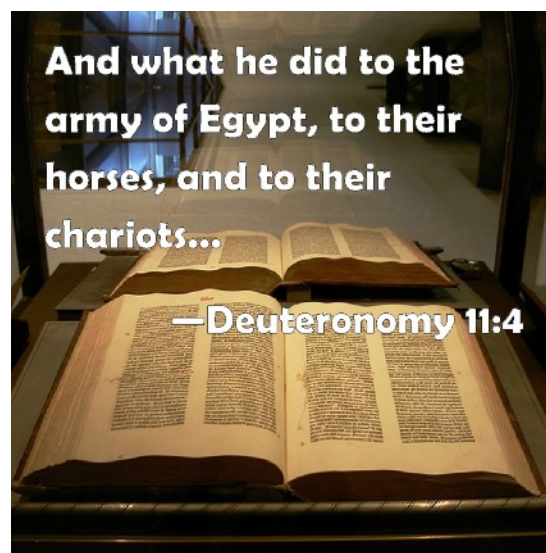

15. And He will give grass 6212 to your fields 7704 for your beasts 929, that they may eat and be satisfied 7646.

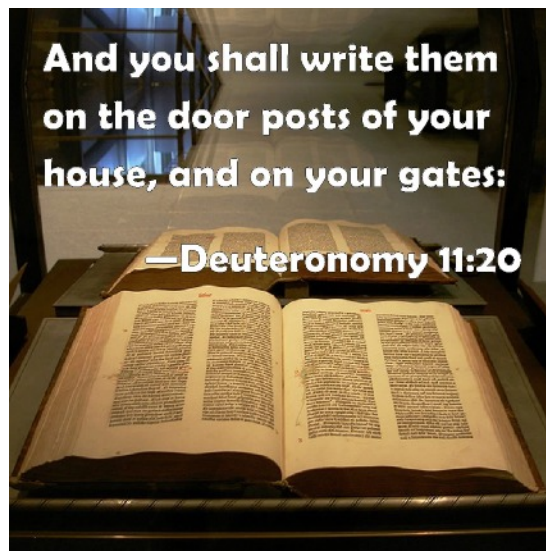

## Allan Robertson 1966 - 2020



Allan Robinson was an active member of the Orange Street Congregational Church (Minister Robert Philips), Leicester Square, London, one of the few churches in the UK still preaching the identity message.

Allan was also a member of The British Israel Bible Truth Fellowship and regularly attended their twice yearly meeting at Orange Street Congregational Church.

It was Tony Martlew, the former minister of Orange Street, who conducted the funeral service for John Tyndall, who was co-founder of the BNP together with Capt. Kenneth McKilliam a British Israel believer, as indeed was Allan Robinson.

Allan Robertson was best known as chairman and organiser of the London Swinton Circle, a conservative forum that he ran for twenty-eight years from 1992 until his death. Following a split in 2008, a rival organisation with the same name was run by ex-NF member Alan Harvey, who became a bitter opponent of his former comrades.

**WE ARE SADDENED TO REPORT THE PASSING OF ALLAN BARRIE ROBINSON** who was a longstanding subscriber to this magazine and well known in Patriot and Identity circles.

The sudden death of Allan Robertson on February 9th 2020, following a massive stroke two weeks before what would have been his 54th birthday, was a great shock to the many Patriot Groups, he was involved with..

He also produced a newsletter “Tough Talking From The Right”.

Born near Glasgow and educated at Glasgow University, Allan Robertson joined the Monday Club aged 18 and became chairman of its Scottish branch but resigned in 1986, recognising that the Club was emasculated by its own national leadership.

After moving to London he was active in a circle of young patriotic and racially-conscious Tories, most of whom became alienated from the politically-correct modern Conservative Party (which is in reality a socially and economically liberal party, though the jury is still out on its post-Brexit transformation).

In 1992 Mr Robertson took over from Bee Carthew (Enoch Powell's former political secretary) as organiser of the Swinton Circle, which he built into a high-level forum for meetings addressed by the handful of remaining pro-White and pro-Union MPs. At the turn of the millennium he was a contributing editor for several years

at the patriotic magazine Right Now, edited by Derek Turner.

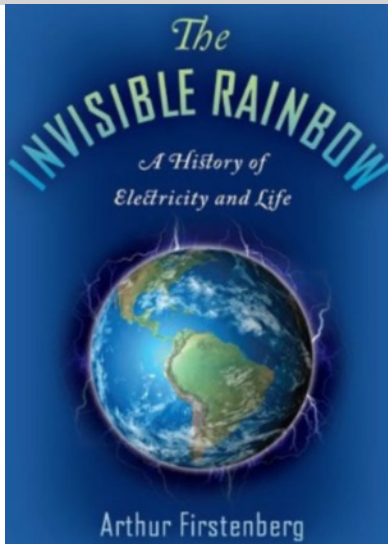

## The Story of Influenza. An Important Tale to Tell Your Friends Gordon Tapewire News



**I**T IS HIGHLY RECOMMENDED that readers use the following uncontroversial, historical detail as a (rather bland and unobtrusive) instrument that just might wake up those who are still sleeping.

The word "influenza" originated in Italy. The first record of this strange and inexplicable

### It Was Not Contagious

This "flu" narrative was accepted throughout the 1700's and 1800's. There were multiple references to the illnesses brought on by the proliferation of telegraph communications and the installation of AC power grids in US cities. Some of the reported effects were very serious for the persons involved, listlessness, loss of energy, depression, headaches and much more. ### The Spanish Flu

Blood was extracted from the sick and injected into the volunteers. Patients spat into trays and the uninfected drank their sputum. Patients sneezed and coughed while volunteers, nose-to-nose, inhaled the droplets ejected as deeply as they could.

Little has presented itself after intense study of this virus and its behaviour to change this perception.

This is somewhat of an unusual virus in that for the vast majority of people infected by the virus, one experiences either no illness (asymptomatic) or very little sickness. Only a very small number of people are at risk of a potentially serious outcome from the infection—mainly those with underlying serious medical conditions in conjunction with advanced age and frailty, those with immune compromising conditions and nursing home patients near the end of their lives.

There is growing evidence that the treatment protocol issued to treating doctors by the Centre for Disease Control and Prevention (CDC), mainly intubation and use of a ventilator (respirator), may have contributed significantly to the high death rate in these select individuals.

By wearing a mask, the exhaled viruses will not be able to escape and will concentrate in the nasal passages, enter the olfactory nerves and travel into the brain.

As for the scientific support for the use of face mask, a recent careful examination of the literature, in which 17 of the best studies were analysed, concluded that, “None of the studies established a conclusive relationship between mask/respirator use and protection against influenza infection.” Keep in mind, no studies have been done to demonstrate that either a cloth

mask or the N95 mask has any effect on transmission of the **covid-19** virus. Any recommendations, therefore, have to be based on studies of influenza virus transmission. And, as you have seen, there is no conclusive evidence of their efficiency in controlling flu virus transmission.

It is also instructive to know that until recently, the CDC did not recommend wearing a face mask or covering of any kind, unless a person was known to be infected, that is, until recently. Non-infected people need not wear a mask. When a person has TB we have them wear a mask, not the entire community of non-infected. The recommendations by the CDC and the WHO are not based on any studies of this virus and have never been used to contain any other virus pandemic or epidemic in history.



Now that we have established that there is no scientific evidence necessitating the wearing of a face mask for prevention, as there are dangers to wearing a face mask, especially for long periods? Several studies have indeed found significant problems with wearing such a mask. This can vary from headaches, to increased airway resistance, carbon dioxide accumulation, to hypoxia, all the way to serious life-threatening complications.

There is a difference between the N95 respirator mask and the surgical mask (cloth or paper mask) in terms of side effects. The N95 mask, which filters out 95% of particles with a median diameter >0.3  $\mu\text{m}^2$ , because it impairs respiratory exchange (breathing) to a greater degree than a soft mask, and is more often associated with

headaches. In one such study, researchers surveyed 212 healthcare workers (47 males and 165 females) asking about presence of headaches with N95 mask use, duration of the headaches, type of headaches and if the person had preexisting headaches.



They found that about a third of the workers developed headaches with use of the mask, most had preexisting headaches that were worsened by the mask wearing, and 60% required pain medications for relief. As to the cause of the headaches, while straps and pressure from the mask could be causative, the bulk of the evidence points toward hypoxia and/or hypercapnia as the cause. That is, a reduction in blood oxygenation (hypoxia) or an elevation in blood CO<sub>2</sub> (hypercapnia).

It is known that the N95 mask, if worn for hours, can reduce blood oxygenation as much as 20%, which can lead to a loss of consciousness, as happened to the hapless fellow driving around alone in his car wearing an N95 mask, causing him to pass out, and to crash his car and sustain injuries. I am sure that we have several cases of elderly individuals or any person with poor lung function passing out, hitting their head. This, of course, can lead to death.

A more recent study involving 159 healthcare workers aged 21 to 35 years of age found that 81% developed headaches from wearing a face mask. Some had pre-existing headaches that were precipitated by the masks. All felt like the headaches affected their work performance.

Unfortunately, no one is telling the frail elderly and those with lung diseases, such as COPD, emphysema or pulmonary fibrosis, of these dangers when wearing a facial mask of any kind—which can cause a severe worsening of lung function.

This also includes lung cancer patients and people having had lung surgery, especially with partial resection or even the removal of a whole lung.

While most agree that the N95 mask can cause significant hypoxia and hypercapnia, another study of surgical masks found significant reductions in blood oxygen as well. In this study, researchers examined the blood oxygen levels in 53 surgeons using an oximetre. They measured blood oxygenation before surgery as well as at the end of surgeries. The researchers found that the mask reduced the blood oxygen levels (paO<sub>2</sub>) significantly. The longer the duration of wearing the mask, the greater the fall in blood oxygen levels.

The importance of these findings is that a drop in oxygen levels (hypoxia) is associated with an impairment in immunity. Studies have shown that hypoxia can inhibit the type of main immune cells used to fight viral infections called the CD4+ T-lymphocyte.

This occurs because the hypoxia increases the level of a compound called hypoxia inducible factor-1 (HIF-1), which inhibits T-lymphocytes and stimulates a powerful immune inhibitor cell called the Tregs. this sets the stage for contracting any infection, including **covid-19** and making the consequences of that infection much graver. In essence, your mask may very well put you at an increased risk of infections and if so, having a much worse outcome.

People with cancer, especially if the cancer has spread, will be at a further risk from prolonged hypoxia as the cancer grows best in a microenvironment that is low in oxygen. Low oxygen also promotes inflammation which can promote the growth, invasion and spread of cancers. Repeated episodes of hypoxia has been proposed as a significant factor in atherosclerosis and hence increases all cardiovascular (heart attacks) and cerebro-vascular (strokes) diseases.

There is another danger to wearing these masks on a daily basis, especially if worn for several hours. When a person is infected with a respiratory virus, they will expel some of the virus with each breath.

If they are wearing a mask, especially an N95 mask or other tightly fitting mask, they will be constantly re-breathing the viruses, raising the concentration of the virus in the lungs and the nasal passages. We know that people who have the worst reactions to the corona virus have the highest concentrations of the virus early on. And this leads to the deadly cytokine storm in a selected number.

It gets even more frightening. Newer evidence suggests that in some cases the virus can enter the brain. In most instances it enters the brain by way of the olfactory nerves (smell nerves), which connect directly with the area of the brain dealing with recent memory and memory consolidation. By wearing a mask, the exhaled viruses will not be able to escape and will concentrate in the nasal passages, enter the olfactory nerves and travel into the brain.

It is evident from this review that there is insufficient evidence that wearing a mask of any kind can have a significant impact in preventing the spread of this virus. The fact that this virus is a relatively benign infection for the vast majority of the population and that most of the

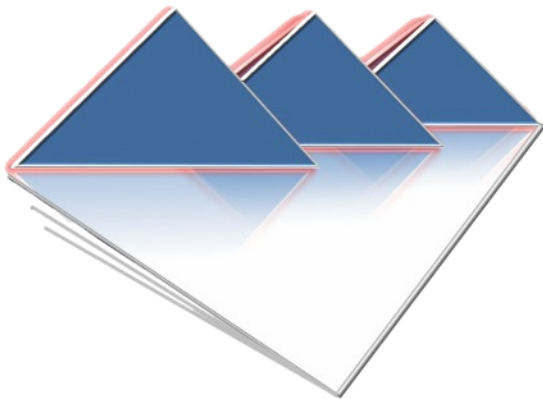
at-risk group also survive, from an infectious disease and epidemiological standpoint, by letting the virus spread through the healthier population we will reach a herd immunity level rather quickly that will end this pandemic quickly and prevent a return next winter.

During this time, we need to protect the at-risk population by avoiding close contact, boosting their immunity with compounds that boost cellular immunity and in general, care for them.

One should not attack and insult those who have chosen not to wear a mask, as these studies suggest that is the wise choice to make.

## **The Life and Philosophy of Pythagoras Part 3** **By Ella Rose Mast** **Based on Dr. Wesley Swift's Studies and Library**



**T**HE KEY TO HARMONIC RATIO'S IS HIDDEN in the famous tetractys, or the triangle of dots of your diagram. The first four numbers 1 through 4 reveal the intervals of the octaves. To the Pythagoreans, music was one of the dependencies of the Divine science of mathematics, and its harmonies were inflexibly controlled by mathematical proportions. That mathematics demonstrated the exact method by which God established and maintained the universe. Thus numbers therefore preceded harmony since it was the immutable law that governs all harmonic proportions.

Pythagoras assigned a tone to the spheres, he assigned different colours and forms, thus his diagrams, and in all he followed the program and story of the ancient mysteries. In fact he brought

back to the people the love of true music, which effects the senses, and emotions of different people. The type of music which influences the mind of Adam-man as well as his body is called musical medicine. Pythagoras maintained that the music of the stars was as from stringed instruments.

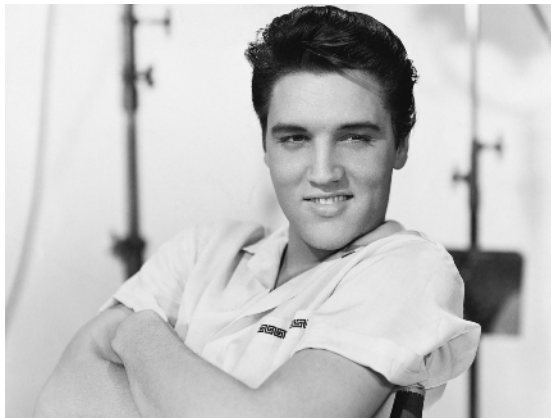
In fact he used the Song of Solomon sung to the accompaniment of the Lyre as musical medicine. It is said that while observing the stars one night that he encountered a young man befuddled with strong drink, and mad with jealousy who was piling faggots around the door of his mistress, with the intention of burning her house. He noticed that a flutist was playing a short distance away, the music a strange and wild rhythm then being played so much in Greece. He induced the magician to change his music to a slow rhythmic type and the intoxicated youth immediately became composed, and gathering up his bundles of faggots quietly returned to his own home.

Pythagoras believed that the introduction of a new and presumably different scale would endanger the future of a whole nation, and that it was not possible to alter a key without shaking the very foundations of the state. He maintained that music which ennobled the mind was of a far higher kind than that which merely appealed

to the senses, he instructed that it was the paramount duty of the legislature to suppress all music that was not pure and dignified, that bold and stirring melodies were for men, and gentle soothing ones for women. The greatest care was also to be taken in the selection of instrumental music, because the absence of words rendered its significance doubtful, and it was difficult to foresee whether it would exercise upon the people a benign or baneful influence.

Even today martial music is used with telling effect in times of war, and religious music while no longer developed in accordance with the ancient history and theory, still profoundly influences the emotions of the laity.

Now: then can you believe that types of music has been used against the kingdom in an effort to destroy young minds? Dr. Swift told us long ago of the program of the enemy to send to Africa and develop the jungle beat into American music which brought about what we witnessed in the 60's Do you now understand what happened to, for instance Elvis Presley?



A young man was taken and schooled in the jungle beat, and body movements which appealed to the senses, and he became a rock and roll star. But in the process his body was destroyed from the constant pressure of foreign rhythm, and he was kept going with the aide of prescription drugs from his own doctor. But his body in a few short years was destroyed. But the music stayed and has been used through the years, even though it is out of harmony with the music of the spheres. Back through the years before Pythagoras and even before Adam, this music of the spheres was known.

They believed that the heavenly bodies joined in a cosmic chant as they moved in stately manner across the sky. Job then describes a time, "When the stars of the morning sang together," and then

in the play, "The Merchant of Venice", the author of this Shakespearian play states: "There's not the smallest orb which thou beholdest but in his motion, like an Angel sings."

Today we have not only lost the Pythagorean system of Celestial music, but have no idea of the influence, or the effect of being in perfect rhythmic harmony, The Pythagoreans believed that there was a cord that stretched between heaven and earth, we would say this cord is spirit, but if you hang on to this cord you will not follow after the jungle beat of the pagans. When the music and harmony and rhythm which you inherited is maintained there is peace in your mind.

Pythagoras maintained that the first division of this rhythm was from the sphere of fixed stars, the Zodiac, then through the planets which are identical to the candlestick of the Hebrews. ## Harold Stough Notes The Coming of Elijah (El-Jah)

**T**HE MEANING OF ELIJAH, according to Strong's Concordance, is "God of Jehovah," and no one of the men of faith in the Old Testament was more worthy because of his life of faith and service, than the man who could stand before the priests of Baal, and the King, than Elijah the man. Surely he was the foremost of the prophets, in the strict sense of the word, for prophet means 'speaking forth for God'.

He showed no fear when he challenged and taunted the priests of Baal, and yet he was caring in the raising of the widow's son. In contrast he was fearful when threatened by Jezebel, fleeing to Horeb, forty days and nights without food, where God spoke to him telling him that He had seven thousand who had not bowed the knee to Baal.

He could rebuke Israel for her sins and, for punishment, shut up the heavens for three and a half years, 'that it rained not.' In narrating this James tells us (5:17) that 'he was a man and subject to like passions as we are.'

Yet he was the personification and representative of the prophets, as Moses was of the Law. 'The law and the prophets' is also identified as 'church and state' and it was Moses and Elias who appeared with our Lord at the Mount of Transfiguration representing the 'Kingdom of God with Power' as they were all with Holy Spirit-power before the eyes of the three Disciples.

So highly esteemed was he that the scribes and people generally, based on the prophecy of Malachi, anticipated his return and asked John the Baptist and our Lord if they were Elias. The answer was an emphatic No, but our Lord did say: 'If ye will receive it, this is Elias, which was for to come' (Matt 11:14).

In Matt 17:12 He said that 'Elias is come already and they knew him not, but have done unto him whatsoever they listed. Like wise shall also the Son of man suffer of them'. So both John and our Lord could have fulfilled Malachi's prophecy had the people repented



and heeded John's warning and our Lord's salvation.

In Matthews Gospel (17:11) Jesus clearly stated 'Elias truly shall first come, and restore all things'. That is a firm promise. But which Elijah? The man in Old Testament history bearing the sacred name? Or the Man Himself, the 'God of Jehovah.' He is the returning One as He has promised- 'I will come again' (John 14:3). He is the Name in reality - not the prefiguring one.

What are the 'all things' to be restored? If the Elijah is the Old Testament prophet of Israel, the 'all things' were all part of the Israel economy. **and they are not to be restored!** For instance (1) There is to be no temple (Rev 21:22) (2) There is no Aaronic priesthood (Heb 7:11, (3) There are no more ordinances of worship (Col 2:14) The Law is not to be written on tables of stone, but in our hearts (Jer. 31. Heb:10).

This interpretation is not of the generally taught views of the physical reappearing of the man Elijah, and I am conscious of the fact that I differ from other teachers, including colleagues. Orthodox Jewry also accepts interpretation of Elijah's return, having an extra chair at the Passover Feast, for his use.

Perhaps we should go back to the source of the prophecy and ask who is Malachi? As he is the only prophet, as far as we can discover, who specifically mentions this expectation. Reference books do not help much as they all resort to 'probabilities'. Lumen, in his *The Date of Malachi*, published in 1907, suggests that Malachi was not the last of the prophets, writing in the period of Esra and Nehemiah, 500-400 B.C. More likely he was the first!

Witnessing at the time of the accession of Rehoboam, and the division of the Kingdom of Israel. 'The burden of the word of the Lord to Israel by Malachi'. Not to the House of Israel nor to the House of Judah, and therefore before the division was complete. He argues from internal evidence that there is no mention of the Temple or its destruction as there would surely be if the temple of Solomon had been destroyed and Zerubbabel 'was a-building', that much mention is made of the Edom might and power which was destroyed by David and Solomon but which would be unknown at the time of Esra. He suggests the date of 960 circa, and that the 'man

of Judah' who was sent to Jeroboam warning of God's judgments for his making of sacrifices to false gods (I Kings 13) might well have been Malachi. If Malachi had existed in Esra's time united Israel would have been divided and the House of Israel some 300 years into captivity!



**Elijah**

Thus Elijah the prophet who had not yet commenced his ministry, must be a type of 'God of Jehovah' Who, in both revelations, warns the nation of judgments for unfaithfulness but it is the 'God of Jehovah' who brings restoration, as later prophets confirm.

But much more than that! He is the Creator-God! He is the Triune Godhead! He is the Eternal Son, to be the Word Incarnate! He is the Jehovah King! He, the second Adam, who restores all that the first Adam lost. He restores and He makes all things new! He the Creator-Christ makes a New Heaven and a New Earth!

How wonderful is this restoration is revealed in the victories of the Over-comers as promised in Rev. chapters 2 and 3 and the New Jerusalem reign of the One Who upholds all things by the Word of His Power.

# Ireland Remembers How 19th Century Aid from Ottoman Sultan Changed The Fate of Thousands

**P**OTATOES HAVE A SPECIAL PLACE IN IRISH CULTURE, as for centuries the people of the Emerald Isle have depended on this tuber as a diet staple.

A seven-year famine in the 19th century, known as the Great Famine or Potato Famine, killed more than a million people in Ireland, and stories from that time have left deep scars on the national psyche.

The famine in Ireland, which was under British rule at the time, was triggered by the potato blight or late blight, a disease caused by a fungus-like organism causing collapse and decay.

The greatest single disaster Ireland has ever suffered – *Gorta Mor* in Gaelic – forced more than a million citizens to migrate to the U.S., but those who were too poor to go anywhere were doomed to die from starvation or illnesses that struck the weak and malnourished.

Observing the suffering, English philanthropist James Hack Tuke said people in the worst-affected areas were "living, or rather starving, upon turnip-tops, sand-eels and seaweed, a diet which no one in England would consider fit for the meanest animal."

The worst year for the famine was 1847, as it saw no improvement in crop yields from the first two years of the plague.

But it was at that time, the plague's worst year – "Black '47" – that unexpected aid arrived from afar.

### Help from Ottoman Sultan

Thousands of miles away, in the Ottoman capital Istanbul, Sultan Abdulmejid I was made aware of this great human suffering when his dentist, who came from Ireland, told him about the desperate situation.

The sultan quickly offered 10,000 British pounds – just over a million pounds at current values, or \$1.3 million – to be used to help the starving people of Ireland.

However, Queen Victoria had already aided Ireland with 2,000 British pounds, and her advisors in London refused to accept any offer exceeding the monarch's aid.

Faced with this dictate, Sultan Abdulmejid unwillingly slashed his original offer of aid and sent Ireland 1,000 British pounds instead.

However, the sultan had a fierce desire to extend more help for this humanitarian cause.

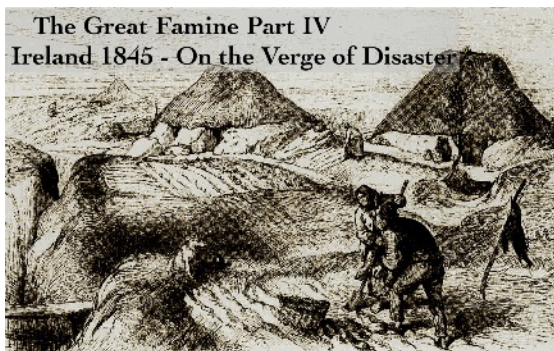
"He was eager to do more, and that's why he ordered three ships to take food, medicine and other urgent necessities to Ireland," said Levent Murat Burhan, Turkey's ambassador in Dublin, describing what happened next.

Speaking to Anadolu Agency (AA), Burhan said the historic aid operation was done on the sly, as the British navy would not allow any foreign ships to dock at harbours in either the capital Dublin or Cork.

"So the Ottoman ships had to travel further north and deliver the aid to the harbour of Drogheda," Burhan said.

The aid was delivered to the wharves of Drogheda on the coast of the River Boyne, and it is especially in that place that the generosity of the

Ottoman Empire is still remembered by the locals, 173 years later.



Visitors to Dublin museums can come across memorials and information about this unforgettable aid from the Ottoman Turks, but a plaque on the wall of a central Drogheda building, unveiled in 1995 by Mayor Alderman Godfrey and then-Turkish Ambassador to Ireland Taner Baytok, reads, "The Great Irish Famine of 1847 – In remembrance and recognition of the generosity of the People of Turkey toward the People of Ireland."

During a 2010 visit to Ankara, Ireland's then-President Mary McAleese expressed the Irish people's gratitude for the aid, saying that the people of Drogheda had "incorporated into their coat of arms your own beautiful emblems, beautiful crescent and star, and they are there to the present day."

One can indeed see the emblematic Turkish crescent and star across the town and most famously in the emblem of the local football team, Drogheda United.

Apart from the plaque of gratitude in the centre of the town, the crescent and star are engraved on stones and painted on a wall.

But perhaps the most significant evidence of the aid and the local gratitude for it comes in a letter signed by local dignitaries of Drogheda.

With pride, Ambassador Burhan showed AA a copy of the letter in his official room in Dublin.

The letter reads: "We, as Irish nobles, dignitaries and people, submit our gratitude to the Ottoman Sultan for his generous assistance to us due to famine disaster. It is inevitable that we apply for other countries' assistance to get rid of the threat of hunger and death.

"The answer given to assistance call generously by the Ottoman Sultan has also been a model for the European countries. Thanks to this accurate behaviour, many people have been relaxed and got rid of death. We submit our gratitude on behalf of them and pray for the Ottoman Sultan and his country not to face any disasters as we do."

### **Good, Humane, Generous**

An article titled, "A Benevolent Sultan," written in a religious journal, praised Abdulmejid's generosity.

"For the first time a [Muslim] sovereign, representing multitudinous Islamic populations, manifests spontaneously a warm sympathy with a Christian nation," it said.

"May such sympathies, in all the genial charities of a common humanity, be cultivated and henceforth ever be maintained between the followers of the crescent and the cross!"

A nationalist Irish journal also celebrated the sultan's philanthropic approach to the Irish famine, hailing Abdulmejid as a "good, humane, and generous man."

"A believer in Islam, he acted in the true spirit of a follower of Christ, and set an example which many professing Christians would do well to imitate."

Irish son James Joyce, the legendary novelist, even referred to Abdulmejid's aid in his masterpiece, Ulysses.

"Even the Grand Turk sent us his piasters," one of the book's characters says, criticizing the lack of aid from the British during those hard times.

### Good Relations

Ambassador Burhan has visited Drogheda a few times, each time getting a warm welcome from local politicians.

Indeed, the respect and love for the Turks is still there. He remembered a charity foot race with Frank Geoffrey, then the mayor of Drogheda.

"He went home and brought a Turkish flag to run with it," Burhan said, explaining that he was happy to see the mayor kept a Turkish flag at home.

Burhan also said the embassy is working on plans for a charity football game between Drogheda United and Trabzonspor, a Turkish Super League team from the Black Sea region.

Sharing the same colours, maroon and blue, the two sides became sister clubs in 2011, the Turkish ambassador explained, an enduring symbol of long-distance compassion between two peoples.

# Modern Wind Turbines Generate Dangerously “Dirty” Electricity

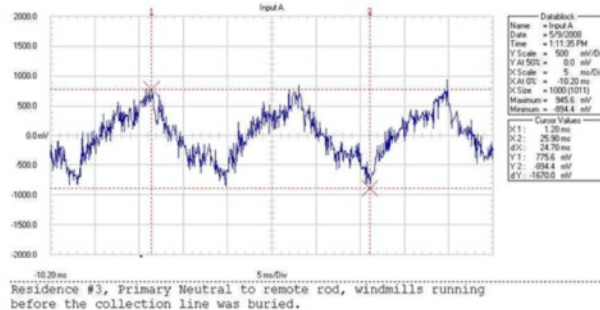
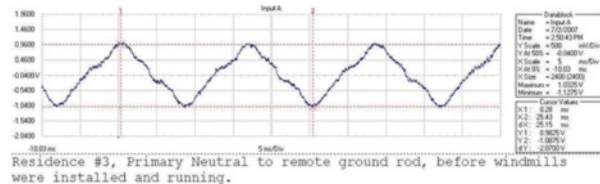
**W**IND TURBINES ARE CAUSING SERIOUS HEALTH PROBLEMS. These health problems are often associated, by the people having them, with the flicker and the noise from the wind turbines. This often leads to reports being discounted.

Residents of the area around the Ripley Wind Farm in Ontario where Enercon E82 wind turbines are installed feel that the turbines are making them ill. Residents suffer from ringing in the ears, headaches, sleeplessness, dangerously elevated blood pressure (requiring medication), heart palpitations, itching in the ears, eye watering, earaches, and pressure on the chest causing them to fight to breathe.

The symptoms disappear when the residents leave the area. Four residents were forced to move out of their homes, the symptoms were so bad. Residents also complain of poor radio, TV and satellite dish reception. There is no radio reception under or near the power lines from the wind turbines because there is too much interference. Local farmers have found that they get headaches driving along near those power lines.

The waveforms below were taken at one of the residences in the area. The first waveform was taken before the wind farm started operation. (As you can see, a ground current problem existed even before the wind farm started.) The frequency profile of the neutral to earth voltage changed dramatically after the wind farm became operational (second waveform). There

are far more high and very high frequencies present; indicated by the increased spikiness of the waveform.



As demonstrated by these waveforms, wind turbines are extremely electrically polluting. Studies and anecdotal reports associate electrical pollution with a similar set of symptoms to those experienced by the residents of the area (1, 2, 3).

The symptoms associated with electrical pollution are caused by overexposure to high frequencies and are known as radio wave sickness (4). Technical papers discuss the fact that it requires only very small amounts of high frequency signals (either from transients or communications) on wiring to induce significant electrical currents in the human body. They support findings of human health problems caused by exposure to even small amounts of high frequencies (5, 6).

The specific symptoms experienced depend on both the frequencies present and the body type and height of the person being exposed. Increased risk of cancer is associated with exposure to both “dirty” power on wires and electrical ground currents (7, 8). Animals also experience health problems related to electrical pollution exposures. Dairy cow’s milk production and health suffers as exposure to high frequency transients increases (9, 10).

They support findings of human health problems caused by exposure to even small amounts of high frequencies (5, 6). Increased risk of cancer is associated with exposure to both “dirty” power on wires and electrical ground currents (7, 8). Animals also experience health problems related to electrical pollution exposures. Dairy cow’s milk production and health suffers as exposure to high frequency transients increases (9, 10).

Suncor and Acciona have tried to some degree to correct the problem at the Ripley Wind Farm. They buried the collector line from the turbine near some of the most badly affected homes and gave the homes a separate distribution line. They also put an insulator between the neutral line and the grounding grid for the wind farm.

As you can see, from the waveform below, it helped somewhat. It reduced the high frequencies being induced on the distribution system by the proximity of the collectors and the high frequencies put directly on the neutral by the tie to the wind farm grounding grid.

However, it is still not as good as before the wind farm installation and neither is their health.

This is not the only wind farm that seems to be causing serious health problems for local residents. The Enercon E82 does not seem to be unique in its design or problems. Wind turbines generate a sine wave of variable frequency in order to be able to take advantage of the full range of wind speeds.

However, the grid only operates at 60Hz, so the variable frequency is converted to DC and then an inverter is used to convert the DC signal to 60 Hz AC. This is the signal that is put on the power line. Most inverters generate an extremely “dirty” signal, which is a 60Hz waveform polluted with a lot of high frequency transients. The previous waveforms are examples of this. The people in this house were so sick at home with the wind turbines running that they had to abandon their home and move elsewhere while they waited for the problem to be fixed. The changes made by the wind farm combined with a neutral isolation device installed by the homeowners has made the home livable, but their health is still affected by the operation of the wind turbines.

## Prehistoric London Its Mounds And Circles By E. O. Gordon ( Published 1946 ) Part 15



**T**HAT STONEHENGE was standing at this time is no longer an uncertainty, thanks to Sir Norman Lockyer's observations and calculations, taken from the precincts of the Solar Circle, which have proved the "Circle of the Dominion" to have been erected circa 1680 B.C., some five centuries before the fall of Troy in 1185 B.C., and the subsequent dispersion of the Trojans. These dates may possibly help us to identify the personalities of the mysterious "7 Old Kings" and "7 New Kings," whose barrows may be seen on the horizon from the Great Circle of the Ambresbiri (above).

The tumuli of the "7 Old Kings" may be the burial mounds of the monarchs of Hu Gadarn's

migration, who each in his day had been "lifted" and "crowned" within the northern circle of the "Potentes," under the shadow of the mighty mound of the Cludair Cyvrangon whose age, like that of the Temple of Abury, will probably never be known.

And may not the barrows of the "7 New Kings" contain the mortal remains of the successors of Brutus, of the heroic Trojan race, destined, as they believed, to sway a wider Empire than either the Asiatic or Italian Troy (Rome)—a tradition which some hope is in the course of fulfilment?

In the Chronicles it is stated that "Brutus, minded to build him a chief city, went round the whole circuit of the land in search of a fitting site.

When he came to the river Thames he found the very spot best suited to the purpose. He therefore founded his city there and called it New Troy, and by this name it was known for many ages thereafter until at last, by corruption of the word, it came to be called Trinovan turn."

A glance at the index of an atlas shows that London was not the only city in Europe to have been called after the historic Troy; there are two towns of that name in Italy and one in France. In the ancient Troy on the Tagus, although practically destroyed by the earthquake, many remains of so-called Phoenician masonry may still be seen.

In our own case we have to account for the loss of the name of Troy before the Roman invasion in 52 B.C. The solution of the difficulty may be that the older prehistoric name of the Llandin triumphed over the alien appellation of Caer Troia.

Brutus's (right) knowledge of the different seaports of the Mediterranean would have led him at once to appreciate the exceptional capabilities of the site of the Kymric Caer, perched on a hillock on the narrowest reach of a tidal river, with two natural ports, the Walbrook and the Fleet, and practically impregnable by land, girt in as it was by primeval forest on the north, by fen and moor on the east and west and unapproachable from the south, the shore from Battersea and Greenwich being one unbroken expanse of mud some 8 miles long, varying from 2 to 20ft in width, twice in every twenty-four hours submerged by the tide.

The numerous prehistoric remains unearthed in the city and figured in the catalogue of the Guildhall Museum afford positive proof of a Neolithic occupation, succeeded by that of the Bronze Age. The evidence of these material remains point to the probability that the original settlers were no other than the first wave of emigrant under Hu Gadarn, the mounds and circle-builders of Britain.

Seeing that the great waterway of the Severn had its Glastonbury and its Caerleon, and the South Coast its Totnes and its Winton, it is most unlikely that the site of London would have been neglected from the coining of Hu Gadarn in the time of Abraham, to the arrival of Brutus and his Trojans in the days of Samuel, unique as it is, in position as the only high ground on the North Bank of the Thames, 60 miles from the sea.

Navigable, moreover, for nearly its entire length of 150 miles, the prehistoric mounds of Windsor, Wallingford and Oxford testify to the existence of early Kymric settlements on the banks of this all-important waterway on the East of the Island.

Brutus is celebrated in the Triads as one of the "Three King Revolutionists of Britain," the Trojan system under him being incorporated with the Patriarchal. The changes which the

Trojan Prince intended to carry out may have influenced his choice in making the Porth of the Llandin his capital, a trading centre, removed from the immediate influence of the Druidic authorities at Abury, who would, naturally, have resented any innovation of their own ancient laws. It is satisfactory to find the text of the Triad confirmed by the most learned jurists, who refer the original Institutes of our Island to the Trojan law brought by Brutus. Lord Chief Justice Cope (Preface to Vol. III of Report) affirms "the

original laws of this land were composed of such elements as Brutus first selected from the Ancient Greek and Trojan institutions."

It is to these native laws, says Morgan, and "not as has been absurdly alleged to any foreign or continental source, German, Saxon or Norman, Britons have in all ages been indebted," for the superior liberties they have enjoyed as contrasted with other nations.

Lord Chancellor Fortescue, in his work on the Laws of England, justly observes, "Concerning the different powers which kings claim over their subjects, I am firmly of opinion that it arises solely from the different nature of the original institutions. So the kingdom of Britain had its original from Brutus of the Trojans, who attended him from Italy and Greece and wove a mixed government, compounded of the regal and democratic."

The most memorable of the laws of Brutus is that of the Royal Primogeniture, by which the succession to the Throne of Britain was vested in the eldest son of the King. This was known as pre-eminently "the Trojan law," and has in all ages regulated the succession to the British Crown among the British dynasties. It was



eventually adopted by the Normans and became the law of England.

Another fundamental ordinance established by Brutus was, that the sovereigns of Cambria and Alban should be so far subordinate to the sovereign of Lloëgria that they should pay him annually forty pounds weight of gold, for the military and naval defence of the Island. The whole Island was never to be regarded otherwise than one Kingdom and One Crown.

This Crown was called “the Crown of Britain” and the sovereignty over the whole Island vested in it—the Crownship of Britain, Unbennaeth Prydain. The military leadership remained in the Eldest Tribe, the Kymry, and from it the Pendragon, or military dictator, with absolute power for the time being, was, in the case of foreign invasion or national danger, to be elected.

The leadership was the same as Sparta exercised in Greece and Rome in Italy. Every subject was as free as the King. There were no other laws in force than those which were known as Cyfreithiau, or “Common Rights.” There were no slaves, the first slaves in aftertimes were the Caethion, or captives taken in war.

The Usages of Britain could not be altered, by any act of the Crown or National Convention. They were now considered the inalienable rights to which every Briton was born, and of which no human legislation could deprive him. Many of these usages are remarkable for their humane and lofty spirit, for instance, “There are three things belonging to a man, from which no law can separate him—his wife, his children and the instruments of his calling, for no law can unman a man, or un-call a calling.”

A British or Trojan law remains in full force to this day—that the sceptre of the Island might be swayed by a queen as well as a king. In the Piet kingdom, the succession went wholly by the female side. Amongst the continental nations no woman was permitted to reign, the Saxons considered it a disgrace to a king to be seen seated on a throne with a queen.

The chariot system of warfare and the system of military castrametation are said to have been introduced into Britain by Brutus. Cæsar describes both as having attained, in his time, the highest perfection. The British castrametation

was, in some important respects, superior to the Roman.

Another memory of the Trojan colonization is perpetuated in the numerous Troy Towns or Mazes cut in the turf in all parts of England and in those which still exist in the uplands of Wales, called by the shepherds “Caerdroia,” the city of Troy, allusion to which is made in Drych y Prif Oesoedd and in other Welsh histories. There is nothing more popular among the Welsh, we are told, than the belief that they came originally into this island from Caerdroia.

This tradition has impressed itself so indelibly on the Keltic mind, that we see even shepherds on the summit of every hillock making pictorial representations in the surface of the grass of the labyrinthine walls of ancient Troy. On the plains on both sides of the Solway, mazes are also to be met with, and as in Wales herdsmen still cut labyrinthine figures upon the turf, which they call, for no reason except that their fathers used the same expression, the “Wall of Troy.”

Whether the name Troy Town was used generically of all turf-cut mazes, it is impossible to say, but it is certain that many of them in different parts of the country were so designated, and both in name and in form take us back to classical antiquity. Even around London the name survives; for example, at Peckham Rye an old row of cottages built on the site which formed part of the Common is called Troy Town.

The upper garden at Kensington was known as the “Siege of Troy”; it was on this site William III laid out a topiary maze, and at about the same time he restored Henry VIII’s popular maze at

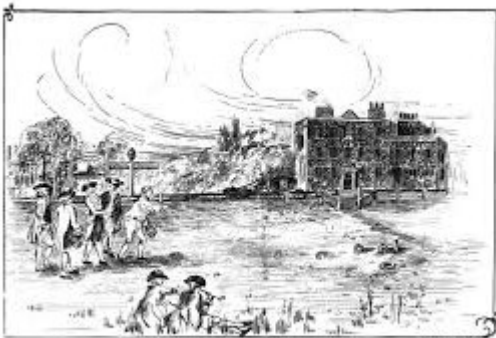


**Blackheath Maze Now Built Upon** Hampton Court, which that monarch may have probably founded upon a yet earlier maze of unknown antiquity.

At Blackheath another maze may be identified in the midst of the prehistoric remains, where, not far from the entrance to Morden College, successive ridges and depressions, faintly discernible, represent the remains of the old labyrinthine pathway. An old survey of the Manor of Greenwich shows that the familiar thoroughfare of Maze Hill led direct to the Maze.

That this commanding tableland was an important centre of civilization in remote antiquity is certain from the partial remains of the prehistoric Gorsedd (Great Seat) to-day known as Whitfield's Mount, where, as upon similar sites in the vicinity of London previously described, the "Privilege" of the people to hold public meetings still survives, and it is only within the memory of the present generation that the numerous barrows, which for centuries crowned the Lansdown (Llan, sacred) and the Point, commanding the river for some six miles on the east and west, as also the upper part of the royal Park, have been ruthlessly destroyed in order to supply the ever-increasing demands for cricket and football grounds.

Passing right through the middle of these tumuli on the Heath ran Watling Street, the old trade route from the South Coast to the Porth of the Llandin. Its north-westerly course has been traced on the high ground near Peckham, where, as we have seen, was another Troy Town, probably connected with the "Place of Assembly," the Sacred Mound at Kennington.

The names of Maze Pond, Maze Street, and Maze Lane, near the site of the old Ferry on Backside, Southwark (Wark means fortification), preserve the memory of yet another of these places of amusement, as some suppose them to have been, and suggest the presence of a large population, composed probably of traders and merchants connected

with the control of the corn supplies from the numerous "dene holes," or granaries, in Kent and Surrey, for it was at this point that food and other commodities were conveyed into the old Caer of New Troy.

The Ferry at Southwark would appear to have rivaled the ford at Westminster in importance, from the fact that before a stone of the Abbey was laid, we find St. Swithin, Bishop of Winchester, in the ninth century buying up the site of the ferry and building his beautiful cathedral, to which he attached a college for the training of secular priests to minister to the spiritual needs of the people, as well as to administer civic justice.

It is to the first Chancellor-Bishop St. Swithin that the country owes the first organized attempt to reestablish the Druidic system of Church and State government on Christian lines, a system peculiar to Britain, with the traditions of which the Bishop would have become acquainted in royal Winchester, where his Cathedral stood on the actual site of a Druidic Court of Justice.

It has been thought, moreover, that it was the Druidic College of Priests in the Close that suggested to St. Swithin to found Theological Colleges at Winchester and Southwark.

Be this as it may, on the north side of the sacristy of Southwark Cathedral the remains of the Saxon apse are said to exist, and marking the work of St. Swithin as the first Chancellor-Bishop of England is the original stone seat on the north-east side of the Chancel, where, for centuries, Bishops of Winchester held their Consistory Courts.

Not only was the great St. Swithin the founder of secular education in Saxon times, but it is to the Chancellor-Bishop, the Church owes the revival and restoration by statute of the Druidic law of tithes. The terrible incursions and depredations of the Danes, the Bishop regarded as a visitation of Providence for the neglect and poverty into which the Churches in all parts of the country had been allowed to fall from the lack of funds and dearth of clergy.

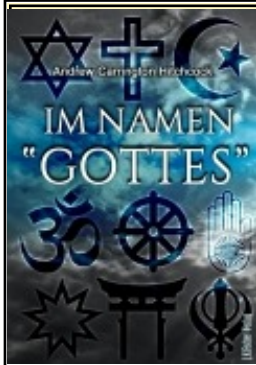

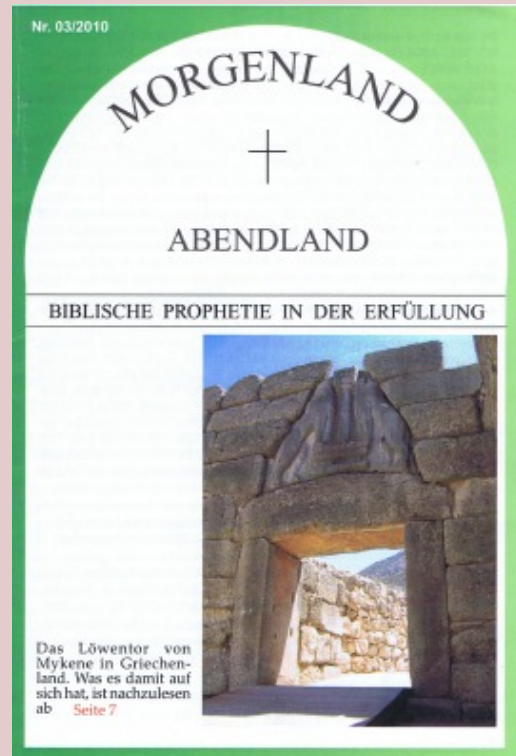
