# Arsenal Of Words (Part 16)

## A Demonstration of The Deceptive Use of Words

#### Know Your Enemy!

**T**HE JEWS have always been the enemies of Jesus Christ, who said, "Those who are not for me are against me." (Matt. 12:30.)

#### Dispersed Israel in the New Testament

**Hebrews 8:8-13** is a direct cross-reference to Jer. 31:31-33, the New Covenant **with Israel**, verifying that it was and still is a Covenant made solely with the Israelites. No other people are either named or mentioned.

The entire Book of Hebrews verifies that the Sacrifice at the Cross was made exclusively to redeem Yahwah's people, Israel, and that the sacrificial priesthood was abolished in favor of the Melchizedek priesthood, which is the hereditary "Kingdom of priests" that Yahweh wants us to become.

Each male head of household will be the king-priest of his household. It will be government by Divine Law/Decree. Friends, the Universe **IS NOT** a Democracy. It is an organic hierarchy, with specialized roles for specialized organs. Just as the Patriarch is the head of the family, so will the Kingdom be represented and led by these Patriarchs. It will be run like one, huge, law-abiding Family!

Here is how Jesus describes this Kingdom:

"Therefore every scribe which is instructed unto the kingdom of heaven is like unto a man that is an householder, which bringeth forth out of his treasure things new and old." (**Matt. 13:52.**)

Hey, I resemble that – teaching from **BOTH** the **NEW** and the **OLD** Testaments!!!! The Jews claim to have the Old Testament, and the Judeo-

Christians claim to have the New Testament. But the true citizens of the Kingdom will come to know and appreciate **BOTH**, as Yahweh intended.

And a double witness: "For the kingdom of heaven is like unto a man that is an householder, which went out early in the morning to hire labourers into his vineyard." (**Matt. 20:1.**)

(By the way, this parable absolutely demolishes the ideal of socialism, in which everyone is supposed to be treated according to human standards of "equality"! In this parable, there is no such thing as "equal pay for equal work." Political attempts to establish equality have always failed miserably, because the slothful put in just as much time as the assiduous, yet they expect the same wages for less effort! Only Yahweh knows what each one of us is worth. He rewards us accordingly. Have you ever objected to being **OVERPAID**? Don't complain if you think someone else is being overpaid. Do your job well and you will be rewarded. Paul amplifies on this point in **Rom. 9:18.**)

Since the Kingdom replaces the Levitical, sacrificial priesthood with the reformed Melchizedek priesthood of householder/scribes (family men with a commanding knowledge of the Scriptures, having it written in their hearts), the context is still the Servant People, Israel. Therefore, this redemption of Israel has nothing to do with the "salvation" of any other people.

That is an exaggerated claim, and the distorters have once again invented a universalistic extrapolation of the language used in Scripture, which is not justified by the Greek New Testament / Covenant.

This universal interpretation and its subsequent application to Biblical passages, intended only for Israel, will not hold up under intensive scholarship. Since only the Adamic Race fell, only the Adamic Race needed to be redeemed. It's just that simple. The convoluted reasoning of the universalists is just so much gibberish.

For those of you who are concerned about the fate of the other races, and their destiny, don't fret. These are the pre-Adamic races that existed in Genesis 1 before Adam and Eve were formed in Genesis 2.

There are some hard-core Identists who will say that I am giving the other races too much credit. They believe that Yahweh will make an end of all other races; but this is not what the Bible teaches. (See Ezek. 38:16, 39:7, 21.) Even Dr. Wesley Swift, considered by some anti-Identists to be the most racist person who ever lived, teaches this:

"Those who preach the Gospel of the Kingdom know that this Gospel is the transference of God's Kingdom from heaven to earth with a spiritual seed with the very sons of Glory. with the very purposes He has of establishing a Kingdom in the earth forever. And that His Grace reaches out to the ends of the earth, and to people of every race, and every kind.

That it has been His purpose to bring them all into proper relationship to Himself, to teach them the errors of their way, and to give them the capacity to think correctly. And the Administration of Righteousness in the earth was to be conducted by the children of His Kingdom.

His children, who had a spiritual capacity to think His thoughts, the offspring of THE MOST HIGH, having been begotten in the spirit in the beginning." -- from "*The Kingdom and the Lake of Fire.*"



If you have never heard a sermon preached by Dr. Wesley Swift, you have never heard dynamic preaching!!!!

The world has been seduced by the false concept of "Unity in Diversity." Those of us who teach the Organic Unity of the Universal Body are being called "racists" because we **KNOW** that there is no such thing as the "equality of the races," just as there is no such thing as the "equality of the sexes," or "equality of lifestyles," etc.

These are all seductive lies that appeal to your emotions. It's funny that only White people are susceptible to this **GUILT TRIP!!!!** The spleen cannot perform the function of the heart; and the colon should not be jealous of the lungs, and muscle cells should not try to perform the function of brain cells; but this is what the "Unity in Diversity" crowd offers as a solution to the world's problems. They teach socialistic mumbo-jumbo. We teach scientific, Biblical and historical facts. They teach wishful thinking. We teach discernment.

Over and over, the Bible teaches that the Caucasian people have a particular role, established by Yahweh, Himself, that will not be changed by any act or circumstance:

"And I will strengthen the House of Judah (Two Tribes), and I will save the house of Joseph (The Ten Tribes), and I will bring them again to place them; for I have mercy upon them: **and they shall be as though i had not cast them off:** for I am Yahweh their God, and will hear them." (Zech. 10:6.)

Does this sound like literal Israel will be changed into a "spiritual Israel" of many races? Or does this sound like a **RESTORATION?** Only the fertile imaginations of the false priests of Judeo-Christianity can twist and pervert such passages into today's universalistic, theological trash; or

should I call "Spiritual TRASH"? On the other side of the trash heap, the rabbis of Judaism teach that the House of Joseph has vanished forever, thus, directly contradicting Zech. 10:6. Whom will you believe, God or the false priests?

He has been patiently waiting for you to call on Him. He is your Father. You are His child. You are Christian Israel. Don't let the false priests estrange you from your Father and your True Family any longer.

Throughout the Book of Acts, when the word Israel is used, it refers exclusively to the literal, flesh and blood Israelites. Acts 1:6 is a perfect example. The Apostles ask Jesus when the Kingdom will be restored to Israel, that is, to their kinsmen, Israel.

This cannot possibly be in reference to the Jews, for the Jews were the very persecutors of Israel and Judah at this very time. The New Testament is very clear in telling us that it was the Jews who were persecuting the Apostles in particular and the early Christian Israelites in general.

Do you think that these Israelites were actually desirous of giving the Kingdom to their arch-enemies, the Jews? NO!

They wanted the Kingdom to be restored to **THEMSELVES**, Israel and Judah, and their Adamite Kinsmen. But, because we have been brainwashed into automatically equating Jews and Israelites, we cannot read the Bible without confusing the bad guys with the good guys. Without the proper racial and theological distinctions between Jews and Israelites, modern Christianity is following the wolves in sheep's clothing.

The Israelites of Judea knew very well that the Jews were another species altogether. Because of the erroneous and fictitious definitions attributed to the words that appear in Scripture today, everyone is confused about who or what a Jew is. I hope you are beginning to understand who the Jews really are. They are most definitely **NOT** Israel!

Except for Judas, 11 of the original 12 Apostles, and St. Paul, derived from the tribe of Benjamin; they all belonged, racially, to the same genealogy as the Patriarch, Benjamin, one of the two Tribes of the **HOUSE OF JUDAH**.

Just before he died, Jacob/Israel made this prophetic statement about the descendants of Benjamin:



"Benjamin shall ravin as a wolf: in the morning he shall devour the prey, and at night he shall divide the spoil." (Gen. 49:27.)

A wolf in the service of Yahweh will tear the enemy (the Pharisees) to shreds. The "morning" is the dawn of the Christian era, brought in by the Tribe of Benjamin, which has the wolf as its heraldic symbol. The "night" is the Judgment Day, after which Benjamin will help salvage ("divide the spoil") what is left of Western Civilization.

At all times, and in every instance, the New Testament distinguishes between the True Israelites, in the flesh, versus the Jews, who are never referred to as Israel, but who are referred to as Judeans. Nowhere does the Bible say, Jew = Israelite. This is always an incorrect inference, which is only made possible because of Jewish interpolations of these words in Scripture.

By routinely translating **both** the words, Judean, and Judah, as Jew, a false equation between those two words has been accomplished. Obviously, the intentionally biased commentaries, such as those found in the Scofield Reference Bible, and other self-serving literature, contain a multitude of misleading statements and words. Few Christians are aware of the fact that Scofield was financed by the Rothschild banking family.

[Scofield and other Judaizers](#) make habit of falsely equating Jews with Israelites, but the

original language of the Bible **NEVER MAKES SUCH AN EQUATION OR ASSERTION.** This erroneous equation/conclusion can only come after following many false leads, deliberately planted by the Deceiver.

The reason you don't know this is because you have been consistently lied to by expert, professional, media-savvy Jewish theologians and their sycophantic stooges, the Judeo-Christian clergy. It is these two groups that own and control virtually the entire gamut of Jewish and Christian religious publications, including production and distribution.



This monopoly is an unholy alliance of dogma and money. But this is only the religious arm of their propaganda machine. The Jew, apart from the Judeo-Christians, also exercises totalitarian control of our secular media, publishing, recording, entertainment and advertising industries; and this output keeps our minds tightly focused inside the box of commercialism, sexual promiscuity and anti-Christian values, which is to say, inside their matrix of deception. {For a detailed study of the historical origin of this matrix of deception, please see this [study](#):}

The following verses, Acts 2:22, 36; 3:12, 4:8, 10, 27; 5:21, 31, 35; and many more **Are All References to Israelites in the Flesh** and refer to no other people.

Acts, Chapter 2 lists all of the flesh and blood Israelites who came to Jerusalem **from the dispersion**, listing their countries of residence, and these people were all Israelites in the flesh, NOT the fictional, "spiritual Israel," which is constantly paraded before the pulpits of Baal. The Judeo-Christian fantasy, that beckons to men of all races, colours, and creeds, encompassing them all under the umbrella of "universal salvation," is a patent fraud. This is not God's plan.

God's Plan is to use Israel, as a segregated nation, to be an example of His Lawful Government on earth. From our example, the other races will learn righteousness. This is our commission. If they think it is haughty of us to make this claim, I would ask this question: "What's the difference between **OUR CLAIM** versus the Jewish claim?"

We Caucasians can prove our lineal descent from Israel. The Jews cannot. And Caucasian Israel has been an obvious blessing to the world, thus fulfilling the promises made to Abraham (Gen. 18:17-19; 22:17-18), Isaac (Gen. 26:1-4), and Jacob (Gen. 28:1-4), that their descendants would be an unconditional blessing to the world.

So, why are you willing to accept, uncritically, the claim of an impostor, with all that it entails, including the curses, deceit, and evils that they have foisted upon every nation, over the claims of the rightful heirs, Christian Israel, the White Christian people who have blessed the world with technological wonders (transportation, construction, computers, etc.), an ample supply of food through agriculture, the Bible, and countless other blessings, too numerous to list here? If you have eyes that see, you can see which direction the world is heading under Jewish hegemony. The prospects of Zionism and Talmudism are very bleak, indeed.

When Paul addressed the Greeks on Mars Hill, he was talking to the literal descendants of Zarah-Judah, whose ancestors were the founders of the city Athens. The city of Athens may even have been named for the Egyptian god, Aten.

This migration of Hebrews would have occurred around 1500 BC, during the Egyptian captivity of Israel. These were migrant Israelites who had escaped the Egyptian captivity and sailed across the Mediterranean Sea, circa 1500 BC.

Thus, the nation of Greece was founded by a sub-tribe of Judah, as were Sparta and Rome. It was to these **RACIAL JUDAHITES** that he spoke these words:

"For in him we live and move and have our being; as certain also of your own poets have said, For we are also His offspring. Forasmuch as **WE ARE THE OFFSPRING OF GOD...**" (Acts 17:28-29)

<-- No Eli, Paul in Acts 17 was talking to Ionian Greeks, who were the founders of Athens, as is evident in all ancient history. Also, Athens was named for Athena, from the Syro-Phoenician goddess-idol Anath! wmfinck 06/05/09 -->

Only the Adamic Race is the direct offspring (sperma) of God, as recorded in Luke 3:38.

It is also true of Greece and the Balkan area that many Japhethites had settled there. These Japhethites (mainly the Ionian Greeks) would have been the kinsmen of Zarah-Judah, since Japheth and Shem were brothers.

The Epistle of James (1:1) is specifically addressed to the **"Twelve Tribes Scattered Abroad."** But the Jews teach that those millions of Israelites "just disappeared" from the face of the earth, never to be heard from again. Who is the liar? The Bible or the Jew?



The First Epistle of Peter is addressed to these same "strangers" [kinsmen according to the flesh who live in another country], in several of the same nations mentioned in Acts, to whom he refers as the "elect according to the foreknowledge of God the Father." Now, I ask you: Can the Elect be everybody? Narrow is the gate, but broad is the path of Judeo-Christianity. (Matt. 7:13-14; Luke 13:24.)

"But ye are a **Chosen Generation [Race], a Royal Priesthood, an Holy Nation, a Peculiar People;** that ye should shew forth the praises of him that hath called you out of darkness into his marvellous light." (**I Peter 2:6**)

It doesn't sound like Peter is saying that **Everybody** is going to show forth this light! Still believe the New Testament is addressed to the whole world? On the contrary, it is an instruction manual written to, by, for and about True Israel and Our particular role in restoring this world to His Order. And the Jews, as the children of the

rebellious one, have always been the major obstacle in the re-establishment of His Order.

The Book of Revelation confirms that the New Jerusalem will consist of the **ELECT** of the 144,000, of the **Twelve Tribes of Israel.**

Jesus Christ confirms that "I am not sent but unto the **LOST** [Greek *appolumi*, meaning exiled, dispersed] **Sheep of the House of Israel.**" (Matt. 15:24)

When Jesus sent the Apostles out to teach, He told them, "Go not in the way of the nations, and into any city of the Samaritans [most of whom were the mongrelised descendants of Shelah, the very same people that Ezra and Nehemiah refused to allow to help rebuild the Temple], enter ye not: But go ye rather to the **Lost Sheep of the House of Israel.**" Matt. 10:5-6)

That is to say, **Seek Out the Israelites of Those Nations, and Preach to Them.** Don't worry about those of other races. They will be blessed when you, dear Christian Israelite, have performed your commission.

The reason why Jesus instructed the Apostles to avoid Samaria was because the leadership of the Samaritans of that time were the mongrelised descendants of Shelah, the son of Judah and a Canaanite woman. These people had taken over part of the territory that the Ten Northern Tribes had vacated as a result of the Assyrian Captivity. (2 Kings 17:24.) These people had concentrated themselves around the old city of Samaria, the former capital city of the Ten Northern Tribes.

In fact, these people still exist today! They are the Karaites of Samaria, who, very interestingly, practice of form of the Mosaic Law which was never infected by the Talmud! Isolated from Judaism, they have maintained their Mosaic traditions for over two thousand years! Since their religion is based on the Old Testament, it is much closer to Mosaism than Judaism ever was! The problem is that they are not Hebrews, so they cannot be part of our congregation, nor do they desire to be. This is more proof that Judaism was an innovation, not the **ORIGINAL** Mosaic Law.

Matthew 10:23, incidentally, refutes Preterism, an old Catholic doctrine, which teaches that all the prophecies of Scripture were fulfilled by 70

AD, with the destruction of the Temple. On the contrary, the Word had not even reached the Children of the Dispersion yet, as they were scattered throughout Europe and Asia Minor, from old Babylon to Ireland. The carrying out of the Great Commission had only just begun!!! In the year 70, the vast majority of Israelites had not yet heard the Gospel. This just goes to show how the lack of a historical perspective can lead people into false doctrine.

Scholars have marvelled at how pagan, racially White Europe so quickly converted to Christianity, "quickly" meaning a period of several hundred years! Despite the fact that most of the Dispersed of Israel were practicing pagans at that time, they still had, hidden deep within their genetic make-up, the intrinsic expectation of the coming of the Messiah.



That fact, combined with their cultural heritage, created an irresistible urge to respond to His call. Jesus said, "My sheep hear my voice." (**John 10:27.**) When they heard this "Good News," that the Messiah had come, they converted en masse, in the spirit of gladness and reconciliation. This genetic and cultural fusion was the fulfilment of many other prophecies, including Jer. 14:8 ("the hope of Israel"), Jer. 31:31-33 and Heb. 8: 8-13.

Israel was brought closer to the Father through the sacrifice of His Son. This is just further proof that the Jews are not Israel, because the Jews, both then and now, remain totally alienated from Yahshua and utterly unresponsive to His call. To be a Jew is to **Deny The Son!!!**

"Whosoever denieth the Son, the same hath not the Father." (1 John 2:23.)

The merciless Roman, Jewish and Catholic persecutions, that raged from the crucifixion onwards, extended well into the Reformation Period, but the forces of antichrist were powerless to stop this miraculous conversion.

The fact is that this conversion of Israel is still a work in progress, even today! From my perspective, I see that the Restoration of True Israel is now under way. The awakening of True Israel is in progress, at this very moment.

Matt. 10:23 states this long-range prophecy: "For verily I say unto you, Ye shall not have gone over the cities of Israel, **Till The Son of Man Be Come.**"

The New Testament confirms that, while Jesus was ministering to Judah and Benjamin, the House of Israel was living in the cities, towns, villages and farms of the nations in the Dispersion. Has your rabbi or your clergyman ever revealed this fact to you?

Also, many of the "Greeks" and "Romans," who were in Palestine in those days, were actually descendants of Dispersed Israel. This includes Pontius Pilate, whose native home was Spain. Since Spain was settled heavily by the tribe of Gad, he was probably a Gadite. The modern city of Cadiz was originally named Gadesh, which, in the Hebrew, means "men of Gad."

There is only one possible meaning to Verse 23, since the Israelites were prophesied to become uncountable millions of people, unlike the Jews, who, even today, are **STILL** a minority wherever they live (Obad. 1-2) and are, in fact, still the main persecutors of True Israel.

Yes, still! The exact meaning of verse 23 is this: The conversion process will not cease until the Second Coming; and that Day is on the horizon. The "cities of Israel" are the **Cities of the White Race!!** Since most of our people are still under the thrall of Judeo-Christianity, they have yet to hear the Gospel of Christian Identity!!!

Furthermore, it is a fact that the Jews **Have Never Built a City**. All of the European cities, to which the Apostles went, were built by White Israelites. Even in the so-called Israeli State, the Jews have never built a city, for those cities, such as Tel Aviv, and others were already built. The Zionists just came in and stole it from the native inhabitants, who were the real builders.

As a nation of moneylenders, thieves and harlots, they have always **STOLEN** the property of others through their usury and unsavoury business rackets. Throughout history, the Jews



have never built anything, except for gambling parlours, money changing houses, whorehouses and pawn shops.

These truly unique Jewish institutions, all of which were first instituted in ancient Babylon, have always been constructed on the basis of exploitation, civic strife and degenerating morals.

If a Jew does anything of worth or value, it is only for his own benefit or that of his tribe, never for the benefit of non-Jews. Jewish religion and culture are designed and calculated to leave the host culture bereft of value. After they have left a host nation in ruins, they move on to fresh prey. It starts all over again with the plaintive ruse, "Please help us! We are being persecuted!"

By the time of Christ, nearly 800 years after the Dispersion of the House of Israel, the Dispersed Israelites numbered in the millions. These were the true genetic Israelites that converted to Christianity. Without this knowledge of our past history as Anglo-Saxon, Caucasian Israel, and not knowing that the entire House of Israel was extant and well known to all of the Apostles, as well as to the Jews of that day (John 7:35),

Twenty-First Century Christians are easily duped into the fantasy of universalism, because they falsely believe that the "Gentiles" are non-Israelites.



Josephus, the **JUDAHITE** (not Jewish, another deception!) historian of our people, tells us this: "...wherefore, there are but two tribes in Asia and Europe subject to the Romans, **WHILE THE TEN TRIBES** are beyond Euphrates till now, and are an immense multitude, and not to be estimated by numbers." -- Antiquities of the Judahites, Book XI, Chapter V, para. 2.

So, even Josephus knew that the House of Israel still existed in the Dispersion. And, of course, we are **STILL** in a state of Spiritual Dispersion as long as we don't realize who we are! [I don't want to hear any snickers about my use of the word "Spiritual" here! -- Eli]

The crazy Dispensationalists would have us believe that Paul and the other Apostles brought the Good News of the Messiah's redemptive Sacrifice for Israel to people of **ALL PEOPLE** and **ALL NATIONS**, despite their racial and cultural distance from True Israel.

By this point, in this book, and at this moment in your life as a Christian Israelite, you should be able to appreciate what utter lunacy this is. Non-Israelites had utterly **No Tradition of Our Messiah, Our Kinsman Redeemer**. If Paul had talked of such things as the Egyptian and Babylonian captivities, the Exodus, the Giving of the Law, and the Dispersion, which were historical events **Particular Only to Israel**, they would have said, "Who?" "Where?" "What?" "What are you talking about, man? That's interesting, but what has that got to do with us?" "Your people are over in the next town."

That is presuming that these non-Israelites even understood the language or dialects of the various Dispersed, or that they shared an interest in our history or our national destiny. Can you see how the lack of a true historical context can lead to the folly of universalism? In projecting the modern heresy of universalism back onto the ancient world, they are making a fairy tale out of the past, which was an era of intense racial consciousness and separation. Besides, it would have been a direct violation of Yahshua's command to seek out only the Lost Sheep of the House of Israel. (Matt. 10:6; 15:24; Jer. 50:6.)

Of course, those Judeo-Christians, who claim that Paul actually **VIOLATED** this command, are in error. As I have been demonstrating, by quoting the very statements of Paul himself, he is a most eloquent defender of the Faith for racial, Covenant Israel.

## Chapter 12

1. These are the statutes and judgements, that you shall observe and do in the land that gives

you Yahweh, Elohey 430 of your forefathers for a possession, for all the days that you live upon the soil 127.

2. You shall utterly destroy 6/6 all the places that serve there the nations that you will dispossess their eloheyhem, upon the high 7311 mountains 2022, and upon hills 1389, and under 8478 all luxuriant 7488 tree 6086:

3. and you shall tear down 5422 their altars, and break 7665 their sacred pillars 4676, and their asheryhem 842 you shall burn with fire; and

their carved idols 6456 of eloheyhem you shall hew down 1438, and destroy 6 their names from that place.

4. You shall not do 6213 in this manner 3651 to Yahweh Eloheychem,

14. but only in the place that shall choose Yahweh in one of your tribes, there you shall send up your burnt offerings, and there you shall do all that I command you.

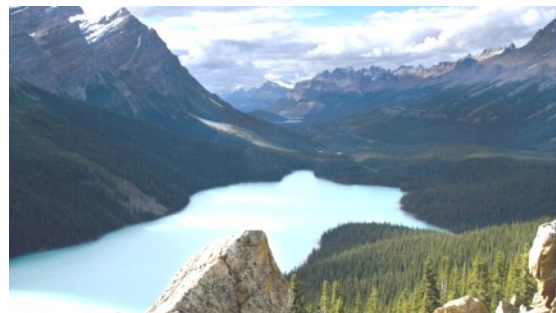

16. Only 7535 the blood 1818 you shall not eat; upon the ground you shall pour 8210 it, as water.

20. For shall enlarge 7337 Yahweh Eloheycha your borders 1366, as He spoke to you, and you shall say, "I will eat flesh," for you want 183 for your beings to eat flesh, and all you desire 185 for your beings, you may eat flesh.

21. Because if it is too far 7368 from you is the place that chooses Yahweh Eloheycha to put 7760 His Name there, then you shall slaughter of your herd or your flock that which gives Yahweh to you that I have commanded you, and you shall eat within your gates all that desire

your beings.

**22.** Even as are eaten the gazelle and the deer, so you shall eat: Those unclean, and those clean alike shall eat.

**23.** Only 7535 be sure 2388 to not 1115 eat the blood 1818: because the blood is the life 5315; and you shall not eat the life with the flesh 1320.



**24.** You shall not eat it, upon the ground 776 you shall pour it out 8210 as water:

**25.** you shall not eat it; so that it may go well 3190 with you, and with your children after you, when you do 6213 uprightly 3477 in the sight 5869 of Yahweh.

**26.** Only the holy things 6944 that are with you, and your vows 5088, you shall take, and go to the place that shall choose Yahweh:

**27.** and you shall make burnt offerings, the flesh and the blood, upon the altar of Yahweh Eloheycha: and the blood of the slaughterings 2077 shall be poured out upon the altar of Yahweh Eloheycha, and the flesh you shall eat.

**28.** Observe 8104 and hear 8085 all these things 1697 that I command you, that it may be well with you, and your children after you even 5704 forever 5769; when you do good 2896 and uprightly in the sight of Yahweh Eloheycha.

**29.** When cuts off 3772 Yahweh Eloheycha the nations where you go there to dispossess them before you, and you dispossess them, and dwell 3427 in the land;

**30.** guard yourselves lest you are snared 5367 by following 310 them, after 310 they are destroyed 8045 from before you; lest you seek after 1875 eloheychem 430, saying, " How 349 did serve these nations eloheychem? I will do likewise."

**31.** You shall not do this way to Yahweh Eloheycha: because every abomination 8441 to Yahweh, that He hates 8130, they do to eloheychem; because even their sons and their daughters they burn 8313 in the fire 784 to eloheychem.

## Chapter 12 NOTES

**Chapter 12** has several critical passages. In vs. 2-4 is the command to destroy all pagan places of worship. This includes the "Ashera poles", altars, statues, graven images, cast idols, etc. There is a stern warning not to worship Yahweh in the manner of the local pagan tribes. This worship included orgies, and child sacrifice (to Molech). This is repeated graphically in vs. 30,31, clearly telling of child sacrifice by fire. In vs. 5&6, Yahweh will choose His own place of worship in the territory of one of the tribes. Later, this turns out to be Yahudah, and the place will be the Temple at Yerushalaim. In vs. 8, there is a notice that the manner of worship will change when Yisrael crosses over the Yarden River. No more "do as you feel is right" worship. In vs. 10, the term "hated enemies" is more emphatic than other words for hate. It carries racial and tribal overtones. In vs. 5 & 22, "clean" and "unclean" are "legal" terms. Touching anything unclean, such as a dead body, would render that person ritually unclean until he/she followed the procedures to ritually cleanse themselves. In vs. 16, 23-25, it again is a command not to eat blood. The local pagans ate blood, and Yisrael is to be set-apart from everyone else, in dress, circumcision, worship, and dietary practices.

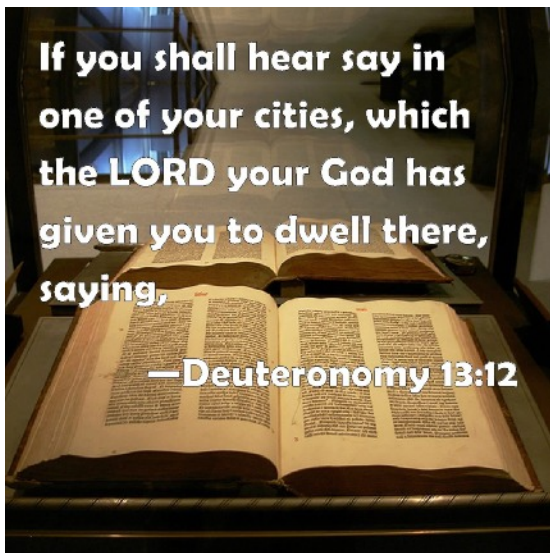

In verse 1 is the admonition not to add to the commandments, such as those added by the followers of the Babylonian Talmud, which are "rabbinical commands". ## English Was Derived From The Ancient Hebrew By Willie Martin



This objection is based upon an ignorance of actual facts as history provides at least two instances of nations having so changed their method of writing in this radical manner.

It is an acknowledged fact that the early Greeks wrote from right to left, but many years later they wrote from left to right as they still do today. At one period between the use of these two methods of writing they wrote alternately from right to left and left to right. This form of writing was known as Boustrophedon. The Encyclopaedia Britannica, 14th Edition, Volume III, page 972, states:

**A** COMMON OBJECTION RAISED AGAINST THE ANGLO-SAXON, GERMANIC, SCANDINAVIAN, CELTIC PEOPLES BEING ISRAEL is that they cannot possibly be Israelites because the Israelites always wrote from right to left, whereas we write from left to right. Thus Mr. George Goodman, in his pamphlet against Anglo-Israel Identity, states, it is impossible to conceive of a nation changing its method of writing in so radical a manner.

Boustrophedon: A term descriptive of a peculiar form of writing common among the early Greeks. The direction of writing was alternately right to left and left to right in horizontal lines, or conversely, left to right and right to left. It was a transition between the earlier right to left writing and the later left to right style. The term was derived from two Greek words meaning ox and to turn, from the resemblance of the writing to the winding course taken by oxen in ploughing.

Even more important for the case, however, is the evidence brought to light by archaeological discovery and referred to by Sir Charles Marston. As he states in his book, *The Bible Comes Alive: The Israelites had, from the time of Moses onwards, at least three alphabetical scripts. First, what is known as Sinai Hebrew; next, what is known as Phoenician Hebrew; and lastly, after the captivity in Babylon, what is known as the Assyrian Hebrew.* (Page 8, 1938 Edition, page 7, 1944 Edition, *The Bible Comes Alive*)

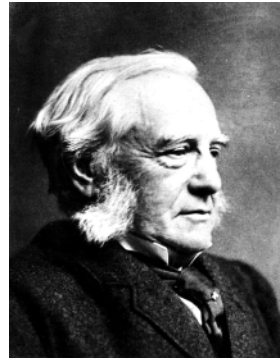
Examples were discovered by archaeologists of the oldest of these, the Sinai Hebrew Script. The most important of these discoveries was that of a bowl of red pottery found in a tomb at Lachish in 1931. Across the outside of this bowl was an inscription painted in white letters. This inscription, in the Sinai Hebrew Script, was published in *The Times* of June 24, 1935, by Mr. J. L. Starkey.

Professor Stephen Langdon, M.A., B.D., Ph.D., F.B.A., late Professor Assyriology at Oxford University, wrote in a letter to *The Times* on October 5, 1935, with reference to this inscription: The inscription as published in *The Times* should be inverted and read from left to right; for this was the original direction of writing in the Sinai Script.

Thus it appears that not only the Greeks, but also the Israelites changed the direction of their writing. The fact that the Greeks changed their method of writing in this radical manner would provide a sufficient answer to the objection raised.

How much more weighty still is the fact that the Israelites did actually change their method of writing in this way once, while still using the same language, how much less impossible is it to conceive of their having again changed their direction of writing after they had lost their Hebrew language and adopted the languages of the peoples among whom they moved during their banishment from Palestine.

Thus knowledge of the historical facts clearly solves this apparent but oft-repeated difficulty. (From *The National Message*, London, England) (*The Lachish Red Bowl*, by Bernard L. Bateson, *Destiny The Magazine of National Life*, July 1946, p. 228)



The English Language - Was Derived From The Hebrew. Professor Max Muller (Left), in his lectures on language, having shown that several of our common English words are derived from the Sanskrit, it struck me to

inquire, what would be the result of tracing the obligations of the English language to the Hebrew? And, having gone into this matter to some extent, I now believe that English is derived from the Hebrew.

Dean Alford supposes that the Celtic, Hebrew, Arabic, Persian, and Spanish jointly contribute some five percent of words to our native tongue. As the result of my inquiry I should be inclined to say that **THERE ARE NOT MORE THAN FIVE PERCENT OF SAXON WORDS WHICH CANNOT BE TRACED TO HEBREW.** I wish, however, not to theorize, but to present the reader with examples, from which he can deduce his own conclusions.

It is the object of the author in the following work, to show, that the Druids of the British Isles were the priests of a very ancient nation called Celtæ. That these Celtæ were a colony from the first race of people, a learned and enlightened people, the descendants of the people who escaped the effects of the deluge on the borders of the Caspian Sea. That they were the earliest occupiers of Greece, Italy, France, and Britain, arriving in those places by a route nearly along the 45th parallel of north latitude. Then, in a similar manner, colonies advanced from the same great nation, by a southern line through Asia, peopling Syria and Africa, and arriving at last, by sea, through the pillars of Hercules, at Britain.

In the course of the work, the mode in which the ancient patriarchal religions, as well as those of Greece and Italy, were founded, will be pointed out, and the author flatters himself that he shall have much strengthened the foundations of rational Christianity. (It must be remembered, that the foundation is the substructure of a building, that upon which it stands, and not the upper stories or the ornamental parts. In the following work the author carefully avoids those figments which constitute orthodoxies and

heresies, about which foolish man, at the instigation of the priests, persecutes and murders his brother)

He will show, that all the languages of the western world were the same, and that one **System of Letters, That of the Ancient Irish Druids, Pervaded the Whole; Was Common to the British Isles and Gaul, to the Inhabitants of Italy, Greece, Syria, Arabia, Persia and Hindostan** and that one of the two alphabets (of the same system) in which the ancient Irish manuscripts were written, namely, the Beth-Luis-nion, came by Gaul, through Britain, to Ireland; and that the other, the Bobeloth, came through the Straits of Gibraltar.

It has been my wish to draw a definite line of debarkation between facts which I conceive to stand on clear and unquestionable evidence, and deductions the result merely of theorizing speculations; without some indulgence in which, no improvement would ever take place, and all inquiries of this kind must be dull to the very last degree. By these means I have flattered myself with the hopes of producing a work which may be satisfactory to people who are above the vulgar prejudices of education; people who will not consider every thing to be absurd as a matter of course, merely because to them it is new: but people who will try the evidence, by the correct rules of reason and approved modern criticism.

### The Druids - Preliminary Observations



In examining the very early histories of the Western parts of Europe, we every where meet with the monumental remains of a race of people called Druids. In many places the ruins of which I speak are of very great size, and, perhaps, in remote ages,

have been highly ornamented and of great magnificence. Numbers of treatises have been written respecting them and their supposed founders by different people, each of whom in support of his particular system, has made important observations or collected curious original information. But these different works have been much dispersed, and many of them are very difficult to be obtained.

From a consideration of these circumstances I have been induced to entertain an opinion, that the subject is by no means exhausted, and that a general review of the whole might be interesting to the antiquarian public. I have flattered myself, that I possess some advantages which my predecessors have not enjoyed; among which, the opportunity of profiting by their observations is not the least. I have endeavoured to avoid what I conceive to be their errors; and, particularly, to guard against a too great pruriency of imagination; a moot into which most people who have a taste for investigations of this kind are apt to fall.

### Etymology

As proofs of many important circumstances of these people will depend upon etymological researches, I am induced, in the first place, to submit to my reader a few observations respecting the origin of language. And here, in the very beginning, he may be inclined to think that I violate the rule I have just alluded to, for the regulation of my conduct in this discussion; but yet I hope that, by keeping the line between fact and theory well defined, he will not have much reason to complain. In order to get to the bottom of my subject better,

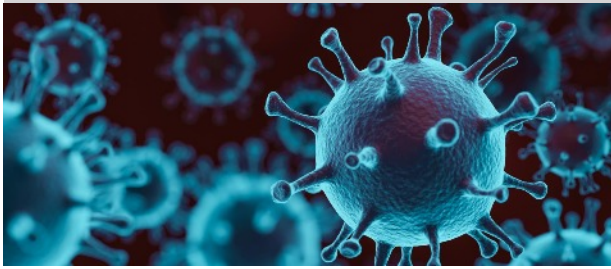
I have found it necessary to make a careful inquiry into the alphabets of several of the ancient languages, from which it is probable that the names of places or people connected with the ancient Druids may have been derived, and to make a comparison between them. This has led me to a speculation respecting the origin of written language itself. It is, indeed, merely a speculation; but as it is only advanced as such, I cannot think that it is an instance of aerial castle-building which may not be pardoned. Besides, it is closely connected with some reasoning upon certain facts which will be found quite original; and will be, I flatter myself, conclusive upon the antiquity of the letters of the Celtæ and their Druids in these countries. It seems to be of consequence to establish these facts in the first place, as, by that means, I shall be enabled without impropriety to assume rather greater latitude in my range of investigation hereafter.

# Is The Corona Virus Scare a Psychological Operation?

## **G**OVERNMENTS HAVE USED PSYCHOLOGICAL WARFARE

throughout history to manipulate public opinion, gain political advantage, and generate profits. Western governments have engaged in such tactics in the war on terrorism as well as in its predecessor, the war on communism.

In both cases, state-sponsored terrorism and propaganda were used to distort the public's perception of the threats, leading to increased governmental control of society and huge financial benefits for corporations.

It appears that the same kinds of effects are being seen as a result of the COVID-19 pandemic.

Many of the features and outcomes seen in the war on terrorism and the war on communism are evident in this new "war on death."

Therefore, it's reasonable to wonder if the extreme response to **COVID-19**, and its associated virus **SARS-COV-2**, could be another psychological operation against the public.

Considering facts about the disease and the disproportionate response emphasizes the possibility.

If **COVID-19** has been co-opted for manipulation of the public, through hyping the threat and pushing exploitive solutions, who is behind it and who benefits?

Let's first review what features and outcomes the "corona virus scare" shares in common with the "red scare" that drove the perceived threat of communism and the "Muslim scare" behind the perceived threat of terrorism. Here are a dozen characteristics that these perceived threats share. Fear-based and globally directed Media saturation with bias toward fear Data manipulation and propaganda.

## **Censorship of opposing views**

Intelligence agency control of information Preceded by exercises mimicking the threat Series of claims made that are later proven false Response threatens democracy Large increase in wealth and power for a few; increase in social inequality Increased government control of the public and reduced individual freedoms.

Response kills far more than the original threat Evidence for manufactured events (see below) There are also differences between the COVID-19 pandemic response and the "wars" on communism and terrorism. One difference is that, for the virus, agencies dedicated to public health have taken the lead. Although the central characters that hyped the communism threat and the terrorism threat were sometimes the same people, they tended to represent military, diplomatic, or intelligence agencies.

The primary actors driving the corona virus lock-downs and associated control mechanisms are political leaders. However, the directives being acted upon come from the World Health Organization (WHO), an agency of the United Nations ostensibly responsible for international public health.

Others controlling the corona virus scare are national health agencies, most notably the US Centres for Disease Control and Prevention (CDC) and the United Kingdom's National Health Service (NHS).

Are these agencies acting solely in the interest of public health?

## **THE WHO**

The common impression is that the entire matter began in reaction to events in China but even that is not clear. For example, the virus is said to have originated in the city of Wuhan and the first, limited, lock-down occurred in that area from January to March.

China has since said that it warned the **WHO** about the virus during the first week of January. However, it is known that U.S. intelligence

agencies were aware of the potential outbreak even before that, in November 2019. A Chinese spokesman later suggested that the U.S. military might have brought the virus to Wuhan during the military games held there in October.

The first instance of an entire country being locked down for the corona virus was in Italy. This occurred on March 9th based on advice from the Italian government's corona virus adviser Walter Ricciardi, who said, "The situation risks going out of control and these measures are necessary to keep the spread at bay."

Ricciardi, a WHO committee member, later admitted that Italy had inflated the death counts from the virus, stating:

"The way in which we code deaths in our country is very generous in the sense that all the people who die in hospitals with the corona virus are deemed to be dying of the corona virus."

Many have noted the inordinate influence of billionaire Bill Gates on the activities and direction of the WHO. As of 2017, this influence was seen as troubling, with health advocates fearing that:—

because the Gates Foundation's money comes from investments in big business, it could serve as a Trojan horse for corporate interests to undermine WHO's role in setting standards and shaping health policies."

Gates has been called a ruthless schemer by his Microsoft co-founder Paul Allen and Allen is not alone in that assessment.

Despite engaging in a costly "public charm offensive," Gates is seen by many as a predatory and monopolistic opportunist hiding behind a false front of philanthropy. With regard to the corona virus scare and Gates' stated goal of vaccinating the entire world population, however, people should be most concerned that he has worked diligently on mechanisms of population control.

Of course, no one person controls the world yet so who is supposed to be running **WHO**, apart from Bill Gates? The face of the **WHO** is Dr. Tedros Adhanom, the director-general of the organization. Tedros has a poor history of ethics in leadership, with many accusations having

been made against him including that he covered-up epidemics in the past.

Alarms about Tedros began to go off immediately after his appointment in 2017, when he named Robert Mugabe, the former dictator of Zimbabwe, as a goodwill ambassador to the WHO. Mugabe's rule over Zimbabwe was dominated by "murder, bloodshed, torture, persecution of political opponents, intimidation and vote-rigging on a grand scale." This appointment indicated that Tedros' judgment of goodwill was dubious at best.

A letter from a group of American doctors that same year described why Tedros has become known as "Dr. Cover Up."

**They wrote:** "Your silence about what is clearly a massive cholera epidemic in Sudan daily becomes more reprehensible. The inevitable history that will be written of this cholera epidemic will surely cast you in an unforgiving light."

They added that Tedros was "fully complicit in the terrible suffering and dying that continues to spread in East Africa."



Problems at WHO didn't start with Tedros, however.

After the H1N1 pandemic of 2009, evidence came to light that the WHO had exaggerated the danger and had spread fear and confusion rather than helpful information. It was later learned that "Italy, Germany, France and the UK made secret agreements with pharmaceutical companies" that "obliged the countries to buy vaccinations only if the WHO raised the pandemic to a level 6."

The **WHO** then proceeded to change its guidelines for defining a pandemic in order to accommodate those contracts, thereby increasing the

public's fear despite the fact that the pandemic never became a serious threat.

Although **WHO** has been praised for its work to reduce some illnesses like polio, it has also been found that drugs and vaccines recommended by **WHO** have been "found to be harmful and without significant clinical effect."

A comprehensive view suggests that the WHO is more of a corporate interest agency than an organization committed to preserving public health. That's not surprising due to the fact that 80% of WHO's funding comes from "voluntary contributions" provided by private donors including pharmaceutical companies and industry groups like Bill Gates' Global Alliance for Vaccines and Immunization (GAVI).

And since the worldwide response to COVID-19 has been directed and coordinated by an organization that works on behalf of multi-national corporations that stand to benefit, the idea that the corona virus scare could be a psychological operation seems plausible.

### THE CDC

In the US, the CDC is also heavily influenced by corporate and political interests. This became clear when, in 2016, a group of senior scientists within the CDC filed an ethics complaint against the agency making that exact claim. They wrote:

It appears that our mission is being influenced and shaped by outside parties and rogue interests."

The scientists noted that, in order to pursue political objectives, "definitions were changed and data cooked" at CDC, even to the point of misrepresenting data to Congress.

Like the WHO, the CDC has a history of pushing harmful vaccines. An example was covered in a 60 Minutes episode exposing the harm done by the Swine Flu vaccine in 1976 and CDC's urging that all Americans be injected with that harmful vaccine.

The report revealed that the illness was hyped based on very questionable data and the vaccine caused neurological damage. The current Director of CDC is retired US Army doctor Robert Redfield, who is known for having led the

Pentagon's disastrous response to HIV-AIDS in the 1980's.

A devout catholic, Redfield saw AIDS as the product of an immoral society. For many years, he championed a much-hyped remedy that was discredited in tests. That debacle led to his removal from the job in 1994."

Public health reporter Laurie Garrett remarked:

"Redfield is about the worst person you could think of to be heading the CDC at this time. He lets his prejudices interfere with the science, which you cannot afford during a pandemic."



The CDC is an agency within the department of Health and Human Services (HHS). Alex Azar, a lawyer and former pharmaceutical company executive, was appointed as Secretary of HHS in 2017. Azar has deep connections to the pharmaceutical industry and is known for having engaged in price gouging with his former employer.

Azar is also known for leading the HHS response to the anthrax scare of 2001, the first known bio-terrorism attack on the United States. The anthrax attacks were targeted against members of Congress and the media that were dissenting voices in the national discussion about the Patriot Act, the oppressive legislation introduced immediately after the 9/11 attacks.

Although Muslims were first blamed through highly questionable evidence, it was ultimately found that the weaponised anthrax came from U.S. military laboratories.

Azar was instrumental in defining the National Bio-defence Strategy in 2018, working closely with John Bolton, Trump's National Security Advisor. Bolton, a neocon and member of the Project for a New American Century (PNAC), has a long history of pushing authoritarian policies and war.

In the US the person most visibly in charge of the COVID-19 response is Anthony Fauci, who is the long-time director of the National Institute of Allergy and Infectious Diseases (NIAID). Like Redfield, Dr. Fauci is a Catholic and has said that values he learned in his Jesuit education continue to guide him.

After weeks of Fauci having led the corona virus response in the US, it was learned that his NIAID had funded “gain of function” research at the Wuhan laboratory where the SARS-COV-2 virus is suspected of having originated.

Fauci’s response to questions about that inexplicable coincidence was simply to denounce “conspiracy theories” rather than addressing the questions directly, much as others did when questioned about 9/11 foreknowledge.

Whether SARS-COV-2 was genetically engineered in a laboratory, like the NIAID-funded Wuhan lab, is a subject that has become of interest to many scientists.

The Wuhan laboratory is not the only place the US supports work like this, however, as the Pentagon funds such labs in 25 countries across the world. Located in places such as Eastern Europe, the Middle East, South East Asia, and Africa, these labs isolate and manipulate viruses like the bat corona viruses from which SARS-COV-2 originated. This bat-research program is further coordinated by a group called Eco-Health Alliance.

The manipulation of viruses for gain of function at US funded labs is, like the origin of the weaponized anthrax at US labs, evidence that bio-terrorism and pandemics can be manufactured events. This is another way in which the corona virus scare could reflect the war on terrorism and war on communism, both of which were driven by manufactured terrorist events.

It is remarkable that Fauci funded work to manipulate corona viruses then became the voice of the corona virus pandemic response while also working closely with Bill Gates’ GAVI initiative. Fauci has boasted that NIAID and GAVI work together to push vaccines with “outright collaboration between us in setting the standard of what is needed.”

This makes it easier to see that a new pattern of hyped pandemics resulting in increased population control and global vaccinations is not only possible but would be a very lucrative business model.

### **THE NHS AND CORPORATE NATIONS**

By now it’s well known that the initial projections for deaths due to COVID-19 were massively overestimated and one academic paper was responsible for the panic. The lead author of that paper, Neil Ferguson of Imperial College, has since resigned in disgrace from his government advisory position. Much like the US government’s explanation for destruction of the World Trade Centre buildings, his estimates were based on computer models that cannot be shared with the public.

As in the US, UK intelligence agencies have taken a leading role in managing the corona virus scare. The terrorism expert who is expected to be the next chief of MI6 was selected to lead a new “bio-security centre” to evaluate the corona virus threat and “enable rapid intervention.”

Additionally, the UK intelligence agency known as Government Communication Headquarters (GCHQ) was granted powers over the NHS’s computer systems. GCHQ is known for engaging in illegal activities related to population control mechanisms such as mass surveillance.

Totalitarian outcomes are further enabled with billionaire Peter Thiel’s CIA-initiated company Palantir managing the databases used by both the CDC and UK’s NHS that drive COVID-19 decision making.

For perspective, in 2009, Thiel said, “I no longer believe that freedom and democracy are compatible,” providing another clue that public health and awareness are not the main priorities behind the corona virus scare.

The data behind the COVID-19 pandemic was never reliable, with test kits being inaccurate, government policies inflating the death counts, and the media focusing solely on fear-based predictions that are repeatedly proven false.

Recently, scientists and government leaders from other countries, including Russia, Germany and Denmark, have begun speaking out about how the corona virus threat has been exaggerated.

The outcomes of the corona virus scare have included huge windfalls for billionaires, financial institutions, and corporations. Legislation being passed in response to COVID-19 is largely beneficial to corporate interests. The outcomes for everyone else have been fear, unemployment, poverty, loss of freedoms, grave risks to democracy, and death.

How this is possible is related to the fact that governments, and the nations they represent, are no longer what they were. In many ways, corporations have replaced governments as the drivers of public policy and, as with Peter Thiel's Palantir, the public's interest is not their concern.

Meanwhile, over two dozen companies have become larger and more powerful than many national governments.

As a result, governments are now false fronts for corporations and the decisions they make, for example to lock-down citizens and remake their economies, are driven by profit-based strategies indifferent to public interests.

In summary, the features and outcomes of the corona virus scare reflect those of previous psychological operations including the war on terrorism and its predecessor, the war on communism.

The people and agencies driving the corona virus scare have a history of unethical behaviours, including hyping pandemics to push vaccines, and appear to seek long-term profits through implementation of a highly controlled society. Therefore, the response to COVID-19, if not the virus itself, can be seen as a psychological operation used to drive those outcomes. [Source](#)

## **Harold Stough Notes St. Martins Church Canterbury Reputedly The Oldest Church in England**



**T**HOUSANDS OF TOURISTS VISIT CANTERBURY Cathedral every year, but few of these know about or visit, a far more important church, with regard to early Christianity in the British Isles and indeed is far older than Canterbury Cathedral. This church is St. Martin's, Canterbury, One of England's lovely old churches, on the site of an earlier building which was in existence before the coming of Augustine; it is said to be the oldest church in England. Of course tourists will not be told this, as the fable that it was St. Augustine

who brought Christianity to Britain has to be maintained!!

St. Martin's was the private chapel of Queen Bertha of Kent (died in or after 601) before Saint Augustine of Canterbury arrived from Rome in 597. Queen Bertha was a Christian Frankish princess who arrived in England with her chaplain, Bishop Liudhard. Her pagan husband, King Æthelberht of Kent, allowed her to continue to practise her religion by renovating (ca. AD 580) an existing church which the Venerable Bede says had been in use in the late Roman period but had fallen into disuse. As Bede specifically names it, this church was dedicated to Saint Martin of Tours, a city located near where Bertha grew up.

Upon Augustine's arrival he used St Martin's as his mission headquarters, immediately enlarging it (AD 597), and King Æthelberht was soon baptised here. With the subsequent

establishments of Canterbury Cathedral and St Augustine's Abbey, St Martin's lost prestige but retains its priority and historical importance.

Shortly before 1844, a hoard of gold coins which may date from the late 6th century was found in the churchyard, one of which is the Liudhard medalet, which bears an image of a diademed figure with a legend referring to Liudhard.

Local finds prove that Christianity did exist in this area of the city at the time of the Romans, and the church contains many reused Roman bricks or spolia, as well as complete sections of walls of Roman tiles.

At the core of the church the brick remains of a Roman tomb were integrated into the structure. Several sections of walls are clearly very early, and it is possible that a blocked square-headed doorway in the chancel was the entrance to Bertha's church, while other sections of wall come from the period after the Gregorian



mission in the 7th or 8th centuries, including most of the nave. The apse that was originally at the east end has been removed. The tower is much later, in Perpendicular style. The church is a Grade I listed building.

With in the church is a painting showing the haughty Augustine at a conference held on the banks of the Severn, A.D. 605, with the Celtic bishops who are seen leaving the conference in sorrow.

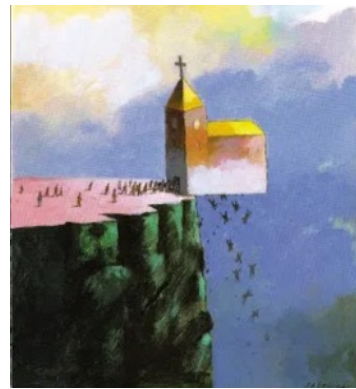

### **A Letter to Robin Tilbrook Concerning His Suit against The Government Regarding The Unlawful Lock-Down**

**Dear Robin,** I belong to a group of like minded people who try to use the law to obtain justice. We note that you are concerned that the law is being used by the establishment in a detrimental way as a means of controlling the populace. Your recent appeal for funds to support your case proving that the corona-virus laws are ultra vires indicates that you are of a like mind to us.

I have got to be blunt here. We are puzzled as to why you need funds to get the fact established that the corona-virus laws, statutes, regulations promoted by the government and enforced by the police and the courts are ultra vires.

We, in this group, have successfully stopped legal proceedings against us by using the process of the void order.

You may be unfamiliar with the the process, because as the solicitor advocate to the Higher Rights (civil and criminal courts) Shirley Lewald writes," the —nature of a void order—is not fully understood and appreciated in England."

It is my opinion that this is purposely kept hidden but at certain times a court itself finds it expedient to use the process . This was borne out last year when the court voided Boris Johnson's proroguing of parliament by declaring his order void due to his abuse of the process.

I and my friends have voided cases where there has been an abuse of process.

Some are advising those accused of offending the lock-down legislation to either void any process against them or serve a sworn affidavit on the police and court stating that the law that they are accused of offending is ultra vires because it offends our common law as codified in the Bill of Rights Act 1689. They quote the recent case viz

"The right at common law to go unhindered by the state or other authority was confirmed by the UK supreme court as recently as 12th February 2020. The case analysed the relationship between a man's common law right to conduct his affairs unhindered by the state and the concept of imprisonment at common law to be

aligned with Convention rights concept of deprivation of liberty— Human Rights Act 1998 (c 42), s 1, Sch 1, Pt I, art 5 .

It was held that any instruction restricting a man’s freedom by requiring him to remain in his home during fixed times amounted to false imprisonment.

Supreme Court Regina (Jalloh (formerly Jollah)) v Secretary of State for the Home Department [2020] UKSC 4B 2019 Nov 12; 2020 Feb 12"

Each of us in the group know that the first sworn duty of a solicitor is to the court which is a secondary consideration to any client that they represent.

We are concerned that your action will be stymied by the court and possibly that you will be barred from future practice because you have acted against the court's interest. I state the court's interest because they have shown that they are willing to enforce laws that are ultra vires.

We see that you could protect yourself by using your political party to promote the use of the sworn affidavit or void order to assist individual members of the public who are being prosecuted unlawfully by the state.

I wrote that I was going to be blunt. I called Nigel Farage's bluff and proved that he was being used by the establishment as a diversion by eliciting from him a statement that he would not expose the fact that all EU treaties were against our constitution.

So I ask you directly. Are you in the same position as Nigel Farage? viz making a show of doing something for the benefit of all or are you genuinely trying to get this country back to operating under the rule of law?

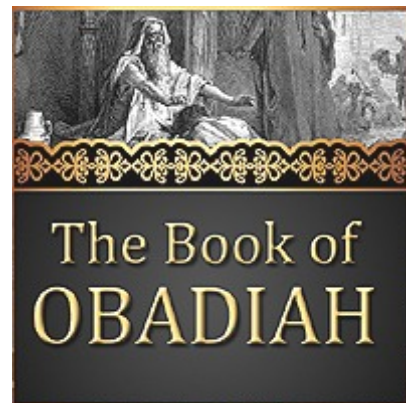
### A Response

# Arrivals and Departures: The Jews in England

**A**LTHOUGH some Jews may have been present in Ancient Britain during the Roman occupation, as well as dealing in slaves during the Anglo-Saxon period, the first recorded evidence for a settled Jewish community in England was in 1066. Jews had accompanied the invading armies of William the Conqueror (1028-1087) during the pivotal year of 1066 when, as the Domesday Book clearly attests, Anglo-Saxon England was ripe for plunder and the Normans set about evaluating and then pillaging the entire country in accordance with their long-term economic objectives.

A Jewish minority, much to the detriment of ordinary Jews, had partly financed William's expedition. For a decent return, of course.

The first Jews in England, therefore, were an extension of French Jewry and, once they had settled in London, formed a strong community at Oxford when land stolen from the Anglo-Saxon church was granted to them in 1075. This, without the consent of the bishops and monks.

At that time, Jews were considered to be the property of the Crown, something which clearly indicates just how important the Jews had become to the financial wranglings of those monarchs who sought to swell their proverbial coffers by further expanding their imperial kingdoms.

According to the twelfth-century chronicler, William of Malmesbury (1095-1143), writing in his *Gesta Rerum Anglicanarum*, in 1090 William II (1056-1100) had even tried to

persuade the Jews of England to challenge the theological beliefs of their Christian neighbours by engaging in a face-to-face debate, joking that, if successful, he would even go so far as to "join their sect". [1] Consequently, the Jews lost this battle of religious minds and the fragile reputation of English Christianity thus remained intact.

According to St. Anselm (1033-1109), who became Archbishop of Canterbury, a similar and comparatively more friendly debate took place between Jews and Christians in 1096. [2]

One of the first serious incidents involving Jews took place in 1144, when it was alleged that a Christian child – now known to be William of Norwich – was ritually murdered so that Jews could use his blood to prepare unleavened bread for their own festival of Passover.

Other such cases have taken place all over the world, but ritual murder involving Jews residing in England was later perpetrated against 'Little Hugh' of Lincoln (1255), another child who was brutally crucified in Nottingham (1279) and the murder of a boy in Oxford (1290) by Isaac de Pulet. Modern historians persistently deny these accusations, of course, dismissing them as "blood libel," but the incidents themselves have been faithfully recorded for posterity and the details are no less convincing than any other legal document from the late and post-Angevin periods.

By 1182, sections of the English church began to complain that the deepening relationship between the Jews and sections of the Christian hierarchy was becoming intolerable. According to the *Chronica* of Jocelin de Brakelond, himself a monk of St. Edmundsbury, relations were also becoming rather strained among the ordinary rank and file and when a local sacristan had fallen into debt with the Jews it began to affect the manner in which he treated them:

The Jews, I say, to whom the sacristan was said to be a father and a patron. And they did rejoice in his protection, having freedom to enter and to leave the monastery, and wandering all over it.

For they walked by the altars and round the shrine while high mass was being celebrated; their money was lodged in our treasury under the care of the sacristan; and, a thing still more foolish, their wives and little ones were entertained in our pittance during time of war. [3]



Despite the fact that usury, or lending money at great interest, occasionally allowed Christians to manage their affairs more effectively, much of this activity was cruel, exploitative and opportunistic. One of England's chief Jewish moneylenders, for example, Aaron of Lincoln (1125-1186), was at the head of an international operation that extended across twenty-five countries, nineteen of which were controlled and administered by his own financial agents.

Aaron of Lincoln, a boastful man whose banking houses spread throughout Norman England like a plague, was said to have been the wealthiest man in the country and when he died his immense wealth exceeded that of the King himself. Aaron, therefore, was a forerunner of the parasitical Rothschild family which later rose to prominence in the nineteenth and twentieth centuries.

However, the increasing role of Jews in economic affairs soon began to raise the hackles of the indigenous population and, by 1189, at the very beginning of the reign of Richard I (1157 - 1199), also known as Richard the Lionheart, Jews were being massacred in both London and York (1190). *The Historia Rerum Anglicanarum of William of Newbury* (1136 - 1198), an Augustinian canon, describes what happened after 150 Jews were brutally killed at York:

But when the slaughter was over, the conspirators immediately went to the Cathedral and caused the terrified guardians, with violent threats, to hand over the records of the debts placed there, by which the Christians were oppressed by royal Jewish usurers, and thereupon destroyed those records of profane avarice in the middle of the church with the sacred fires to release both themselves and many others. [4]

On 12th July, 1199, King John of England (1166-1216) was becoming aware of the burgeoning Jewish problem and appointed an advisor to mediate between himself and the Jewish community itself:

The King to all his subjects and to all both Jews and English greeting. Know that we have granted and by this present charter of ours have confirmed to Jacob, Jew of London, priest of the Jews, the presbyterate, of all the Jews of the whole of England, to have and to hold as long as he lives freely and quietly, honourably and fully, so that no one thereon shall presume to offer him any hurt or hindrance. Wherefore we will and firmly order that you shall guarantee and maintain and guard in peace the presbyterate of all the Jews throughout England to the same Jacob so long as he lives. [5]

John's decision was not motivated by a desire to strengthen English-Jewish relations, however, but as a means of curtailing their growing power and influence. In 1210, just eleven years later, the King forced the Jews to pay an enormous £44,000 in tax and immediately passed this revenue on to those Christians who had fallen victim to the wiles of the Jewish moneylender.

The usurious practices of the Jews themselves were making it difficult for the King to extract taxation from his own people, so it seems fairly safe to assume that his rigorous new policy was determined purely by economic factors.

In 1216, after the ascension of a young Henry III (1207-1282) at just nine years of age, Jews went through a period of comparative peace and stability, but as the King grew older he turned against them and, once he was asked to remove their presence from the environs of Bury St. Edmunds (1190), Newcastle (1234), Wycombe (1235), Southampton (1236), Berkhamsted (1242) and Newbury (1244), responded



favourably and took the necessary action. In January 1275, meanwhile, Jews were also expelled from the lands of Eleanor of Leicester (1215-1275), daughter of King John.

On 31st January, 1253, Henry III went one step further by ushering in a series of new restrictions, demanding that Jews must (i) only reside in England if they were prepared to serve the King himself, (ii) lower their voices whilst performing their religious services at the synagogue, so as not to offend Christians, (iii) never allow a child to be 'suckled' by a Christian nurse or share food with Christians in their houses, and (iv) remain conspicuous at all times by wearing a yellow badge. Again, this was not the result of religious or ethnic hatred, but an attempt to control economic corruption and thus avoid a repeat of the massacres which had taken place earlier at both London and York.

In 1275, just after the coronation of Edward I (1239-1307), the Statutum de Judaism was introduced. Joseph Jacobs, in a typically feeble effort to account for the criminal activities of his co-racialists, tells us that:

Church laws against usury had recently been reiterated with more than usual vehemence at the Second Council of Lyon (1274), and Edward in the Statutum de Judaismo absolutely forbade Jews to lend on usury, but granted them permission to engage in commerce and handicrafts, and even to take farms for a period not exceeding ten years, though he expressly excluded them from all the feudal advantages of the possession of land.

This permission, however, regarded as a means by which Jews in general could gain a livelihood, was illusory. Farming can not be taken up at a moment's notice, nor can handicrafts be acquired at once. Moreover, in England in the 13th century the guilds were already securing a monopoly of all skilled labour, and in the majority of markets only those could buy and sell who were members of the Guild Merchant.

By depriving the Jews of a resort to usury, Edward was practically preventing them from

earning a living at all under the conditions of life then existing in feudal England; and in principle the "Statute of Judaism" expelled them fifteen years before the final expulsion. Some of the Jews attempted to evade the law by resorting to the tricks of the Caursines, who lent sums and extorted bonds that included both principal and interest. Some resorted to highway robbery; others joined the Domus Conversorum; while a considerable number appear to have resorted to coin clipping as a means of securing a precarious existence. As a consequence, in 1278 the whole English Jewry was imprisoned; and no fewer than 293 Jews were executed at London. [6]



Money-lending, therefore, was completely banned. In 1290, on the other hand, Edward I's patience finally ran out and he decided to expel the Jews from England once and for all.

On July 18th, 1290, by Royal decree, King Edward I (left) and his advisory council made the expulsion official. Writs were sent out to each of the sheriffs in the county shires, informing them that by Royal edict all Jews were to leave the English realm before November 1st, 1290, and that any who remained were to be executed. Both the Parliament, as well as the population of the country in general, reacted with great relief and joy. [7]

In his 1988 biography, Edward I, Michael Prestwick states that when Parliament was summoned to Westminster in July 1290, a generous subsidy was granted and collected. [8] This subsidy was an offer of gratitude for the Jewish expulsion.

As a pious and conscientious ruler, Edward I wanted the expulsion to be humane. The wardens of the Cinque Ports were to supervise the deportation of the Jews and to see that the poor were able to obtain cheap tickets for departure.

No man was permitted to "injure, harm, damage or grieve" them, but whilst they were allowed to take with them all their cash and personal property, their bonds and real estate was handed over to the Crown. In accordance with the

comfort (or discomfort) that their finances could allow, a total of 16,000 Jews set sail in a wide variety of seagoing vessels and left English shores for good.

Whilst England breathed a collective sigh of relief, however, a number of Jews died on the voyage when Autumn storms completely wrecked Channel shipping. According to Holinshed's Chronicle, one particularly large group from London had arranged to be picked up from a sandbank in the Thames at low tide.

After pocketing their money, the ship's captain left them to drown in the rising waters. Nonetheless, true to his word, Edward I condemned this act and hanged the captain for his part in the murders.

The vast majority of Jews went to France, whilst others wandered through Spain, Germany and Flanders. It remains a fact, however, that to this very day the edict of expulsion has never been revoked.

## The Corona-Virus Act 2020 is Null and Void! Posted By Gordon

This is outlined in the Department of Health’s report ‘**UK Influenza Pandemic Preparedness Strategy 2011**’.

This report made it clear that the Rule of Law should be upheld and life should carry on as normal for the healthy. Not the deliberately induced fear and hysterics and disproportionate reactions as an excuse for taking away our Human Rights, Civil liberties and destroying our economy in the process.

Shamefully, the Corona virus Act 2020 has been written as an ‘Enabling Act’ worse than even Hitler in Nazi Germany had. It is an abomination that has been used by the Government to illegally seize absolute power and control and has no place in a modern Democracy.

As ‘covid-19’ has never been isolated and proven to be a virus or disease, it cannot be tested for. Instead of ‘covid-19’ being tested for, what is actually being tested for is genetic material and a RNA sequence based upon lung fluid extracted from Chinese patients. Further, the test that is being used is called the RT-PCR test and the inventor said it should NEVER be used for diagnostics. Further, the ‘lock-down’ and ‘social distancing’ were measures that were forced upon us and were based upon advice by Government ‘advisors’, from ‘modelling estimates and reports not even peer reviewed. ## Prehistoric London Its Mounds And Circles By E. O. Gordon ( Published 1946 ) Part 16



**I**T WAS TO REMEDY the latter need that he established his Seminary at Winchester, the “Nurserie” of his College at Southwark, and in order to alleviate the former, King Ethelwulf (left) by his Chancellor’s

advice “booked” (gebochde) the tenth part of the land of the kingdom to God’s praise and his own eternal welfare. The deed was written at Winchester (from early British times to Edward III the seat of government) and laid solemnly on the altar of the Cathedral Church in presence of Swithin and the Witan—the Saxon Parliament. It was thus by consent of Church and State that the payment of tithes became established as a national institution. The original Charter is in the British Museum, written in the year 854, with

the consent of those witnesses whose names and signatures are attached.

To go further afield, in addition to the mazes at Black- heath, Peckham Rye and Southwark, there is Troy Town at Rochester, adjoining an open space called the Vines; Troy Town, 84 miles from Dorchester, a maze at Leich between Yetminster and Yeovil; Wick Down at Downton; Breame Down near Salisbury; St. Ann’s, Sneinton, Notts.; another near Ripon; Comberton in Cambridgeshire; Caerleon in Monmouthshire, and the maze at Somerton, near Oxford, known to this day as Troy Town or Troy Farm. Ruskin compares the design of this Oxfordshire turf-cut Troy Town, or maze, to the circular labyrinth of Dædalus depicted on a stone in Lucca Cathedral, and he is the first to call attention to the fact that it closely resembles the circular labyrinth on a coin of Knossos in Crete. But the three most interesting examples are Saffron Walden maze,

which occupies a space of 138 feet by 100, while the convolutions of its path are said to measure about a mile in length; the maze on the Winton (sacred mound), St. Catherine's Hill, Winchester; and the Alkborough Maze, commanding the Humber on the borders of Lincolnshire, known as Julian's Bower.

It is a curious coincidence that the design of these three existing mazes should belong respectively to the types seen on the coins of Crete, casts of which have been kindly given to the author for reproduction, by Mr. G. F. Hill of the Coin and Medal Department, British Museum.

This is no chance resemblance, but has behind it the fact attested by Virgil that the Trojans came from Crete (*Æneid* iii. 90).

Stukeley tells us that the Maze at Alkborough, in Lincolnshire, used to be known within his own recollection as "Julian's Bower," and he adds that the same name was applied to many other mazes then existing on village greens. The word Bower in place-names is a corruption of Burgh, a castle or city. Julian is probably no other than Julius or Iulus, the son of Æneas of Troy. Julian's Bower is therefore the "City of Iulus," which may be taken as the equivalent of Troy Town.

The names of Troy Town and Julian's Bower, applied to our ancient English mazes, were treated in uncritical times as "confirmation strong as Holy Writ" of the descent of the Ancient Britons from Brutus and his Trojan followers. However much this tradition may be questioned there must have been some reason for associating these turf-cut labyrinths on our downs and commons with the city of Priam and the connecting link may perhaps be found in the Roman game of Troy.

An animated description of the Troy Game is given in the *Æneid*, book v, in a passage in which Virgil professes to afford an account of its origin:

"Father Æneas commands all the thronging people to draw back from the long Circus and that the plain should be clear. The youthful warriors advance and in even line glitter on their bridle steeds before their fathers' eyes: as they pass by all the youth of Troy and Sicily admire and cheer. The hair of all is restrained according to rule by garlands of slipped leaves; they bear two shafts of Cornel wood tipped with steel; some wear polished quivers on their shoulders; high on the breast a bent circlet of twisted gold runs round their neck.

Three troops of horse and three leaders gallop hither and thither; twelve youths follow each captain and shine in divided bands under leaders of equal bodies, and each of the three squadrons broke up its companies with parted bands and again at a signal they wheeled around and charged with levelled spear.

They then made charges and retreats to and fro, still opposite to one another, and they interlock hither and thither their wheeling circles, and in arms present the image of a battle; and now they expose their backs in flight, now charge with spear, and now make peace and ride abreast.

"As in days of old, the Labyrinth in lofty Crete is said to have possessed a way, enmeshed 'mid baffling walls and the tangled mystery of a thousand paths, that there, a trickery, that none could grasp, and whence was no return, might destroy the clue of progress; just so the sons of Troy entangle their paths at a gallop, and interweave flight and combat in sport; like dolphins who, as they swim through the waters of the sea, cleave the Carpathian and Libyan deep and gambol through the waves.

This mode of exercise and these contests first did Ascanius revive, when he girdled Alba Longa with walls, and taught our Latin forefathers to celebrate after the fashion in which he himself when a boy, and with him the Trojan youth, had celebrated them. The Albans taught their sons and from them mighty Rome received the games in due course and cherished the ancestral custom, and even now the game is called Troy, and the boys are called the Trojan band. Thus far were the games celebrated in honour of the holy sire of Æneas.”

This account of Virgil’s produces the impression of a bewildering complexity of movement upon clearly formulated lines, and it must be admitted that there is a striking coincidence in the fact that on the one hand we find Virgil describing the Troy Game as consisting of movements which are only comparable to the entangled pathways of the labyrinth or maze of Crete; and that, on the other hand, we find our ancient turf-cut mazes so commonly known down even to our own time as Troy Towns or Walls of Troy. The coincidence becomes all the more remarkable when we see how Virgil connects Iulus or Julius with the Troy Game, and recall that Julian’s Bower, that is Julian’s Castle or City, is another name given to our old English mazes.

The story of the Cretan Labyrinth referred to by Virgil, in illustration of the “entangled” and “interwoven” figures of the Troy Game, is familiar even in our nurseries. The skilful workman Dædalus constructed for King Minos a labyrinth, in the centre of which the Minotaur had his lair. No one who entered this labyrinth could find his way out again.

The seven young men and maidens who formed the annual tribute of Athens were sent into the Maze, lost themselves in its winding passages, and were devoured by the monster. Theseus slew the Minotaur and escaped out of the labyrinth by the help of the clue which Ariadne had given him.

But what had the Cretan legend to do with Troy?

It is material to recall that Ilium was supposed to have been founded by settlers from Crete. Virgil tells us in the Æneid, that Crete was the cradle of the Trojan race and the source of its national religion. Virgil is understood to have based his poem upon mythical histories which

have since altogether disappeared, and it may be assumed that the ethnical connection of Troy with Crete was an accepted belief in the age in which he wrote.

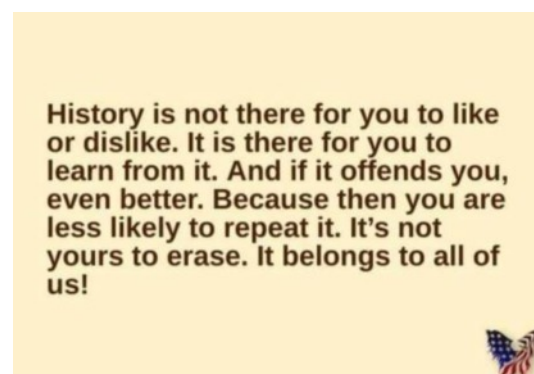


The Æneid By Vigil

Thus it is possible that the story of the Minotaur may have been regarded as a legend of the Trojan people, and the famous labyrinth may have been associated in the popular mind with Troy as well as Crete.

Again it must be remembered that Troy had a legend of its own which bore a strong resemblance to that of Crete. The story was that Neptune and Apollo appeared in the guise of men before Laomedon, King of Troy, and luidcrttook, for an agreed price, to build a wall round the city. When the task was accomplished, Laomedon refused to pay them.

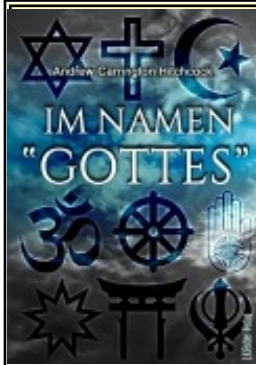

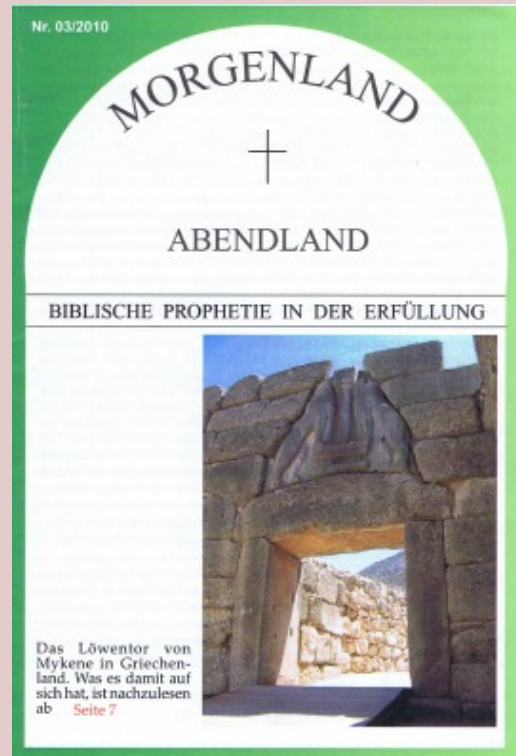
