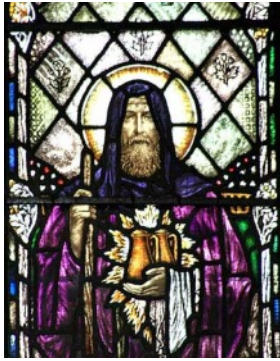

Arsenal Of Words (Part 17)

A Demonstration of The Deceptive Use of Words

**"Prove all things."
(1 Thes. 5:21)**

IT IS A GIVEN THAT THE AVERAGE Judeo-Christian minister does

not like to have his theology questioned. And there is a good reason for this. It is because they are not able to prove their own theology. To them, Christian Identity represents a very serious challenge to their status. When we start quoting Scripture passages that they have ignored or distorted, they typically react with anger...and this from the "God loves everybody" school of "Christianity."

Are you beginning to understand how the Bible has been **Distorted by the Jews and Their Co-conspirators**? By repeating the lie that the "Jews are Israel" millions of times, millions of Christians have been deceived.

Now that you understand the difference between a Jew and an Israelite, let us read John 10:11-16, the parable of the good shepherd, in a new light, in its proper racial, historical and prophetic context. Don't be afraid to read your Bible! Don't rely on the word of a seminary-taught distorter of God's Word. Study it for yourself. This is what Christian Identity is all about. Here, we are putting the Bible in your lap. Read it.

"Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." (2 Tim. 2:15.)

"I am the good shepherd: the good shepherd giveth his life for the sheep [Israel]. But he that is an hireling [the priesthood hired to watch over and feed the sheep], and not the shepherd, whose own the sheep are not, seeth the wolf coming, and leaveth the sheep and fleeth: and the wolf [the old priests of Baal, with their modern counterparts: the Jew-Beast system of false religion, Judaism and Judeo-Christianity] catcheth them, and scattereth the sheep [both

literally and spiritually]. The hireling fleeth, because he is an hireling, and careth not for the sheep. I am the good shepherd, and know my sheep, and am known of mine. As the Father knoweth me, even so I know the Father: and I lay down my life for the sheep [of the House of Judah in Judea].

And other sheep [of the scattered House of Israel] I have, which are not of this fold [in the land of Judea]: them [the Dispersed Caucasian Israelites] also must I bring, and they shall hear my voice [having become the Christians of Europe and the other White nations globally]; and there shall be one fold and one shepherd [the two Houses reunited in the Kingdom].

Judeo-Christian interpreters assume the expression "not of this fold" is a reference to non-Israelites. They do not know what they are talking about, because they do not understand the Bible. Their **opinion** is a **direct contradiction** of "I come not but [only] unto the Lost Sheep of the House of Israel." (Matt. 15:24, 10:6, 18:11; Luke 15:4-9.)

Most Judeo-Christians don't even know that All Israel was divided into two Houses. Their pastors don't tell them such frivolous details, because that would provide an alternative, rational, Biblical, historical context for the true meaning of these words!!! "That's Old Testament stuff," their pastors tell them. Not relevant!! The fact is that the process of bringing both Houses back into one fold is an end times prophecy. (The "two sticks" of Ezek. 37:16-20.)

How can you understand the end times, if you don't know the **WHOLE BIBLE???** The fulfilment of the Two Sticks prophecy began here in America, where **all twelve tribes** (both Houses) of Israel have been regathered. WE, True Israel, are now awaiting the great and terrible Day of the Lord, which is only a few years away. That is why this message must be delivered to our kinsmen, with the highest sense of seriousness and urgency, because lives and souls are stake.

Yahweh is regathering the flock, His sheep, but most of the flock don't even know it...because they/we are "blinded in part," and they have been denied the eyes to see and ears to hear, because they have believed a lie. (Rom. 11:8, 25). Because of Talmudism, which is a monument to Jewish deceit, and because of Judeo-Christian fantasies, True Israel has been sleepwalking around in a trance.

The false shepherds have had their day. The "dead men's bones" of Ez. 37 are coming back to life. The ministers of Christian Identity are the only ones that are following the Messiah's specific instruction:

"Feed my sheep." (**John 21:17.**)

He did not say, "Feed the world."

Romans 11, in the Light of the Exclusiveness Doctrine

Given the above listed Arsenal of Words, with their correct meanings restored, I will now translate Romans, Chapter 11 as it was meant to be understood by Paul. My changes are all in CAPS, comments in [brackets], important words in bold. William Finck's comments will be in {braces}.

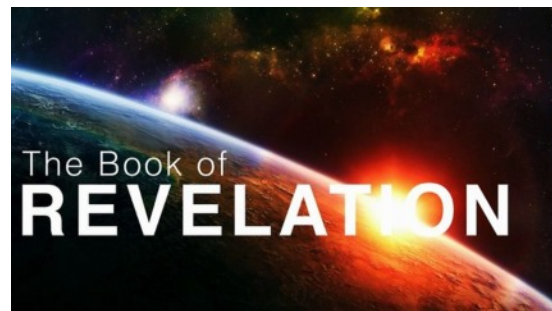
1 I say then, Hath God cast away his people? God forbid. For I also am an Israelite, of the seed of Abraham, of the tribe of Benjamin.

2 God hath not cast away his people, which he foreknew. [This is a direct contradiction of Dispensationalist doctrine!] **KNOW** ye not what the scripture saith of Elias? how he maketh intercession to God against Israel saying,

3 Lord, they have killed thy prophets, and digged down thine altars; and I am left alone, and they seek my life. [We Identists experience the same hatred that Elijah experienced, coming from the brainwashed Judeo-Christians today! They absolutely HATE our racial interpretation of Scripture! The Scriptures predict that we will be hated of men for our doctrine!! (Luke 21:17) In fact, seeing their faces turn 15 different shades of self-righteous RED proves that they are self-hating Adamites!]

4 But what saith the answer of God unto him? I have reserved to myself seven thousand men,

who have not bowed the knee to the image of Baal. [Race-mixing and prostitution were common practices of the Baal religion in those days, as they are again today. In fact, it is proper to say that race-mixing and prostitution were institutionalised in these Baal temples. Unlike Mosaism, which demanded that the Israelites separate themselves from all alien nations and religions, paganism accepted everybody...as it still does today, although it now passes under the name of ecumenism.



The Book of Revelation tells us that, at the Judgment Day, Yahweh will reserve 144,000 for Himself.]

5 Even so then at this present time also there is a remnant according to the election of grace. [By definition, the remnant cannot possibly be everybody, nor even all of the White Race or all Israel!!!]

6 And if by grace, then is it no more of works (rituals): otherwise grace is no more grace. But if it be of works, then it is no more grace: otherwise work is no more work. [Paul is not saying that grace replaces works. He is saying that Yahweh's **Favour**, which we call "grace," was obtained in spite of our inability to earn it through works. Our works of the law were insufficient to accomplish this. In essence, though guilty, we were pardoned.]

[The antinomians have here seized upon the word works, interpreting this to mean that neither good works nor evil works matter anymore, along with their sinister doctrine that "the law has been abolished"! All that matters is "grace." Of course, this is a preposterous over generalization of the meaning of the text. For comparison, here is Ferrar Fenton's elegant and straightforward translation, which uses the word ritual, instead of works.

"But if by a gift, it cannot be from a ritual; or the gift would no longer be a gift.]

{William Finck's translation: "But if in favour, no longer from rituals: since favour would be favour no longer."}

7 What then? Israel hath not obtained that which he seeketh for; but the election hath obtained it, and the rest were blinded. [We obtained Mercy because we, the Elect, were destined to receive it by His sacrifice at the Cross. We did not earn it through the works of the Law, though we may have tried. Those of our people who do not understand this are still blind...and so are the Edomite Jews!]

{William Finck: "What then, what Israel seeks after, this it did not attain to? But the chosen have succeeded, and the rest were hardened."}

8 (According as it is written, God hath given them the spirit of slumber, eyes that they should not see, and ears that they should not hear;) unto this day. [And our people, especially the Judeo-Christians, still do not see or hear, even unto this day as well, Dec. 2007.]

9 And David saith, Let their table be made a snare, and a trap, and a stumbling block, and a recompense unto them:

10 Let their eyes be darkened, that they may not see, and bow down their back alway.

11 I say then, Have they stumbled that they should fall? God forbid: but rather through their fall salvation is come unto the nations **DISPERSED**, for to provoke them to jealousy.

12 Now if the fall of them be the riches of the world, and the diminishing of them the riches of the **NATIONS**; how much more their fullness?

13 For I speak to you **DISPERSED**, inasmuch as I am the apostle of the **DISPERSED**, I magnify mine office: [Paul is not saying that he is more important than the other Apostles, as many critics falsely assume. Rather, he is simply stating the fact that he is now speaking to a much larger audience, as by this time, the Israelites of the Dispersion numbered many millions!]

14 If by any means I may provoke to emulation them which are my flesh, and might save some of them. [Note that Paul affirms here that he is speaking to and about those OF HIS OWN **FLESH**, i.e., his kinsmen of the Dispersion.]

15 For if the casting away of them be the reconciling of the world, what shall the receiving of them be, but life from the dead? [The Resurrection of the "Dead" is a metaphor for our people coming back into the fold via the Restoration of Their True Identity. Those Whites who are still unaware of their Identity are like zombies, the walking dead. Those who take such passages literally think that bodies will emerge out of the graves and come back to life!]

16 For if the firstfruit be holy, the lump is also holy: and if the root be holy, so are the branches. [All Israel is **Holy, Set Apart.**]

17 And if some of the branches be broken off, and thou, being a wild olive tree, wert grafted in among them, and with them partakest of the root and fatness of the olive tree; [Notice that the "grafting in" is limited to Israelites only (the olive tree), not to all races, as your pulpitmasters would have you believe. Also, the branches that were "broken off" were originally a part of the same tree!!]



{The "grafting in" of Romans, Chapter 11 may be better understood when the entire context of Israel's previous history of dispersion is considered. Paul only uses this example with the Romans, and nowhere else. In contrast, he tells the Dorian Greeks of Corinth that "All of our fathers were under the cloud, all passed through the sea." (I Cor. 10:1.) In other words, the ancestors of the Dorians had once been given the laws at Sinai, and they were descendants from the "good" (cultivated) "olive tree." But, the Zarah-Judahites, who founded Troy and then Rome, had broken off from the main body of Israel long before Mt. Sinai and the giving of the law. Hence, they were "wild" olives, who had to be "grafted (back) into" the cultivated tree!}

18 Boast not against the branches. But if thou boast, thou bearest not the root, but the root thee. [Don't puff yourself up against your own

kinsmen, who may be living in another town or another country. You should be teaching them and encouraging them to study the Word. And if they challenge your knowledge of the Scriptures, take it as an opportunity to fellowship. If you boast of your racial heritage, then you have not yet become a mature, humble **Servant of Yahweh.**]

{Nor should we puff ourselves up over our kinsmen who do not yet have the truth! They have not yet been blessed with the revelation that they are Anglo-Saxon Israel! Hence, we should be striving to teach them rather than gloating over our own knowledge.}

19 Thou wilt say then, The branches were broken off, that I might be grafted in. [The branches (tribes and clans that were broken off from the original tree), will be grafted back in. No universalism to be found here! No other races or people or churches are involved, because they were never part of the original TREE! Those who were not "broken off" of the original tree cannot be grafted in! I hate to insist on logic again. I just can't help myself!]

20 Well; because of unbelief they were broken off, and thou standest by faith. Be not highminded, but fear: [Firstly, only those branches that were broken off can be grafted back in. There is no such thing as "branches" that are alien to Israel. Secondly, Faith is not a substitute for the Law.

Faith is our ability to practice the Law in spite of hardships, because we understand that Yahweh's Redemptive Plan is still working. This is why we are encouraged to accept tribulation as a positive thing! (John 16:33; 2 Cor. 7:4.) Why? Because, as Israelites, we should understand that we are being "refined by fire."

This does not mean that we should become masochists! It means that we should understand that this struggle is preparing us for eternal life! Since most of our people always follow the path of least resistance, or because they want instant gratification, they fail to demonstrate the patience necessary to reap life's greater rewards. The Judeo-Christian concept of "faith" as consisting of mere belief that "Jesus died for our sins," thus abolishing the Law, is a fraud. It is a form of instant "spiritual gratification" if you will, and moral laziness, par excellence! Just as

many Judahites of Judea chose to follow the Pharisaic Jews then, the Judeo-Christians follow the Pharisaic rabbis today!]



{The branches of the olive tree "broken off" can only be those unbelieving Judahites who followed the Edomites rather than Christ. Those would have been the true "Judaizers" of the day!}

21 For if God spared not the natural branches, take heed lest he also spare not thee.

22 Behold therefore the goodness and severity of God: on them which fell, severity; but toward thee, goodness, if thou continue in his goodness: otherwise thou also shalt be cut off. [If the law has been abolished, on what basis can we be "cut off" from the inheritance? Goodness and righteousness are synonyms for obedience to a higher authority. Watch your own behaviour, lest you be judged unworthy to be a citizen of the Kingdom.]

23 And they also {those who follow Esau}, if they abide not still in unbelief, shall be grafted in: for God is able to graft them in again. [It is an ongoing fact that we in Christian Identity are trying to reach those of our people who have been spellbound by Jewish fables. Paul is here speaking of them being brought back into the fold by our evangelising efforts!]

24 For if thou wert cut out of the olive tree which is wild by nature {The Greek word which is here translated as "good olive tree" actually means "cultivated olive tree."}, and wert grafted contrary to nature into a good olive tree: how much more shall these, which be the natural branches, be grafted into their own olive tree? [The olive tree has always been understood as the symbol of Christian Israel only. This symbol is never used to represent other or all nations, as the universalists would like to have it.]

25 For I would not, brethren, that ye should be ignorant of this mystery, lest ye should be wise in your own conceits; that blindness in part is happened to Israel, until the fullness of the NATIONS be come in. [This is a very specific prophecy that Israel's collective identity amnesia will preponderate until the last days, when all nation-states will have fulfilled their purpose or have been superseded by some other entity. We can see that the former borders of our White nation-states are dissolving (have dissolved) under the influence of Rothschild's

United Nations and the New World Order. Yet, at the same time, we are regaining our Identity as God's Chosen People, getting ready for the Kingdom that will replace the current order. Paul's prophecy is right on the money, as Christian Identity is taking True Israel's blinders off while the formerly White and Christian Nation-States fall apart.]

Old Testament

“Word for Word” Deuteronomy Part 10

Translation by Stephen Howard Anderson



Chapter 14

1. You are the children of Yahweh Eloheychem: you shall not cut yourselves 1413 in mourning, and shall not make 7760 any baldness 7144 between 996 your eyes 5869 for the dead 4191.

2. Because you are a Holy 6918 people to Yahweh Eloheycha: and you has chosen 977 Yahweh to be His treasured 5459 people, of all 3605 the nations 5971 that are upon the face of the land.

3. You shall not eat any abominable thing 8441.

4. These are the beasts 929 which you shall eat: the ox 7794, the sheep 3775 of the flock 7716, and the goat 5795 of the flock.

5. The deer 354, and the gazelle 6643, and the roebuck 3180, and the wild goat 689, and the ibex 1788, and the wild ox 8377, and the mountain sheep 2169.

6. Every beast that divides 6536 the hoof 6541,

and divides 8156 the divide 8157 into two 8147 hooves, and brings up 5927 the cud 1625 among the beasts, that you shall eat.

7. Nevertheless these you shall not eat of those that bring up the cud, or of them that divide the divided hoof; the camel 1581, and the hare 768, and the hyrax 8227: because they bring up the cud, but do not divide the hoof; they are unclean 2931 to you.

8. And the swine 2386, because it divides the hoof, yet does not bring up the cud, it is unclean to you: you shall not eat of their flesh, nor touch 5060 their dead carcass 5038.

9. These you shall eat of all that are in the waters: all that have fins 5579 and scales 7193 you shall eat:

10. and whatever does not have fins and scales you may not eat ; it is unclean to you.

11. All birds 6833 that are clean 2889 you shall eat.

12. But these 2088 are what you shall not eat: the eagle 5404, and the ossifrage 6538, and the buzzard 5822,

13. and the raah 7201, and the falcon 344, and the dayah 1772 after their species 4327.

14. Every raven 6158 after its species,

15. And the daughter 1323 of the ostrich 3284,

and the male ostrich 8464, and the seagull 7828, and the hawk 5322 after its species,



16. the little owl 3563, and the great owl 3244, and the [tineshemets 8580],

17. and the pelican 6893, and the carrion vulture 7360, and the cormorant 7994,

18. and the stork 2624, and the [anapah 601] after its species, and the hoopoe 1744, and the bat 5847.

19. And every creeping thing 8318 that flies 5775 is unclean to you, they shall not be eaten.

20. All birds that are clean you may eat.

21. You shall not eat of any dead carcass 5038: you shall give it to the sojourner 1616 that is within your gates, that he may eat it; or you may sell 4376 it to a racial alien 5237: because you are a Holy 6918 People to Yahweh Eloheycha. You shall not boil 1310 a kid 1423 in its mother's milk 2461.

22. You shall truly tithe 6237/6237 all the increase 8393 of your seed 2233 that the field brings forth year by year.

23. And you shall eat before Yahweh Eloheycha, in the place which He shall choose to establish 7931 His Name there; the tithe of your corn 1715, of your new wine 8492, and of

your fresh oil 3323, and of the firstborn 1062 of your herds 1241 and of your flocks 6629; so that you may learn 3925 to revere 3372 Yahweh Eloheycha all the days.

24. And if the way is too much 7235 for you, so that you are not able to bear 5375 it; if the place is too far 7368 from you, when Yahweh Eloheycha shall choose to set 7760 His Name there, when Yahweh Eloheycha has blessed 1288 you:

25. then you shall give 5414 it as silver 3701, and bind up 6696 the silver in your hand, and you shall go to the place which Yahweh Eloheycha shall choose:

26. and you shall bestow 5414 that silver for all that your being desires 183, for oxen, or for sheep, or for wine, or for strong drink 7941, or for all that your being desires 7592: and you shall eat there before Yahweh and you shall rejoice 8053, you and your household,

27. and the Lewiy 3881 that is within your gates; you shall not forsake 5800 them; because they have no portion 2506 or inheritance 5159 with you.

28. At the end of three years you shall bring forth all the tithe of your increase the same year, and it shall rest 5117 within your gates:

29. and the Lewiy, because he has no portion or inheritance with you, and the sojourner 1616, and the fatherless child 3490, and the widow 490, which are within your gates, shall come, and shall eat and be satisfied 7646; so that Yahweh Eloheycha may bless you in all the work 4639 of your hands which you do.

CHAPTER 14 NOTES

Chapter 14 is a repeating of Levitical laws for the younger generation of Yisrael.

References Chapter 14

Verse 1 concerns pagan mourning practices of cutting oneself ritually, and shaving of the hair above the forehead. Lev. 19:28; 21:5;

Verse 2 – Ex. 19:5,6; Deut. 4:20; 7:6; 26:18; Titus 2:14; 1 Pet. 2:9;

Verses 2-21 are food laws. Many of the words for the species are either lost, or unclear in meaning, or probable meanings.

Verse 5 – 8377 wild ox, or antelope, 2169 mountain sheep, or chamois;

Verse 7 – Lev. 11:4-6; 768 unknown species, 8227 another species of rabbit;

Verse 8 – Lev. 11:7;

Verse 9 – Lev. 11:9;

Verse 10 – Lev. 11:10;

Verses 11-20 -Lev. 11:13-19;

Verse 12 – 6538 a type of vulture; 5822 or “black vulture”;

Verse 13 - 7201 unclear species; 1722 a bird of prey; 7201 and 1722 are not in Leviticus;

Verse 16 – 3563 unknown species; 3244 from Egyptian, species unknown; 8580 unknown;

Verse 18 – 601 unknown; 1744 probable meaning;

Verse 21 – Ex. 23:19; 34:26;

The last part of verse 21 is a subject of controversy. It does not say to not eat meat and milk together. This stipulation is a rabbinical pronouncement from long ago, and is another of the added regulations of orthodox Judaism from their Babylonian Talmud. It is not a command from Yahweh, but a "tradition of men." See Deut. 12:32.

Verses 22-29 have to do with tithing. Lev. 27:30 – 33; Num. 18:21;

Verse 26 – 7941 is a type of beer.

English Was Derived From The Ancient Hebrew By Willie Martin (Part 2)

PROBABLY AT FIRST THE UNLEARNED READER may be a little alarmed at the show of learning exhibited in the following tables of strange and ugly figures, drawn up in lines and placed in battle array. But when the first terror has subsided, he will find nothing that is difficult; and which, with mere school-boy learning, he will not easily understand.

To comprehend the reasoning used in the following work, a knowledge of the languages in the tables of the different alphabets will not be necessary. A very little attention to the principle upon which I proceed, will enable any person to judge of the probability of the

consequences deduced from the etymologies of the names of places and people which are used.

The English Language - Derived from the Hebrew, so says R. Govett in an old manuscript. From this point on the writings presented will be presented from his own words: Professor Max Muller, in his lectures on language, having shown that several of our common English words are derived from the Sanskrit, it struck me to inquire, what would be the result of tracing the obligations of the English language to the Hebrew? And, having gone into this matter to some extent, I now believe that English is derived from the Hebrew.

Section 1: I propose to give specimens of the derivation of our names of Animals from the sacred language.

What is the Hebrew name for the Hare? ARNHBit. (I give the letters simply; not according to the Masoretic pointing; adding in smaller type the vowels supplied). Now may not these letters at once hint to us, whence our name

of an allied animal is derived? Reverse the order of the A and the R, and you have RANBIT, whence our word RABBIT evidently comes. What is the Hebrew for the terrible serpent, deceiver of our race? NaHHaS. Change the last letter to the foremost place, and you have our SNAKE.

Hence too, by A prefixed, we get the Latin Anguis, and the Greek Echis, the letter N being dropped, as it is very often in Hebrew. If the Scripture be true, we might expect this word to be retained; and so it is. The Greek word for the viper is Aspis, whence our word Asp. It comes from the Hebrew ZP'A transposed; which also signifies a viper.



BOA, familiar to us as the name of the destroying Boa. The letters B, P, and F, are perpetually interchanged in their passage from one language to another. From the same Hebrew word comes our English "Eft," a small creature of the lizard kind. And probably the Latin VIPERA comes from the same root; the F or V being prefixed to the commencing vowel.

The Adder proceeds from ATaR, "to encircle," and is derived from its coiling itself into a series of circles. The Lion in Hebrew is LeBIAW. The B is dropped in English, Latin, and Greek. And we have Leo in Latin. Perhaps we might say that the B is transferred to the end, and becomes N. KITTEN? From the Hebrew QuiToN, which signifies "a little one." That which the Hebrews applied generally, we have, singularly enough, appropriated to the young of the cat alone. CAMEL? From the Hebrew GeMeL, which signifies the same animal. Here the G of the Hebrew becomes changed into the C or K of the English, Latin, and Greek.

What is the derivation of the word ELEPHANT? It comes from the Hebrew ELePH, which means an ox. But how is an elephant like an ox? I

answer, the termination "ant" carries with it, most probably, the word which denoted the difference between it and the common ox. We naturally, on seeing a new creature, associate it with one familiar to us.

Some of the South Sea Islanders, as Williams has informed us, had never beheld a European, or the animals with which we are familiar. Hence, as he observes, "On seeing the goats, they called to their companions to come and look at the wonderful birds with great teeth upon their heads." So with us, "the cock of the woods" and "the wood-cock" are very different birds from the common barn-door cock. This same Hebrew word was the origin of the Greek Elaphos, 'a stag.' And it is very remarkable that we find the same combination of "ant," and "elaph" in the ANTELOPE. I am not clear what is the meaning of "ant."

The Hebrew SHOOR, and the Chaldee TOOR signify an ox; whence we obtain our English STEER. The name of the Jerboa arises from the Hebrew ZHeB'O, which means a hyena. The Chaldee adds the R. Our word BADGER is derived from the Hebrew 'ACBaR, which means a mouse. By transposition we have BACaR, whence "Badger" easily springs. GIRAFFE? From the Hebrew GaRaPH, which signifies "the neck;" and every one who has seen that creature, knows that its great peculiarity is the enormous elongation of its neck. GOAT and KID? From two different pronunciations of the Hebrew GiDI, which signifies that animal in the sacred tongue. Our expression "the giddy heights" perhaps springs from the remembrance of the lofty pinnacles of rock to which these creatures climb. The heights to which the mountain goats climb, produce in us the sensation of "giddiness." ZEBRA?

From the Hebrew ZeBI, which signifies a roebuck. The "R" in the midst, and the "A" at the end come from the Chaldee, which frequently adds these letters. Indeed, the R occurs so often in English, where it is not found in the Hebrew, as to make it most probable that the Hebrew came to us through the Chaldee. The DOE clearly is traceable to the TOA, or antelope.

Section 2: Now turn to some examples of BIRDS. We have two names of birds spelt differently, but of the same radical base. COOT and KITE, These are off-shoots, I doubt not, from the Hebrew QuAT. (I retain the English

letter Q to represent the Hebrew Koph or Quoph, though I suppose it was generally pronounced K). Probably also our CAT is derived therefrom, though whence the confusion arose, it would be difficult to determine, without the history of Genesis XI. The meaning of the Hebrew word is "the pelican," or cormorant.

The Hebrew speaks of a bird called INSOP. This is supposed to be a water-fowl of some kind. The Septuagint renders the word, ibis: our translators, "the great owl." But whatever its original signification, it is the parent of our word SNIPE, a bird fond of marshy places. This is an instance of the Saxon love of brevity. Two syllables in the Hebrew are contracted into one in English. This principle appears often.

DOVE? From the Hebrew DOoB; which signifies to murmur. The B was frequently pronounced V. Sometimes also it was changed into P and PH, as I have noted above. The SARROW is found in most parts of the old world. What is its Hebrew name? ZaPPOR. The Saxon word has manifestly sprung from this.

The Z and P combine, the vowel is inserted after them, and the long O, which is Hebrew precedes the R, is set last: 'Sparrow.' The Latin name is another variation of the same letters: PASSER. Hence too the Greek Peristera, 'a dove.' PELICAN? From the Hebrew PeLeG, which signifies a stream or channel. it indicates, then, a water-bird: and it is well known, the Pelican obtains its food from the water.



RAVEN derived? From the Hebrew 'ARaB. (I denote the Hebrew letter Ayin by an A or E or O with a comma, thus: 'A, 'E, or 'O). Transpose the two first letters, and add an N, which addition at the close is common in Hebrew, and you have RAVEN. Thence, too, our ROBIN. The CROW (or Rook) takes his name from his perpetual "Caw-caw." His appellation is derived from the Hebrew QRAW, with a broad A, which means

to call. The name "Rook" comes from the same letters transposed.

Hence also come our words "cry," and "crew," a number of men whose names are called over, and who must answer to the call. A bird's "craw" comes from the Hebrew GeRaH, which signifies "the cud." We may often hear at nightfall, especially in the spring a harsh, reedy call of a single note, proceeding from the midst of the corn. This cry is uttered by the corn-CRAIN. Its name is derived from the Hebrew HRaiQ, which means the unpleasant sound produced by grinding or gnashing the teeth.

Now, as the genius of our language will not admit of "H" immediately preceding "R," the H is turned into its sister letter C, and it becomes the parent of words descriptive of unpleasant sounds, as creak, croak. This is also the origin of the Greek word for "CROW" KORAX. Hence Keerux, a herald. The HAWK was formerly called HAFOC by the Saxons. It is still in Danish Havik; in German Habicht. It derives its name from the Hebrew HaFoC, which means "the Destroyer." We still retain the word "HAVOC," as meaning destruction. DAW? From DAH, which probably means a kite. Our Chough from SeHOUPH, a 'sea-gull.'

What shall we say is the origin of our word EGRET? It comes from the word 'EGORT, a crane. The word CRANE is derived from the Hebrew GaRaN, a throat. It is related of one of the epicures among the ancients, that, believing the throat to be the organ of taste, he wished his throat were as long as a crane's.

From this word is derived the Greek Geranos, and the Latin Grus; each of which signifies "the crane." Our word GULL, to move in a circuit: which is quite characteristic of the sea-gull. The name of the CONDOR comes from the Hebrew QoDoR, which means to be dark; the N being inserted by way of strengthening in the root. From the same base is derived the brook KEDRON. The name TOUCAN is probably obtained from the Hebrew TooQuaN, to be straight; from the remarkably long bill of the bird.

Hebrew is traceable in the Latin and Greek names also. The Latin name of the Nightingale is Luscinia, which is derived from the Hebrew LuSHeN, the tongue. Its melodious voice could

but give it its distinguishing title, "the bird with the tongue of melody." So the ASS is in Latin Asinus, which is derived from the Hebrew AZIN, an ear. Its long ears gave it the name of 'the beast with the prominent ears.' The Greeks called the SWALLOW, Chelidon. This comes from the Hebrew HheLID, which signifies "transient." It took its name as being "the bird of passage." Our word SWALLOW comes from the Hebrew SaLO, which we translate "quail" in the history of Israel in the wilderness; but which Forster has shown to mean a red-legged goose.

The Greek Actos signifies an eagle. It takes its origin from the Hebrew AiT, which means, a bird or beast of prey. The Latin Aquila, which also signifies an eagle, comes from the Hebrew AKuL, a devourer. Our Osprey derives from PeRoS, a kind of eagle.

Section 3: Shall we look to some specimens among the FISHES? Where do we obtain the word FISH? From the Hebrew NePHeSH, which generally signifies a living creature; but fishes are the first to which it is applies: Genesis 1:21. But we, after dropping the first letter N, (which is a very unstable one in that language), have appropriated it to one class of animals in the sea. Thence, too, spring the Latin Piscis, and the French Poisson. Hence also probably our Puss.

What is the Hebrew for SCORPION? 'AQRaB. 'But we have no scorpions! How then should that

name be naturalized among us?' It is true that we have no scorpions; and let us be thankful for it! But when our ancestors traveled from the east to our shores, they saw a creature in the sea possessed of great claws, moving about like a scorpion; and they cried, "AcraB! 'AcraB!"

The first A was mistaken for the English indefinite article; and our love of monosyllables soon cut it short into CRAB. This is also the parent of the Greek and Latin Scorpio. The S is added by the Chaldee. The 'A and Q change places, and become "Sco." The B becomes a P, and so we have Scorpio.

Hence also the Latin Crabro, 'a hornet.' The Latin word for CRAB, Cancer, (the second C being hard), springs from the Hebrew CaCaR, a circle, with the strengthening N. The fish's body is CIRCULAR. The WHELK is a shell-fish which sticks to the rocks. It comes from the Hebrew 'ELQ, to adhere. The Elk comes from this root. Probably too our LEECH is derived from the same root by transposition. The Hebrew HaDDoQ signifies a thorn. The name probably originally signified some fish with a thorny back. But the English HADDOCK clearly derives thence its name. Our PERCH takes its name, from the Hebrew PeRaHH, which signifies to break out, to shoot out; and it refers probably to its power of erecting the prickles on its back.

No One Has Died from The Corona Virus Rosemary Frei and Patrick Corbett



Important revelations shared by Dr Stoian Alexov, (left) President of the Bulgarian Pathology Association

A high-profile European pathologist is reporting that he and his colleagues across Europe have not found any evidence of any deaths from the novel corona virus on that continent.

Dr. Stoian Alexov called the World Health Organization (WHO) a "criminal medical organ-

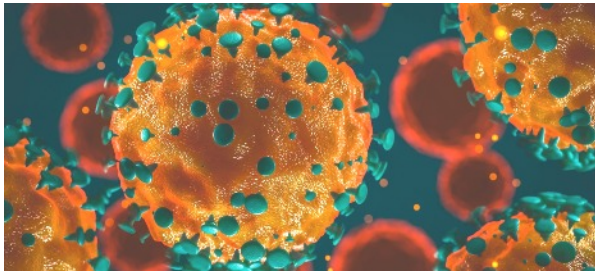
ization" for creating worldwide fear and chaos without providing objectively verifiable proof of a pandemic.

Another stunning revelation from Bulgarian Pathology Association (BPA) president Dr. Alexov is that he believes it's currently "impossible" to create a vaccine against the virus.

He also revealed that European pathologists haven't identified any antibodies that are specific for SARS-CoV-2.

These stunning statements raise major questions, including about officials' and scientists' claims regarding the many vaccines they're rushing into clinical trials around the world.

They also raise doubt about the veracity of claims of discovery of anti-novel-corona virus antibodies (which are beginning to be used to treat patients).



Novel-corona virus-specific antibodies are supposedly the basis for the expensive serology test kits being used in many countries (some of which have been found to be unacceptably inaccurate).

And they're purportedly key to the immunity certificates coveted by Bill Gates that are about to go into widespread use — in the form of the COVI-PASS — in 15 countries including the UK, US, and Canada.

Dr. Alexov made his jaw-dropping observations in a video interview summarizing the consensus of participants in a May 8, 2020, European Society of Pathology (ESP) webinar on COVID-19.

The May 13 video interview of Dr. Alexov was conducted by Dr. Stoycho Katsarov, chair of the Centre for Protection of Citizens' Rights in Sofia and a former Bulgarian deputy minister of health. The video is on the BPA's website, which also highlights some of Dr. Alexov's main points.

We asked a native Bulgarian speaker with a science background to orally translate the video interview into English. We then transcribed her translation. The video is here and our English transcript is here.

Among the major bombshells Dr. Alexov dropped is that the leaders of the May 8 ESP webinar said no novel-corona virus-specific antibodies have been found.

The body forms antibodies specific to pathogens it encounters. These specific antibodies are known as monoclonal antibodies and are a key tool in pathology. This is done via immunohistochemistry, which involves tagging antibodies

with colours and then coating the biopsy or autopsy-tissue slides with them. After giving the antibodies time to bind to the pathogens they're specific for, the pathologists can look at the slides under a microscope and see the specific places where the coloured antibodies — and therefore the pathogens they're bound to — are located.

Therefore, in the absence of monoclonal antibodies to the novel corona virus, pathologists cannot verify whether SARS-CoV-2 is present in the body, or whether the diseases and deaths attributed to it indeed were caused by the virus rather than by something else.

It would be easy to dismiss Dr. Alexov as just another crank 'conspiracy theorist.' After all many people believe they're everywhere these days, spreading dangerous misinformation about COVID-19 and other issues.

In addition, little of what Dr. Alexov alleges was the consensus from the May 8 webinar is in the publicly viewable parts of the proceedings.

But keep in mind that whistle blowers often stand alone because the vast majority of people are afraid to speak out publicly.

Also, Dr. Alexov has an un-impugnable record and reputation. He's been a physician for 30 years. He's president of the BPA, a member of the ESP's Advisory Board and head of the histopathology department at the Oncology Hospital in the Bulgarian capital of Sofia.

On top of that, there's other support for what Dr. Alexov is saying.

For example, the director of the Institute of Forensic Medicine at the University Medical Centre Hamburg-Eppendorf in Germany said in media interviews that there's a striking dearth of solid evidence for COVID-19's lethality.

"COVID-19 is a fatal disease only in exceptional cases, but in most cases it is a predominantly harmless viral infection," Dr. Klaus Püschel told a German paper in April. Adding in another interview:

In quite a few cases, we have also found that the current corona infection has nothing whatsoever to do with the fatal outcome because other causes

of death are present, for example, a brain haemorrhage or a heart attack [...] [COVID-19 is] not particularly dangerous viral disease [...] All speculation about individual deaths that have not been expertly examined only fuel anxiety.”

Also, one of us (Rosemary) and another journalist, Amory Devereux, documented in a June 9 Off-Guardian article that the novel corona virus has not fulfilled Koch’s postulates.

These postulates are scientific steps used to prove whether a virus exists and has a one-to-one relationship with a specific disease. We showed that to date no one has proven SARS-CoV-2 causes a discrete illness matching the characteristics of all the people who ostensibly died from COVID-19. Nor has the virus has been isolated, reproduced and then shown to cause this discrete illness.



In addition, in a June 27 Off-Guardian article two more journalists, Torsten Engelbrecht and Konstantin Demeter, added to the evidence that “the existence of SARS-CoV-2 RNA is based on faith, not fact.”

The pair also confirmed “there is no scientific proof that those RNA sequences [deemed to match that of the novel corona virus] are the causative agent of what is called COVID-19.”

Dr. Alexov stated in the May 13 interview that:

—the main conclusion [of those of us who participated in the May 8 webinar] was that the autopsies that were conducted in Germany, Italy, Spain, France and Sweden do not show that the virus is deadly.”

He added that:

What all of the pathologists said is that there’s no one who has died from the corona virus. I will repeat that: no one has died from the corona virus.”

Dr. Alexov also observed there is no proof from autopsies that anyone deemed to have been

infected with the novel corona virus died only from an inflammatory reaction sparked by the virus (presenting as interstitial pneumonia) rather than from other potentially fatal diseases.

Another revelation of his is that:

“We need to see exactly how the law will deal with immunization and that vaccine that we’re all talking about, because I’m certain it’s [currently] not possible to create a vaccine against COVID. I’m not sure what exactly Bill Gates is doing with his laboratories – is it really a vaccine he’s producing, or something else?”

As pointed to above, the inability to identify monoclonal antibodies for the virus suggests there is no basis for the vaccines, serological testing and immunity certificates being rolled out around the globe at unprecedented speed and cost. In fact, there is no solid evidence the virus exists.

Dr. Alexov made still more important points. For example, he noted that, in contrast to the seasonal influenza, SARS-CoV-2 hasn’t been proven to kill youth:

[With the flu] we can find one virus which can cause a young person to die with no other illness present [...] In other words, the corona virus infection is an infection that does not lead to death. And the flu can lead to death.”

(There have been reports of severe maladies such as Kawasaki-like disease and stroke in young people who were deemed to have a novel-corona virus infection.

However, the majority of published papers on these cases are very short and include only one or only a small handful of patients. Moreover, commentators on the papers note it’s impossible to determine the role of the virus because the papers’ authors did not control sufficiently, if at all, for confounding factors. It’s most likely that children’s deaths attributed to COVID-19 in fact are from multiple organ failure resulting from the combination of the drug cocktail and ventilation that these children are subjected to.)

Dr. Alexov therefore asserted that:

the WHO is creating worldwide chaos, with no real facts behind what they’re saying.”

Among the myriad ways the WHO is creating that chaos is by prohibiting almost all autopsies of people deemed to have died from COVID-19. As a result, reported Dr. Alexov, by May 13 only three such autopsies had been conducted in Bulgaria.

Also, the WHO is dictating that everyone said to be infected with the novel corona virus who subsequently dies must have their deaths attributed to COVID-19.

“That’s quite stressful for us, and for me in particular, because we have protocols and procedures which we need to use,” he told Dr. Katsarov. “...And another pathologist 100 years from now is going to say, ‘Hey, those pathologists didn’t know what they were doing [when they said the cause of death was COVID-19]!’ So we need to be really strict with our diagnoses, because they could be proven [or disproven], and they could be checked again later.”

He disclosed that pathologists in several countries in Europe, as well as in China, Australia and Canada are strongly resisting the pressure on them to attribute deaths to COVID-19 alone:

I’m really sad that we need to follow the [WHO’s] instructions without even thinking about them. But in Germany, France, Italy and England they’re starting to think that we shouldn’t follow the WHO so strictly, and [instead] when we’re writing the cause of death we should have some pathology [results to back that up] and we should follow the protocol. [That’s because] when we say something we need to be able to prove it.”

(He added that autopsies could have helped confirm or disprove the theory that many of the people deemed to have died of COVID-19 in Italy had previously received the H1N1 flu vaccine. Because, as he noted, the vaccine suppresses adults’ immune systems and therefore may have been a significant contributor to their deaths by making them much more susceptible to infection.)

Drs. Alexov and Katsarov agreed that yet another aspect of the WHO-caused chaos and its fatal consequences is many people are likely to die soon from diseases such as cancer because the lock-downs, combined with the emptying of hospitals (ostensibly to make room for COVID-

19 patients), halted all but the most pressing procedures and treatments.

They also observed these diseases are being exacerbated by the fear and chaos surrounding COVID-19.

We know that stress significantly suppresses the immune system, so I can really claim 200% that all the chronic diseases will be more severe and more acute per se. Specifically in situ carcinoma – over 50% of these are going to become more invasive [...] So I will say that this epidemic isn’t so much an epidemic of the virus, it’s an epidemic of giving people a lot of fear and stress.”

In addition, posited Dr. Alexov, as another direct and dire result of the pandemic panic many people are losing faith in physicians.

Because in my opinion the coronavirus isn’t that dangerous, and how are people going to have trust in me doing cancer pathology, much of which is related to viruses as well? But nobody is talking about that.”



We emailed Dr. Alexov (above) several questions, including asking why he believes it’s impossible to create a vaccine against COVID-19.

He didn’t answer the questions directly. Dr. Alexov instead responded:

We also emailed five of Dr. Alexov’s colleagues in the European Pathology Society asking them to confirm Dr. Alexov’s revelations. We followed up by telephone with two of them. None responded.

Why didn’t Dr. Alexov or his five colleagues answer our questions?

We doubt it's due to lack of English proficiency.

It's more likely because of the pressure on pathologists to follow the WHO's directives and not speak out publicly. (And, on top of that, pathology departments depend on governments for their funding.)

Nonetheless, pathologists like Drs. Alexov and Püschel appear to be willing to step out and say

that no one has died from a novel-corona virus infection.

Perhaps that's because pathologists' records and reputations are based on hard physical evidence rather than on subjective interpretation of tests, signs and symptoms. And there is no hard physical evidence that COVID-19 is deadly.

Harold Stough Notes Escomb Saxon Church County Durham Third Oldest UK Church Built AD 670



One of only three complete Saxon churches in Britain, this wonderfully preserved church sits in a sunken circular enclosure bordered by battered walls, an influence from Celtic Ireland.

About this church

The masonry of large blocks and quoins is partly made up of Roman stones from nearby Binchester fort, but the walls are constructed in the Saxon style of long and short work.

The church is a simple two cell structure and is largely as it was originally built in 650-700, though the south porch, with its ancient cross fragments, is a much later 14th century addition.

As you approach the west end of the church, try to spot the footprint of a former two storey annex, which was discovered during 1968 excavations. Access to the church was once by means of stone steps and included an underground chamber.

The interior is dominated by the Roman arch to the chancel, beneath which can be seen the

remains of a simple red medieval painting thought to be of the 12th century. The nave is lofty, with steeply pitched rough timbers.

The north nave windows are of small Saxon style, but the south nave wall is a veritable gallery of historical English styles, featuring windows in Saxon, Norman and Gothic traditions, each giving its own light but without detracting from the others.

A Roman inscription reading **LEG VI** (the Sixth Legion) can be seen on a stone built into the north wall, though it was placed in upside down as simply another piece of masonry. The font (probably 7th century) contains lock holes on the edges dating from the 13th century, when it was covered to prevent baptismal water being taken 'for superstitious use.'

A Saxon sundial is believed to be the oldest in the country still in its original position built into the south wall, and not to be confused with the later 17th century sundial. Besides a beast and a fishtailed serpent, there are only three marks on the dial, showing the early monks' three principal times of worship around which their lives revolved.

Shut your eyes to the surrounding modern housing and you might almost think you were transported back to the 7th century.

The Ancient Keys To Adam-Man - The Number 33

QUESTION: This number 33, does it belong to Freemasonry, or did it originate way back in ancient history?

ANSWER: We have told you much about this in the tape series. About true Masonry, how it was taken over and how like most things today became just opposite its beginning.

In the old big book we have traced how this was accomplished over the years and how Freemasonry then brought out their version of Symbolism, **Which Is the Universal Language**. We see how Albert Pike, Freemasonry's enamoured spokesman even reveals whether he knew it or not that Chriam the god of Freemasonry is really Demirgus the god of Darkness. And we know today that many Adamites do not realize that the Masonic lodge they belong to no longer recognizes Jesus the Christ as King of Kings.

Freemasonry of today now claims they have the 'Wisdom of Solomon', and all the symbols handed down with that ancient wisdom. We see this as just another instance of good being declared evil and evil being declared as good.

We have seen this development in architecture also, as those who are not Master Builders entered that field in the 19th century. The Master Builders of the race constructed buildings which created distinct impressions, constant with the purpose for which the structure itself was designed. It was thought that the 'Ark of the Covenant' was so constructed, that it was oracular in character because of special prepared chambers in its interior. These by their shape, and arrangements were so attuned to the vibrations of the invisible world (we would say

to the spirit of YAHWEH) that they caught and amplified the voices of the ages, imprinted upon and externally existent in the substance of the Glorious Light of Heaven.

They marked the stones with certain symbols, sometimes putting into the hands of the Saints a cluster of builders tools marking their work and the Saints as being of this Master Builder race.

In the old world of Europe and even on back through history there was always ornate carvings upon the fronts of their great churches, and different buildings such as the : .compass, square, rule, mallet or clusters of such tools. Josephus, the Judean Historian wrote: 'The sagacity of wisdom which God bestowed on Solomon was so great that he was in no way inferior to the Egyptians (of Enoch's day) who are said to have been beyond all men in understanding. God also enabled Solomon to

learn that skill which expelled Demons, which was useful to him and was a science.

The Mediaeval alchemists were convinced that King Solomon understood the secret processes that Enoch wrote of by means of which it was possible to multiply metals. We have read where the gold for the Temple was made by means of Alchemy, not taken from the ground of earth.

The basic principles of the ancient wisdom were imparted to Alexander the Great by Aristotle, (above) and at the Philosophers feet the Macedonian youth came to realize the transcendency of the message, and how Greek learning was personified in Plato's immortal disciple. At the feet of this great teacher young Alexander beheld the world of the sages, the purpose and plan of the creator, thus he learned of # 33 and its significance for his race.

Aristotle in his leisure hours edited 'The Iliad' of Homer, and presented the finished work to Alexander. This book the young conqueror so highly prized that he carried it with him, on all his campaigns. At the time of his triumph over Darius the Persian, he discovered among the spoils a magnificent gem studded casket of unguents, and he dumped its contents upon the ground saying he at last had found a case worthy of Aristotle's edition of 'The Iliad'.

While on his Asiatic campaign, Alexander learned that Aristotle had published one of his most prized discourses, and occurrence which

deeply grieved the young king for he felt that this was mysteries not to be lightly handed out to the public. So to Aristotle, conqueror of the unknown, Alexander the Conqueror of the known, sent this reproachful and pathetic admission of the inefficiency of world pomp and power: (quote) 'Alexander to Aristotle. 'Health'. You were wrong in publishing those branches of science hitherto not to be acquired except from oral instruction. In what shall I excel others, if the more profound knowledge I gained from you is communicated to all? For my part I had rather surpass the majority of mankind in the sublimed branches of learning, than in extent of power and dominion. Farewell'.

The receipt of this letter caused not a ripple in the life of Aristotle who replied; that altho the discourse had been communicated to the multitude, none who had heard him deliver the lecture, who lacked spiritual consciousness could understand its true import. In a few short years Alexander the Great would be gone from the scene, into the greater world where he would more fully understand all that he had learned. He had found here in earth that he was not allowed to gather all Adamites. For Destiny decreed they would be scattered to the four winds through out the world order, and yes, for a purpose. After all at the time of Alexander the Great, it would be a few hundred years yet before the coming of Messiah for the redemption, in that great program of YAHWEH established so long before in the heavens.

And below that in the clouds is a globe, a world with the symbols of the ancient Master Builders, here you see the Square, Trowel, Compass, Rule and so forth. Now in symbolism is this just the symbol of Freemasonry and their 33 degrees??? We think not. Since Symbolism is the Universal Language then here in the footnotes to this picture we find truths and some error. We are told that this picture is the symbol of the Supreme Master of the Double Holy Empire.

Some Dead Sea Scrolls

The recent shock discovery that some Dead Sea Scrolls are modern forgeries and that they have now been withdrawn from public viewing has rocked the scholastic world.

Tests are to be carried out on the remainder of the Scrolls next year to determine how many are authentic.

All books written by professors and biblical experts about the importance of those Scrolls in

Is it possible that this is being said by perhaps Vatican forces because the Scrolls themselves contain sufficient evidence to prove that the real origin was Egypt?

Robert Feather was the metallurgist entrusted with cutting open The Copper Scroll and his analysis of the Copper showed that it was exactly the same copper as was used in other Copper that was known to have come from the time of Rameses II in Egypt.

Furthermore, the weights and measures could only have been Egyptian for the 'Hebrew' weights that the Biblical society tried to use



came up with an amount of gold far in excess of all the gold that exists on Planet Earth. Using Ancient Egyptian weight measurements they then found that the gold listed in one column of the Copper Scroll came to within 4% of the amount of gold discovered at Amarna - site of Akhenaten / Moses 'New Jerusalem' i.e. IAH RE SALIM the spiritual name given to the Ancient Temples first in Luxor and then Akhetaten.

Similarly the measurements and lay out of streets in The New Jerusalem Scroll would never fit any ancient city of Canaan, Galilee or Judea and a search of ancient cities found that the only site that was large enough, was the Ruins at Amarna. Then we come to The Temple Scroll. This scroll gives a measurement for the outer courtyard wall which is remarkably close to that of the outer courtyard wall in the ruins of Akhetaten - Amarna.

From my files on the Scrolls - "The dimensions of the outer courtyard were vast, 1590 x 1590 cubits (one cubit equals 800 square meters). For the sake of comparison the measurements of the Herodian Temple Mount was 280 x 480 meters and was, in its day, one of the largest holy precincts in the world."

Returning to the Copper Scroll, Robert Feather found a number of Greek Letters, mainly in couplets which when put together spell out a name very close to 'Akhenaten' or 'Akhetaten' - One of the letters doesn't really fit, - Gamma. But then it is in the position where we should find the second 'T' in 'Akhetaten'. It is a bit late for whoever to try and hide The Copper Scroll. There is a full copy of it in Robert Feather's book along with a translation. Another point that is overlooked by the Faithful is that Herodotus

travelled from Egypt back to Ephesus via Canaan. It is well known that he was highly interested in all other religions and never missed a single Temple.

Yet there isn't a single mention of 'Jerusalem' in his 'Histories'. Jerusalem of today could not have existed circa 400 BC never mind a Holy Temple.

The 75 and older group accounts, all on its own, for 48.7 percent of all COVID deaths in the city.

Do the study you never did. Do something coherent. Since you announced a global pandemic affecting billions of lives, do a real study.

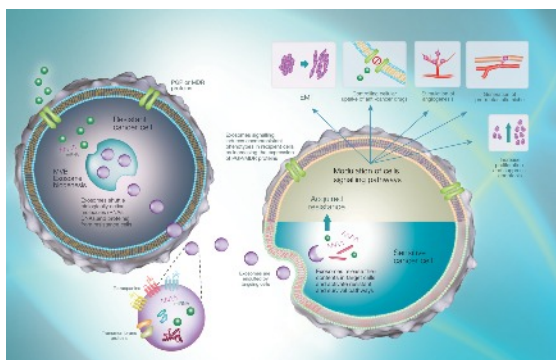

Arrivals and Departures: The Jews in England

William Shakespeare’s well-known plays, *The Jew of Malta* (1590) and *The Merchant of Venice* (1597).

Although the Jews had returned to Gascony soon after their expulsion in 1290, apart from the secret resettlement in England of forty ‘Marranos’ who had been forced to leave Spain under duress in 1492, Jews did not return to England in significant numbers until the time of Oliver Cromwell (1599-1658), almost four centuries later.

DURING THE ELIZABETHAN PERIOD the role of the stereotypical Jewish moneylender often became a topic of discussion in some of the country’s leading theatrical performances, not least in

By the second half of the seventeenth century, the economic demands of the English parliament were such that Cromwell decided to permit the Jews to re-enter the country. The quest to borrow money was not the only reason for Cromwell’s tolerance of the Jews, however, and after his victory in the English Civil War that had taken

place between 1642 and 1651, the Cromwellian regime initiated a series of theocratic measures designed to reinforce and consolidate the Protestant religion that had held sway since the Reformation a century earlier. This led to the encouragement – often through religious violence, superstition and bigotry – of a more rigorous study and appliance of the values found in the Old Testament, something which soon led Cromwell and his henchmen to assume that the Jews, or the ‘People of the Book’, were their natural allies. For the Cromwellian establishment, therefore, philo-Semitism became the order of the day.



In 1655, Cromwell allowed a rabbi by the name of Manasseh ben Israel (1604-1657) to travel to London from his native Holland and set out the reasons why Jews should be permitted to re-enter the country. Previously, in 1649, Royalist newspapers such as the *Moderate Intelligence* and *Mercurius Pragmaticus* had attempted to deter Cromwell from re-admitting the Jews into England, arguing that they cannot be trusted in business matters and that nobody should ever shake the hands of those responsible for the death of the Saviour.

In December 1655, Manasseh ben Israel and those ‘Marrano’ families which had been living in England under assumed names since 1492, issued a petition openly declaring their Jewish identity.

In a country where Catholics had been so viciously persecuted, it was naturally considered safer for them to be seen as Jewish immigrants, rather than as potential Spanish ‘papists’. Oliver Cromwell, himself a mere ‘commoner’ in a

country that had only recently committed an act of regicide against the English monarch, Charles I (1600-1649), did not have the power to revoke Edward I’s royal edict of expulsion and, therefore, in 1658 he gave the Jewish leader, Antonio Fernandez Cavajal (1590-1659), a verbal assurance that he and his people would be protected. This, in defiance of his former recommendations to the Council that Jews should only be permitted to attain the status of ordinary aliens. Given that Edward I’s edict remains on the statute books, Cromwell’s rather vague assurances still hold true today. Indeed, according to Joan Comay, wife of the one-time Israeli Ambassador to the United Nations, in a book originally published in 1974 and then hurriedly withdrawn in 1977:

Although Edward I’s 1290 edict of expulsion was not formally revoked as Manasseh [Ben Israel] had hoped, the resumption of open Jewish worship achieved the same practical result. The edict has actually not been revoked to this day. [9]

As a result, Jewish power in England was permitted to grow and prosper – some might say fester – with the first synagogue having already been founded in 1657 at London’s Creechurch Lane by Sephardic Jews from Spain and Portugal. Meanwhile, the first Ashkenazi synagogue was established in 1690 and the famous Great Synagogue of London opened its doors in 1722. The latter was finally destroyed in a bombing raid in 1941.

One of the first significant manifestations of Jewish power in the British Isles was the establishment of the Bank of England by William Paterson and his Jewish associates in 1694. Professor Carroll Quigley (1910-1977) of Harvard University, who, in many ways, was himself an insider on such matters, remarked that this event

is one of the great dates in world history. For generations men had sought to avoid the one drawback of gold, its heaviness, by using pieces of paper to represent specific pieces of gold. Today we call such pieces of paper gold certificates. Such a certificate entitles its bearer to exchange it for its piece of gold on demand, but in view of the convenience of paper, only a small fraction of certificate holders ever did make such demands. It early became clear that

gold need be held on hand only to the amount needed to cover the fraction of certificates likely to be presented for payment; accordingly, the rest of the gold could be used for business purposes, or, what amounts to the same thing, a volume of certificates could be issued greater than the volume of gold reserved for payment of demands against them.

Such an excess volume of paper claims against reserves we now call bank notes. In effect, this creation of paper claims greater than the reserves available means that bankers were creating money out of nothing. The same thing could be done in another way, not by note-issuing banks but by deposit banks.

Deposit bankers discovered that orders and checks drawn against deposits by depositors and given to third persons were often not cashed by the latter but were deposited to their own accounts. Thus there were no actual movements of funds, and payments were made simply by bookkeeping transactions on the accounts.

Accordingly, it was necessary for the banker to keep on hand in actual money (gold, certificates, and notes) no more than the fraction of deposits likely to be drawn upon and cashed; the rest could be used for loans, and if these loans were made by creating a deposit for the borrower, who in turn would draw checks upon it rather than withdraw it in money, such “created deposits” or loans could also be covered adequately by retaining reserves to only a fraction of their value.

Such created deposits also were a creation of money out of nothing, although bankers usually refused to express their actions, either note issuing or deposit lending, in these terms. William Paterson, however, on obtaining the charter of the Bank of England in 1694, to use the moneys he had won in privateering, said, “The Bank hath benefit of interest on all moneys which it creates out of nothing.” This was repeated by Sir Edward Holden, founder of the Midland Bank, on December 18, 1907, and is, of course, generally admitted today. [10]

It was no accident, either, that King William III (1650-1702), had become embroiled in costly wars against Catholic France and plunged England into debt. As a result, a powerful clique of Jews in Amsterdam persuaded the Treasury

to borrow £1.25 million from the Jewish bankers who had helped him to the throne. William’s huge debts were continuing to mount and the government had no choice but to accept. However, the names of the lenders were to be kept secret and they would be granted a Charter to establish a Central Bank of England. Consequently, Parliament accepted these recommendations and the Jews now controlled the British economy.

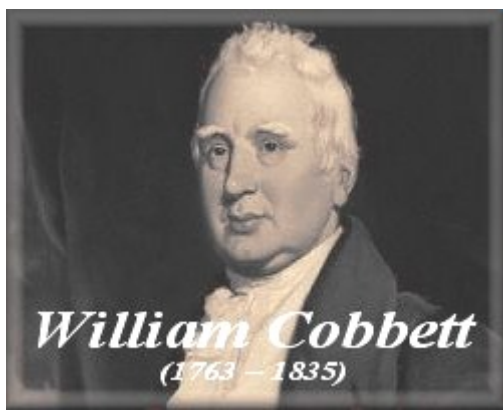


In 1714, John Toland (1670-1722) – a leading rationalist philosopher and freethinker – argued that Jews should be naturalised and permitted to seek employment both with the State and in the handicrafts, farming and building industries, something which might deter them from their usurious practices. In 1753, the so-called ‘Jew Bill’ or Jewish Naturalisation Act was forced through parliament and enabled a minority of Jews to become completely naturalised after a period of three years.

The fact that the bill only related to wealthy Jews tells us something about the true motives that lay behind this politically-charged decision.

In 1760, George III (1738-1820) came to the throne and a council of powerful Jews was established to pledge their allegiance to the British monarchy. The council, known as the London Committee of Deputies of British Jews, still exists today and has performed a major role in concealing the nefarious activities of Organised Jewry across three centuries.

By 1835 the Committee and its President, Sir Moses Haim Montefiore (1784-1885), had become extremely powerful and drew up a Constitution in which he and his cohorts expressed their commitment to advance “the interests of the Jews of Britain.” Montefiore, who was an immensely powerful banker and financier, was later honoured by Queen Victoria (1819-1901) and given his own coat of arms in the wake of his attempt to defend ten Jews in Damascus who had ritually murdered a Catholic monk and his servant in 1840. As always, and despite much evidence to the contrary, modern historians dismiss all such claims as ‘blood libel’ and ‘patent nonsense’.



Some time earlier, in 1833, Lord Macaulay (1800-1859) – an historian and leading Whig politician – campaigned to have the Jews admitted to Parliament, despite the fact that the MP for Oldham and fierce anti-usury campaigner, William Cobbett (1763-1835), had described the Jews as a mean race, a sordid race, a money-getting race; that they are averse to all honourable callings; that they neither sow nor reap; that they have neither flocks nor herds; that usury is the only pursuit for which they are fit; that they are destitute of all elevated and amiable sentiments. [11]

To a large extent Cobbett, a champion of the people and a leading proponent of the English Radical tradition, was correct in his analysis and, not content with their economic domination, a minority of the wealthiest and most influential Jews were now seeking to gain political, power.

At the same time, and as we shall discover in a subsequent chapter, one of the world’s most notorious Jewish banking families was

embarking upon its own unconscionable rise to prominence.

Occult Ritual Transformation and Corona Virus: How Mask Wearing, Hand Washing, "Social Separation" and Lock-downs Are Age-Old Occult

And quite frankly, many Christian churches have been infiltrated by practitioners of Kabbalah, which is a book of Jewish mysticism, magick spells, enchantments, man-made numerology and other esoteric and occult practices that the orthodox rabbis use in the course of their daily lives, and now teach Christian leaders to use, as well. So, with so many of the world's "top tier" leaders pushing occultism – including those **enemies of Christ who run the four hidden dynasties of politics, education, economics and religion**— it should come as no surprise to you that the **entire global corona virus crisis is replete with occult symbology and ritual occult initiation themes.**

Indeed, as you'll see throughout the rest of this commentary, the entire manufactured corona virus crisis is one giant, occult ritual from start to finish, divided up into four mini-rituals, each with the distinct occult purpose of initiation and transformation of the world and its people into a new global order.

So, let's start by examining the four distinct, but interrelated, occult rituals that make up this massive global occult ritual initiation ceremony

1. **Ritual Mask-Wearing**
2. **Ritual Hand-Washing**
3. **Ritual "Social Distancing"**
4. **Ritual Lock-downs**

In the course of examining these four occult rituals, I'll do my best to explain to you how

each one is part of an elaborate stage play designed to symbolically initiate the people of this world into their new positions in a new global order – a new order that rejects Jesus Christ and Christianity, and puts the people of



this world under the ultimate control of a global elite whose god is the devil himself.

The Ritual Wearing of the Mask

Have you ever wondered why, in Revelation 17:5, Babylon is called “Mystery, Babylon”?

You already know that the word “Babylon” means “confusion.” But what does the word “mystery” mean? Here’s what the Strong’s Concordance tells us: **G3466 *Musterion*** — From a derivative of *muo* (to shut the mouth); a secret or “mystery” (through the idea of silence imposed by initiation into religious rites)—mystery.

Don’t overlook that. **The word “mystery” in the Bible has to do with shutting the mouth as one undergoes a secret religious initiation. Again, it’s: “the idea of silence, imposed by initiation into religious rites.”**

Isn’t that interesting?

After all, at this point in time, **30 countries**, including the United States, **are now forcing their citizens to wear face masks over their mouths** on a mandatory basis, ostensibly to help stop corona virus infections.

This, even though numerous medical experts, including the **Surgeon General of the United States**, have openly stated that **wearing masks has no beneficial effect whatsoever against corona virus.**

What’s more, numerous medical experts have attested to the fact that face masks can even be dangerous to one’s health in that they curtail clear thinking (and even

consciousness) by trapping carbon dioxide in the chamber of the mask, **forcing you to re-breathe it over and over, thus depleting your blood of fresh air and the life-giving oxygen component it contains.**

So why are the powers-that-be, globally, forcing their citizens to wear these face masks, if the masks simply don’t work against corona virus, and might very well be dangerous to your health? The answer might surprise you:

Masking Has Traditionally Played a Very Important Role in Occult Rituals.

Among other things, **the wearing of the mask over one’s mouth is a token of submission...**a gesture of your willingness to be subject to others who are not your usual Sovereign.

But there’s more. According to the *Encyclopaedia Britannica*, mask-wearing is:

“A form of disguise or concealment usually worn over or in front of the face to hide the identity of a person and by its own features to establish another being.”

In other words, **the wearing of a mask represents an occult transformation—** a human alchemy, if you will — from one role to another. From one manner of being, to another. Indeed, in this case, **from individual sovereign under God to collective subject under the children of the devil.**

You see, **the masking ritual is specifically designed to reverse the order of hierarchy set in place by God Himself.** In the hierarchy of your heavenly Father, you are a sovereign representative of His Word on this earth. And your job is to speak His Word, on His Sovereign behalf to others.

In other words, **He’s the King, you’re a Prince of His kingdom,** and your job is to carry His Word to others, so they too can get on board with it and return to the Father eternally, through Jesus Christ. As it’s written regarding our primary duty as Christians:

II Timothy 4:2 — Preach the word; be instant in season, out of season; reprove, rebuke, exhort with all long suffering and doctrine.

In short, your job is to teach your Father's Word. And you must be ready and willing to do so at all times (i.e., "be instant, in season and out of season").

As such, **you must always remain unmasked**, because your job — in your earthly role as one of His faithful representatives — is to speak and explain His Word to others. And to do so, **you must open your mouth. You cannot be muzzled. You cannot be masked.**

Wearing the mask is a powerful occult symbol indicating your submission to another power other than the Creator God who gave you the direct commission to preach His Word to the world:

Matthew 28:18 And Jesus came and spake unto them, saying, All power is given unto me in heaven and in earth.

Matthew 28:19 Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost:

Matthew 28:20 Teaching them to observe all things whatsoever I have commanded you: and, lo, I am with you always, even unto the end of the world. Amen.

So, in God's hierarchy, you're a sovereign representative of His Word on this earth. And **your job is to spread that Word to as many others as possible in the course of your adult lifetime.** But in the hierarchy of the ritualists,



it's quite the reverse:

The entire point of occult ritual mask-wearing is to hammer home to your sub-

consciousness — until it becomes completely true in your daily life — the idea that things are no longer the same, and will never be the same again.

Masks hasten the suppression of ego to help facilitate the death of the old identity before the identification with, and the manifestation of, a new identity.

It's an initiation into a new order. But it's also a **transformation of the self into a new position in that new order.**

Under the sway of the occult ritualist, you, being mouth-masked, are no longer the person you used to be. **You're no longer a designated mouthpiece of God on this earth.** You're suddenly demoted and **re-assigned to the position of obedient subject.**

Symbolically, **you become a serf in the new order.** That's your new role...your new identity... as represented by the wearing of mask.

The wearing of the mask is simply part of the initiation ritual used to visually and psychologically signal your consent to this new arrangement. Yes, by wearing the mask, **you're signalling your consent to accept a new and very different position in a new global order.**

Instead of being a sovereign representative of the Most High God and His Word on this earth, in essence, **you agree to become a willing subject — a slave—** to the very enemies of God and His Christ. Masked, you're now **willingly serving the enemy's purposes**, and no longer God's.

When you obediently put the mask over your mouth, you're symbolically saying to the ritualists, "I admit my words no longer have any purpose or relevance in this life. My sole purpose now is obedience to your words and commands."

And in raising themselves to the position of your new sovereign, and **muzzling you like a dog** in the process, **they alchemically create a new you in a new role under new rulers.** That's the alchemical transformational change involved in the ritual.

They're quite literally attempting to take the place of God in your life, and make you their willing subject. They're **becoming your instead-of-Christ. Your antichrist.** And by placing the mask on your face, you're becoming their unwitting faithful servant. You're being ritually initiated into the new order. You may not realize it. **But in occult magic, the victim doesn't have to be knowledgeable of the meaning behind what he or she is being told to do.** The performance of the ritual itself – on demand — is all that matters.

So, who, exactly, is doing this to us?

1 John 2:18 — Little children, it is the last time: and as ye have heard that antichrist shall come, **even now are there many antichrists**; whereby we know that it is the last time.

You didn't think these "many antichrists" would sit around on their hands all day, doing nothing, in the final days of this flesh earth age while they're waiting on the return of their father the devil in his role as the false messiah, did you?

Naturally, they're softening things up for their god – Satan — before he gets here. They're using ceremonial occult ritual magic, on a global scale, to capture the entire world in their dragnet.

By wearing the mask, **you're being symbolically and alchemically transformed — "reborn"**— into their new global system, through occult ritual programming.

More from the Encyclopaedia Britannica on ritual mask-wearing:

"The person who wears the mask is also considered to be in direct association with the mask's spirit force and is consequently exposed to like personal danger of being affected by it...**Upon donning the mask, the wearer sometimes undergoes a psychic**

change, and, as in a trance, assumes the spirit character depicted by the mask."

Well, folks, the antichrist – the instead-of-Christ — is the "spirit force" of the mask we're talking about. You get that, don't you? He's the spirit behind the powers-that-be who are working to pull off this global coup.

And it's the powers-that-be who have **masked, muzzled and demoted you to your new status of slave**, on the behalf of their god, the devil himself.

The mask-wearing ritual is designed to possess you with the spirit of subservience to your new overlords, who are the "many antichrists" of **1 John 2:18.**

And it sets you up to do the same when the antichrist arrives and offers his actual "mark," which we'll examine at the end of this commentary.

If you don't think wearing the mask quite literally changes people, as the Encyclopaedia Britannica states in the quote above,

think about all of the masked "Karens" you've seen online videos of, wildly chasing people who aren't wearing masks down the road, publicly berating them for not wearing masks, and screaming at them that there's "blood on their hands" for not masking up like good little boys and girls always should.

Here's one, for example, in which the "Karens" are all big, burly, mask-wearing males, quite literally shoving an elderly gentleman out of a store for not wearing a mask:

Through the wearing of the mask, the occult ritualists have created an army of "Karens" —**programmed automatons who take the ritual so seriously that they feel personally and physically threatened when you don't.** And they don't mind telling you so. Often vigorously.



The Encyclopaedia Britannica goes on to say about the masking ritual:

“Usually, however, **the wearer skilfully becomes a ‘partner’ of the character he is impersonating**, giving to the mask not only an important spark of vitality by the light flashing from his own eyes **but also bringing it alive by his movements and poses.**”

In other words, in the end, the mask becomes part of the very identity of those who wear it. The occult transition becomes complete. The “new you” is born from the ritual.



The Encyclopaedia Britannica further states:

“But often the wearer [of the mask] seems to become **psychologically one with the character he is helping to create. He seems to become an automaton, without his own will, which has become subservient to that of the personage of the mask.**”

You might want to think about those dozens of online videos showing fully-masked hospital nurses and hospital workers participating in elaborately choreographed Tik-Tok dance videos, while simultaneously thousands of hapless coronavirus victims are supposedly dying cruel deaths and being stacked up like cord wood in those very same hospitals.

Yes, **a veritable masked dance of death**, just like you see in the movies. And we all know who Mr. Death is, don't we?

Revelation 6:8 And I looked, and behold a pale horse: and his name that sat on him was Death, and Hell followed with him. And power was given unto them over the fourth part of the earth, to kill with sword, and with hunger, and with death, and with the beasts of the earth.

What's more, **by adding dance to the mask-wearing, the new slaves show their willingness to entertain their captors**— to become little more than flesh play-sports to them — just as the Babylonian soldiers of old tried to force the Israelite captives to entertain them with music. As it's written:

Psalm 137:1 By the rivers of Babylon, there we sat down, yea, we wept, when we remembered Zion.

Psalm 137:2 We hanged our harps upon the willows in the midst thereof.

Psalm 137:3 For there they that carried us away captive required of us a song; and they that wasted us required of us mirth, saying, Sing us one of the songs of Zion.

Psalm 137:4 How shall we sing the Lord's song in a strange land?

As you can see, **the Israelites of old refused to entertain their captors...refused to provide the requested mirth... asking amongst themselves, “How can we sing the Lord's song in a strange land?”**

But unlike the time of the Babylon captivity, today's coup against God's People, and today's ongoing overthrow thereof, is, so far, being accomplished without conventional warfare.

So, **the people, by-and-large, don't even realize the depth and severity of the attempted coup against them, because it's being accomplished almost solely through occult ritual deception.** Which is why God's Word warns us that there will be times we can't even trust our own **neighbours.** As it's written:

Jeremiah 9:4 Take ye heed every one of his neighbour, and trust ye not in any brother: for every brother will utterly supplant, and every neighbour will walk with slanders.

Jeremiah 9:5 And they will deceive every one his neighbour, and will not speak the truth: they have taught their tongue to speak lies, and weary themselves to commit iniquity.

Jeremiah 9:6 Thine habitation is in the midst of deceit; through deceit they refuse to know me, saith the Lord.

First, the powers-that-be deceive your neighbours into putting on the mask. Then your neighbours, thinking they're doing right, work to push you into doing the same, using peer pressure and "virtue signalling."

And if you refuse to be deceived, as they are, they'll slander you, turn against you, and work to supplant you.

Does this sound at all familiar to you? Tell me again, **how many cities and states now have highly-publicized "snitch lines"** in which your

neighbours can call up and report you for not wearing a mask? One U.S. city alone is said to have registered an astonishing 200,000 "tip-off" calls on their snitch line in a single week.

Yes, it's just an updated version of what the book of Jeremiah tells us has happened before. **Neighbour being turned against neighbour.** In this case, over their failure to perform a prescribed ritual.

Like the old movie, **Invasion of the Body Snatchers**, your own neighbours end up as mind-controlled "pod people" who want nothing more than to drag you into the interconnected

pod hive with themselves and all of the other victims of mind-control, happily betraying you (and your God-given freedom and position) in the process.

But the mask-wearing has another occult meaning, as well, which we've only lightly touched on. As the **Coronacircus.com** website states about the wearing of the masks:

"To better understand the symbolism of wearing the mask, try typing the word 'censorship' into Google Images and see what kind of illustration predominantly comes up. Here's a sampling of what you'll find:



That's also why our figurehead leaders are ostensibly refusing to "mask up": We are the one's being gagged, not them.

A GAIN IT MUST BE REMEMBERED THAT TROY had a legend of its own which bore a strong resemblance to that of Crete. The story was that Neptune and Apollo appeared in -the guise of men before Laomedon, King of Troy, and luidcrtook, for an agreed price, to build a wall round the city. When the task was accomplished, Laomedon refused to pay them. Thereupon, Neptune sent a marine monster, which was wont to issue forth from the

water into the fields of Ilium, seizing and devouring the inhabitants. An oracle declared that in order to appease the angry god it was necessary for Laomedon to expose his daughter, Hesione, upon the shore, that the monster might devour her.

Hesione was accordingly taken forth, but Hercules came to her rescue and undertook to destroy the monster. In order to assist him in his enterprise, Minerva built for him a wall of earth, behind which he would retire "when the sea monster from the shore unto the plain would chase him" (see xx. II. 145; Deod. iv. 42; Apollod. ii. 5-9).

It is to this story that Shakespeare refers in The Merchant of Venice, Act III, Scene 2:

**“with much more love
Than young Alcides, when he did reduce
The virgin tribute paid by howling Troy
To the sea monster.”**

The Rev. R. L. Morgan, in his History of the Kymri, referring to Laomedon, says that in the reign of the latter “the citadel and walls of Troy were rebuilt by Belin and Lêv, architects of Crete, after the model of the Cretan labyrinth, which was also an exact representation of the stellar universe.” This interesting statement must not be omitted, although at present Science has neglected to prove its claims.



Reference is also made to the Walls of Troy by Lydgate in his Troy Book, where he speaks of Brutus, who won Britain from the giants. Chaucer, Caxton, Denham, Milton, all refer to the story of Brutus.

This legend is rather alluded to than related by Homer and other writers whose works have come down to us. It is taken for granted by authorities in classical literature that a more complete and detailed narrative than we possess existed and was familiar to the ancients. One wonders whether, if the full story were before us, we should find that the analogy to the Cretan legend was carried out and that Minerva’s walls were labyrinth in their form.

Even without this added circumstance is it possible that the charging and retreating, the chasing and eluding, which seem to have characterized the combat between Hercules and the Trojan monster, were sufficient to suggest the name of Troy Game as descriptive of the mock combat of the Roman youths? The game may have been designated without any special reference to the labyrinthine movements of which it consisted.

In London, in the days of Henry II, Fitz Stephen relates that Troy Game was played by the young men of the King’s household every Sunday in Lent, the King and his courtiers frequently being

present. Troy Game on horse-back continued to be played down to the Middle Ages and was probably the origin of jousts and tournaments, afterwards so popular. We have come across more than one reference to its having been played on Tothill Fields.

Mimic warfare between opposing companies of schoolboys might very naturally be named after the immortal combats that formed one of the principal subjects of their lessons. Even in modern English playgrounds the game of Greeks and Trojans still holds its place with French and English, and few among us realize that the game of Troy is still played in our streets under the name of “Hop Scotch.” Intricate lines are drawn on the pavement in chalk and competitors try to reach the goal by devious ways.

As to the origin of the word Maze, it is from a Kymric word maes, meaning greensward in the Cornish language=a field; the name seems to indicate that in some bygone age, the maze game was played on the greensward. We still use the word maze and amazement to express the bewilderment of one who knows not which way to turn.

But to return to the story of the Trojan prince, the founder of London.

Brutus died after a memorable reign of twenty-four years and was interred by the side of Imogene on the Bryn Gwyn (the White Mount). The genealogies record the names of the British kings, Brutus, descendants and successors, but it is not mentioned that any of these monarchs were buried on the Royal Gorsedd until Dunwal Molmutius in the fourth century B.C., whose history we shall learn later.

Brutus was succeeded in Lloegria by his eldest son Locrinus, in Albyn by his second son, Alban, and in Cambria by his youngest son, Camber. The portion of Britain assigned to Trœnius, the valiant companion of Brutus, was the Western Keryn, or promontory, extending from Torbay to the Land’s End, part of which is now known as Cornwall. From the Keryn, Trœnius changed his name into Keryn or Corincus.

The Dukedom of Cornwall thus founded was a Dukedom Royal, that is the Duke within it exercised the same prerogatives as the Kings of Lloegria, Cambria

and Albyn did within their territories. Next to these crowns, it is the oldest title in Britain. Spenser alludes to this naming of Cornwall in the *Faerie Queene*:

**“In meed of these great conquests by them
gott,
Corincus had that province utmost west
To him assigned for his worthy lott,
Which of his name and memorable gest,
He called Cornwaile.”**

The tradition that a race of giants dwelt in Cornwall, Drayton quaintly alludes to in his *Polyolbion*. After a terrible struggle, the Trojans got the upper hand and killed all their assailants, except the leader, Goemagot who was preserved for combat with Corineus, who, “holding it a diversion to encounter giants,” met him on a spot pointed out to this day on Plymouth Hoe.

Goemagot broke three of his opponent’s ribs and this so enraged Corineus that, taking the giant upon his shoulders, he ran with him to the shore and getting upon the top of a high rock, hurled the savage monster into the sea.

The struggle between these mighty men of valour was recorded as late as Queen Elizabeth’s time, by what Carew calls the “pourtradure of two men with clubbes in their hands cut in the turf, the one bigger, the other lesser, whom they term Gogmagog and Corineus, intimating the wrestling to have been between these two champions and the steep rocky cliff affording aptitude for such a cast.” Carew considers that the great activity of Devon and Cornishmen in the faculty of wrestling seems to “derive them a special pedigree from that grand wrestler Corineus.”

Spenser in his *Faerie Queene*, where he records the early history of Britain, refers to the conflict of Brutus and Corineus with the giants.

**“But ere he had established his throne
And spread the empire to the utmost shore,
He fought great battles, with his savage foes,
In which he defeated evermore,
And many giants left on groaning hore,
That well can witness yet unto this day.
The Western Hough, besprinkled with the
gore
Of mighty Goemagot, whom in stout play
Corineus conquered and cruelly did slay.”**



The Plymouth Corporation records confirm the re-cutting and renewal of these figures as early as 1494. It was only when the citadel was erected in 1671 that this interesting monument was destroyed. The story of Jack (above) the Giant Killer is said to have had its origin in the combat of Corineus with the Cornish giant and there seems little reason to doubt the tradition that the two gigantic figures in the Guildhall of the City of London, popularly called Gog and Magog, really present Corineus and Goemagot.

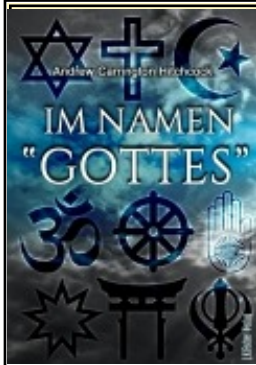

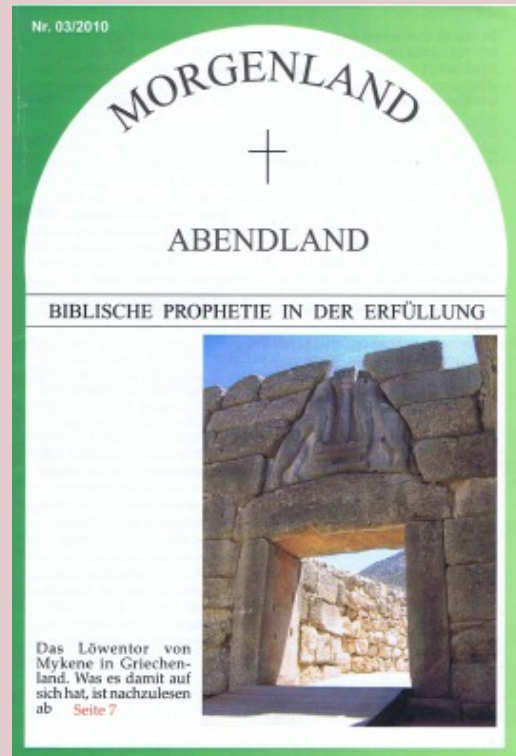
