# Arsenal Of Words (Part 18)

## A Demonstration of The Deceptive Use of Words

### By The Rabbis of Judaism

**26 AND SO ALL ISRAEL SHALL BE SAVED:** as it is written, There shall come out of Sion the Deliverer, and shall turn away ungodliness from Jacob: [Is there any hint of universalism here? He who delivers Jacob/Israel will judge the world.]

**27** For this is my covenant unto them, when I shall take away their sins. [Only Israel made a Covenant to obey the Law. Judeo-Christianity is, by default, outside of this Covenant, since it teaches the Law has been abolished. How can your sins be taken away if there is no sin? This is how everybody is "grafted into" "Spiritual Israel." The same condemnation goes for Judaism, since Judaism is the denial of the Mosaic Law.]

[Now, listen, Children of Israel, for this concerns the intra-racial dispute that is presently going between and among our own people:]

**28** As concerning the gospel, they are enemies for your sakes: but as touching the election, they are beloved for the father's sakes.

**29** For the gifts and calling of God are without repentance. [So, if Yahweh chooses to forgive the blindness of those Adamites who have become Christian Zionists, He will do so as He sees fit. It is His prerogative to forgive and heal. He does not punish the deceived as harshly as the deceivers, nor will He reward them as He will reward those who have obeyed His Law. In the meantime, this Cosmic Drama is being played out so that the Remnant will awaken.]

**30** For as ye in times past have not believed God, yet have now obtained mercy through their unbelief:

**31** Even so have these also now not believed, that through your mercy they also may obtain mercy. [By ministering to our unbelieving

brethren, we are attempting to awaken them and bring them back into the fold. This awakening will not happen through their own efforts. WE awakened Israelites must have a mindset of rescuing our sleeping brethren just as Jesus rescued us.

This is because our love for our brethren must be such that we will not give up on them. So, our motivation is LOVE, not hatred. Our motivation is TRUTH, not lies. This is the attitude we must have in order to rescue them out of their own stupor, ignorance and folly. This is what Yahshua did for those of us who are already awake. If we do not do this, then we are not loving or obeying HIM. We have to understand that their ignorance and unbelief are symptoms caused by false teachings.

The sheeple just don't know any better. They are not necessarily evil. They have been diverted from Yahweh's truth and are steeped in spiritual ignorance, so we just have to keep on working on behalf of our Caucasian brethren out of love for them, in spite of the fact that they hate us for what we teach!!! We will keep hammering away at the truth, so they do not die in their ignorance. This does not apply to people like John Hagee, though – even if he is White. He is a bona fide, conscious agent of Satan, a well-paid race-traitor, like Esau. He has sold his soul for the rewards of this world, the only world he really believes in. "Cast ye not pearls before swine."

{Commenting on Rom. 11:30-32, the Nations (Dispersed) are reconciled because the majority of Judeans had followed the Edomites rather than Christ, thereby creating the circumstances that the Edomites needed to kill Him. In other words, the deceived Judahite Judeans became the enablers of the Edomite Judeans. They set the stage for the Pharisees, who seized the opportunity! Interesting question: If all of Judea had believed and followed Christ, how would Redemption have come?}

[My own answer to this question is that Yahweh was using the unbelief of our own people as a

test of their understanding of the True Faith. Obviously, they failed this test. At the same time, the unbelief of these Judahites was seized upon by the Pharisees as the opportunity they needed to kill Him, for they feared the multitude as long as they followed Jesus! The fact that they were willing to do this proved their reprobate status. Recall the parable of the evil husbandmen (Matt. 21:33-41), who murdered the son of the householder, by which Yahshua prophesied that the Pharisees would murder the Son of God!!!



Just as Cain slew Abel, the Pharisees, his genetic descendants, demonstrated that their thirst for power and blood was still as strong as that of Cain himself. Hence, they had not changed one bit. Time and experience had not tempered their ambition one iota. Here, the Luciferian rebellion was shown to be still fully as strong as the day on which that archangel rebelled!! They were still rotten to the core! Thus, Yahweh "killed two birds with one stone," using both the Edomites and the unbelieving Judahites to demonstrate their character.]

**32** For God hath concluded them all in unbelief, that he might have mercy upon all. [The context is still Israel, and nobody else, so the word "all" means "all Israel," not "all the people of the earth."]

**33** O the depth of the riches both of the wisdom and knowledge of God! how unsearchable are his judgments, and his ways past finding out!

**34** For who hath known the mind of the Lord? or who hath been his counsellor?

**35** Or who hath first given to him, and it shall be recompensed unto him again?

**36** For of him, and through him, and to him, are all things: to whom be glory for ever. Amen.

Clearly, Paul is a humble and willing servant of Yahweh. Those who have trashed his ministry have been deceived by the false translations just as much as the Dispensationalists. There is no way that Paul was a universalist or a Dispensationalist. Just because the universalists CLAIM that Paul is their inspiration does not make that claim true.

{Since none of the Jews of today are true Israelites, all of them being mixed, none of them could be Paul's kinsmen, and so his discourse at Romans 11 cannot be applied to them. He is talking about Israelites, not Jews, as his kinsmen.}

### The Three Main Laws of Separation

Generally speaking, all of the laws that apply to Israel apply also to non-Israelites (the rest of the world). That is, we are not to lie, cheat, steal, murder, etc. In short, we are to obey the Ten Commandments and treat all beings with fairness, honesty, and guilelessness. Here, William Finck's translation of Col. 4:5-6 is relevant: "In reference to those outside, you walk in wisdom, buying the time, your speech always with goodwill, seasoned with salt. It is necessary for you to know in what manner to answer every single one."

Briefly put, we cannot deviate from ethical behaviour with respect to non-Israelites. Especially, we are not to act like the Jews, who arrogate unto themselves the "right" to mistreat non-Jews, even to the point of murdering non-Jews without incurring a Talmudic penalty. Of course, this is Satanism, plain and simple.

For True Israel, however, there are specific laws that tell us what NOT TO DO with respect to those who are not of our race.

The three basic, foundational laws of segregation are these:

**1.)** We are not to worship with non-Whites. Our Bible studies and religious fellowships are to remain exclusive and strictly segregated at all times. Non-Whites are not allowed. (See Deut. 7:4, Acts 2:42, I John 1:3-7)

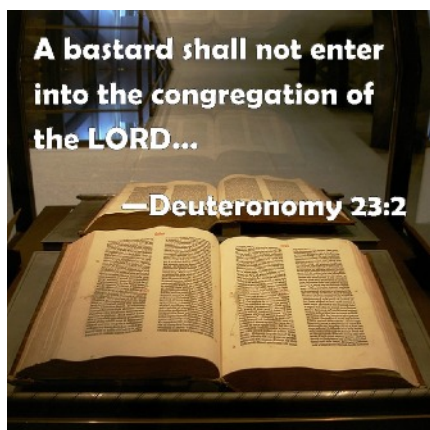
**2.)** We are not to break bread with non-Whites. (See Ex. 12:45, Acts 2:42.) This certainly applies to our meals taken at home and during Feasts

and family celebrations. When having meals at business, political or technical gatherings, this rule would be difficult to enforce, at least under the present political circumstances. The general "rule of thumb" is **No Social Fraternization**. Official business only, just like a chaperone at the prom!

3.) We are forbidden to engage in sexual relations or any form of intimacy with non-Whites.

Ezra 9:2: "For they have taken of their daughters for themselves, and for their sons: so that the holy seed have mingled themselves with the people of those lands: yea, the hand of the princes and rulers hath been chief in this trespass."

You should know that Adamic DNA is **Holy Seed**. It is forbidden for you to mix your Holy Seed with heathen seed. If the Jews practice the Law of Moses, why do they blatantly IGNORE Ezra 9:2 and Deut. 23:2?



**Deut. 23:2:** "No mongrel [mamzer] shall enter the congregation of Yahweh."

**I Kings 11:1-2:** "But King Solomon loved many **Strange Women**, together with the daughter of Pharaoh, women of the Moabites, Ammonites, Edomites, Zidonians, and Hittites; Of the nations concerning which Yahweh said unto the children of Israel, **Ye Shall Not Go into Them, Neither Shall They Come in Unto You....**"

(I'll bet your Judeo-Christian minister has never quoted this passage to you!)

**Jer. 2:21:** "Yet had I planted thee a noble vine, wholly a **Right Seed**: how then art thou turned

into the degenerate plant of a strange vine unto me?"

Yahweh considers race-mixing a **Degenerate Act**. Just think about the meaning of the word, degenerate, which implies genetic dissolution.

**Ezra 10:10-11:** "And Ezra the priest stood up, and said unto them, Ye have transgressed, and have taken **Strange Wives**, to increase the trespass of Israel. Now, therefore make confession unto Yahweh Elohim of your fathers, and do his pleasure: **and Separate Yourselves from the People of the Land, and from the Strange Wives.**"

**Ezra 9:12:** "Now therefore give not your daughters unto their sons, neither take their daughters unto your sons, nor seek their peace nor their wealth forever."

I guess the universalists don't know the meaning of the word, forever.

**Ezra 10:2-3:** "We have trespassed against our God, and have taken strange wives of the people of the land: yet now there is hope in Israel concerning this thing. Now therefore let us make a covenant with our God to put away all the wives, and such as are born of them, according to the counsel of my Lord, and of those that tremble at the commandment of our God; and let it be done according to the law."

You say, "I didn't know that race-mixing was against the law."

Don't you remember, "Thou shalt not commit adultery"? (Ex. 20:14.) To "adulterate" means to "pollute, defile," as in polluted water, or polluted seed. You wouldn't drink polluted water, would you? Why would you want to pollute your seed?

**Ezra 10:11:** "Now therefore make confession unto Yahweh Elohim of your fathers, and do his pleasure: and separate yourselves from the people of the land, and from the strange wives."

**Neh. 10:28:** "...they had separated themselves from the people of the lands unto the law of God...having knowledge, and having understanding."

**Neh. 10:30:** "And that we would not give our daughters unto the people of the land, nor take their daughters for our sons."

**Neh. 13:30:** "Thus cleansed I them of all strangers, and appointed the wards of the priests and the Levites, every one in his business."

For those outside of Christian Identity, such passages must come as quite a shock, for the message is quite clear: **Race-mixing Is a Violation of the Law of God.** Yahweh did not create the separate races so that we should mix them together. **His Order** is this: "Kind after kind" and "Like begets like." This is also the law of genetics.

Given this understanding, you should know that all of the passages that deal with the separateness of Israel include the prohibition against intermarriage. The Israelites are simply forbidden from mixing **Their Holy Seed** with that of the heathen. Period. This law has never changed. Nehemiah, Chapter 10 deals with this in great detail.

Paul's admonishment to the Corinthians concerning fornication (race-mixing) at I Cor. 10 is a direct reference to Numbers 25, which is therefore relevant to the New Testament! Numbers 25 tells the story of Phineas, the priest who executed an Israelite man and Midianite woman, while they were in the act, thrusting a single javelin through them both. This judgment was counted by Yahweh as a just punishment for the sin of race-mixing. In fact, the increasing level of whoring that was occurring at that particular time had caused a severe plague (venereal disease?) among the Israelites; and the instant that Phineas executed these two law-breakers, the plague was stopped. If you think I am making this up, read the account for yourself. Read it! Live it! Love it!

I am a Christian Identity minister. I do not expect you to take my word for it, like the dogmatic, "faith only" priests of the other denominations do. Furthermore, I encourage your questions, and even your skepticism, for I am always learning from Scripture. Sincere people write to me and inform me of mistakes I have made; and I have been corrected by them about Scripture, because nobody knows it all. Therefore, I will NEVER SAY, "Just believe"! A Christian Identity minister, like any minister, should be an authority, but not an authoritarian. A servant must remain humble. True Christianity is a religion of service and Scriptural knowledge, not a religion of pomp and dogma.

At all times, we are to maintain in our consciousness the fact that we are Yahweh's Covenant People and that Yahweh has ordered us to remain separate and aloof from the other races, as the numerous Biblical citations adduced herein have shown. If we are forced into their company because of work, business, politics, etc. (i.e., official business), then we are to be cordial and respectful towards them; but we have no obligation to treat them as our own racial family (kind). This we are strictly forbidden to do.

Moreover, we are **NEVER** to have non-Israelites ruling over us.

"...thou mayest **NOT** set a **Stranger over Thee, Who Is Not Thy Brother.**" (Deut. 17:15.)



Of course, if we are not race-mixing to begin with, this can never happen. Nor should our leaders be other than well-versed in the Holy Scriptures. Verses 16-20, of Deut. 17, authorize and command us to appoint God-fearing, law-abiding men only, not Scripture-denying atheists or liberals, even if they are of our own Race.

The fact is that, throughout history, the various races have always instinctively separated themselves from other cultures, following the natural law of "Kind after kind." (Gen. 1:11, 12, 21, 24, 25; 6:20; 7:14; and Lev. 19:19.) The history of America bears this out, as Blacks, Orientals, Hispanics, Jews and other distinct ethnicities have always remained within their own communities. Only until very recently (due to the onslaught of race-mixing propaganda by the Jewish media and the Judeo-Christian pulpitmasters), race-mixing was a universal taboo and rarely engaged in. Of course, the Ku Klux Klan assisted in enforcing Yahweh's Laws of segregation regionally here in America, but, even they couldn't stem the tide of demonic, Jew-engineered social change, that swept across the country during the turbulent 60's. At least they were following Yahweh's Law!!! Are you?

# Old Testament

## “Word for Word” Deuteronomy Part 11

### Translation by Stephen Howard Anderson



## Chapter 15

1. At the end of seven years you shall make a remission 8059 of debt.

2. And this is the manner of remission: every creditor 1167/4874/3027 that lends 5383 to another 7453 shall let it fall 8058; he shall not exact 3027 of your hand 5065 it of his neighbor, or his kindred 251; because it is called Yahweh's remission.

3. Of a racial alien 5237 you may exact it: but what is yours with your racial kindred your hand shall let fall;

4. Ceasing 657 when there shall be no poor 34 among you; because Yahweh shall greatly bless you in the land which Yahweh Eloheycha gives you as an inheritance 5159 to possess 3423.

5. Only if 518 you carefully listen to the voice of Yahweh Eloheycha, to observe 8104 and do 6213 all these commandments 4687 which I command 6680 you this day.

6. Because Yahweh Eloheycha blesses you, as He has spoken to you: and you shall take pledges from 5670 many, but you shall not give a pledge 5670; and you shall reign 4910

over many nations, but they shall not reign over you.

7. If there is among you a poor man 34 of your racial kindred within any of your gates in your land which Yahweh Eloheycha gives you, you shall not harden 553 your heart, nor shut 7092 your hand from your poor kinsman:

8. But you shall open 6605 your hand wide 6605 to him, and shall surely lend 5670/5670 him sufficient 1767 for his need 4270, what he lacks 2637.

9. Guard 8104 that there is not a wicked 1100 thought 1697 in your mind 3824, saying, "The seventh year, the year of remission is near," and your eye 5869 is evil 7489 against your poor kinsman, and you give him nothing; and he cries 7121 to Yahweh against you, and it is sin 2399 to you.

10. You shall surely give to him, and your heart shall not be grieved 7489 when you give to him: because for this thing shall bless you Yahweh Eloheycha in all your works, and in all that you put your hands to.

11. Because the poor shall never cease 2308 from within 7130 the land: therefore I command you, saying, "You shall open your hand wide to your kinsman, to your poor 6041 and to the needy 34 in your land.

12. And if your kinsman, an Ibriy 5880, or an Ibriyyah 5880, is sold 4376 to you, and serves you 5647 six years; then in the seventh year you shall let him go free 2670 from you.

13. And when you let him go free from you, you shall not let him go empty 7387 handed.

14. You shall supply him well 6059/6059 from your flock, and from your threshing floor, and from your winepress: by which Yahweh Eloheycha has blessed you, you shall give to him.

15. And you shall remember that you were slaves 5650 in the land of Mits'rayim, and Yahweh Eloheycha redeemed 6299 you: therefore I command you this thing this day.

16. And it shall be, if he says to you, "I will not go away from you; because he loves 157 you and your household, because he is well off 2895 with you:

17. then you shall take an awl 4836, and put 5414 it through his ear into the door 1817, and he shall be your slave 5650 forever. And also to your female servant 519 you shall do likewise.

18. It shall not seem hard 7185 in your eyes when you send him away from you; because he has been worth the wages 7939 of two 4932 hired servants 7916, in serving you six years: and Yahweh Eloheycha shall bless you in all you do.

19. All the firstborn 1060 males 2145 that are born of your herd and your flock you shall consecrate 6942 to Yahweh Eloheycha: you shall do no servile work 5647 with the firstborn of your cattle, nor shear 1494 the firstborn of your sheep.

20. You shall eat it before Yahweh Eloheycha year by year in the place which Yahweh shall choose, you, and your household.

21. And if there is any blemish 3971 in it, lame 6455, or blind 5787, or any ill 7451 blemish, you shall not slaughter 2076 it to Yahweh

Eloheycha.

22. You shall eat it within your gates: the unclean 2931 and the clean 2889 person alike, as the gazelle 6643 and the deer 354.

23. Only you shall not eat the blood of it: you shall pour it upon the ground as water.

## English Was Derived From The Ancient Hebrew By Willie Martin (Part 3)



### Section 4 Insects

**S**HALL WE NOW TAKE A GLANCE AT INSECTS? The spider in Hebrew is 'ECVIS. With the Chaldee R added, it becomes the French Ecrevisse; which we have turned into CRAYFISH. (Max Muller noticed the two cognate words in French and English, but not its Hebrew origin). Here is a curious change of meaning. The WASP takes its name from its sting. The Hebrew root is 'AZB, the meaning of which is "pain." The peculiar Hebrew letter with which it begins, is often

expressed in English by an initial W, as we have seen above in the case of WHELK. Hence, too, the Latin Vespa, 'a wasp.' The FLEA in Hebrew is FR'AS. But philologists are agreed, that the "L" and "R" are constantly interchanged. A lisping pronunciation of "R" makes "L." The "S" was dropped as being in our language a sign of the plural. Thence we have FLEA.

There is a singular worm which surrounds itself with stones and sticks, well known to anglers, and called the CADDIS-WORM. This name is derived from the Hebrew QuaDeSH, which signifies "Holy." Jerusalem in our day is called 'EL KUDS, "the Holy."

From this I should gather, that the creature was once regarded as holy. Nor would it be difficult to guess whence its title was derived. The English word BEETLE may be derived from the Hebrew FLAT, by transposition. It is the original of our words FLAT; PLATE; FLEET; FLOAT; FLIT; PETAL; and others.



The word **EMMET** takes its origin from the Hebrew 'EMiH, "to associate together," "a people" owing to the creature's social propensities. The English **MOTH** is derived from the Hebrew M'OT, "little," "small" -- whence also our "MOTE," and "MITE." The word **WORM** springs, I believe, from the Hebrew 'ORM, "to be naked," "to be slippery." Here again the peculiar letter with which the Hebrew word begins, is expressed in English by "W." Hence too the Latin Vermis and the Greek Helmins. The destructive **LOCUST** takes its name from the Hebrew LoQueSH, "to pluck," "to consume." The **GNAT** takes its name from NaD, "to fly."



Section 5: I will now give instances in which our names for members of the **VEGETABLE KINGDOM** are from the Hebrew. Let us notice first the word **Shrub**, which is derived from the Hebrew ZhRuB, signifying to be straitened; the **Shrub** being smaller than the tree.

The Latin word for **Leaf** is Folium; the Greek, Fullon; the French, Feuille. We have ourselves adopted the word **TRE-FOIL**, or "the three-leaved plant." This word is derived from the Hebrew 'OLI. The Hebrew letter Oin is very peculiar, and, when transferred into other languages, often takes before it what grammarians call "the digamma," or F, in place of aspiration. This, then, gives us the Latin Folium, together with the Greek and French forms.

**Leaf** is derived from the same letters transposed -- FOIL, Leaf. From the same root we may conclude that the word **Loaf** arises. The bread made in early times, and in eastern lands, was in the form of a broad thin cake, like Scotch oatmeal cakes. These cakes were stuck against the side of the oven, and so baked. From their thin leaf-like form came the word **Loaf**. This

gives us also, I believe, the derivation of the word **Bread**. It comes from **Broad**. In German, the word **Brod** signifies both **Loaf** and **Bread**. The botanic word **FronD**, taken from the Latin, is derived from the Hebrew FRoD, to spread; N being added, as frequently is the case, to strengthen the root.

The English **Berry** has its origin in the Hebrew PeRi, which means "Fruit in general." Our word **fruit**, in the French represented by the same letters, in Spanish Fruto; in the Italian, Frutto, is derived, through the Latin Fructus, from the Hebrew FRuCH, which means "to bud or blossom." The Greek Opora is evidently the offspring of the first of the two words. It signifies "tree fruits," as pears, apples, grapes and etc. Observe the "O" at the commencement; a not uncommon addition in Greek.

Our word **Branch** takes its rise from BRaCH, "to reach across -- a bar, a cross beam": N being added, as in former instances, to strengthen the root. **Bark** is derived from BOOK, "to roll round." The R is added by the Chaldee. Hence comes our **Book**, which was formerly a roll or scroll. **Sap** owes its origin to the Hebrew ZaB, "to flow;" **Gum** to the Hebrew GaM, "to join together." Hence the Greek 'Gamos,' marriage. The old English **Wort**; in German, WurZ; in Swedish, Ort; in French, Vert, verd; in Latin, Viridis, is derived from the Hebrew YROK, "to be green."

The first letter here is generally rendered into English by "W." Then the vowel "O" is taken out of its place in order to follow the "W."

Here is another example of a word of two syllables in Hebrew being shortened into one in English. The term "wort" is familiar to botanists, as forming an association with many names of plants. **Star-wort**, **mug-wort**, **spleen-wort**. The final K has apparently become T in English, to distinguish it from work. We could go on and on, but we believe this will suffice to prove that the English Language came from the Hebrew!

Pastor Curtis Clair Ewing, in a cassette tape lecture on this subject, destroys all their arguments with the facts of history. His lecture is titled **The Hebraic Origin of the English Language**, and the following are a few of his deductions:

First: If we can't be Israelites because we don't speak Hebrew, then the Jews can't be Israelites because they don't speak Hebrew either! Many ministers mistakenly think they do, but most European Jews speak Yiddish, which is a corrupted combination of Russian, Polish, and German. They do use the Hebrew alphabet, but that no more proves they are Hebrews than the Norwegian's use of the Roman alphabet proves they are Italians. The Jews in Palestine are attempting to teach Hebrew, but with little success.

Second: The argument that writing from left to right proves we are not Hebrews is specious. Some claim no nation ever changed its writing that way; but if they would took up the term "boustrophedon" in the Encyclopaedia or any large dictionary, they would find it means a style of writing where the lines alternate, right to left, then left to right, and that the Greeks used that style in ancient times, as did the Egyptians, and at one time, even the Irish and the Norsemen. Now they have all changed, although opponents of our Israel identity continue to insist no nation ever changed its style of writing!

Third: Most mistakenly believe there was only one Hebrew language, but there were three. The first was known as Sinai Hebrew; then came the Phoenician Hebrew; and then after the Babylonian Captivity, the Tribe of Judah used what is now called Assyrian Hebrew.

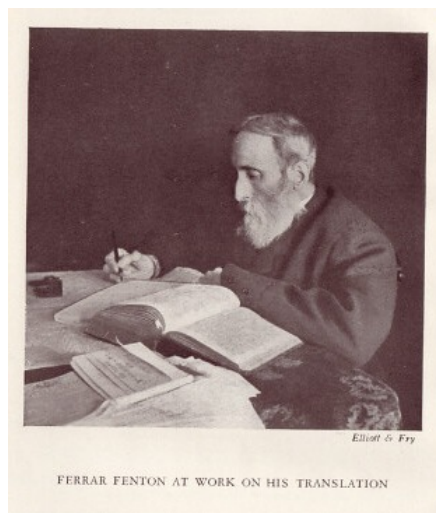
From early examples, it appears the earliest was written from left to right, and later from right to left! So, early in their Palestine sojourn, they changed their language and style of writing; and every Bible translator knows that at the time of Christ, the Israelites in Jerusalem spoke Aramaic, a third change in less than 2,000 years! To insist the English-speaking peoples cannot be Israelites because they do not speak the ancient Hebrew or write from right to left is an utterly nonsensical argument.

Finally: The English language is still similar enough to the ancient Hebrew that it must be the ancestor tongue of English! Here are a few testimonies given in Pastor Ewing's lecture:

Rev. Jacob Tomlin of England, in *A Comparative Vocabulary of 48 Languages*, wrote there was a close affinity between Hebrew and English, not only in words, but in the

arrangement of ideas and the structure of sentences.

William Tyndale, one of the great Reformers and a translator of the original Hebrew and Greek manuscripts into the English Language, said the Hebrew agreed more closely with the English than it did with the Latin.

Ferrar Fenton, who translated the Fenton Bible, once wrote a letter to the famous Professor Totten in which Fenton stated that while he was yet an unbeliever, his thorough studies of the ancient languages, including Hebrew, had convinced him the Welsh language was closely aligned with Hebrew and that the English-speaking peoples must be racially aligned with the Hebrews!

Pastor Ewing gave much more information to prove the amazing similarity between Hebrew and English and then concluded his lecture with the statement that since English was rapidly becoming the official trade and political language of all nations, the English language may well be the fulfilling of the promise of God to Israel in Zephaniah 3:9, For then will I turn to the people a pure language, that they may all call upon the name of the Lord, to serve Him with one consent.

# State Controlled Churches

## The 501c3 Deception

**C**HURCHES AND RELIGIOUS ORGANIZATIONS THAT ACCEPT GOVERNMENTAL AUTHORIZATION FOR FINANCIAL GAIN, for permission to assemble, etc., are then controlled by the state. They invariably become tools of the government, carrying out the agenda of rulers and spreading state propaganda. Church members themselves often demand their church obtain state recognition in order for their tithes and offerings to be deductible from their personal income tax reports.

The classification 501(c)(3) is a tax exempt status for religious or charitable organizations in the United States. While this article repeatedly refers to this particular classification, the warning crosses international boundaries. Any religious organization that is recognized as such by the national government comes under the control of that government. It is then an arm of the state and must comply with state policy or lose the desired recognition.

In August, 2007, KSLA News 12 out of Shreveport, Louisiana, reported on a shocking new tactic used by the United States government in its ongoing destruction of the U.S. Constitution. It was reported that the government had begun training pastors and religious leaders to influence the populace to comply with government demands, stating: "KSLA News 12 has discovered that [in the event of a disaster] the clergy would help the

government with potentially their biggest problem: Us."

The United States was founded with the deliberate intent of having a country without a king and ensuring the freedom to have a church without a pope. Consequently, the "separation of church and state" has long been a governing principle of laws and policy within the U.S. It is extremely portentous for the government to reach out to religious leaders in an attempt to control the citizenry. Revelation 13 warns of a despotic power that would seek to enforce its own agenda over the entire world:

And he had power to give life unto the image of the beast, that the image of the beast should both speak, and cause that as many as would not worship the image of the beast should be killed.

And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads:—

And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name. **(Revelation 13:15-17)**

It is deeply concerning that the U.S. is already preparing to use clergy to control the populace. Dr. Durell Tuberville is the chaplain for both the Shreveport Fire Department and the Caddo Sheriff's Office. When asked how clergy from differing denominations would work together for the government in times of crisis, Tuberville said:

"The primary thing that we say to anybody is, 'let's cooperate and get this thing over with and then we'll settle the differences once the crisis is over.'" Such emphasis on interdenominational uniformity and conformity to government agendas is a danger to individual churches that often have theological beliefs that are contradictory to morally liberal laws and corrupt politics.

People naturally look up to their religious leaders. It is deeply engrained in congregants to trust their pastor, priest or rabbi. Churches have always placed a high value on their unique, distinctive beliefs. It is a primary cause for why so many thousands of denominations exist within Christianity. But when religious leaders start promoting government agendas, differences are deliberately glossed over. Conformity, even at the cost of truth, becomes more important than religious individuality.



The argument religious leaders are told to present to their congregations, is based on an incorrect understanding of Romans 13: “Let everyone be subject to the governing authorities, for there is no authority except that which God has established. The authorities that exist have been established by God.” (Romans 13:1, New International Version).

According to Dave Hodges of The Common Sense Show, “an estimated 28,000 pastors were recruited by FEMA/DHS, as part of the Clergy Response Team, and—. . . their initial and primary training was to tell their flock to obey the DHS [Department of Homeland Security] version of Romans 13.” This incorrect understanding of Romans 13 silences pastors on important issues by arguing that because Yahuwah appointed the government, everything the government says or does should be supported.

The once separate churches of the United States have become joined to the government. They can now be forced to spread government propaganda – even that which conflicts with their denomination’s moral standards. In October, 2014, the city of Houston, Texas got court orders against five pastors who had encouraged their

church members to take political action against the Houston Equal Rights Ordinance.

This legislation granted civil protection to homosexuals, bisexuals, and trans-gender citizens. The court orders were extremely broad. They demanded all sermons, speeches, and correspondence (including private text messages) dealing with the legislation, the petition against it, homosexuality, gender issues and the Mayor, Annise Parker. These orders included not just material presented by the pastors, but included anything revised or approved by them or even in their possession.

Fox News reporter Todd Starnes observed there was a brewing “war over religious liberty in Houston, Texas.” In the same report, Starnes shared a comment posted by Parker on Twitter in which she declared that if the pastors preached on political topics, the city had every right to demand the release of all requested materials.

As horrifying as this sounds, Mayor Parker was correct if these pastors worked for churches that were incorporated as 501(c)(3) entities, which most churches are in the United States. The once great principle of “separation of church and state” has been destroyed. True religious liberty has been destroyed by one thing: money.

### **Creeping Governance**

Money is power. Christ recognized this when He stated: “No man can serve two masters: for either he shall hate the one, and love the other, or else he shall lean to the one, and despise the other. Ye cannot serve [Yahuwah] and riches.” (Matthew 6:24, 1599 Geneva Bible)

Churches have been beguiled and seduced into voluntarily submitting to governmental control. In 1954, then-Senator Lyndon B. Johnson offered tax exempt status to churches as a “favour.” All they had to do was fill out a government form, the 501(c)(3) form, declaring their organization to be a church.

It was a Trojan horse. By law, churches were tax exempt anyway! The Internal Revenue Service (IRS) is the agency that collects taxes for the federal government of the United States. One IRS agent, Peter Kershaw wrote: I am not the only IRS employee who’s wondered why churches go to the government and seek



permission to be exempted from a tax they didn't owe to begin with, and to seek a tax deductible status that they've always had anyway. Many of us have marvelled at how church leaders want to be regulated and controlled by an agency of government that most Americans have prayed would just get out of their lives. Churches are in an amazingly unique position, but they don't seem to know or appreciate the implications of what it would mean to be free of government control.

Tax exempt status has been the tempting whore to seduce churches into voluntarily giving the government control over what they can and cannot say.

In order to retain their official tax exempt status, churches cannot say certain things about the government or even teach certain things that are in conflict with government policy. If they do, their 501(c)(3) status can be revoked and their members will no longer be able to deduct their tithes and offerings from their personal income taxes.

This results in fewer contributions given to the support of the church. Religious organizations that accept licenses or some other form of recognition from the state or, as in the U.S., apply for 501(c)(3) status, willingly place themselves under the jurisdiction of the state. Accepting government recognition or 501(c)(3) status willingly surrenders to the state the right to dictate to the church what it can and cannot preach about.

Churches who refuse to conform to government requirements have their 501(c)(3) status revoked. Tax exempt status is of vital importance to church leaders because without it, most of their

members will no longer give money in support of the church.

An example of this occurred when the Congressional Black Caucus held a conference to give advice to black churches on how to deal with the rise in voter ID laws to aid in voting for Barack Obama, the United States' first black president. Congressman Emanuel Cleaver, President of the Congressional Black Caucus, spoke of the conference, explaining to an MSNBC news reporter:

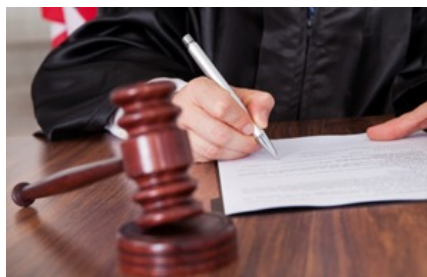
We'll have representatives from nine denominations who pastor somewhere in the neighbourhood of about 10 million people and we are going to, first of all, equip them with the information they need to know about what they can say and what they cannot say in the church that would violate their 501(c)(3) status with the IRS. In fact, we're going to have the IRS Administrator there, we're going to have the Attorney General, Eric Holder, there, we're going to have the lawyers organization from around the country there, the ACLU [American Civil Liberties Union] – all giving ministers guidance on what they can and cannot do.



When a government gives a license for anything, implied in that very act is the right of that government to remove the license and withdraw permission for whatever action is covered by that license. The power to bestow grants the power to remove. If a government does not give a license for something, it is understood that the individual does not need government permission for that activity and thus, the government does not have any authority in that area. It is wrong for a church to submit their theology or an individual his conscience to the government just to save money.

The apostle Paul warned against being unequally yoked with unbelievers.

Be ye not unequally yoked together with unbelievers: for what fellowship hath righteousness with unrighteousness? and what communion hath light with darkness? And what concord hath Christ with Belial? or what part hath he that believeth with an infidel? (2 Corinthians 6:14-15)



A religious organization becomes a corporate entity under the regulation of the government when it accepts 501(c)(3) status or by accepting state recognition as a licensed church. Accepting government recognition allows government intrusion that, invariably, ends up changing the policy of the church or organization accepting such recognition from the government. During the Cold War, church leaders in the Soviet Union and its satellites not only changed their teachings to not be offensive to the government, but also even went so far as to betray fellow Christians to the authorities. Nor did this end with the fall of the Iron Curtain. It continues to a greater or lesser degree wherever the state exercises control of the church.

The vast majority of denominational churches, religious organizations and charitable institutions in the United States are actually corporations holding 501(c)(3) tax exempt status. In **Amos 3:3**, Yahuwah asked, “Can two walk together except they be agreed?”

To submit to government oversight, is to submit to government control.

- 1. When a church accepts the 501c3 status, that church:**
- 2. Waives its freedom of speech.**
- 3. Waives its freedom of religion.**
- 4. Waives its right to influence legislators and the legislation they craft.**
- 5. Waives its constitutionally guaranteed rights.**
- 6. Is no longer free to speak to the vital issues of the day.**
- 7. Becomes controlled by a spirit of fear that if it doesn't toe the line with the IRS it will lose [revoke] its tax-exempt status. Becomes a State-Church.**
- 8.**

Such churches are no longer under the leadership of our Heavenly Father, but under a new master: the state. They take their direction and guidance from the state, not from the word of the Heavenly Father. Lest there be any doubt that the government's intended purpose is to exert control over the theology of the incorporated churches, one need only consider *Bob Jones University v. United States* (461 U.S. 574). In this ruling, the US Supreme Court revealed the government's intended purpose for the 501c3:

The Court asserts that an exempt organization (one that has become a 501c3) must “demonstrably serve and be in harmony with the public interest,” must have a purpose that comports with “the common community conscience,” and must not act in a manner “affirmatively at odds with the declared position of the whole Government.” Taken together, these passages suggest that **the primary function of a tax-exempt organization is to act on behalf of the Government in carrying out governmentally approved policies.**

### **Submission to the State for Monetary Gain**

**Churches value their official 501(c)(3) status more than the truth as presented in Scripture. If there were no other reason, this alone would be sufficient to identify these organizations as synagogues of Satan.** But there is more. When a church incorporates as a 501(c)(3) entity with the government, it agrees to be bound by all the rules and laws governing 501(c)(3) corporations!

A church which has filed a 501c3 application has agreed to forego its Constitutional right to practice religion without government interference.

—A church that has built boundaries around itself by 501c3 rules has consented to diminish [God's] law in favour of private civil law. For example, by agreeing not to speak out and

campaign against morally corrupt politicians. They do this in order to 'enjoy' an exemption from taxes to which they were immune in the first place——

It is for this reason that we have been urging all faithful believers to flee all organized religions. Regardless of the amount of truth that any individual church has, **it is truth that is mingled with error. God's true and faithful followers will have nothing to do with Babylon.**



It should not be assumed, however, that all of the blame lies with a handful of church leaders at the very top of each denomination. Individual church members are as guilty as the leaders because often it is the members themselves that pressure the leaders to incorporate as 501(c)(3) entities. Again, the motivation is purely financial. While churches may technically be tax exempt, the members' donations in tithes and offerings cannot be deducted from their personal income tax reports unless they can prove to the satisfaction of the IRS that their charitable donations were given to a legitimate church.

Although there is no requirement to do so, many churches seek recognition of exempt status from the IRS because such recognition assures church leaders, members and contributors that the church is recognized as exempt and qualifies for related tax benefits. For example, contributors to a church that has been recognized as tax-exempt would know that their contributions are tax-deductible.

Sadly, truth is sacrificed on the altar of personal gain.

This is a vital issue to the last generation. "For what shall it profit a man, if he shall gain the whole world, and lose his own soul? Or what shall a man give in exchange for his soul?"

(Mark 8:36, 37) All organized religions that have submitted to the government for financial gain or temporal security are a part of Babylon and will, in turn, become persecuting powers as depicted in prophecy. John the Revelator was shown a beast, ridden by a "great whore."

And the woman was arrayed in purple and scarlet colour, and decked with gold and precious stones and pearls, having a golden cup in her hand full of abominations and filthiness of her fornication:

And upon her forehead was a name written, Mystery, Babylon The Great, The Mother Of Harlots And Abominations Of The Earth.

And I saw the woman drunken with the blood of the saints, and with the blood of the martyrs of Christ. (Revelation 17:4-6)

"Fornication" is the joining together of that which is not lawful by the law of God. Religion in bed with government is fornication. God's people will not be members of any such organizations.

## The Thirteen Legendary Treasures of Britain

**T**HE ANCIENT GREEK WRITER HESIOD ONCE WROTE THAT THERE WERE FIVE AGES OF MANKIND – the Golden Age, the Silver Age, the Bronze Age, the Heroic Age, and the Iron Age. Similarly, in Hinduism, there are four different epochs – the Satya Yuga , Treta Yuga , Dwapar Yuga and Kali Yuga . In both Greek mythology and Hinduism, the ages preceding our present age is described as much more pleasant, with humanity experiencing deterioration over the ages.

Likewise, in early British legends, it is said that the British Isles were, in a bygone age, the home of gods and heroes. Although these figures no longer dwell on the British Isles, legends sprung up about the magical objects these beings left behind.

The ‘Thirteen Treasures of Britain’ are a group of magical items found in late medieval Welsh tradition. These precious relics are mentioned in 15 th and 16 th century manuscripts, such as the Welsh Arthurian tale of ‘Culhwch and Olwen’. The Thirteen Treasures are said to have been located in the north of the British Isles, i.e. northern England and Scotland.

One of the Welsh manuscript is in fact entitled ‘Tri Thlws ar Ddeg Ynys Prydain’, which has been translated into English as ‘The Names of the Thirteen Treasures of the Island of Britain, which were in the North’.

### 1. Dyrnwyn, gleddyf Rhydderch Hael (White-Hilt, the Sword of Rhydderch the Generous)



This peculiar sword belonged to Rhydderch Hael, a 7 th century ruler of Alt Clut, a Brittonic kingdom in what is now Strathclyde, Scotland. When the sword was drawn by a worthy man, it would burst into flames from its hilt to its



tip. Although Rhydderch was willing to lend his sword to anyone who asked for it, the recipients would reject it after learning of the sword’s strange quality.

### 2. Mwys Gwyddno Garanir (The Hamper of Gwyddno Long-Shank)



Gwyddno Long-Shank was the ruler of Canolbarth, a legendary sunken land off the coast of Wales (now Cardigan Bay), who possessed a magical hamper, a wicker basket that could multiply food. Known as the ‘basket of plenty’, food for one man would be placed into the hamper and then closed. When the basket was opened again, there would be enough food for a hundred men.

### 3. Korn Bran Galed o'r Gogledd (The Horn of Bran the Niggard from the North)



According to Welsh legend, this horn once belonged to Hercules, who acquired the object from the head of the centaur Nessus after he was slain by the hero. The horn was



able to grant whatever drink a user wished to find within it.

The Horn of Bran was said to provide its owner with whichever drink they wished. Bearded Pictish warrior from the Bullion Stone, Angus, now in the National Museum of Scotland. (Wikimedia Commons)

#### 4. Kar Morgan Mwynfawr (The Chariot of Morgan the Wealthy)



Morgan, the king of Glamorgan, was the grandson and probable successor of King Meurig, who ruled over the early Welsh kingdoms of Gwent and Glywysing sometime

between 400 and 600 AD. Morgan was said to have possessed a chariot that could travel quickly to any destination desired by its user.

#### 5. Kebystr Klydno Eiddin (The Halter of Clydno Eiddyn)



The fifth treasure was a halter fixed to a staple at the foot of the bed Clydno Eiddin, a ruler in the Hen Ogledd, the Brythonic-speaking area in what is now Northern England and southern Scotland during the Early Middle Ages. "Eiddyn" is the Brythonic name for Edinburgh,

implying a connection to that territory. According to legend, whatever horse Clydno wished for, it would appear in the halter.

The magical horse halter of Clydno Eiddyn would grant Clydno with any horse he wished for (Wikimedia Commons)

#### 6. Kyllell Llawfrodedd Farchog (The Knife of Llawfrodedd the Horseman)

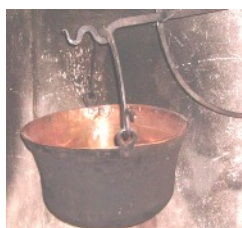


Llawfrodedd Farchog was a hero of Welsh tradition and a legendary figure in Arthur's court in the tales of Culhwch and

Olwen and Breuddwyd Rhonabwy. He is mentioned in Trioedd Tnys Prydein as the owner of a knife that would serve a company of 24 men at a dinner table, named as one of the Thirteen Treasures. The knife was great for a feast, but was also said to be a deadly weapon on the battlefield.

#### 7. Pair Dyrnwch Gawr (The Cauldron of Dyrnwch the Giant)



This cauldron, which belonged to the Welsh god Dyrnwch, would quickly boil meat placed in it by a brave man. The meat placed in it by a coward, however, will never boil. Thus, the

cauldron would reveal who was brave and who was cowardly.

#### 8. Hogalen Tudwal Tutklyd (The Whetstone of Tudwal Tudglyd)



Tudwal is thought to have been a ruler of Alt Clut, later known as Strathclyde, a Brittonic kingdom in the Hen Ogledd or "Old North" of Britain. He probably

ruled sometime in the mid-6th century. If a brave man sharpened his sword on his whetstone, a man whose blood was drawn from this sword would die. The whetstone would have no effect on the sword of a cowardly man.

The whetstone of Tudwal Tudglyd would imbue any sword sharpened on it with deathly qualities. (Wikimedia Commons)

#### 9. Pais Badarn Beisrydd (The Coat of Padarn of the Scarlet Robe)



Historical sources suggest Padarn Beisrydd ap Tegid was a Romano-British official of high rank who had been placed in command of Votadini troops stationed in Clackmannanshire in the 380s or earlier by the Emperor Magnus

Maximus. Alternatively, he may have been a frontier chieftain in the same region who was granted Roman military rank. His red coat, one of the Thirteen Treasures, was said to perfectly fit a well-born man, regardless of his size. It would not, however, fit a common person.

**10. and 11. Gren a desgyl Rhygenydd Ysgolhaig (The Crock and the Dish of Rhygenydd the Cleric)**



Whatever food a user wishes for, it would be found in the crock and dish.

**12. Gwyddbwyll Gwenddoleu ap Ceidio (The Chess board of Gwenddolau son of Ceidio)**



Gwenddoleu ap Ceidio or Gwenddolau was a 6th century Brythonic king

who ruled in Arfderydd (now Arthuret). This is in what is now south-west Scotland and north-west England in the area around Hadrian's Wall and Carlisle during the sub-Roman period in Britain. His chessboard of gold and silver was said to play any opponent on its own.

**13. Llen Arthyr yng Nghernyw (The Mantle of Arthur in Cornwall)**



King Arthur's llen or mantle is said to make anyone underneath it invisible, though able to see out. This item is known from two sources, the prose tales Culhwch and Olwen (c. 1100) and The Dream of Rhonabwy (early 13th century) Ultraviolet light reveals hidden text in ancient book of Arthurian stories

The Legendary Origins of Merlin the Magician  
In some lists, the crock and dish of Rhygenydd are regarded as a set, thus counting as one item. Additionally, one of the items on the original list would be replaced with either the Mantle of Tegau Eurfron 'Gold-Breast', or the Stone and Ring of Eluned the Fortunate, thus bringing the number of treasures back to thirteen.

In the Welsh legends, the Thirteen Treasures were eventually acquired by Myrddin (introduced into Arthurian legends as Merlin). The bearers of each treasure agreed to hand over their magical items to Myrddin if he succeeded in obtaining the Horn of Bran, which they thought impossible. Myrddin, however, got the horn from Bran, and with the other treasures, went into the Glass House / Tower, where they are said to remain until the return of King Arthur.

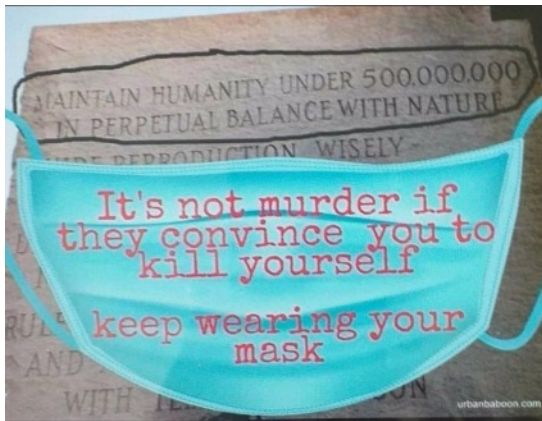

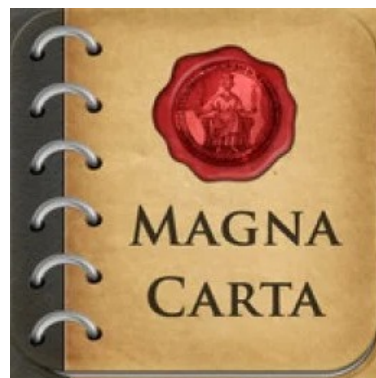

**Dissolved** is an imposter committing **Treason**. I await your **Crime Reference**. Do you deny that government was **Dissolved** Mr Trencher?

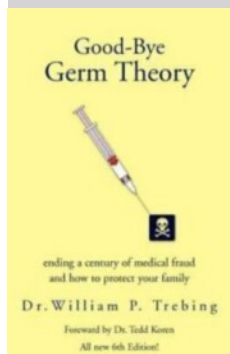

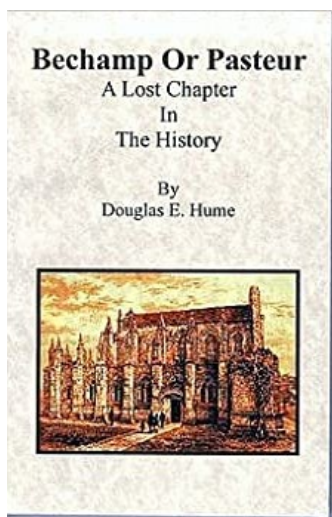

"In all that I have witnessed inside and outside of laboratories, there is only one cause of disease: Industrial pollution in medication, food, air, soil and water. Strengthening a body's constitution and lymphatic system is the first step to reversing/curing disease" - Aajonus Vonderplantz.

"Germs cannot be the cause of disease, because disease germs are also found in healthy bodies." -- NATURE CURE H. Lindlahr, M.D.

"What's happening is, like I said, we have colds, which are mainly bacterial, which go feed on toxic tissue that's been damaged – we don't eat well enough, we don't eat all raw and therefore we accumulate

toxicity. So bacteria have to come in and eat that waste product because we can't keep up with all the waste. OK. So that's what a cold is. Flu is mainly viral. Some bacteria may be active during flu. "Any kind of flu is the same thing. When the climate and temperature are right, certain tissues will cleanse. They may have a 7-years cycle. They may have a 6-months cycle. It depends upon the tissue and how contaminated it is. If certain tissue needs to cleanse every two years, our bodies will create, if waste tissue is too toxic for microbes, our bodies will create a solvent (a virus) that fractionates and cleanses that particular tissue every two years, every 6 months, every 3 months, every 7 years, every 12 years, depending upon that tissue and how contaminated it is. The myth that herpes is

contagious is pharmaceutical industry fiction to scare you into taking medication." - Aajonus Vonderplanitz

"Rudolph Virchow, a great German scientist, repudiated the germ theory of disease. He said that disease brought on germs rather than the germs caused disease. Claude Bernard, Bechamp and Tissot - great French scientists - all disproved the germ theory of disease. In Hans Selye's book Stress of Life (Page 205), an account is recorded that Louis Pasteur, inventor of the germ theory of disease, admitted he was wrong. Sanitation is the only factor that has reduced the spread of the old-time scourges. If the germ theory were founded on facts, there would be no living being to read what is here in written, for germs are ubiquitous - they exist everywhere. In many diseases supposedly caused by a specific germ, that germ is not present. Contrariwise, specific germs said to cause a specific disease are present in huge proportions without the specific disease manifesting itself.

## Earning the Wrath of God! By William T Boyd



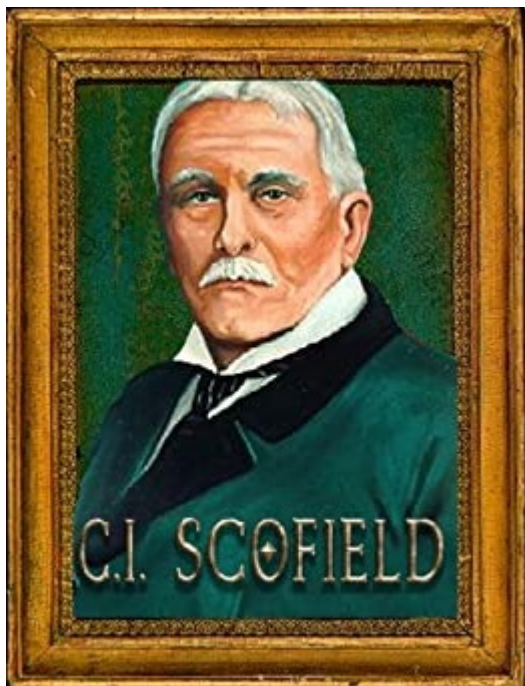

Now that really sounds like all we need to do is get humble and pray! But it’s not quite like that at all – one thing, that quote is taken out of context and it was addressed to a specific group of people in a talk God had with Solomon. Here is the entire monologue:

**11** Thus Solomon finished the house of the LORD, (the Solomon temple) and the king's house (Solomon’s castle) and all that came into

Solomon's heart to make in the house of the LORD, and in his own house, he prosperously effected.

**12** And the LORD appeared to Solomon by night, and said unto him, I have heard thy prayer, and have chosen this place to myself for an house of sacrifice.

**13** If I shut up heaven that there be no rain, or if I command the locusts to devour the land, or if I send pestilence among my people; (three conditional, hypothetical actions, then)

**14** If my people, (Israel) which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land.

**15** Now mine eyes shall be open, and mine ears attent (paying attention) unto the prayer that is made in this place. **16** For now have I chosen and sanctified this house, that my name may be there for ever: and mine eyes and mine heart shall be there perpetually.

You will note that The Lord God of Israel is saying that “my People” are to act in a certain manner if and when He sends upon them the drought, locusts and pestilence for their disobedience. He tells them that He will be “attent” (pay attention) to the prayer being made “in this place”, that is the “house of the Lord” referred to in v11.

Now, I am not saying that if America were to “humble themselves and pray and seek my face and turn from their wicked ways” God would ignore them, but it would be difficult to do those 4 things and retain the decadence permeating America today.

How long has it been since anyone has heard a sermon from an American pulpit praising Phinehas? We’re so concerned with “tolerance” and “diversity” that we ignore some very emphatic lessons put in the scripture for our edification. But, just to refresh your memory read Numbers 25:

**Numbers 25** (Note: This is after the Balaam/Balak attempts to curse Israel in Numbers 23 -24 where it was decided to use the women of Midian/Moab to destroy the Israelites)

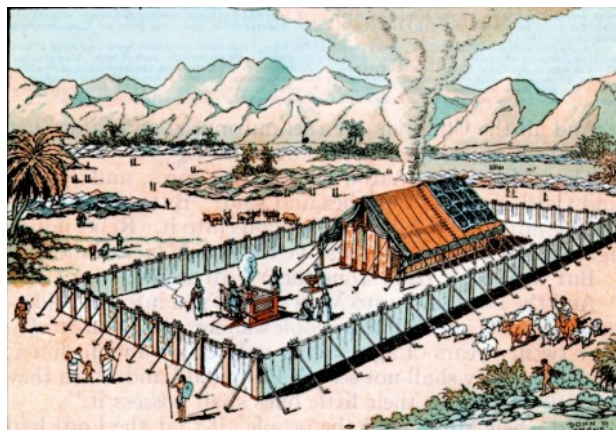
**1** And Israel abode in Shittim, and the people (Israel) began to commit whoredom with the daughters of Moab (miscegenation, one of the major sins of “horny” men of Israel through the ages!).

**2** And they called the people (Israel) unto the sacrifices of their gods: and the people (Israel) did eat, and bowed down to their (Moabite) gods.

**3** And Israel (the twelve tribes) joined himself unto Baalpeor: and the anger of the LORD was kindled against Israel.

**4** And the LORD said unto Moses, Take all the heads of the people (this means the leaders of the various houses within the Israelite congregation), and (actually, kill them and hang them up for an example to the others) hang them up before the LORD against the sun, that the fierce anger of the LORD may be turned away from Israel.

**5** And Moses said unto the judges of Israel, Slay ye every one his men that were joined unto Baalpeor.



**6** And, behold, one of the children of Israel came and brought unto his brethren a Midianitish woman in the sight of Moses, and in the sight of all the congregation of the children of Israel, who were weeping before the door of the tabernacle of the congregation. (this was a flagrant and “in your face” demonstration of violating the laws of the congregation for a forbidden sexual union with an outsider)

**7** And when Phinehas, the son of Eleazar, the son of Aaron the priest, saw it, he rose up from among the congregation, and took a javelin in his hand;

**8** And he went after the man of Israel into the tent, and thrust both of them through, the man of Israel, and the woman through her belly. (It appears that the decadence of the congregation had diminished to the point that Phinehas was the only man to rise up and take action against this ungodly act.) So the plague was stayed from the children of Israel.

**9** And those that died in the plague were twenty and four thousand. (For some reason, Paul recounts this as three and twenty thousand - 1st Corinthians 10:8 – don’t know why.)**10** And the LORD spake unto Moses, saying,

**11** Phinehas, the son of Eleazar, the son of Aaron the priest, hath turned my wrath away from the children of Israel, while he was zealous for my sake (and acted appropriately) among them, that I consumed not the children of Israel in my jealousy. (actually, anger)

**12** Wherefore say, Behold, I give unto him my covenant of peace:

**13** And he shall have it, and his seed after him, even the covenant of an everlasting priesthood; because he was zealous for his God, and made an atonement for the children of Israel.

**14** Now the name of the Israelite that was slain, even that was slain with the Midianitish woman, was Zimri, the son of Salu, a prince of a chief house among the Simeonites.

**15** And the name of the Midianitish woman that was slain was Cozbi, the daughter of Zur; he was head over a people, and of a chief house in Midian.

**16** And the LORD spake unto Moses, saying,

**17** Vex (discriminate against ) the Midianites, and smite them:

**18** For they vex you with their wiles, wherewith they have beguiled you in the matter of Peor, and in the matter of Cozbi, the daughter of a prince of Midian, their sister, which was slain in the day of the plague for Peor's sake.

(This is a profound command! Israel is to “vex and smite” the Midianites – this means to persecute and kill them!)

Few men in the scripture have ever been honoured by God as has Phinehas! Note in the emphasized parts above that God gave him a perpetual status of priesthood – that means that somewhere even today there is/are sons of Phinehas living, perhaps unknowing that they are, in a very unique position with the Lord God of Israel! Later, in Numbers

31 Moses and the Israelites are directed by their Lord God, to totally annihilate the Midianites. Unfortunately, the Israelite army does not complete the task and Moses and the Priestly leaders are angry about that. Read chapter 31 in its entirety to see how God handles “diversity” (miscegenation).

During the 17th and 18th centuries, the term “One Nation Under God” was applicable to the young nation of the USA. But over the years that has been rendered useless. At that time, it was a statement that the men creating and developing the new nation were aware of the relationship the nation had specifically with the Lord God of Israel.

Today we have scores of different “nations” all under their own gods having nothing to do with the Lord God of Israel. Although still insisting on being called a Christian nation, America is the home of all sorts of religions that are in direct opposition to true Christianity. A glimpse into the congregation on any given Sunday will reveal a high percentage of mixed-race couples and even of pastors not in compliance with the tenants of the bible. **ER Editor:** The highly informative comparison piece by the Gefira team, comparing the New Silk Road Project with the infamous TPP trade deal, makes some key takeaway points:

The TPP was designed to limit and override the sovereignty of participating nations in favour of US corporations; and to form a trade ‘club’ around China geographically without including it.

**EVERY STATE TRIES TO MAKE AS MUCH PROFIT AS POSSIBLE.** These come for the most part from taxes along with customs duties, which remain an important source of income.

Deals like the TPP deliberately disempower the state sector and state-run enterprises in participating countries.

The Obama administration, serving the neo-liberal US elites, forged a plan to encircle China in the Asia-Pacific region called TPP. The





**Transpacific Partnership** was designed to get China to open its market completely, to waive customs duties and to align its law with that of the US. The TPP has been

denounced by many of its critics, oddly enough mainly in Europe and in the United States, and not in China. Julian Assange's statement is perhaps best known: "If the treaty is adopted, the TPP's trademark regime will trample on human and civil rights."

**The TPP was in fact created to give US corporations a head start in Asia by limiting the sovereignty of participating countries.**

Trump, realizing that Democrats were on very thin ice with the project, cancelled the contract and began his trade war with-- tariffs, which brought considerable gains to the US budget. Both governments – Obama's and Trump's – realized and still pursue the same strategy by different means: America must countervail China's superpower. The strategy has failed.

**China's New Silk Road plan opposes American attempts to reduce Beijing's role in world trade.**

The TPP works even without the USA, and China is surrounded by the participating countries in the Pacific. Japan, Vietnam, Brunei, Malaysia and Singapore form a semicircle around the South China Sea, a sea that plays a key role for China in trade with the rest of the world. This is why the Chinese decided to shift trade to the railway – a bold, huge and risky project. Let's take a closer look at it.

The main difference between the New Silk Road and TPP is that it does *not force the countries of Asia and Europe to change their policies or laws*. The roads and railway lines to be built as part of the major Chinese project will benefit not only China but *also the countries where they will be constructed*.

**Even so, the Chinese can use the same method that Western countries are using everywhere in underdeveloped countries:** Beijing might, too, make countries dependent on Chinese companies (e.g. those that will maintain new infrastructure) through loans and dependence on

them. On the one hand, this will boost growth in the countries along the New Silk Road, while on the other, they could easily fall into **Beijing's debt trap**. By the way, Beijing has already taken over a large port in Sri Lanka and is slowly buying up Pakistan.

The TPP forces countries to **limit the role of the state sector and the state in the economy**, which is not the case with the New Silk Road initiative: it respects the authoritarian governments of Central Asia and focuses on **cooperation with state enterprises**.

In addition, the TPP focuses on agriculture, intellectual property rights, environmental protection and high-tech industries, in other words, areas where the US is a leader and where it would like to export its know-how for a fee and without customs duties. The New Silk Road, on the other hand, focuses on what the underdeveloped countries of Asia lack most: **infrastructure and the creation of a large energy supply network** that could prevent eternal blackouts (see the example of Pakistan, where the Chinese are building coal-fired power plants) and **boost industrial development**.

Great Britain, the Netherlands, Spain, France, Portugal and latterly the USA have built up their power through maritime trade. Three or two hundred years ago, in the agricultural era and later in the early industrial era, it didn't matter whether you had to wait one or two months for a commodity. Today, the ever faster flow of information has increased the need for fast transport. In the IT era, we want to have everything immediately. Maritime trade became too slow for the consumer society.

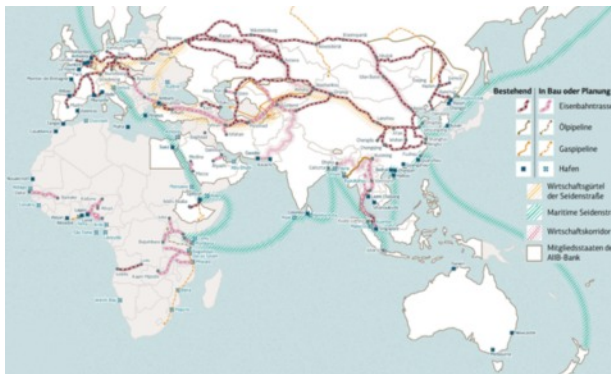
The days of air freight are also numbered in view of the climate targets of Western governments. **The governments of Western Europe will have to rely on the connection to the Chinese express train network**, also because of the green agenda.

Within the framework of the New Silk Road, Beijing is planning three main train routes:-

1. from Manchuria to Western Europe via Russia, Belarus, Poland;
2. from Xinjiang in northwest China via the Central Asian countries, Iran, Turkey to Europe;

3. from the Chinese city of Kunming directly to Singapore.

With an average transit time of 16-20 days, train transport between China and Europe is now 15-20 days faster than ocean freight. There are connections between China and Germany which are even faster (e.g. 11 days). Of course, the fastest way is by air, but the volume and weight are very limited there so that the freight does not become too expensive. Therefore, rail freight is expected to have an average cost advantage of at least 80 percent compared to air freight.



However, Beijing is planning to build a network of super-fast trains with the aim of reaching Shenzhen from Western Europe within **48 hours**. In his book "*Currency Wars 5*", the Chinese financial expert and bestselling author Song Hongbing calculated in 2015 that the three train routes mentioned, with a total length of more than 30,000 km, would cost around 650 billion dollars. Apart from the possible un-profitability of the whole undertaking, there are other risks:

1. **Technical problems.** China has great experience in building fast passenger trains, but in order to become competitive with sea transport, trains would have to be able to transport **large loads through different climatic zones** at lightning speed.

2. **Infrastructure safety** in many regions of Asia. In Pakistan, for example, the power of the government does not extend to every corner of the country.

3. **Different track width** in the countries of the former Soviet Union and in Europe is not a technical obstacle that can be easily overcome. It is a kind of military protection. Trans-shipment costs time and money.

4. **Non-standardised** customs clearance, bills of lading, communication systems.

5. **Currency.** Will all countries be ready to settle trade via the New Silk Road in the **yuan**?

6. **Power supply.** Parallel to the rail network, enough **electricity** would have to be provided for the energy-consuming express trains.

**We believe that the New Silk Road will be built and operated despite all these potential problems. History and politics provide arguments for this.**

Remember the **Marshall Plan**. It seemed to be unfavourable for America; it cost the US budget an insane amount of money for a prolonged period. Yet, after World War II, it forced Western European countries to use the dollar for trade. The dollarisation of Europe (it also involved the purchase of US government bonds) took a very long time, until the 2000 introduction of the euro. Now China can "**yuanise**" **Euro-Asia** to consolidate its position as a superpower. The flooding of the world with the yuan will certainly bring dividends.

**A Eurasia united by a common energy and rail system, with the yuan as its lead currency, is Washington's nightmare.** America would then be like an island on the edge of the largest continent where most of the world's people live. [Source.](#)

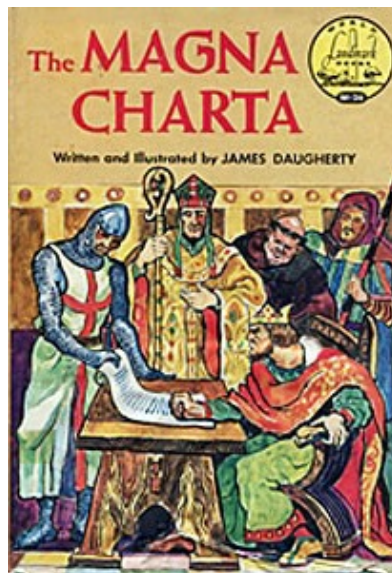


# Covid 1984 - Magna Carta 2020 – Declaration of Rights Posted By Kate, UK.

## Magna Carta 2020 – Declaration of Rights

**L**ET IT BE KNOWN BY ALL CONCERNED, interested and affected parties, that the following declaration is made by and for the Sovereign People of Britain [the People], in the absence of a legitimate Parliamentary democracy or lawful governance, following the constitutionally repugnant subjugation of the People to the dictates of unaccountable government, in accordance with a demonstrably fraudulent and genocidal agenda. Wherefore, given that since the enactment of the European Communities Act 1972, the UK Parliament has committed the following Common Law wrongdoings against the People:

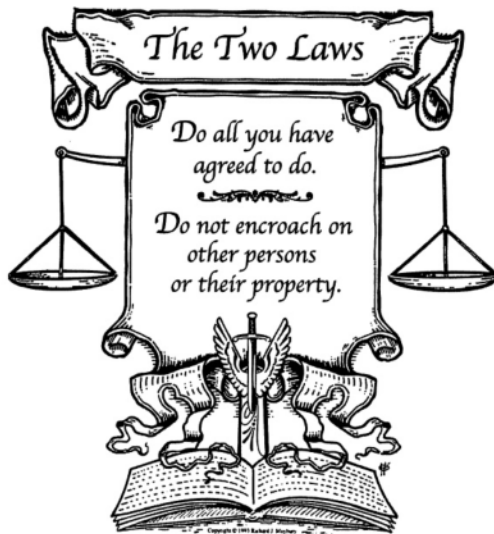
1. Unconstitutionally ceded British Sovereignty to the European Union [a foreign power].

4. Disgracefully enabled private banking interests to dictate government policy, monopolise industries and control natural resources.
5. Dishonourably allowed those private banking interests to perpetuate institutionalised signature forgery and banking fraud on an industrial scale.
6. Facilitated the enforcement of millions of fraudulent mortgage possession claims by forbidding a complicit judiciary from ruling fraud against any UK bank or making any serving MP bankrupt.



7. Caused the frequently brutal and violent unlawful evictions of more than 3 million people over the last three decades alone, often with the assistance of the police.
8. Constructed a total surveillance state which prevents the enjoyment of a private family life.
9. Licensed the poisoning of the air, water and food supplies, as well as caused the destruction of the farming, fishing and manufacturing industries.
10. Conspired with foreign powers to implement the genocidal United Nations agendas 21 and 30 at a local government level, under the guise of ‘Sustainable Development Goals’.
11. Waged illegal wars against other sovereign nations of people, causing millions of men, women and children to die through no fault of their own.
12. Committed treason felony against the monarch, by way of section 38 of the European Union (Withdrawal Agreement) Act 2020, which implicitly deposed Q E II of the crown by declaring Parliament to be sovereign.
13. Committed treason felony against the monarch, by way of section 38 of the the European Union Withdrawal Agreement Act 2020, which implicitly deposed QE II of the crown by declaring Parliament to be sovereign.
14. Decreed the unlawful house arrest of every Briton, imposing draconian regulations which resulted in untold thousands of deaths, the destruction of the national economy and the bankruptcy of a vast number of businesses.
15. Enacted the treasonous Corona virus Act 2020, which purported to suspend the legal rights guaranteed to every Briton by the Common Law, whilst legalising mandatory vaccination and the falsification of death certificates, in addition to

suspending the democratic right to remove the government from office.

## Restoration of Common Law



For the purposes of restoring the rights and protections guaranteed by the Common Law, it is hereby reaffirmed that Sovereignty is naturally vested in the People, who are naturally endowed at birth with the following unalienable rights, which no government has the authority to suspend or impede:

1. The rights to self-determination, both as individuals and collectively.
2. The right to be presumed innocent of any crime or civil offence, until proven guilty before a jury of our peers.
3. The right to bear arms and defend ourselves, our family, property and community, from unlawful acts of aggression and theft, with all reasonable force necessary.
4. The rights to exercise our conscience and to remain silent whenever appropriate.
5. The rights to a private family life, freedom of expression and religious freedom.
6. The right to live freely in an unpolluted environment, with unrestricted access to clean air, water and food sources.
7. The rights of free assembly and to campaign against injustices of all natures and descriptions.

8. The right to come and go as we please, without unwarranted intrusion, harassment, surveillance or delay.

9. The right to declare any unconstitutional law or treaty unlawful by unanimous Common Law Grand Jury.

10. The right to depose criminal governments by any lawful means necessary, including the Unilateral Declaration of a properly convened Common Law Grand Jury.

11. The rights of autonomy in the conduct of every aspect of our lives, within the boundaries set by the Common Law, as restored by the lawful execution this declaration.

12. The rights to contract and conduct any lawful business and to trade in any lawful currency of our choosing, without government interference, licensing or taxation.

13. The right to seek a Grand Jury order that the police and the military arrest, detain and charge criminal government officers for Common Law crimes against the People.

15. The right to claim Lawful Excuse in performing or refusing to perform any act or deed our conscience dictates we must, even if we are subsequently held to be wrong and/or such a course of action is prohibited by law.

16. The right to convene Common Law courts, where every case, both civil and criminal, is heard and decided by a Common Law jury, upon its merits.

17. The right to seek Grand Jury nullification of international agreements, including but not limited to, the nullification of the UK becoming a signatory to UN Agendas 21 and 30.

This declaration has been drafted in the genuine hope that everybody, from where soever they come, will one day soon be able to live their lives, on these shores and everywhere else, according to our ancient Universal Maxim of Common Law:

Cause no harm, injury, damage or loss, but defend yourself, your family, your community and your property with all reasonable force necessary, from all those who seek to do you wrong.

## Solemn Declaration

We solemnly swear that we have Lawful Excuse to take this course of action in defence of the rights and protections of the Common Law governing the British Isles, having witnessed our beloved homeland being subjected to the most treasonous government crimes against the People.

It is therefore with sound minds and sincere hearts that we are compelled to declare that we revoke our consent, whether express or implied, to be governed under the laws of any Parliament

which has made the government unaccountable to the People and in so doing forfeited its legitimacy under the Common Law; and that we are seeking a Unilateral Declaration from a Common Law Grand jury that Magna Carta 2020 must from henceforth be held to be the law of our homeland, which we will do our utmost to uphold, apply and preserve.

**A**ND NOW IN THE LIGHT GATHERED FROM SIMILAR MOUNDS IN OTHER PARTS OF BRITAIN, we will pass on to a more detailed examination of the prehistoric mounds that stood round about the Porth of the Llandin (or the Lyndin-the Lake City) the Caer Troia of Brutus, the Londin or Londinium of the Romans. Upon the two natural eminences of the Llandin and the Penton, the eyes of Brutus must have rested when he made choice of the Kymric Caer for his capital; the two smaller artificial mounds of the Bryn Gwyn and the Tothill may have been erected by the Trojan king as trade increased under his rule.

It is conceivable that in the foreknowledge of the Creator, the two “high-places” commanding the marshes, east, west and south may have been predestined to be used in the service of the Lord of Hosts, as Holy Hills from whose summits the astronomer-priests, in the dawn of civilization, might study the “heavens,” that “declare the Glory of God” and the firmament that “sheweth his handiwork”; and by heliograph, semaphore or beacon light, signal the time and the seasons, the result of their observations for the daily direction of the lives of the traders and sea-faring population of the Porth.

History has proved the wisdom of Brutus’ choice of what appeared a very unpromising district for a capital, which has held its own and won its way to the foremost place, as the capital of the British Empire and the greatest city in the world. The Llandin—Parliament Hill—is the largest, loftiest

and most imposing of the four prehistoric “Gorsedds of Great Scats” of the Metropolis. Standing on a spur of the Northern Heights in an amphitheatre of wooded hills midway between Hampstead and Highgate, from its site and surroundings the Sacred Eminence retains somewhat of its original dignity as a “high-place of worship.”

The structure of the hill is London clay at its base, gradually changing to a sandy loam. The central boss would appear to have been sculptured from the highest layer, since there is a circular terrace still distinct. Half a century ago, the sighting lines (somewhat similar to those on Silbury) and graded slopes were to be traced, but a pathway over the summit and trees planted on the sides have destroyed the original contour; a vestige of the trench remains, which in Kymric times encircled the base, but the spring has been diverted by the L. C. C., and now forms a series

of ponds where bathing and boating may be enjoyed by the general public. Symbolic, as are all our prehistoric mounds, of the earth rising out of the sea, a British Gorsedd may always be known by its symbolic trench.



**Parliament Hill** carries on its Keltic traditions as a place of assembly to this day. On the north-eastern slope is a stone monument on which an inscription states that here public speaking is allowed. The numerous assemblies, religious and political, which from time immemorial have been held either on the mound itself or on “Parliament Fields” at its base, is an interesting survival of a national custom.

The Llandin has been called the “Areopagus” of Britain, from the tradition that St. Paul preached from the summit. On this account the Apostle became the Patron Saint of London, and his emblem, the sword of martyrdom, incorporated in the arms of the City, in the same way as St. Peter became the Patron Saint of Chartres from the tradition that this Apostle preached in the “Grotte des Druides,” the Druidic rock temple, the actual foundations of the oldest Cathedral in France.

What is more likely if, as history tells us, St. Paul’s friends were the children of Caractacus, than they should take measures for the conversion of their native land? And the great love St. Paul had for his peculiar mission to the Gentile world would not have allowed him to overlook the claims of such an important city as the “Colonia Augusta” of the Roman writers.

The Roman historian, Tacitus, writing in AD 61, describes Londinium as famous for its vast number of merchants who resorted to it for its widely-extended commerce and for the abundance of every species of commodity which it could supply. Strabo speaks of British merchants as bringing to the Seine and the Rhine shiploads of com and cattle, iron, hides, slaves

and dogs, and taking back brass, ivory, amber ornaments, and vessels of glass. And that the Port was considered by the Romans as the Metropolis of Britain is further established by the fact of its being the residence of the Vicar of Britain. The abode of such an officer clearly marks London to have been a Seat of Government, of Justice, and of the administration of the finances which

consequently contributed to its extent, its magnificence and its wealth. “As early as the year A.D. 859, eight hundred vessels were employed for the conveyance and exportation of corn only,” says Brayley in his Londinium.

The prehistoric burial-ground of the leaders of pre-Roman times was close around Parliament Hill, reminding us of the cemetery round about Silbury. Several barrows remain to this day, notably Primrose Hill and Barrow Hill, the site today of a reservoir. Other tumuli have been levelled and all trace of them lost. A bird’s-eye view of the two cities, one in Britain and one in Asia Minor, would offer a general resemblance, and in the case of the latter the tombs bear the names of the heroes of the Trojan war, as every tourist will remember.



**At Highgate** a memorial of the national religion survives in the place-names of the Grove and Bishopswood. Situated on high ground, on the fringe of the forest that in Kymric times framed the Gorsedd, the Grove commands a view of both Parliament Hill and the Penton, and was the probable site of the Druidic College where dwelt the “ministers of law and order”—the Druids. Bishopswood (mainly consisting of oak trees) lies at the foot of a steep descent westward of the Grove and is so called from the fact that it has formed, from time immemorial, part of the endowment of the Bishopric of London.

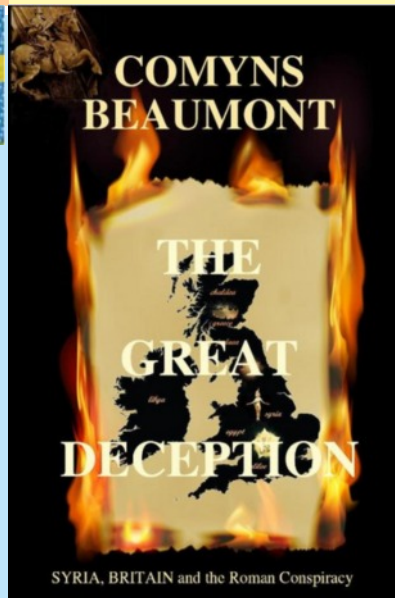

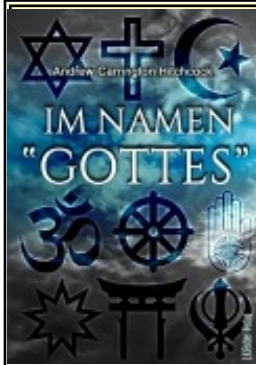

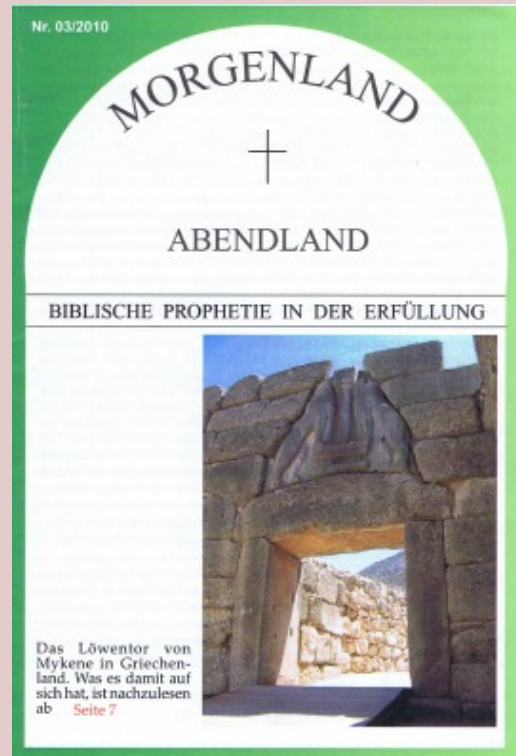
