### Introduction

**T**HE TWO LEADING BIBLE-BASED THEOLOGIES IN THE WORLD TODAY ARE JUDAISM AND JUDEO-CHRISTIANITY. The systemic errors of these two theologies must be exposed before the Truth can be understood. Even though both of these theologies claim to adhere to the teachings of the Bible, this is not the case. A brief historical survey of how these two

theologies came about will first be presented in order to provide an idea of the vastness of the deception that has occurred. Once the true Christian appreciates how these two priesthoods have distorted the Holy Scriptures for filthy lucre's sake, only then can the unlearning of false ideas begin.

### Judaism

Judaism is based on two gigantic lies: 1.) that Judaism is the religion of the Old Testament, and 2.) that the Jewish people are the Israelites of the Bible. Contrary to Judaism's public claims about its own origins, the fact is that many rabbis, Jewish historians and encyclopaedias admit that the true basis of Judaism is not the Bible at all. The true source of Jewish theology is the Talmud.

The Talmud is a mere collection of commentaries on the Bible and other subjects. The rabbis claim that the Talmud is the “oral tradition” of Moses, which was supposedly passed down by “Jewish scribes.” Who these people were, the rabbis cannot say. It is a myth. There was no such tradition. The idea is nothing but rabbinical invention, for the purpose of elevating themselves above the very Scriptures they pretend to uphold. The “oral tradition” is the best explanation the rabbis have for this false tradition.

**Deut. 4:2** explicitly states that no person has the authority to contradict the written Law of Moses. Hence, any commentaries, which claim to have authority over the written laws of the Bible, are fraudulent, by the Bible's own standards.

The fact is that the Talmud contradicts virtually every law that Moses recorded, so the Talmud is nothing but a mountain of lies heaped up against Scripture. Despite public pronouncements declaring Judaism's faithfulness to the Torah, in the eyes of the Jewish rabbi, the Talmud supercedes the Torah. This is why Yahshua condemns rabbinism as “the tradition of the elders” which makes “the law of none effect.” (Matthew 15:6 & all of chapter 23.)

The ethnicity of the Jewish people is also a matter of deception. The Bible is clearly written to a specific group of people, whom Yahweh refers to as His “chosen.” The Chosen People are clearly identified in Scripture by their appearance, characteristics, historical exploits and prophetic achievements. The fact is that the Jewish people fit absolutely none of these identifying marks.

The Israelites were repeatedly told to remain separate and aloof from all other races and cultures. Contrary to this dictum, the Jews have always insinuated themselves into other peoples lands, having never built a city or country of their own. Like the cuckoo bird, the Jews nest in other people’s nests. The Israelites were warned repeatedly that, should they fraternize with other races and cultures, they would lose the very “chosenness” by which He had jealously guarded them. “Learn not the way of the heathen” is the Biblical command.

The Israelites were forbidden to circumcise non-Israelites. This was true from Jacob down to the Maccabees, who refused to circumcise non-Israelites. Contrary to the law of separation, the Jews have always taken converts of all races. This is why the Jews are the most miscegenated people on the face of the earth. As you will see from the evidence presented herein, this fact automatically disqualifies them as Yahweh’s chosen.

All Jewish scholars admit that up to 95% of modern Jews are a non-Shemitic people, namely the Ashkenazi branch of Jewry, which is descended from the Khazar nation, which **Converted** to Judaism around 740 AD. These Khazars have never had a single Hebrew, Israelite or Shemitic ancestor. Hence, this branch of Jewry has no right to claim Israelite ancestry, much less the land of Palestine.

The other five percent of modern Jews are of Sephardic ancestry. These people are also non-Israelites, but they are the originators of the religion called Judaism. It was the scribes and Pharisees who originated Talmudic doctrine just before the days of Jesus Christ. The New Testament provides ample proof that their doctrine and ethnicity are suspect. The four Gospels condemn their religion on every page, but few Christians are aware of this, because the theology of Judeo-Christianity has withheld this

information from them and because most Christians don’t read their Bibles, except for the verses selected for them by their Judaized priesthood.

Although the Pharisees began as a Judahite cult during the Maccabean era, the tides of war began to influence their loyalty to Israel. Successive invasions of the land of Judah, which was a racially homogenous nation, divided the nation into sects of dubious loyalty. The Maccabees were the most loyal to the Hebrew traditions, and they maintained their ethnic and theological purity until King John Hyrcanus violated the Mosaic Law by circumcising the males of Idumea.

This event occurred in the year 121 BC. These Idumeans were the racially mixed descendants of Esau, the perpetual enemy of Judah and Israel. By circumcising these Edomites and incorporating them into the nation of Judah, Hyrcanus opened the floodgates to subversion by these Edomites.



This subversion began with Antipater (Coin above), the “advisor” of John Hyrcanus. As part of his subversive activities, Antipater also financed the Roman occupation of Judea, having bribed Julius Caesar for the favour of installing his son, Herod, as the governor of Galilee. The Judahite historian, Josephus, records all of this treachery in his books, *The Antiquities of Judah* and *The Wars of Judah*. Scholars have been duped into believing that the works of Josephus are the works of the “Jews.” But Josephus clearly distinguishes between the true Judahites versus the invading Edomites.

Once the reader is aware that an impersonation is going on, the text becomes immediately clear. Josephus has documented all of the treachery of the Edomites against True Judah. This is the main theme of the “*Antiquities*,” especially regarding the activities of Antipater, Herod, and the brief Herodian dynasty which lasted until 70

AD. It was the Edomite Herodians, in partnership with the largely Edomite sect of the Pharisees, who executed Christ.



As Josephus records, after Herod assassinated the last true Judahite King of Judah, Hyrcanus II, he assassinated the entire Sanhedrin and replaced them with his Edomite cronies. This “reconstituted” Sanhedrin, which contained a smattering of Judahites, such as Nicodemus and Joseph of Arimathea, was, in fact, an alien outfit, created by Herod to impose Herod’s pagan religion upon the people of Judah.

These historical facts provide an entirely different perspective on the events of the four Gospels. This explains why Herod and the Pharisees were so hostile to Jesus. They were **NOT** His kinsmen. “Ye are not My sheep,” Jesus told them. They were usurpers who fully understood that Yahshua was the true claimant to the throne of Judah. Yahshua exposed their treachery at every turn, but modern Judeo-Christian scholarship simply ignores the historical record in favor of the “gospel of personal salvation,” or “the gospel of prosperity,” while eschewing the historical significance of the four Gospels.

Once all of these facts are known, it becomes abundantly clear that the religion of Judaism is an Edomite religion masquerading as Israelite religion. And the Jewish people are non-Israelites masquerading as Israel. The Bible itself predicted that all of this would happen. For proof of this, please see my essay, “The Marks of Israel,” which documents the prophesied and fulfilled exploits of the children of Israel, who are today’s Caucasian Race.

The Edomites of the Bible are the Jews of today. By their own admission: “Edom is in modern Jewry.” – Jewish Encyclopaedia, 1905 edition.

## Judeo-Christianity

“An appalling and horrible thing has happened in the land: the prophets prophesy falsely, and the priests rule at their discretion; **My People Love to Have It so.** But what will ye do when the end comes?” – Jer. 5:30-31.

The Apostle Paul, at II Thes. 2, declared that, just before the Second Coming, Christian Israel would abandon the true Faith. The KJV describes it as a “falling away.” Astute theologians call it the Great Apostasy. Because Judeo-Christianity ignores its historical and racial roots, modern “Christianity” has abandoned the precious chosenness of True Israel. Hence, like Judaism, Judeo-Christianity is also based on two enormous lies: 1.) that the Covenants made exclusively with Israel were transmitted to “believers” or to some “church” organization, and 2.) the promises made to True Israel can be extrapolated to all non-Israelite peoples. This miracle is somehow accomplished by simply “accepting the Lord into your heart.” The fact is that the Bible denies both of these propositions, as this essay will prove with abundant evidence.

The universalization of the Bible began with the Catholic Church. The word ‘catholic’ means “universal.” But the Bible nowhere authorizes such universalization. The reformers of the Protestant Reformation realized that the Catholic Church was riddled with false doctrine. That is why Luther and others referred to Catholicism as “Popery” and condemned the Catholic Church as the “anti-Christ” of their time. Unfortunately, the Reformation has been likewise subverted by universalistic doctrine, to such an alarming extent that Protestantism is today more catholic than the Pope. This is the Great Apostasy foreseen by Paul. (II Thes. 2.) It is also the “false prophet” of Revelation.

Completely lost, whether ignored or deliberately obfuscated, in modern “Judeo-Christianity” is the eternal Covenant relationship that Yahweh God has established with True Israel. The Bible is absolutely clear about this Covenant relationship. It will exist forever and it cannot be revoked. Paul affirms this at Gal. 3:17. “And this I say, that the **COVENANT**, that was confirmed before God in Christ, the law, which was four hundred and thirty years after, cannot disannul, that it should make the promise of none

effect.” Paul is simply stating that the Mosaic Law had nothing to do with the unbreakable Covenant relationship that Yahweh had established exclusively with the descendants of Abraham, Isaac and Jacob. Law or no Law, the promises and covenants cannot be annulled. Paul is asserting the exact opposite of what the Judeo-Christians have falsely assumed, namely that Paul is supposedly asserting that the law has been “done away with.” A full analysis of what Paul is really saying in Chapter 3 of the book of Galatians will be presented later.

Before that can be done, the reader must fully understand the eternal and exclusive nature of the Covenants, promises and inheritance of the Old Testament, none of which can be transferred to any other people, and none of which have ever been abolished. The fact is that Paul confirms the racial covenants. He never denies them.

#### Part 1: The Exclusive, Racial Covenants of the Old Testament

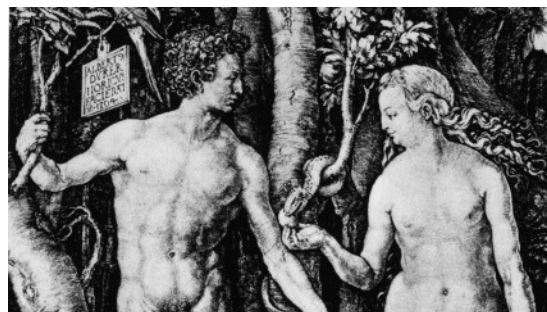
The numerous distortions of biblical passages will now be revealed as being a combination of Jewish perversions of the Torah, plus Judeo-Christian distortions of the Gospel. Jesus said, “All things will be revealed.” Yahweh said “I will choose your delusions.” He has allowed True Israel to fall into a state of amnesia, precisely because we have refused to obey His laws. Hence, we have fallen into a stupor of denial, just as a drunkard collapses into the gutter, so drunk that he no longer knows who he is. Yahweh does not intend to allow True Israel to be kept in the dark forever. The Scriptures clearly state that Israel will awaken out of his delusion just before the Second Coming, so that we will realize the magnitude of our sin and repent before the return of our Lord and Savior, Jesus Christ.

The very first thing that must be realized is that the Hebrew word, **AWDAWM**, means “to show blood in the face.” This literally means “to be able to blush.” Only the White Adamic race has ever had this ability. Hence, Gen. 1:26-27 is declaring that only the White Race was made in the image of Elohim. The other races were already created at Gen. 1:24-25, as the “beast of the earth.” This includes the Orientals, the Blacks, the Amerindians and all non-Whites. As will be shown, the Covenants were continuously narrowed down to an ever smaller group of

people, from the Adamites down to Noah’s eight souls. From Noah, the Covenants were transmitted, exclusively, through Abraham, Isaac and Jacob (Israel). Only the direct descendants of this genealogy were ever made a party to these promises and covenants. Note that a Covenant is a legal contract, which cannot be disannulled, just as Paul says. Yahweh has sworn by His own Name that these Covenants will never be altered or abolished.

**Jonah 3:8** describes the fact that Nineveh had both “beasts” (non-Whites) and “men” (White Adamites), both of whom were dressed in sackcloth and repented of their sins. There is no such thing as a four-legged “beast” capable of repenting. Only two-legged non-Whites can perform what is required here.

Gen. 1:28-30 declares the Dominion Mandate, which is given exclusively to the Adamic Race and to no one else. History proves that the White Race has always been the Dominion Race, exactly as Yahweh had intended. Likewise, our current decline was prophesied. Fortunately, our eventual re-emergence as God’s Chosen People was also prophesied; and nothing can stop this prophecy from being fulfilled.



It must be understood that Adam and Eve were **NOT** the first members of the White Race. Gen. 1:26-27 is declaring the **Creation of the Race**: “Male and female He created them.” First the race was created. This is confirmed by Jesus Himself at Matt. 19:4. (“Male and female **from the Beginning**.”) Then, **after the Day of Rest**, in Gen. 2, Yahweh selected two individuals of the White Race and breathed the breath of life into them. All of the races were created in Gen. 1, “kind after kind,” bearing their own DNA, each kind carrying its own type of seed within itself (Gen. 1:11-12). As all scientists know, each species has its own seed, which is designed to replicate itself. This is the way Yahweh designed it; and that’s the way it has always

been. Nor will this ever change. The science of genetics utterly refutes the fable of evolutionism, which is a totally unscientific speculation about the origin of species.

**Genesis 2** introduces the single man, Adam, and the individual woman, Eve. It is upon these two individual specimens of the already existing Adamic Race upon whom Yahweh graciously bestows potential physical immortality, so long as they obey His commandments. He specifically tells them that they are **NOT** to even touch the “trees” of the other races.

Throughout Scripture, trees are metaphors for peoples and races. Therefore, the “tree of the knowledge of good and evil” is that particular group, living in the Garden of Eden, in which both good and evil exist.

This cannot possibly be a literal tree, for no wooden trees have knowledge of good or evil. The plant species do not have such capacity. Only humanoids have such knowledge, so this commandment is a prohibition to Adam and Eve against mixing with any species that has knowledge of good and evil. This includes the already existing Adamic race, which was and is still mortal.

Adam and Eve were specially selected to be immortal; but sin and immortality do not mix. This is why Yahweh told Adam and Eve, “Do not touch the ‘tree’ that knows good and evil.” Their offspring were not supposed to know evil. Satan perfectly understood that the creation of an immortal seedline would overthrow his rebellion (Rev. 12). Hence, he understood that the only way he could thwart Yahweh’s Plan to overthrow this rebellion was to adulterate Eve’s offspring, by seducing her. That is exactly what Gen. 3 is about.

All of the punishments that were inflicted upon Adam and Eve in that chapter are sexual in nature, from covering their sexual organs with loin cloths to Eve’s conception being cursed with exceptional pain. The resultant offspring of this seduction was Cain, while Abel was actually the son of Adam. Eve had a dual pregnancy (superfecundation) by two different males. Although superfecundation was rare among the Israelites, it is very common today, as more and more women have become promiscuous, sharing their beds with different men on different nights,

and sometimes with men of different races. In this way, a woman can be pregnant by two different men at the same time.

**Gen. 4:1** records Eve’s surprise at Cain’s appearance, where she says, “I have gotten a man (IYSH, not AWDAM) from Yahweh.” The meaning of the Hebrew word IYSH is “a male of any species.” Moreover, the root word from which IYSH derives is ENOSH, meaning “mortal.”

Eve was twice surprised: by Cain’s appearance and by the fact that she perceived he was a mortal. Given Yahweh’s promise that Adam and Eve would be immortal if they refrained from sin, Eve was very surprised that she would have produced a non-Adamic, mortal offspring, such as Cain.

The fact that Cain killed Abel is proof that there was something seriously wrong with Cain. We two-seedliners understand why: Adam was not Cain’s father.



Nachash, the “serpent,” was Cain’s father. The “Serpent” having thus polluted Eve’s womb, Abel was also born a mortal; and Eve could no longer produce immortal offspring. She never got the chance, because Nachash impregnated her about the same time that Adam did.

This is the true meaning of the FALL of Adam and Eve. Rather than ask Yahweh for a replacement, Adam chose to do what Eve did. He fraternized with the other races and apparently bore hybrid offspring as well. He should have asked Yahweh for a replacement for Eve; but this idea never occurred to him. Either that, or he loved Eve so much that he could not bear to lose her. Another possibility is that neither one of them were able to comprehend the consequences of their sin.

Gen. 5:1 records Adam’s satisfaction with Seth, Abel’s replacement, because Seth was born in Adam’s own image, just as the Adamic race was conceived in the image of Elohim. Since Cain was not Adam’s son, Cain was never even considered as part of Adam’s genealogy. Even the New Testament genealogy leaves Cain out. Had Cain been the elder son of Adam, he would have had the rights of the elder son over Seth. But since he was not Adam’s son, Cain had no such claim. (This theme will be repeated later, when Esau, the elder, despises his birthright, transferring it to Jacob-Israel, the younger.)

Although our species lost its potential immortality and fell into sinfulness, we did not lose our race-specific DNA. The law of kind after kind still applies, even though we fell back into mortality. We should not compound our sin by adulterating our seed ever again. And the Bible repeatedly commands us to avoid this sin, even though the Jews, in their subversiveness, and the Judeos, in their apostasy, constantly advise us to do the opposite.

Given this understanding of what really happened in the Garden, we can now proceed to relate the story of Yahweh’s Chosen People,

Adamic Israel, and how we are commanded to remain separate and distinct from all other peoples. **(NOTE:** Paul’s admonition to avoid controversies about genealogies does not apply to biblical genealogies, as he was criticizing the Adamic Greeks (who were dispersed Israelites) about **THEIR** false genealogies, which asserted descent from fictitious gods.

The Israelites of the dispersion had become so paganized and Hellenized that they no longer practiced circumcision and they had adopted many Greek customs, such as claiming descent from the gods and goddesses of the Greek pantheon. Those genealogies have nothing to do with OUR genealogy. This will be proven later in our discussion of the pertinent New Testament pericopes.) The fact the New Testament opens with the very detailed genealogy of Jesus Christ cannot be downplayed or ignored. His genetics cannot be ignored or criticized. Without these genetics, Yahshua could not have fulfilled His role as our Kinsman Redeemer. Also, without these genetics, we Israelites cannot achieve our destiny, which is to have restored to us the dominion and immortality which was lost by the sins of Adam and Eve.

**Old Testament**  
**“Word for Word” Deuteronomy Part 18**  
**Translation by Stephen Howard Anderson**



**Chapter 24**

1. When a man has taken a wife, and married 1166 her, and it comes to pass that she finds no favor 2580 in his eyes, because he has found a matter 1697 of nakedness 6172 with her: then let him write her a scroll 5612 of severance 3748, and put it in her hand, and send her from his house.

2. And when she has gone forth from his house, she may go and be another 312 man's wife.

3. And if the latter 314 man hates 8130 her, and writes a scroll of severance, and puts it in her hand, and sends her from his house, or if the latter man dies, that took her as wife;

4. she is not able to return to her first 7223 husband which sent her away and he may not take her as wife, after that she is defiled 2930; for that is abomination 8441 before Yahweh: and you shall not cause to sin 2398 the land that Yahweh Eloheycha gives you as an inheritance.

5. When a man takes a new 2319 wife, he may not go forth to military service 6635, and shall not pass over upon him any matter: he shall be blameless 5355 at his house one year, and shall cause to rejoice 8055 the wife that he has taken.



6. None may bind with a pledge 2254 the mill 7347 or upper millstone 7393, because a life 5315 he binds with a pledge.

7. If is found 4672 a man stealing 1589 a person 5315 of his kinsmen 251 of the children of Yis'rael, and enslaves him 6014 or sells 4376 him, shall be put to death 4191 that thief, and you shall remove wickedness from among you.

8. Guard 8104 yourselves from the blemish 5061 of skin disease 6883, and guard carefully 3966, and do all that teach 3384 you the priests, the Lewiyyim 3881. As I commanded them, you shall observe 8104 and do.

9. Remember 2142 that which did Yahweh Eloheycha to Mir'yam 4813 on the way, as you came forth from Mits'rayim.

10. When you lend your kinsman any 3972 loan 4859, you shall not enter his house to take his pledge 5667.

11. You shall stand outside, and the man to whom you lend shall bring forth to you the pledge outside.

12. And if the man is poor 6041, you shall not lie down to sleep in his pledge;

13. but return his pledge when the sun goes down, so that he may lie down to sleep in his own garment 8008, and bless you. To you it shall be righteousness 6666 before Yahweh Eloheycha.

14. You shall not oppress 6231 a hired servant 7916 that is poor and needy, of your kinsmen, or of sojourners 1616 that are in your land within your gates.

15. Each day you shall give his wages 7939, neither shall the sun go down upon it; for he is poor, and supports 5375 himself with it: lest he cries against you to Yahweh, and it becomes sin to you.

16. Fathers shall not be put to death for children, nor shall children be put to death for fathers. Every man shall be put to death for his own sin.

17. You shall not wrest 5186 the rights 4191 of the sojourner, or the fatherless child; nor take a widow's clothing as a pledge:

18. but you shall remember that you were a slave in Mits'rayim, and Yahweh Eloheycha redeemed 6299 you from there: therefore I command you to do these things.

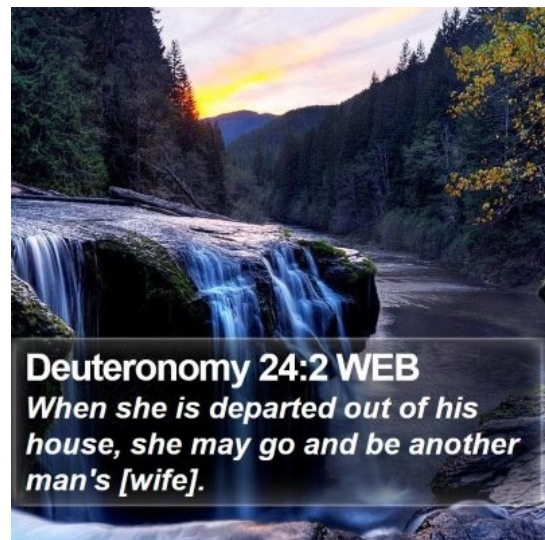
19. Because you reap 7114 your harvest 7105 in your field, and have forgotten 7911 a sheaf 6016 in the field, you shall not return to take it. It shall be for the sojourner, for the fatherless child, and for the widow, so that Yahweh Eloheycha may bless you in all the work of your hands.

20. When you beat 2251 your olive tree, you shall not go over the boughs 6286 again 310: it shall be for the sojourner, for the fatherless child, and for the widow.

21. When you gather the grapes 1219 of your vineyard 3754, you shall not glean 5953 afterward, it shall be for the sojourner, for the fatherless child, and for the widow.

22. And you shall remember that you were a slave in the land of Mits'rayim: therefore I command you to do these things.

All of this chapter is about the decent treatment of other people, and remembering the humble past of Yis'rael in the land of Mits'rayim. Common sense tells us to look after the welfare of our widows and orphans. It also tells us to treat a man that we hire in a fair manner. ### Foreword

**T**HERE ALWAYS SEEMS TO BE SOMETHING TO WRITE ABOUT ALTHOUGH I NEVER KNOW BEFOREHAND WHAT IT WILL BE. God

always finds something and always the subject is thought provoking. The following subjects are those that really ought to have our whole nation thinking. Of course, the ‘thought-shapers’ (Media, churches, schools) have their pet subjects all worked out, so no chance (yet) of a ground swell fascination for things other than their themes. Nevertheless, God uncovers things for those who have eyes to see and ears to hear.

Once in every several weeks I go along to a Bible study group, where, on one occasion a certain student told me of a wonderful find a friend of his came across whilst working overseas. “This friend I know called Peter heard about fair-skinned tribes living in the Hindu Cush, not far from the Tarim Basin,” he said, “Some say that the Tarim Basin was the site of the Noachic flood.” So I asked him if he could contact this friend to get me more details. While this was

going on another friend phoned me and asked “Have you heard of the Urumchi Mummies?” He began telling me about an article he read in a weekend edition of one of the national papers, some radio interviews he heard and a recent book he bought about these mummies. The book outlines the mummies as looking Nordic or Celtic and that they were buried north of the Tarim Basin in western China. Some of the mummies are over 3000 years old.

The writer of the book as well as the media were guessing as to what had become of the race of people of whom these mummies belonged. Nor, it seemed, could they work out why their culture died and if descendants live today .. if so, then where are they?

The writer made it clear that these finds will challenge historians to rethink the ethnic history of Asia. Interestingly, only months before the ‘Mummy Book’ was released, this Peter, (the students friend) discovered lost tribes that looked as if they could be descendants of the race that left us the ‘Urumchi’ mummies.

This is very thrilling! So many folks make such a big deal when someone finds a primitive nonwhite (zûwr - racial alien) tribe in the jungle –ok– but ‘Peter’s find’ is special. The tribes he stumbled upon may not only be linked to middle Asian Celtic mummies, but they are also our kin! Kin whom the world knows nothing of, kin who know nothing of us, kin who have never heard the gospels, who are not in Babylon, who are self-sufficient in a green Eden surrounded by towering barren mountains and dusky, hostile

nations who greatly outnumber them. They live as their forefathers did some 2000 years ago.

Besides my own research, in this book I will also highlight parts of the book on the mummies and, I bring in details of Peter's astounding find.

In the book of Judges (Chapter 6), God gives the Israelites a history lesson before He delivers our Israelite forebears out of their bondage. It seemed even back then they forgot their identity. The Christian Identity 'spirit' is an Elijah work that strives to leach our folk to know who they are, who brought them into bondage and who will deliver them out of it.

This Elijah work relies on things 'our God' uncovers for our learning. This means that much was hidden for centuries, awaiting the time when it is most needed; needed, to be part of God's plan to 'hit' the world with absolute truth. Today we say 'like a ton of bricks,' in John's day they said '**great hail fell on men the weight of a talent**' to outline how truth will sweep the world - Rev 16:21

One of the great truths is the revealing of the sons of God, in other words, uncover or identify just who are God's servant folk: just who is true Israel. Finding Israel also highlights the need to remember God's Laws. This is the Elijah work in a nut shell. It is dealt with in many chapters in the Holy Writ, such as in Malachi 4:4 - finding the servant nation, their calling and destiny leads up to the second work of Christ, reaching its fullness.

This book will help Christians become aware of identifying who is and who isn't 'kin' and the importance thereof. The very word 'kin' shares a common root with the words 'gene', 'genetics', 'generation' and the poorly understood word 'gentile'.

As our specie (specie: sort begets sort) becomes a minority-specie in a sea of non-Israelites, it becomes clear that the 'Word' needs to go out to all of what is left of the nations of Israel. (Israelites do not beget Negroes or Asians therefore they are a specie separate and distinct from other forms of homo-erectus.) The history of our specie is cycle after cycle of dominion growth followed by decline typified by ethnic cleansing carried out against our specie. Our specie (folk, kin) would gain vast areas of land only to lose it all to people not our kin.

We begin this book with an account based on 'Peter's find and the Urumchi mummies. When coupled, we uncover a history of a sudden rise of a folk who carved out an indigenous homeland for themselves but only to find themselves (centuries later) to be the victims of barbarous waves of ethnic cleansing in which only a small remnant lived on in a forgotten part of the world. This history, to my great surprise, only helps to back-up the knowledge we have, that our Celto-Saxon links do go back to the Middle East and to the Biblical Abraham.

## Chapter 2 The Fall of Celtic Middle Asia

**L**ONG BEFORE THE ROMANS AND GREEKS were setting up their rickes (empires) and when the cradle of western civilization in Mesopotamia was waning, whites (whose clothing seemed almost Celtic) were migrating and settling on vast tracks of land in central Asia and the Asian subcontinent. Their settlements were thriving at the time when Abraham was fleeing a declining Chaldia (declining because of multiculturalism in which the white Chalds were mingling with the Asiatic Sumerians). These white, eastern homelands (around 2000 BC) were way to the east, in what is today Western China. The Chinese did not move into the area until 1000 BC, some 2000 years AFTER white settlement! These whites were Abraham's kin folk. In other words, they were of the same specie. These far eastern whites became known as the Tokharians (below).



The size of land they held was not simply a farm or homestead here and there. It was vast. The Tokharian land stretched some 500 miles (about

750kms) west from where now stands the Jade Gate of the Great Wall of China, along northern parts of the Tarim Basin. As no one else lived there before, these Tokharian whites could rightfully be called indigenous to the area larger than the state of Victoria or Great Britain.



### Proto-Tocharians: From Afanasievo to the Tarim Basin ...

Wall paintings found in caves in the area from 900AD show the Tokharians to be alive and well after 3000 years of settlement. In the paintings we see men with red beards, rosy cheeks and green eyes. At the time this was painted, European whites were on the threshold of what is called 'modern history', when William the Plunderer was about to set off to over-run England to set up central government. White Europe was in an upheaval, elsewhere our racial kin were already comfortably settled for centuries in western China! Yet today there is no trace of these folk left. The area is now populated by non-whites.

What happened to the Tokharians? Ethnic Cleansing! Wild and fierce tribes of mongoloid blood called the Xiong-nu began to sweep down upon the Tokharians and the neighboring Chinese. This prompted the Emperor of the Qin Dynasty around 200 BC (China takes its name from Qin) to order the building of the Great Wall of China, (contrary to popular belief, it can not be seen from outer space)

The Xiong-nu swept down wave after wave from the north, chasing away the Tokharians, the Asian-Celts. Once, the Tokharians were mighty but somehow they became weak. When the Xiong-nu over ran them, the Celtic Tokharian king was taken, killed and his skull used as a drinking cup. These barbarous Xiong-nu later became known as the Huns. (There are many Neo-Anti-Semites who still ignorantly or deliberately refer to the Germans as Huns. The Germans are a Saxon, i.e.. Semitic folk, they are not Mongoloid. Some British-Israelites and those of the Armstrong sect should know better. Sadly they take their cue from the Jews, many of whom actually have mongoloid blood in their veins, so guess who is the modern Hun?)

After some 2000 years of skirmishing, the Huns won in 1260 AD ruling the area from China to the Black Sea spanning some 3500 miles. Only pockets of Tokharians stayed behind to survive in the area. Most survivors were forced to flee hundreds of miles west into Bactria (Northern Afghanistan today).

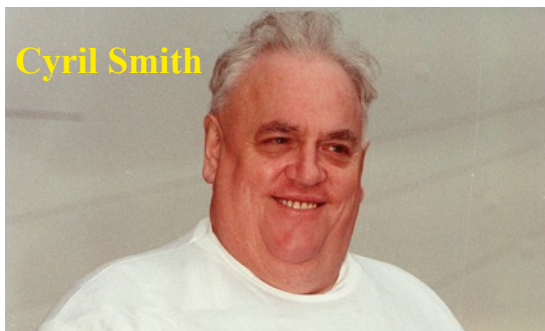

### **Row Loomed over Mp's 'Keep 'Em Out' Bill**

A **CURB** on immigrants produced an "emotion-charged" Commons debate in March 1965. Behind it was Louth MP Sir Cyril Osborne, who sought to introduce a Private Members' Bill.

The Grimsby Telegraph reported: "MPs of all parties are ganging up against him to strenuously oppose the measure and probably interrupt him as he speaks."

But Sir Cyril hit back, claiming his opponents were "half-witted."

His Bill sought to prohibit all immigration into the UK, except for those whose parents or grandparents were born here "until local authorities have dealt with the urgent problems arising from previous immigration... to stop the widespread avoidance of existing regulations to

provide for the repatriation of immigrants who enter the United Kingdom illegally.

"To make further provision regarding deportation of immigrants, who have been convicted of offences punishable with imprisonment, and to provide for assisted passages for immigrants who wish to return to their own country."

Despite making what was said to be "a surprisingly moderate speech" and winning the support of most of the Shadow Cabinet, Sir Cyril's Bill was voted out by 261 to 162 - a Government majority of 99.

## **The Political Influence of the British-Israel Movement in the Nineteenth Century (Part 3)**

### **Church of England**

**T**HE BRITISH-ISRAEL MOVEMENT **CROSSED DENOMINATIONAL LINES** but was predominantly Anglican but despite an anchor in the Church of England, British-Israel appealed across multi-denominational Protestantism. The key to this was its literal interpretation of the Old Testament in stressing its identity with the British Empire, as opposed to divisive spiritual interpretations.

The Church Quarterly criticised this in that the movement 'is found to weaken the hold of practical religion over its adherents without giving them anything in its place[50]' and 'Like Good Templarism, Plymouth Bretherenism or Freemasonry, it is a quasi-religion and, once accepted, is looked upon as the most important of all religious truths[51].'

An argument countered by British-Israel, which insisted that the knowledge of being one of God's chosen people reinforced their Christianity and supported by the influential Bishop Titcomb maintained that the Reformation liturgy, drawing heavily on the Hebrew Old Testament, was granted by God to British-Israel and that the reiteration of the Ten Commandments on Sundays and Holy days was peculiar to Anglicans and in 1897, Dr Potter, archbishop of York, had pleaded at the Lambeth Conference for a more definite union between the branches of the 'Church of Anglo-Saxon Christians'.

It is ironic that a proposal, to strengthen kinship between Anglicans and Lutherans, originated with the King of Prussia, Frederic William IV., who sent the Chevalier Bunsen to England in the summer of 1841, as a special envoy. Bunsen, Prince Albert, Lord Shaftesbury, Archbishop of Canterbury Howley and Bishop of London Blomfield founded a Protestant bishopric in Jerusalem consecrated by English bishops and exercising jurisdiction over both England and German Protestants, which was carried into effect by 1841 Act of Parliament[52].

The first bishop Michael Solomon Alexander was a converted rabbi. The Jerusalem bishopric caused a stir amongst Tractarian churchmen and John Henry Newman described it as one of 'three blows which broke me', leading to his departure from the Church of England. In 1845, Newman cited his 'fear that the Church of England stood in danger of being taken over by the Christian Israel Identity movement[53]' as one of his

reasons for leaving the Anglican Church to embrace Roman Catholicism.

Bishop Titcomb asserted that some believed Protestantism and Catholicism were more a matter of race than belief but he himself did not believe it was a question of ethnology. But did maintain that the only nations yielding to the Protestant faith were Teutonic and according to Jeremiah iii, Israel during her 'converted' state would commence a meagre return of a few of her sons to Palestine alluding to the accomplishment by the establishment of the Jerusalem Bishopric on Mount Zion under the protectorate of England and Germany[54].

However, despite a significant clerical membership, it was admitted, by British-Israel in 1880, that British-Israel was reviled by the clergy, as a whole[55]. Bishop Beckles regretted that the clergy, in general, did not give the subject the study it deserved. In fact, In replying to a particularly critical article in The Church Quarterly Review, British-Israel asserted 'The clergy generally seem to have the happy knack of reading Holy Scriptures with their brains in their pockets, and their eyes in their commentaries[56]'.

In the Church Times, of 12th June 1885, British-Israel was compared to the Mormons in what and declared to be the latest development of "Chosen Peopleism" a phenomenon which has 'perpetually appeared and re-appeared in the world, but always with disastrous results' dismissing British-Israel as a religious equivalent of craving for aristocratic distinction[57].

British-Israel maintained that observation of the Sabbath was an identifying feature not only of the Anglican faith but also of British-Israel. Edward Hine vigorously opposed John Stuart Mill's opinion that 'it was only strictly binding on the Jews' on the basis that the Jews were part of Israel and Britain was Israel[58].

The Reverend J. Tomlin asserted the national observation of the Sabbath was a characteristic distinction of Great Britain compared to continental nations, both Protestant and Catholic. The Sabbath question invariably spilled over into the Teutonic question and a letter to the St James Gazette, of 11th May 1885, by Prince Bismarck

was taken as proof of that Germans were not Israel:-

'I must say that when I was in England I always had a painful and uncomfortable impression of the English Sunday; and I was always glad when it was over. I am sure, too, that many Englishmen had the same feeling about it for they... were overjoyed when Monday dawned—thank God that we live not under the yoke of an English Sunday[59].'

Attempts to reverse this had been thwarted by both The Lord's Day Observance Society and the Conservative government[60]. In 1855, a bill restricting Sunday trading was presented to Parliament and already irritated by the previous year's act restricting Sunday drinking hours, on three Sundays in June and July the working classes demonstrated in Hyde Park. Karl Marx, who was present, thought that the English revolution had begun. British-Israel was adamant about keeping the Sabbath special, unlike on the continent and Robert Morrell's The National Sunday League, who argued that on the Continent innocent Sunday amusement and recreation did not lead to more Sunday labour than existed without them in England. In fact, France's legalising of labour on the Sabbath, in 1880, was judged by British-Israel to be a rebellion against God[61].

## Catholics

### The Roman Catholic Church



The re-establishment, by Pope Pius IX, of the English Catholic hierarchy, was to the liberals an extension of full religious liberty but to others it was a sign that the Church of England was in retreat before the Catholic Church. Disraeli had



opinioned that Rome was infiltrating all levels of British society and the presence in Parliament, in 1906, of 83 catholic MPs confirmed to many British Israelites that the papacy was not a religion but a colossal political system. 68 Paranoia about the intentions of the Catholic Church may well have been justified and British-Israel reminded readers of the danger, in 1880, quoting a lengthy sermon from Cardinal Manning's address to the 3<sup>rd</sup> Provincial Council of Westminster.

'This 19th century will make a great epoch in the history of the Church—It is good for us to be here in England. It is yours, right reverend fathers, to subjugate and to subdue, to bend and break the will of an imperial race, the will which, as of Rome of old, rules over nation and people, invisible and inflexible...

You have a great commission to fulfil, and great is the prize for which you strive. Surely a soldier's eye and a soldier's heart—Protestantism weakened in England, it is paralysed everywhere; conquered in England, it is conquered throughout the world; once overthrown here, all is but a war of detail[69].

However, fourteen years later, in 1884, at the annual Meeting for the Suppression of the Opium Trade, Manning stated 'I therefore believe, that, in these latter days, the great British Empire has been built up, not by us, but for us', which heartened British-Israel immensely[70].



This concern was again reflected by British-Israel in it's alarm at **Catholic Lord Ripon's (left) appointment as Viceroy of India in 1880**, 'All we can say to that is, that his lordship is a very poor convert to Rome if he does not use his great influence to the very utmost to serve his church[71].

This fear was fuelled by Lord Hartington's announcement in the Commons, in 1880, that it was up to Lord Ripon to decide if the 'Gates of India' - Kandahar - were to be relinquished after acquiring them at the Treaty of Gandamah. The Reverend H. Tristram of the Society for Promoting Christian Knowledge met with Daourd Pasha, Governor of the Lebanon, a Christian as stipulated by the Great powers after the 1860 murders. The governor had published

a large work on the history of Teutonic stock and attributed the present liberties of England to the malign influence of the Roman Catholics on the continent, which British-Israel eagerly recorded[72].

It was not only in England that British-Israel felt the Vatican was undermining the Protestant faith. The Bishop of Jerusalem, in 1866, remarked that evangelisation of the natives of Palestine was failing due to the unwillingness of the Turkish authorities to tolerate Protestants and that the Catholics were gaining the upper hand[73].

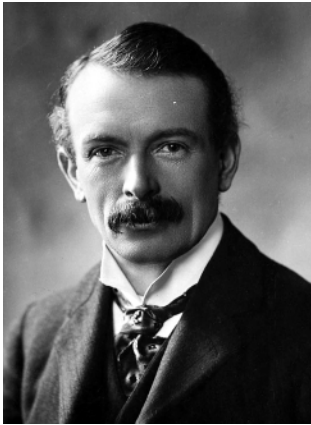
Quoting an un-named provincial journal, in 1876, Rome, under Pius IX, was allegedly going to make Palestine a Roman Catholic province in a deal with the Turks.

And a 'whip' was going round leading Roman Catholics to raise capital to attract emigrants from European Catholic countries. British-Israel acknowledged that they did not know the truth of the story but it was contrary to biblical prophecy and therefore the work of Satan[74].

John Wilson, saw this as an opportunity rather than a threat and noting the dearth of Protestants stated 'parties are so well balanced as regards Jews, Latins, Greeks, Armenians, Syrians, Arabs, and Turks, that there is no mediating powers so well adapted for promoting peace in the land as the English.' However, he added a cautionary note that Britain should not selfishly take political and commercial advantage of Palestine.

As the twentieth century approached the Great War, this anti-Catholicism increasingly mutated into anti-German propaganda. Publications such as British Ecclesia and British-Israel Ecclesia sought out any perceived link between the Kaiser and The Vatican. Ironically, the editor E. T. Wiseman was a relative of but foremost a self-publicist in the Edward Hine mould. Adherents believed in the notion of 'British Hebrews' claiming decent from the ancient British Church apostolically planted at Glastonbury in AD 35 succeeding from the Jewish church, as opposed to Rome, and advocating the re-establishment of the Sabbath on Saturdays[75].

Wiseman even authored his own bible, which George V was petitioned to authorise, in 1911



but rejected by **Herbert Asquith (left)** [76]. However the readers of British Ecclesia were not without humour as one reader noted the editor had sent him a British-Israel postcard ‘printed in Austria’[77].

The conflation of German territorial expansion with the Vatican was, to British-Israel, justified. With Cardinal Manning’s assertion in The Tablet, of January 24, 1874 that in order to restore Papal power, a mighty European war would have to take place, which would ‘exceed in horrors’ and British-Israel alleged that priests confessed their sympathy with Germany and directing their efforts towards weakening the country in order to prepare for the success of a German invasion[78].

## Jews



In racial terms, this concept of "chosen people" appeared to put British-Israel at odds with the Jewish community. Nothing was further from the truth. To British-Israel, every Jew was an Israelite but every Israelite was not a Jew. Israel referred to the larger northern kingdom of ten tribes, whilst Jew referred to the smaller southern kingdom of Judah.

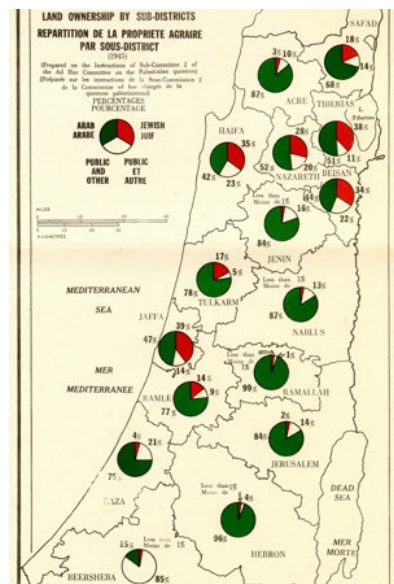
John Wilson writing on the restoration of the Jews, in 1866, maintained it was desirable for Palestine to be occupied by ‘a friendly people; having all the advantages of European enlightenment; with whom we can have important commercial relations; and who may open up new markets for our manufacturers, and give an impetus to civilization all over the East.’

However, he maintained that repentance and faith were pre-requisites of a happy restoration ‘whilst continuing in the same mind as they were when cast out of the Lord’s inheritance about eighteen centuries ago, the Jews cannot without fearful disaster, be received back there into power and possession[79]. However, he noted that although the world had begun to participate in Christian kindness for Jews others thought that they had been too eager in their pecuniary interests among the Gentiles and should be restored quickly to their homeland[80].

John Wilson made contradictory statements on this subject maintaining that the Jews should be converted to Christianity but not necessarily before the Second Coming. In 1900, S. J. Deutschberger, a converted Jew and head of ‘The Industrial Mission to the Jews’ became General Secretary of the British-Israel Association[81].

In 1874, there was an allegation by one Rev. John Wilkinson of Mildmay Mission To The Jews that British-Israel had reduced contribution for conversion work by thousands of pounds[82].

According to The Times every conversion from Judaism cost the Society for Promoting Christianity among the Jews at least £2000.83 However, it had not always been an acrimonious relationship as a pillar of the “London Jew’s Society”, William Marsh, had alluded that he found several points of British-Israel convincing, at a public meeting in Leamington, in 1840, and had also subscribed to The Time of the End Prophetic Witness, in 1844[84].



British-Israel needed a Jewish state in Palestine for theological reasons but it didn't necessarily mean they liked the Jews. In 1874, Hine reported that certain Christian churches have suggested that a trickle of

Jews in Palestine represented the scriptural return of Israel to their land[85].

Hine dismissed these Jews as ‘a miserable lot - may fairly be discarded as beggars; men without soul, without spirit; content to degrade their nationality by being satisfied to live upon the charity.’ And emphasised they must return with Israel. Further, Hine advocated that Jewish venture capitalists, such as Rothschild’s and Montefiores, purchase and invest in Palestinian land but acknowledged this was currently hindered by Turkish rule[86]. However, Hine did predict that the safety protection of Britain’s routes to India, would force her to take a deeper interest in Palestine[87].

The Anglo-Jewish community reflected British-Israel’s policy on Palestine and the Jewish Chronicle forecast that Palestine was to be the trading centre between East and West, and trading suited the Jews. However, they were afraid Russia wanted Palestine and proposed that as England was the only country that looked favourably on the Jews, England should aid settlement in Palestine[88].

The leader in the Jewish Chronicle, of 20th August 1875, stating ‘Think only of Palestine under the mild sceptre of Queen Victoria, of the Union Jack waving from the top of Mount Zion’ was reflected in British-Israel as support for their opinion that as the Turkish Empire crumbled, England must rule Palestine as the French, Germans and Russians must not be allowed to hinder access to India[89]. i.e. This would fulfil the biblical prophecy that ‘In these days the House of Judah shall walk to the House of Israel, and they shall come together out of the Land of the North to the land that I have given to their fathers for an inheritance.’ (Jer. III. 18)[90].

However, the Anglo-Jewish community, whilst acknowledging the Ten Tribes, did not exhibit a reciprocal opinions that the British were part of Israel. The Jewish Chronicle, on 2<sup>nd</sup> May 1879, stated ‘The fate of the Lost Ten Tribes is a mystery which has a peculiar fascination for some minds— The Scriptures speak of a future Restoration of Israel— The problem, then, is reduced to the simplest form. The Ten Tribes are certainly in existence.

All that has to be done is to discover which people represent them.’ British-Israel often berated the inability of the Anglican and Non-



conforming ministries to see the Scriptural distinction between Israel and Judah and speculated that the sympathy between Jews and Britain was an ethnic instinct remarking on the current Master of the Rolls, Sir George Jessel

(left), being an unconverted Jew ‘The Lord loves the Jews! Christian Israelites, bear that in mind[91]!’

This was reflected by the Anglo-Jewish community in an article in The Jewish Chronicle, on 28th April 1876, referred to Jewish feeling towards Britain on the dissolution of the Turkish Empire and the prospects of the English ruling Palestine: ‘England has given so many proofs of her feeling towards the Jewish people that they could not wish to see the land of their forefathers under safer keeping than that of Great Britain—And if the English are not the brethren of the Jews according to the flesh, as is contended by those who maintain that the Anglo-Saxons are descended from the Ten tribes, they certainly act towards them as kinsmen in spirit and feeling[92].

## Germany's No-Deal Brexit of 1948 From Fortune And Freedom



**Ludwig Erhard**

**E**VERY DAY THAT TICKS BY, the question gains a little more urgency: Sure, we've left the EU. But now what?

Well, we're not completely in the dark about what happens next. As usual, history can give us some idea of what could be in store.

Did you know that the Germans were once ruled by British unelected bureaucrats, who ruined their economy with stupid regulations?

Until the Germans staged their own *no-deal exit*, thanks to the bravery of one man on a Sunday radio programme. At first they called him mad. Then they told him it was illegal. Then they tried to stop him.

But it was too late. The no-deal exit happened anyway. And, as a result, the German economy left Britain's for dead. They even called Germany "*an economic miracle*".

Today, I'd like to tell you the story of Germany's no-deal exit of 1948. And explain what it means for post-Brexit Britain's future.

You'll be left asking yourself a simple question: is Boris Johnson Mr Fatty Wirtschaftswunder? But, before we get to that, let's start at the beginning...

### **Brexit by Radio Broadcast**

After the war, the German economy was in ruins. Reichsmark banknotes were worthless. People

survived thanks to the black market. American cigarettes were the currency for small transactions. Cognac for large transactions. Nylon stockings for in between.

Growing up, my German grandmother would eat my apple cores because of the waste-not-want-not attitude she learned from back then.

The Allied occupation government was led by the American military governor general Lucius Clay. But he didn't do a very good job when it came to economic policy.

In November 1945, Clay agreed to keep Hitler's price controls and rationing in place. He also continued the Nazi conscription of resources, including labour. It was the ultimate centrally planned economy, with government directing all economic activity.

The British representatives in the military government supported this position. And even implemented much of the same bad economic policy back home. My English grandparents remember it well. Excessive regulation and control of the economy. Just like the EU today, only worse.

### **But not everyone agreed.**

Economist Ludwig Erhard had refused to join the Nazi Association of University Teachers during the war – a career-ending move. Instead, he published a manuscript advocating a free market economy in 1942. His co-author was interned by the Nazis for it.

But Erhard didn't just talk the free market talk. He walked the walk.

After the war, the Allies became aware of his manuscript and its anti-Nazi nature. And so they "*asked*" him to become their economic adviser for Bavaria. Which he reluctantly agreed to.

He soon became Bavarian finance minister and the head of the Office of Economic Opportunity. His anti-Nazi credentials made him popular with the Allied elite, compared to other German leaders with questionable wartime backgrounds.

As part of the Office of Economic Opportunity, Erhard became a close adviser to General Clay. He eventually convinced the general to undergo currency reform. They replaced the worthless reichsmark with the deutschmark.



But Erhard wasn't finished. What he did next is shocking and legendary in Germany. Think of it as a no-deal exit from the Allied military government.

Here's how Erhard himself recalled what he did, in a TV interview 25 years later, as translated by me:

*I knew exactly what the currency reform would bring. Also its consequences. But it could only work if we simultaneously enacted a decisive economic reform, from a completely centrally planned economy to one as free as possible.*

*But that had, because of its very nature, to include abolishing all rationing, price controls, economic controls and more. But the perception of this was, in people's heads at that time, so unthinkable that it was only possible with a brave breakthrough.*

In other words, the German economy had to be freed from the interventionism and regulation of the foreign bureaucrats at the time.

Now economic policy and bravery rarely go together. But Erhard was special:

*The Frankfurt Economic Council gave me a series of broad executive powers in the expectation that we didn't know exactly what the currency reform would bring and, in the case of chaos, someone would have to react quickly.*

*At the time, as the director for policy in the economy, I had secretly and quietly in my desk drawers accumulated the documents needed to repeal all price controls by simple decree.*

*I scattered all the inclinations and suspicions of my staff as to whether I would ever use them.*

*They said, "For God's sake, you're not actually considering doing it, are you?" And I told them, "No, no, it's just in case..."*

*And of course I could never have told the [Allied] military bureaucracy. They would've had even less understanding for my plans, and I would've had even less influence with them.*

*And then, on the Sunday of the currency reform, I announced it all [on the radio], in the correct assumption that, on a Sunday, no government bureaucrats are capable of work. And thereby it was done.*

Erhard's surprise radio announcement abolished the Nazi government price controls, and many other economic regulations, which the Allied occupation government had kept in place.

It was a shock move. He had no legal authority to do so. He just hopped on the radio and did it, of his own volition, in complete violation of the Allied military government in Germany.

It's as if Dominic Cummins were to abolish the common agricultural policy and common fisheries policy on Twitter.

Making his move on a Sunday bought Erhard some time – why he chose that day of the week. But there would be hell to pay come Monday. Erhard recalls the meeting that morning, which made him even more famous than his surprise radio performance.

*The next Monday, at an early hour, I was brought before the military government. I was told that what I had done was impossible and unimaginable. That it was forbidden and all of it would have to be re-imposed. That I had broken all sorts of Allied military laws.*

*When I asked which laws I had broken, "I'd like to hear them precisely", they read to me that, without consent from the military government, no changes to price controls could be made.*

*And I replied, "but I didn't change them, I abolished them".*

That snarky response is what made Erhard so legendary in Germany. His defiance against the excessive regulations imposed by a foreign unelected government which were ruining Ger-

many's economy. But General Clay took some convincing when it came to Erhard's economic policy coup. Journalist Edwin Hartrich described what General Clay asked his friend Erhard that day:

*Lorem ipsum dolor sit amet, consectetur adipiscing elit. Cras gravida sem ut "Herr Erhard, my advisers tell me what you have done is a terrible mistake. What do you say to that?"*

Ludwig replied *"Herr General, pay no attention to them! My advisers tell me the same thing."*



The Brexit parallels are obvious. Erhard's point was that it was precisely the experts who centrally planned the German economy into a mess who were also against the free market reforms...

The journalist Hartrich also wrote about how a US Army colonel followed up later with another stinging rebuke:

*"How dare you relax our rationing system, when there is a widespread food shortage?"*

Ludwig answered, *"But, Herr Oberst. I have not relaxed rationing; I have abolished it! Henceforth, the only rationing ticket the people will need will be the deutschemark. And they will work hard to get these deutschemarks, just wait and see."*

Don't the warnings about food shortages sound familiar?

What happened next earned Erhard the nickname Herr Wirtschaftswunder – Mr Economic Miracle. His other nickname was "der Dicke", meaning *"the Fatty"*. Which is why I call him Mr Fatty Wirtschaftswunder.

After Erhard's reforms, the German economy was suddenly freed from the controls and regulations the foreign and unelected government had imposed. They created what's still known today as an economic miracle– Wirtschaftswunder.

Supposedly, Erhard's timing was key. By the time the Allies got around to discussing how to reverse the liberalisation of the economy from excessive regulation, the effects were simply too strong to ignore. Author and historian Henry Wallich wrote, *"The spirit of the country changed overnight. The grey, hungry, dead-looking figures wandering about the streets in their everlasting search for food came to life"*.

Shops literally filled overnight as the black market came clean. The new money was worth enough to actually sell things for, instead of having to barter, which made transactions more efficient. And the market prices allowed supply and demand to balance. Profit became possible, encouraging production too.

Of course, abolishing price controls and currency reform were just the beginning. An economist at the Federal Reserve Bank of New York wrote that between June and August, *"directive followed directive removing price, allocation, and rationing regulations."*

David Henderson, author of *The German Economic Miracle* wrote that Erhard's motto could have been: *"Don't just sit there; undo something."* Erhard freed all the staples of life and manufactured goods from absurd EU like controls. I wonder if Britain will have the same bonfire of regulations after Brexit.

My favourite twist is that a lot of the remaining controls were simply no longer enforced. If you'll recall, that's what some UK politicians threatened to do over Brexit too.

## **So, What Happened to the German Economy?**

In three months, absenteeism at work halved from as high as nine and a half hours per week – time Germans had spent foraging or looking for the right person to barter with. Industrial production increased by more than 50%. Ten years later it had quadrupled and was three times as high on a per capita basis. A productivity and employment boom, in other words.

Six million new jobs were created between 1950 and 1960, sending the unemployment rate from 10.3% to 1.2%. That's even lower than Britain's unemployment rate in the years after the Brexit referendum!

West Germany's economic boom took place while East Germany's economy stagnated under central planning and socialism. Even today, East Germany hasn't caught up. In fact, Germany's economy quickly became bigger than Britain's.

My English grandparents always said, not in a spiteful way, that Germany won the war, in that sense. But they never ate my apple cores...

Being like Germany wasn't a winning political strategy in Britain (at the time), so Britain's much more interventionist governments continued to ruin their economy with central planning and regulation – the sort of thing the EU does now. The free market stayed out of fashion in Britain for a few more decades, even as it proved itself in West Germany.

It took a long time for Britain to discover Erhard's intellectual inspiration, FA Hayek. In fact, the Allies banned his book *The Road to Serfdom* in Germany. But eventually Margaret Thatcher carried around one of Hayek's books too, reportedly thumping the book on a table and declaring "*this is what we believe*".

Erhard went on to become the first German minister of economic affairs and even became the German chancellor (like our prime minister). He wasn't very good at the latter though. Which isn't a surprise given how he dealt with the

unelected foreign bureaucrats ruling his country in 1948. Not to mention his pro-American views clashing with the emerging attempts to create the EU at the time.

In fact, General de Gaulle (left) criticised the Erhard government's alignment with Washington and its refusal to align with France and create an independent European policy. Erhard wanted a Europe of cooperating nation states instead of a supranational structure like the EU. His opponent Walther Hallstein won the argument and even became the first president of the European Commission. Hallstein's Nazi ties were later exposed, but let's not go there...

The Wirtschaftswunder of 1948 was extraordinary. And I think the parallels to Brexit Britain are very strong. At least they should and could be. I can't wait to find a German complaining about Brexit and point them out...

### **But What Does All This Mean for You?**

I'm telling you about all this because we should be optimistic about Britain's future. Brexit could be Britain's very own Wirtschaftswunder. Breaking free from overzealous, over-regulating, foreign, undemocratic rule of our economy.

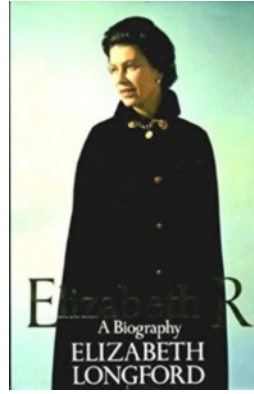
### A Letter to The Queen Re The Constitution

There are no independent scientific studies published in any reputed scientific journal in the world for one simple reason. It is impossible to independently verify that GMO crops such as Monsanto Roundup Ready Soybeans or MON8110 GMO maize perform as the company claims, or that, as the company also claims, that they have no harmful side effects because the GMO companies forbid such tests!



That's right. As a precondition to buy seeds, either to plant for crops or to use in research study, Monsanto and the gene giant companies must first sign an End User Agreement with the company. seeds from another company. Most alarming, they are prohibited from examining whether the genetically modified crops lead to unintended side-effects either in the environment or in animals or humans.

The only research which is permitted to be published in reputable scientific peer-reviewed journals are studies which have been pre-approved by Monsanto and the other industry GMO firms.

The entire process by which GMO seeds have been approved in the United States, beginning with the proclamation by then President George H. W. Bush in 1992, on request of Monsanto, that no special Government tests of safety for GMO seeds would be conducted because they were deemed by the President to be "substantially equivalent" to non-GMO seeds, has been riddled with special interest corruption. Former attorneys for Monsanto were appointed responsible in EPA and FDA for rules governing GMO seeds as but one example and no Government tests of GMO seed safety to date have been carried out.

All tests are provided to the US Government on GMO safety or performance by the companies themselves such as Monsanto. Little wonder that GMO sounds to positive and that Monsanto and others can falsely claim GMO is the "solution to world hunger."

In the United States a group of twenty four leading university corn insect scientists have written to the US Government Environmental Protection Agency (EPA) demanding the EPA force a change to the company censorship practice.

It is as if Chevrolet or Tata Motors or Fiat tried to censor comparative crash tests of their cars in Consumer Reports or a comparable consumer publication because they did not like the test results. Only this deals with the human and animal food chain. The scientists rightly argue to EPA that food safety and environment protection "depend on making plant products available to regular scientific scrutiny." 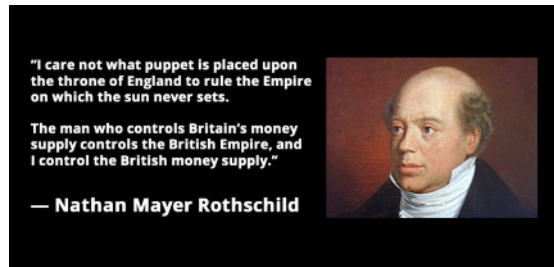
- Cryptos in general permit no chargebacks or refunds. Once the transaction is completed it's final. Reversing any transaction in a different manner is quite challenging at best.

## Chronic Electrical Illness (Part 2)

**I**N CITIES, EACH WIRE CARRIED ABOUT 0.02 AMPERE AND EXPOSURE WAS UNIVERSAL.

The London District Telegraph Company, for example, commonly had ten wires together, and the Universal Private Telegraph Company had up to one hundred wires together, strung above the streets and rooftops over a large part of town.

Although the apparatus and alphabet of London District differed from those used in America, the current through its wires fluctuated at a similar rate—about 7.2 vibrations per second if the operator transmitted 30 words per minute[7]. And Universal's dial telegraph was a hand-cranked magneto-electric machine that actually sent alternating current through the wires.

One enterprising scientist, professor of physics John Trowbridge at Harvard University, decided to put to the test his own conviction that signals riding on telegraph wires that were grounded at both ends were escaping from their appointed paths and could easily be detected at remote locations. His test signal was the clock at the Harvard Observatory, which transmitted time signals four miles by wire from Cambridge to Boston. His receiver was a newly-invented device—a telephone—connected to a length of wire five hundred feet long and grounded to the earth at both ends.

Trowbridge found that by tapping the earth in this way he could clearly hear the ticking of the observatory clock up to a mile from the

observatory at various points not in the direction of Boston. The earth was being massively polluted with stray electricity, Trowbridge concluded. Electricity originating in the telegraph systems of North America should even be detectable on the other side of the Atlantic Ocean, he said after doing some calculations. If a powerful enough Morse signal, he wrote, were sent from Nova Scotia to Florida over a wire that was grounded at both ends, someone on the coast of France should be able to hear the signal by tapping the earth using his method.

A number of historians of medicine who have not dug very deep have asserted that neurasthenia was not a new disease, that nothing had changed, and that late nineteenth and early twentieth century high society was really suffering from some sort of mass hysteria[8].

A list of famous American neurasthenes reads like a Who's Who of literature, the arts, and politics of that era. They included Frank Lloyd Wright, William, Alice and Henry James, Charlotte Perkins Gilman, Henry Brooks Adams, Kate Chopin, Frank Norris, Edith Wharton, Jack London, Theodore Dreiser, Emma Goldman, George Santayana, Samuel Clemens, Theodore Roosevelt, Woodrow Wilson, and a host of other well-known figures.

Historians who think they have found neurasthenia in older textbooks have been confused by changes in medical terminology, changes that have prevented an understanding of what happened to our world a hundred and fifty years ago.

For example, the term "nervous" was used for centuries without the connotations given to it by Freud. It simply meant, in today's language, "neurological." George Cheyne, in his 1733 book, *The English Malady*, applied the term "nervous disorder" to epilepsy, paralysis, tremors, cramps, contractions, loss of sensation, weakened intellect, complications of malaria, and alcoholism. Robert Whytt's 1764 treatise on "nervous disorders" is a classic work on neurology.

It can be confusing to see gout, tetanus, hydrophobia, and forms of blindness and deafness called “nervous disorders” until one realizes that the term “neurological” did not replace “nervous” in clinical medicine until the latter half of the nineteenth century. “Neurology,” at that time, meant what “neuro-anatomy” means today.

Another source of confusion for a modern reader is the old use of the terms “hysterical” and “hypochondriac” to describe neurological conditions of the body, not the mind. The “hypochondria” were the abdominal regions and “hystera,” in Greek, was the uterus; as Whytt explained in his treatise, hysterical and hypochondriac disorders were those neurological diseases that were believed to have their origins in the internal organs, “hysterical” traditionally being applied to women’s diseases and “hypochondriac” to men’s. When the stomach, bowels and digestion were involved, the illness was called hypochondriac or hysterical depending on the patient’s sex.

When the patient had seizures, blackouts, tremors, or palpitations, but the internal organs were not affected, the illness was called simply “nervous.”

Confounding this confusion still further were the Draconian treatments that were standard medical practice until well into the nineteenth century, which themselves often caused serious neurological problems. These were based on the humoral theory of medicine as set forth by Hippocrates in the fifth century B.C.

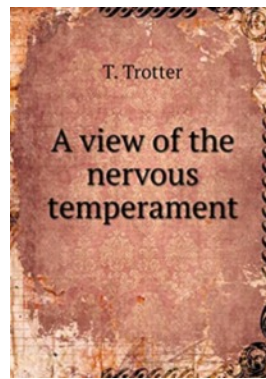
For thousands of years all sickness was believed to be caused by an imbalance of “humors”—the four humors being phlegm, yellow bile, black bile, and blood—so that the goal of medical treatment was to strengthen the deficient humors and drain off those that were in excess.

Therefore all medical complaints, major and minor, were subject to treatment by some combination of purging, vomiting, sweating, bleeding, medicines, and dietary prescriptions. And the drugs were liable to be neurotoxic, preparations containing heavy metals such as antimony, lead, and mercury being frequently prescribed. By the early nineteenth century, some doctors had begun to question the humoral theory of disease, but the term “neurology” had not yet acquired its modern meaning. During this

time the realization that many illnesses were still being called “hysterical” and “hypochondriac” when there was nothing wrong with the uterus or internal organs led a number of physicians to try out new names for diseases of the nervous system.

In the eighteenth century Pierre Pomme’s “vaporous conditions” included cramps, convulsions, vomiting, and vertigo. Some of these patients had total suppression of urine, spitting of blood, fevers, smallpox, strokes, and other illnesses that sometimes took their lives.

When the disease didn’t kill them the frequent bleedings often did. Thomas Trotter’s book, *A View of the Nervous Temperament*, written in 1807, included cases of worms, chorea, tremors, gout, anemia, menstrual disorders, heavy metal poisonings, fevers, and convulsions leading to death.



A series of later French doctors tried out names like “proteiform neuropathy,” “nervous hyperexcitability,” and “the nervous state.” Claude Sandras’ 1851 *Traité Pratique des Maladies Nerveuses* (“Practical Treatise on Nervous Diseases”) is a conventional textbook on neurology. Eugène Bouchut’s 1860 book on “l’état nerveux” (“the nervous state”) contained many case histories of patients suffering from the effects of blood-letting, tertiary syphilis, typhoid fever,

miscarriage, anemia, paraplegia, and other acute and chronic illnesses of known causes, some lethal. Beard’s neurasthenia is not to be found.

In fact, the first description anywhere of the disease to which Beard called the world’s attention is in Austin Flint’s textbook of medicine published in New York in 1866.

A professor at the Bellevue Hospital Medical College, Flint devoted two brief pages to it and gave it almost the same name Beard was to popularise three years later. Patients with “nervous asthenia,” as he called it, “complain of languor, lassitude, want of buoyancy, aching of the limbs, and mental depression. They are wakeful during the night, and enter upon their

daily pursuits with a sense of fatigue[9].” These patients did not have anemia or any other evidence of organic disease. They also did not die of their disease; on the contrary, as Beard and others were later to also observe, they seemed to be protected from ordinary acute illnesses and lived, on average, longer than others.

These first publications were the beginning of an avalanche. “More has been written about neurasthenia in the course of the last decade,” wrote Georges Gilles de la Tourette in 1889, “than on epilepsy or hysteria, for example, during the last century[10].”

The best way to familiarize the reader with both the disease and its cause is to introduce another prominent New York City physician who herself suffered from it—though by the time she told her story the American medical profession had been trying to find the cause of neurasthenia for nearly half a century and, not finding one, had concluded that the illness was psychosomatic.

## The Banker, The Model and The Jewish Spy Role Model on Trial (Part 2) From Our Hastings Correspondent



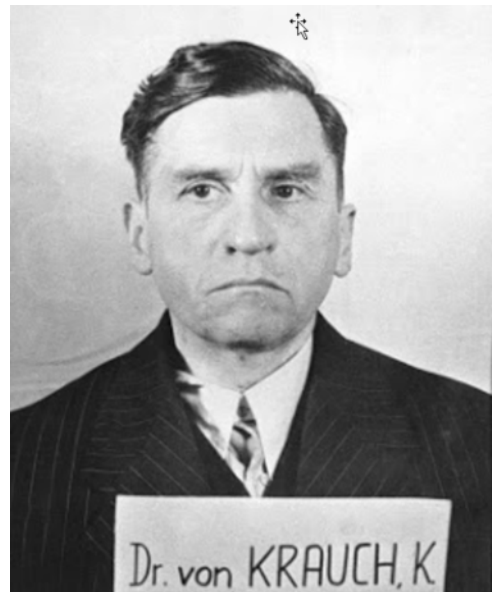
**F**ARBEN HAD MANY GOVERNMENT CONTRACTS during the Third Reich: the company’s importance to the war effort across Europe led to it being targeted for black propaganda rumours by a special subcommittee of Britain’s Political Warfare Executive.

A Farben subsidiary produced Zyklon B, the cyanide-based pesticide used to destroy lice that carried the deadly disease typhus. Since typhus was especially hazardous in crowded conditions such as prisons and concentration camps, Zyklon B was extensively used in camps such as Auschwitz – but in ‘Holocaust’ mythology it has come to be assumed that Zyklon B’s purpose was to kill Jews in homicidal gas chambers.

Hence Farben was demonised and many of its directors were put on trial at Nuremberg for ‘war crimes’. Nine were convicted, including supervisory board chairman Carl Krauch who was given a six-year sentence, and Walter

Dürrfeld, technical manager of IG Farben Auschwitz, who got eight years.

Similarly several leading German bankers were pursued by war crimes prosecutors. The most prominent were among the accused at the so-called ‘Ministries Trial’ at Nuremberg. Lutz Graf Schwerin von Krosigk Minister of Economics throughout the Third Reich, who had worked very closely with Abs, was sentenced to ten years. (His granddaughter Beatrix von Storch is now a deputy leader of the anti-immigration party Alternative for Germany – AfD.) Another of Abs’s most senior colleagues, Reichsbank vice-president Emil Pühl, was jailed for five



years, and Karl Rasche, director of one of Deutsche's rivals the Dresdner Bank, for seven years.

It is inevitable therefore that historians (whether or not they are highly partisan 'anti-nazis') have asked: why was Hermann Abs not among the defendants? He was in fact sentenced to 15 years *in absentia* by a communist court in Yugoslavia, but this could be put down to Cold War propaganda against the West. Elsewhere, until the World Jewish Congress succeeded in having him banned from the USA 45 years after the war, Abs had seemed untouchable.

3rd May 1945: Abs swiftly vacated his suite at Hamburg's Vierjahreszeiten (Four Seasons) Hotel immediately on the city's surrender to the British 7th Armoured Division – within hours the hotel had been converted into the new headquarters for Britain's occupying forces. For six weeks he prudently stayed out of sight, safely hidden at the nearby home of a friend. Yet when the British eventually tracked him down it was not to arrest him – despite his name being (for alphabetical reasons) at the very top of a list of wanted 'war criminals'. Instead the British wanted to recruit him to help rebuild Germany's postwar banking system!

To do so, the British had to protect Abs from their vengeful allies. A US intelligence report prepared for the War Department in March 1945 had featured Abs prominently among those financial and business leaders who "in an outstanding way thrived under National Socialism, ...aided the Nazis to obtain power, ...[and] shared the spoils of expropriation and conquest."

Jewish-American attorney Col. Bernard Bernstein was a partisan supporter of the Morgenthau Plan devised by his co-racialist Henry Morgenthau, President Roosevelt's Treasury Secretary, who aimed at the permanent destruction of Germany's industrial and technical capacity, despite an assessment that this would mean the deaths of 40% of German civilians. Bernstein had himself been a US Treasury Department attorney before being transferred to the Army as financial adviser to Allied Commander Gen. Dwight Eisenhower. Col. Bernstein led the American effort to put Abs on trial, sending a fellow Jewish officer, Maj. Andrew Kamark to interrogate him in the British zone.

This interrogation failed to obtain any evidence on which Abs could be charged, but by the start of 1946 continuing political pressure from the Americans, including threats to leak stories about Abs to the British press, meant that he had to be purged from his directorships and jailed. Even now, held in Altona prison in Hamburg, and later at the notorious Bad Nenndorf interrogation centre during the first half of 1946, Abs was locked up not so that he could be ill-treated in any way, but so that he could be kept away from the Americans.

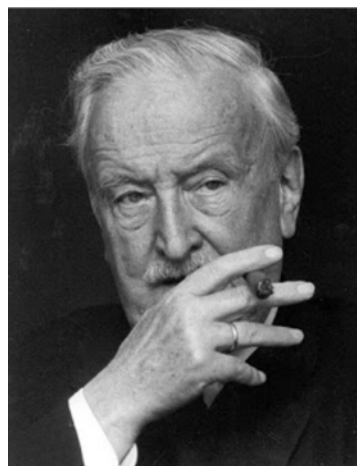
Predictably this saga has been interpreted repeatedly by Jewish historians and other partisan observers as a tale of “perfidious Albion” – of Britain deliberately ignoring evidence of Nazi criminality. This theme has been taken up in other contexts by Jewish polemicists attacking Britain for its postwar opposition to establishment of the state of Israel, and for recruiting Russian and Eastern European anti-communists for Cold War operations against Stalin. The late Prof. David Cesarani was especially outspoken, when campaigning for introduction of the War Crimes Act 1991: Cesarani’s first book published in 1992 condemning postwar British policy was entitled *Justice Delayed: How Britain Became a Refuge for Nazi War Criminals*.

These witch-hunters point in particular to Abs’s role at Deutsche Bank in the ‘Aryanisation’ of Jewish-owned banks, including Germany’s largest private bank, Mendelssohn & Co. The anti-Abs campaign began soon after the war, led by the anti-British US Senator Guy Gillette, an infamous supporter of Jewish terrorists in Palestine.

### **Hermann Abs Has Been Demonised by Authors Keen to Peddle Myths about a 'Fourth Reich'**

As recently as the Brexit referendum of 2016, echoes of the anti-Abs campaign resounded. Novelist and foreign correspondent Adam LeBor wrote two non-fiction books, a novel and [several articles about “nazi bankers”, fuelling the notion that the European Union was in some sense a fulfilment of “old nazi” dreams of a Fourth Reich](#). This theory was explicitly rooted in the so-called ‘Red House Report’, supposedly an account of a secret meeting of the Third Reich’s industrial and financial elite, held at the Maison Rouge Hotel in Strasbourg on 10th August 1944.

Three months later the supposed minutes of this meeting reached US military intelligence, via a French source.

According to this report, the German financial elite planned a “**secure post-war foundation in foreign countries... existing financial reserves must be placed at the disposal of the party so that a strong German empire can be created after the defeat**”. Front companies abroad would then carry out military research and intelligence tasks until a multinational, German-dominated empire could be rebuilt.

“Now,” the report’s author continued, “the Nazi Party stands behind the industrialists and urges them to save themselves by getting funds outside Germany and at the same time advance the party's plans for its post-war operations.”

LeBor treated the Red House Report as accurate, and some time later his story was regurgitated by the World Jewish Congress who in 2011 became the latest to 'discover' the Red House Report. This same yellowing paper has been sensationally 'rediscovered' at least three times during the last twenty-five years: by Adam Lebor in 1996; by the medical doctor and controversial historian Hugh Thomas in 2001; and by the World Jewish Congress in 2011.

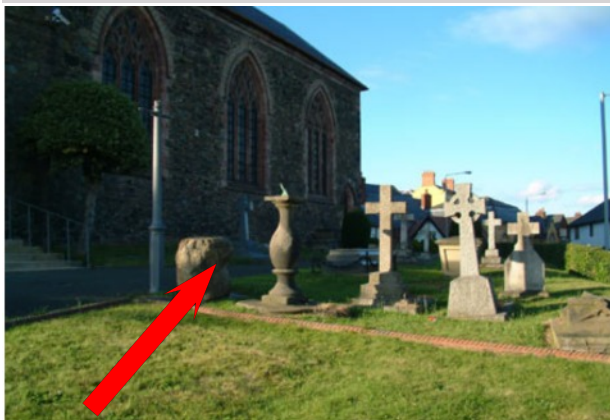
Yet there is no convincing evidence for its authenticity. It suited the interests of both Henry

Morgenthau and the Soviet Union in the mid-1940s, and was promoted by a Soviet asset in Roosevelt’s administration, Harry Dexter White, but even those mainstream historians who willingly swallow other wartime propaganda inventions now view the Red House Report with considerable scepticism.

It remains however very attractive to some pro-Brexit propagandists, especially because of Hermann Abs’ role in promoting European unity postwar. Not only was Abs instrumental in establishing the Deutsche Mark in 1948, giving West Germany a stable currency, he also became one of the leading advocates of what became the Common Market and later the European Union, and was a principal backer of Germany’s pro-European Chancellor Konrad Adenauer.

## **Prehistoric London Its Mounds And Circles By E. O. Gordon ( Published 1946 ) Part 25**

The Maen Llog must be placed in a central position and must be untouched by any tool. It is supposed to have the same symbolic significance as the sacred rock on Mount Moriah, that rises from the rocky platform of Mount Sion. The name Sion signifies stone, and Mount Sion, the Mount of the Stone, has been regarded from the time of David and Solomon as the most sacred ground in Jerusalem. The stone is still here on the original site.

Before the Holy City came into the possession of the Mussulman, the Christians regarded this curious monument of old Jerusalem as the “Rock of the Holy of Holies, and it must have formed

an essential feature of the Temple Area,” says Dean Stanley. The great unhewn mass of rock is believed to rest on one point of junction only, with the rocky platform of the Mount. Immense stress is laid by the Mohammedans on what they consider the miraculous suspension of the Stone above the Mount.

There is little doubt but that the venerable relic on the Temple Area in the Holy City was at one time a rocking stone, rocking in imitation of the movement of the Sacred Ark, and on this account was regarded by the Ancients as the type of the Ark; hence the origin of the term “Logan Stone” as applied to the rocking stones of Great Britain, and the Maen Llogan of the Welsh Gorsedd Circle!

Twelve Bards, one by each stone, guard the Gorsedd Circle to-day as in times past, and two Keepers of the Gate are stationed at the entrance, which is on the East side. The ground plan of the Welsh Circle is similar to that of Stonehenge.

At the entrance of the Circle may be seen three prostrate unhewn stones pointing outwards from the central “Maen Llogan”; these represent the ancient Kymric symbol of the Awen, or Holy Wings, the three rays or rods of light signifying the Eye of Light, or the radiating light of the Divine Intelligence shed upon the Druidic Circle.

In the Iolo MSS. (a selection from the ancient Welsh writings, published by the Welsh MSS. Society) the origin is given of this ancient hierogram, which analyses into the three bardic letters of the “ineffable name,” “I AM,” JHVH, JEHOVAH, answering to the Christian device of I. H. S., the emblem that has come down to us along the ages in the “Holy Wings,” the “Logos” or the “Voice” of the Supreme God.

On three occasions only in God’s Word do we find the utterance of the Divine Name mentioned—at the burning bush, in our Lord’s words, “Before Abraham was, I am,” and in the Garden of Gethsemane, when Our Lord said to those who had come to take Him, “I AM HE[8],” and the men and officers “went backward and fell to the ground.”

“The announcement of the Divine name is the first event traditionally preserved and it occurred as follows: ‘God, in vouchsafing His Name, said /\\ and, with the Word, all worlds and animations sprang co-instantaneously to being, and from their non-existence, shouting in ecstasy of joy /\\, and thus repeating the Name of the Deity.

Still and small was that melodious sounding voice (that is the Divine Utterance) which will never be equalled again, until God shall renovate every pre-existence from the primary utterance of which emanated all. lays and melodies, whether of the voice or of stringed instruments; and also all the joys, ecstasies, beings, vitalities, felicities, origins and descents, appertaining to all existence and animation.—Co-impulsive with the blessed were all animated beings, and God placed them in their innate order and primitive state, within the expanse of felicity,1 but He Himself existed in the expanse of felicity[9], where the blessed perceived Him in one communion of glory, without secrecy, without number and without species, that could be ascertained, save essential Light, essential Love and essential Power, for the good of all existences and

vitalities. Then the maxim, ‘God and Enough’ became established as the basis of truth and oral tradition, and it was the second principle of all realities and sciences transmitted by memory.” **Iolo M.S.**



The sacred symbol of the British Gorsedd, the three rays or rods, survive in two forms, in the three “feathers” (above) of the Prince of Wales, and in the “Broad Arrow” of the Government. When Edward III re-founded on the Windsor Table Mound the British King Arthur’s Order of the Round Table as a reward for those knights who had won for him his victories in France, he adopted the Gorsedd symbol, the sign of spiritual and temporal power of the ancient Keltic kings and priests, as the cognizance of his son, the Black Prince. In the form of three ostrich

feathers, the three golden rays have been borne from that time by successive Princes of Wales.

As a mark of the Royal Household, they first appear in 1386, and after 1693 were stamped on all Government stores. In our own day, we find the Awen, or Holy Wings, stamped by the Ordnance Survey as a landmark (in the form of the Broad Arrow) alike upon solitary mountain peak and kerbstone of crowded alley—the sacred symbol that proclaims from generation to generation the national faith in the eternal overshadowing of the Divine Wings.

The sign is still sacred among at least half of mankind. It is called the “Sul” throughout Judea. In India it is found employed as a caste mark, the trisul; “and his name shall be in their foreheads.” In earliest days every Druid wore the symbol of the ineffable name of the Deity, in gold rays on the front of his linen mitre.

Proceeded by the Regalia of the Order, the members assemble in the market-place, and, marshaled in procession according to their different degrees, wend their way to the Circle. The Arch-Druid, an impressive figure, takes up his position besides the Maen Llogan, raised above the others. Like the High Priest of old, he is clad in white, and wears a golden crescent-shaped breast-plate, symbolic of the Ark or Sacred Boat.

He wears a crown of bronze oak leaves round the linen cap upon his head, representing the sacred tree of the ancient Druids. The Druid priests, like their chief, are clad in white, the Bards in blue, symbolic of celestial love, the Ovates in green, signifying the growth of the human intelligence in the circle of the arts and sciences.

The Welsh Bards thus characterize the Druidical Orders in reference to their costume. They describe the Bards as “wearers of the long blue robes”; the Ovates as “having a place in the assembly with their robes of bright green”; and the Druids as the “splendid race-wearers of gold chains—the eminently white.” So conservative is the Order that to this day the same coloured vestments continue to be worn.

Nor must we omit to describe the magnificent Regalia of the Eisteddfod borne in the procession of the Order, before the Arch-Druid. In

commemoration of the late Queen’s Jubilee the original Regalia, which had disappeared, was replaced on traditional lines under the direction of Professor Herkomer.

Next to the Sword, surmounted by its crystal and emblematic dove, the most striking object is the Hirlas Horn of most ancient symbolism and significance. The Hirlas bore three attributes, viz. authority or might, the loud voice of the sun and its beneficent effects of causing abundance upon the earth. The Hirlas was the chief emblem of the strength of the Creator through the sun, which, at the time of the institution of the Order, rose in Taurus. The sun’s rays were represented by the horns of a buffalo pattern.

In Welsh, a horn is called “corn,” and a crown is called a “coron.” In the Bible the horn is alluded to as the emblem of might and power and as the cause of the juice in fruits. The Hirlas Horn was used by the Druids as a sacramental vessel, out of which they drank the first fruits of the sacred Apples, viz. Cider, and afterwards wine, and as each drank out of the Hirlas Horn he bowed to the sun his thanksgiving.



One of the Bards of the Neath Valley alludes to the ceremony. There is no doubt our custom of drinking healths is a survival of the holy ancient Bardic custom. In this we have also the origin of passing the wine in the path of the sun. The most historic Hirlas Horn was presented to Henry Tudor by Sir Rhys ap Thomas and the Gentlemen of Wales, who had been instrumental in placing him upon the throne of his Keltic ancestors. It is reputed to be the work of Torrigiano, the Italian artist, who designed the Tomb of Henry VII in Westminster Abbey, and is now in the possession of the Earl of Cawdor, a lineal descendant of Sir Rhys ap Thomas.

When all have taken up their respective positions within the circle, four long blasts of a silver trumpet announce the fact to the vast concourse. The Arch-Druid, with uplifted, outstretched arms, then proceeds to open the congress with the Gorsedd prayer, reputed to be as old as the Institution.

The translation of this magnificent invocation gives no sort of idea of the rhythmic grandeur of the sublime utterances, as petition after petition is poured forth in the sonorous tones of the Welsh language. With Arnold we may find here, and in Keltic literature generally, “traces of a kinship, and that the most essential sort of kinship, spiritual kinship, between us and the Kelt, of which we never dreamed.”

At the moment of prayer all the twelve Bards, the guardians of the twelve stones, bow the head towards the Arch-Druid, and the resemblance of the scene to the Great White Throne described in the Revelation is most startling.

The mysterious reverence, awe and silence that holds the vast multitude spellbound, whilst the historic “solemnities” of the Order are proceeded with, gives one an idea of the influence that such “solemn assemblies” must have exercised upon the nation at large in past times.

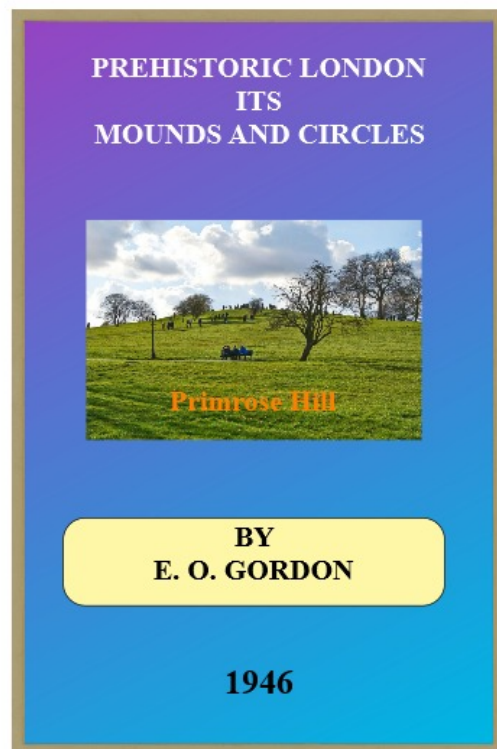

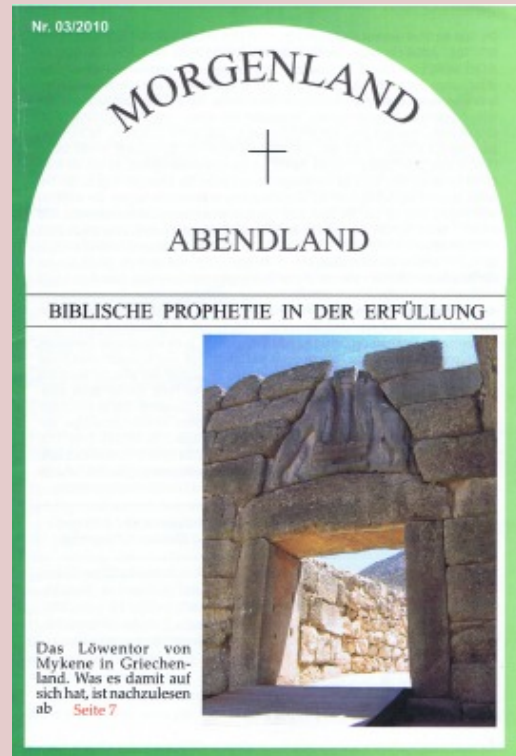
