# The Exclusive Covenants (Part 5)

Of Covenant Theology: Documenting the Bible's Commandment of Racial Segregation

## Part 3: Racial Exclusivity Confirmed in the New Testament

*"I am Yahweh. I change not. Therefore,*

*you sons of Jacob are NOT consumed."* – **Malachi 3:6.**

*"Has God forsaken His people, Israel? God forbid! For I am an Israelite, of the tribe of Benjamin."* - **Romans 11:1.**

**T**HE BOOK OF MATTHEW opens with Yahshua's genealogy. The whole point of this genealogy is prove that Jesus is a direct, racial descendant of David. The prophets declared that the Messiah must be a son of David. (II Sam. 7:11-16; Isa. 9:6-7; Isa. 11:10-13; Matt. 1:1; Acts 2:29-30; Romans 8:29-32.) Matthew and Luke provide proof of this line of descent.

The Gospel of Luke (Luke 3:23-38) gives a more extensive genealogy of Jesus Christ, giving His line of descent, through David, all the way back to Adam and Yahweh. Messiah is also called "son of Man," which means that He is also a pure-blooded descendant of Adam, the one who shows blood in the face.

John 7:35. The Pharisees acknowledge that the Lost Tribes still exist and are scattered throughout the Greco-Roman world.

John 8:32-47. The Edomite Jews expose their non-Israelite sperma. (*'Seed'* comes from the Greek word *sperma*.) There is no such thing as spiritual sperm. John 8 cannot be spiritualized. The discussion here is about literal descendants and the false Jewish claim to being the descendants of Abraham.

Since these Pharisaic Jews admit that they were "*never in bondage to any man,*" Christ tricked them into admitting that they are the descendants of Esau.

## Some Common Misperceptions of Paul's Epistles Corrected

In this section, I will deal with some of the horrible translations of the King James Bible. King James "authorized" this version with the explicit intention of negating the influence of the **Geneva Bible**, and other versions, which were not approved by the Anglican Church.

His motivation was to unify church and state under himself, so as to have authority over both. Englishmen who did not buy into his version were severely persecuted.

In fact, the Pilgrims and Puritans were Britishers who fled away from the tyranny of King James. The Bible they brought with them to America was the Geneva Bible. They had no use for the "Authorized Version."

It was in response to this ecclesiastical tyranny of King James, still fresh in the memory of the Founding Fathers, that they created the so-called "Separation Clause" of our Constitution, which states that, "*Congress shall make no law with respect to the establishment of religion or the free exercise thereof.*"

Space and time do not permit a thorough analysis of the deliberately universalistic and spiritualised passages contained the New Testament of the KJV. A few important pericopes will be considered.

## Romans, Chapter 9.

Because of the false definition of the word '*Gentiles,*' many Christians falsely believe that Jesus came to redeem non-Israelites. Contrary to this notion, Paul, in Romans 9 is actually confirming the exclusivity of the Covenants (Rom. 9:3-5) and confirms that **Esau is excluded** from the Covenants (Romans 9:7-15. "*Esau I have hated.*"). Romans 9 is actually a confirmation of John 8, where the racial distinction between Israelites and Edomites is declared. The Israelites are the "*vessels of mercy,*" (Verse 23) while the Edomite Jews are the "*lump of dishonor.*" (Verse 21.)

The correct translation of Verse 24 is this: “*Even US, whom He has called, not of the Judeans only, but also of the Race [ethnos]?*” Verse 25 confirms that he is speaking exclusively about the race of Israel.

## Endless Genealogies

The genealogies that Paul criticizes at I Tim. 1:4 and Titus 3:9 are **NOT** references to Israelite genealogies. Paul is here criticizing the endless genealogies among the Greeks and other Dispersed Israelites. The Dispersion (James 1:1) consisted of many estranged Israelites. “I am not sent but unto the estranged [or exiled] sheep of the House of Israel.” - Matt. 15:24.

Many of these estranged Israelites had adopted heathen practices and claimed to have descended from the “gods” of the various nations within which they lived. This is what Paul is criticizing in these passages. He is not challenging the genetic code of True Israel. In fact, Paul goes out of his way to assert that he is an Israelite of the Tribe of Benjamin. (Romans 11:1-2.)

The reference in Titus 3:9 and 1 Timothy 1:4 in which Paul denies the need to search out one's own genealogy, does not conflict with Isaiah's call to Israel. Herod the Tetrarch had ordered the burning of those genealogical records of Israel which were kept in the archives of the Temple, to protect his own rulership.

He himself was an Idumean, and therefore he feared any investigation into ancestral records. At that time, of course, the Pharisees were frantically trying to retrace their genealogies in order that they could continue to boast about their ancestry.

Paul was also well aware of the class distinction, which would arise when the "heathenised" Israelites, having lost all their records in the captivity, would be joined to the [Assembly](#).

This discussion of endless genealogies shows that the subject is not the genealogies of the Israelites, but the genealogies of the pagan Greeks:

Some even claim that people who believe in British-Israel “... give heed to fables and endless genealogies, which minister questions, rather

than godly edifying which is in faith:” (1 Tim 1:4; Titus 3:9). Is this true?

Answer: First, the Bible is loaded with genealogies. All one has to do is look into the books of Genesis, Numbers, 1 Chronicles etc. and even the New Testament Gospels to see all the genealogies of the people of Israel, and the world in Genesis. Doesn't this contradict what Paul is saying? Absolutely Not!

The genealogies that Paul is speaking of are not the Biblical genealogies, but are, “...found in Philo, Josephus and the book of Jubilees, by which the Jews [sic, Judahites and Israelites - Eli] traced the descent from the Patriarchs and their families, and perhaps also to Gnostic ‘genealogies’ and orders of aeons and spirits.

Amongst the Greeks, as well as other nations, mythological stories gathered around the birth and ‘genealogy’ of their heros [hence Paul's reference to ‘fables’]. Probably Jewish ‘genealogical’ tales crept into the Christian communities” (Vines Expository Dictionary, p.262).



Clearly these are not the Biblical genealogies Paul was speaking of. Josephus (Above) “appeals to the priestly registers and is proud of the royal descent of his mother; he shows that even the priests residing in Egypt had their sons registered authentically in Jerusalem, so as to safeguard their priestly prerogatives (C. Apion., I, vii). (The Catholic Encyclopaedia, under article “Genealogy”). Philo, “to the various stories and fables told about Moses and the Patriarchs” (ibid).

As for the Gnostics, “[These were] genealogies of spirits and aeons, as they called them, “Lists of Gnostic emanations” [ALFORD]. So TERTULLIAN [Against Valentinian, c. 3], and IRENÆUS [Preface]...Endless” refers to the tedious un-profitableness of their lengthy genealogies (compare Tit. 3:9). - **Peter Salemi**,

Hence, Paul’s condemnation of genealogies concerns the existing mythical genealogies of the Dispersion as well as those of the emerging anti-Gospel sects, whose “genealogy” was traced back to the Gnostic aeons.

Not all of the Gnostic sects were anti-Christian, but most of them added ideas and ideology that were either spurious or anti-Gospel. Thus, serious scholarship proves that Paul has no intention of negating the genealogies of Matthew and Luke. Nor do these passages have anything to do with denying the racial genealogy of the Israelites, past, present, or future.

### **Circumcision Versus Un-Circumcision**

Contrary to the doctrine of the Judeos, Paul, in Romans 2-4, is NOT asserting that the “un-circumcision” refers to “Gentiles,” or non-Israelites. Rather, Paul is distinguishing between the Israelites of the House of Judah, then living in Palestine (the “Circumcision”), versus the Dispersed Israelites (House of Israel) scattered throughout the Greco-Roman world (the “Un-circumcision”).

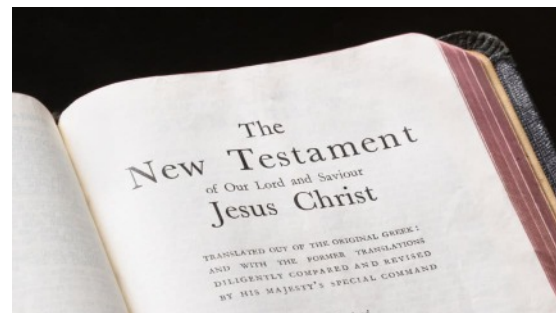
Remember that the rite of biblical circumcision was made exclusively with the posterity of Abraham, Isaac and Jacob. No other peoples are included in this Covenant.

The Circumcision are the Israelites who still practiced circumcision, as the Levitical priesthood still existed in Judea, but it had been commingled with Edomite Pharisees.

The Dispersion, adopting the customs of the nations in which they lived, stopped practicing circumcision. Therefore, the Israelites of the Dispersion are the U-ncircumcision. This is what Paul means by his usage of these two words. Paul is trying to explain that both groups of Israelites, circumcised or not, were forgiven for their past sins at the Cross. Because that

promise was given exclusively to the Progeny of the Chosen People, it has nothing to do with any other people, nor can any other people claim the benefits of inheritance. We have here another example of expert word twisting at the hands of the KJV translators, who, by conveying the notion that “Gentiles” are non-Israelites, make the Gospel of none effect.

The history of the laws of inheritance proves that no one but those specifically named in the Will (Testament) can be a party to the Will. No outsiders are ever invited to the reading of the Will.



It is none of their business! The New Testament is the story of the delivering of the Will to its intended recipients, namely, the two Houses of Israel. (Jer. 31.) But most Israelites are still clueless that this Will even applies to them.

The Epistles of Paul document his strenuous efforts to 1.) explain to the Un-circumcision that they are a Party to the Covenants and 2.) explain to the Circumcision that their forgiveness is a direct result of the unconditional promise to Abraham, Isaac and Jacob that all of these direct descendants will get this inheritance, whether they practice circumcision or not, whether they live in or outside of Judea.

Thanks to the poor translations of Paul’s writings, as found in the KJV, Paul’s words have been universalised; but this universalisation is totally contrary to the specificity of the Covenants themselves.

Paul, throughout his Epistles, is constantly explaining to members of both Houses that the unconditional promise to forgive Israelites of their sins (via the sacrifice on the Cross) applies to both categories (“Houses”) of Israelites, the circumcised and the uncircumcised. Since the Judeos know nothing of the actual history of the Dispersion, they are forced to make wild

speculations that defy the categorical imperatives of Covenant Theology.

There is **NO WAY** that Paul is extending the terms of the Covenants, Promises and Inheritance to anyone else. Paul did not have such authority. Paul did not claim such authority; nor did he do any such thing. The idea that Paul universalised the terms of the covenants to all peoples and races is pure balderdash. It is a total distortion of the Gospel. The devil himself could not have created a more devious, anti-Scriptural doctrine. Actually, he did create it.

Remember that Jeremiah 31 prophesied that the New Covenant would be made to **Both Houses**. Thus, the two houses have been reunited, as also prophesied by the Two Sticks prophecy of Ezekiel. Christ's Passover sacrifice on the Cross **Did Not** unify all races, as the apostate churches claim today.

No Israelite in Scripture has ever made such a claim. This claim is totally contrary to the entire history of the covenants, promises and inheritance, which are exclusive to the posterity of Abraham, Isaac and Jacob. There is simply no doubt about this.

When Abraham placed his son, Isaac, on the sacrificial altar, Isaac's progeny were thus being dedicated to Yahweh. Only Isaac's descendants can qualify for this promise. "In Isaac shall thy seed (progeny, descendants, posterity) be called." Only the Anglo-Saxons have ever been called by Isaac's name.



This is a very specific branch of the Adamic Race. The rest of the world will be blessed as long as they bless us. They will be cursed if they curse us. Because the Jews have successfully trained the world to bless them and curse us, we have patent evidence of why the world is going to hell in rapid fashion. This deluded world is blessing the progeny of Satan.

The beginning of America's precipitous decline into moral degradation began the moment that

President Truman recognized the Bastard State of Israeli, that illegitimate, hybrid child of Khazar and Edomite parents, who claim descent not through the patriarchs of Israel but through their hybrid mothers.

There is a direct, causal relationship between Truman's recognition of that Luciferian State and the chaos that we have descended into since. Since then, American Israel has allowed all sorts of non-Whites to enter into our borders, thus violating all the laws of segregation that Yahweh has commanded us to follow. **Israel Is to Dwell Alone**. We cannot dwell alone in an integrated society.

Jesus Himself declares that, when He returns to judge the nations, He will **Separate** them, not integrate them: "When the Son of Adam shall come in His glory, and all the holy angels with Him, then shall He sit upon the throne of His glory: And before Him shall be gathered all nations: and He shall **Separate Them One from Another**, as a shepherd divides sheep from the goats." - **Matthew 25:31-32**.

Since the Jews reckon their genealogy through the various mothers of their breed, most of whom have little or no Israelite blood, they cannot possibly be the Israel of Scripture. This matriarchal reckoning is totally contrary to the **PATRIARCHAL** reckoning of genealogy of True Israel, which is amply documented in the Bible.

Paul confirms the law: "But we know that the law is good." Jesus was "born of a woman, according to the Law." (Gal. 4:4) This means that His genealogy is purely Adamic, through the patriarchs. His mother, Mary, was also of royal blood, being descended from David.

Joseph, his legal father, or "stepfather," was also a descendant of David. Therefore, Yahshua's genealogical descent is totally in conformity with Hebrew law and the Covenants. His genealogy is **Perfect**, just as Noah's was. Mary's genealogy is reckoned through her father, Heli, at Luke 3:23.

Heli was Mary's father and became Joseph's father-in-law. Since the expression, "father-in-law" was not in common usage, verse 23 simply declares Joseph to be the "son of Heli." Jesus said, "I am the **Root** and the **Offspring** of

David.” (Rev. 22:16.) Because Mary was a descendant of David, so was Yahshua.

It is amazing that the Jews claim that Jesus could not have been the Messiah because He did not have an earthly father – while they themselves reject the patriarchal lineage!!! This is nothing but incredible sophistry and hypocrisy! But the prophecy concerning the Messiah simply states that He will be the offspring of David.



And David’s genetic code was transmitted to Yahshua through Mary. That is the bottom line. Furthermore, who better than the Holy Spirit could be your father?

From Wikipedia, which is a Jewish-owned service, we are told, under the heading of “Who Is a Jew?” According to Halakha (Jewish law), only a convert or a child born to a Jewish mother is counted as Jewish. A child with a Jewish father and a non-Jewish mother is considered a non-Jew.

So, who are the Jews to criticize Christ’s genealogy when they themselves admit that they do not follow a patriarchal reckoning? Hypocrisy, thy name is Judaism!

### **Israel, the Anointed People, Both Judah and Israel**

“And many of the people believed on him and said, When Christ [Messiah] cometh, will he do more miracles than these which this man hath done?”

The Pharisees heard that the people murmured such things concerning him; and the Pharisees and the chief priests sent officers to take him. Then Jesus said unto them, Yet a little while am I with you, and then I go unto him that sent me. Ye shall seek me and shall not find me: and where I am thither ye cannot come.

Then said the Jews among themselves, Whither will he go, that we shall not find him? will he go unto the DISPERSED among the Gentiles (Nations) and teach the Gentiles?” – John 7:35.

This verse proves that even the rabbis of His day understood that the Dispersed Tribes were scattered throughout the Greco-Roman world.

The Judahite scribe, Josephus, tells us “...wherefore, there are but two tribes in Asia and Europe subject to the Romans, **While the Ten Tribes** are beyond Euphrates till now, and are an immense multitude, and not to be estimated by numbers.” Antiquities of the Judahites, Book XI, chapter V, Para. 2.

II Esdras 13:39-46: “Those are the Ten Tribes, which were carried away prisoners out of their own land in the time of Osea the King, whom Salmaneser the King of Assyria led away captive.”

The Book of James opens with this dedication: “To the **Twelve Tribes Scattered Abroad, Greetings.**”

Psalm 20:5-6. “WE will rejoice in Your salvation... The Lord saveth His anointed.” Jesus is the Savior, not the one to whom salvation was promised. Get it?

Psalm 28:8-9: “Yahweh is **Their** strength, and He is the saving strength of His **Anointed**. Save your people and bless Your Inheritance: feed **Them** also, and lift **Them** up forever.”

II Esdras 711: “Even so also is Israel’s portion. Because for their sakes I made the world; and when Adam transgressed my statutes, then was decreed what now is done.”

I John 2:27: But the anointing which ye have received of him abideth in you, and ye need not that any man teach you: but as the same anointing teacheth you of all things, and is truth, and is no lie, and even as it hath taught you, ye shall abide in him.

These examples prove conclusively that the word ‘anointed’ does not always refer to the individual, Christ Jesus. The KJV often mistranslates ‘anointed’ as referring to the person of Yahshua, when it in fact refers to the **Anointed People**, the whole house of Israel,

meaning all twelve tribes. It clearly does not refer to Yahshua in Gal. 3:28.

**2 Cor. 1:20-22** “Now He who establishes us with you in Christ and has anointed us is God, who also has sealed us and given us the Spirit in our hearts as a guarantee.”

Paul is directly referencing the promise of the New Covenant in Jer. 31. Here is the true promise of salvation, as it applies to True Israel: Only those Israelites of Adam-kind, through the redemption at the cross and the restoration of His Remnant at the Second Coming, will inherit immortal flesh bodies, protected by the Holy Spirit. This is the true meaning of “salvation,” for Israel and the White Race.

The other races, which were indeed created by Yahweh Elohim, will continue to exist; but they will no longer inhabit our lands. The Law of Segregation will be forever enforced. Hybridisation will henceforth be a capital offence and will be punished accordingly. Here is how Isaiah puts it:

“Therefore I will shake the heavens, and the earth shall remove out of her place, in the wrath

of Yahweh of hosts, and in the day of His fierce anger. And it shall be as the chased gazelle, and as a sheep that no man (#120, awdawn) takes up: they shall every man (#376, iysh, mortals of all races) turn to his own people, and flee every one into his own land.” - Isa. 13:13-14.

The Blacks will go back to Africa. The Orientals will go back to China. The Mexicans will be sent back to Mexico. The Jewish Viper State will be wiped off the face of the map; and we Adamites will keep the lands that Yahweh has given to us. And there will be peace and prosperity everywhere, after Adam-kind gets restored to the condition intended for our parents, Adam and Eve. There will be no more race-mixing! Praise Yahweh! Matt. 25:32-33 confirms Isa. 13:13-14.

## Old Testament

### “Word for Word” Deuteronomy Part 22

#### Translation by Stephen Howard Anderson



## Chapter 29

1. And called Mosheh to all Yis'rael, and said to them: "You have seen all that did Yahweh in your sight in the land of Mits'rayim to Par'oh 6547, and to all his servants, and to all his land;

2. and the great tests 4531 that saw your eyes,

the signs 226, and those great wonders 4159:

3. and has not given to you Yahweh a mind 3820 to know, and eyes to see, and ears to hear, until this day?

4. I have led 1980 you forty years in the wilderness: and your clothing 8008 has not grown old 1086 upon you, and your shoes 5275 have not grown old upon your feet;

5. and bread 3899 you have not eaten, and wine 3196 or strong drink 7941 you have not drunk 8354: so that you might know I am Yahweh Eloheychem.”

6. And when you came into this place, Siychon the king of Chesh'bon and Og the king of Bashan met us for battle, and we smote them:



7. and we took their land, and gave it for an inheritance to the Rubeniy 7206 and the Gadiy 1425, and to the half tribe of the Menashshiy 4519.

8. Therefore keep the Words of this Covenant, and do them, so that you may prosper 7919 in all you do.

9. You stand this day, all of you, before Yahweh Eloheychem; your chiefs 7218 of your tribes 7626, your elders 2205, and your officers 7860, all the men of Yis'rael,

10. and your little ones 2945, your wives, and the alien sojourner 1616 that is within your camp, from the hewer 2404 of your wood, to the drawer 7579 of your water:

11. that you pass over into the Covenant of Yahweh Eloheycha, into the oath 423 that Yahweh Eloheycha makes with you this day:

12. so that He may establish 6965 you today as a people, and to you He shall be Elohiym, as He spoke to you, as that He swore to your forefathers, to Ab'raham, to Yits'chaq, and to Yaaqob.

13. Nor with you alone 905 do I make this Covenant, and this oath;

14. but with those that exist 3426 here 6311 with us to stand today before Yahweh Eloheynu, and with those that are not here with us today.

15. Because you know that we have dwelled in the land of Mits'rayim, and that we passed through the nations that you passed through;

16. and you have seen their abominations 8251, and their idols 1544, wood and stone, silver and gold, that were among them:

17. lest there exist with you a man, or a woman, or a clan, or a tribe, that their hearts turn away today from Yahweh Eloheynu, to walk after and serve the elohey of these nations, lest there exist among you a root 8328 that bears 6509 gall 7219 and wormwood 3939.

18. And it might be, when he hears the words of these curses 423, that he blesses 1288 himself in his heart, saying, "Peace shall be with me, though in the stubbornness 8307 of my mind I

walk, that I may snatch away 5595 the watered 7302 and the thirsty ground 6774."

19. Yahweh will not spare 5545 him, because then shall smoke 6225 the anger 639 of Yahweh and His jealousy 7068 against that man, and shall lie 7257 upon him all the curses that are written in this scroll, and shall blot out 4229 Yahweh his name from under the sky.

20. And shall separate 914 him Yahweh for harm 7451 from all the tribes of Yis'rael, according to all the curses of the Covenant that are written in this scroll of the Torah 8451.

21. Shall say the generation 1755 of children that shall rise up after you, and the racial alien 5237 that comes from a land far away, and sees the plagues of that land, and the sicknesses that has made Yahweh there;



22. "Sulfur 1614, and salt 4417, and burning 8316, is the whole land, and it is not sown 2232, and does not produce 6779, nor comes up any grass 6212, like the overthrow 4114 of Sedom 5467, and Amarah 6017, and Ad'mah 126, and Tseboyim 6636, that overthrew 2015 Yahweh in His anger 639 and rage 2534. "

23. Shall say all the nations, "Upon what grounds has Yahweh done this to this land? Why the heat 2750 of this great anger?"

24. And shall say men, "Over that they forsook the Covenant of Yahweh Elohey of their forefathers, that He made with them when He brought them forth from the land of Mits'rayim:

25. and they went and served other elohiym, and prostrated before them, elohiym that they did not know, and had no portion 2505 in:

26. and was kindled 2734 the anger Of Yahweh

upon this land, to bring upon it all the curses 7045 that are written in this scroll:

**I**T IS GOD THAT CAUSES THE HEATHEN TO SWALLOW US UP, but if we obey God He will give us the might to swallow them up, i.e. rule them, be the head, then drive them out “. 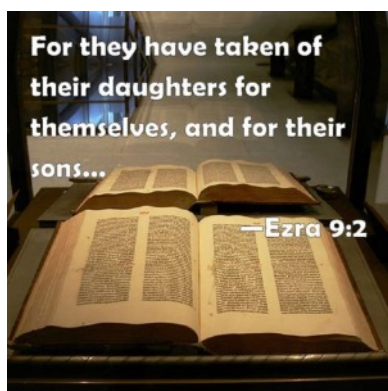

## Chapter 9 Back to Basics

**LIKE THE EASTERN BRANCHES OF PROTO-CELTS SOME 4000 YEARS AGO,** the Western branches of Indo-Europeans were ready, since the Middle Ages, to build their empires. When you read on in this chapter of Revelation, you will read that the fruit of this deal results in death for the Israelites. Only the over-comers would be spared, signified in verse 6.— "A measure of

**wheat—three measures of barley—and see thou hurt not the oil and the wine."**

### **The Greeks and The Hebrews (4)**

**I**NVENTORY OF POTTERY, from Hagia Triada, combines Linear A symbols with pictographs that show what types of vessels are being counted. In three cases (colour) when the author used the phonetic values established for the symbols by Ventris, he found the resulting words to be Semitic names for various pot types (see syllables and equivalents, right).

Even earlier a group of western Semites, speaking dialects closely related to Hebrew, came to control the ports and sea-lanes of the eastern Mediterranean. The Egyptians called them Keftiu; ancient Greek tradition refers to them as Phoenicians.

They were not concerned with affairs inland; their way of life was built around access to the sea. From the third millennium B.C. on these Semites were able to synthesize the accomplishments of the Egyptians, Mesopotamians and other talented predecessors. By 1800 B.C. the seafaring Semites were in control of the entire eastern Mediterranean, including the waters and shores of Greece, of Anatolia, of Syria, Lebanon and Palestine, and the Nile delta. They were not

the only seafarers present, nor did they inhabit every community throughout the region; they were, however, the controlling element that imposed order on the whole area.

Greek sources describe these Semites correctly as thalassocrats, or "sea lords." Since the prosperity of the seafaring Semites hinged on Mediterranean trade, they developed the island of Crete as their main base; it was closer than any other island to the continents of Europe, Asia and Africa.: Around 1800 B.C. the sea lords were in control of central and eastern Crete, and it was then that the great Minoan palaces were first built.

The main body of the Minoan invaders came to Crete from the Nile delta. It is quite possible that they were among the Semites forced out of the delta by the strong and nationalistic Pharaohs of the 12th Dynasty, who reunited the upper and lower kingdoms of Egypt. In any case the art and architecture of the Minoans reflect the warm climate of their homeland: the palaces are exposed to the elements and there are no built-in hearths to provide warmth. Later, when

the Mycenaean Greeks from the north inherited and modified Minoan civilization, they introduced the hearth.

The Minoans have a unique place in Western history. They nurtured the first high and literate culture on European soil. The earliest Greek civilization, the Mycenaean, was based directly on the Minoan culture. Before the Hebrews conquered Palestine around 1200 B.C. they, like the Minoans, were western Semites living in the Nile delta. Thus approximately the same eastern Mediterranean culture strongly influenced both Greek and Hebrew civilization, although the Hebrews did not depart from the Nile delta until some 600 years after the Minoans.

At some time after 1450 B.C. the Mycenaean Greeks seized Knossos, the urban centre of the Minoan thalassocracy. The Minoans held out in other parts of Crete, but it was clear that they would have to emigrate or face extinction. In order to base themselves in a more secure area many of the Semitic sea lords of Crete migrated with their followers to the Phoenician cities on the Levant coast, notably to Ugarit. In Ugarit, and perhaps elsewhere, the immigration brought a dramatic flowering of the arts around 1400 B.C. Among the manifestations of the upsurge at Ugarit was a new poetic literature that looked to Crete for its artistic roots.

Thereafter Semites and Greeks diverged for a considerable time, each group creating its own distinctive way of life out of a common heritage. One factor accelerating divergence was the succession of empires in the first millennium B.C.—Assyrian, neo-Babylonian and Persian—that engulfed the Near East but left European

Greece relatively untouched. By 500 B.C. a sharp eye and ear would have been required to detect the ancient bonds between -the Athens of Pericles and the Judah of Ezra. Yet the bonds had been there, as one further example will demonstrate.

The notion that sexual attraction is due to the fact that the two sexes were once one appears to have been current in the eastern Mediterranean before the emergence of either the Hebrews or the Greeks. When this concept is encountered in Greek literature—as in Plato's Symposium, in which Aristophanes says of the joining of man, and woman that the action reunites "our original nature, making one of two"—we ascribe it to philosophy. When woman is made from a part of Adam, however, and it is stated in Genesis 2:24 "Therefore man ... clings to his wife, and they become one flesh," we consider it divine revelation. That we do not at once recognize the common source of both concepts is attributable to our ingrained habit of keeping the two cultures in separate compartments.

Now that the first decipherment of Linear A are demonstrating anew that no such separate compartments exist, there is much to be expected from a united front in eastern Mediterranean archaeological studies. Perhaps the prime target area should be the Nile delta; in spite of technical difficulties, evidence may be unearthed there that will cast new light on the delta Semites who in successive waves established the first high culture in Europe and the first Hebrew commonwealth in Palestine.

## **The Lost Disciple** **Alan Wilson & Baram Blackett**

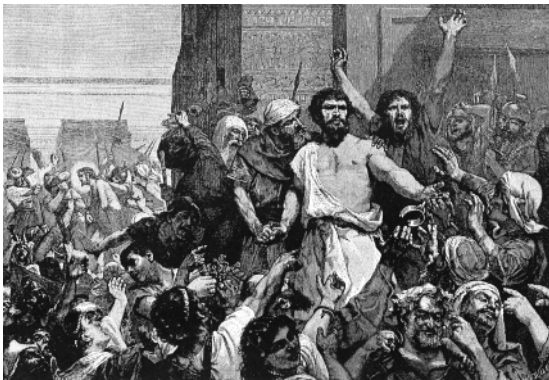

**THE ORIGINAL TWELVE APOSTLES ARE NAMED IN THE NEW TESTAMENT** as Simon (Peter), Andrew, James, John, Philip, Bartholomew, Thomas, Levi (or Matthew), James (the less), Jude (perhaps also named Thaddeus or Lebbaeus), Simon (the Zealot or Cananean) and Judas Iscariot. It is obvious that they fall into two main groups: those who were former disciples of John the Baptist and those who were members of Jesus's extended family. Of the former group are Simon Peter, his brother Andrew, Philip, and probably Bartholomew and Thomas. Family 3 members are Jesus's brothers James (the less), Jude, Simon the Zealot and Matthew/Levi, along with his cousins, James and John the sons of Zebedee. Judas Iscariot could be in either

group as he is described as the 'son of Simon' and it is not clear if this means that he is a son of Simon Peter, Simon the Zealot (Cananean) or some other Simon that we don't know about.

Thus at least six, possibly seven, of the original twelve were family members. However, there is one important name missing from the list of apostles and this is Jesus's other brother Joses (or Joseph) who, like James the less, is definitely named as being a son of both Mary and Alpheus. Why should he alone not have been included in the twelve?



### Barabbas

It seems to us that the answer to this question is hinted at in several places in the New Testament, most specifically in the Crucifixion story. When Jesus is being tried by Pilate, the latter is clearly willing to release him, making use of an alleged custom among the Jews that a prisoner of their choice should be freed at the Passover. However, the crowd shout out for someone called Barabbas, with the result that he, instead of Jesus, is released.

In the Gospel of St Matthew this Barabbas is described as a 'notable' prisoner (the adjective is actually *επισημου* (episemon), which means 'official', whilst St John calls him a 'robber'. The truth seems to be that he was a noted (that is, recorded) dissident, for in the Gospel of Mark it says: 'Now at that feast he released unto them one prisoner, whom they begged. And there was one named Barabbas with the rebels having been bound, who in the rebellion murder had done'.

The rebellion being spoken of was probably the event recorded by Josephus the historian of the Jews when Pilate, shortly after his appointment in AD 26, caused widespread commotion in Judea because he insisted on bringing Roman insignia into Jerusalem. Alternatively, it may have been another insurrection, also mentioned

in Josephus, that occurred shortly afterwards on account of Pilate's having spent 'sacred treasure' on building a new aqueduct.

This event led to many deaths when an angry crowd of demonstrators was clubbed into submission by Roman soldiers. It is possible that the Barabbas of the Bible was one of the ringleaders of this demonstration. In any event, the name Barabbas, which means 'son of the father', is surely a 'surname' that is intended to be understood descriptively and not as a personal name. The question is: what was Barabbas's personal name and who was the father of whom he was the son?

Now according to Lincoln et al, Barabbas's father was Jesus, the Jews being given a choice between father and son: the suffering Messiah or his heir. It seems to us that the 'father' in question is the patriarch of the Holy Family: Alpheus. We have seen that Jesus is a son of Mary but not of Alpheus, and that Mary had at least two sons, Jude and Joseph (Joses), who are stated as being Alpheus's children.

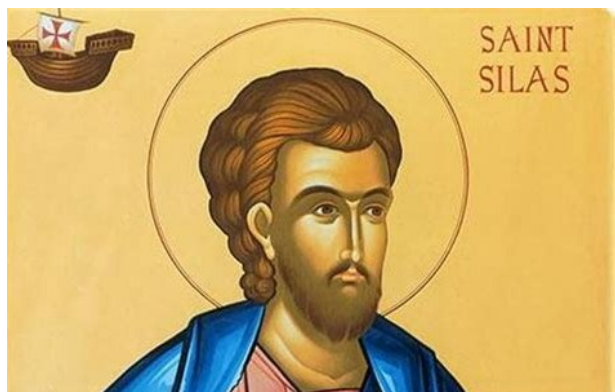
The 'son of the father' could therefore seem to be one of these and his most likely identity - indeed as we shall see the only possibility that makes any sense - is Joseph. If this is so, the choice being offered to the Jews by Pilate was between two brothers, one an unorthodox prophet (Jesus), the other a political prisoner (Joseph Barabbas, son of Alpheus).

If this is so, it makes sense that Joseph is not included in the list of apostles, for, unlike his brothers James, Simon, Levi and Jude, he would have been in gaol throughout most, if not all, of Jesus's ministry; not only that, but if he had indeed been the 'black sheep' of the family (a robber or even a political murderer), he may have been considered unsuited to the task of apostle. The next question, then, is: what happened to Barabbas after he was released?

A possible answer to this question can be found in the first chapter of the Acts of the Apostles, which describes how the disciples gathered together to elect a new apostle to take the place of Judas Iscariot, who, following his treachery, hanged himself. Two candidates present themselves: one is Matthias (who wins when the disciples draw lots) and the other is 'Joseph called Barsabas, who was surnamed Justus'. In Acts 15:22 there is a 'Judas surnamed Barsabas',



who is one of the 'leading men among the brethren'.



He is sent out with Silas to accompany Paul Antioch. If, as seems reasonable, we assume that Joseph and Judas Barsabas were brothers, it is worth looking at their surname, which is almost exactly the same as Barabbas.

We also know that Joseph, the son of Mary, had a brother called Jude, who was also a son of Alpheus or 'the father'. It would seem, therefore, that the Joseph Barsabas who applies for the seat vacated by Judas Iscariot, and Barabbas, the now free former revolutionary, are one and the same person. He is Joseph, son of Alpheus and brother of St Jude.

There is, however, another candidate for the identity of Joseph, the brother of Jesus, and this is someone called Joses (Joseph) Barnabas. He also asked to be made an apostle, and to persuade the others to accept him, he sold a field and laid the money he received for it at their feet: 'And Joses, who by the apostles was surnamed Barnabas, (which is being interpreted, The son of consolation,) a Levite, a Cypriot by birth, having land sold it, and brought the money, and laid it at the feet of the apostles'.

The story of how Barnabas became an apostle is deeply symbolic, for when Judas betrayed Jesus, he did so for a payment of thirty pieces of silver. Feeling remorse for what he had done, or perhaps realizing that no amount of money would make up for the fact that he was now an outcast, Judas sought to return the silver to the priests who had paid him: 'And he cast down the pieces of silver in the temple, and departed, and went and hanged himself. And the chief priests took the silver pieces, and said, It is not lawful for to put them in the treasury, because it is the price of blood.

And they took council and bought with them the potter's field, to bury strangers in.'

The sale of a piece of land by Barnabas and his giving the money as a donation to the apostles would seem to be some sort of recompense, a recognition that the debt of Judas needed to be paid off if he were to take over his seat. It seems likely that Joseph Barsabas and Barabbas are one and the same person.

If so, we can understand why his surname may have been changed again to Barnabas, meaning 'son of consolation'. A clue to this is a curious scene that takes place at the end of Jesus's Crucifixion, in which he apparently gives away his mother for adoption to a disciple, who is generally recognized as being St John the Evangelist.

Now there stood by the cross of Jesus his mother, and his mother's friend Mary, the wife of Cleophas, and Mary Magdalene. And when Jesus therefore saw his mother, and the disciple standing by, whom he loved, he saith unto his mother, Woman behold thy son. Then he says to the disciple, Behold thy mother. And from that hour the disciple took her to his own home.

There are several things to be said about this scene. First of all, the word translated as 'home' does not mean this. In the Greek it is ἰδία (idia), which seems to be a play on the word ἰδε (ide), meaning 'behold'. A more correct translation might be that the disciple in question took Mary to his own 'beholding' - that is, he recognized her for what she was: his mother.

Second, we don't know that it was John, the author of the Gospel, whom Jesus was addressing as the disciple 'whom he loved'. John was in no more need of adoption than Jesus's mother, Mary, who had other children to turn to.

However, if the beloved 'disciple' in question was really Jesus's brother Joses and he is identified as Barabbas, this passage makes sense. Having been recently released from a death sentence, he would probably still have been in a very emotional state. We can imagine him being filled with guilt and remorse at seeing Jesus's death and hesitating from coming too near the

Cross. Mary, meanwhile, would have been torn in half. On the one hand she would have been filled with grief at seeing the Crucifixion; on the other she would have been relieved that her wayward son Joseph/Barabbas had been set free. Neither son nor mother would have known how to deal with each other in these difficult circumstances. In our interpretation, it appears that in calling on his ‘beloved disciple’ to behold his mother, Jesus is effecting a reconciliation. Having Joseph, her lost son, back with her would indeed have been some considerable ‘consolation’ for Mary and we can see why his name would have been changed from Barsabas (or Barabbas) to Barnabas (son of consolation).

In any event Josès Barnabas later accompanied Paul on many of his journeys, including the one to Antioch when they went in a party that included Jude Barsabas. This makes it seem even more than likely that Josès Barnabas was the same person as Joseph Barsabas, who was a brother of this Jude.

Identifying Barnabas as Joseph, son of Mary and Alpheus, raises the question of how he could also have been a Levite Cypriot. The emendation that Barnabas was a Levite could mean that he was a priest, rather than of a different tribe; and it is not impossible that Joseph, son of Mary, was born in Cyprus.

## The Political Influence of the British-Israel Movement in the Nineteenth Century (Part 7)

**I**N 1880, **BRITISH-ISRAEL ANNOUNCED** that the British had just Secured Cyprus and Suez so a protectorate would only be a matter of time. 165 Disraeli’s Anglo-Turkish Convention handing over Cyprus to the British in return for a military alliance against Russia was again paralleled with biblical prophecy that Israel would return to the Holy Land.

However, British-Israel maintained that the only way to convince unbelievers in Britain was by stressing the pecuniary, national and commercial advantages of this return. They supported this notion quoting the editorial of the Bristol Times and Mirror, of 10 December 1879, stating that the Tigris Valley was one of the greatest potential markets to manufacturers of the North and Midlands and an article in The Times, of 10

December 1879, pointing out that the recent blocking of the Suez Canal by a grounded steamer illustrated the need for alternative overland routes to the East. 166

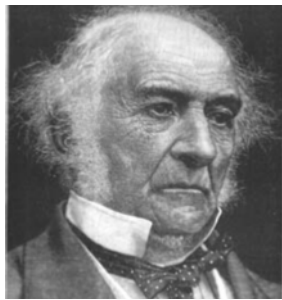
British Industrialist, Edward Cazalet, asserted in The Jewish Chronicle, that Palestine could only be recovered by the introduction of a Jewish ruling class as the present Arabs and Turks were Ineffectual.

He maintained England should create conditions under which Jews would migrate to Palestine under their own accord by establishing a British protectorate and building a Euphrates Valley Railway to provide initial employment.

The establishment of a British protectorate would provide an attractive alternative to the then trend of migration of East European Jewry to America ‘Nobody who has any knowledge of the Jewish character, can for a moment doubt that if the Jews were restored to their country, under an English protectorate, they would prove true to our nation, and that Syria would become as firmly united to England as if it were peopled by our own countrymen. 167’

These sentiments also had the approval of the Americans, whose President Harrison stated The immigration of these people to the United States - many other countries being closed to them - is

largely increasing, and is likely to assume proportions which make it difficult to find homes and employment for them, and to seriously affect the labour market.’ 168



British-Israel maintained that British Imperialism was a direct result of Gladstone’s (left) Home Rule policy, which was viewed as sign of weakness in that electors had to choose between Britain existing as an

Empire or falling to pieces by a series of secessions.

In 1880, British-Israel commentating on foreign policy asked ‘Shall the colonies be retained by Israel? Shall the great “company of nations” in federation with the “little island of the North” fulfil their grand destiny as marked out in the Word of God? “Nay”, say the Opposition, “federation is a mistake; the greatest injury that might happen to this empire.’ 169 Imperialism strengthened ties with the Mother country and British-Israel dived this into Political and Biblical.

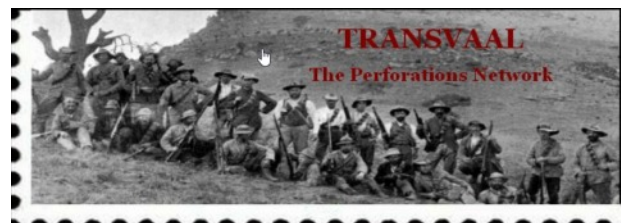
Under Biblical Imperialism, Britain’s appointed destiny was to annexe regions of the world in fulfilment of Biblical covenant such as Palestine. Judah had been employed for this purpose in that a Jew, Disraeli, had purchased the Suez canal shares and a Jew, Rothschild, had financed the acquisition. Political Imperialism involved conquering of states that menaced Britain’s interests and the next on the list was “Gog”—Russia.

Bishop Titcomb of Rangoon was bishop to the Anglican clergy and congregation in Northern and Central Europe. 170 An evangelical Christian, he believed the bible prophecies seeing a powerful regenerated Ephraim restoring Judah to Palestine in that the British Empire was the fifth great empire forecast in the book of Daniel. 171 In a somewhat perverse comparison, the Rev. H Read, American Nonconformist and author of *The Hand of God in History* stated ‘We cannot but discern the hand of God, which has given such a decided supremacy. England is the Rome of the day’. 172 He was dismissive of the rival Great powers labelling Russia as anti-Semitic,

France as a declining anti-Semitic empire, Germany with no foreign empire and with both France and Germany not honouring the Sabbath but ‘are given up to fetes, racing, concerts and theatres’. 173

British-Israel referred to Salisbury’s election, in 1900 as a thoroughly Imperial party and attributed election victory to Joseph Chamberlain, whose role as Colonial secretary, had struck blows against Home rule and Kruger’s Boers, and proof that electors wanted an extension of the Empire.

In fact British-Israel displayed intense relief that, in their opinion, the two greatest disasters of modern times - the handing of Transvaal to the Boers and the abandonment of Sudan - were now behind the country.



The establishment, in 1907, of a permanent annual Imperial Conference was seen as part fulfilment of the prophecy of ‘Company of Nations’ and attributed to the enterprise ‘the chosen race’ topped by the inauguration of Empire Day in 1909.

In order to fulfil biblical prophecy, British-Israel wished to see unification of the colonies under the security of a United Empire of Great Britain. In this respect they were buoyed by the 1897 Federal Convention of Australia to unify the antipodean colonies based on successes in Canada.

As with Disraeli, they used an influential individual as a symbolic vehicle for their Imperial aspirations - Joseph Chamberlain. Speaking at the Royal Colonial Institute, in 1897, ‘As regards the self-governing Colonies, we no longer talk of them as dependencies... We think of them and we speak of them as part of ourselves, as part of the British Empire.’

They applauded him for acting ‘honourably, generously and nobly’ to the defeated Boers and opined that South Africa would bloom under

Britain as had other lands brought under subjection. A subject they reminded Edward VII (below), on his coronation 'that your Reign may witness the Federation of the Anglo-Saxon Race by consolidating the ties which unite the Colonies with the Mother Country.'



Joseph Chamberlain had great sympathy with the Jewish Community. He promoted the aims of Zionism aiding Herzl's project to found a Jewish settlement between Egypt and Palestine securing an offer from the British government for a Zionist colony in East Africa and in particular appealing to British-Israel through his aversion to Home Rule. In an obituary to Joseph Chamberlain, 'the missionary of Empire', British-Israel proclaimed 'He leaves, indeed, to British-Israelites, an imperishable memory, an endearing influence, and an instructive message.' Joseph Chamberlain was praised for pushing the confederation of Empire toward a "Company of Nations".

Crete, Arabia and Palestine, at the end of the nineteenth century were struggling for independence from Turkey and British-Israel was at pains to advocate respect for his Muslim subjects quoting a select pilgrimage to Mecca where Sheik ul Islam stood before the Beit-Ulla (Tabernacle of God) and prayed aloud 'that the scourge of Turkey might be quickly removed from them, even if it were by the English taking over the guardianship of Mecca and Medina'.

Lord Shaftesbury noted at a meeting of The Turkish Mission Society, in 1879, 'God in His providence had given to Anglo-Saxon Christians everywhere in a remarkable manner the confidence of the Mohammedan world'. 174 Conversely, British-Israel also saw Turkey as an ally, at the same time in that the Muslims had given confidence to the English over the other

Great powers as when the Ameer of Afghanistan had declared war on England and Turkey had sided with Britain. 175

Then there was the Germans, another candidate empire for the 'company of nations'. Hine argued against the newly united Germany as part of Israel maintaining 'those who talk of German Protestantism as if it were identical with the Christianity of Christ, betray an ignorance of facts which in these days of travel and a prolific press is altogether unaccountable.' 176

This reflected an article in The Times, of 3rd December 1875, commenting that the German Protestant church was dying from an apathy exhibited by both the state and the congregation. 177

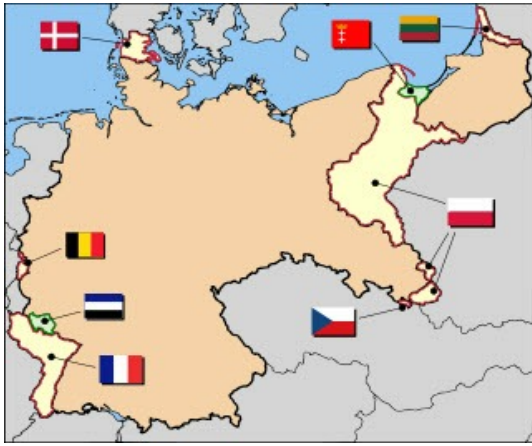
However, in Forty Seven Identifications, did admit 'The Germans are not our enemies, and there is evidence to show that they could not become our enemies'. 178

The ceding of Heligoland to the Germans was of great importance to their maritime power, however, British-Israel maintained they were no more entitled to it than any other part of Asia, Europe or Africa and as Germany had acquired Alsace Lorraine from France, we should seek their restoration before considering Heligoland. 'Possession of the residue of Denmark, followed by that of Holland, would be more so; and if Yorkshire were thrown in, the rejoicing excitement of the German mind would become so excessive as to prove perilous.' 179

Thomas Cook, in a letter to The Times in 1877, noted the movement of the Jerusalem Jews, out of the old quarter, into tenements erected by the 'societies'.

He also noted the Germans were increasingly colonising Jerusalem but antagonising the Turks by organising volunteer military corps, using Turkish effigies for rifle practise and organising cruises off Jaffa.... in gunboats. He noted only three English families residing in Jerusalem. 180

There was concern in British-Israel about the influence of the Pan-Germanic movement inspired by the writings of Heinrich von Treitschke, which wanted to combine under one government all the German speaking people of the continent.

His contemporary, Frederic Nietzsche was also perceived to have fuelled the development of German ambition since the German campaigns of 1870. British-Israel was able to attack Nietzsche's imperial influences through his weakness on the theological argument in that he believed the world was without any moral goal, the purpose of a race should be effected by intellectuals, not God and Christianity was 'the greatest of all conceivable corruptions'.

In 1892, Ein Deutes Weltreich was published and the Pan-Germanic League, formed in 1894, displayed open hostility toward Great Britain with the intention of overthrowing the British Empire. This was not unfounded, as in 1914, picking up the British Israel thread Kaiser Wilhelm II addressed his troops with 'Remember that the German people are the chosen of God. On me, as German Emperor, the Spirit of God has descended. I am His weapon, His sword and His Vice regent. Woe to the disobedient.'

British-Israel had of course accused the Kaiser in the past of being descended from the Assyrians, initial prisoners of the Ten Tribes in the seventh century BC and their opinion was re-enforced by Professor L. Paton, of Hartford Theological Seminary in Hibbert Journal, October 1916, in which he compared Assyrians to Germans in their empire ambitions. 181

could support itself at the present standard of living, using present technology.

(4) This leaves 50% of the Earth's land surface open to wildlife and conservation areas.

The lower limit of 8 times the current population (about 44 billion) has been considered as being perfectly workable.

According to Dr. Kasun, "better yields and/or the use of a larger share of the land area would support over 40 billion persons." Former Harvard Center for Population Studies Director Roger Revelle estimated that the agricultural resources of the world were capable of providing an adequate diet (2,500 kilo calories per day) for 40 billion people, and that it would require the use of less than 25% of the Earth's ice-free land area –Revelle estimated that the less-developed continents were capable of feeding 18 billion people, and that Africa alone was capable of feeding 10 billion people, or twice the current

**D**R. JACQUELINE KASUN professor of economics at Humboldt State University in California, observes in her 1988 book *The War Against Population* that:

- (1) No more than 1-3% of the Earth's ice-free land area is occupied by humans.
- (2) Less than 11% of the Earth's ice-free land area is used for agriculture.
- (3) Somewhere between 8 and 22 times the current world population

world population, and more than 12 times the 1990 population of Africa.

In addition to the fact that many new strains of food have been developed that can boost food production, there are other indications that food would not be a problem. In the September 1976 issue of Scientific American, Dr. David Hopper asserted that the world's "food problem" does not arise from any physical limitation on potential output or any danger of unduly stressing the environment.

The limitations on abundance are to be found in social and political structures of nations and the economic relations between them. In fact the planet, during its least populous years, suffered from hunger and famine.

It was only when state political controls receded in the late 19th century that hunger also began to recede. With the rise of Communism, welfare states, fascism and international corporate capitalism (all forms of Darwinist Socialism), many of the destructive controls preventing adequate growth and distribution of resources returned.

Since absolute cooperation and free-market planetary economic is counterproductive to global socialist and capitalist goals, it is quite apparent that the myth of overpopulation is a form of attack on this same free market, even though no more lawlessness and evil use of men and materials exists than under Socialism.

It is curious that many densely populated countries with relatively free economies are thriving, and are seldom mentioned in the "overpopulation" debate, while sparsely populated nations with oppressive governments are "plagued with problems relating to population." Taiwan, with a population density of five times that of China, produces 20 times as much Gross National Product than China.

Similarly, Singapore, with a density of 11,910 per square mile, enjoys a per capita GNP of \$8,782, while Ethiopia, with a density of 101 per square mile, has a per capita GNP of \$121. The real problem is that big government is the greatest obstacle to the social advancement of the human race. [Source](#)

### July 3 Is the Feast Day of Saint Peblig.

Sir\_\_\_\_, Peblig (Publicus in Latin), born c. 393, was the third son of Magnus Maximus (Western Roman Emperor from 383 to 388) and his second wife Saint Elen Luyddog (Helen of the Hosts). Lacking in political ambition, he relinquished his right of succession which enabled his brother Dionotus II to later become the Roman ruler of

Britain. Instead, he entered the ministry, establishing the church of Llanbeblig just outside the town of Caernarfon. He served there as abbot until his death.

He is said, along with his mother and brother Cystennin, to have introduced into Wales the Celtic form of monasticism established originally in Gaul.

Llanbeblig Church is associated with the "The Llanbeblig Book of Hours" which probably dates from the period 1390-1400 and contains the illustration of Magnus Maximus.

Books of Hours were very popular texts during the Middle Ages in Western Europe. Many thousands of these were created for religiously devoted lay people, who used them to enhance their programme of private prayer and daily devotion to God.

*The Books of Hours* were intended to echo the liturgy of the contemporary Church, in which the day was divided into eight distinct sections



Or 'hours'. There were specific prayers for each of these designated hours, with an elaborate calendar of feast days and religious celebrations. Many of the pages in these treasured volumes were painstakingly and richly illuminated with colourful images of Christ, the Saints and the Virgin Mary.. Yours truly, Thomas Dixie.

### The Fishguard Wicklow Stone Computer

Sir \_\_\_, I found this interesting in a book I was reading about South Wales (*Open Secrets. Explorations in South Wales.*, By Piet Brinton and Roger Worsely:—

Why? I asked an old lady who'd lived in Llanllawer, near Fishguard, all her long life (she was ninety); Why was it called this name?

She didn't know, but there were old stones up the lane to the mountain about a quarter of a mile.

What were they like I asked. She didn't know. Though she had been born in this cottage, lived in it all of her life, she had never gone up the lane to see the stones. They terrified her. She said "You see, there's a ghostly lady dressed in white, wandering about the fields up there."

Didn't want to meet her, the old lady said firmly.

The great stone row of Parc y Meirw is a row with a purpose, pointing, showing us the direction to look – in this case for the setting moon. The end of the rifle barrel? Ninety one miles away, over the Irish sea. And they seem to have included not only the moon's monthly cycle, but another only rediscovered fairly recently, a cycle of 173 days, a tiny 'wobble' of the moons orbit.

Only when the 'wobble' of the monthly cycle, the 18.6 year cycle and the 173 day cycle coincide and the moon is at it's most northerly point, does it set by sliding down the 'Dragons Teeth' of Mount Leinster, one of the Wicklow Hills in Ireland. Seen quite clearly from Parc y Meirw.

When you look down the sight lines and see this happening and the moon does that, you know that something very important is imminent... Because only when the moon moves into the Ecliptic (the apparent path of the sun through the sky) that eclipses occur ... Parc y Meirw is an eclipse predictor. We found it still works in 1982's autumnal eclipses.

What of the old lady’s story, who had never seen the stones. Well her story gives one clue, the ghostly lady dressed in white, wandering the fields at night. The moon..... Parc y Meirw a set of stones which still work as a calculator is probably one of the oldest and largest scientific instruments in this part of the world.

### Conkwell Stone Circle

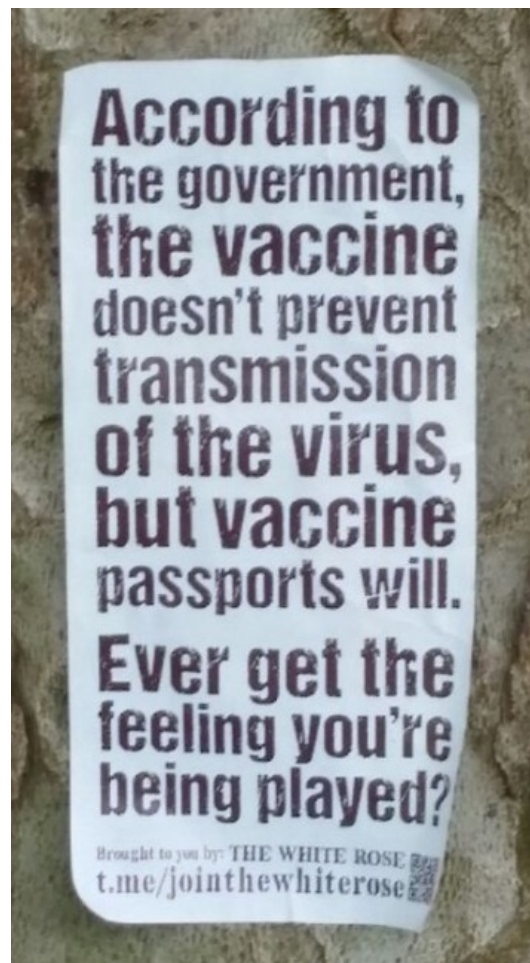

However, within spitting distance of that site is the Spring of the Green Man in Conkwell, and equidistant on the other side was/is Jug’s Grave, a barrow where the above gold disk (now in Devizes Museum) was found – again by

Underwood. Some feel the disk was made of gold coming from Ireland, while others think it’s Cornish. I go for the former, as the design is almost identical to those found in Ireland, and there was a known ‘Gold Route’ from there. 4000 years ago.

However, I think that on this sun disk the equi-armed cross must have stuck into the collective memories/DNA of the locals, as in Christian times they revered St Katherine (she of the Wheel!), and she is still honoured in this very small geographical area today, via place names and churches. **Yours truly, Alan Richardson, Wiltshire, UK.**

Yesterday I posted how Germany's flood disaster could have been prevented in large part, especially in terms of lives lost. The latest death toll has risen to over 150.

## Negligence Worse than We Thought

But it turns out the gross negligence may have been even worse than we thought: Dams constructed to regulate the flow of mountain streams and rivers had been left full for weeks before the disaster struck – despite Europe being stuck in a rainy period. No controlled release to add dam volume.

One independent journalist, Henning Rosenbusch, tweeted at Twitter a clip of a German citizen commenting to a "Welt" reporter: The resident in a flooded region tells the "Welt" reporter how every week he rides his mountain

bike along dams that hold back waters in valleys. “I noticed that for the last 3 weeks all dams were full to the top – up to just 20 – 30 cm from the brim. These dams are there to hold back the water. Why didn’t they release some of the water in a controlled way much earlier? For me it’s unimaginable. This whole thing should not have happened if there had been 10 or 20% more available volume in the dams.”

The reporter answered: “That’s criticism I’ve heard again and again today.”

### **Dereliction of Duty?**

Three weeks long dams were left full to the top even with long range forecasts (14 days) showing more and more rain on the way. It’s been a rainy summer, and there were no signs things would change soon.

Then 4 days before the catastrophe struck, meteorologists warned that up to 150 mm of rain was on the way. The filled dams were ticking time bombs that needed to be defused – and there was the opportunity to do so. But for whatever reason, nothing was undertaken by the authori-

ties to release water behind the dams in a controlled manner to create capacity and slow the downstream flow.

Portions of the rail network in Western Europe could be out of service for months or years after massive flooding that has left hundreds dead across a swath of western Germany and Belgium. Rail service has been suspended after the floods that saw rivers running 3 yards higher than previous records in some cases and destroyed homes and businesses.

In neighbouring Germany, where the scale of destruction and loss of life has been greater, some rail lines, again built following river valleys, have been completely washed out. In total, German national railroad Deutsche Bahn has reported 600 kilometers (more than 370 miles) of tracks and 80 stations are impassable.

## **Acute Electrical Illness (Part 3)**

**U**SUALLY INFLUENZA TRAVELS AT THE SAME SPEED AS MAN but at times it apparently breaks out simultaneously in widely separated parts of the globe. Jorgen Birkeland (1949), *Microbiology and Man* 36 [Before 1918] there are records of two other major epidemics of influenza in North America during the past two centuries. The first of these occurred in 1789, the year in which

Flu virus may be communicated from person to person in droplets of moisture from the respiratory tract. However, direct communication cannot account for simultaneous outbreaks of influenza in widely separated places. Roderick E. McGrew (1985), *Encyclopaedia of Medical History* 38. centuries, centuries that have seen great increases in the speed of human transport? John J. Cannell, M.D. (2008), "On the Epidemiology of Influenza," in *Virology Journal*

The role of the virus, which infects only the respiratory tract, has baffled some virologists because influenza is not only, or even mainly, a respiratory disease. Why the headache, the eye pain, the muscle soreness, the prostration, the occasional visual impairment, the reports of encephalitis, myocarditis, and pericarditis? Why the abortions, stillbirths, and birth defects? 39

In the first wave of the pandemic of 1889 in England, neurological symptoms were most often prominent and respiratory symptoms absent. 40

Most of Medical Officer Röhring's 239 flu patients at Erlangen, Bavaria, had neurological and cardiovascular symptoms and no respiratory disease. Nearly one-quarter of the 41,500 cases of flu reported in Pennsylvania as of May 1, 1890 were classified as primarily neurological and not respiratory. 41

Few of David Brakenridge's patients in Edinburgh, or Julius Althaus' patients in London, had respiratory symptoms. Instead they had dizziness, insomnia, indigestion, constipation, vomiting, diarrhoea, "utter prostration of mental and bodily strength," neuralgia, delirium, coma, and convulsions.

Upon recovery many were left with neurasthenia, or even paralysis or epilepsy. Anton Schmitz published an article titled "Insanity After Influenza" and concluded that influenza was primarily an epidemic nervous disease. C. H. Hughes called influenza a "toxic neurosis." Morell Mackenzie agreed: In my opinion the answer to the riddle of influenza is poisoned nerves—

In some cases it seizes on that part of (the nervous system) which governs the machinery of respiration, in others on that which presides over the digestive functions; in others again it seems, as it were, to run up and down the nervous keyboard, jarring the delicate mechanism and stirring up disorder and pain in different parts of the body with what almost seems malicious caprice... As the nourishment of every tissue and organ in the body is under the direct control of

the nervous system, it follows that anything which affects the latter has a prejudicial effect on the former; hence it is not surprising that influenza in many cases leaves its mark in damaged structure.

Not only the lungs, but the kidneys, the heart, and other internal organs and the nervous matter itself may suffer in this way. 42



Insane asylums filled up with patients who had had influenza, people suffering variously from profound depression, mania, paranoia, or hallucinations. "The number of admissions reached unprecedented proportions," reported Albert Leledy at the Beauregard Lunatic Asylum, at Bourges, in 1891. "Admissions for the year exceed those of any previous year," reported Thomas Clouston, superintending physician of the Royal Edinburgh Asylum (above) for the Insane, in 1892. "No epidemic of any disease on record has had such mental effects," he wrote.

In 1893, Althaus reviewed scores of articles about psychoses after influenza, and the histories of hundreds of his own and others' patients who had gone insane after the flu during the previous three years. He was perplexed by the fact that the majority of psychoses after influenza were developing in men and women in the prime of their life, between the ages of 21 and 50, that they were most likely to occur after only mild or slight cases of the disease, and that more than one-third of these people had not yet regained their sanity.

The frequent lack of respiratory illness was also noted in the even deadlier 1918 pandemic. In his 1978 textbook Beveridge, who had lived through it, wrote that half of all influenza patients in that pandemic did not have initial symptoms of nasal discharge, sneezing, or sore throat. 43

The age distribution is also wrong for contagion. In other kinds of infectious diseases, like measles and mumps, the more aggressive a strain of virus

is and the faster it spreads, the more rapidly adults build up immunity and the younger the population that gets it every year. According to Hope Simpson, this means that between pandemics influenza should be attacking mainly very young children. But influenza keeps on stubbornly targeting adults; the average age is almost always between twenty and forty, whether during a pandemic or not.

The year 1889 was no exception: influenza felled preferentially vigorous young adults in the prime of their life, as if it were maliciously choosing the strongest instead of the weakest of our species.

Then there is the confusion about animal infections, which are so much in the news year after year, scaring us all about catching influenza from swine or birds. But the inconvenient fact is that throughout history, for thousands of years, all sorts of animals have caught the flu at the same time as humans.

When the army of King Karlmann of Bavaria was seized by influenza in 876 A.D., the same disease also decimated the dogs and the birds. 44 In later epidemics, up to and including the twentieth century, illness was commonly reported to break out among dogs, cats, horses, mules, sheep, cows, birds, deer, rabbits, and even fish at the same time as humans. 45

Beveridge listed twelve epidemics during the eighteenth and nineteenth centuries in which horses caught the flu, usually one or two months before the humans. In fact, this association was considered so reliable that in early December 1889, Symes Thompson, observing flu-like illness in British horses, wrote to the British Medical Journal predicting an imminent outbreak in humans, a forecast which shortly proved true. 46

During the 1918–1919 pandemic, monkeys and baboons perished in great numbers in South Africa and Madagascar, sheep in northwest England, horses in France, moose in northern Canada, and buffalo in Yellowstone. 47 There is no mystery here. We are not catching the flu from animals, nor they from us.

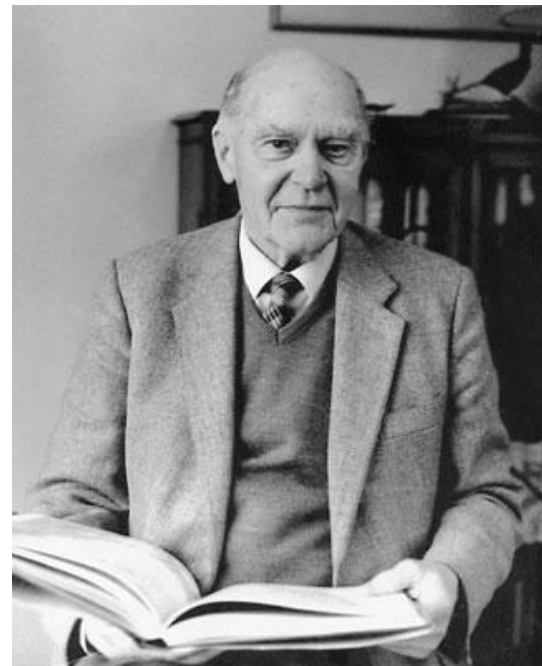
If influenza is caused by abnormal electromagnetic conditions in the atmosphere, then it affects all living things at the same time,

including living things that don't share the same viruses or live closely with one another.

The obstacle to unmasking the stranger that is influenza is the fact that it is two different things. Influenza is a virus and it is also a clinical illness. The confusion comes about because since 1933, human influenza has been defined by the organism that was discovered in that year, and not by clinical symptoms.

If an epidemic strikes, and you come down with the same disease as everyone else, but an influenza virus can't be isolated from your throat and you don't develop antibodies to one, then you are said not to have influenza.

But the fact is that although influenza viruses are associated in some way with disease epidemics, they have never been shown to cause them.



Seventeen years of surveillance by Hope-Simpson (above) in and around the community of Cirencester, England, revealed that despite popular belief, influenza is not readily communicated from one person to another within a household. Seventy percent of the time, even during the "Hong Kong flu" pandemic of 1968, only one person in a household would get the flu. If a second person had the flu, both often caught it on the same day, which meant that they did not catch it from each other.

Sometimes different minor variants of the virus were circulating in the same village, even in the same household, and on one occasion two young

brothers who shared a bed had different variants of the virus, proving that they could not have caught it from each other, or even from the same third person. 48 William S. Jordan, in 1958, and P. G. Mann, in 1981, came to similar conclusions about the lack of spread within families.

Another indication that something is wrong with prevailing theories is the failure of vaccination programs. Although vaccines have been proven to confer some immunity to particular strains of flu virus, several prominent virologists have admitted over the years that vaccination has done nothing to stop epidemics and that the disease still behaves just as it did a thousand years ago. 49

In fact, after reviewing 259 vaccination studies from the British Medical Journal spanning 45

years, Tom Jefferson recently concluded that influenza vaccines have had essentially no impact on any real outcomes, such as school absences, working days lost, and flu-related illnesses and deaths. 50

The embarrassing secret among virologists is that from 1933 until the present day, there have been no experimental studies proving that influenza—either the virus or the disease—is ever transmitted from person to person by normal contact.

As we will see in the next chapter, all efforts to experimentally transmit it from person to person, even in the middle of the most deadly disease epidemic the world has ever known, have failed.

## **9th Century Anglo-Saxon King's Cave House - Derbyshire, UK Posted By Zoe Spencer**



**9th century Anglo-Saxon cave house - that may have once been home to a king - identified in Derbyshire**

**A** NEAR-COMPLETE ANGLO-SAXON DWELLING AND ORATORY, believed to date from the early 9th century, has been discovered in Derbyshire by archaeologists from the Royal Agricultural University (RAU) and Wessex Archaeology.

Archaeologists from the RAU's newly-formed Cultural Heritage Institute, working with colleagues from Wessex Archaeology, undertook a detailed survey of the grade II listed Anchor Church Caves between Foremark and Ingleby in South Derbyshire.

The caves, which were cut out of the soft sandstone rock, have long been considered to be 18<sup>th</sup> century 'follies', but this new study, published in the Proceedings of the University of Bristol Spelaeological Society, demonstrates that these caves are more likely to be early Medieval in date.

Edmund Simons, principal investigator of the project and a research fellow at the RAU, said: "Our findings demonstrate that this odd little rock-cut building in Derbyshire is more likely from the 9<sup>th</sup> century than from the 18<sup>th</sup> century as everyone had originally thought.

"This makes it probably the oldest intact domestic interior in the UK - with doors, floor, roof, windows etc - and, what's more, it may well have been lived in by a king who became a saint! "Using detailed measurements, a drone survey, and a study of architectural details, it was possible to reconstruct the original plan of three rooms and easterly facing oratory, or chapel, with three apses."

The narrow doorways and windows of the rooms in the dwellings closely resemble Saxon architecture, while a rock-cut pillar is similar to those found in the Saxon crypt at nearby Repton which



is believed to have been completed by the Mercian King Wiglaf who reigned as King of Mercia (a Kingdom in the English Midlands from the 6th century to the 10th century) from 827 until his death in 839.

Caves, such as the Anchor Church Caves, are often associated with anonymous medieval hermits or anchorites but, in this case, there is a legendary association between the Anchor Church Caves and Saint Hardulph.

A fragment of a 16<sup>th</sup> century printed book states that at *‘that time Saint Hardulph has a cell in a cliff a little from the Trent’* and local folklore identifies these caves as those occupied by Hardulph.

Modern scholarship identifies Hardulph with King Eardwulf who was deposed as king of Northumbria in 806. Hardulph subsequently visited both Pope Leo III in Rome and Charlemagne’s court in Nijmegen and spent the last years of his life exiled in Mercia.



He died in around 830 and was buried at Breedon on the Hill in Leicestershire, just five miles from the caves. It is believed that some of the surviving sculpture in the village’s Church of St Mary and St Hardulph (above), which was founded as a monastery in the 7th century, came from his shrine.

Edmund added: “The architectural similarities with Saxon buildings, and the documented association with Hardulph/Eardwulf, make a convincing case that these caves were constructed, or enlarged, to house the exiled king.

“It was not unusual for deposed or retired royalty to take up a take up a religious life during this period, gaining sanctity and in some cases canonisation. Living in a cave as a hermit would have been one way this could have been achieved.

“These cave dwellings have often been overlooked by historians but may be the only intact domestic building to have survived from the Saxon period. This project has so far identified more than 20 other sites in the West Midlands that could date from as early as the 5th century.” The area around the nearby village of Repton was the location of intensive Viking activity and, shortly after Hardulph’s death, the Vikings set up a winter camp at Repton. Archaeologists from the RAU have located several locations associated with the Great Heathen Army, some very close to the Anchor Church Caves, suggesting that the caves were probably abandoned at that time.

The archaeologists believe that the caves may have been modified in the 18<sup>th</sup> century when it was recorded that Sir Robert Burdett (1716-1797) *‘had it fitted up so that he and his friends could dine within its cool and romantic cells’*. These changes included the addition of brickwork and window frames, and the opening up of some of the wall openings in order that well-dressed ladies could pass.



More archaeological and scientific dating is now planned to confirm the architectural evidence. Mark Horton, Professor of Archaeology at the RAU who is also running excavations of Viking and Anglo Saxon remains at Repton, commented: “It is extraordinary that domestic buildings over 1200 years old survive in plain sight, unrecognised by historians, antiquarians and archaeologists. We are confident that other examples are still to be discovered to give a unique perspective on Anglo Saxon England.”

Putting action to his words he rented the fairgrounds near where Timberlake Road and the Airport Road meet, set up a tent, put sawdust on the ground, and started to preach - sunny days, rainy days, cold-wet-snowy-winter days, sweltering hot summer days - Billy Sunday preached under that big tent. He preached all the things the establishment churches didn't preach. Sometimes he preached to a handful, at other times he preached to overflowing crowds.

One at a time, non-establishment Lynchburgers (and some establishment ones) walked the sawdust trail and accepted God's Commandments to rule their lives. Gradually people stopped going to whorehouses, saloons, and gambling joints. One at a time these establishments closed up for the lack of customers. When Billy Sunday left Lynchburg, Lynchburg had changed. While "establishment Lynchburg" was the same, the rest had changed. Lynchburg was different.

For years I belonged to the Gideons; many of the old timer members were saved under Billy Sunday. They told me what Lynchburg was like before Billy Sunday, and what they were like before they changed.

Billy Sunday did something that no one else in Lynchburg was doing. He told people what God required of them - God's Law. While people may forget what Billy Sunday said and what their preacher said, they aren't going to forget God's Law. Billy Sunday spoke with authority because he spoke God's Law when no one else did and people respected that. This was Billy Sunday's secret weapon. It changed Lynchburg.

The Children of Israel left Egypt and spent 40 years in the wilderness where a new generation

could be born that was cleansed of the evils of Egypt and fit to enter the promised land. But, when the Children of Israel emerged from the wilderness, they brought with them a full blown Priesthood that was as worthless, destructive, hypocritical and evil as the priesthood we have today. They were so rotten that Moses wrote the following to warn Israel:

"Moses commanded the Levites— saying, Take this— Law and put it in the side of the ark— that it may be there for a witness against thee. For I know thy rebellion— behold, while I am yet alive— ye have been rebellious against the Lord; and how much more after my death?—For I know that after my death ye will— turn aside from the way which I have commanded you." **Deut 31: 24-29**

Moses spoke truly. Preachers are the root cause of all our troubles. They prostitute "the **WORD** which is God" for filthy lucre, and except for a few who have often sacrificed all by carrying the light of the **WORD**, these evil creatures would have destroyed us long ago.

### Two Kinds Of Preachers

- A few preachers serve God and teach that God's Commandments are supreme.
- Most preachers serve the king and teach that the king's statutes are supreme.

**State Priests:** - Priests who serve kings are called "state priests". Evil kings need evil priests to bless their rule. This keeps the people docile and agreeable when the king's rule flagrantly violates God's Commandments.

**30% C:** - State priests keep the King's subjects peaceful by censoring 70% of the Bible - the 70% of God's Commandments dealing with government. The Scriptures say, "**All Scripture** is given by inspiration of Yahweh and is profitable for doctrine." **II Timothy 3:16-17.**

A 30% Christian priest who allots 70% of God's Commandments to the king for his interpretation isn't Christian at all. That priest's god is the king! He teaches only the 30% of the Bible that

deals with the individual. This is why those who hear and believe the teachings of State Priests are called "30% Christians" (30%C), because that's all they are - Thirty Percent Christian!

The world can go to hell in a hand basket and all they know is - "love", and, they don't know the true definition of love because that secret is part of the forbidden 70% dealing with government that the state priest tries to keep them from learning.

The king pays the priests performing these services for him with "tax- exemption".

**God's Priests** - The few pastors who teach God's Commandments, including the 70% of the Scripture that deals with government, are punished by being condemned and hounded by the king's State Priests and by having the King deny them the same tax-exemption he gives his own priests.

## The International Merchant



For the benefit of those who have only recently discovered that there is something drastically wrong in the Christian West, a brief review is necessary:

Esau is the international merchant. He married the daughter of a Caananite, one cursed by God, therefore Esau's descendants are also cursed by the Lord God of Israel. They go under the generic name of "Turks".

Their organization is like the organization of a wolf-pack - rule from the top down - and is known as the International Trade Cartel (ITC). It's several branches are perpetually at on-again, off-again war with each other. However, they are united in their determination to destroy the sons of Jacob from the face of the earth so that they can inherit the blessings that God took from their father Esau.

## King

God made "man" both king and priest and said that man's insistence on having an earthly king to rule them instead of depending on God's **WORD** to rule them was the same thing as rejecting God. It still is:

"Then all the elders of Israel... came to Samuel... make us a king to judge us like all the nations... And the Lord said... the people... have not rejected thee, but they have rejected me, that I should not reign over them.... How be it yet protest solemnly unto them, and show them the manner of the king that shall reign over them. And Samuel told all the words of the Lord...

"This will be the manner of the king that shall reign over you: tie will take your sons, and appoint them for himself, for his chariots, and to be his horsemen; and some shall run before his chariots.... And he will take your daughters to be confectioneries, and to be cooks, and to be bakers.

And he will take your fields, and your vineyards, and your olive yards, even the best of them, and give them to his servants. And he will take the tenth of your seed, and of your vineyards, and give to his officers, and to his servants.... He shall take the tenth of your sheep: and ye shall be his servants. And ye shall cry out in the day because of your king which ye shall have chosen you; and the Lord will not hear you in that day." **I Sam 8:11-18**

In spite of God's warning, man insisted. They claimed they needed an earthly king to fight their battles so God gave them the best man available to be their king; all the time warning them that earthly kings are not to be trusted - that they would oppress those they ruled. From that day to this, kings (by whatever names they are called) have oppressed their people.

## The Stranger Arrives

The stranger found that kings can be bribed. Bribed kings will accept the merchants' money

and grant them monopoly privileges, a thing forbidden in the 70% of God's Commandments that State Priests do not teach.

If the king is uncooperative, a pretender to the throne can be easily found who will exchange trade agreements for ITC help to obtain the throne. In this way the ITC has bought the world's rulers and is the power behind their thrones - which would be impossible if strangers were banned according to the priestly censored 70% of God's Commandments.

### The Job of Kings

The job of kings selected by the ITC is to protect the interests of the ITC. The welfare of those the king governs is of secondary importance.

### Judges

Kings appoint judges to settle disputes among the king's subjects and to rule that what the king does is legal[6]. To do this, the judge must rule that the king's statutes are superior to God's Law when the two come in conflict. Only a man who cares nothing for his soul will rule against God and for the king. No mercy can be expected from these kinds of judges who don't fear God. And God will hold them to account for their acts.

If lawyers appear before the king's judges and argue that God's Law is superior to the king's statutes - the king's judge will see that the lawyer is punished in some way. Kings appoint judges to rule that the king's acts are legal and lawful. He is not appointed to rule that God's Commandments are supreme over the king's statutes.

### Money Managers

Most of the world's multi-billionaires are appointed to manage a portion of vast ITC assets. In spite of stories to the contrary, these managers are not former penniless immigrants who by dint of struggle and sacrifice and by saving their nickels and dimes for twenty years, manage to accumulate multi-billions. In fact, very little of the money they manage is their own. Kings work with these money managers by passing NAFTA type laws to help these people to do their thing.

### Media

The ITC owns ALL the world's major media. These media managers select those of their own agents they wish to receive coverage by their managed media. With this publicity the voters will know for whom to vote for public office.

Conscientious citizens vote for the best man they know, but the only ones they know are the ones receiving media coverage. Thus, ALL elected kings with very few exceptions are hand picked ITC agents elected by the ITC's own media.

### Priests



There are two kinds of priests:

- One serves God and teaches that God's Commandments are supreme.
- The other kind serves the king and teaches the king's statutes are supreme. Most priests serve the king. Without them there could be no kings, judges, strangers' media, usury banks, etc.

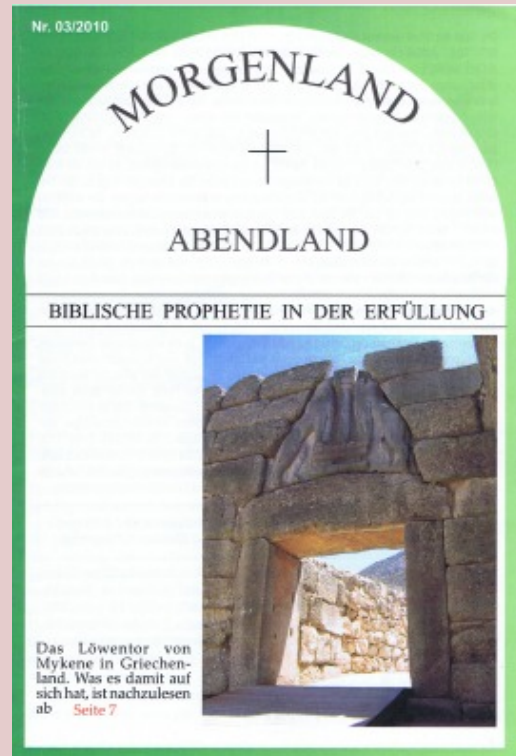
