The Exclusive Covenants (Part 7)

Of Covenant Theology: Documenting the Bible's Commandment of Racial Segregation

The Last Word: GENTILE

ONE OF THE MOST ABUSED AND MISUNDERSTOOD WORDS OF

SCRIPTURE is the word 'gentile.' This word is actually of Latin origin and it NEVER had the meaning of "those who are non-Jews."

This meaning is of modern origin and is based on the false Jewish idea that Jews are Israelites and that all non-Jews are so-called "Gentiles." The reality is that the Latin word 'gentile' was substituted for the Greek word **Ethnos**, which simply means, "race, tribe."

In the original Latin, the word meant, very specifically, a person of one's **Own Race or Tribe**. Hence, we see that the Jewish-inspired definition of the word is the exact opposite of the original meaning.

The Jews use it to designate non-Jews, when, Scripturally, the word most often refers to the Israelites of the Dispersion (dated 745 BC). Just as the modern word, 'race,' can refer to any race, the Greek 'ethnos,' the Hebrew 'goy' and the Latin 'gentil' can refer to any race, so the context of a particular passage must be taken into consideration before determining which race is being spoken of.

Race-mixing with non-Whites was simply unheard of in the Greco-Roman world. It only occurred among the wealthy who brought non-White slaves back to Greece and Rome from the various military campaigns. Race-mixing was taboo in America as late as the 1950's.

It was the Jewish-owned televangelist networks that began promoting the idea that the races must integrate; and it was the Supreme Court under the Jewish rabbi, Earl Warren, that urged Eisenhower to forcibly integrate Mississippi's

schools. It wasn't the Bible that changed. The Bible Belt of the South was just fine with segregation since 1776. What changed? It was the pastors of apostate Judeo-Christianity who started changing THEIR doctrine, claiming that today, after 2,000 years of segregation, that the Bible must be interpreted differently!

Although Strong's Concordance includes, as the last entry, the Jewish definition of the word 'goy' as "foreign nation," a careful study of the passages in which this word is used shows conclusively that the word 'goy' is used far more often of Israelites than of any other nation, so "foreign nation" is a false definition by the standard of Biblical usage.

This false definition has been picked up by the deceived "Gentiles" who don't know how the Jews have distorted the definitions of words for their own, supremacist purposes.

Here is how the Ensign Message describes the deception that has come about, regarding this word:

THE ENGLISH WORD "GENTILE" A SAD ERROR IN TRANSLATION

An examination of this word, and how it came into the English language from the Bible, shows that it was evidently coined by the translators of the Authorised Version to their individualistic understanding that excluded the main national theme of Israel from the New Testament. Ignorant of the whereabouts of dispersed Israel and the Nation building in the Isles of the West, they considered "Israel" and "Jew" as interchangeable terms as denoting the same people mostly resident in the Holy Land and nearby districts. They used the word "Gentile" to describe all peoples other than those termed "Israel" or "Jew."

They took great liberties, in translating the Greek word ethnos in a variety of ways - Gentiles 93 times, heathen 5 times, nation 64 times, people twice with the greatest inconsistency including the Greek word Hellen, which they also

indiscriminately rendered "Gentile." The collective word *ethnos* which means - "nation" - is not applicable to an individual. A person cannot be addressed as a "nation." The idea that a person can be called a "gentile" - stems from incorrect translation of the original word.

The English word - Gentile - has its origin from the Latin *gentilis* and the French *gentil*, both derived from the root stem *gens*, a Latin word meaning - "A Selected Clan or Race of the same stock," in a collective sense.

Had the translators used the word - "nation" - in every instance, the context would reveal whether *ethnos* was applicable to the nations of Israel or nations of non-Israel race.

Church leaders erroneously read the Pauline Epistles as addressed to alien peoples of non-Israel race - termed "Gentiles."

In doing so they introduce doctrine so full of contradictions as to subvert the Gospel of the Kingdom as taught by Jesus and the message the Apostles were commanded by **HIM** to expound to the lost sheep of Israel and not alien "Gentiles" (**Matthew 10:5-6**).

The true Kingdom Gospel - covered by the Mystery of the Kingdom - (Matthew 13:11), was revealed only to **HIS** Disciples and those who had ears to hear. Blind Israel was not immediately receptive to the message and those of the early centuries A.D. - lost in a maze of Christian dogmas - had relegated God's Servant Nation to the limbo of forgotten legend.

In the light of new knowledge the old mistakes can be accounted for. It can now be seen that the Bible contains a "cover story" implanted for the very purpose of concealing Israel from the world at large.

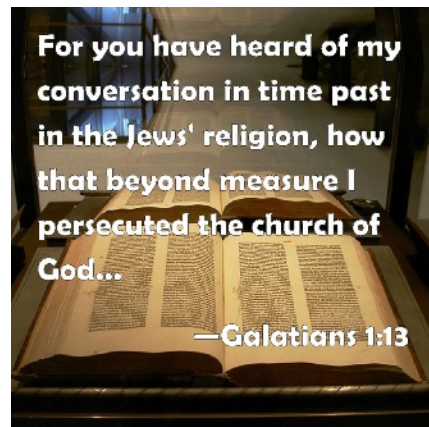
Instead of following the unchanging purpose of Yahweh in the Israel race and the political base of the Gospel of the Kingdom, Christians were carried away with the individual aspects of personal salvation and substituted a gospel that excluded the national theme.

Undoubtedly the translators of the A. V., biased by this attitude, misapplied the meaning of the original word for nation and substituted religious connotations to it - such as "Jews" and

"Christians." In proof of this corruption see our modern English dictionaries, which continued to perpetuate the error, an example - according to "The New Hamlyn Encyclopedic World Dictionary":

"Gentile = of or pertaining to any people not Jewish."

The absurdity of such an error is profound, and that it should have been handed down to this day and age without correction, shows to what an extent tradition may lead astray. The muddle can only be solved by accurate definitions:



"Jewish" denotes a person professing - "the Jews' religion" - (Gal. 1:13) and is not applicable to a race.

Directly opposed to the above, *gens*, the root stem of Gentile, appertains to people belonging to the same family, clan or nation - and **NOT** to a heterogeneous collection of many different races of people.

The same bias that actuated the translators of the AV to distort the meaning of *ethnos*, is evident also with the Greek words *genes*, *genos* and *gennema*, whose primary meaning in each case is race.

In many passages they confused the racial theme by rendering "race" as "generation" - striking examples of this, where "generation" makes no sense with the context, are - **Matthew 3:7, 12:34; 23:33, 24:34, Mark 13:30; Luke 3:7; 21:32; 1 Peter 2:9.**

Summary: The Pattern of Exclusion, From Genesis 1 to Revelation 22

In Gen. 1, the dominion covenant was given to the Adamic race exclusively. In Gen. 2, a

specific man and a specific woman of **Awdawn** were selected to be the leaders of this race. Yahweh personally breathed the breath of life into them, so that they could produce a dedicated bloodline.

They were even promised an immortal posterity if they obeyed Yahweh's laws of separation, but Eve was seduced by the Nachash critter and Adam tasted the fruit of miscegenation as well. This is what led to the Fall.

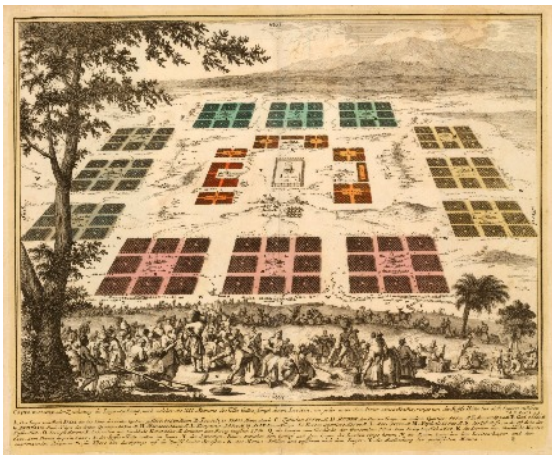
The Hebrew word, nachash, has its root in the Aryan word, Naga, meaning the fallen ones of the primordial world. Naga is cognate with such words as **Anakim** (the fallen angels of Scripture) and with the Chaldean **Anunaki**. We can also see that the Hebrew root is similar to the English **Naked** and the Germanic **Nakt** (naked) and even **Nacht** (night, dark), because what Adam and Eve did (forbidden sex) required them to be naked and they mated with the children of darkness and probably with the dark-skinned chay of the field, in the Garden.

The pattern of exclusion that Scripture details is designed to get the Adamic Race back on its segregated path. The pattern of exclusion names only White patriarchs as the leaders of the Race.

The Sethites grew and expanded until the days of Noah, when a great purging of the ranks of the Sethites took place, because of miscegenation with the Nephilim and other races. Sethites, Noah, Naamah and all other tribes, including any other surviving Whites

From here on the covenants are made with an ever more exclusive line of descent, even excluding other existing White tribes.

(THE TWELVE TRIBES OF ISRAEL)



The Twelve Tribes of Israel are the final exclusionary group. We are the heirs of the Promises. The pattern of exclusion demonstrates that the Covenants, Promises, Dominion and Inheritance devolved from Adam and Eve down to Jacob and his twelve sons.

All other ethnicities, including the other tribes of the White Race, are excluded from these Covenants. The Bible makes all of this explicit and clear, as this record has demonstrated. However, it is also clear that tribal membership is based on the father. Intermarriage between Israelites and Adamic Aryans was always permitted. However, the posterity was always reckoned through the father.

So, if the Bible goes to extremes in order to sever even the close Adamic kinsmen of Israel, how in the world are "all races" going to be included? The pattern of exclusion proves that universalism is a crock.

Abraham, Isaac, Jacob and his twelve sons all married Shemitic women. Once these women were selected, the posterity of Israel continued through the patriarchs.

Intermarriage between men and women of the different tribes meant that, for example, the offspring of an Asherite woman and Simeonite male would be reckoned as Simeonites.

Although it is impossible for us to keep track of all of this genealogy, Yahweh knows all; and He has His reckoning all set for the New Jerusalem of Rev. 21, which consists exclusively of the 144,000 of **the Twelve Tribes of Israel**. This prophecy cannot be spiritualised. It is genetic reality, according to Yahweh's own laws, will and testaments.

Finally, if an Israelite man marries a White woman of a non-Israelite nation, such as a Slavic woman of Japheth or a Shemitic woman of Armenian, Scythian or Parthian extraction, those offspring will be reckoned as Israelites. However, if an Israelite woman marries a non-Israelite White man, her offspring will not be counted as Israelites. Therefore, her children will not be Heirs of the Covenants.

Nevertheless, all White non-Israelites, who call upon His Name and obey His commandments, will have a share in the Kingdom, but rulership

of the Kingdom will devolve exclusively upon the Israelite patriarchate.

“Japheth shall dwell in the tents of Shem.” This prophecy came exactly true as the Davidic Throne, through both Zarah and Pharez, continued through the Emperors of Rome (First Reich) and then through the Kings and Queens of Europe (Second Reich).

The royal Houses of Europe were all cousins to each other; and they are all descendants of the Shemitic House of David, whether their subjects were Celts, Iberians (Hebrews), Cimmerians, Scythians, Israelites, Saxons or Slavs. Hitler’s “Third Reich” was premature. It was not based on Scripture. It is yet to come.

What the world knows as Western Civilization was organized by the Caucasian Israelites, who are the direct descendants of Abraham, Isaac and Jacob.

Under our leadership, the other branches of the White race were unified into one great culture, based on honour, honesty, inventiveness, hard work and common law.

All of these qualities were grafted into Caucasian Israel as a result of the promise of Jer. 31, the New Covenant, being fulfilled in True Israel. Christian Jurisprudence, with all of its stress on justice and fair play, was brought to the world by the Anglo-Saxon, Caucasian people. The Jews had nothing to do with it.

In fact, the Jews have been a subversive force since Gen. 4:1, where Cain was cursed with the inability to farm. The Jew wanders the landscape until he finds a nice, cosy Saxon state to feast off of. We are the builders. The Jews are the destroyers.

It can be stated as a plain fact of history that the primary pastime of the Jewish people is to subvert and destroy Adamic/Saxon nations. They have done this through usury, Talmudism, war-mongering, degradation of morals, Zionism, communism, etc. A primary feature of all of these methodologies is their commitment to “integration”- for Whites.

It should be obvious to everyone that Satan is the author of these theologies and methodologies; and the Jewish people are Satan’s minions working overtime for their lord and master, Baal.

It is We, not the Jews, who brought the common law, which is biblical law – from Moses to the judges to David to Yahshua to King Alfred (Centre) the Great to the Declaration of Arbroath to the Magna Carta to the US Constitution - into

prominence in the modern era. The Jews have done everything they possibly can to subvert these freedom-loving declarations.

It is we Anglo-Saxons who are Yahweh’s servant race. The Jews have always been anti-Mosaic in practice while publicly proclaiming the lie that Judaism is a Mosaic religion. The Jews have **Never** authored any liberty-producing legislation. On the contrary, their every move is profit-motivated, subversive, deceptive, supremacist and tyrannical.

Jesus Christ, the self-declared “son of Adam (**Awdawm, Anthropos**),” had a two-fold purpose in His sacrifice at the Cross: 1.) redeeming the Adamic Race from the Fall and 2.) forgiving the past sins of the Israelites, to whom the Law was delivered. The fact that He was an Adamite and a descendant of David gave him the qualifications for this dual deliverance.

The Enmity declared at 3:15 does not get resolved until the Second Coming, when He will return with His holy angels to smite the Edomites and anyone who has allied himself or herself with them (Mystery Babylon).

Conclusion

“Yet I planted you a choice vine, wholly of pure seed. How then have you turned **Degenerate** and become a wild vine?” Yes, this verse is in the Bible, but it is not the KJV translation. It is the Revised Standard Version, which gets the context right, as Jeremiah is enumerating the sins of Israel. In Jer. 3:1, He says, “You have played the harlot with many lovers.” Since Yahweh is



speaking to the whole nation of Israel, the “many lovers” can only be the other nations that Israel is forbidden to intermarry with!

When it is time for the children of Israel to be punished for their sins, He says, “I will appoint over them four kinds of destroyers, says Yahweh: the sword to slay, the dogs to tear, and the birds of the air and the beasts of the earth to devour and destroy.” – **Jer. 15:3. (RSV)**

Yahweh punishes our national fornication by using those very nations to kill us, by turning them into destroyers of Israel. How many times has this happened to our once glorious, Whites-only societies?

Nevertheless, He will not totally abandon us. He will bring us back to our senses, breaking the matrix of deceit, the bonds of delusion and apostasy! Not only that, the rest of “humankind” will acknowledge that **We are His Chosen People**. Observe:

“And their seed shall be known among the nations, and their offspring among the people: all that see them shall acknowledge them, that they are the seed which Yahweh hath blessed.” – Isa. 61:9.

Amos 3:2 puts it this way: “**You Only Have I Known of All the Families of the Earth.**”

Isa. 43:21: “This people have I formed for Myself; they shall show forth My praise.”

Numbers 23:9 – “Behold it is a people that shall **Dwell Alone.**”

What part of the expression “dwell alone” don’t you understand? We are to segregate ourselves from all the other races.

Deut. 32:9: “For Yahweh’s portion is His people. Jacob is the lot of His inheritance.”

Deut. 33:28-29: Israel then shall dwell in safety **Alone:** the fountain of Jacob [shall be] upon a land of corn and wine; also his heavens shall drop down dew.

Happy art thou, O Israel: who is like unto thee, O people saved by the **Lord**, the shield of thy help, and who is the sword of thy excellency! and thine enemies shall be found liars unto thee; and thou shalt tread upon their high places.

Instead of treading down the heathen idolaters, today’s Judeo churches are inviting them into their homes and churches, just like the reprobate Israelites of Palestine! The Great Apostasy will be judged along with the Synagogue of Satan.

I Kings 8:53: For you did **Separate Them** from among all the people of the earth, to be Your inheritance.”

Despite all of this segregationist language, the world believes that the mongrelised Jews are “Israel.” But, because Yahweh’s servant people, Israel, have been blinded to their true Identity, many of us, thanks to Jewish propaganda, remain in the dark. Paul tells us at Romans 11:25,

“...that blindness in part is happened to Israel, until the fullness of the nations be come in.” Now that the New World Order has done away with sovereign nations, our blindness is finally beginning to lift. Do you see how easy it is to discern Paul’s true meaning, once the blinders of mistranslation are removed?

In Matt. 13, Jesus is asked by the Apostles why he speaks in parables. His answer is exclusive. At verse 11, He answers, “Because it is given to **You** to know the mysteries of the kingdom of heaven, but to **Them** it is not given.” Clearly, the gospel is not for everybody. It is only for a few, even within Israel. “Many are called but few are chosen.”



Yet, today’s apostate churches unanimously teach that we are all “saved” by mere belief in Jesus Christ. The exclusivity of the covenants has been replaced by the heathenism of the churches, who profit by having more butts in the pews and more shekels in the basket.

At verse 14, regarding those people for whom this Gospel is not intended, He says that He has no intention of preaching to them, “lest at any time they should see with their eyes, and hear with their ears, and should understand with their heart, and should be converted, and I should heal them.”

Why would Jesus say such a thing? The obvious reason is that there were always Pharisees in the audience, seeking to entrap Him with His words. Yahshua never minced words with these Pharisees.

He condemned them at every turn. He did not even **Try** to convert them. At John 10:26, he tells them, “But you believe Me not, because **You Are Not of My Sheep.**” So much for everyone being “one in Christ.” Also, there were various non-Israelites in the crowds, to whom the gospel does not pertain.

In Matt. 15, the Canaanite woman asks to be given the “bread of life,” but Jesus tells her, in Covenant language, “It is not fitting to take the children’s bread and give it to the dogs.” Yahshua is telling her, in no uncertain terms, that the inheritance stored up for the children of Israel cannot be given to anyone else but those exact children. Her answer is just as revealing.

She says, “Truth, Lord, yet the dogs eat of the crumbs which fall from their masters’ table.” Note the location of the apostrophe in the word masters.’ It is plural! For once, the KJV translators got it right!!! She is acknowledging that the Israelites, not merely Jesus Christ, are her masters.

The Canaanite woman understands that the children of Israel are to inherit the Kingdom; and no one else has any claim to it. Because she acknowledged Him as the Son of David and because she acknowledged the Israelites as her masters, Yahshua granted her wish and even praised her for her “great faith.” But He refused to give her what belongs only to the children of Israel.

Even the Edomite and Khazar Jews will ultimately acknowledge that we Anglo-Saxons are their Israelite masters. Just read Rev. 3:9.

Deut. 4:23-32 declares, through Moses the prophet, that at the Day of Judgment, He will regard Israel as a separate people, to be redeemed out of the nations among which they have been scattered:

I call heaven and earth to witness against you this day, that ye shall soon utterly perish from off the land whereunto ye go over Jordan to possess it; ye shall not prolong your days upon it, but shall utterly be destroyed.

And the **Lord** shall scatter you among the nations, and ye shall be left few in number among the heathen, whither the **Lord** shall lead you. And there ye shall serve gods, the work of men's hands, wood and stone, which neither see, nor hear, nor eat, nor smell.

But if from thence thou shalt seek the **Lord** thy God, thou shalt find him, if thou seek him with all thy heart and with all thy soul.

When thou art in tribulation, and all these things are come upon thee, **Even in the Latter Days**, if thou turn to the **Lord** thy God, and shalt be obedient unto his voice; (For the **Lord** thy God is a merciful God;) he will not forsake **Thee**, neither destroy **thee**, **nor forget the covenant of thy fathers which he swore unto them.**

For ask now of the days that are past, which were before thee, since the day that God created man upon the earth, and ask from the one side of heaven unto the other, whether there hath been any such thing as this great thing is, or hath been heard like it?



At Matt. 7:6, Jesus says, “Give not that which is holy unto the dogs, neither cast your pearls before swine, lest they trample them under their feet, and turn again and rend you.”

What does this mean? 1.) We are not to give our Inheritance to non-Israelites. They have no part in the Covenants. 2.) When we intermarry with non-Whites, we give our inheritance to those who will abuse the covenants, thinking themselves better than us; and they will turn against us and kill us.

This is what is happening in South Africa today, as the Judeo-Christians have tried mightily to convert the Blacks away from voodoo and their pagan, tribal beliefs, but it has not worked. This is also happening in all of the formerly White nations on planet earth, where the Jews have systematically disenfranchised White people and empowered non-Whites against us.

Now, these same non-Whites, especially Blacks, Arabs, and Mexicans, pretend to be superior to Whites, even to the point of committing genocide against their White benefactors.

Matt. 7:6 is a prophecy of what happens when we Israelites give our inheritance away to those who are not meant to have it. They are turning against us and rending us! We are not to mingle our seed with the non-White races. Whenever we do, Yahweh punishes us for disobeying His Law of Segregation.

The doctrine of racial integration is coming from the **Enemies** of God's People, Israel. These enemies are the Canaanite, Edomite, Khazar Jews, the Great Pretenders to the Inheritance of True Israel.

This is what the Bible calls the **Great Hatred** (Psalm 139:22; Ezek. 36:5; Hos. 9:7), that was announced in Gen. 3:15 and is still the most powerful religious and political force operative in the world. It is Esau's **Hatred** of Jacob's posterity that is driving the Jews headlong towards judgment by Yahshua when He comes again. Contrary to the Word of God, the doctrine being preached from today's pulpits is racial integration!!!

"Cain's line continued to grow and later Nimrod picked up the religion which eventually became known as Babylon and Baal.

Esau married into this mixed line of Canaanites and became known as the Edomites.

Today this doctrine is being pushed by their descendants in modern day Talmudic Jewry, Free Masonry, Catholicism, Cabala-ism, and centralized in the United Nations.

The UN policy is 'The International Brown Man.'

These enemies of Christ and the Adam/Israel people are carrying the grudge of Esau and Cain.

They both lost their rights to the blessing and the sceptre.

Now they do not want Jacob/Israel Adam to have it. They know from experience with torture in their new world orders of Babylon, Medo-Persia, Greece and Rome that they cannot turn Adamic Israel Christians from their faith in God and Christ.

Therefore, as Balaam told Balaak, the only avenue you have left to curse an Israelite is to get him to inter-racially fornicate and produce children in which God cannot live and function. They will automatically lose their right to be part of the kingdom and the redeemed.' – p. 20-21, The Bible and Race Relations, Dr. Everett Ramsey.



Remember the tower of Babel? Well, it was Satan's first attempt to create a multicultural, anti-Adamic "United Nations." That was why Yahweh disrupted their language, so they could not continue to conspire with Baal against us.

Dr. Ramsey's analysis is confirmed by the Book of Jubilees, where Rebecca says to Isaac, "And she went in to Isaac and said to him, 'One petition I ask of thee: Let Esau swear that he will not harm Jacob, and will not persecute him in enmity, for thou knowest the thoughts of Esau, that he was terrible from his youth on, and there is not gentleness in him; for he desires after thy death to kill him.

And thou knowest how he has done all day, that **He Has Left Us with His Whole Heart**, and does evil with us. He has collected thy flocks, and all the possessions **He Robs from before Thy Face**, and when we entreated and asked for what was ours, **He Did as a Man That Practices Usury on Us.**" – Jubilees, XXXV, 12-14.

Which ethnic group is most well-known, having no equal, for practicing USURY? Only we in Christian Israel know exactly who and what the Jews really are.

The rest of the world still gropes through the murky matrix of Mystery Babylon, having made common cause with the Jews in making merchandise of True Israel. (John 2:16; 2 Peter 3.) Commerce by day, fornication by night, just as Esau, their mackdaddy, did ages ago. Barack Obama is nothing but the latest puppet of the Edomites.

The Jews make merchandise of White Israelites, while the “Amen Corner” of Judeo-Christians cheer, “More! More!” “And they love to have its so!” The holier-than-thou “Christian” Zionist is asking for a double dose of judgment. They think and act like Jews, not even realizing their apostasy.

But, there is **Good News!** The slow, gradual Awakening of True Israel is occurring, just as prophesied: “And it shall come to pass, in that day, that Yahweh shall beat off from the channel of the river unto the stream of Egypt, **and Ye Shall Be Gathered One by One**, O ye children of Israel. "Word for Word" Deuteronomy Part 24

Translation by Stephen Howard Anderson



Chapter 31

1. And went Mosheh and spoke all these words to all Yis'rael;

2. and said to them, "I am a hundred and twenty years old today; and I am not able anymore to go forth and come in: and Yahweh has said to me that I may not pass over this Yarden River.

3. Yahweh Eloheycha will pass over before you and He shall destroy these nations before you and dispossess them. Yahshua 3091, he shall pass over before you, as has spoken Yahweh.

4. And shall do Yahweh to them that which He did to Siychon and Og, kings of the Emoriy, and to their land that He destroyed.

5. And shall give them up Yahweh before you, to do to them all the commandments that I commanded you.

6. Be strong 2388 and courageous 553, and do not fear 3372, nor be afraid 6206 of their presence, for Yahweh Eloheycha, He walks with you; and will not abandon 7503 you, nor forsake 5800 you. "

7. And called Mosheh to Yahshua, and said to him in the sight of all Yis'rael, "Be strong and courageous, for you must go with these people to the land that swore Yahweh to our forefathers to give them, and you shall give it as an inheritance 5157 to them.

8. And Yahweh, He will walk before you, He will be with you, and will not abandon or forsake you, do not fear, nor be dismayed 2865."

9. And wrote Mosheh this Torah, and gave it to the priests of the sons of Lewiy, which carried the Ark of the Covenant of Yahweh, and to all the elders of Yis'rael.

10. And commanded Mosheh to them, saying, "At the end 7093 of seven years, in the appointed 4150 year 8141 of release 8059, at the Feast 2282 of Booths 5521,

11. when comes all Yis'rael to appear before Yahweh Eloheycha in the place that He shall choose, you shall read aloud 7121 this Torah in front of 5048 all Yis'rael in their hearing 241.

12. Assemble 6950 the people, the men, and the women, and the little ones, and the sojourner that is within your gates, so that they may learn 3925, and fear 3372 Yahweh Eloheychem, and observe and do all the words of this Torah;

13. and their children, that have not known, may hear, and learn to fear Yahweh Eloheychem, all the days that you live upon the soil that you pass over the Yar'den River there to possess.

14. And said Yahweh to Mosheh, "**Behold,**

approaches your day to die: call Yahshua, and present 3320 yourselves at the Tent of Meeting, so I may command him." And went Mosheh and Yahshua, and presented themselves in the Tent of Meeting.



15. And appeared Yahweh in the Tent in a pillar 5982 of cloud 6051, and stood the pillar of cloud at the door of the Tent.

16. And said Yahweh to Mosheh, "**Behold, you shall lie down to sleep 7901 with your forefathers; and shall rise up this people, and go whoring 2181 after elohey 430 of racial aliens 5236 of the land where they go among them, and will forsake 5800 Me, and break 6565 My Covenant that I made with them.**

17. And shall be kindled 2734 My anger 639 that day, and I will forsake them, and will hide 5641 My face from them, and they shall be devoured, and shall find them many evils and troubles 6869; and they shall say in that day, 'Is this not upon us because Elohey 430 is not among us, and have found us these evils?'

18. And I shall surely hide My face that day over all the evils that they have done, because they have turned 6437 to other elohiym.

19. Now write you this song 7892, and teach it to the children of Yis'rael: and put 7760 it in their mouths, so that shall be this song a witness 5707 against the children of Yis'rael.

20. Because when I brought them into their land 127 that I swore to their forefathers, that flows 2100 with milk 2461 and honey 1706; and they have eaten, and are satisfied 7646, and grown fat 1878; they will turn to other elohiym, and serve them, and reject 5006 Me, and break My Covenant.

21. And it shall be, when find them many evils and troubles, shall answer them this song before them as a witness; for it shall not be forgotten 7911 from the mouths of their seedline: for I know their plans 3336 that they make, this day, before 2962 I bring them to the land that I swore."

22. So wrote Mosheh this song that day, and taught it to the children of Yisrael.

23. And He commanded Yahshua son of Nun, saying, "Be strong and courageous; because you shall bring the children of Yis'rael into the land that I swore to them: and I will be with you."

24. And it was when Mosheh made an end of writing the Words of this Torah upon a scroll, until they were completed 8552,

25. that commanded Mosheh the Lewiyyim, which carried the Ark of the Covenant of Yahweh, saying,

26. "Take this scroll of the Torah, and put it in the side 6654 of the Ark of the Covenant of Yahweh Eloheychem, and it shall be there for a witness against you,

27. because I know your rebellion 4805, and your hard 7186 neck 6203: behold, while I am yet 5750 alive with you today, rebellious 4784 you have been against Yahweh; and how much more 637 after my death?

28. Assemble to me all the elders of your tribes, and your officers, so I may speak in their ears these words, and call as witness 5749 against them the sky and the land.

29. For I know after my death you will be utterly corrupt 7843/7843, and turn aside from the way that I commanded you; and will befall 7122 you evil in the latter 319 days, because you will do evil in the eyes of Yahweh, to provoke Him to anger 3707 through the works 4639 of your hands.

30. And spoke Mosheh in the ears of all the assembly of Yis'rael the words of this song, until it was completed 8552.

The Fall and Rise of Abraham's House (Part 7)

THE DESCENDANTS OF THE LEVITES are still with us, as are those of David, but Jesus took over their job. **“For unto us a child is born, unto us (who? Israelites, no one else) a son is given, and the government shall be upon His shoulder (not the Queen’s)— of the increase of His government—there shall be no end, upon the throne of David—”** Isaiah 9:6-7.

That is the everlasting dynasty, a Melchizedek dynasty, by the King Jesus on David’s throne. **“—And in the sixth month the angel Gabriel was sent from God unto a city of Galilee, named Nazareth—and the messenger said...and behold thou shalt conceive in thy womb and bring forth a son, and thou shalt call His name Jesus. He shall be great and shall be called the Son of the Highest and the Lord God shall give unto Him the throne of His father David.”** (the throne was taken and given to Jesus because He was/is the Lawfully enthroned, anointed) Luke 1:26-33.

“(After Samuel) they desired a king; and God gave them Saul the son of Kish—and when He had removed him He raised up unto them David to be their king—of this man’s seed hath (ie already done) God according to His promise raised (ie, already done) unto Israel a Saviour, Jesus” Acts 13:20-24.

We read here that Jesus is the end of the ‘man-kings’, as far as their right to rule from David’s throne goes because Jesus **TOOK** it. We read that this King is a Saviour. No man-king can save us from the transgression of the Law, after all, they by being kings break even the first commandment to have no other gods (sars)

before God. We also see that Jesus is a Melchizedek, rightfully enthroned King.

Accepting Jesus becomes far more meaningful when you understand he ‘rolled away’ the wickedness of Gilgal. But the deed of ‘saving’ comes only to those who believe in Him, part of the proof in believing Him is to believe or accept that He is King, right now.

All other people calling themselves kings carry on the curse of Gilgal. Who was to accept Jesus? **“Men, brethren, children OF THE STOCK OF ABRAHAM, and whosoever among you (who? You--’Men of Israel’ for Paul was addressing them in Acts 13:16)—feareth God, to you (men of Israel) is the word of this salvation sent.”**

Man-king monarchists say that God is on the side of the Royals because the ungodly Jews have been behind the plots to kill royal families; the logic is; Jews are bad, then those the Jews attack must be good folk. To add to the confusion, Judeo-Christians say that Super spook, Mr. S. A. Tan does the throwing down of men, nations, and kings.

Maybe they should hear what God says on this. Isaiah 63:1-6 **“Who is this that cometh from Edom (the Jews)—this that is glorious in his apparel, travelling in the greatness of his strength? (ie Edom thinks he can stomp all over us by his own strength)— Wherefore art thou red in thine clothing, and thy garments like him that treadeth in the wine vat? (symbolic of rebellious Israelites or crushed grapes signifying that Esau knows he stomps all over us).**

I HAVE TRODDEN the winepress ALONE— for I trample in my fury—” God says that He does it! **“To wit—and (to) the kings thereof, and the princes (sars) thereof, to make then a desolation, an astonishment...”** Jeremiah 25:18. And so God kills the kings, the sars.

Yes, God, He wants the pretenders out the way. The problem is, rebellious Israelites keep enthroning man-kings, either by lineage or by voting. Oh, what a stiff-necked folk we are.

King Jesus added to this, saying the same as His Father did in Jeremiah 25:18; basically, the following paraphrases it by showing that God uses men to tread under their feet those who are good for nothing, no hopers, those who rebel against God, those who have lost their saltiness, those who claim to have a heart for God but their deeds belie their words. They are most at risk of being trodden under foot, or to be spewed out, for they are neither hot (full on) or cold (they don't know Him). Revelation 3:15-16.



We are told by many that the Queen of England swears to uphold the Coronation Oath Act, that she vowed to do so upon her coronation. She undertook to govern lawfully, in righteousness and mercifully, to uphold God's Law and to treat the Bible as the rule for the whole of life and government.

As we have so far read, (for more see 'to be added') she has failed bitterly from the start and her salt has lost its strength. Many of the royals are Israelites like us. We are all potentially the salt of the earth.

"But if the salt have lost his savour (strength), wherewith shall it be salted? It is thenceforth **GOOD FOR NOTHING**, but to be cast out and to be trodden under the foot of men." Matthew 5:13. Again we see God using men to do the treading, it is not some Church created spook called Satan by way of poor translations.

The Queen heads the Anglican Church which to day is part of the Laodician church age. Laodicia means a folk who justify themselves or who are self-evident. That is to say that through their 'kings' they are justified, protected—it is self-evident, they claim. It is worth reading this part of the Bible carefully. Revelation 3:15 "I know" says Jesus, "thy works, that thou art neither cold nor hot: I would that thou wert cold or hot." He

wishes they were one way or the other, "So then because thou art lukewarm" (hardly warm, ie pledging to God as in a coronation oath, church vows, wedlock vows, but never upholding such) "I will spew thee out of my mouth." That feeling of self-justification is so clearly shown in the way the Saxon nations behave.

We have God on our side, we are a Christian nation, i.e., "the temple of the Lord is in our midst." With that arrogance in the late 1800's, Christian nations all claiming to have God on their side, or the temple of the Lord to trust in, warred against each other. Yet, each were wholly lawless.

Each were wholly Gilgallian. But God does not hide His thoughts, He made it quite clear why we suffered so much, we just never bothered to read what God told us in black and white.

In Jeremiah 7:4-16 "Trust ye not in lying words saying, the Temple of the Lord, the Temple of the Lord, the Temple of the Lord are these," (ie we are a Christian nation, God gives us the might to win.) "Will you steal, murder and commit adultery (as was so clear in the Anglo-Boer War, adultery is to race-mix)..and walk after other gods—" (parliament, mighty men, man kings)—"And come and stand before me in this house (nation) which is called by my name." (in New Testament times that means Christian)..and say, We are delivered to do all these abominations." Christians say we are saved and under grace and no longer need the law. Thus, they are lawless and literally say that they can make their own laws, thus committing abominations.

"Therefore—! will cast you out of my sight—pray not for this people, neither lift up cry nor prayer for them—FOR I WILL NOT HEAR THEE." Sounds like He is saying I will love you no more!

Christ outlines their wealth which they see as self-evident of God's blessing. He then says in Matthew 5:20 "**Behold, I stand at the door and knock:** (what door? To the hearts of those in the system) **if any man (of Israel) hear my voice** (ie. accept the word, the Laws and the true King Jesus) and open the door—" What then? Keep staying in the churches? Keep pledging allegiance to man-kings? Answer, "**I will come in to him and will sup with him** (the process of becoming Christ's Body, not Christ's bride) **and he with Me.**"

To him that overcometh will I grant to sit with Me in My throne, even as I ALSO OVERCAME, and AM set down with My Father in His throne.” So, as Jesus comes to you, you go to Him, it means you are called-out (more on that as we go on), out of the churches! These called out ones then are reckoned as over-comers and are planned to sit with

Christ! Where? On His throne, that is to say **“He hath made us Kings and Priests unto God and His Father.”** Revelation 1:6. Note well, this was written only decades after the crucifixion and Jesus says to John that He already sits on the throne and rules the earth. The rest of Revelation shows how He rules.

In verse 19 Christ called then to change their ways. We see much of verses 19-20 paraphrased in Amos 5, we read a call for Israelites to change their ways **“For thus saith the Lord unto the house of Israel (this is an end-time prophecy, to only Israelites) Seek ye Me, and ye shall live.”** i.e. seek something else and you’ll die, God then lists the something else. **“But seek not Bethel, nor enter into Gilgal, and pass not to Beersheba—”** (Westminster Abbey has carved into the arch, “Surely this is the house of God” i.e. “Beth-el”. God says not to seek Him there!) all three terms are linked to royalty and churches and finance, the age-old triad. God is not using the terms in a geographic sense because—**For Gilgal shall surely go into captivity.”** Firstly seek the Lord, where? Anywhere!

Therefore Gilgal is also anywhere where man-kings rule in this context, because Gilgal was the starting point of a system of Elohiym; mighty men, rulers. Man’s system of Elohiym is called Gilgal. It says that if you put your trust in Gilgal, man-kings, you’ll go into captivity. In modern history this is so clearly shown in Russia. The white Russians put their trust in the Czar, and they went into an iron yoke captivity.

Some people think that the man-king monarchy will save us here today. God says no. At all costs these well-meaning folks will defend the monarchy and say ‘well, if they stood up for God’s Laws they’d be killed. If that be so, then, how can they save you? So are we to suffer them being lawless? The afore-stated says otherwise.

What’s more, Samuel says of the man-king order that it is rebellion and outlines how God sees this. The context is to do with kings, **“For**

rebellion (to God’s Law) is as the sin of witchcraft (and we are not to suffer witches to live) and stubbornness (the royalty stubbornly ignore God’s Laws) is as the iniquity and idolatry. Because thou hast rejected the word of the Lord, He hath also rejected thee from being a king.” 1 Samuel 15:23.



Gilgal

In Micah chapter 6 we read what God asks, asking what have I done to deserve this, you choose kings rather than Me, **“O my people, what have / done unto thee? For I brought thee up out of the land of Egypt (which was ruled by man- king monarchs) ...remember now what Balak king of Moab consulted and what Balaam (the Israelite Church minister) answered him from Shittim unto Gilgal— Shall I count them (Israelites) pure with the wicked balances and with a bag of deceitful weights?”**

The rich men—are full of violence (they promote it today with films and drugs) and the dwellers thereof have spoken lies— Therefore.— will I make thee sick in smiting thee in making thee desolate because of thy sins (rejecting God)— For (or because) the statutes of Omri (an Israelite king) are kept (the king’s laws are yielded to) and all the works of the house of Ahab (another king) and ye walk in their counsels, (man-king laws) that (therefore) I should make thee a desolation and the dwellers thereof a hissing” (ie. others vilify you; racists; invaders and so on, we see it every day all because of folks yielding to man-kings).

People think that Jesus had to redeem the Israelites from Adam’s sin. Of course Jesus had to put right where Adam failed but they overlook the selling that God does. God sells us into captivity. When God took us out of Egypt, He redeemed us, yes, redeemed back then. **“For I brought thee up out of the land of Egypt and redeemed thee...”** Micah 6:4, but in verse 5 Gilgal gets mentioned.

Thus in Micah 6:16 picking up where we left off dealing with them following man-kings laws... **“therefore ye shall bear the reproach of my people (Israelites).”** Jesus was to take away the reproach which began at Gilgal, but you have to recognize that He took away the reproach by taking David’s throne, which He did at ‘Gilgaltha’ (Golgotha).

“Thus hath the Lord dealt with me in the days wherein he looked on me to take away my reproach among men.” Clearly other men still had the reproach (Luke 1:25) but if He looks on you, He has called you out to be under His kingship. Those that walk in the statutes of kings, ie constitutions as opposed to the ‘Word’ will suffer the curses of reproach. Micah in chapter six lists a number of curses that are identical to the curses in Deuteronomy 28:15 onwards.

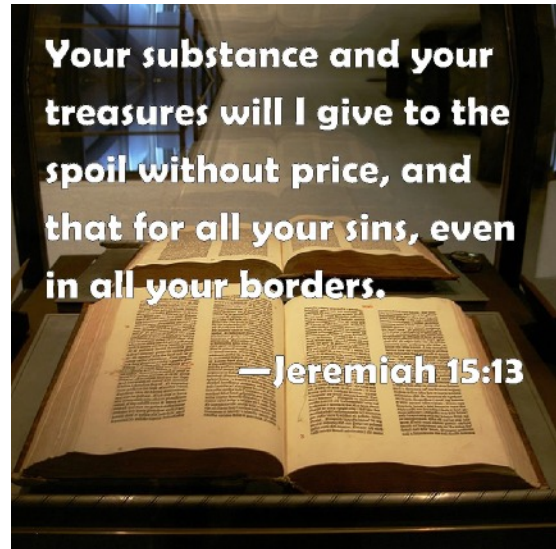
In short, calling others kings or voting for PMs and Presidents is a rejection of Jesus that brings on God’s wrath. Our people look to a man-king (a man-god; Elohiym) to save them— **“Now make us a king to judge us like all the nations..”** 1 Samuel 8:5.

Again, this wanting to have a man-king was the wickedness of Gilgal, it is the ‘spiritual’, the mindset (so as a man thinks) that led the actual **CRIME** or misdeed; the crowning of the man-king at Gilgal. The word ‘judge’ in 1 Samuel 8:5 is used as a verb from the noun ‘deliverer’ ie. ‘to save’. The want therefore is to ‘make a king to save us.’ (The deliverers in the book of Judges were all called judges).

The Saxon word forejudge is ‘doom’, the noun is ‘dooms-men’. Variations of ‘doom’ are damn, condemn, and deem. To ‘deem’ is almost an act of justifying. We see here that there is a Laodicean element of thought, namely, to justify society’s attitudes).

God says of the man-king monarchy (which in republics is an order of man-king Presidents), **“They have Rejected Me, that I should reign over them.”** Thus how do you stop God or Jesus from being your King? Choose your own kings, P.M’s or Presidents. But do so at your own risk, Deuteronomy 28:47, because so many, even the conservative man-king monarchists, know we are ruled by crooks. **“Because thou servedst not the Lord thy God with joyfulness (ie accept Him as king happily)— Therefore shalt thou**

serve thine enemies which the Lord shall send against thee, in hunger, and in thirst, and in nakedness (porn. yes, many of our daughters serve our foes this way, nakedness is also symbolic of shame.) **and in want of all things** (we have PMs, Presidents and Queens, yet we are all short of money, and more so after the GST) **and He shall put a yoke of iron upon thy neck until He have destroyed thee...”** God does this because we choose man-kings. **“Thy wealth and the treasures will I give to the spoil without price and that for all thy sins...”** Jeremiah 15:13.



Notice that it is God, not Super spook (Satan), that does this. Indeed, Satan must be bored senseless as God gives little to nothing to do! **“Howbeit thou (God) art just in all that is brought upon us (at last admitting we deserve the yokes)— we have done wickedly.**

Neither have out kings, our princes, our priests nor our fathers kept thy law (lawless from the top to the bottom of the pile, from the monarchy and elected monarchs- ie PM’s & Presidents, to the man in the street)— For they (the above stated) have not served thee in their kingdom— neither turned they from their wicked works (by making laws).

Behold, we are servants (i.e. not Freemen as kings and priests under God)..and for the land that thou gavest unto our fathers to eat the fruit thereof and the good thereof, behold we are servants in it; and it yielded much increase **Unto the Kings Whom Thou Hast Set over Us Because of Our Sins—”** Nehemiah 9:33-37.

The Kings, i.e. man-king monarchs (lineage and elected) are given rule over us not to protect us

but to **Punish** us for our refusal to obey God's Laws, the first law being to have God as king, now of course His Son (police mottos saying "to protect and serve" mean to protect and serve the man-kings and his agents; but to the people as a whole they become "Law-enforcement" to punish us).

Recently there was another "petition" circulating in a campaign to **KILL THE GST** (tax). Look that up in the dictionary - "petition" is another word for "prayer." And to whom was this petition - this prayer - addressed? You guessed it! "To Her Most Gracious Majesty - we humble petitioners, pray and beseech your Majesty." See what I mean about praying, and grovelling to a false god? Stop voting for elected man-kings, stop upholding lineage man-kings. Over-comer Christians are called "the elect".

How can you be elected if you refuse to be elected? You refuse to be elected when you elect someone else. What is the election for? You are elected to rule with Christ. If you elect other rulers, then you nullify the work of Christ because you discard your given authority to rule. It is clear that PMs and Presidents are elected. Monarchists say they don't elect their kings, but they do. Election is a spiritual thing.

In their hearts they chose (elect) to serve the monarch. Further more, if Queen Elizabeth is descended from King David, then there was an election process, no different to a presidential election or a PM vote. The only difference is that

it was a one off. The folk elected the monarch, "Now therefore hearken unto their voice..." 1 Samuel 8:9. God says to the folk, "**And you shall cry out—because of your king which ye have chosen..**" 1 Samuel 8:18

In Australia, the Referendum was not about what is best for the Israelites, it was simply to choose what sort of man-king system to have, one by lineage or one by modern votes. Both are saying, "our king, not Jesus Christ." The referendum should have been, vote ye today for President, the line of Von Battenberg or Jesus. Which way did you vote? Back to Gilgal? Choose you this day whom ye will serve.

"The kings of the earth set themselves and the rulers take counsel together against the Lord and against His 'Christ'= anointed (called out ones, elect, chosen of Israel) saying, Let us break their bands asunder and cast away their cords from us. He that sitteth in the heavens shall laugh— Then shall He speak unto them in His wrath and vex them in His sore displeasure.

YET HAVE I SET MY KING UPON MY HOLY HILL OF ZION." (Zion, set up as a sign, ie. your life is a sign in Zion if your King is King Jesus. You can acknowledge His throne today Psalm 2. For some reason man-king monarchists always see the word 'kings' in the Bible applying to Presidents or PMs only, never to the Royal family.

BARDSEY ISLAND (WELSH: YNYS ENLLI), known as the legendary "Island of 20,000 Saints", is located 1.9 miles (3.1 km) off the Llŷn Peninsula in the Welsh county of Gwynedd. The Welsh name means "The Island in the Currents", while its English name refers to the "Island of the Bards", or possibly the Viking chieftain, "Barda". At 179 hectares (440 acres; 0.69 sq mi) in area it is the fourth largest offshore island in Wales, with a population of only 11.

The north east rises steeply from the sea to a height of 548 feet (167 m) at Mynydd Enlli, which is a Marilyn, while the western plain is low and relatively flat cultivated farmland. To the south the island narrows to an isthmus, connecting a peninsula on which the



lighthouse stands. Since 1974 it has been included in the community of Aberdaron.

The island is claimed to be the burial site of Merlin. It has been an important religious site since the 6th century, when it is said that the Welsh kings of Llŷn and Saint Cadfan founded a monastery there. In medieval times it was a major centre of pilgrimage and, by 1212, belonged to the Augustinian Canons Regular. The monastery was dissolved and its buildings demolished by Henry VIII in 1537, but the island remains an attraction for pilgrims to this day, marking the end point of the North Wales Pilgrims Way.

Bardsey Island is famous today for its wildlife and rugged scenery. A bird observatory was established in 1953. It is a nesting place for Manx shearwaters and choughs, with rare plants, and habitats undisturbed by modern farming practices. The waters around the island attract dolphins and porpoises and grey seals. The island was inhabited in Neolithic times, and traces of hut circles remain.

During the 5th century, the island became a refuge for persecuted Christians, and a small monastery existed. Around 516, Saint Einion, king of Llŷn, invited the Breton Saint Cadfan to move to the island from his first residence in Tywyn. Under Cadfan's guidance, St Mary's Abbey was built. For centuries, the island was important as "the holy place of burial for all the bravest and best in the land".

Bards called it "the land of indulgences, absolution and pardon, the road to Heaven, and the gate to Paradise", and in medieval times three

pilgrimages to Bardsey were considered to be of equivalent benefit to the soul as one to Rome.

In 1188, the abbey was still a local institution but, by 1212, it belonged to the Canons Regular. Many people still walk the journey to Aberdaron and Uwchmynydd each year in the footsteps of the saints, although today only ruins of the old abbey's 13th century bell tower remain. A Celtic cross amidst the ruins commemorates the 20,000 saints reputed to be buried on the island.

Saint Einion is sometimes claimed to have joined the community on the island, although his relics are claimed by Llanengan on the mainland. Saint Deiniol, the Bishop of Bangor, was buried on the island in 584. Saint Dyfrig was also buried on Bardsey Island, although in 1120 his remains were transferred to Llandaff.

The Dissolution of the Lesser Monasteries Act of 1536, on the orders of Henry VIII, resulted in St Mary's Abbey being dissolved and its buildings demolished in 1537. The choir stalls, two screens and the bells were transferred to Llanengan, where the parish church was then being built.

For many years Bardsey Island formed part of the Newborough Estate, and between 1870 and 1875 the island's farms were rebuilt; a small limestone quarry was opened, and a lime kiln

constructed. Carreg and Plas Bach are separate buildings, but the remaining eight were built as semi-detached houses, each pair with outbuildings set around a shared yard. The buildings are Grade II listed and, in 2008, Cadw approved a grant of £15,000 to cover the first phase of repairs. Only one of the original croglofft cottages, Carreg Bach, survives. Given the choice of a harbour or a new church, in 1875 the islanders asked the estate to provide a place of worship; a Methodist chapel was built.

The island had a population of 90 by 1841. It had increased to 132 in 1881; by 1961 it had fallen to seventeen. The island's small school, opened in a former chapel in 1919 and closed in 1953. In 2019 there was a long-term population of

eleven, of whom four lived on the island during the winter.

The Bardsey Island Trust (Welsh: Ymddiriedolaeth Ynys Enlli) bought the island in 1979, after an appeal supported by the Church in Wales and many Welsh academics and public figures. The trust is financed through membership subscriptions, grants and donations, and is dedicated to protecting the wildlife, buildings and archaeological sites of the island; promoting its artistic and cultural life; and encouraging people to visit as a place of natural beauty and pilgrimage.

“That’s one of the things the Edomites didn’t like about Hitler’s concentration camps. There were no gas chambers. That’s all baloney. But when you go into the camp, there’s a big sign, ‘*Arbeit Macht Frei*,’ which meant, ‘Work Makes You Free.’

The Jews don’t believe in that. They believe you do all the work and they get all the benefit. They hate work. This is the problem with the Jews. They don’t like work.

“They are soft, flabby. Look, even the young Israeli soldiers, they’re soft! Even in their teens and early 20’s, because they’re simply not used to work. Jews are not used to manual labour.

“They’re parasites. And they’ve been parasites for thousands of years.”

“But Bobby – execution? It’s too much, eh?”

“Well, no – I wish it was more. Maybe I said too few, few hundred thousands. Maybe it should be in the millions should be executed. But all the rest, all the other tens of millions should go to re-education camps, kind of like they did in Red China, until they learn something, so they accept Christ and decency. Admit the errors of their ways.

“Well, the world is in terrible shape because of the Edomites. They’re driving the world toward extinction, with all these atom bombs and missiles and nuclear power plants.

And now they’re in genetic engineering, which will just totally erase life as we know it if it continues. I mean, there’s just no end to this genetic engineering. This is really criminal and it shows, this one thing, tells you right there that the Jews are bastards. You’re not supposed to go any further. Now, you know, they’ve created all kinds of nonsense surrounding this that it’s beneficial. Bullshit! It’s not beneficial – it’s very, very harmful. It is harmful physically, it is harmful mentally. It is harmful in every way. It’s just a terrible crime. And they’re vicious.”

This was spoken after Chernobyl but long before Fukushima. The guy was brilliant and brave and died in 2008. The Edomite nuclear industry has as a well-known side effect the certainty of cancer from exposure to radiation. But even that is not the Jewish cancer damage I have in mind.

Can we calculate the damage to humanity done by Edomites? The first great damage was Christianity. Whether you see it as a Jewish plot, as I do, or a pathetic reaction to Judaism to me doesn’t matter.

But this piece is about another form of Edomite damage you may not have heard of yet. Cancer. Two Jews, Jonas Salk and Albert Sabin, poisoned millions of us to death and put all of us in jeopardy.

Now I'm reading the most significant book in my lifetime of reading. Dr. Mary's Monkey, by Edward Haslam. He probably wouldn't be too happy about an endorsement from this writer, just as James Bacque wasn't thrilled about my comments on his great books back in the Nineties.

Edward Haslam grew up in New Orleans and his father was a physician who worked with Dr.

Mary Sherman, a prominent orthopedic surgeon who became involved with the study of cancer viruses, specifically monkey viruses.

Haslam's book changes what we thought we knew about the New Orleans group involved in the JFK assassination – David Ferrie, Dr. Alton Ochsner, Guy Bannister, Lee Oswald and Clay Shaw. That's how it starts. We get some background behind Jim Garrison's attempts to bring them to justice (and justice to Oswald), attempts sandbagged by the CIA, FBI and Lyndon Johnson.

Then the book shifts gears and details Haslam's years-long and reluctant investigation into the murder of Dr. Mary Sherman, who had been a friend of Haslam's father. Dr. Mary was murdered by colleagues at the US Public Health Hospital after her right arm was blown off and disintegrated by a three-storey-tall linear particle accelerator being used covertly in that hospital for a top-secret project to fix what Dr. Salk and Dr. Sabin had done to us ten years earlier.

And to create a cancer virus that could be used for assassination and perhaps mass murder. The doctors and technicians were persuaded they were doing a patriotic service to kill Castro and save the economic basis for New Orleans itself - continued business with a non-Communist Latin America.

When her colleagues saw that Dr. Mary Sherman was still alive, although blind and horribly maimed, she was stabbed in her heart and taken back to her apartment where a fake lesbian murder scene was concocted by mutilating her sexual organs and setting her corpse on fire, which would allow a corrupt coroner to explain how her arm and ribcage were burned away. It worked and the New Orleans PD went along with the lies. The killers had to do this to prevent exposure of their secret and illicit use of the linear particle accelerator to mutate and soup-up the monkey cancer viruses that could be used to kill Castro, which were used to kill Jack Ruby before his re-trial.

The main point I wish to make is that Drs. Salk and Sabin used diseased monkey organs to grow their "polio vaccines." They either knew before or right after the mass inoculations that the monkeys had in their blood streams many cancer-causing diseases and that these diseases

The other Jewish doctor, Sabin, sold us his live virus potion on sugar cubes in '55 and we kids were relieved that there wouldn't be any more shots.

The US Public Health Service knew the extent of the crime after one hundred million doses had been administered and went ahead with another hundred million doses right up to 1963!

Most people probably didn't believe the warnings that Jewish doctors must be shunned by Gentiles. Thomas Edison advocated for the Direct Current, while Nikolai Tesla held forth for the Alternating Current. Pasteur’s science said disease could be cured, if not prevented, by killing the germs. Pasteur’s science became the economic foundation of modern medicine, with all of its drugs and vaccines.

Bechamp’s science, which advocated for the social responsibility of healthy living, made no one rich, and so he, and his science, were relegated to the dustbin of history.

And today in the here and now, along comes the Made-In-China novel corona-virus, with its attendant promises of new drugs and vaccines.

And so, we wonder –Whose science of disease is most real: Louis Pasteur’s or Antoine Bechamp’s?

The signs say, “Science is real.” No doubt Napoleon the Pig would follow that up with, “But some science is more real than others!”

The Man after Whom Pasteurisation Is Named

“...UNESCO proclaimed 1995 as “The Year of Pasteur.” Just prior to that, Pasteur’s family proudly released his notes and research. Gerald Geison, a science historian, was among the first people to thoroughly review those notes. In 1995, The Year of Pasteur, Geison wrote an article in the New York Times proclaiming that Pasteur had lied about his research on vaccines and germs and that most of his ideas had been plagiarized from his contemporaries. His article, “Pasteur’s Deception” claimed that Pasteur was, in the end, a fraud...”

“...In researching medicine, following the money has always led to the truth. The money, in Pasteur’s case, has led to unnecessary and mandatory vaccination programs. Wouldn’t we all like to own a company that gets support from a government that will enact laws to make the purchase of our product mandatory?”

Where to begin? Well, let’s begin with the Germ Theory.

As discussed in The Lost History of Medicine, the Terrain is more important than the Germ.

Pasteur described germs as non-changeable. We know today, from the use of Darkfield Microscopes that microorganisms are pleomorphic that they can change and often do.

A virus can become a bacterium which can mutate into a yeast or fungus. Modern medicine has yet to acknowledge this because it would turn the pharmaceutical interests on their backs like a helpless tortoise. Again, we follow the money....” “...It was Bechamp who discovered the pleomorphic nature of germs, and later on Bernard described the “milieu” or environment

that affected/caused those changes. Bernard is the one responsible for our theories today on pH and how the nature of the microorganisms change as the body moves from an alkaline pH to an acidic pH. (This is covered in depth in our article The Lost History of Medicine.)

On his deathbed, Pasteur recanted, saying that Bernard was right; the Terrain is everything, the Germ is nothing.

However, since the Germ is so profitable, the medical world has written off his final statements as the madness of a dying man. We should all be so mad.

Another problem with the Germ Theory of medicine is discovered when we look at Koch’s Postulates:

The germ which causes a disease must be found in every case of the disease under the conditions

The germ must not be found in other diseases or healthy people.

Pasteur never quite fulfilled all the rules. He was not able to find the germ in all cases of a disease, and this is where his research became

And finally, when Pasteur passed a germ from one animal to another to cause the disease, he did not pass the germ alone, but took some blood with it. Injecting toxic blood from one animal to another will guarantee the receiving animal becomes sick....”

“...Pasteur instructed his family never to release his lab notes. After his grandson died in 1975, they were finally released. This was when Professor Gerald Geison got a hold of them and



presented his findings in 1993 to the American Association for the Advancement of Science. The New York Times, seeing how UNESCO had named 1995 the Year of Pasteur, felt that this would be the proper time to release Gerald Geison's research. Don't you just love a good drama?"

The Myth of Pasteurisation



One more thing before we go. Our second reference above makes this statement: "Pasteur developed 'pasteurisation, a process by which harmful microbes in perishable food products are destroyed using heat, without destroying the food.'"

This is not entirely true. Pasteurisation does **Not Kill All** harmful microbes in milk and it **DOES** harm the milk.

In her book, The Medical Mafia, Dr Lanctôt debunks pasteurization with a one-two punch:

The temperature is not high enough.

The temperature is too high.

First off, Dr Lanctôt points out that germs that bring us typhoid, coli bacillus, and tuberculosis are not killed by the temperatures used, and there have been a good number of salmonella epidemics traced to pasteurised milk.

Secondly, the heating process injures the milk. She points out that pasteurisation destroys milk's intrinsic germicidal properties, not to mention healthy enzymes. She goes on to state that 50% of milks calcium is unusable (the body cannot assimilate it) after pasteurisation. So much for all those milk commercials.

Here's something we found online that was drawn up for a Los Angeles County Board of Supervisors concerning outbreaks from pasteurized milk:

1997, 28 persons ill from Salmonella in California, **All from Pasteurized Milk.**

1994, 105 persons ill from E. coli and Listeria in California March of 1985 19,660 confirmed cases of Salmonella typhimurium illness **FROM Consuming Properly Pasteurised Milk.** Over 200,000 people ill from Salmonella typhimurium in **Pasteurised Milk**

1985, 142 cases and 47 deaths traced to **Pasteurised** Mexican-style cheese contaminated with Listeria monocytogenes. Listeria monocytogenes **Survives Pasteurisation!**

1985, 1500 persons ill from Salmonella infection

August of 1984 approximately 200 persons became ill with a Salmonella typhimurium from **Consuming Pasteurised Milk**

November of 1984, another outbreak of Salmonella typhimurium illness from **Consuming Pasteurised Milk**

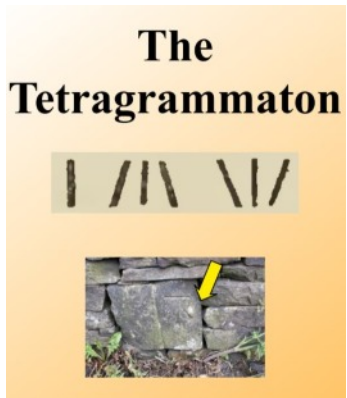

A recent investigation of stone-age rock art at a megalithic construction known as Hendraburnick Quoit, in Cornwall, has revealed that ten times the number of artistic markings are visible when viewed in moonlight or feeble sunlight from the south east. These mysterious markings are now exclusively revealed by Ancient News researchers to be coded star markers.

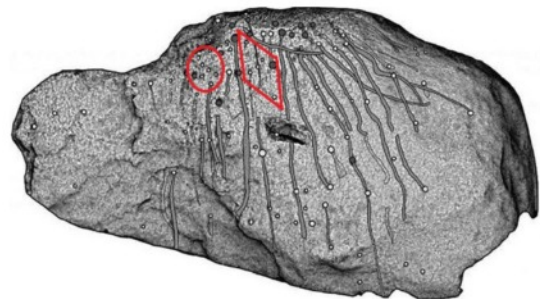
They also discovered that pieces of quartz had been deliberately crushed and spread around the site, which would have reflected moonlight, or firelight, creating an effect that would have likely accentuated any viewing of the rock-art.

Hendraburnick Quoit is a large propped ‘axe-shaped’ stone that rested upon a low platform of slates on Hendraburnick Down, near Davidstow. The investigating archaeologist, Dr. Jones, suspects that the megalithic stone was dragged up from the valley below to be used as a ritual marker associated with a more extensive Late Neolithic or Early Bronze Age, sacred site – perhaps around 2 500 BC. Dr. Jones and his team argue that the layer of slate beneath the 16-tonne quoit indicates that it was not a natural formation.

Before the research project lead by Dr. Jones and assisted by his colleague Thomas Goskar, 13 cupules (circular scoop markings) were recorded on the stone, their detailed observations under reduced light have resulted in a total of 105 engravings noted. Hendraburnick Quoit has duly been elevated to the status of the most highly decorated and complex example of rock art in southern England.

The fact that the art was created in a way that makes it more visible at night brings into question one of the prominent understandings associated with Neolithic structures, that they were features of a solar cult, often believed to be aligned with the solstice sun rise. The findings of Dr. Jones and his team would seem to suggest that some of the important megalithic sites may, in fact, be artifacts of a primarily lunar cult, with important rituals being carried out under the light of the full moon.

Dr. Jones, of the Cornwall Archaeological Unit, said: “I think the new marks show that this site was used at night and it is likely that other megalithic sites were as well. “Stonehenge does have markings, and I think that many more would be found at sites across the country if people were to look at them in a different light.”

Writing in the archaeology journal Time and Mind, Dr. Jones and Mr. Goskar conclude: “As in many cultures where darkness is associated with the supernatural and the heightening of senses, it is possible that some activities at Hendraburnick Quoit may have been undertaken at night.

Smashed up quartz pieces have also been discovered at the Early Bronze Age cairn at Olcote near Calanais, on the Isles of Lewis, these are already suspected to be linked with lunar

rites. Similar quartz debris has been identified at a growing number of neolithic sacred spaces.

The type of markings observed is found across the ancient world and often feature an indentation surrounded by concentric circles (cup and ring marks). These cupule markings are most often found at ancient sites in Northern Europe, but similar patterns have also been found even in Australia.

Dr. Jones admits that his team has not yet deciphered the meaning of the markings, however, we can reveal that the Ancient News team's lead researcher, Bruce R. Fenton, is first to solve the mystery. **Yours truly, John Rider, UK.**

Mystery on The Isle of Wight (Part 2)

Again It Was the Bees That Gave the First Warning

MR. CHARLES SCHILKE OF MORGANVILLE, Monmouth County, a beekeeper with considerable experience operating about 300 colonies reported a great loss of bees from the hives in one of his yards located near Bradevelt, read one report, published in August 1918. “Thousands of dead were lying and thousands of dying bees were crawling about in the vicinity of the hive, collecting in groups on bits of wood, on stones and in depressions in the earth.

The affected bees appeared to be practically all young adult workers about the age when they would normally do the first field work, but all ages of older bees were found. No abnormal condition within the hive was noticed at this time.”

This outbreak was confined to Morganville, Freehold, Milhurst, and nearby areas of New Jersey, just a few miles seaward from one of the most powerful radio stations on the planet, the one in New Brunswick that had just been taken over by the government for service in the war.

A 50,000-watt Alexanderson alternator had been installed in February of that year to supplement a less efficient 350,000-watt spark apparatus. Both provided power to a mile-long aerial consisting of 32 parallel wires supported by 12 steel towers 400 feet tall, broadcasting military

communications across the ocean to the command in Europe.

Radio came of age during the First World War. For long distance communications there were no satellites, and no shortwave equipment. Vacuum tubes had not yet been perfected. Transistors were decades into the future.

It was the era of immense radio waves, inefficient aerials the size of small mountains, and spark gap transmitters that scattered radiation like buckshot all over the radio spectrum to interfere with everyone else’s signals.

Oceans were crossed by brute force, three hundred thousand watts of electricity being supplied to those mountains to achieve a radiated power of perhaps thirty thousand. The rest was wasted as heat. Morse code could be sent but not voice. Reception was sporadic, unreliable.

Few of the great powers had had a chance to establish overseas communication with their colonies before war intervened in 1914. The United Kingdom had two ultra-powerful stations at home, but no radio links with a colony. The first such link was still under construction near Cairo. France had one powerful station at the Eiffel Tower, and another at Lyon, but no links with any of its overseas colonies.

Belgium had a powerful station in the Congo State, but blew up its home station at Brussels after war broke out. Italy had one powerful station in Eritrea, and Portugal had one in Mozambique and one in Angola. Norway had one ultra-potent transmitter, Japan one, and Russia one.

Only Germany had made much progress in building an Imperial Chain, but within months after the declaration of war, all of its overseas stations—at Togo, Dar-es-Salaam, Yap, Samoa, Nauru, New Pomerania, Cameroon, Kiautschou, and German East Africa—were destroyed.

Radio, in short, was in its faltering infancy, still crawling, its attempts to walk hindered by the

onset of the European War. During 1915 and 1916, the United Kingdom made progress in installing thirteen long-range stations in various parts of the world in order to keep in contact with its navy.

When the United States entered the war in 1917, it changed the terrain in a hurry. The United States Navy already had one giant transmitter at Arlington, Virginia and a second at Darien, in the Canal Zone.

A third, in San Diego, began broadcasting in May 1917, a fourth, at Pearl Harbour, on October 1 of that year, and a fifth, at Cavite, the Philippines, on December 19. The Navy also took over and upgraded private and foreign-owned stations at Lents, Oregon; South San Francisco, California; Bolinas, California; Kahuku, Hawaii; Heeia Point, Hawaii; Sayville, Long Island; Tuckerton, New Jersey; and New Brunswick, New Jersey. By late 1917, thirteen American stations were sending messages across two oceans.

Fifty more medium and high powered radio stations ringed the United States and its possessions for communication with ships. To equip its ships the Navy manufactured and deployed over ten thousand low, medium, and high powered transmitters.

By early 1918, the Navy was graduating over four hundred students per week from its radio operating courses. In the short course of a year, between April 6, 1917 and early 1918, the Navy built and was operating the world's largest radio network.

America's transmitters were far more efficient than most of those built previously. When a 30-kilowatt Poulson arc was installed at Arlington in 1913, it was found to be so much superior to the 100-kilowatt spark apparatus there that the Navy adopted the arc as its preferred equipment and ordered sets with higher and higher ratings.

A 100-kilowatt arc was installed at Darien, a 200-kilowatt arc in San Diego, 350-kilowatt arcs at Pearl Harbor and Cavite. In 1917, 30-kilowatt arcs were being installed on Navy ships, outclassing the transmitters on most ships of other nations. Still, the arc was basically only a spark gap with electricity flowing across it

continuously instead of in bursts. It still sprayed the airway with unwanted harmonics, transmitted voices poorly, and was not reliable enough for continuous day and night communication.

So the Navy tried out its first high speed alternator, the one it inherited at New Brunswick. Alternators did not have spark gaps at all. Like fine musical instruments, they produced pure continuous waves that could be sharply tuned, and modulated for crystal clear voice or telegraphic communication.



Ernst Alexanderson (above), who designed them, also designed an antenna to go with them that increased radiation efficiency sevenfold. When tested against the 350-kilowatt timed spark at the same station, the 50-kilowatt alternator proved to have a bigger range. So in February 1918, the Navy began to rely on the alternator to handle continuous communications with Italy and France.

In July 1918, another 200-kilowatt arc was added to the system the Navy had taken over at Sayville. In September 1918, a 500-kilowatt arc went on the air at a new naval station at Annapolis, Maryland. Meanwhile the Navy had ordered a second, more powerful alternator for New Brunswick, of 200-kilowatt capacity.

Installed in June, it too went on the air full time in September. New Brunswick immediately became the most powerful station in the world, outclassing Germany's flagship station at Nauen, and was the first that transmitted both voice and

telegraphic messages across the Atlantic Ocean clearly, continuously, and reliably. Its signal was heard over a large part of the earth.



The disease that was called Spanish influenza was born during these months. It did not originate in Spain. It did, however, kill tens of millions all over the world, and it became suddenly more fatal in September of 1918. By some estimates the pandemic struck more than half a billion people, or a third of the world's population.

Even the Black Death of the fourteenth century did not kill so many in so short a period of time. No wonder everyone is terrified of its return.

A few years ago researchers dug up four bodies in Alaska that had lain frozen in the permafrost since 1918 and were able to identify RNA from an influenza virus in the lung tissue of one of them.

This was the monster germ that was supposed to have felled so many in the prime of their lives, the microbe that so resembles a virus of pigs, against whose return we are to exercise eternal vigilance, lest it decimate the world again. But there is no evidence that the disease of 1918 was contagious.

The Spanish influenza apparently originated in the United States in early 1918, seemed to spread around the world on Navy ships, and first appeared on board those ships and in seaports and Naval stations. The largest early outbreak, laying low about 400 people, occurred in FtIs victims were often sick repeatedly for months at a time. One of the things that puzzled doctors the most was all of the bleeding.

Ten to fifteen percent of flu patients seen in private practice, and up to forty percent of flu patients in the Navy suffered from nosebleeds, doctors sometimes describing the blood as "gushing" from the nostrils.

Others bled from their gums, ears, skin, stomach, intestines, uterus, or kidneys, the most common and rapid route to death being haemorrhage in the lungs: flu victims drowned in their own blood. Autopsies revealed that as many as one-third of fatal cases had also haemorrhaged into their brain,¹² and occasionally a patient appeared to be recovering from respiratory symptoms only to die of a brain haemorrhage.

"The regularity with which these various haemorrhages appeared suggested the possibility of there being a change in the blood itself," wrote Drs. Arthur Erskine and B. L. Knight of Cedar Rapids, Iowa in late 1918. So they tested the blood from a large number of patients with influenza and pneumonia. "In every case tested without a single exception," they wrote, "the coagulability of the blood was lessened, the increase in time required for coagulation varying from two and one-half to eight minutes more than normal.

Blood was tested as early as the second day of infection, and as late as the twentieth day of convalescence from pneumonia, with the same results...

Several local physicians also tested blood from their patients, and, while our records are at this time necessarily incomplete, we have yet to receive a report of a case in which the time of coagulation was not prolonged."

This is consistent not with any respiratory virus, but with what has been known about electricity ever since Gerhard did the first experiment on human blood in 1779. It is consistent with what is known about the effects of radio waves on blood coagulation.

Erskine and Knight saved their patients not by fighting infection, but by giving them large doses of calcium lactate to facilitate blood clotting.

Another astonishing fact that makes no sense if this pandemic was infectious, but that makes good sense if it was caused by radio waves, is

that instead of striking down the old and the infirm like most diseases, this one killed mostly healthy, vigorous young people between the ages of eighteen and forty—just as the previous pandemic had done, with a little less vehemence, in 1889.

This, as we saw in chapter 5, is the same as the predominant age range for neurasthenia, the chronic form of electrical illness. Two-thirds of all influenza deaths were in this age range. Elderly patients were rare. One doctor in Switzerland wrote that he “knew of no case in an infant and no severe case in persons over 50,” but that “one robust person showed the first symptoms at 4 p.m. and died before 10 the next morning.”

A reporter in Paris went so far as to say that “only persons between 15 and 40 years of age are affected.” The prognosis was better if you were in poor physical condition. If you were undernourished, physically handicapped, anaemic, or tuberculous, you were much less likely to get the flu and much less likely to die from it if you did.

This was such a common observation that Dr. D. B. Armstrong wrote a provocative article, published in the Boston Medical and Surgical Journal, titled “Influenza: Is it a Hazard to Be Healthy?” Doctors were seriously discussing whether they were actually giving their patients a death sentence by advising them to keep fit!

The flu was reported to be even more fatal for pregnant women. A further peculiarity that had doctors scratching their heads was that in most cases, after the patients’ temperature had returned to normal, their pulse rate fell below 60 and remained there for a number of days. In more serious cases the pulse rate fell to between 36 and 48, an indication of heart block. This too is puzzling for a respiratory virus, but will make sense when we learn about radio wave sickness.

Patients also regularly lost some of their hair two to three months after recovering from the flu. According to Samuel Ayres, a dermatologist at Massachusetts General Hospital in Boston, this was an almost daily occurrence, most of these patients being young women. This is not an expected after-effect of respiratory viruses either, but hair loss has been widely reported from exposure to radio waves.

Yet another puzzling observation was that so few patients in 1918 had sore throats, runny noses, or other initial respiratory symptoms. But neurological symptoms, just as in the pandemic of 1889, were rampant, even in mild cases.

They ranged from insomnia, stupor, dulled perceptions, unusually heightened perceptions, tingling, itching, and impairment of hearing to weakness or partial paralysis of the palate, eyelids, eyes, and various other muscles.

The famous Karl Menninger reported on 100 cases of psychosis triggered by influenza, including 35 of schizophrenia, that he saw during a three-month period.

Although the infectious nature of this illness was widely assumed, masks, quarantines, and isolation were all without effect. Even in an isolated country like Iceland the flu spread universally, in spite of the quarantining of its victims.

The disease seemed to spread impossibly fast. “There is no reason to suppose that it travelled more rapidly than persons could travel [but] it has appeared to do so,” wrote Dr. George A. Soper, Major in the United States Army.

In those nations where small businesses have been forced out of existence - those who formerly operated them, from corporation president down to floor sweeper, regardless of educational or monetary background, eventually find themselves in the great pool of workers serving Babylon. A worker pool that does not distinguish between natives and aliens, each struggling against the other for his daily bread.

The Appearance of Freedom

Babylon tolerates a minuscule alternate press. Short-wave broadcasts are allowed as well as newsletters such as HR. It gives the illusion of freedom where none exists, and defuses a nationalism that could bottle up and explode. This the great city does not need.

Trusts

Disbelievers point to the stock exchanges and say that many people own industry through their purchase of stocks. Babylon takes control of a nation's industry in a very simple manner. People with large estates have most of their wealth invested in common stocks. To avoid inheritance taxes their owners put these estates into trusts under bank trust department management.

Bank trust departments vote the stock that they hold in trust. In this manner, by voting the stock without having to own it, banks elect anyone they choose to corporate boards of directors. Since usury banks are Babylon's monopoly, Babylon elects their own agents to corporate boards.

These agents, sitting on corporate boards, direct their corporation to make "good will" grants to educational institutions such as colleges and Christian seminaries. The sub-rosa condition is that in exchange for generous grants of money, the corporate directors will participate in the selection of professors and curriculum - and they do. As a result, there are Christian seminaries which have aliens teaching Biblical law. Colleges, built to train Saxon leaders, now teach that the Saxon male is the enemy of the world.

In this way the ancient bulwarks of Christendom have been handed over to Babylon and have become educational indoctrination centres churning out Dharmatized Christian-Hindu robots. Young impressionable Saxon nationals walk in their front doors and emerge four years later as citizens of Babylon.

King

"Woe to you, ye powerful, who with power strike down righteousness; for the day of your destruction shall come." I Enoch 95:8

In spite of the constant eye-wash and theatricals, the fact is that worldwide, **ALL** leaders of countries (kings, presidents, premiers, etc.) are put in office and kept in office by the international merchant. They are necessary to protect his interests.

These kings must have an army to keep them in office or else abused populations would soon drive them out.

In the West, the illusion of democracy is maintained by the election system's managed by the merchant's media. It selects and advertises Babylon's agents for public office. "I beheld the angels of punishment... they are preparing for the kings and powerful one's of the earth— I beheld a deep valley burning with fire. To this valley they brought monarchs and the mighty." **I Enoch 52:3-5, 53:1-2.**



The King's Legal System

To abolish the rule of God's **WORD** understood by all, and substitute in its place the decrees of Babylon, the king establishes his own courts.

To head these courts the king appoints judges to rule that the king's decrees are legal.

To help the judges "law-schools" are established. These schools train people to find their way around and through the voluminous maze of conflicting statutes enacted by the king. These lawyers are legal "officers of the court" and belong to the court system.

They spend their lives instructing and advising people as to the king statutes and the legal way to circumvent the ancient laws and customs of their nation.

It is from this "lawyer" group, a group firmly grounded in inter-nation statutes and doctrine, that the merchant's media chooses most candidates for public office[5]. It is a rare one who escapes God's condemnation:-

Thus, the governing process that Babylon's government uses to support its hand-picked king rests in the hands of those who have a vested interest in seeing that the merchant's legal system prevails.

"Woe unto you, lawyers! for ye have taken away the key of knowledge: ye entered not in yourselves, and them that were entering in ye hindered. " Luke 11:52

Priest

In India, the priest is supreme. He chooses kings and appoints merchants to manage the priestly wealth given them by Asoka[6]

In Dharma-conquered lands foreign to India, the world's great merchants choose kings who in turn appoint priests to bless them. "The Prophet who shall presume to deliver a message in **MY NAME**, which I have not commanded him to deliver, or who shall speak in the name of other gods: - that Prophet shall die!" **Dent 18:20**

Government Regulated Churches

The establishment "Christian" Church in America is paid not to teach the **WORD**. If it did Babylon would fall, which is why Babylon pays it not to. Babylon exempts them from taxes that are paid by all others[7].

The Scriptures say that the **WORD** is King of kings and that "man" was made in the image of the **WORD**.

It is logical to expect that those made in the image of the **WORD** would study the Word day and night. It is logical to expect ministers of churches to teach church members the **WORD** so that they would know what God requires of them.

Therein lies the problem. However, to learn God's **WORD** one must learn by his own study, attend a home church, or attend one of a hand full of small churches that still teach God's Law's, Statutes, and Judgments.

Worker

Beneath the three castes of merchant, king & army, and priest - stands the worker. The worker's labour supports Babylon and the three ruling castes. The major duty of the three ruling castes is to keep the worker at his work - and they do.

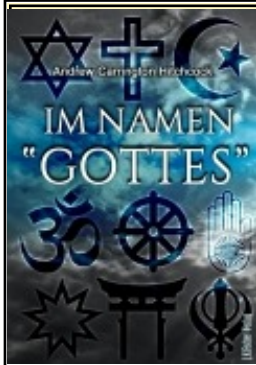

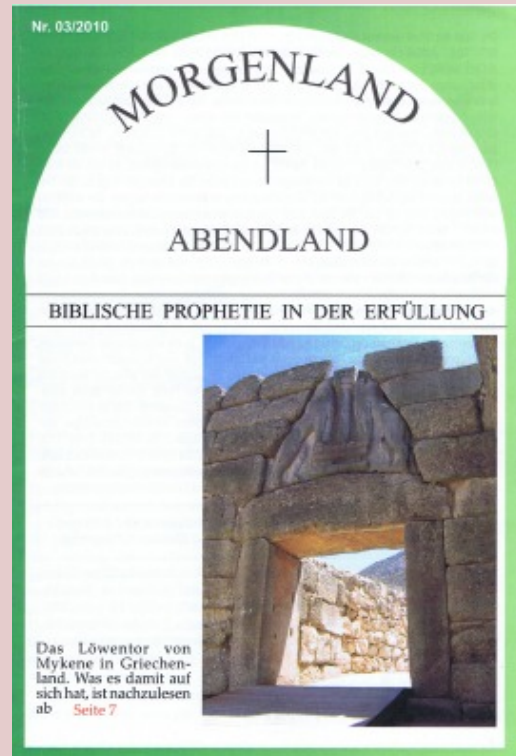

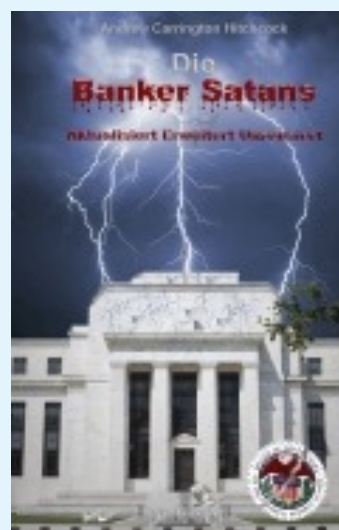
