IT WAS DURING THE REIGN OF SOLOMON that northern House of Israel formed their own government and broke away from the House of Judah.

let no lot fall upon it. For her blood is in the midst of her; she set it upon the top of a rock [Calvary]â€ Therefore, thus saith Yahweh God, Woe to the bloody city! I will even make the pile for fire great." (Eze. 24:1-9).

St. Paul confirms that one of the main objectives of the Messiah's mission was to heal the breach between the Two Houses of Israel and Judah. Speaking to the Ephesians, who were descendants of the exiled House of Israel:

"But now in Christ Jesus ye who sometimes were afar off are made nigh by the blood of Christ. For he is our peace, who hath made both one, and hath broken down the middle wall of partition between us and came and preached peace to you which were afar off [House of Israel], and to them that were nigh [House of Judah]." (Eph. 2:13-17)

Ezekiel's Curse Upon Jerusalem

With the destruction of the Temple in 70 AD by the Roman General Titus, the Second Temple period came to a close. It is actually at the point of the Pharisaic persecution of Messiah that this curse begins.

"Again in the ninth year, in the tenth month, in the tenth day of the month, the word of Yahweh came unto me, saying, Son of man, write thee the name of the day, even of this same day: the king of Babylon set himself against Jerusalem this same day.

And utter a parable unto the rebellious house Wherefore thus saith Yahweh God; Woe to the bloody city, to the pot whose scum [the scribes and Pharisees] is therein, and whose scum is not gone out of it! Bring it out piece by piece;

Except for the Wailing Wall built by Herod, the Temple was completely burned to the ground by the fire set by Titus' troops. There, at the wailing wall, the rabbis wail and bemoan their loss of authority under Herod to this day!

Jerusalem has been a cursed city ever since. They want to build a Third Temple in his honour! The Jewish impersonators ("scum") of Judah who occupy it today have turned it into the "abomination of desolation." It will be consumed by fire one more time, possibly even by an atomic fire.

Introduction

Sh'moth
(Exodus)

The Second Book of Mosheh

Stephen H. Anderson, translator



Sh'moth refers to the opening words of the book - “These are THE NAMES” in the Hebrew.

“Exodus” is Latin for “the going forth”, and was put on this book by the Romish Catholic “church”. It is erroneous, as is most of Catholicism, so I won't be using their title. My translation follows the Hebrew chapter numbering, and some discrepancies will occur between the number of verses in the KJV and this translation. As in “Genesis”, all proper names of people and places will be in the Hebrew spelling. If you want to see the KJV spelling,

Chapter 1

1. These are the names of the children of Yis'rael, that came into Mitsrayemah: every man and his household came with Yaaqob.
2. Reuben, Shimeon, Lewiy, and Yahudah,
3. Yissaschar, Zebulun, and Binyamin,
4. Dan, Naphtaliy, Gad, and Asher.
5. All the beings 5315 that came forth from the loins of Yaaqob were seventy 7657 beings: because Yoseph was already in Mits'rayim.

6. Yoseph died, and all of his brothers, and all of that generation.

7. The children of Yis'rael were fruitful, and increased abundantly 8317, and multiplied, and became exceedingly 3966 mighty 6105; and the land was filled with them.

8. There arose a new king against 5921 Mits'rayim, that did not know Yoseph.

9. Said he to his people, "Behold, the people of the children of Yis'rael are more and mightier than we:

10. Let us deal wisely 2449 with them; lest they multiply, and it come to be, that when war happens, they join with those who hate us, and battle against us; so get them up from the land."

11. Therefore set 7760 they taskmasters 8269/4522 over them to oppress 6031 them by forced labor 5450. And they built treasure 4543 cities 5892 for Par'oh 6547, Pithom 6619 and Rameses 7486.

12. But the more they oppressed them, the more they multiplied, and so burst forth 6555. And they were disgusted 6973 because of the presence of the children of Yis'rael.

13. They made to serve 5647 Mits'rayim the children of Yis'rael with cruelty 6531:

14. They made bitter 4843 their lives with harsh 7186 labor 5656, in mortar 2563, in brick 3843, and in all manner of labor in the field: all the labor in which they made them serve was with cruelty 6531.

15. Spoke the king of Mits'rayim to the Ibriy midwives 3205, of which the name of the one was Shiphrah 8236, and the name of the other Puah 6326,

16. said he, "When you do the office of a midwife to the Ibriy, and see them upon the birthing stools 70; if it is a son, then put him to death 4191, but if it is a daughter, then she shall live."

17. But the midwives feared 3372 Elohiym 430, and did not do as the king of Mits'rayim said to them, but saved alive 2421 the male children.



Mits'rayim Wrongly Named Egypt

18. Called the king of Mits'rayim for the midwives, and said to them, "Why have you done this thing 1697, and have saved alive the male children?"

19. Said the midwives to Par'oh , "Because the women of Mits'rayim are not as the Hebrew women; because they are vigorous, and are delivered before the midwives come to them."

20. Therefore Elohiym 430 dealt well 3190 with the midwives, and the people multiplied, and quickly 3966 became mighty 6105.

21. It came to be, because the midwives feared Elohiym 430, the He made them Houses 1004.

22. Charged 6680 Par'oh all his people, saying, "Every son that is born you shall cast 7993 into the river 2975, and every daughter 1323 you shall save alive."

Chapter 1 Notes

The new king that arose against Mits'rayim was of the conquering Hyksos, that were noted for their use of a duck-bill shaped battle axe that inflicted particularly terrible wounds.

This king was not of the bloodline that ruled during the time of Yoseph and Yaaqob, when his entire family moved to Goshen during the seven years of area-wide famine.

The new rulers were more concerned with the physical number of Yis'rael living in their land, and the military implications that such a large number presented to them as conquerors. They used many methods to dominate Yis'rael, all of which were extreme physical labor under harsh treatment.

The taskmasters mentioned here were placed over officers, that served the Hyksos rulers willingly for “privileges”. In short, they were self-serving betrayers of their own people, just like many in power today that oppress their own, all for money and power.

The situation today is nothing new. The birthing stools were a low chair-like affair, with a hole for the infant to pass through. The mother squatted for birthing, rather than lying down on her back. Gravity aided to pull the child from her body. It was quite efficient, and eased birth considerably.

Making them “houses” means making them a large family, as the House of Yis’rael. The Book of Jasher expands these verses with better explanation in Jasher 66:1

Chapter 2

1. There went a man of the House of Lewiy, and took a daughter of Lewiy *as a wife*.

2. The woman conceived 2029, and bore a son: and when she saw that he was good 2896, she hid 6845 him for three months.

3. When she could no longer hide him, she took for him a box 8392 *made of papyrus* 1573, and smeared 2560 it with asphalt 2564 and pitch 2203, and put the child in it; and she laid it in the reeds 5488 by the river’s bank 8193.

4. His sister stood afar off, to see what would be done to him.

5. Came the daughter of Par’oh to bathe in the river; and her maidens walked along by the river’s side; and when she saw the box among the reeds, she sent her maidservant 519 to fetch it.

6. When she had opened it, she saw the child: and behold, the babe wept. She had compassion on him, and said, “This is a child of the Ibriym.”

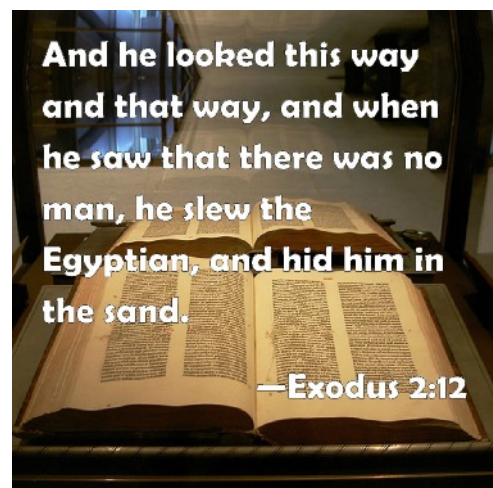
7. Said his sister to the daughter of Par’oh, “Shall I go and call for you a woman to give suck 3243 of the Ibriy women, that she may give suck to the child for you?”

8. Said Par’oh's daughter to her, “Go.” And the maiden went and called the child's mother.

9. Said Par’oh's daughter to her, “Take away this child, and give suck to it for me, and I will give you wages.” And the woman took the child and suckled 5134 it.

10. Grew the child, and she brought him to Par’oh’s daughter, and he became her son. She called his name Mosheh 4872: said she, “Because I drew 4871 him out of the water.”

11. It came to be in those days, when Mosheh 4872 was grown, that he went forth to his kinsmen, and looked on their burdens: and he saw a man of Mits’riy smiting a man of Ibriy, one of his kinsmen.

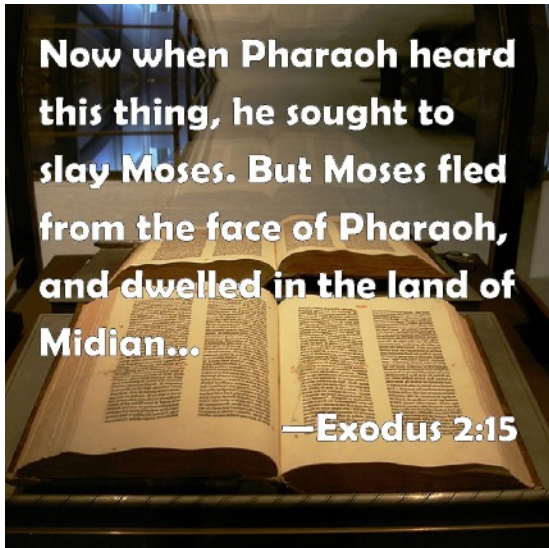


12. He looked this way and that way, and when he saw there was no man, he smote the Mitsriy, and hid him in the sand.

13. When he went out the second day, behold, two men of the Ibriym strove together 5327: and

he said to he that did the wrong 7563, “For what reason 4100 do you smite your fellow 7453?”

14. And he replied, “Who made you a magistrate 8269 and a judge 8199 over us? Do you intend to kill me, as you killed the Mits’riy?” And Mosheh was afraid, and said, “Surely this thing is known!”



15. When Par’oh heard this thing, he sought to kill Mosheh . But Mosheh fled 1272 from the presence of Par’oh, and dwelt in the land of Midyan 4080: and he sat down by a well.

16. The priest of Midyan had seven daughters: and they came and drew 1802 water, and filled the troughs to water their fathers flock,

17. and shepherds 7462 came and drove them away 1644: but Mosheh rose up 6965 and helped 3467 them, and watered their flock.

18. When they came to Reuel 7467 their father, he said, "How is it 4069 that you have come so soon 4116 today?"

19. They replied, “A man of Mitsriy delivered 5337 us from the hand of the shepherds, and also drew water enough for us, and watered the flock.”

20. Said he to his daughters, “Where is he? Why is it that you have left the man? Call him, so that he may eat bread.”

21. Mosheh was content to dwell with the man: and he gave Mosheh Tsipporah 6855 his daughter.

22. She bore him a son, and he called his name Gereshom 1648: because he said, “I have been a sojourner 1616 in a racially alien 5237 land.”

23. It came to be in process of time, that the king of Mits’rayim died: and the children of Yis’rael sighed 584 from their bondage, and they cried out 2199, and their cry 7775 ascended unto Elohiym 430 from their bondage.

24. Heard Elohiym their groaning 5009, and Elohiym remembered 2142 His covenant with Abrah’am, with Yitschaq, and with Yaaqob.

25. Looked upon Elohiym the children of Yis’rael, and knew Elohiym *their suffering*.

Chapter 2 Notes

Verse 2 - A child being “good” means well formed and healthy. Acts 7:20; Heb. 11:23; Yashar (Jasher) 68:5; **Verse 3** - The K.J.V. has “ark”, which literally means a box or container of some sort.

The box here was of woven papyrus (paper-reed), that they used in the manufacture of paper back then. This was not as the ark of Noach, or the ornate Ark of the Covenant, but a simple affair, so “box” is proper. **Verse 5** - Yashar 68:17, 18 ; 519 as a lowly female servant, almost a slave.

Verse 10 - Mosheh 4872 is the Hebrew version of the Egyptian “mosis”, and also was attached to the name of royalty, such as Tutmosis, etc. mosheh 4872 was raised as a royal child would be. Acts 7:21; Yashar (Jasher) 68:24;

Verse 11 - Heb. 11:24;

Verses 11-14 - Acts 7:23-28;

Verse 12 - “Smite” can mean to strike, or to kill by a blow. Severity depends on the context of individual word use. Yashar (Jasher) 71:3;

Verse 14 - Yashar 71:8;

Verse 15 - Gen. 25:1; Acts 7:29; Heb. 11:27;

Verse 16 - The book of Yashar gives much greater explanation on this entire section. Yashar 76:14;

Verse 18 - Reuel 7467 is the man's name, and means "friend of God". In the next chapter he will also be called Yithro. This is a title, and means "his excellence". They are the same man.

Verse 21 - Mosheh was imprisoned by Reuel for ten years. This is explained in the Book of Yashar. Tsipporah cared for him while he was imprisoned. When the king died that wanted to kill him, he was released. Reuel was a local official, with "his excellence" as his title. Yashar 77:51;

Verse 22 - Ger'shom is related to ger'shom 1648, and 1616 ger means "sojourner". 5237 is from 5234, which is racial alien. This entire word-line is connected to "alien", meaning RACIAL alien. Yashar 78:9;

Verse 23 - "bondage" here means slave labor, with brutal treatment.

Verse 24 - Gen. 15:13,14

Satan Lost in Translation By Christopher Sparkes (From Our Irish Correspondent)



THE IMAGE OF A DEVOTED CHRISTIAN AT NIGHT WOULD BE OF READING SOMETHING FROM THE BIBLE AND MAKING PRAYERS, perhaps kneeling at the side of the bed. So what might Satanists do, Luciferians?

A panicked British broadsheet has been campaigning against 'conspiracy theories'. For example: "America has been taken over by a Satan worshipping, child-abducting cabal. Like the mythical Beast in Revelations, it has many heads-- Hillary Clinton--Bill Gates-- George Soros-- Oprah Winfrey" (*Sunday Telegraph, June 27 2021*; book review of *The Storm Is Upon Us* by Mike Rothschild). Such views, it

says, make appeal to "people with brain damage". Well, it would.

But does their Satan really exist? Are world leaders taking orders from empowering satanic forces? A recent YouTube comment says: "Both Obama [sic] and Biden [sic] are working for Satan and Satan's children."

In the mythologies of Roman paganism, fictional 'gods' conducted evil things among men. Jupiter (also Jove), son of Saturn and Opis, was king of the gods. His Greek equivalent was Zeus.

In the poetical works of Homer, heroes blamed their misdeeds on the 'gods'. They were the real culprits. Hades, ruler over the dead and the underworld, was cruel and pitiless, silent to any pleading. His realm also was known as Hades. Hermes led dead souls of the wicked to Hades, from where there was no escape.

Jesus had no hesitation in mocking such Hellenistic myths that the priesthood of Jerusalem had swallowed. In his parable of the rich man and Lazarus, Jesus has Abraham say to the rich man: "They have Moses and the prophets. Let them hear those". (Luke 16/29). In other words, not Hellenistic myths.

When the Bible came to be translated into Latin (c. 390), its editor, Jerome, seeing the Hebrew and Greek words *Satan* and *Satanas*, rather than translating them as 'enemy' or 'adversary', merely transliterated them to give the

name Satan. Yet they are not the names of anybody.

The same happened with the Greek word *diabolos*, meaning slanderer, not a title of anybody. At 1 Timothy 3/11 and Titus 2/3 it is clear that *diabolos* makes reference to human slanderers, slander-mongers, transgressing, among other things, the ninth commandment (**Exodus 20/16**).

The Latin version merely transliterated it as *diabolos*. So English translators put 'Devil'.

When John Wycliffe made the first complete English translation (1380), he had only that corrupt Latin translation to work from.

So he put 'Satan', the notion of Satan being long-embedded in the culture, and all English translators followed suit.

The teaching appeared in confessions and commentaries.

A 1901 Greek lexicon says of Satan: "The prince of evil spirits, the inveterate adversary of God and of Christ."

Thus a translation blunder came to be regarded as unquestionable orthodoxy. When you say 'Satan', you are speaking un-translated Hebrew and Greek words. They need translating. They are not names.

These myths came all the way from paganism into evangelical teachings of orthodoxy. Jupiter simply got re-branded.

Mediaeval and later artworks, fictional writings of John Milton's *Paradise Lost and Paradise Regained* (1667, 1671) and CS Lewis's *Screw tape Letters* (1942), all lionising Satan as the universal tempter of man, help reinforce into the consciousness of orthodoxy the myth of whispering devils.

I have tabulated every occurrence of all biblical words concerning adversaries of God. There is no word or context revealing any monster called 'Satan' and 'the Devil'. The Prophets and Apostles knew of no such character. There was no 'Satan' in Eden. It just says 'serpent'.

At 1 Chronicles 21/1 we read: "An adversary (Satan) stood up against Israel." The comment on that same event at 2 Samuel 24:1 reveals that 'adversary' - Satan - to Israel, to be God Himself!

Yet English Bibles have 'Satan' at 1 Chronicles 21/1. So what to sloppy translators was 'Satan' is actually God. Blasphemy.

Nothing more shows that the Greek forms *satan* and *satanas* do not represent a universal monster than Jesus' words to Peter, "Get behind me, adversary (*satanas*)" (**Matthew 16 23**).

Jesus was speaking to Peter, not invoking a mythological monster. Nor would Jesus have called his friend Peter such a name.

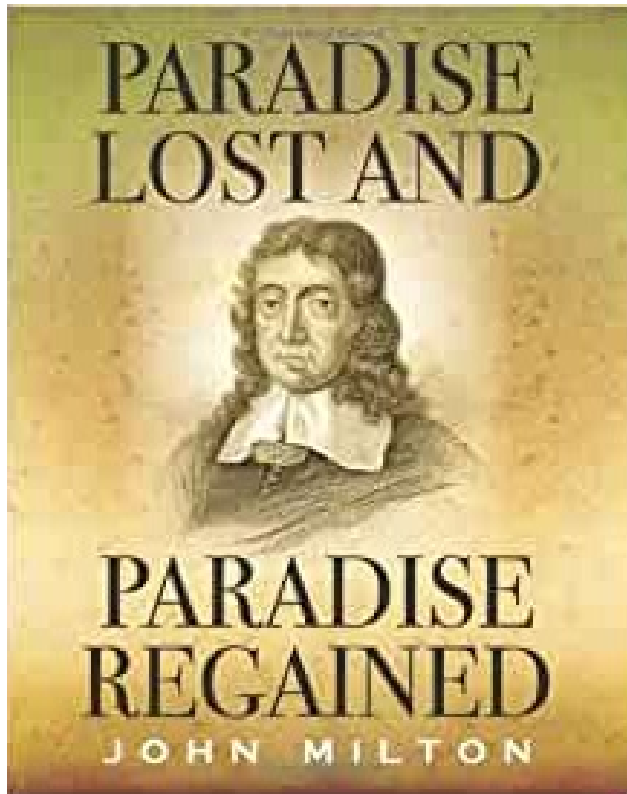
When Jesus was tempted in the wilderness he was confronted not by John Milton's angel-winged monster, but by 'an adversary' (*satan*) and 'a slanderer' (*diabolos*).

You would imagine being the actual Messiah invoked some psychological battles - it

does not say. Jesus though - as the Son of God - would have been instantly alert to Milton's fallen angel and sent him on his way.

That leaves 'Lucifer'. It is in the King James Bible just once, at Isaiah 14/12. The doomed King of Babylon is compared in his pomp and his fall to a star, a frequent biblical, astral metaphor.

He had been a 'shining star'. But for the Hebrew word *balai*, 'shining star', the translators turned the King of Babylon into 'Lucifer'. This was



another transliteration from the Latin version. There is no being 'Lucifer'.

God has declared through the Prophets: "There is no other God but Me", the Creator.

Translated, rather than lazily transliterated, these narratives are taken out of the realms of myth, and become very human. Satanism is self-worship. Satanism is an assertion of lusts, an arrogant rebuttal of the beautiful laws of God. But the elite of the Beast system have no demonic commander other than themselves. Their chanting fall unheard.

The power they (the real conspirators) do possess is control of the military, finance, politicians, media, law, medicine, technology, education, arts. They are kosmokrators, 'world rulers' (Ephesians 6/12) of darkness.

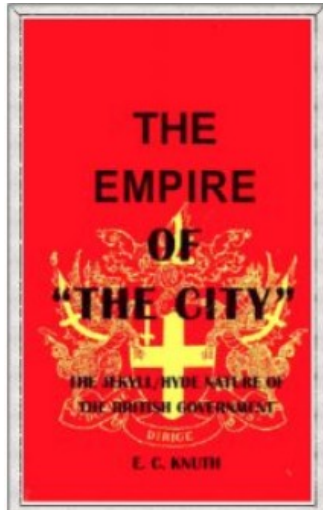
suffered greatly as this Triad pact with the Muslims allowed the Muslims to further oppress the Kalash.

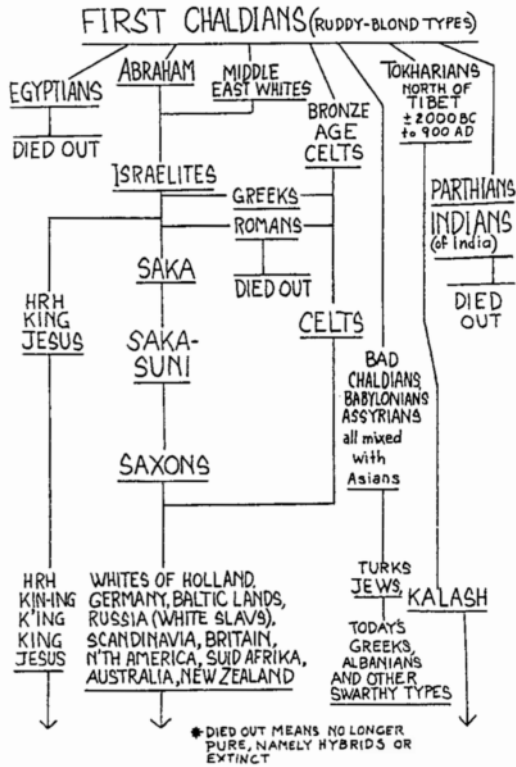

Harold Stough Notes A Paper By Ben Johnson The Last Invasion of Britain Fishguard 1797



THE ANNALS OF HISTORY RECORD THE NAME OF HASTINGS AS THE SITE OF THE LAST INVASION OF MAINLAND BRITAIN BY NORMAN FORCES IN 1066. True, this was the last successful invasion. However, little is reported about the French invasion of Fishguard, which took place in southwest Wales in 1797, nor of the brave resistance offered by Jemima Nicholas, also known as “Jemima Fawr” (Jemima the Great), who single-handedly captured twelve of the invading soldiers.

In 1797, Napoleon Bonaparte was busy conquering in central Europe. In his absence the newly formed French revolutionary government, the Directory, appears to have devised a ‘cunning plan’ that involved the poor country folk of Britain rallying to the support of their French liberators. Obviously the Directory had recently taken delivery of some newly liberated Brandy!

The French invasion force comprising some 1400 troops set sail from Camaret on February 18th, 1797. The man entrusted by the Directory to implement their ‘cunning plan’ was an Irish-American septuagenarian, Colonel William Tate. As Napoleon had apparently reserved the cream of the Republican army for duties elsewhere in Europe, Colonel Tate’s force comprised a ragtag collection of soldiers including many newly released jailbirds.

Tate’s orders were to land near Bristol, England’s second largest city and destroy it, then to

cross over into Wales and march north onto Chester and Liverpool. From the outset however all did not proceed as detailed in the ‘cunning plan’. Wind conditions made it impossible for the four French warships to land anywhere near Bristol, so Tate moved to ‘cunning plan’ B, and set a course for Cardigan Bay in southwest Wales.

On Wednesday February 22nd, the French warships sailed into Fishguard Bay to be greeted by canon fire from the local fort. Unbeknown to the French, the cannon was being fired as an alarm to the local townsfolk.

Nervously the ships withdrew and sailed on until they reached a small sandy beach near the village of Llanwnda. Men, arms and gunpowder were unloaded and by 2 am on the morning of Thursday February 23rd, the last invasion of Britain was completed. The ships returned to France with a special despatch being sent to the Directory in Paris informing them of the successful landing.

Upon landing, the French invasion force appear to have run out of enthusiasm for the ‘cunning plan’. Perhaps as a result of years of prison rations, they seem to have been more interested in the rich food and wine the locals had recently removed from a grounded Portuguese ship.

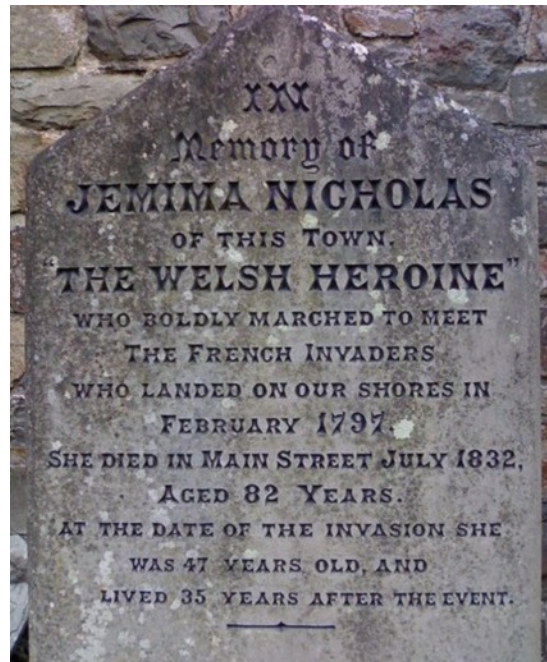
After a looting spree, many of the invaders were too drunk to fight and within two days, the invasion had collapsed: Tate’s force surrendered to a local militia force led by Lord Cawdor on February 25th 1797.

Strange that the surrender agreement drawn up by Tate’s officers referred to the British coming at them “with troops of the line to the number of several thousand.”

No such troops were anywhere near Fishguard, however hundreds, perhaps thousands of local Welsh women dressed in their traditional scarlet tunics and tall black felt hats had come to witness

any fighting between the French and the local men of the militia. Is it possible that at a distance, and after a glass or two, those women could have been mistaken for British army Redcoats?

Gemima Fawr During their two days on British soil the French soldiers must have shaken in their boots at mention of name of “Jemima Fawr” (Jemima the Great). The 47-year-old Jemima Nicholas was the wife of a Fishguard cobbler. When she heard of the invasion, she marched out to Llanwnda, pitchfork in hand, and rounded up twelve Frenchmen. She ‘persuaded’ them to accompany her back into town, where she locked them inside St Mary’s Church and promptly left to look for some more! Men of Harlech meet your match!

Call From Our Australian Brethren



Sir ___, A long-time church of God member writes, We would be thankful for prayers for my family and all of God’s people in Australia.

Over these past two years the Australian government has been exerting more and more tyrannical power and control over every state and Territory but it has now reached a critical stage with deadlines in place to punish and discriminate against those who do not accept the Covid vaccine. My family and I reject the Covid-19 injection and PCR test in accordance with God’s Law. We also believe the injection is dangerous and poisonous.

I do not think, as many do, that going into survival mode is a way to continue existing. Once the electricity is turned off every vestige of normal life will collapse. Most ignore the simple fact that electricity is needed to operate fuel pumps that supply Gas Petrol and Diesel.

In effect I see it as being too late to do anything to save myself.

Neither do I rely on others who gain huge followings by mounting court cases against the various governments on points of principle. These points of principle are that man is free to make his own choices as to how he conducts his life. These cases are bound to fail because the judges would be sowing the seeds of their own destruction if they opposed the government.*

What I do see as a possible answer is that many individuals refuse to obey the government's unlawful rules. This has been shown to work.



Those arrested for breaking covid laws have had their cases dropped by the Crown Prosecution Service. Presumably the CPS doesn't want the 'offenders' going into court where judges have to follow the law because otherwise it would go to appeal and eventually end up in the Supreme court, where judges, as in the Jalloh case** have to rule that the common law giving us our freedoms is supreme.

Does this fact not tell you something?

It shouts at me. It says that individuals standing up for their rights and freedoms can keep those freedoms.

How should this fact affect you and the way you conduct your affairs.

Signed and served electronically according to the civil procedure rules. "**Your name.**"

That's it folks. Take a chance and do nothing and hope my prediction of the coming catastrophe is wrong. I too hope that I am wrong but I try to do my little bit. Please ask yourself, "Could I do more?"

*The high profile cases by Simon Dolan and Dr. Reiner Fuellmich failed because they took on the government and triggered a response that blocked the cases. They tried but did not realise that if they were successful the governments would fall. It's the small cases that win but they need you to spread the word so that people know how to do this.

**Understand how Mr. Jalloh pushed back the state which as a bail condition required him to stay in his home overnight.

They declared, "That ordering someone to stay in their home was unlawful imprisonment". Google, "Supreme Court Jalloh to read the case.

The Earth's Electric Envelope Part 2

ONE WAY TO FIND OUT IF THE EARTH'S NATURAL FIELDS ARE AS IMPORTANT to people as to hamsters would be to place human subjects in a completely shielded room for a few weeks and see what happens.

Which is exactly what behavioural physiologist Rütger Wever did at the Max Planck Institute in Germany (above). In 1967 he had an underground building constructed containing two isolation chambers. Both were carefully shielded against outside light and sound, and one was shielded also against electromagnetic fields.

During the next two decades hundreds of people had their sleep cycles, body temperature, and other internal rhythms monitored while they lived in one or the other of these rooms, usually for a month at a time. Wever found that even

without any variation in light and darkness, and without any clocks or time cues, the body's sleep cycle and internal rhythms remained close to 24 hours, so long as the earth's natural electromagnetic fields were present. However, when those fields were excluded, the body's rhythms usually became longer, erratic, and desynchronised with each other.

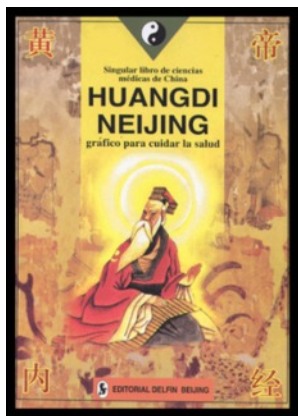
The average "free-running" sleep cycle was 25 hours, but in individual cases was as short as 12 hours and as long as 65 hours. Variations in body temperature, potassium excretion, speed of mental processes, and other rhythms drifted at their own separate rates, was completely different from one another, and no longer coinciding with the sleep-wake cycle at all. But as soon as an artificial 10 Hz signal—close to the first Schumann resonance introduced into the shielded room, the body's rhythms all immediately desynchronised to a 24-hour period.

Life, residing between heaven and earth, partakes of both polarities. As we will see in the next chapter, the distribution of electric charge in living beings has been measured and mapped externally.

In plants this was done by professor of anatomy Harold Saxton Burr, at Yale University, and in animals by orthopaedic surgeon Robert O. Becker, at the State University of New York, Upstate Medical Center, Syracuse. The areas of greatest

positive voltage in animals are the centre of the head, the heart, and the lower abdomen, and in trees the crown.

The places of greatest negative voltage, in trees, are the roots, and in animals, the four feet and the end of the tail. These are the places where the global electrical circuit enters and leaves the body on its way between heaven and earth. And the channels through which the electricity travels inside living beings, distributing the electricity of heaven and earth to every organ, were precisely mapped several thousand years ago, and are part of a body of knowledge that we know today as Chinese acupuncture.



It was written down in the Huangdi Neijing, the Yellow Emperor’s Classic of Internal Medicine, between 500 and 300 B.C.

The very names of key acupuncture points reveal an understanding that the circuitry of the body is continuous with that of earth and sky. Kidney 1, for example, the point underneath the foot, in the centre of the sole, is known in Chinese as yong quan, meaning “bubbling spring,” because earth energy bubbles up into the feet through these points and climbs up the legs into the rest of the body toward the heavens. Governing Vessel 20, the point on top of the head, in the centre, is called bai hui, the “hundred convergences.”

This is also the “thousand petal lotus” of Indian traditions, the place where the energy of heaven descends into our body toward the earth, and the flows of our body converge and reach toward the sky.

But not until the 1950’s did scientists, beginning with Yoshio Nakatani in Japan and Reinhold Voll in Germany, begin to actually measure the electrical conductivity of acupuncture points and

meridians, and to finally translate the word “qi” (formerly spelled “chi”) into modern language: it means “electricity.”

Hsiao-Tsung Lin is a professor of chemical and material science at National Central University in Taiwan. The qi that flows through our meridians, he tells us, is an electrical current that brings both power and information to our cells, current whose source is both internal and external. Every acupuncture point has a double function: as an amplifier for the internal electrical signals, boosting their strength as they travel along the meridians; and as an antenna that receives electromagnetic signals from the environment.

The dantians, or energy centres of Chinese medicine, located in the head, heart, and abdomen—equivalent to the chakras of Indian tradition—are electromagnetic oscillators that resonate at particular frequencies, and that communicate with the meridians and regulate their flow. They have capacitance and inductance like oscillators in any electronic circuitry. The body, says Lin, is a super-complex electromagnetic oscillation network, enormously intricate and delicate.

In 1975, Becker and his colleagues at Upstate Medical Center found that, in general, acupuncture points are not only places of low resistance, but of high potential, averaging five millivolts higher than the surrounding skin. They also found that the path of a meridian, at least on the surface of the body, has significantly greater conductivity and lower electrical resistance than nearby skin.

As a result of the work of Nakatani, Voll, Becker, and others, electro-acupuncture, using microampere currents, has taken its place alongside traditional acupuncture, and commercial point locators, which find acupuncture points by measuring the electrical conductivity of the skin, have come into use among nontraditional practitioners here in the West. In China, electro-acupuncture devices have been in use since 1934.

They are a tacit acknowledgement that the body is an electrical instrument, and that its health or sickness depends on the proper distribution and balance of the electrical energies that constantly flow around and through us. But ironically they

also prevent that scientific knowledge from becoming true knowledge, for to substitute artificial electricity for atmospheric electricity in replenishing the body is to forget that the electricity of the air is there, nourishing us and giving us life.



At the Shanghai University of Traditional Chinese Medicine, the Fujian Institute of Traditional Chinese Medicine (above), and elsewhere in China, scientists continue to confirm that the substance that flows in our meridians is electricity, and that electricity is not only a force that moves locomotives, but is the incredibly complex and delicate stuff of life.

Typically, the electrical resistance of an acupuncture point is two to six times lower than the resistance of the surrounding skin, and its capacitance—its ability to store electrical energy—is five times as great.

Commercial point locators do not always work, because sometimes—depending on the internal state of the individual—an acupuncture point can have a higher resistance than its surroundings. But the meridians always respond in an active and nonlinear way to electrical stimulation, and they react, say modern researchers, exactly like an electrical circuit.

The physical structures of the conductive points and meridians have been tentatively identified. In the 1960's, a North Korean physician, Bong Han Kim, published detailed photographs of an entire network of tiny corpuscles, and threadlike structures that connect them, that exist throughout the body in our skin, in our internal organs and nervous system, and in and around our blood vessels.

These ducts, he found, were electrically conductive and the fluid within them, surprisingly, contained large amounts of DNA. Their electri-

cal pulsations were considerably slower than the heartbeat: in the skin of a rabbit, the pulsation rate was between 10 and 20 per minute. The pathways of the superficial ducts in the skin matched the classical pathways of the acupuncture meridians.

The reason Kim succeeded in identifying this system is that he worked only on living animals, because the ducts and corpuscles, almost transparent to begin with, disappear shortly after death. He stained the living tissue with an unspecified blue dye that was absorbed only by this network of ducts and corpuscles. Kim's book, *On the Kyungrak System*, was published in Pyongyang in 1963.

The reason his work has been so completely ignored has partly to do with his relations with the North Korean government—Kim was expunged from official records in 1966, and rumour has it that he committed suicide—and partly with the fact that the outside world does not want to find physical proof of our electrical nature.



But in the mid-1980's, Jean-Claude Darras, a French physician (above) working in the nuclear medicine department at Necker Hospital in Paris, replicated some of Kim's experiments. He injected a radioactive dye containing technetium-99 into various acupuncture points on the feet of volunteers, and found that the dye migrated precisely along the meridian pathways of classical acupuncture, just as Kim had found.

In 2002, Kwang-Sup Soh, who had already been investigating the electromagnetic properties of acupuncture meridians, headed up a team at Seoul National University in South Korea, which looked for and found most of the threadlike duct system described by Kim. A breakthrough came in November 2008 with the discovery that trypan

blue, a dye that was previously known to stain only dead cells, if injected into living tissue, will stain only the nearly invisible threads and corpuscles they had painstakingly begun to identify.

The “primo vascular system,” as it was now called, suddenly became a subject of research in other centres in South and North Korea, as well as in China, Europe, Japan, and the United States.

The ducts and corpuscles of this system were found, just as Kim had described, resting on the surface of and penetrating inside the internal organs, floating inside the large blood and lymphatic vessels, winding along the outside of major blood vessels and nerves, travelling inside the brain and spinal cord, and following the paths of the known meridians within the deep layers of the skin.

When the surface of the skin was stained with the dye, only points along the meridians absorbed it. In September 2010, at the First International Symposium of Primo Vascular System,

held in Jecheon, Korea, Satoru Fujiwara, retired professor of anatomy at Osaka City University, Japan, reported tentative success at surgically identifying a superficial primo node—an acupuncture point—in the skin of a rabbit’s abdomen.

And in 2015, researchers at Seoul National University used a commercially available staining kit to reveal a threadlike vessel running just beneath the abdominal skin of anaesthetised living rats. The vessel, coloured dark blue from the stain, followed the pathway of the acupuncture meridian called the conception vessel, and connected discrete corpuscles corresponding in location to the known acupuncture points on that meridian.

The fine structure of this system of nodes and ducts was revealed by electron microscopy. The staining process, they noted, takes less than ten minutes.

Internal Revenue Service (Part 3)

THIRTY WAYS THE IRS TRIES TO CONTROL PREACHERS AND CHURCHES IN AMERICA As inspired from the list with the same name, by Dr. Greg Dixon.

If your church has a "tax exemption" granted by the Internal Revenue Service (IRS). then you must examine it to determine if it is worthy in the eyes of God. Review this and then, decide if

you do need to make a change in the church you are supporting.

1). The church must have a "distinct legal existence:" According to IRS publication #557 that legal existence would date from incorporation, pg. 3. Therefore, a church must be incorporated or it cannot be called a church.

2). The church must admit that it exists by a privilege granted by the IRS (tax-exempt), rather than by RIGHT, as granted by God through the Holy Scriptures (non-taxable); the latter of which is recognized and guaranteed autonomy by the U.S. Constitution, Bill of Rights, 1st Amendment. The church must thereby recognize another as Head, the State, as opposed to the true Head, which is God.

3). The church must have a "recognized creed and form of

worship." The IRS must approve (recognize) the creed (belief) and form (manner) of worship.

4). The church must have a "definite and distinct ecclesiastical government." That is, the church must be ruled in the form of a hierarchy or hierarchical (as is found in many so-called main stream churches –e.g., Catholic, Methodist, etc.), and not individually ruled by the local church's ministry (pastor / leader) and/or congregation (as in Baptist, Christian-Israel, James Lloyd or Christian Media Ministries or some other autonomous-type of church / ministry / movement).

5). The church must have a "formal code of doctrine and discipline," as in some churches who have established "doctrines" or "traditions of men," as opposed to those Christians whose churches / groups/ministries have established their faith, practices and doctrines solely from the Holy Scriptures. Unfortunately, many of the 501(c)3 churches have established doctrine/traditions that are not in accordance with the **Word** of God.

6). The church must have a "distinct religious history" that is denominational – e.g. Catholic, as opposed to being "autonomous" or serving its congregation as an "independently acting, Bible oriented, body of believers."

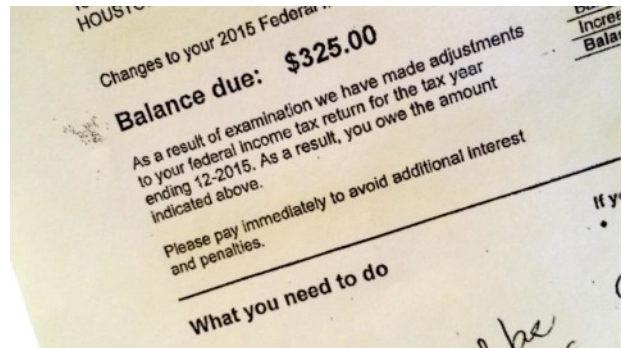
7). The church must be structured as an "organization." Again, this is modelled after the Catholic church-type organization, not the autonomous-type of church – e.g. Baptist.

8). The church must be an "organization of ordained ministers." The local Baptist church approves its own ministers, many of whom could be laymen, such as Charles Haddon Spurgeon and the late G. B. Vick – men "ordained of God," as opposed to men that are ordained and licensed by institutions, state or religious.

9). The church must have these ordained ministers who are "selected after completing

prescribed courses of study". Again, Catholic-style, not Baptist. Like the Apostles, who had only "been with Jesus" (taught and ordained by him to serve His kingdom), local autonomous churches many times approve pastors who have not received any formalized institutional religious training – but are ordained of God because of their Faith, Practice, Study, and Example.

10). The church must have "established places of worship." Many churches, ministries, groups have no permanent address or facility (place of worship - some meet in parks or other scenic places, some have only radio facilities) for a variety of reasons (because they are circuit preachers, because of persecution, because of their type of ministry, etc., they move from place to place or have no congregation meeting facility per se).



11). The church must submit to the IRS by paying a "user fee" (tribute) for tax-exempt status. This is contrary to the Scriptures, the U.S. Constitution and all the State Constitutions.

12). The church must be engaged in activities that further "exclusively Public purposes, rather than Private interests." The true church of Christ exists for the Personal and Private interest of Christ and His Elect, and not the State.

13). The church must answer to the IRS as to its "daily activities."

14). The IRS dictates its control over all financial activities of the church – including sources of income, donors of \$100.00 or more, and expenditures.

15). The church may not use cash, or it will be suspected of "money laundering." All books and records must be made available for IRS inspection at all times.

16). The church must serve the IRS in the capacity of "informer" – by reporting a history of who serves in the various jobs within the church – e.g. Pastors, associates, counsellors, directors, teachers, office/clerical/maintenance personnel.

17). The church must inform the IRS who it is that receives charitable help from the church.

18). The church must inform the IRS about "love gifts and offerings" in excess of \$600.00 given to evangelists and missionaries, by filing a Form 1099 on each recipient, including on those who are regularly supported.

19). The church must use only IRS approved methods of fund raising.

20). The pastor of the church must not preach against the U.S. tax system, or say anything against the practices and tactics of the IRS.

21). The pastor of the church must answer to the IRS and give unlimited submission to the civil magistrate pertaining to all laws – federal, state and local, including "Public Policy."

22). The pastor of the church must advocate, promote, and actively encourage race mixing (interracial

marriage), which is in violation of the "kind after kind" standard established by God at the creation, if the church has an educational ministry.

23). The pastor of the church cannot influence legislation concerning the licensing of church ministries.

24). The pastor of the church cannot promote or engage in any political activity that opposes pornography.

25). The pastor of the church cannot actively support legislation that declares that children belong to their parents as opposed to the authority of the state.

26). The pastor of the church cannot actively support legislation that opposes a state's lottery or other "legalized" gambling pursuits.

27). The pastor of the church cannot advocate support of the concept that the U.S. or state Constitutions are the Supreme Law of the Land or the various states, respectively.



28). The pastor of the church cannot actively participate in any activity that is in opposition to the public school system.

30). The pastor of the church cannot oppose laws that are in support of or legalize "sodomy" – which is in direct conflict with the Word of God.

Number of The Beast and The American Bar Association



IS THE SOCIAL SECURITY NUMBER (SSN) JUST A NUMBER TO IDENTIFY AMERICANS OR IS IT THE NUMBER OF THE MARK OF THE BEAST? (Or is this just a bad joke by bad lawyers?)

Revelations Chapter 13 speaks of a beast who "forced everyone, small and great, rich and poor, free and slave, to receive a mark on his right hand or on his forehead, so that no one could buy or sell unless he had the mark, which is the name of the beast or the number of his name. This calls for wisdom. If anyone has insight, let him calculate the number of the beast, for it is man's number. His number is 666."

Title 42, Section 666

Title 42, Section 666, paragraph "13" of the United States Code (USC) requires that as a condition to receiving federal funds States must establish procedures requiring that the social security number (SSN) of any applicant for a professional license, driver's license, recreational license, occupational license, or marriage license be recorded on the application.

Also, if you assign the number value of each letter in the word "Title" relative to how each number appears in the alphabet, these five

numbers add up to 66. 4 + 2 equals 6. Therefore, Title 42 adds up to 666 in numerology, completing a second "666" in front of "Section 666". The odds of this occurring "by coincidence" are astronomical. The fact that these numbers are being used to restrict and control basic human rights that one needs to survive is further evidence that this is not just a coincidence.

This SSN requirement occurred in 1996 when Title 42, Section 666, paragraph 13 was amended by Section 317 of the "Personal Responsibility and Work Opportunity Reconciliation Act of 1996" (Public Law 104-193).

The intent was to make this uniform throughout all the States. Can you guess who was behind this?



If you guessed "lawyers", you are right on the mark. Did not Congress pass these laws and isn't the most prevalent profession in Congress lawyers, i.e., members of the "Bar Association"? Also, when the so-called "Patriot Act" was passed by Congress, none of the congressmen actually read the bill! The Orwellian Patriot Act and Real ID Act were both introduced by lawyer/politician Jim Sensenbrenner. According to Sensenbrenner's Wikipedia page, one the

authors of the Patriot Act was "Assistant Attorney General of the United States Viet Dinh" (i.e., another lawyer).

Section 321 of Public Law 104-193 (which amended aforementioned Section 666, paragraph 13) states:

"SEC. 321. ADOPTION OF UNIFORM STATE LAWS.

"Section 466 (42 U.S.C. 666) is amended by adding at the end the following new subsection:

"(f) UNIFORM INTERSTATE FAMILY SUPPORT ACT - In order to satisfy section 454(20)(A), on and after January 1, 1998, each State must have in effect the Uniform Interstate Family Support Act, **as approved by the American Bar Association on February 9, 1993**, together with any amendments officially adopted before January 1, 1998 by the National Conference of Commissioners on Uniform State Laws.'."



The question we should be asking ourselves is: **Why does each State have to get the approval of the "American Bar Association"?** The American Bar Association is not a government entity! Here again is a documented example of the violation of the separation of powers doctrine--that is, tyranny.

The "Father of the Constitution", James Madison, stated in the Federalist Papers: "The accumulation of all powers, legislative, executive, and judiciary, in the same hands, whether of one, a few, or many, and whether hereditary, self-appointed, or elective, may justly be pronounced the very definition of tyranny."

Most people do not believe that the Social Security Number is the Mark of the Beast, but

until you actually revoke it and try to survive without that number, you will never realize how much your survival depends upon it.

Even though there is no constitutional provision for a social security number, Americans can no longer get a bank account to conduct their business without a social security number. You cannot get a credit card without a Social Security Number.

You cannot get a professional or occupational license to make a living without a social security number. No one will hire you as an employee if you do not have a social security number.

Even if you have a job or business, how are you going to get to work without a driver's license (unless you happen to live in a city with public transportation)? You can be imprisoned for not having a driver's license. You cannot get insurance without a social security number. You cannot get a hunting or fishing license without a social security number. You cannot get a marriage license without a social security number. How are you going to buy a home or car unless you have the cash or credit?

The bottom line is that you cannot buy or sell (that is, survive financially) without a Social Security Number unless somebody with a Social Security Number is providing for you by buying your food, clothing, shelter and all the things you need to survive.

Although there is no law that forces people to obtain a SSN (the 13th Amendment prohibits slavery and "involuntary servitude"), once you get a SSN, you will be stuck with it for the rest of your life because the Social Security Administration will never rescind it. Also, if someone with a SSN is providing your worldly needs, they cannot deduct you as a dependent unless you have a SSN.

It is also important to note that this Orwellian, unconstitutional federal statute was pushed through the US Congress by promoting as a "dead-beat dad" law. The chief promoter was a lawyer (and president) Bill Clinton. In other words they had to deceptively disguise this assault on freedom by fraudulently claiming it was all about going after fathers who weren't paying child support. Unfortunately, this so-called "law" applies to everyone living in the US,

not just "dead-beat dads". Here are few more important facts about the Social Security Administration (SSA) and the Internal Revenue Service (IRS):

1. The Social Security Administration is not authorized by the United States Constitution and therefore is unconstitutional.
2. The Social Security Administration is not even located in Washington D.C., the constitutional seat of the "federal" government. The SSA is located in Baltimore, Maryland.
3. The Social Security Administration does not even have franking privileges. That is, they have to pay for their own postage on their mailings. Since the US Post Office is authorized by the Constitution, there is no need for federal entities to purchase postage when conducting "official business". If the SSA were a legitimate entity under the Constitution it would have franking privileges, but it does not.
4. The Social Security system is broke according to former US Congressman Ron Paul.
5. According to form letters sent from the Social Security Administration in Baltimore, Maryland, **the IRS has jurisdiction over the SSA.**



6. **The IRS is not an agency of the US government** according to official court documents filed by the US Attorney in the following [case in Idaho](#): Given 1) that the IRS has jurisdiction over the Social Security Administration and 2) that the IRS is not an agency of the US government, the

next question we should all be asking is where do people's payments to the IRS go? To answer that question correctly one must determine what is being paid to the IRS--that is, Federal Reserve Notes (or "checks" denominated in Federal Reserve Note "dollars"). According to Black's Law Dictionary, the definition of money cannot include "notes". A note is a promise to pay or "IOU" and is not "payment" in itself. Federal Reserve Notes are not money. According to the US Constitution, the only currency that can pay debts is silver and gold coin. Federal Reserve notes (i.e., "bills of credit") are prohibited by the Constitution.

What we do know is that the checks that people send to the IRS are cashed by large banks in the Federal Reserve system, such as "Bank of America". Sometimes the back of cancelled checks list a large bank then state: "or pay to the nearest FRB". "FRB" stands for Federal Reserve Bank. Since the Federal Reserve is a secretive, privately-controlled banking cartel, We the People are apparently not allowed to know where these "notes" end up.

It is doubtful that these "notes" ever reach the United States Department of the Treasury. It appears that they end up at the Federal Reserve to be applied as interest to the national debt to these banksters. The Federal Reserve Act of 1913 was unconstitutional from the start because Congress cannot lawfully amend the US Constitution with a mere statute.

During the Constitutional Convention the delegates used the words "emit bills of credit" to refer to the issuance of paper (debt-based) currency. The UK Dictatorship Takes Shape By Ian Davis



THE UK GOVERNMENT HAS USED THE CLAIMED COVID-19 CRISIS (or pseudopandemic) to quietly establish all necessary components for a UK dictatorship. The construction phase is nearing completion and, unless the people engage in **mass non-compliance** and petition their representatives to stop it, the UK dictatorship will be in full force soon.

The Global Governance Dictatorship

A dictionary **definition** of "dictatorship" is:

Government by a dictator [...] A country governed by a dictator [...] Absolute authority in any sphere.

The British dictatorship is not unique. Its emergence has been mirrored in the US, EU member states and elsewhere. This is a global model of dictatorship run by a coalition of public and

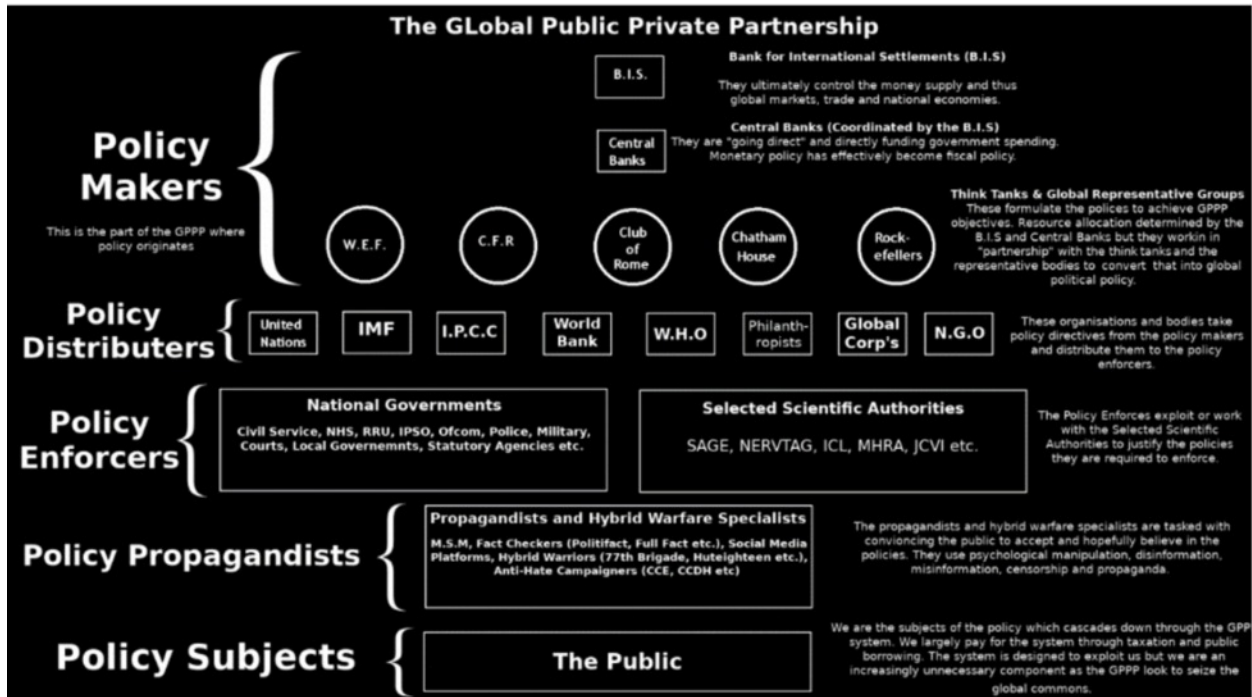
private organisations. National governments are the implementing **partners**.

The nebulous structure of the **Global Public-Private Partnership (G3P)** makes political opposition to it almost impossible. It maintains the offer of **so-called democratic elections** and even purports to enhance democratic accountability through **new forms of claimed democracy**.

The "New Abnormal" dictatorship is elusive. It does not have a single, identifiable dictator. There is **no despot** to depose. The architects of the **technocratic dictatorship** have **learned from history**. The modern, worldwide control system is one of **governance**, not government. Government is the lens which brings it into focus for all of us.

Talk of **devolution and sortition** (federalisation and citizens' assemblies) and other suggested improvements to "**local governance**" and political engagement are not remedies for but rather part of this new tyranny. These offers are illusions of representative democracy, confining policy debates to that which has already been decided by the G3P. You can choose net zero by 2030 or net zero by 2050, but whatever you choose it is going to be **net zero**.

This makes it difficult for some people to recognise the nature of the totalitarianism that is being stamped upon our societies. This is a technocra-



cy, more akin to the neocolonialism of a megacorporation than history’s previous autocratic military regimes. However, this dictatorship will, by corporate fiat, have *absolute authority in any sphere* and will be just as cruel and oppressive as any that preceded it.

Perhaps a fuller explanation of the kind of dictatorship we face can be found in the **Encyclopedia Britannica**:

[A] [...] form of government in which one person or a small group possesses absolute power without effective constitutional limitations [...] Dictators usually resort to force or fraud to gain despotic political power, which they maintain through the use of intimidation, terror, and the suppression of basic civil liberties. They may also employ techniques of mass propaganda in order to sustain their public support.

The G3P is a web of multinational corporations, **tax-exempt foundations** (philanthropists), private investors, think tanks, governments, non-governmental organisations, civil society groups and alleged charities. The G3P’s globalist think tanks—for example, the Club of Rome, the Royal Institute of International Affairs (Chatham House) and the World Economic Forum—the global governance policy agenda.

This then cascades down through the policy distributors, like the IMF, World Bank and the IPCC, to be enforced by governments and their

selected scientific bodies, such as the FDA and the MHRA. Government and the G3P are *partners*, and it is government’s role to convert the policy agenda into hard legislation and local government policy.

It is this which we are subject to. Governments don’t form policy, they simply impose it.

Wherever you look in the former western “democracies”, be it the US, France, Germany, Italy or the UK, the objective of their individual models of dictatorship are the same: to create a global system of bio-security-based digital identity, to be linked, eventually, to payment of **central bank digital currency** (CBDC). This digital gulag, or **technocracy**, will mimic the current **social credit system** in China.

The UK Dictatorship Takes Shape

Less than a week after **Public Health England (now the UK Health Security Agency) downgraded Covid-19** from a High-Consequence Impact Disease, due to **low overall mortality**, the UK Government claimed that the country was in an emergency situation. Emergency legislation was suddenly presented.

Despite the claimed urgency, the Government chose not to use the existing legislation designed for precisely such a crisis. By ignoring the **Civil Contingencies Act 2004** (CCA), the Government sidestepped the required regular thirty-day parliamentary scrutiny of permitted plenary power.

In not invoking the CCA, the UK Government was among many executives around the world that did not formally declare a state of emergency in response to Covid-19. This remains the case.

In legal terms, the Covid-19 pandemic is not, and never was, a **national emergency**. Instead, the UK Government presented legislation that had obviously taken many months to draft, which gave it at least six months of absolute executive power.



Coronavirus Act 2020

No MPs voted to pass the **Coronavirus Act 2020**. It was **fast-tracked through Parliament** in just four sitting days. At more than 340 pages, there was no opportunity for MPs or peers to scrutinise it in any depth.

Our parliamentarians thus blithely permitted the UK Government to **snatch extraordinary power**. Among its many new powers, the Coronavirus Act allowed the Government to detain people without trial and to section people in mental health institutions with far greater ease; it extended mass surveillance powers and the retention of biometric data; it created, Erewhon-like, the **crime of being ill** (“spreading infectious diseases”).

With the Act, the Government took the power to halt legal gatherings, including protests, whenever they chose; and it removed all the safeguards surrounding NHS care assessments and death registration.

On 19 October 2021, the Deputy Speaker of the House of Commons, Rosie Winterton, accepted a *voice vote* among the few MPs present, to wave through the third renewal of the Coronavirus Act. The “ayes” had it easily, in the practically deserted chamber.

There is no reason to imagine that a formal division would have produced a different result.

In the preceding March renewal vote, despite a small Tory backbench rebellion, the Coronavirus Act was extended with overwhelming support as the Government secured a 484 to 76 majority vote on the issue.

As the journalist and former British diplomat Craig Murray **correctly observed**:

It is a recognised pattern for dictatorship to commence with emergency measures designed to combat a threat. Those emergency measures then become normalised and people exercising arbitrary power find it addictive. A new threat is then found to justify the continuation.

The normalisation of dictatorial powers is precisely where we stand at the moment. There is no meaningful political opposition to the Coronavirus Act tyranny. The granting of semi-annual renewal on a rolling basis currently appears to be a *fait accompli*.

The UK Dictatorship Allows Itself to Torture and Murder with Impunity

However, the Coronavirus Act isn't the only dictatorial law which MPs have enacted and continue to accept without any qualms.

In October 2020, the Covert Human Intelligence Sources (Criminal Conduct) Bill sailed through its third Commons (and Lords) readings, virtually unopposed. In the Commons, most opposition MPs didn't even bother to vote.

The opposition leader, Sir Keir Starmer, whipped his parliamentary colleagues not to oppose the bill. Just 20 Labour MPs defied the whip to vote against this tyrannical bill. The Act (CHIS) subsequently became law in March 2021.

On behalf of the G3P, the UK Government has given itself and its agencies under this law the authority to commit any crime it likes without fear of prosecution. The **Joint Committee on Human Rights** spelled out the purpose of the CHIS:

The Covert Human Intelligence Sources (Criminal Conduct) Bill provides a statutory basis for a variety of public authorities to authorise informants, covert agents and undercover officers to engage in criminal conduct [...] by explicitly making authorised conduct ‘lawful for all purposes’ [...]

There is no express limit within the Bill on the type of criminal conduct that can be authorised. This raises the abhorrent possibility of serious crimes such as rape, murder or torture being carried out under an authorisation.

The CHIS amends the Regulation of Investigatory Powers Act 2000 and means that government bodies ranging from the intelligence services, the police and the military to the Department of Health and Social Care, the Food Standards Agency and, ironically, the Ministry of Justice can commit crimes against the people with total abandon.

The State doesn't need to justify its criminal activity but, if anyone asks, it can simply say that it broke the law “in the interests of national security; for the purpose of preventing or detecting crime or of preventing disorder; or in the interests of the economic well-being of the United Kingdom”. In essence, it can make up any excuse it likes.

Not that asking the question will serve any practical purpose. The CHIS gives agents of the State immunity from prosecution and so, even if you had a watertight case proving state crimes, there would be no defendant to bring it against. Article 6 of the **European Convention on Human Rights** (ECHR), which remains in UK statute law after Brexit, claims to guarantee the right to a court hearing for cases of civil rights abuses.

In addition, Article 8 of the UN **Universal Declaration of Human Rights** (UDHR) states: Everyone has the right to an effective remedy by the competent national tribunals for acts violat-

ing the fundamental rights granted him by the constitution or by law.

Such violations might include, for example, the police planting evidence and then concocting false witness statements. However, as no crimes are ruled out in the CHIS, the violations concerned could also include murder.



The pretty words in the ECHR and the UDHR transpire to mean nothing. The concept of “human rights” is a total charade. The CHIS demonstrates that whenever government so chooses, it can completely ignore these so-called rights. They are not worth the paper they are written on. “Human rights” are just an empty marketing strategy to convince you to trust in the institutions of government.

They are scribbled on bits of paper by politicians and lawyers to make people imagine that their rights emanate from politicians and lawyers, thus affording them alleged authority over said rights. “Human rights” are not rights. They are government permits. What government grants, government can take away.

The only form of rights that actually exist are **inalienable (or unalienable) rights**. They are ours from birth and have nothing whatsoever to do with government. Government can respect or ignore them, and we can judge government accordingly.

Government cannot alter, amend or claim any dominion over inalienable rights. Hence the global, decades-long propaganda campaign to convince us all to believe in the asinine promise of “human rights”.

We must not allow those who claim authority to continue to use duplicitous language unchallenged. Whenever they speak of “human rights”, we should refute this deception. “Human rights”

do not exist. The CHIS proves this beyond dispute in a particularly pure form.

When Britain set up the post-war “human rights” model for Europe, it went along with enshrining in several international treaties the right not to be killed or tortured as the untouchable “absolute human rights” with **no scope for curtailment** no matter what the claimed emergency, but Britain has now given itself a “human rights” model in which not even the right not to be killed or tortured turns out to be “unqualified”. They were touted as “absolute” until they were decided not to be “absolute”.

Together the Coronavirus Act and the CHIS form the basis for the rest of the UK dictatorship. When combined with the other Bills and amendments currently gliding effortlessly towards the status of legislation, it ensures the kind of dictatorship that we are familiar with from the annals of history—just one cloaked in the faux democracy of “civil society”.

The CHIS provides the context for the forthcoming dictatorial powers. All are to be set within an environment of unfettered criminality to be exercised by the UK state.

The UK Dictatorship To End The Right of Protest The **Police, Crimes, Sentencing and Courts Bill (PCSC)** has at least been **opposed by opposition parties**. It could be argued that this fact makes the total lack of resistance to the CHIS even more notable. Clearly, *all* major political parties want the power to commit crime. Among its many dictatorial measures Section 61 (2) (a) states that it is an offence if, by your acts or omission, you create a situation where another person: **suffers death, personal injury or disease**.

This raises the distinct possibility of arrest for the crime of being unvaccinated in a public space. This may be hard for many to accept. Perhaps proving this charge in court would be difficult, but the possibility is certainly raised by the PCSC.

This is a huge, sprawling piece of legislation. It makes provisions on a multitude of judicial, law-enforcement and penal powers and regulations. As this is all encapsulated in one Bill, it will be extremely difficult for most MPs to grasp its implications in full before they vote on it. To

do so, they would have to devote practically all their time to nothing else.

Moreover, we see the continual process of adding to what is already a hefty Bill. The Home Secretary stacked it with an additional eighteen amendments after it had passed the second Commons reading stage, consistently limiting MPs’ opportunity to scrutinise it.



The surreptitious extensions include: outlawing “lock-ons”, where protesters chain themselves to trees and machinery to stop the activity they oppose, such as **fracking**: any obstruction of a corporation’s normal activity, which is the **whole point** of direct action, could land a protester with nearly twelve months in prison. The Bill also extends police stop-and-search powers, lets the authorities prevent people going to a protest in the first place, and ultimately allows them simply to ban named individuals or groups from protesting.

The green activist and raconteur of the chattering, progressive left, George Monbiot, wrote a well-composed article **expressing his concern** at the Bill. In a moment of almost jaw-dropping irony, he concluded his piece thus:

So where is everyone? Why isn’t this all over the front pages? Why aren’t we out on the streets in our millions, protesting while we still can? We use our freedoms or we lose them. And we are very close to losing them.

Of course, people *have* been out in their millions protesting “out on the streets” against the establishment of a dictatorship. That is precisely what eighteen months of pro-freedom protests have been about.

However—because these enormous protests, uniting left and right, black and white, old and

young, *also* opposed the use of the Government's Covid-19 narrative to bring about this emerging dictatorship—Monbiot called the **very protesters he now pleads for** far right, anti-vaxxer, white supremacists, just three months earlier.

While they were out in their millions, across the globe, fighting for the rights which he belatedly bemoaned the loss of, Monbiot—and almost the entire mainstream media he works for, especially the *Guardian*—were attacking them. They were literally making up **fake news** to deliberately divert public attention away from the protestors' entirely legitimate concerns.

As Monbiot and many others are now coming to understand, the PCSC will make protest and other forms of direct action practically illegal in the UK. The right to protest, in any kind of meaningful sense, will be terminated when this Bill is enacted.

We may have thought that the right to peaceful protest was a democratic right. Indeed it was, but once the PCSC is enacted that particular Human Right won't exist in the UK any more.

The inalienable rights of freedom of expression, freedom to congregate and freedom to roam will still exist.

Part 3 of the Bill deals with public order. No-one will be able to cause anyone else “unease, alarm or distress” by protesting noisily. So no whistles or drums. Silent protest is all it permits. No-one will be able to disrupt the “activities of an organisation”, or even impact normal “life in a community”.

The crime of “intentionally or recklessly causing public nuisance” is created, with up to ten years in prison for protesters who dare to raise their voices. You don't even need to have made any noise. If it is deemed likely that you might cause “serious annoyance” or “serious inconvenience”, then the jail sentence for you could be twelve months.

Protests movements of all kinds have a long history of infiltration and surveillance by the police and intelligence agencies. A 2016 investigation discovered that undercover British police officers had infiltrated **more than a thousand UK-based political movements** over

the span of some decades. Their activities included being active leaders of these movements, and went as far as having families with the activists they were spying on and manipulating.

With the CHIS in place, such police infiltrators are now free to steer protest movements in any direction they wish and can use any means, criminal or otherwise, to achieve government objectives. Agent provocateurs can cause the *right kind* of “annoyance” or “inconvenience” in order to trigger their colleagues' powers under the Act.

As they are deemed to be “emergency workers”, an assault on the police receives an increased tariff of up to two years in prison. So while the state can beat, extort, defraud or even murder protestors, if anyone lays a finger on its agents they can expect a harsh custodial penalty—as they can for protesting in the first place.

The UK Government already allows the police to control protest routes or even ban marches and other forms of protests. To do so, they must currently demonstrate evidence which leads them to have a reasonable suspicion that “serious public disorder, serious damage to property or serious disruption to the life of the community” will occur.



The PCSC goes way beyond existing authoritarian powers to limit potentially dangerous protests that threaten public safety, **such as those blocking roads**. Westminster, in particular, is protected with an exclusion zone, promised in the PCSC, ensuring that the people can no longer protest before their own parliament.

In order to ban a march or protest, the police will no longer need to bother with any deliberations or present any evidence to the courts. They can stipulate when, where and if a protest is “allowed”. They can decree its duration and can deny a protest for any reason they choose.

Other measures in the Bill render protesting ineffective anyway. Most people won't even know a protest has taken place, thus utterly defeating the objective of protesting. It also makes protesting an extremely high risk activity. The majority of ordinary people with families won't be able to afford to take those risks.

Under the PCSC, democratic protest is finished. Therefore, it also ends any pretence that we live in a democracy.

We have already seen the mainstream media completely ignore huge global **pro-freedom marches**. Meanwhile they eagerly report much smaller protests by groups like **Extinction Rebellion and Insulate Britain**. They do so because these groups are protesting in support of the G3P agenda, not standing against it.

Under the rule of the PCSC, any high profile demonstrations should be viewed with suspicion. The legislation will give the G3P complete control of protest in the UK. Only the chosen protests will be "approved." Primarily to maintain the farcical allusion to democracy in our new abnormal civil society.

As the dictatorship unfolds, with agents of the G3P state able to **act like the Stasi**, and with real protest curtailed, the only place left to challenge G3P authority will be online. However, the UK government are very close to passing legislation to censor the Internet and aim to put a stop to that too.

The UK Dictatorship An End To Freedom Of Speech Online



The **Online Safety Bill** (OSB) exploits people's legitimate concerns about online child sexual exploitation and abuse (CSEA) and terrorist propaganda. The UK Government claims that the proposed Online Safety Act will contribute to tackling these crimes.

It achieves **no such thing**. This deceptive piece of legislation does nothing to address CSEA or alleged online radicalisation. Rather, it is designed to enable the Government, and its G3P Big Tech partners, to censor information they don't like and disable the sharing of it on the big social media platforms. The UK dictatorship will also hide unwanted information from the search results.

Just as it did with the Coronavirus Act, the UK Government will rely upon statutory instruments to give the proposed Online Safety Act real teeth. Many of the new legal concepts it introduces, such as "content that is harmful to adults", are not defined in the Bill itself, save in the broadest and ultimately meaningless terms.

Instead the Government will use secondary legislation, which cannot be amended by MPs, to establish the regulations that will determine what content it considers to be "harmful to adults". All the OSB does clarify is that it will be Ofcom, the regulator, that draws up these "regulations" under the direct control of the relevant Secretary of State.

The House of Lords appears to recognise the threat, its competent committee having issued a report specifically addressing the burgeoning use of the secondary legislation ruse by the executive branch of government. In another recent report, a separate Lords committee stresses that representative democracy is dying, as the the Cabinet Office clique (not their Lordships' words) increases the pace of centralising all dictatorial power. The peers recognise that this is the continuation of a process that has been ongoing for some time:

A critical moment has now been reached when that balance must be re-set: not restored to how things were immediately before these exceptional recent events but re-set afresh.

Unfortunately, the Lords are reaching out to a House of Commons which appears to be largely populated by MPs who have little care for or understanding of the British constitution. Parliamentarians have always sought to centralise authority in Parliament, despite that not being the constitutional seat of power but rather of the *limitation* of power. Executive power rests in the people's contract with the Crown, not Parlia-

ment. Parliament serves *us*. That is our constitution.



MPs are currently either sleepwalking towards, or approve outright of, proposed legislation that has no legal limit. Once it is enacted, and unless we inform and lobby MPs, it will be the Government that will stipulate whose content it intends to “take down”—effectively removing it from the major social media and search engine websites.

The true purpose of the OSB is hidden in one very short, easily missed section. There appears to have been a deliberate attempt to hide the OSB’s intent even from the inspection of MPs. Section 98 mentions “**disinformation** and misinformation” but, as usual, does not explain what these terms mean.

In Section 98, Ofcom is empowered to specify how a social media platform or search engine should “deal with disinformation and misinformation”. By virtue of 98 (4) (b), Ofcom has a power “under section 49 to require information of a kind mentioned in subsection (4) of that section, so far as relating to disinformation and misinformation”.

As far as this key concept of “disinformation and misinformation” goes in the OSB, that is the full extent of what we know! When we look at Section 49 (4), it appears merely to require online services to prepare an annual transparency report.

However, the OSB is a highly deceptive piece of legislation. Section 49 (4) (e) also stipulates that social media and search services must provide:

Information about systems and processes which a provider uses to deal with illegal content, content that is harmful to children and content that is harmful to adults, includ-

ing systems and processes for identifying such content, and — (i) in the case of a user-to-user service, taking down such content.

We can see from Section 98 that “disinformation and misinformation” is “of a kind” mentioned in Section 49. The OSB calls disinformation and misinformation “content that is harmful to adults”.

This content is treated in the rest of the OSB as indistinguishable from “illegal content”. Most people, including MPs, will support the removal of child pornography, paedophile predators, terrorists and terrorist propagandists from the major Internet platforms.

Yet, possibly unknowingly, if they pass the OSB into law, the UK Government will also gain the centralised authority to “take down” anything that it (not a court) considers to be “disinformation or misinformation”, by labelling it as “content that is harmful to adults”.

This approach does require the complicity of the Big Tech giants, but that is assured. They too are *stakeholder partners*, alongside governments, in the Global Public-Private Partnership. It is to their advantage to go along with the future **policing of the Internet.**

The independent legal journalist, CyberLeagle, **points out:**

The Impact Assessment accompanying the draft Bill states:

‘...it is expected that undertaking additional content moderation (through hiring additional content moderators or using automated moderation) will represent the largest compliance cost faced by in-scope businesses.’ (Impact Assessment [166])

That compliance cost is estimated at £1.7 billion over 10 years. That does not suggest a regime that is not focused on content.”

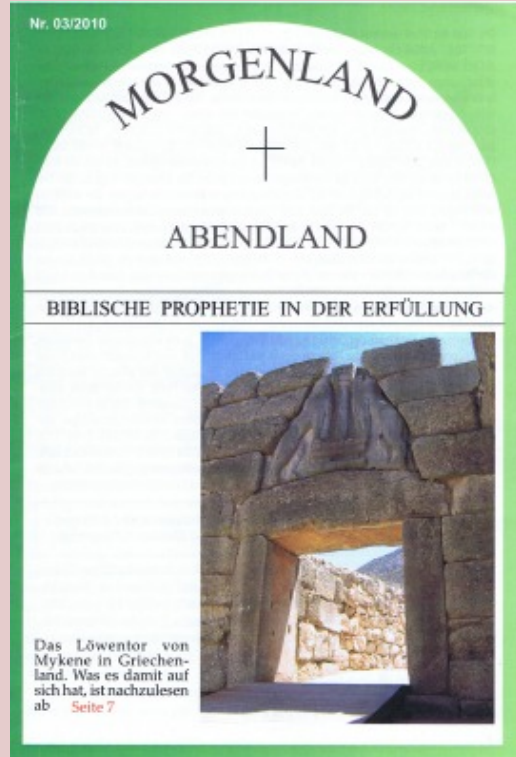
