I'LL NEVER FORGET HOW PROUD I WAS when I got a perfect score on my computer programming final.

My teacher said it had been four or five years since anyone had done that. Degree in hand, I got a job in San Francisco during the boom years. The ninety grand salary almost justified the 200 grand my folks paid for my college education. Boy, were they proud of me. "Our son, the computer programmer."

Success beyond their - and my - wildest dreams! Besides being proud of my accomplishment, I felt a great sense of relief that their investment had paid off. I had graduated right around the time of the first Gulf War.

America had come away smelling like roses. We had just defeated the bloody dictator, Saddam Hussein, after his invasion of Kuwait. If any war seemed justified, that was it. Bush 41 had full support internationally.

Even though Iraq had ancestral claims on Kuwait, who was Saddam Hussein to try to make good on them? He didn't have enough oil? The thing that troubled a lot of people, though, was: Why didn't we finish the job? Here we were at his doorstep, ripe for the taking, and we just pulled out.

My uncle John, a Vietnam veteran, was beside himself. Like Patton, who wanted to take Berlin at the end of World War II, he wanted us to go to Baghdad. Things started to turn sour for me with the decline of the Internet stocks.

The boom, the speculation, was nothing more than a shift of economic resources. Unlike the computer driven boom of the 80's, with real

manufacturing jobs being created and real goods being sold, the boom of the 90's was nothing but speculation. Instead of more jobs being created, the economy just shifted from old technology to new technology, with online companies trying to take the place of conventional companies. Some companies, like Amazon and Ebay, succeeded. Most didn't.

As the boom faded, so did the number of lucrative jobs in Silicon Valley, as it had come to be called.

Tom, a friend of mine from Chicago, had moved to Silicon Valley to get a \$100,000 a year job, but it was so expensive to live there that, after two years, he quit and moved back to Chicago. Like the Roman Empire 2,000 years ago, America is facing a crisis of corruption.

My Uncle John told me about the misgivings he had about the Vietnam War, how it had not been a declared war. "We should have declared war," he said. "It sets a horrible precedent."

Now, our Presidents go around the world making war on feeble nations, paying lip service to freedom and democracy, asking for meaningless resolutions, but Congress has shirked its responsibility to declare war Constitutionally.

The politicians don't want to be perceived as warmongers, but they want their constituents to make money, so they give the President free reign to do as he pleases, saying to themselves. "Let the President take the fall."

So, it occurred to me that there are these very interesting, if not frightening parallels: Just like Rome, which started out as a Republic, we have had a succession of military dictators who make war on behalf of the special interests who invested in the latest Caesar, er, I mean, President. Johnson had his Vietnam. Reagan had his Grenada and Panama. Bush 41 had his Gulf War. Clinton had his Somalia and Kosovo.

Now, Bush 43, premising his War in Afghanistan on finding and getting a bogeyman named Osama bin Laden and premising his War in Iraq on the existence of those elusive weapons of mass destruction, has decimated two more countries, and no sign of Osama and no sign of these mysterious weapons.

I used to be a proud American, but now I'm not so sure if Old Glory stands for the Constitution of the United States or whether it stands for the Big Corporations. Please, America, give me a reason to be proud again!

It used to be that the tech buildings in Silicon Valley had the lights going all night long. The programmers, engineers, and business people burned the midnight oil sometimes 'til sunrise. There was so much excitement. The boom was tangible. The computer geeks didn't care if they ran out of deodorant. They just kept hacking away, sleeping on the office floor or on a cot to take catnaps.



Those were different times. Things were starting to slow down just before Y2K. Now that I look back, I realize that Y2K gave the industry a shot in the arm. Old-timers who new languages like Fortran and Basic were being recalled to work on the problem.

The government never admitted it publicly, but the Strategic Air Command computers went down for two weeks right after Dec. 31, 1999. The millennium bug had struck!

My friends who worked for the missile defence system told me about it. This news only made a few technical journals. The military could never admit publicly that they, and we, were totally defenceless for two weeks.

But since the world didn't stop, all the newspaper editorials were saying that Y2K was just a bunch of hype! It wasn't hype; and all the programmers know it wasn't. The billions of dollars spent on

preparation was necessary. The private sector did what it had to in order to prepare. In the process, a lot of new jobs were created and a lot of new computer equipment was installed. But that was the end of the boom! Modernization through panic! That's what drives the economy today. Because I had the most seniority, I was one of the last ones to get a pink slip. The days when the office lights were left on throughout the night are long gone.

There are maybe two or three offices that still have enough work to justify late hours. The corporations started moving their facilities overseas, to places like India, where there are plenty of mathematicians and programmers who are willing to work for half as much money and who have ten times as many mouths to feed.

Here I stand, a once proud computer programmer, with no job and a big mortgage. I'm going to have to sell the condo at a loss and move back to Indiana. The uncertainty began creeping in slowly, but now it is reality.

The Roman Empire fell because of internal corruption. (Alliterates and rhymes with "international corporation," doesn't it?) With one Emperor in charge of the East and another Emperor in charge of the West, their interests often conflicted.

Most people don't realize that Rome was just as much an economic empire as it was a military empire. The reason Julius Caesar invaded Britain was to try to capture the mining operations. Why pay for tin when you can steal it? The British defeated him twice, both times by cutting off his supplies.

With the subsequent persecutions of the Christians throughout the Empire, Rome was at war with itself, collapsing from within, from decadence and political intrigue. The competing economic factions within the Empire fought each other as much as they fought the barbarian hordes. Today, in America, we have the Empire of the Democrats and the Empire of the Republicans, with their respective special interest groups.

We "protect" our airports while the illegal immigrants ("barbarian hordes") stream across our borders unimpeded. Question: Can you tell the difference between an illegal Arab and an illegal Mexican once the Arab dons a sombrero?

Actually, I never had such a dream. I was too busy working to even think about it. I just got caught up in all the action. Aside from the odd jobs I've been doing in the surrounding towns and the occasional trip to Chicago looking for work, my dad has been teaching me how to farm.

Constantine the Great did not want to rock the boat by giving Christians equal rights with pagans, but the social unrest was unending. Something had to be done. Old Testament

“Word for Word” Exodus Part 2

Translation by Stephen Howard Anderson



Chapter 3

1. Now Mosheh was shepherd of the flock of Yithro 3503 his father-in-law, the priest of Midyan: and he led the flock to the backside 310 of the desert 4057, and came to the mountain 2022 of Elohiym, to Choreb 2722.

2. The messenger 4397 of Yahweh appeared to him in a flame 3827 of fire 1197 from the midst of a bush 5572: and he looked, and behold, the bush burned 1197 with fire, and the bush was not consumed.

3. Said Mosheh, “I will now turn aside 5493, and see this great sight 4758, why the bush is not burnt.”

4. And when Yahweh saw that he turned aside to see, Elohiym called to him out of the midst of the bush, and said, “Mosheh! Mosheh!” And he replied “Behold me!”

5. Said He, “Do not draw near 7126 here: put off 5394 your sandals 5275 from your feet, because the place where you stand is Holy 6944 ground 127.”

6. Said He also, “I am Elohey 430 your forefathers, Elohey Abraham, Elohey Yitschaq, and Elohey Yaaqob.” And Mosheh hid his face, because he was afraid to look upon the Elohiym 430.

7. Said Yahweh, “I have surely seen the affliction 6040 of My people which are in Mits’rayim, and have heard their cry 6818 by reason of their taskmasters; for I know their sorrows 4341;

8. and I am come down to deliver them from the hand of Mits’rayim, and to bring them up from that land to a good 2896 land and large 7342, to a land flowing 2100 with milk 2461 and honey 1706; to the place of the Kenaaniy, the Chittiy, the Emoriy, the Perizziy, the Chiwviy, and the Yebusiy.

9. Now therefore, behold, the cry of the children of Yis’rael is come to Me: and I have seen the oppression 3906 by which the Mits’rayim oppress 3905 them.

10. Come now therefore, and I will send you to Par’oh, so that you may bring forth 3318

My people, the children of Yis'rael out of Mits'rayim."

11. Said Mosheh to Elohiym, "Who am I, that I should go to Par'oh, and that I should bring forth the children of Yis'rael out of Mits'rayim?"

12. Said He, "Certainly ³⁵⁸⁸ I will be with you; and this shall be a sign to you, that I have sent you: when you have brought forth the people out of Mits'rayim you shall serve ⁵⁶⁴⁷ Elohiym upon this mountain ²⁰²²."

13. Said Mosheh to Elohiym, "Behold, when I come unto the children of Yis'rael, and shall say to them, 'Elohey ⁴³⁰ your forefathers has sent me to you'; and they shall say to me, 'What is His Name ⁸⁰³⁴?', what shall I say to them?"

14. Said Elohiym to Mosheh, "Ehyeh ¹⁹⁶¹ Asher ⁸³⁴ Ehyeh," Said He, "Thus shall you say to the children of Yis'rael, 'Ehyeh has sent me to you.'"

15. Said also Elohiym to Mosheh, "Thus shall you say to the children of Yis'rael, 'YHWH Elohey your forefathers, Elohey Abraham, Elohey Yitschaq, Elohey Yaaqob, has sent me to you': this is My Name forever ⁵⁷⁶⁹, and this is My remembrance ²¹⁴³ to all generations ¹⁷⁵⁵."

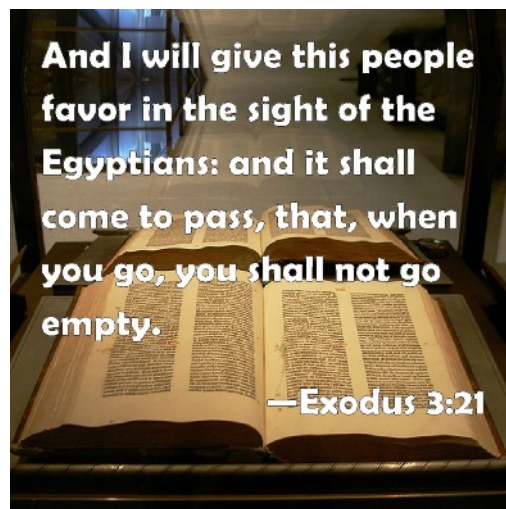
16. Go, and gather all the elders ²²⁰⁵ of Yis'rael together, and say to them, 'Yahweh Elohey your forefathers, Elohey Abraham, Yitschaq, and Yaaqob, appeared to me, saying, 'I have surely visited ⁶⁴⁸⁵ you, and seen that which is done to you in Mits'rayim;'

17. And I have said, 'I will bring you up from the affliction of Mits'rayim unto the land of the Kenaaniy, the Chitty, the Emoriy, the Perizziy, the Chiwwiy, and the Yebusiy, to a land flowing with milk and honey.'

18. They shall listen to your voice: and you shall come, you and the elders of Yis'rael, to the king of Mits'rayim, and you shall say to him, 'Yahweh Elohey Ibriy ⁵⁶⁸⁰ has met with us: and now let us go, please, three day's journey into the wilderness, so that we may sacrifice ²⁰⁷⁶ to Yahweh Eloheynu ⁴³⁰.'

19. And I am sure that the king of Mits'rayim will not let you go, no, not by a mighty ²³⁸⁹ hand ³⁰²⁷."

20. And I will stretch out ⁷⁹⁷¹ My hand, and smite Mits'rayim with all My wonders ⁶³⁸¹ that I will do in the midst ⁷¹³⁰ of it: and after that he will let you go.



21. And I will give this people favor in the sight of the Mits'rayim; and it will come to be, that when you go, you shall not go empty ⁷³⁸⁷:

22. But every woman shall ask ⁷⁵⁹² of her neighbor ⁷⁹³⁴, and of her that sought hospitality ¹⁴⁸¹ in her house, jewels of silver, and jewels of gold, and clothing: and you shall put them upon your sons, and upon your daughters; and you shall plunder ⁵³³⁷ the Mits'rayim."

Chapter 3 Notes

Verse 1 - Yithro is a title, meaning "his excellence", as Reuel was a priest of some sort, and had standing and authority in the community.

Verse 6 - Remember that Elohiym is not a name, but a title of majesty when it refers to Yahweh. ⁴³⁰ has multiple uses, and configurations when tense is changed, so I try to note this in the margin.

Verses 13 - 15 - Here the Holy Name is introduced. The Name was used by Mosheh when B'reshiyth (Genesis) was written, because he knew the Name when the book was written at a later time. "I will become what I will become" is important, because Yahweh manifested Himself in many forms — burning bush, pillar of cloud, pillar of fire, a man that

wrestled with Yaaqob, and Yahshua Messiah as the Redeemer of Yis'rael. Hayah Asher Hayah is a prophecy in itself, as one of the foretellings of the Messiah to come.

Verse 15 clearly states that YHWH is His Name forever, and is to be remembered, and never changed or hidden by a substitution of Adonay 136 (Lord) by a tradition of the elders. I have a Jewish Publication Society Tanakh, to access the Hebrew text, and even they say in their notes that Adonay was substituted by *TRADITION*.

YHWH (Yahweh for pronunciation) is The Holy Name, and no other.

Verse 20 - Yahweh is going to crush a mighty kingdom to show His power. This is to impress upon the minds of all the non-Yis'rael nations the set-apart status of Yis'rael.

Verse 22 - Yis'rael is to plunder the Egyptians when they leave. This occurs in Shemoth 12:35.

British-Israelism to Christian Identity & the Palestine Campaign

TRANSLATING THE BIBLE INTO ENGLISH HAD AN ENORMOUS IMPACT ON ANGLO-SAXON CULTURE. Most importantly, Britons began to feel an identification with the characters of the Old Testament. This identification eventually created a movement called British-Israelism. The theology of British-Israelism and its racially-aware offshoot of Christian Identity is described by Michael Barkun in his 1997 book *Religion and the Racist Right*.

The concept behind British-Israelism is the belief that the British people are descended from

the “10 Lost Tribes” of Israel. The 10 Lost Tribes disappeared from history after the northern part of Israel was conquered by the Assyrians. (This is described in the Old Testament’s *Second Book of Kings*.) As such, the British people are God’s “Chosen People” and are expected to play an important role in the final battle between good and evil within Christian eschatology.

The first theologian that advanced British-Israelism in this pure form was Richard Brothers (1757-1824). Brothers was a retired Royal Navy officer who had a vision that he was to lead the Jews back to Palestine, and those Jews were the 10 Lost Tribes and were British. Later in the middle of the 19th century, an Irishman named John Wilson (1799 – 1871) carried on the work of Brothers and published *Lectures on Our Israelitish Origin* in 1840. Through Wilson’s intense promotion, British-Israelism reached a broad audience of middle-class Britons.

British-Israelism flowchart. This chart has a philo-Semitic outlook. In the same way that British-Israelism influenced Christian Identity, it also paves the way for the Christian-Zionist movement where white American Protestants support Israel without question.

British-Israelism’s pattern was the following: in the British Isles, many of its lead writers and adherents were former military officers that were also well-educated members of the middle class. British-Israelism didn’t attempt to create

its own church organization with a unique doctrine and an ability to ordain and excommunicate. Instead, adherents to the philosophy existed in nearly every Protestant denomination.

Additionally, adherents came from every part of the British Isles. There was however, a heavy component among the Protestants in Northern Ireland. In Britain, the movement supported the British Establishment and the British Empire, and felt that actual Jews (of the two non-lost tribes) were partners to the Anglo-Saxons. It was thus a God-ordained destiny for the British to rule in Palestine and issue the Balfour Declaration, which identified Palestine as a Jewish homeland. In this sense, British-Israelism also paved the way for the more mainstream Christian Zionism.

British-Israelism made the jump to the United States through the work of US Army 1st Lieutenant C. A. L. Totten (1851-1908). In the United States, British-Israelism had some surface level similarities to the British movement. Like in Britain, the American version attracted former military officers, the concept initially latched on to numerous Protestant denominations without becoming a denomination in its own right, and Americans from all of the traditional regions (Yankee, Quaker-Midland, Scots-Irish Appalachian, etc.) endorsed the theology.

1st Lt. Totten influenced Howard Rand[4] (1889-1991) and William J. Cameron.[5] The latter two men lead the transition of British-Israelism to racially aware Christian Identity. British-Israelism was pro-Establishment and philo-Semitic. In America, the concept became anti-establishment and anti-Semitic. Essentially, the theological evolution of British-Israelism to Christian Identity is how Protestant Bible-believers mesh their identification with the characters of the Old Testament to the fact that American whites have a conflict of interest with Jews. (This will be described further below.)

In the late 1980's and 1990's this movement came on to the scene when a number of adherents, or at least people with substantial links to the theology, got involved in high-profile events. This includes Robert Mathews of The Order and Randy Weaver in the 1992 standoff in Ruby Ridge, Idaho. Lieutenant Colonel "Bo" Gritz, a third party candidate for President,

served as a go-between between the FBI and Weaver.

Bo Gritz had many Identity associates and through him Identity ideas got a wider hearing. Other high-profile Identity adherents included the preacher Lt. Col. William Potter Gale,[7] (1917-1988),[8] a former officer on the staff of Douglas MacArthur in the Pacific War. The most famous Identity preacher was Richard Girnt Butler (1918-2004). Butler had a large following in northern Idaho and he had a genius for public relations. He organized marches, distributed literature, and also got his message out during the Ruby Ridge situation.

Michael Barkun explains the theology in detail in his book and shows precisely how the ideas moved from the British Isles to the West Coast of the United States and beyond. There is so much detail that reading the ins and outs can get pretty boring. Barkun concludes that in the 1990's, the political right's high-profile debacles enhanced the movement rather than discredited it.

In the big picture, British-Israelism morphed from a philo-Semitic pro-Establishment movement in Britain into the exact opposite in America, because in the United States Jews and American whites have a sharp conflict of interest. Howard Rand, for example drove British-Israelism towards its Christian Identity variant from the 1920's until the 1940's due to this conflict.

In the 1920's, the conflict expressed itself by the fact that many Jews were involved in the very real Red Scare Communist agitation. In the 1930's, the conflict adjusted to the fact that Jews

had moved into positions of power within the administration of FDR. In the 1940's, the conflict expressed itself in the clash over different ways of dealing with World War II and the subsequent Cold War.

Every minute of these decades Jews worked to stir up blacks and other non-whites against American whites. Most recently, the inconvenient US Government shutdown in January 2018 started with a Jewish-led pro-“Dreamer” protest in Congress.

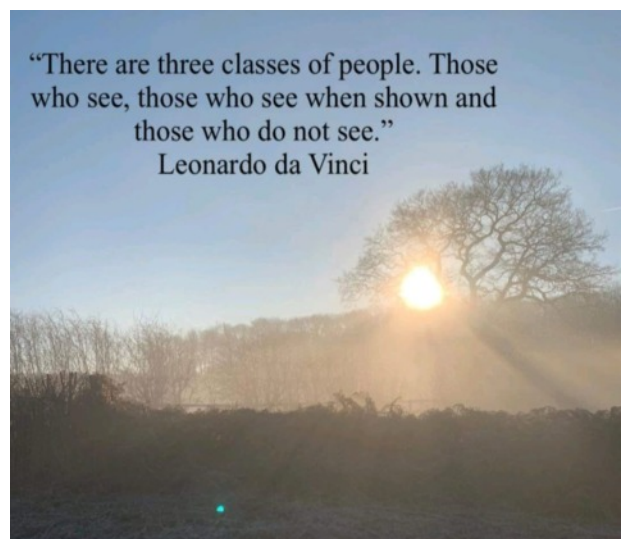
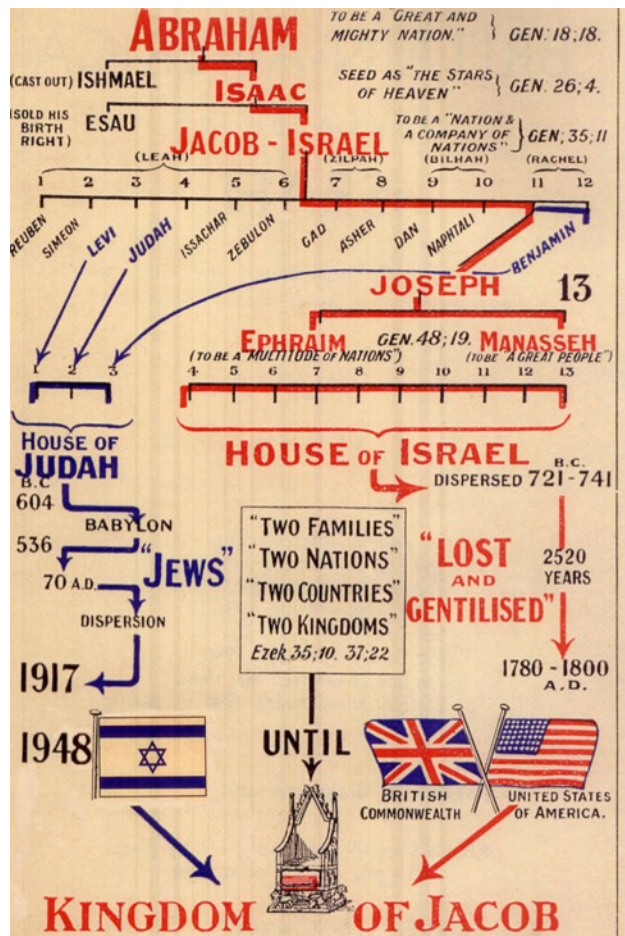

Economic Law of the Lord

NOW, AS TO MONEY, WE DON'T HEAR MUCH OF IT UNDER GOD'S LAW — only certain prohibitions concerning it. Today we make automobiles and raise wheat and sell our labour in order to buy money — the buying and selling of money is the whole of modern business. In a natural society, we buy and sell commodities of use — money is just the counter across which the exchange passes. It is only where the Law of God is unknown that money is regarded as wealth.

“The principal money law in Divine Economics is the law against Interest. I simply state the fact; it would require an entire lecture to give the reasons underlying this law. It may, however, impress this financially wise generation to know that the Interest Business and the Debt Business are today the foundation of national and international finance. In Israel, because of this law, there was no incentive to invent means to

get everybody into debt, because there was no profit in debt.

“And there really is no profit in debt, even today — but we are just finding that out! We only thought there was! The internal debt of the United States today, a debt instigated primarily for interest profit, amounts to 148 billions of dollars[1].

The national income last year was only 40 billions of dollars, in 1929 it was only 85 billion — largely fictitious — and yet in good years and bad, the ‘debt service’ or the ‘carrying charges’ as it is euphoniously called, that is, the interest burden, commands more than 20 per cent, nearly 25 per cent, of the national income. Every five years we give one whole year's work to interest. That is a practical commentary on this Bible law. We pay dearly for every departure from God's economic law.

“Strangely enough, this Law which prohibits the creation and expansion of long term debts, is also the strong source of Credit. Do you know of any law which commands that credit shall be given? Well, this divine law legislates Credit just as it legislates taxes. Credit — not a burdensome debt, not an advantage taken of our pressing need, but Credit, a lift, a help, a true favour, an assistant of our advantage rather than a tax on it.

“The creation of Credit without the multiplication of debt, is a masterpiece of divine legislation.

“Another strange point is that this law which absolutely prohibits interest or the increase which is called usury, comes from the same divine power which practices increase all the time! We make dead money artificially yield a paltry 3 or 4 or 5 per cent — not that the money yields it, the borrower does. But God's increase — did you ever count that?

The Lord Christ once touched upon it; speaking of God's interest which He pays to men, Jesus

said that in some instances it was ‘ thirty fold, some sixty, some an hundredfold.’ And that is not 30, 60 or 100 per cent, but 3000, 6000, and 10,000 per cent. And because we reject the living system of 10,000 per cent increase for our dead system of 5 per cent, here we are!

We have elected to follow after the Babylonian system. As a result John says,

“And he caused all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.”

THE MARK

There are many kinds of marks. The branding and marking of cattle show ownership and in that sense the mark is here used.

The right hand represents all manual labour (Job 40:14) while the forehead is emblematical of mental and intellectual work. (Ezek. 3:8-9.) Whether rich or poor, men must labour with brawn or brain in order to acquire money, the possession of which in some one of its many forms is necessary in order to buy and sell.

When the entire desire and energy of a man, either in his mental or physical labours, is to acquire money and with that as the goal of his life such a one has received the mark of the beast. Such men have a price and are subject to bribery. If the inducement is sufficient they would sell their own souls to acquire the wealth that this beast can give, for they are his, having received his mark.

Chapter 12 The Pudding Test

BEEN, but how bitter it all turned out. The proof of the pudding is its bitter taste, our history has been one of much thrashing. Let’s look at the pudding ingredients. Ephraim represented the Northern Kingdom, a Joseph type, this was one of dominion. That is why the British Rikke was the largest of Israelite Empires. But there must be, in order to keep dominion, authoritative rule, as symbolized by the sceptre.

All these woes mirror perfectly the calamities we read in Revelation 14:14-20 and Matthew 13:37-43. All are brought on by a ruling King, King Jesus, who thrashes the wheat company-Israelites upon the threshing floor and crushes the grape company-Israelites in the wine press.

Many will say, “But most of those that died were Christians.” Indeed so, for they were the types that we read in Jeremiah 4:7-16 who cry ‘the Temple of the Lord’ or ‘We are Christians, Christians, Christians, we have been **SAVED** by Christ to do all these abominations,’ most notable of the Gilgallian type.

Those that voted for man-kings to rule over them, but would not have Jesus on David’s throne, “He that hath not the Son of God, hath not life.” 1 John 5:12. The rule with the rod of iron’ began with the ‘white horse and its rider’ in Revelation 6. The following horses (such as the red one for Esau) typify his doom or judgement upon a rebellious folk, rebellious because they reject King Jesus and His Law - for man-kings and their laws.

The church age or ‘wheat age’ is typified by rebellion to God’s Laws. Rebellion to God’s Laws means the rebels (the Churches, the man-kings and their constitutions) have dethroned King Jesus, effectively they are thrashees, ie. destined for a thrashing by His Royal Highness King Jesus 1 (the first and only). Does the title sound strange? well, get used to it, for He is all those things right now. But although His high calling, He was never a snob to the poor (of Israel) but instead was born into the poor to be

a servant, for no one can be a Fitting master unless he was a servant first. Man-kings and their ‘cling-ons’ looked favourably upon those of like means, even wealthy zuwr, but called the poorer kinsmen ‘vulgar’ or unclean. In reality, the unclean are really the zuwr.



The churches have restored the wrong things, the system in I Samuel where the man-priests bless man-kings with man’s laws under a pretence of godliness to rule over the folk. The churches have usurped their job.

Their job was to ensure that there would be no man-kings, no central government and to ensure that all men knew the law; and that the ecclesia (a circle or ring) of older men, as elders or overseers ruled their affairs directly under King Jesus through the Holy Writ. These ‘Rings’, ‘Circles’ or ‘Ecclesias’ would never be allowed to do as the heathen by choosing a ruler, SAR or king to rule over them, or over a cluster of ‘rings’ thereby centralizing might. In that way, all men would be kings and priests (on their own land) under King Jesus.

Instead, the churches realized that, like their rebellious counterparts before the crucifixion, it is easier to feed off the sheep rather than feed the sheep. Thus they brought us back to Gilgal. What did the sheep do?

They said ‘Amen’ to the priest-craft. God’s hatred was rekindled but now through His Son Jesus, because Jesus can do only what His Father does. Behold that God’s hatred is real, it varies greatly from what those no-hoper, deceiving church ministers say. Those Judeo-Christians say, “Hate the sin but love the sinner.” **NO!** God says He **HATES** the sinner. Those ‘lovely love-em-all’ church ministers are not so nice after all.

They are all a bunch of whoring, idolating warlocks that could have staved off God's wrath. Many are freemasons, many are queers, many are Canaanites, many advise government, many keep government alive, but NONE say that governments that are headed by P.M.s, Presidents or Queens have de-throned King Jesus. Of course, they serve man-kings, a cosy triad that allows wolves to eat the sheep.

Thankfully, throughout the church age, there are and have been Christians who did understand. They are 'called out' of the churches and out of secular society. They are the first fruits, the over-comers, the barley company.

They only need to be winnowed; the breath of God (His Word) goes by and the husks simply fall off. They don't need thrashing or crushing to know God's mind. The Barley group are separate, apart; they are thus 'holy', or the 'holy ones'. 'Saint' is simply a Latin word (chosen to usurp the Saxon term 'Holy-one') for a Christian that fits the above.

The Catholic definition of 'saint' is totally wrong. 'Saint' in their eyes is one that the church sets upon a pedestal for worship and is some how deified. But a true Holy one is one that has left the church to grow as a Christian "outside the temple ground."

The falsehood of 'brides of Christ' also comes from the church. This nonsense teaches that women can wed Christ. God's wish for women is to bring forth godly children of Israelite stock, ie. of the flesh. A nun is not a bride of Christ but instead she is a barren brick! Children are the wombs sweetest fruit (see Psalm 127, 128).

The order for men and women is to replenish (fill) the earth with offspring. Nowhere does the Bible use the term 'brides of Christ'. The term is totally singular and is used for men and women of the wheat company.

Christ has only one bride. It is a pitiful one at that, for now it is the churches; be it Catholic, Anglican, Dutch Reformed, Russian Orthodox and so on. BUT only the Israelite population of those churches are the bride of Christ. Non-Israelites do not count (see the last chapter on Abraham's seed.) Yes, the Israelites of the churches, they are the bride. **BUT THEY ARE NOT THE BODY OF CHRIST.**

The body of Christ is made up of the called-out ones. They are the ones who know we are the Israelites, those who know that we need to remember the God who took us out of Egypt.

The teaching that fires up the called-out ones is not new; it has always been around, but needs to be revived every so often, as it is today. It is growing and is commonly called the Identity movement (although **Not** the 'Identity movement' by FBI and ADL definition), it is more truthfully called the Elijah movement.



It is in essence, an Elijah mindset, an Elijah ministry. It is preparing the hearts for those who seek for Christ's second work in the same way that the 'spiritual Elijah', John the Baptist, made ready the way for Christ's first work.

The first work implies a second work at a later time. In order for the husband (ie. the body) to step in and be the head of the household (of God, ie. Saxon nations), the wife (the churches) need to stop wearing the spiritual pants and step down. This is happening. The churches are empty. Sure, a few 'Charis-maniac' churches fill up, but overall, the churches are empty.

The Charis-maniac churches are simply the death throes of a dying age. That the churches are empty is not a bad sign. It is a wonderful sign, it's a sign that the bride of Christ will one day be the wife in obedience to the body. The body is the husband of which Christ is the head, becoming ready for the second work. Thank God for thrashing the wheat and crushing the grapes, for shutting down their priest system and throwing down their thrones.

All God's judgements (dooms) are righteous, after all, these dooms will put the last touches to the process that rolled away the Gilgallian reproach. This rolling away began at Golgotha. Thank you God, for King Jesus!

Harold Stough Notes A Paper by Stephen Spykerman Is The Welsh Language Akin to Hebrew?



There are many indicators that demonstrate our Hebrew origins, almost too many to mention. One of these is the language of the Welsh in particular, as a number of linguistic scientists have discovered a remarkable link between Welsh and Hebrew. A scientist by the name of Glass published an article entitled “Welsh Hebraisms” in the Cambrian Quarterly Magazine and Celtic Repertory dated July 1832.

In his article Mr. Glass remarked upon the close resemblance and connection existing between the Welsh and Hebrew languages, and said that this was the best proof of the Eastern descent of the ancient British. The article then went on to provide clear proof by supplying a vocabulary of words in both tongues, so closely resembling each other in sound and meaning as to put the question beyond all doubt.

Previously, in 1675, Charles Edwards published a number of Welsh Cambro-Britannic Hebraisms in which he clearly demonstrated that “whole phrases” in Welsh could be closely paralleled by “whole phrases” in Hebrew. Mr. L G A Roberts in his British History Traced from Egypt and Palestine (1919) quotes a certain Reverend. Eliezer Williams (b. 1754), who wrote several works on the Celts, as follows:

“In the Hebrew – which the ancient British language greatly resembles – the roots of most of the ancient British, or real Welsh, words may

be regularly traced in the Hebrew. Scarcely a Hebrew root can be discovered that has not its corresponding derivative in the ancient British language. But not only the words – their variations and inflections afford a much stronger proof of affinity.”

The Revd. Dr. Margoliouth discovered many such examples of Hebrew influence in Britain. In his book entitled Jews in Britain, he remarked upon the folklore of the Cornish people of southwest England, where whole sentences were treasured up (without being understood), and when written down were found to be pure Hebrew.

Three of these rendered into English are: “Lift up your heads, o ye gates, and be ye lift up ye everlasting doors, and the King of Glory shall come in; Who is this King of Glory?; The Lord Yesu, He is the King of Glory.”

The extraordinary fact is that this is an almost exact quotation from the Book of Psalms in the Bible (Psalm 24:7-8). The only difference being in the last sentence, where in answer to the question, ‘Who is this King of Glory?’ the actual Psalm states, “The Lord strong and mighty, the Lord mighty in battle.”

It clearly is a messianic message that is speaking of a promised ‘great deliverer’ who is yet to come. To the Jews he is the Messiah to come, and it appears that the Druids of Britain were also expectant of a great ‘King of Glory’ and Messiah. In this we have yet another indicator of the Hebrew roots of our ancient British and Irish ancestors.

Does English Language Also Relate to Hebrew?

The English language too is akin to Hebrew. A number of Bible translators and Hebrew scholars have remarked that the English language is the most similar to Hebrew. The greatest of these

was William Tyndale, who first translated the Hebrew Bible into English. Tyndale was an accomplished linguist and an exceptional scholar who had mastered seven languages including Hebrew. He said that English was the easiest language to translate from Hebrew.

Is Hebrew – The Mother Tongue of Mankind?

According to the eminent etymologist Isaac E Moseson, Hebrew is the mother tongue of mankind. After more than ten years of original research he was able to trace more than 22,000 English words back to their ultimate origin in Biblical Hebrew. His conclusive research proves that ‘English and Hebrew are profoundly connected.’

His findings show that “many more words should be acknowledged as borrowings from the Hebrew.”

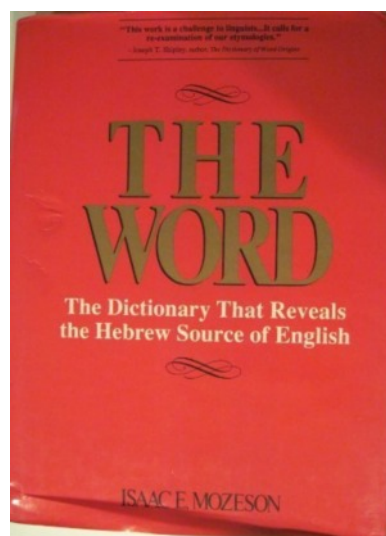
He says, “There are hundreds of English and Hebrew words that sound remarkably alike and mean the same but are not cited by linguists. A few of these are abash and boosha, albino and labhan, evil and avel, lick and lakak, regular and rageel, and direction and derech.

Further evidence of a connection exists in word meanings. Moseson tells us, “Many names of animals have meanings in Hebrew. Giraffe means ‘neck’ and skunk means ‘stink’ ” His recently published ground-breaking book called simply, “The Word,” presents the greatest challenge to linguists the world over.

The 22,000 English parallels he traces to Hebrew are totally beyond coincidence, and they call for a fundamental re-examination of our etymological understanding. In fact his “The Word,” book gives the greatest boost to the biblical thesis that all human languages derive from a single ‘mother tongue.’

Now, why should that surprise us? According to the account in the Book of Genesis Chapter 11, verse one: “Now the whole earth had one language and one speech!” Nimrod, the evil founder of Babylon wanted to unite the whole world population under his rule in one city, and his message was: “Come let us build ourselves a city, and a tower whose top is in the heavens; let us make a name for ourselves.....

Yair Davidy, an Israeli author of numerous historical books, has come up with his own examples of Hebrew parallels to English words.



As none of his examples are listed in Isaac Moseson’s “The Word” book, it indicates that there are many more than 22,000 English words that can be traced to their Hebrew originals.

To mention only a few of the thousands of examples of the similarity between English and Hebrew, just look at the similarity of the meaning of the following words:

The Hebrew word for “mire” is *botz*, and for a swamp where the ground is waterlogged is *baitsa*. This can be pronounced much like the word “beach” in English, and it is in all probability the origin of the word.

The English word for “eye” is derived from the Hebrew word *ayin* meaning “eye.”

The word “ink” in Hebrew is *diyoy*. This is clearly where the English word “dye” comes from.

A “penknife” in Hebrew is called *taar* meaning any kind of sharp cutting instrument. This is the most likely origin of the English word for “tear.”

The English word “dumb” is derived from the Hebrew *dom* meaning to be silent.

Is there a genetic relationship between English and both Hebrew and Egyptian?

An eminent Danish language scholar, Dr. Louis Hjelmslev, carried out extensive ground-breaking research into the root structure of languages. In his book, *Language: An*

Introduction (University of Wisconsin Press, 1970), he highlights the enormous influence of the Semitic tongue upon the Indo-European languages.

He states that most European words are borrowings from non-Indo-European languages. In fact, “a genetic relationship” between Indo-European and Hamito-Semitic (i.e. Egyptian-Hebrew) was demonstrated in detail by the Danish linguist Herman Moller, using the method of elemental functions” (p. 79).

This is a most important point. Why? Simply because the similarity between Hebrew and English goes far beyond the mere resemblance of words. The elemental functions represent a “genetic relationship” between English and both Hebrew and Egyptian (p. 83).

These languages are therefore related in their very root structure, showing a common origin. We know from the Book of Genesis that the Jewish nation was birthed in the land of Egypt, so it should therefore not surprise us to find this genetic relationship between the Egyptian and Hebrew languages. In fact all of this fits perfectly with the Scriptural account in the Bible.

Are The Semites Our Own Countrymen?

Given these facts, a group of Danish language scholars has proposed eliminating the separate language categories of Semitic and Indo-European, combining them into one new category called, “Nostratic, a name proposed by Holger Pedersen for the languages related to our own,” namely Hamito (Egyptian) and Semitic (Hebrew).

Interestingly, the word, ‘*nostratic*,’ is taken from the Latin word *nostras*, meaning “our own countrymen” (p. 80). Yes, the Semites (he says) are our own countrymen, because both language streams indicate a common origin in their very root structure.

The question is, how on earth could the Celtic and Anglo-Saxon people of Britain exhibit language characteristics similar to both Hebrew and Egyptian? The most logical explanation is that the ancestors of those same Celts and Anglo-Saxons were themselves Hebrews who escaped from their captivity in Egypt in ancient times. Israel’s own history book – the Bible – confirms that the ancient Israelites spent a

considerable time in Egyptian bondage and consequently would have acquired a solid mixture of both Egyptian and Hebrew in their vocabulary.

Thus the mystery, as to why the root structure of modern day English shows a clear Egyptian and Hebrew origin, is solved. This also explains why some 22,000-plus words in the English language are clearly borrowed from Hebrew originals. Going by the above facts it does appear that there are considerable grounds for believing that the English-speaking peoples have indeed descended from Abraham.

A Common Language is prima facie evidence of a Common Lineage!

At this point the sceptic may well ask, “What relevance does all this talk of language really have?” James Cowles Pritchard was considered to be the most famous language expert of the 19th Century. In fact today he is considered the ‘founder of modern anthropology.’ This same Pritchard said:

“A common language is prima facie evidence in favour of a common lineage—Language is one of those signs of community of origin which is slow to be abolished – slower than most others.” (*Eastern Origins of the Celtic Nations*, 1857)

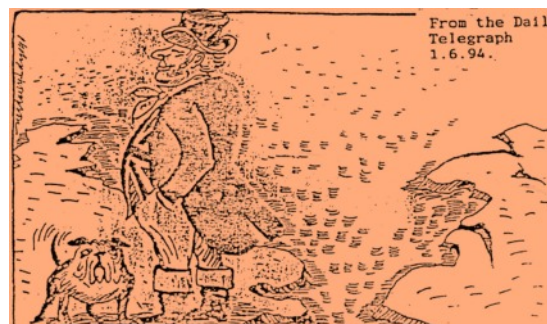

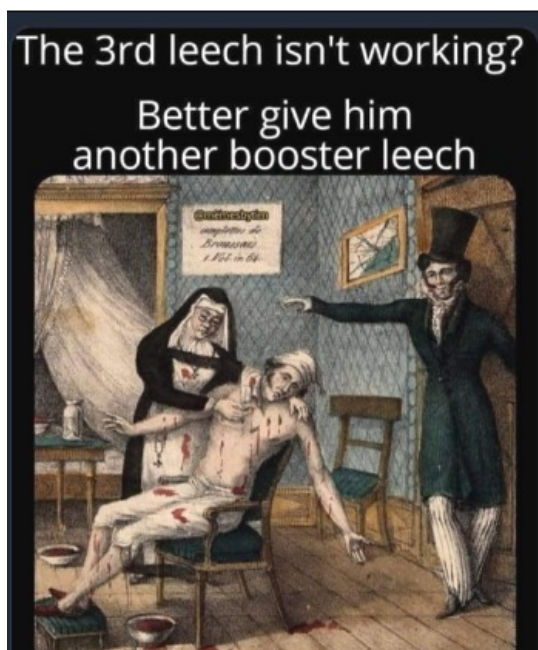

Sevastopol Plague Riot 1830

Sir___, The commandant of Sevastopol, Lieutenant-General A. P. Turchaninov, who by a court decision "for cowardice and for the committed violation of all duties in the service" was stripped of all ranks and awards and demoted to the rank and file.

The plague riot in Sevastopol is a popular uprising on June 3, 1830, in Sevastopol, provoked by quarantine measures against the spread of the cholera epidemic, which was initially mistaken for the plague. It became the first in the chain of cholera riots of 1830-1831

Background Insurrection

In March 1830, the quarantine was tightened and residents were forbidden to leave their homes. The ban was lifted in May, but the quarantine in the poorest Korabelnaya Sloboda was extended by 7 days.

However, after 7 days, the inhabitants of the settlement were ordered to be taken out of the city and quarantined to be extended for 2 weeks. This caused indignation among the inhabitants of the settlement, as well as sailors who had relatives and friends there. The population refused to carry out the order despite the persuasion of Rear Admiral I. S. Skalovsky and

Archpriest Sofrony Gavrilov. The quarantine cordon of the settlement was reinforced by 2 infantry battalions.

Desperate residents prepared for armed resistance, armed groups were formed under the leadership of retired military personnel.

The cordon soldiers and many officers sympathized with the residents. Both sides refrained from starting hostilities that could blow up the situation in the city and in the navy.

On June 3, the military governor Stolypin, taking into account the emergency situation in the city, strengthened the guard on the streets and the guards of the governor's house. These measures angered the Sevastopol residents, who marched in droves to the governor's house and the admiralty.

The governor was killed by the mob. The sailors joined the rebels. Part of the rebels went to remove the quarantine cordon at Korabelnaya Sloboda, the soldiers attacked from both sides joined the rebels. By 22 o'clock the city was in the hands of the rebels, the police fled from the city, and the garrison refused to suppress the riot.

The crowd beat up the "plague" officials and officers, demanding a receipt from them that there was no plague in the city, and smashed their houses and apartments.

On June 4, the commandant of the city of Turchaninov, who was acting as military governor after Stolypin's death, under pressure from the rebels, issued an order to end the quarantine: I announce to all residents of the city

of Sevastopol that the internal quarantine line in the city has been lifted, residents have unhindered communication with each other, services are allowed in churches, and the chain around the city from the current institution has been moved further two miles.

Meanwhile, the authorities pulled units of the 12th division of General Timofeev to the city, which entered the city on June 7. The Commission of Inquiry under the leadership of the Governor-General of Novorossiya and Bessarabia M.S.Vorontsov examined the cases of about 6,000 people. 7 people who led the uprising were executed, about 1000 townspeople and sailors were sent to hard labor.

About 4,200 civilians were deported to other cities. The officers received disciplinary punishments. **Yours truly, K. H., West Midlands, UK.**

PERHAPS THE ONLY WEAPON that 'we, the people' have at our disposal in the face of the totalitarian system being forced upon us in these dark times, is absolute and total non-compliance and non-violent defiance of the current rules on mask wearing, movements and social interaction.

These 'rules' (significantly not laws, although they are presented as such) are allegedly there for our protection and to curb the spread of an alleged, yet non-existent virus

Dr Lorraine Day – [The Germ & Virus Theory & The inversion of truth](#) which we are falsely led to believe will result in many, many deaths unless we consent to obey their draconian lockdowns and severe restriction of our inalienable right to freedom of movement.

But what do I mean by 'non-compliance' precisely?

Peaceful non-compliance is simply:

- **Refusing to wear masks where designated as compulsory.**
- **Driving to wherever you choose, whenever you choose.**
- **Visiting friends or relatives whenever you choose.**
- **Congregating in whatever numbers you choose.**
- **Opening your own businesses whenever you wish.**

This of course will necessitate some of us dealing with the spectre of false arrest by the police or a government enforcement officer of some description.

To guard against this eventuality it would be wise to be fully prepared. To this end it would be advisable to familiarise yourself with the process outlined below.

You may still be unlawfully arrested in the very worst case scenario, but this is usually sufficient to deter that outcome.

Common Law is the ‘real’ law of the land and not the fake ‘maritime’ and corporate law that they use against us to further their own nefarious ends and to control us illegally.



They are only able to make an arrest without a warrant if there is evidence you have committed a Common Law offence. This in effect therefore means that we cannot be arrested for breaking Covid ‘rules.’

So, record all encounters with enforcers (police or others purporting to have the authority to order you to comply with their wishes).

Always answer any question with another question. **DO NOT** give your name or any form of **ID** or directly answer any question. If the enforcer does not answer, simply say; “with respect, please answer the question” and then ask it again. Example below—

You – “Do you need any assistance, officer?”

Them – “Where are you going?” / “What is your reason for being here?” / “What is your name?” / “Can I see some ID?” Etc.

You – “With the up most respect officer, am I obliged to contract with you today?”

The answer is actually ‘no!’ although they may not fully comprehend what you are asking or flatly refuse to answer.

If they say ‘no you are not,’ then great! Reply; “That is correct, and I don’t wish to contract with you today, so am I free to go?” and leave if they allow it.

If they will not answer, try this questioning tactic three times after which you can answer for them, explaining that you are not obliged to contract with them and you do not wish to contract with

them so you will be leaving now! If they then attempt to entrap you by suggesting you are obstructing them, or if they cite any supposed law you are in breach of such as Covid regulations (which are Acts, statutes, legislation, etc., **Not** laws) or that they have reason to believe that you may have committed a crime and you must identify yourself etc., simply state:

You – “**Officer(s) Please Take Notice:** I am **Not** refusing your request to contract/disclose my private information – I simply require proof of Claim. Your offer to do business is returned and any attempt to create joinder, construe consent through performance or lack thereof is refuted and denied – no permission is granted.”

“You are now being **Served** and put on **Notice** with this lawful and binding **Notice** of Conditional Acceptance of your offer.”

“Please now provide me with your name(s), number(s) and indemnity insurance number(s) as you are lawfully required to do.”

In the very unlikely event that you are arrested, make the arresting officer aware that you do not comply or consent and that you are submitting under duress, and state they will be presented with a formal complaint and claims for damages, effected in their private capacity as an individual and not as a police officer.

At the station, do not comply, do not consent to any of the procedures such as fingerprinting, but if they are forced upon you state, “I am submitting under duress” and say nothing else.

They will likely attempt to coerce and scare you into complying with their requests, **Do Not** acquiesce! They can only hold you for up to 24 hours without charge and they have no-one to charge as you have not provided them with a legal fiction/name and accompanying trust account to attach charges to/extort currency from, to pay for your lodgings while they hold you in custody.

They will have no choice other than to release you without charge and your stay has just cost them money, so thank them for it and leave knowing that you can now pursue the arresting officers within their private capacity for the damages, harm, and loss you have endured. Likely assault, battery, kidnapping, potentially

forced commercial intercourse, your time, emotional distress and so on.

between corporations, (**Not** living men and women) and should be treated as such.

You may wish to state that-- “Under the protection of Magna Carta 2020, you are hereby notified that everything you say or do will be used as evidence against you in a Common Law court, where you will be charged with crimes ancillary to fraud, treason and genocide, should you choose not to immediately cease and desist in your unlawful aggression against the people.”

Without standing surety to, or identifying as, the legal fiction (your legal name/ID) they cannot interact with you and their ‘laws’ therefore **Do Not** apply to you!

The Earth’s Electric Envelope Part 3 Arthur Firstenberg



deliberately alter the earth’s electromagnetic environment—efforts that have culminated, today, in the operation of Project HAARP, located in Gakona, Alaska (left).

Under contract with the Office of Naval Research, scientists at Stanford University’s Radioscience Laboratory had built a 100-kilowatt VLF transmitter at Siple Station, Antarctica, broadcasting in the 1.5 to 16 kHz range.

IN THE EARLY 1970'S, ATMOSPHERIC PHYSICISTS FINALLY WOKE UP TO THE FACT that the earth’s magnetic field was highly disturbed. Not all of those whistlers, hiss, chorus, lion roars, and other colourful sounds they had been listening to for half a century were caused by nature! This discovery came about as a result of efforts to

The purposes of the 13-mile-long antenna that stretched over the frozen ice, according to Robert Helliwell, one of the members of the Stanford team, included “control of the ionosphere, control of the radiation belts and new methods of v.l.f. and u.l.f. communication.” It had been discovered accidentally in 1958 that VLF transmissions originating on the earth interact with particles in the magnetosphere, stimulating them

to emit new VLF waves, which can then be received at the opposite end of the earth.

The purpose of the Stanford project was to do this deliberately—to inject sufficient quantities of very low frequency energy into the magnetosphere so that it would not only trigger new waves, but that these triggered waves might in turn cause electrons to rain out of the earth’s radiation belts into the atmosphere, altering the properties of the ionosphere for military purposes.

Biohazards of Extremely Low Frequencies (ELF)

A primary goal of the Department of Defence was to devise a method of stimulating the ionosphere to emit VLF (very low frequency), ELF (extra low frequency), or even ULF (ultra low frequency) waves in order to communicate with submarines submerged beneath the oceans. The VLF transmitter at Siple, and a VLF receiver in northern Quebec, at Roberval, were part of this early research.

The data they collected were surprising. First, the signal received in Quebec, immediately after transmission from Antarctica, was larger than expected.

The waves broadcast from Antarctica were not only triggering new emissions from particles in the magnetosphere, but were being amplified more than a thousandfold in the magnetosphere before returning to earth and being received in Quebec.

Only half a watt of broadcast power was required in order to be detected near the opposite pole of the earth after being relayed from the magnetosphere.

The second surprise was that Roberval was receiving frequencies that were unrelated to the frequencies that originated at Siple, but that were instead multiples of 60 Hz. The Siple signal had been altered, on its journey through outer space, to bear the imprint of the electric power grid.

Since those first discoveries, scientists have learned a great deal about this form of pollution, now known as “power line harmonic radiation.”

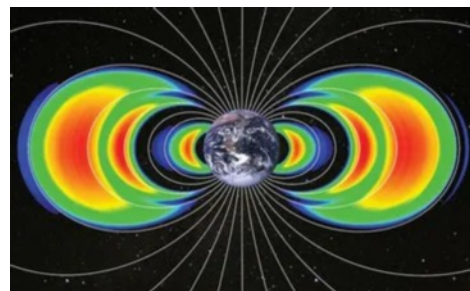
It appears that harmonics from all of the world’s power grids leak continuously into the magnetosphere, where they are greatly amplified as they bounce back and forth between the northern and southern hemisphere, generating their own rising and falling whistlers just like radiation from lightning.

But there is a fundamental difference. Before 1889, whistlers and other lightning-triggered sounds played continuously over the entire range of the terrestrial instrument. Today the music is stilted, dulled, often confined to multiples of 50 or 60 Hz. Every component of the natural symphony has been radically altered.

The “dawn chorus” is quieter on Sundays than on other days of the week, and the starting frequencies of most chorus emissions are power line harmonics. “It seems likely that the entire hiss band is caused by power line radiation,” wrote Helliwell in 1975.

And the natural, slow pulsations of the earth’s magnetic field, below 1 Hz, which are also important to all life, are strongest on weekends, evidently because they are being suppressed by radiation from the power grid, and this radiation is stronger on week days.

Antony Fraser-Smith, also at Stanford, by analysing geomagnetic activity data collected since 1868, showed that this is not a new phenomenon but has been happening since the first use of alternating current, and has been increasing over time. Data collected between 1958 and 1992 showed that Pc 1 activity, representing geomagnetic pulsations between 0.2 and 5 Hz, has been fifteen to twenty percent greater on weekends than in the middle of the week.



The structure of the Van Allen radiation belts seems also to have been altered. What the Department of Defence had wanted to do intentionally was apparently already being done massively by the world’s electric power grids.

Why, physicists had long wondered, are there two electron-filled radiation belts around the earth, an inner and an outer, separated by a layer that is virtually empty of electrons?

This “electron slot,” some think, is continually drained of its electrons by their interaction with radiation from power lines. These electrons, in turn, rain down over the earth, modifying the electrical properties of the atmosphere. Not only may this increase the frequency of thunder storms, but it may shift the values of the Schumann resonances to which all living things are attuned.

In short, the electromagnetic environment of the entire earth is radically different today from what it was before 1889. Satellite observations show that radiation originating from power lines often overwhelms natural radiation from lightning.



Power line radiation is so intense that atmospheric scientists lament their inability to do fundamental research: there is almost nowhere left on earth, or even in space, where a VLF receiver can be used to study natural phenomena.

Under natural conditions, as they existed before 1889, intense VLF activity, leading to electron rain and the shifting of the Schumann resonances, occurred only during geomagnetic storms. Today, the magnetic storm never ends.

Influenza

If the atmosphere is, at times, electrified beyond the degree which is usual, and necessary to preserve the body in a due state of excitement, the nerves must be too highly excited, and under a continued operation of undue stimulus, become extremely irritable, and subject to debility.

Noah Webster, *A Brief History of Epidemic and Pestilential Diseases*, 1799, p. 38

A large, rapid, qualitative change in the earth’s electromagnetic environment has occurred six times in history.

In 1889, power line harmonic radiation began. From that year forward the earth’s magnetic field bore the imprint of power line frequencies and their harmonics.

In that year, exactly, the natural magnetic activity of the earth began to be suppressed. This has affected all life on earth. The power line age was ushered in by the 1889 pandemic of influenza.

In 1918, the radio era began. It began with the building of hundreds of powerful radio stations at LF and VLF frequencies, the frequencies guaranteed to most alter the magnetosphere. The radio era was ushered in by the Spanish influenza pandemic of 1918.

In 1957, the radar era began. It began with the building of hundreds of powerful early warning radar stations that littered the high latitudes of the northern hemisphere, hurling millions of watts of microwave energy skyward.

Low-frequency components of these waves rode on magnetic field lines to the southern hemisphere, polluting it as well. The radar era was ushered in by the Asian flu pandemic of 1957.

In 1968, the satellite era began. It began with the launch of dozens of satellites whose broadcast power was relatively weak.

But since they were already in the magnetosphere, they had as big an effect on it as the small amount of radiation that managed to enter it from sources on the ground. The satellite era was ushered in by the Hong Kong flu pandemic of 1968.

The other two mileposts of technology—the beginning of the wireless era and the activation of the High Frequency Active Auroral Research Program (HAARP)—belong to very recent times and will be discussed later in this book.

The Fall Of The Mainstream Media And The Biggest Lies They Told In 2021

IF THE PAST YEAR HAS CONFIRMED ANYTHING it is that the mainstream media is thoroughly dishonest. While there have been a few shining examples of independent and mostly unbiased journalism in the MSM, these moments are as rare as Loch Ness Monster sightings and almost as unbelievable. The public has been lied to so consistently that sometimes we ignore legitimate journalism when it pops up because it's safer to assume the media is disingenuous at all times.

I've personally noticed a wash of commercials lately paid for by major legacy media platforms like the New York Times desperately trying to convince the public that they are still relevant. The message is that they are the only "true source" of news information while they beg people to start subscribing and reading their hot garbage once again.

Leftist media is crumbling, with online propaganda peddlers and click-bait prostitutes like BuzzFeed and Vox imploding. The lack of profits is obvious and the layoffs have been aggressive.

These platforms survived for the past few years on tech media hype and venture startup capital,

but the free money has run out and now they don't know what to do. BuzzFeed's scheme was to go public and sell shares, but this plan failed so completely and the company's stock plunged so hard that the event has exposed all other fledgling tech media to wider scrutiny. In other words no one has faith in these outlets, at least not enough to invest in them, and now the veil of their supposed "success" has been lifted. BuzzFeed used to claim they were worth \$1.5 billion; reality revealed they are worth almost nothing.

Legacy media has also seen its audience numbers plummet over the past ten years, but the last year in particular has been especially unkind to them.

ALL of the major corporate news channels saw their audience ratings decline, with CNN seeing the largest drop overall. CNN is facing an epic cut of 68% in its prime time numbers in 2021, while MSNBC now has the smallest prime time audience it has witnessed since 2016.

Fox also dealt with audience declines this year but continues to remain the most watched cable news outlet so far, probably because of the continued popularity of commentators like Tucker Carlson.

Some might blame the loss of election coverage, but it's not as if there hasn't been enough news to hype in 2021. With millions of people still working from home and facing intermittent covid restrictions this year (in blue states), you would think that this would represent a captive audience for the fear machine.

Hell, even YouTube and other social media platforms are forcing MSM content into our faces daily while burying any alternatives. Yet, their numbers are still plunging and audiences are laughing.

YouTube has even removed the "Dislike" button just to protect the corporate media and the White House from the hilarious bombardment of thumbs down they receive on every video. It's

unacceptable for us peasants to have the ability to voice our discontent.

So, where are people turning for their news if not the mainstream? While stats are not as well tracked for independent sources, it is obvious from viewership and subscription numbers that the alternative media is quickly becoming the dominant force in information. My own audience numbers have jumped at least 30% in the past two years alone and this seems to be the trend across the board for conservative and libertarian media. Websites like Social Blade, which tracks YouTube channel stats, support the conclusion that the alternative media is becoming the go-to media.



Why is this happening? It's actually been a long time coming. Mainstream media numbers have been in decline for many years and their audience age brackets have been increasing dramatically. This accelerated after 2016 when the mainstream media mask came off completely and what we now know as the "Culture War" revealed itself.

The migration of audiences is undeniable in entertainment and pop culture media. Mainstream platforms funded by a steady cash flow from the corporate coffers of Disney, Time Warner, Comcast, Viacom, etc, used to reign supreme in entertainment publications.

Moderately sized tech media operations clamoured to remain in the good graces of these corporations in exchange for favours and special access. Now, operations with billions of dollars behind them are being thwarted by low cost do-it-yourself YouTube channels like Geeks And Gamers, The Quartering, Nerdrotic, Clownfish TV, etc.

The bloodletting has been so horrific that social media companies (with a shared agenda) have

partnered with the majors to suppress these types of channels, demonetizing them or erasing them from public view with their algorithms. Alternative channels get so much attention because they offer something people want – An honest opinion and analysis instead of an opinion bought and paid for with corporate dollars.

In the political and social sphere there have been numerous success stories, including Joe Rogan's podcast, Steven Crowder, Ben Shapiro, Blaze TV's 'You Are Here', Tim Pool the list goes on and on. In economic media, outlets like Zero Hedge continue to bring in millions of readers that most other mainstream institutions WISH they had.

To be sure, some of these information sources are still playing catch-up to those of us once considered "conspiracy theorists" a few years ago. That's okay. I'm not saying that there isn't more that could be done. What I'm saying is that there is a revolution happening in how people consume media and at least some truths are getting out there to the normies.

I have been working and publishing within the alternative media for 16 years and I don't think many who are new to the field realize how much Americans have broken free from the mainstream narrative in that time. When I got started, to even dream of the audience numbers we now have was considered naive fantasy. Today I continue to find great hope in the growth of independent journalism.

The fact of the matter is, for decades corporate institutions conned the masses into believing only **THEY** were qualified to act as gatekeepers and guardians of the information bottleneck. Only they were the true "journalists." They have now lost the respect of the public and their gatekeeping is over. On that note, lets examine just a few of the reasons why trust in the mainstream has imploded. Lets look at some of the biggest lies perpetuated by the MSM in 2021...

The Jan 6th "Insurrection"

Probably one of the most fake news stories of the decade. The mainstream media has relentlessly parroted the propaganda that the conservative protest at the Capitol Building on Jan 6th was some kind of planned attempt at a

national takeover and violent coup resulting in multiple deaths. The reality was much less sexy.

The numbers prove Paul Krugman and the MSM utterly wrong. The Mises Institute published a comprehensive article on this based on analysis from the Institute For Energy Research, but I’ll summarize:

The MSM and Paul Krugman argued that the entire incident was caused by Texas’ ill prepared natural gas powered grid and that Wind Turbines had nothing to do with it. By extension, the MSM asserted that this makes any notion of a state like Texas becoming independent from centralized governance and a centralized grid “laughable.” It’s important to note that Krugman offers no real stats to support his arguments. An “economist” should know better.

The truth is that failing wind turbines were indeed the primary source of the power grid decline. Leading up to the winter storm in February, wind turbines were generating around 28% (nearly one third) of Texas power while natural gas was providing 43%.

By the end of the freeze wind power had dropped to 6% while natural gas took up the slack and increased to 65% of the grid. In other words, Krugman either lied, or he was oblivious to the actual stats.

While there were failures in some natural gas plants, the majority of the fault was in federally funded wind power. During the grid down crisis, natural gas lost 7% of its overall output while

the federally funded wind turbines lost 47% output. **This Is a Fact.**

Also keep in mind that power demand in the state skyrocketed at this time breaking all previous records, perhaps because the state population jumped from 29 million to 30 million from the end of 2019 to the beginning of 2021. Millions of people had just transplanted to Texas in a matter of months to escape blue state policies such as high taxes and oppressive covid mandates.

And here is where we find what is likely the core motive behind the media's lies about Texas – The establishment does not want Americans to migrate and congregate to fight against the mandates. Lying about Texas at any opportunity, even during tragedy, reveals their underlying fears.

Fauci's Gain Of Function Research

With the mild Omicron variant now in circulation the death numbers are falling even further. However, there have been fatalities that did not need to happen and Fauci is partly to blame.

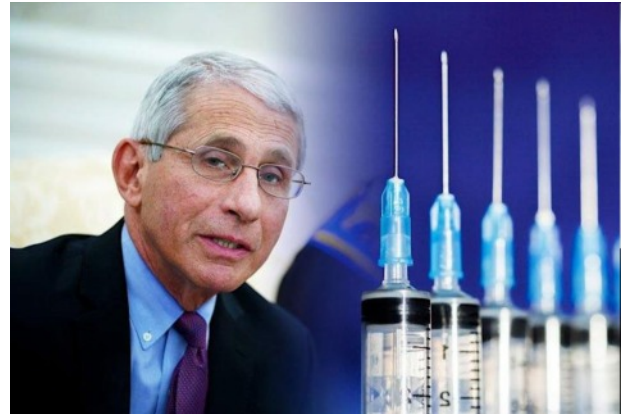
Despite the fact that the largest Level 4 virology lab in Asia is in Wuhan, China right down the street from the epicentre of the Covid-19 outbreak, the mainstream media at the behest of the government and the medical establishment has fought tooth and nail to deny any connection.

If the vaccines actually work, then how is this possible? Conclusion: The vaccines don't work, at least not in the way that pharmaceutical companies initially claimed.

Add to this the fact that people with natural immunity are 13 to 27 times more protected from covid than people who submit to the jab. One has to ask – What is the point of these experimental mRNA vaccines with no long term data to prove their safety?

The UK Dictatorship Takes Shape

SECTION 13 OF THE OSB (ONLINE SAFETY BROADCASTING) SPEAKS OF A DUTY TO PROTECT “content of democratic importance”. However, Section 13 (2) refers to “taking down” democratic content and and sanctioning individual users who share what is presumably the *wrong kind* of democratically important content. Quite obvi-

ously, the UK Government considers some democratic content to be more important than other democratic content.

Section 13 (6) defines “content of democratic importance” as any which is posted by a “news publisher” or “regulated content”, for which the Secretary of State, via the regulator Ofcom, decrees that the content is “specifically intended to contribute to democratic political debate in the United Kingdom”.

This, then, is to be a decision for the Government, not our parliament or our courts, to make. The executive will decide what we are allowed or not allowed to debate on the big social media platforms, which will be the only platforms left on the new, shrunken Internet.



When the Government says “news publisher”, it has its own definition. It means a “recognised news publisher”, which it itself defines in Section 40 as: the public-service broadcasters BBC and *Sianel Pedwar Cymru* (Channel 4 Wales); any licensed broadcaster; or any other media outlet which “meets all of the conditions in subsection (2)”

Subsection 40 (2) rules out independent blogs as having a hope of being “recognised”, because the content must be “created by different persons” for it to be eligible for that distinction. The days of independent journalists reaching a wider audience through their own blogs are ended by the OSB.

To be *recognised* as an independent news provider, certain criteria must be fulfilled. A news organisation like UK Column, which principally publishes “news-related material” created by “different persons”, and which has a registered business address and exercises editorial control, would *appear* to be eligible to qualify as a “recognised news publisher”. Time will tell.

We need to be clear, and to keep in mind, what the intention is here. It is to centralise government control over cyberspace and the information we collectively share.

The Government intends to use secondary legislation (known in other countries as executive orders or extra-parliamentary decrees) to finalise concepts like “news-related material”. It will order what “content of democratic importance” will be “taken down”.

This will be the content which the UK Government chooses to censor, only the most naive could imagine otherwise. They will label it as “disinformation” which will then fall into the category of “content that is harmful to adults” to be removed from the social media platforms and the search results. It doesn’t matter if it is

produced by a “recognised news publisher” or not.

Representatives of the National Union of Journalists and the current press regulator, Impress, **have expressed concern** about the power wielded by the Secretary of State and the social media platforms to determine what does or does not constitute “journalism”. Yet not a single mainstream media journalist or representative body has even vaguely questioned the principle. They accept en masse, apparently without question, that the Government has the right to censor journalism and even free speech.

They do so under the apprehension that *they* will be protected from the discrimination of the UK dictatorship. They are seemingly satisfied that only the so-called alternative media, such as the UK Column, will be silenced. That assumption is misplaced.

The new UK dictatorship is an absolute tyranny. It will not permit dissent from any quarter. It also proposes **Legislation To Counter State Threats**. This, by dressing up officials’ disclosures of abuses as Russo-Chinese interference, will end whistle blowing—and consequently investigative journalism as we understand it.

The UK dictatorship intends to amend existing Official Secrets, counter-espionage and counter-terrorism legislation, although it saw us through two world wars and a Cold War. They will remove the defence of “acting in the public interest” for the disclosure or reporting of any information they deem to be contrary to the national interest, as *they*—not our parliament or our courts—define it.



Journalists like **Julian Assange** (above) and **Craig Murray** have been imprisoned in the UK for daring to cross the *authorities*. A government minister **called** Assange a “miserable little worm” and “**tried to keep the smirk off his face**” after having watched his arrest from an

operations room; a judge told Murray he could not expect to be afforded the protections at law enjoyed by a *regulated* journalist. Unless we act and demand that our MPs stop the march towards a full-blown UK dictatorship, the days of questioning power are over in our former Mother of Representative Democracies.

Bringing this whole raft of legislation together, we can now see how the UK dictatorship will function.

The UK Dictatorship Model

The *Global Public-Private Partnership* will set the policy agenda as it exercises *global governance*. The UK Government, like others around the world, is the G3P's implementation and enforcement partner. It is the Government's role to convert the G3P policy agendas into hard policy and legislation at both the national and local level.

Under the proposed Police, Crimes, Sentencing and Courts Act, you will not be able to protest against the manifestation of the G3P's will ("government policy"). The **only protests that will be permitted** will be those orchestrated by organisations which broadly support the G3P objectives, such as Extinction Rebellion and Insulate Britain.

Under the Online Safety Act, you won't be able to challenge the dictatorship online either. Those who are willing to question power, primarily the alternative media and their audience, will not be permitted to post their material on the big social media platforms and their content will be cut out of the search results—as will the content of any journalist, be they mainstream media-affiliated or not, if they fall foul of the intended legislation

to counter state threats. Imprisonment for questioning the G3P is a distinct possibility.

The operatives of the state dictatorship are free to commit any crime the dictatorship authorises, under the Covert Human Intelligence Sources (Criminal Conduct) Act. Dissenters who slip through the surveillance grid can be "**fitted up**" or otherwise done away with.

Currently, the Government enjoys supreme executive power, thanks to the Coronavirus Act and to its ploy of using **secondary legislation** to manipulate the laws previously rubber-stamped by their parliamentary colleagues. There is little to no parliamentary political opposition in the UK, and it has become effectively a one-party state.

Voting Red or Blue, Green or Yellow will change nothing. MPs are either ignorant, willing, or uninterested puppets and are content for the legislative basis of the UK dictatorship to evolve. As a group, they are almost entirely complicit and have offered virtually no resistance to the removal of representative democracy.

At this stage, all we can do is demand that our MPs stop the slide towards what is obviously a UK dictatorship. We should all write to our local MP and politely but firmly insist that they do not vote to allow the formation of a dictatorship to proceed.

Beyond that, our only lawful recourse is that we fiercely defend our individual sovereignty, refusing to comply with the diktats of the tyranny. We must use any and every peaceable means to reject the authority that the UK dictatorship has arrogated to itself.

The English Revolution By John Hammer



THERE IS OF COURSE NO DISPUTE THAT KING CHARLES I OF ENGLAND WAS EXECUTED by being beheaded at the scaffold erected outside the Guildhall in the City of London in January 1649.

However, the events that led to his execution, as is often the case with many historical events have been twisted to fit the sanitised version of history that is always presented to the

masses by our ruling Elite, in order to conceal the real truth.



“It was fated that England should be the first of a series of Revolutions, which is not yet finished.” Isaac Disraeli, father of Benjamin Disraeli (above), former British Prime Minister, 1851

In London in the latter years of the decade of the 1630's, immediately prior to the English Revolution now more expediently known as the 'English Civil War', there were many minor, armed uprisings of the 'people', usually involving the same ringleaders and 'agents provocateurs', as is often the case today. These armed 'mobs' caused panic and fear in the streets wherever they went, including the sometimes-violent intimidation they inflicted upon members of both houses of Parliament.

This in fact was a very similar modus operandus as that employed by the 'Sacred Bands' and the 'Marseillaise' of the French revolution 150 years later. Indeed, the striking similarities between the two events are most noteworthy.

There were illegal print operations being instigated all around the city, producing inflammatory leaflets inciting the good citizens of London to revolt against the ruling powers that be.

This period of unrest led directly to the conflict between 'the people' or in effect Parliament and the Monarchy, that was to be the defining attribute of the English Revolution or the Civil War as it is more commonly and yet misleadingly called. So who was behind this

movement that was to culminate in the 'legalised' murder of the reigning British monarch and the abolition of the monarchy for a period of eleven years which came to be known as the 'Commonwealth' at the time and later, the 'Interregnum'?

Within the pages of works such as the 'Jewish Encyclopaedia' and 'The Jews and Modern Capitalism', it is possible to discern that at this time, Oliver Cromwell, the prime-mover behind the conflict was in constant contact with and actually being financed by the powerful Jewish/Dutch bankers behind the Bank of Amsterdam scam that in effect usurped the control of currency issuance from the Dutch government in the early seventeenth century.

Through such figures as Manasseh ben Israel and Fernandez Carvajal, both prominent Jews of the times, the whole of the English Revolution was funded. Carvajal himself was the paymaster of the entire 'New Model Army' or the 'Roundheads', as Cromwell's fighting forces were disparagingly named as a direct result of the round metal helmets they wore.

In the 12th century, some 500 years prior to the English Revolution, all Jews had been summarily expelled from England for various reasons but primarily because of their general propensity for usury, the lending of money at interest which at the time was totally contrary to the fundamental tenets of Christianity.

In the January of 1642, the attempted arrest of five Members of Parliament, had led to even more extreme mob violence and subsequently to the King and the royal family leaving their palace at Whitehall for security reasons. The five MPs backed by the mobs returned in triumph to Westminster and thus was the stage now set for the Jews to make their moves using none other than Cromwell himself to front their movement.

“1643 brought a large contingent of Jews to England; their rallying point was the house of the Portuguese Ambassador de Souza, a Marrano Jew. Prominent among them was Fernandez Carvajal, a great financier and army contractor.” Excerpt from *'The Jews of England'* The actual bloodshed and open warfare between the two factions began in earnest at the Battle of Edgehill, Warwickshire later that year in 1642

where a contingent of Royalist troops commanded by Prince Rupert, a nephew of King Charles, fought against a Parliamentary army commanded by Cromwell.

The outcome of this battle was totally inconclusive, both sides subsequently claiming victory and over the course of the next several years, a series of major battles and minor skirmishes took place at such locations as for example, Marston Moor, Oxford, Worcester, Newbury and finally Naseby amidst much bloodshed in an ongoing conflict that often pitted father against son and brother against brother in an attempt to gain ultimate supremacy by each of the respective 'sides'.



Eventually after years of attrition, it was Parliament who emerged as victor following the Battle of Naseby. Charles was taken prisoner and remained under house arrest at Holmby House (above) in Oxfordshire awaiting a decision on his fate which at the time was fully expected to be no more serious than foreign exile, a fate befalling many a defeated 'royal' in the past. However, in June 1647, things were about to take a major turn for the worse for Charles.

On 4th June 1647, Cornet Joyce, acting on secret orders from Cromwell himself and unknown even to General Fairfax, Cromwell's army chief of staff, descended upon Holmby House with 500 picked revolutionary troopers and seized the King.

According to Isaac Disraeli— "The plan was arranged on May 30th at a secret meeting held at Cromwell's house, though later Cromwell pretended that it was without his concurrence."

This move coincided with a sudden development in the army; the rise of the 'Levellers' and

'Rationalists' whose doctrines were identical in almost every facet to those of the French revolutionaries in the 1780's and 1790's. In fact, they were identical in most aspects to what is now known today as 'Communism'.

These were the infamous regicides, the King-killers, who 'purged' Parliament until there were only 50 members remaining, all 'communist-like' themselves and who were ultimately responsible for Charles' execution around eighteen months subsequently. This was the Parliament that came to be known colloquially as the 'Rump Parliament'.

However, back to the main story; in constant collusion with his Jewish benefactors throughout the duration of the war, Cromwell wrote to them again at Mulheim Synagogue in Holland in a letter received by them on the 16th June 1647—

"In return for further financial support will advocate admission of Jews to England: This however impossible while Charles living. Charles cannot be executed without trial on adequate grounds which do not at present exist. Therefore advise that Charles be assassinated, but have nothing to do with arrangements for procuring an assassin, though willing to help in his escape."

To which the following reply was sent to Cromwell on the 12th July 1647—

"Will grant financial aid as soon as Charles removed and Jews admitted. Assassination too dangerous. Charles shall be given opportunity to escape. His recapture will make trial and execution possible. The support will be liberal, but useless to discuss terms until trial commences."

The source of this dialogue was a weekly review, 'Plain English' published by the 'North British Publishing Co.' and edited by Lord Alfred Douglas, in 1921.

And so it duly came to pass that on the 12th of November 1647—Charles was 'allowed' an

opportunity to escape in order to bring the plan to fruition and he duly absconded to the Isle of Wight, to where he was followed and quickly recaptured by Cromwell's men.

“Contemporary historians have decided that the King from the day of his deportation from Holmby to his escape to the Isle of Wight was throughout the dupe of Cromwell.”

Now all that remained at this time to complete the blood-bargain was to stage the ‘show trial’ of Charles and sentence him to death and the Jews would have attained their goal of being allowed to officially set foot on English soil for the first time in almost 500 years.

It soon became apparent that even though the members of the ‘Rump’ who were allowed to remain in situ in Parliament, were broadly speaking anti-monarchists, most were still nevertheless in favour of a peaceful and amicable settlement with the king.

On 5th December 1647, the house sat through the night in debate and finally carried the motion ‘that the king’s concessions were satisfactory to a settlement’.



This of course was unacceptable to Cromwell (Above) and his plans for the Jews, not to mention his own bank balance and so he arranged for yet another ‘purge’ of the house, this time undertaken by one of his army officers, Colonel Pride in an action which has subsequently come to be known to history as ‘Pride’s Purge’, on the 6th December 1647.

And then on the 4th January 1648 the remaining 50 members of the house finally invested themselves with the supreme power required to usurp the role of the king.

However, Algernon Sidney warned Cromwell that—

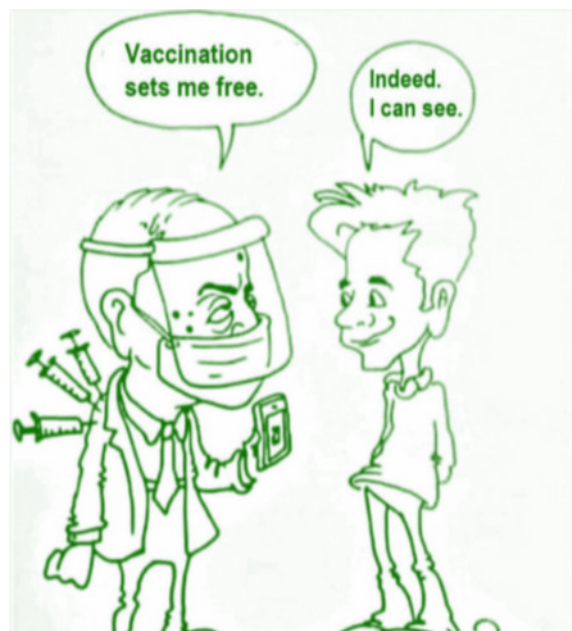
“First, the King can be tried by no court. Second, no man can be tried by this court.” And further added that-- “—no English lawyer could be found to draw up the charge, which was eventually entrusted to an accommodating alien, Isaac Dorislaus.”

It is probably superfluous to reason for me to report that Isaac Dorislaus was exactly the same ‘type’ of alien as Carvajal and Manasseh Ben Israel and the other financiers who paid Cromwell his blood-money.

And so were the Jews thus permitted once again to live freely in England despite protests by the masses (who were of course ignorant of all the background machinations) and by the sub-committee of the Council of State which declared them to be-- “—a grave menace to the State and the Christian religion”.

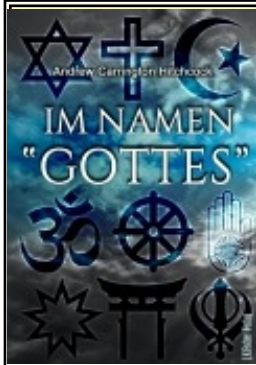

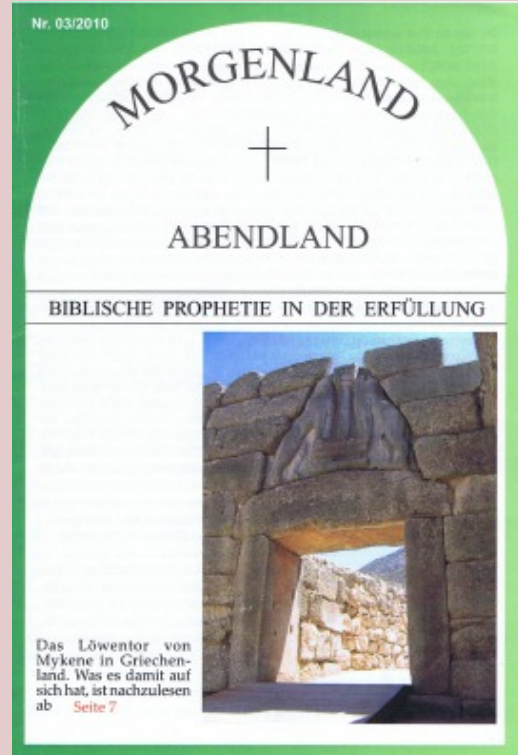
