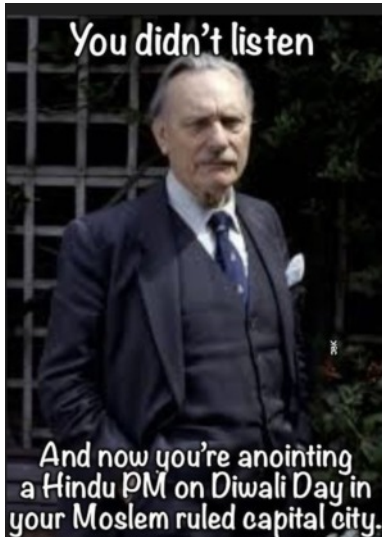

## The Enmity, Part 6: The Clash of the Bloodlines (3)

**T**HE RACIAL DESCENT LAWS HAD TO APPLY OR JESUS COULD NOT HAVE BEEN BORN! SO, WHOM ARE YOU GOING TO BELIEVE, THE BIBLE OR A RABBI?

Here is the whole prophecy from Jeremiah, Chapter 24, giving us the distinction between the good figs and the evil figs:

*“Thus sayeth Yahweh, the God of Israel; Like these good figs, so will I acknowledge them that are carried away captive of Judah, whom I have sent out of this place into the land of Chaldea [Babylon], for their good.*

*For I will set mine eyes upon them for good, and I will bring them again to this land: and I will build them, and not pull them down; and I will plant them, and not pluck them up.*

*And I will give them an heart to know me, that I am Yahweh: and they shall be my people, and I will be their God: for they shall return to me with their whole heart.”* (Vs. 5-7)

In complete fulfilment of this prophecy, Ezra and Jeremiah re-established the racial laws forbidding intermarriage.

They found the old Jerusalem books of genealogy (Neh. Chapter 7) and threw out of the congregation all of those who could not verify their 100% Judahite lineage!

Does this square with what Capt and Rand teach?

No, it does not. Rabbi Wise’s statement is calculated to deceive in five ways:

- 1.) It presumes an identity between Judahites and Jews.
- 2.) It creates a plausible yet false scenario for the change from Hebrewism (the Law of Moses) to Judaism (Talmudism).
- 3.) Contrary to what he says, the Talmud was Not adopted by those who returned. The Bible teaches otherwise. Here, Rabbi Wise is attaching a false sense of antiquity to Judaism. Judaism was started by the scribes and Pharisees.



### The Pharisees

The sect of the Pharisees did not appear in history until the merger of Judah and Idumea in 150 B.C. This merger was accomplished by virtue of the anti-Mosaic decree of King John Hyrcanus of Judah. The resulting nation of mixed multitude came to be known as “Judea.”

4.) The Talmud, the written version of the oral traditions and teachings of the Pharisees, was not encoded until 500 A.D.

5.) Hebrewism never died. It was restored and energized by Ezra and Nehemiah. It was subsequently defended by the Maccabees; and it was kept alive by the early Christians, and it is today known as Christian Identity.

It is imperative that we understand our true history in order to determine exactly where and when the Jewish heresy began to displace the Mosaic Law.

**Consequently, it is an anachronism to refer to any Judahites before 150 B.C. as Jews!** They were Judahites who practiced the Mosaic Law. They were not mamzers who practiced Talmudic Judaism!

I cannot stress these distinctions enough. It is imperative that we understand the cultural, racial, historical and religious distinctions between Judahites and Jews. I hope this analysis is sufficiently clear so that we can recognize how the Jews have created a false history for themselves so as to confuse even our most erudite scholars, such as Capt and Rand.

Here are the historical facts: The Pharisees are the originators of the religion known as Judaism. As usurpers later empowered by King Herod, who was an Idumean/Edomite put in place by the Roman authorities over the people of Judah, who were **Not His Racial Kin**, the Pharisees began to infiltrate the priesthood of Judah at all levels.



The historian, Josephus (who was not a Jew but a Judahite whose family was of the first of the 24 courses!), tells us that, with regard to the ruling priesthood, Herod had all of the racial Judahites murdered and replaced with Edomites!

## Identity Lite

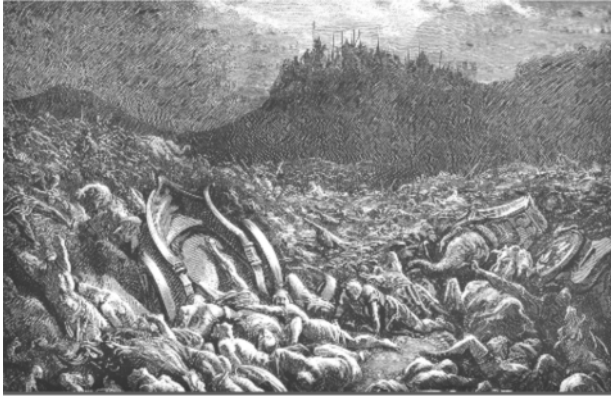
“Identity Lite” is the name I have given to those members of Christian Identity who downplay the race issue. The very word, ‘Identity’, means that we identify with Israel of the Bible.

I fear that there are those in CI today who are trying to appear "non-racist." There is no possibility that CI will go mainstream. CI is biblically mandated separatism.

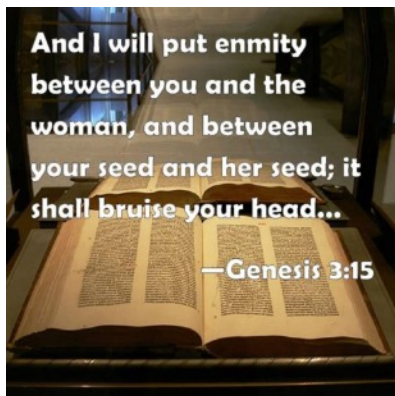

### The Judeo-Christian View of The Original Sin

Some of the major objections the anti-seedliners have to our scholarship consist of the following:



## Literal Versus Figurative Interpretation of Genesis 3:15.

- 3.) Two-Seedliners quote the Talmud in order to document the fact that Eve was sexually seduced by the Serpent.

## Old Testament “Word for Word” Exodus Part 10 Translation by Stephen Howard Anderson



### Chapter 14

1. Spoke Yahweh to Mosheh, saying,
2. “**Speak to the children of Yis’rael, that they turn and encamp before Piy ha Chiroth 6367, between Migdol 4024 and the sea, over against Baal-Tsephon 1189: before it you shall encamp by the sea.**
3. **Because Par’oh will say of the children of Yis’rael, ‘They are entangled in the land, the wilderness has shut them in.’**

**4. And I will strengthen Par'oh's heart, so that he shall follow after them; and I will be honored 3513 upon Par'oh, and upon all his army 2428; so that the Mits'rayim may know that I am Yahweh."** And did they so.

5. And told was the king of Mits'rayim that the people fled: and the heart of Par'oh and of his servants was turned against the people, and they said, "Why have we done this, that we have let Yis'rael go from serving us?"

6. And made ready he his chariot 7393, and took his people with him:

7. and took he six hundred chosen 977 chariots, and all the chariots of Mits'rayim, and captains 7991 over every one of them.

8. And strengthened Yahweh the heart of Par'oh king of Mits'rayim, and pursued 7291 he after the children of Yis'rael: and the children of Yis'rael went out with a high hand.

9. But pursued the Mits'rayim after them, all the horses and chariots of Par'oh, and his horsemen 6571, and his army 2428, and overtook 5381 them encamping by the sea, besides Piy ha-Chiyroth, before Baal-Tsephon.

10. And when came near Par'oh, the children of Yis'rael lifted up their eyes, and behold, marched the Mits'rayim after them; and they were very afraid: and the children of Yis'rael cried out 6817 to Yahweh.

11. And said they to Mosheh, "Because there were no graves in Mits'rayim, have you taken us away 3947 to die in the wilderness? Why have you dealt with us this way, to go forth from Mits'rayim?"

12. Is this not the word that we told you in Mits'rayim, saying, 'Let us alone, so that we may serve the Mits'rayim'? Because it would have been better for us to serve the Mits'rayim than to be put to death in the wilderness!"

13. And said Mosheh to the people, "Fear not, stand still 3320, and see the salvation 3444 of Yahweh, which he will show you today: because the Mits'rayim whom you have seen today, you shall see no more until everlasting 5759.

14. Yahweh shall fight 3898 for you, and you shall keep silent 2790!"

15. And said Yahweh to Mosheh, "For what reason do you cry to Me? Speak to the children of Yis'rael, so they will go forward:



**16. But lift up the rod, and stretch out your hand over the sea, and divide 1234 it: and the children of Yis'rael shall go on dry ground 3004 through the midst of the sea.**

**17. And I, behold, I will strengthen the hearts of the Mits'rayim, and they shall follow them: and I will get Me honor 3513 upon Par'oh, and upon all his army, upon his chariots, and upon his horsemen."**

**18. And shall know the Mits'rayim that I am Yahweh, when I have gotten Me honor upon Par'oh, upon his chariots, and upon his horsemen."**

19. And moved the messenger of Elohiym, which went before the camp of Yis'rael, and went behind them; and went the pillar of the cloud from before their face, and stood behind them:

20. and came it between the camp of the Mits'rayim and the camp of Yis'rael; and it was a cloud of darkness 2822 to them, but it gave light by night to these: so that the one did not come near the other all the night.

21. And stretched out Mosheh his hand over the sea; and caused Yahweh the sea to go back by a strong east wind all that night, and made the sea dry land 2724, and the waters were divided.

22. And went the children of Yis'rael into the midst of the sea upon the dry ground: and the waters were a wall to them on the right hand and on their left.

23. And pursued the Mits'rayim, and went in after them to the midst of the sea, even all Par'oh's horses, his chariots, and his horsemen.

24. And it came to be, that in the morning watch, looked Yahweh into the army of the Mits'rayim through the pillar of fire and of the cloud, and confused 2000 the army of the Mits'rayim,

25. and took off their chariot wheels, so that they were heavy to drive; so that said the Mits'rayim, "Let us flee from the presence of Yis'rael; because fights Yahweh for them against the Mits'rayim!"

26. And said Yahweh to Mosheh, "**Stretch out your hand over the sea, so that the waters may turn back upon the Mits'rayim, upon their chariots, and upon their horsemen.**"

27. And stretched forth Mosheh his hand over the sea, and returned the sea to its permanence 386 when the morning appeared; and fled the Mits'rayim away from it; and tumbled about 5287 Yahweh the Mits'rayim in the midst of the sea.

28. And returned the waters, and covered the chariots and the horsemen, and all the army of Par'oh that came into the sea after them; there remained not so much as one of them.

29. But the children of Yis'rael walked upon dry land in the midst of the sea; and the waters were a wall to them on their right hand and upon their left.

30. Thus saved Yahweh Yis'rael that day from the hand of the Mits'rayim; and saw Yis'rael the Mits'rayim dead upon the sea shore.

31. And saw Yis'rael that great work which did Yahweh upon the Mits'rayim: and the people feared 3372 Yahweh, and believed Yahweh, and His servant Mosheh.

## Chapter 14 Notes

Yahweh basically sets up Par'oh to be used as an example of what happens when a powerful king dares to oppose Yahweh. He has Yis'rael camp by the sea in plain sight, and appear to be trapped against it.

When Par'oh's great army arrives, Yahweh puts the pillar of cloud/fire between them and Yis'rael, separating and protecting His chosen people.

He has Mosheh hold out his hand toward the sea, which is the Sea of Reeds, and Yahweh splits the sea with a wind, and also dries out the ground so Yis'rael may walk through on it in plain sight of Par'oh and his army. Yis'rael had been so mentally beaten down that they were still afraid, and Mosheh tells them to stand still and be quiet. When the process with the sea is complete, he is told to take them across. After a while, Par'oh sends the army after them, but Yahweh again has Mosheh stretch out his hand, and the sea collapses on Par'oh's army, while Yis'rael continues on to the other side.

Yis'rael then looks back, and they see all the drowned army of Par'oh. They fear Yahweh then, as all of this huge miracle has been done in their sight. Mosheh is now firmly established in their minds as Yahweh's prophet.

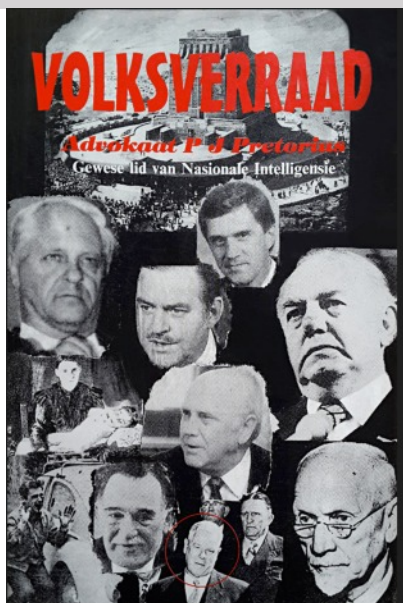


# The Hoskins Report

## Chapter 265

### Volksverraad - Betrayal - Review

**T**HE BOOK, *VOLKSVERRAAD*, BY PIET PRETORIUS, slipped through the establishments censorship net before it could be stopped, and is now the talk of all South Africa. Authored by an insider, it reveals the schemes, connections, bribes, theft and yes, murders, that has kept the South African Establishment in power for decades. It is a carbon copy of Establishment operations in every Western state, including America.

"It is a commentary on the "freedom of the press" that a best-selling book, filled to the brim with significant and dramatic revelations, should systematically be ignored by the mainstream press, both English and Afrikaans. This press is said to be ever on the lookout for sensationalism. Well, here it is - and one and all have given it the silent treatment. Even "Radio Pretoria," the "voice of conservatism" described it as "too controversial" to review.

"Indeed, so explosive is the material in the book, that only those with strong nerves can read and review it. As far as is known, Rapport was the only mainstream publication to review it, as did Die Afrikaaner, plus a few smaller publications. To add to the drama, the author and publishers are reported to have been charged with defamation, and an attempt has been made to

prevent the publication of a second edition. But apparently nothing has so far come from either action. There are apparently plans to publish English and German translations of the book.

### Tradition

"In the tradition of ex-Mossad agent Victor Ostrovsky (who wrote *The Other Side of Deception*, in which he exposed the Mossad's secret agenda) and ex-CIA agent Terry Reed (in his *Compromised*, in which he revealed Bill Clinton's and the CIA's involvement in the movement of drugs into Arkansas while governor of that state) - Advocate Piet Pretorius, and ex-NIS (National Intelligence Service, later Nat. Intelligence "BOSS") agent, has written a book entitled *Volksverraad* (Betrayal).

It is now in its second edition, the first edition having been sold out within one month. Both Ostrovsky and Reed live in hiding for fear of assassination, and it is possible that Pretorius's life could also be in danger.

"This is a deeply disturbing book, which is bound to shock some rightists and patriots. But many of the subjects have been a matter of public speculation for years, and Pretorius simply confirms the details from an Insider's point of view. He has stated that he would welcome a court case against him.

"The facts in the book are thoroughly documented. In the nature of this type of book, sources cannot always be named. Although not every word in the document can be vouched for, the main exposition is so clear, so many puzzles in South African politics clarified - especially the role played by secret forces in South Africa's political life over the past four or five decades - that it would be difficult to fault. Since 1967, South African politics have been increasingly determined by forces with their own secret agendas. The book will help to explain the apparent "paralysis of will" during the abdication of white power.

## The Smit Murders

"One of the most shocking chapters in the book deals with the murder of Dr. Smit and his wife in 1977. Robert Smit, who had previously been the South African representative at the IMF, told then-Minister of Finance, Owen Horwood, about an unexplained flow of money out of South Africa. Horwood then instructed Smit to investigate secret currency movements to the Union Bank in Switzerland.

It was established that then-State President Dr. Nie Diederichs had a secret account of R17 million. This information was given to Horwood and Prime Minister John Vorster.

"Shortly before his death, Smit told a colleague that his information would shake the whole nation, and that higher-ups would also be implicated. The revelations clearly had to be stopped.

"According to the author, the help of the CIA was called in. A man who had committed several assassinations for the CIA was assigned. He and two CIA agents and, incredibly, Nie Diederichs went to the Smit house, where Smit and his wife were shot to death, and the incriminating papers removed from Smit's briefcase.

Dietrich's fingerprints were identified on the case. This was hushed up, as was the correlation between the CIA and the bullets used in the Smit murder. Apparently, Diederichs made a confession to a nurse on his death-bed.

### John Vorster



"Advocate Pretorius goes into detail about the man who succeeded Dr. Verwoerd after he was assassinated. "While many regarded John Vorster as a rightist who "turned" once he became Prime Minister, it will seem that long

before that Vorster was busy forging secret connections with the far-left SA Institute of Race Relations, with Julius. First (father of Ruth First, and father-in-law of Joe Slovo); with the Broederbond and Freemasonry; with the CIA; with the SA Institute of International Affairs and the CFR; the SA Foundation; and MI6. When Afrikaner finance went into "partnership" with Oppenheimer's General Mining, Vorster was present at the celebration party.

"The author throws light on the circumstances surrounding Dr. Verwoerd's murder in which Vorster played a decisive role, and which can definitely be classified as a conspiracy.

Demitrio Tsafendas arrived in England in 1959 and worked at Anton Rupert's British cigarette factory, Rothmans Int. In May 1960, he said if he got the chance, he would kill Dr. Verwoerd. Rupert was informed. In 1962, Tsafendas left Rothman's employ but remained on the pay sheet.

In March 1963, a meeting was held in Birmingham at which Rupert consulted with four members of the CFR, MI6 and CIA. It decided that Dr. Verwoerd should be assassinated, and was that Tsafendas should be approached for the assignment. MI6 would train and pay him. He would also receive hypnosis. "Tsafendas arrived in SA in 1963 under suspicious circumstances.

On 27 July 1964, John Vorster, who was still Minister of Justice, was present at a meeting with Rupert, Harry Oppenheimer, Quinton White and an MI6 agent, held in Oppenheimer's Parktown house, when the murder of Dr. Verwoerd was planned, reports Advocate Pretorius. Vorster apparently blackmailed to become involved. As a reward, was he would become Prime Minister. A blueprint was handed to him

instructing him how to rule once he achieved the position. At 9 p.m. the same evening, Vorster contacted Gen van den Bergh about the matter. Tsafendas was paid R 5000 by an MI6 agent.



**Henry Kissinger**

"Pretorius gives details of the roles played by Van den Bergh, Rupert and Henry Kissinger. On 1 August, Tsafendas got work as a messenger in Parliament. A writ of expulsion to deport Tsafendas was signed by the minister, but was never sent on to the police.

"On 6 September 1966, Tsafendas assassinated Dr. Verwoerd. As Minister of Justice, Vorster was responsible for the lax security in the House. Van den Bergh was given the task of investigating the murder. Tsafendas was interrogated for 48 hours, after which it was announced that no conspiracy involved and that Tsafendas had acted alone. Vorster denied that the police had a file on Tsafendas.

## The Generals



"The founding of certain right-wing movements by BOSS and Military Intelligence is dealt with in detail. The purpose to was protect the National Party and to checkmate genuine resistance to the plans as they became apparent. From the beginning, the main intriguer was Gen Tienie Groenewald (above) and his Korn Ops. Names, places and dates are given in detail in the book.

"Pretorius finds that the planting of the Generals into the right-wing movement in the early 1990's had two purposes: First, the right-wing had to be confused by divisive factors such as the "folkstaat" concept; and secondly, the threat of armed resistance to the handover of authority to the ANC/SACP had to be defused.

"Because of his financial difficulties, Constand Viljoen was the ideal candidate for the task. The Broederbond played a key role, and Groenewald was throughout the chief architect. He was the author not only of F. W. de Klerk's "Red Friday" speech, but also several other pivotal speeches by John Vorster, Willie Jonker and others. Pretorius states that Groenewald was not only a member of Military Intelligence, but also of National Intelligence (agent 93G/1092MG), and of the American CIA.

"His *modus operandi* was to collect various rightist and conservative organizations under one umbrella and under one neutralizing control. Pretorius follows the trail relentlessly. The involvement of the CIA at this stage was critical. Names are given of various other prominent Afrikaners who were involved with CIA espionage.

"Throughout the period of "handover," Viljoen and Groenewald were constantly seen by National Intelligence in the company of F. W. de Klerk, Neil Barnard, Roelf Meyer and members of the ANC; as well as leftist cleric Johan Heyns[4].

## Harold Stough Notes Usaid and World Bank Unite Church and State Government Money Silences the Church

The partnership incorporates the churches with the U.S. Agency for International Development (USAID), a federal government agency that conducts foreign aid to advance the political and economic interests of the United States. Its stated function is to disburse foreign aid to the developing countries of the world.

### Government Money Silences the Church While Turning it Into a Partner in Crime

**B**Y A LITTLE KNOWN ALLIANCE established between major religious organizations in America and the United States government, the longstanding wall of separation between church and state has been effectively torn down.



It appears that the Seventh-Day Adventists, the Catholics and Jewish organizations have been the major profiteers from their league with the government, yet this league also involves most other religious bodies as well.

To phrase it as the Federal Highway Administration does, "this is your tax dollars at work;" your tax dollars are indeed at work here, but whose interests are they working to advance and whose hands are being stained with complicity and duplicity in promoting USAID's agenda?

This unseemly union has been formed under the guise of humanitarianism, but there is a larger agenda than appears on the surface. The issues involved here compromise the mandate of both church and state.

## USAID and Their Other Partners

According to a Los Angeles Times article, USAID relies on a host of Nongovernmental Organizations (NGOs) to achieve its goal of advancing the United States' foreign policy. "For generations, the U.S. government has worked to foster America's image as benevolent benefactor to the world's needy.

Most people do not realize, however, that this often amounts to goodwill by proxy. (US) AID has come to rely more heavily than ever on a network of 417 private groups, sharing an annual pot of \$1.4 billion.

As incongruous as it may seem, some of the largest recipients of USAID funds--United States tax dollars--go to religious organizations. According to the L. A. Times report, the Seventh-Day Adventist (SDA) church through its Adventist Development and Relief Agency Inc. (ADRA) "was given more direct U.S. funding than all but three organizations out of more than 400 federal program participants.

The Adventists [ADRA] received \$85 million in federal cash, food and freight, plus tens of millions more from other nations and donors during the last two years for which reports were available."

According to a USAID annual report, the Adventists are joined by the Catholics, Lutherans, Mennonites, Nazarenes, Salvation Army, United Methodists, Jewish organizations and others. These churches gather in almost ecumenical-like fashion for their allotment of federal tax money.

The Times report calls the Adventist partnership with the government "ironic," saying the church founders equated the United States government with the biblical "beast." "Now, says Queens

College sociologist Ronald Lawson, an Adventist, the church has become "an arm of American foreign policy." [3] Equally ironic is the church's announcement that ADRA's "educational" program "Global Village" is operated in partnership with the World Bank.

Realizing that USAID uses these funds for the advancement of U.S. political and economic interests, it would be well to examine one of the major objects of its current focus. Central to US policy for the past eight years has been the Iraqi sanctions. According to human rights groups, the principal casualty of this policy is young children under five years of age. The leading cause of death in these children is malnutrition, put more bluntly, starvation.

About one-and-a-half million people, mainly children, have been killed by the sanctions. That equates to about five percent of the Iraqi pre-sanction population. This is equivalent to about thirteen million dead Americans.

Most of the Iraqi people live in poverty and approximately one-fifth are threatened with famine. The per-capita income has fallen from \$2900 to the current sub-survival average of \$60 per year. Mideast Realities reports that a can of powdered milk costs more than a doctor's monthly wage, a tray of thirty eggs costs more than a university professor's monthly wage.



**Madeleine Albright**

Referring to the death and destruction inflicted on the Iraqi people resulting from American foreign policy, Secretary of State Madeleine Albright was asked if the cost in human suffering was worth the gain to the United States. Albright commented, "It's a hard decision, but we think the price is worth it."

For such atrocities, the Adventists, the Catholics, the Jews and all of the other religious

organizations involved with government foreign policy, make themselves responsible for those things government does. Their willing collaboration with the State indicates where their true allegiance lies.

### Separation of Church and State?

Speaking of the Adventists, one USAID official said, "We have found them to be a good, solid partner." What this statement actually says is, the Adventists and other religious groups have become good, solid partners in the work of moral destruction, tyranny and revolution that is represented in the system now being "lovingly" imposed on the world. The "caring" church participates in the process through its union with international policy.

USAID forbids proselytising by the organizations using USAID grant money

because the United States and other countries prohibit the use of their funds for religious purposes.

The government, however, effectively uses the churches as evangelistic mediums for their brand of religion, crusading for democracy around the globe. Donald Falkenberg, a top official of Global Mission and brother to the SDA church president says ADRA "'is not out there proselytising,' he acknowledged, however, that the effect has been to heighten the denomination's profile with local residents.

Adventist sociologist Lawson said the church's intent perhaps can best be seen in the candour of a relief worker he met in Africa, who confided: 'If I'm going to build a road, I'm going to have it go past an Adventist church.'"

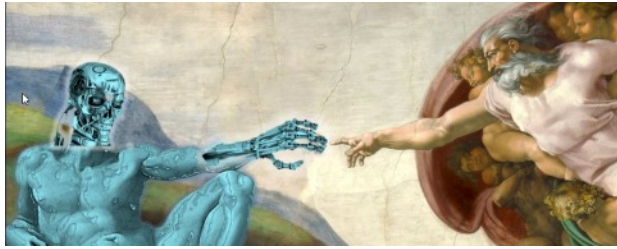
"Voltaire said about God that 'there is no God, but don't tell that to my servant, lest he murder me at night'. *Hammurabi.*

"God is dead. It just takes a while to get rid of the body."

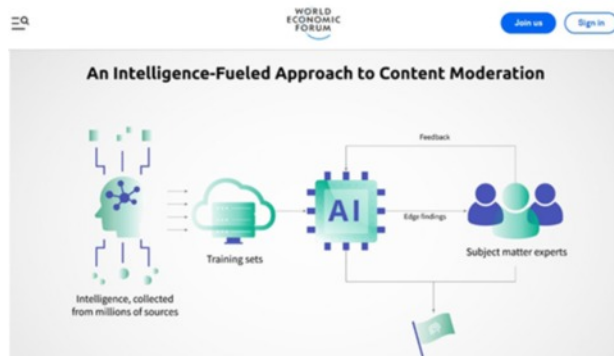

## The Invisible Rainbow Irritable Heart (Part 2)

**H**EART DISEASE HAD NOT, HOWEVER, SPRUNG FULL-BLOWN FROM NOTHING at the turn of the twentieth century. It had been relatively uncommon but not unheard of. The vital statistics of the United States show that rates of heart disease had begun to rise long before White graduated from medical school.

The modern epidemic actually began, quite suddenly, in the 1870's, at the same time as the first great proliferation of telegraph wires. But

that is to jump ahead of myself. For the evidence that heart disease is caused primarily by electricity is even more extensive than Milham suspected, and the mechanism by which electricity damages the heart is known.

To begin with, we need not rely only on historical data for evidence supporting Milham's proposal, for electrification is still going on in a few parts of the world.

From 1984 to 1987, scientists at the Sitaram Bhartia Institute of Science and Research decided to compare rates of coronary heart disease in Delhi, India, which were disturbingly high, with rates in rural areas of Gurgaon district in Haryana state 50 to 70 kilometers away.

Twenty-seven thousand people were interviewed, and as expected, the researchers found

more heart disease in the city than in the country. But they were surprised by the fact that virtually all of the supposed risk factors were actually greater in the rural districts.

City dwellers smoked much less. They consumed fewer calories, less cholesterol, and much less saturated fat than their rural counterparts.

Yet they had five times as much heart disease. “It is clear from the present study,” wrote the researchers, “that the prevalence of coronary heart disease and its urban-rural differences are not related to any particular risk factor, and it is therefore necessary to look for other factors beyond the conventional explanations.”

The most obvious factor that these researchers did not look at was electricity. For in the mid-1980’s the Gurgaon district had not yet been electrified.

In order to make sense of these kinds of data it is necessary to review what is known—and what is still not known—about heart disease, electricity, and the relationship between the two.

My Hungarian grandmother, who was the main cook in my family while I was growing up, had arteriosclerosis (hardening of the arteries). She fed us the same meals she cooked for herself and, at the advice of her doctor, they were low in fat.

She happened to be a marvellous cook, so after I left home I continued eating in a similar style because I was hooked on the taste. For the past thirty-eight years I have also been a vegetarian. I feel healthiest eating this way, and I believe that it is good for my heart.



However, soon after I began to do research for this chapter, a friend gave me a book to read titled *The Cholesterol Myths*. It was published in 2000 by Danish physician Uffe Ravnskov (left), a specialist in internal medicine and kidney disease and a retired family practice doctor living in Lund, Sweden.

I resisted reading it, because Ravnskov is not unbiased: he thinks vegetarians are pleasure-avoiding stoics who heroically deny themselves the taste of proper food in the mistaken belief that this will make them live longer.



Ignoring his prejudices, I eventually read Ravnskov’s book and found it well-researched and thoroughly referenced. It demolishes the idea that people are having more heart attacks today because they are stuffing themselves with more animal fat than their ancestors did. On its surface, his thesis is contrary to what I was taught as well as to my own experience.

So I obtained copies of many of the studies he quoted, and read them over and over until they finally made sense in light of what I knew about electricity.

The most important thing to keep in mind is that the early studies did not have the same outcome as research being done today, and that there is a reason for this difference.

Even recent studies from different parts of the world do not always agree with each other, for the same reason. Ravnskov, however, has become something of an icon among portions of the alternative health community, including many environmental physicians who are now prescribing high-fat diets—emphasizing animal fats—to their severely ill patients.

They are misreading the medical literature. The studies that Ravnskov relied on show unequivocally that some factor other than diet is responsible for the modern scourge of heart disease, but they also show that cutting down on dietary fat in today’s world helps to prevent the damage caused by that other factor.

Virtually every large study done since the 1950’s in the industrialized world—agreeing with what I was taught in medical school—has shown a direct correlation between cholesterol and heart Disease.

And every study comparing vegetarians to meat eaters has found that vegetarians today have both

lower cholesterol levels and a reduced risk of dying from a heart attack.

Ravnskov speculated that this is because people who eat no meat are also more health-conscious in other ways. But the same results have been found in people who are vegetarians only for religious reasons. Seventh Day Adventists all abstain from tobacco and alcohol, but only about half abstain from meat. A number of large long-term studies have shown that Adventists who are also vegetarians are two to three times less likely to die from heart disease.

Perplexingly, the very early studies—those done in the first half of the twentieth century—did not give these kinds of results and did not show that cholesterol was related to heart disease.

To most researchers, this has been an insoluble paradox, contradicting present ideas about diet, and has been a reason for the mainstream medical community to dismiss the early research.

For example, people with the genetic trait called familial hyper-cholesterolemia have extremely high levels of cholesterol in their blood—so high that they sometimes have fatty growths on their joints and are prone to gout-like attacks in toes, ankles, and knees caused by cholesterol crystals.

In today's world these people are prone to dying young of coronary heart disease. However, this was not always so.



### Leiden University Holland

Researchers at Leiden University in the Netherlands traced the ancestors of three present-day individuals with this disorder until they found a pair of common ancestors who lived in the late eighteenth century.

Then, by tracing all descendants of this pair and screening all living descendants for the defective

gene, they were able to identify 412 individuals who either had definitely carried the gene and passed it on, or who were siblings who had a fifty percent chance of carrying it.

They found, to their amazement, that before the 1860's people with this trait had a fifty percent lower mortality rate than the general population. In other words, cholesterol seemed to have had protective value and people with very high cholesterol levels lived longer than average.

Their mortality rate, however, rose steadily during the late nineteenth century until it equalled the rate of the general population in about 1915. The mortality of this subgroup continued rising during the twentieth century, reaching double the average during the 1950's and then levelling off somewhat. One can speculate, based on this study, that before the 1860's cholesterol did not cause coronary heart disease, and there is other evidence that this is so.



In 1965, Leon Michaels, working at the University of Manitoba (Left), decided to see what historical documents revealed about fat consumption in previous centuries when coronary heart disease was extremely

rare.

What he found also contradicted current wisdom and convinced him that there must be something wrong with the cholesterol theory. One author in 1696 had calculated that the wealthier half of the English population, or about 2.7 million people, ate an amount of flesh yearly averaging 147.5 pounds per person—more than the national average for meat consumption in England in 1962.

Nor did the consumption of animal fats decline at any time before the twentieth century. Another calculation made in 1901 had shown that the servant keeping class of England consumed, on average, a much larger amount of fat in 1900 than they did in 1950.

Michaels did not think that lack of exercise could explain the modern epidemic of heart disease

either, because it was among the idle upper classes, who had never engaged in manual labour, and who were eating much less fat than they used to, that heart disease had increased the most.

Then there was the incisive work of Jeremiah Morris, Professor of Social Medicine at the University of London, who observed that in the first half of the twentieth century, coronary heart disease had increased while coronary atheroma—cholesterol plaques in the coronary arteries—had actually decreased. Morris examined the autopsy records at London Hospital from the years 1908 through 1949.

In 1908, 30.4 percent of all autopsies in men aged thirty to seventy showed advanced atheroma; in 1949, only 16 percent. In women the rate had fallen from 25.9 percent to 7.5 percent. In other words, cholesterol plaques in coronary arteries were far less common than before, but they were contributing to more disease, more angina, and more heart attacks.

By 1961, when Morris presented a paper about the subject at Yale University Medical School, studies conducted in Framingham, Massachusetts and Albany, New York had established a connection between cholesterol and heart disease.

Morris was sure that some other, unknown environmental factor was also important. “It is tolerably certain,” he told his audience, “that more than fats in the diet affect blood lipid levels, more than blood lipid levels are involved in atheroma formation, and more than atheroma is needed for ischemic heart disease.”

That factor, as we will see, is electricity. Electromagnetic fields have become so intense in our environment that we are unable to metabolise fats the way our ancestors could.

### Animals and Birds in Zoos

Whatever environmental factor was affecting human beings in America during the 1930’s and 1940’s was also affecting all the animals in the Philadelphia Zoo.

The Laboratory of Comparative Pathology was a unique facility founded at the zoo in 1901. And from 1916 to 1964, laboratory director Herbert Fox and his successor, Herbert L. Ratcliffe, kept complete records of autopsies performed on over thirteen thousand animals that had died in the zoo.

During this period, arteriosclerosis increased an astonishing ten to twenty-fold among all species of mammals and birds. In 1923, Fox had written that such lesions were “exceedingly rare,” occurring in less than two percent of animals as a minor and incidental finding at autopsy.

The incidence rose rapidly during the 1930’s, and by the 1950’s arteriosclerosis was not only occurring in young animals, but was often the cause of their death rather than just a finding on autopsy. By 1964, the disease occurred in one-quarter of all mammals and thirty-five percent of all birds.

## The Worst Adulteration of The Scriptures

**I BELIEVE THAT ONE OF THE WORST ADULTERATIONS OF THE BIBLE WAS WHEN ITS BOOKS HAD CHAPTERS AND VERSES ADDED BY STEVEN LANGTON IN 1227.** The claim is that it simplifies Bible study but in fact it helps to destroy the Bible's meaning. As far as I'm aware very few books e.g. Shakespeare etc, that is regularly studied, has been divided in such a way.

I can understand chapters being added in order to define the start of a new thought but in the case of Genesis 1 and 2, Chapter 2 is said to be a repetition of Chapter 1. If you read Genesis as a narrative, without the Chapter divisions, then it clearly shows that Adam was not 'created' as man was in Chapter 1 but was 'formed' (from something pre-existing) in Chapter 2 and had the Spirit of God breathed into him.



Creationists have got this completely wrong believing that all races must have come from Adam. They ignore the fact that God had created a pre-Adamite man and that is where the other races came from.

Clearly the Bible says that it is only God's children (the 12 tribes of Israel) that can be saved and have eternal life. Accepting the name of Jesus as their saviour is not a simple passport to eternal life but only applies to the Israelites and nobody else.

Also the Law was only given to the Israelites and transgression of the Law is sin. This is what Jesus came to save them from. Since other races were not given the Law then Jesus did not die for them.

**NOTE**

It must be clearly understood that the 'Jews' are not the OT Israelites as is commonly believed by most Christians. The original 'Jews' were the descendants of Esau whom God hated and was the father of the Edomites and later referred to as Jews! The vast majority of Jews today are the descendants of the Khazars who converted to Babylonian Judaism.

The regular misuse of the word 'Jew' in the Bible has created endless confusion for establishing Christian identity.

**Eating Unclean Food. Acts 10 :10-15**



He became hungry and wanted to eat, but while they were preparing the meal, a trance came over him. He saw heaven opened and an object

something like a large sheet descending, being let down to earth by its four corners.

In it were all kinds of four-footed animals and reptiles of the earth and wild birds. Then a voice said to him, "Get up, Peter; slaughter and eat!" But Peter said, "Certainly not, Lord, for I have never eaten anything defiled and ritually unclean!"

The voice spoke to him again, a second time, "What God has made clean, you must not consider ritually unclean!"

This is used to dismiss God's commandment not to eat unclean food. It was symbolic in that Peter considered a Roman to be unclean and that as Peter was an Israelite he was simply obeying God's command not to mix with non-Israelites.



The fact that God commanded Peter to visit the Roman Cornelius meant that he wasn't a non-Israelite and it was OK to mix with him.

Eating unclean food was imbedded in God's Laws and that the Law could not be done away-with.

**Mat 5:18** For verily I say unto you, Till heaven and earth pass, one jot or one tittle shall in no wise pass from the law, till all be fulfilled.

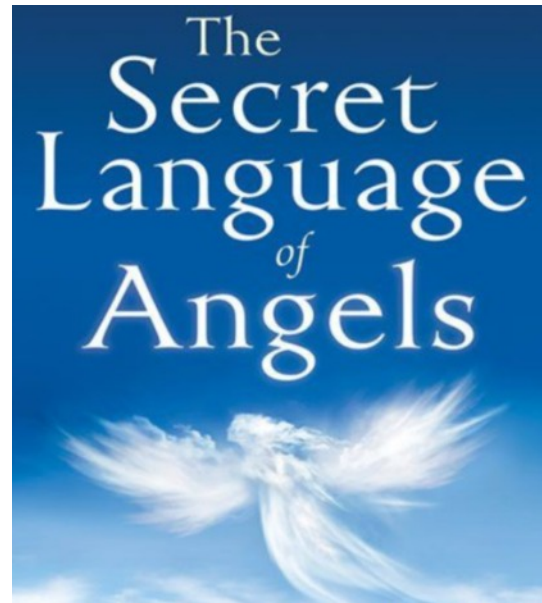
Further evidence offered is that the Law was nailed to the cross. It wasn't the Law that had been nailed to the cross but the sacrificial ordinances.

**Col 2:14-15:** He has destroyed what was against us, a certificate of indebtedness expressed in decrees opposed to us. He has taken it away by nailing it to the cross. Disarming

the rulers and authorities, he has made a public disgrace of them, triumphing over them by the cross.

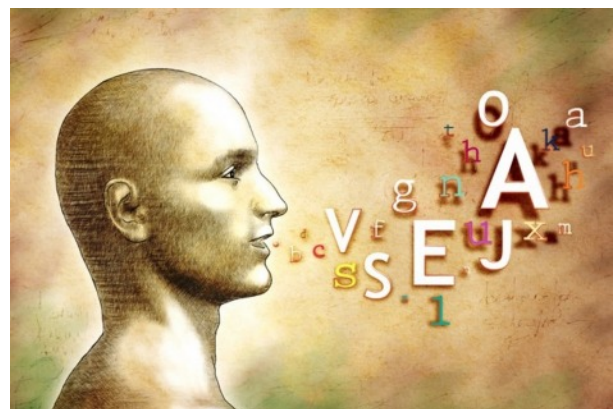
This is referring to the sacrificial ordinances which were no longer necessary as Jesus was the final sacrifice. All other Laws and ordinances remain intact as in Mat 5:18 left column bottom paragraph Therefore Christians should still be refraining from eating unclean food.

### Tongues is an Angelic language

Today's churches do not offer interpretations after someone as spoken in a tongue. Also what passes for tongues is also called 'glossolalia' and is common in the occult. .

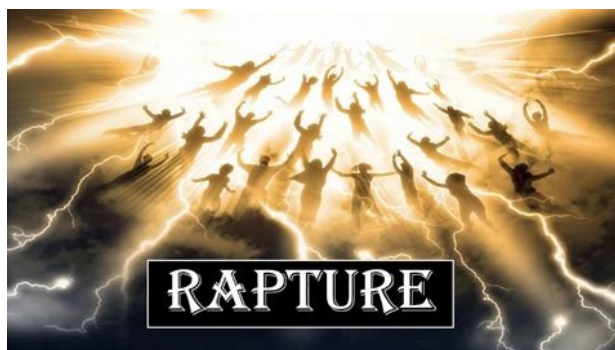
**1 Cor 14:13-15;** Wherefore let him that speaketh in an unknown tongue pray that he may interpret.

The "rapture" doctrine was virtually unknown as a major doctrine until 1830 and began following a prophecy made by a 15 year old girl named Margaret MacDonald, in Scotland.

It was endorsed up by J. N. Darby of the Exclusive Brethren at that time and the doctrine has been widely propagated over the years through the popular Schofield Bible notes.

It is now a common Bible College and Seminary teaching, but it is not a historic doctrine of Protestant orthodoxy.

Most of the teachings are based upon the words "caught up"; that is, suggesting that being "caught up" means being taken away from this earth's scene. This is based upon **1 Thess. 4:13-18:-**



**13:** Now we do not want you to be uninformed, brothers and sisters, about those who are asleep, so that you will not grieve like the rest who have no hope.

**14:** For if we believe that Jesus died and rose again, so also we believe that God will bring with him those who have fallen asleep as Christians.

**15;** For we tell you this by the word of the Lord, that we who are alive, who are left until the coming of the Lord, will surely not go ahead of those who have fallen asleep.

**16:** For the Lord himself will come down from heaven with a shout of command, with the voice of the archangel, and with the trumpet of God, and the dead in Christ will rise first.

**17:** Then we who are alive, who are left, will be suddenly caught up together with them in the clouds to meet the Lord in the air.

**18:** And so we will always be with the Lord.

Is what they say about being "caught up" really what "caught up" means? If the scene painted by "Rapture" teachings were true, then there is much difficulty because we find in scripture that

other people who were "caught up" remained on earth after the event!

The Greek word for "caught up" is *harpazo*, and it is found 18 times in the New Testament. From these we should get a good picture of what the word means. The KJV translates the word with various different meanings.

Catch..... 1 time. Catch away.....2 times. Catcheth.....3 times. Catch Up... 3 times. luck.....2 times. Pull..... Take by force... 3 times. Take.....1 time. Pulling.....1 time.

This is the key verse of the "Rapture" doctrine. We do not find any other verses like it in the Bible and so the popular interpretation lacks the two or three scriptural witnesses as required to "be established" and to back it up.

**30:** Let both grow together until the **Mat 13:24-30;** The kingdom of heaven is likened unto a man which sowed good seed in his field:

This parable demonstrates that the 'Wheat' is not Raptured away first but it's the wicked 'Tares' who are gathered first and burnt.

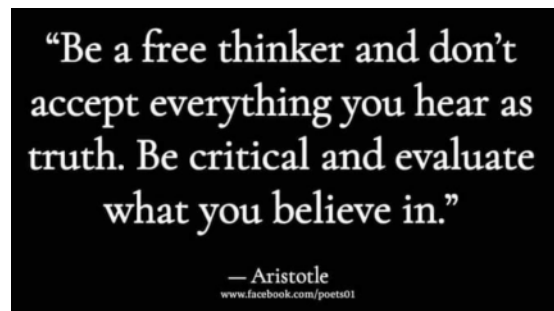

The first image is from the OS 25-inch map of 1892, St Peter's is enclosed, surrounded by trees as Alan Wilson described it used to be in the

1990 excavation notes, and the graveyard is still respectfully marked.

The area of the boat-shaped mound is enclosed and the track-way skirts around the southern flank.

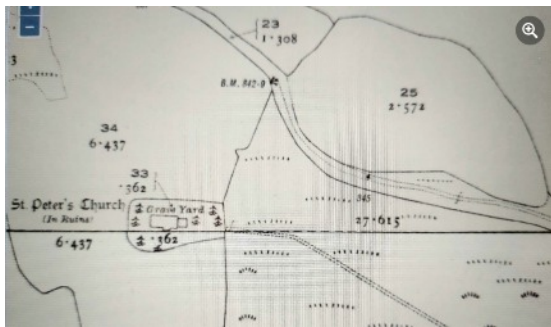
The second image is from the 1961 OS 1:25000 map and clearly shows that the track-way is still skirting the enclosure of the boat-shaped mound.

The graveyard description and trees have disappeared from St Peter's. Some might argue that this omission is to do with the map scale, but there is plenty of room around the area, and graveyards are marked on other, more detail-dense areas.

The third image is a current drone shot of the area of the boat-shaped mound from above the track-way looking from E to W.

The course of the old route of the track that had been respecting the enclosure of the boat-shaped mound for centuries can still be seen to the left, while the recent modification to the route cuts through the enclosure and across part of the mound like a deliberate act of vandalism.

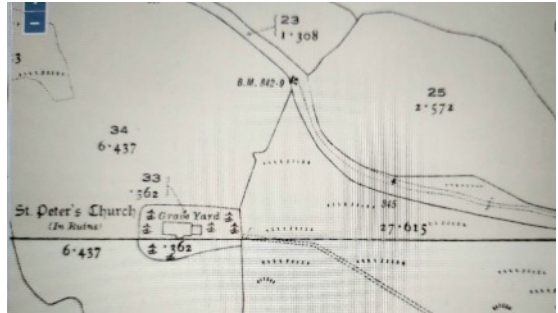
### St Peter's Church Ruins and the Boat Shaped Mound

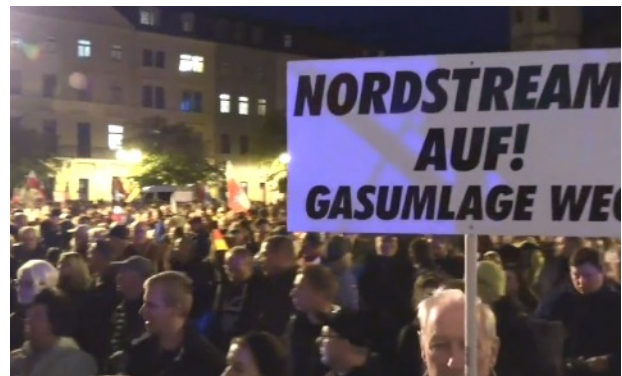

## A Christian Response To 'Yahweh Did Not Create Us' By A White Nationalist



**The Fall of Babylon by John Martin (1789-1854)**

**WE OFTEN SEE VERY VEHEMENT ANTI-CHRISTIAN SENTIMENTS EXPRESSED BY SO-CALLED "WHITE NATIONALIST" CIRCLES.** Their sentiments are much the same, centring on the demonstrably false idea that the faith of the Bible is a "foreign" or "alien" religion not native to the white European race — and that Jews created "Christianity" as part of a conspiratorial plan to subjugate and ultimate destroy the "noble" Aryan peoples.

A recent essay entitled "Yahweh Did Not Create Us" by Chris Rosetti, an editor for National Vanguard, caught our attention because it contained most of the

typical talking points — and straw man arguments — typically made by White Nationalists against the "Jewish" religion of Christianity.

A similarly themed anti-Christian essay recently appeared in *The Occidental Observer* by Tom Sunic — containing similar straw man arguments and superficial understanding we see in Rosetti's essay. Ironically, the founder of *The Occidental Observer*, Kevin MacDonald — although not a Christian himself — is objective enough to readily concede that Christianity has historically benefited the white European people as a mechanism of "in-group survival" that — when cohesive and strong — provides a beneficial opposition to the destructive force of Judaism.

That said, these sentiments expressed in "Yahweh Did Not Create Us" are rather ironic coming from someone with a decidedly Christian name as "Chris Rosetti". His given name obviously comes from "Christ" — and his surname — "Rosetti" has both Medieval Christian and Hebrew origins. No, that doesn't mean "Rosetti" is Jewish, but it does show the profound historical connection between Christian Europe and the Near East — and as we shall see, for good reason.

So here we will quote Rosetti's essay point-by-point and offer our response to each of his allegations against Christianity — and hopefully show that Christianity — real Christianity — not the "Christianity" practiced by most of the subverted and distorted mainstream denominations — is indeed the original — and "native" — faith of our European ancestors.

### **Rosetti Begins:**

"Even after having been exposed to the great qualities — and achievements — of European peoples before they were swept up in the Middle Eastern religion that now dominates them, one racial patriot recently stated:

"I still trust the Bible and Christianity." I responded: But why? Christianity isn't the native, organic, ancestral belief of the White race. None of our ancestors were Christian until it was forced on them through tyranny, oppression, and brutal violence."

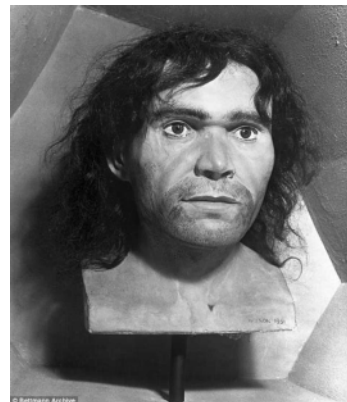
CFT: For the last 1,000 years, the vast majority of our ancestors were indeed Christian. In fact, there's evidence that Christianity was first

established in England not long after the death of Christ in Glastonbury — a remarkable accomplishment considering it's allegedly such an "alien" faith to the Anglo-Saxon race.

Archaeologists have found early Christian artefacts from the Roman occupation of England — demonstrating that Christianity had taken hold far earlier than they had originally believed. Prior to 900 AD, our pagan ancestors on continental Europe largely worshiped — to one degree or another — pagan gods — which, ironically, can trace their origins to pagan cults of Rome, Greece, and the Near East — and even Babylon.

No one with any historical understanding would argue that the Aryan race didn't have its origins in the Near East. In fact, the original Aryans arose in the ancient Persian Empire.

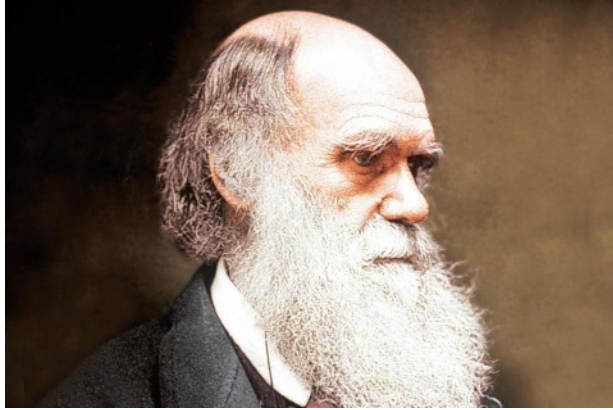
And this may infuriate many such White Nationalists, but the ancient Aryan Persians — also known as the Medes — according to the Roman historian Josephus — descended from Noah's grandson Madai — yes, the son of Shem — the same patriarch of Abraham, Issac, and Jacob — making the Israelites not-so distant cousins of the original "Aryans" — hardly an "alien" race.



Many White Nationalists dismiss this documented ancient history and instead claim the white Europeans somehow "evolved" either from monkeys and Blacks in Africa — or natively in Europe from Cro-Magnon man (above) or some such nonsense —

—nonsense because there is absolutely no archaeological record in Europe of any transitional skeletal remains between Cro Magnons and modern Homo Sapiens. And for good reason — there simply wasn't enough time

elapsed between the time when Cro Magnons lived and when white Europeans first appeared — so-called necessary “evolutionary” changes in DNA would take hundreds of thousands of years — if you are foolish enough to believe in the occult metaphysics of the Freemason, Charles Darwin.



### Charles Darwin

White Europeans are also known as “Caucasians” for a reason — our ancestors entered south eastern Europe from the Near East and passed through the Caucasus Mountains — and rather significantly, the pass through which they traversed those mountains is still to this day called “The Pass of Israel.”

Which leads us to Rosetti’s next allegation — an oft-repeated legend that Christianity was forced on the native European pagans “by the sword.” This theory is demonstrably false. Forced conversion was strictly forbidden by the early church fathers, such as Tertullian of Carthage, Hippolytus of Rome, and Origen of Palestine and Egypt.

In fact, many Christian circles even reject infant baptism as unscriptural because baptism — as performed in the New Testament [see Acts 2:38; Romans 6:3-4] — required the subject to freely and consciously accept Christ as his saviour — and clearly, new-born infants are incapable of such understanding.

Much to the chagrin of White Nationalists who are ignorant of the true history of Christian conversion in Europe, it largely did not take place “under threat of the sword.” There are literally hundreds of examples of free conversion of European tribes and nations [see the Timeline of Christian Conversions [here](#)].

The Gregorian mission to the Anglo-Saxons did not involve force — nor did the mission to the Picts at Iona by Columba — nor St. Boniface’s conversion of the (German) Saxons — nor the Christianisation of Scandinavia.

If Christianity were such a hostile and alien religion, why would they so readily accept it without coercion?

Any forced conversions occurred much later — when Crusaders misguidedly forced non-Europeans — racial Saracens and Jews — to convert by the sword. And then later, of course, in the 15th century when the Catholic Church compelled racial Jews and some Arabs to convert during the Inquisition. But neither of these cases involved white European people.

### Rosetti Continues

“Why do you trust a book written by the very same race of people you recognize today as a threat? The Bible wasn’t written by our White ancestors. It was written by the ancestors of Jews, and written for the Jewish people.”



The Bible was not written by “Jews” — no matter how many times White Nationalists insist they did — and certainly not by the ancestors of today’s Ashkenazi and Sephardic Jews who are not legitimate descendants of the ancient Israelites who actually did write both the Old and New Testaments.

In fact, the 1980 Jewish Almanac admitted that today’s Jews are not the same people as the ancient Israelites: “Strictly speaking, **it is incorrect to call an ancient Israelite a Jew or to call a contemporary Jew an Israelite or a Hebrew.**”

And white Europeans most decidedly are related to the ancient Israelites — the evidence is overwhelming that the ten northern tribes of

Israel — who were never known as “Jews” — did migrate north west through the Caucasus Mountains into Europe — some became known as the “Scythians” who were earlier known as the Israelite Cimmerians in the Bible.

The “noble” Germanic Goths were descendants of these Scythian tribes who migrated into Europe from Parthia.

In fact, in the 1320 Declaration of Arbroath, the Scottish people declared that they were descendants of the very same Scythians who had their origins in the ten northern tribes of Israel — of course, mainstream historians obfuscate or ignore the Israelite origins of the Scythians, falsely claiming that they were solely the descendants of the ancient Persians — perhaps understandable considering the Persians were Aryans as mentioned above.

White Nationalists cannot explain, for example, why the Welsh people — who call themselves Cymry/Cymru — speak a unique language that is virtually identical to that of the ancient Khumry — the name that the ancient Assyrians used to describe the ten northern tribes of Israel they held in captivity.

And like the Welsh language, Gaelic clearly has numerous — and “inexplicable” — similarities to the ancient Hebrew language — a fact that modern linguists refuse to recognize for “fear of the Jews” who dominate academia — and falsely maintain that they are the only living remnant of the ancient Israelite people.

“In the Old Testament, the Jewish authors describe themselves (with no apparent shame) — terrible, depraved, wicked, sadistic, savage, greedy, deceptive, subversive, genocidal — in great detail. So why would you take the words of such people as absolute, eternal truth?”

Again, Jews didn’t write the Old Testament — Israelites did. And if White Nationalists weren’t too busy chauvinistically defending the white European race, they’d admit that our history shows us, at times, to have the very same qualities that Rosetti attributes to “Jews” — we indeed have been “depraved, wicked, sadistic, savage, greedy, deceptive, subversive, genocidal” — the endless fratricidal wars in Europe — even among the early pagan tribes — demonstrate these unflattering tendencies. The

pagan Greek and Roman emperors were notorious for their moral depravity and savagery — but because they weren’t “Jewish” the White Nationalists give their depravity a free pass.

Indeed, in the Bible those who were “depraved, wicked, sadistic, etc.” had fallen away and disobeyed God’s simple commandments — and instead worshiped pagan gods and idols — the same type of “native” pagan gods that Rosetti endorses.

The Bible does not hold up the wicked as paragons of virtue for others to follow, as Rosetti seems to suggest. They are punished — as examples of what awaits the ones who refuse to live by these simple precepts.

As Christ said in Matthew 11:30, “My yoke is easy, my burden is light.” Christianity does not encourage followers to live in fear of the material world — or death — quite the opposite.

Those who live in fear do not trust God — as Christ advises, “Peace I leave with you; my peace I give you. I do not give to you as the world gives. Do not let your hearts be troubled and do not be afraid” (John 14:27).



The same principles appear in the Old Testament about the alleged wrathful “Jewish” God — “So do not fear, for I am with you; do not be dismayed, for I am your God. I will strengthen you and help you; I will uphold you with my righteous right hand” (Isaiah 41:10).

The Ten Commandments — our basic code of moral behaviour — is the foundation of Christian civilization, and we find it hard to believe that any pagan such as Rosetti could possibly point to any of the Ten Commandments and claim that they are “anti-white.”

“Why trust what Christianity teaches? Is it because you fear Yahweh’s wrath and want to



avoid an eternity of torment? Who created the narrative that we're all damned to an eternity of torment? What does this actually teach us?"

This belief is hardly unique to Christians — in fact, the false Catholic and Protestant teachings about “burning in hell” were based on the pagan Greek myths of the underworld — Hades — where the wicked were tormented for eternity by the vengeful and angry gods.

But we suppose this Greek belief — to fear the wrath of the pagan gods — is defensible because these beliefs were “native” to the white race? No doubt even the pagans of Europe feared the unknown “gods” in the sky — and carried out their own rituals to “appease” them — in hopes of a good life and bountiful crops. But these primitive beliefs are more “virtuous” and “valid” merely because our racial kinsman believed in them. Makes sense.

“The New Testament’s Romans 3:10 gives us the doctrine of “sin equity.” As Saul of Tarsus explains, Jews are superior to non-Jews, but “sin equity” ensures all are “equal under the power of sin.” Much like how Communists want

everyone to be equally poor, so that none can claim to have more than others, your Christianity needs everyone to be “equally wicked,” so none can claim to be more moral than others.”

The phrase “sin equity” appears nowhere in the Bible — and a quick search of the internet will show that the only reference to that phrase occurs in Rosetti’s own essay. His presumption that the Jews who created communism had used the same concept when they invented Christianity — is a classic example of the logical fallacy “begging the question” — the premise is same as the conclusion — “after this, because of this.”

Contrary to Rosetti’s claim, Paul denies that his Israelite racial ancestry makes him superior in any way to non-Israelites — in fact, Paul admits that being born an Israelite is worthless “rubbish” without having redeeming faith in Jesus Christ (Philippians 3:8). In fact, Christ praises the pagan Roman centurion in Matthew 8:10, claiming that his faith — his righteousness — was far superior to any of the Israelites.

## **In The UK, Our Government Is Definitely at War with Us – Dr. Vernon Coleman**



### **Get Rid of Cash.**

Introduce compulsory vaccinations “because they’ve been trying to do this for years.”

Dr. Coleman briefly discussed the social credit system that is being incrementally implemented in the UK without people even realising it is happening. Ultimately, we are not going to be able to own anything and the government is going to control every aspect of our lives.

**T**WO DAYS AFTER CORONAVIRUS (COVID-19) WAS DOWNGRADED TO THE SEASONAL FLU, the UK government introduced emergency legislation to “tackle the spread of Coronavirus.”

So why would they create a fake pandemic? Dr. Coleman’s thoughts in February/March 2020 were that there were three things that they were going to try and do: Kill off as many of the elderly as they possibly could.

### **Returning to the Aims of the Fake Pandemic.**

The killing of the elderly started years ago with the murderous Liverpool Care Pathway. And then the United Nations made it easy for governments to kill off citizens over the age of 70. Then DNR notices flourished. Then governments slaughtered the elderly by the thousand with the midazolam murders. Today, in the UK, doctors are legally allowed to kill

anyone who cannot look after themselves. If you doubt me, read my article on this website entitled **'Have You Been Put on a Death List?'** The UK government ruling is that anyone who is 'mildly frail and may need help with heavy housework, shopping and preparing meals can be left to die if they fall seriously ill.



“In the UK, our government is definitely at war with us. The elderly are regarded as worthless and expensive – because they have to pay pensions to old people and because they ‘oh well, you’re not working so you’re useless so go away we don’t want you’.

And they’re encouraging young people to think the same thing about the elderly instead of thinking ‘what can we learn from the elderly,’” Dr. Coleman said.

“They’ve been killing the old people for years in the health service but now it’s really accelerating. And the DNR notices which they’re slapping on whole communities of people, and which they’re doing very often not asking—they’re just putting the DNR notices on, or they’re killing with the benzos – midazolam, morphine cocktails ...

We’ve been encouraged to denigrate the elderly and to applaud the drug companies. The drug companies are the most evil corporations in world history.”

If we look at where health is going in the UK, it is very much prioritising information and security over healthcare. In the early days, the National Health Service (“NHS”) considered

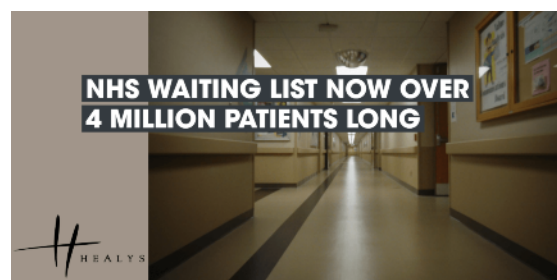
patient care, basic nursing care and tender loving care as all important. This all seems to have been eliminated, explained Debi Evans, an NHS-trained nurse and UK Column’s Nursing Correspondent, who joined the discussion.

“The NHS now, I believe, is a dangerous place to be ... We seem to be living in an age where the NHS seems to be ruling [over] all of us.”

“I don’t think we have a health service in the UK anymore ... it’s been destroyed,” Dr. Coleman responded.

“The [British Medical Association] BMA has said that we have to cut back the amount of money and energy that goes into looking after the people with too many tests and too many treatments – because of climate change. I couldn’t believe that when that came out.

“Doctors are now insisting on doing everything by video —they’ve lost the placebo response the elderly have been left to one side— What’s happened now is the health service has been utterly destroyed. There is effectively no GP service.



“What is it – 4 million people on a waiting list at the moment? Anyone who’s on a waiting list is on a waiting list because they need treatment. That figure’s going to reach 12/13 million before the year is out or at the beginning of 2023?

That is going to make a massive increase to the mortality figures —far more people are now going to be dying which is, of course, part of the depopulation plan. The problems in the health service have created within the health service because doctors no longer care. “The whole of society has been being deliberately destroyed ... because they’re preparing us for the Great Reset.”

It seems the UK Medicines and Healthcare products Regulatory Agency (“MHRA”) is indicating that they do not want any more data to be entered into the Yellow Card reporting system for adverse effects. Evans wonders if the Yellow Card reporting system was simply a “smoke screen that they’re paying lip service to.”



agenda, by using all sorts of psychological tricks “they have created a form of mental illness,” Dr. Coleman said.

“I worry about them defining discontent and unhappiness as mental illness because then it gets treated. People have been throwing about ‘the benzos are back’ —they’ve got to get benzodiazepines into people, anti-depressants which don’t work. Benzodiazepines are the most dangerous, most addictive drugs on the planet—

We have to be careful about calling all the disappointments and unhappiness and the discontent – allowing people to dramatize it as a mental illness because I think that’s what the government wants.”

The pharmaceutical industry owns the medical profession, said Dr. Coleman, and the industry owns the NHS. The NHS pays a ridiculous amount of money for a lot of the rubbish they buy, the covid injections are just part of that.

“It would appear the yellow card [reports] are going absolutely nowhere, no one’s taking any notice of them or if they are it’s only for the pharmaceutical industry’s good or medical research – certainly not in the patient’s best interest ... Now we believe that the Yellow Card [reports] have actually been binned,” she said.

“It’s a war. We are fighting a war with our own government and we can win it,” said Dr. Coleman. “We have to fight the lies and we have to avoid their little tricks; we have to be aware of all their little tricks —If you’ve got a smart meter, get rid of it —don’t have apps on your smart-phone

The problem, said Dr, Coleman, is as it has always been. “Almost everyone involved in the control of drugs has links with the drug industry. The drug industry controls the medical establishment and they control the committees and the groups.”

Don’t be afraid to talk to people and try to persuade people to listen to programs like [UK Column], even if they’re sceptical at the end of it say, ‘okay, go and check everything that you’ve heard, pick out some facts that have been shared and check them out’ —and don’t listen to mainstream media because mainstream media will deny everything. The BBC will deny everything because they’re a propaganda machine—This is not a game; this is a war.”

“You look at all the people who are involved on these committees, [and] all the doctors who are involved on these committees, and you say: ‘do you have any links [to the pharmaceutical companies]?’ ‘Oh well, of course I have —I do consultancy work for the drug companies, of course I do’.

## The Venetian Conspiracy (Part 5)

**I**AGO USES HIS THROWAWAY AGENT, THE DUPE RODERIGO, for financing and services. He sets up scenes where he cons one participant with one story, briefs another participant with a different story, brings them together in a controlled environment, and exploits the resulting fireworks for his overall strategy.

He sets up a fight between Roderigo and the drunken Cassio that leads to the wounding of Montano by Cassio, who is ousted as chief lieutenant by Othello. After this, he manipulates Desdemona's naive desire to help Cassio regain his post into prima facie evidence that Desdemona is an adulteress. Iago is then able to goad Othello all the way to killing Desdemona and, finally, himself.

At the centre of the play are epistemological questions of truth and proof. In Act 3, Iago drives Othello wild with innuendoes about Desdemona's alleged adultery, and makes him commit to the murder of Cassio, all without the slightest shred of proof.

What Othello then regards as definitive proof of adultery, sufficient to motivate the murder of Desdemona, is a handkerchief which Iago obtains and plants on Cassio.

This handkerchief is an object of deep emotional and superstitious importance for Othello, as it had been given by his father to his mother. It had been his first love token for Desdemona. When he sees it in the hands of Cassio, he is ready to kill.

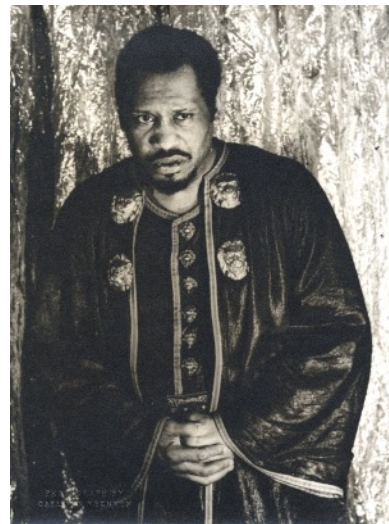
Iago is well aware of Othello's epistemological weakness. When he first obtains the handkerchief, he gloats:

**I will in Cassio's lodging lose this napkin,  
And let him find it. Trifles light as air  
Are to the jealous confirmations strong  
As proofs of holy writ; this may do  
something.**

Shortly thereafter, Othello demands certainty that Desdemona is betraying him. What would be definitive proof, Iago asks? Would you, the supervisor, grossly gape upon – Behold her tupp'd?

This kind of certainty, he says, is impossible to obtain, but he offers an inductive- deductive substitute:

But yet, I say, If imputation and strong circumstances, Which lead directly to the door of truth, Will give you satisfaction, you might haven't.



In the final scene, we can agree with Iago's wife Emilia that Othello (left) is a gull and a dolt, a "murderous coxcomb —as ignorant as dirt." But the lesson is that not only Othello, but all those who love not wisely but too well, who, "being wrought" and "perplexed in the extreme," are potential victims of Venetian intelligence.

### Destruction of the Renaissance

Since the Venetian oligarchy relied for its survival on the secret weapon of political intelligence manipulation, its primary strategic targets were first and foremost dictated by

epistemological rather than military criteria. Fleets and armies, even in the hands of a powerful and aggressive enemy state, could well rebound to Venetian advantage.

The real danger was a hostile power that developed epistemological defences against manipulation and deceit. In the face of such a threat Venice did – and does – kill.

The Italian Renaissance of the fifteenth and sixteenth centuries, perhaps the greatest outpouring of human creativity in history, represented such a threat to the Serene Republic, and in a more concentrated form than it had ever faced before.

The threat arose from the epistemological warfare and alliance system of the great Cosimo de' Medici of Florence and his successors. Venice mobilized every resource at its disposal to destroy the Renaissance. After decades of sabotage, going so far as to arrange the ravaging of Italy by foreign armies, Venice succeeded.

The potential political and epistemological power of the Italian Renaissance are best identified in the ecumenical council of the Church convened in Florence in the year 1438.

The council, first convened in Ferrara, was moved to Florence at the urging of Cosimo de' Medici, who held power from 1434 to 1464. Cosimo was the major financial and political sponsor of the proceedings.

Cosimo was a self-declared enemy of Venice. On one occasion he wrote, "Association with the Venetians brings two things which have always been rejected by men of wisdom: certain perdition and disgrace."

The council had to deal with the ongoing crisis in the western church, which had been exacerbated by the struggle between the Council of Basel and Pope Eugene IV, who had been driven out of Rome by a revolt.

In the East, the Ottoman Turks were beginning to recover from the crushing defeat that the

Turkish Emperor Bajazet had suffered in 1402 at the battle of Ankara at the hand of Tamerlane the Great. The first, unsuccessful, Turkish siege of Constantinople had already been mounted in 1422.



The hope held out by the Council of Florence was to implement Nicolas of Cusa's program of the *Concordantia Catholica* – a community of principle among humanist sovereign states for cultural and economic development, against Venetians, Turks, and all enemies of natural law.

To Florence came the Emperor of Byzantium, John VIII Palaiologos, (left) accompanied by his advisor Gemisthos Plethon and Plethon's student, Archbishop Bessarion of Nicea.

The Latin delegation was titularly headed by Pope Eugene IV, heavily dependent upon the support of Cosimo de' Medici at that time. This delegation was dominated in outlook by men like Nicolas of Cusa, Leon Battista Alberti, Leonardo Bruni, Cardinal Capranica, and Aeneas Piccolomini of Siena, later Pope Pius II. The Greek and Latin delegations were each profoundly vitiated by powerful Aristotelian factions, but this was still one of the most impressive assemblies in history.

The culmination of the council was an impassioned oration by Plethon on the antithesis between Plato and Aristotle, a speech which went far beyond anything ever heard in the West. Marsilio Ficino, himself a participant at the council, tells the story of how Cosimo de' Medici, while listening to Plethon, made up his mind to create the Platonic Academy in Florence.

The most immediate question to be addressed was the reunification of the Roman and Greek churches, abrogating the mutual excommunications issued by the pope and the patriarch of Constantinople in 1054. The contending theologians debated the question of the "filioque" in the Latin credo, attempting to resolve the question of whether the Holy Spirit proceeds only from the Father, as the Greeks argued, or from the Son as well, according to the Roman view.

The Greeks eventually agreed to recognize the correctness of the Latin position, although they declined to modify their own credo accordingly. The Paleologue emperor intervened repeatedly in these discussions, stressing that there were no real differences in doctrine, and that anyone who let nonexistent divergences stand in the way of common action against the Turks was a worse traitor than Judas. In the end a purely formal reunification of the two churches was attained, but it remained a dead letter.



Even so, Cosimo (left) and his co-thinkers came close several times to welding an alliance capable of dominating the world, and the first to pay the price of their success would have been the Venetians. Medici Florence

was at the centre of a network of trade and finance that was beginning to rival Venice, with the crucial difference that the Florentines were the producers, thanks to Cosimo's dirigism, of the textile products they offered for sale.

The Duchy of Milan would shortly come under the domination of the condottiero (mercenary commander) Francesco Sforza, installed in power with the help of the Medici, and an enemy of Venice. In 1461 the humanist Louis XI would take the throne of France.

This new king was determined to apply the concepts of statecraft developed in Italy, and considered the Venetians "insolent merchants." In 1460, the humanist Aeneas Silvius Piccolomini would be elected Pope Pius II; in the meantime he was in a position to influence Frederick III of Hapsburg, the Holy Roman Emperor.

The Venetian reaction to this potential for the implementation of an ecumenical Grand Design on the platform of the Italian Renaissance humanists was, predictably, to bring on the Turks once again. During all these years the Turks possessed a combined warehouse-residence-safe-house in Venice, the Fondaco dei Turchi, which facilitated dealings between the doge and the sultan.

Spurred on by Venetian financing and Venetian-procured artillery, the Sultan Mohammed the Conqueror laid siege to Constantinople and captured it in 1453. The Turks were aided by the Greek patriarch, who had pronounced the defence of the Paleologue dynasty a heretical cause. Finally, it was the Genoese troops who opened the gates of the city to the forces of the sultan.

Hardly a coincidence was the burning of the library of Constantinople with its matchless collection of Ionian and Platonic codices, most unavailable anywhere else since the library of Alexandria had been destroyed some fifteen centuries earlier. In their own sack of Constantinople in 1204, the Venetians had declined to appropriate these manuscripts.

The destruction of Byzantium by the Turks gave the Venetians a slogan with which to organize their war against the Renaissance. Since the Roman Empire had finally ended, it was left to the Venetians to arrogate to themselves the task of building a new Roman Empire. The foundation of a new Roman Empire became, in Venice, from the middle of the fifteenth century on, the leading obsession of the oligarchs.



"The Venetians are called new Romans," confided the patrician Bernardo Bembo (left) to his diary. Francesco Sforza of Milan wrote that the Venetians were:

"obstinate and hardened, always keeping their mouths open to be able to bite off power and usurp the state of all their neighbours to fulfil the appetite of their souls to conquer Italy and then beyond, as did the Romans, thinking to compare themselves to the Romans when their power was at its apex."

Machiavelli wrote that the Venetians had "fixed in their souls the intention of creating a monarchy on the Roman model."

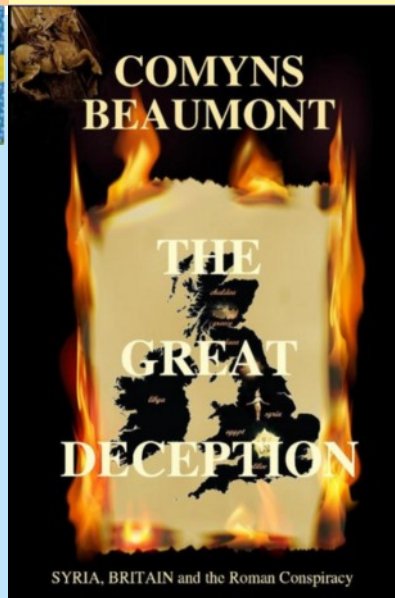

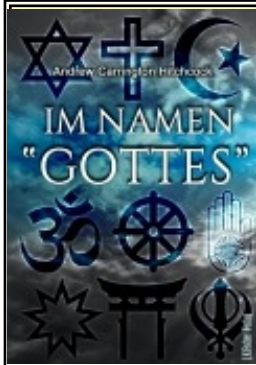

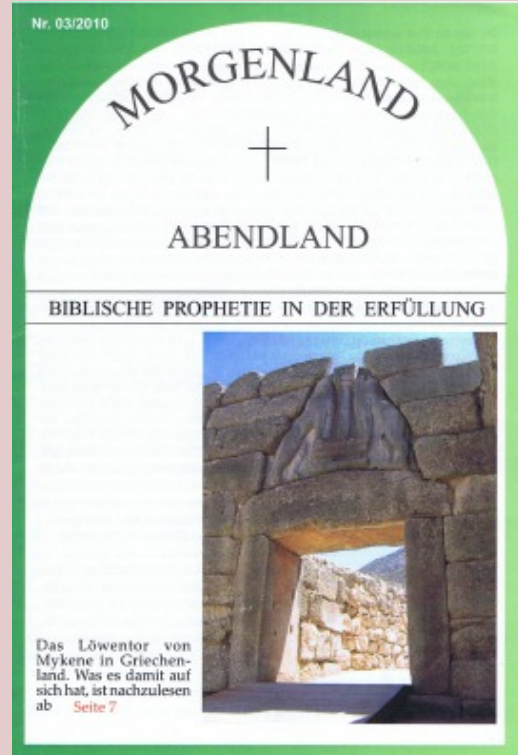
