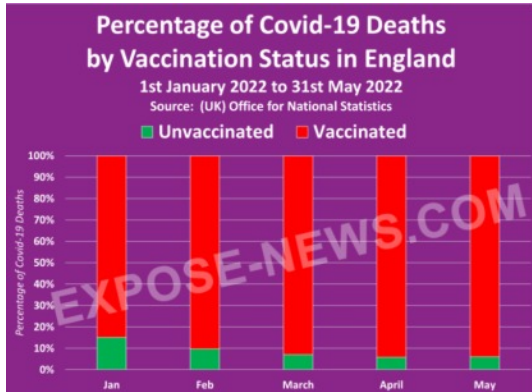

## The Enmity, Part 6: The Clash of the Bloodlines (4)

**FIRST, LET US LOOK AT STRONG'S DEFINITION OF 'GROUND,' #127, ADAMAH (PRONOUNCED "AD-AMAW"):**

**"soil (from its gen. redness): -- country, earth, ground, husband [-man] (-ry), land.**

Most dictionaries list the most common meaning first and the least common last. I want to point out three meanings which do not imply literal dirt: *husband, husbandman, husbandry*. These three words are references to people, not dirt.

Next, the word 'tree.' 'Tree' is **Strong's** #6086, ets (pronounced "ates"): *...a tree (from its firmness); hence wood (plur. sticks)...carpenter, gallows, helve...pine, plank, staff, stalk, stick, stock, timber, tree, wood.*

Notice in the middle of all those definitions the word 'carpenter.' This is a reference to a *person*, not a piece of wood.

In William Wilson's **Old Testament Word Studies**, under the word 'tree,' we are given this definition: 3.) *A tree; often collective trees; green trees the righteous, dry trees the wicked, Ez. 20:47; 17:24, all trees of the field, all men, the high tree, lofty and powerful, the low tree, the weak and contemptible.*

**Question:** Are literal trees capable of righteousness or wickedness?

George M. Lamsa, in his book, **Idioms In the Bible Explained**, gives us the following idiomatic meanings: '*garden*': *metaphorically, a wife, a family; tree of life in the midst of the garden: sex; posterity, progeny. "Tree of life": eternal life.*

If the anti-seedliners are arguing that all idiomatic language must be translated literally, then about a quarter of translated literature would never be understood. Certainly, poetry and much fiction could not even be translated, because such language is often highly figurative.

But idioms are different in that the expressions have very specific meanings that cannot be deduced from the literal definitions of the words employed. One has to know the history of the language in order to understand the meanings of idioms.

In the following verses, Scripture clearly equates trees, sticks, branches, roots and boughs with human beings:

**"Joseph is a fruitful bough" – Gen. 49:22.** According to the logic of the anti-seedliners, God is declaring that Joseph is a literal clump of small branches. Holly, perhaps?

"Behold, I will take the stick of Joseph, which is in the hand of Ephraim, and the tribes of Israel, his fellows, and will put them with him, even with the stick of Judah, and make of them one stick, and they shall be one in mine hand."

-- Ezek. 37:19. Is Yahweh declaring that He is going to turn these Israelites into literal pieces of wood?

**"If he commit iniquity, I will chasten him with the rod of men" -- II Sam. 7:14**

**"Remember thy congregation, which thou hast purchased of old; the rod of thine inheritance, which thou hast redeemed." -- Psa. 74:2.**

"And there shall come forth a rod out of the stem of Jesse, and a branch shall grow out of his roots." -- Isa. 11:1. Here we have the words, 'rod,' 'stem,' 'branch' and 'roots' all referring to the family tree of David and Messiah. Are we to understand these terms as literal pieces of wood, as the anti -seedliners would have us believe, or is the Father Himself using figurative language to convey the idea of a Family Tree?

Hundreds of examples can be adduced to show the legitimacy of translating such words as referring to human beings, not literal trees or wood. Trees bear fruit. Is the expression, "fruit

of the womb” a reference to fruit that you put on a table for consumption?

### Let’s Eat!

**Statement #2:** The word ‘eat’ can only mean eating literal food.

**Response: Strong’s Exhaustive Concordance** tells us that one of the meanings of the word ‘eat,’ *akal*, is LAY. When Eve admitted to being beguiled by nachash, was she admitting to being raped? “He tricked me!” she said. One of the definitions of the word ‘beguiled,’ *nasha*, is “seduced.”



Genesis 3:13 tells us “*And the woman said, the serpent beguiled me and I did eat.*” Why should “*And the deceiver seduced me and I did lay*” be deemed impossible in the light of these alternative meanings?

I submit that one of the listed meanings ought to be “partake,” because “to partake of” covers a wide variety of indulgences. Does “*and I did partake*” not cover the possible meanings being discussed here?

Here follow some biblical verses in which the meaning of the word ‘eat’ is clearly sexual:

“Such is the way of an adulterous woman; she eateth, and wipeth her mouth, and saith, I have done no wickedness.” -- **Proverbs 30:20.**

The context of this passage is adultery. Eating and adultery are compared synonymously.

“*And they called the people unto the sacrifices of their gods; and the people did eat, and bowed unto their gods.*” -- Num. 25:2. Here is a good spot for the word ‘partake’ in place of ‘eat.’

The **Wycliffe Bible Commentary** has this to say about the above passage, page 145: “The subject **They** is feminine, referring to the daughters of Moab with whom the men of Israel committed fornication.”

“Stolen waters are sweet, and bread eaten in secret is pleasant.” – **Prov. 19:7.**

Now, let’s read Genesis 2:17 in the light of the above context:

“But of the tree of the knowledge of good and evil, thou shalt not eat of it: for in that day that thou eatest thereof thou shalt surely die.”

We all know what it means to “*know*” in the biblical sense. It means sexual intercourse.

This verse is talking about “knowing” good and “knowing” evil. Good knowing is “kind after kind.” Evil knowing is mixing forbidden seed. The “forbidden fruit” is the race-mixed children of forbidden “eating.” And the “tree of knowledge of good and evil” is the tree of mixed offspring as a result of miscegenation.

Now, Genesis 3:15 warns of the enmity between the two resulting offspring. The Father is warning Eve of the potential death of the White Race due to race-mixing.

He is **Not** warning her of her own immediate death due to poisoning by the “literal fruit.” If that were the case, she would have died then and there. **But, no, the consequences bear upon her offspring, not just her.** If the meaning is non-sexual, how can the consequences of her sin bear upon future generations of Adamites? Look at what is happening in the world today.

The White Race is being ganged up on by all of the other races through immigration and miscegenation. Which ethnic minority is encouraging these other groups to race-mix with us? It’s the offspring of the other seedline.

### Singular Versus Plural

One of the stranger accusations hurled against two-seedline doctrine is that we distort Scripture with our interpretations. But just observe the contortions that our adversaries go through in order to argue against us. The second clause of Genesis

**3:15 states:** “*it shall bruise thy head, and thou shalt bruise his heel.*”

**Statement #3:** According to the anti-seedliners, the “bruising” does not refer to offspring in the plural but only to Jesus Christ in the singular.

The problem with this statement is that the preceding clause most definitely re-

fers to offspring, which is always a collective noun.

Collective nouns can be treated grammatically as being singular, but their meaning is always plural in the sense of a collection or group of individuals.



### The Judea Version of the Original Sin

The word ‘seed’ means “progeny, offspring, children” in so many instances that this point cannot be debated. So, instead of debating that point, the anti-seedliners jump to the second clause and try to infer that it is not referring to the collective offspring of Eve but to the singular child, Jesus.

Actually, I agree that this passage is a prophetic reference to Jesus Christ. But it **Also** means offspring in the collective sense. How else would Messiah come in the flesh anyhow? – except through all of the intermediary offspring from Seth to Mary – as even Charles Weisman admits!

The seed of all of the intervening generations is an absolute biological necessity for Jesus to be born in the flesh, of the seed of David. How can these generations be ignored in the light of the first clause of the sentence?

Grammatically, since the pronouns (‘it,’ ‘thy,’ ‘thou,’ and ‘his’) of the second clause are direct references to the collective offspring of the first clause, there is no justification in assuming either one to be singular.

The words ‘head’ and ‘heel’ are clearly figurative, so no direct, one-to-one correspondence can be assumed with regard to the first clause. If I say “You children are buzzing like a beehive,” the subject (children) is literal but the object (beehive) is figurative. The first is collective; the second is singular. I am still talking about a

collective group of children in spite of the fact that I have used a singular noun to describe them.

In effect, the anti-seedliners are admitting that there is some sort of enmity between the Serpent’s seed and the seed of the Woman, but they try to limit the “seed of the Woman” as a reference to Jesus Christ only. They think that by changing the value of the expression “his heel,” they can circumvent the seedline argument that the enemy seedline began with Cain.

But since the Adamic seedline is reckoned patriarchally, the word ‘his’ is merely a reference to the male seed (sperm) that follows in these generations. And the fact is that, throughout history, True Israel has been followed around by Jewry wherever we have gone.

They have been nipping at *our* “heel,” not just the heel of Jesus Christ! They simply will not leave us alone. The story of White Civilization is the story of how True Israel builds kingdoms and nations after which the Jews slither in, like snakes in the grass, and then subvert our culture with their usury and their pornography, gambling, infiltration of our institutions and other vices. The language of Genesis 3:15 fully bears this out.



The Serpent had his head bruised once by Titus, the Roman General (above) of Israelite stock who destroyed Herod’s Temple. It has yet to be crushed by Jesus Christ at the Second Coming.

The Serpent’s head was also bruised by Joshua, Saul, David, and all of the other Israelite Kings who made war against the Canaanites. We, as a race, have, by ignoring the constant threat that the Jews pose to our civilization, allowed them to nip at our heels throughout history. At least

twenty-two times in the history of Europe, the Jews have been evicted from our nations because of their subversive culture. **Because we are always looking ahead, we have failed to watch our backside; and the Jews always attack us from behind, from their familiar position, hiding in the grass, like serpents, waiting for a chance to bite.**

### Idiomatic Hebrew

In any language, words can have multiple meanings. If there is any doubt as to the intended meaning of any word, it is always prudent to determine, to the best of our ability, the *context* of any given passage. In real estate, the three most important factors in selling and renting are “*Location, location, location.*”

In translation, the three most important factors in determining meaning of a doubtful passage are “*Context, context, context.*” The meaning of a word and the sentence in which it is used depends on its context. The meaning is not automatically determined by the most common definition.

In addition, when we translate from one language to another, we have to take into account expressions, such as idioms and figures of speech, or the translation will be hopelessly lacking.

Idioms are very common expressions which can be at complete variance from the literal meaning. Take, for example, the expression, “*Can I give you a lift?*” I’m sure that this idiom harkens back to the horse and buggy, stagecoach days when a person often needed help getting up into the buggy or stagecoach.

Today, whoever uses this expression means “*Can I give you a ride?*” or “*Can I take you to your destination?*” The word ‘lift’ has nothing to do with riding in a vehicle. Its dictionary definition is “to raise up.” Yet, everyone who uses this expression knows that it means “*Can I give you a ride?*”

Ancient Hebrew was no exception. Idiomatic expressions abound in Scripture and, in order to understand a given passage, one **MUST** take into account idiomatic usage before assuming a literal interpretation.

Unfortunately, the King James Version of the Bible, has, among its many faults, a severe lack of consideration for idiomatic expressions in its translation. Other faults include the fact that it is based on the Jewish Masoretic text. The



### Jewish Masoretic Scribe

Masoretes were Pharisaic Jews who rewrote the Old Testament in order de-emphasize the prophetic role that Messiah Jesus would play. They also took out the 7000 instances of the word ‘Yahweh’ and replaced it with LORD.

Their excuse for doing this is the claim that “*The name of g-d is too holy to be pronounced.*” However, there is nothing in Scripture which validates this claim. **The claim is Talmudic, not Biblical!!**

On the contrary, the Bible repeatedly admonishes us to “*Publish the name of Yahweh.*” (Deut. 32:3), not deny its use. The Third Commandment says we are not to take His name in vain. **It does not say we are to stop using it.** How can you take His name in vain if you don’t use it? This is a blatant example of false Jewish piety. With Rothschild’s trillions, the rabbinate spends man-years of time devising slogans which will deceive the goyim.

Another one of their brilliant deceptions is the claim that the rabbis “study” the Torah. Yes, they study the Bible, but they don’t **Teach** it, nor do they practice it. They teach the Talmud instead. Those who don’t understand the nature of Jewish deceptions naturally assume that they teach what they study! The sheep are so gullible, aren’t they?

If we are using exclusively a text that does not take idiomatic expressions into account, we have a serious problem. We are missing out on the meanings employed by the original authors. The translators have let us down.

The fact is that, idiomatically, the words "tree", "fruit", "branch" and "seed" are repeatedly used in the Bible to refer to human offspring, **the genealogical tree.**

**There is no justification for us to deviate from this dual usage of words, literal and idiomatic. If an idiomatic expression is used more than once in Scripture, and consistently**

**so in different Books, then we have to give serious thought as to whether to translate literally or idiomatically.** This is nothing less than honest scholarship.

Given everything presented here up to this point, the anti-seedliners' blanket denial of idiomatic usage is absurd. From the point of view of scholarship, it is an untenable position. It will not do to simply declare idiomatic interpretations invalid. You have to give an account of why a literal translation is preferable to the idiomatic translation. The anti-seedliners have not done this; nor is it likely that they can do it with regard to Genesis Chapters 2-4.

The anti-seedliners are adamant that these words can only be taken literally. They insist that any figurative or idiomatic interpretation which implies sexuality is invalid.

Given the above examples cited from Scriptures outside of Genesis 3 and 4, can this proposition be taken seriously? By not taking Hebrew idioms into account, the anti-seedliners have jumped to a premature conclusion. In essence, what they are saying is "*You can only use my interpretation. You cannot use your idiomatic interpretation.*" I'm afraid that this is simply a closed-minded attitude, and we all must understand it for exactly what it is.

Another great example of an idiomatic expression is "*turned into a pillar of salt.*" When Lot's wife looked back at Sodom and Gomorrah, was she transmogrified into a literal pillar of salt? Possibly, but the idiomatic expression we are dealing with is still used in the Middle East today to mean "*petrified with fear.*"

Evidently, what she saw was quite astounding and terrifying. Scripture just leaves it at that. If she were turned into a literal pillar of salt, then

the experience would have killed her. If she was frozen in her tracks from terror, she may have recovered. Then again, she might have been scared to death, literally.

The word translated as "pillar" in Gen. 19:26 is #5333, *netsib*, meaning "*stationary, i.e. a prefect, a military post, a statue....*" The implication is standing erect or standing still, like a soldier at attention.

As listed in **Strong's Concordance**, this is the only use of this word in Scripture. A more common word for pillar is #4676, *matstsebah*, meaning "*something stationed, i.e. a column (or memorial stone).*" Here we have a slightly different shade of meaning, implying something set in place, like a stone pillar.

Here, again, the idiomatic meaning of an expression must be considered to see what the writer truly intended.

Since the translators of the KJV were apparently not aware of this idiom, they were left with only one possible translation: Lot's wife was literally turned into salt. Does the punishment fit the crime? Or was she, as the idiomatic translation implies, *petrified by fear*?

Do you, dear reader, still think idiomatic expressions should always be translated literally? At the very least, the reader should be made aware of the idioms so he can consider the alternatives. Apparently the anti-seedliners are either unaware of the idiomatic nature of ancient Hebrew or they don't want you to consider it.

Wouldn't you want to know about any relevant idioms? Wouldn't you want to know that, if someone wanted to give you some "ecstasy," it is only by means of a dangerous drug?

## Old Testament

### "Word for Word" Exodus Part 11

### Translation by Stephen Howard Anderson

## Chapter 15



**[Note - This is a song in Hebrew. The tune for it is lost, and so is the one for Mir'yam's song]**

**1.** Then sang Mosheh and the children of Yis'rael this song to Yahweh, and spoke, saying, "I will sing to

Yahweh, because He has triumphed gloriously *1342*: the horse and its rider He has thrown into the sea.

**2.** Yah *3050* is my strength *5957* and my song, and He is become my salvation *3444*: He is Eliy *410*, and I will prepare Him a habitation *5115*; Elohey *430* my father, and I will exalt *7311* Him.

**3.** Yahweh is a man of war *4421*: Yahweh is His Name!



**4.** Paroh's chariots and his army He has cast into the sea: his chosen captains are also drowned in the Sea of Reeds.

**5.** The depths have covered them: they sank into the bottom as a stone.

**6.** Your right hand, O Yahweh, is become glorious *142* in power *3581*: Your right hand, O Yahweh, has shattered *7492* the hated enemy *341*.

**7.** In the greatness of Your excellency You have overthrown *2040* those that rose up against You: You sent forth Your burning wrath *2740*, which consumed them as stubble *7179*.

**8.** With the blast *7307* of Your nostrils *639* the waters were gathered together *6192*, the floods *5140* stood upright *5324* as a heap, and the depths *8415* were congealed *7087* in the heart of the sea.

**9.** Said the hated enemy, "I will pursue, I will overtake, I will divide the spoil; my desire *5315* shall be filled *4390* upon them; I will draw my sword, my hand shall destroy *3423* them!"

**10.** You blew with Your wind, the sea covered them: they sank as lead *5777* in the mighty waters.

**11.** Who is like unto You *3644*, O Yahweh, among the elim *410*? Who is like You, glorious in holiness, revered in praises, doing wonders?

**12.** You stretched out Your right hand, the land swallowed them.

**13.** You in Your mercy *2617* have led forth *5148* the people which You have redeemed *1350*: You have guided them in Your strength to Your holy habitation.

**14.** The people shall hear, and be afraid *7264*; sorrow shall take hold on the inhabitants of Pelasheth *6429*.

**15.** Then the chieftains *441* of Edom shall tremble *926*; the chieftains *352* of Moab, trembling *7461* shall take hold of *270* them; all the inhabitants of Kenaan shall melt away.

**16.** Fear *367* and dread *6343* shall fall upon them by the greatness of Your arm they shall be as still *1826* as a stone; until Your people pass through, O Yahweh, until the people pass through which You have purchased *7609*.

**17.** You shall bring them in, and plant them in the mountain of Your inheritance *5159*, in the place, O Yahweh, which You have made for You to dwell in, in the Sanctuary *4720*, O Yahweh, which Your hands have established,

**18.** Yahweh shall reign forever *5769* and ever *5703*!



**19.** Because the horse of Par'oh went in with his chariots and with his horsemen into the sea, and Yahweh turned back the waters of the sea upon them; but the children of Yis'rael went on dry



land in the midst of the sea!" (End of Mosheh's Song)

20. And Miryam 4813 the prophetess 5031, the sister of Aharon, took a tambourine 8596 in her hand; and all the women went out after her with tambourines and with dances.

21. And answered Miryam to them, "Sing you to Yahweh, because He is lifted up in triumph 1342; the horse and his rider He has thrown into the sea!" (End of Miryam's Song)

22. So brought Mosheh Yis'rael from the Sea of Reeds, and they went out into the wilderness of Shur; and they went three days into the wilderness, and found no water.

23. When they came to Marathah 4785, they could not not drink of the waters of Marah 4785, because they were bitter 4751: so therefore the name of it was called Marah.

24. And murmured 3885 the people against Mosheh, saying, "What shall we drink?"

25. And cried he to Yahweh; and showed Yahweh him a tree 6086, which when he had cast into the waters, the waters were made sweet: there He made for them a statute and an ordinance, and there He tested 5254 them,

26. and said, "If you will listen to the voice of Yahweh Eloheycha 430, and will act uprightly 3477 in My sight, and will give ear 238 to My commandments, and keep all My statutes, I will put none of these diseases 4245

on you, which I have brought upon the Mits'rayim: because I am Yahweh that heals you 7495."

27. And came they to Eylimah 362, where there were twelve springs 5869 of water, and seventy palm trees 8558: and encamped they there by the waters.

## Chapter 15 Notes

Verse 1 - Rev. 15:3 - The Song of Mosheh, and that of Miryam, are victory songs. Yahweh said He would "get honor" upon Paroh, and He did.

Verse 2 - Psalms 118:14; Isaiah 12:2;

Verse 3 - It leaves no doubt as to the proper Name, YHWH is His Name. In several places, the Name was replaced with adonay 136 in this chapter, and I have restored it.

Verse 23 - There was a chemical problem with the waters at Marah. The tree probably had a neutralizing agent in it, and that is why Yahweh told Mosheh to toss it in the water. Remember - Yahweh invented both chemistry, and water.

Verse 26 - The big IF comes into play again. This is the test 5254 - obey, or not obey. It seems an easy choice, but how much trouble do we have doing it today? This is why The Messiah came to make propitiation for us. The word for "uprightly" - yashar, is the same as in "The Book of Yashar (Jasher), or "The Book of the Upright".

## The Hoskins Report Chapter 265 Volksverraad - Betrayal - Review (Part 2) By Piet Pretorius



### Why The Big Lie

**S**AXONS ARE CHRISTIANS - OR THEY ARE NOTHING. CHRISTIANS BELIEVE THAT "WE MUST OBEY GOD RATHER THAN MEN." ACTS 5:29. The establishment churches, claiming to be spiritual Israel, teach that man-made statutes are to be followed instead. To keep Saxons quiet, establishment priests promote the following three things:

## 1. They Teach the Dogma That All the People of World Are Descended from Noah[6].

The doctrine that Whites and non-Whites both originated in one set of ancestors logically results in the silly theory that separate races must be a myth and that one God fathered us all. This theory violates the **WORD** and nullifies God's command, "A bastard (Heb: mamzêr - mixed breed, mongrel) shall not enter into the congregation of Israel."

**Deut 23:2.** The dogma drags on to its logical conclusion which is that since everyone is descended from Noah, all must be bastards (mixed- breeds) from the beginning[7]. Noah carried non-Whites on his ark, but not as "blush red" men, but under another name.

### 2. Ignore the Word MAN

Ignoring the word man ("blush red") permits the Establishment Church to continue to receive tribute from man and human (hued-man) alike. The Establishment Church sits securely on its ancient feudal throne proclaiming that it holds the keys to heaven, while carefully protecting itself with hired politicians and their mercenary armies. This is near the centre of Babylon where the Saxon-Israel message is banned[9].

### Back To The Book

Both proclaim that Saxon-Israel is composed of 10 tribes, 10 the other two tribes being the Jews - one of which is Judah. The Jews say that being Judah gives them the right to rule the rest of Israel - meaning us[11].

## Manassah Ben Israel Letter of Commendation



The most interesting thing about the book is the Letter of Commendation in the front, from Rabbi Abraham Feld of the Maccabee Institute, POB 31264, Jerusalem, Israel. He states that, "Upon reading Mr. Yari Davidy's book on the dispersion of the ten lost tribes, and contemplating on how most people will receive this as startling new information, I was reminded of a law that US President Bush recently endorsed."

This law was passed on March 20, 1992, when President Bill Clinton signed a joint Resolution of both Houses of Congress recognizing the Seven Noahide Laws as the "bedrock of society from the dawn of civilization" and urged America to "return the world to the moral and ethical values contained in the Seven Noahide Laws[12]."

Rabbi Feld continued, "This —is at once a recognition of Torah's relevancy and a basis for a common denominator among all the nations of the world ... a common heritage and bloodline that so many people share unbeknownst to themselves."

Now comes the punch line, "—the Jerusalem Talmud declares in the days to come the ten tribes will be righteous converts (Sanhedrin, 10)" and concludes, "We of Mosad Maccabee have only the highest praise and respect for this valuable contribution to understanding our roots and heritage." This is an interesting admission. It spells out what we have long suspected, and that is, the Establishment Church has its itinerary and the Jews have theirs. ## **The Invisible Rainbow Irritable Heart (Part 3) By Arthur Firstenburg**



Coronary heart disease appeared even more suddenly. In fact, before 1945 the disease did not exist in the zoo[13]. And the first heart attacks ever recorded in zoo animals occurred ten years later, in 1955.

Arteriosclerosis had been occurring with some regularity since the 1930's in the aorta and other arteries, but not in the coronary arteries of the heart. But sclerosis of the coronary arteries now increased so rapidly among both mammals and birds that by 1963, over 90 percent of all mammals and 72 percent of all birds that died in the zoo had coronary disease, while 24 percent of the mammals and 10 percent of the birds had had heart attacks.

And a majority of the heart attacks were occurring in young animals in the first half of their expected life spans. Arteriosclerosis and heart disease were now occurring in 45 families of

mammals and 65 families of birds residing in the zoo—in deer and in antelope; in prairie dogs and squirrels; in lions, and tigers, and bears; and in geese, storks, and eagles.

Diet had nothing to do with these changes. The increase in arteriosclerosis had begun well before 1935, the year that more nutritious diets were introduced throughout the zoo. And coronary disease did not make its appearance until ten years later, yet the animals' diets were the same at all times between 1935 and 1964.

The population density, for mammals at least, remained about the same during all fifty years, as did the amount of exercise they got. Ratcliffe tried to find the answer in social pressures brought about by breeding programs that were begun in 1940.

He thought that psychological stresses must be affecting the animals' hearts. But he could not explain why, more than two decades later, coronary disease and heart attacks were continuing to increase, spectacularly, throughout the zoo, and among all species, whether or not they were being bred.

Nor could he explain why sclerosis of arteries outside the heart had increased during the

1930's, nor why, thousands of miles away, researchers were finding arteriosclerosis in 22 percent of the animals in the London Zoo in 1960[14], and a similar number in the Zoo of Antwerp, Belgium in 1962[15].

The element that increased most spectacularly in the environment during the 1950's when coronary disease was exploding among humans and animals was radio frequency (RF) radiation.

Before World War II, radio waves had been widely used for only two purposes: radio communication, and diathermy, which is their therapeutic use in medicine to heat parts of the body.



**RF Oscillator**

Suddenly the demand for RF generating equipment was unquenchable. While the use of the telegraph in the Civil War had stimulated its commercial development, and the use of radio in World War I had done the same for that technology, the use of radar in World War II spawned scores of new industries.

RF oscillators were being mass produced for the first time, and hundreds of thousands of people were being exposed to radio waves on the job—radio waves that were now used not only in radar, but in navigation; radio and television broadcasting; radio astronomy; heating, sealing and welding in dozens of industries; and “radar ranges” for the home.

Not only industrial workers, but the entire population, were being exposed to unprecedented levels of RF radiation.

For reasons having more to do with politics than science, history took opposite tracks on opposite

sides of the world. In Western Bloc countries, science went deeper into denial. It had buried its head, ostrich-like, in the year 1800, as we saw in chapter 4, and now simply piled on more sand. When radar technicians complained of headaches, fatigue, chest discomfort, and eye pain, and even sterility and hair loss, they were sent for a quick medical exam and some blood work.



When nothing dramatic turned up, they were ordered back to work[16]. The attitude of Charles I. Barron, (left) medical director of the California division of Lockheed Aircraft Corporation, was typical. Reports of illness from microwave radiation “had all too often found their way into lay publications and newspapers,” he said in 1955.

He was addressing representatives of the medical profession, the armed forces, various academic institutions, and the airline industry at a meeting in Washington, DC. “Unfortunately,” he added, “the publication of this information within the past several years coincided with the development of our most powerful airborne radar transmitters, and considerable apprehension and misunderstanding has arisen among engineering and radar test personnel.”

He told his audience that he had examined hundreds of Lockheed employees and found no difference between the health of those exposed to radar and those not exposed.

However, his study, which was subsequently published in the *Journal of Aviation Medicine*, was tainted by the same see-no-evil attitude. His “unexposed” control population were actually Lockheed workers who were exposed to radar intensities of less than 3.9 milliwatts per square centimetre—a level that is almost four times the legal limit for exposure of the general public in the United States today.

Twenty-eight percent of these “unexposed” employees suffered from neurological or cardiovascular disorders, or from jaundice, migraines, bleeding, anaemia, or arthritis. And when Barron took repeated blood samples from his “exposed” population—those who were exposed to more than 3.9 milliwatts per square centimetre—the

majority had a significant drop in their red cell count over time, and a significant increase in their white cell count. Barron dismissed these findings as “laboratory errors[17].”

The Eastern Bloc experience was different. Workers’ complaints were considered important. Clinics dedicated entirely to the diagnosis and treatment of workers exposed to microwave radiation were established in Moscow, Lenin-grad, Kiev, Warsaw, Prague, and other cities.

On average, about fifteen percent of workers in these industries became sick enough to seek medical treatment, and two percent became permanently disabled[18].



The Soviets and their allies recognized that the symptoms caused by microwave radiation were the same as those first described in 1869 by American physician George Beard. (Left) Therefore, using Beard’s terminology, they called the symp-

toms “neurasthenia,” while the disease that caused them was named “microwave sickness” or “radio wave sickness.”

Intensive research began at the Institute of Labour Hygiene and Occupational Diseases in Moscow in 1953. By the 1970’s, the fruits of such investigations had produced thousands of Publications[19]. Medical textbooks on radio wave sickness were written, and the subject entered the curriculum of Russian and Eastern European medical schools.

Today, Russian textbooks describe effects on the heart, nervous system, thyroid, adrenals, and other organs[20].

Symptoms of radio wave exposure include headache, fatigue, weakness, dizziness, nausea, sleep disturbances, irritability, memory loss, emotional instability, depression, anxiety, sexual dysfunction, impaired appetite, abdominal pain, and digestive disturbances. Patients have visible tremors, cold hands and feet, flushed face,

hyperactive reflexes, abundant perspiration, and brittle fingernails.

Blood tests reveal disturbed carbohydrate metabolism and elevated triglycerides and cholesterol. Cardiac symptoms are prominent. They include heart palpitations, heaviness and stabbing pains in the chest, and shortness of breath after exertion. The blood pressure and pulse rate become unstable. Acute exposure usually causes rapid heartbeat and high blood pressure, while chronic exposure causes the opposite: low blood pressure and a heartbeat that can be as slow as 35 to 40 beats per minute.

The first heart sound is dulled, the heart is enlarged on the left side, and a murmur is heard over the apex of the heart, often accompanied by premature beats and an irregular rhythm.

The electrocardiogram may reveal a blockage of electrical conduction within the heart, and a condition known as left axis deviation. Signs of oxygen deprivation to the heart muscle—a flattened or inverted T wave, and depression of the ST interval—are extremely frequent.



Congestive heart failure is sometimes the ultimate outcome. In one medical textbook published in 1971, the author, Nikolay Tyagin, (above) stated that in his experience only about fifteen percent of workers exposed to radio waves had normal EKGs[21].

Although this knowledge has been completely ignored by the American Medical Association and is not taught in any American medical school, it has not gone unnoticed by some American researchers.

Trained as a biologist, Allan H. Frey became interested in microwave research in 1960 by following his curiosity. Employed at the General Electric Company’s Advanced Electronics Center at Cornell University, he was already explor-

ing how electrostatic fields affect an animal's nervous system, and he was experimenting with the biological effects of air ions.



Late that year, while attending a conference, he met a technician from GE's radar test facility at Syracuse (above), who told Frey that he could hear radar. "He was rather surprised," Frey later recalled, "when I asked if he would take me to a site and let me hear the radar. It seemed that I was the first person he had told about hearing radars who did not dismiss his statement out of hand[22]."

The man took Frey to his work site near the radar dome at Syracuse. "And when I walked around there and climbed up to stand at the edge of the pulsating beam, I could hear it, too," Frey remembers. "I could hear the radar going zip-zip[23]."

This chance meeting determined the future course of Frey's career. He left his job at General Electric and began doing full-time research into the biological effects of microwave radiation.

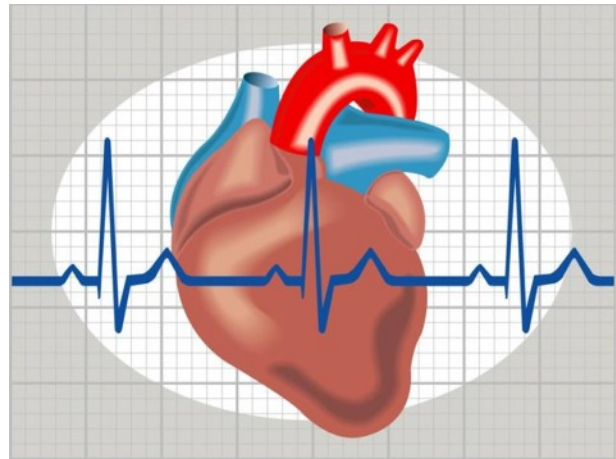
In 1961, he published his first paper on "microwave hearing," a phenomenon that is now fully recognized although still not fully explained. He spent the next two decades experimenting on animals to determine the effects of microwaves on behaviour, and to clarify their effects on the auditory system, the eyes, the brain, the nervous system, and the heart.

He discovered the bloodbrain barrier effect, an alarming damage to the protective shield that keeps bacteria, viruses, and toxic chemicals out of the brain—damage that occurs at levels of radiation that are much lower than what is emitted by cell phones today. He proved that nerves, when firing, emit pulses of radiation themselves, in the infrared spectrum. All of

Frey's pioneering work was funded by the Office of Naval Research and the United States Army. When scientists in the Soviet Union began reporting that they could modify the rhythm of the heart at will with microwave radiation, Frey took a special interest.

N. A. Levitina, in Moscow, had found that she could either speed up an animal's heart rate or slow it down, depending on which part of the animal's body she irradiated. Irradiating the back of an animal's head quickened its heart rate, while irradiating the back of its body, or its stomach, slowed it down[24].

Frey, in his laboratory in Pennsylvania, decided to take this research one step farther. Based on the Russian results and his knowledge of physiology he predicted that if he used brief pulses of microwave radiation, synchronized with the heartbeat and timed to coincide precisely with the beginning of each beat, he would cause the heart to speed up, and might disrupt its rhythm.



## Heart Arrhythmias

It worked like magic. He first tried the experiment on the isolated hearts of 22 different frogs. The heart rate increased every time. In half the hearts, arrhythmias occurred, and in some of the experiments the heart stopped.

The pulse of radiation was most damaging when it occurred exactly one-fifth of a second after the beginning of each beat. The average power density was only sixtenths of a microwatt per square centimetre—roughly ten thousand times weaker than the radiation that a person's heart would absorb today if he or she kept a cell phone in a shirt pocket while making a call.



Frey conducted the experiments with isolated hearts in 1967. Two years later, he tried the same thing on 24 live frogs, with similar though less dramatic results. No arrhythmias or cardiac arrests occurred, but when the pulses of radiation coincided with the beginning of each beat, the heart speeded up significantly[25]

The effects Frey demonstrated occur because the heart is an electrical organ and microwave pulses interfere with the heart's pacemaker. But in addition to these direct effects, there is a more basic problem: microwave radiation, and electricity in general, starves the heart of oxygen because of effects at the cellular level.

These cellular effects were discovered, oddly enough, by a team that included Paul Dudley White. In the 1940's and 1950's, while the Soviets were beginning to describe how radio waves cause neurasthenia in workers, the United States military was investigating the same disease in military recruits.

The job that was assigned to Dr. Mandel Cohen and his associates in 1941 was to determine why so many soldiers fighting in the Second World War were reporting sick because of heart symptoms.

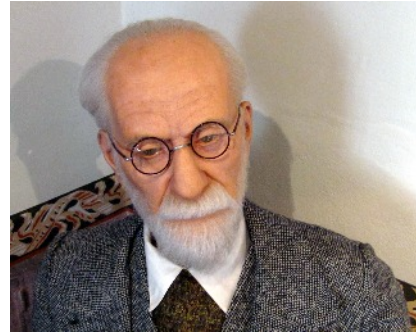


**Pennsylvania Medical Library**

Although their research spawned a number of shorter articles in medical journals, the main body of their work was a 150-page report that has been long forgotten.

It was written for the Committee of Medical Research of the Office of Scientific Research and Development—the office that was created by President Roosevelt to coordinate scientific and medical research related to the war effort. The only copy I located in the United States was on a single deteriorating roll of microfilm buried

in the Pennsylvania storage facility of the National Library of Medicine[26].



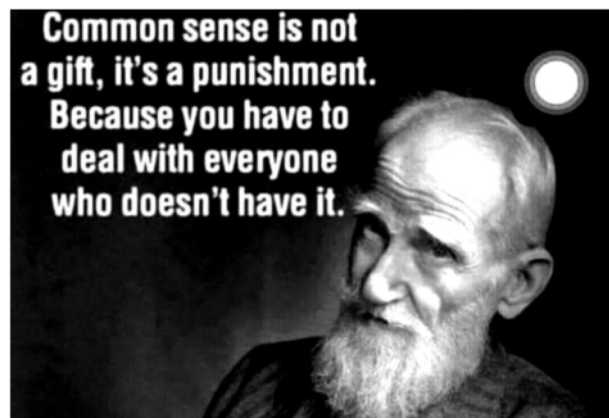
Unlike their predecessors since the time of Sigmund Freud, this medical team not only took these anxiety-like complaints seriously, but looked for and found physical abnormalities in the majority of these patients.

They preferred to call the illness “neuro-circulatory asthenia,” rather than “neurasthenia,” “irritable heart,” “effort syndrome,” or “anxiety neurosis,” as it had variously been known since the 1860's. But the symptoms confronting them were the same as those first described by George Miller Beard in 1869 (see chapter 5).

Although the focus of this team was the heart, the 144 soldiers enrolled in their study also had respiratory, neurological, muscular, and digestive symptoms. Their average patient, in addition to having heart palpitations, chest pains, and shortness of breath, was nervous, irritable, shaky, weak, depressed, and exhausted. He could not concentrate, was losing weight, and was troubled by insomnia. He complained of headaches, dizziness, and nausea, and sometimes suffered from diarrhoea or vomiting. Yet standard laboratory tests—blood work, urinalysis, X-rays, electrocardiogram, and electroencephalogram—were usually “within normal limits.”

# The Original 'NWO' Conspiracy Theorist

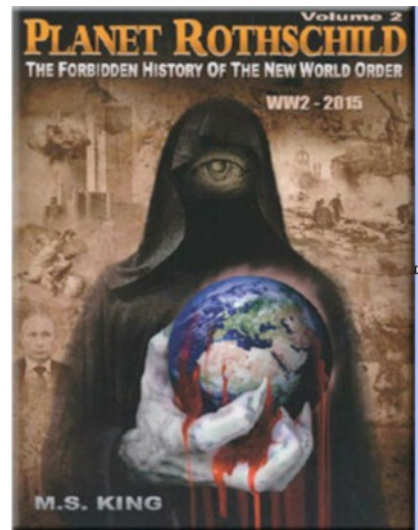
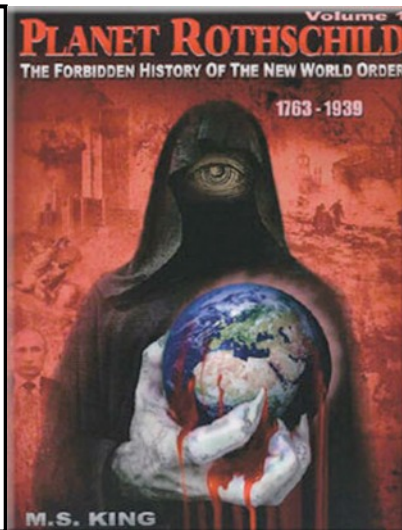
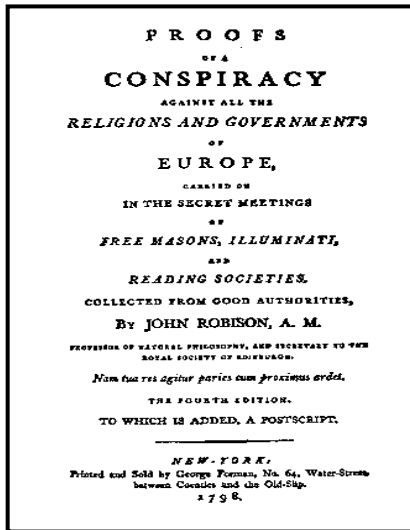

**J**OHAN ROBISON WAS A PROMINENT PHYSICIST, mathematician and professor of philosophy at Scotland's Edinburgh University. He worked with **James Watt** on the early steam car and he later invented the siren. As one of Europe's leading intellectuals -- in an age when that actually meant something -- the conspiratorial Illuminati had attempted to recruit into their ranks, but he declined. **Robison on the Illuminati:**

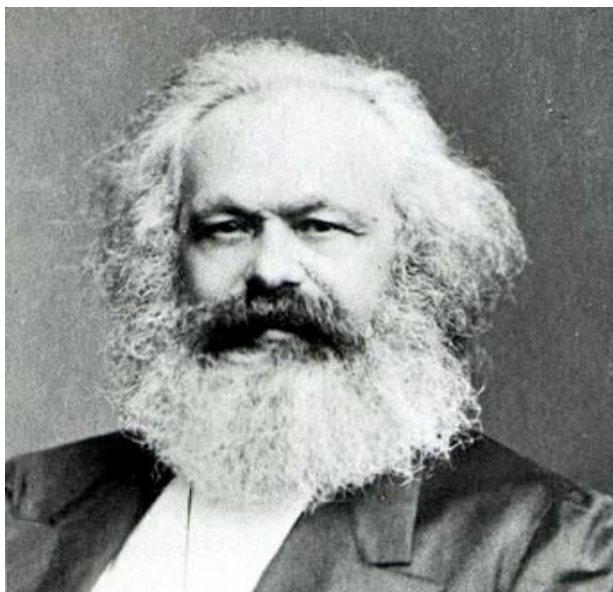
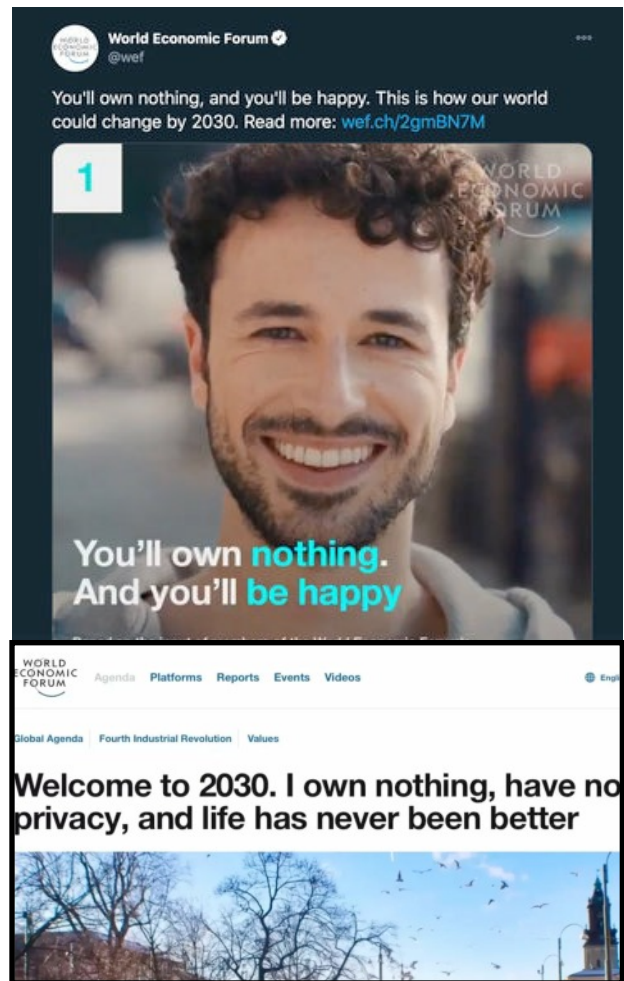

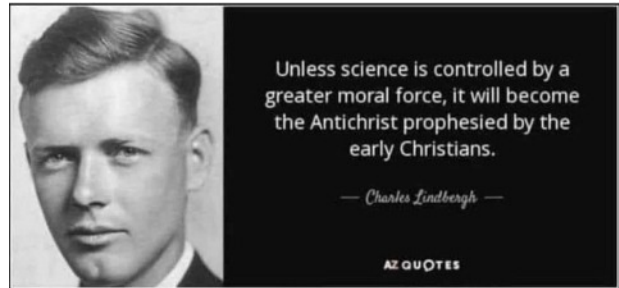
### Letter to Charles III

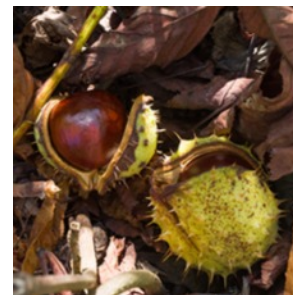

### Horse Chestnut Laundry Detergent

Sir\_ Horse chestnuts (conkers) are high in saponin – a natural detergent that removes dirt and grime from clothing. Autumn is the perfect time to collect conkers. They are easy to identify (pic. below).



**Nb: Do Not Consume Horse Chestnuts as They Are Toxic. Thoroughly Wash All Kitchen Items and Surfaces That Come into Contact with the Nuts.**

#### Method

Using a strong kitchen knife and cutting board, cut the conkers into large chunks. Alternatively, wrap a handful in a kitchen towel and whack really hard with a hammer to break them up.

Place the large broken pieces into a high-power blender and grind/pulse until they are crumbled (pic below).

Spread the conker crumb onto baking trays or dishes and place in a warming oven or bottom oven shelf on the lowest setting. The aim is to

dehydrate the crumb (not cook them), which can take a minimum of 2-3 hours, but often much longer. Keep checking the moisture level from time to time.

When the crumb is dehydrated and cooled, place in a storage container and label it. Adding a small muslin bag of rice to the container will help to draw out any remaining moisture and prevent mould.

**To Use (Per Load)**



Place a large heaped tablespoon or approx. 40-50g of crumb into a cup and add a little warm water (roughly 1:2 ratio by volume). Leave for 20-30 minutes so the saponin leeches out and the liquid turns milky.

Strain the liquid into a second cup and then discard the crumb.

Add the liquid to your washing machine in the usual manner. **Yours truly, Diana Coleman, UK.**

God is within us and around us is his creation, what more could we possibly need? **Yours truly, Laura, USA.**



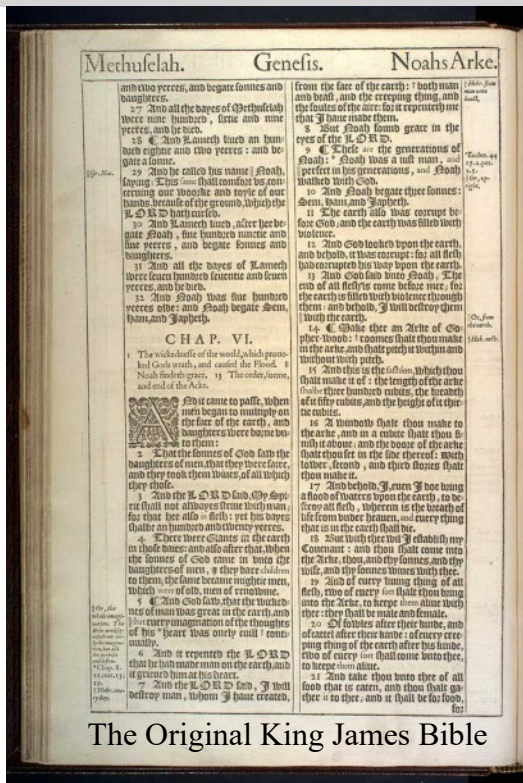

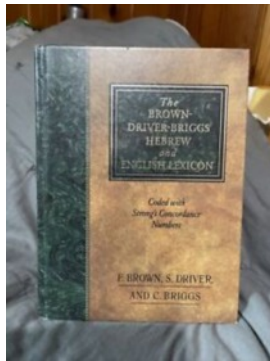

**Robert Baker Girdlestone**[6] argued in 1871 the word comes from the hif'il causative stem, implying that the Nephilim are to be perceived

as 'those that cause others to fall down'. Ronald Hendel states that it is a passive form: 'ones who have fallen', grammatically analogous to paqid 'one who is appointed' (i.e., a deputy or overseer), asir 'one who is bound' (i.e., a prisoner), etc.[7][8]

The majority of ancient biblical translations - including the Septuagint, Theodotion, Latin Vulgate, Samaritan Targum, Targum Onkelos, and Targum Neofiti - interpret the word to mean "giants." [9] Symmachus translates it as "the violent ones" [10][11][12] and Aquila's translation has been interpreted to mean either "the fallen ones" [10] or "the ones falling [upon their enemies]." [12][13]

## Thatcher's Right-Hand Man Was MI5 Target From Jailing Opinions



This investigation of Sir Keith Joseph – who was to serve in Conservative cabinets during the 1960's, '70's and '80's and was considered the closest political ally of Prime Minister Margaret Thatcher – caused panic among MI5 officers in the summer of 1948, though at the time Sir Keith was a little-known financier, recently returned from war service.

So obscure was the future minister – eight years before being elected to Parliament – that MI5 staff resorted to looking him up in *Who's Who!*



**L**AST WEEK THE REAL HISTORY BLOG REVEALED that the grandfather of Tom Tugendhat – a candidate for leadership of the Conservative Party and now seen as a potential Foreign Secretary or Defence Secretary in the next government – [was investigated for decades by MI5 due to his links to international criminals, arms dealers, and leading Zionists including the father of Israel's nuclear weapons programme.](#)

Today we examine documents showing that one of the most prominent British politicians of the 20th century was also targeted by MI5 – the UK's Security Service which counters subversion, espionage and terrorism.

His name had come to their attention during MI5's interception of correspondence between

the Jewish Agency offices in London and the newly created state of Israel's representative at the United Nations, Abba Eban.

Like Joseph, Eban was a young Jew who served in the British Army during the Second World War – in Eban's case as a secret liaison with Zionist agents working in cooperation with Britain's Special Operations Executive – the 'dirty tricks' department of the British war effort.

Before his appointment to the UN, Eban was regarded by MI5 as one of the most important operatives of an increasingly aggressive Zionist secret service engaged in propaganda, intelligence gathering, arms smuggling and even terrorism.

He was posted to London in October 1946 alongside Teddy Kollek (future Mayor of Jerusalem) to create a new and more active Zionist intelligence operation, officially working for the Jewish Agency.

British security and intelligence officers knew that for several years supposed 'moderates' at the Agency, especially Eban's ultimate boss David Ben Gurion, had coordinated terrorist and other subversive acts with rival Zionist groups including Menachem Begin's Irgun and Yitzhak Shamir's Stern Gang.

At other times however the likes of Ben Gurion and Eban had been bitter enemies of Begin and Shamir (each of whom later became Israeli prime ministers in their turn, while Eban served as deputy prime minister from 1963 to 1966 and foreign minister from 1966 to 1974).

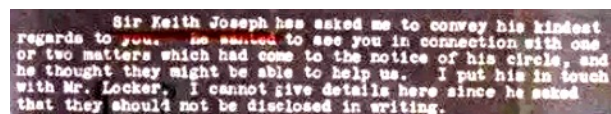
Hence Abba Eban and his Jewish Agency offices in London were an important surveillance target for MI5.

In June 1946 the Agency's offices in Palestine (then ruled as a British mandate) were raided as part of Operation Agatha, a counter-terrorist operation by the British Army involving 2,700 arrests, including senior Agency personnel. British code breakers had been reading the Jewish Agency's secret communications, so MI5 and its sister service MI6 knew that Ben Gurion's disavowal of involvement in terrorism was bogus.

By 1948 their concern had shifted to Zionist money-laundering and arms dealing for the new Israeli state: Abba Eban and Teddy Kollek were leading figures in these secret deals.

It was against this background that MI5 officers opened a letter from the Jewish Agency to Eban, posted on 4th June 1948. Formerly top secret records now available at the UK National Archives show that one paragraph in the letter was heavily underlined by the MI5 department specialising in Zionist terrorism, espionage and subversion. It read:

***“Sir Keith Joseph has asked me to convey his kindest regards to you. He wanted to see you in connection with one or two matters which had come to the notice of his circle, and he thought they might be able to help us. I put him in touch with Mr Locker. I cannot give details here since he asked that they should not be disclosed in writing.”***

Berl Locker was the chairman of the Jewish Agency's board of directors, and a long time ally of Chaim Weizmann, newly installed as the first President of Israel.

An MI5 officer passed an urgent request to the service's registry, which in those mostly pre-computer days kept a massive card index of spies, saboteurs, terrorists, and just about anybody regarded as dangerous to the security of the state: "Please look up Sir Keith Joseph

everywhere you can think of – including *Who's Who!*”

MI5's Pamela Stibel sent a memo to her colleague David Scherr, another young MI5 high-flyer who had run cross-border operations from Gibraltar against the German secret service. Postwar Scherr and Stibel had become specialists on the new threat to Britain from Zionist intelligence and terrorist organisations:



#### **David Scherr: MI5 Specialist on Zionist Espionage and Terrorism**

“David – What, if anything, can we do about the para side-lined re Sir Keith Joseph?”

Scherr replied that no action should yet be taken against Joseph, except to enter his name in MI5's card index of Zionist suspects, and to copy the intercepted letter into the MI5 files on Abba Eban and Berl Locker.

An entry for Sir Keith was drawn from *Who's Who* and added to the file, noting that he was a 30-year-old baronet who had inherited the title from his father, Bovis construction tycoon Sir Samuel Joseph, in 1944 while serving in the

Middle East as a captain in the Royal Artillery. He had since become a barrister and Lloyds underwriter, and had begun to cement a position in the British establishment as a Fellow of All Souls College, Oxford, and an Alderman of the City of London.

MI5 have not yet published any later records that they kept on Sir Keith, though it is certain they took an interest when a man who had featured in their counter - espionage files became Conservative MP for Leeds North East in 1956 and went on to serve as a minister in successive Conservative cabinets.

**In 1974 after the Tory election defeat, Sir Keith even became Shadow Home Secretary, in line to take responsibility for MI5 itself had the party returned to government! Would this have been the first time that MI5 acquired a political boss who had once himself been a target of their investigations?**

Perhaps fortunately, Sir Keith's party was not to return to office for another five years, and he never got to run the Home Office. After briefly considering a campaign for the Conservative leadership, he stood aside to support the successful candidature of Margaret Thatcher and became her closest ideological ally in government, serving as Secretary of State for Industry from 1979 to 1981, then as Education Secretary from 1981 until his retirement in 1986.

**In 2019 the Jewish Chronicle described Sir Keith as “the most influential Jewish politician of the past half-century”.**



Sir Keith Joseph stepped down as an MP in 1987 and was raised to the upper house as Lord Joseph of Portsoken (taking the title from his old ward on the City of London Council where he had started his postwar career - above).

In their book and PBS series on the transformation of the world economy, *Commanding Heights*, economists Daniel Yergin and Joseph Stanislaw wrote:

“Arguably, Keith Joseph did as much as any other single person around the world to reshape the debate about government and marketplace, to take a variety of ideas and bind them together into a powerful critique of the mixed economy and, in the course

of things, help shape them into a political program.”

In 2014 his name was dragged into a scandal over alleged paedophile abuse that obsessed the British press for several years. However, many of the allegations made during this affair have since been discredited. Having examined the witness statements and other documents considered by the Independent Inquiry into Child Sexual Abuse, I don't see any serious evidence against Joseph. **(Readers are invited to look at these documents themselves, by searching the IICSA website.)**

Unlike the paedophile saga, the links between Sir Keith Joseph and the Zionist spy network in 1940's London are part of real, documented secret history – not crank conspiracy theory.

While the investigation of George Tugendhat continued for decades and became a multi-volume personal file, MI5's investigation of Sir Keith Joseph is at present only visible in a few pages of a single file.

As readers of this blog and a forthcoming book will discover, related evidence shows the extraordinary scope of the Zionist intelligence effort in 1940's Britain – a time when organised Zionism was both ally and enemy of the British Empire.

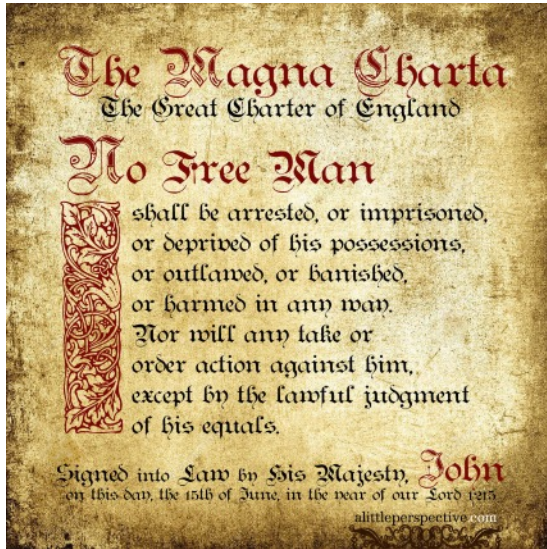

We maintained stable, secure societies without it. We did “the right thing” without it. White people never needed Christianity to be moral people.”

It sounds like Rosetti has written his own religion that all White people should follow — where he gets the authority to do so remains a mystery.



He claims that Christianity has “nothing to offer the White race,” yet the Magna Carta and the U.S. Constitution — our fundamental precepts of law and order — are based on inalienable biblical principles of freedom and justice for all under God. European civilization — the first built to glorify Jesus Christ — has been far more advanced and prosperous — and morally grounded — than any previous societies built by the White race.

Only in the last 100 years — when Jews have gained ascendancy over Christendom — have the white European people fallen away from Christianity — and fallen into a state of moral degeneracy.

If Christianity is a “Jewish” conspiracy to subjugate the white race, then why are Jews feverishly trying to discredit it and encourage white people to become like-minded atheists and pagans? If Jews benefit from white people being “passive” Christians, then why don’t they encourage and promote Christianity 24/7 in their media?

“If you have not already, I encourage you to read Germania by the Roman historian Tacitus. You will likely be shocked speechless when you discover that the Germanic peoples lived much like we would live today if we were able to live without Jewish influence and subversion.”

What white person would want to live as the early Germanic peoples did in, say, pre-500 AD? Is that life — full of superstition, disease, and gruelling labour — really something modern White Christians would readily trade their lives for? According to historians, white slavery was common in pagan nations of Europe — how “noble” of them. This sounds like some very romantic wishful thinking.

“You don’t have to fear Jewish “Hell.” You don’t have to have to fear the wrath of the Jewish god. These are Jewish inventions, crafted to keep you terrified and obedient. If you love and cherish your White ancestry, you must come to the realization that your religion was invented by non-White people for the purpose of enslaving White people — and destroying our culture and heritage.”

Rosetti is starting to repeat himself here — perhaps because he’s run out of any more arguments. Early Anglo-Saxons worshiped their “warrior-god” — Odin — who wasn’t even a god at all — he was a real-life tribal chief named Wotan, whom they ignorantly turned into a god over time — not much different from the pagan Egyptians who worshiped their mortal pharaohs.

What did worshiping a dead ancestor ever offer the white race? If these pagan gods were so beneficial for the white pagan race, why did their civilizations not advance until after they were converted to Christianity?

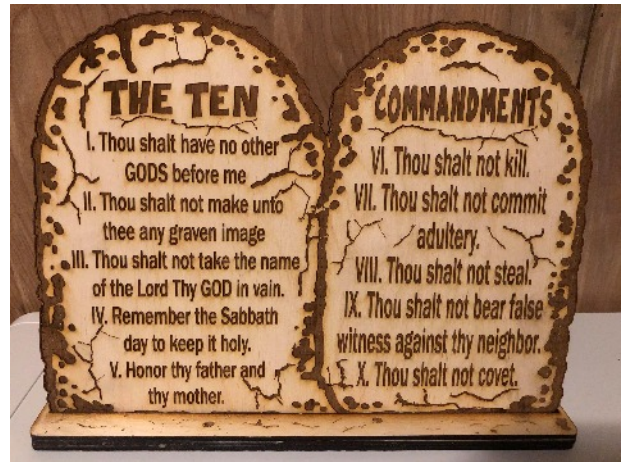

All societies — even pagan ones — demanded that we “suppressed” some of our “human nature” — especially if those “human” desires were a threat to the order of the tribe — say, murder, rape, lying, etc. — obeying the Ten Commandments hardly puts us in a “tiny box” and restricts our ability to enjoy life — and to call these rules a form of “repression” is hypocritical, considering Rosetti himself probably lives by them himself — and would even defend those “rules” if he didn’t know they came from the “evil” Bible.

“Friend, you don’t have to believe in anyone’s gods to recognize that Yahweh, the god of Abraham and Isaac, represents genocide, subversion, tyranny, degeneracy, usury, and greed.”

Rosetti again repeats himself — he’s clearly run out of ideas. He holds up all the behaviours that are prohibited and punished in the Bible and suggests that they are encouraged instead. This is a classic straw man argument — it’s pointless to defend a misrepresentation of the God of the Bible, but Rosetti feels this is a valid form of argumentation — something even his pagan Greeks would have admonished him for engaging in.

## Conclusion

“You don’t have to accept the Jewish description of your Creator to recognize and be in awe of your Creator. But your Creator is nothing like the entity described in the Torah, in the Jewish scripture.



The Jewish scripture teaches you that your Creator is a jealous, easily-angered, vindictive, mercurial despot who specially favours Jews and will execute people on the spot if they anger him enough. You were not created by such a psychotic, anti-human entity.”

More repetitions of the same straw man arguments. Notice the emotional appeal — if you hate “Jews” the way Rosetti does, don’t worship their “psycho” god. Again, Jews have nothing to do with the Bible — they didn’t write it — but Rosetti who knows Jews are liars yet chooses to believe them when they make this spurious — and destructive — claim.

Ironically, the Jews are pagans like himself — their occult religion — Judaism — is based on pagan beliefs straight out of Babylon — in complete opposition to the Bible — and they literally worship themselves — their desire is to replace God and rule the world themselves. Their

beliefs, ironically, are very similar to the “native” pagan beliefs of his European ancestors before their conversion to Christianity.

Two of the greatest tools that Jews have used to dominate and subvert Christian nations are the so-called “Holocaust” and the myth that Jews are “God’s chosen people” from the Bible — and, ironically, when White Nationalists like Rosetti grant them this false stature of being true Israelites, they unwittingly aid and abet this Jewish domination.

No wonder we are where we are, we were given everything and we chose to turn our backs to it. Such foolishness, such folly!

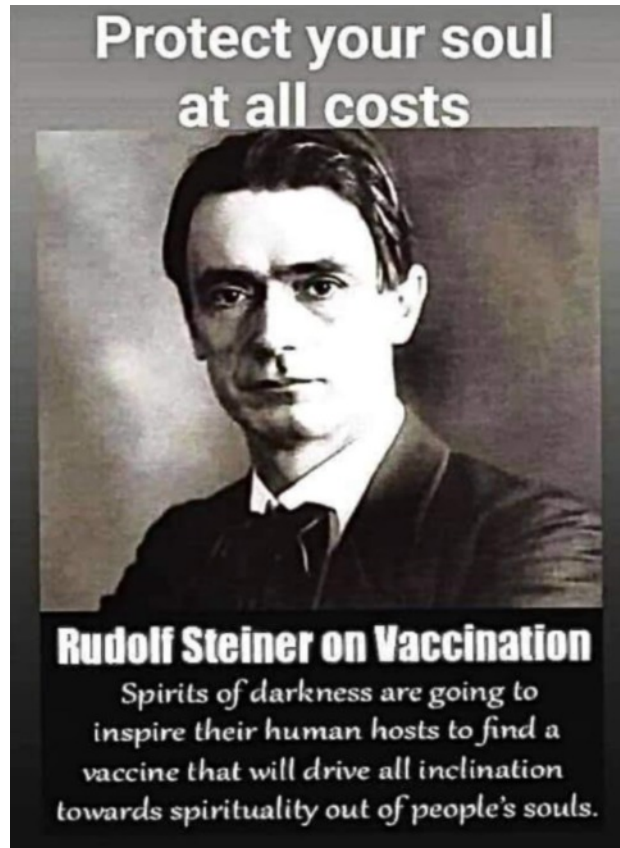
The Great Awakening is about realizing our own stupidity, it’s about shaking our heads in disbelief at our profound ignorance, our idiocy and our myopic existence.

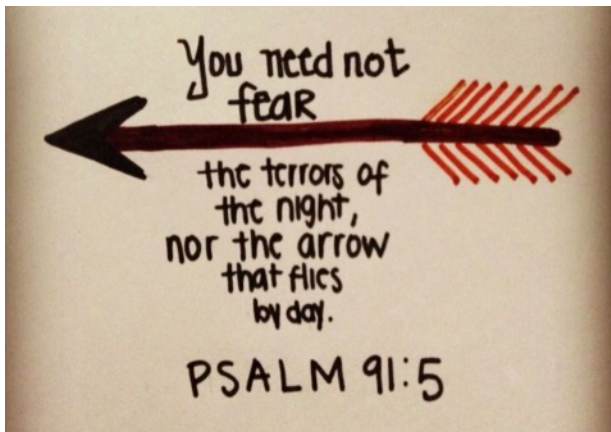

## The Venetian Conspiracy (Part 6)

**M**ACHIAVELLI WROTE THAT THE VENETIANS had “fixed in their souls the intention of creating a monarchy on the Roman model.” This is corroborated by a dispatch of the ambassador of Louis XII of France at the court of the Emperor Maximilian I some years later, which described the Venetians as:

“traders in human blood, traitors to the Christian faith who have tacitly divided up the world with the Turks, and who are already planning to throw bridgeheads across the Danube, the Rhine, the Seine, and Tagus, and the Ebro, attempting to reduce Europe to a province and to keep it subjugated to their armies.”

These megalomaniac plans of the Venetians were no secret. In 1423, the Doge Tommaso Mocenigo had urged upon his fellow oligarchs a policy of expansionism which would make them the overlords “of all the gold and of Christendom.”

The most penetrating indictments of the Venetians during this period were issued by Pope Pius II Piccolomino, who tried in vain to force Venice into joining a crusade against the Turks. A Venetian saying of this period was *Prima son Vinizian, poi son Cristian*. (I am a Venetian first, then a Christian.)

In his *Commentaries*, Pius II excoriates the Venetians for their duplicitous treachery, and establishes the fact that they are a pagan, totalitarian state. The Venetians, he says, have acted in their diplomacy:

“with the good faith characteristics of barbarians, or after the manner of traders whose nature it is to weigh everything by utility, paying no attention to honour. But what do fish care about law?

As among the brute beasts aquatic creatures have the least intelligence, so among human beings the Venetians are the least just and the least capable of humanity, and naturally so, for they live on the sea and pass their lives in the water; they use ships instead of horses; they are not so much companions of men as of fish and comrades of marine monsters.

They please only themselves, and while they talk they listen to and admire themselves—They are hypocrites. They wish to appear as Christians before the world, but in reality they never think of God and, except for the state, which they regard as a deity, they hold nothing sacred, nothing holy.

To a Venetian, that is just which is for the good of the state; that is pious which increases the empire—What the senate approves is holy even though it is opposed to the gospel—They are allowed to do anything that will bring them to supreme power. All law and right may be violated for the sake of power.”



During many of these years Venetians were in a tacit alliance with the Turks. When, for example, a revolt against Venetian rule in Albania was started, threatening the Venetian naval base

at Durazzo, the Venetians made a deal with the Turks to crush the revolt. On one occasion Pius II (above) received the Venetian ambassador to the Roman court and condemned Venetian policy with these words:

“Your cause is one with thieves and robbers— No power was ever greater than the Roman empire and yet God overthrew it because it was impious, and He put in its place the priesthood because it respected divine law—

You think [your] republic will last forever. It will not last long. Your population so wickedly gathered together will soon be scattered abroad. The off scourings of fishermen will be exterminated. A mad state cannot long stand.”



### Ancona Italy - Modern Picture

In 1464 Pius II, despite a serious illness, travelled from Rome to Ancona to personally lead a crusade against the Turks. He wished to force the hand of the Venetians, who had promised him a battle fleet. He died shortly after the Venetian warships arrived, and Venice thereupon pulled out of any serious fighting against the Turks. But his attack on “the mad state” was on target, then and now.

During the first half of the fifteenth century, much Venetian energy was devoted to a rapid expansion up the Po Valley toward Milan. They seized Padua, Vicenza, Verona, Brescia, and Bergamo, reaching the Adda River, just a few miles from Milan. With Milan under Venetian control, the “new Romans” could bid fair to dominate northern Italy and then the entire peninsula.

Cosimo de’Medici, as we have seen, secured a Florence-Milan alliance by supporting the claims of Francesco Sforza, fighting a war against Venice to do it. Basing himself on this Florence-Milan axis, Cosimo then proceeded to create an uneasy peace in Italy that was to last forty years. This was the Italian League, formed at the Peace of Lodi in 1453, which united the leading powers of Italy, the pope, Naples, Mi-

lan, Florence, and Venice, ostensibly in an alliance against the Turks, who had for a time held a toe-hold in Apulia.

In reality, the Italian League was a Florence-Milan- Naples combination designed to check Venetian expansionism. In this it proved effective, giving the Renaissance almost half a century of time to develop under the *longa pax* of the Medici.

During these years, stymied in Italy, the Venetians concentrated on overseas expansion, including the conquest of Cyprus. But on the death of Cosimo’s successor, Lorenzo the Magnificent, they began their systematic campaign to destroy the civilization of the high renaissance.

Their basic premise was that, given their own inability to devastate the centres of Renaissance culture and economic development, they must concentrate on duping the overwhelming military forces of European states like France, Spain, and the other Hapsburg dominions into accomplishing this task for them.

The most competent contemporary observer of these matters was Niccolo Machiavelli, active somewhat later in the post-Medici Florentine diplomatic service, and a factional ally of Cesare Borgia, Duke of Valentino. Machiavelli noted that the two most dangerous forces in Italy around the turn of the century were the Venetians and the pope.

His own hatred was directed especially against Venice, firstly because of the stated Venetian intention to subjugate Italy in a new Roman Empire.

Secondly, Venice more than any other state relied on armies of mercenaries, and thus embodied precisely that practice which Machiavelli knew had to be extirpated, in favour of citizen-soldiers, if Italy was to be saved from humiliating subjugation to the likes of the Hapsburgs.

Machiavelli pointed out that the disintegration of Italy began when the Venetians succeeded in turning Lodovico il Moro, successor of Francesco as Duke of Milan, making him their agent of influence. Lodovico was responsible for the first major invasion of Italy in many years when he agreed to support the claims of Charles VIII

of France to the Kingdom of Naples. This was the French king whom his father, the great Louis XI, considered a hopeless imbecile. In 1494 the French army crossed the Alps, accompanied by a Genoese advisor we will meet again later: Giuliano della Rovere.

This was enough to bring about the fall of the Medici regime in Florence, to the advantage of the Pazzi, Albizi, and related oligarchs of that city. These oligarchs immediately sought to crush the Florentine Renaissance using the regime of the demented Dominican monk Girolamo Savonarola, who set up a theocracy a la Khomeini. Savonarola proudly trumpeted that his rule was based on sound Venetian principles; his family was closely related to the Padua Aristotelian community. As for Charles VIII, he went on to establish a tenuous hold on Naples.

Several years later, in 1498, the Venetians repeated this maneuver, with the variation that this time it was they who blatantly invited the French to cross the Alps. This time the pretext was the French claim to the Milanese dukedom, and the dupe was a new French king, Louis XII. The French army knocked out Milan in 1500, a fatal blow to the Renaissance cultural ferment associated there with Leonardo da Vinci. Shortly thereafter, Louis XII decided to compensate the Hapsburgs with Naples. Naples accordingly became the first beachhead of what would shortly become a totally destructive Hapsburg hegemony in Italy.

## Venice and Genoa Combine

For Venice, so far so good: Florence, Naples, and Milan had been ruined. But ironically, the same dumb Valois and Hapsburg giants which had taken out three dangerous rivals were now to turn like Frankenstein's monsters on the wily new Romans.

Venetian manipulations were about to boomerang in the form of an alliance of all of Europe against Venice. This was the famous crisis of the War of the League of Cambrai, which it nearly worked.

At Agnadello, near the Adda River, the Venetian mercenary army was crushed by an army composed predominantly of Frenchmen. The Venetians were driven all the way down the Po Valley to Padua, and they soon lost that as well.

Machiavelli exulted that on the day of Agnadello, the Venetians lost everything that they had conquered in more than 800 years. Machiavelli was himself engaged in operations against Venice, bringing a grant of Florentine cash to the aid of the Franco-Imperial forces holding Verona.

With nothing left but the lagoons, the Venetian position was desperate. The doge sent a message to the pope asking for mercy, and announcing that Venice would vacate territory taken in the past from the Papal States.

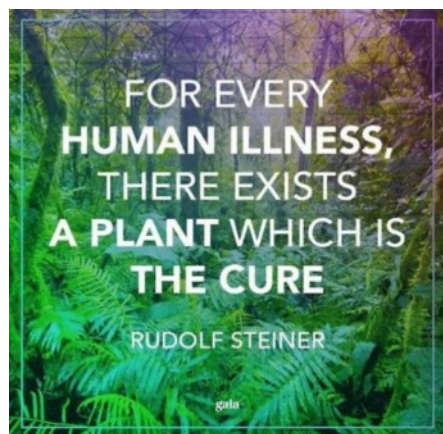
Inside Venice, Agnadello brought on an orgy of hysterical self-flagellation among the terrified patricians. The banker Girolamo Priuli wrote in his diary that Agnadello had been a punishment for the sins of the Venetian nobility, among which he numbered arrogance, violation of promises, lechery in nunneries, sodomy, effeminate dress, and luxurious and lascivious entertainments.

Antonio Contarini, newly appointed patriarch of Venice, gave a speech to the Senate in which he characterized the Serenissima as a thoroughly amoral city.

The defeat was a punishment for the city's sins, he said. Nunneries were catering to the sexual needs of the rich and powerful. Homosexuality was so widespread that female prostitutes had complained to him that they had earned so little during their youth that they had to keep working far into their old age.

But more significantly, the shock of Agnadello set into motion a strategic review in the Venetian intelligence community which led to very far-reaching conclusions, some of which were not obvious before several decades had gone by.

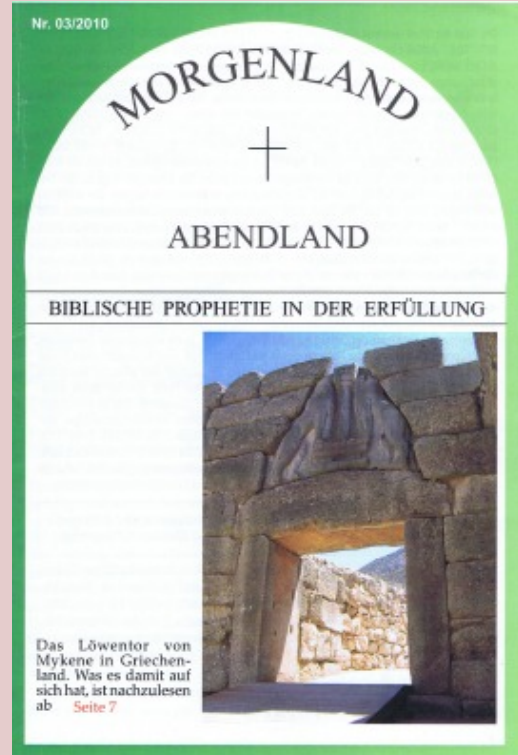

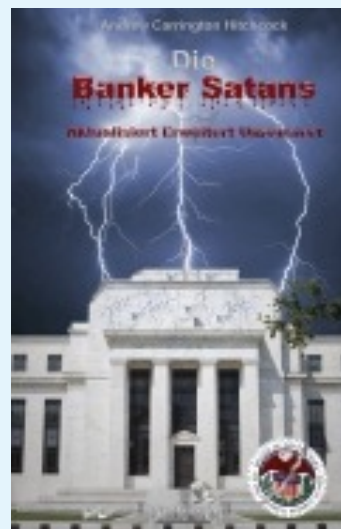
