The Sacred Names: Yahweh and Yahshua (3) Judgment Day Perspectives, Volume II, Number 9 by Pastor Eli James



On page 13:

THE NAME OF THE FATHER WAS SO IMPORTANT TO THE APOSTLE PAUL (and the other apostles) because within its definition is found all the dimensions of authority and influence, whether these attributes are human or spiritual, visible or invisible (Col. 1:16).

That is why Paul could say in Ephesians 3:14-19: For this cause I bow my knees unto the Father, of whom the whole family in heaven and earth is named—that ye being grounded in love, may be able to comprehend with all the saints what is the breadth, and length, and depth and height—which passeth knowledge. In other words, the Father’s love in breadth is boundless, in length endless, in depth fathomless, in height measureless. These unlimited dimensional expressions that Paul was using—represent the exact definition of the name Yahweh when one considers all its ramifications.

Or, as I interpret these things: Wisdom is transmitted to us when we requite His Love back to Him. Once we Israelites recognize the spark of Divinity within each other and **Love One Another** accordingly – and this necessarily means in terms of actions, not just words and beliefs -- then and only then will the Kingdom manifest itself in our midst.

And full comprehension of the meaning of His Name infuses us with the requisite awe and

gratitude that our lowly human status require if we are to appreciate His grandeur and His Love. That is why we must approach Him in all humility, for we are mere specks on a planet, or, as the song by Kansas says, dust in the wind. For me, using the **I AM** is a constant reminder to me of the actual Presence of God in my being: that **I AM** made of His Substance and that I live in Him and breathe in Him.

When we forget this intimate connection with Him, we get lost in our own self-importance and we sink into materialism.

What’s in a name, you ask? Jesus’ or Yahshua’?

One of the most important treatises on the subject of the Sacred Names is a booklet entitled *The Mistaken J*. It is the story of how the letter J entered into the English language. The opening paragraphs say this:

Often heard in the churches of our land is the refrain sung about the Savoir, There’s something about that name... In our English-speaking world we have been taught that the saving name of the Redeemer of Israel is Jesus. So accepted is this name that few stop to consider its authenticity.

But the truth is, there is indeed something about that Name. That something’ is the inescapable fact that the Saviour’s name is not Jesus, and never was. What’s more, the Name of the heavenly Father is not Jehovah, a designation that is only five centuries old.

Churchianity has so thoroughly immersed the world in the error of this tradition for the past 500 years that few even think to research the matter or to consider the consequences of calling on the wrong name.

As a result, most continue believing that the Hebrew Savior is called by a Latinised Greek name that could not possibly have existed at the time He walked the earth. It’s a name that would have been completely foreign to Him.

The story of the Mistaken J goes on to explain how the letter J was incorporated into the English language around 1500 AD. Before then, English employed the same sound for J as other languages do, namely, the y sound.

Up until then, even the English people referred to Jesus as Iesus (pronounced Yay-Soos). If you look at the earliest copies of the King James Bible, you will see His name spelled I-e-s-u-s. (The complete text of “The Mistaken J” can be accessed [HERE](#).)

But even Iesus is, as the authors point out, a Latinised version of a Greek transliteration of a Hebrew name. The name, Jesus, therefore, is thrice removed from the original, which is Yahshua.

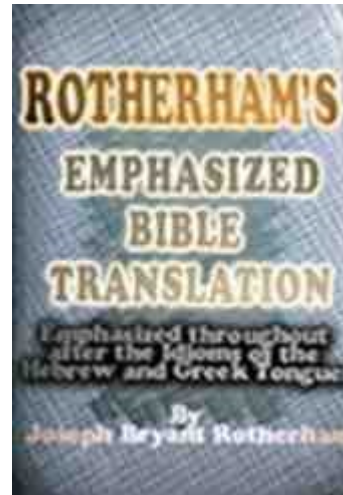
Now, the name Yahshua has a very specific meaning. It means **Yahweh Saves**. Does the word Jesus’ mean that to you? If not, then I suggest getting familiar with His **Real Name**, Yahshua, because His real name is intimately tied to the Father, Yahweh, in His aspect as **the Messiah**, the saving presence of God.

There is indeed something about the name Jesus. But for many people who call themselves Christians, it is just an emotional experience: a giddy high that may last a few years. But when the importance of obedience to Yah’s Law and the full impact of Yahshua’s supreme sacrifice are realized, that giddy high is seen to be an illusion. Christianity, first and foremost, is **Responsibility** to one’s brethren.

Do all of the Churchians sitting in the twenty-thousand seat auditoriums, listening to the “Gospel of Self-Help, Self-Aggrandizement and Personal Gratification” through milquetoast preachers, come away with a sense of greater responsibility to love and respect their brethren? True Christianity is the Gospel of **Tough Love**. We must demand that we love each other by **Obeying Yahweh’s Law**. We cannot hold each other to any lower standard. Anything short of this is mediocre religion...and backsliding towards another fall.

It has been objected that Yahshua Himself never used the name of Yahweh. This is not exactly true. There are a few instances in which He did. We have to remember that when the Father divorced us, He temporarily departed from us;

and we henceforth forgot His Name. We also have to bear in mind that the Masorettes and other translators have done their level best to obscure the Sacred Names. So, before I quote the relevant New Testament passages, I would like to quote from the Introduction of Joseph Rotherham’s translation of the Bible. Under the heading of The Name Suppressed, he tells us:



...the Tetragrammaton is nearly hidden in our public English versions. Not quite. To those who can note the difference between LORD and Lord and between GOD and God, and can remember that the former (printed with **Small Capitals**) do while the latter do not stand for The Name **B** to such [people] an intimation of the difference is conveyed.

But although the **Reader** who looks carefully at his book can see the distinction, yet the mere **Hearer** remains completely in the dark respecting it, inasmuch as there is no difference whatever in sound between **LORD** and **Lord** or **GOD** and **God**. It hence follows that in nearly all the occurrences of The Name (some 7,000 throughout the Old Testament) the especial Name of God is absolutely withheld from all who simply hear the bible read.

Nearly all, for there are about half a dozen instances in the AV, and a few more in the RV., in which this concealment does not take place.

In other words there are these very few places in which the Tetragrammaton appears as Jehovah; and although it may be asked, what are they among so many? still their presence has an argumentative value. If it was wrong to unveil the Tetragrammaton at all, then why do it in these instances? If, on the other hand, it was right to let it be seen in these cases, then why not

in all? With the exceptions explained, however, it remains true to say, that in our public versions the one especial Name of God is suppressed, wholly concealed from the listening ear, almost as completely hidden from the hastening or uncritical eye.

So, my answer to the question Why is the Tetragrammaton not found in the New Testament? is this: The question is naive. It is asked by someone who is unaware of the historical tampering that has occurred in the Scriptures with the deliberate intent to obscure the Sacred Names, Yahweh and Yahshua.

Those who have deleted them from the Old Testament would surely work feverishly to delete them from the New Testament; and they have succeeded. Nevertheless, let us look at a couple of instances in which the I AM occurs in the New Testament:

In the eighth Chapter of John, the Jews accuse Jesus of having a devil after He tells them that they are not of God.

Now we know thou hast a devil. Abraham is dead, and the prophets; and thou sayest, If a man keep my saying, he shall never taste of death. Art thou greater than our father Abraham, which is dead? [These comments prove that the Pharisees do not believe in Eternal Life.] And the prophets are dead: whom makest thou thyself?



Jesus answered, If I honour myself, my honour is nothing: it is my Father that honoureth me; of whom ye say, that he is your god; Yet ye have not known Him; but I know Him: and if I should say I know Him not, I shall be a liar like unto you: but I know Him and keep His saying. Your father Abraham rejoiced to see my day: and he saw it, and was glad.

Then said the Jews to Him, Thou art not yet fifty years old, and hast thou seen Abraham? [These

Jews here display an utter lack of spiritual consciousness, implying that the only way He could possibly have known Abraham is to have been in the flesh for hundreds of years!]

Jesus said unto them, Verily, verily, I say unto you, Before Abraham was, I AM. John 8:52-58.

Here, with the expression, I AM, Yahshua is declaring His eternity. Since He is one with the Father, He is life everlasting. That quality is, of course, part of the meaning of I AM THAT I AM. A I AM the eternally self-creating Being. Or, as Jesus puts it in the book of Revelation: I AM Alpha and Omega, the beginning and the end.

At Matthew, Chapter 22, Yahshua asks, Have you not read that...



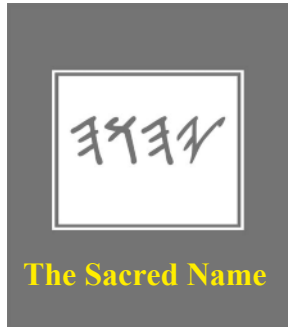
I AM [capitalization in the text] the god of Abraham, and the God of Isaac, and the God of Jacob? God is not the god of the dead, but of the living. Verse 32.

Again, Yahshua is quite literally expressing His Oneness with the Father, Yahweh, and His own eternity. This eternal life, by the way, is available to all of us who keep His sayings. Most others don't take His sayings very seriously.

Of the numerous instances in which the word Lord' is used in the New Testament, you will note that many of them are written in **All Caps: LORD**. Examples are Matt. 3:4; 3:10 and 23:39.

This is the Tetragrammaton staring you right in the face, if you have eyes to see, but well disguised, as Joseph Rotherham so eloquently expressed above. Because of the failure of both the House of Judah and the House of Israel to obey Yah's Law, the use of His Name gradually fell into disuse because of their reprobate status. This means that they were ashamed to use the Sacred Name because they had used it so often

in vain, not that the Sacred Name was too holy to be pronounced!



Not for your sakes do I this, saith Yahweh God, be it known unto you; be ashamed and confounded for your own ways, O house of Israel. **Ezek. 36:32.**

If thou wilt not hearken unto the voice of Yahweh thy God, to observe to do all His commandments and His statutes which I command thee this day, that all these curses shall come upon thee and overtake thee. **Deut. 28:15.**

Indeed, our world is coming apart at the seams. Paris, its suburbs, and other towns in France and Europe are burning as I write (November 6, 2005) because we have refused to obey His Commandment not to mix our seed with other races! Now, we are reaping the result. Tsunamis, hurricanes, earthquakes, and plagues are all around us and we do not see the connection between these judgments and our rebellion against His Law.

We have to remember that in biblical times, people of all races had a much stronger racial and tribal awareness and loyalty. Even as late as the 1950's, race-mixing was still taboo even here in America.

The Judahites of the land of Judah were keenly aware of the racial differences between themselves and the non-Israelite Edomites who had taken over their nation when the Roman Empire placed the Idumean Jew, Herod, over the nation of Judea and the House of Judah.

Since these Judahites of the House of Judah knew that they were surrounded by Edomite Jews of either half-breed (like many of the Pharisees) or non-Judahite stock (such as Herod and his allies), they were careful not to use the Sacred Name in front of these heathen.

Give not that which is holy unto the dogs, neither cast ye your pearls before swine. Lest they trample them under their feet, and turn again and rend you." (Matt. 7:6.)

This is also why Yahshua spoke in parables, so that the Jews would not be able to understand what He was saying to True Israel. The Jews, as allies of the Romans against the Judahites, were seeking every opportunity to condemn Jesus for His speech.

The language of the day was Aramaic; and Aramaic was a dialect of Hebrew. So, when Jesus said "Lord, Lord," He wasn't saying "Baal, Baal." You can bet He was saying "Yahweh, Yahweh."

Understand that the Jews have been working for the last 2,000 years to keep us from reuniting with our Father, Yahweh. They have also been working feverishly to separate us from Jesus Christ through their diabolical religion called "Judeo-Christianity," which is nothing more than an attempt to substitute Judaism for Christianity.



They have re-instituted this Pharisaic tyranny today, for you cannot criticize their breed or their religion, or their hoaxacaust, without being threatened with imprisonment. When it comes to "freedom of speech," the Jews are consummate hypocrites. They can criticize and malign Christians and Germans with impunity, but no one can criticize them, "for fear of the Jews." During Christmastime, you can say "Happy Holidays," but it is becoming more and more "incorrect" to say "Merry Christmas"!

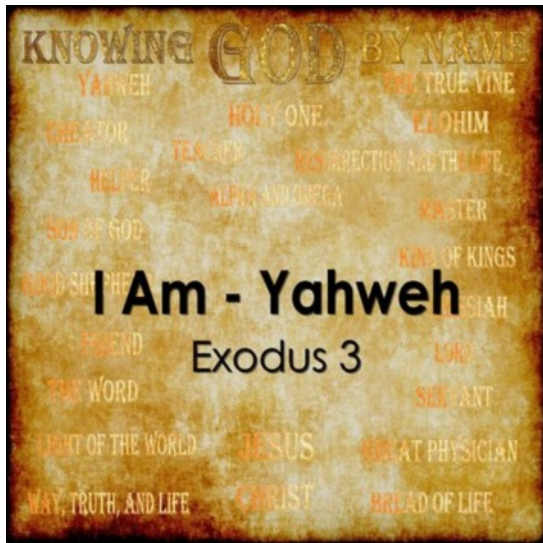
There is only one solution to this crisis: White Christendom must return to their God, Yahweh.

Conclusion

In spite of all the evidence presented here, I do not demand that you all start chanting Yahshua,

Yahshua, Yahshua instead of **Jaysus, Jaysus, Jaysus**, as some of the priests of Preachianity like to pronounce it. This is an extremely personal decision. It requires a great amount of introspection and humility to overcome one's upbringing and make a fundamental change in one's thinking.

If, for you, the name Jesus conveys the idea Yahweh is Salvation, then who am I to say that you should make such a change? The fact is that I routinely still use the name Jesus affectionately. But at the same time I understand the value and meaning of the name Yahshua.



Given the multitude of meanings and the nuances of God's personality, only the name Yahweh is meaningful to me where the Father is concerned. I only use the word 'God' when I am talking about the office that He holds. In my prayers to Him and in my communications with Identity believers, only 'Yahweh' means anything to me.

When I communicate with those who are not familiar with 'Yahweh' and 'Yahshua,' I do not press the issue. I humble myself and speak their language so that I can be understood by them.

As I have tried to show, our use of 'Lord' and 'Jesus' are conventions that require deeper scrutiny. We should not reject the original Hebrew names merely because we have been brought up in a different tradition.

The fact is that the Hebrew language is part of our heritage. That does not mean that we all have to start learning Hebrew again. It does mean that we should be aware of the deeper significance of certain Hebrew words which have been inadequately translated into English.

We have fallen victim to the false prophets of Judaism and Judeo-Christianity. Jeremiah 23:25-27 gives us this meaningful prophecy:

"I have heard what the prophets said, that prophesy lies in my name, saying, I have dreamed, I have dreamed. How long shall this be in the heart of the prophets that prophesy lies? Yea, they are the prophets of the deceit of their own heart: Which think to cause my people to forget my name by their dreams which they tell every man to his neighbour, as their fathers have forgotten my name for Baal." -- just as the Masoretes did by substituting 'Yahweh' with 'Lord' (Baal).

As reported above, the Book of Revelation tells us this about those servants who are given admission to the Wedding Feast of the Lamb and to the New Jerusalem:

And they shall see His face; and His Name shall be in their foreheads. (Rev. 22:4.)

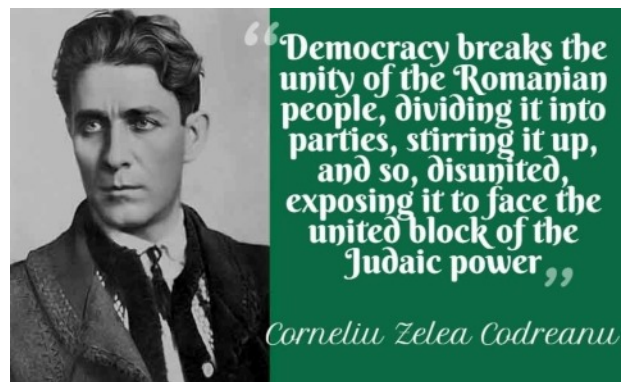
There is also this remarkable prophecy contained in the Book of Zechariah (13:6):

They shall call upon my name, and I will hear them. I will say it is my people, and they shall say Yahweh is my God.

The Christian Identity Movement is fulfilling this prophecy at this very moment.

Old Testament

“Word for Word” Exodus Part 20

Translation by Stephen Howard Anderson



Chapter 26

1. Moreover you shall make the Tabernacle *4908* with ten curtains *3407* of fine linen, and blue, and purple, and scarlet: with kerubiym of artistic *2803* workmanship *4639* you shall make them.

2. The length of one curtain shall be twenty eight cubits, and the width of one curtain four cubits: and all of the curtains shall have one measurement *4060*.

3. The five curtains shall be joined together *2266* one to another; and the other five curtains shall be joined together one to another.

4. And you shall make loops *3924* of blue upon the edge *8193* of the one curtain from the edge *7098* in the junction *2279*; and likewise you shall make in the uttermost *7020* edge of another curtain, in the juncture *4225* of the second.

5. Fifty loops you shall make in one curtain, and fifty loops you shall make in the edge *7097* of the curtain that is in the juncture of the second; that the loops may take hold *6901* of one another.

6. And you shall make fifty hooks *7165* of gold, and join the curtains together with the hooks: and it shall be one Tabernacle.

7. And you shall make curtains of goats hair to be a tent *168* over the Tabernacle: eleven curtains you shall make.

8. The length of one curtain shall be thirty cubits, and the width of one curtain four cubits: and the eleven curtains shall be of one measurement.

9. And you shall join five curtains by themselves, and six curtains by themselves, and you shall double *3717* the sixth curtain in the forefront of the tent.

10. And you shall make fifty loops on the edge of the one curtain that is outermost in the junction, and fifty loops in the edge of the curtain that joins the second.

11. And you shall make fifty hooks of bronze *5178*, and put the hooks into the loops, and join the tent together, so that it may be one.

12. And the remnant *5629* that remains *5736* of the curtains of the tent, the half that remains, shall hang over the backside *268* of the Tabernacle.

13. And a cubit on the one side, and a cubit on the other side of that which remains in the length *753* of the curtains of the tent, shall hang over the sides of the Tabernacle on this side and on that side to cover *3680* it.

14. And you shall make a covering *4372* for the tent of the skins of rams dyed red, and a covering of [t'chashiym *8476*] skins from above.

15. And you shall make boards *7175* for the Tabernacle of wood of Shittiym standing up *5975*.

16. Ten cubits shall be the length of a board, and a cubit and a half shall be the width of one board.

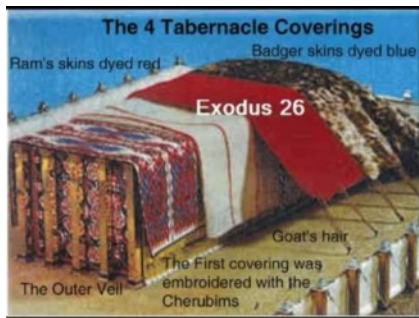
17. And there shall be two tenons *3027* in one board, joined *7947* one against another: thus

shall you make for all the boards of the Tabernacle.

18. And you shall make for the boards of the Tabernacle, twenty boards on the south side 5045 side 6285 southward 8486.

19. And you shall make forty bases 134 of silver under the twenty boards; two bases under one board for its two tenons, and two bases under another board for its two tenons.

20. And for the second side of the Tabernacle on the north side, twenty boards:



21. And their forty bases of silver; two bases under one board, and two bases under another board.

22. And for the sides of the Tabernacle seaward 3220 you shall make six boards.

23. And you shall make two boards for the corners 4742 of the Tabernacle in the two sides.

24. And they shall be joined together 8382 beneath, and they shall be joined together above the top of it unto one ring: so shall it be for them both; they shall be for the two corners.

25. And they shall be eight boards, and their bases of silver, sixteen bases; two bases under one board, and two bases under another board.

26. And you shall make two bars 1280 of wood of shittiyim; five for the boards of the one side of the Tabernacle,

27. and five bars for the boards of the other side of the Tabernacle, and five bars for the boards of the side of the Tabernacle, for the two sides sea-ward.

28. And the middle bar in the middle of the boards shall reach from end to end.

29. And you shall overlay the boards with gold, and make their rings of gold for places for the bars: and you shall overlay the bars with gold.

30. And you shall raise up 6965 the Tabernacle according to the manner 4941 thereof which was shown to you in the mountain.

31. And you shall make a veil 6532 of blue, and purple, and scarlet, and fine twined linen of artistic workmanship: with kerubiym it shall be made:

32. and you shall place it upon four pillars of wood of shittiyim overlaid with gold: their hooks shall be of gold, upon the four bases of silver.

33. And you shall hang up the veil under the hooks, so that there you may bring inside the veil the Ark of the Testimony: and the veil shall divide to you between the Holy 6944 and the Holy of Holies 6944/6944.

34. And you shall put the kaporeth upon the Ark of the Testimony in the Holy of Holies.

35. And you shall set the table outside of the veil, and the menorah opposite the table on the side of the Tabernacle toward the South: and you shall put the table on the North side.

36. And you shall make a hanging for the doorway of the Tent of blue, and purple, and scarlet, and fine twisted linen, wrought with needlework.

37. And you shall make for the hanging five pillars of wood of Shittiyim, and overlay them with gold, and their hooks shall be of gold: and you shall cast five bases of bronze for them.

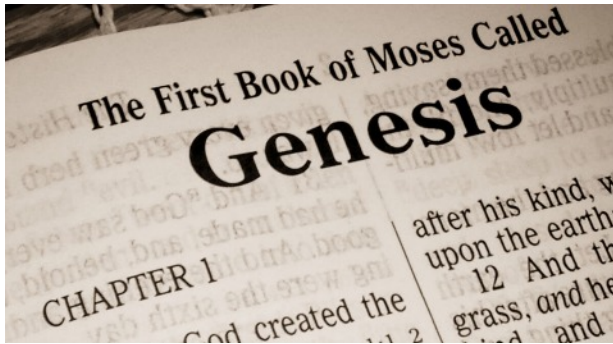

Genesis 6

King James Version

All Definitions Come from the Bible... Not the "Book of Enoch"

6:1 And it came to pass, when men [all the different Races] began to multiply on the face of the earth, and daughters [non-Whites] were born unto them,

2 That the sons of God [White Race (believers)chosen by Yahweh] saw the daughters of men [non-White Races] that they were fair; and they took them wives [had sexual relations which produced mixed-blood children] of all which they chose.

3 And the Lord said, My spirit shall not always strive with **Man** [his chosen White Race], for that he also is **Flesh** (not "fallen angels"): yet his days shall be (reduced to) an hundred and twenty years.

4 There were giants [those tyrants who caused men to "fall"] in the earth in those days; and also after that, when the sons of God [White chosen people] came in unto the daughters of men [had sex with the other **Races**], and they bare children to them ["broken cisterns", unable to contain the "Holy Spirit".... Jeremiah 2:13], the same became mighty men which were of old, men of renown [these mixed-Race people became tyrants and troublemakers, too].

5 And God saw that the wickedness of **Man** [not "angels"] was great in the

earth, and that every imagination of the thoughts of his heart was only evil continually.

6 And it repented the ;Lord that he had made **Man** on the earth, and it grieved him at his heart.

7 And the Lord said, I will destroy man whom I have created from the face of the earth; both man, and beast, and the creeping thing, and the fowls of the air; for it repenteth me that I have made them. [the "Flood" was only in the area that the Races were mixing. Other ancient Races (eg. Chinese, Negro, Pygmies, etc.) survived beyond the time of the flood.

8 But Noah found GRACE in the eyes of the Lord. [Because he did not mix his Race with others]

9 These are the generations of Noah: Noah was a just man and **Perfect in His Generations** and Noah walked with God. [and was protected, with his family, through the Flood]

10 And Noah begat three sons, Shem, Ham, and Japheth [All three were **White-skinned**].

11 The earth also was corrupt [with evil men] before God, and the earth was filled with violence.

12 And God looked upon the earth, and, behold, it was corrupt; for **All Flesh** (except for Noah's family) had corrupted his way [mixed Races in disobedience to Yahweh] upon the earth.

13 And God said unto Noah, The end of all **Flesh** (not "angels") is come before me; for the [that particular area of) earth is filled with violence through them [mixing of the Races]; and, behold, I will destroy them with [that part of] the earth.

Why is this important to understand? Because the "end of days" will be like those "days of Noah".... and **Race-mixing**, again, will be encouraged by those who **Hate** Yahweh. For unto which of the angels said he at any time, Thou art my Son, this day have I begotten thee? And again, I will be to him a Father, and he shall be to me a Son?

The **Flood** in that area where Noah lived was to suffer the **Judgment of Yahweh** for disobeying by **Mixing the Races** of the "pre-Adamites" with the Chosen Adamite Race (White People). Noah and his family were saved because their bloodline was kept pure—**Noah obeyed Yahweh.**

BLACKLISTED HISTORIAN'S WORKS REVEAL THE DECEPTION OF MAINSTREAM HISTORY. Lots of fine folks around the world have been worried lately about the welfare of legendary anti-establishment historian Eustace Mullins.

Actually, half-baked reports and calculated rumours have had him killed, kidnapped, missing or otherwise under siege for decades. Some of these items have been true, others only near misses.

I'm here to tell you tonight that Eustace is fine. One is tempted to describe him as "never better," but for a writer as young as myself, describing an old codger of 86 years filled with intrigue and tragedy, whose legs don't work very well anymore and who is prone to nodding off after

a good meal, that would be a subjective judgment I would not care to make.

I've been hearing stories about the persecution and exploitation of Eustace Mullins by shadowy people with ulterior motives since the late 1980's, when they'd already been happening for 30 years. To make a long story short, Eustace would be dead today — murdered, actually — if not for the miraculous intervention of a guardian angel. Yes, it does happen.

The thing that first strikes me as remarkable about Eustace is his face, especially when he laughs, which is often. Good humour amidst adversity is perhaps the finest human trait, which this battler for objective human truth possesses in abundance.

Even though the subject at hand may be tragic and portend dire consequences for the entire human race, when the point is made, and Eustace laughs wryly, all the wrinkles on his face disappear, except for two little crow's feet. His eyes sparkle as he glances upward, as if to say, "I tell them what I've found, Lord, that's about all I can do." The best way I can put it is that he is infused with a kind of light I've seen in very few others.

Eustace Mullins is the most blacklisted, suppressed and harassed writer in American history. In the introduction to his "A writ for martyrs," which is a report on the files the FBI compiled on him for decades, Mullins writes, "In a single day, my life changed from one of peaceful artistic endeavour to one of constant struggle for survival. One dark winter day in 1948, some friends persuaded me to visit the poet Ezra Pound in his cell at St. Elizabeth's

Hospital, Washington, D.C. That day was to cast a pall over my life, and to bring great suffering to my innocent family.”

After 25 books, including such pertinent titles as “*The Secrets of the Federal Reserve*,” “*Murder by Injection*,” and “*The World Order: Our Secret Rulers*,” Mullins is now living the good life, sort of, thanks to his rescue from oblivion by a lone man who takes life very seriously.



Mullins and his steadfast caretaker Jesse Lee are essentially homeless, but touring the country, going from friend to friend, selling the same books Mullins has been peddling for sixty years. (You too can acquire these precious, museum quality books for a song — and possibly get a visit from Eustace and Jesse in the bargain — simply by writing to me and I’ll pass the info on.)

But in their happy travels, they do something a lot more than that. With Jesse’s thoughtful guidance, they raise eyebrows and elicit love wherever and with whomever they meet. The minute Eustace’s message reaches the unenlightened, they seem to universally respond, “I need to hear this information, because it relates to what is happening now more than anything I’ve ever heard on TV.”

Sitting comfortably in an easy chair, Mullins dismisses the physical problems that have plagued him in recent years with a wave of his hand, and says matter-of-factly, chuckling with that twinkle again, “I still have 25 more books to write!”

The astonishing output of works of supreme relevance to our understanding of today’s world can perhaps best be viewed on Wikipedia, a site I don’t normally recommend, and can’t say is accurate. But it gives you an idea of the volume and magnitude of Mullins’ works: [HERE](#). Savour the titles. “*The plagues of pharaoh*.”

“*Jewish TV: Sick sick sick*.” “*Why General Patton Was Murdered*.”

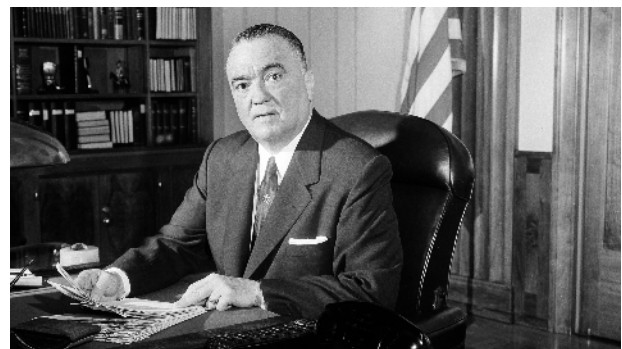
But more importantly, understand the content of all these publications and simply marvel at the profound enormity of the output. Among his major works—

“*The Secrets of the Federal Reserve*” may just be the single book that can save the American republic, if that’s possible, because it objectively examines how the international bankers have reshaped reality throughout the 20th century and turned our freedom into slavery.

“*Murder by Injection: The Story of the Medical Conspiracy against America*” reveals the American Medical Association’s sordid history of killer quackery and heartless profiteering that continues today with the ubiquitous use of poison medicines to cure fictional diagnoses.

“*The World Order: Our Secret Rulers*” names the five men who rule the world.

In “*The Rape of Justice: America’s Tribunals Exposed*,” Mullins writes: “——the cause of our legal dilemma, that our Constitutional courts, as authorized in the Constitution, have stealthily been replaced by equity courts, operating on the stern military principles of admiralty punishment.”



So now you have some idea why the notorious FBI director J. Edgar Hoover (above) put a tail on Mullins for decades; in fact, probably, the agent is still posted.

Eustace’s guardian Jesse says “*The Curse of Canaan*” is the key to all of Mullins’ works, because it explains the demonic plot that has plagued civilization for five thousand years. Back in the late 1980’s, when I first encountered “Curse of Canaan,” I was put off by religious terminology I didn’t understand, and I thought all evangelical types were the same — hypocrites.

Since then I've learned differently. Like the debate about good Jews and bad Jews, there is no debate that there are good Christians and bad Christians. Israel-poisoned skills like John Hagee, Billy Graham and Jerry Falwell are the bad Christians; but the good ones like Jesse Lee and Eustace leave no doubt in anyone's mind that they are driven by the light of truth, and overjoyed at the prospects of the trip they're on.

As stimulating as reading Eustace Mullins can be, conversing with him can be even more startling, not to mention educational.

“People don't realize the United States didn't win the Revolutionary War,” Eustace casually says. “They let us think we won, but it never really happened.”

Jaws usually drop considerably at that line. Summoning my meagre knowledge of America's war for independence, I began to babble on about Alexander Hamilton, the guy on the \$10 bill, as being one of the key figures preventing America's independence from Britain and the international bankers. I brought up a name familiar to Eustace, the respected Jewish economic historian Emanuel Josephson, who was Mullins' close friend when they both lived in the same New York City neighbourhood a half century ago.

Josephson wrote that Hamilton was half black and half Jewish, went to Hebrew school in London, and later prevented the fledgling colonies from financial freedom by reserving the printing of paper money to the banks, rather than the government, despite what the Fourth Amendment of the Constitution appears to say.

“That kind of reminds me of Abraham Lincoln,” Eustace retorted. “Lincoln's mother was a slave and his father was a Jew. Did you know that Lincoln's wife went mad and spent the later part of her life in an insane asylum, and that both of Lincoln's sons committed suicide?” He continued. “Lincoln was put in place by the bankers, too. That whole greenbacks thing was just a smokescreen.”

As I said, jaw dropping. After a pause, Eustace went on. “Did you know that for two whole

years, Averill Harriman was the leader of Russia?”



Harriman (above), member of an infamously rich American family comparable and in league with the Bushes, was sent to Russia by the Rockefellers right after Hitler invaded in 1941, because when that happened, Stalin had a nervous breakdown which lasted two years. Harriman later returned to the U.S. and ran for vice president in 1948.

Perhaps with Eustace Mullins rather than any other single author, you can really get a feel for how deep the rabbit hole goes.

Among Mullins' more astounding publications are both whole books of commentary on the Jewish question, including a mammoth tome titled “*Mullins' New History of the Jews*,” and small booklets containing the riveting essays “*Jewish War Against the Western World*,” “*Sigmund Freud: Anti-Christ Devil*,” “*There's a Gulag in Your Future*,” and “*The Biological Jew*,” plus scores of other essays and short works with similar titles and the same subject. So it seemed natural to suggest my own observations for his scrutiny, and when I did, was I surprised.

“So, Eustace,” I queried, “who really runs the world?”

“The Queen,” he answered quickly.

“You mean it's not the Sanhedrin!?” I exclaimed, flabbergasted. “Are you sure it's not the Sanhedrin that runs the Queen?”

“No, it's Queen Elizabeth who runs the Sanhedrin and everything else — most definitely.”

As I said, with Eustace Mullins, both with reading his works and listening to him, prepare to be astounded. Prepare to learn the real history that has been concealed from us by the people who own the media, who just happen to be the

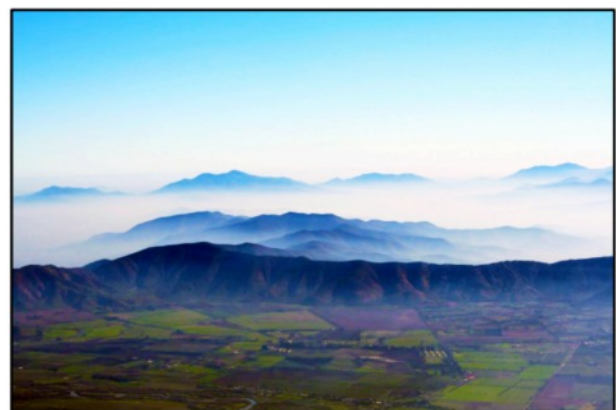

A Voice in the Wilderness



“And if so be that he find it, verily I say unto you, he rejoiceth more of that sheep, than of the ninety and nine which went not astray.

Even so it is not the will of your Father which is in heaven, that one of these little ones should perish.” – **Matt 18:13-14**

OUR GOD IS A GOD OF SECOND CHANCES. His expressed will is that not one of his sheep should perish. This is demonstrated in the second chance given the Adamites as we tried to show in **Part V** of this series.

The study of the adamites and Adam show us that mankind is represented in scripture both individually and corporately. Just as man had two examples of beginnings, so do the people who were the direct descendants of Adam. Throughout the scripture both the individual man and the nation have a physical and spiritual aspect. Unfortunately, most of today's

‘Christianity’ see only the spiritual and all too many of the Christian Israelites, see only the physical.

Aw-dam (corporately) created on the sixth day represented the physical. Adam taken from the adamites of the sixth day, became the first type of the spiritual counterpart. Not spiritual like some wisp of ether, but spiritual in nature. “Ye are my witnesses, saith the Lord, and my servant whom I have chosen: that ye may know and believe me, and understand that I am he: before me there was no God formed, neither shall there be after me” – Isa 43:1,5.

Here again we find the scriptural principal of created and formed. The physical is created

without any desire or inclination to be so. He has no say in the matter whatsoever. In contrast, the second man here represented by Israel, is the man drawn into a New Covenant relationship with God by the Holy Spirit.

This new creature then begins a forming process likened to being clay in the hand of the potter who is the Almighty. He is moulded into exactly what the creator desires him to be. This is true regardless of whether it is talking about the corporate body of Jacob/Israel or the individual Adamite; be he male or female.

Names in the Hebrew were often prophetic adjectives of the character the person named. Examples of this would be Abram (father) changed to Abraham (father of many); Sarai (dominative) changed to Sarah (lady, princess, queen, female noble); Jacob (heel catcher, supplanter, i.e. one who takes place of another) changed to Israel (one who rules with God i.e. depends on God or leans on God); and Saul (to demand) changed to Paul.(to stop, restrain or quit; in essence to ask)

In the case of Jacob; his name meant heel catcher or supplanter. Supplant means to supersede and replace. How well this describes the exact process which took place when Jacob conspires with his mother to replace Esau as the heir to the birthright[1]. This looks evil from the human stand point and yet it was the intention and plan of God for it to be this way. Why? Because everything God has ordained in His plan is to teach us about the process of the clay yielding to the potter's touch.

The physical is always imperfect and a mere shadow of that to come; the spiritual. It is a forming process always beginning as a spiritual new birth. We as individuals and we as a people must both go through that process to return to the image and likeness of our creator.

The illustration given in scripture is repetitive.



It is like several hour glasses fired together one on top of the other. God created mankind and narrowed it down to one man Adam. Adam like sand multiplied and ran through the narrow passage to the next level (restriction) of the connected

hourglasses, and was again narrowed down into the small family of Noah.

Noah's family grew and again God chose one man, Abraham. Then Isaac, then Jacob, then Judah and so forth until it came to our kinsman redeemer, Jesus the Christ.

At that point the spreading has never ceased. It is the progeny of Jesus who will ultimately be the family of God and those inheriting the Kingdom of Heaven. That is exactly what Paul is telling us. It is the spiritual people, the children of Christ that are heirs to the promises made to Abraham.

The contrast in the physical and spiritual seed was demonstrated in the prophetic blessings given to Abraham. His physical seed was likened to the sand of the sea. His spiritual seed as the stars of the heavens. In the story of Jacob/Israel; it is Jacob which represents the physical and Israel which represents the spiritual. They are not one in the same. The physical/spiritual division is also typified by the trees in the garden of Eden.



“Not as though the word of God hath taken none effect. For they are not all Israel, which are of Israel:

Neither, because they are the seed of Abraham, are they all children: but, In Isaac shall thy seed be called. That is, They which are the children of the flesh, these are not the children of God: but the children of the promise are counted for the seed.” – Rom 9:6-8

The Physical (Jacob)

“And I will make thy seed to multiply as the stars of heaven, and will give unto thy seed all these countries; and in thy seed shall all the nations of

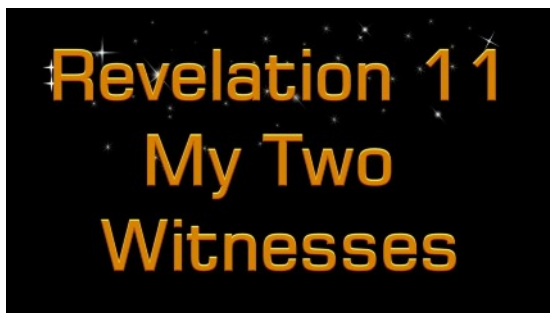
the earth be blessed; Because that Abraham obeyed my voice, and kept my charge, my commandments, my statutes, and my laws” – Gen 26:4-5

The Spiritual (Israel)

Old Testament manifestations of Jesus Christ. In any case, Jacob would not let the man go until he delivered a blessing.

The man asked Jacob his name. Obviously, the man already knew his name but was making the point of the story.

Knowing the mental excitement Jacob was experiencing in anticipation of meeting his brother, we can easily see him crying out “My name is Jacob! Yes, I know I am a supplanter! Yes, I know who and what I am! Forgive me! Bless me! I will not let you go—you **Must** bless me ere I perish!”



Jacob got his blessing that night and his name was changed. He went to bed as Jacob and when he arose, he was Israel! When he arose, he knew his thigh was out of whack. He could no longer walk as he had previously walked. He was now Israel; he who prevails **with** God. He who had to lean on God to walk uprightly. He had been born anew.

Oh! can you see it? The physical man, knowing he has been blessed with the blessings of the patriarchs, stands and prayed aloud:

It is then our responsibility to understand the level on which God is speaking when he talks about his witnesses! Too often our people insist on keeping all understanding on the physical level. An Open Letter to The Archbishop of Canterbury — Justice Anna Von Reitz Aug 18, 2021

To: The Most Reverend and Right Honourable Justin Welby, Archbishop of Canterbury.

It has come to our attention that the Queen vacated her Christian Coronation Office a mere three days after the Public Covenant Ceremony took place, and has also therefore left the land and soil jurisdiction of Great Britain vacated since June of 1953.

These facts have been definitively proven and entered into the Public Court Record in the matter of **JAH v. Regina**. This circumstance has also deprived the Church of England of its Supreme Governor for nearly seventy years.

At which point, if any, is it required of you by Law and tradition, to recognize the fact that the People of England, Ireland, Scotland, and Wales have been deprived of the Christian Monarchy they were solemnly promised, and that the sovereign is and has in effect, been missing from the land and soil?

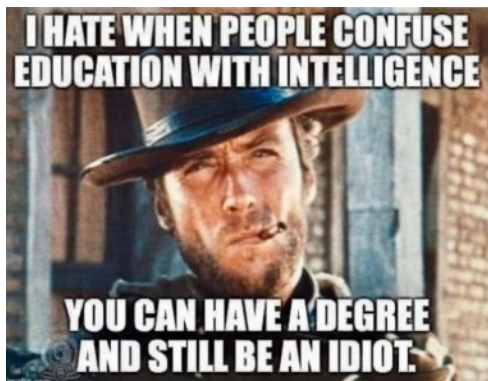

A Letter to HRH King Charles III



Sir __, Below is a copy of the letter I sent to King Charles III on 20th August this year:

Ref the Limits of Kingship

Majesty, I understand you are calling a meeting to discuss the future of the Monarchy. It is clear your knowledge of English Common and Constitutional Law is severally limited or you would know that you do not have authority to change anything about the law restricting what a King of England can do.

English Kings are elected. The one requirement of the King/Queen upon election is to do only that which benefits the Subject and the Kingdom and though you will have been taught that the 1689 Bill of Rights transferred authority from the King to Parliament, it did no such thing. It merely reiterated the things that Kings of England may never do. It did not remove any of the King's authority.

In May 1213 King John, in need of a powerful ally, surrendered England to the Pope renting it back as a vassal King to the Pope for 1000 marks a year. (*Stubbs vol 1 page 560*) After his death the tribute was paid until his son came of age. Henry III wrote to the Pope repudiating his father's surrender of England and he stopped paying the tribute. Magna Carta 1215 lays out the duty of the King to ensure his subjects live a safe and secure life.

In May 1366 King Edward III called a meeting of the Estates of England after the then Pope had demanded the unpaid monies saying he would take action against King Edward III. A meeting of the Lords Spiritual, Lords Temporal and the Commonality of England took place and first the Lords Spiritual, then the Lords Temporal and finally the Commonality of England all told the King, that he did not own England and that it

was not his to give away. He held the Crown only in trust for those who follow on. King John broke the law, the monies were not to be paid (*Stubbs Vol 11 Page 435.*)

As you can see, the Crown is not yours. You hold it only in trust for those who follow you. By the Common Law on Kingship you cannot diminish the Crown in anyway. Any attempt to do so is an act of high treason against your subjects and you have no authority to change anything for the worse as far as the Crown is concerned.

The automatic Assent is constitutionally illegal. You are required to insist upon seeing everything and you may refuse the Assent to anything that harms even the lowliest of your subjects. Anything else is constitutionally illegal. Under English Constitutional and Common Law and the Common Law of Kingship, you are required to remove the World Economic Forum and World Health Organisation from your Kingdom.

These foreign bodies are unlawful in Britain and are attempting to impose policies that will harm your subjects. You are also required to inform Parliament that they are to refuse any outside interference in the governance of your Kingdom. They are your servants, thus in turn the servants of your people. Anything less constitutes an act of treason against the constitutional arrangements of England. You are first and foremost King of England. The Invisible Rainbow Cancer and The Starvation of Life By Arthur Firstenburg



The Vatican Radio Antennae Transmitters

AT THE COMMENCEMENT OF THE TWENTIETH CENTURY THE GREAT PROBLEM OF THE CAUSATION OF TUMOURS, like a giant sphinx, looms large on the medical horizon. **W. Roger Williams**, Fellow of the Royal College of Surgeons, England, 1908

On February 24, 2011, Italy's Supreme Court upheld the criminal conviction of Cardinal Roberto Tucci, former president of Vatican Radio's management committee, for creating a public nuisance by polluting the environment with radio waves.

The Vatican's broadcasts to the world, transmitted in forty languages, emanate from fifty-eight powerful radio towers occupying over one thousand acres of land, surrounded by

suburban communities. And for decades, residents in those communities had been screaming that the transmissions were destroying their health as well as causing an epidemic of childhood leukaemia.

At the request of the Public Prosecutor's office in Rome, which was considering bringing charges against the Vatican for negligent homicide, Judge Zaira Secchi ordered an official investigation by the National Cancer Institute of Milan.



Lymphoma

The results, released November 13, 2010, were shocking. Between 1997 and 2003, children aged one to fourteen who lived between six and twelve kilometers (3.7 to 7.5 miles) from Vatican Radio's antenna farm developed leukaemia, lymphoma, or myeloma at eight times the rate of children who lived further away. And adults who lived between six and twelve kilometers from the antennas died of leukaemia at almost

seven times the rate of adults who lived further away.

The third disease of civilization that Samuel Milham related to electrification is cancer. At first blush it is not obvious what the connection is. Impaired metabolism of sugars is surely connected to diabetes, and impaired metabolism of fats to heart disease. But how does cancer fit in?

The key was provided by a scientist who studied sea urchin eggs in his laboratory over one hundred years ago. He was a native of the same city where, a century later, three thousand doctors were to sign an appeal to the world stating, among other things, that radio waves cause leukemia.



**Otto Heinrich Warburg, M.D., Ph.D.
(1883-1970)**

On October 8, 1883, a son was born to Emil Warburg, a prominent Jewish physicist in Freiburg, Germany. When he was thirteen, the family moved to Berlin, where visitors to his parents' home included some of the giants of the natural sciences—chemist Emil Fischer, physical chemist Walter Nernst, physiologist Theodor Wilhelm Engelmann.

Later, when Albert Einstein moved to Berlin, the great scientist used to come over to play chamber music with his father—Einstein on violin and Emil Warburg on piano.

No one was surprised when young Otto, growing up in such an atmosphere, enrolled in the University of Freiburg to study chemistry. But by the time he received his Ph.D. in 1906, a growing disease epidemic had caught the attention of this ambitious young man.

His was the first generation seriously to be affected by it. Cancer rates all over Europe had doubled since he was born, and he determined to devote his life to finding the reason and, hopefully, a cure. With this in mind he returned to school, receiving his M.D. from the University of Heidelberg in 1911.

What fundamental changes, he wondered, take place in the tissue when a normal cell becomes cancerous? "Does the metabolism of tumours," he asked, "growing in a disorganized manner, differ from the metabolism of orderly cells growing at the same rate?"

Impressed that both tumours and early embryos consist of undifferentiated cells that multiply rapidly, Otto Warburg began his life's work by studying fertilized eggs. Perhaps, he speculated, cancer cells are just normal cells that have reverted to an embryonic pattern of growth.



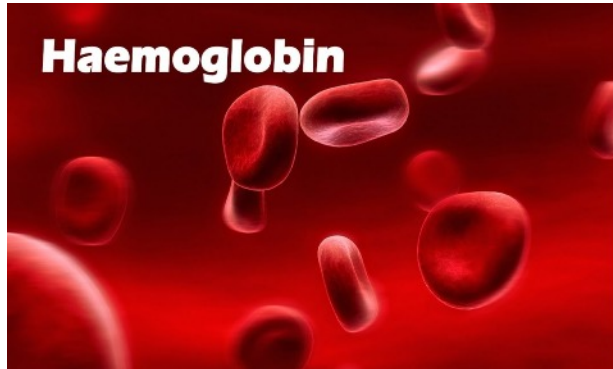
He chose the sea urchin egg (above) to study because its embryo is large and grows particularly fast. His first major work, published while he was still in medical school, showed that on fertilization the rate of oxygen consumption of an egg rises sixfold. But in 1908, he could pursue his ambition no further because the chemical reactions within cells that involve oxygen were completely unknown.

Spectrophotometry—the identification of chemicals from the frequencies of light they absorb—was new, and had not yet been applied to living systems.

Existing techniques for culturing cells and measuring gas exchange were primitive. Warburg realized that before any real progress could be made in elucidating the metabolism of cancer, fundamental research on the metabolism of normal cells would have to be done. Cancer research would have to wait.

During the coming years—with a break during which he served in the World War—Warburg, using techniques that he developed, proved that respiration in a cell took place in tiny structures that he called “grana” and that we now call mitochondria.

He experimented with the effects of alcohols, cyanide, and other chemicals on respiration and concluded that the enzymes in the “grana” must contain a heavy metal that he suspected, and later proved, was iron.



He conducted landmark experiments using spectrophotometry that proved that the portion of the enzyme that reacts with oxygen in a cell is identical with the portion of haemoglobin that binds oxygen in the blood. That chemical, called heme, is a porphyrin bonded to iron, and the enzyme containing it, which exists in every cell and makes breathing possible, is known today as cytochrome oxidase.

For this work Warburg was awarded the Nobel Prize in Physiology or Medicine in 1931.

Meanwhile, in 1923, Warburg resumed his research on cancer, picking up where he had left off fifteen years earlier. “The starting point,” he wrote, “has been the fact that the respiration of sea urchin eggs increases six-fold at the moment of fertilization,” i.e. at the moment that it changes from a state of rest to a state of growth. He expected to find a similar increase of respiration in cancer cells. But to his amazement, he found just the opposite.

The rat tumour he was working with used considerably less oxygen than normal tissues from healthy rats. “This result seemed so startling,” he wrote, “that the assumption seemed justified that the tumour lacked suitable material for combustion.” So Warburg added various

nutrients to the culture medium, still expecting to see a dramatic rise in oxygen use. Instead, when he added glucose, the tumour’s respiration ceased completely! And in trying to discover why this happened, he found that tremendous amounts of lactic acid were accumulating in the culture medium.

The tumour, in fact, was producing fully twelve percent of its weight in lactic acid per hour. Per unit time, it was producing 124 times as much lactic acid as blood, 200 times as much as a frog’s muscle at rest, and eight times as much as a frog’s muscle working to the limit of its capacity.

The tumour was consuming the glucose, all right, but it was not making use of oxygen to do it. In additional experiments on other types of cancers in animals and humans,

Warburg found that this was generally true of all cancer cells, and of no normal cells. This singular fact impressed Warburg as of utmost importance and the key to the causation of this disease.

The extraction of energy from glucose without using oxygen, a type of metabolism called anaerobic glycolysis—also called fermentation—is a highly inefficient process that takes place to a small extent in most living cells but only becomes important when not enough oxygen is available.



For example, runners, during a sprint, push their muscles to use energy faster than their lungs can deliver oxygen to them.

Their muscles temporarily produce energy anaerobically (without oxygen), incurring an oxygen debt that is repaid when they end their

sprint and stop to gulp air. Although capable of supplying energy rapidly in an emergency, anaerobic glycolysis produces much less energy for the same amount of glucose, and deposits lactic acid in the tissues that has to be disposed of.



INDUSTRIAL FERMENTATION METHODS

Fermentation is a very old form of metabolism from which all forms of life obtained their energy for billions of years, before green plants appeared on earth and filled the atmosphere with oxygen. Some primitive forms of life today—many bacteria and yeasts, for example—still rely on it, but all complex organisms have abandoned that way of making a living.

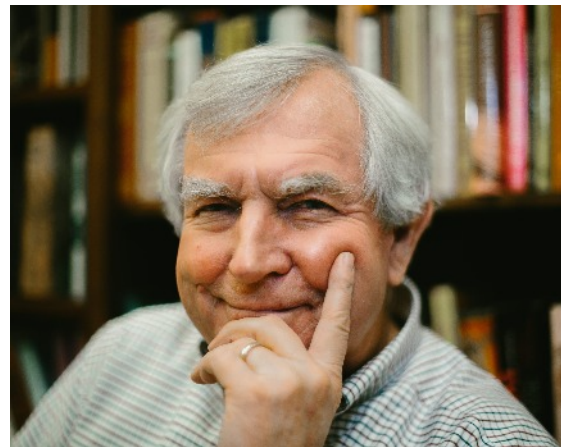
What Warburg discovered in 1923 is that cancer cells differ from normal cells in all higher organisms in this fundamental respect: they maintain high rates of anaerobic glycolysis and produce large amounts of lactic acid even in the presence of oxygen.

This discovery, called the Warburg effect, is the basis for the diagnosis and staging of cancer today, using positron emission tomography, or PET scanning. Because anaerobic glycolysis is inefficient and consumes glucose at a tremendous rate, PET scans can easily find tumours in the body by the more rapid uptake of radioactive glucose. And the more malignant the tumour, the more rapidly it takes up glucose.

Warburg reasonably believed he had discovered the cause of cancer. Evidently, in cancer, the respiratory mechanism has been damaged and has lost control over the metabolism of the cell. Unrestrained glycolysis—and unrestrained growth—are the result. In the absence of normal metabolic control the cell reverts to a more primitive state. All complex organisms, proposed Warburg, must have oxygen in order to maintain their highly differentiated forms.

Without oxygen, they will revert to a more undifferentiated, simple form of growth, such as existed exclusively on this planet before there was oxygen in the air. “The causative factor in the origin of tumours,” proposed Warburg, “is nothing other than oxygen deficiency.”

When cells are deprived of oxygen only temporarily, glycolysis takes over during the emergency, but ceases again when oxygen is once more available. But when cells are repeatedly or chronically deprived of oxygen, he said, respiratory control is eventually damaged and becomes independent. “If respiration of a growing cell is disturbed,” wrote Warburg in 1930, “as a rule the cell dies. If it does not die, a tumour cell results.”



Warburg’s hypothesis was first brought to my attention in the mid-1990’s by Dr. John Holt, a colourful figure in Australia (above) who was treating cancer with microwave radiation, and who warned his colleagues that the same radiation could convert normal cells into cancerous ones.

I didn’t fully understand the connection of Warburg’s work on cancer to my work on electricity, so I filed away the research papers Holt sent me for future reference. Today, with so many more pieces of the puzzle in place, the connection is obvious. Electricity, like rain on a campfire, dampens the flames of combustion in living cells. If Warburg was correct, and chronic lack of oxygen causes cancer, then one need look no further than electrification for the origin of the modern pandemic.

Warburg’s theory was controversial from the beginning. Hundreds of different kinds of cancers were known in the 1920’s, triggered by

thousands of kinds of chemical and physical agents. Many scientists were reluctant to believe in a common cause that was so simple. Warburg answered them with a simple explanation: each of those thousands of chemicals and agents, in its own way, starves cells of oxygen. Arsenic, he explained by way of example, is a respiratory poison that causes cancer.

Urethane is a narcotic that inhibits respiration and causes cancer. When you implant a foreign object under the skin, it causes cancer because it blocks blood circulation, starving neighbouring tissues of oxygen.

Although they didn't necessarily accept Warburg's theory of causation, other researchers lost little time confirming the Warburg effect.

Tumours did, universally, have the ability to grow without oxygen. By 1942, Dean Burk at the National Cancer Institute was able to report that this was true of over 95 percent of the cancerous tissues he had examined.

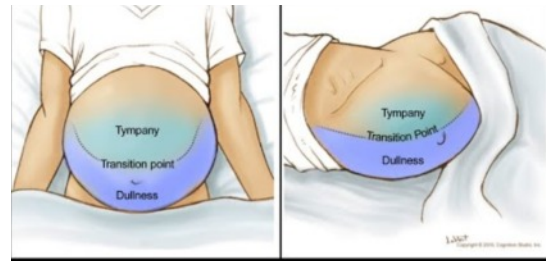
Then, in the early 1950's, Harry Goldblatt and Gladys Cameron, at the Institute for Medical Research at Cedars of Lebanon Hospital in Los Angeles, reported to a sceptical public that they had succeeded in transforming normal cells—cultured fibroblasts from the heart of a five-day-old rat—into cancer cells merely by repeatedly depriving them of oxygen.

In 1959, Paul Goldhaber gave further support to Warburg's hypothesis when he discovered that some types of Millipore diffusion chambers, but not others, when implanted under the skin of mice, caused large tumours to grow around them. Diffusion chambers were used to sample tissue fluid in many kinds of animal experiments.

Their ability to cause cancer turned out to depend not on the type of plastic they were made of, but on the size of the pores that allowed fluid to flow through them. Only one animal out of 39 developed a tumour when the pores were 450 millimicrons in diameter. But 9 out of 34 developed tumours when the pore size was 100 millimicrons, and 16 out of 35—close to half—developed tumours when the pore size was only 50 millimicrons.

The interference with free fluid circulation when the pore size was too small apparently deprived

the tissues next to the chamber walls of oxygen. In 1967, Burk's team proved that the more malignant a tumour is, the higher its rate of glycolysis, the more glucose it consumes, and the more lactic acid it produces.



“The extreme forms of rapidly growing ascites cancer cells (above).” Burk reported, “can produce lactic acid from glucose anaerobically at a sustained rate probably faster than any other living mammalian tissue—up to half the tissue dry weight per hour. Even a hummingbird, whose wings may beat up to at least one hundred times a second, consumes at best only half its dry weight of glucose equivalent per day.”

Because he insisted that the origin of cancer was known, Warburg thought that “one could prevent about 80 percent of all cancers if one could keep out the known carcinogens.” He therefore advocated, in 1954, for restrictions on cigarette smoking, pesticides, food additives, and air pollution by car exhaust.

His incorporation of these attitudes into his personal life earned him a reputation as an eccentric. Long before environmentalism was popular, Warburg had a one acre organic garden, obtained milk from an organically maintained herd, and purchased French butter because in France the use of herbicides and pesticides was more strictly controlled than in Germany.

Otto Warburg passed away in 1970 at the age of 83—the same year the first oncogene was discovered. An oncogene is an abnormal gene, thought to be caused by mutation, that is associated with the development of cancer. The discovery of oncogenes and tumour suppressor genes promoted a widespread belief that cancer was caused by genetic mutations and not by altered metabolism. Warburg's hypothesis, controversial from the start, was largely abandoned for three decades

Why Wasn't English Replaced By French During The Norman Conquest

WHAT WAS THE SOCIO-LINGUISTIC ENVIRONMENT OF EARLY MEDIEVAL BRITAIN?

When the Normans defeated the Saxons at Hastings in 1066, they arrived in a country that had already effectively witnessed a wholesale linguistic replacement: that of the Celtic-speaking Britons some five or six centuries before.

(See my other answer: Why did the Celtic population of Great Britain switch to English following the Saxon invasions?) English had also recently sustained rather intense conflict with Scandinavians of various types and some but not all of these invaders had come to settle permanently in the Danelaw.

Let's tally up what the new Norman aristocracy faced:

The Normans came in the tens of thousands, not hundreds of thousands, when they secured power for themselves. The indigenous English by comparison probably numbered at least two and a half if not three million people.

Even if you double or triple the highest estimate of William's soldiers at Hastings, around 12k, and assume that additional bureaucrats followed in their wake, the number of Norman French

speakers in England was still totally dwarfed by the indigenous population.

It is undeniable that pre-Conquest English aristocrats now had very good reasons to become fluent in French to maintain and add to their power base (though many lost their lands anyway).

The vast majority of the peasantry (95% of the population) however never had any such need: the people they interacted with were not the



nobles, but the people who oversaw the nobles' lands, who continued to be primarily English speaking. Socio-linguistically speaking,

England was not entirely unlike the exploitative colonies of 19th-20th century Africa that Salikoko Mufwene has spent decades describing in which an interface class of overseers ran the government for the elites. In this case, many upper elites didn't even spend much time in England, choosing rather to pursue petty feuds in France.

The Norman Conquest of England in 1066 was a significant event in English history, and it did have an impact on the language spoken in England.

However, it did not replace English with French. During the Norman Conquest, the Normans, who were originally from the region that is now known as Normandy in France, invaded and conquered England.

The Normans were a powerful and influential group, and they brought with them a version of Old French, which was the language spoken by the ruling class at the time. Despite this, the

majority of the population in England at the time still spoke Old English, the language of the Anglo-Saxons.

Over time, the two languages began to merge and evolve, giving birth to the Middle English language. This process was gradual and took several centuries. In summary, the Norman Conquest did not replace English with French. Instead, it influenced the development of the English language and led to the creation of a new dialect known as Anglo-Norman.

In most of Britain outside Wales and Scotland (which were at that point not under the English crown anyway), there were essentially no alternatives to speaking English: every community, from top to bottom, was English-speaking.

This is even true in the Danelaw, where the Scandinavians had largely assimilated to the local population giving us words like skirt, sky, and the pronoun they.

In the 11th century, French did not have the immense internal or external prestige that it was to acquire in later centuries. Indeed, French did not even become the official language of France until 1539, when King Francis I made it the official language of the court. (Just think about that fact for a second.)

For these reasons, it is not surprising that the English, especially among the illiterate peasantry, would probably have seen the use of Norman French as the language of occupation rather than of a self-evidently superior conqueror. French probably had high external prestige in comparison to English's not inconsiderable (but by no means high) internal prestige.

Lastly, although French is an Indo-European language like English, it was nowhere near as similar lexically or grammatically as the Norse spoken in the Danelaw -- and that Norse soon disappeared. This criterion is in any event rele-

vant only for adults trying to learn French, since children can acquire any human language with ease.

The Germanic Influence

It appears that the current, heavily Anglo-Saxon centric, version of early English history came to the fore in the early 18th century.

Act of Settlement



In 1714, in accordance with the anti-Catholic act of settlement of 1701, a protestant Saxon Duke from Hanover was crowned king of England, Wales and Scotland; he took the name George I. The new king was Georg Ludwig, Elector of Hanover; he was a mild mannered 54 year old man who couldn't speak English.

His claim to the throne was actually quite tenuous; the real power had passed to Parliament with the first de facto Prime Minister, Robert Walpole, really running the show. But Parliament had to do something to keep their hands on the real power in the country.

What they really needed to do was to make the puppet king, the very German Georg Ludwig, more popular with the British people and a bit of Water Music or a few lavish firework displays wouldn't do the trick. It is from this point in time that history told us that our "Anglo-Saxon" origins both physically and from a lingual point of view were almost exclusively from Northern Germany.

Further, that the mass Anglo-Saxon invasion had swept all the Gallo/Roman natives aside, in what is now England, in an what amounted to genocide.

This would mean of course that all the inhabitants of England were thus Anglo-Saxons, like their new king. Maybe it was just spin, Parliament instigated propaganda to manipulate British public opinion. It's, however, a myth that

became set in stone since then and this in spite of the easily findable evidence to counter it.

Racial Nihilism can be passive as well as active, characterized by acts of omission as well as commission. The preservation or condonation of a behaviour often requires positive, sustaining and affirming actions. The lack of affirmation of racial rights and values, and the acquiescence to the causes of racial destruction, are all examples of Racial Nihilism by the default, the nihilism of indifference.

This type of Racial Nihilism; a simple lack of interest, care and concern, often not consciously intended, is by far the most common form, and the most insidious. No statement expresses the essence of Nihilism more than the rhetorical question, "Who cares?" It is an expression of denial and rejection of caring, and even of contempt for caring.

When Nihilism rejects or denies the value or importance of something, or even denies its existence, it condones its sacrifice or destination, and resents and condemns as immoral those who do care for, and seek to uphold and preserve, that which is threatened.

If racial diversity is to be preserved in the modern world, where the preserving barriers of geographic distance have been overcome by advances in transportation and communication, Racial Nihilism, even in its passive, acquiescent, indifferent and unconscious form, is an error humanity can no longer afford.

The two causes of racial destruction are intermixture and replacement. Intermixture causes racial destruction by genetic dilution or submergence. Replacement involves one race being dispossessed, or "squeezed out" by others who take its place.

Multi racialism is the ideology (of the enemies of the White Race; composing mostly of Jews), or system of beliefs and values, that supports multiracial conditions and the resulting racially destructive processes of intermixture and replacement.

Racial Nihilism is the underlying ideology, psychological attitude of view of existence that provides the foundation for Multi-racialism by denying and rejecting racial rights and values, particularly the right of a race to life, independence, and the condition of separation required for both.

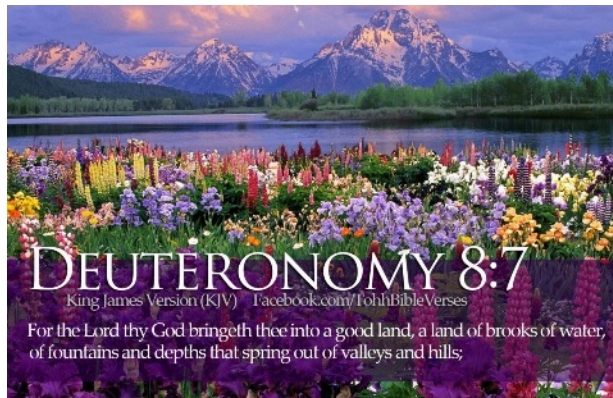


Racial destruction by intermixture and replacement is an unavoidable consequence of a multiracial society, but is effectively prevented in a mono-racial society. The reasons why certain individuals interbreed with members of different races are many and varied, but only occur under multi cultural conditions (where there is contact between different races).

There is the fact that God has chosen to cause the Children of Israel to desire mixing with the black race as punishment for their collective sins. “Behold, the days come, saith the LORD, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast.” (Jeremiah 31:27)

They do not occur under mono-racial conditions of geographic racial separation and reproductive isolation; i.e., the conditions in which the different races were created and preserved until modern times.

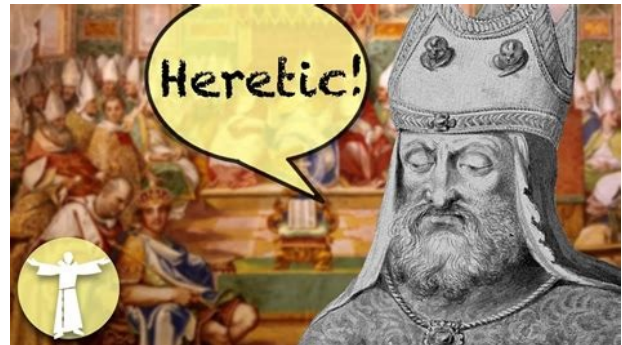


A “wasteland” is a land, place, society or situation where life is deprived of the conditions it needs to exist. A multiracial society is a racial wasteland, where the forces that cause racial death, destruction and extinction are dominant over those that promote racial life, preservation and continuation.

The wasteland of the Modern Age is the secular faith or dogma of Multi racialism; the interracialist and internationalist ideology of Universalism or “Oneness,” that denies and prevents racial freedom (independence), uniqueness, growth and development, and continued racial life, and promotes the submergence of races in a multiracial “melting pot,” replacing racial preservation and independence with the racially destructive process of Racial Nihilism.

Egalitarianism labels racial, sexual, historical, cultural and moral ideas or beliefs on the basis of whether or not they agree with and support its position. “Political correctness,” or conformance to the orthodox ideological position, is given precedence over factual correctness and the classical ideals of freedom of inquiry, and belief and conscience.

The Oneness ideal of “One World” and “One Race” seeks to eliminate human diversity by a process of blending or convergence of all into one, replacing the great variety of types with one uniform type.

Racial Nihilism has created an air of unreality with regard to racial matters, where the subjects of racial variation, diversity, differences, uniqueness and continued existence are confronted with evasion, dissimulation or denial,

where it is regarded as morally proper to pretend that races and racial differences do not exist, and where those who openly acknowledge, recognize and affirm these differences; and especially those who celebrate them and assert their value and importance, are regarded as immoral.

In this ideological climate, human racial diversity and differences are denied, trivialized or behind as unimportant and not worth preserving, or are actually regarded as immoral and as something which should be destroyed. It logically follows that racial rights are also denied or belittled, and their assertion reported as immoral.

To the Racial Nihilist racial differences are something evil, and racial diversity, variation and uniqueness is something to be denied, belittled and destroyed rather than affirmed, loved and preserved. The Racial Nihilist seeks the Egalitarianism of sameness and oneness. He wants all humanity to be the same, and the rich diversity of human racial types to be reduced to one uniform type.

Racial Nihilism is racial Egalitarianism in its most extreme form, eliminating all racial inequalities by the elimination of all racial diversity and differences.



Extreme Racial Nihilists consider it immoral to even admit that different races exist, and it would seem that some “true believers” actually believe their own propaganda.

Others dissimulate, seeking the end of racial diversity and knowing that the denial of racial existence promotes the actual destruction of that existence. Racial rights cannot be logically acknowledged or defended if the existence of races is not recognized.

Without the factual belief in a true diversity between the races there is no basis for the ethical

belief in racial rights. By denying racial existence, Racial Nihilism can rationalize its opposition to racial rights and assume a moral pose while promoting racial genocide.

But to be logically consistent, the denial of the existence of different human races not only requires the denial of the existence of genetically distinct human populations, but also the denial of the existence of all different life forms. If one is an illusion all are an illusion, at which point Racial Nihilism becomes racial Gnosticism. Gnosticism is the belief that physical life and



existence are not real, that everything in the material world is an illusion, without meaning or value. It is a form of metaphysical Nihilism. Gnostics belittle or deny the importance; in fact the reality or existence, of all that is physical or material, claiming that the only true reality is nonmaterial or “spiritual.” They seek to escape from life and physical existence, or to end it.

The word “Gnostics” is derived from the Greek word for knowledge, and the original Gnostics; “those with knowledge,” were the initiates in the Greek Mystery religions. During the Hellenistic period (the three centuries preceding the Christian era) Gnosticism became associated with a disbelief in the reality of physical existence.

This development can be attributed in part to the influence of Indian Buddhist missionaries who brought their ideas to the Mediterranean world during the Hellenistic era. (Joseph Campbell, *The Masks of God: Occidental Mythology*, Penguin Books, 1964, p. 362)

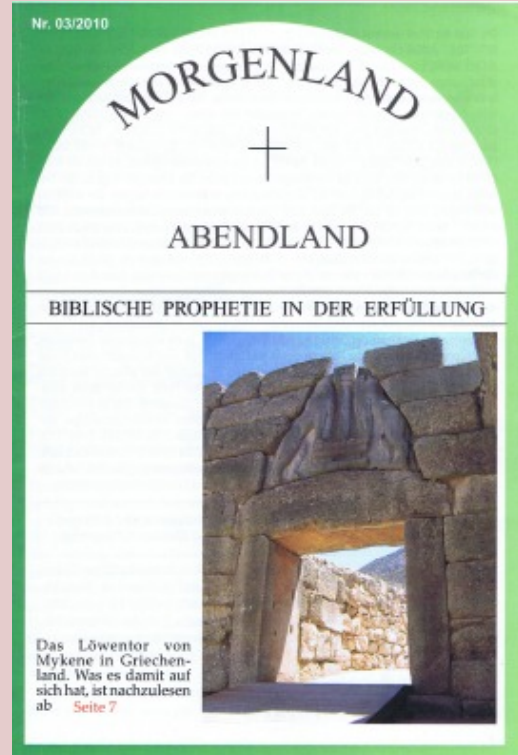
