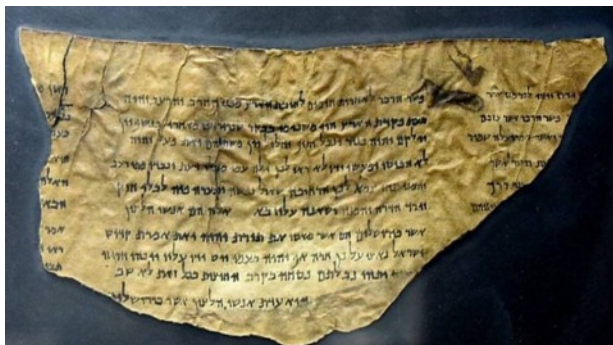

The oldest copies of the Masoretic  
Text only date back to the 10th  
century, nearly 1000 years after the  
time of Christ. And these texts differ  
from the originals in many specific  
ways. The Masoretic text is named  
after the Masoretes, who were  
scribes and Torah scholars who  
worked in the middle-east between  
the 7th and 11th centuries. {Note  
carefully:}

The texts they received, and the edits  
they provided, ensured that the  
modern Jewish texts would manifest  
a notable departure from the original  
Hebrew Scriptures. Source:

Since AZ falsely identifies the MT as a faithful

not want the veracity of biblical history to overthrow their evolutionary theories!!!! - Eli]

When you look at Strong's Concordance of the Old Testament, look at the top of the page if you have a hard copy. It says "Aramaic" dictionary, and if you have an older copy, it says "Chaldean dictionary"!

Strong's Concordance does not give you the original Hebrew words of the original bible! Instead, it gives you the Assyrian, Babylonian Aramaic words of the very corrupt Babylonian Targum bible that the Israelites were forced against their will to write while in captivity!

**[Comment:** This is, again, a very poor analysis of the situation. First of all, AZ is assuming that the Targums are "Babylonian" literature. They are not. They are Judahite literature.

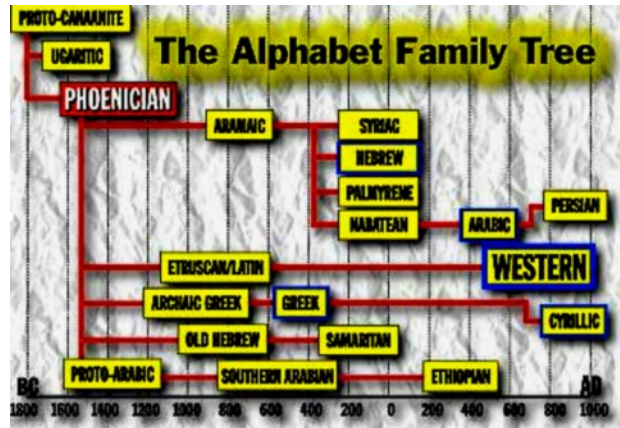

Since Ham, Shem and Japheth were brothers, they all spoke the same language. How else could they have communicated? This language is correctly referred to as Proto-Hebrew, not Proto-Canaanite.



**Noah's Flood**

The reasons for this are quite obvious from both biblical and archeological history! The Flood occurred around 2345 BC. The three brothers and their families eventually parted ways after the Ark landed in southeastern Turkey.

The biblical records tell us that Japheth went north, Shem stayed in Mesopotamia and Ham went to Egypt (Mizraim).

During this time, the descendants of these three brothers were able to communicate with one another. The Hamites spoke a language that used to be categorized as “Hamito-Semitic,” but that designation has been changed by these devious academics to “Afro-Semitic” in order to imply the evolutionists’ false “out of Africa” claims.

Moses and Joseph had no problems communicating with the Egyptians. This is because their languages had to be either identical or very similar in order to communicate as easily as they did! I hope this makes sense to all of the sceptics who follow the anti-biblical “scholars” of secular academia.



### The Curse of Ham Falls on Canaan

Since Canaan was a son of Ham, Canaan spoke proto-Hebrew, not proto-Canaanite. Canaan begat the various Canaanite tribes, who became the worst enemies of the Israelites. Nevertheless, the Canaanites and the Israelites were able to communicate very easily.

The Bible very clearly tells us that, after the Israelites conquered the territory of the Canaanites, several tribes, such as Dan and Asher took over the area and the city of Tyre (above).

Under David and Solomon, Hiram, king of Tyre was an ally of both Israelite kings. However, after the split between Jeroboam and Rehoboam, the ten northern tribes became idolatrous pagans and adopted the religion of the Canaanites. This split occurred circa 900 BC.

It was not until **after** this event that any talk of Phoenicians and their language is possible, because Phoenicia was an offshoot of Tyre; and the ships of Tyre (Phoenicia) were manned by these paganised Israelites.

Hebrew preceded Phoenician, not vice-versa. AZ has been flummoxed by both Talmudic Jews and god-hating evolutionists!

This is the type of “proof” he is offering?

Douglas Petrovich, biblical linguist and archaeologist, has this to say about this topic: In Part 1 of the series it was shown that most academic outlets have long portrayed Phoenician

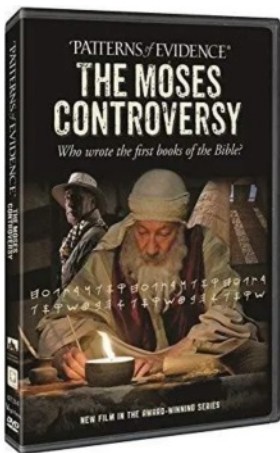
as the world's first alphabet, which developed after the time of the Exodus and became the basis of all modern alphabets. This thinking has been propagated despite the fact that there has been clear evidence that the oldest examples of the alphabet don't come from Phoenicia and predate the existence of Phoenician culture.

Leaders in the field would be careful not to ascribe the name of "Phoenician" to the first alphabet, but that message has not been getting out to the myriad of classroom and media outlets that continue to teach that.

This issue is critical for understanding the roots of the Bible, since the sophistication of the biblical narrative required an alphabet to be in place for it to be written. If the alphabet was first developed by Phoenicians in 1050 BC (or even around 1200 BC) that would mean Moses could not have been the author of writings that ended up becoming the first books of the Bible as tradition and the Bible itself claim.

However, if the alphabet developed centuries earlier, in the very area where the Israelites are said to have been active in the years before and during the Exodus, then this would fit nicely with the claims of the Bible.

Many experts in the area of ancient languages have recognized that the earliest alphabetic scripts developed from Egyptian hieroglyphs and were in a Semitic language (the broad cultural group that the Israelites were a part of), but few have entertained the idea that this language may have been the more specific category of "Hebrew," the language of the Israelites. Linguistic Evidence from the New World: David Allen Deal, in his book, *Discovery of Ancient America*, on p. 11 has this to say about Dr. Robert Pfeiffer's

translation of the paleo-Hebrew inscriptions on the Ten Commandments Stone, near Albuquerque, New Mexico: (Picture below:



“Though most of Dr. Pfeiffer’s translation is correct, his definition of the language as Phoenician, implying that the authors of the inscription were Phoenician, is certainly a **m i s c o n c e p t i o n**. Unfortunately, Dr. Pfeiffer is not alive to answer any of the obvious questions which arise.

Why would the Phoenician people have any inclination to write the Ten Commandments? Would this not more logically be an act of an Israelite, especially a Judahite or Jew [sic – Eli] who of the various tribes of Israel tenaciously continued in the laws of Moses long after the other tribes had abandoned the faith? Indeed, the very thought, meaning and essence of Inscription Rock points to a worshipper of Yahweh.”

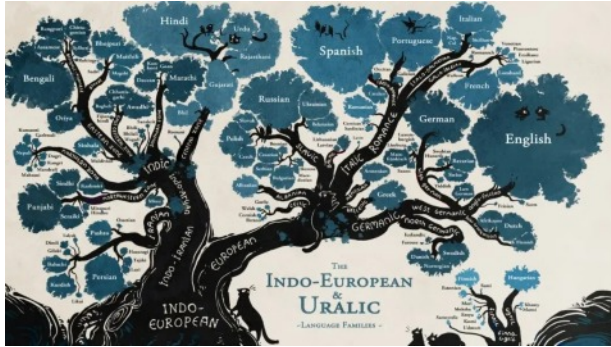
This is indeed correct, however, most Judeo-Christians have no idea that the Phoenicians were actually the same paganised Israelites Mr. Deal identifies. Even in their paganism, they would still have remembered the name of their exclusive God, Yahweh.

The fact is that the Phoenicians cannot be Canaanites, because the Canaanites were neither shipbuilders nor seafarers, like virtually all twelve tribes of Israel were. As Mr. Deal explains, no Canaanite would ever inscribe a monument to Yahweh and the Ten Commandments, because these things were hated by the Canaanites, precisely because they were exclusively a part of Israelite culture.

Note also that today’s Jews are descendants of those Canaanites; and they still hate Yahweh. That is why they have gone to such great lengths to erase His name!

Such paleo-Hebrew inscriptions are found all over North America, as David and Solomon sent Israelite ships out to mine tin, copper and other metals and crystals. In variations of the paleo-

Hebrew script, the name of Yahweh is literally found all over the area today known as America. Here is the **Correct Tree of Languages, as Given to Us by the Bible:**



Note that Aram and Asshur were direct sons of Shem. Now, what language would these brothers have spoken? Greek, Latin, English, Yiddish, Assyrian? How about proto-Hebrew or Aramaic?



Proto-Hebrew (probably spoken by Adam and Eve in the Garden and on down to Noah and his three sons and their wives.)

### Next Come Japhetic, Shemitic and Hamitic.

“And the children of Aram; Uz, and Hul, and Gether, and Mash. And Arphaxad begat Salah; and Salah begat Eber. And unto Eber were born two sons: the name of one was Peleg; for in his days was the earth divided; and his brother's name was Joktan.” – Gen. 10:23-25.

Japhetic gave rise to Greek, as Javan, the fourth son of Japheth settled in that territory called Ionia (an epithet of Javan, originally pronounced Yahvahn – here, the J is also pronounced like Y, not a J, even today). This territory became known as Greece.

Arphaxad, brother of Aram, is Eber’s grandfather. Asshur is also a brother of Aram. A portion of Asshur, in due time, became known as Assyria. It is obvious that these people were able to communicate with each other down to the times of the break-up of the Tribes of Israel. Their scripts may have been different, but their speech was similar.

Heber, a descendant of Shem, also spoke proto-Hebrew. The Hebrew language is named after Eber. But the Hebrews obviously created their own dialect, which was the language of both spoken and written Hebrew in OT times.

Since they are literal brothers and cousins, they all spoke the same language and subsequently developed their own dialects of proto-Hebrew.

As stated earlier, the Hamites, except for those Hamites that were present with Nimrod at the tower of Babel, retained their dialect of proto-Hebrew, because all of these dialects are either the direct descendants or cognates of Proto-Hebrew.

At this point, since AZ’s theology and understanding of the Bible is so obviously coloured by pagan, Jewish and atheistic/agnostic opinions, I think it should be obvious that his thesis is brutally defective. At this point, the reader should understand why I think AZ lacks discernment.

These three groups easily communicated with one another. The written forms of these languages varied widely, but there is no doubt that the spoken languages were very similar even into the days of the Israelite invasion of Canaan, as the Amarna Letters prove.

Further on, “Apostle” Zimmerman presents the argument that, because Satanists use the name of Yahweh in their chants, then Yahweh must be their god. This false idea has given rise to the completely spurious idea that Yahweh must be Satan, or a demon, because these Satanists **Supposedly** invoke the name of Yahweh in their rituals. **Continuing with AZ:** Notice chart 1 (next column) of the alphabet family tree. Notice how "Hebrew" & "Syriac" are brother languages, sons of Aramaic (Assyrian). Yet "Old Hebrew" or Paleo-Hebrew is not. They both descended from Phoenician language;

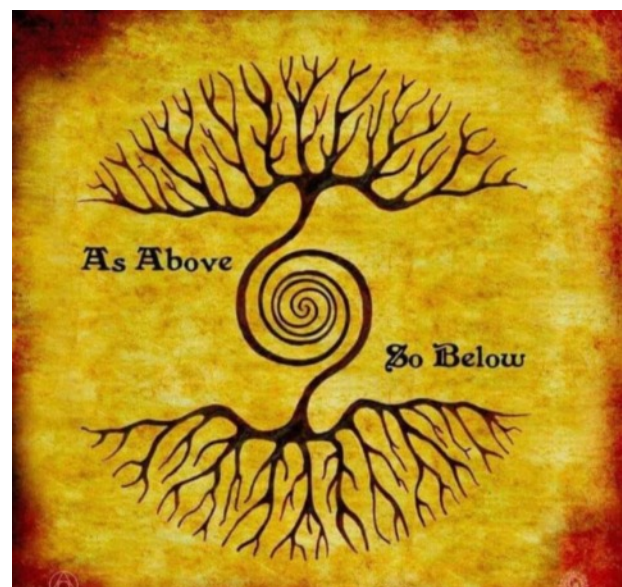
Examine chart 4 farther down the page to see that true ancient Hebrew looks & sounds like Greek. History also shows that the Greeks attained their language from the Israelites.

# Old Testament

## “Word for Word” Exodus Chap. 34 - Part 29

### Translation by Stephen Howard Anderson



## Chapter 34

1. And said Yahweh to Mosheh, "**Hew you two tablets of stone like the first ones: and I will write upon these tablets the Words that were on the first tablets, which you broke.**

2. **Be ready in the morning, and come up in the morning unto Mount Siynay, and present yourself there to Me in the top of the mountain.**

3. **And no man shall come up with you, neither let any man be seen throughout all the mountain; neither let the flocks or the herds feed before the mountain."**

4. And he hewed two tablets of stone like the first ones; and Mosheh rose up early in the morning, and went up into Mount Siynay, as Yahweh had commanded him, and took the two tablets of stone with him in his hand.

5. And Yahweh descended in the cloud, and stood with him there, and proclaimed The Name of YHWH.

6. And Yahweh passed by before him, and proclaimed, "**Yahweh! Yahweh! El 410, merciful 7349 and gracious 2587, longsuffering 750/639, and abundant in kindness 2617 and truth 571,**

7. **keeping mercy 2716 for thousands, forgiving 5375 iniquity and transgression**

**and sin, and that will by no means clear 5352 the guilty; visiting 6485 the iniquity of the fathers upon the children, and upon the children's children, unto the third and to the fourth generation."**

8. And Mosheh made haste, and bowed his head toward the ground, and prostrated himself.

9. And said he, "If I have now found favor in Your eyes, O Yahweh, let Yahweh, please, go among us; for it is a stiff necked people; and pardon our iniquity and our sin, and take us for Your inheritance 5157."

10. And said Yahweh, "**Behold, I make a Covenant 1285: before all your people I will do wonders 6381, such as have not been done in all the land, nor in any nation: and all the peoples among which you are shall see the work of Yahweh: for it is an awesome thing 3372 that I will do with you.**

11. **Observe 8104 what I command you this day: behold, I drive out the Emoriy, the K'naaniy, the Chittiy, the Perizziy, the Chiwviy, and the Yebusiy.**

12. **Guard yourselves, lest you make a covenant with the inhabitants of the land where you are going, lest it be a trap 4170 in the midst of you:**

13. **But you shall tear down 5422 their altars, break 7665 their sacred pillars 4676, and cut down 3772 their images of Asherah 842:**

14. **for you shall bow down to no other el 410: for I Yahweh, whose Name is Jealous 7067, is a jealous El:**

15. **lest you make a covenant with the inhabitants of the land, and they go-a-whoring 2181 after eloheyhem 430, and do sacrifice to eloheyhem, and one of them calls you, and you eat of his sacrifice;**

16. **and you take of their daughters unto your sons, and their daughters go-a-whoring after**

eloheyhen 430, and make your sons go-a-whoring after eloheyhen.

17. Elohey 430 of castings 4541 you shall not make.

18. You shall keep the Feast of Matstsoth. Seven days you shall eat matstsoth, as I commanded you, in the month Abiyb: because in the month Abiyb you came forth from Mitsrayim.

19. All that opens the womb 7358 is Mine; and every firstling 6363 among your livestock 4735, whether ox or sheep that is male 2145.

20. But the firstling of an ass you shall redeem with a lamb: and if you do not redeem him, then you shall break his neck 6202. All the firstborn of your sons you shall redeem. None shall appear before Me empty handed 7387.



21. Six days you shall work, but on the seventh day you shall cease from work 7673: in shearing time 2758 and and in harvest 7105 you shall cease from work.

22. And you shall observe the Feast of Weeks, of the firstfruits of wheat harvest, and the Feast of Ingathering at the end of the year.

23. Three times a year all your male children 2138 shall appear in the presence of the Lord 113 Yahweh Elohey Yisrael.

24. I will cast out the nations before you, and enlarge 7337 your borders 1366: and no man shall desire your land, when you go up to appear in the presence of Yahweh Eloheycha 430 three times in the year.

25. You shall not offer the blood of My sacrifice with leaven 2557; and the sacrifice of the Feast of the Passover shall not be left until morning.

26. The first of the firstfruits of your land you shall bring to the House of Yahweh Eloheycha. You shall not boil 1310 a kid in its mother's milk."

27. And said Yahweh to Mosheh, "You shall write these words: because upon 5921 the speaking 6310 of these words I have made a Covenant with you and with Yisrael."

28. And he was there with Yahweh forty days and forty nights; and he did not eat bread, nor drink water. And He wrote upon the tablets the Words of the Covenant, The Ten 6235 Words 1697.

29. And it came to be, when came down Mosheh from Mount Siynay with the two tablets of Covenant in Mosheh's hand, when came he down from the Mount, that did not know Mosheh that the skin 5785 of his face shone 7160 while he talked with Him.

30. And when Aharon and all the children of Yisrael saw Mosheh, behold, the skin of his face shone, and they feared to come near him.

31. And called Mosheh to them; and Aharon and all the leaders of the congregation returned to him: and talked Mosheh with them.

32. and afterward all the children came near: and he gave them in commandment 6680 all that Yahweh had spoken with him on Mount Siynay.

33. And he put a veil upon his face until he was done speaking with them.

34. But when went in Mosheh to the presence of Yahweh to speak with Him, he took the veil off, until he came forth. And he came forth, and spoke to the children of Yisrael that which he was commanded.

35. And the children of Yisrael saw the face of Mosheh, that the skin of Mosheh's face shone: and put on Mosheh the veil again upon his face, until he went in to speak with Yahweh.



## Chapter 34 Notes

This chapter is filled with action, as Yahweh says He will re-write the two stone tablets for Mosheh. No one could come on the Mountain while this was going on, on pain of death. This included livestock.

Yahweh proclaims His Name, and Mosheh is overwhelmed and bows in worship instantly. Mosheh cries out the Holy Name twice, and begs for mercy for Yisrael. Yahweh agrees, and tells Mosheh all the things He will do. He gives strict orders not to have dealings with the indigenous pagan people around them, because their pagan worship will corrupt them.

Yisrael is to destroy all the pagan worship sites. He then repeats the commands to observe all the sacred feast-days and keep the Shabbath day holy. The very act of His Words being spoken constitute a Covenant, the Ten Words.

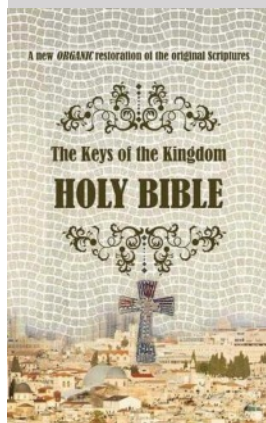

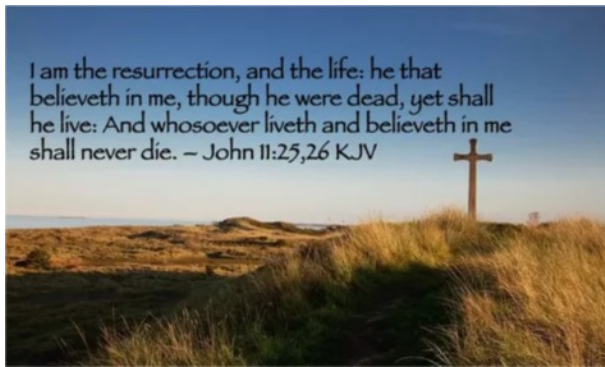

## Harold Stough Notes Were Stonehenge Stones Transferred From Kildare By Ambrosius and Uther

**A**N INTERESTING EXERT FROM DANIEL HAIGH'S CONQUEST OF BRITAIN. Did Ambrosius and Uther transport stone circles from Kildare to create Stonehenge? Extract below:



**Stonehenge**

.....incidentally records an instance of this restitution, when it has occasion to notice Pascent, the third son of Vortigern, who reigned in two provinces, Buelt and Guorthegirnam, by the gift of Embresius, who was a great king amongst "the kings of Britain."

The restoration of Winchester and other cities also occupied Ambrosius. When this was done he proceeded to Ambresbury, to visit the tombs of those who were slain by Hengest, resolved on the erection of a monument to their memory; and through the aid of the mechanical skill of Merlin, at whose disposal a force of fifteen thousand under the command of Uther was placed, transported from Kildare to Salisbury Plain, the grand circles of Stonehenge, after a victory over one of the kings of Ireland, who attempted to impede the execution of their design.

I see no improbability in this story. There the monument stands, erected at some period or other by the hands of men; a force such as that which is said to have been sent to Ireland was more than sufficient for the work; and its energies were directed by the master-mind of Merlin, whom we have no occasion to suppose anything more than a philosopher, though he

may have had the credit of being a magician, like others who have been in advance of their age.

The constant tradition of Wales assigns the erection of it to Ambrosius (below), and calls it Cor Emrys; and the Rev. W. D. Coneybeare has satisfactorily proved that its geological character is decidedly in favour of this tradition.



**Ambrosius Aurelianus**

It consists of four concentric circles; of which the innermost and the third are composed of single tapering stones of green-stone rock, which is not found nearer to the spot than Dartmoor in Devonshire on the one hand, and Charnwood in Leicestershire on the other, each fully one hundred miles distant; but the mountains which rise from the Bog of Allen in Kildare are composed of it; and as the carriage of such stones would be more easily accomplished by water than by land, it is far more probable that they were brought down the Liffey, across the Channel, and up the Avon to within a few miles of the site of Stonehenge, than that they should have been transported one hundred miles over land.

These stones are much inferior in dimensions to those of the second and fourth circles which enclose them, and which consist of gigantic triathlons of the coarse sand-stone which abounds on the neighbouring downs; and there seems to be no more probable way of accounting for the circumstance of two such noble circles, of indigenous material, enclosing two others of

meaner character, which have certainly been brought from an immense distance, than that which the story supplies and suggests; viz. that the latter, on account of their supposed virtue, were transported by Ambrosius from a mountain in Kildare (below), (or from Killair in the adjoining county of Meath, in which circles of the same kind still exist), to their present home, and that he there surrounded them with the two circles of trilithons, which differ from all other works of the kind.



The stones being brought over, and the circles erected, Ambrosius celebrated the feast of his coronation at Pentecost, and nominated Dubricius and Sanxo to the metropolitan sees of Caerleon and York. S. Dubricius had already been Bishop of Llandaff, and as we are informed in his Life, that S. Germanus performed the ceremony of his consecration to that see, and that of his translation to Caerleon, we have additional evidence that S. Germanus' second sojourn in this country was during Ambrosius' reign[3].

The History of the Britons[4] says, that he returned to his own country after the death of Vortigern. This cannot have been later than A.D. 447, and may have been earlier; he died at Ravenna, July 25, A. D. 448.

Buchanan says, that Ambrosius attempted to take Westmoreland from the Scots, and that the matter was on the point of being settled by the sword, when fears of the common enemy put an end to the dispute.

This probably occurred towards the conclusion of his reign, when Pascent, the son of Vortigern, began to aspire to the crown of Britain, formed a league with Octa, accompanied him to Germany, raised an army there, and returned with him to Northumbria. Ambrosius marched against them promptly and defeated them, yet

(says Boece) with so great loss, that he refrained from further hostilities, and granted them a four months' truce.

Octa availed himself of this respite to send Pascent to Germany for reinforcements; and he, being driven by contrary winds to Ireland, found Gillomaur inflamed with desires of revenge on account of the removal of the stone circles, and glad to embrace the opportunity of an alliance with him and Octa. Accordingly they fitted out a large fleet, and landed near Menevia. Ambrosius lay sick at Winchester, and was consequently unable to lead his forces in person,

Gildas, abbot of a monastery which he founded at Llancarvan, where we shall find him some years later in this history. S. Iltut, also, is said, by Vincent and in the Register of Llandaff, to have been one of his disciples; a fact which Usher has noticed as incompatible with his chronology, but which is perfectly consistent with ours. Some accounts say, that S. Iltut was appointed by S. Germanus abbot of Caer Worgorn, now Llanilyd ; others that he was a soldier at the court of Arthur, was persuaded by S. Cadoc to renounce the world, and appointed by S. Dubricius, (who is said to have had the monastery committed to his charge by S. Germanus), his successor. These statements again are quite in accordance with our chronology, as well as with that which may be deduced from the pedigree of S. Iltut. For he was the grandson of Aldor, S. Germanus' brother-in-law, and as S. Germanus was born in A.D. 378, S. Iltut may well have been a pupil of his, and, (as being of Arthur's kindred), may have been present at his court at the beginning of his reign.

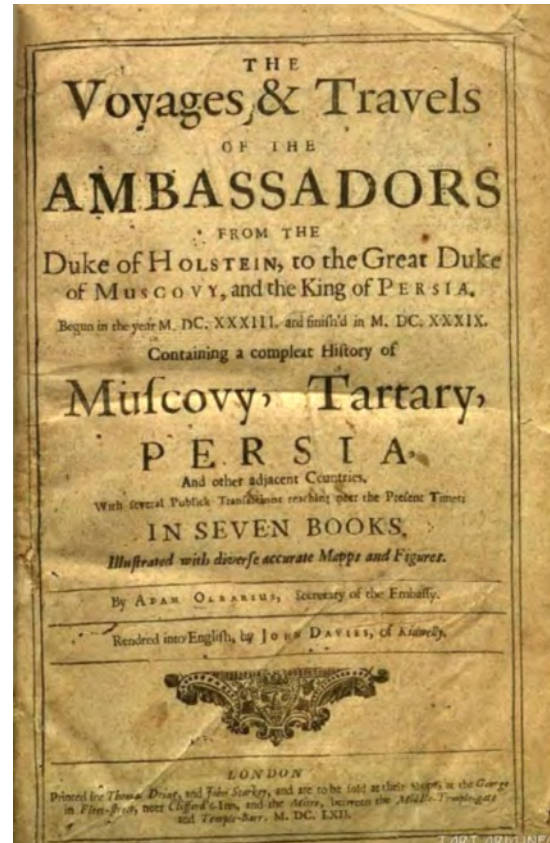
12. That the Book of Revelation we know of contains a horoscope that is dated to 25 September - 10 October 1486 compiled by cabbalist Johannes Reuchlin.

**Anatoly Fomenko**

Fomenko claims that the most probable prototype of the historical Jesus was Andronikos I Komnenos (allegedly AD 1152 to 1185), the emperor of Byzantium, known for his failed reforms, his traits and deeds reflected in ‘biographies’ of many real and imaginary persons.[18]

The historical Jesus is a composite figure and reflection of the Old-Testament prophet Elisha (850–800 BC?), Pope Gregory VII (1020?–1085), Saint Basil of Caesarea (330–379), and even Li Yuanhao (also known as Emperor Jingzong or “Son of Heaven” – emperor of Western Xia, who reigned in 1032–1048), Euclides, Bacchus and Dionysius.

Fomenko explains the seemingly vast differences in the biographies of these figures as resulting from difference in languages, points of view and timeframe of the authors of said accounts and biographies.

He claims that the historical Jesus was born in Cape Fiolent, Crimea, on December 25th, 1152 A.D. and was crucified on March 20th, 1185 A.D., on Joshua’s Hill, overlooking the Bosphorus.



Mr. Fomenko also merges the cities and histories of Jerusalem, Rome and Troy into “New Rome” = Gospel Jerusalem (in the 12th and 13th centuries) = Troy = Yoros Castle.

To the south of Yoros Castle is Joshua’s Hill which Fomenko alleges is the hill Calvary depicted in the Bible. Fomenko claims the Hagia Sophia is actually the biblical Temple of Solomon. He identifies Solomon as sultan Suleiman the Magnificent (1494–1566).

However, according to Mr. Fomenko the word “Rome” is a placeholder and can signify any one of several different cities and kingdoms. He

claims: the “First Rome” or “Ancient Rome” or “Mizraim” is an ancient Egyptian kingdom in the delta of the Nile with its capital in Alexandria, that the second and most famous “New Rome” is Constantinople, and that the third “Rome” is constituted by three different cities: Constantinople (again), Rome in Italy, and Moscow.

Also according to his claims, Rome in Italy was founded around AD 1380 by Aeneas and Moscow as the third Rome was the capital of the great “Russian Horde”.

#### 1. the Division of the Remains of Russia-Horde between the Romanovs And the USA, Which Occurred in the Wreckage of the American Territories Of the Empire Immediately after the Romanovs’ Victory over ‘Pugachev’.

In the XVIII century there existed another ‘Tartar’ state – the Independent Tartary with its capital in Samarkand [1118], v. 2, p .682-684. It was another large ‘splinter’ of Russia-Horde. Unlike Moscow Tartary, the fate of this state is known. It was conquered by the Romanovs in the middle of the XIX century.



**Samarkand**

Samarkand, the capital of the Independent Tartary, was seized by the Romanovs army in 1868 [183], part 3, p. 309. Before the defeat of Pugachev the entire Siberia was on the whole a country independent of the Romanovs. There were a number of states.

Only after the victory over ‘Pugachev’ the Romanovs began to ‘place’ on the map of Russia the countries’ names famous in old Russian history – the countries-provinces of the ‘Mongol’ Empire [4 v 2], ch. 2:20. For example, Perm and Vyatka. In fact, mediaeval Perm is Germany, and mediaeval Vyatka is Italy.

These names of the old Imperial provinces were on the Russian coat of arms. After the break-up of the Empire the Romanovs began the rewriting the history of Russia.

In particular it was necessary to relocate these names from Western Europe to some place far off, into the wilderness. Which was done. But only after the victory over Pugachev. Notably, it was done rather quickly. The Romanovs began to replace the coats of arms of the Russian cities and regions only in the second half of the XVIII century.



**The Victory over Pugachev**

On the whole in 1781, change of the coats of arms began 6 years after the victory over Pugachev – the last independent Hordian Czar, or the military commander of the Czar of Moscow Tartary.

According to the maps of the XVIII century, the border of Moscow Tartary was very close to Moscow. Such a dangerous proximity greatly concerned the Romanovs. It is possible that it was the reason for Peter the Great to make a decision to relocate the capital further away, to the swampy coasts of the Gulf of Finland. Here the new capital was built – St. Petersburg.

This location was convenient for the Romanovs. Now the capital was far away from the Hordian Tartary.



### Tatars in the Vanguard of the Ottoman Army

Besides, in the case of an invasion from the Siberian-American Horde, it would be easier to flee to the West from St. Petersburg than from Moscow. Mind you, for some reason they didn't fear invasion from the sea to the **West**.

In St. Petersburg it is possible to board a ship made ready at the doorstep of the Czar's castle and quickly embark to Western Europe - to friends and relatives, to the historical motherland of the Romanov house.

The official explanation of the Romanovs for relocating the capital of Russia from Moscow to St. Petersburg was not very convincing. They said that Peter I was 'cutting a window through to Europe', since it was easier to trade from there.

But it was possible to trade from the shores of the Gulf of Finland without moving the capital there. They could have simply built a large trading port, and a city next to it. But why did they need to make it the capital of the country? Furthermore, Siberia becomes a place for the exiled only after the Romanovs' defeat of Pugachev at the end of the XVIII century.

Prior to this they exiled people to Solovki, i.e. Solovetsky Archipelago. In any case to the North, but not to Siberia. Let us see when the regular exiles to Siberia began. In particular, Tobolsk became a place of exile only since 1790, when A. N. Radishev was The One World Tartarians exiled there. Since then Tobolsk has

become the **Permanent** place of exile. For example, the Decembrists were exiled there. But prior to 1790 over almost the entire XVIII century nobody was exiled to Tobolsk for some reason. The vast governmental system of Siberian exile and Siberian hard labour was created only in the XIX century.

### USA

Let's go back to the question of when and how the USA was established. 'During the War of independence of North America in 1775-1798 an independent state – the USA was formed. And here we realise, that it **Surprisingly Coincides with the End of the War with 'Pugachev' in Russia.** 'Pugachev' was crushed in 1775. Everything falls into place.



### American War of Interdependence

'The War of independence' in North America was the struggle with the weakening Russian Horde. The Romanovs attacked the Horde from the West. And from the East in America - it was attacked by the Americans 'fighting for independence'.

Today we are told that the Americans purportedly fought for their 'independence from Britain'. In fact it was a battle for the parceling of the vast American land of Moscow Tartary left without any central administration.

This map is very significant, because it demonstrates that the Americas is Asia Major/Asia Proper, aka, the Orient (the East). It actually makes perfect sense that Ancient Greece and Ancient Rome was in Old World’

# Where Have All the Insects Gone? Satellites Are Taking Them, Every One!

**T**HE LEAST NOTICED AND GREATEST ASSAULT ON EARTHLY LIFE RAINS ON US FROM THE SKY. Nature's wires strung above us from horizon to horizon, carrying the electricity that helps power our bodies, and the information that informs our growth, healing, and daily lives, now carries dirty electricity -- millions of frequencies and pulsations that confuse our cells and organs, and dim our nervous systems, be we humans, elephants, birds, insects, fish, or flowering plants.

The pulsations pollute the Earth beneath our feet, surround us in the air through which we fly, course through the oceans in which we swim, flow through our veins and our meridians, and enter us through our leaves and our roots. The planetary transformer that used to gentle the solar wind now agitates, inflames.

The lake pictured above is the United Kingdom's largest. Located in Northern Ireland, Lough Neagh swarms so densely with flies every spring and summer that residents shut their windows against the living smoke. Clothes left out on a line are covered with them. So is any windshield on a vehicle travelling around the lough's 90-mile shoreline. Until 2023.

Last year, unbelievably, no flies were to be seen. Windshields and hanging clothes were bare of them. None flew into open windows. Other

species that used to eat them were gone as well —ducks, frogs, fish, eels, and predatory insects. Fly larvae were not there to keep the lake bottom clean. Little was alive in the lough (Irish word for loch) except an overgrowth of algae. “Has the ecosystem of the UK's largest lake collapsed?” asked The Guardian in a February 19, 2024 article.

Has the ecosystem of the entire Earth collapsed? we ask, for the same is happening all over, according to reports I have been receiving for a year from almost everywhere on every continent. 56 Years of Global Vandalism.



On June 13, 1968, the United States completed its launch of the world's first constellation of military satellites. Twenty-eight of them, more than twice as many satellites as were in orbit around the Earth until then, were lofted to an altitude of 18,000 feet, in the heart of the outer Van Allen radiation belt. The “Hong Kong” flu pandemic began two weeks later and lasted for almost two years.

For the next three decades, the skies slowly filled up with hundreds of satellites, mostly for military purposes. Then in the late 1990's, cell phones became popular.

On May 17, 1998, a company named Iridium completed its launch of a fleet of 66 satellites into the ionosphere, at an altitude of only 485 miles, and began testing them.

They were going to provide cell phone service to the general public from anywhere on earth. Each satellite aimed 48 separate beams at the

earth's surface, thus dividing the planet into 3,168 cells. Reports of insomnia came from throughout the world.



Iridium's satellites began commercial service on September 23, 1998. The effect was devastating. I contacted 57 people in my network in 6 countries, plus two nurses, one physician, and a support group for patients.

86% of the people I interviewed, and the majority of patients and support group members, became ill on Wednesday, September 23 exactly, with headaches, dizziness, nausea, insomnia, nosebleeds, heart palpitations, asthma attacks, ringing in the ears, etc.

One person said it felt like a knife went through the back of her head early Wednesday morning. Another had stabbing pains in the chest. Some, including me, were so sick we weren't sure we were going to live. We were all acutely ill for up to three weeks. I suddenly lost my sense of smell on September 23, and did not recover it for six years.

Mortality statistics from the U.S. Centres for Disease Control revealed a 4% to 5% rise in the national death rate beginning the last week in September and lasting two weeks. Some people reported a reddish sky the night of September 23.

In early December 1998, I again received telephone calls from far and wide asking me what had changed. Orbcomm, providing data service to industries, had gone commercial on November 30 with 28 satellites orbiting 500 miles up.

On July 25, 1999, another company, Globalstar, achieved worldwide cell phone coverage with 32 satellites, 876 miles up, and began testing. I again received calls from people who were certain the earth felt different again.

On February 28, 2000, Globalstar completed its constellation of 48 satellites and went commercial. Nausea, headaches, leg pain, and respiratory problems were widespread, both among people who called themselves electrically sensitive and people who did not. The effects were felt starting on Friday, February 25, the previous business day.

Iridium, which had gone bankrupt in August 1999, resumed full commercial cell phone service worldwide on March 30, 2001 after signing a contract with the U.S. Military.

The night of March 30 was accompanied by an even more intense and widespread red sky than the one that had accompanied its initial launch of service two and a half years previously.

A red aurora was seen in the northern hemisphere as far south as Mexico, as well as in the southern hemisphere.



There was a catastrophic loss of Kentucky race horse foals in late April and early May, and since mares abort several weeks to a month after a viral infection or other triggering event, this put the triggering event at about the end of March.

Similar foaling problems were reported at the same time from Ohio, Tennessee, Pennsylvania, Illinois, Maryland, Texas, northern Michigan, and Peru. Breeders also reported both newborn and older horses with unusual eye problems, and adult horses with pericarditis.

On June 5, 2001, Iridium added data to its voice service, including connection to the Internet. Hoarseness was a prominent complaint of many who contacted me during the next few weeks. For the next two decades, Iridium and Globalstar were the only providers of satellite phones. Enter SpaceX in 2019.





In November 2019, SpaceX began regular launchings of 60 satellites at a time into even lower orbit, only 326 to 350 miles up, and I began to receive reports from people around the world of headaches, dizziness, insomnia, exhaustion, skin problems, feelings of oppression, and heart problems. Almost 200 people in my network reported heart palpitations, heart arrhythmias, or heart attacks.

In March 2021, the density of signals polluting the ionosphere increased significantly. SpaceX, which had already launched more than 1,000 Starlink satellites and was testing them on a limited number of customers, launched 60 satellites on March 4, 60 more on March 11, 60 more on March 14, and 60 more on March 24.

A competitor, OneWeb, also launched 36 satellites on the night of March 24. More satellites were launched into space in that month and on that day than ever before. And on March 24, SpaceX dramatically increased the speed of its satellite internet connections to over 400 Mbps.

On March 24, 2021, a threshold was passed, and the deterioration of life on Earth accelerated tremendously. Some people reported not feeling well beginning on March 4 or March 11, but 1,000 people in 50 countries emailed or called me on or after March 24 confirming my own awareness that something terrible was happening to our planet.

The reports came from people in New York City, Paris and London, and from people living in

remote locations miles from the nearest cell tower. They came from people who used no wireless technology at all, and from people who had smart meters on their homes and 5G antennas outside who emailed me from their cell phones.

They came from people young and old. It did not matter, they all had similar experiences. Everybody, whether they were previously ill or not, became suddenly and profoundly sicker on March 24 or March 25, depending on the time zone in which they lived, and most slept little or not at all the night of March 24.

People reported that not only they, but also their spouse, children, parents, neighbours, friends, coworkers, clients, and everyone else they knew were sick, exhausted and irritable on March 24 or 25 and had trouble sleeping. Some reported that their pets or farm animals were sick at the same time -- cats, dogs, chickens, goats, cows.

The details were consistent. They could not sleep for one, two, three or more nights, beginning March 24 or 25. Some took melatonin or other sleeping aids and still could not sleep. They had pain and itching, either all over or in specific parts of their body, commonly their feet and legs. They had headaches.



They had muscle spasms. They were weak and exhausted and could hardly stand or walk, and some tripped or fell. They had skin rashes. They were dizzy and nauseous, and had stomach aches and diarrhea.

The ringing in their ears was suddenly more intense. Their eyes were red, or inflamed, or their vision suddenly worsened. They had heart palpitations, rapid or irregular heartbeat, or suddenly high or very low blood pressure. A few had nosebleeds, or coughed up blood, or their

eyes popped a blood vessel. They were anxious, depressed or suicidal, and irritable.



### Launching Site

Since then, SpaceX has been launching rockets carrying dozens of satellites at a time on a weekly or biweekly basis, filling the heavens with luminous objects that interfere with astronomy, spewing chemicals that are destroying our planet's protective ozone layer, filling the upper layers of the atmosphere with water vapour that should not be there and that is increasing the current in the global electric circuit and the violence of thunderstorms, and cluttering up space with satellites.

They are nothing but solar arrays and computers that are continually failing, wearing out, and having to be replaced, and which are de-orbited to burn up in the lower atmosphere, filling it with metals and toxic chemicals for everyone to breathe -- and altering the electromagnetic environment of the Earth that had not changed in three billion years and that life below depends on for its vitality and survival.

Last Thursday morning, from Boca Chica, Texas, SpaceX successfully launched its Starship -- the largest rocket ever built, the one it wants to ferry men and women to Mars with -- into space for the first time. And on Friday it launched yet another 23 Starlink satellites to bring its total polluting the ionosphere up to more than 6,000, now not only for internet communication with rooftop dishes but for direct communication with handheld cell phones.

The 6,000 satellites are also now communicating directly with one another, wrapping the Earth with pulsating lasers carrying 42 million gigabytes of data every single day. Everyone I know has had trouble sleeping and been

suffering since last Wednesday, the night Starship launched.

Since March 24, 2021, not only has human health deteriorated, but the bio-diversity of the Earth, everywhere, has plummeted. People have not so much noticed the decline of the larger wildlife like wolves, bears, lions and tigers, which were already scarce, but they are shocked by the total disappearance of the smallest animals that were only recently so common you couldn't open your windows without them flying in.

They are shocked by the disappearance of all the frogs that used to swim in their ponds, the birds that used to nest in their trees, the worms that used to slither on the ground, the insects that used to fly through their windows and cover their clothes hanging on the line.



My newsletters of March 29, June 21, September 20, October 17, and November 28, 2023 carried major stories about this from various parts of the world. My newsletters of December 5 and December 26, 2023, and January 9 and February 6, 2024 quoted from individuals all over the world who have emailed or called me, and I have a huge backlog of more such reports that you can read when I publish them in the future.

If we want to have a planet to live on, not only for our children but for ourselves, the radiation has to stop. Not only do the cell towers have to come down that are so ugly to look at, but also the cell phones that we hold in our hands and have become so dependent on, and the satellites that are squeezing all the life that remains out from under them. We are running out of time.

would persist

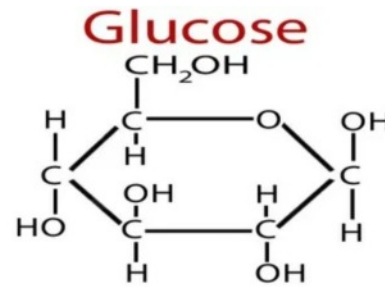
Till we all need applications for a licence to

fingertips of a man's outstretched arms.

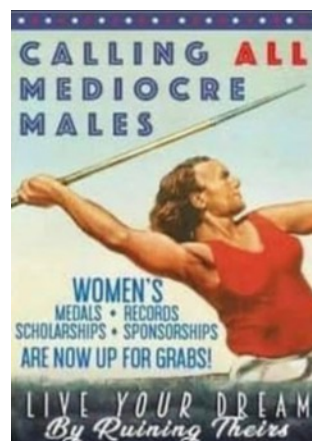
**A rod** was the length of the left feet of 16 men

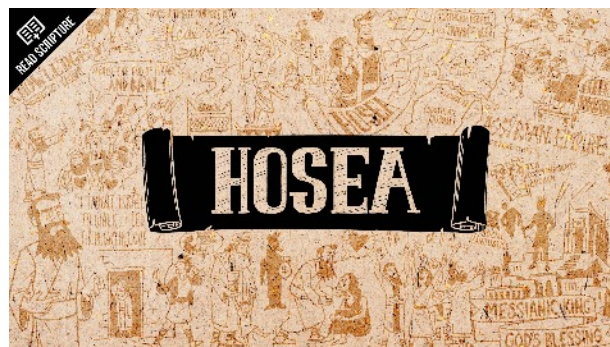

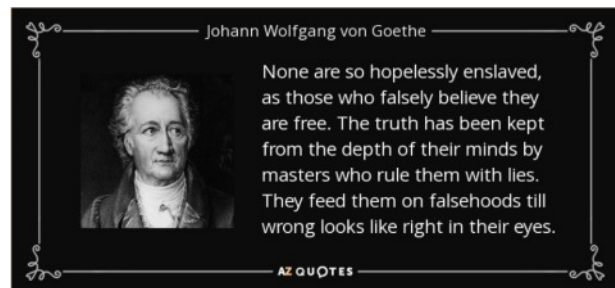

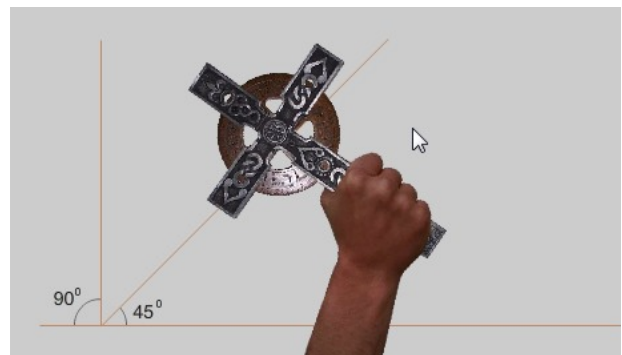

**Sir\_\_\_**, Was The **Black Death** used in medieval Wales for invasions and castle sieges?

Perhaps 50% of the Welsh 14th century population died.

The idea of using plague as a weapon is not new. Anecdotal reports describe the catapulting of plague cadavers into enemy fortifications in 14th and 18th century warfare (See refs.)

**NB** Bubonic plague (The Black Death) we now know was caused by the bacterium *Yersinia pestis* and spread by fleas, not by rats as then thought. We had to wait until the discovery, adaption and use of antibiotics in the 20th Century to find a cure. There had always been suspicions that biological warfare was used at the siege of Harlech and other Welsh Castles.

The use, in Wales, of biological warfare strategies, tactics and attacks? There was the real or at least the possible threat that this could



Harlech came to prominence during the Welsh rebellion led by Owain Glyn Dwr, when in 1404 the castle became occupied by Glyn Dwr's court and family until 1409, the year it was retaken by the English.

The English were accused, unfairly perhaps, of using the fear of the Black Death to break the siege and retake the Castle (below).



There were to be another two sieges, the first being in the War of the Roses when it was taken by Yorkist forces in 1468. It is argued that the famous song 'Men of Harlech' originated during the siege at Harlech during the War of the Roses in 1468. The second during the Civil War when it was surrounded by parliamentarian forces in 1647.

Each time the English re occupied our castles, they were accused of using the plague as a biological weapon (don't bother looking for references by English historians).

Strategy and tactics for 'de-sieging': 'A ship could be seen at a distance from the castle-ramparts burning fiercely.

A mounted messenger would arrive at the castle gates in a mad rush, did not demand access but gave a terrifying message that the pestilence, they all so feared, had arrived in the land.

The ship that they could see far off was full of dead, dying and purifying bodies of men, women and children. The local magistrate had given orders for ship to be towed away and burnt!

He went on that unfortunately several survivors had escaped, were roaming the land and being desperately pursued He reminded them that the only known method against it was quarantine

in order to prevent the spread of the disease and massive death tolls!



### The Siege

Consequently they should stay in their castle until further notice, where siege or no siege they would be 'safe'.

The castle inhabitants were often so surprised and terribly grateful for the apparent great humanity shown by the enemy in letting the messenger through, that they stayed quite happily in their castle, which they had no intention of leaving anyway. They thought, what a noble enemy.

This was later re enforced by sightings of some, but not all, of the surrounding villages being enflamed too. And assumed it was again to destroy the pestilence spreading.

However next steps in the siege strategy were:

**A.** A body or bodies sometimes animals, but often human cadavres, (as far more terrifying ) to be catapulted over the wall, visibly contaminated by the plague, swollen and horribly covered with blackened boils, ulcers, carbuncles, pustules, cysts, etc.

**Or**

**B.** Undertakers were employed to use their skills to convincingly 'make-up' the cadavres with the same signs. In this case if/when the castle inhabitants took flight, occupation of the castle was the proverbial 'piece of cake!'

The poor inhabitants were at first feeling such joy and relief at being saved, that they now went into complete panic mode. Knowing that the

only solution was quarantine in a now ‘infected’ castle or returning to their homes, farms or villages and isolate.

Too many became hysterical, tussled and actually fought with the guards and high-tailed it home, including many of the lords . It was a very un-edifying spectacle of ‘each one for his/herself’, all decorum abandoned and the

siege lifted. They ‘scarpered’ quicker than rabbits finding a ferret in their Warren.

Not very chivalrous, chevaleresque, gallant, gentlemanly and certainly not lady-like!

The satanic seed of the serpent of Genesis 3:15, now identified as International Jewry is the most highly organized race of people on the face of the earth.

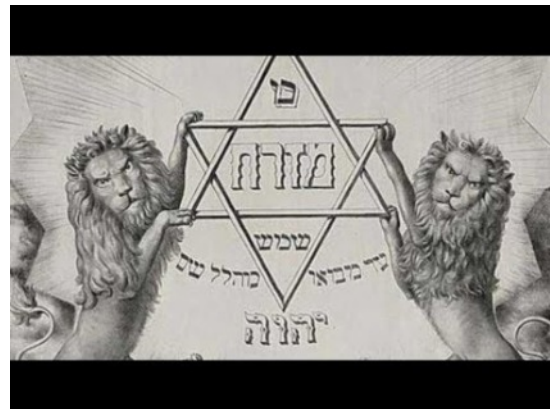
The Jews have organized everything into some type of organization and they control most or nearly all of the organizations in existence.

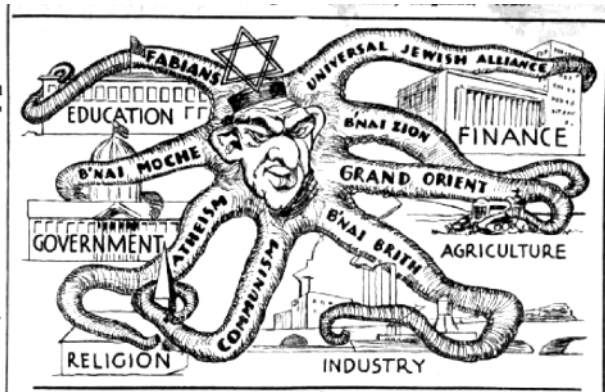

order to cope with their fears. Jesus did not teach us to live in fear.

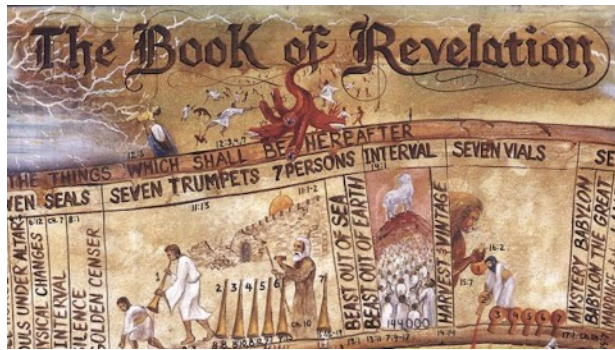
despair of millions of young people, often being the cause of suicide.

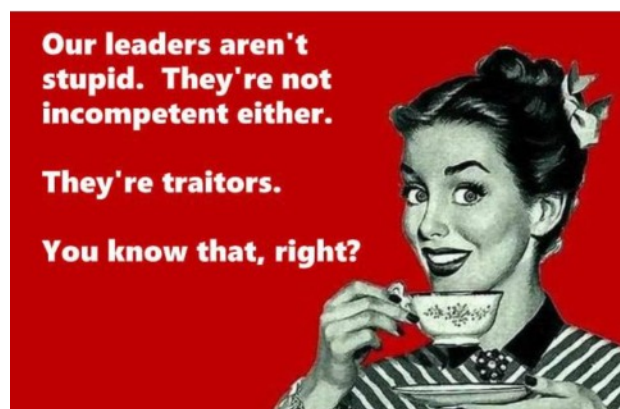

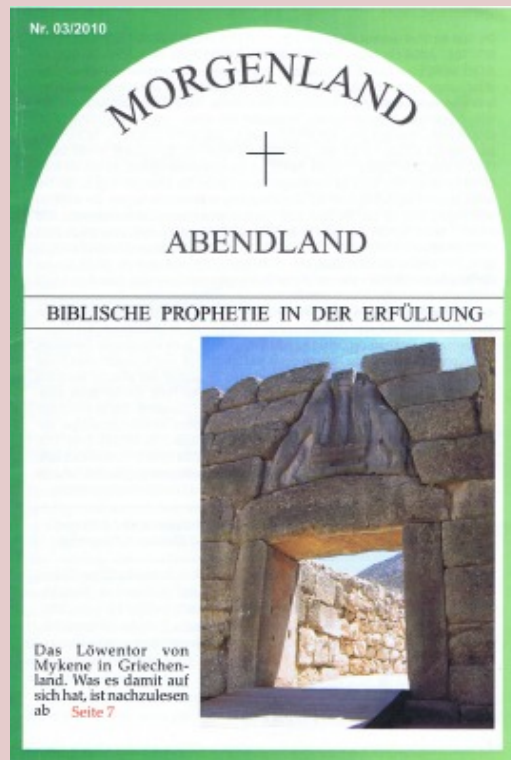
