

Where is the documentation for this statement? Is there any Bible scholar he can cite to back up this claim? This contention is nothing blatant, Talmudic deception.


None of the Scriptural languages, including Hebrew, Aramaic, Assyrian, Greek and even Latin had the J sound. It was the Y sound exclusively.



[**Comment**: Unfortunately for AZ, he totally misrepresents the import of the article he is referencing. First of all, the 1611 KJV had no J at all. King James was spelled King Iames, pronounced like Y.

What the author of the article is saying is that the early letter J actually had a Y sound, not a J sound. This contradicts Zimmerman's thesis. Even the very name of the letter is proof of this: yota, or iota.

Both the Latin i and j were pronounced like a Y, although the j was considered to be a consonant and the i a vowel. That is the only difference. The Latin j was NEVER pronounced like a modern J. Very clever, if not totally effective, dissimulation by AZ.

From the same article, here is a direct quote that Zimmerman avoids: (The [j] sound (technically called consonantal i) appears in the beginning of

the words before a vowel or in the middle of the words between two vowels, as in ius [jus] and cuius ['kujus]; the compound words preserve the [j] sound of the element, that begins with it, cf. coniunx [konjunks] and adjuctivum [adjektivum].

For convenience we will use the letter j (named jota) to mark the [j] sound, as it is common from the Middle Ages onward; so we will write the above words as jus, cujus, conjunx and adjectivum.)

AZ is arguing that the article cited is asserting that the J sound has replaced the I sound **before** the Middle Ages, but that, very clearly, is not what the authors are saying. They are saying that, before the Middle Ages, the 'jus' syllable and the 'ius' syllable were both pronounced like a Y. Zimmerman pretends to understand the article, but he doesn't.

Here is a **Much Better** explanation of how and when the English J acquired the modern J sound, as in budge or judge:

[The letter J is, as you mentioned, relatively recent, and originated as a variant of the letter I. Why that happens is a little complicated, and requires unpacking some assumptions in your question.

In the original languages (Latin, Greek, Hebrew) which provide us with the names Jesus, Joseph, Justinian, etc., the sound which we write as J was pronounced as the English letter Y. (Just to make things confusing for English speakers, the phonetic symbol for this sound is [j].)

In Latin, the letter for this was I/i, in Greek it was I/i (iota), and in Hebrew it was '(yod). Thus, the Greek spelling for "Jesus" was I $\eta\sigma\sigma\nu\varsigma$ , pronounced something like "Yeh-SOOS", and the Latin likewise was Iesus.

Subsequently, in the Latin alphabet the letter J was developed as a variant of I, and this distinction was later used to distinguish the consonantal "y" sound [j] from the vocalic "i" sound [i].

However, at about the same time there was a sound change in many of the languages of Western Europe, such that the "y" sound changed into a "j" sound ([dʒ], or sometimes [3]). So we have it that in English, the letter J in Latin is Gaius Iulius Caesar. Written in Latin now represents a consonant [d<sub>3</sub>] which is not majuscule script, this would be Caivs Ivlivs obviously similar to the vowel [i], despite the fact that they descend from the same letter and the same sound. (English also has many [dʒ] sounds spelled with J which come from native Germanic roots.)

You can see this history worked out differently in the spelling systems of German and many of the Slavic languages of Eastern Europe, where the letter J spells the "y" sound [j], and the letter Y, if used at all, is primarily used as a vowel.

Source: history - If the letter J is only 400–500 years old, was there a J sound that preceded the design of the letter? - English Language & Usage NO J sound! NO J sound! NO J sound! Did you Stack Exchange Capiche? Back AZ's very confused, if not demonic, opinions: - Eli]

Then at the bottom of the article it says: "By the epoch of the Late empire (3rd and 4th c.) the diphthongs ae and oe were equalized with the short e and au with the short o. The pronunciation of y coincided with that of i and by then the letter name ypsillon was replaced in the popular language by i graeca Greek i."

It does not say that it was pronounced Y in every word and combination of letters. The first section mentioned already declared rules for when it was pronounced with J sound.

[But not until the Middle Ages, Zimmerman. Stop lying! – Eli] Nothing in the bottom section demands a Y sound in every word possible. [Even more importantly: Nor is the modern J sound even suggested. - Eli]

[Comment: Zimmerman preaching is gobbledygook. The Greek and Latin J Were Not Pronounced like a Modern J. Nor are they pronounced like a J even today. Rather, the j was used as a consonant but still retained the Y sound and the I retained its vowel status but was pronounced like a short i.

If you know the International Phonetic Alphabet, then, in the Classical Latin of the first century BC, this name would have been pronounced something like /'ga:.i.us 'ju:.li.us 'kae.sar/.

If you do not know the International Phonetic Alphabet, then, using English phonetic respelling, this would be something like "GAHee-oos YOO-lee-oos KAI-sar" with the "r" on the end of Caesar being an alveolar trill, as in Spanish or Italian.)



Then it says: "The most important phonetic change of that period was, however, the palatalization of c and g before the anterior vowels e and i and the equalized with them ae, oe and y... G was palatalized in all Latin speaking world to [D3]. The consonantal i [j] was also transformed to [D3]."



[**Comment**: First of all, here is the definition of the word 'palatalized:' "In technical terms, palatalization refers to the secondary articulation of consonants by which the body of the tongue is raised toward the hard palate and the alveolar ridge during the articulation of the consonant. Such consonants are phonetically palatalized."

You will notice that when you pronounce the Y sound, your tongue is raised up toward the palate, sometimes touching, sometimes not. When you pronounce the J sound, your tongue stays more forward towards your teeth. The fact is that **Both Sounds** are palatalized, but in a slightly different way.

This is what differentiates the I sound from the Y (consonantal j) sound. The I sound is produced from the throat, without having to involve the palate. All vowel sounds are produced exclusively from the throat, with only slight variations of the tongue and mouth for the different vowel sounds. Go ahead and pronounce A, E, I, O, U, to see what I mean. Vowels are not palatalized.

Secondly, the quotation I cited above was from doctrine. [Not hardly, as AZ does not recognize the same article, which clearly states the J sound that the consonantal j was still pronounced like

occurred "from the Middle Ages onward." I guess AZ doesn't understand plain English! So, either the article is contradicting itself, or AZ is misrepresenting the fact that "consonantal I" was still pronounced like a y, not a j.

The j's position in a word would make it a consonant, which has nothing to with how it was pronounced. The Latin j was created in order to differentiate it from the vowel, i. Note: Even more importantly, this line of reasoning has nothing to do with earlier languages, such as Hebrew, which Never had a J sound.

And AZ has provided no evidence for any earlier J sound! Zimmerman is doing his utmost to trump linguistic facts with mere Jewish assertions, i.e., chutzpah.


Also, there were no audio recordings in the ancient civilizations. The study of ancient languages is complex and ever evolving.



BY STATED WAS EITHER THE KING OR HIS TRANSLATING BODY that the purpose of the translation should be dynamic labour to recover the truths of the prophets and apostles that had been lost through the international church system. Nothing of the word of tradition and orthodoxy was overturned.

The translators were divided into committees, to work on different sections of the Bible, which explains why many themes of the King James Bible are discordant, destroying the miraculous internal harmony of the prophets and apostles.

There is, rather, disharmony, and it is even inconsistent with itself, such as, for example, "world without end" and "end of the world" (both of which are wrong anyway). It is easily

apparent that the translators lacked strong translating principles, which is why they allowed themselves to add and take away words, and to change meanings.

Its Old Testament books are in the wrong order. There are textual issues the translators failed to resolve, especially in Genesis. They included the Apocrypha, which is not part of the inspired writings of God.

It has occultic and pagan teachings of the Mysteries religion: ghosts, Lucifer, Satan, the Devil, going into hell fire, people going to Heaven, immortality of the soul, Easter, giants, unicorn, satyrs, cockatrice; all mythological figures and concepts.





The original publication had pictures with symbols of a handshake, a diagram of a hierarchy structure, and the Sun of Sun Worship. Its James 3:1 has "masters" instead of "teachers"


Some of its language is incomprehensible gibberish, such as Exodus 38:4: "And he made for the altar abrazen grate of network under the compass thereof beneath unto the midst of it.".

And its 2 Corinthians 6:11-13: "O ye Corinthians, our mouth is open unto you, our heart is enlarged. Ye are not straitened in us, but ye are straitened in your own bowels. Now for a recompense in the same, (I speak as unto my children,)be ye also enlarged".

Nicholson says of it: "This [concerning 2 Corinthians 6:11-13] is clearly a translation done by people who didn't really understand what they were translating, and in the circumstances rhythmic language and interesting vocabulary can do very little to save the situation" (p. 225). And: "[its] language it seemed was not the language of the people" (p. 228).

Its punctuation is appalling and scruffy. I have truly seen better punctuation in primary schoolchildren's work.

It is Calvinistic, which was achieved by adding words not in the Greek text in the phrase "before the world began" (2 Timothy 1:9, Titus 1:2). Only "before" is correct. The rest is invention.




It does have at times have some attractive words and phrases from a literary point of view, but these are not concerning major doctrinal points. It promotes Paul as another saviour of the Israelites: "For I could wish that myself were accursed from Christ for my brethren" (Romans 9\3). How would it help his "brethren" if he were "accursed from Christ"?

It blasphemes God with "God forbid", reflecting not a word of the underlying Greek, which actually says "May it not be!". Some curious excuses have been put forward for the alteration.

It is heavily influenced by the Latin Vulgate, especially concerning the person of Christ, of which matter I tabulated in my training days.

The translators were given by their employers the Bishops' Bible, as David Daniell explains (which I also cite in Chapter 1, page 2):



The Bishop's Bible

When James 1 gave his Bible revisers the huge Bishops' Bible as their foundation, which meant that the Latin Vulgate-based Rheims version would be attractive to them, he ensured that a wash of Latinity would be spread over Tyndale's English ... The objection was not narrowly political. Powerful ecclesiastical voices throughout Europe maintained that the Latin Bible was the true word of God and that the moves of humanist scholars to press for the originality of Hebrew and Greek was a blasphemous and seditious conspiracy born of hatred.

**Daniell, p. XXIV** ... "the moves of humanist scholars to press for the originality of Hebrew and Greek was a blasphemous and seditious conspiracy born of hatred" ... "a blasphemous and seditious conspiracy born of hatred".

It is deliberately Latinate and awkward, to keep the word of God from the plough boy. For a tiny example, "Then spake Jesus" should be "Then Jesus spoke". It's not **Organic.** It's **Processed.** It does not follow the grammatical structures of the underlying sentences of the Hebrew and Greek.

Time and again, it is **Processed**, rather than **Organic**. It alters grammatical forms of words, grammatical structures of phrases and sentences, meanings of words, and it adds and it takes away and it changes. It would not translate back into the original underlying languages.

The translators altered nouns and adjectives, verbs and adverbs, pronouns and prepositions. These alterations, doctoring of the text, produced results that agree with the teachings of men of the flesh, the natural religion of the international church system, and they are in constant conflict with the teachings of the prophets and apostles.

The translation adds and takes away, an offence punishable by God, as stated in Proverbs 30:6, 2 Peter 3:16, and Revelation 22:18-19.

By doing these things the King James translators shipwrecked every major teaching of the prophets and apostles, especially concerning the person of Christ.

As I have stressed again and again, in the King James Bible translators' failure to adopt translation principles they shipwrecked the prophets' and apostles' themes of who God is; who Christ is; who the Holy Spirit is; what the holy spirit is; creation; election; salvation; our structural identity; our destiny; the gospel message; Paradise; God's words to Eve; God's words to Cain; whom Jacob met at Genesis 32:1;



—money; Moses; Jesus' death; Jesus' resurrection; the success of Jesus' New Covenant; what "satan" and "devil" mean; who the real enemy is; the identity in the New Testament of the house of Israel and God's faithfulness to them; the gospel promise of life on Earth in the coming eons; who and what the New Testament is really about; what Paul's work really was; and even the immortality of God.


It blasphemes God, implying by the translators' ignorance that one occurrence of "Satan" is God. It blasphemes God with "God forbid", reflecting not a word of the underlying Greek.



The translators spent only eight years, saying in Calvinistic. It also shipwrecks the same themes the preface they were "hastened" by the King (not their fault for that, then); in which time it is not possible to gain understanding of the themes of the prophets and apostles, even less so when influenced so strongly by the Latin Vulgate and carried out by men of the flesh, paid for their work by an unrighteous King interested in the occult and who had a male lover and a wife. I would not have worked for King James.

In 1997, when I began this work, I wrote that the Scriptures of God had fallen into the wrong hands.

I do not like to read or hear the King James Bible. That is because I know and dislike the spirit behind it. I dislike the spirit of the man who commissioned it. I dislike the spirit of the translators who persecuted good Christian people. I have been looking into these things for over a quarter of a century. Its Jesus is "another Jesus" and its spirit is "another spirit" and its gospel is "another gospel" (2 Corinthians 11:4).



4. The Douai-Rheims Bible

In 1610 the Catholics published the first complete English translation of the Bible, the Douai- Rheims Bible. It was translated mostly from the Latin Vulgate. (The King James Bible also was, as already stated, heavily influenced by the Vulgate.) The Douai-Rheims contains many of the same errors as the King James. It also has the Old Testament books in the wrong order. It also contains the Apocrypha. It also is

that the Protestant King James Bible shipwrecks. And it has the same "Lucifer" and "Satan" and "Devil" and "hell fire" as does the King James.



However, contrary to Protestant expectations, it teaches salvation by "grace" and "faith" and not by works.

It is often stylistically better than the King James Bible. It is properly punctuated, done with care and respect.

It has some serious passages correctly translated, where the King James Bible has blundered, especially concerning the person of Christ.

Exodus 38:4, which the King James Bible renders incomprehensible, is clear in the Douai Rheims. Its Hebrews 3\2 has of Jesus "faithful to him that made him", where the King James fidgets the text with "appointed", to avoid saying God created Jesus.

Its Genesis 3:16 has "under thy husband's power", where the King James blunders with "desire". Its Matthew 5:5 has "land", where the King James blunders with "earth", and also at Psalm 37. It does not change "Greek" to "Gentile" at Romans 2:9, 2:10, 3:9 (although, unfortunately, it changes it at John 7\35, 1 Corinthians 10:32, 12:13).

It has "length of days" correctly at Psalm 23:6, where the King James invents "for ever". It has "Then Jesus spoke", where the King James has the comical and Latinate "Then spake Jesus"(!). Its Romans 9:3 has the verb phrase correct as "I wished myself", where the King James blunders with "I

could wish that myself", reinventing and The Douai-Rheims Bible has many of the same concocting Paul as a potential saviour of the mistakes the King James men wanted, but not Israelites. Its Isaiah 9:6 has the promised all; they would have needed to falsify a few Messiah as "the Father of the world to come", things and rough up the punctuation. where the King James blunders with "The everlasting Father". It is better than the King James Bible.


Protestants have no cause for pride over Catholics for their King James Bible. (I am not a Catholic; I'm wholly independent.) I have not found there to be anything of gain from it over the Douai-Rheims. Perhaps the King's men just ignored the Douai-Rheims, although Nicholson suggests they "lifted many pungent phrases" (p. 218).

The King's translators would have had time to adjust their Latin-influenced blunders, but they did not.

After the Douai-Rheims Bible was published in 1610, what need was there for the King James Bible to be published the following year, apart from, perhaps, the vanity of the King? It was all, really, of the same religion.



#### 5. KJV-Only



Because the body of Christ is so wayward, there has arisen an aggressive cult of "KJV-only", some even going so far as to say it was inspired by God! And that through such unrighteous men. Righteous work does not proceed from evil men. God does not inspire evil men to make corruptions of the writings of His prophets and apostles. Yet its supporters will say almost anything to you to protect it.

Nothing "impure" may enter the gates of the New Jerusalem. I do not expect to be seeing the Chapter 29 KJV unnecessary publication? King James Bible there. It does have some good word choices here and there, which I would defend (for example, "foundation" in Ephesians). Its prose style is truer to the text - and less Processed - than modernistic versions (whose New Testaments are based on anciently corrupted Greek texts).

But every major theme of the prophets and apostles is shipwrecked, because the translators were men of the flesh, not men of the spirit, and the intention of their work never was stated as recovering the truths of the prophets and apostles. (Has that ever been the stated intention of any of the committee made church system Bibles?)

Perhaps it was the King James Bible's royal authority that propelled that curious and very aggressive "KJV- only" movement. You have to wonder.

#### 6. the Translators' Allegiance

The preface of the King James Bible is a sickly

adoration of King James, whom it promotes as Here are a few of the revised passages in the almost another saviour. It exhorts that King Queen James Bible, alongside their King James James might become "the world counterparts. More examples can be found on in this latter age for happiness and true felicity". their website.

It addresses him - in capitalised pronouns ("You") – with such flattery as: "Your very name is precious ... their eye doth behold You with comfort, and they bless You in their hearts, as that sanctified Person, who, under God, is the immediate Author of their true happiness. And this their contentment doth not diminish or decay, but every day increaseth and taketh strength."

To the paid translators he was "Your most Sacred Majesty". To the people - "Queen James". That King James Bible preface says that the work is "one more exact Translation of the holy Scriptures into the English Tongue", implying, perhaps without realising, that it is only "one among others. Source: more"

The Hebrew Meaning of The 'Guardians of The Garden of Eden': Revealing The Cherubim's Grasp

**HE THIRD CHAPTER OF THE BOOK OF GENESIS** ends with the description of Adam and Eve's expulsion from the Garden of Eden:

"So the LORD God banished him from the Garden of Eden to work the ground from which he had been taken. After he drove the man out, he placed on the east side of the Garden of Eden cherubim and a flaming sword flashing back and forth to guard the way to the tree of life." (Genesis 3:23-24)

The biblical description is very intriguing because it mentions the measures that were taken in order 'to guard the way to the tree of life' which were "cherubim and a flaming sword flashing back and forth."

The original Hebrew word for 'cherubim' is 'Keruvim' {סיבורכ} (which is the Hebrew plural form of 'Keruv' {בורכ}) and refers to a particular type of angels commonly known by their 'childlike facial features.'

According to the ancient Jewish literature this term – 'Keruv' – comes from the old and rare Aramaic phrase 'Kerabia' איברכ} which means 'like a child' and this is probably the reason why the 'cherubim' were represented in the Christian European culture as angels who look like children.

The Bible tells us that besides the 'cherubim' there was also 'a flaming sword flashing back and forth to guard' which appears in the original Hebrew as 'Lahat Ha-Cherev Ha-Mit'hapechet.'{ תכפהתמה ברחה מהל}



The Hebrew word 'Lahat' {טהל} was translated as 'flaming' and has a strong connection in Hebrew to the 'supernatural' and 'fire' as can be found in the following example from Exodus:

"Pharaoh then summoned wise men and sorcerers, and the Egyptian magicians also did the same things by their secret arts" (Exodus 7:11)

There the original Hebrew word for 'secret arts' is 'Lahatem' {סהיטהל} which derives from the same Hebrew root as 'Lahat' (L-H-T {ט-ה-ל}).

The English translation has encountered a difficulty in translating the unique Hebrew verb 'Le-Hitapech' {דפהתהל} (appears in the

translation as 'flashing back and forth') because it has MORE than one meaning.

In fact, this Hebrew verb is describing ALL different forms of shifting from one situation to the complete opposite of it. 
This map of 1810 (above) shows New and Old California and lands of vast lands of the Louisiana Purchase allegory.



## The Invisible Rainbow You Mean You Can Hear Electricity? By Arthur Firstenburg

1962, LOCAL WOMAN Α **CONTACTED THE UNIVERSITY OF BARBARA** CALIFORNIA, **SANTA** FOR HELP TRACKING DOWN **MYSTERIOUS NOISE**. She had moved into a newly built home in a quiet neighbourhood and this noise, whose location she could not find, was accompanying her wherever she went like an unwanted ghost.

It was impairing her health, keeping her awake, and forcing her, in desperation, to abandon her home for large periods of time just to get relief. In response to her plea for help, an engineer showed up at her house with a load of electronic Equipment.

Clarence Wieske, who was with the Laboratory for the Study of Sensory Systems in Tucson, a military contractor that was working on the interface between man and machine, happened to be involved with a project at the University at Santa Barbara when the woman's call came. His initial intention was to look for electric fields on her property that might be setting some metal object into vibration, creating the noise that was bothering her. He was startled by what he found.




His search coil, as he anticipated, did pick up unusually strong harmonic frequencies. They emanated not only from her electric wires, but also from her telephone wires, gas pipes, water pipes, and even the metal in her heating system. But his stethoscope could find no audible noise being emitted by any of these items.

He therefore tried what he thought was a farfetched experiment: he attached a tape recorder to his search coil, which recorded the electric frequency patterns and translated them into sounds, and then played the recording for the woman.

When she put on the headphones and listened to the tape, she recognized the sounds as identical to the noise that was tormenting her. Wieske then took the experiment one step farther. He disconnected the headphones and played the tape directly back into his search coil. The woman said instantly, "You mean you cannot hear that?" She was hearing the same thing again directly from the search coil although it emitted only an electromagnetic field and no actual noise.

In a further experiment Wieske, without telling the woman, connected a low power frequency generator to the water pipe about one hundred feet from her house. She remarked that there was peculiar noise "like a barking dog."

When Wieske turned on the pickup equipment in her house and put on the headphones, he found that she was correct. He heard a sound like a barking dog!




These experiments and others done at her home and at the university left no doubt that the woman was hearing electricity—and that the noise was not coming from her dental fillings.

Wieske then set about to try to alleviate her problem. Electrically grounding her refrigerator, freezer case, door chimes, and other appliances reduced the noise level a bit but did not get rid of it.

One day, during a power outage, she telephoned Wieske, ecstatic. The noise had stopped! But it returned as soon as the power came back on. Therefore Wieske contacted all the utility companies. With their cooperation, he put filters on her phone line, an isolation transformer on her electric line, and sections of non-conducting pipe into her water line and her gas line.


These time-consuming, expensive measures prevented unwanted electric frequencies originating elsewhere in the neighbourhood from being conducted over these paths. Finally, the noise was reduced to an endurable level and the woman could inhabit her home.

His article about his experiences, published in Biomedical Sciences Instrumentation in 1963, concluded with a technical description of human hearing, including all of the places within the ear where electromagnetic fields might cause electric currents to flow.

He speculated as to the reasons some people can hear them and not others: "If the nerve for some reason in some individuals is not as well insulated from these currents as in the normal individual, or if the cochlea (see above) is not as well insulated from these currents in some individuals, perhaps this could make them sensitive to these electrical fields."


Wieske's prediction has come to pass. Today companies serving the population that can feel and hear electromagnetic fields form a significant cottage industry in every part of the United States. One organization, the International Institute for Building Biology and Ecology, lists sixty consultants, scattered throughout the United States and Canada, that it has trained in the methods of detecting and mitigating residential electromagnetic pollution. About eighty million Americans today have Applying a piece of silver to his eye, and "ringing in the ears" to some degree. Some hear them only when everything else is quiet. But for increasingly many, the sounds are so loud all of the time that they cannot sleep or function.

Most of these people do not have tinnitus, which is an internally generated sound, often in one ear, usually accompanied by some degree of hearing loss. Most people today who have "ringing in the ears" hear it equally in both ears, have perfect hearing, and are hearing a pitch at the very top of their hearing range.

They are hearing the electricity around them, and it is getting louder all the time. The clues to what is happening were planted over two centuries ago.

French electrotherapist Jean Baptiste Le Roy, in 1755, was apparently the first to elicit an auditory response to static electricity. He was treating a man blind from cataracts by winding wire around the man's head and giving him twelve shocks from a Leyden jar (below).



The man reported hearing the explosion of "twelve pieces of cannon." Experimentation began in earnest when Alessandro Volta invented the electric battery in 1800.

The metals he first used, silver and zinc, with salt water for an electrolyte, generated about a volt per pair—less when he stacked them upon his original "pile." Applying a single pair of metals to his own tongue produced either a sour or sharp taste, depending on the direction of the current.

Applying a piece of silver to his eye, and touching it with a piece of zinc held in his moistened hand, produced a flash of light—a flash, he said, that was "much more beautiful" if he placed the second piece of metal, or both pieces, inside his mouth.



Stimulating the sense of hearing proved more difficult. Volta tried in vain to elicit a noise with only a single pair of metal plates. But with thirty pairs, roughly equivalent to a twenty-volt battery, he succeeded. "I introduced, a considerable way into both ears," he wrote, "two probes or metallic rods with their ends rounded, and I made them to communicate immediately with both extremities of the apparatus.

At the moment when the circle was thus completed I received a shock in the head, and some moments after (the communication continuing without any interruption) I began to hear a sound, or rather noise, in the ear, which I cannot well define: it was a kind of crackling with shocks, as if some paste or tenacious matter had been boiling." Being afraid of permanent injury to his brain, Volta did not repeat the attempt.

But hundreds of other people did. After this report by one of the most famous men in the world, everyone wanted to see if they could hear electricity. Carl Johann Grapengiesser, a physician, was careful to use only small currents on his patients, and he was a much more careful observer than Volta. His subjects varied widely in their sensitivity and in the sounds they heard. "The noises, in respect of their quality and strength, are very variable," he wrote. "Most often, it seems to the patient that he hears the hissing of a boiling teakettle; another hears Carl Eduard Flies (Experiments of Dr. Flies, ringing and bell-pealing, a third thinks that 1801) outside a storm wind blows; to a fourth it seems that in each ear a nightingale sings most lustily."

A few of his patients heard the electricity generated by only a single pair of metals applied to blister plaster wounds underneath their ears.



Physicist Johann Ritter (above) was not afraid of currents much greater than those risked by Volta. Using batteries containing 100, 200, and more pairs of metals, he was able to hear a pure musical tone that was approximately "g" above middle "c", and that persisted as long as the current flowed through his ears.

Many were the doctors and scientists who, in the heady years following Volta's gift to the world of its first reliable source of steady electricity, stimulated the acoustic nerve with greater or lesser quantities of current.

The results of his experiments filled a 264-page book. His apparatus contained 20 zinc-copper Daniell cells, each producing a maximum of about one volt, connected to a rheostat that could be adjusted to any of 120 positions.


Any desired number of cells could be inserted into the circuit at the turn of a dial. He performed 47 different kinds of experiments on a large number of individuals.

Once the powerful Aegidius Afranius Flavius Syagrius is identified as the person to whom the letter was sent then the start date of the Welsh Annals is corrected to c AD 473.

The immediate effect is to transfer the Battle of Baedan from an impossible AD 517 to a very credible 551, and the catastrophic Battle of Camlann is corrected to around AD 569, and all this makes perfect historical sense.


It has to be understood that Christianity arrived in Britain in AD 37, and the early Christians

The third group thought that he was born and lived as one with God and became united so when he died. This means that "the Incarnation" of Jesus the Nazarene was believed by the British to be when he died and the Romans believed the "the Incarnation" dated from when he was born.

This is important because the only date given in the Bruts of England is that "King Arthur (meaning II) died 546 years after the Incarnation of the Lord". August 1, a Friday, the Daily Express published the story on the front page, with a photograph of the bodies which, he told his readers, promised crowd. to shock the world.

Representatives of the British Jewish community condemned the killings, but the newspapers of the next day returned to the charge by reporting even more crude details. As Walter Lever, a Jew of the Manchester working class, recalls:

This weekend, there was nothing to do other than stroll through the streets discussing newspapers, etc, and it's the story of the hanged sergeants that took precedence over the murders and rapes of the week.

There were already beginnings of an imminence backlash. At Birkenhead, near Liverpool, slaughterhouse workers refused to work for the kosher sector until the attacks in Palestine stopped. Around Merseyside, anger began to spread in the streets, crowds of angry young people formed in the Jewish quarter.

reached On Sunday afternoon. unrest Manchester. Small groups began taking to the windows of Cheetham Hill, shop а neighbourhood just north of downtown that had been home to a Jewish community since the early 19th century.

Pubs closed early that day due to a shortage of beer and, in the evening, rioters were several hundred. Most were on foot, but others would

cross the neighbourhood throwing bricks from moving cars.

In Eccles, a former sergeant-major, John Regan, was fined £15 pounds for telling a crowd of 700 people: "Hitler was right. Exterminate all Jews, men, women and children. What are you afraid of? There was only a handful of police officers. 

Yet we know that the majority of our Israel people care little about being disarmed as is represented in the wars with the Philippines, when they were conquered and were not allowed a sword, spear, knife or anything sharp, including plough shares.

They were not allowed to even have blacksmiths to make such weapons and sharpen them, and they really didn't care.

The masses have never minded losing their freedoms as was demonstrated in the Book of Judges, and in the present day here in America

are decadent and have allowed the government to confiscate their weapons. In America we are faced with the same thing, it is just taking a little longer than it did in the other countries.

The large middle group; never able to be actively good, yet only followers of evil, not originators of it, has always constituted the great bulk of the nation. Since they never rise to the greatness of true goodness, and periodically lapse into all kinds of evil, why has God kept them in existence? Only because, without them there would not be a nation.

Yet God has always found a way to use His remnant for His own special purpose. Eve was not sinless, yet in Genesis 3;15 God declared that the Redeemer would be one of her descendants.



Abel was presumably as sinful as other men; yet we are told in Hebrews 11:14 that "By faith, Abel offered unto God a more excellent sacrifice than Cain, by which he obtained witness that he was righteous. God testifying of his gifts; and by it, being dead, he yet speaketh."

While he was comparatively good as men go, Noah must have had his share of human faults; but we are told that "By faith, Noah, being warned of God of things not seen as yet, moved with fear, prepared an ark to the saving of his house; by which he condemned the world and became heir of the righteousness which is by faith." Abraham also had his sins, yet "For what saith the scriptures: Abraham believed God, and it was counted unto him for righteousness."

knew that even the best of His creatures would not be able to achieve righteousness by man's own goodness; so God prepared to give them His own righteousness. In Isaiah 54:17, He says:



This is the very essence of Christianity! All men have sinned; even the Remnant, and have justly earned the penalty of death; but God has paid that penalty for us in the death of Jesus Christ upon the stake; and if we believe God in this, He imputes to us the perfect righteousness of Christ.

"Their righteous-ness is of me." The great mass of people never obtain even this; only a remnant ever did or ever will.

Isaiah 10:20-22: "And it shall come to pass in that day, that the remnant of Israel, and such as are escaped of the house of Jacob, shall no more again stay upon him that smote them; but shall stay upon the Lord, the Holy One of Israel, in truth.

The remnant shall return, even the remnant of Jacob, unto the mighty God. For though thy people Israel be as the sand of the sea, yet a remnant of them shall return: the consumption decreed shall overflow with righteous-ness."

During most of the Old Testament times, the nation Israel was nominally faithful to God; that at all times there were some apostates among them, and several times almost the entire nation lapsed into idolatry.

In New Testament times, the Israel nations have been nominally Christian; yet at all times there have been relatively few who truly understood their religion and were more than nominal Christians. Today, the "churches" are becoming Remnant God has spared the nation. ## **Stokesay Castle a Fortified Manor House One of Britain's Many Marvellous Buildings** By **Julian Munby**

**TOKESAY CASTLE** is a remarkable survival, a fortified manor house which has hardly altered since the late 13th century. The house was built by Lawrence Ludlow, a leading wool merchant of his day, who created a comfortable residence combining an aesthetically pleasing design with some defensive capabilities.

In doing so, he took advantage of the newly established peace on the Welsh border following Edward I's defeat of the Welsh prince Llywelyn the Last. This enabled him to build a large hall,

comfortable solar, or private apartment, with windows on the outside world, without fear of attack.

By good fortune Stokesay escaped destruction during the Civil War despite being involved in a skirmish. In the 19th century the castle was sympathetically restored and preserved, thanks to the enlightened efforts of several early conservationists.

In the 1980's English Heritage carried out an extensive programme of repair.



Despite its name, Stokesay was not called a castle before the 16th century and is really a fortified manor house, more domestic in character than military.

As with many early manor houses, the church and castle are now isolated, the village of which they were once the focal point having either moved or disappeared. The first records of Stokesay date from the period immediately following the Norman Conquest.

William the Conqueror installed Roger Montgomery as earl of Shrewsbury, and he in turn granted Stokesay to one of his retainers, Roger de Lacy.

The Say family were tenants of Stokesay until the death of Walter de Lacy in 1240, when his son-in-law John de Verdon inherited, and obtained possession from Hugh de Say in exchange for land in Ireland.

It is possible that de Verdon began the actual building of Stokesay around this time; the north



tower and parts of the solar block may be his works. Verdon's tenant John de Grey sold the tenancy of Stokesay to the merchant Lawrence of Ludlow in 1281.


The Ludlows (Judge Lord Ludlow left) were the leading wool merchants of the

Marches, based in Shrewsbury, but with international connections in trade and finance. Although he remained technically a feudal tenant

of Gray and Verdon, for all intents and purposes, Ludlow was the owner of the whole manor, obtaining a royal charter of free hunting rights in 1281.

We can assume Lawrence began building soon after 1281, while completion of his work is perhaps indicated by the 'license to crenellate' which he obtained in 1291 from Edward I at Hereford.

This was a license granted by the king allowing the license-holder to make a structure defendable by adding battlements. Many generations of Ludlows became well established as country gentry, frequently serving as Sheriffs of Shropshire in the 14th and 15th centuries.

Certain features of the design clearly indicate that Lawrence was as concerned to impress with the elegance of his house as with its strength. The moat surrounding the castle is entirely artificial, as the castle stands on a slope.

The water came from a large pond to the southwest of the castle. The impressively-built north tower (left) stands on a sloping (battered) base which is lower than the rest of the castle.

From the west, the main range of buildings appears to advantage, and this may have been intended as the main facade of the castle, since the road from Ludlow may have originally passed on this side of the valley.

The section of curtain wall between the hall and south tower originally contained battlements, but was rebuilt in the 17th century. Of the postmedieval additions to the castle, only the gatehouse now remains. This is an elaborate example of the regional style of timber framing built around a central gate passage.

To the north of the castle is the Church of St John the Baptist, its churchyard extending almost to the castle walls.

The Craven family and their tenants succeeded the Ludlows at Stokesay, but by the beginning of the 19th century the castle buildings had fallen into a state of decay and were being used by a nearby farm.


Moves to preserve the castle buildings were initiated in about 1850 by Mrs Stackhouse of Acton (1794-1881). In 1869 J.D. Allcroft, an

The Allcroft family opened the castle to the public in 1908 and in 1992, following the death of Lady Magnus Allcroft, the castle came into the guardianship of English Heritage.
