## The History Of The Letter J

**L**ET'S GO OVER THE HISTORY OF THE LETTER J and see how it went from being an alternative version of I to its own letter.

**In the year 1524, Italian Gian Giorgio Trissino was the first to use J as a letter. The sound that this new letter would make has another common way of being written “dg”.**

Due to the influence that Latin and French had on Italian, the letter J was just another way of writing “dg”.

However, back then, the usage of J was far from common, even in Italy, and it wouldn't be until much later that it would become as recognisable as it is today. It's unlikely he would have lived long enough to see his new letter become popular.

Much later in the 16th century, a Frenchman called Pierre Ramous was the next person to separate I from J. Back then, words that today we would spell with a J would have been spelt

with an I. But, this was only amongst a few French scholars. It wasn't until the 17th century that the letter J became common in *English*. If you read some of the older versions of the King James Bible, you will see the letter I where today's version has the letter J.

## What Was Jesus' Name Before The Letter J?

Did you know that Jesus' name wasn't actually Jesus?

When he was alive, the letter J did not exist. And his name was “Yeshua”. This name is the same place that we get the name “Joshua” from.

The reason why modern English translations use Joshua and Jesus as two separate names is to separate the two to prevent people from getting them mixed up.

Before the Letter J was invented, to translate the Hebrew name “Yeshua” into English would have given you Yesus. This is what Jesus was known as for most of English history.

Most of the names we give people in the Bible are not their actual names.

Yahweh Vs Jehovah: What Is God's Real Name? If you read Christian literature, there will be two names that God tends to be given. One of them is Jehovah and the other is Yahweh.

The reason why God seems to have two names is that his original Hebrew name has been translated differently. **In the Bible, his name is “יהוה” Yəhōwā.** When spelt out phonetically, this name sounds like Yahweh.

**However, if you were to take the letters of his original name, and turn them into Latin letters, his name is closer to Jehovah.**

Because the Bible wasn't written in English, it can be translated in multiple different ways.

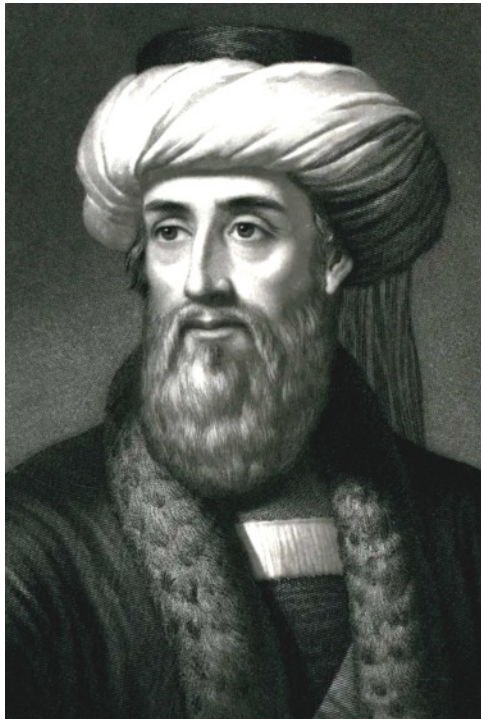

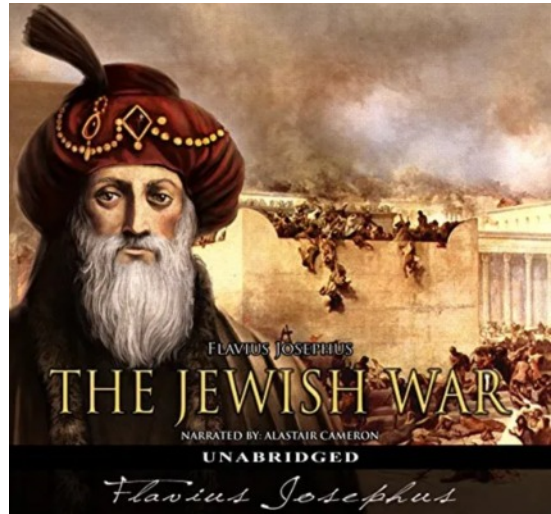

The well respected historian, Josephus (above), who lived in the first century, said that during the time of the first temple, on the Day of Atonement, the high priest would enter the Holy of Holies wearing the name of God on his headband & that it was 4 vowels!

[I wouldn't expect AZ to know about this, but the YHWH sounds doubled as vowels, just as the I and J sounds did early on! They were BOTH vowels and consonants, depending upon the context.

This is the explanation for Josephus's declaration that there were "four vowels"! As in the French, "oui" consists of three vowels, but it is pronounced the same as "we" in English.

In a similar manner, when transliterated into Greek, YHWH can be written and pronounced Iaoue, with five vowels! Here is a more scholarly answer from Fred Moeller:



### The Aleppo Codex

Relatively modern Hebrew manuscripts (e.g., the Aleppo Codex) do have "vowels"—or rather, vowel pointing (referred to in Hebrew as nikkud). However, these vowel points were not

created until approximately the 10th century A.D. The original scrolls lacked vowel pointing. Instead, the original scrolls contained only twenty-two consonants.



However, Josephus wrote the **following concerning the Tetragrammaton engraved on the high priest's crown (tiara)**: And a tiara of fine linen encompassed the head, and it was crowned with hyacinth, around which there was another golden crown, bearing the engraved holy letters. And these are four vowels.

This appears to be a contradiction, but in Hebrew, a few of the letters also functioned as vowels, even today. Two of the consonants doubling as vowels are ך and ן, which can be transliterated as “i” and “o”/ “u,” respectively. Coincidentally, these two letters (ך and ן) also appear in the Tetragrammaton, hence the reason Josephus referred to them as vowels (φωνήεντα).

Another letter that also used to function as a vowel, but rarely so today, is the letter ה. In his [analysis](#) of the Isaiah Dead Sea Scroll, Fred Moeller wrote,

Just as the Masoretes invented pointing to indicate vowel sounds so the Q[umran] scribes have added some semi-vowels to the text. **The use of yod, waw, and “he” are frequent.** Source: [names of god - Is יהוה ever transliterated in the Septuagint? - Biblical Hermeneutics Stack Exchange](#)

I would say that AZ is making a mountain out of a dissimulated mole hole {misspelling

deliberate because it is actually a BLACK HOLE of disinformation!!}, having done very little research beyond what he wishes to inculcate. Although Josephus was a pure-blooded Judahite, he was also a soldier in the Roman army. The “four vowels” comment is interesting, but what does it really mean?

All scholars, Jewish, Christian, Aramaic, have stated that the **written Hebrew** was consonants only, for the reasons given above.

The inscription Josephus refers to may have been written in vowels, but the inscription is **Not** biblical. As Fred Moeller explains, an inscription on a rabbinical tiara is not the same as Exodus 3:14-15. – Eli.]

Before we get back to AZ, I will again reproduce here the document that he is commenting on. Up to this point, we have only covered the letter yod:



2. The next letter looks like a backward E or F. It had the E or EH sound.

3. The next letter almost looks like Y but the top portion of the letter looks like C instead of a pointed Y. In fact, the letter C was sometimes used to represent a sound similar to the S sound. [Says who? Citation please! **Extended Comment:** Question for AZ: What historical era are you talking about? This is a very important

question, because you are asserting that the Tetragrammaton contains the S sound, so that you can fabricate the word 'Jesus' out of the Tetragrammaton. You have made two assertions about the third letter of the paleo-Hebrew YHWH, waw, which can sound like a V or a W. After searching the internet on this matter, there is no one else who asserts that vav can be pronounced like an S. Here is a good image of the situation.

NOTE ORIGINAL HEBREW LETTER SHAPE Y FOR U:



**No S!** Amazingly, Zimmerman is asserting that, because the top of the letter vav looks like a sideways C, the top of the letter vav represents a C!!!! Talk about pretzel logic turned sideways!! Or should I say schmutzig logic? [Schmutzig means filthy in German. – Eli]

It should be obvious to any intelligent person that there is **No Letter C** in the Tetragrammaton! And then the C miraculously becomes an S for some unnamed “experts”!!! – probably his sissy co-religionists!

Here is an image of the earliest form of the Tetragrammaton:



The letters from left to right are Hey, Waw, Hey, Yod. Notice that the Waw does not have the cup shape. That was a later development.

Zimmerman, or some other rabbi, has stylised the Waw, giving it, in the earlier image, the nice round cup shape, which is required to convince you that the letter S derives therefrom. More corkscrew logic! Even with this later shape, the Waw was always pronounced like a V or W, never like an S. Kapiche?

It would be instructive for us to also take a quick look at cuneiform. Here is an image of a clay tablet and the stylus:



Cuneiform script originally lacked curves because it is an offshoot of inscribing lines on rocks. It is difficult and time-consuming to carve curved lines onto hard rock.

This is why ancient letters carved into stone typically lack curved writing. Cuneiform script dates back to 8,000 BC. Writing on papyrus was invented in Egypt around 3,000 BC. This transition to quill and paper made it easier write curved letters. **Naturally, Zimmerman only shows you the highly stylized, cup-topped version of the letter Waw, so you can be easily misled.**

From the website Hebrew today, we read concerning the letter gimel:

### The Hebrew Letter Gimel (ג)

The letter Gimel is the third letter in the Hebrew alphabet. This letter is actually the source of the Greek letter Gamma, as you can see by the similarities in the two letters’ names. The English letters “C” and “G” are ultimately derived from Gimel, as well.

While the name of the letter remains a mystery, some have speculated that it comes from the word “gamal” meaning “camel” (the English word “camel” is actually derived from “gamal”)

because some say the letter looks like a camel. Whether or not the letter actually looks like a camel, you can use this trick to try to help you learn the Hebrew alphabet and as you try to improve your control of the Hebrew language.

letter C is derived from the paleo-Hebrew waw! I'll bet the other rabbis at Zimmerman's yeshiva are most proud of his letter twisting antics! Back to our intrepid word bender!]

While Gimel is generally pronounced like the "G" in "gap", some dialects pronounce it differently in certain cases. Some Yemenite Jews, for example, pronounce it as more of a "J" in specific cases. [Source:](#)

**Here is the Britannica entry on the third letter of the Hebrew alphabet:**

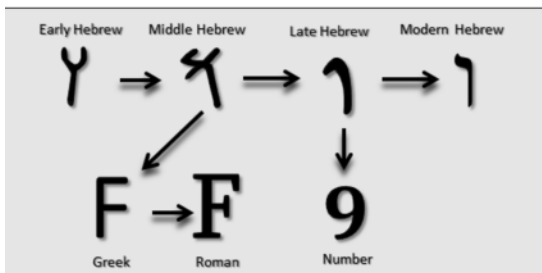
“c, third letter of the alphabet, corresponding to Semitic gimel (which probably derived from an early sign for "camel") and Greek gamma (Γ).

In some scrolls, it looks more like a U on the top instead of C. In other scrolls it looks like a S on top of the stick. [Documentation, please! Mere assertions will not fly for real scholars!! This kind of schmutzig, sullen logic might fly for novices, but not for those of us in Israel Identity! – Eli.]

A rounded form occurs at Corinth and in the Chalcidic alphabet, and both an angular and a rounded form are found in the early Latin alphabet, as well as in Etruscan. The rounded form survived and became general, and the shape of the letter has since altered little.” - Eli.]

So whether it looked like a S, C or U, in all cases there are curves. [So, this is a graphic of the Hebrew letter vav, showing how it started out looking like a Y and then later morphing into a hook shape:

**The Letter Vav**



For the reasons stated above, the earliest form of waw was a simple Y shape, without curves, because curves were difficult to inscribe on rock. However, as you can see, this letter became the Greek F, not an S. No J! No S! – Eli.] Back to Zimmerman.

So, we can see that the rounded form of the letter gimel was a much later development, but Zimmerman would have you believe that the

This is **not** a Y like we use today in English & also not the Yod they use in Assyrian Aramaic. If we look at all 4 letters of the divine name & render this letter as only a U sound without any consonant sound, then we would have 4 vowel

sounds together which would be impossible to speak as a name. [Not true. The four vowel sounds can still be pronounced like iaua or ieue. – Eli.]

The fact is that some letters represented both vowel & consonant sounds, such as is true with the first letter. Language & how to write was constantly evolving & continues to evolve even to this day. ## Old Testament

### “Word for Word” Exodus Chap. 38 - Part 32

#### Translation by Stephen Howard Anderson



## Chapter 38

1. And made he the altar of burnt offering of wood of Shittiyim: five cubits was the length of it, and five cubits the width of it; it was foursquare; and three cubits the height of it.

2. And made he the horns of it on the four corners of it; the horns of it were of the same: and overlaid he it with bronze.

3. And made he all the articles of the altar, the pots, and the shovels, and the basins, and the miz'lanoth 4207, and the fire pans: all the articles of it made he of bronze.

4. And made he a bronze grate for the altar of network under the rim of it beneath unto the middle of it.

5. And cast he four rings for the four ends of the grate of bronze, to be places for the poles.

6. And made he poles of wood of Shittiyim, and overlaid them with bronze.

7 And put he the poles into the rings on the sides of the altar, to carry it with; made he the altar hollow with boards.

8. And made he the laver of bronze, and the base of it of bronze, of the mirrors 4759 of the assembly, which assembled at the door of the Tent of Meeting.

9. And made he the courtyard: on the south side southward the hangings of the courtyard were of fine linen, a hundred cubits:

10. Their pillars were twenty, and their bronze bases twenty; the hooks of the pillars and their fillets were of silver.

11. And for the north side the hangings were a hundred cubits, their pillars were twenty, and their bases of bronze twenty; the hooks of the pillars and their fillets were of silver.

12. And for the seaward side were hangings of fifty cubits, their pillars ten, and their bases ten; the hooks of the pillars and their fillets were of silver.

13. And for the east side eastward fifty cubits.

14. The hangings of one side of the gate were fifteen cubits; their pillars three, and their bases three.

15. And for the other side of the court gate, on this hand and on that hand, were hangings of fifteen cubits; their pillars three, and their bases three.

16. All the hangings of the courtyard round about were of fine linen.

17. And the bases for the pillars were of bronze; the hooks of the pillars and their fillets were of silver and the overlaying of their capitals of silver; and all the pillars of the courtyard were filleted with silver.

18. And the hanging for the gate of the courtyard was of needlework, of blue, purple, scarlet, and fine linen: and the length was twenty cubits, and the height along the width was five cubits, comparable to the hangings of the courtyard.

19. And their pillars were four, and their bases of bronze four; their hooks of silver, and the overlaying of their capitals and their fillets of silver.

20. And all the tent pins of the Tabernacle, and of the courtyard round about, were of bronze.

21. This is the sum of the Tabernacle, of the Tabernacle of Testimony, as it was counted, according to the word of Mosheh, for the service of the Lewiyyim, by the hand of Iythamar, son to Aharon the priest.

22. And Betsaleel the son of Uriy, the son of Chur, of the tribe of Yahudah, made all that commanded Yahweh to Mosheh.

23. And with him was Oholiyah, son of Achiyasach, of the tribe of Dan, an engraver, and an artistic workman, and an embroiderer in blue, purple, scarlet, and fine linen.

24. All the gold that was occupied for the work in all the work of the Holy Place, even the gold of the offering was twenty nine talents, and seven hundred and thirty shekels, after the shekel of the Sanctuary.

25. And the silver of them that was numbered of the congregation was a hundred talents, and a thousand seven hundred and seventy five shekels, after the shekel of the Sanctuary.

26. A bekah 1235 for every man, that is, half a shekel, after the shekel of the Sanctuary, for every one that went to be numbered, from twenty years old and upward, for six hundred and three thousand five hundred and fifty men.

27. And of the hundred talents of silver were cast the bases of the Sanctuary, and the bases of the veil; a hundred bases of the hundred talents, a talent for a base.

28. And of the thousand seven hundred and five shekels made he hooks for the pillars, and overlaid their capitals, and filleted them.

29. And the bronze of the offering was seventy talents, and two thousand and four hundred shekels.

30. And with it made he the bases to the doorway of the Tent of Meeting, and the altar of bronze, and the grate of bronze for it, and all the articles of the altar,

31. and the bases of the courtyard round about, and the bases of the courtyard gate, and all the tent pins of the Tabernacle, and all the tent pins of the courtyard round about..

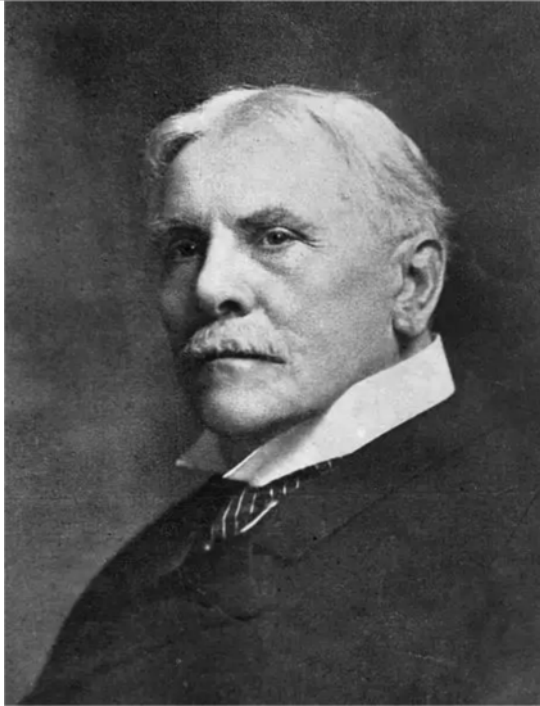

## Why I Left Scofieldism

**B**REAKING AWAY FROM THE FASCINATING TEACHINGS OF THE SCOFIELD REFERENCE BIBLE was one of the most difficult decisions of my entire life.

Even after doubts arose in my mind, it took some seven or eight years to relinquish the readymade theological clothing I had worn since the day of my conversion.

For I was saved, at the age of sixteen, in a Baptist church where almost everyone carried a Scofield Bible. My spiritual tutors knew the footnotes and headings placed in the Bible by C. I. Scofield as well as they knew the Bible itself.

Indeed, the two had become almost synonymous in their minds even as they were destined to become in my own mind. Even today it is difficult at times to clear my mind of some of Scofield's presuppositions when I study God's Word.

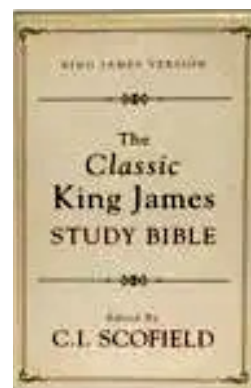
It was while I was serving in Europe as a member of a medium tank crew that God called me into the ministry of his dear Son. Even before the beginning of World War II - in fact, from the time of my conversion, I had been active as a

Sunday School teacher and had taken other active interests in the local church. However, acting on the advice of Scofield himself, I had distrusted the outstanding Bible commentaries and had felt that all I needed for a thorough understanding of the Bible was supplied by the notes of my favourite "Bible."

With my call to the ministry came the jolting realization that I would be called upon to say to members of my congregation, "This is why we believe thus and so about the Bible; here is the verse and chapter for our belief on a given subject."

With this thought in mind I deliberately took my theology apart to see whether or not I could put it together again, based on the Bible. My thinking was that if I could not convince myself, then certainly I could not convince others. In other words, I asked myself, concerning each and every major doctrine in which I believed, "What saith the scripture?" (Romans 4:3).

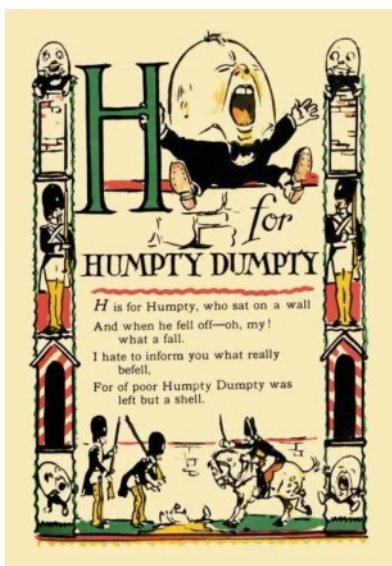
This was a helpful experience in my life and ministry. I heartily recommend it to every preacher and teacher. Let me caution you, however, that there are risks involved in such a procedure.



You might have to burn some favourite sermons or lessons! I did. Still, it was a rewarding experience, too. To me it was like walking out of a dimly lighted room into one flooded with light. My God and his Book appeared larger than ever before.

Getting back to the dissecting of my beliefs, it was disconcerting, to say the least, to find that

some of my most cherished beliefs simply would not stand up under a close scriptural scrutiny.



I got most of Humpty-Dumpty back together with relative ease. I could show, from the Bible, why I believed in such great doctrines as the Virgin Birth, deity of Christ, his literal Second Coming, the inspiration and infallibility of the Scriptures, believers' immersion, eternal security, perseverance of the saints, the bodily resurrection of all, the judgment, eternal heaven, an equally eternal hell, and many other cardinal doctrines.

But, try as I would, certain beliefs kept embarrassing me. For I could not find the verse and chapter to support my beliefs concerning national Israel.

I had been taught that the Jews would go back to Palestine, rebuild the Temple, reinstitute the blood sacrifices, serve as Christ's missionaries during an earthly millennium, and be involved in many other related events.

I was so determined to find scriptural support for these teachings that oftentimes I became angry with myself for being so lacking in Bible knowledge.

Finally, after some seven or eight years of searching in vain, God jolted me into reality. It finally dawned upon me that what I sincerely thought were verses of the Bible actually were footnotes put inside the covers of the Bible by a man. I acknowledged, too, that C. I. Scofield was a man. like ourselves and that he did not belong in the same authoritative category as Peter, James,

and John. I broke with Scofieldism grudgingly. He had been such a help in preparing a Sunday School lesson and, later, in "getting up a sermon."

All one needed to do was to turn to the passage in mind. In most cases the headings and footnotes presented a ready outline, requiring very little study. Also, just about every Christian in my peer group seemed to agree that here was profound teaching.

Perhaps one of my greatest surprises came with the realization that followers of Scofield actually represented a comparatively small minority among Christians. It was only their dogmatism, plus the fact that they were so vocal, which made them appear to be in the majority.



It was a comfort to learn that Scofield's "rediscovered truths," which he had learned at the feet of John Nelson Darby (above), a Plymouth Brethren, differed not only from most known commentaries, but from the great majority of the church fathers, and the reformers as well.

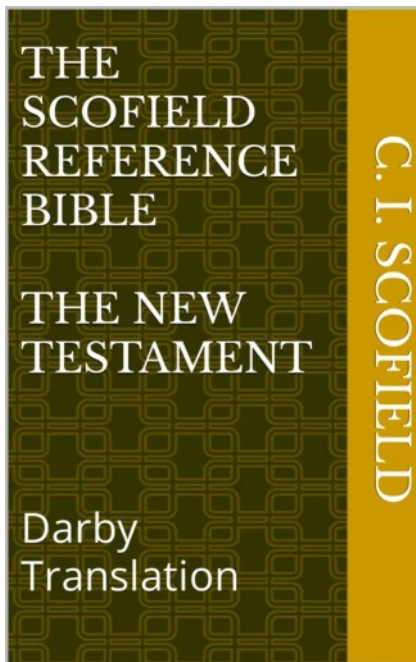
I learned, too, that most of the critics of Scofieldism had, as I had, been devoted followers at one time.

Having come out of Scofieldism, I passed through at least three stages to arrive at my present position.

My first feeling was that, although many things my former hero taught were not so, the good points (and he has many of these) in his system outweighed the bad.

From this stage continued study led me to believe that I must leave The Scofield Reference Bible alone completely, but that I should not make an issue of it with equally sincere Christians. Further study led me to the position which I now hold.

Historic Christian teaching always has been that the church was the antitype of national Israel. This teaching goes on to say that the church succeeded Israel at the first advent, and that all unfulfilled promises to Abraham will be fulfilled in and through the church.



Scofield admits that this is the historic Christian teaching, then proceeds to teach that it is erroneous. He says: "Especially is it necessary to exclude the notion - a legacy in Protestant thought from post-apostolic and Roman Catholic theology - that the Church is the true Israel, and that the Old Testament fore-view of the kingdom is fulfilled in the Church" (p. 989, S.R.B.).

He begins early in his footnotes to lay the groundwork for his teaching that the church will end in failure and be replaced by national Israel, who will succeed where the church failed.

On page 8, in footnote I, he states that Eve is a type of the church! Like most of Scofield's "types," this one is arbitrary, artificial, and forced. Any interested reader may turn to the passages given as "proof" that Eve is a type of the church, and he will see that there is no mention whatsoever of this fact.

That position is that Scofieldism is heresy, and that, since God has given me this light, I must seek in love to warn others of the household of faith against this subtle, intriguing heresy.

He lists John 3:28,29; 2 Corinthians 11:2; Ephesians 5:25-32; and Revelation 19:7,8. This is typical of Scofield's scriptural references; they rarely say what he says they do. He apparently counted on the fact that his readers would not turn to the passages given. Either that, or he slighted the intelligence of his readers.

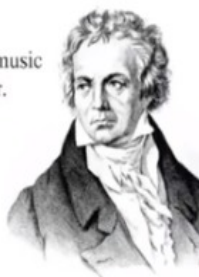
It has been some 14 years since my final break with Scofieldism. Let me share with you some of the objections to this teaching as they are now formulated in my mind.

We know that everything is vibration and how as humans we are heavily influenced by sound, and in particular music. Musical frequencies have the ability to either raise or lower our

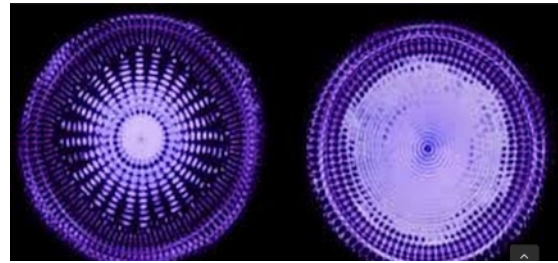
vibrations which affects our mood, our connections with others around us, and our ability to raise our consciousness. The music conspiracy goes much deeper than distorted sounds.

Significance of the Viceroy is in the definition of the term. A viceroy is a regal official who runs a country, colony, city, province, or sub-national state, in the name of and as the representative of the monarch of the territory.

The griffin, griffon, or gryphon (Ancient Greek: γρύψ, grū ps; Classical Latin: grūps or grūpus; Late and Medieval Latin: gryphes, grypho etc.; Old French: griffon) is a legendary creature with the body, tail, and back legs of a lion; the head and wings of an eagle; and sometimes an eagle’s talons as its front feet.



Because the lion was traditionally considered the king of the beasts, and the eagle the king of the birds, by the Middle Ages, the griffin was thought to be an especially powerful and majestic creature. Since classical antiquity, griffins were known for guarding treasures and priceless possessions. In Greek and Roman texts, griffins and Arimaspians were associated with gold deposits of Central Asia.

Indeed, as Pliny the Elder wrote, “griffins were said to lay eggs in burrows on the ground and these nests contained gold nuggets.” In medieval heraldry, the griffin became a Christian symbol of divine power and a guardian of the divine.



In Tartarian legend of this period, it was believed that griffins mated for life, and that when one partner died, the other would live the rest of his/her without seeking another partner (perhaps due to the fact that there weren’t many griffins around)

This has led to claims that the griffin was used by the Church as a symbol against re-marriage. It is unclear, however, whether this was the actual belief, or just a modern interpretation.

Although the griffin might seem like a creature conjured from the imagination of mankind, there might actually be some truth to this creature.



In this desert, the fossils of a dinosaur called the *Protoceratops* can be found. As these bones, especially the skull, which has a bird-like beak, were exposed on the desert floor, ancient observers may have interpreted them as proof that such a hybrid creature once lived in the desert.

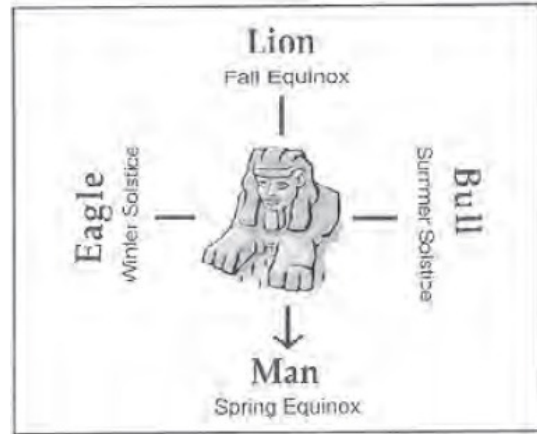
Yet, it has been shown that stories of the griffin have been around even before the Silk Road was developed.



Interestingly, there are various hybrid creatures that are similar to the griffin. For instance, the Lamassu was an Assyrian mythical creature that had **the head of a man, a body of a lion or bull, and the wings of an eagle.**

This is also what the original Great Sphinx of Egypt was designed as. According to biblical references, these four animal faces represent **the four domains of God's rule**: the man represents

humanity; the lion, wild animals; the ox, domestic animals; and the eagle, birds.



These four creatures first appear together in the Judeo-Christian context in *Ezekiel*, which was probably written around the third century BC. In chapter 1, the prophet encounters fantastic beings in the heavens:

“As for the likeness of their faces, they four had the face of a man, and the face of a lion, on the right side: and they four had the face of an ox on the left side; they four also had the face of an eagle,”

Queen Khalifia (below) ruled the Island of California with Griffins which she fed the flesh of men to keep Spanish Invaders away. She supposedly commanded a fleet of ships with which she ruled and maintained peace in the surrounding lands, and islands including Baja and Hawaii.

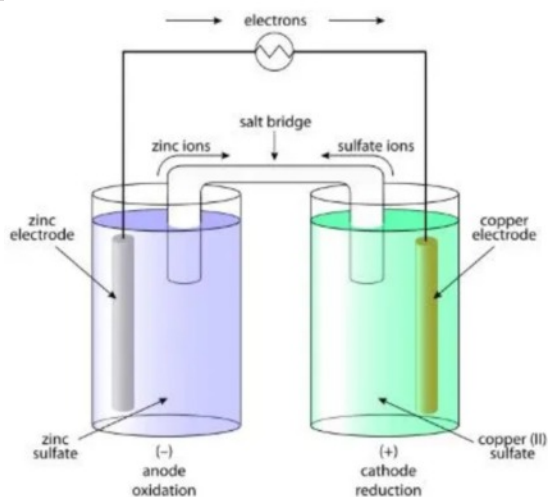

**T**HE AVERAGE PERSON, WITH 7 VOLTS OF DIRECT CURRENT COURSING THROUGH HIS OR HER EAR CANAL, heard a clear metallic sound resembling a small dinner bell. The range of sensitivity of normal human beings, however, was enormous. Some heard nothing at all, even when all twenty Daniell cells (above) were in the circuit.

The greater the current, the purer the tone, and the greater the resemblance to a bell. When Brenner asked his subjects to sing the tone they heard, some, agreeing with Ritter’s report of 1802, heard a g above middle c. Others disagreed.

For others, who were deemed to have “acoustic nerve hyperaesthesia,” the sound from only one cell was intense. Some heard nothing unless their ear canal was filled with salt water, which helped conduct the electricity.

But although the threshold of perception varied enormously, and the quality and exact pitch were different for everyone, each individual always heard the same thing. They always heard the identical sound and pitch, and had the same threshold, whenever they were tested, even at intervals years apart.

Others, their ear canals dry, heard the ringing bell when the knob-shaped electrode was simply placed on the cheek in front of the ear, or on the mastoid process, the bony protrusion behind the ear.

After experimenting with different placements of the second, non-ear electrode on the skull, neck, torso, arms, and legs, Brenner became convinced that a sound was heard only when the inner ear was in the path of the current, and that direct stimulation of the acoustic nerve was the cause of the sensation of sound.

The direction of the current was crucial. The sound—unless the person had “hyperaesthesia”—was heard only when the negative, not the positive, electrode was in the ear. With minimal current the sound typically resembled the “buzzing of a fly.” This was elevated to “distant

American physician Sinclair Tousey, one of the last electrotherapists of the old school, wrote

about electricity and the ear in the third edition of his textbook on Medical Electricity, published in 1921.



Brenner's results with direct current, completely forgotten today, were still at that time taught, accepted, and verified by every electrical practitioner. Sounds were normally caused by cathodic (negative) stimulation of the auditory nerve.

The range of sensitivity was extraordinary. "Many individuals," wrote Tousey, closely echoing Brenner's words, "give no reactions whatever." In others, the sound was so loud that the person was deemed to have "a distinct hyperesthesia of the auditory nerve."

With the disappearance of the electrotherapist's art and the dwindling of opportunities for the average physician to become familiar with the auditory response to electricity, the old knowledge was again almost forgotten.

Then, around 1925, amateur radio enthusiasts thought they found a way to listen to the radio without a loudspeaker, by directly stimulating the acoustic nerve.

**"Thus, even deaf persons whose eardrums no longer function properly, but whose nerve centres are intact, can hear radio," wrote Gustav Eichhorn.**

The device he patented, however—a kind of flat electrode held against the ear — was soon dismissed as being nothing more than a "condenser receiver." Apparently, the surfaces

of the skin and the electrode, vibrating, took the place of a loudspeaker, creating an ordinary sound that reached the inner ear by bone conduction.

Nevertheless, the experiments of the radio engineers spawned a spate of genuine efforts by biologists to stimulate the inner ear with alternating current.

This was typically done after the manner of Brenner—by inserting one electrode in the ear canal, which was first filled with salt water, and completing the circuit with a second electrode on the back of the forearm or hand.

The subjects most often heard a tone that corresponded in pitch to the frequency of the applied current. The sensitivity of the subjects, as before, varied tremendously.

In experiments done in Leningrad, the most sensitive individual, when tested with a current of 1,000 cycles per second, heard a sound as soon as the voltage exceeded a fifth of a volt; the least sensitive subject required six volts—a thirty fold difference in sensitivity.

There was nothing wrong with the hearing of any of these people. The variations in their ability to hear electricity bore no relation to the subjects' ability to hear ordinary sound.



In 1936, Stanley Smith Stevens (above), an experimental psychologist at Harvard University, gave the hearing phenomenon a new name: "electrophonic hearing." Four years later, at his newly-created Psycho-Acoustics Laboratory, he proposed three different mechanisms of hearing by electrical stimulation.

Most people with normal hearing, when stimulated by an electrode in their ear, heard a pitch that was exactly one octave higher than the frequency of the applied current.

However, if a negative DC voltage was applied at the same time, they heard the fundamental frequency as well. His knowledge of physics led Stevens to conclude that the ear was responding like a condenser receiver, with the ear drum and the opposite wall of the middle ear being the vibrating “plates” of that condenser.

People without ear drums, however, heard either the fundamental frequency or a “buzzing” noise, or both. None heard the higher octave. And as Brenner had also reported, ear drumless ears were much more sensitive to electricity than normal ears.

One of Stevens’ subjects heard a pure tone when stimulated with only one-twentieth of a volt. Stevens proposed that the hearing of the fundamental frequency was caused by direct stimulation of the hair cells of the inner ear.

For those that heard a buzzing sound, he proposed that the auditory nerve was being stimulated directly.

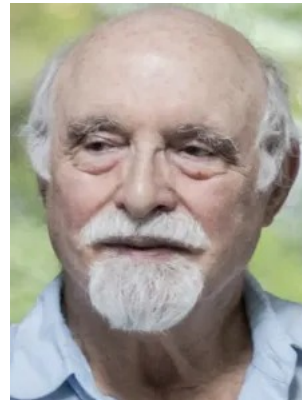
Thus, by 1940, three different parts of the ear were being proposed as capable of turning electricity into sound: the middle ear, the hair cells of the inner ear, and the auditory nerve. All three mechanisms appeared to operate throughout the normal hearing range of human beings.

Stevens tried one additional experiment, whose significance he failed to appreciate, and which was not repeated by anyone else for two decades: he exposed subjects to a low frequency, 100 kHz radio wave that was modulated at 400 Hz.

Somehow the ear demodulated this signal and the person heard a 400-cycle pure tone, close to a g above middle c.

In 1960, biologist Allan Frey introduced yet another method of hearing electromagnetic energy, this time without placing electrodes on the body. A radar technician at Syracuse, New York swore to him that he could “hear” radar. Taking him at his word, Frey accompanied the man back to the Syracuse facility and found that

he could hear it too. Frey (below) was soon publishing papers about the effect, proving that even animals, and people with conduction deafness—but not nerve deafness—could hear brief pulses of microwave radiation at extremely low levels of average power.



This phenomenon, known as “microwave hearing,” attracted a fair amount of publicity, but is probably not responsible for most of the sounds that torment so many people today.

However, the 1960’s would bring still more surprises. Renewed research into electro-phonics hearing had both civilian and military goals. The medical community wanted to see if the deaf could be made to hear.

The military community wanted to see if a new method of communication could be devised for soldiers or astronauts.

In 1963, Gerhard Salomon and Arnold Starr, in Copenhagen, proved that the inner ear was far more sensitive to electrical energy than anyone had previously suspected. They placed electrodes directly adjacent to the cochlea in two patients who had had surgical reconstruction of their middle ear.

One patient heard “clicks” or “cracklings” when stimulated by only three micro-amperes (millionths of an ampere) of direct current. The second patient required 35 micro-amperes to hear the same sound.

As the current was gradually increased, the clicks changed to “walking on dry snow” or the rush of “blowing air.” Alternating current elicited pure tones whose pitch matched the applied frequency, but this required about a thousand times more current.

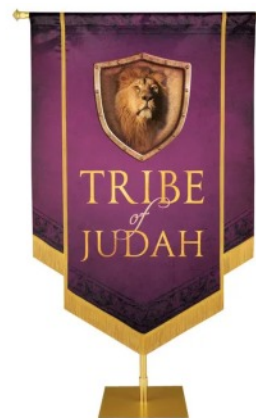

comes out of Hollywood, the television, the music industry, and the gaming industry? No.

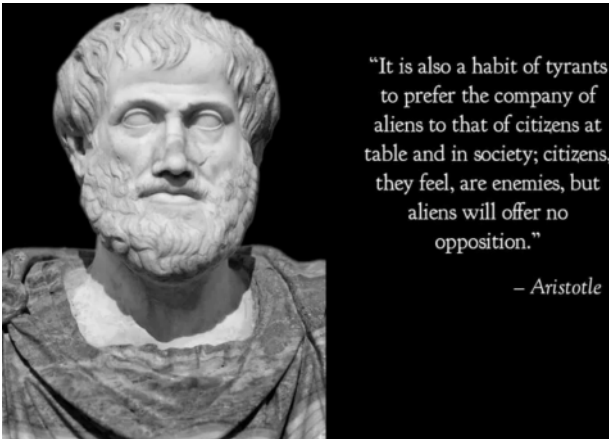

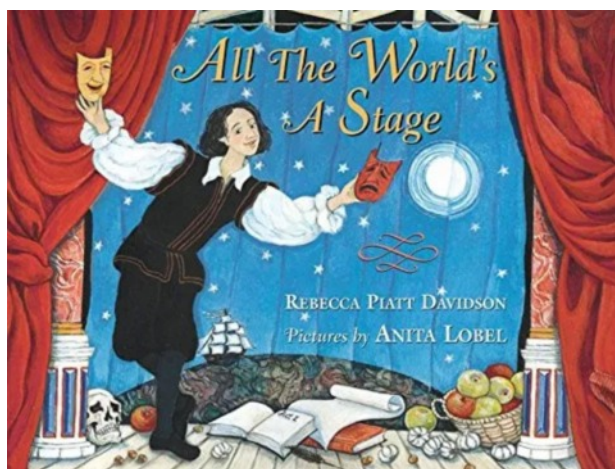
That is the place of my nativity. Thus, I am a native, meaning, indigenous to these lands, to

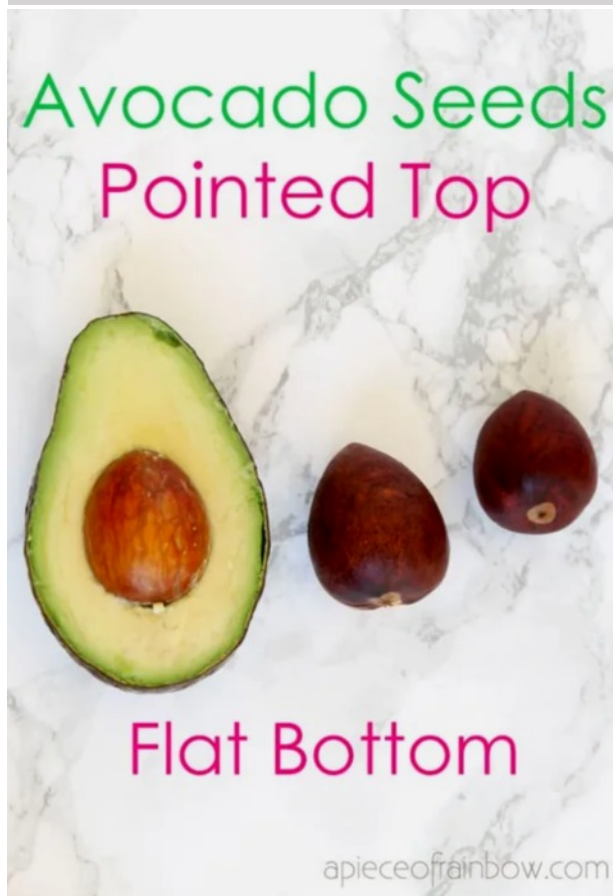

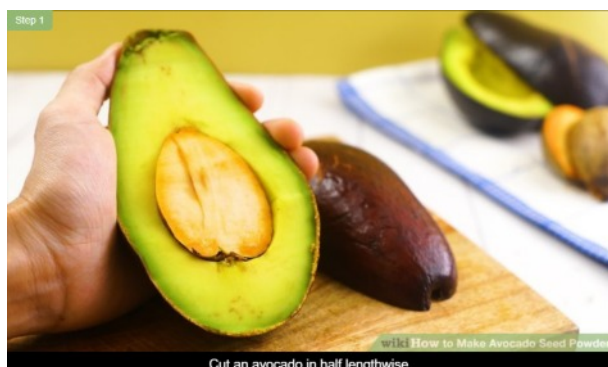

### Easy Way to Make Avocado Seed Powder



**Cut an avocado in half lengthwise.** Run a sharp knife around the middle of the fruit, then gently twist the two halves apart. If it's your first time working with an avocado, the seed will be that big, round, light brown thing sticking out of the soft, pale green fruit.

Avocado seeds are quite large. You should be able to feel the seed pressing up against the blade of your knife when you slice through.

**Extract an avocado seed,** rinse it off, and let it air-dry overnight. Crush the dried seed with a mallet, tenderiser, or rolling pin to break it up, then grind the seed to the desired texture in a blender or food processor. Store the avocado seed powder in an airtight container in the fridge for up to 2 weeks.

Work the seed out with the tip or edge of your knife. The simplest way to do this is to tap the dead-centre of the seed and lift it out clean. If

you don't think your knife is sharp enough for this kind of finesse, you can always just scoop it out with a spoon, though this will be slightly more messy.

Once you've successfully extracted the seed, stick the rest of the avocado in an airtight food storage container or plastic baggie and try to use it within a day or two.

**Warning:** The knife will be very close to your hand during this step, so be careful not to cut yourself by accident while digging out the embedded seed.

Leave the seed exposed to air until it's thoroughly dry. If you're not in any particular hurry, simply slide a plate under it and let it sit out on your countertop or in the refrigerator overnight.

For crunch-time projects, you can speed things along by setting the seed in a warm, sunny spot or placing it on a baking sheet and popping it in the oven at its lowest heat setting for 2-3 hours.

You'll know your seed is sufficiently dry when the thin outer skin cracks and begins to flake off. Atmospheric moisture will increase the seed's overall drying time, so keep it out of humid rooms and away from frequently-used water sources like sinks and dishwashers.

### Processing the Seed

Grind the seed to the desired texture in a blender or food processor. For a coarse grind, pulse the machine 4-5 times for a couple seconds at a time to pulverize the chunks a bit. If you'd prefer a finer powder, let it run uninterrupted for 10-20 seconds, then check the seed's progress and repeat as many times as needed.



A basic coffee grinder will also work nicely for this task.



Keep the powder in an airtight container in the fridge for up to 2 weeks.

When you're happy with your powder's consistency, transfer it to a mason jar or lidded storage container and stash it in the refrigerator. A tightly-sealed container and cool environment will ensure that it stays off-limits to moisture.

You can probably get away with storing your avocado seed powder at room temperature if you need to, so long as it remains sealed whenever you're not using it.

The smallest amount of moisture could cause the once-dry powder to clump or stick, making it harder to portion out.

### Conclusion

Avocado seeds, often overlooked, hold significant nutritional value and potential health benefits.

By exploring creative ways to incorporate them into your meals, you not only enhance your diet

It is incredible that the millions of zombies drifting around today are the direct descendants

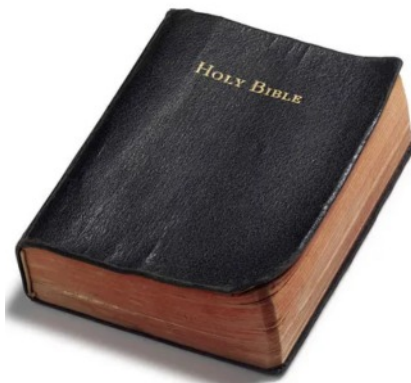

We notice first that most of Jesus' ministry took place deliberately in the northern region of Galilee who lived in the ancient house of Israel, not to be confused with Judah, progenitor Jews. {sic., 'progenitor' is incorrect, since the Jewish people are not derived from Judah but from Esau-Edom.



Also, the religion called "Judaism" was never practiced by the House of Judah. Judaism was concocted by the Edomite Pharisees. – Eli.} It is of extreme importance to clearly establish in our thinking the fact that our Lord's message was "the good news of the government to be established by divine intervention into the present world order."

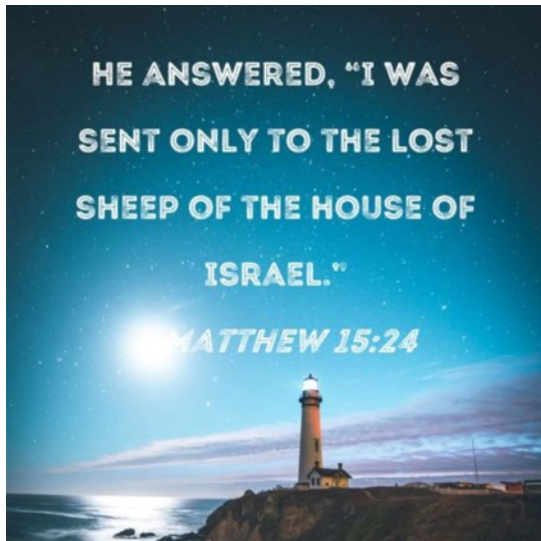
The whole Bible is written to a whole people who carry God's mission, not simply scattered individuals here and there. We distort the gospel when we take it to mean little more than a soothing panacea for our individual needs if we

could take our eyes off ourselves and make a commitment to the divine plan for all the world.

Remember: the gospel is the "good news" announcement of a coming Providential world government. Jesus was proclaiming the destined establishment of a new order, a divine authority for all the nations.

Do not confuse this with Satan's counterfeits, the various humanistic efforts toward world government, such as the United Nations Organization.

In Luke 4:43 we read of Jesus' pressing concern that this gospel of world order (not heavenly escape) might reach a wider circle: "I must preach the kingdom (government) of God to other cities also: for therefore am I sent." Here Jesus clearly defines His mandate.



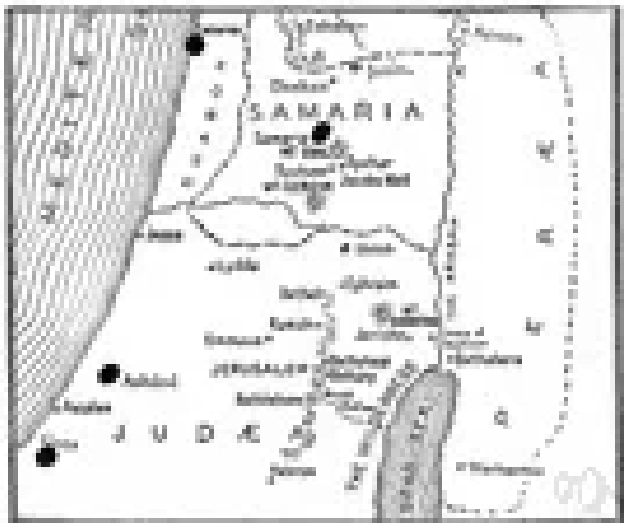
Contrary to the naive assumption of most people, Jesus was sent to a specific population group. He clearly stated, "I am not sent but unto the lost sheep house of Israel" (Matthew 15:24).

His reference to the "house of Israel" refers precisely to the ten tribes who, centuries earlier, had comprised the northern kingdom of Israel after the death of Solomon and until those ten tribes were taken into captivity about 721 B.C.

Since the house of Israel, as scholars well know, did not include the tribe of Judah, Jesus was not "sent" primarily to the Jews, but was specifically on a mission to take a message to the people of the ten tribes of the house of Israel, none of whom were Jews (properly called Judaites or Judeans). {Yahshua was not sent to the Jews at

all, because the Jewish people of this time were aliens descended from Esau/Edom, not from any of the tribes of Israel. The same is true of today's Jews. If the Jews were Israelites, why would they reject the redemption offered at Calvary? And then commit decide on top of this rejection! - Eli.}

There has been continuing confusion at this point, partly because the King James version Bible, at the beginning of the seventeenth century, used the medieval term "Jew" to translate the term yehudim and its Greek equivalent.



Clarity would be achieved by employing the term Judaite or the word Judean; of those two terms, Judaite is to be preferred because Judean evokes images of the land rather than the people.

Even so, there are many today who are Judaites but are not Jews, and there are many others among today's Jews who are not descended from Abraham through Judah.

{The fact is that no Jews are descended from Abraham, except for the minuscule amount of DNA that Jews may have gotten from Esau. See John 8. - Eli}

More to the point, if Jesus was "not sent but unto the lost sheep of the house of Israel," it would seem to be impossible that any message could reach them, for they had been scattered beyond little Palestine for about seven hundred years. In their wanderings through centuries, the people of Israel forgot their roots, adopting other languages, religions, and tribal names. Moreover, there would be the suspicion that they

had mixed with other races as they migrated, creating a mixed people and effectively breeding themselves out of existence.

But God had promised many generations before, "I will command, and I will sift the house of Israel among all nations, like as corn is sifted in a sieve, yet shall not the least grain fall upon the earth." (Amos 9:9).

In other words, there was the irrevocable divine promise that as Israel wandered through other lands to far distance places, they would maintain their genetic code, their racial integrity, and so their identity as the Chosen People of God, destined in good time to be used in the establishment of the creative rule of the Eternal.

Jesus was sent to "the lost sheep of the house of Israel." Those ten tribes were certainly "lost" in the eyes of the world and were "lost" as well in their own memory, yet not for one moment were they lost in the sight of the One who shapes human history. And since we believe the Bible

to be true, despite the attacks upon it by all antichrists, we are assured that the people of "the house of Israel" still exist as an identifiable biotype.

{The Greek word translated as 'lost' is *appolumi*, which means "put away in punishment," which is an exact description of the Israelites who were exiled into the wilderness of Europe. – Eli}

II Esdras 13:41: reports the travel of the ten tribes of the house of Israel: "They took counsel among themselves, that they would leave the multitude of the heathen, and go forth into a further country where never mankind dwelt."

**Note:** II Esdras was included in the *original* KJV Bible, but it has been omitted from most American Bibles for a century. Copies may be found in old family Bibles or translations including the *Apocrypha*, or *hidden Books of the Bible*.

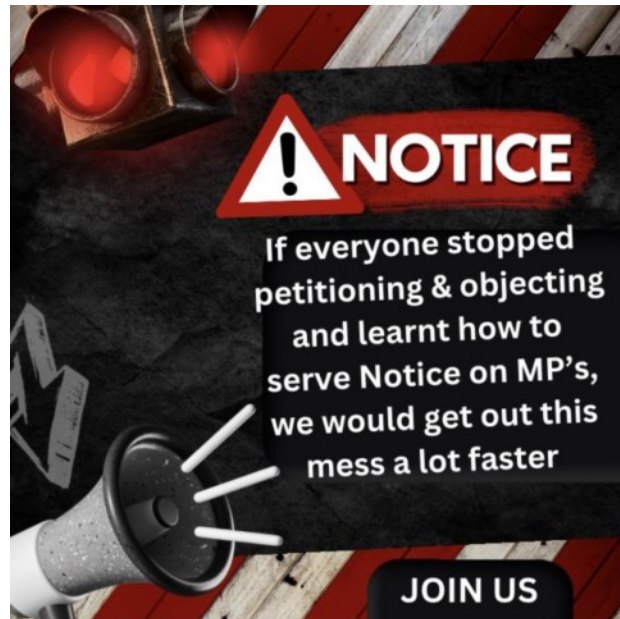


**The Rock Stump**

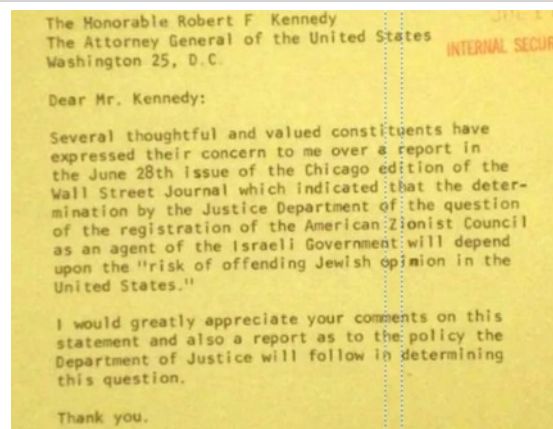
Close by to the ruins are rock cut graves which could of been cut around the 9th to 11th century, possibly older.

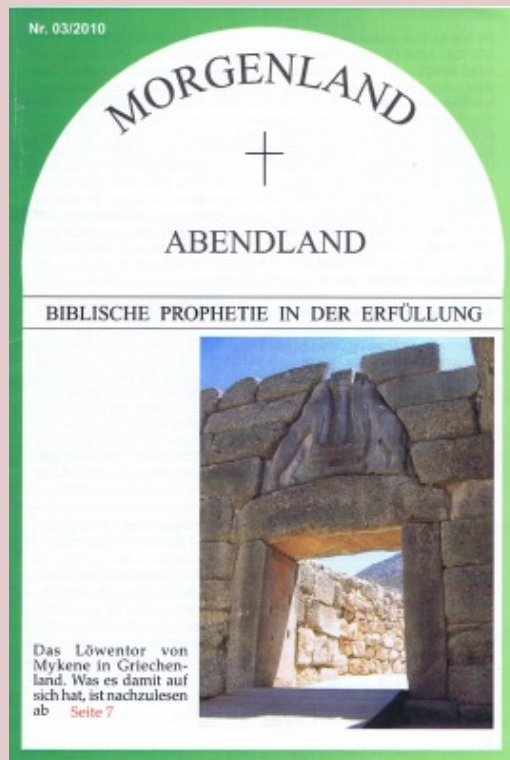
