from the 1611 KJV:



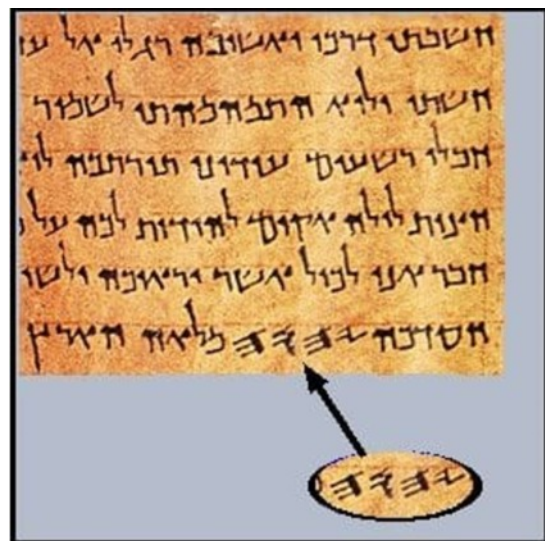

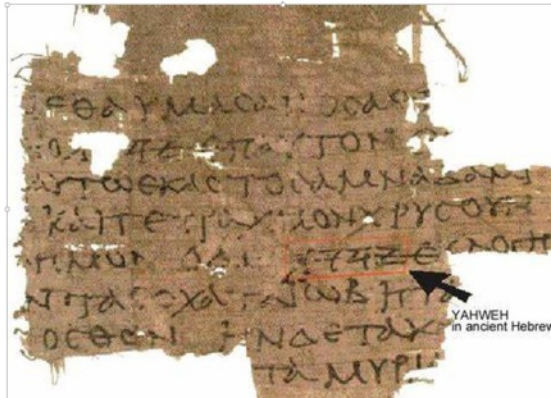
The Greek Septuagint, the Bible that Jesus & the Apostles Used, Almost Identical to Paleo-Hebrew.

Both Chart #4 (left) and Chart #1 (top of page) shows that Greek and Paleo-Hebrew are closely related. Whereas "Modern Hebrew" (& Strong's Concordance Hebrew) is closely related to Assyrian Aramaic.



The Assyrians

[This idea has already been refuted herein. There is no such thing as "Assyrian Aramaic." "Apostle" Zimmerman is simply making this up! The chronology of the Assyrian language shows that the Assyrians picked up the Aramaic speech and writing late in their history, well after the events described in Genesis and Exodus. – Eli]

Greek & Paleo-Hebrew look and sound almost identical. Notice also that Paleo-Hebrew did have vowels!

[AZ has no way of knowing how Greek and Hebrew sounded in those days. Yes, the paleo-Hebrew did have vowels, but the vowel characters were left out of the text to save space and because Moses and the scribes knew how to pronounce the words. Early Greek had no written vowels either. It was the Greeks who took the Hebrew – not Phoenician – alphabet and started inserting vowels into their written words. For example, the paleo-Hebrew Aleph became A; the Paleo-Hebrew Hey produced E; Yod became Y; Waw spawned a short a; etc– Eli.]

The Hebrew roots sacred name followers claim that Hebrew did not have vowels. [This is inaccurate. Nobody has ever said that the Hebrew language had no vowels. AZ fails to

[Modern Hebrew is Jewish, but AZ has no idea of how ancient Greek sounded. Even today, neither Greek nor Jewish “Hebrew” have a J sound! To this day!

Yhwh & What It Means in Assyrian Babylonian Aramaic: The original scriptures **did not** have the four letter tetragrammaton of **Yhwh**. [Nonsense! – Eli] The 4 letters shown here are "Modern Hebrew" which is really Babylonian {sic, modern Jewish – Eli} Aramaic.



They did not appear in the original scriptures. Moses (above) did not write them. They are not Paleo-Hebrew. They are Aramaic (Modern Hebrew) which did not exist during Moses lifetime. Moses would have written during 1446-1406 B.C. in old Paleo-Hebrew.

The language of Aramaic, the language of "**Yhwh/Yhvh**", did not exist until around 900 B.C. Chart 1 and notice the time line at the bottom of that chart. So, how can we say that Moses wrote the Aramaic letters of **Yhwh / Yhvh**? We can't!

We must admit that the scriptures were translated from one language to another language during

each era, just as we witness in our modern times. We must admit that the original name that God spoke (and Moses wrote) was not the 4 letters **Yhwh/Yhvh** which people then translate into Yahweh, Yahshua, Yeshua, Jehovah & a host of other names other than Jesus.

The 4 letters **Yhwh / Yhvh** & all the translations from it are all Babylonian Aramaic. **Yhwh/Yhvh** is actually the tetragrammaton name of Baal. [Nonsense! The Hebrew equivalent of Baal is "**Lord**," which is the word the Jews have substituted for YHWH. – Eli]

Even the *Encyclopedia Britannica* 1958 edition, Volume 12, page 996 says: "...Yahweh is not a Hebrew name".



[This claim is also bogus. Here is what the EB says about the name Yahweh today: Yahweh, name for the God of the Israelites, representing the biblical pronunciation of "**YHWH**," the Hebrew name revealed to Moses in the book of Exodus. The name **YHWH**, consisting of the sequence of consonants Yod, Heh, Waw, and Heh, is known as the tetragrammaton.]

After the Babylonian Exile (6th century BC), and especially from the 3rd century BC on, Jews ceased to use the name Yahweh for two reasons.

As Judaism became a universal rather than merely a local religion, the more common Hebrew noun Elohim (plural in form but understood in the singular), meaning "God," tended to replace Yahweh to demonstrate the universal sovereignty of Israel's God over all others.

At the same time, the divine name was increasingly regarded as too sacred to be uttered; it was thus replaced vocally in the synagogue ritual by the Hebrew word Adonai ("My Lord"), which was translated as Kyrios ("Lord") in the Septuagint, the Greek version of the Hebrew Scriptures.

The Masoretes, who from about the 6th to the 10th century AD worked to reproduce the original text of the Hebrew Bible, added to “YHWH” the vowel signs of the Hebrew words Adonai or Elohim.

Latin-speaking Christian scholars replaced the Y (which does not exist in Latin) with an I or a J (the latter of which exists in Latin as a variant form of I). Thus, the tetragrammaton became the artificial Latinised name Jehovah (JeHoWaH).

As the use of the name spread throughout medieval Europe, the initial letter J was pronounced according to the local vernacular language rather than Latin. [Source](#):

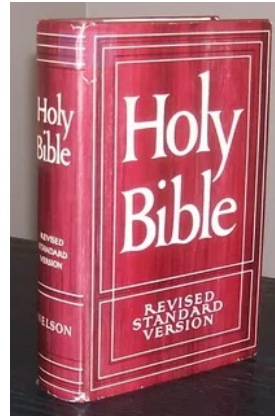
So, you see, there is no support for AZ’s bogus claims about the pronunciation of Hebrew words.

I typed the words “Encyclopedia Britannica 1958 edition, Volume 12, page 996 says: “...Yahweh is not a Hebrew name.” into my browser. This is what comes up: [HERE](#)

If you click on the link, it is obviously “Apostle” Zimmerman’s own handiwork. If Encyclopedia Britannica ever made such a statement, it no longer does. Sanity prevails, occasionally! If you look at all the listings under that heading, they are all repetitions of “Apostle” Zimmerman’s bogus claims. He has also hired people to repeat his nonsense!

It is becoming very clear to me that “Apostle” Zimmerman is a Talmudic disinformation specialist whose mission in life is to suppress the use of the Sacred Names, Yahweh and Yahshua.

This situation is eloquently expressed by the editors of the Revised Standard Version of the Bible (1974). From the Preface:



[A major departure from the practice of the American Standard Version is the rendering of the Divine Name, the “Tetragrammaton.” The American Standard Version used the term “Jehovah”;

The King James Version had employed this in four places, but everywhere else, except in three cases where it was employed as a part of a proper name, used the English word Lord (or in certain cases **God**) printed in capitals.

The precedent of the ancient Greek and Latin translators and the long established practice of reading the Hebrew scriptures in the synagogue. While it is almost if not quite certain that the Name was originally pronounced “Yahweh,” this pronunciation was not indicated when the Masoretes added vowel signs to the consonantal Hebrew text.

The four consonants **Yhwh** of the Name, which had come to be regarded as too sacred to be pronounced [by the rabbis of Judaism! – Eli], they attached vowel signs indicating that in its

place should be read the Hebrew word “Adonai” meaning “Lord” (or Elohim meaning “God”).

The ancient Greek translators substituted the word ‘Kyrios’ (Lord) for the Name. The Vulgate (previous page) likewise used the Latin word ‘Dominus.’



The form “Jehovah” is of late medieval origin; it is a combination of the consonants of the Divine Name and the vowels attached to it by the Masorettes (above) but belonging to an entirely different word.

The sound of Y is represented by J and the sound of W by V, as in Latin. For two reasons the Committee has returned to the more familiar usage of the King James Version:

(1) the word “Jehovah” does not accurately represent any form of the Name ever used in Hebrew; and

(2) the use of any proper name for the one and only God, as there were other gods from whom He had to be distinguished was discontinued in Judaism before the Christian era and is entirely inappropriate for the universal faith of the Christian church.} Online source: [HERE](#)

From this statement, we can see that the suppression of the Name of Yahweh is an entirely Jewish business and that the modern churches have succumbed to this practice by imitating the Jews in this suppression.

The second letter "N" is the first letter for the word "Nazareth" in Latin. Then "R" for Rex, is the first letter for "King," and finally "I" would be for the "J" in the word "Jews."

Those are the first four letters of the four words in Latin. "INRI." And since the Roman Catholic religion uses Latin in their services, it only stands

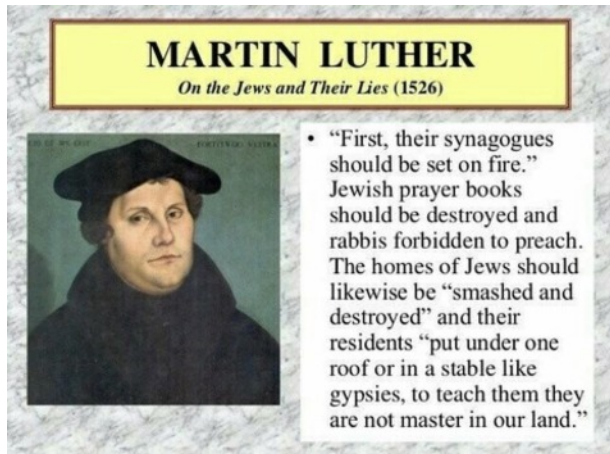
to reason that on their crucifix they would' use these four Latin letters.

Old Testament

"Word for Word" Exodus Chap. 40 - Part 34

Translation by Stephen Howard Anderson



Chapter 40

1. And spoke Yahweh to Mosheh, saying,

2. "On the first day of the month shall you set up the Tabernacle of the Tent of Meeting.

3. And you shall put in it the Ark of the Testimony, and cover the Ark with the veil.

4. And you shall bring in the table, and set in order the things that are to be set in order 6187 upon it; and you shall bring in the menorah, and light the lamps of it.

5. You shall set the altar of gold for the incense before the Ark of the Testimony, and put the hanging of the door to the Tabernacle.

6. And you shall set the altar of the burnt offering before the door of the Tabernacle of the Tent of Meeting.

7. And you shall set the laver between the Tent of Meeting and the altar, and shall put water in it.

8. And you shall set up the courtyard around it, and hang up the hanging at the courtyard gate.

9. And you shall take the oil of anointing, and anoint the Tabernacle, and all that is in it, and shall hallow it, and all the articles of it: and it shall become Holy.

10. And you shall anoint the altar of the burnt offering, and all its articles, and sanctify the altar: and it shall become an altar most holy.

11. And you shall anoint the laver and its base, and sanctify it.



12. And you shall bring Aharon and his sons to the door of the Tent of Meeting, and wash them with water.

13. And you shall put the holy garments upon Aharon, and anoint him, and sanctify him; so that he may minister to Me as a priest.

14. And you shall bring his sons, and clothe them with coats:

15. and you shall anoint them, as you anointed their father, so that they may

minister to Me as priests: for their anointing shall surely be an everlasting priesthood throughout all their generations."

16. Thus did Mosheh: according to all that commanded Yahweh to him, so did he.

17. And it came to be in the first month of the second year, on the first day of the month, that the Tabernacle was raised up.

18. And raised up Mosheh the Tabernacle, and fastened its bases, and set up the boards of it, and put in the bars of it, and raised up its pillars.

19. And spread he abroad the Tent over the Tabernacle, and put the covering of the Tent upon it from above; as commanded Yahweh to Mosheh.

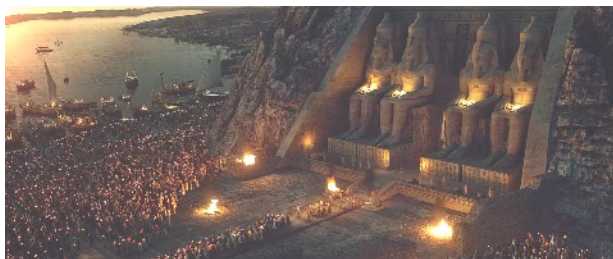
20. And he took and put the Testimony into the Ark, and set the poles on the Ark, and put the kaporeth upon the Ark from above:

21. And brought he the Ark into the Tabernacle, and set up the veil of the covering, and covered the Ark of the Testimony; as commanded Yahweh to Mosheh.

22. And put he the table in the Tent of Meeting, upon the north side of the Tabernacle, outside of the veil.

23. And set he the bread in order upon it in the Presence of Yahweh; as commanded Yahweh to Mosheh.

24. And put he the menorah in the Tent of Meeting, opposite the table, on the south side of the Tabernacle.



25. And lighted he the lamps in the Presence of Yahweh; as commanded Yahweh to Mosheh.

26. And put he the golden altar in the Tent of Meeting in front of the veil:

27. and burned he incense of spices upon it; as commanded Yahweh to Mosheh.

28. And set up he the hanging at the door of the Tabernacle.

29. And put he the altar of burnt offering by the door of the Tabernacle of the Tent of Meeting, and offered upon it the burnt offering and the grain offering; as commanded Yahweh to Mosheh.

30. And set he the laver between the Tent of Meeting and the altar, and put water there, to wash with.

31. And washed Mosheh and Aharon and his sons their hands and feet there:

32. When they went into the Tent of Meeting, and when they came near the altar, they washed; as commanded Yahweh to Mosheh.

33. And raised up he the courtyard around the Tabernacle and the altar, and set up the hanging of the courtyard gate. So finished Mosheh the work.

34. Then a cloud covered the Tent of Meeting, and the Glory of Yahweh filled the Tabernacle.

35. And Mosheh was not able to enter into the Tent of Meeting, because the cloud abode on it, and the Glory of Yahweh filled the Tabernacle.

36. And when the cloud was taken up from over the Tabernacle, the children of Yisrael went onward in all their journeys:

37. but if the cloud was not taken up, then they did not journey until the day when it was taken up,

38. because the cloud of Yahweh was upon the Tabernacle by day, and fire was upon it by night, in the sight of all the House of Yisrael, throughout all their journeys.

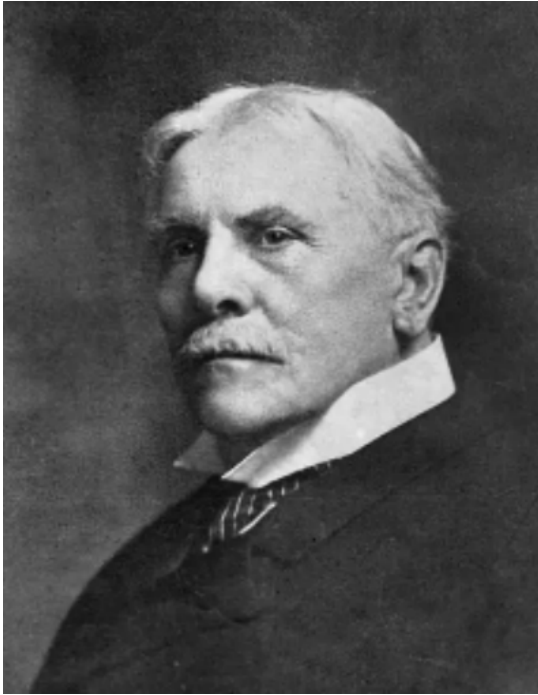

Why I Left Scofieldism (Part 3)

Iv. Scofield Mishandles Many Clear Verses of Scripture

IN 2 CORINTHIANS 4:2 Paul prided himself on walking without craftiness and on not handling the Word of God deceitfully. Unfortunately, this claim could not be made for Dr. Scofield.

For he posits his teachings on craftily manufactured premises, then handles the Word deceitfully in order, to support these premises. Lest this statement seem too harsh, let us look at only a few of the plain scriptures on which he places interpretations altogether contrary to their obvious meaning.

Let us begin with Acts 15:16, since this verse is said by leading dispensationalists to be the most important verse of scripture in their entire school of thought (p. 1169, SRB.). Scofield interprets James as saying that, after the time that James was speaking,

God would return and rebuild the tabernacle of David. Actually, Acts 15:16 is a quotation from Amos 9:11, and the words are those of Amos, not those of James. So that the "after this" refers to a time following Amos's time, not to a time subsequent to James. In fact, James says (read the entire context) that Amos's prophecy was

fulfilled when Cornelius' household (Gentiles) were added to the church. If this be spiritualising then the blame must be placed on James, who spoke under the inspiration of the Holy Spirit. And James definitely disagrees with Scofield on this interpretation.

On page 1015, note 2, Scofield says: "The parable of the wheat and tares is not a description of the world, . . ." Verse 38 of this passage which the footnote is interpreting says, "The field is the world." Here we have the words of Jesus versus the words of C. I. Scofield!

On page 1036, note 1, one reads that the judgment of Matthew is to be distinguished from the judgment of the great white throne. One of the "proofs" of this is that "three classes are present, sheep, goats, brethren...."

These 'brethren' are the Jewish Remnant who will have preached the Gospel of the kingdom to all nations during the tribulation." What saith the scripture?

In Matthew 12:48-50 our Lord asked a question and also gave the answer to it. "... and who are my brethren? . . . whosoever shall do the will of my Father which is in heaven, the same is my brother, and sister, and mother." Jesus' own words would make the brethren of Matthew synonymous with the sheep of that same passage.

This would give, not three, but two groups of people at the judgment of Matthew 25 - the same two groups present in Revelation 20:11-15. Acts 1:15 and Hebrews 2:11,12 also refer to Christians as the brethren of Christ.

On page 1023, note 1, Scofield says: "Christ confirms the specific and still unfulfilled prophecy of Mal. 4:5,6: 'Elias shall truly first come and restore all things.' "

He goes on to speak of "that yet to be fulfilled in Elijah." Here again, Scofield is daring to contradict the words of Christ himself. Jesus said: "But I say unto you. That Elias is indeed come, and they have done unto him whatsoever they listed, as it is written of him" (Mark 9:13, italics mine). Is any further comment necessary

here? Scofield assigns Zechariah 12:10 ("they shall look on him whom they have pierced") to a time following the tribulation and says it teaches that national Israelites will accept Christ at a future date. John says explicitly that this prophecy was fulfilled when the spear pierced Jesus' side on the cross at Calvary (John 19:34-37).



On page 1115, note 2, these words appear: "As a dispensation, grace begins with the death and resurrection of Christ (Rom. 3:24-26; 4:24,25). The point of testing is no longer legal obedience as the condition of salvation, but acceptance or rejection of Christ, with good works as a fruit of salvation. . . ."

And on page 1011, note 2, he speaks on this same subject. "The new message of Jesus. The rejected King now turns from the rejecting nation and offers, not the kingdom, but rest and service to such in the nation as are conscious of need. It is a pivotal point in the ministry of Jesus."

Here Scofield lays himself open to the charge levelled against him, i.e., that he has more than one plan of salvation in his system. Note his words, "no longer legal obedience as the condition of salvation." He plainly implies that:

- (1) before Christ came, people were saved by good works (legal obedience);
- (2) now that Jesus has come, they are saved through Christ; and
- (3) good works now are a fruit of salvation, whereas before they were the means of salvation.

And if Jesus offered people one thing in his "old" message while offering something else in his "new" message, what other conclusion can be

drawn except that he offered two plans of righteousness?

That thinking people have taken dispensationalism to present various means of salvation is evident in the report adopted by the Southern Presbyterian Church in the United States. That report, adopted by this assembly in May, 1944, was in part as follows:

It is the unanimous opinion of your Committee that Dispensationalism is out of accord with the system of doctrines set forth in the Confession of Faith, not primarily or simply in the field of eschatology, but because it attacks the very heart of the theology of our Church.

Dispensationalism rejects the doctrine that God has, since the Fall, but one plan of salvation for all mankind and affirms that God has been through the ages administering various and diverse plans of salvation for various groups. . .

Conclusion

Many other discrepancies could be pointed to in Scofieldism. However, to discredit any of the points dealt with above is to bring his entire system into serious question, since these are pivotal dogmas. It has not been the intention of this writer to discredit a person, but to challenge unscriptural teachings put forth by a person. This pamphlet is sent forth in Christian love for all the household of faith, and with the prayer that it might lead many to a "more excellent way" of handling the Word of God.

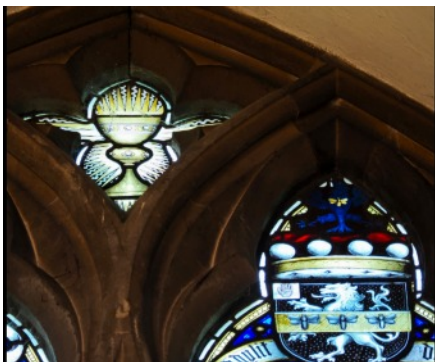

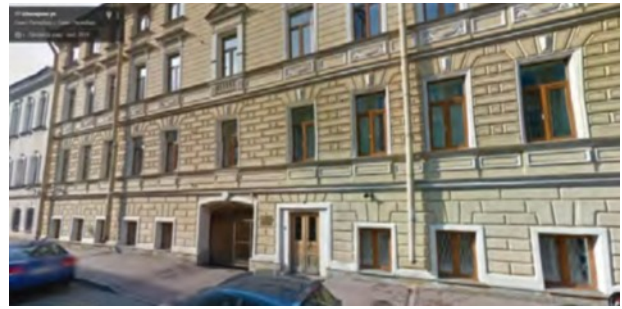

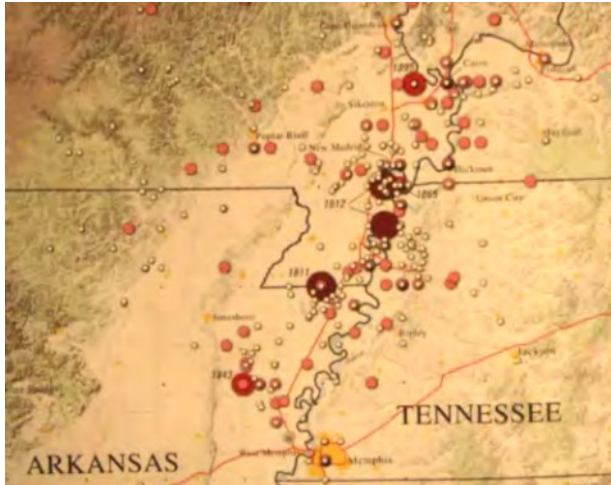

From December 16, 1811, through March of 1812 there were **over 2,000 earthquakes in the central Midwest, and between 6,000-10,000 earthquakes in the Boot heel of Missouri where New Madrid is located** near the junction of the Ohio and Mississippi Rivers.

In the known history of the world, no other earthquakes have lasted so long and resulted in so much damage as the New Madrid earthquakes.



A Sequence of Three Main Shocks in 1811-1812 (above) of three very large earthquakes is usually referred to as the New Madrid earthquakes, after the Missouri town that was the largest settlement on the Mississippi River between St. Louis, Missouri and Natchez, Mississippi.

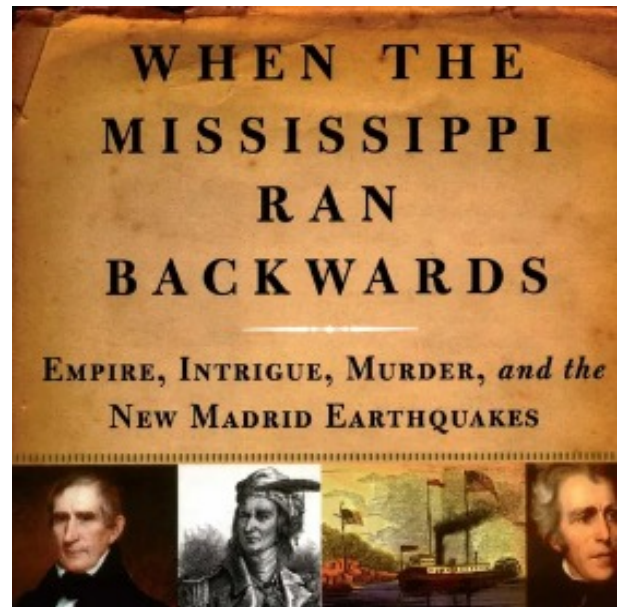
On the basis of the large area of damage (600,000 square kilometers), the widespread area

of perceptibility (5,000,000 square kilometers), and the complex physiographic changes that occurred, **the New Madrid earthquakes of 1811-1812 rank as some of the largest in the United States since its settlement by Europeans.**

They were by far the largest east of the Rocky Mountains in the U.S. and Canada. The area of strong shaking associated with these shocks is two to three times as large as that of the 1964 Alaska earthquake and **10 times as large as that of the 1906 San Francisco earthquake.**

The New Madrid earthquakes were felt as far away as Canada and the eastern seaboard, *the tremors caused church bells to ring in Boston and Philadelphia*, the earth's surface remained in a state of constant motion for nearly four months, several towns were destroyed, an 18 by 5 mile lake was created (Reelfoot Lake in Tennessee). The earthquakes felt strongly across 130,000 square miles and moderately for a total of nearly 3sq million miles. The effect was devastating and widespread.

The upheaval was so violent it created Reelfoot Lake fifteen miles south of New Madrid and drowned the inhabitants of an entire Indian village along the Mississippi.



The river amazingly “ran backward” for several hours, which may have been a tsunami-like event exacerbated by the eruption of groundwater for miles along the shore, which caused a rapid rise of the water level in the riverbed.

The earthquakes were felt as far away as the White House, and it's said that church bells in Boston rang on their own. Shortly before the first earthquake, people reported strange behaviour by animals.

Many animals were nervous and frightened. Domestic animals became wild, and wild animals became tame. Snakes came out of the ground from hibernation. Flocks of ducks and geese landed near people.

Tecumseh's Comet



In 1811, a great bright comet appeared in the skies. It was visible the naked eye for around 260 days. In the USA, the comet was named Tecumseh's Comet and the Europeans called it "Napoleon's Comet".

The last time the comet had been witnessed was during the reign of Egyptian Pharaoh Ramses II, 3,065 years before. The arrival of the Tecumseh's comet was followed by the New Madrid earthquakes, the biggest earthquakes in American history, events that are linked to the Black Sun prophecy.



Tecumseh (above) was an important Native American mystic, warrior and military leader of the Shawnee. He is today remembered as a great hero who fought for freedom. His name

ominously meant "Shooting Star" or "He who walks across the sky."

Tecumseh's brother, who was a religious leader, known as "The Prophet," had predicted a solar eclipse in 1806. William Henry Harrison, governor of Indiana was worried the Prophet was becoming too popular and challenged him to produce a miracle. The Prophet announced another solar eclipse occur and so it did, on September 17, 1811.

The Island of California

Written in the 16th Century romance novel by a Spanish author named Garcia Ordonez de Montalvo. It was titled, “*Las Sergas del muy esforzado caballero Esplandian, hijo del excelente rey Amadis de Gaula,*”

The inspiration for the word was likely “Khalif” or “Khalifa” which means “successor” in Arabic but more specifically refers in Islam to a head of state or leader of the Muslims.

Montalvo was surely familiar with these words. Portions of Spain were ruled by the Moors (Tartarians!), Who were Muslim, from 757 to 1492. And it fits the story’s narrative. Montalvo’s novel was a fanciful rehash of the struggle between Christians and Muslims during the crusades.

Was Wonder Woman Mythology Really Queen Calafia’s Lands?

When Wonder Woman’s homeland is first introduced in 1941, it is referred to as **Paradise**

Island, a secret and hidden island on Earth inhabited by the Amazons of myth. The Amazons were given a break from the hostilities and temptations of Man’s World, and so were decreed to start a new life improving themselves by sequestering themselves to this island away from ancient Greece, after being enslaved by Hercules.

With the island blessed by the Olympian Gods, no man was allowed to physically set foot on it. It was established that all

Amazons are adept at a discipline called “bullets and bracelets” in which they are able to deflect bullets fired at them using the chain bands on their wrists.

It was originally implied, but not yet fully confirmed, that Paradise Island was located somewhere in the Pacific Ocean. Then in the 1970’s television incarnation (as portrayed by Lynda Carter), Paradise Island’s location was set in the Bermuda Triangle. And the 2009 animated movie version had set it in the Aegean Sea.

For centuries, the Amazons of Themyscira live in a perfect state of harmony with their surroundings, under a theocracy. They know no racism, although many consider Antiope’s Lost Tribe of Amazons as little more than savages.

They do not think in terms of male gender; the word “policeman” is alien to them until Diana’s departure into the outside world.

Homosexuality is completely natural to them — while some Amazons are chaste, others have loving consorts.

Their city is composed entirely of Greco-Roman architecture from 1200 BC, and they wear Greek garb, togas, sandals, and period armour.

They are fervently religious, worshipping their gods as living deities. Artemis is their primary goddess, and they worship her with a sacrifice of a deer.

The Amazons also all wear the Bracelets of Submission as constant reminders of their Enslavement and obedience to their patrons, although only Diana is able to deflect bullets with them.

The Amazons celebrate their creation each year in a Feast of Five, remembering the goddesses who brought them to life.

**The Invisible Rainbow
You Mean You Can Hear Electricity? (Part 4)

IN 1970, MICHAEL S. HOSHIKO, UNDER A POST-DOCTORAL FELLOWSHIP from the National Institutes of Health, tested the device of Puharich and Lawrence at the Neuro communications Laboratory at The Johns Hopkins University's School of Medicine (above).

Subjects not only heard pure tones from 30 Hz up to the remarkable frequency of 20,000 Hz equally well at low sound levels, but scored 94 percent in speech discrimination.

The twenty-nine college students who were tested performed equally well whether the words were delivered through the air as ordinary sounds, or whether they were delivered electronically as modulations to a radio wave in the ultrasonic range.

Two more efforts to make people hear modulated radio waves were made by members of the military, but probably because they did not use ultrasonic frequencies they were unable to identify any cause of hearing besides the vibrating

skin. One of the reports, a master's thesis submitted by Lieutenants William Harvey and James Hamilton to the Air Force Institute of Technology at Wright-Patterson Air Force Base, specified a carrier frequency of 3.5 MHz.

The other project was undertaken by M. Salmonsohn, Command and Control Division at the Naval Air Development Center in Johnsville, Pennsylvania. He also did not use an ultrasonic carrier, in fact he later dispensed with the carrier wave altogether and used direct audio-frequency current.



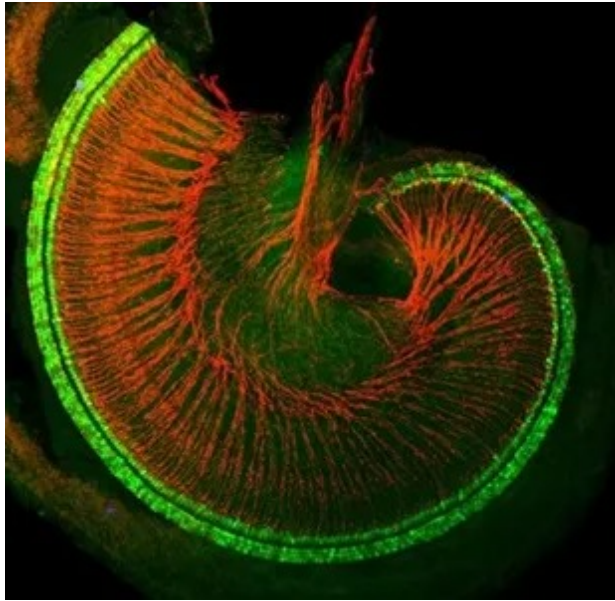

Finally, in 1971, Patrick Woodruff Johnson, for his master's thesis at the Naval Postgraduate School, decided to revisit "ordinary" electro- phonic hearing.

He wanted to see how little electricity it took to make people hear a sound. Most previous researchers had exposed their subjects' heads to up to one watt of power, resulting in large and potentially dangerous levels of AC current.

Johnson found that by using a silver disc plated with silver chloride as one of the electrodes, and simultaneously applying a positive direct current, an alternating current of as little as 2 micro amperes (millionths of an ampere), delivered with only 2 microwatts (millionths of a watt) of power, could be heard.

Johnson proposed that “an extremely small low cost hearing aid” could be developed using this system.



A Cochlea

In June 1971, at M.I.T., Edwin Charles Moxon reviewed the entire field for his Ph.D. dissertation and added the results of his own experiments on cats. By recording the activity of the cats’ auditory nerves while their cochleas were electrically stimulated, he proved definitely that two distinct phenomena were occurring at the same time.

The electrical signal was somehow being converted into ordinary sound, which was being processed by the cochlea in the normal way. And in addition, the current itself was stimulating the auditory nerve directly, producing a second, abnormal component of the discharge pattern of the nerve.

At this point efforts at understanding how electricity affects the normal ear ceased, as practically all funding was diverted to the development of cochlear implants for the deaf. This was a natural outcome of the development of computers, which were beginning to transform our world. The brain was being modelled as a

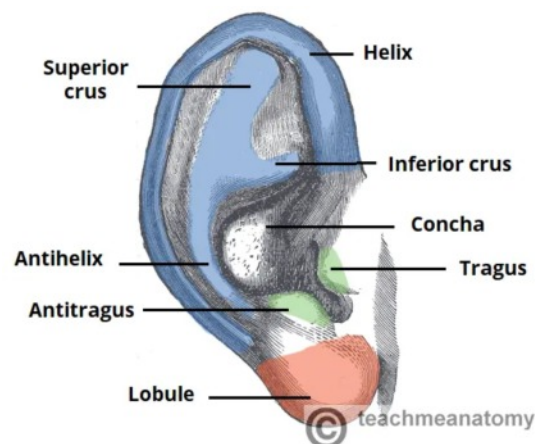
fantastically elaborate digital computer. Hearing researchers thought that if they separated sounds into their different frequency components, they could feed those components in digital pulses to the appropriate fibres of the auditory nerve for direct processing by the brain.

And, considering they are stimulating thirty thousand nerve fibres with only eight to twenty electrodes, they have been remarkably successful. By 2017, the number of cochlear implants worldwide exceeded five hundred thousand. But the results are robotic and do not duplicate normal sound.

Most patients can learn to understand carefully articulated speech well enough to use the telephone in a quiet room. But they cannot distinguish voices, recognize music, or converse in average noisy environments.

Meanwhile, progress in understanding electro- phonic hearing came to a complete halt. Some research into microwave hearing continued for another decade or so, and then ceased as well. The peak power levels that appear to be required for microwave hearing make it unlikely to be the source of sounds that bother most people today.

The phenomenon discovered by Puharich and Lawrence is a much more likely candidate. To understand why requires an excursion into the anatomy of one of the most complex and least understood parts of the body.



In the normal ear, the ear drum receives sound and passes the vibrations on to three tiny bones in the middle ear. They are the malleus, incus, and stapes (hammer, anvil, and stirrup), named after the implements they resemble. The stapes, the last bone in the chain, although only half the size of a grain of rice, funnels the world of

vibrational sound to the bony cochlea, a snail-shaped structure which itself is a marvel of miniaturization. No bigger than a hazelnut, the cochlea is able to take the roar of a lion, the song of a nightingale, and the squeak of a mouse, and reproduce them all with perfect fidelity in the form of electrical signals sent to the brain.

To this day no one knows exactly how this is accomplished. And what little is known is probably wrong.



“It is unfortunate,” wrote Augustus Pohlman, an anatomy professor (above) and dean of the school of medicine at the University of South Dakota, “that no machinery is available for deleting from the literature those interpretations which have proven to be incorrect.”

Pohlman stood, in 1933, looking back on seventy years of research that had failed to eradicate what he regarded as a fundamentally flawed assumption about the operation of the liquid-filled cochlea. Another eighty years have still failed to eradicate it.



The tiny cochlear spiral is divided along its length into an upper and lower chamber by a partition called the basilar membrane. Upon this membrane sits the organ of Corti, containing thousands of hair cells with their attached nerve fibres.

And in 1863, the great German physicist Hermann Helmholtz (above) had proposed that the cochlea was a sort of an underwater piano, and suggested that the ear’s resonant “strings” were the different length fibres of the basilar membrane. The membrane increases in width as it winds round the cochlea. The longest fibres at

the apex, he suggested, like the long bass strings of a piano, resonate with the deepest tones, while the shortest fibres at the base are set into vibration by the highest tones.

Helmholtz assumed that the transmission of sound was a simple matter of mechanics and levers, and subsequent research, for one and a half centuries, has simply built upon his original theory with remarkably little change.

According to this model, the motion of the stapes, like a tiny piston, pumps the fluid in the two compartments of the cochlea back and forth, causing the membrane separating them to flex up and down, thereby stimulating the hair cells on top of it to send nerve impulses to the brain.

Only those parts of the membrane that are tuned to the incoming sounds flex, and only those hair cells sitting on those parts send signals to the brain.



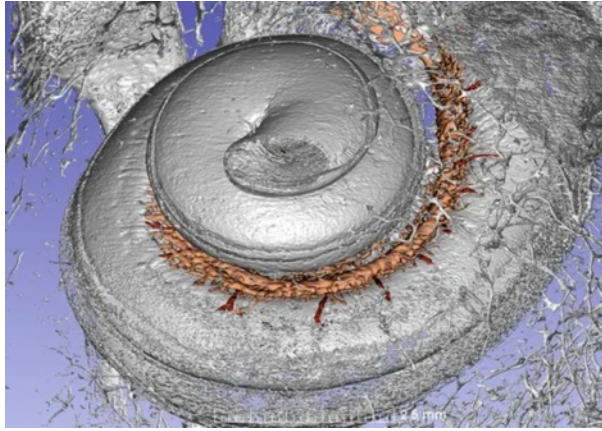
Close-up of The Inner Ear

But this model does not explain the hearing of electricity. It also fails to explain some of the most obvious features of the inner ear. Why, for example, is the cochlea shaped like a snail shell? Why are the thousands of hair cells lined up in four perfectly spaced rows, one behind the other like the keyboards of a pipe organ?

Why is the cochlea encased in the hardest bone of the human body, the otic capsule? Why is the cochlea the precise size that it is, fully formed in the womb at six months of gestation, never to grow any larger?

Why is the cochlea only marginally bigger in a whale than in a mouse? How is it possible to fit a full set of resonators, vibrating over a greater

musical range than the largest pipe organ, into a space no bigger than the tip of your little finger? Pohlman thought that the standard model of the ear was contradicted by modern physics, and a number of courageous scientists after him have agreed.



Blood Supply of The Human Cochlea

By including electricity in their model of hearing, they have made progress in explaining the basic features of the ear. But they are up against a cultural barrier, which still does not permit electricity to play a fundamental role in biology.

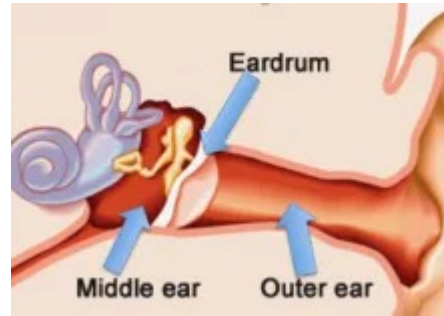
The ear is much too sensitive to work by a system of mechanics and levers, and Pohlman was the first to point out this obvious fact. The real resonators in the ear—the “piano strings”—had to be the thousands of hair cells, lined up in rows and graded in size from bottom to top of the cochlea, and not the fibres of the membrane they were sitting on.

And the hair cells had to be pressure sensors, not motion detectors. The extreme sensitivity of the ear made that evident. This also explained why the cochlea is embedded in the densest bone in the human body. It is a soundproof chamber, and the function of the ear is to transmit sound, not motion, to the delicate hair cells.

The next scientist to add pieces to the puzzle was an English physician and biochemist, Lionel Naftalin, who passed away in March 2011 at the age of 96 after working on the problem for half a century.

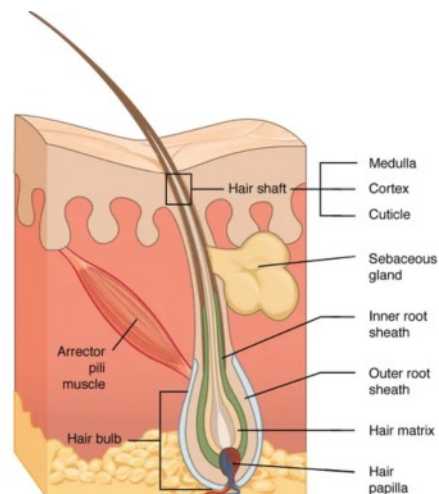
He began by making precise calculations that proved conclusively that the ear is much too sensitive to work in the accepted fashion. It is a known fact that the quietest sound that a person

can hear has an energy of less than 10 a watts (one ten-thousandth of one trillionth of a watt) per square centimeter, which, calculated Naftalin, produces a pressure on the eardrum that is only slightly greater than the pressure exerted by randomly moving air molecules.



Naftalin stated flatly that the accepted theory of hearing was impossible. Such tiny energies could not move the basilar membrane. They could not even move the bones of the middle ear by the assumed lever mechanism.

The absurdity of the standard theory was obvious. At the threshold of hearing the eardrum is said to vibrate through a distance (0.1 ångstrom) that is only one tenth the diameter of a hydrogen atom. And the motion of the basilar membrane is calculated to be as small as ten trillionths of a centimeter—only slightly larger than the diameter of an atomic nucleus, and much smaller than the random motions of the molecules that make up the membrane.



A Hair and Root

This “movement” of subatomic dimensions supposedly causes the hairs on the hair cells to “bend, triggering an electric depolarisation of the hair cells and the firing of the attached nerve fibres.

Recently some scientists, realizing the foolishness of such a notion, have introduced various ad hoc assumptions that increase the distance the basilar membrane must move from subatomic to only atomic dimensions—which still doesn't overcome the fundamental problem.

Naftalin pointed out that the contents of the cochlea are not solid metal objects but liquids, gels, and flexible membranes, and that such infinitesimal distances could have no basis in physical reality.

He then calculated that to move a resonant portion of the basilar membrane only one langstrom—about the distance now claimed necessary to trigger a response from the hair cells—would require over ten thousand times more energy than is contained in a threshold sound wave that hits the ear drum.

During his fifty years of work on hearing, Naftalin thoroughly demolished the prevailing mechanical theory and created a model in which electrical forces are central. Instead of focusing on the basilar membrane, on which the hair cells sit, he drew his attention to a much more unusual membrane—the one that covers the tops of the hair cells.

It has a jelly-like consistency and composition that occurs nowhere else in the human body. It also has unusual electrical properties, and a large voltage is always present across it.

Elsewhere in the body, voltages of this magnitude—about 100 to 120 millivolts—are usually found only across cell membranes.

5. Joseph of Arimathea



JOSEPH OF ARIMATHEA LED THE HOLY FAMILY from Jerusalem into Western Britain in AD 37 “the last year of Tiberius” In Wales he was known as St Ilid. He

had a principal site at Trefran –Manor of Bran, and traditionally he was the chaplain of the young Bran who was a great-nephew of King Caradoc I who was in Rome from AD 51, and a son of Caradoc II. This is a Church of St Ilid alongside Trefran and also a very ancient religious Cor.

A Cor is a large circular mound with a hollow centre where the congregation sat around the sloping inside in a circle and the speaker addressed them from a flat platform. These Cors appear to have been the original religious meeting places.

The British owned Brittany and Amoric (Normandy) since before the time of Julius Caesar. Magnus Maximus gave these territories to Conan Meriadauc as King in AD 383 and they remained British overseas territories and a buffer state against foreign invasions until AD 952 when the French King allied with the Northmen to seize and create Normandy.

The tomb of king Conan still exists. There were therefore ancient religious Cors in what became

Normandy. The English archaeologists playing their usual role of the circus clowns now see the ancient religious Cors of both Normandy and Wales as Norman creations, which they are not.

This means that all ancient pottery and other remains are classed as being Norman, and the result is that Wales and the Welsh are now the only nation on Planet Earth who could not make a piece of pottery and everything ancient is misdated to the Norman era in Wales that never actually existed beyond an 8 to 10 mile coastal strip in Glamorgan. The grave of Joseph of Arimathea was described by the Sixth century Maelgwn of Llandaff, and Llandaff Cathedral stands on the West bank of the river Taff a mile north of Cardiff Castle (above) on the East side of the river. Around 1/3rd of a mile south of Llandaff Cathedral the river Taff divided and split into two and then rejoined into one stream immediately south of the Castle, and so an island was formed “enclosed by water on all sides”.

This is the exact description written by the Maelgwn of Llandaff who was almost certainly a brother of King Meurig the father of King Arthur II, when describing the place of the grave of Joseph of Arimathea. The grave is described by Maelgwn as being in the southern bifurcated angle of the Church. There was a mediaeval

Black Friars abbey on this river island and there is a very ancient tomb in the Southern bifurcated angle of the church.

There is a strange tomb like slab at the foot of the altar that has a long inscription made of bronze letters set into the stone. This appears to commemorate the Bishop of Bethlehem, and records several visits made to this place by King Edward II of England. Llandaff Cathedral is recorded as being founded by King Lleirwg-Luke, and another Llan-Lleirwg church now called St Mellons was on the East side of the city.

In Mediaeval times there was this Black Friars abbey church just 100 yards west of Cardiff Castle and a Grey Friars Abbey 150 yards to the west and a small White Friars abbey was 100

yards to the south. In addition there was as large St John's church around 80 yards to the south east and a large St Mary's church about 240 yards to the south of the castle. The whole place was peppered with religious institutions.

In addition King Lleirwg sent two relatives to Rome to talk to the Bishop of Rome about Roman secular Law, and they returned with two others. All four left churches in the Cardiff area at St Dyfan, St Fagan, St Medwy, and St Elfan. The total negativity displayed towards all this mass array of evidence is astonishing.

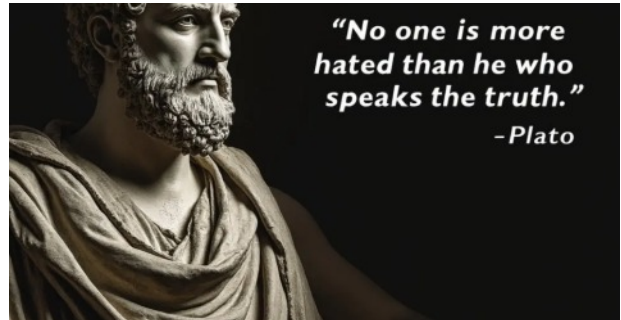

Evening Primrose as Food



Sir_, Evening primrose (*Oenothera biennis*) is a biennial and collecting the roots while it is still spring means you get sweet, succulent and somewhat fleshy root.

This plant grows a big root, some of them the width (and appearance) of a parsnip and once washed, you can eat them raw if you wanted to.

You can collect roots later in its growth but they won't be as fleshy as they are now.

The leaves of the second year plant can be used in any way you prepare greens in the kitchen, the roots can be eaten raw (in small quantities) or roasted, the flowers taste amazing so toss them into a salad and the seed pods while they are young can be roasted. Even young stems can be used in the kitchen to create some amazing meals.

The seeds are a great source of the amino acid tryptophan which our bodies convert into serotonin, the mood improving brain chemical. Lastly, the leaves are a great source of the bioflavonoid quercetin.

This keeps our blood vessels healthy, improves circulation and it can ease the effects of asthma. Native Americans used evening primrose for a variety of medicinal purposes.

The Ojibwa poulticed all parts of this plant for use on bruises. The Cherokee drank a tea made from the root to help lose weight. The Forest Potawatomi considered the seeds a valuable medicine, but records documenting its use have sadly been lost. European settlers started using the plant as medicine in the 1700's.

The Shakers used the leaves or roots externally to promote healing of wounds and a tea of the leaf and root to settle an upset stomach. ([Source](#))

Sir__, Calendula (*Calendula officinalis*) is a plant known as pot marigold. It is not the same as ornamental marigolds of the *Tagetes* genus grown in vegetable gardens. The dried petals of the calendula plant are used in tinctures, oint-

ments, and washes to treat burns, bruises, and cuts, as well as the minor infections the cause.

In colours of orange and yellow you can pick your calendula petals and put them fresh into salads which are soothing for the body, or dry them out to keep them longer.

Since Manasseh means literally "forgetfulness" it is not surprising that few Americans have any awareness of their heritage and their wonderful promise.

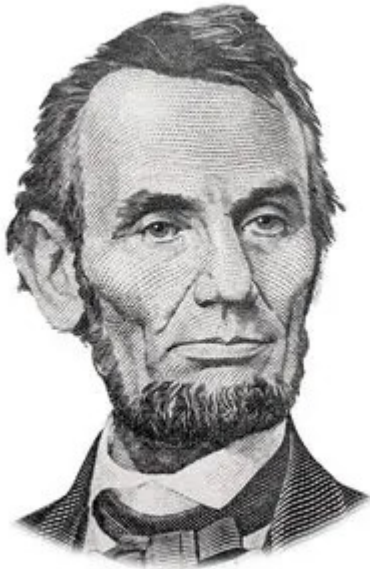

The disciples of Jesus were and are charged with responsibility to take that message to the scattered peoples of the “lost” house of Israel.

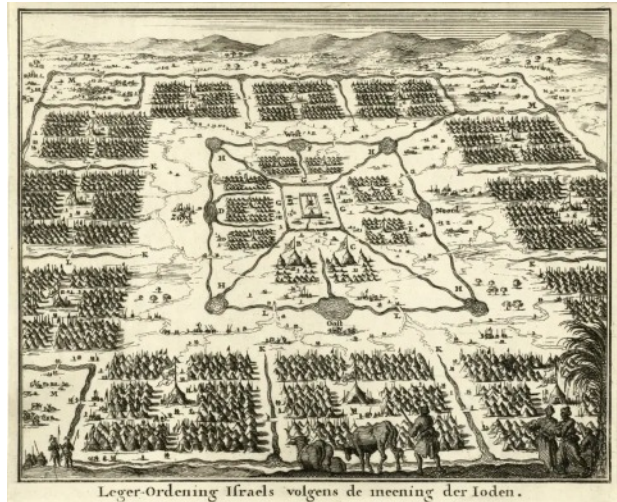
The white people of Europe and related nations around the globe are the unrecognised lost tribes of the house of Israel.

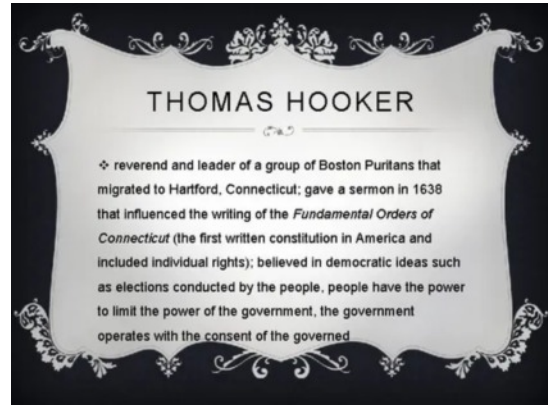
They saw this virgin land as the new Promised Land wherein they would be the New Jerusalem, the people who are the Temple of God.
