

"Therefore thou art inexcusable, O man, whosoever thou art that judgest: for wherein thou judgest another, thou condemnest thyself; for thou that judgest doeth these same things. But we are sure that the judgment of God is according to truth against them which commit such things."

Lest I be accused of "hate" or "anti-Semitism," it must be pointed out that a hatemonger prescribes violence or ostracism or ridicule whereas an analyst in the spirit of truth prescribes only understanding and the correction of evil practices. Hence, as a believer, I stand in fear of the judgment of Jesus Christ if I be unfair in the smallest detail of the criticism.

In keeping with my duty as a Christian and considering my assumption of the role of defender of the Faith, I in no small measure regard the responsibility of this role. I have weighed heavily whether I should appease the ostrich, who does not wish to be told he has been deceived, or be a watchman sounding the alarm

of the international effort to destroy Christianity and Christendom. The general method of this book is to document the history of the Jews along with the separate, distinct, and parallel history of the Tribes of Israel.

Along with the documentation of these historical distinctions, relevant ethical considerations are brought up which are germane to the history under discussion.

This will be the method up until the last two chapters, where the subject matter turns more toward ethics and prophecy, with a thorough discussion of Jewish ethics and tactics permeating these two chapters.



Such claims as "Judaism invented monotheism," "Jesus was a Jew," "The Jews are God's chosen people," and others will be examined in the light of Scripture and in the light of secular history.

What emerges from this study is a definite pattern of grandiose deceit and tribal self-worship trying to impose itself upon a resistant outside world. This primitive form of tribal self-worship, due to its nearly total insularity (separate language, separate food, customs, literature, art, etc.), has managed to survive into the modern world and even find its most fruitful soil in the age of democracy, an age which ideologically repudiates tribalism.

Yet, for reasons to be explained, Jewish tribalism is tolerated and even condoned by the most verbose democratic ideologues (hypocrites) of our time.

The reasons for the survival of this religious tribalism are numerous; and there is no end to the number of lessons to be learned from the study of its methods, both physical and

psychological, of insulating its adherents from the liberating influences of the outside world. It is this insularity—this rabbinical demand for tribal loyalty —which has kept Judaism alive down through the centuries in spite of its lack of a homeland.

Crucial to maintaining the rag-tag cohesiveness of the Jewish tribal society is its mythology. This mythology makes several claims about Jewishness besides that being "chosen" by God. This mythology centers around the Talmud and other "holy" books, which give the rabbi the psychological tools with which to corral his flock and fence them in while they are led to believe they are, in spite of their insular lifestyles, cultural and intellectual world leaders.



This is control by flattery; and it is extremely effective. By maintaining separate Jewish, courts of law, the *kehilla*, or the Jewish ruling clique, asserts punitive powers even unto the death of those who would resist it. The typical punishment for offending the Jewish ruling clique is ostracism, and for a person who looks, thinks, and acts Jewish, this is well-nigh a spiritual death sentence.



Old Testament "Word For Word" - Leviticus Chap. 1 - (Part 1) Translation By Stephen Howard Anderson



Introduction Wayiq'ra (Called) Commonly called Leviticus

AYYIQ'RA IS A BOOK OF LAWS and procedures for the Aharonic priests. Also here are many National laws for Yisrael, for health, sexual behavior, proper conduct towards each other, business dealings, conduct toward visiting Yisraeliy from other countries, conduct toward aliens of other races in Yisrael, holy days and feasts, food laws, and sacrificial laws.

The sacrifice for the propitiation (covering over) of sin has been eliminated by Yahshua Messiah. He made the last sacrifice of Himself, and animal sacrifice is no longer needed. The other laws that do not have to do with sin sacrifice still stand, however, and they are all common sense laws. Heaven and earth have not passed away, yet.

Some words are unclear today as to the type of unclean animals. The meaning has been lost over time, and where this occurs, I will note it in the Chapter Notes following the chapter.

The term "leprosy" is used in connection with fabric, and houses. This was a mold or mildew

that was unhealthy to be around, such as toxic "black mold" in our time. This would cause severe health problems from breathing in the spores, and they had no other term to use back then, so they termed it "leprosy" for want of a better word. Leprosy concerning people, however, is actual flesh destroying leprosy, which then was incurable, and resulted in eventual death for those afflicted with it. Yahweh cured several people of it in Scripture, and this was always considered a major miracle. Even today, with modern drug treatments, leprosy is a true horror to cure.

Where "leprosy" is used in the KJV and others, but actually refers to some type of skin disease, I have used "skin disease" for accuracy.

As in the first two books of Mosheh, proper names of people and places are as in the Hebrew for spelling. Strong's Numbers will be used after key words a single time.

Chapter notes will be small in this book, as a lot of it is fulfilled sacrificial stuff. I will note the verses where laws still stand, and why. There is quite a bit of this in here, so read the Chapter notes carefully.

Please note - All words spoken by Yahweh and His messengers will be in **bold** type.

- 3. If his offering is a <u>burnt sacrifice</u> 5930 of the herd, let him offer a male without blemish 8549: he shall bring it for acceptance 7522 to the door of the Tent of Meeting before Yahweh.
- 4. And he shall put his hand upon the head of the burnt offering, and it shall be accepted 7521 for him to make propitiation 3722 for him.
- 5. And he shall slaughter 7819 the calf 1121/1241 in the presence of Yahweh: and the priests 3548, sons of Aharon, shall bring the blood 1818, and sprinkle 2536 the blood round about the altar that is by the door of the Tent of Meeting.
- 6. And he shall flay 6584 the burnt offering, and cut it into pieces.
- 7. And the sons of Aharon the priest shall put fire upon the altar, and lay the wood in order upon the fire:
- 8. And the priests, sons of Aharon, shall lay 16. and he shall remove 5493 its crop 4760

- the pieces, the head 7218, and the fat 6309, in order upon the wood that is on the fire, which is upon the altar.
- 9. But its inner organs 7130 and its lower legs 3767 he shall wash 7364 in water: and the priest shall burn 6999 all on the altar, a burnt sacrifice, an offering made by fire 801, of a pleasing odor 7381 to Yahweh.
- 10. And if his offering be of the flocks, of the young sheep 3775, or of the young goats 5795 for a burnt sacrifice; he shall bring a male 2145 without blemish,
- 11. and he shall slaughter it on the north side of the altar before Yahweh: and the priests, sons of Aharon, shall sprinkle its blood round about upon the altar.
- 12. And he shall cut it into pieces, with its head and its fat: and the priest shall lay them in order on the wood that is on the fire which is upon the altar:
- 13. But he shall wash the inner organs and the lower legs with water: and the priest shall bring all, and burn upon the altar: it is a burnt sacrifice, an offering made by fire, of a pleasing odor to Yahweh.
- 14. And if the burnt sacrifice for his offering to Yahweh be of birds 5775, then shall he bring an offering of turtledoves 8449, or of young pigeons 3123.



- 15. And the priest shall bring it to the altar, and wring off 4454 its head, and burn it on the altar; and the blood of it shall be wrung out 4680 at the side of the altar:

with its feathers 5133, and cast it beside the carries through for all blood sacrifices. Yahshua altar, on the east part 6924, by the place of Messiah was without blemish, as was required, the ashes 1880:

In verses 3 and 10 we see the stipulation of a Male without Blemish for the sacrifice. This

After that point, if we continue in sin, there is no further sacrifice for us. All animal sacrifices have been rendered of no effect, and are of historical significance only now.


The spectacularly brutal life and reign of Medieval Pictish King Oengus map Fergus (686 AD - 761 AD), the first monarch to unite the Picts and Scots under one ruler. The man who devised the plan to create one realm under God whose Patron Saint was Saint Andrew.

His controversial life is revealed here via serialised extracts from the book 'Destiny of the Picts' A narrative reconstruction of real historical events, people and places, only in some rare cases have the names of female participants been added, and battle tactics based upon historical examples included, to give gravitas to these otherwise unidentified historical figures.

What you read next will provoke controversy, however I have simply followed the evidence to its logical conclusions. I'll leave you to make up your own mind.

Origins of Clan Fegus (Uurguis)!

Prince Fergus ap Beli was the son of Beli ap Neithon, the King of Alt Clut and a Northumbrian Princess Ædwen Ædwinsdohtar. He was brother to Prince Eugein ap Beli, Lady Der-Ilei ferch Beli, Dumnagual ap Beli, Guret ap Beli, and King Brude ap Beli, King of the Picts. Fergus's first wife was Princess Brigid ferch Feredach, from House Cenél Loairn of Dal Riata.



Feirbe ferch Erp was sister of Cano ferch Erp and was the aunt of King Nechtan ap Cano the grandson of Erp who was king of the Picts from 595 to around 616.

Brigid ferch Forth's parents were King Foith / mastering the intricate arts of statecraft in the Gwid ap Brude of Circinn and Bebba ferch Erp convoluted world of Pictish politics. who was the sister of Feirbe and Cano.

It was after his brother, King Brude, conquered Circinn, that Fergus became the King of Circinn. Together Fergus and Brigid had several children including; Oengus, Talorgan and Ninian.



After Queen Brigid ferch Feredach had died King Fergus map Beli married the much younger Lady Cano ferch Nechtan, the daughter of his nephew, Prince Nechtan map Der-Ilei. The Cenél Loairn of Dal Riata were the descendants of Loarn mac Eirc.


At the height of their power, the clan ruled northern Argyle around the Firth of Lorne, and the islands of Mull and Colonsay, Morvern and Ardnamurchan. The clan's territorial boundary with the Picts ran along the Druim Alban mountain ridge that separated Dál Riata from Pictland.

The major seats of power for the clan were Dun Ollaigh, near Oban and the seat of Dal Riata's power, Dun Ad near Crina. Prince Oengus born in 686 AD had five brothers; Talorgan, Nechtan, Ninian, Drustan, Brude, and an unknown number of sisters.

Living in the north with their family in 693 Princes Oengus and Talorgan were sent south to Dun Nechtan (Dunnichen Hill) to live with their cousin Prince Nechtan ferch Der-Ilei in fosterage. It was to be under his tutelage that they would learn the arts of being a warrior, becoming devout Christians, and most importantly

Within weeks of their arrival, the boys were riding into exile alongside the families and retainers of the proscribed princes Brude and Nechtan map Der-Ilei. In that same year, Taran mac Feredach Anferthwch was crowned King of Pictland at Tap O' Noth, instead of Prince Brude map Der-Ilei.

Fearing capture or assassination the elder sons of Queen Der-Ilei, Brude and Nechtan, relocated to the relative safety of Cowal to plan their next moves. With Nechtan went Oengus and Talorgan as members of Nechtan's court. In 694 Prince Ferchar mac Feredach (Ferchar the Tall), their uncle, seized the throne of Dal Riata for the Cenél Loairn.

He was assisted in his aims by Pictish Princes Brude and Nechtan mac Der-Ilei. Brude's and Nechtan's time in exile had not been wasted. Safely ensconced in Cowal they had gathered allies opposed to the harsh rule of King Taran mac Feredach.

Many were the ordinary folk who hated the Irish usurper and eagerly provided valuable intelligence about his troop numbers and movements, most telling Cruithne allies came the nobles in the High King's court who were throne.

From Cowal, the princes secretly journeyed north to rally support amongst the nobles of Fortriu, Ce', Fib, Fidach and Circinn. The death of High King Fínsnechta Fledach seriously crippled King Taran's financial and military resources and he was forced to rely increasingly upon his Irish mercenaries to uphold his right to rule.

The princes, Oengus and Talorgan mac Fergus continued to serve Prince Nechtan map Der-Ilei, working as pages in his brother's court. At the end of 695, Brude and Nechtan secretly returned from Dal Riata with an army of supporters, and then openly took up residence at Dun Nhydwyr (Dunnideer), eyeballing King Taran at his winter residence of Tap O' Noth, just across the valley.

By the time the princes arrived at the base of Tap O'Noth, the only people left within the fortress were King Taran, his household, immediate family, and a war band of Irish mercenaries from Southern Ui'Niell.

> With Rhi Nhy fully occupied and the king's hill fort completely surrounded it was a matter of weeks before Taran mac Feredach capitulated. After surrendering, the deposed King Taran, his life saved by a direct appeal from Lady Der-Ilei to spare his life, was forced to sail back to Ireland.



> In 1550 and 1556, the name appears three times in reports about Cortés written by Giovanni Battista Ramusio. Thus, over the years of increasing conquest, colonization and rape of the land of California, the ancient land of the Moors has held onto its name and identity, in the knowledge that one day, it will be as it was in the beginning. There are over 800 maps of California as an island up until the early 1800's domiciled at the Stanford Research Library at Stanford University.

> And of course it is the Jesuits who claimed the whole "Island of California" is a myth. Although some early maps showed California on the mainland, a powerful refutation of the island theory came in 1701 when Jesuit explorer Eusebio Kino crossed the Baja peninsula and, with a telescope, saw that it was part of the continent.

> Over 250 maps from the 17th and 18th centuries show California as an island. The definitive catalogue of "California as an Island" maps is "The Mapping of California as an Island" by McLaughlin. The first map in McLaughlin's catalogue dates to 1621.



Island maps continued into the 1800's (above), in spite of Spanish explorer Father Kino demonstrating California's connectedness in 1705 by walking there from New Mexico. But since there were no accurate maps of the New World, map makers continued to supply the market using ancient sources.

Hapgood attributes the ancient sources to maps black Indians and red preserved in Constantinople and later distributed sources is shown by their all falling into categories according to the features on the map. For example, some show the California island with a flat top, others showing it with a "W" top.



McLaughlin assigns maps to groups throughout his catalogue according to features such as the shape of the top of the island. Since no explorers had mapped the California coast at that point, there was no way for map makers to know which source was right. As it turns out, both sources are right, they were just mapped at different times and different ocean levels.

Polk chronicles the extremely slow progress of exploration along the California coast for the next two centuries ("The Island of California, A History of the Myth", Dora Beale Polk).

She relates how Cortez mapped only the lower portion of the Gulf of California. Alarcon sailed up the Gulf to the Colorado River in 1540 and rowed up the river a long way but left no map.

The explorer Onate reached the mouth of the Colorado at the head of the Gulf in 1604, over a century after Columbus' voyage. (Polk p. 261) lin).

That there were only a limited number of original In the late 1500's, Spanish trade ships followed ocean currents from the far east to the area of Mendocino, where they turned south to Baja. But they would not venture near the coast and so provided only limited information on California geography. (Polk, p. 244)

> In 1603, on a voyage cloaked in secrecy and plagued with misfortune, Vizcaino explored the Pacific coast of California up to Cape Blanco, Oregon, where they presumed a large river was the sought-after passage to the Atlantic. (Polk, p. 257).

> In all these explorations, Polk emphasizes the political pressure on explorers and map makers to find that California was an island. It was in the best interest of people like Cortez that California be an island, because Cortez was promised governorship of the island.



The Island Coastline - Northern Portion

The Pacific coast has been pushed eastward about 200 miles. The area that was pushed eastward extends from the top of the island at the north, to Point Concepcion at the south. This section of the coastline bears no resemblance to today's coastline.

In the overlay map to the left the northeast corner of the island forms a point that is created by the mountain range ending at the Willamete National Forest east of Eugene.

The flat top follows the visible break in the coastal range just south of Eugene. Many "California as an Island" maps from the 1600's and the 1700's show the north end of the island as a distinct "M". McLaughlin categorizes maps by whether they have a "flat" or "indented" top throughout his catalogue of California as an island maps ("The Mapping of California as an Island, an Illustrated Checklist", Glen McLaughThe "M" was the result of later pushing up of the coastal and Cascade ranges around Portland.

The salt lakes east of the northeast corner are evidence that there was a lot of saltwater left there after the ocean receded.

South on the Pacific side from the flat island top, we find the coastline from the top of the island to Point Concepcion extends 200 miles farther out into the Pacific than it does today. Because the geography of the coastline is so different from the present day, the Vingboons map offers no points of alignment with modern landmarks.

Vingboons adorned this section of the coast with many names of features that could not have had any resemblance to what the early explorers saw, but rather assigned them the names given by the Spanish to the modern features found by the Spanish at that latitude.



What caused this 200-mile eastward movement of the coastline? While changing ocean level played a small part in the shape of the coast, the biggest cause was plate movement of the Pacific Sea floor.

Two significant rifts extend across the Pacific, starting at the Hawaiian Islands chain and meeting the continent at Eureka on the north end and Point Conception on the south, at Eureka by the Murray Fracture zone, and at Point Conception by the Mendocino Fracture zone.

These rifts do not stop at the Pacific coastline but rather continue to the east coast, the northern rift to New York, and the southern rift to the active earthquake zone of North Carolina.



These rifts gradually buckled the continent from east to west, starting during the Flood with the Appalachians.

A Midwest uplift buried under Mississippi river valley sediment was the location of the great earthquakes of 1811-1812. The Rockies were pushed up next, then the Wasatch range in Utah and last the folded ridges of Nevada. Finally, after the Vingboons map was made, the Sierra Nevada and California Coastal ranges were pushed up.

These two ridges do not appear on an otherwise extremely accurate map. I must assume they were not on the source maps because they did not yet exist. The formation of these last two ranges pushed the coastline of the map east by over 200 miles to where it is today.

The eastward shift can be seen in this map of California geology. "Older Metamorphic and sedimentary rocks" are dark blue. There is a sharp break in this rock between the Murray and Mendocino rifts. Formation of the Sierra Nevada range (below) pushed this block east about 50 miles.

The resulting snow melt flooded valleys, inundated or swept away towns, mills, dams, flumes, houses, fences, and domestic animals, and ruined fields. It has been described as the worst disaster ever to strike California.

The Invisible Rainbow You Mean You Can Hear Electricity? (Part 5) **Arthur Firstenburg**




N 1965, NAFTALIN, thinking in terms of solid state physics, postulated that this membrane called the tectorial membrane—is a semiconductor that is also piezoelectric.

Piezoelectric substances, we recall, are those that convert mechanical pressure into electrical voltages, and vice versa. Quartz crystals (left) are the most familiar example.

Often used in radio receivers, they convert electrical vibrations into sound vibrations. Judging by its structure and chemical composition, Naftalin suggested that the tectorial membrane ought to piezoelectric liquid crystal that converts sound waves into electrical signals, which it communicates to the hair cell resonators embedded in it.

He suggested that the large voltage across the membrane causes great amplification of these signals.

Naftalin then built scale models of both the cochlea and the tectorial membrane, and began to find answers to some of the outstanding mysteries of the ear. He discovered that the snail-like shape of the cochlea (below) is important to its function as a precision musical instrument.



He also discovered that the makeup of the tectorial membrane has something to do with the instrument's small size.

While the speed of sound in air is 330 meters per second, and in water is 1500 meters per second, in ten percent gela-

tin it is only 5 meters per second, and in the tectorial membrane it is likely to be considerably less.

By slowing the speed of sound, the jelly-like substance of the membrane contracts the wavelengths of sounds from meters to millimetres, allowing a millimetre-sized instrument like the cochlea to receive and play the world of sound we live in for our brain.

George Offutt came to this problem as a marine biologist, and reached similar conclusions from an evolutionary perspective. His doctoral dissertation at the University of Rhode Island's School of Oceanography dealt with codfish hearing.

His theory of human hearing, first published in 1970, was later expanded into a book, The Electro-model of the Auditory System. I interviewed him in early 2013, shortly before his death.

Like Naftalin, Offutt concluded that the tectorial membrane is a piezoelectric pressure sensor.

have this property. He proposed that it is a And because of his background, he argued that human hair cells, by evolution and by function, are electro-receptors.

The mammalian cochlea, after all, evolved from a fish organ called the lagena, which has hair cells not too unlike ours, covered by a gelatinous membrane, also similar to ours. But the fish's membrane is in turn topped by structures called otoliths ("ear stones"), which are crystals of calcium carbonate and are known to be about one hundred times more piezoelectric than quartz.

Offutt (above) said that this is not accidental. The hair cells in the ears of fish, he said, are sensitive to the voltages generated by the otoliths in response to sound pressure.

This, he said, explains why sharks can hear. Fish, being composed largely of water, are supposed to be transparent to water-borne sounds unless they have a swim bladder containing air.



Therefore sharks, which have no swim bladder, ought to be deaf according to standard theories, but they aren't. In 1974, Offutt elegantly solved his model for how fish hear. And by extension, he said, there is no reason why human hearing should not still work in the same basic fashion.

If the cochlea evolved from the lagena, then the tectorial membrane evolved from the otolithic membrane and ought still to be piezoelectric. And the hair cells, which are substantially the same, should still function as electro-receptors.



In fact, fish have other, related hair cells that are known to be electro-receptors. Lateral line organs, for example, arranged in lines along the sides of every fish's body in order to sense water currents, actually respond not only to water currents but also to low frequency sounds and to electric currents.


These organs' hair cells, too, are covered by a jellylike substance, called the cupula, and they, too, are supplied by a branch of the acoustic nerve. In fact, the lateral line and the inner ear are so closely related functionally, evolutionarily, and embryonically, that all such organs in all types of animals are referred to as the acousticolateralis system.

from this system, that are exquisitely and primarily sensitive to electrical currents. With these organs, sharks can detect the electric fields of other fish or animals, and can locate them in darkness, in murky water, or even when hidden in the sand or mud at the bottom.

The hair cells of these electric organs lie beneath the surface of the body in sacs called ampullae of Lorenzini and are covered, again, with a gelatinous substance.

All such fish organs, no matter their specialization, have proven to be sensitive to both pressure and electricity. Lateral line organs that primarily

this contradiction by introducing electricity into stimuli, and ampullae of Lorenzini that primarily sense electric currents also react to mechanical pressure.



Therefore marine biologists were once of the opinion that piezoelectricity was at play in both the lateral line and the ear. Hans Lissman, once the world's foremost authority on electric fishes, thought that this was so.





Some fish have other organs, which evolved Later, anatomist Muriel Ross, who had a grant from NASA to study the effects of weightlessness on the ear, emphasized that the otoliths of fish, and the related otoconia ("hair sand") of our own ears' gravity sensors, are known to be piezoelectric.

> Mechanical and electrical energy, she said, are interchangeable, and feedback between hair cells and piezoelectric membranes will transform one form of energy into the other.

In a related study in 1970, Dennis O'Leary exposed the gelatinous cupulas of frogs' semicircular canals—the organs of balance in the inner ear—to infrared radiation. The response of sense water currents also react to electrical the canals' hair cells was consistent with the

electrical and not the mechanical model of such acoustic wave resonator, a common electronic organs.



Recently the outer hair cells (above) of the cochlea have themselves proven to be piezoelectric. They acquire a voltage in response to pressure, and they lengthen or shorten in response to an electric current. Their sensitivity is extreme: one picoamp (one trillionth of an amp) of current is enough to cause a measurable change in a hair cell's length.

Electric currents, travelling in complex paths, have also been found traversing the tectorial membrane and coursing through the organ of Corti.


And pulsating waves have been discovered, in the thin space between the tops of the hair cells and the bottom of the tectorial membrane, that reverberate between the outer hair cells, the tectorial membrane, and the inner hair cells.



Australian biologist Andrew Bell (above) has calculated that in the human cochlea these fluid waves should have wavelengths roughly between 15 and 150 microns (millionths of a meter)—just the right size to put hair cells 20 to 80 microns in length into musical resonance. Bell has compared these waves to surface acous-

device that has replaced quartz crystals in a wide variety of industries.

In the electro-model of hearing that these scientists have constructed, there are several places where electricity can act directly on the ear. The inner hair cells are electro-receptors. The outer hair cells are piezoelectric.



The tectorial membrane (above) is piezoelectric. And since both direct and alternating current can act on any of these structures, many of the early reports of the hearing of electricity, said Offutt, including reports that were dismissed as being due to "skin vibration," should be reevaluated.

The exquisite sensitivity of the organ of Corti to electricity explains the nineteenth century reports of the hearing of direct current and the twentieth century reports of the hearing of alternating current.

And it forms a basis for understanding the torment suffered half a century ago by Clarence Wieske's client in Santa Barbara, and the suffering of so many millions today. But a piece of the auditory puzzle is still missing.

Direct or alternating current applied to the ear canal requires about one milliampere (one thousandth of an ampere) to stimulate hearing. If an electrode is placed directly in the cochlear fluid, about one microampere (millionth of an ampere) suffices.

If current is applied directly to a hair cell, one picoampere (trillionth of an ampere) is all that is necessary to cause a mechanical reaction. Clearly, sticking electrodes in your outer ear is an inefficient way to stimulate the hair cells. Very little of the applied current ever reaches those cells. The Empress Helen and the Holy **Cross**

When Licinus was defeated at the battle of the Milvian Bridge Constantine entered Rome and by AD 322 he was able to make Christianity a legally permitted religion in Rome.

Constantine then went to ancient Byzantium to rebuild this key trading centre as his new capital city of Constantinople. Julius Caesar had planned to relocate the centre of Roman power to this place at the crossroads of Europe and Asia.

The widowed Empress Helen then went on a pilgrimage around Sinai accompanied by a large body of soldiers. Helen then went north to Jerusalem where she demanded that the Holy Cross that had been used in the crucifixion of Jesus the Nazarene must be handed over to her.

After much prevarication that compelled Helen to use force and threats the precious piece of timber was handed to Helen, who immediately had it plastered with jewels and gold and placed into a silver casket. She had the nails made into a bridle bit for her son's horse and then she sailed her fleet back to Britain.

There are twenty five various accounts of this event scattered across Europe and the Near East. The Exeter Book has a good account of this.

When Helen arrived back in Britain she clearly had the Cross paraded around Wales which was much larger in those days before the constantly moving border drifted west. The practice of ancient royal and noble persons was never to leave their possessions at home, and usually a train of Ox drawn carts lumbered along around 10 miles a day.

The parade of the Cross can still be traced by place names like the Ford of the Cross, the Field of the Cross, the Vale of the Cross, the Hill of the Cross, and so on, all around 8 to 10 miles apart.

What is remarkable is that the place where the Cross was finally deposited is recorded in a manuscript first written around AD 920 and re-copied in circa AD 1100. There are an estimated 14,000 known chemicals in food packaging. And according to a newly published study, more than 3,600 of them could now be lurking in your body.

On Tuesday, a research team from Switzerland and several other nations published their findings in the new study, "Evidence for widespread human exposure to food contact chemicals," in the Journal of Exposure Science & Environmental Epidemiology. The team compared more than 14,000 known food contact chemicals

What Are Food Contact Chemicals?



As described in 2020 in the consensus statement, "Impacts of food contact chemicals on human health," FCCs are the chemical constituents of "food contact materials and finished food contact articles, including food packaging, food storage containers, food processing equipment, and kitchen- and tableware."

The team defined FCCs as "all the chemical species present in food contact articles, regardless of whether they are intentionally added or present for other reasons."

Are 'Forever Chemicals' In Your Favourite Sparkling Water? Here's what to Know

Again, there are thousands of FCCs; however, as the authors of the new study note, they found metals and per- and polyfluoroalkyl substances, also known as PFAS or "forever" chemicals, had made their way to the human body through food packaging.

How Dangerous Are These Chemicals?



As Food & Wine previously reported, exposure to PFAS chemicals, which have been used for decades in packing and other products to "impart oil, water, stain, and soil repellency," could potentially have serious health consequences. The Agency for Toxic Substances and Disease Registry (ATSDR) noted several "potential outcomes" from PFAS exposure, including changes in cholesterol and liver enzyme levels, small changes in infant birth weight, and changes in the immune system and response to certain vaccines.

"One of the main outcomes is suppression of your immune responses after you get a vaccine," Dr. Jamie De Witt, the director of the Environmental Health Sciences Center at Oregon State University, who has long studied the human immune response to PFAS, shared with Food & Wine.

"The type of suppression that has been observed from PFAS and other environmental chemicals would be considered clinically to be mild to moderate. It doesn't mean that people are going to immediately get sick and immediately have problems, but we know from studies of people who are mild to moderately immune suppressed that there is an increased risk of infection and

The team defined FCCs as "all the chemical there is an increased risk of other types of species present in food contact articles, regard-diseases such as cancer."

How can I mitigate my risk?

The researchers of the new study note that "toxicity data are often incomplete or missing, which means that safe use cannot be assessed." So, they suggest reducing exposure "to known hazardous FCCs and assessing untested FCCs can contribute to the prevention of non-communicable diseases that are associated with chemical exposures."

This can be done in a multitude of ways. As the Washington Post reported, exposing food to these chemicals at high temperatures can cause them to leach more quickly into what you're about to consume.



Thus, it's not advisable to microwave anything in its takeout container. Simply educating yourself on which containers may be worse than others is also critical, as they may not be what you expect.

A High Seafood Diet Could Increase Your Risk of Exposure to 'Forever Chemicals'

"Probably the worst one is recycled paper and cardboard," Muncke told the paper. "And I know that's a hard one to stomach." That's because recycled paper, cardboard, and plastic can leach non food grade ink mixing with food, adding more chemicals than before.

Additionally, the experts Food & Wine spoke to previously noted that there are other ways people can limit their exposure, including looking for products that are "BPI certified," which means they are certified by the Biodegradable Products Institute, which requires all compostable food packaging to be PFAS-free. 



Modern Grounding Shoe

Up until say the 1940's grounding was something that happened pretty much automatically when we went walking. The leather soles of our shoes were good conductors for electricity between us and the ground even on concrete.

However, since the increased use of rubber soles and later plastic shoes we have insulated ourselves from the earth and grounding doesn't happen. This is closely linked to a number of illnesses that we now suffer from to the delight of 'big pharma'.

A number of companies have been set-up that sell products that will enable us to get back grounding ourselves. These can be special bed sheets, grounding mats, wrist bands and even shoes (below).




All of these products are made of electrically conducting materials that are connect via a wire to the grounding (earthing) part of an electrical socket. The shoes however have conductive soles and insoles and will connect you with the earth provided you are not walking on insulating surfaces like asphalt or plastic floor coverings.

Some types of EMF radiation will produce the 'free radicals' that are eliminated when we ground ourselves. Free radicals are molecules with an unpaired electrons and thus can adversely alter lipids, proteins, and DNA and trigger a number of human diseases. It has been

suggested that free electrons from the earth thicker and so increase the blood pressure. neutralize the positively charged free radicals that are the hallmark of chronic inflammation.

Below are red blood cells before and after grounding from 3 different people.



It is quite easy to test grounding before investing in grounding products. All that is required is a simple, inexpensive multimeter.

Depending on the meter purchased, switch and turn the dial to AC volts Connect the red and black cables to their respective sockets. normally you would need to put the black probe into the ground/earth socket in your power point. But if you are a cautious about which is the correct socket then just take the meter outdoors and stick the black probe in the ground/grass.


Assuming you are wearing plastic or rubber soles on your shoes, just hold the metal tip of the red probe and note the voltage.

Next remove one of your shoes and put a bare foot on the ground. You will see that your body voltage drops to almost zero! This is because you are now at the same negative charge as the earth which is natural and how it should be.

Animals don't have this problem and that is why they suffer with far less diseases than humans.


I suffer with high blood pressure and was given medication, which I reluctantly took, to stabilise my blood pressure. I check my blood pressure daily with a BP monitor and record the average day by day.

The medication seemed to keep within the recommended values for a particular condition. On discovering grounding I noticed that it lowered blood pressure. This is because when you are insulated from the earth the red blood cells tend to clump together and make the blood



So thought I would try grounding to see if it had any effect on my heart condition. I then purchased a wrist band and cable and started to use it on 31 August. I connected myself to a grounding socket whenever I was sitting at my computer, having lunch/dinner, just resting and during the night.

The first BP test went up slightly. Then on 31 August 2024 I started grounding and the BP average is now fairly constant. I put the slight increase between medication and grounding down to the over thinning of my blood by the medication.



The result shows a high BP at the start of the monitoring process on 31 July 2024, when I was taking the medication, and as I measured the BP show a reduced BP.

medication and the BP was slightly higher average and would be a true reflection of what my normal blood pressure should be. The doctor said that my target BP should be 140 Systolic was performed. over 80 Diastolic.

The actual average is about 156 over 86. I hope over time that the overall healing to my body from grounding will reduce the BP a bit more.


In 2004, electrical engineer and electrostatic discharge expert Roger Applewhite conducted an experiment to measure voltage on a grounded and ungrounded body.






After the death of Solomon, the united kingdom of Israel was divided into two distinct political units,



Jerusalem Well Defended

The Assyrians' record of that invasion says the Assyrian armies captured forty-six cities of the house of Judah and that Assyrians "brought away" 200,150 people.




Those Judaite prisoners in Assyria moved eastward into the mountains of Central Asia where they were known as the Yoti, but about the time of Christ the migrated into Europe and settled in the Danish Islands and in Jutland, or Judahland. These people of the house of Judah became ancestors of the Germans today. Though

they are of the house of Judah (the tribes of Judah and Benjamin), they are far different from the Jews of today.

The Jews through the centuries have mixed with Edomites, Khazars (Mongolian), and North African stock, so that the Jews of today have little blood of Abraham in their veins while the Germans of today could (if they knew the facts) trace their ancestry to the house of Judah centred on Jerusalem.

Perhaps this fundamental conflict of identity explains the ancient tensions between Jews and Germans.



About one hundred years after the exile of two hundred thousand Judaites by the Assyrians, the house of Judah was invaded by Babylon. Only a relatively small number ever returned to the area around Jerusalem, the rest remaining in Babylon. These {non-Israelite} people in Palestine and Babylon became the ancestors of the people known today as the Jews.


The book of Esther records that in her time many people of other races adopted the Jewish {sic, Mosaic – Eli} religion, which added thousands of people who became known as Jews but were not descended from Abraham (Esther 8:17).

{The most correct way of stating this is that the non-Judahites of the time contrived a bastardised, Babylonian version of the Mosaic Law, which is today known as the Babylonian Talmud. – Eli}

According to Josephus, the Jewish {sic, Judahite – Eli} historian, writing 95 A.D., about 150 B.C. a Judean leader named John Hyrcanus led a Jewish {sic, Judahite – Eli} army; which captured many cities of the Idumeans (Greek

form of Edomites) and compelled them to follow the Jewish {sic. Judahite – Eli} religion.

The men were all circumcised and all the Edomites were forced to adopt the Jewish {sic, Judahite, Mosaic – Eli} ceremonial and dietary laws.

From that day on, all those Edomites were counted as Jews {sic, Judeans, not as Judahites or Israelites – Eli}, though racially they were descended from Esau.

Significantly, these descendants of Esau have always deeply resented that God's salvation plan was carried down through the line of Jacob Israel rather than Esau, their forefather; and the Edomite Jews have bitterly resented Jesus of Nazareth, rejecting the Crucified One as Messiah. Interestingly, "Edom" means "Red".



In the eighth and ninth centuries after Christ, basically Mongolian people called Khazars (or Chazars) lived in the area north of the Black Sea and the Caspian Sea.

Their King Bulan (left) decreed that all

Khazars adopt the religion of the Pharisees as an

instrument of political unity. Arnold Toynbee, the eminent British historian, places this mass conversion to Jewry as taking place across the period 750-870 A.D.

This Khazar empire became the backbone of the Jews who migrated into the Slavic nations of eastern Europe and from there into the United States about the turn of the Twentieth century, bringing with them the mentality of socialist revolution, which has always included terrorism.

The basic Communist documents are 'Das Kapital" and 'The Communist Manifesto" written by Karl Marx, a Jew. He was assisted in his writing by another Jew, Friederich Engles. Jewish influence, if not control, of the Communist movement continued through Lenin, who is today worshipped as the Red Messiah, and Leon Trotsky, a New York Jew whose real name was Braunstein.

According to U.S. Document No. 62 of the 66th Congress, Vol. 3, at the Communist meeting in Petrograd (now Leningrad) Russia, in 1918; the group in attendance consisted of 16 Russians, 1 American Negro, and 371 Jews.

Above all the Karl Heinrich Marx, whose real name was Kissel Mordekay, was born in Trier, Rhineland. His father was a Jewish lawyer. His grandfather was a talmudic Rabbi. "On both paternal and maternal sides he was descended



from rabbinical families." Univ. Jewish Encyclopedia, Vol. VII, p. 289; etc.



Another Jew, Sigmund Freud (above), invented psychoanalysis. Though the whole system of thought is purely Freud's own creation and is totally non-medical and non-scientific it has been amazingly seductive, being accepted today throughout Western medicine.

Freud's system has no more scientific credibility than does voodoo, yet his pseudoscience has become the effective religion of thousands of Jews and Anglo-Saxons, the two groups who comprise most practitioners and "patients" today. S "NIGHTMARE BACTERIA" IMPERVIOUS TO ANTIBIOTICS PROLIFERATE, AN ANCIENT

REMEDY STEEPS HOPE FOR MODERN MEDICINE IN LIME PEELS AND STEAM

Amid alarm over rising antibiotic resistance, new research restores hope by reaching back to ancient plant cures. Scientists in Thailand tested an essential oil made from Kaffir lime peels against dangerous, multi-drug resistant staph infections.

In lab dishes, the oil potently blocked growth and killed methicillin-resistant Staphylococcus aureus (MRSA), restoring effectiveness to failing antibiotics like gentamicin.

(CDC) warns that common bugs like MRSA are gentamicin with minimal lime oil concentrations becoming "nightmare bacteria" - impervious to annihilated MRSA colonies. most antibiotics.



This leaves doctors scrambling as more standard drugs fail against formerly routine illnesses. Seeking solutions, researchers extracted Kaffir lime's pungent, citrusy essential oil through steam distillation of the peels. In lab tests, they discovered this natural oil alone halted MRSA's spread (above). But it also exhibited a littleknown power: restoring potency to gentamicin, an antibiotic beaten down by resistance.

This ancient-meets-modern pairing of plant oil and gentamicin provides a new strategy against stubborn infections.

The CDC now acknowledges that rather than relying solely on new antibiotics, incorporating old botanical treatments may better protect public health.



The research team first confirmed antibiotic resistance levels in staph cultures from hospital patients. As expected, most strains resisted multiple drug penicillins, like classes cephalosporins, fluoroquinolones, and more, qualifying as nightmare But when super bugs. exposing MRSA samples to Kaffir lime oil (Left), growth diminished. The oil also completely killed MRSA

within 12 hours at higher, but still safe, levels.

Additionally, the researchers tested lime oil and gentamicin together using checkerboard testing. This assesses if combining treatments improves

The Centres for Disease Control and Prevention efficacy. Strikingly, pairing tiny doses of

The mix also prevented single drugs from breeding resistance. Rather than crude plant compounds versus pharmaceuticals, the study revealed an elegant synergism against microbes when delicately blended by nature and science. So with antibiotic miracles waning against proliferating drug-resistant threats, this research proffers hope.

It suggests reviving ancient botanical wisdom could offer modern medicine tools to combat our most urgent infections. A little natural sour and spice, with gentamicin's still mighty punch, may concoct the soothing savour we desperately need.




