#### **CONCLUSIONS**

The subdivision into three different groups is, unquestionably, also applicable to the Jewish sector of the European and Eastern European populations.

The child-producing part of the women of these populations is to be found in the middle group of 20 - 59 years, half of which consists of women, i.e. 25%.

Since the menopause starts around the age of 45 a conservatively estimated 15/40th or 37, 5% of 25% or 9,% should be subtracted from 25%, so that only 15,7% of world Jewry MINUS 6,000,000 must have succeeded in supplying the depletion of their number by gas-induced deaths. But, there is more that we should take into account before we embark on our thesis to prove the ineluctable refutation of the wild "Myth of the Six Million." To wit: not all of the female part of **WORLD** Jewry would have been able to take part in the replenishment of their decimated European numbers! The endless stream of survivors who keep appearing on the scene to this day could not by any stretch of the imagination have "executed" their marital vows in these, for them, hectic times! As the exact number of survivors (specifically the female part) is by no means ascertainable because of no available demographic data we will leave them out of this analysis. Let's now have a closer look at the points 1-9 of the list of data. Point 3 emphatically states that World Jewry just prior to World War II consisted of 16.180.000 Jews.

The alleged gassings. in Europe refer to 9,394,837 persons — of which number should be subtracted 6,000,000 dead so that with Germany's surrender on 18.4.45 - 3,394,837 Jews must have remained in Europe and Russia. By inference there were outside this area 6,785,163 Jews.

This remnant of 10,180,000-Jews of which number only 15,7% or 1,598,260 women of childbearing age could have accomplished the job, meaning everyone and no one in the age-bracket of 20-79 year excepted and assuming that no deaths of natural causes, miscarriages and infertility cases occurred.

Let's now see how many children must have been born during the following periods of time based on the post-war demographic data issued by the American Jewish Committee in the World Almanacs i.e. points 7, 8 and 9 in the above list of data.

- **a.** (7) 15,192,089 10,800,000 = 4,392,089 children born in a time span of 18.5.45 31.12.45 or 258 days! As the female gestation period lasts 270 days this allegation is utter nonsense and therefore further attention to a. will henceforth be discarded.
- **b.** (8) 15,753,638 10,800,000 = 4,953,638 children born in a period of time of 18.5.45 31.12.46 or 623 days!
- **c**. (9) 16,643,120 10,800,000 = 5,843120 age children born during the time span of 18 May 1945 and 31 December female, single, married.

#### Re.: b.

4,953,638 children born to 1,598,260 women of child-bearing age during 623 post-war days, means 3.1 children to each and every female, single, married, fertile and no deaths and/or pregnancy miscarriages having occurred.

Since the human female gestation period lasts 270 days and a conservative 6 weeks (\*) recovery period be added after each pregnancy the resultant 312 days can lead to the obvious and only conclusion that, if the incidence of quadruplets or even triplets be excluded, we are faced with the biological miracle of AT LEAST 1,651,213 twins and the same number of single babies born to the above 1 598 260 women! To the writer's knowledge no such extraordinary, most peculiar biological phenomenon has ever been recorded and should therefore be discarded forthwith as complete and stupidest nonsense!

#### Re.: c.

Here we tread on safer ground! Since 5,843,120 offspring born to the 1,598,260 women mentioned earlier these children born to each and every female - and we repeat, no one excepted, nor deaths of natural causes or infertility cases allowed - amounts to 3,6 children in the span of time of 1719 post-war days. That is: 1719/3.6 = 477,5 days per child, including a gestation period plus a "rest" period = 312 days. Quite feasible, though miraculous all the same!

Miraculous in the sense that we are most conspicuously confronted with the utter impossibility of a short term growth performance never before exhibited in recorded world history. Our analysis proves irrefutably that this sudden and explosive Jewish birthrate that the holocaust-protagonists want us to believe, abruptly grinds to a halt the moment this people reached again their pre-war 16 (or is it 14?) million markin 1949 or even earlier. As the population growth is found to be 16,643,120:101800 = 157.4% in 4.7 years or 57.4:4.7 = 12,2% Per year the "six-million myth" wants us to swallow the nonsense that they "succeeded" in adding during 4.7 consecutive years more than 57% to their number where other peoples and the world population as a whole need MORE THAN 57 YEARS for to accomplish! If we now turn to the problem of feasibility of exterminating 6,000,000 humans by the Nazis then several questions come to mind.

- 1. Why go to the extreme of building structures for the sole purpose of killing people if a more obvious and less costly means would be available through the bullet?
- 2. Especially if Germany's position in the war years 1944 and part of 1945 - the period of time during which the alleged gassings took place - be contemplated the question arises why Germany, having its railway system utterly devastated by continuous allied bombing raids, would stubbornly resort to the means of transportation by rail to an outpost of the then existing Reich - Poland - of 6,000,000 people! It would have meant at least the use of 85714 railway cars (6 000 000:70\*) and if one trainload of "doomed ones" be estimated to comprise 100 cars and two locomotives (for uphill traction power supply) the implication is obvious: 857 trips up and down to Poland involving 1700 odd locomotives! And... our follow-up question of "what did those trains have as payload on the return-trip?" remains unanswered. But the \$64,000 = question would be - if at least common sense and logic govern our deliberations on this subject - "Who, in his right mind, would ever charge his country with this additional and unbearable burden over a stretch of 800 km. knowing full well that the national railroad system being heavily devastated, the country itself in dire straits as far as the war is concerned, every available railroad car is needed for transportation of its own fighting men and supplies?"

- 2. An intriguing problem that has no solution whatsoever because of its improbability is the cremation of 6,000,000 corpses.

Let it suffice that a succinct resume is given of a research into this matter. It bears the heading: **A SIMPLE CALCULATION IN** 1946. Written by Reinhard K. Buchner - in vol.2, no.3 of *The Journal of Historical Review* - Torrance, Cal. USA.

Needless to mention that this writer availed himself of many details relating to the process of cremating corpses by having gathered the necessary particulars through interrogation and intermediary of experts. (This concerns the time-factor playing an important role in the process of cremation) Excerpt:

"To emphasize that this technical problem has existed openly all the time – but is simply pretended not to exist by historians and Holocaust theory promoters - the picture as it presented itself as early as 1946 is first reproduced here. The mathematical part is simple. If one knows the total number of "cremator hours" (that is the sum of all existing cremators multiplied by their individual time of operation in hours) and the incineration time per corpse, one can calculate the theoretically possible maximum number of cremations.

It is convenient to write the relevant correlation in the form of a simple equation:

$$\underbrace{\mathbf{N} = \mathbf{C} \times \mathbf{T}}_{\mathbf{I}}$$

N = Number of possible cremations

**C** = **Number of Cremators** 

T = Time of operation in hours

I = Incineration time for single charge cremation (one corpse in hours)

The term "cremator" as used here refers to a single furnace.

Having no other relevant information in 1946 I proceeded to calculate the theoretical number of cremators necessary to incinerate 6,000,000 corpses during an "assumed" operational time of 5 years i.e. roughly the full duration of WWII." End of quote.

Since we now know the exact point in time of the start of the alleged homicidal gassings - see data note 10 - we are in the position to substitute the true numerical values in the above formula.

To arrive at the number of cremators needed the formula changes into:

Substitution gives:

$$C = \underline{6.000.000 \times 5} = 2847$$

$$439 \times 24$$

cremators in which the value 5 constitutes the expert empirical duration to incinerate a corpse. Since no more than a couple of dozens of cremators have been found to exist in Germany we are here confronted with an insuperable hurdle, to say the least.

But for clarity's sake let's assume that 100 cremators existed in Germany's Polish concentration camps, then we have:


100 =  $\underline{6.000.000 \times 5}$  = 300 000 hours or 12,500 days of 24 hours each, reserved for necessary overhaul and/or maintenance of the cremators. But from the points 10 and 11 of the table of data we derive that only 439 days were involved in doing away with the 6,000,000!
