One (Klaus Jaeger, elder in OCC Germany) responded with a strong argument for the 1918-2018 Prussian de jure government (above). As is the norms of international law, and laws of prescription the claims to rightful title have fully ended as there were no protests by the Prussians against the occupiers for more than 50-100 years.
