


# Calling The True Israel Peoples

2.) To Make an End of Sins

Unfortunately for us, this was not accomplished at Calvary, as we Israelites are still sinners, even today; but it was a great start. Ultimately, we Israelites are to become a sinless people. The New Covenant, which was announced at the Last Supper, was prophesied by Jeremiah, in Chapter 31.

**31** Behold, the days come, saith the LORD, that I will make a new covenant with the house of Israel, and with the house of Judah:

**32** Not according to the covenant that I made with their fathers in the day that I took them by the hand to bring them out of the land of Egypt; which my covenant they brake, although I was an husband unto them, saith the LORD:

**33** But this shall be the covenant that I will make with the house of Israel; After those days, saith the LORD, I will put my law in their inward parts, and write it in their hearts; and will be their God, and they shall be my people.

**34** And they shall teach no more every man his neighbour, and every man his brother, saying, Know the LORD: for they shall all know me, from the least of them unto the greatest of them, saith the LORD: for I will forgive their iniquity, and I will remember their sin no more.

**35** Thus saith the LORD, which giveth the sun for a light by day, and the ordinances of the moon and of the stars for a light by night, which divideth the sea when the waves thereof roar; The LORD of hosts is his name:


**36** If those ordinances depart from before me, saith the LORD, then the seed of Israel also shall cease from being a nation before me for ever.

**37** Thus saith the LORD; If heaven above can be measured, and the foundations of the earth searched out beneath, I will also cast off all the seed of Israel for all that they have done, saith the LORD.

Since the moon and stars still shine by night, we can rest assured that Yahweh intends to accomplish His Will for BOTH Houses of Israel and Judah. Both Judaism and Judeo-Christianity ignore this prophecy. The Jews teach that the House of Israel (the Ten Exiled Tribes) vanished and will never be heard from again. The Judaeo-Christians teach that, since Israel (by which they falsely assume the Jewish people!!!) rejected the Messiah, literal Israel has been replaced by THEIR Church, or by "spiritual Israel," by which they mean themselves!

Of course, these teachings are false. Yahweh never declared that He would reject all Israel. He only said that He would "divorce" Israel until the days when both Houses would be gathered back together!! We know that we Anglo-Saxons are of Both Houses. And, since we, True Israel, are alive and well, no "church" can claim OUR inheritance! We also know that the Jews are impostors, impersonators of Israel and Judah. Since they are, in fact, Edomites and Khazars, they NEVER had any claim to the Covenants promised to True Israel. They are the "beast that deceiveth the whole world" with their impersonation of Israel. (Rev. 12:9.)

The Judeo-Christians, ignoring these prophecies and totally fooled by the Jewish impersonation of Israel and Judah, have thus laid claim to the New Covenant, since it is obvious that the Jews failed to recognize Jesus as the Messiah. It is true that the Jews reject Jesus, even today; but it is false that the Jews are the children of Israel. At that time, 99.9% of the Israelites in the world were in the Dispersion (outside of Judea); and they didn't even know that their Messiah had come. That Good News was not spread until after His death. Several Old Testament prophecies tell us that the Israelites would forget their Identity as Israel. (Isa. 29:10-12; 42:16,19,20; Hos. 2:1-8; Romans 11:7,8,25.) Yet, even while this state of amnesia had befallen our Israelite ancestors, they nevertheless accepted Yahshua as the Messiah. They did this instinctively, because they were True Israelites, even though they didn't know it. Falsely believing the Jews to be Israelites, the Judeo-Christians go on to assert that the Jews will one day accept Jesus as the Messiah. But this will never happen, because the Jews are not His kinsmen.



They are, in fact, the children of the devil (John 8:44), who will never repent of their repudiation of Him. This repudiation is called Judaism. Don't hold your breath, waiting for the Devil to suddenly worship the One against whom he has rebelled. The Bible teaches that the rebellious ones will be destroyed by fire. It does not teach that they will have a change of heart and convert.

But the sins of True Israel will eventually be a thing of the past, once we come to the full realization of who we are and that our Destiny is to be the administrators of Yahweh's everlasting Kingdom.

Messiah's intercession at Calvary instituted a Grace Period of 2,000 years (the "two days" of Hosea 6:2, being a thousand years each (2 Peter 3:8)), a Grace Period needed by us in order to absorb all of the wisdom, promises, Laws, Faith, and Covenants, which we agreed to at Mt. Sinai – to lock them into our hearts. Once this step is accomplished in Israel, then our sinful ways will be over. The Judgment Day occurs after these two "days," when we will all have to pay for our sins. Some will have to pay by going into spiritual oblivion, the "second death."

## 3.) To Make Reconciliation for Iniquity

Reconciliation is atonement for our sins. As our Kinsman Redeemer, Yahshua Messiah took upon Himself all of our sins under the Old Covenant, thus atoning for the millions of violations of our oath at Mt. Sinai.

#### 4.) To Bring In Everlasting Righteousness

Again, this process was only begun at Calvary. All of Christian history, starting from that day, was designed and intended by Yahweh to bring in everlasting righteousness (justice according to His Laws). This will not be accomplished until the Second Coming, when both death and evil will be destroyed.

## 5.) To Seal Up the Vision and the Prophecy

This means that Calvary fulfilled the Seventy All of the prophecies Weeks prophecy. concerning the first Advent were fulfilled in Jesus Christ. Jesus fulfilled literally hundreds of Messianic prophecies. Of this there is no doubt. The Jews cannot argue against these fulfilments; therefore, they ignore them and teach a completely different religion. This religion is NOT based on the Old Testament. It is based on anti-Messianic interpretations of the Old Testament, called the Babylonian Talmud. The Babylonian Talmud utterly rejects Jesus as the Messiah. This is only one of the thousands of reasons why Judaism cannot be considered the religion of Moses.

> The anointing of His head verified Him as King of Israel. The anointing of His feet verified Him as the Passover Lamb, for His burial would take place in less than a week.

> Thus, Jesus Christ is the fully **ANOINTED** ONE, having been anointed as King and Messiah before numerous witnesses - even the Pharisees were witnesses, and they understood that He was a True Israelite, which they were not. That is why they resolved to kill Him. The Pharisees understood that, had Jesus taken His royal crown, He would have abolished their priesthood, which was a usurpation of the Levitical priesthood of True Judah. This fact is confirmed at John 7:35.

> The Lamb of God had to be slain before the Lion of Judah could take the throne. Two thousand years must intervene between these two Advents.

Given all of these fulfilments, it is quite certain that Jesus of Nazareth is the ONE AND ONLY 11 Because that by reason of him many of the MESSIAH. No other human being has come prophecies, let alone all of them! Let God be true and every Jew a liar (paraphrasing Paul at Romans 3:4). He who denies that Jesus is the Messiah is antichrist. #### The Historicity of Daniel's Seventy Weeks

**25** Know therefore and understand, that from the going forth of the commandment to restore and to build Jerusalem unto the Messiah the Prince shall be seven weeks, and threescore and two weeks: the street shall be built again, and the wall, even in troublous times. (Daniel 9:25.)

The Book of Ezra tells us:"And even I Artaxerxes, the king, do make a decree to all the treasurers which are beyond the river, that whatsoever Ezra the priest, the scribe of the law of the God of heaven, shall require of you, it be done speedily." - Vs. 21.

The Bible records several decrees to rebuild Jerusalem, but only one can count as the starting point of the Seventy Weeks prophecy. The decree of Artaxerxes to rebuild Jerusalem is the commandment of which the archangel Gabriel spoke. This decree was given in 457 B.C.

Here is a good summary of these historical events:

Cyrus, in 536 B.C., allowed the Jews [sic, Judahites - Eli] to return to Jerusalem, but Cyrus died in 530 B.C., he was followed by Cambyses, who was followed by False Smerdis. Smerdis reigned only half a year, long enough for his soldiers to destroy a great many temples around the empire. It would seem that the earlier progress made of rebuilding the temple in Jerusalem was also ruined at this time, because, according to Haggai 2:18, in 520 BC the Israelites are again beginning work by laying the foundation of the temple. Very probably it was under Smerdis' rule that the Israelites gave up all hope of ever restoring their temple again. Haggai says, they stopped work believing "The time is not right", and he says that the temple was in "ruins".

In 522 B.C., Darius I, a fairminded ruler, goes about setting things straight again in the Persian empire. With his support and Haggai's encouragement, temple construction is resumed. From 520-515 B.C. the work went forward, and the temple was built.

Basically from 536-457 B.C. the Israelites were a struggling group of people with no real government, city or well defined country. They built themselves houses, and managed to build a temple. It wasn't until Artaxerxes came to the throne 464 B.C. that we actually see them rebuilding the city. It was during Artaxerxes reign that the adversaries appealed to legislation to stop Israel, for they were "building a rebellious and evil city".

Ezra So we see receiving his decree from Artaxerxes in 457 BC. (In the seventh year of Artaxerxes) The decree gives further help in establishing the temple, but it also gives Israel right the to self government. Up till 457 BC the leaders in Judea were no more

than county commissioners. They could look after local problems but they did not have judicial or executive authority. Now they did! They could set up their own magistrates and judges to carry out their laws. Now they were recognized as a nation. This is why this decree is so important to the reestablishment of Jerusalem!

Israel must have seen this decree as a decree to rebuild Jerusalem as well for we read: "In the reign of Artaxerxes," they (adversaries) wrote to Artaxerxes that Israel should not be allowed to rebuild, "the rebellious city, finishing its walls and repairing the foundations" because (the adversaries said) Israel would rise in rebellion." (When the Bible says Artaxerxers, I believe it means Artaxerxes not Cambyses)

Artaxerxes writes back a command that is very unlike the commands of Persian kings, it seems to be uncertain, as if he's not sure he's doing the right thing: "Now give command to make these men cease, that this city may not be built until the command is given by me." This probably took place between 456-454 B.C. when the Persian Governor over the (western) section of the middle east, Megabyzos, rebelled against Artaxerxes, taking his subjects with him. It's was a perfect setup for Samaria to win points with the Persian monarch and get even with Israel.

Did Artaxerxes believe the Samaritans? He seemed not sure, however the region was in rebellion and he didn't want to take chances. The kings reply was great victory for the Samaritans who went "immediately to the Jews in Jerusalem and compelled them by force to stop" (Ezra 4:23) While they were about it, they apparently knocked down the rebuilt sections of the wall, and burned several gates. (Neh.1:3)

Artaxerxes and Megabyzos made peace, and things settled down again. This is where Nehemiah comes into the picture. He hears the sad news that the attempts to rebuild Jerusalem were totally frustrated. He talks it over with Artaxerxes, who gives him permission to go and rebuild Jerusalem. Artaxerxes had left the option of reversing his "Cessation command" open and now that rebellion was over he allowed the work to progress once again. 444 B.C. Work once again began. This time the walls were put up successfully.

Daniel 9:24 said they would be rebuilt in troublous times and they definitely had trouble. Is 457 B.C. the right date? Is it the starting point of the great time prophecies? As I've said before, it makes sense to me. Coupled with the fulfilment of the Messiah coming 483 years later, being cut off in the midst of the final week of the 490 year prophecy, causing ceremonial sacrifices to cease. To me there is no question. The beginning point for the "seventy weeks", according to the historical Messianic interpretation, is the "going forth of the word to restore and to build Jerusalem" (Dan. 9:25). The 69 weeks or 483 years, takes us to the anointing of Messiah the Prince, at His baptism in 27 A.D. in the 15th year of the Roman emperor Tiberius (Luke 3:5)

Messiah is "cut off" for our transgressions (Isaiah 53:8) in the midst of the "week" or after three and a half years, 31 A.D. Then, at the end

of the 490 years allotted to Israel, we see them launch their attack against Christians (against Christ) with the stoning of Stephen. Thus ends the "time given to Israel" as a nation (though as individuals God sees neither Jew nor Gentile, all who come to Him in sincere faith are His children)

In 457 B.C. they did not have calendars like we have. This fact can give room for doubts and arguments on the exactness of the date. Different nations used different ways to figure the years of the kings' reigns.



Ezra 7:7-8 tells us the decree was issued in the 7th year of Artaxerxes I. The seventh year of Artaxerxes I is relatively sure as being in 458/457. (Remember years run backward in

B.C.)

That means the seventh year of Artaxerxes started in the fall of 458 and ran through to the summer of 457.

Several historians say that the seventh year of Artaxerxes extended from the fall of 458 to the fall of 457 B.C. or 458/457.


Ezra returned to Palestine in 457 B.C. Ezra's journey to Jerusalem began in Nisan and ended in Ab of 457 B.C. (Ezra 7:8-9). Thus, according to our months, Ezra's trip lasted from April to late July 457 B.C.

The decree of Artaxerxes I went into effect after Ezra's arrival in Palestine in the early fall—or late summer—of 457 B.C. This was "the going forth" of the decree recorded in Daniel 9:25-26.

**EUTERON OMY 24:1** – When a man hath taken a wife, and married her, and it come to pass that she find no favour in his eyes, because he hath found some uncleanness in her: then let him write her a bill of divorcement, and give [it] in her hand, and send her out of his

house.

**Deuteronomy 24:2** – And when she is departed out of his house, she may go and be another man's [wife].

**Deuteronomy 24:3** – And [if] the latter husband hate her, and write her a bill of divorcement, and giveth [it] in her hand, and sendeth her out of his house; or if the latter husband die, which took her [to be] his wife;

**Deuteronomy 24:4** – Her former husband, which sent her away, may not take her again to be his wife, after that she is defiled; for that [is] abomination before Yahweh (the LORD): and thou shalt not cause the land to sin, which Yahweh (the LORD) thy God giveth thee [for] an inheritance.

**Deuteronomy 25:6** – And it shall be, [that] the firstborn which she beareth shall succeed in the name of his brother [which is] dead, that his name be not put out of Israel.

**Deuteronomy 25:7** – And if the man like not to take his brother's wife, then let his brother's wife go up to the gate unto the elders, and say, My husband's brother refuseth to raise up unto his brother a name in Israel, he will not perform the duty of my husband's brother.

**Deuteronomy 25:8** – Then the elders of his city shall call him, and speak unto him: and [if] he stand [to it], and say, I like not to take her;

**Deuteronomy 25:9** – Then shall his brother's wife come unto him in the presence of the elders, and loose his shoe from off his foot, and spit in his face, and shall answer and say, So shall it be done unto that man that will not build up his brother's house.

**Deuteronomy 25:10** – And his name shall be called in Israel, The house of him that hath his shoe loosed.

The duty of a childless man's brother to marry his widow, in the event of his death.

Women are prohibited from entering into disputes between men.

Deuteronomy 25:14 - Thou shalt not have in thine house divers measures, a great and a small.

**Deuteronomy 25:16** – For all that do such things, [and] all that do un-righteously, [are] an abomination unto Yahweh (the LORD) thy God.

Here Yahweh is condemning the modern financial system which is geared towards allowing speculators to exploit the people.

Firstly they exploit the producer by paying a small amount for the goods he produces.

Secondly the speculators then exploit the consumer by charging them several times more than they paid the producer for his goods.

Those speculators who do this are the middlemen, who are basically pimps and are essentially a cancer. They neither produce nor consume the goods, they just cream off the biggest profit of all, based upon their infiltration of both the producer and the consumer.

Furthermore the real source of wealth, a person's labour, has been replaced by money which is merely a medium of exchange for the fruits of person's labour. That has allowed the banking system of today to print money not backed by



as of December 2010, the average house price is £232,628, and the average annual salary for

and national insurance is taken out the average person would take home £19,795.

This means the average person needs over 11 times their annual take home pay to purchase an average home in the UK, but don't worry, the banks have a solution, a mortgage!

Just give them 10% of the purchase price and pay the principal (£209,365) off at the then average rate of 5% a year. That means in your first year alone you will pay them interest of £10,468 (more than half your annual take home pay), before you have paid any of the principal off, so in other words you'll still owe all the money you borrowed.

This is why we have so-called interest only mortgages today, the banks are now quite simply renting property to their customers', whilst putting the property in their customer's name giving them the illusion of ownership. But if you think you own the property, just try getting hold of the title deeds, as even if you only have literally a pound left to pay on the mortgage, the bank still retain these.

As we have seen with the recent so-called credit crunch, if the banks run out of money to run their money printing scams, then they will come back to you to keep them afloat, via your governments, and get bailed out with your tax money (or rather the banks received government money because they were going to collapse, and now the governments are in debt to the banks make sense of that...).

On the other hand, if you cannot pay your mortgage, the bank will evict you from what was always their home, sell the property at an debts every seven years, as opposed to a auction, and leave you owing the difference between what you were still in debt to them for and the rock-bottom price your house received at auction, for the rest of your life.

Oh and by the way, the price of your house can go down as well as up, so although the average is £232,628 now, it may be £100,000 more or less next year, depending on how the money markets are manipulated for the benefit of the few. Are you still proud of living in a democracy?

In a system of just weights and measures, which would come into force under a theocracy (the adherence to Yahweh's laws), food has a price and property has a price, to which the labour of people is relative.

#### Foreword

HALOM ALEYCHEM my fellow pureblooded Yisraelites! I have been working for many years to produce a copy of the Old Testament with the malicious tampering of the Masoretes and so-called "churches"

removed, the Holy Name of Yahweh fully restored, along with the word order corrected where it misrepresents the context of the verse. I have put all margin notes, and the chapter notes following each chapter. Many Strong's numbers are included, but not for every word. Spelling of proper names of people and places are as they appear in the Hebrew.

**Please Note** – Masoretic vowel pointing has many errors, and some are intentional to deceive the readers because of the Babylonian traditions they followed. Spelling is not consistent, and changes from scribe to scribe. At best, they are only a suggestion for pronunciation. The several sects of jewry have different ways of pronouncing many words, and vary also in their particular "traditions" that they follow. Original paleo-Hebrew had no vowels, and there have been two types of vowel indication in more modern times. Many words have unclear meanings, and "opinions" of what they mean were inserted by the former "mistranlators". Where the meanings are unclear, I have put the word in transliterated Hebrew, and note the problem in the notes for the chapter which follow. I have not inserted any opinions in this translation. 

Please have whatever version of Scripture you have been using nearby when studying for comparison. Proper names here will be spelled as in the Hebrew, and it might be confusing to you, so check your other text for reference. The word Elohiym / elohiym 430 has many variations, as to changes in tense, so you may need to reference those as well.

I have transliterated the Hebrew into English letters, followed by the Strong's<sup>©</sup> number for the pages opposite my English translation. This will help you to become more familiar with Hebrew. Word order in the Hebrew is not always the same as in English. I have changed it in the English where it has changed the context of the sentence. I have not changed the entire text, but only where it was needed for clarity. Many words in Hebrew require several words in English. Where this occurs the English words will be underlined to indicate one Hebrew word.

Elohiym (#430) – Plural in construction, often in singular application, especially as a title for Yahweh. When used thusly, it is similar to the majestic "we" used by royalty, as "We decree ... " when one person is speaking. As applied to Yahweh, it carries the meaning of "Supreme Divine Being", above all other divine beings such as "angels", or false "gods" (fallen angels). It has a capital E.

1. When used with a lower-case e, it refers to false "gods" (mighty ones), judges, magistrates, and

generally has the meaning of some kind of power when associated with people.

2. El (#410)- Has the meaning of "God", or "gods", depending upon the "E/e".

- 3. Elohayy (#430) My God
- 4. Elohey (#430) God of ...

6. Eloheynu (#430) – Our God



## No More Law? (Part 2) **By Arnold Kennedy**



The Judaisers.

**HESE WHO TROUBLED** the early disciples of Jesus were concerned with the commandments of men and not the commandments of God. Several of Paul's letters deal with circumcision of the flesh, just as the above passage in Colossians. This is because of problems the local ecclesia were having with the "Judaisers".

Acts 15:1-2 And certain men which came down from Judaea taught the brethren, and said, Except ye be circumcised after the manner of Moses, ye cannot be saved.

Those men of Judah were robbing the uncircumcised 'gentilised' House of Israel of "redemption" i.e., restoration from their alienated (divorced) condition to fellowship with the law, do by nature the things contained in the

the 'circumcised' during the sabbaths, new moons, holy days (Col. 2:16). The Judaisers were saying in essence, "don't come near us, we are holier than thou because we're circumcised and you're not." Recall that Peter was rebuked by this same group for even eating (sitting down to meat and drink - Colossians 2:16)- with the uncircumcised of the House of Israel-[Acts 1 1:2-3].

Paul circumvented this problem by showing that Abraham obeyed God's commandments before he was circumcised!

Romans 4:9-10 Cometh this blessedness then upon the circumcision only, or upon the uncircumcision also? For we say that faith was reckoned to Abraham for righteousness. How was it then reckoned? when he was in circumcision, or in un-circumcision? Not in circumcision, but in un-circumcision.

Abraham obeyed God prior to circumcision.

Gen. 26:5: Because that Abraham obeyed my voice, and kept my charge, my commandments, my statutes, and my laws.

Paul laid the foundation for Romans 4 in Romans chapter 2

Rom 2:14-15 and 26-27. For when the Gentiles [i.e. ethnos - House of Israel], which have not law, these, having not the law, are a law unto themselves: which shew the work of the law written in their hearts, their conscience also bearing witness, and their thoughts the mean while accusing or else excusing one another;

Therefore if the un-circumcision keep the righteousness of the law, shall not his uncircumcision be counted for circumcision? And shall not un-circumcision which is by nature, if it fulfil the law, judge thee, who by the letter and the circumcision dost transgress the law?

Before we go on, two important phrases here should be noted, namely "by nature" and "written in their hearts". There is no promise or fulfilment about the Law of God "written in their hearts" and do "by nature", the things contained in the moral law, applying to other then Israel. This is made clear in the context of the verse below.

Hebrews 8:9-11 Not according to the covenant that I made with their fathers in the day when I took them by the hand to lead them out of the land of Egypt; because they continued not in my covenant, and I regarded them not, saith the Lord. For this is the covenant that I will make with the house of Israel after those days, saith the Lord; I will put my laws into their mind, and write them in their hearts: and I will be to them a God, and they shall be to me a people:

Continuing, circumcision of the flesh was a sign of the covenant that was added after Abraham proved his faith by obedience to the Lord's Laws. Because of this, when the divorced House of Israel (i.e., "uncircumcised Gentiles") showed the work of the law written in their hearts, they proved their faithfulness just as Abraham did without circumcision of the flesh. But those who were circumcised in the flesh and not in the heart were exposed as hypocrites.



#### "BLOTTING OUT THE HANDWRITING".

Back to Colossians, the "blotting out the handwriting of ordinances that was against us" is blotting

out the commandments of men which may also contain the sacrificial law. It is not the moral law as those who want to lump both together teach.

The word 'ordinances' here-(Strong's # 1378 -1379) is dogma in the Greek, which is where we get the word dogmatic, synonymous with 'traditions of men.' It is nothing like the same Greek word for ordinances as used in Luke 1:6 speaking of Zacharias and Elisabeth who "were both righteous before God, walking in all the commandments and ordinances of the Lord blameless." The latter word is Strong's number 1345-dikaioma, clearly implicating the Lord's moral ordinances.

It was the dogma of these Judaisers that had long kept uncircumcised and divorced Israel from being "saved" and brought back into fellowship. First, they held these Israelite "gentiles" under the judgement of divorce-(John 4:9). Then, even after Christ, the Judaisers thought that the only way these "gentiles" could come into fellowship was through circumcision. But, by the sacrifice of Jesus, in spite of the Judaisers, He "saved" His people anyway, nailing their dogmatic requirements to His cross (Col. 2:14) and fulfilling the judgement of divorce (Deut. 24:1-4 and Romans 7:1-4), thus bringing the uncircumcised House of Israel, ["gentiles" in dispersion], back to himself and into fellowship with the House of Judah. This is vividly demonstrated:

**Ephesians 2:11** Wherefore remember, that ye being in time past Gentiles in the flesh, who are called un-circumcision by that which is called the Circumcision in the flesh made by hands;

That at that time you were without Christ, being aliens [Greek: alienated - i.e. divorced] from the Commonwealth of Israel, and strangers from the covenants of promise, having no hope, and without God in the world, But now in Christ Jesus ye who some times were far off are made nigh by the blood of Christ. For he is our peace, who hath made both one, and hath broken down the middle wall of partition between us; Having abolished in his flesh the enmity, even the law of commandments contained in ordinances [dogma]; for to make in himself of twain one new man, so making peace;

And that he might reconcile both unto God in one body by the cross, having slain the enmity thereby:

And came and preached peace to you which were far off, and to them that were nigh.


For through him we both have access by one it. The passage is convoluted to mean, "don't let anyone judge you if you don't want to keep the

Now therefore ye are no more strangers and foreigners, but fellow- citizens with the saints, and of the household of God.

The "middle wall" is the enmity between the Houses of Judah and Israel-(see Isaiah 9), and not between "Jews and Gentiles" in the popular concept. The House of Israel was "far off" and the House of Judah was "nigh".

This passage perfectly sets forth fulfilment of the prophecy of the "two sticks" found in Ezekiel 37:15-28 where the "sticks" or "sceptres" of Joseph, representing the Houses of Israel and Judah becoming joined as one in the prophet's hand, symbolic of re-uniting the divided kingdom-(See especially Ezek. 37 verse 22).

#### WHERE DO THINGS LIKE THE SABBATH COME IN?



Consideration is not made here as to which day of our present week is the Sabbath.

The important point here is perhaps at the very heart of questions about law and whether the Sabbath was abolished in Christ. Paul says:

**Colossians 2:16-17** Let no man therefore judge you in meat, or in drink, or in respect of an holy-day, or of the new moon, or of the Sabbath days: Which are a shadow of things to come; but the body is of Christ.

Many believe that because the sacrificial laws were closely tied to the Sabbaths and feasts and that when Christ came to be the final sacrifice, that all holy days or shadows, had fulfilled their purpose. Further proof, they say, is that Jerusalem was destroyed in A.D. 70 thereby bringing a crashing end to the sacrifices, with the Sabbaths and feasts, ending them also. This argument uses Paul's words above to try to prove

it. The passage is convoluted to mean, "don't let anyone judge you if you don't want to keep the Sabbaths, holy days, new moons, or if you do eat pork." This doesn't take into account, however, that the Lord said as recorded in Exodus 3 1:

The Sabbath is a sign between Him and His people for ever,

**1.** It is a perpetual covenant,

**2**. It is tied directly to the pattern of His resting after He made heaven and earth, which was long prior to the ritual sacrifice being codified.

**3**. There were sacrifices every day. The apparent contradiction between that sign/perpetual covenant and verse 16 above is easily resolved with the understanding of the Judaisers' purpose, and the following concepts.

Paul wrote to the Colossians some 30 years after the New Covenant was established by the crucifixion and resurrection. Notice he doesn't say they "were" a shadow of things which came when Christ gave us the New Covenant. He says "are" a shadow of things to come. We cannot say that sometime between Paul and the 21<sup>st</sup> Century we left the "shadows" and now clearly see the object creating the shadow.

I Corinthians 13:12 "For now we see through a glass darkly; but then face to face" is speaking of a time "when that which is perfect is come." Indeed, that which is perfect has not yet come, otherwise Paul would not have spoken of a future day.

Paul's words in Colossians 2:16 were simply encouraging these 'gentilised' Israelites to keep the holy sabbath day as was determined by the Apostles, in spite of the Judaisers. Peter in his vision where unclean animals appeared on a sheet was told to "rise, kill and eat." Peter, knowing that the Lord would not contradict His well established law-("I have never eaten anything that is common or unclean")- states unequivocally that the vision meant "God hath shewed me that I should not call any man common or unclean"- (Acts 10:13-19 and 28). [It is strange how some can refuse what was shown to Peter in order to try to prove that God God's will is expressed. But how does God has changed his mind about pork and shell fish being unclean!]. God's will is expressed. But how does God express His will? Does He simply say, "Love . . ." or does He express His will by giving us His

Lastly, if verses 16 and 17 of Colossians 2 are read together properly, they would say, "Let no man therefore judge you—but the body is of Christ." The word "is" in vs. 17 is not in the original Greek text. In other words, the body of Christ (the circumcised in heart under the New Covenant) is the only group of people capable of judging whether one may sit down to meat and drink on the holy days, based on whether one is obeying His Laws. We can see this acted out where Paul exhorts believers during the Feast of Passover/Unleavened Bread in the following verse

I Corinthians 5:11 But now I have written unto you not to keep company, if any man that is called a brother be a fornicator, or covetous, or an idolater—or a railer, or a drunkard, or an extortioner; with such an one no not to eat.

We will not go into detail here but look at "law" from another perspective.

What God Has Joined.

John 14:15 If ye love me, keep my commandments --- 1 John 5:3 For this is the love of God, that we keep his commandments: and his commandments are not grievous.

In order to serve the Lord faithfully, we must not only distinguish things that differ but also preserve the connection of things God has joined. Law and love are two such things that God has joined. They are inseparable.


What is pleasing to God? This needs some explanation, lest the issue be oversimplified or confused. One of the greatest difficulties in dealing with this subject is the many ways the words themselves, law and love, are used in the Bible. "Law" has differing meanings. Likewise, in Scripture we read of the love of Christ, love for your wife, love for our neighbour, love for our enemies, and a special and peculiar love for the brethren. Volumes have been written on these two little words, law and love.

Every true Christian wants to know how to please God. This desire comes with regeneration and immediately thrusts us into the Bible, where context. We are delivered from the old sacrificial

God's will is expressed. But how does God express His will? Does He simply say, "Love . . ." or does He express His will by giving us His commandments? The Bible clearly does both, all the while teaching us the proper relationship between law and love. We must exercise our best efforts to discern what that relationship is. In terms of discerning what the will of God might be, the answer in the form of the "commandments of God" may be staring the churches in the face as the first step. Some churchgoers almost desperately want to know the will of God, but in doctrine their church hides the "commandments of God" from them.

"All You Need Is Love"?

Every heresy and cult waves the word love around like a banner of virtue. It is their favourite word, but it is never connected to God's law. The hippie movement of the sixties also proclaimed this word-painted on vans and placards-often in the form of "free love." Political and religious liberals continue to speak of love divorced from individual responsibility.



In March of 1965, magazine Time reported a meeting of hundred nine ministers and students at Harvard Divinity School in which thev considered the subject of the "new morality." The title of the article, "Love in Place of Law?" set up

an antithesis. Under the heading, "We Are Delivered," the article said, "Inevitably, the speakers reached no definite conclusion, but they generally agreed, that, in some respects, the new morality is a healthy advance as a genuine effort to take literally St. Paul's teaching that through Christ we are delivered from the law."


Though these words do come from the New Testament, they certainly do not teach what the Harvard speakers implied. Some questions need to be asked about the context of Paul's words: In what respect are we delivered from the law, and, from what laws are we delivered? At times the deliverance is from the individual law of the context. We are delivered from the old sacrificial law. People who are motivated by genuine love are certainly not lawless. They love the moral and ethical standard that Jesus loved and kept, contrary to the words of Princeton president, Paul Ramsey, who said in the same article, "Lists of cans and cannots are meaningless."

Now, we are not surprised at this dangerous, destructive ignorance when we find it among cults, liberals, and agnostics. But when Biblebelieving preachers set up a false antithesis between law and love, we should be shocked, appalled, saddened, and greatly pained.

Setting up a false antithesis between law and love (as if they are conflicting, opposing ideas) is one of the most subtle ways to undermine the Ten Commandments, biblical morality, and true Christianity. Granted there is a difference between law and love; but there is also an immutable connection. The failure to see this unchangeable relationship has led people into countless errors, heresies, and spiritual shipwrecks.

And while they suppose it proper to honour God, from whom they obtain this plentiful provision, in the first place, they offer the first-fruits of their barley, and that in the manner following: They take a handful of the ears, and dry them, then beat them small, and purge the barley from the bran; they then bring one tenth deal to the altar, to God; and, casting one handful of it upon the fire, they leave the rest for the use of the priest. And after this it is that they may publicly or privately reap their harvest. They also at this participation of the first-fruits of the earth, sacrifice a lamb, as a burnt-offering to God.

## Josephus confirms in Book 3, Chapter 10 the calculation of Pentecost, as follows:

When a week of weeks has passed over after this sacrifice, (which weeks contain forty and nine days,) on the fiftieth day, which is Pentecost, but is called by the Hebrews Asartha, which signifies Pentecost, they bring to God a loaf, made of wheat flour, of two tenth deals, with leaven; and for sacrifices they bring two lambs; and when they have only presented them to God, they are made ready for supper for the priests; nor is it permitted to leave any thing of them till the day following. They also slay three bullocks for a burnt-offering, and two rams; and fourteen lambs, with two kids of the goats, for sins; nor is there anyone of the festivals but in it they offer burnt-offerings; they also allow themselves to rest on every one of them. Accordingly, the law prescribes in them all what kinds they are to sacrifice, and how they are to rest entirely, and must slay sacrifices, in order to feast upon them.

#### Josephus confirms in Book 13, Chapter 8 that Pentecost is the day after a Sabbath day:

And truly he did not speak falsely in saying so; for that festival, which we call Pentecost, did then fall out to be the next day to the Sabbath. Nor is it lawful for us to journey, either on the Sabbath day, or on a festival day (24) But when Antiochus joined battle with Arsaces, the king of Parthin, he lost a great part of his army, and was himself slain; and his brother Demetrius succeeded in the kingdom of Syria, by the But on the approach of pentecost, which is a permission of Arsaces, who freed him from his captivity at the same time that Antiochus attacked Parthin, as we have formerly related elsewhere.

#### Josephus confirms in Book 14, Chapter 13 that they continued to celebrate Pentecost:

But while there were daily skirmishes, the enemy waited for the coming of the multitude out of the country to Pentecost, a feast of ours so called; and when that day was come, many ten thousands of the people were gathered together about the temple, some in armor, and some without.

Josephus again confirms in Book 17, Chapter 10 that they continued to celebrate Pentecost:

festival of ours, so called from the days of our forefathers, a great many ten thousands of men got together; nor did they come only to celebrate the festival, but out of their indignation at the madness of Sabinus, and at the injuries he offered them.

#### Dead Sea Scrolls Date

According to a book called the Quman Cave by John M. Allegro, the Dead Sea Scrolls calendar showed that Pentecost was celebrated the 15th of the third month and was called the 'Festival of Weeks' or the 'Festival of First Wheat'. The picture below is from his book. They may have just continued the celebration on the date started with Noah even though Yahweh provided different laws for that date.

## How Venice Rigged the First, and Worst, Global Financial Crash In 1340

IX HUNDRED AND FIFTY YEARS AGO came the climax of the worst financial collapse in history to date. The 1930's Great Depression was a mild and brief episode, compared to the bank crash of the 1340's, which decimated the human population.

The crash, which peaked in 1345 A.D. when the world's biggest banks went under, "led" by the Bardi and Peruzzi companies of Florence, Italy, was more than a bank crash - it was a financial disintegration. Like the disaster which looms now, projected in Lyndon La Rouche's "9th Economic Forecast" of July, 1994, that one was a blowup of all major banks and markets in Europe, in which, chroniclers reported, all credit vanished together," most trade and exchange stopped, and a catastrophic drop of the world's population by famine and disease loomed.

Like the financial disintegration hanging over us in late 1994 and 1995 with the collapse of Mexico, Orange County, British merchant banks, etc., that one of the 1340's was the result of 30-40 years of disastrous financial practices, by which the banks built up huge fictitious "financial bubbles," parasitizing production and real trade in goods. These speculative cancers destroyed the real wealth they were monopolizing, and caused these banks to be effectively bankrupt long before they finally went under.

The critical difference between 1345 and 1995, was that in the fourteenth century there were as yet no nations. No governments had the national sovereignty to control the banks and the creation of credit; or, to force these banks into bankruptcy in an orderly way, and replace fictitious bank donations to the Church. But, goes the myth,

credit and money with national credit. Nor was the Vatican, the world leadership of the Catholic Church, fighting against the debt-looting of the international banks then as it is today; in fact, at that time it was allied with, aiding, and abetting them.

The result was a disaster for the human population, which fell worldwide by something like 25 percent between 1300 and 1450 (in Europe, by somewhere between 35 percent and 50 percent from the 1340's collapse to the 1440's).

This global crash, caused by the policies and actions of banks which finally completely bankrupted themselves, has been blamed by historians ever since on a king -- poor Edward III of England. Edward revolted against the seizure and looting of his kingdom by the Bardi and Peruzzi banks, by defaulting on their loans starting in 1342. King Edward's national budget was dwarfed by that of either the Bardi or Peruzzi; in fact, by 1342 his national budget had become a sub-department of theirs. Their internal memos in Florence spoke of him contemptuously as "Messer Edward"" we shall be fortunate to recover even a part of his debts, they sniffed in 1339.

A "free trade" mythology has been developed by historians about these "sober, industrious, Christian bankers" of Italy in the fourteenth century "doing good" by their own private greed; developing trade and the beginnings of capitalist industry by seeking monopolies for their family banks; somehow existing in peace with other merchants, and explating their greedy sins by



these sober bankers were led astray by kings (accursed governments!) who were spendthrift, warlike, and unreliable in paying their debts which they forced the helpless or momentarily foolish bankers to lend them. Thus, emerging "private enterprise capitalism" was set back by the disaster of the fourteenth century, concludes the classroom myth, noting in passing that 30 million people died in Europe in the ensuing Black Death, famine, and war. If only the "sober, Christian" bankers had stuck to industrious "free trade" and prosperous city-states, and never gotten entangled with warlike, spendthrift kings!

#### **The Real Story**

Two recent books help to turn over this cover story, though perhaps that is beyond the intention of their authors. Edwin Hunt's 1994 book The Medieval Super-companies: A Study of the Peruzzi Company of Florence, establishes that this great bank was losing money and effectively going bankrupt throughout the late 1330's, as a result of its own destructive policies -- in Europe's agricultural credit and trade in particular -- before it ever dealt with Edward III.

"Indeed, the great banking companies were able to survive past 1340 only because news of their deteriorated position had not yet circulated—"

#### Just as in 1995

And Hunt adds a shocker for the historians, based on exhaustive restudy of all the surviving correspondence and ledgers of the Bardi and Peruzzi. He concludes that their lending to King Edward III was done with such brutal "conditionalities" seizing and looting his revenues that his true debt to them may have been no more than 15-20,000 pounds sterling when he defaulted.

Mr. Hunt himself works for an international bank, so he knows how such "conditionalities" of lending work today. He probably knows that the true international debt of Third World countries today is a small fraction of what the banks and the International Monetary Fund claim they owe. He definitely understands that fourteenth century England was a Third World country to the Bardi and Peruzzi and Acciaiuoli international banks. They loaned Edward II and Edward III far less than their promises— but their promises have been dutifully added up as "total loans" by historians, starting with their fellow banker Giovanni Villani.

Even if we accept the highest figures ever given for Edward III's 1345 default against the bankers of Florence, the debt to them of the city government of Florence which they controlled, was 35 percent greater, and those bonds also defaulted.

More revealing is the latest work of the historian of Venice, Frederick C. Lane, Money and Banking in Medieval and Renaissance Venice. This work shows that it was Venetian finance which, by dominating and controlling a huge international "bubble" of currency speculation from 1275 through 1350, rigged the great collapse of the 1340's. Rather than sharing the peace of mutual greed and free enterprise with their "allies"- the bankers of Florence- the merchants of Venice bankrupted them, and the economies of Europe and the Mediterranean along with them. Florence was the fourteenth century "New York," the apparent centre of banking with the world's biggest banks. But Venice was "London," manipulating Florentine bankers, kings, and emperors alike, by tight knit financial conspiracy and complete dominance of the markets by which money was minted and credit created.

As long ago as the 1950's, in fact, one historian Fernand Braudel consciously demonstrated that Venice, leading the Italian bankers of Florence, Genoa, Siena, etc., wilfully intervened from the beginning of the thirteenth century to destroy the potential emergence of national governments, "modern states foreshadowed by the achievements of Frederick II." Frederick II Hohenstauffen was the Holy Roman Emperor in the first half of the thirteenth century, an able successor of Charlemagne's earlier achievements in spreading education, agricultural progress, population growth, and strong government. The great Dante wrote De Monarchia in a vain attempt to revive the potential of imperial government based on divine law and natural law, which had been identified with Frederick's reign.

#### Wrote Braudel:

"Venice had deliberately ensnared all the surrounding subject economies, including the German economy, for her own profit; she drew her living from them, preventing them from acting freely— The fourteenth century saw the creation of such a powerful monopoly to the advantage of the city-states of Italy— that the embryo territorial states like England, France and Spain necessarily suffered the consequences."

In addition to what Braudel shows, Venice intervened to stop the accession of the great Alfonso the Wise of Spain, as successor to Emperor Frederick II.

This triumph of "free trade" over the potential for national government, rigged the fourteenth century's global human catastrophes, the worst onslaught of death and depopulation in history. It was not until the Renaissance created the French nation state under Louis XI, 100 years later, and then England under Henry VII, and the Spain of Ferdinand and Isabel, that the human population could recover.

#### **Population: The Fundamental Measure**






Figure 1: The Stonehenge site was built to be slightly elliptical, but it can be seen that a circle of 378 feet diameter perfectly houses the Stonehenge site from 45-degrees azimuth to 225-degrees azimuth. The diameter of that circle is precisely <sup>1</sup>/<sub>2</sub> of the length of the Great Pyramid. A line running through site centre from 135degrees to 315-degrees forms the base of a  $\frac{1}{2}$ scale Great Pyramid and a stone sitting adjacent to the Aubrey Circle (marked "H") helps to

The clearest measure of the destruction wrought by the merchants and bankers of Venice and its "allies" in the financial crash of the fourteenth century, is shown in Figure 1. What had been 400-600 years of increasing population growth in Europe, China, and India (altogether, threefourths of the human population) was reversed.

The world's population collapsed. Famines, bubonic and pneumonic plagues, and other epidemics killed more than 100 million people. Wars, dominated by military slaughters of civilians as in Rwanda and Bosnia today, raged throughout Eurasia; Mongol armies alone slaughtered between 5 and 10 million people. This depopulation did not begin with the 1340's banking crash, although it accelerated after that for nearly a century. The policies of Venetianallied finance were already reversing human population growth for 40-60 years before their speculative cancer completely exhausted what it monopolized, bringing on the 1340's rolling crash of all major banks which had not collapsed earlier.

How did free enterprise finance, with no government able to control it, collapse all the economies of the Eurasian continent? How could banks concentrated in one part of Europe— tiny on the scale of modern banks work such a global catastrophe?

## The Great Pyramid, Khafre & Menkaure Pyramid Geometry Encoded Into The New Zealand Landscape By Martin Doutré

**HERE ARE A MULTITUDE OF THEORIES** concerning the purposes of the Great Pyramid, as well as those of Khafre and Menkaure Pyramids of the Giza Plateau. Whatever the more extended and speculative possibilities were, the edifices worked perfectly to serve the function of a World Bureau of Standards for astronomical cycles, navigation, weights, measures and volumes principles.

It would seem that cousin peoples, travelling from pre-dynastic Egypt to set up colonies on other continents, religiously preserved the knowledge encoded into the pyramids by marking it into their newly discovered and settled landscapes. This profound "out of Egypt" knowledge had to be remembered at all cost, as to lose it was to lose one's grasp on the concept of mobilised, optimised and fully functioning civilisation.

Dimensions and angles of the 3 pyramids of Giza, both internally and externally, code a highly sophisticated and scientific system of metrology in use at a very early epoch. The coffers of each pyramid were, undoubtedly, for housing measuring rods, volume vessels and weights. These were the world's master standard sets, kept in perfect temperature-controlled environments that never varied, summer to winter, day or night.

Ancient emissaries from distant lands could return to Egypt as commissioned representatives of their people to periodically check their nation's weights measures and volumes standards against the master set. New, precisely fashioned sets could also be issued to satellite or more isolated cousin nations and, regardless of certain national, popular preferences related to a weight, measure or volume increment, all standards used were tied to a common origin.

Moreover, all weights and volumes used by individual nations coded some aspect of the lunar cycle or navigational (Earth size) knowledge, etc. Measuring rods used by the cousin peoples were largely the same or simple ratio increases and decreases on the length most preferred by another nation. In order to facilitate trade and the exchange of resources, each system being used regionally was in a fluid, easily calculable ratio relationship to those used in other cousin nations. This standardisation persisted in the Mediterranean and Europe reasonably intact to China and Korea. until a fairly late period of the Roman era.

It can be shown that the measurement systems worked very well and in ratio to each other if based upon the British Standard inch. The same holds true in the ratios existing between volume measures.

Weight systems, which were originally determined by counting out and weighing, mainly, wheat grains (the origin of the term "grains" as a unit of weight) were also in a perfect ratio to each other between nations. Because of these workable relationships in ancient metrology the British Standard of Measurement can be shown to be as old as the pyramids themselves.

#### SO WHO WERE THE "COUSIN PEOPLES" THAT DESCENDED FROM THE PYRAMID BUILDERS?

If we analyse the features of pre-dynastic Egyptian or Sumerian skeletons, then the physical anthropology shows a skeletal type consistent with that found in Swiss cist graves, the London plague pits or the tumulus mounds of Europe. The craniological evidence of pre-dynastic Egyptian or Sumerian skeletons alone shows the long faces of European Caucasoid skull types. Egypt and Mesopotamia were, amongst several other countries in the Middle East and Near East, European homelands before a mass exodus from those increasingly parched territories in about 5000-4000 BC.

The waymark trails composed of cairns and standing stones from this early era exodus were still very much in evidence in the late 1800's. They extended from Israel along the North African coast to the Pillars of Hercules across from Gibraltar, then from Spain to France and Scandinavia. Another set of waymark trails ran to China and Korea.

Despite present academic opinions to the contrary, the pyramids were already steeped in age by 5000 BC, with the possible exception of Menkaure Pyramid, which was abandoned by its builders to the encroaching aridity before it was fully completed.

As these former Egyptian/ Sumerians (to use generalised umbrella terminology) found new homelands around the world on many continents, they encoded their profound pyramid knowledge into the landscape of the colonial territories, such that it could never be lost.

These early, nomadic cousin peoples were known by a multitude of names in various epochs and their migratory history and pedigree is well known in certain historical circles, based establish that line. A perfect 1/2 scale replica of upon well-founded oral traditions, cultural idiosyncrasies and documented evidence.

#### **PYRAMID GEOMETRY**

Two-dimensional representations of the Great Pyramid are found in the geometry of Stonehenge in England, as well as that of the Octagon of Newark, Ohio in North America. Unsurprisingly, Great Pyramid, Khafre and Menkaure two-dimensional geometric representations are found carefully marked into the landscape of the Waitapu Valley region of New Zealand as well.

the pyramid is then drawn, with side slopes equating to 51.84-degrees. The front face of a post on the Avenue marks the position where the two converging lines intersect at the apex.

The actual Great Pyramid, however, always had a flat top and it was essential that it did in order for it to demonstrate specialised "circumference of the Earth" codes based upon the pyramid's vertical height. In the above picture lines brushing the Aubrey Circle posts determine where the "flat top" altar floor of the Great Pyramid commenced.

The two-dimensional geometry of the Great Pyramid is clearly marked into the Stonehenge site...Let's now see how it was (along with the configurations of Khafre and Menkaure Pyramids) carefully marked into the New Zealand landscape half a world away from Stonehenge.




Figure 2: Four yellow circles appear on this map, which are the locations of some of the most important and laboriously created structures of the Waitapu Valley region. Apart from providing stations from which many coded alignments commenced, the primary function of these four sites was to preserve knowledge of the dimensions and angles of the pyramids of the Giza Plateau. (SITE 1)

## The Ruthwell, Or Rood Well, Cross - The Long **Forgotten Marker On The English Scottish Border** John Bayne



UITE accident, while researching the history of Galloway, I came across an item in an obscure journal relating to the Ruthwell Cross, that once marked the border between Scotland and England.

This important part of our heritage is now hidden away in the local parish church.

The Cross was destroyed by the Cromwell regime as it was classified as being "Pagan"! In reality it was the Edomite controllers endeavouring to remove all traces of our Israelite origin. The Ruthwell cross, had inscribed on it the "Vine Motif" - the faces of the four beasts that

represent the four brigades within the 12 tribes - only part of the original was able to be It appears that the monument has been modified incorporated into the restored cross.

by An account of the Ruthwell Cross is given in the book - "We The Skythians" by David Ritchie, to quote:


The Ruthwell stood at the southern end of what was originally known as the Wilderness of Matson, on the coast of the Solway Firth, the southern border between Scotland and England. The Rood in the title refers to the Holy Rood, the Sacred Measure that was part of the Royal Regalia of Scotland. Holyrood Palace, at the foot of Arthur's Seat, refers to the same artefact, but 'Rood' is also the medieval name for the Tree of the Crucifixion.

The Holy well by which it stood has an origin in the far distant time :before the Romans came to conquer and the Ruthwell Cross itself contains a riddle. In very ancient times it was moved a short distance to its current location from the Solway shore at Priestside. That's not the riddle.

The monument had been destroyed in 1642 by order of the General Assembly of the Church of Scotland as being idolatrous, but it was later restored and relocated to the church at Ruthwell by local subscription.

at various times in its history, the cross part itself

being of a different sandstone to the base column historians and creates the debate about its and probably added long after the original construction. Notice in the centre of the cross that the three-pointed pyramid symbol in a circle is opposed on the other side by a fourteenpointed rosette  $(3 \times 14 = 42)$  with a face in the centre, representing the Sun. (DunDreich is 1/14 north of Giza) The elaborate carving on the cross contains many Biblical scenes depicting the life of Jesus Christ.



The main panel in the centre of the north face shows Him as Judge, trampling on the Lion and the Adder. One panel shows a scene of Christ healing a blind man; another shows Mary Magdalene washing His feet. Around the border of the Biblical scenes is a series of texts, in Latin, describing each tableau. However, the sides of the column have a completely different type of carving style, older but far superior to the reworked front and back.

The carving on the east and west sides depicts a vine populated by animals, it is called 'the inhabited vine', a reference to the Tree of Life. This type of carving is also found at St Bede's monastery in Jarrow, exactly 77 miles to the east at the same latitude of 55° N. This fact is unlikely to be a coincidence. Jarrow is on the east coast on the south bank of the River Tyne opposite Wallsend, the eastern terminus of Hadrian's Wall and astride the 11th division Ruthwell and Priestside are sitting on the '137' - grid longitude, one whole division west of the Roseline. The Cross was reputed to be a 'Preaching Cross' where sermons were delivered to the populace by the Priesthood of the day, but as I said, there is a riddle to be found here.

The 'Inhabited Vine' carving also has a text inscribed into the border, but it's not in Latin, it is written in old Anglo Saxon runes. It is the context of this older inscription that puzzles

original construction date. The problem is that the Runic script was not the language of Roman Christianity, which did not take hold in this part of Celtic Scotland until around 682 AD. The text in runes is excerpted from one of the oldest poems in British literature, 'The Dream of the Rood'.

This ancient encrypted poem is a tale told from the point of view of the tree, or rood, on which Christ. was crucified, but it contains some very interesting elements that allude to aspects of the Cross not found in the usual crucifixion tableau. In fact, it appears to be referencing the **Book of** Ezekiel once again. The arms of the Ruthwell Celtic Cross contain the symbols known in Masonic lore as the 'Four Living Creatures'. They are from Ezekiel's description of the Ophanim, the 'whirling wheels', the four faces.

Ruthwell's most inhabitant famous was the Rev. Dr. Henry Duncan. He was minister, а author, antiquarian, geologist, publisher, philanthropist, artist and businessman. In 1810, Dr. Duncan opened the world's first commercial

savings bank, paying interest on its investors' modest savings. The Savings Bank Museum tells the story of early home savings in Britain.

In 1818, Dr. Duncan restored the Ruthwell Cross, one of the finest Anglo-Saxon crosses in the United Kingdom, now in Ruthwell church, which had been broken up in the Scottish Reformation. This cross is remarkable for its sculpture and inscriptions in Latin and Old English, some in Anglo-Saxon runes, which include excerpts from The Dream of the Rood, an Old English poem. After the Disruption of 1843 in the Church of Scotland, Dr. Duncan became one of the founding ministers of the Free Church of Scotland.

Us seamen had the same procedure imposed on us (at great expense to the ship owners) in 1931, when they "rationalised" helm orders. Politicians are NOT rational.



## Magnetism And The Standing Stones Charles Brooker Traces Some Physical Forces In Oxfordshire

It was prompted by Don Robbins article on the "Dragon project" ("the talking stones", 21st October page 166) to dig out some notes that I had made on the Rollright Stones. My work involves the effects of lifeforms of the Earth's magnetic field. The investigation concerns whether "extrasensory" perception was related to any environmental components. From speculations about the homing instinct that most animals process, I became interested in the concept of ley lines and the puzzle of how our ancestors knew the certain location on the surface of the earth, and paths between them, were of special significance. If there really is some significance to these locations and if the significance cannot be detected by the five accepted senses, it seemed to me sensible to test the sites for unusual magnetic effects.

I must admit I knew nothing about megalithic sites, or dowsing, or the means of measuring magnetic fields. In my working life I have been an engineer. My plan was to obtain the services of an expert dowser to survey a megalithic site and the area surrounding it, then to check out the same area with a magnetometer. I didn't even know how a magnetometer works; but fortunately I live near the Institute of oceanographic sciences, Wormley, and their Dr. A. I. Rees advised me of the problems that would face me and he suggested how I should tackle them. He ruled out Stonehenge as a test site because of the high level of noise due to human activity in the vicinity, and advised me to head for the Hebrides. Alas it was not possible for me to make the journey north, but one of the papers Rees lent me mentioned a maker of magnetometers, the Littlemore Scientific Engineering Company, in Oxford, not too far from the only well-known megalithic stone circle in the Midlands. So I went to the site of the Rollright stones in Oxfordshire and persuaded the owner of the land, Miss Pauline Flick, to allow me to experiment there with a borrowed magnetometer.

By chance, I had discovered a Dowser in my own village, a "sensitive" who works by reacting to a tingling sensation in the hands not with the aid of a twitching rod or a pendulum. When I visited

the site, I learnt that several young people had experienced this sort of feeling, although I could not detect it myself. With my hired knapsack magnetometer I surveyed the site by walking in circles inside and outside the stones to locate any intersecting "ley lines" then made several traverses inside the circle along lines running north – south, east – west, NE-SW, and NW-SE. The results of my rough survey were so extraordinary that I decided to hire a more accurate recording magnetometer.

The survey showed lay lines – detected by fluctuations in the local magnetic field – converging on the geometric centre of the stone circle, with a pattern of about half a dozen concentric circles of high and low magnetic intensity also showing up inside the stones. The average intensity of the field within the circle was significantly lower than that measured outside as if the stones acted as a shield.

When my dowser associate joined me on the site and walked around the survey route, she reported tingling sensations exactly where the recording magnetometer produced blips on its charts (of course, she had no knowledge of the magnetometer readings at the time). To my mind, the perfect correlation between the feelings and the instrument confirmed that her skill was based on a magnetic sense. The recorder showed that she could not detect magnetic gradients as small as five gamma in an ambient field of about 0.48 gauss-- 10 ppm. And the dowsing reaction was in response to a reduction not an increase, in field strength.

A more accurate survey was clearly worthwhile. Eventually I found that, as well as the converging ley lines proper, the magnetic pattern inside the stone circle forms a seven rings spiral, broadening as it moves outwards until it leaves the circle by the "eastern gate", what it all means remains a mystery, but it is curious that many of the symbols carved in various agents stones show spirals.

The point I started out to make that mankind, as other animal life, responds to changes in the Earth's magnetic field, was indeed confirmed in this one instance. But the study has opened up a realm of research that is, at least to me, new. I believe that the ancients knew exactly what they were doing, and that the stone circles from magnetic refuges, – Stone Age Faraday cages. Why the wizards should want magnetic refuges, savages as our history books would lead us to though, is another question.

## The Addiction Conspiracy: How Government And Big **Pharma Created An Epidemic Dr. Mercola**



HILE MOST DRUGS come with a long list of potentially devastating side effects, painkillers - courtesy of their addictive nature — tend to be among the most lethal. Prescriptions for opioid painkillers have risen by 300 percent over the past 10 years, and Americans use 80 percent of the world's opioids.

In 2013, about 23,000 Americans died from overdosing on prescription drugs, and painkillers accounted for about 16,000 of those deaths.

Drug Industry Is Responsible for Mass Addiction Many believe the drug companies that create and sell these drugs need to be held accountable for this dangerous trend, especially since several have been caught lying about the benefits and risks of their drugs.

As noted by the Organic Consumers Association (OCA), the drug industry has "fostered the opioid addiction epidemic" in several ways, by:

• Introducing long-acting opioid painkillers like OxyContin, which prior to reformulation in 2010 could be snorted or shot. Many addicts claimed the high from OxyContin was better than heroin.

In fact, from a chemical standpoint, OxyContin is nearly identical to heroin, and has been identified as a major gateway drug to heroin

• Changing pain prescription guidelines to make opioids the first choice for lower back pain and other pain conditions that previously did not qualify for these types of drugs.

• Promoting long-term use of opioids, even though there's no evidence that using these drugs long term is safe and effective

• Downplaying and misinforming doctors and patients about the addictive nature of opioid drugs. OxyContin, for example, became a blockbuster drug mainly through misleading claims, which Purdue Pharma knew were false from the start.

The basic promise was that it provided pain relief for a full 12 hours, twice as long as generic drugs, giving patients "smooth and sustained pain control all day and all night."

However, for many the effects don't last anywhere near 12 hours, and once the drug wears off, painful withdrawal symptoms set in, including body aches, nausea and anxiety. These symptoms, in addition to the return of the original pain, quickly begin to feed the cycle of addiction.

A 2015 article in The Week does a great job revealing the promotional strategy developed by Purdue, and backed by the U.S. Food and Drug Administration (FDA), that has led to such want us to know, that's for sure,' Boffetti said. enormous personal tragedy. As noted in this article,

"The time-release conceit even worked on the FDA, which stated that 'Delayed absorption, as provided by OxyContin tablets is believed to reduce the abuse liability of a drug.'

New Hampshire Suing Over Deceptive Marketing

Several states are indeed trying to hold drug makers accountable for the epidemic of addiction.



One of them is New Hampshire, where the state attorney general's office has filed a lawsuit against Purdue Pharma, accusing the company of deceptive marketing, saying it misrepresented the risks and benefits of long-term opioid use for chronic pain.

But while the attorney general's legal team consists of three people, Purdue has 19 lawyers on the case. As reported by Concord Monitor:

"One year after the state attorney general's office filed subpoenas against five large drug companies to discover how addictive painkillers have been marketed in the state, the pharmaceutical giants have handed over nothing more than legal briefs ...

The current legal fight is whether the attorney general's office can hire outside help.

All of the drug companies have refused to turn over any internal documents, as long as the attorney general's office works with hired counsel — Cohen Milstein — a firm that has litigated similar cases against the pharmaceutical industry.

Lawyers representing the drug companies have argued Cohen Milstein has an inherent bias against them because it will only get paid if the state takes future legal action against the drug companies. A Merrimack County Superior Court judge recently sided with the state, but the drug (WAPF), about the use of low-dose naltrexone companies are refusing to budge-- 'They don't (LDN) for autoimmune diseases. Naltrexone is

OxyContin — The \$30 Billion 'Widow Maker'

Since its approval in 1996, Purdue has raked in more than \$31 billion from the sale of OxyContin. Sales remained unaffected even after Purdue and three of its executives pleaded guilty in 2007 to criminal charges of misleading regulators, doctors and patients about the drug's addiction and abuse risk.

The company paid \$600 million in fines and payments. The three executives, which included Purdue's president and one of its lawyers, agreed to pay another \$34.5 million in fines after pleading guilty of misbranding.

As early as 2003, the FDA ordered Purdue to pull its printed advertisements for OxyContin, saying the ads "grossly misrepresent" the drug's safety profile.

Despite such obvious warning signs that opioids were being misrepresented and misbranded, little was done to rein in their use. More than 194,000 people have died from overdoses involving opioids, including OxyContin, since 1999. During this time, the death rate from overdoses among women has risen by 450 percent.

Addiction among younger adults has also dramatically risen. As noted by Dr. Andrew Kolodny, founder of Physicians for Responsible Opioid Prescribing (PROP), many get caught in a cycle of addiction after being prescribed an opioid drug for a sports injury or wisdom tooth extraction.

But the elderly are the most vulnerable group. Not only are they prescribed opioids more often than younger people, they also have the highest addiction and death rate.

Beware: Opiates Are Potent Immuno-suppressive Drugs

Earlier this month, I interviewed Dr. Thomas Cowan, a family physician and founding board member of the Weston A. Price Foundation an opiate antagonist, originally developed in the early 1960's for the treatment of opioid addiction. It blocks the effects of the narcotic by attaching to opioid receptors in your body.

For heroin overdoses, a dose of about 30 to 50 milligrams (mg) of naltrexone is used to prevent the fatal respiratory depression from a narcotic overdose. However, when used at a very LOW dose, about one-tenth or less of the dose you'd use for opioid addiction, LDN ends up working as an immune booster.

Cowan shared some interesting and largely unknown information about opioids in that interview. As it turns out, opioids are actually very potent immune suppressors. As such they can wreck your health in serious ways, leaving you far worse off than where you started.

A famous study called the European Prostitute Study actually showed the primary risk factor for HIV and AIDS was neither sexual exposure nor IV exposure, but rather opiate exposure. It is believed that over stimulation of the opioid receptors, as from opioid drugs, results in severe immune impairment.

According to Cowan, you will typically see that as soon as a patient starts taking opiates for chronic pain, their health rapidly declines as their immune system becomes increasingly compromised. Besides avoiding addiction, this is another important factor to consider before you start taking a narcotic pain reliever.

Drug maker Knew OxyContin Ended Up in Hands of Criminals and Addicts.

The Los Angeles Times recently published a scathing exposé on Purdue Pharma, describing how the company had extensive knowledge of and evidence showing their drug OxyContin was being sold through pill mills and organized drug rings, yet did nothing to stop it. According to the article:

"[F]or more than a decade, Purdue collected extensive evidence suggesting illegal trafficking of OxyContin and, in many cases, did not share it with law enforcement or cut off the flow of pills. A former Purdue executive, who monitored pharmacies for criminal activity, acknowledged that even when the company had evidence pharmacies were colluding with drug dealers, it did not stop supplying distributors selling to those stores.

Purdue knew about many suspicious doctors and pharmacies from prescribing records, pharmacy orders, field reports from sales representatives and, in some instances, its own surveillance operations, according to court and law enforcement records ..."

Purdue insists it has "at all times complied with the law."16 Yet according to federal law, drug makers are required to report suspicious drug orders and activity to the U.S. Drug Enforcement Administration (DEA), and must also reject orders if they suspect the drugs may be sold on the black market. Purdue did neither.

Senate-Approved Opioid Legislation Another Boon for Drugmakers.

Frustratingly, government action is simply "feeding the beast" that is Big Pharma. While concerns about rising addiction rates led to the passing of the Comprehensive Addiction and Recovery Act, which was approved by the U.S. Senate in May, the bill does little to address the root of the problem.

Rather than punish drug makers who promote addiction through misleading or false marketing, the bill focuses on the treatment of addicts and availability of anti-addiction drugs. For example, the bill will allow doctors and nurse practitioners

to prescribe buprenorphine, which has previously been notoriously difficult to obtain.

Buprenorphine is a partial opioid agonist, so while it's a type of opioid, it's less likely to cause a "high," and hence less likely to promote addiction. Meanwhile, it also functions as a pain reliever.

While safe and effective treatment is certainly necessary, one could argue that replacing one addictive drug with another is not a real solution.

Rather than reining in the misuse and excessive use of narcotic painkillers, the bill simply rewards Big Pharma with more orders for more albeit different — pills!

So the same industry that created the addiction problem in the first place is now rewarded for its callousness, as the government's plan to address the addiction epidemic simply feeds back into the drug industry's pockets.

## The Bartlow Hills Roman Barrows Essex From Our Romford Correspondent



Here is another example of how monuments of our ancestors are being gradually removed in order in order to blind people to their identity as the people of the Bible just as history has been changed down the years. We are grateful to our Romford correspondent for bringing this to our attention.

Bartlow Hills was originally the largest group of Roman barrows in northern Europe and includes the highest burial mound in Britain. The seven mounds covered extraordinarily rich burials containing a wonderful collection of artistic objects, the best found in Britain. Mound IV, the largest, is 45 feet high and 144 feet in diameter. Mound II is still visible as a low rise, I is just discernible and III is totally destroyed. Their steep conical shape, originally surrounded by a ditch, is typical of Roman burial mounds.

Large wooden chests with iron fittings were found in five mounds and there was a brick cist in another.

Cremated burials, with food and drink in exotic vessels of decorated bronze, glass, and pottery and other sacrificial offerings had been deposited in the chests, which were buried with lamps still burning in them. Items found included an iron folding chair and remains of flowers, box leaves, a sponge, incense, and liquids including blood, milk and wine mixed with honey.

Burial mounds of this type were built in the late first and early second centuries AD in Eastern England and Belgium. Most artefacts in them show the high status of the owner; they were usually imported from the Rhineland and Northern Gaul, and are concerned with feasting and sacrificial offerings, rather than personal belongings which would be useful in the After life.

In 1815 Busick Harwood "excavated" VI to provide work for the unemployed...."They began at the apex and digging down at great labour to the cist despoiled it of its contents, which were distributed and no account of them taken". However, some of the humbler items went to Saffron Walden museum where they survive. John Cage carried out better recorded excavations between 1832 and 1840. Eminent scientists, including Faraday, pioneer of electricity, analysed the contents of vessels and other organic remains. Cage's reports are the only evidence we now have, for all the objects were taken to Easton Lodge, Dunmow, where they were destroyed by fire in 1847.

The surviving mounds became overgrown before they were taken into guardianship by Essex County Council in 1978. the scrub was cleared and fences built for protection. the Hills passed to Cambridgeshire County Council in 1990 after a change in the County boundary. Built of chalk and unusable for agriculture, the hemmed in by trees, suddenly you are confronted surviving mounds are a refuge for the distinctive plants and insects of chalk grassland; the Pasque flower grew here until early this century. Regular mowing in late summer will prevent the scrub from spreading.

The barrows are the largest group of Roman barrows in Northern Europe. Think Silbury Mound, high conical mounds sprouting a luscious green growth of plants. Seven originally, though now only three remain.

The Barrows are set in a wood, approached along a dark and winding path, suddenly the space opens up. shading trees give way to bright sunshine. Their greeting is unexpected, closely by three miniature mountains.

Steps up the side of the tallest barrow - 45 feet high. Built of chalk, similar to Silbury, these barrows house rich pagan burials of the late 1st to early 2nd century.

Large wooden chests, cremated burials, food and drink in exotic vessels of bronze, glass and pottery, these were foreign imported goods reflecting the high status of the deceased; concerned more with feasting and sacrificial offerings rather then take all this worldly wealth to the other world. Lamps left to burn, what did that signify? a light for the spirit to see as he departed this world.






