The Old Jerusalem is Not the New Jerusalem Pastor Eli James Comments on Sheldon Emery's Classic

Historic Jerusalem is not Prophetic Jerusalem

"For out of Zion shall go forth the law, and the Word of the Lord from Jerusalem" (Isaiah 2:3).

JERUSALEM, Jerusalem. There is probably more confused preaching in recent years on "Jerusalem" than on any other name from Scripture except perhaps "Jew."

Scripture, such as that quoted above, is used by a great many Christian ministers to mean the literal city of Jerusalem in old Palestine. They say that there God is going to restore His Israel people and begin to set up His earthly kingdom from which Jewish missionaries will go out to preach the gospel all over the world! Other ministers claim this Jerusalem is a "heavenly" city located somewhere other than on the earth.

One of the major sources of confusion in today's preaching comes from ministers who are unable to separate historic Biblical cities from prophetic cities of the Bible. They do fairly well on Babylon, since the actual city has been destroyed and exists no more in the earth. So when "Babylon" is used in prophecy, they realize it must be something other than the old city.

But with Jerusalem they are fooled. Because the old city still exists and still carries its ancient name, they assume prophetic Jerusalem must have something to do with the old city of Jerusalem.

It was Voltaire who is credited with saying, "If you would speak with me, define your terms." He realized that words must have an understandable meaning to both parties to a conversation, or one would be confused or deceived. And so

it is with "Jerusalem." I want you to follow me in the Scriptures to find God's true meaning of Jerusalem, when He says, "For out of Zion shall go forth the law, and the Word of the Lord from Jerusalem."

In Matthew 23:37-39 we read the words of Jesus Christ: "O Jerusalem, Jerusalem, thou that killest the prophets, and stonest them which are sent unto thee, how often would I have gathered thy children together, even as a hen gathereth her chickens under her wings, and ye would not! Behold your house is left unto you desolate. For I say unto you, ye shall not see Me henceforth, till ye shall say, blessed is he that cometh in the Name of the Lord."

[Can you imagine the Jews calling on the Name of Yahshua Messiah (Jesus Christ)? Never! The fool hath said "The Jews will all be converted just before the Judgment Day!" -- Eli]

Here Christ was speaking to the city of Jerusalem that He was standing and looking at Jerusalem, the city that had killed Israel's prophets down through the centuries; and He said, Jerusalem, "your house is left unto you desolate." He could not have been speaking of prophetic Jerusalem, for that has a glorious future!

The Lord Shall Yet Choose Jerusalem

I will quote some Scripture verses used by those who insist that the old city of Jerusalem will be the Jerusalem that will be "chosen" and "blessed" of God. They are in the first chapter of Zechariah. "I am jealous for Jerusalem and for Zion with great jealousy—I am returned to Jerusalem with mercies: My house shall be built in it ... and the Lord shall yet comfort Zion, and shall yet choose Jerusalem." These are phrases from verses 14 through 17, and those who quote them say they mean that God will set up the temple (His house) at some future time in the old city of Jerusalem.

But there are other phrases in the same verses which must be considered. I will add them here in their context. "Thus saith the Lord of Hosts; My cities through prosperity [good] shall yet be spread abroad." Then comes "and the Lord shall yet comfort Zion, and shall yet choose Jerusa-

lem." Since the phrase, "spread abroad," was spoken through Zechariah while he was in old Palestine, it could mean places other than old Palestine!

Christ also gave some indication that the cities of Israel would be in great number and cover much territory. In Matthew 10 are His well known instructions to the twelve disciples. In verse 6, He tells them to "go rather to the lost sheep of the house of Israel," and then in verse 23 He says, "For verily I say unto you, ye shall not have gone over the cities of Israel, till the Son of man be come." The disciples could have gone over the towns in old Palestine in a matter of weeks, and missionaries still could do so today. But if the cities of Israel were to be "spread abroad" and to be a great number, it could not be done so quickly.



We must also take into consideration that Zechariah, as a prophet to Israel, spoke not only to those in the Babylonian captivity, but to the millions of Israelites who were at that time in the Assyrian lands and never returned to Jerusalem or Palestine. That Zechariah's prophecy above was not fulfilled by the return of less

than 45,000 Jews from Babylon under Ezra and Nehemiah will be clear as we go on. Also, what the "Jerusalem" is that the Lord "shall yet choose" is made clearer by reading on in the next verses from the same prophet.

An Angel Will Measure New Jerusalem

Read on in Zechariah 2:1-4, "I lifted up mine eyes again, and looked and behold a man with a measuring line in his hand. Then said I, Whither goest thou? And he said to me, To measure Jerusalem, to see what is the breadth thereof, and what is the length thereof. And, behold, the angel that talked with me went forth, and another angel went out to meet him. And said unto him, Run, speak to this young man, saying, Jerusalem shall be inhabited as towns without walls for the multitude of men and cattle therein."

That is quite a description. "Towns" (plural) and many men and cattle were to be in it. This is the

Jerusalem of prophecy, and it is so large it took an angel to measure it! Maybe this was because it had been then "spread abroad" as was prophesied in Zechariah 1:17.

In chapter 8 of Zechariah (and Zechariah has much to say about prophetic Jerusalem) we read in verse 2, "Thus saith the Lord of hosts; I was jealous for Zion with great jealousy and I was jealous for her with great fury. Thus saith the Lord; I am returned unto Zion, and will dwell in the midst of Jerusalem." So God says He will be in both Zion and Jerusalem. Zion is the seat of government; Jerusalem is the whole nation.

"And Jerusalem shall be called a city of truth; and the mountain of the Lord of hosts the holy mountain." (vs. 3) This is similar to what we have in Isaiah 2 and Micah 4, "the mountain of the Lord." It will help you understand prophecy, if you know that mountain usually means nation. Micah, Isaiah, Zechariah and others are actually saying that prophetic Jerusalem will be the nation of the Lord.

Then in verse 7 of Zechariah 8 we read, "Thus saith the Lord of hosts; Behold I will save My people from the east country, and from the west country; and I will bring them, and they shall dwell in the midst of Jerusalem: and they shall be My people, and I will be their God, in truth and in righteousness." God is saying that "My people" (Israel) will be brought to this Jerusalem by Him, and they will be His people "in truth and in righteousness." i.e. they will be Christians.

Preachers Confuse Old City with New Jerusalem

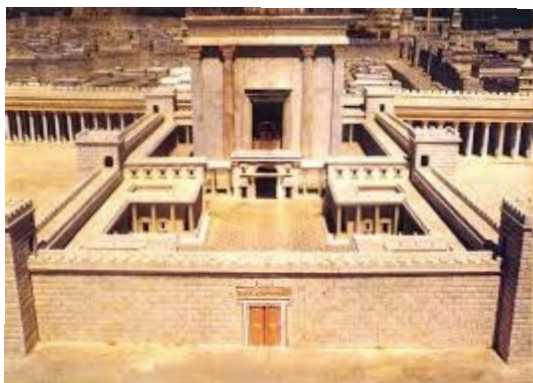
Now if we take these prophecies and attempt to put them in little old Palestine, we are in trouble! It is just not big enough. As these scriptures show, the Lord will dwell there, Zion will be there, many from the east country and the west country, a multitude of men and cattle, and it will spread abroad and be so large that angels will have to measure it.

I have some statistics on the Jewish occupied area of old Jerusalem and Palestine that will show it is not the size for a "multitude of people." Jerusalem, as it was set aside by the United Nations, has 289 sq. miles. It is about 20 miles long and 15 miles wide. That would be about

the size of Phoenix, Arizona and its suburbs or twice the size of Baltimore.

The entire country of Palestine, as established by the U.N. mandate, was 7,993 sq. miles. Since the so-called war in 1967, the area controlled has increased substantially, but even if they took control of several entire Arab countries, it would still be smaller than an average American state! That is hardly fitting for Zechariah's prophecy, is it?

Temple at Old Jerusalem to be Like Shiloh



The confusion among ministers is also caused by their mistaken belief that God chose the old city of Jerusalem perpetually as the place where He would place His Name. But like Shiloh, Jehovah's presence there was conditional upon Israel obeying God. This is made very plain in Jeremiah 7 where we read, "The Word that came to Jeremiah from the Lord, saying, Stand in the gate of the Lord's house [the temple in Jerusalem], and proclaim there this word, and say, Hear the Word of the Lord, all ye of Judah, that enter in at these gates to worship the Lord."

So God gave Jeremiah a commandment to speak to all those who worshipped at the temple. Verses 3 through 10 give a promise that if they obeyed the Lord, they would then, "dwell in this place, in the land that I gave to your fathers, for ever and ever."

But then God accused them of disobeying and said, "Is this house which is called by My Name, become a den of robbers in your eyes? Behold, even I have seen it, saith the Lord. But go ye now unto My place which was in Shiloh, where I set My Name at the first, and see what I did to it for the wickedness of My people Israel" (verses 11-12).

Then God pronounced the fate of the temple at Jerusalem, "Therefore will I do unto this house [the temple], which is called by My Name, wherein ye trust, and unto the place which I gave to you and your fathers [Jerusalem and Judah], as I have done to Shiloh."

So in order to see what God has done to Jerusalem, we must see what he did to Shiloh. Its history as the place where God had set His name at the first starts in Joshua 18:1, "And the whole congregation of the children of Israel assembled together at Shiloh, and set up the tabernacle of the congregation there." The ark of the covenant was there, and it was there that the high priests sacrificed to the God of Israel.

This continued for many years for we read in Judges 18:30-31, "And the children of Dan set up the graven image: and Jonathan, the son of Gershom, the son of Manasseh, he and his sons were priests to the tribe of Dan until the day of the captivity of the land [Philistine captivity]. And they set them up Micah's graven image, which he made, all the time that the house of God [the tabernacle] was in Shiloh."

God To Forsake Shiloh

Then in 1 Samuel we read the story of God's leaving Shiloh, as He was later to leave Jerusalem. This is quite lengthy and requires the reading of all Chapters 2 through 7. We will quote only a few verses because of space limitations.

The story begins in 1 Samuel 2:12 with the sons of Eli, "Now the sons of Eli were the sons of Belial; they knew not the Lord." Because of their abominations and the sins of Israel, the Lord appeared to Eli and among other things told him, "Behold the days come, that I will cut off thine arm, and the arm of thy father's house, that there shall not be an old man in thine house. And thou shalt see an enemy in My habitation [the tabernacle at Shiloh]. And this shall be a sign unto thee, that shall come upon thy two sons, on Hophni and Phinehas; in one day they shall die both of them."

Then God tells Eli what will replace His habitation. "And I will raise me up a faithful priest, that shall do according to that which is in mine heart and in My mind; and I will build him a sure house..." This was a reference to Samuel.

Shiloh Forsaken

God then set about to carry out this promise of punishment to Eli and removing Himself from Shiloh. In Chapter 4, the Philistines won a battle against the Israel armies, and Israel made a decision (1 Samuel 4:3). "And when the people were come into the camp, the elders of Israel said, Wherefore hath the Lord smitten us to day before the Philistines? Let us fetch the ark of the covenant of the Lord out of Shiloh unto us, that, when it cometh among us, it may save us out of the hand of our enemies." Instead of putting their trust in God, they put their trust in the physical ark.

Verses 10 and 11 tell the results: "And the Philistines fought, and Israel was smitten, and they fled every man into his tent - and there was a great slaughter; for there fell of Israel thirty thousand footmen. And the ark of God was taken, and the two sons of Eli, Hophni and Phinehas, were slain." God's promise that the enemy would be in His habitation and that the sons of Eli would both be slain in one day had come to pass.

Eli died when he heard the news, and Phinehas' widow was so shocked by the events that she was immediately delivered of her child. That she recognized the terrible disaster to Israel is shown in the name she gave the baby. "And she named the child Ichabod, saying, The glory is

departed from Israel: because the ark of God was taken" (verse 21).

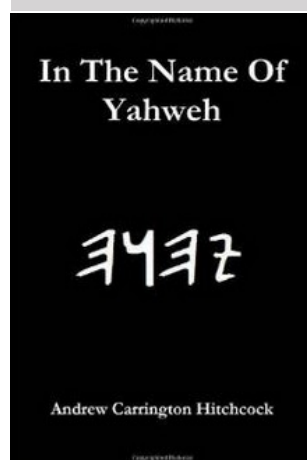
The Lord had departed from Shiloh

Ramah - Then Jerusalem: Chapter 7 shows that God then gave Samuel rule over Israel, but he did not worship at Shiloh for we read in verses 15-17, "And Samuel judged Israel all the days of his life. And he went from year to year in circuit to Bethel, and Gilgal, and Mizpeh, and judged Israel in all those places. And his return was to Ramah; for there was his house; and there he judged Israel; and there he built an altar unto the Lord."

Psalm 78:59-61 verifies this forsaking of Shiloh in this manner: "When God heard this [Israel's abomination] He was wroth, and greatly abhorred Israel: So that He forsook the tabernacle of Shiloh, the tent which He placed among men; and delivered His strength into captivity, and His glory into the enemy's hand." Then verses 65-72 refer to the placing of His temple in Jerusalem under David and Solomon. Most Bible students know the story, so we will not recount it here. But the Psalmist does verify that Shiloh was forsaken. So, if Jerusalem was to be "as Shiloh," and if God's Word is true, which it is, then the old city of Jerusalem is forsaken and deserted by the God of Israel forever!

The laws that neither fat nor blood may be eaten.

LEVITICUS 11:1 – And Yahweh (the LORD) spake unto Moses and to Aaron, saying unto them,

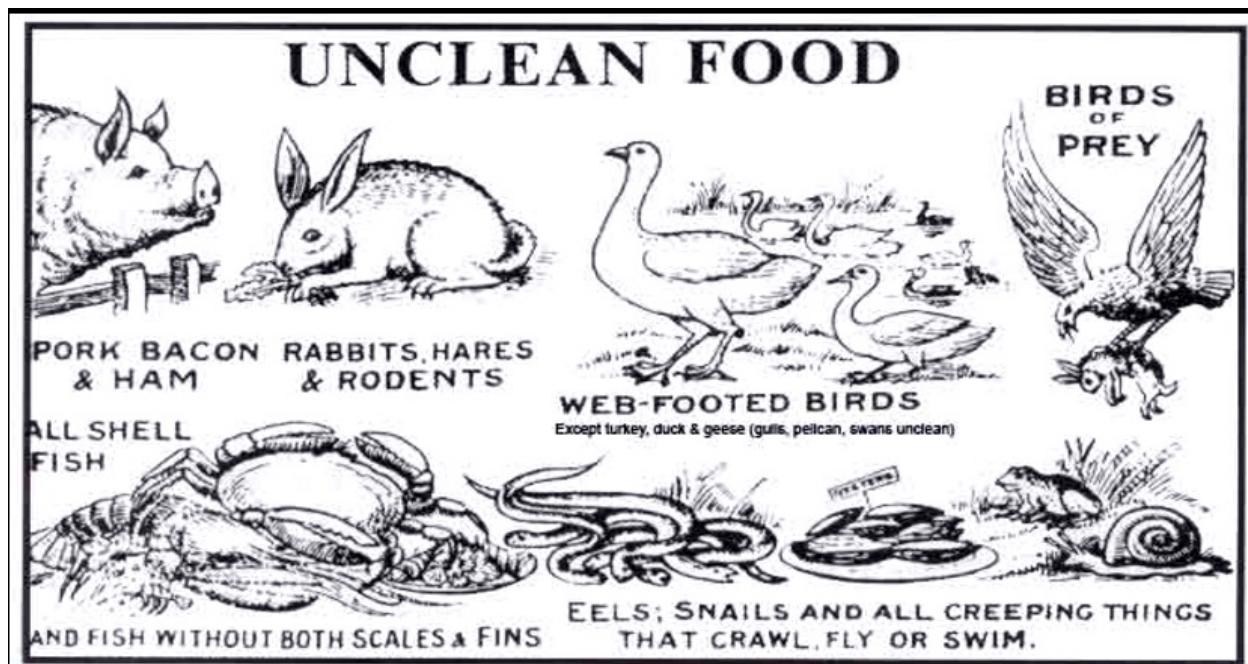
Leviticus 11:2 – Speak unto the children of Israel, saying, These [are] the beasts which ye shall eat among all the beasts that [are] on the earth.

Leviticus 11:3 – Whatsoever parteth the hoof, and is clovenfooted, [and] cheweth the cud, among the beasts, that shall ye eat.

Leviticus 11:4 – Nevertheless these shall ye not eat of them that chew the cud, or of them that divide the hoof: [as] the camel, because he cheweth the cud, but divideth not the hoof; he [is] unclean unto you.

Leviticus 11:5 – And the coney, because he cheweth the cud, but divideth not the hoof; he [is] unclean unto you.

Leviticus 11:6 – And the hare, because he cheweth the cud, but divideth not the hoof; he [is] unclean unto you.



Leviticus 11:7 – And the swine, though he divide the hoof, and be clovenfooted, yet he cheweth not the cud; he [is] unclean to you.

Leviticus 11:8 – Of their flesh shall ye not eat, and their carcase shall ye not touch; they [are] unclean to you.

Leviticus 11:9 – These shall ye eat of all that [are] in the waters: whatsoever hath fins and scales in the waters, in the seas, and in the rivers, them shall ye eat.

Leviticus 11:10 – And all that have not fins and scales in the seas, and in the rivers, of all that move in the waters, and of any living thing which [is] in the waters, they [shall be] an abomination unto you:

Leviticus 11:11 – They shall be even an abomination unto you; ye shall not eat of their flesh, but ye shall have their carcases in abomination.

Leviticus 11:12 – Whatsoever hath no fins nor scales in the waters, that [shall be] an abomination unto you.

Leviticus 11:13 – And these [are they which] ye shall have in abomination among the fowls; they shall not be eaten, they [are] an abomination: the eagle, and the ossifrage, and the osprey,

Leviticus 11:14 – And the vulture, and the kite after his kind;

Leviticus 11:15 – Every raven after his kind;

Leviticus 11:16 – And the owl, and the night hawk, and the cuckow, and the hawk after his kind,

Leviticus 11:17 – And the little owl, and the cormorant, and the great owl,

Leviticus 11:18 – And the swan, and the pelican, and the gier eagle,

Leviticus 11:19 – And the stork, the heron after her kind, and the lapwing, and the bat.

Leviticus 11:20 – All fowls that creep, going upon [all] four, [shall be] an abomination unto you.

Leviticus 11:21 – Yet these may ye eat of every flying creeping thing that goeth upon [all] four, which have legs above their feet, to leap withal upon the earth;

Leviticus 11:22 – [Even] these of them ye may eat; the locust after his kind, and the bald locust after his kind, and the beetle after his kind, and the grasshopper after his kind.

Leviticus 11:23 – But all [other] flying creeping things, which have four feet, [shall be] an abomination unto you.

Leviticus 11:24 – And for these ye shall be unclean: whosoever toucheth the carcase of them shall be unclean until the even.

Leviticus 11:25 – And whosoever beareth [ought] of the carcase of them shall wash his



clothes, and be unclean until the even.

Leviticus 11:26 – [The carcasses] of every beast which divideth the hoof, and [is] not clovenfooted,

nor cheweth the cud, [are] unclean unto you: every one that toucheth them shall be unclean.

Leviticus 11:27 – And whatsoever goeth upon his paws, among all manner of beasts that go on [all] four, those [are] unclean unto you: whoso toucheth their carcass shall be unclean until the even.

Leviticus 11:28 – And he that beareth the carcass of them shall wash his clothes, and be unclean until the even: they [are] unclean unto you.

Leviticus 11:29 – These also [shall be] unclean unto you among the creeping things that creep upon the earth; the weasel, and the mouse, and the tortoise after his kind,

Leviticus 11:30 – And the ferret, and the chameleon, and the lizard, and the snail, and the mole.

Leviticus 11:31 – These [are] unclean to you among all that creep: whosoever doth touch them, when they be dead, shall be unclean until the even.

Leviticus 11:32 – And upon whatsoever [any] of them, when they are dead, doth fall, it shall be unclean; whether [it be] any vessel of wood, or raiment, or skin, or sack, whatsoever vessel [it be], wherein [any] work is done, it must be put into water, and it shall be unclean until the even; so it shall be cleansed.

Leviticus 11:33 – And every earthen vessel, whereinto [any] of them falleth, whatsoever [is] in it shall be unclean; and ye shall break it.

Leviticus 11:34 – Of all meat which may be eaten, [that] on which [such] water cometh shall

be unclean: and all drink that may be drunk in every [such] vessel shall be unclean.

Leviticus 11:35 – And every [thing] whereupon [any part] of their carcass falleth shall be unclean; [whether it be] oven, or ranges for pots, they shall be broken down: [for] they [are] unclean, and shall be unclean unto you.

Leviticus 11:36 – Nevertheless a fountain or pit, [wherein there is] plenty of water, shall be clean: but that which toucheth their carcass shall be unclean.

Leviticus 11:37 – And if [any part] of their carcass fall upon any sowing seed which is to be sown, it [shall be] clean.

Leviticus 11:38 – But if [any] water be put upon the seed, and [any part] of their carcass fall thereon, it [shall be] unclean unto you.

Leviticus 11:39 – And if any beast, of which ye may eat, die; he that toucheth the carcass thereof shall be unclean until the even.

Leviticus 11:40 – And he that eateth of the carcass of it shall wash his clothes, and be unclean until the even: he also that beareth the carcass of it shall wash his clothes, and be unclean until the even.

Leviticus 11:41 – And every creeping thing that creepeth upon the earth [shall be] an abomination; it shall not be eaten.

Leviticus 11:42 – Whatsoever goeth upon the belly, and whatsoever goeth upon [all] four, or whatsoever hath more feet among all creeping things that creep upon the earth, them ye shall not eat; for they [are] an abomination.

Leviticus 11:43 – Ye shall not make yourselves abominable with any creeping thing that creepeth, neither shall ye make yourselves unclean with them, that ye should be defiled thereby.

Leviticus 11:44 – For I [am] Yahweh (the LORD) your God: ye shall therefore sanctify yourselves, and ye shall be holy; for I [am] holy: neither shall ye defile yourselves with any manner of creeping thing that creepeth upon the earth.

Leviticus 11:45 – For I [am] Yahweh (the LORD) that bringeth you up out of the land of Egypt, to be your God: ye shall therefore be holy, for I [am] holy.

Leviticus 11:46 – This [is] the law of the beasts, and of the fowl, and of every living creature that moveth in the waters, and of every creature that creepeth upon the earth:

Leviticus 11:47 – To make a difference between the unclean and the clean, and between the beast that may be eaten and the beast that may not be eaten.

The laws concerning foods permitted and forbidden.

Also see:

Genesis 1:29 – And Yahweh (God) said, Behold, I have given you every herb bearing seed, which [is] upon the face of all the earth, and every tree, in the which [is] the fruit of a tree yielding seed; to you it shall be for meat.

This means vegetables yielding seed and the fruit of the trees yielding seed can be eaten, which clearly excludes fungi of all kinds such as mushrooms.

Let's go back to Leviticus 11:7-8 where it states you must not eat the swine.

Many people believe this was due to pork rotting quickly in the time the Bible was written (i.e. prior to electric refrigeration), but scientific studies show the following:

A pig will eat anything, absolutely anything. To nail this down for you we're talking about rotting flesh, rotting vegetables, excrement, urine, maggots, etc.



The pig does not pass toxins out of their system through perspiration as they do not sweat or perspire. This is why pig meat is

thirty times more toxic than beef and contains twice the fat content.

Although pork has a higher rate of toxins than beef, it only takes about half the time to digest, meaning the liver has half the time to filter out thirty times the amount of toxins.

Pigs carry many parasites such as tapeworms and trichina worms. Trichina worms can cause trichinosis which leads to a variety of diseases including typhoid, multiple sclerosis, and meningitis.

These are just some of the unsavoury facts regarding pork products and why they are best avoided. As you can see this is not for religious reasons, as some religious denominations claim, but for health reasons.

How about Leviticus 11:10-11 where it states you must not eat shellfish?

Shellfish are basically the pigs of the seabed. They eat off the ocean floor where many toxins and bacteria are present, so they are absorbing this into their systems the same way as the pig.

The pigs and shellfish provide a purpose: to clean the land and the seabed respectively. As stated in the Bible, they are not for human consumption.

Leviticus 12:1 – And Yahweh (the LORD) spake unto Moses, saying,

Leviticus 12:2 – Speak unto the children of Israel, saying, If a woman have conceived seed, and born a man child: then she shall be unclean seven days; according to the days of the separation for her infirmity shall she be unclean.

Leviticus 12:3 – And in the eighth day the flesh of his foreskin shall be circumcised.

Leviticus 12:4 – And she shall then continue in the blood of her purifying three and thirty days; she shall touch no hallowed thing, nor come into the sanctuary, until the days of her purifying be fulfilled.

Leviticus 12:5 – But if she bear a maid child, then she shall be unclean two weeks, as in her separation: and she shall continue in the blood of her purifying threescore and six days.

Two Confusing Words

The two confusing words that I am referring to here are 1. Church and 2. Gentiles (s). Part 1. will deal with the word church. Each part even though complete in itself, will in no way cover all details. Such a task would require many pages. The accepted understanding of these two words has caused considerable misunderstanding in the interpretation of Scripture.

It might come as a surprise that the word church cannot be translated from any Greek or even Hebrew word. The Greek words translated as church have totally different meanings. The closest Greek word is "*kuriakos*" (Strong's 2960), which means pertaining to the Lord (or lord). The only two times this word is used is in 1 Corinthians 11: 20 and Revelation 1:10 where it refers to the Lord's Supper and the Lord's Day. As a result of the phrase "coming together" as mentioned in 1 Corinthians 11: 20 , the word "*kuriakos*" with its meaning , has come to be known as the church.

Strong's Concordance shows that the word church is only used in the New Testament (Strong's 1577). It is used in Acts 19: 37 with a very different meaning. In every other case where the word church is used it is the Greek word *ecclesia* which means "a calling out". Other words in the Bible, namely assembly and congregation can also be used, but again not in all cases. As for the Hebrew use of the words, assembly or congregation it is the word *qahal* (Strong's Hebrew 6951).

Acts 7: 38 brings these two words, namely *ecclesia* and *qahal* together when it refers to the "church in the wilderness", this being a reference to Israel as a nation. It is confirmation of a continual theme that Israel was a called out or separated assembly. Isaiah 48: 12 confirms this

special calling: "Hearken unto me, O Jacob and Israel, my called: I am he: I am the first, I also am the last". In 1 Peter 2: 9 F. Fenton translates the word generation as "a select race".

Some research was needed into the reason why the word church remains in the King James Version. One article stated, it is a mystery. There was one quote from an article entitled, "Christ's Ekklesia and the Church Compared" by Richard Anthony, that provides a feasible answer. This quote says, "In 325 A.D., "The Church" joined the State under Constantine, and it was carried through the Reformation. The Reformers were all involved in civil government, such as John Calvin who set up the civil government in Geneva.

The pope was the head of the Catholic Church and he was kicked out of England, and King Henry VIII took jurisdiction over the Church. And then when the King James version was done, it was very important for them to retain the word "church" because they had jurisdiction over it, so **King James made fifteen specific edicts**, as far as the translation goes, and one of those edicts (edict number 3) stated that this Bible was to retain the word "church" in the translation and it was not to be replaced with the word "congregation". That was his specific edict. He has no jurisdiction over the congregation (people), but he does over the church (physical buildings).

So you can see he never wanted the word "assembly" associated with the original meaning of the Old Testament which meant "congregation". So he knew the correct translation, obviously, but he didn't want it in there, that way they retain control over "the church" "(end quote). The first English Bible by W. Tyndale did not use the word "church", but he used the words "assembly" and "congregation". How much more of the translations have been tampered with? My only answer to that question is that it causes serious students of the Bible to keep searching for the Truth.

The following question is not out of context: "Are there two Testaments or Covenants?". The answer is, "No". The New Covenant is an improvement on the Old Covenant and secondly it

is with the same people, Israel as stated in Jeremiah 31 and Hebrews 8. Spiritualising these covenants does not do away with the fact that God declared an eternal Covenant with Israel and no other people. It is for this reason that the *ecclesia* of the New Testament is the assembly or congregation of the Old Testament. One has to ask the question; "To whom was the Bible primarily written for and to?" James 1:1 provides the answer:" To the 12 tribes scattered abroad greeting". James was maintaining one of the many themes of the Bible.



We all use the word church when we refer to the building. When travelling through Europe and England, we all marvel at the magnificent architecture. I have stood in awe and wonder at how they were built. In Isaiah 17:

7, 8 we have a remark relating to how man will not respect what he has made. "At that day shall a man look to his Maker and his eyes shall have respect to the Holy One of Israel. And he shall not look to the altars, the work of his hands, neither shall respect that which his fingers have made, either the groves or the images". See Micah 5:13, 14. A building is required to gather together the people, but in effect the believers are God's building (1 Corinthians 3: 9).

The origin of the word church is interesting. In Old English and German it was Kirche and in Scotland it was Kirk. Further back in history the word church evolved from "*ciricie* or *circe*". The word has pagan origins with connections to a Greek goddess, Circe. W. Tyndale was of this opinion. *Circe* had the power of cleansing and could perform the ritual of purification. The Babylonian churches of Europe took upon themselves these very same attributes. The word circle originates from *Circe*. The pagans performed mystical rites within these circles. These practices are now part of ecumenicalism. In Acts 19: 37 the word churches is used and it is the Greek word, "*hierosulos*" which means robber or plunderer of temples (Strong's 2417). This is the only time Tyndale allowed the word church to be applied. This confirms the origin of the word church, which is not only not in accordance to Christ's teachings but has nothing to do with the meaning of the word *ecclesia*.

An *ecclesia* is an assembly or congregation that has been called out or separated from the world or *Kosmos* or order (Strong's 2889 Greek). In the Old Testament it is the same as *qahal* (Strong's 6951 Hebrew). Israel is the *qahal*, assembly or congregation or *ecclesia*, **but she is not of the Church.** In Joshua 8: 35 we read:" There was not a word of all that Moses commanded which Joshua read not before all the congregation of Israel, with the women and the little ones and the strangers that were conversant among them". The word congregation is the word *qahal*. The word assembly is the number 6951 and occurs in Exodus 12: 6.

One Bible theme is the separation of Israel from all other peoples. This is one of the meanings of the word holy and it was this hope of the prophets and the apostles that is continually mentioned. Read Leviticus 20: 26 and Romans 11 1, 2, 5. The first Commandment of having no other Gods before me was a vital part of the *ecclesia* or *qahal*. It is in God's plans that Israel will be formed into a theocracy, not a democracy. Caesar was not to be worshipped and this includes the present plan to set up a world government based upon a humanist manifesto. The ecumenical plan for a global unified faith where all gods are expressions of the one god, is being used to destroy God's plan for His *ecclesia* or *qahal*. Many of the elect have been deceived (Matthew 24:24). They have sold Israel who is God's inheritance (Deuteronomy 32:9, Isaiah 19:25) to strangers (Lamentations 5:2).

This article should not discourage those who attend what has become known as the church for I wish more attended. Rather, this article is merely a sketchy attempt to explain that it is the *ecclesia* that we should be a member of, for when that is realised, we will become more aware of how the world has crept into the church and defiled it. It is when we show kindness to the afflicted, keep ourselves unspotted from the world (James 1:27) and cease our friendliness with the world (James 4 :4) that we will begin to understand the "calling out " aspect of the *ecclesia*. The remnant, according to the election of Grace is still alive and will be, in agreement with God's will and plan. The *ecclesia* and the elect will then become as one - this is a mystery. May the God of our fathers grant us the understanding in all these things (2 Timothy 2:7).

'Give Us Our Eleven Days!' The English Calendar Riots of 1752

The eleven days referred to here are the 'lost' 11 days of September 1752, skipped when Britain changed over from the Julian calendar to the Gregorian calendar, bringing us into line with most of Europe.

The Gregorian calendar is today's international calendar, named after the man who first introduced it in February 1582, Pope Gregory XIII.

Before 1752, Britain and her Empire followed the Julian calendar, first implemented by Julius Caesar in 46 B.C. However this calendar had an inbuilt error of 1 day every 128 years, due to a miscalculation of the solar year by 11 minutes. This affected the date of Easter, traditionally observed on March 21, as it began to move further away from the spring equinox with each passing year.

To get over this problem, the Gregorian calendar was introduced. This is a solar calendar, based on a 365-day year divided into 12 months. Each month consists of either 30 or 31 days with one month, February, consisting of 28 days. A leap year every 4 years adds an extra day to February making it 29 days long.

First to adopt the new calendar in 1582 were France, Italy, Poland, Portugal and Spain. Turkey was the last country to officially switch to the new system on January 1st, 1927.

The Calendar (New Style) Act 1750 introduced the Gregorian calendar to the British Empire, bringing Britain into line with most of Western Europe.

Its introduction was not straightforward. It meant that the year 1751 was a short year, lasting just 282 days from 25th March (New Year in the Julian calendar) to 31st December. The year 1752 then began on 1 January.

There remained the problem of aligning the calendar in use in England with that in use in Europe. It was necessary to correct it by 11 days:



the 'lost days'. It was decided that Wednesday 2nd September 1752 would be followed by Thursday 14th September 1752.

Claims of civil unrest and rioters demanding "Give us our eleven days" may have arisen through a misinterpretation of a contemporary painting by William Hogarth. His 1755 painting entitled: "An Election Entertainment" refers to the elections of 1754 and depicts a tavern dinner organised by Whig candidates. A stolen Tory campaign banner with the slogan, "Give us our Eleven Days" can be seen lower right (on the black banner on the floor under the seated gentleman's foot). The Tories can be seen outside the window, demonstrating.

The changing of the calendar was indeed one of the issues debated in the election campaign of 1754 between the Whigs and the Tories.

It is also true that when the British government decided to alter the calendar and skip these 11 days, many people mistakenly believed that their lives would be shortened by 11 days. People were also unhappy and suspicious at the moving of saint's days and holy days, including the date of Easter. Many people also objected to the imposition of what they saw as a 'popish' calendar.

However, most historians now believe that these protests never happened. You could say that the calendar rioters were the late Georgian equivalent of an urban myth.

Not everyone was unhappy about the new calendar. According to W.M. Jamieson in his book, 'Murders Myths and Monuments of North Staffordshire', there is a tale about one William Willett of Endon. Always keen on a joke, he apparently wagered that he could dance non-stop for 12 days and 12 nights. On the evening of September 2nd 1752, he started to jig around the village and continued all through the night. The next morning, September 14th by the new calendar, he stopped dancing and claimed his bets!

Footnotes

Have you ever wondered why the tax year in Britain starts on the unlikely date of 6th April, rather than 1st January?

The official start of the year on the Julian calendar used to be Lady Day (25th March), and this was also the official start of the tax year. However the introduction of the new calendar and the loss of the eleven days in 1752 meant this date was changed to 5th April in 1753, to

avoid losing 11 days of tax revenue. Another change was made to the date in 1800, as this would have been a leap year in the Julian calendar but not in the new Gregorian calendar. So again the tax year was extended and the date changed to 6th April where it remains to this day.

There is still a remembrance of the length of a Biblical day being 12 hours in length, starting at 6 am, namely am and pm, although now measured from midnight to noon and pm from noon to midnight.

John 11:9 Jesus answered, Are there not twelve hours in the day? If any man walk in the day, he stumbleth not, because he seeth the light of this world.

However, the Jewish day starts 6pm to 6pm the following day. Therefore, they are the children of the night, while the Hebrews are the children of the day as inferred in the above verses.

Ginger Fights Cancer



Those of us fearful about getting cancer, especially as we tumble into our senior years, should have glad hearts at the news contained in a scientific paper with the most challenging title: A.Ray (et al.), "6-Shogaol.

Inhibits Breast Cancer Cells and Stem Cell-like Spheroids by Modulation of Notch Signalling Pathway and Induction of Autophagic Cell Death", PLOS One, September 10, 2015. 6-Shogaol is derived from common ginger.

In laboratory tests it was found that 6-Shogaol effectively killed both breast cancer mono-layer cells and stem cell like spheroids, which is difficult to do with conventional cancer drugs.

Further, the ginger - derived chemical was not toxic to normal cells, which is a major advantage. Many Internet sources say that 6-Shogaol is 10,000 times more efficient than chemotherapy drugs at attacking cancer stem cells.

The paper, as I read it does not cite this figure but does say that few chemotherapeutic compounds attack cancer stem cells at all and cancer stem cells are resistant to standard drugs such as paclitaxel, doxorubicin, 5-fluorouracil, and platinum drugs. (p.17 of 22)

The good news about nutrition as a weapon against cancer doesn't end there. Another paper not discussed much in the Internet press is: D.Wang (et al.), "Phenethyl Isothiocyanate Upregulates Death Receptors 4 and 5 and Inhibits Proliferation in Human Cancer Stem-like Cells", Biomed Central Cancer, vol 14, 2014: 591.

Phenethyl isothiocyanate (PEITC) is found in vegetables such as broccoli, cabbage and cauliflower. The experiments described in the paper indicates that PEITC can also attack cancer stem cells, with no toxic effects.

So, eat up your broccoli, laced with ginger (cooking ginger activates 6-Shogaol) and wash it all down with a nice cup of green tea - also anti-cancer. **Yours truly, Olga Scully, Australia.**

Solution To Missing Three Generations of The Kings of Judah

Sir--, The Solution to the Apparent Contradiction of Why the Gospel of Matthew Leaves Out Three Generations of the Kings of Judah.

Yahshua's Genealogy According to Matthew Compared with Chronicles

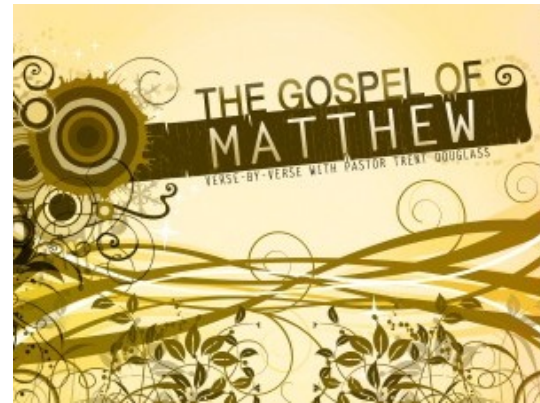

Matthew has only 14 names and gives a presumably incomplete list. The questions are of course: why is Matthew incomplete? Missing are Ahaziah, Joash and Amaziah, and Jehoiakim.



The gospel of Matthew starts with the genealogical list of Jesus' descent and this list is introduced as, “*The book of the generation of Jesus Christ*”.

This is the line of descent through Joseph, not Mary. Both Joseph and Mary are descendants of King David. The problem of why Jehoiakim is left out cannot be resolved here. It is not a matter of the purity of the blood, which is our subject. Joseph was a descendant of Jeconiah, whose bloodline was cursed by not being allowed to have the Messiah derive therefrom. (Jeremiah 22:22-24.) Nevertheless, Joseph, a descendant of Jeconiah, became Yahshua's **Stepfather** by marrying Miriam (Mary). Sir—, Here are some pearls from Ed Johnston---16th American Jurisprudence Section 177 (16 Am Jur. 2d. Const. Law Sect. 256)

The State did not give the Citizen his rights and thus cannot take them away as it chooses.

The State did not establish the settled maxims and procedures by which a citizen must be dealt with, and thus cannot abrogate or circumvent them. It thus is well settled that legislative enactments do not constitute the law of the land, but must conform to it.

From the 16th American Jurisprudence, Second Edition, Section 177:

“The general misconception is that any statute passed by legislators bearing the appearance of law constitutes the law of the land. The U.S. Constitution is the supreme law of the land, and any statute, to be valid, must be in agreement. It

is impossible for both the Constitution and a law violating it to be valid; one must prevail. This is succinctly stated as follows:

The general rule is that an unconstitutional statute, though having the form and name of law, is in reality no law, but is wholly void, and ineffective for any purpose; since unconstitutionality dates from the time of its enactment, and not merely from the date of the decision so branding it.

As unconstitutional law, in legal contemplation, is as inoperative as if it had never been passed. Such a statute leaves the question that it purports to settle just as it would be had the statute not been enacted. Since an unconstitutional law is void, the general principles follow that it imposes no duties, confers no right, creates no office, bestows no power or authority on anyone, affords no protection, and justifies no acts performed under it... A void act cannot be legally consistent with a valid one. An unconstitutional law cannot operate to supersede any existing valid law. Indeed, in so far as a statute runs counter to the fundamental law of the land, it is superseded thereby. No one is bound to obey an unconstitutional law and no courts are bound to enforce it.”

Any court, government or government officer who acts in violation of, in opposition or contradiction to the foregoing, by his, or her own actions, commits treason and invokes the self-executing Sections 3 and 4 of the 14th Amendment and vacates his or her, office. **Yours truly, Anna Von Reitz**

An Interesting Note From Rapin’s History of England on The Reign of William The Conqueror or as Some Would Say - The Desolator.

I. The justiciarii regis, or barons of the exchequer during the reign of William I. were: 1. Odo bishop of Bayeux. 2. William Fitz-Osbern. 3. Goisfrid bishop of Coûtance. The most remarkable occurrences in this reign, not mentioned by Rapin, are these: I. king William brought the Jews from Rouen to inhabit in England. 2. In his reign, or much about that time, surnames came first to be used. 3. Trial by Battail was introduced into this kingdom. 4. The Normans brought in a new way of creating

knights; and also the use of seals and witnesses in all deeds and instruments. Before that time, or at least before the reign of Edward the Confessor, the persons concerned only set down their names, with a cross before them. Lastly, the Normans brought in the shocking vice of common swearing. In the year 1076, there was an earthquake in England; and a frost from the beginning of November, till the middle of April. In 1077. Aug. 14, there was a very great fire in London. And again in 1087, the greatest part of that city was burnt down (with St, Paul's cathedral;) as were also most of the chief towns in England.



III As it is intended to give a short account of the coin in every reign, we here commence with observing, that, probably, the Britons never coined any money, but in Caesar's time used only iron rings and shapeless pieces of brass; and that even their tribute money was the ordinary current coin brought in or minted here by the Romans, as long as this island continued a province.

For among the many thousand Roman coins, there was never one undoubted British coin yet produced, those of Cunobelin being liable to unanswerable objections. After the Saxons were settled in England, their silver coins were generally all of a size and ill minted, which they called pennies, worth about three-pence of our money.

They had also half-pennies and farthings, (as appears from the Saxon Gospels,) and half-farthings, called sticas. Of which kind bishop Nicolson takes those brass pieces to be that were found some years since at Rippon Yorkshire, and communicated by Sir Edward Blacket the owner to several curious antiquaries.

After the Norman conquest, a pound of gold being divided into twenty four carats, (or half ounces,) and every carat into-four grains, the old sterling, (as it was afterwards called,) or right standard of gold, consisted of twenty three

carats, and three grains and a half of fine gold, and half a grain of alloy of copper or silver. Again, a pound of silver being divided into twelve ounces, and every ounce into twenty penny-weights, and every penny-weight into twenty-four grains, a pound weight of old sterling consisted then (as it does now) of eleven ounces two penny-weights of fine silver, and eighteen penny weights of allay.

The first eight kings after the Conquest continued to coin money much like their Saxon predecessors, only a little lighter; for of the Saxon pennies there are some at this day that weigh more than a penny-weight, whereas few of those of the Norman kings reach twenty-two grains till Edward I. when the English pennies were to weigh a penny-weight.

The Normans also continued the like method with the Saxons as to inscriptions, having round the king's head his name and stile, which was very short, only REX or REX ANGL. and on the reverse the name of the mint-master and place of coinage. The coins of the Williams were very rare till a nest of them was accidentally found at York 1703-4. On their coins they both appear in a pearl diadem with L at each ear, and an arch cross the head, consequently they are impossible to be distinguished. Mr. Thoresby indeed ascribes those with a full face to the Conqueror, and those with the half face and scepter to Rufus. The inscription on the conqueror's money is, WILLEM. WILLEMV. (mistaken by Dr. Nicoison for WILLEM or WILLEMVS. PILLEM.

PILLEMV. PILLEVS. (P being the Saxon W) REX. REX. A. ANGL. ANGLO. or ANGL or. reverse, a cross fleurée with four sceptres quarterly, or a cross with four pellets in each quarter, the name of the mint-master and place of tintage, as HEREFORD. LVNDEN. LOND. LVNDRE. LVNDR. for London; C for Canterbury; EO or EOFER for York; LINDCULN. EXETER. LEOYNC. for Lancaster; PINC. for Winchester; DEOTFORD for Thetford. See the coin in the foregoing page, which hath on one side PILLEM REX ANGLOR. and on the reverse GODICON LVNDNEN. **Yours truly, J. James, County Durham, UK**

The Trojan Origins Of European Royalty! (Part 4)

Enter the Hapsburgs!



Hapsburg was the name of a noble and Royal German family which, at various periods in European history, was the ruling house of Germany -- as a separate kingdom and also as part of the Holy Roman Empire. Not only did the Hapsburgs rule Germany, but also Austria, Bohemia, Hungary, Spain and many other smaller European kingdoms.

According to *Funk and Wagnalls New Encyclopedia*: "The name of the family is derived from a family seat, the castle of Hapsburg or Habichtsburg ('Hawk's Castle'), built in 1028 on the Aare River in what is now Aargau Canton, Switzerland." (Vol. 12, p. 183).

What, might you ask, do the Hapsburgs have in common with the Trojan line of kings that came down through the Franks? Just this: "From Pharamond [fifth duke of the East Franks], king of the Franks came a princely line of rulers who **intermarried with Austrian Royalty**.

This line, preserved in the *Historia de Xerez* by Gutierrez, descends down to Rudolf II of Hapsburg, who became Holy Roman Emperor in 1273.

The **Judah origins** of the Hapsburg line can be clearly seen on the tombstone of Emperor Rudolf I -- located in the Cathedral of Speyer, Germany. The tombstone has a life-sized portrait of the emperor engraved in it, surrounded by a border containing Latin script. The emperor is shown holding the sceptre and orb of royal power -- and with a shield depicting the **Lion of Judah** on each shoulder! To further emphasis his origins from that line, the emperor is shown **standing on a lion** -- thus demonstrating his power and authority stemmed from the **Line of Judah!**

The Mysterious Odin

The present-day royal lines of Northwestern Europe and Great Britain are **all** related to **Dan I of Denmark** who was this **Dan** of mythical proportions, otherwise known as **Odin**?

Tradition and history records the existence of **three famous men** who bore the name "**Odin**." The first, according to author J. Garner, was known as **Wodan** and "is the same as the **Odin of the Scandinavians**." He goes on to say:

It would also appear that **Wodan**, or **Odin**, who seems to be identified with those gods **whom Cush was the human original**, had a son "**Balder**," who was slain by **Loki**, the spirit of evil, just as **Osiris** was slain by **Typhon**, the spirit of evil. Just also as the deaths of Osiris, Bacchus, Thammuz, etc., are **lamented**, so is **Balder** lamented by his mother, **Freya** or **Frigga**, who was told by Hela, the goddess of Hell, that he would be restored to life if everything on earth wept for him. Again, just as the war god **Mars** or Mergal was another manifestation of the younger **Babylonian** god, so "**Thor**," the war god of the Scandinavians, was another son of Odin—Odin, Freya and Thor, in short, are the **Scandinavian trinity, corresponding to the Egyptian trinity, Osiris, Isis, and Horus**, and other forms of the same Trinity, and like Horus, Apollo and Christna, Thor is represented as bruising the head of the serpent. -- *The Worship of the Dead*.

Obviously, this **Odin** was none other than the **Nimrod** of the Bible!

Notice, now, what Alexander Hislop says about the first Odin:

1. **Nimrod**, or **Adon**, or Adonis, of Babylon, was the great war-god. **Odin**, as is well known, was the same. 2. **Nimrod**, in the character of **Bacchus**, was regarded as the god of wine: **Odin**, as we read in the **Edda**, "stands in no need of food; **wine**, is to him instead of every other ailment, according to what is said in these verses: The illustrious father of armies, with his own hand, fattens his two wolves; but the victorious

Odin takes no other nourishment of himself than what arises from the unintermitted quaffing of wine" (Mallet, 20th Fable, Vol. II, p. 106). 3. The name of one of **Odin's sons** indicates the meaning of Odin's own name. **Balder**, for whose death such lamentations were made, seems evidently just that **Chaldee form of Baal-Zer**, "The seed of Baal"; for the Hebrew Z as is well known, frequently in the later Chaldee, becomes D. Now Baal and Adon both alike signify "Lord," and, therefore, if Balder be admitted to be the seed of Baal, that is as much as to say that he is the son of Adon; and consequently, **Adon and Odin must be the same.**



This, of course, puts [this] **Odin** a step back; makes his son to be the object of lamentation and not himself; but the same was the case also in Egypt; for there Horus the child was sometimes represented as torn

in pieces, as Osiris had been. Clemens Alexandrinus says (*Cohortatio, Vol. I, p. 30*), "they lament an infant torn in pieces by the Titans." The lamentations for Balder are very plainly the counterpart of the lamentation for **Adonis**; and, of course, if **Balder** was, as the lamentations prove him to have been, the favourite form of the Scandinavian Messiah, he was **Adon**, or "Lord," as well as his father. 4. Then, lastly, the name of the other **Son of Odin**, the mighty and warlike **Thor**, strengthens all the foregoing conclusions. Ninyas, the son of Ninus or **Nimrod**, on his father's death, when idolatry rose again, was, of course, from the nature of the mystic system, set up as Adon, "the Lord."

Now, as **Odin** had a son called **Thor**, so the second Assyrian Adon had a son called **Thouris** (Cedrenus, Vol. I, p. 29). The name Thouris seems just to be another form of Zoro, or Doro, "the seed"; for Photius tells us that among the Greeks Thoros signified "Seed"...The D is often pronounced as TH, -- Adon...the pointed Hebrew, being pronounced "Athon."-- *The Two Babylons*. Loizeaux Brothers, Neptune, N.J. 1959. Appendix, note L, p. 312.

The **second Odin** -- the one we are interested in -- is mentioned in the *Saxon Chronicle* where his ancestry is given: "The Saxon Chronicle commences the **line of Dan I** with the following two names: 'Noah, Sem.' Thereafter a long break occurs in the genealogy -- similar to the Biblical statement : "Jesus Christ, the son of David, the son of Abraham' (Matthew 1:1)." *Compendium of World History*, Vol. II, p. 44).

The *Icelandic Langfedgatal* fills in these gaps in the **second Odin's genealogy**. Those who came after Shem (Sem) -- on **Odin's father's side** -- are as follows:

- 2) Jupiter
- 3) Darius
- 4) Erichhonius
- 5) Troes
- 6) Ilus

A study of Danish literature reveals that **Seskef**, sometimes spelled **Sceaf**, is a **Title of Odin**. What does this title mean? Seskef, or Sceaf, literally means a "sheaf" of grain. **Odin** claimed to be a kind of lord, or Savior, and laid claim to being **the sheaf** represented in Leviticus 23:9-14 as symbolically referring to the **Messiah!**

But why, might you ask, would **Dan I** -- a king of Denmark -- copy a ceremony perpetuated by the law of Moses? Is there a **connection** between **Odin and Israel?**

Notice the surprising answer!

The answer is found in who **Saturnus of Krit**, ancestor of **Odin**, really was. In modern English the name would be **Saturn of Crete**. There were **many** Saturns in antiquity, often confused with one another. Usually the name was applied to a man who **flees** or who **hides** himself.

Saturn is a Latin word derived from a root meaning **to flee into hiding**. The Greek term was **Kronos**. This particular **Saturn of Crete** was so famous that the **Phoenician historian Sanchoniathon** spoke of him. Fragments of his works have been preserved by Eusebius in *Preparation of the Gospel*, book i, ch. x. Here are his words: "For **Kronos** or (**Saturn**), whom the Phoenicians call **Israel**—" (*Corey's Ancient Fragments of the Phoenician, Carthaginian, Babylonian, Egyptian and other Authors*, by E. Richmond Hodges, page 21.)

Israel was the name of Jacob. That would make **Odin a son of Shem and a son of Jacob**. But why was Jacob called Saturn? Because Jacob became famous for **fleeing** or **hiding** from his enemies. Jacob's mother warned him of his brother Esau's wrath: "Now, therefore, my son, hearken to my voice; and arise, **flee** thou to Laban my brother in Haran" (Genesis 27:43). "And it was told Laban...that Jacob was **FLED**" -- this time back to Palestine. (Gen. 31:22) -- *Compendium of World History*, Vol. II, pp. 45-46.

With this fascinating revelation in mind, we can now **clarify** the *Langfedgatal* genealogy of **Odin of Denmark**:

- 1) **Saturnus of Krit (Israel)**
- 2) **Jupiter (Judah)**
- 3) **Darius (Dardanus)**
- 4) **Erichhoniuss (Ericctanus)**
- 5) **Troes (Tros)**
- 6) **Ilus**
- 7) **Lamedon (Laomedon)**
- 8) **Priam (Priamus)**

The eighth king in descent from **Priam** was **Seskef** ("the Sheaf"), who was none other than **Danus I** or **Odin (Votan)**. Danus I was the first king of Denmark and reigned from 1040-999. **Odin was therefore a Trojan of the line of Judah!!**

S. Gusten Olson recognizes this link in the line of **Odin**: "It is commonly accepted that **all** the ruling families of the North [Northwestern Europe] definitely date **back to Odin** (however not the original Odin [Nimrod], but perhaps the **Primary, historical Odin**). The historical **Odin is descended from the Trojan lines of Kings**

(*The Incredible Nordic Origins*. Nordica S. F. Ltd., Kent, England. 1981, p. 87).

The December, 1981 issue of *The Link* discusses the royal lines of northern Europe and their **LINK** to the mysterious **Odin**:

The varied collection of sagas, poetry and prose which comprises the early literature of the northern nations of Europe contains much interesting and valuable historical material, although it is often difficult to separate the fanciful from the factual. The **repeated** assertions and implications that the **families descended from Odin** (or **Woden**) derive from **the ancient Trojan Kings** (often thought to belong to the fanciful category) may indeed prove to have **firm foundation of truth**. Several factors provide evidence which is **harmonious** with such a claim.



Ancient classical and extra-biblical sources indicate that the **Trojan Kings** were of the **Royal line of Judah** and that they were closely related to other **Royal families in Ionia, Greece and Crete**. The early British king-line is traditionally **descended through the Trojan Kings**, and the kings of Ireland are stated to have sprung from the **Milesians Royal family in Ionia** into which "Pharaoh's daughter" married. Accepting these sources, the royal families of the northern nations of Europe--Irish-Scottish, Early British, Frankish, Norwegian -- are all of the **Sceptre Tribe of Judah** and the many intermarriages of these royal lines would thus all be within the **One Great Royal Family** of which so much is prophesied in Scripture. Queen Elizabeth II has stated that she is **Woden-born**-- Christian Israel Foundation, Walsall, England, p. 117.

The written history of Denmark properly begins with the **First King** to reign over the people in the Danish peninsula--this was **Danus I!** He is also known as **Dan I** in Danish history and was the second **Odin or Votan**.

How this **Odin** arrived in the Northwest of Europe is noted by Herman L. Hoeh: "Denmark originally received its name from the **Tribe of Danaan**. It passed to the king who took the name of the subjects over whom he ruled. **King Dan I** commenced his reign IN 1040 [B.C.]. This was the year of the breakup of the German realm. The division of German territory between the three sons of Wolfheim--Kells, Gall and Hiller--left the seafarers of the far northwest of Europe without leadership. To fill the void the German and **Hebrew** inhabitants of **Denmark** called upon a **scion of the Trojan House** to reign over them. That scion was **Dan I**. He lived at that time

in **Thrace**." (*Compendium of World History*, Vol. II, pp. 43-44).

Odin answered the call and led a large migration **out of Thrace** into **Denmark** and the neighbouring regions. After organizing his new realm and setting up the institutions necessary to underpin a stable government, Odin set out on a trip **across the seas** to establish a **new colony** in a faraway land!

Irish Queen “Britannia” Brings Hope For Ireland: Lost Ark At Tara With Teia From Our West London Correspondent



Irish Queen Teia Tephī
“Britannia”

THE LIFE OF TEIA TEPHI would make a legendary-epic movie, but no one touches her. Why she is forgotten, obscured, and hidden goes beyond belief, but Teia Tephī is Britannia. Teia is Ireland's link to Jerusalem's royalty, because she was the

tender twig from the High Cedar that Jeremiah planted in Inis Fail, the Isle of Destiny.

the only daughter of king Zedekiah to survive Nebuchadnezzar's destruction of both Jerusalem and Egypt, Teia holds an **olive sprig**, representing her lineage from Jacob-Israel and the House of Judah-Pharez. Lying next to her is the **amber lion couchant**, also representing Judah-Pharez. Teia holds Neptune's **trident spear** given to her in Gibraltar when she was enroute to Ireland. She wears a **helmet**, because she was a warrior-queen for God and His Laws. Lastly, a **shield** leans on her side, featuring God's flag, the Aleph x and Tau +, the Alpha and Omega. This is the Union of Jakob flag, which also belongs to Christ. Yes, it's the British flag, but its origin is ancient, as in Hebrew “British” means “People of the Covenant” – Israel.

In the Britannia emblem, Teia is featured with **five symbols**, clearly identifying her. As she was

Teia's life was one of adventure, sorrow, heroism, love, war and writing. In her travels; she

was adopted by a Pharaoh and two Israelite kings, and recognized as queen of Gibraltar, all before landing in Ireland and marrying the High-king. And while she was a warrior-queen, fighting to uphold the Laws of God, Teia also became a mother of three boys and a girl. Her first big sorrow was the destruction of her home, Jerusalem.



God said He would destroy it for its backsliding and He did. Many mourned and wailed over its fall. Her last greatest sorrow was the loss of her first child, who died at a young age, and who became her lament. In Old-English prose, she essentially wrote an autobiography, which included prophecies. Teia was also someone of interest to Nostradamus who studied ancient Irish history; and he made predictions about the discovery of her tomb in the end times.

Teia's adventure started with Jeremiah, who took her as well as The Ark of The Covenant and Jacob's Pillar Stone away from Jerusalem's destruction, as Divinely instructed. He was to protect all of them. Teia's brothers met a horrible fate of being killed in front of their dad, king Zedekiah, who was blinded after he witnessed the horror, making it the last thing he saw, for his treason against God. Teia, her two sisters, their handmaidens, and Baruch, Jeremiah's secretary, all left with him for safety in Egypt. Pharaoh Hophra adopted Zedekiah's daughters and gave them a palace. And although it's in ruin, there is a place named "Quasr Bint el Jehudi" that means "palace of the daughter of Judah".

God again warned Jeremiah to leave Egypt because it would soon experience His wrath, at the hand of Nebuchadnezzar, for its wickedness and alliance with Zedekiah against him. Teia's sisters decided they wanted to stay in the comforts of their palace, but were soon killed. Teia would trust Jeremiah and leave with him, her handmaidens, Baruch and a boat crew. Of

course, they took The Stone and The Ark, which contains the original Torah given to Moses by Father and the Ten Commandment tablets. And while they left Tanis, Egypt, this is where Indiana Jones in "Raiders of the Lost Ark" started looking for the treasure.

They sailed to Gibraltar, the "Gate" and Biblical "Rock of Defence". They hid The Ark in Saint Michael's cave, where Moses had received instruction by Archangel Michael when he was there, as Gabriel told Mohammad in the Koran, Chapter 18, "The Cave". Gibraltar was the home of the lost tribe of Gad, who unfortunately were lured into idol-worship again, with their false god Neptune. It was Teia who reprimanded them and helped them turn back to The Way of God. This is why the Gadites gave her Neptune's spear from his statue-idol.

They stayed in Gibraltar five months. And during that time, they discovered and spoiled a plot to kill them and steal the treasures, planned by the crew of the Tyrian ship that helped them get there. That crew left, to its fate of sinking at sea, which Baruch saw in a vision, to let him and the others know that no one in Egypt would know where The Ark had gone. It was Baruch who rewrote Jeremiah's Roll, also known as the Book of Baruch, which was a part of Holy Scripture until they figured out it was a description of the Vatican and its pagan idol-worship, and had it removed. Baruch, who was around 80, spent his last days in Gibraltar and is buried there.

The rest left Gibraltar in a Greek ship that had been captured by their allies. Simon, the son of Gibraltar's Israelite ruler Elier, helped sail them across the Bay of Algeciras and through the Straits to Breogan in Spain, where he introduced them to Ith Cian, the Israelite ruler who also adopted Teia Tephi. He would tell her of his lost son, Lughaidh, who had sailed-off several years before, with his five ships and was presumed dead. After sailing from Breogan, they headed for Ireland, but a violent storm set them off-course and broke the ship's oars and rudder.

The wind divinely led their boat and guided it right into a bay, now known as Mara-Zion, near St. Michael's Mount in Cornwall, England. This is where they met Elatha, the Israelite ruler of Cornwall, who happened to be the kinsman of Ith Cian of Breogan whom they just left, and an ally of Elier bar Ziza of the Gate-Gibraltar.

Elatha, who incidentally knew he was an Israelite and descended from Abraham, repaired their boat and sent word to the kings of Ireland requesting safe passage for the queen of Jerusalem. With Teia's visit, Elatha learned of the destruction of Jerusalem and Solomon's Temple and wept bitterly in sorrow. This is why the bay is called Mara-Zion, which means "Bitter for Jerusalem" in Hebrew.

The Irish kings were elated that the queen of Jerusalem sought home in their land. They sent gold, silver, gifts, and messages from those who sought her hand in marriage. After receiving their positive answer and invitation, Elatha sent his son, Bressail, with 53 ships and over two thousand men to escort her. Teia landed with the crew in Howth, Ireland, where she was greeted and carried ashore by Eochaidh, the High-king, and Ethan, his harper, who both instantly fell in love with this tender twig.



Teia only knew the identity of the harper and didn't know that the other person carrying her was actually Eochaidh, because he was urgently called away to rescue his sister. Interestingly, as a boy, Eochaidh was given a vision not to marry until his queen came from the East. When he heard of Teia, he knew who she was. From Howth, she was escorted to the Hill of Tara, to a house that was already prepared for her, called Rath Grainne, or Fort of the Seed. Teia saw an obscene pagan Baal pillar-stone of fertility on the land and wanted it removed, but the priests ignored her.

In order to decide whom she should marry, they opted to shoot for it. Their broadest man, Ethdan, would use Samson's bow whilst lying in the center circle of the kings' seat at Tara, known as Rath na ri, "the Fort of the king". [They had Samson's bow, because he was from the tribe of Dan, which had migrated to Ireland]. Whoever's seat the arrow fell closest to would be her husband. Divinely-guided, the first arrow, gold-

tipped, landed on Jacob's Pillar Stone, indicating she was married to God and His Laws first; then, Ethdan shot the second arrow, silver-tipped, which landed nearest to an empty seat; then, he shot and the third, lead-tipped one, hitting the Baal phallic-stone and knocking the gilded horns off it, proving to them that Baal-worship was evil. While they were doing this, Teia looked around for the man who helped Ethan carry her ashore.

It turns out the empty seat was Eochaidh's, whom she was destined to marry. The Druid kings repented, took her side against the Baal priests, and removed the phallic stone, burying it, and placing the Stone of Destiny in its place on the Inauguration Mound, where Teia and Eochaidh were married over it and she was crowned queen of Ireland on it. [The Stone is the real Lia Fail, not the phallic stone, which was found and put back up in the 1800's.]

This marriage sealed the "breach" caused centuries earlier when the two-strand House of Judah was divided, when Judah's twin sons Zarah and Pharez were born. Zarah of the Red-hand lost his birthright, went into exile, and migrated to Heberia-Spain – Zara(h)goza, then to Hebernia-Ireland, meaning Hebrew's new-land. Interestingly, some of their descendants migrated from Ireland to Scotland, choosing to use their own Zarah version of the Judahite emblem, the red lion rampant, just as Pharez used the amber/golden one. This sealed breach is represented on the Ulster flag. Eochaidh was from the Zarah branch and Teia Tephi was from the Pharez branch. The Ulster flag features the "red hand of Zarah" mounted on the "Star of David" with a single royal crown.

Eochaidh and Teia ruled Ireland under God's Law and Ireland flourished with God's Blessings. Evil would still plot against them and more war came. [This is a world of good and evil; everyone gets to decide out of free-will choice which side he is on]. Because they remained true to God's Law, they remained undefeated, even though they were smaller in number. God sets His hand of protection on those doing so, and removes it from those who commit adultery against Him. [It's a simple concept really, but century after century, man proves over and over again he aligns himself with evil, by letting the pretty little liars rule over him; and everyone is punished. Know the evil rulers by their fruits.

And in the End Times, know them for who they really are: the Synagogue of Satan, the Great Liar and Opposer of God, who uses deceit to lure the masses into damnation. Entire nations currently have no hand of God protecting them, and lessons will be learned from this adultery, just like in Jerusalem].

While God remained their number one priority, Ireland flourished with good weather, abundant crops, and victories of war against those who sided with evil. Teia would also end up meeting Lughaidh, the lost son of her adopted Spanish dad, Ith Cian. Lughaidh ended up in Ireland when he left Spain. He was now her brother by adoption and pledged alliance to fight for God with her. Ith Cian finally learned of Lughaidh's whereabouts and went to Ireland to see him. Learning of the enemies' approach, Ith Cian tried to return to Spain to gather his men for the fight, but was killed before he got there.

He was killed by three Tyrians, whom he had once driven out of Spain. They actually stoned him to death and buried him with the stones. Later, Lughaidh avenged his dad's death by killing the ones who murdered him and buried them under the same stones. He reburied his dad on the highest hill in a place that became known as Cian aneus Mor, "Great Cian from the South", or simply now Kells, Ireland.

The battle of good and evil continued. As those united under God, fought against the kingdom sects of Ireland, who opposed Torah Law, because it meant everyone was equal; and they'd have to redistribute the wealth they had stolen using the sneaky little ways they do. In their arrogance and greed, they refused to get off their high horses and act for the benefit of all. Under God's Law, kings were never to add riches unto themselves (Deut. 17:16), so why do kings always do that, no matter what century we're in? Laid up in her riches, Elizabeth II can't hold a candle to Teia Tephi, the true Britannia.

Yet, the Irish remain subject to QE2 and her worship of wood, "laws and treaties written on paper" through the BAR of which she is the head, instead of what's been written in Stone on their own land. Unfortunately, no matter what century we are in, kings tend to be arrogant, greedy, and selfishness. They certainly haven't been kind; and God loves those who are obedient to His Commandments.

One of Ireland's greatest ancient battles would be with the powerful Bressail, who helped them get to Ireland in the first place. In his vanity, he united with many kings to overthrow God's Kingdom. Teia sent word to his dad, Elatha of Cornwall, who had previously also adopted her. Elatha, then in turn, sent ships to help. Some main players were killed, as in war there is always death, but in the end God's Kingdom won with far fewer casualties. Teia rode Eochaidh's white horse to the enemy line with her trident spear and asked for their surrender. There was no way they could have won other than the fact that the Hand of God was upon them. It was a miracle. Bressail surrendered; and he would then go on to help clear the waters of pirate ships.

Because of this divine victory, and even before her death, people started making Teia into a goddess, Bovinda, to be exact. She was furious about this and set up the Teltown funeral games to be held on the anniversary of her death, so that people would remember she was human, not a goddess and keep God's Law, that she had brought and which brought them peace and prosperity for a thousand years. These funeral games were referred to by Nostradamus in Quatrain 10,74, as the Hecatomb Games, which he predicted would be reinstated. He also predicted that the Lost Ark would be recovered with her bones at the Mound of the Hostages at Tara. Eochaidh didn't escape pagan folklore either. He was deemed Daighda, the god in pain, all because he defended Teia from an attack of a soldier's grieving wife. She came at Teia with a poisoned blade. In the struggle, it fell on Eochaidh's foot, but he lived and limped with pain ever after.

All these details and much more are within the Book of Tephi as well as other historical documents. In her book, Teia prophesied that the last overturn of the Throne, to Christ, would happen on the 2,484th anniversary of her death, in 534

BC, which coincides perfectly with 1950 when four brave Scottish Nationalists removed the Stone of Destiny from Westminster Abbey. In today's war of good versus evil, everyone picks his side. Does he fight for God's Kingdom and justice for all; or does he fight for man's will and

"But please, my dear friend," he continued. "Always remember, there are Russians and then there are Russians. And some who are Russian are not Russian."

Confusing language, I thought, if intriguing. I made a mental note to later inquire further into the nature of Lunachev's puzzling words. However, I soon discovered that follow up was not at all necessary. The good Professor Lunachev more than answered my curiosity with what he had to say.

A Stellar Career Until...

Lunachev recounted his stellar career, beginning as a leader of the Communist Youth, his earning of high-level doctorate degrees, and his academic career, during which he was lauded and commended on a regular basis. Apparently,

Lunachev was poised for further advancement; he was even being considered for a top political position in the Kremlin as a Marxist theoretician and was well rewarded economically by the elite intelligencia. Until...until he said something very, very vital—and very, very sensitive—to the wrong person.

It seems that a high-ranking Commissar had come from Moscow to the Institute to interview Lunachev for the Kremlin post.

The Commissar, who was very pleased with Lunachev's department and his responses to standard questions, finally stated: "Professor Lunachev, is there any area of research or study that you have conducted that is unique or unusual?"

"Yes," Lunachev replied. "I have recently been studying the field of race and biology. I have discovered that the great Karl Marx was a Jew and so was Comrade Lenin." "Comrade Stalin was an avid reader of the Jewish Talmud, and Comrade Khrushchev's real surname was Perlmutter. He, too, was a Jew."

Understanding Lunachev's Predicament

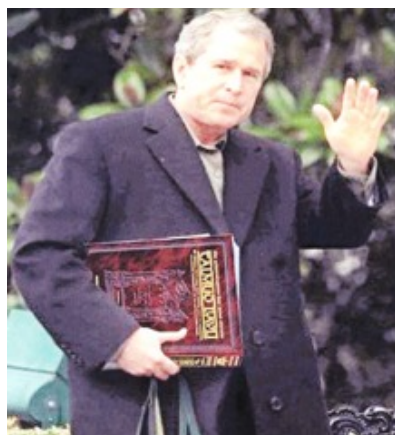

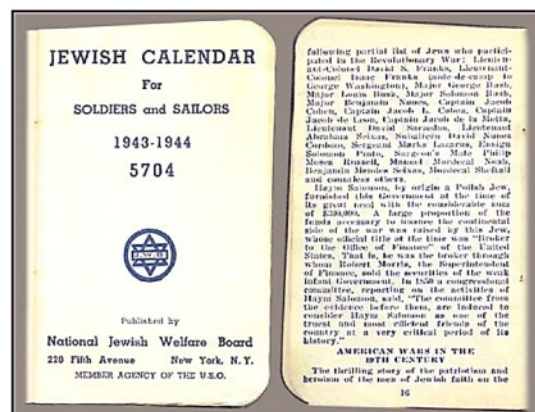
And Now, Yet Another Revelation

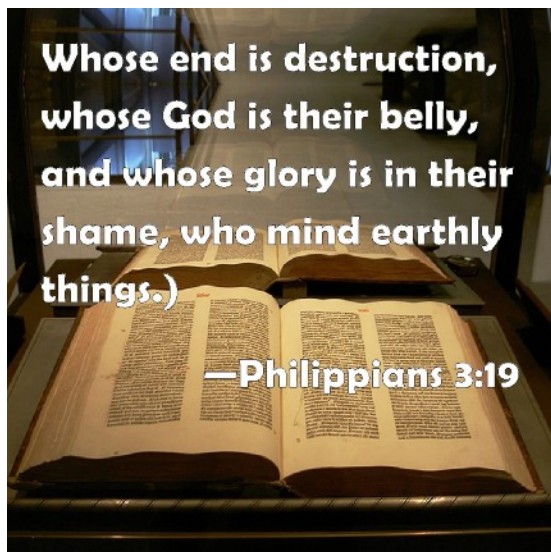
Christians' bodies are polluted with pork even as a person whose body is accustomed to certain chemicals or poisons slowly over time---
