

27 THE PROM-ISE AND "THY SEED" IN THE NEW TESTA-MENT

Acts 3:25 Ye are the children of the prophets, and of the covenant which God made with our fathers, saying unto Abraham, And in

thy seed shall the kindreds of the earthbe blessed.

**NLY** Israelites are being addressed here! We can find references in Scripture to the families [plural] of Israel. "Kindreds" is *patriai* which all lexicons give as kindred from one ancestor. The Hebrew *mishpachah*' supports 'family' 288 times and it is used of the subdivisions of Israel. The Tribes became national identities but were of one racial group from one ancestor. Israel is still an exclusive race existing as families or nations. It is unto these Jesus was sent.

Acts 3:26 Unto **you** first God, having raised up his Son Jesus, sent him to bless **you**, in turning every one of **you** from his iniquities. In context, "you" still is the Israelites being addressed.

Without continual recourse to the Old Testament origins, it is impossible to rightly interpret passages in the New Testament. Only by going back can we know what *all nations* means and only then find a doctrine that is 100% consistent. Galatians 3:8 can no longer be allowed as an "out" for those preaching universal racial salvation. When we take Scripture as originally written in the Hebrew and Greek, we find that conflicts disappear.

We can understand that an exclusive Israel in would justify by belief were not heathen, but were of Israel. The proof of this is that this is the fulfilled *in us their children* and never in others. They are fulfilled in *brethren* of the same *kin*. *from all things from which ye could not be* 

The blessings of the Patriarchs [as given by Jacob in Genesis 48 and by Moses in Deut 33] for the last days still apply separately to each of that same group of peoples, who are being specified. These include the sons of Joseph, Ephraim and Manasseh. In Genesis 49 Jacob gives his prophecy about what will befall each individual Tribe of Israel, in the last days. These are limited, specific and definite. We cannot find prophecy for the application of the blessings given by the patriarchs as being applicable to all other races. This is why all nations is commonly taken wrongly today as meaning every race on earth. The statement of Romans 4:11, a father of all-them that believe is only in the context of Israel.


For the *last days*, Jacob gave his blessings to his children one by one [Genesis 49]. The blessings were to his seed only. They were not to other seeds. The New Testament is still made only with the House of Israel and the House of Judah [Heb 8:8]. The word *children* in Galatians 3:7 [the Children of Abraham] is *huios* which denotes kinship or physical offspring. [Note: This word is also used of animals, so it cannot refer to spiritual offspring in the way commonly taken!]

How can the Patriarchal blessings apply to all races? If they were all the same, what would be the point of separation? And, if they are for the "last days", why not accept this as a reality, rather than saying that some singular multi-racial church that has nothing to do with these Twelve Tribes is the recipient of these blessings?

As it has been pointed out, translators show what they believe in their translations. For instance, in Galatians 3:8 the words translated *heathen* and *nations* are identical. The translation as *heathen* gives an entirely different connotation to the verse. The nations whom God would justify by belief were not heathen, but were of Israel. The proof of this is that this is the fulfilment of the prophecy made by the Patriarchs. This is confirmed – *by him are ye justified from all things from which ye could not be*  justified by the law of Moses. These justified **Deut 28:10** And all the people of the earth shall people must have first been under the Law of Moses, so they could only be Israelites. Most of *and they shall be afraid of thee*. this book of Galatians is written relating Law and Grace to the one people. The whole argument might be summed up by questioning whether or not they were going to remain under the schoolmaster or whether they were going to believe God as Abraham did. What they were to believe was that Jesus had redeemed Israel and that Jesus was the Son of God.

Ultimately, that which is reserved for Israel, namely redemption, salvation, resurrection to eternal life, belongs only to Israel. It is their inheritance from Abraham, according to the promise made by God to the fathers of Israel.

#### **CONCLUSION**



We can see that the churches today have a major problem in doctrine. This is simply through wrong teaching that has arisen through failure to base doctrine upon the same basis used by Jesus and the Apostles. The basis must ever be the Law, the Psalms and the Prophets. The Law and the Word of God were given only to Israel among the nations. Because of the misuse of the word all, particularly within the New Testament, the presumption is made that the Law of Moses, together with the associated covenant with Israel, was given to every person of every race. In this way, all have sinned is taught forgetting the context statement whatsoever the Law saith, is said to them who are under the Law [Rom 3:19].

Look at this quotation that is one of many that shows "all" in the reverse situation.

see that thou art called by the name of the Lord,

Here all the people of the earth does not include Israel! This same situation exists more often the other way around with all being Israelites. There is yet one more important impediment preventing people accepting an exclusive Israel.

It is addressed in the writer's booklet, That Unfortunate Word "Gentile". The unity of the Scriptures is made or broken upon this un-translated Latin-originating word Gentile and what that word actually means. If we look at the words translated as Gentile in the KJV translation of the Bible and immediately something strange will be seen. From Hebrew, it is translated 374 times as nations, 143 times as heathen, 30 times as Gentile(s) and 11 times as people. From Greek it is translated 64 times as nations, 50 times as heathen, 93 times as Gentiles and twice as people.

The word "Greeks" in the Greek is the word Hellen and is used thirty five times. But our translators have chosen to translate this word (wrongly) as "gentile", particularly in the Book of Romans. Ethnos and Hellen are quite different words! Sometimes the justification is to say that the Greeks were not Jews and therefore they must be Gentiles. This is not translating; rather it is interpreting Scripture in the translations. There is neither rhyme nor reason for all these various translations and mis-translations, other than to perpetuate a belief!

The commonly accepted meaning of the word "gentile" immediately falls flat from the translation point of view alone. When we add the fact that the word in Hebrew is used also of Israel it falls even flatter! When we show the real meaning from the New Testament, it becomes so flat that it cannot be seen! The Hebrew and Greek words mean "nations" as races and peoples. They mean any group of a common origin, including Israel.

Let us look at some Old Testament Scriptures where the word Gowy, Goi or Govim are used. If we apply the logic concerning Gentiles for these verse, we can see the ridiculous conclusions that could be reached. Remember that Goi and *Ethnos* are used of Israel as well as of other races. *Gen 12:1,2 Now the Lord said unto Abram ... and I will make of thee a great nation. Gen 17:5; a father of many nations have I made thee.* 

Did God make a great non-Israel "gentile" nation out of Abraham and did Abraham father many Gentiles? Was the great nation other than Israel? *Gen 25:23 And the Lord said unto her* (Rebecca), *Two nations are in thy womb* Could Rebecca have what would become two non-Israel "gentiles" in her womb? *Gen 48:19 and his seed shall become a multitude of nations.* 

There is no evidence in Scripture that Ephraim would produce a lot of non-Israelites. Gen 46:3 And he said, I am God, the God of thy father (Isaac) fear not to go down into Egypt; for I will there make of thee a great nation. Could the sons of Jacob be non-Israel "Gentiles"? Jer 31:36 If those ordinances [the sun and the moon] depart from before me, saith the Lord, then the seed of Israel shall also cease from being a nation before me for ever.

As the word for "nation" is the same as that translated "Gentile", we could equally read *the seed of Israel shall not cease from being Gentiles before Me*. We could even say Israel would not cease from being heathen! This is absurd!

When we consider the word *ethnos*, which is sometimes translated "gentiles" in the New Testament, we have another block of translations among which we could make transpositions. The consequences are equally absurd!

# Luke 7:5 For he loved our nation, and has built for us a synagogue.

Would that section of Jewry be pleased if the Centurion had built a synagogue for the so called gentiles or the heathen? "Nation" is the word *ethnos*. *Luke 23:2 We found this fellow perverting the nation*, Would "The Jews" care so much if Jesus were perverting the "Gentiles"? John 11:48 the Romans shall come and take away both our place and nation. For the Romans to come to Judea and take away "our" gentiles gets a little silly. John 11:49,50 Ye know nothing at all, nor consider that it is expedient for us, that one man should die for the people, and that the whole nation perish not.

So we can see how transliterating one word is the major cause of objections to the exclusiveness of Israel as consistently presented through Scripture.

# The Sacred Names: Yahweh and Yahshua by

ITHIN t h e Christian Identity (CI) Movement, there is an ongoing debate about whether we should use the original Hebrew names for our God (Yahweh) and

also for our Saviour and King, Yahshua, also known as Jesus Christ. The two sides of this issue are summarized as follows:

**1.)** The English names are good enough and we don't need to resort to the Hebrew or Aramaic languages in order to address our Divine Sovereign.


T H I NA. B. C. The original Hebrew names convey meaningsb. e. which are lost in the English translation.

I am an advocate of the latter position; and I am going to do my best to give all the reasons why I advocate the use of the Divine Hebrew appellations, Yahweh' and Yahshua.'

Let it be known that I have no objection to the use of the English name for our Messiah, Jesus Christ. We have all grown up using this name and there is a certain reverence evoked when this name is spoken, so I do not wish to detract from this in any way. Also, there is a particular singularity to the name, Jesus Christ, which is shared by no other human being, past or present. There is no mistaking whom you are referring when you invoke this name. As a historian for my people, TRUE Jacob-Israel (the Anglo-Saxon, Celtic and Caucasian peoples, NOT "the Jews"), I have come to appreciate the Hebrew Scriptures from a multi-generational standpoint. When I read the story of Adam and Eve or the story of Moses and the Exodus and the writing of the commandments in stone, I know that my ancestors were present there and that my very blood is witness to these events. I feel no sense of disconnection at all. It is as if these events happened yesterday to my own parents and to my brothers and sisters. Indeed, I feel that I was present there. Their history is my history, plain and simple.

As a writer, I understand the power of words and how difficult it is to convey the full meaning and impact of a statement when translating from one language to another. Considering all the problems of translating simple declarative sentences, when we add to this complicated clauses, figures of speech, idioms, slang, vernacular, etc., it is a wonder that we understand the intentions of the Hebrew scribes and prophets at all. Most scholars agree that the King James Version is a poor translation, at best. It was written by Englishmen who had little working knowledge of spoken Hebrew or of Hebrew traditions. In addition to this problem is the fact that these translators had little or no knowledge of their true Identity, meaning that the Celts and the Anglo-Saxons are the true heirs of the heritage of the Israelites. The King James Version perpetuates the absurd idea that the Jews are identical to the Israelites. Even more problematic is the fact that the prevailing world view that these men were labouring under was the Flat Earth Theory, thus forcing them to translate God's Word from that limited point of view.

However, knowing that our Bibles are fraught with these defects, it is easy to reconstruct the language to harmonize with reality. We simply isolate these defects and adjust the language accordingly. I can say that every time I have retranslated verses with these objects in mind, the Bible has become a very accurate book; and this accuracy is reflected in terms of history, science, prophecy, archaeology, linguistics, etc. It is important to understand that the original Hebrew used by our ancient ancestors conveyed much more meaning than even modern interpreters have imagined. This is especially true of the individuals that the Bible names.



Their names are not just names. Their names are uniquely identifying trademarks which tell us what they were known for. There is a reason why Jacob was renamed Israel. There is a reason why Abram was renamed Abraham. There is a reason why Esau was renamed Edom. Esau was a Saxon (son of Isaac); but when he rejected his heritage and married into the hook-nosed Hittite race, he became a Jew and his name was changed to Edom.

Biblical names reveal much about the individual. So, to ignore their meanings is to ignore knowledge and wisdom. And the two most important names in the Bible are Yahweh and Yahshua.

#### The Tetragrammaton, YHWH

Commandment #3: Thou shalt not take the name of the Lord [Yahweh] thy God in vain; for the Lord [Yahweh] will not hold him guiltless that taketh his name in vain. (Ex. 20:7, Deut. 5:11.) Now, here we have a very important development within Christianity. Israel has forgotten God's name. An equally important realization is that what is being discussed in this Commandment is not cursing or swearing while using the word God' in a sentence. What this Commandment is referring to is the name, YAHWEH. Without the vowels, the name is known as the tetragrammaton, YHWH. This rendition, the LORD, from the Hebrew Yahweh Commandment is telling us not to use 'Yahweh' is listed as word #3068. Strong, obviously in vain. Strong, obviously

Israel's God has a name; and that name is YAHWEH. The titles, 'Lord' and 'God' are not His Name. Consequently, it has not even been possible to take His name in vain because we In fact, when Yahweh have forgotten it. divorced the House of Israel and sent us into the wilderness for our purification, one of the main reasons was that we were using His name, Yahweh, in vain. By causing us to forget His name, we were no longer able to violate this commandment. As we come into remembrance as to who we are and what our purpose is, the time has come for us to reclaim our heritage and start using our God's name again, with sincerity and purpose.



And Moses said unto God, Behold, when I come unto the children of Israel, and shall say unto them, The God of your fathers hath sent me unto you; and they shall say to me, What is his name?

What shall I say unto them? And God said unto Moses, I AM THAT I AM: and he said, Thus shalt thou say unto the children of Israel, I AM hath sent me unto you. And God said moreover unto Moses, Thus shalt thou say unto the children of Israel, Yahweh God of your fathers, the God of Abraham, the God of Isaac, and the God of Jacob, hath sent me unto you: this is my name forever and this is my memorial unto all generations. Ex. 3:13-15.

The Bible repeatedly admonishes us to revere God's name in prayer, praise and song; but, because of our punitive divorcement from Him, we haven't done this for centuries. Despite our forgetfulness, His name is forever and it is to be a memorial unto all Israel.

So, why haven't we been using His name? One of Him. This awesome power is reflected in His answer is provided by Strong's Concordance name and that's why we are commanded to both itself, although unintentionally. The English use it properly and not take it in vain.


Jehovah is a medieval rabbinical concoction which is typically unbiblical. Virtually all scholars agree that the correct pronunciation is Yahweh, with the first syllable pronounced like the German Ya and the second syllable pronounced like the German geh as in Gehen Sie heim. This German eh sound is longer than the English short eh as in Ed but shorter than the English ay sound, as in way. Phonetically, it is almost directly in between. And, in Hebrew, the is pronounced like a V (Yahveh). W Historically, the letter W did not enter into our language until around 1,000 AD. Before then, we only had the vowel U and the consonant V. So, phonetically, the name should be pronounced although YAH-VEY. anglicized the pronunciation "YAH-WAY" has become very common among CI people.

Since we had forgotten we are Israel, we also had forgotten to use His name when praying to Him. God wants us to address Him by His name, Yahweh, which is the specific name that He had instructed Moses that we, His people, were supposed to use. Yahweh means Creator, or, more primordially, I am becoming', or I am that I am' ('I am that which I choose to be'), or even more simply, I am.' Blessed is the people that know the joyful sound: they shall walk, O Yahweh, in the light of thy countenance. In thy name shall they rejoice all the day: and in thy righteousness shall they be exalted. Ps. 89:15,16. Unto thee, O God, do we give thanks, unto thee do we give thanks: for that thy name is near thy wondrous works declare. Psalm 75:1.

Help us, O God of our salvation, for the glory of thy name: and deliver us, and purge away our sins, for thy name's sake. Ps. 79:9.

When we address God by His name, Yahweh, we are acknowledging His self-creating Being. His name means causation, creativity, will, and power. He is the One who creates everything and allows everything else to be created because of Him. This awesome power is reflected in His name and that's why we are commanded to both use it properly and not take it in vain. In Judah God is known: his name is great in mixed mongrels) who possess only partial Israel. Psalm 76:1.

A major feature of the Restoration of Israel in the latter days is this rediscovery of His Name by His remnant people, Jacob-Israel. Revelation 22:4 tells us this: "And they shall see his face; and his name shall be in their foreheads." We are Yah's people and Yah is our God. He has promised us that when we address Him by His Name, Yahweh (or, "Yah," for short), He will listen to us. God' is a title, not a name. A title denotes a position or office. A name denotes a particular individual.



In addition to its meaning as "Creator," Yahweh' is also an affirmation of life. In the Germanic languages, Yah' means yes'. Yahweh is the "ever-living One." We accept life with all of its challenges and responsibilities because life is His blessing given to us. The subject of our God's name is a very important one. It is the subject of many philological articles and sermons.

One of the main differences between Judaism and Biblical Christianity is the use of our God's name.

There is a common misunderstanding by non-Identity Whites that the use of Yahweh' is a Jewish tradition and that the use of Yahweh' insults Christianity or the White race. This idea is completely false and is based on the erroneous assumption that the Jews are Hebrews. The Jews were never Hebrews. The Hebrews, by definition, are racially pure Adamites descended from the patriarch, Eber. The Jews have always been a mixed multitude of mamzers (racially

Adamite/Hebrew blood.

The first portion of Adamic blood they inherited came through Cain, who was a half-breed Adamite/Nephilite. These early Jews were known as Cainites and later became known as Canaanites because they settled in the land of Canaan.

The second infusion of Adamite blood into the Jewish people came from Jacob's brother Esau, who was a race traitor. The Bible tells us that "Esau despised his birthright [genetic heritage]." Jacob and Esau were twins, but when Esau refused to reproduce after his own kind, his parents disowned him, and more importantly, Yahweh Himself disowned him. After being disowned, his name was changed to Edom. Having married into the Canaanite people, his Canaanite descendants became known as Edomites.

The third major infusion of Adamite blood into the Jewish people came as a result of an act by King John Hyrcanus, who merged the Edomite nation of Idumea with the Judahite nation of Judah around 150 B.C. Despite repeated infusions of Adamic blood into the Jewish people, they cannot claim to be Adamites, Israelites, Judahites, Hebrews, or even Semites, because all of those designations, by biblical definition, are reserved exclusively for pureblooded Adamites.

This makes the Jews mixed-race stepsons at best and outright impostors at worst. Irregardless, the Jews were not, are not, and can never be the heirs of the Kingdom because Yahweh does not permit race-mixing in His people. And as long as the Jews continue to impersonate Israel and pretend to be us, they hope and fantasize that they shall steal our inheritance by this grandiose deception. In truth, their main reason for being is to deceive True Israel. By impersonating us, they hope to deprive us of the promised Kingdom, at which time Jesus Christ will return to claim True Israel as His Bride. At the same time. He will judge the Jews, and those who work for or with them, for their iniquity. Even though the rabbis of Judaism love to fool gullible Christians with the slogan, Jesus was a Jew, they know full well that Jesus was a racial Judahite, and not a Jew. Jesus was not a mixed breed

individual. He was a 100% Judahite. "I am the root and the offspring of David," -- Rev. 22:16. As part of the deception of True Israel, and contrary to the teachings of the Bible, Judaism forbids the use of God's name, Yahweh. Christians have to ask: "Why would God's purported 'chosen people' disobey their own God by refusing to use His name at all? Well, since the Jews aren't God's people, it is easy to understand why they don't use His name.



The rabbis of Judaism very cleverly exploit the fact that we have forgotten His Name and claim that His Name is TOO HOLY TO BE PRONOUNCED – by anyone! In this way, they hope to prevent us from re-establishing our relationship with Him!

As part of Yahweh's Writ of Divorcement, the House of Israel was exiled away from Palestine in 745 B.C. (See Isa. 50:1, with elaboration in Hosea, Chapters 1-3.) This period of exile was prophesied to last 7 "times." (Lev. 26:18.) This is known to Bible scholars as the "seven times punishment." In prophetic reckoning, a "time" is equal to 360 years. 7 \* 360 ' 2520. 2520 years after 745 B.C. brings us to 1776 AD, the year in which America, a White Christian nation based on biblical law, was born. The divorce period ended in 1776, and we, True Israel, remembering who we are, are also beginning to remember our God, Yahweh. The International Jew has been trying to destroy America ever since it was created by Yahweh, but he will not succeed. The Book of Revelation (Chapter 12) makes it very clear that the Bride of Christ will be composed of the "saints" of the Twelve Tribes of Israel -and no one else.

The Jews, by forbidding the use of His Name, hope to prolong our national amnesia which has now fulfilled its prophetic purpose. The Anti-Christ rabbis have no choice but to continue their

fraud and mockery in perpetuity. Their only hope of avoiding the Judgment Day is to try to prevent the Wedding Feast of the Lamb, the event at which Yahshua will claim His Bride. If they can prevent us from rediscovering our Identity and prevent us from praying to our God, Yahweh, they can delay both our salvation and their death sentence. Their religion, Judaism, has one main purpose: to deceive True Israel and thereby separate us from our Father, Yahweh. The longer they can keep us apart, the more they can delay our true inheritance of everlasting life in His Kingdom as Yahweh's chosen people.

#### 'YAHWEH' or 'BAAL'?


Most translations of the Bible contain the expression the LORD in place of the name Yahweh'. But Lord' in English is the same as Baal' in Hebrew! Ask yourself: "Why would Yahweh want us to address Him as Baal' (a pagan deity) when He condemns Baal worship?" Even more to the point: why would the translators want to use "Lord" knowing that it means "Baal"? Obviously, Yahweh does not want us to do so. The explanation for this curious phenomenon lies in the fact that the translators of the King James Bible had unquestioningly adopted the Jewish tradition of replacing Yahweh' with "the Lord" wherever it occurred in the Old Testament.

What is the Biblical justification for doing this? There is none!

But there are two reasons why Christians have accepted this tradition. The first is the false assumption that the rabbis are the authorities on this subject. As all CI people know, Judaism is NOT the religion of the Old Testament. Their holy book is the Talmud, which often changes and even contradicts the Torah of the Old Testament. For the rabbi, it overrules the Old The two religions are so Testament. diametrically opposed that it would not be erroneous to say that whatever the Torah forbids, the Talmud permits. For this development, we can directly blame our ancestor, John Hyrcanus, for had he not merged Idumea with Judah, the mixed-race sect known as the Pharisees could not have emerged over the hereditary Levitical (i.e. Israelite) priesthood. It was these Pharisees who invented the religion known today as Judaism.

The second reason can only be a sinister motive Jesus said: Seek ye first the kingdom of God and by the rabbis who want to keep True Israel from praying to their God in an effective way. If we don't know how to use our own God's name, we cannot expect Him to respond to us in a personal manner. It's like the difference between saying Hey, you! versus Dear John B or the difference between wishing upon a star and making a personal appeal to your Creator. To which do you think Yahweh is more likely to respond? What's your name? Are you more likely to respond to someone who uses your name or to someone who calls out Hey, you, Baal!? Of course, humility, faith and patience have a lot to do with effective prayer as well.

#### What does the Bible say about using His name?



I will publish the name of Yahweh: ascribe ye greatness unto our God. Deut. 32:3.

I will praise thy name, O Yahweh, for it is good. Ps. 54:6.

The Bible is full of admonitions for us to use His name and praise His name, especially in the book of Psalms. The Book of Psalms is a book of prayers in which almost every prayer is dedicated to His name and to the use and praise of His name. This should be a lesson for all Israelites, especially when it comes to answering the question, Why doesn't God answer my prayers? When you start addressing Him by His name, Yahweh, then you will start getting answers. But when asking for personal help, be sure to make a plea for all of True Israel and for all of your friends and relatives, because selfish prayer is not what Christianity is about. We pray for others and we do what we can to build the Kingdom of God here on earth. Remember what Kyrios (Lord) for the Name.

his righteousness; and all these things shall be added unto you.

Pray first for instruction and enlightenment, and the same for others; and only thereafter for supplication. Our mutual seeking after righteousness will establish the Kingdom. Only if we are desperately ill should we pray more for ourselves; and then it is good to have other Israelites pray with you. Even here prayer should be done in a spirit of repentance and devotion to the Kingdom.

To underscore this topic about God's name, I would like to quote from the Preface of the Holy Bible, Revised Standard Version, 1972:

A major departure for the practice of the American Standard Version is the rendering of the Divine Name, the Tetragrammaton. The American Standard Version used the term Jehovah; the King James Version had employed this in four places, but everywhere else, except in three cases where it was employed as part of a proper name, used the English word LORD (or in certain cases GOD) printed in capitals. The present revision returns to the procedure of the King James Version, which follows the precedent of the ancient Greek and Latin translators and the long established practice in the reading of the Hebrew scriptures in the synagogue.

Now, dear Christian, should we follow Jewish tradition just because the Jews do it or should we follow what the Bible tells us to do? Your answer may determine which side you're on at the Judgment Day.

#### The RSV continues:

While it is almost if not quite certain that the Name was originally pronounced Yahweh, this pronunciation was not indicated when the Masoretes [the Jewish scribes] added vowel signs to the consonantal Hebrew text. To the four consonants YHWH of the Name, which had come to be regarded as too sacred to be pronounced [without any Biblical authority!], they attached vowel signs indicating that in its place should be read the Hebrew word Adonai meaning Lord(or Elohim meaning God). The ancient Greek translators substituted the word The Vulgate likewise used the Latin word Dominus. The form Jehovah is of late medieval origin; it is a combination of the consonants of the Divine Name and the vowels attached to it by the Masoretes but belonging to an entirely different word. The sound of Y is represented by J and the sound of W by V, as in Latin. For two reasons the Committee has returned to the more familiar usage of the King James Version: (1) the word Jehovah does not accurately represent any form of the Name ever used in Hebrew; and (2) the use of any proper name for the one and only god, as though there were other gods from whom He had to be distinguished, was discontinued in Judaism before the Christian era and is entirely inappropriate for the universal faith of the Christian Church. pages 3 and 4 of the Preface (no printed pagination).

In other writings, I have discussed the merits of the Masoretic Text versus the Greek Septuagint and I have become convinced (as have many other scholars of numerous denominations) that the Septuagint is the more accurate text. The Septuagint is a direct translation from the Hebrew into the Greek by JUDAHITE scribes. The Jews, as the mixed-breed offspring of

Idumeans and Judahites, had absolutely nothing to do with the writing of the Septuagint. The fact is that the Septuagint is Israelite/Judahite literature. The Masoretic text is Jewish, not Israelite, literature.

The authenticity of the Septuagint was proved by the discovery of certain books of the Old Testament in the Dead Sea Scrolls. These Dead Sea Scroll versions proved to be older than either the Masoretic or any of the existing Septuagint texts. The Septuagint almost always adheres more closely to the Dead Sea Scrolls than does the Masoretic heresy, thus verifying that the rabbis had made unauthorized changes to the original text. By "unauthorized," I mean the command of Moses that the Hebrew Scriptures are not to be tampered with by anyone. This command is found at Deuteronomy 4:1 & 2. As it stands, the entire Talmud, since it consists entirely of rabbinical additions and changes to the Torah, is in violation of this Mosaic command.

## The Conspiracy By Dr. Oren Fenton Potito



**ORLD WAR I** was not, as g e n e r a l l y believed, the result of only the natural interplay of the ambitions of the Great Powers and of growing nationalism. Generalities and abstractions are not

sufficient to cause wars; wars are brought on by the actions of men. In both world wars, these actions were deliberately calculated to bring on war with all its misery and suffering. The purpose of those who brought on the First World War was two-fold: first, the war by its own momentum would open huge cracks in the foundation of Western Civilization by destroying the soundest values and most stable institutions Second. our civilization. the in peace conferences following the war would be used to intensity the upheaval and to provide the foundation of a world-wide empire, to be built first on the ruins of all European empires and of the Christian civilization they had spread over the entire globe, and later on the ruins of the United States. Who were these men, and what was their goal?

They were and are a tightly knit clique of jewish conspirators who have been and are made up of, and recruited from, the very top financial, economic, educational and political levels of each country in which they operate. The ultimate goal of this jewish conspiracy is the absolute domination of the entire world to be accomplished by the destruction of civilization through the merging of all nationalities and races into one people under one government; the abolition of all private property; the destruction of all religion except judaism; and the abrogation of all morality. The immediate goal of each generation of these yiddish conspirators was the reward power, wealth and fame, which they received by advancing the final goal. The makeup and purpose of the conspiracy were explicitly defined by its founder, a jew, Adam Weishaupt, and embodied in his organization, the Order of Illuminati, founded May 1, 1776. The Illuminati was strong enough by 1789 to play a major role in planning and precipitating

the French Revolution, and members of the Order held power in France for about six years openly. After 1795 the Illuminati went completely underground, and the secret of their existence became the fundamental law of the Order.

But despite the strict secrecy the conspiracy maintained, we do have a considerable amount of information about its activities between 1795 and 1917 when its principle aim, Communism erupted in Russia. A chief agent of the Illuminati, Joseph Fouche, a French jew, was responsible for placing a member of the Order, Jean Baptiste Bernadotte, a proselyte, on the throne of Sweden. It was an agency or ally of the conspiracy, the League of Just Men, which hired Karl Marx, a Rabbi's son, whose real name was Moses Mordecai Levy, to write the Communist Manifesto which is based on the jewish Holy Book, the Talmud. This group, which was renamed the League of Communists, was a major factor in bringing about uprisings throughout Europe in 1848.

The conspiracy played a more important role in organizing the Italian Revolution, directed by the jew who infiltrated and mislead Masonry, Albert Pike, and also, the Juarezista Revolution in Mexico in the 1860's. Both the assassination of Czar Alexander II and the Haymarket Riot in Chicago were the work of related agencies of the conspiracy. In fact, throughout the last half of the Nineteenth Century, the jewish Order of Illuminati used Communists, socialists. anarchists, and numerous other groups and subsidiaries to advance its goals and solidify its position in nearly every nation.

By 1914 the jews had sufficient power and influence to precipitate World War I. At this point it was not necessary for the Order to be able to control every action in the war. The war itself, by its very nature, served many purposes of the jews. They only needed to direct it to the desired conclusion, which they had the ability to do; and when this occurred with the armistice, they held the control of the peace conferences. The war had so weakened Russia that the jew Trotsky, whose real name was Bronstein, and a band of vicious jewish criminals, financed and directed by their yiddish brethren throughout It was quite another arrangement which finally Europe and in the United States, were able to seize power replacing the truly progressive government of Nicholas with reactionary jewish Bolshevism. The peace conference opened the way for the communization of Europe, and the League of Nations, to which it gave birth, was meant to further the goals of the conspiracy through the activities of its clique of "illuminated' or Fabian diplomats. Although the refusal of America to join the League ruined its planned effectiveness, the League still served many useful purposes, not the least being as a forerunner of the United Nations.



World War II should have been a war and crusade against the jew communist beast, but it became a struggle between Christian countries. Hitler himself never wanted a war in the West and his great goal, as events demonstrate, was the destruction of the Soviet Union. Communism was saved and made victorious in great part because of the conspiracy's diplomatic successes in 1936. After the assassination in 1934 of King Alexander of Yugoslavia, the greatest obstacle to the Barthou-Titulescu-Benes plan to encircle Germany, the balance of power between the anti-communists and the pro-communists was thrown to the Left.

The Western anti-Communist leaders had supported a quadripartite pact proposed by Mussolini which would have been a renewal of the Pact of Locarno and which was, in reality, meant for the common defense of Europe against Soviet Russia. The pact included the Western allies of World War I and Germany, and it would have established an anti-Communist core in Europe. But although all parties signed it, the treaty never came into force because it was not ratified by the jew controlled French Parliament.

triumphed the jewish inspired pact of military alliance between France, Czecho-Slovokia and Soviet Russia ratified in 1936 and the major cause of the disaster to come. It introduced Russia into the mainstream of Western diplomacy, perfected the encirclement of Germany, and instead of protecting Europe from the Soviets, it protected the Soviets from Christian Germany's growing military might.

But the pact with Soviet Russia was going to be of absolutely no benefit to France or Czecho-Slovakia, and would probably never have been ratified by the French Parliament, unless a route could be found to enable the Red Army to join in any conflict that might arise between France or Czecho-Slovakia with Germany. The Christian leaders of Poland and the Baltic states stubbornly refused to permit such passage under any pretext.

The effects of the Franco-Soviet and Czecho-Soviet treaties were immediate. Germany was surrounded and desperately needed to adjust the balance of power, and Germany needed to protect itself on its western and southern borders. Therefore Germany reoccupied the Rhineland, on the basis that the Franco-Soviet alliance invalidated the Pact of Locarno. Germany proclaimed the Anschluss with Austria to the general enthusiasm of the population, and when submitted for approval to the people of Greater Germany, it was approved by 99.08% of the voters. Germany demanded the return to Greater Germany of the three and a half million Germans, which the Versailles Treaty had incorporated, after the Austrian Empire was dismembered, into Czecho-Slovakia.

Contrary to popular belief, sanity won out for a moment at Munich, and after years of harassment and treachery on the part of the jewish government in Prague, what was probably the best possible arrangement was agreed to by the Big Powers. But all was for nought; the jews pulling the strings soon had the very men who saved Europe in 1938 destroy it in 1939. Germany had been maneuvered into a trap, which would be sprung by the hopeless Polish problem. The Polish Crisis was hopeless not because the disagreement between Germany and Poland was so great, the issue involved was chiefly a a matter of border adjustments, or because of an ancient national enmity for

Germany and Poland had in recent years enjoyed destroyed communism in the 1940's and our excellent relations. The problem was made hopeless by the intervention of jewish controlled diplomats, who constantly advised and told the Polish not to negotiate and by Poles such as Marshal Smigly-Rydz, who threw their country into a war she could not possibly win. Germany was forced into a war against the West because the leaders of Western Europe made all other courses of action impossible. Germany did not sign the non-aggression pact with Soviet Russia in order to be free to conquer the West. The pact was an EXPEDIENT and NOTHING MORE!

Its purpose was to secure Germany's rear position in order to be free to destroy jewish communism in Russia when the time came. Hitler abhorred the idea of a two front war. It is ironic, and sad, that he had to conquer the West in order to fight the communist East. When war came, England and France did nothing to help Poland. At no moment were the solicitudes shown by the Western Powers and the vain guarantees they offered Poland motivated by any real intention to save her integrity and her independence. On the contrary, as far as the jews were concerned, Poland was sacrificed even before the beginning of the armed conflict.

With the fall of Poland, France was released from any obligation to continue the war, which she had not even fought, and she could have reached a satisfactory settlement with Germany. But the same leaders who had pushed Poland over the brink now threw their own nation into defeat. The onslaught came on May 10, 1940 and by June 14, 1940 the war for France was over. Now Hitler began to prepare his war against Russia; he refused to first eliminate a fellow Saxon nation as England was, and did not consider another member nation of the House of Israel, the United States a threat. (Germany represents the tribe of Judah).

When the Germans invaded Russia, they could hove wiped communism off the map. That they failed was due to jewish control of the governments of the West, and also, to the jewish agents hidden high in their own government, but by far the major factor causing Germany's defeat was the listening to Satanic jews by us here in the United States and sticking our noses into a fight which was none of our business! If we had not sent our troops and supplies to win the war for the communists, Hitler would have won and

of the German Intellrgence Service (above) His real name was Meyerbeer. HE WAS A JEW! As important as all these points are, Germany would still have won the war against communism but for one thing .... The United States came into the war and won it for the communists. We have been paying for that mistake ever since! When the war started Stalin had some 12 million men and he massed at least four and a half million in the western frontier area, more than a million and a half men than made up the German attack forces, but the German military as usual, was far superior, as they were thousands of years ago when they led the armies of Israel against Jericho with Joshua as their commander. (The Germans are the descendants of the Tribe of Judah). Because of this fact the communists fled in every direction. Many Russian units surrendered in order to join with Hitler. It was only after the Wehrmacht was forced to refuse help from these Russians and imprisoned them on orders from von Paulis that they stopped trying to help Hitler and began fighting to their last breath. Also the Kremlin could depend on its hidden jewish friends in Germany for information. The flow of intelligence data from various sources continued throughout the war. Soviet agent Alexander Rado, in Switzerland was able to advise Moscow of decisions of the German High Command within forty-eight hours after they were made. The jewish source was hidden on the German General Staff.



In this light the statements of Hitler to the effect that the war was being lost by treason do not sound like the ravings of a "drug eater". He became aware that he was being lied to. For in his charges of treason, Hitler was correct: Germany's war against Russia was not lost at Stalingrad by his troops, it was lost in Berlin by jewish spy's and German traitors. (Take note Americans, Washington is loaded with jews and you will never win another war against the communists until you throw them out!) The war against communist Russia was a crusade to save White Christian Civilization from destruction by jewish communism. The men who fought and died in the struggle in the East have been condemned, partly because they lost, but the soundness of their fear of jewish communism has been borne out by history.

World War II was brought on and concluded according to a deliberate plan developed and carried out by a conspiracy of a small, centrally directed group of jews high in the governments

of nearly every nation. That the jews intended to deliver all of Eastern Europe to communism is made clear by their activities as the war came to a close. After Stalingrad, the possibilities of a German victory in Russia were nearly ruined, but the war was by no means over. As the German and allied armies pulled back towards the West, they desperately attempted to form a line of resistance to the communist onslaught; once such a defensive line was formed two courses of action would become available. The first one, and the one on which Hitler based his strategy, was to hold all possible points in the East in the belief that it was only a matter of time before the United States and Britain would stop listening to the Jews and come to see communism as their real enemy. Hitler would have then signed a separate peace with the West, and with the aid of his new allies he would have mounted a great counteroffensive which would totally crush the communist army. As late as March 1945 German troops were ordered to hold, at all costs, bridgeheads across the Oder because they would be needed as launching points for the joint attack. Now you know the real reason why Hitler ordered his men to fight to the last, even in the streets of Berlin, not because he or they were crazy fanatics as the rotten jews have been telling you ever since the war ended. They were HEROES and were actually fighting for us and CHRISTIAN civilization while we were helping the KILLERS OF CHRIST!!!

Although the Jews would never have allowed the Allies to consider such an arrangement, at least the Germans were thinking right even if we were not. The second possibility provided by a stabilized line of defense from the communist hordes offered to the Western powers an opportunity to save Eastern Europe even without accepting Germany as an ally. Those who fought and died to form this line of defense for us, and to permit, thereby, the penetration of Western armies deep into the East fought and died in vain, unless we do something to make up for the sins we committed Remember, ALMIGHTY GOD IS HOLDING US RESPONSIBLE, and that is why America is in such great trouble today!

The iew led Allies refused even to consider the proposal, telling Mihailovich to have the Germans MAKE THEIR OFFER TO THE COMMUNISTS!!!

The war ended with Germany smashed in half; occupied by the communists, with Estonia, Lithuania, Latvia, Poland, Czecho-Slovakia, Hungary, Rumania, Bulgaria, Yugoslavia and Albania under jewish rule, and with only communism victorious. Those military or

for so long were executed, imprisoned or forced into exile. Let this paper provide a stern lesson for those who today believe that they can reach an accommodation with the communists. #### The Conduct of War by Politicians in Cabinet (Cast Iron Railings or Futility)

N London I often passed St Paul's Cathedral and admired the black iron railings still in perfect condition, rust free, after over 300

years old. This reminds me when my stepfather told me, of the mysterious iron pillar in India over 800 years old which had never rusted! After his passing I learned the reason. Until our industrial revolution charcoal was used to smelt iron, which is pure and will not cause the iron to rust. When coal was used the furnace had to be invented to prevent too many impurities in the iron. But by this method pure iron cannot be produced, so it rusts.

Going for my comic the *Daily Mail*, every morning, I see some of the war injuries of Scarborough, noticeably the old folks home. A low stone wall and in the capstones are the holes where the black iron railings used to sit. Behind the wall is the brown wooden fence in lieu of the better looking black iron railings.

And why are the surviving railings black today? In Georgian and early Victorian times railings were painted in bright colours. Roses are red.... This created employment which stopped at the death of Prince Albert. Queen Victoria decreed that all iron railings be painted black in mourning. And they are still mourning the death of Albert!

This was a catastrophe for the colourful artists who painted the railings and they had to find other work to make their livings. The railings have been black ever since. With all due respect to Victoria, I consider her to have made a foolish decree.



We were living at 42 Shotburn Crescent, Leven, Fife, when war started. I watched two men collecting our railings for scrap iron. They used a burner to cut the metal and when my stepfather returned home in the early evening I asked him what they were using. "An oxyacetylene torch", he said.

My stepfather was working at Durie foundry on war production, making aluminium wings for fighter aircraft and assembling armoured cars and sometimes he had to go to see the Ministry in London.

He came home once in a blazing temper. When the train was passing through the wolds or dales of Yorkshire he saw tens of thousands of tonnes of black and railings lying rusting in our brisk British weather.

He explained why to my mother and me. An iron furnace is like a bottle of wine. The best melt is at the top and the lesser is at the bottom. It is so full of impurities it can only be used for and railings. So this "scrap" and could not be used for weapons or shells as these have to be made from the best quality steel. (war uses the best and the best of humanity are killed.)

This reminds me of a poem I read in a boy's book, — "*As I was walking down stupidities Street*". If any reader knows it please inform our editor.

We can all say that this futile and expensive nonsense was dreamed up (our nightmare) in Cabinet. And no politician had the wit to ask a technical expert – an iron-master or an engineer.

We only "won" the war by God's good grace and real men like Dowding, Brook, Auchinleck etc under the authority of fools. There are no winners in any war, except banksters and armaments manufacturers like Chamberlain who got us into the war.

I read once that 30,000 missiles were shot, thrown or dropped to kill one man in World War I. ### Master Or Servant Exodus 19:5-6, Deuteronomy 7:6, Isaiah 41:8, 44:21 John Trotter (Australia)

For thou art an holy people unto the LORD thy God: the LORD thy God hath chosen thee to be a special people unto himself, above all people that are upon the face of the earth.

Deuteronomy 7:6 (KJV)

**HIS** subject deserves a book, not a brief article. It is hoped, nevertheless, that the few thoughts expressed will highlight the difference as to whether true Israel is to be a master or servant people. It is necessary to say that for those who are chosen to rule with Christ and be of service within Israel , will have to be humbled and made to realise that faith and obedience to the God of Abraham, Isaac and Jacob, is absolutely necessary. The 2 Gospels of personal Salvation and the Kingdom message has to be fully understood and accepted.

For too long the churches have been largely preaching from the New Testament. The relevance of the Old Testament and its history has been more often expressed as just lessons for personal living. Verses like Romans 15:4 and 1 Corinthians 10:11 have almost lost their relevance. It is true there might be reference to the Psalms and the Ten Commandments, but more often the historical connection is put aside and in its place a personal message is derived. The true Gospel has become a "me, me Gospel". The national message is completely overlooked. This teaching amazes me, considering Jesus Christ continually quoted from the Old Testament and also the New Testament did not come into being until some decades after the Resurrection of Christ. The book of Revelation was not completed till after 90 A.D. Because of spiritualising, the servant role of Israel has been lost.

Whilst there are a number of reasons why the Old Testament is considered irrelevant, I will be mentioning only one reason. It is the view of some that the Old Testament is a script that is preparing the "Jews" for world domination. This view considers them the "master race" and they have been given the authority to rule the world by the use of money and controlling the world's wealth. This is an immense subject. It is my view that there are cabal plans for world domination but to just point the finger at one group takes the attention away from the broader issues.

There has been written many books on this emotional and illusive subject. Such a book is, "The Controversy of Zion" by Douglas Reed. This book is full of interesting information but for the brevity of this article I will only provide 2 quotes. They are from page 1 and page 13: "The true start of this affair occurred on a day in 458 B.C. which this narrative will reach in its 6<sup>th</sup> ch. On that day the petty Palestinian tribe of Judah (earlier disowned by the Israelites) produced a racial creed, the disruptive effect of which on subsequent human affairs may have exceeded that of explosives or epidemics. This was the day on which the theory of the masterrace was set up as "the Law"" and secondly, "Therefore Deuteronomy is also the basis of the political programmes, of worldly dominion over nations despoiled and enslaved, which has been largely realized in the West during this Twentieth Century. Deuteronomy is of direct relevance to the events of our day, and much of the confusion surrounding them disperses if they are studied in its light".

There is no doubt that Israel, for reasons that would not be normally accepted, was favoured by God over other nations. What is overlooked was that this favouring was not for Israel's sake, but for God's Holy sake. On the surface, the following verses that are used by D. Reed and others do appear to indicate that Israel, more specifically the tribe of Judah, was not only superior but was to be a future master race over all other nations. Without some in depth study you either accept Mr Reed's understanding or you finally accept the teaching that the "bride of Christ" has been replaced by the "body of Christ" or the "church", both of which are incorrect.

Below are some verses that would indicate, on the surface, Israel's role as master over all other nations: Exodus 19:5,6; Leviticus 20:24; Deuteronomy 7:6, 15:6, 26:19, 28:1,13; Isaiah 14:2, 19:25, 49:23, 60:14. There are many other verses that D. Reed and others use to justify their beliefs.

Deuteronomy 7:6 says: "For thou art an holy people unto the Lord thy God: the Lord thy God hath chosen thee to be a special people unto Himself, above all people that are upon the face of the earth". The following few thoughts show why we cannot take words on face value. The word holy means separated. Being separate from the world is also a theme that runs through the New Testament even by Jesus Himself. The same thoughts can be applied to the word chosen. The word special means peculiar treasure. Again this is mentioned in Psalm 135:4, Titus 2:14 and 1 Peter 2:9. The phrase "above all people" is best understood by referring back to the word peculiar. One of the cross references to Deuteronomy 7:6 is MalachI 3:17.

If the sovereignty of God, which is also a Biblical theme, is to be considered then we have to accept the fact that God is the potter and we are the clay (Isaiah 64:8). It is not on our conditions that God can accept or reject. If God needs for His plan a people who will be used to show the way of Salvation for all people, SO BE IT.

Throughout the Bible we are told that even Israel, who is treated so differently to other nations, will be rebuked and chastised (Deuteronomy 8:5, Hebrews 12:6 and Revelation 3:19). It is stated in Hosea 4:6 that God will reject and forget His children due to their disobedience. We also would be cursed if we disobeyed His Laws as stated in Deuteronomy 28. Not one of these verses, and many more would indicate to me that Israel was to be some master race of people. The Laws that Israel was expected to obey only showed that they were a schoolmaster to bring us unto Christ so as we might be justified by faith (Galatians 3:24).

The Bible is very clear that God cannot complete His Kingdom plan if He was to totally destroy Israel as a people. Even if Israel was totally obliterated from the earth, God would raise up children of Abraham from the stones beneath our feet as stated in Matthew 3:9. On the other hand the Unconditional Covenants are as eternal as the existence of God Himself.

This total inability of God to completely eradicate Israel from the affairs of history, shows the providence of God even towards a people who have been stiff necked from the beginning of their history (Exodus 33:3, Deuteronomy 9:6). The reason why it says in MalachI 3:6, "For I am the Lord, I change not, therefore ye sons of Jacob are not consumed", is because the servant work of Israel is not yet complete. It is my belief that in God's plan Israel is to be brought low and that the wickedness and backsliding (apostate unbelievers) are to be used by God to reprove Israel (Jeremiah 2:19), His wife (Isaiah 54:5, Jeremiah 3:14). These are not the signs of a people who are supposed to hold the world to ransom.



From the beginning of Israel's existence the rulers of the have world come together as a counsel to destroy the Lord and His anointed (Psalm 2:2). They have said. "Come and let

us cut them off from being a nation so that the name of Israel may be no more in remembrance" (Psalm 83:4). I ask the question, Why would the enemies of Israel go to so much trouble, if Israel was to be the master race over all nations? It is a sad fact that the churches have carried out most of this attempt to obliterate the name of Israel. They have done it by spiritualising so much of Scripture. Even the Kingdom Parables have been spiritualised to the point that the only message is personal. As Sir Isaac Newton once said, "About the time of the end, a body of men will be raised up who will turn their attention to the prophecies and insist upon their literal interpretation in the midst of much clamour and opposition". It is so fortunate that Israel under the New Covenant arrangements is yet to complete her work as a servant. Also if Douglas Reed is correct how could Israel which included the tribe of Judah be considered a master people when they are "dumb and blind"? (Isaiah 42:19).

The fulfilment of the Gospel being taken to the 4 corners of the earth has been completed. This

Gospel has been taken to the ends of the earth On page 401 the author of the above book asks by the Anglo-Saxon-Celtic nations. This cannot be denied. In a recently written book entitled, "The Book That Made Your World (How the Bible created the soul of Western Civilisation) by Mr. V. Mangalwadi the author makes the following observation. On p. 271 he refers to the 19th century revival. This Great Awakening opened up the intelligent study of the Bible to the masses. EFORE we dive into the Old Testament, let us take a peek into the New Testament. This is for those who lack faith in our Father's Word, or who have been brainwashed in the establishment churches. Cross reference everything in those verses what we are about to read in Matthew chapter 15, and see the example that Yahshua gave when it came to following the above commandments.

Matthew 15: 22: "And, behold, a woman of Canaan came out of the same coasts, and cried unto him, saying, Have mercy on me, O Lord, thou son of David; my daughter is grievously vexed with a devil."

**Verse 23:** "But He answered her NOT A WORD. And His disciples came and besought Him, saying, Send her away; for she crieth after us."

Do you understand, when she asked Yahshua for aid, He just ignored her, and even His disciples wanted Him to send her away. They didn't want anything to do with her. Why? We shall see

**Verse 24:** "But He answered and said, I am not sent but unto the lost sheep of the house of Israel (Who are today known as the Anglo-Saxon, Celtic, Nordic, Germanic, Lombardic, Teutonic, and kindred peoples of Europe.).'

**Verse 25**: "Then came she and worshipped Him, saying Lord, help me."

**Verse 26:** "But He answer and said, It is not meet to take the children's (the Children of Yahweh through Adam) bread, and to cast it to DOGS (beasts...chay kiy 'erets)."

Verse 27: "And she said, Truth, Lord: yet even the dogs eat of the crumbs of which fall from their master's table." Note in Genesis that Adam was given dominance over all beasts, and thus is their master. Note what happens when she accepts her god-ordained role, as a dog (beast) and servant of man (Adamites).

**Verse 28**: "Then Jesus answered and said unto her, O woman, great is thy faith: be it unto thee even as thou wilt. And her daughter was made whole from that very hour."

Note, that Yahshua did not give the children's bread to her, nor offer her anything holy. He did not offer her the keys to the kingdom. She received the crumbs from the table. A healing for her daughter, which is an earthly blessing. In ignorance, many Christians have been deceived by the Ba'al ministers into thinking that this woman was gentile, but for one to be a gentile, they must first be an Adamite, not a beast of the field, for the gentiles came not of the pre-Adamic races, but of the pure racial sons of Adam. **Verse 22:** "Wherefore I perceive that there is nothing better [while here in this flesh

his own works; for that is his portion: for who shall bring him to see what shall be after him?"

You see, the spirit of man, though we see it not, shall return to the celestial planes [upward] to be with Yahweh when his flesh tabernacle returns to dust, while the spirit of the beast shall go into the inner earth [downward], where resides both the grave [Hades] and a chamber known as Paradise.

# **The Genesis Flood** Why the Bible Says It *Must* be Local (2) by **Rich Deem**



**HERE** is another indication in the text that the flood did not cover the highest mountains. Again, from Genesis 8:

So he waited yet another seven days; and again he sent out the dove from the ark. And the dove came to him toward evening; and behold, in her beak was a freshly picked olive leaf. So Noah

knew that the water was abated from the earth. (Genesis 8:10-11)

If the ark had come to rest on the *top* of Mount Ararat, this would be at 17,000 foot elevation. Olive trees (and every other tree) do not grow at 17,000 feet. In fact, you will not find olive trees growing much above 5,000 feet. Therefore, we know from the Bible that the ark did not come to rest on or near the top of Mount Ararat, but probably somewhere on the foothills of the mountain.

The method by which the flood ended also tells us that the flood was local. According to Genesis, the water receded and was dried by the wind. If the flood were global, there would be no place for the waters to recede to. Likewise, a wind would not significantly affect a global flood, further suggesting that the Genesis flood was local in extent.

# Planet Earth became a desert after the flood!



Another problem for the global flood interpretation is what happened to the "earth" after the flood. Read the following verses and see if you can see why the word "earth" does not refer to the entire planet:

Then it came about at the end of forty days, that Noah opened the window of the ark which he had made; and he sent out a raven, and it flew here and there until the water was dried up from the earth. (Genesis 8:6-7, NASB)

After forty days Noah opened the window he had made in the ark and sent out a raven, and it kept flying back and forth until the water had dried up from the earth. (Genesis 8:6-7, NIV)

Now it came about in the six hundred and first year, in the first month, on the first of the month, the water was dried up from the earth. (Genesis 8:13a, NASB)

By the first day of the first month of Noah's six hundred and first year, the water had dried up from the earth. (Genesis 8:13a, NIV)

and in the second month, on the twenty-seventh day of the month, the earth was dry. (Genesis 8:14, NASB)

By the twenty-seventh day of the second month the earth was completely dry. (Genesis 8:14, NIV)

If one were to interpret these verses from a global perspective, one would have to conclude that the entire earth became a desert after the flood.

Obviously this interpretation is false, so the translations must be bad. In these verses, the dryness of the earth is obviously referring to the local land area and *not* the entire planet earth.

#### New Testament perspective

What does the New Testament tell us about the flood? As mentioned previously, the New Testament tells us that the flood was universal in its judgment. Besides this, there is an interesting passage from 2 Peter that gives some insight into the nature of the flood:

For when they maintain this, it escapes their notice that by the word of God the heavens existed long ago and the land was formed out of water and by water, through which the world at that time was destroyed, being flooded with water. (2 Peter 3:5-6)

Peter, instead of just telling us that the entire planet was flooded, qualifies the verse by telling us that the "world at that time" was flooded with water. What was different about the world "at that time" compared to the world of today? At the time of the flood, all humans were in the same geographic location (the people of the world were not scattered over the earth until Genesis 11). Therefore, the "world at the time" was confined to the Mesopotamian plain. There would be no reason to qualify the verse if the flood were global in extent.

#### **Early Hebrew interpretation**

Many Christian believe that a local flood interpretation is a recent invention of those who are trying to reconcile science with the Bible. However, the first century Hebrew writer, Josephus wrote about other writers who indicated that the flood was local and that some inhabitants survived by seeking higher ground:

"Now all the writers of barbarian [Greek] histories make mention of this flood and of this ark: among whom is Berosus the Chaldean... Hieronymous the Egyptian.... Nicolaus of Damascus, in his ninety-sixth book, hath a particular relation about them, where he speaks thus: 'There is a great mountain in Armenia, over Minyas, called Baris, upon which it is reported his sons to demonstrate their commitment and that many who fled at the time of the Deluge were saved; and that one who was carried in an ark came on shore upon top of it; and that the remains of the timber were a great while preserved. This might be the man about whom Moses, the legislator of the Jews wrote'."

Josephus does not seek to correct their narrative. So, the idea that the flood was a local event is not just a 20th century phenomenon

#### **Common objections to a local flood** Why didn't God send Noah on a long trip?

If the Genesis flood were local, why didn't God just sent Noah and his family packing. Once they were out of the Mesopotamian flood plain, God could have judged the unrighteous without making Noah go to all the trouble of building a huge ark. It is true that God *could* have done this, although there are some good biblical reasons why He chose not to do so. Why did God make the Israelites march around Jericho for seven days prior to the wall falling down? Why did God make the Israelite look upon the bronze serpent to be healed of snake bite in the wilderness?



Why did Jesus make the blind man go to the Pool of Siloam to heal his blindness? Were any of these things actually required for God to do His work? No! God could have just wiped out all the evil people in the world, as He did later to the all the Egyptians'

first-born. Maybe God had good reasons for Noah to build the ark? God has a purpose for each person of faith to join Him in preaching His message. God's plan will be accomplished regardless of our participation in it. However, God gives obedient humans the privilege of participating in God's plans. Likewise, God had a plan for Noah, part of which was for him and

perseverance to the Lord.

One will notice in the judgments that God renders, He almost always gives a warning to those who are being judged. For example, God sent angels to Sodom before it was to be destroyed, sent Jonah to Nineveh to warn them of the judgment to come, and will send two prophets to warn the people of the earth of the final judgment. The building of the ark was a great testimony of the coming judgment, since it was preached for 100 years during the building of the ark. The New Testament states this idea directly, since it says that Noah was a "preacher of righteousness":

For if God did not spare angels when they sinned, but cast them into hell and committed them to pits of darkness, reserved for judgment; and did not spare the ancient world, but preserved Noah, a preacher of righteousness, with seven others, when He brought a flood upon the world of the ungodly; (2 Peter 2:4-5)

If God had told Noah to just migrate away from the flood area, the people would not have been warned of the impending judgment. Ultimately, they were without excuse in their rebellion against God, since the impending judgment was proclaimed to them for 100 years before it happened. Likewise, God will send two preachers for 1260 days prior to the ultimate judgment of God. Those who get on God's ark (Jesus Christ) will be saved from the judgment and pass from death to eternal life.

#### God promised no more floods like the **Genesis** flood

What about the Genesis 9:11 and 9:15. If the flood was local, did God lie, since floods have destroyed local areas since the Genesis flood.

"And I establish My covenant with you; and all flesh shall never again be cut off by the water of the flood, neither shall there again be a flood to destroy the earth." (Genesis 9:11)

and I will remember My covenant, which is between Me and you and every living creature of all flesh; and never again shall the water 9:15)

The first part of the verse is a promise not to exercise universal judgment by means of a flood, "all flesh shall never again be cut off by the water of the flood." The flood, although local in extent, was global in judgment, since all humanity lived in the same locale. It wasn't until God confused the languages (Genesis 11) that people began to spread over the earth. So, God promised to never again execute universal judgment of humans by means of a flood. The second part, "never again will there be a flood to destroy the earth" can be explained by other verses found in the Genesis flood account.

Gen 6:11 Now the earth was corrupt in the sight of God, and the earth was filled with violence.

Gen 6:12 And God looked on the earth, and behold, it was corrupt; for all flesh had corrupted their way upon the earth.



The passage in this instance refers to the people of the earth, since planet earth itself was not corrupt. Likewise, Genesis 9:11 is referring to the people of the earth rather than the planet itself. Ultimately, even if the flood were global, it did not "destroy the earth," but just the people on the earth. As stated above, "people" is often understood from the Hebrew word *erets*.

#### Why were birds on the ark?

If the Flood was local, why would birds have been sent on board? They could simply have flown to a nearby mountain range. Most birds (other than a few migratory birds) have a very localized territory. They would have been killed

become a flood to destroy all flesh. (Genesis in the local flood, since they are not designed to fly long distances. Certainly archaeopteryx was not a strong flyer. Hummingbirds would drop dead in 20 minutes or less. One thing that you will notice when there is a strong rain is that birds do not fly. Flying in heavy rain is not easy. They would have sat on their perches until the water drowned them

#### Why did God required Noah to take animals if the flood was local?

Some animals are indigenous only to the Mesopotamian area. More importantly, it would have taken hundreds of years longer to replace the fauna if everything had been wiped out and had to migrate back in. In addition, Noah would have had a huge problem replacing his herds.

#### How could the flood waters rise 15 cubits (8 meters) above the mountains in a local flood (Genesis 7:20)?

Didn't the flood cover the highest mountains? The Hebrew word "har," translated "mountains," occurs 649 times in the Old Testament. In 212 instances, the word is translated "hill" or "hills" or "hill country". In Genesis, it is translated "hill" in 10 out of 19 occurrences. Of course, 4 out of 9 times that it is translated as "mountain" is in the flood passage (the translators were wearing their global glasses when they did that translation!). In every instance in Genesis, the text could be translated "hill". Since no specific mountain range is mentioned in this verse, it is likely that the word refers to the hills that Noah could see.


#### Conclusion

This paper has shown that the Bible declares the Genesis flood to be local in extent, though universal in its judgment of humans (with the exception of Noah and his family). The evidence presented here is purely biblical, although a strong case could also be given for extra-biblical reasons. A global interpretation of the Genesis flood requires that certain non-flood-related verses of the Bible contradict each other. In addition, a global interpretation of the Genesis flood would require the Genesis text to English translations misrepresents the original contradict itself. The lack of global references in the book of Genesis through chapter 11 (with the exception of Genesis 1), reveals that all the early events of Genesis occurred in a small geographic area. In addition, an examination of the original Hebrew text of the Genesis flood passage remarkably different flood account than what demonstrates that the global wording of our you have read before.

## **Psychology And Jews Arnold Leese**



**HE** Institute of Medical Psychology and the organization for the Scientific Treatment of Delinquency are both simply bursting with Jews. It is no exaggeration to say that Jewish influence dominates both institutions.

The first named Institute's social functions at which funds are raised are generally presided over by Mrs. Israel Moses Sief and Mrs. H. Sacher, and attended by people called Cohen, Abrahams, Marks, Lebus, Laski, Braham, Walston, Szarvasy, Erleigh, Montefiore, etc., in the proportion of something like fifty percent.


319 cases from all sources were treated in the three years previous to 1937, and over one fifth were sexual cases.

Another thing I read in the article was that onions and garlic placed around the room saved many from the black plague years ago. They have powerful antibacterial, antiseptic properties.

This is the other note. Lots of times when we have stomach problems we don't know what to blame. Maybe it's the onions that are to blame. Onions absorb bacteria is the reason they are so good at preventing us from getting colds and flu and is the very reason we shouldn't eat an onion that has been sitting for a time after it has been cut open.

#### LEFT OVER ONIONS ARE POISONOUS



I had the wonderful privilege of touring Mullins Food Products, Makers of mayonnaise. Questions about food poisoning came up, and I wanted to share what I learned from a chemist.

Ed, who was our tour guide, is a food chemistry whiz. During the tour, someone asked if we really needed to worry about mayonnaise. People are always worried that mayonnaise will spoil. Ed's answer will surprise you. Ed said that all commercially-made mayo is completely safe.

"It doesn't even have to be refrigerated. No harm in refrigerating it, but it's not really necessary." He explained that the pH in mayonnaise is set at a point that bacteria could not survive in that environment. He then talked about the summer picnic, with the bowl of potato salad sitting on the table, and how everyone blames the mayonnaise when someone gets sick.

Ed says that, when food poisoning is reported, the first thing the officials look for is when the 'victim' last ate ONIONS and where those onions came from (in the potato salad?). Ed says it's not the mayonnaise (as long as it's not homemade mayo) that spoils in the outdoors. It's probably the ONIONS, and if not the onions, it's the POTATOES.

He explained onions are a huge magnet for bacteria, especially uncooked onions. You

should never plan to keep a portion of a sliced commercial mayonnaise will even begin to break onion.. He says it's not even safe if you put it in down. a zip-lock bag and put it in your refrigerator.

It's already contaminated enough just by being cut open and out for a bit, that it can be a danger to you (and doubly watch out for those onions you put in your hotdogs at the baseball park!). Ed says if you take the leftover onion and cook it like crazy you'll probably be okay, but if you slice that leftover onion and put on your sandwich, you're asking for trouble. Both the onions and the moist potato in a potato salad, will attract and grow bacteria faster than any

Also, dogs should never eat onions. Their stomachs cannot metabolise onions.

Please remember it is dangerous to cut an onion and try to use it to cook the next day, it becomes highly poisonous for even a single night and creates toxic bacteria which may cause adverse stomach infections because of excess bile secretions and even food poisoning.

would otherwise naturally disappear if left alone. They always treat those abnormalities, and the patients almost always die from those treatments eventually. People nowadays die from the treatments instead of the cancers, and this is shown in the establishment's own statistics. Whenever the human body is exposed to chemotherapy, cancers will strike sooner or later regardless of whether they existed initially. All chemotherapy drugs are carcinogenic, and they weaken all healthy cells. This is admitted in the official literature for adverse effects for all of the so-called anti-cancer medications, and massive cell destruction is officially a part of standard treatments by design. They claim that their medicines attack the weaker cancer cells, but they actually do that by attacking all of the

Keep walking for the cure, but these numbers are not going to rise much. If you happen to see a rise in orthodox cancer treatment success rates, then you can be assured that the methods of measuring cure rates have changed, not the survival rates. It is how the science of modern medicine is cooked. Just barely surviving for 5 years is actually counted as a cure, but virtually everyone who is not counted in this figure dies between the 5 and 10 year mark. It's called "cooking the books" in accounting circles, but we call it murder. Most people are shocked when they learn that those who are killed in cancer drug trials are dismissed from the results, because they did not "complete the study". In other words, getting killed by the medicine helps the drug company's chance in getting drug approval.

"Success of most chemotherapies is appalling... There is no scientific evidence for its ability to extend in any appreciable way the lives of patients suffering from the most common organic cancer... Chemotherapy for malignancies too advanced for surgery, which accounts for 80% of all cancers, is a scientific wasteland." — Dr. Uhlrich Abel

If the cancer industry were really concerned about scientific progress, then nobody would hide the statistics. Truth does not fear investigation. Instead, its numbers are repeatedly covered up, and the scientific community eliminates from its ranks anyone who refuses to accept its zealous dogma. It's not science. It's politics, and a very deadly form of it. The corrupt scientific community has become far more interested in politics, money, power and control than the truth, or even science itself.

Very interesting. I recently read a statement by a pathologist who, for 30 years, had been examining dead bodies for the purpose of establishing cause of death. To my knowledge, none of these doctors was found guilty of accepting their ill-gotten gains. The real question for me is, given all of these facts, why is it that this "medicine" is still allowed to be prescribed at all? ## Pyramids In Germany? Walter Haug



**HE** less informed layman and even the expert may be surprised by this fact, but there are good reasons to believe in German pyramids. The archaeological outcome offers only one conclusion. **They are the biggest monuments of the Megalith-culture on the continent**. Their size even exceeds all the stony step-pyramids of Brittany. There they are called "cairns" - prehistoric grave-houses and step-pyramids built in stone without mortar including one or several burial-chambers like dolmens or vaults of corbel-stone. The most famous example is the "Cairn of Barnenez" in Brittany,France.

#### **Cairns in Europe**

Cairns are common in Great Britain with the same designation. Generally the spreading of this megalithic tombs (mega = big, lith = stone) reaches from northern Africa, the Balearic Islands, over Spain, France, Great Britain, Scandinavia, northern Germany and the northern Switzerland to Poland. Only here in

southern Germany there is a blank in the map of dissemination.

It is said that in Carnac, Brittany is the biggest megalith-monument, conventionally dated in the time about 4000 B. C.: the cairn Mont St. Michel. Now you can find place-names in southern Germany which give a hint or indication of cairns, f. e. <u>Kirnach</u> in the black forest near Villingen-Schwenningen with one of the biggest mounds of the Celts in Germany (diameter 100 m, height 6 m). It is built of earth and has a stony core with a central burial chamber of oak tree baulks.

#### The spreading of the German cairnsstep pyramids

But here in southern Germany also is standing the highest stone-step pyramid of the continent, one of several others which have been discovered in 1990 by Walter Haug. They are wide-spread in the Sternenfels district. south of village named а Kürnbach, half way between Karlsruhe at the river Rhine, in the surroundings of a small town named Bretten. And they are very similar to the Brittanic and British cairns. They are grouped to complete nekropoles, f. e. the stone-mounds of Schmie nearby the famous and best-preserved monastery north of the alps: Maulbronn.



The round tumuli are standing close together as in the "Sommerhälde" of Schmie. Their round basic-wall is carved out of the rock by the metre. On top a tumuli of earth is heaped up. Only one narrow dead-way leads to the single tombs. In Schmie such a narrow lane is delivered in a document of 1540 as "Häldengasse".

#### THE CAIRN-NECROPOLIS OF SCHMIE/MAULBRONN



This extraordinary "medieval quarry" is called "Sommerhälde" or "Steingrub" (stone grave), located 2 km south of Maulbronn. It is supposed to have been the provider of the boulders for the cistercian monastery of Maulbronn, built in 1147.



The "Hälden" of Schmie, 2 km south of Maulbronn (pic. 3), are comparable to similar burial-places of the Etruscans, f. e. the tombanecropolis of <u>Cerveteri</u> north of Rome The phenomena of this newly discovered German tumuli of stone is the odd fact, that they are erected without exception in very large and deep quarries, but Cerveteri, too, is broken out of the tuff-rock and covers a very large area.



**Cerveteri** is a town of the northern Lazio, in the province of Rome. Originally known as Caere (also **Caisra** and **Cisra** in Etruscan, **Agylla**,  $Ayv\lambda\lambda\alpha$  in Greek), it is famous for a number of Etruscan necropolises.

# **Surprising Discovery Following An Excavation In Alsace**, France **From Our Netherlands Correspondent**

discovery during an excavation in Alsace, France, when they uncovered a substantially elongated skull dating back 1,500 years.




**HE** finding prompted the archaeologists to extend their search over 7.5 acres, which resulted in the discovery of an abundance of artefacts, human and animal remains from Neolithic, Gallic, Gallo-Roman, and Merovingian societies.

The skull appears to have been intentionally elongated through the practice known as cranial deformation, which is usually associated with ancient Mesoamerican cultures and was practiced extensively in Europe, Africa, Asia, and as noted, South America.

Cranial deformation is achieved by distorting the normal growth of a child's skull by applying force through binding the head between pieces of wood or binding it in cloth. It is typically carried out on an infant, as the skull is most pliable at this time. The skull was discovered during excavation of a necropolis containing 18 burials. It was discovered in a tomb belonging

French archaeologists made a surprising to a woman who clearly held a high status position in society as she was buried with a rich assortment of treasures including gold pins, a silver mirror, beads of glass and amber, a comb made from deer antler and a number of other goods. Cranial deformation was frequently associated with the elites of society and affirmed their high status.

> The important question of course is why? A number of alternative theorists have proposed that the practice was done to mimic a race of people who were born with elongated skulls and who were obviously held in high esteem. Brien Foerster has written extensively on the subject and has presented compelling evidence relating to skulls that were significantly elongated through genetics and not through cranial deformation. 


