A History Of British Passports By **Sandie Seward**

THE British passport has had a long and proud history and a good many revamps but there has been one constant. For 600 years it has been inextricably linked to our monarch.

Introduced in 1414, and mentioned by Henry V in his speech on the eve of Agincourt (according to Shakespeare), a passport or 'Safe Conduct' started out as just a note issued to someone document folded into eight, with a cardboard travelling on the king's business.

Written in Latin or English and personally Again the design was short-lived. A League of signed by the monarch, it asked that the holder be allowed to travel freely, and specified the destination, time and purpose of his journey.

There were, of course, earlier passports. The first known reference is found in the Bible's Book of Nehemiah, when an official serving a Persian king asks to travel to Judah. The king agrees and gives him a letter demanding he is granted safe passage.

The oldest surviving British passport – signed With Acknowledgement to: by King Charles I - was issued on June 18, 1641. The latest record of a monarch signing was in 1778, by George III for Sir John Stepney who from 1775 to 1782 was on a diplomatic mission to Dresden.

Like all British passports issued between 1772 and 1858, it was written in French - the official language of diplomacy. From 1794 the system changed so that passports were granted by the Secretary of State and centrally registered.

The First World War was the catalyst for a shake-up. Nation states issued passports to distinguish their own citizens from foreign nationals. At the outbreak of war, they were printed on paper, with a glued on photo of the holder and cost 6d but they changed again when the British Nationality and Status of Aliens Act 1914 came into force in 1915.

This determined in law that all persons born in the United Kingdom and Crown's dominions would hold the status of British subject and was the first modern British passport - a one-page

cover and a detailed personal description.

Nations conference in 1920 agreed to a bookformat passport for member states, each to be issued in two languages - their own and French. Thus 'Old Blue', the passport sporting the Royal Coat of Arms, traditional wording and issued at the discretion of the government under the Royal Prerogative, was born. Microwave Cooking Is Killing You! By Stephanie Relfe B.Sc. (Sydney)

icrowave cooking is one of the most important causes of ill health. It is certainly one of the most ignored.

There was a lawsuit in 1991 in Oklahoma. A woman named Norma Levitt had hip surgery, but was **killed by a simple blood transfusion** when a nurse "warmed the blood for the transfusion in a microwave oven!"

Logic suggests that if heating is all there is to microwave cooking, then it doesn't matter how something is heated. Blood for transfusions is routinely warmed, but not in microwave ovens. Does it not therefore follow that micro-waving cooking does something quite different?

A little evidence of the harm caused by microwaving cooking was given by the University of Minnesota in a radio announcement:

"Microwaves ... are not recommended for heating a baby's bottle. The bottle may seem cool to the touch, but the liquid inside may become extremely hot and could burn the baby's mouth and throat... Heating the bottle in a microwave can cause slight changes in the milk. In infant formulas, there may be a loss of some vitamins. In expressed breast milk, some protective properties may be destroyed.... Warming a bottle by holding it under tap water or by setting it in a bowl of warm water, then testing it on your

wrist before feeding, may take a few minutes longer, but it is much safer".

There have been very few scientific studies done on the effect of eating micro-waved food. This is rather surprising when you think about the fact that microwaves have been with us for only a few decades - and that in that time the incidence of many diseases has continued to increase.

Two researchers, Blanc and Hertel, confirmed that microwave cooking *significantly* changes food nutrients. Hertel previously worked as a food scientist for several years with one of the major Swiss food companies. He was fired from his job for questioning procedures in processing food because they denatured it. He got together with Blanc of the Swiss Federal Institute of Biochemistry and the University Institute for Biochemistry.

They studied the effect that micro-waved food had on eight individuals, by taking blood samples immediately after eating. They found that **after eating micro-waved food, haemoglobin levels decreased.** "These results show anaemic tendencies. The situation became even more pronounced during the second month of the study".

Who knows what results they would have found if they had studied people who ate micro-waved food for a year or more?

The violent change that micro-waving causes to the food molecules forms new life forms called radiolytic compounds. These are mutations that are unknown in the natural world. Ordinary cooking also causes the formation of some radiolytic compounds (which is no doubt one reason why it is better to eat plenty of *raw* food), but micro-waving cooking causes a much greater number. This then causes deterioration in your blood and immune system.

In addition, they found that the number of leucocytes increases after eating micro-waved food something which haematologists take very seriously, because this is often a sign of highly harmful effects, such as poisoning.

Also, after eating micro-waved food, cholesterol levels increased. Hertel said "Common scientific belief states that cholesterol values usually alter slowly over longer periods of time. In this study, the markers increased rapidly after er William Kopp, who gathered much of the the consumption of the micro-waved vegeta- results of Russian and German research - and bles." He believes his study tends to confirm new scientific data that suggest cholesterol may rapidly increase in the blood secondary to acute stress. "Also," he added, "blood cholesterol levels are less influenced by cholesterol content of food than by stress factors. Such stress-causing factors can apparently consist of foods which contain virtually no cholesterol - the microwaved vegetables."

Hertel and Blanc were told that if they published their findings they would face hefty fines or up to one year in prison. In response to this, Blanc recanted his findings. Hertel, on the other hand, went on a lecture tour and demand- ods; ed a jury trial.

FINALLY, in 1998 the Court 'Gag Order' was removed. In a judgment delivered at Strasbourg on 25 August 1998 in the case of Hertel v. Switzerland, the European Court of Human Rights held that there had been a violation of Hertel's rights in the 1993 decision. The Court decided that the 'gag order' prohibiting him from declaring that micro-waved food is dangerous to health was contrary to the right to freedom of expression. In addition, Switzerland was sentenced to pay compensation of F40,000.

In Summary: Blanc and Hertel found that eating micro-waved food:

- Increases cholesterol •

Standing in front of a microwave is also highly damaging to your health. Perhaps you have already felt this intuitively? We know that cells explode in the microwave - just fry an egg in your microwave. We are made up of trillions of cells. So work out how many are getting damaged if you stand in front of your microwave for 5-10 minutes.

In the past I had been told that it was important for people to stop eating micro-waved food, but I did not pay too much attention to this because I had been microwave cooking for years. I never thought much about it but I suppose that I figured that if something was so bad for us, then there wouldn't be so many people using it. Little did I know.

When I first began seeing clients for sessions of kinesiology, I did not worry too much about telling them to give up eating micro-waved food. However, I kept a record of all of the corrections that were needed for each client when they came in. Now, once a correction is made, it is to be hoped that the correction will stay in place for a long time to come, hopefully months if not years. People often ask me "How long will it last?" My answer to them is "That depends on your lifestyle".

Most of my clients came back to see me after about two weeks. In the early days I found that many who came back were not much better. I found that they were again `out of balance'. That is, their electrical circuits were not working correctly (which is common for many people). It was therefore not surprising that they were not much better, because the body does not begin to

The question was, why did their electrical circuits go out of balance? The answer had to be something that was *highly* stressful, to affect the body in such a short space of time. Once that answer was remedied, the client would begin to get better. Using muscle testing, I went through the process of testing if the cause was electrical, chemical/nutritional, emotional or structural. Again and again the same answer would come up - electrical. When I then went through a range of possible electrical causes, the same answer again came up again and again - the person had eaten micro-waved food! Incidentally, this answer never came up food.

I began to tell all of my clients on the first visit that under NO circumstances were they ever to do micro-waved cooking again. I gave this a higher priority than any of things that are normally considered as health risks, such as cigarettes or alcohol. Immediately I began to get a marked improvement in the results I was getting. Long-term problems such as headaches, backaches and emotional instability went away within a few weeks.

Other kinesiologists can confirm these results. David Bridgman, who has years of experience as a kinesiologist, said "Of all the people I test for allergies, 99.9% so far show severe sensi-



tivity to any micro-waved food".

I experienced the effect of eating micro-waved food for myself one time. I had been doing quite a lot

of kinesiology and feeling on top of the world when for no apparent reason I began to feel rather 'gray' and rather low. I realised that I needed a balance from a kinesiologist. Sure enough, I was out of balance. When the kinesiologist used muscle testing to see why my body had gone out of balance, the answer came up ... Micro-waved food! The trouble was, I couldn't remember eating any. Until I remembered a particular vegetarian restaurant I had been to. When I went back to the restaurant and asked them if they micro-waved their food, they told me that they did.

Xenoestrogens are linked to low sperm counts in men and to breast cancer in women. Throughout her junior and senior years, Claire made a couple of trips each week to the research centre, which was 25 miles from her home, to work on her experiment. An article in Options reported "her analysis found that DEHA was migrating into the oil at between 200 parts and 500 parts per million. The FDA standard is 0.05 parts per billion."

Her summarized results have been published in science journals. Claire Nelson received the American Chemical Society's top science prize for students during her junior year and fourth place at the International Science and Engineer-Limits" Options, May 2000. You can heat food quickly in a convection oven. It's just an ordinary oven with a fan.

You can also easily and quickly heat up food, even frozen pasta, by using a saucepan with a lid and a little water, to moisten it from the steam.

If someone is coming home late, and you want to give them warm food when they arrive, put a saucepan lid over the food while it is on a plate. Put the plate of food on a simmering saucepan of water. It will stay warm without drying up.

Most of my fundamentalist friends, who say that they believe the Bible "from cover to cover including the cover," are still content to ignore these alleged contradictions and urge their minister to preach to the hundreds in his congregation on the theme, "Christ died for YOU." While he may think that he is "winning souls," the fact of the matter is that this may not be a truthful statement at all. Who are the chosen kindred, off-spring and stock that make up the holy nation to be reconciled to God? For whom was Christ The Substitute? Did He go to the Cross for the betrayers Esau or Judas the Canaanite? Deeper still, did Christ accomplish His Objective or did He fall far short, since obviously the vast majority of mankind never has been saved.

Without apology, I must insist that Christ accomplished exactly, and completely, what He intended! Most ministers today insult the Gospel of Christ by teaching that there is a distinction and a difference between what Christ did in dying for all mankind, and what he accomplished with such a tiny minority actually being saved through His Sacrifice. They are preaching, and I do not know how to state it more delicately, that percentage wise, Christ's Death was an abysmal failure! He never got what He wanted accomplished: Brother and Sister, that is pure nonsense!

I shudder when I happen to hear this preaching over the radio or on television which teaches, in effect, that Christ not only willingly shed His Blood, but He inadvertently spilled most of it. They preach that he intended to save all mankind, but 99% were never saved by Him. So, our inept Saviour shed 1% of His Blood for the saved, and spilled 99% of it for the unsaved. Rather, each writer witnessed, or recorded from witnesses, all or parts of an event seen from a certain perspective, writing down those por

The Canaanite woman is identified as a "Greek, a Syro-Phoenician by nation" in Mark's gospel, in the A.V. Translation. The word rendered "nation" is genos (Strong's #1085), and is more properly rendered "race". (The 9th edition of the Liddell & Scott Greek-English Lexicon defines genos primarily as "race, stock, kin" and then "generally, race, of beings". Secondly, W.E. Vine in his An Expository of New Testament Words, [although not entirely perfect] on the word "kind" [genos] agrees generally with Liddell & Scott.) Mark was doing the best he could to describe this woman with the terms used by the Greeks of his time. He would have identified the woman as a Greek, Roman, Aramaean, or Judaean by race, if such had been the case, hence Mark's distinction.

The word "Greek" is actually Hellene, and its use here by Mark is understood in its historical context. Hellene was never used to define any specific tribe, nation, or kingdom. Rather, the term came to be used among the tribes of the region and islands about the Aegean who came to use a similar language and customs, namely the Ionians, Danaans, Pelasgians and Dorians. Later there were sub-divisions of these, such as Boeotians, Macedonians, Argives, etc. Those of other tribes, such as the Phoenician colonists of Caria (Miletus) and Thessaly, adopting the language, were also later subsumed into the Hellenic culture, becoming known as "Greeks". Those peoples of other tongues outside of the culture, whether or not they were just as civilized, were labeled "Barbarians". It must be remembered, however, that at this early time all of these peoples were of White Adamic stock. Even later, with the rise of the Hellenistic period – after as happens in any empire, and such as the term " American" is so loosely used today.

disciples, evidently having failed to discourage the woman, became annoyed with her, and asked Yahshua to send her away, yet they were not admonished for such behaviour. Now this is hardly any way to treat a prospective "Christian", one may think, and a situation only understood once one realizes that such a prospect simply did not exist. This must be compared to the reception which certain others, being Israelites, had received, such as those found at John 1:47, Luke 13:16 and 19:9. And it is not merely because the Canaanite woman was not a Judean Israelite that she received such treatment. Contrast the reception which she received to that of the Roman centurion as described at Matthew 8:5-7. While the same event is described somewhat differently at Luke 7:1-10, nevertheless the effect is the same. The Romans were, in fact, "lost" Israelites, having descended from a portion of Judah which emigrated to Europe at a very early time. Paul knew this, and it is evident throughout the epistle addressed to them.

At Matthew 15:24 Yahshua Christ repeats His very commission in response to the Canaanite woman's plea. This commission is repeated throughout the New Testament, i.e. Matt. 1:21, 2:6: 10:6: 18:11; Mark 12:29; Luke 1:16, 54, 67-80; 2:25-34; 19:10; 24:21; John 1:31, 49: 12:13; Acts 1:6; 28:20 et al. Now it is clear both in the Old Testament prophets and throughout the New Testament, that Christ came only for the "lost sheep of the house of Israel ", those ancient Old Testament Israelites who from the days of the Judges unto the Assyrian and Babylonian deportations had been emigrating into Europe, and who eventually formed the Christian Nations of the Medieval period: the White races of today. Yet, as Paul explains to the Ephesians, "lost" Israel having been alienated from Yahshua until His redemptive sacrifice on the cross, His earthly ministry remained among the Judean Israelites, those who retained their relationship with Him through the Old Covenant.

So while Yahshua informs the Canaanite woman that He was sent only for the "sheep", the children of Israel (cf. Ezekiel chapter 34), He then informs her that it is not proper to take the bread of the children (which is His favour) and throw it to the dogs, which is effectively calling the Canaanite woman a dog. While the term "dog" is often used derisively of people in Scripture, one example where it stands out is where it is used in the 22nd Psalm, a Compassion for one's enemies is a noble trait, and a messianic prophecy foreseeing the crucifixion of Christ: "For dogs have compassed me: the assem- righteous nation should have. my hands and my feet ... Deliver my soul from the sword; my darling from the power of the dog." (Psa. 22: 16, 20). Knowing that it is the Canaanite/Edomite leaders of Judea who were primarily responsible for the crucifixion, those who claim to be Judeans, but are not (Rev. 2:9; 3:9), the dog-people are brought to light in this statement by Yahshua to the Canaanite woman. Paul later warns about the **dog-people** (Ph'p. 3:2), as Yahshua also had previously (Matt. 7:6). The woman was certainly not a dog merely because she was sinful, for Christ often professed that He had come for sinners (i.e. Matt. 9:9-13). Surely she WAS a Canaanite, bearing the curses of both Canaan (son of Ham)



and Cain!

When in ancient times the children of Israel had left Egypt, and were presented with the land of Canaan, they were warned that if they did not drive out or destroy all of the Canaanites, then the Canaanites would

become a source of great trouble to them (i.e. Num. 33:55; Josh. 23:13). Of course, the children of Israel did fail to drive out all of the Canaanites (i.e. Jdgs. 3:1-6). All of this must have been foreseen by Yahweh, of course, yet – as Paul explains in 2 Thess. chapter 2 (and see Rom. 16:25-27), the mystery of iniquity had not been fully revealed in the Old Testament scriptures - many of which are also parables difficult to understand - yet it is revealed in the Gospel. On which account we are provided with such parables as that of the wheat and the tares, and the warning that both must grow together until the time of the end, which is the harvest (Matt. 13:24-30, 36-43). When the children of Israel failed to destroy the Canaanites from among them, they lost their commission to do so, and were therefore left to suffer from them. Neither was it the purpose of Christ in His earthly ministry to destroy them; for there are many other Old Testament prophecies concerning the ultimate destruction of all of the enemies of Yahweh at the end of this age (i.e. Obad. 8-9, 18; Mal. 1:1-5; Zech. 14:21; Matt. 13:30, 41-42; 25:31-46; Rev. 20:13-15).

The ancient histories are replete with examples of such incidents, and this account of the Canaanite woman's actions falls into the same pattern. When the Canaanite woman admitted to Yahshua Christ that she was indeed a dog, while professing that He could indeed heal her daughter, she both recognized Him as having been sent by Yahweh God, and surrendered to the truth of the Word. Having such a surrendered enemy making supplication before Him, while at the same time admitting the truth of the Word, Yahshua had no choice but to show mercy to her, since by His own Word the destruction of His enemies was still afar off, and since she volunteered such submission in supplication as her statement demonstrates: "... yet the dogs eat of the crumbs which fall from their masters' table." By this act of mercy, Yahshua also fulfilled the truth of the Scripture, i.e. Proverbs 16:7: "When a man's ways please Yahweh, He maketh even his enemies to be at peace with him." Yahshua had no choice but to grant this act of mercy to the Canaanite woman, as an example of His own teaching!

Here it must be noted, that Yahshua Christ had healed the daughter of the Canaanite woman in body ,, only. For she requested "that He would cast forth the devil out of her daughter" (Mk. 7:26), and He granted her request: "the devil is gone out of thy daughter" (7:29) she having received nothing more than what she had desired (cf. Matt. 15:28, "be it unto thee even as thou wilt"). When a veterinarian heals a dog, it is restored into a whole dog, not into a sheep! The woman's daughter was likewise healed bodily, but she was still a Canaanite. She is not an Adamite, having the Adamic Spirit! For one to be granted eternal life, one must first have that Spirit which Adam had (cf. Gen. 2:7; 3:22; 1 Cor. 15:35-38). The Spirit which Adam had is handed down, like his image, as part of the genetic code, as Paul explains in 1 Cor. 15:44: "It is sown a natural body; it is raised a spiritual body". Producing offspring of mixed races, one is hewing out "broken cisterns, that can hold no

She wasn't even told to "repent" or to "sin no more", she was still a dog - as was her daughter and they could not possibly be made into "sheep Neither she nor her daughter were granted eternal life, and she could not have been expected to somehow have become a Christian. What the woman did receive was a crumb: it cost Yahshua nothing to grant the woman's request. It was more expedient to grant the woman her wish, tossing the dog a bone as a reward for her supplication and honesty - for the woman certainly realized that she was not one of the children. Imagining that Yahshua Christ intended to bring an alien into the New Covenant, which He made exclusively with the house of Israel and the house of Judah (not "spiritual" Israel nor "spiritual" Judah; cf. Jer 31:31 ff.) is to imagine that He would commit an act of fraud. Paul knew as much, and so at Gal. 3:15 he explained that even a covenant between mere men, once confirmed, no one could change or add to. 

Translating James 1:23 By William Finck

The King James Version: For if any be a hearer of the word, and not a doer, he is like unto a man beholding his natural face in a glass...

have recently had a quite succinct

email message from a reader who stated "At 23: verse change race to face". It is true that errors in typing where one word is substituted for another similar and properly spelled word.

and therefore not detected by a software spelling checker, are very common. And while I do imagine that people will find errors in my translations - for no man is perfect - this however, is not one of them. Still, I would encourage those who feel that they have found such errors to notify me, and I shall be more than happy to reply, and to make any necessary corrections. Here my translation of the phrase in question is purposely "the appearance of his race", and I shall explain why.

The Greek to this passage when translated into English characters and words reads, to [the] prosopon [appearance] tes geneseos [of the race] autou [of him]. The words to prosopon are a noun with the definitive Article and are in the Accusative case and therefore are the object of the verb translated 'observing'. The words tes geneseos autou/ are respectively a noun with the definite Article and a pronoun, and are both in the Genitive case.

The word prosopon is defined by Liddell & Scott: '... the face, visage, countenance ... one's look ... outward appearance, beauty ...' The word geneseos is the genitive form of genesis [from which we have the English word *genesis*] and is defined '... an origin, source, productive cause, ... a beginning ...manner of birth ... race, descent ...' In the context here, speaking of the sight of a person in a mirror, I have translated the word race, and would assert that descent, origin or source would bear the same meaning in this case and would only be masking the intent of the statement if employed in the place of race.

All of this is supported by a comment found at the word face here in the Bible Works program in the edition of the New American Standard Bible, where it is stated: "Lit., the face of his birth; or, nature", yet I would assert that neither do they understand the literal and true meaning of the phrase. Phrases such as "the face of his birth" or "the appearance of his birth" make no sense. I have translated them "the appearance of his race" because I believe that such is exactly what James meant: that although we may be children of Adam and of

Israel, born in the image and likeness of Yahweh our God, this is not enough by itself: for unless we are also doers of His Word then we As we go to press it is being reported that large are certainly not doing well, and not performing to the intent of our Creator.
