# The Origin of Talmudism (Part 2) By Pastor Eli James



The Book of Esther leaves off at approximately 450 to 430 B.C.

N ORDER TO TELL
THE STORY of the
Judahites from this

point to the time of Christ, we must turn again to secular history (Josephus, Pliny, and Philo, the Alexandrian Judahite) and the Apocrypha as well as other Judahite literature such as the Pseudepigrapha and the Dead Sea Scrolls.

The Pseudepigrapha are distinguished from the Apocrypha by the fact that neither Protestants nor Catholics consider them canonical although they are nevertheless Israelite literature. The Apocrypha are considered canonical by Catholics.

From the above discussion and examination of relevant historical documents, I can say that I am not aware of any historical evidence which even remotely suggests that any form of sectarianism, either from outside the Levitical priesthood or within the Levitical priesthood, took place in the land of Judah until the time of King John Hyrcanus, around 150 B.C. No exact date can be given for the creation of the sect of the Pharisees, but most scholars place their origin around this time.

The history of the House of Judah from 430 B.C. down to the time of Christ is divided into four periods:

The Persian Period, 430 to 332.

The Greek Period, 331 to 167.

The Maccabean Period, 166 to 63.

The Roman Period, 63 to Christ and after.

Continuing now with Josephus: Chapter 8 relates how the Syrians were defeated by

Alexander the Great and how the Judahites concluded an alliance with him. Relevant to our documentation of the genealogical history of these Judahites is a statement concerning the Samaritans, a group of Syrians who lived just north of Judea:

"----the Samaritans—seeing that Alexander had greatly honoured the Jews [sic], determined to profess themselves Jews; for such is the disposition of the Samaritans, as we have already elsewhere declared, that when the Jews [Judahites] are in adversity they deny that they are of kin to them, and then they confess the truth; but when they perceive that some good fortune hath befallen them they immediately pretend to have communion with them, saying, that they belong to them, and derive their genealogy from the posterity of Joseph, Ephraim, and Manasseh."

Note that Josephus is declaring that the Samaritans were prone to impersonating Judah when it was politically expedient to do so. This type of Jewish duplicity is evident to us today as well, for in America they fervently praise the "separation of church and state" while in Israel, they are Jewish despots practicing a Jewish theocracy.

Here in the story of the Samaritans we get another clue as to how the impostor group is coming into being. Again, the use of the word 'Jew' for both 'Judahite' and 'Judean' by the translator is a good example of not keeping distinctions clear.

The English word 'Jew' did not come into existence until a much later time in history (1600's) when the confusion of the terms 'Judean' and 'Judahite' by various historians had become commonplace.

The German word 'Jude' is subject to the same problems. The Samaritans, as pretend Judahites, were simply perceived by outsiders to be Judeans. These outsiders did not make any distinctions between Edomites, Judahites and

their mixed offspring. Nor did they understand the differences between the Mosaic Law and Pharisaic "law." Josephus is telling us that the Samaritans claimed to be Judahites when and if there was political gain to be made therefrom. Many of these same Samaritans eventually were absorbed into Jewry, although their origin is most likely that of half-breed Israelites of the tribe of Joseph.

Even at this point in time, the Judahites referred to themselves as "Judah", not as Judeans. A good modern parallel is the word 'German' which is used exclusively by outsiders to refer to the German people, who refer to themselves as 'Deutsch,' a word derived from 'Teuton.' The Greek word 'Ioudaios', meaning Judean, is incorrectly translated as meaning Jew, for the word 'Jew' implies a different meaning than would either 'Judean' or 'Judahite.'

W. G. Finlay, late editor of the periodical, *the Covenant Message*, has this to say regarding this great impersonation: "According to Josephus Antiquities of the Jews the name 'Jew' first came into existence with what is generally called 'the return from the Babylonian captivity [actually, Josephus doesn't say that; his translators do!]—


I find it very significant that prior to this time, the word 'Jew' was unknown. Why, in the Masoretic text which is a Jewish work is there no reference to 'Abraham the Jew' or 'Moses the Jew'? This surely tells us something but so few are prepared to open their eyes and see the depth of the masquerade which is having such a disastrous effect on the TRUE Israel people."

W. N. Saxon, in his booklet, "The Mask of Edom", says, "Judaism's masquerade as Biblical Judah and, moreover, as all Israel which is the basis of Jewish Nationalism becomes patently counterfeit when placed in juxtaposition with the historical record of the true Houses of Israel and Judah.

Even a brief summary will show the contrast between the descendants of Biblical Jacob-Israel as opposed to the alien posterity of the cabal which claims for itself not only the Promised Land but the very name and inheritance of Israel ." p. 8.

Envy by the Canaanites over the Israelites and their heritage is recorded in the Book of Psalms:

"For, lo, thine enemies make a tumult: and they that hate thee have lifted up the head. They have taken crafty counsel against thy people, and consulted against thy hidden ones. They have said, Come, and let us cut them off from being a nation; that the name of Israel may be no more in remembrance.

For they have consulted together with one consent: they are confederate against thee. "83:5. The "hidden ones" are the lost tribes and those who have forgotten their true heritage. This envy is nothing more than the lust Esau has for recovering the inheritance which he so foolishly and steadfastly rejected. The Edomites are confederate against true Israel because Esau, who is still in rebellion against God's Law, is the forefather and the animating spirit behind Edom and Judaism.

In addition to Josephus, I and II Maccabees tell us of the struggles of the Judahite leadership to liberate themselves from Greek domination.

They should be read in conjunction with Josephus in order to get a full appreciation of the difficulties, in terms of internal squabbling, Canaanite intrigues and external military threats that the Judahites faced. (The reader should understand that what is being retold here is a mere sketch of this period of history, and only the most salient points are being discussed. Reading Josephus and Maccabees is highly encouraged.)

Upon the death of Alexander the Great, the fortunes of Judah changed for the worse. Alexander's empire was divided among his generals, and two of them, in turn, fought over

ongoing warfare.

Due to the pressures and intrigues of war, it was at this time that infighting among the Judahites for the High Priesthood, and much intrigue resulted with one faction allying themselves with Antiochus while the other faction allied themselves with Ptolemy of Egypt. It was shortly after that the sects known as the Sadducees, Pharisees, and Essenes arose; and the story of the House of Judah cannot be appreciated without understanding the power struggle that was going on among them.

Very briefly, the Sadducees can be said to be pro-Greek. The Sadducees usually consisted of the Judahite upper class and the reigning High Priest. These were influential people holding positions of political power.

More than likely, they favoured the cosmopolitan life style of the Greeks, with its games and spectacles and sophistication, to the rigid doctrines of the Mosaic Law a striking parallel to our "modern" Christian "leadership," which has become very secular!

The Pharisees, on the other hand, as the favourites of the Herodian kings, held authority, if not respect, over the common people of Judah; and it seems that their power was not to be denied. (The modern parallel here is Christian Zionism! Compare the power of the Jewish Neo-Cons in today's Bush administration.

The Bush family might as well be the reincarnation of Herodian dynasty!) Several Judahite leaders, such as John Hyrcanus and Alexander Janneus, had their lives made difficult

Judea. In response to the invasion of Antiochus by opposing the Pharisees. The Essenes seemed the Great, the Maccabeans revolted and gained to be a more monastic group which included a independence from the Greeks at the cost of branch of Cenobites who took vows of celibacy. All of the available evidence suggests that it was the Essenes who took most seriously their Israelite heritage and obeyed the racial law against intermarriage. (Christian Identity today, thank you!)

> The Essenes, therefore, diametrically opposed the Pharisees, seeing them as hypocrites and usurpers.

> Judas Maccabeus (a Judahite, not a Jew!) arose as a great spiritual and military leader and successfully fought off Antiochus and even subdued the Idumeans and Ammonites to the south. Judas was so successful that he nearly regained all the territory which belonged to the Twelve Tribes before the captivity!

> After the Maccabees successfully evicted the Greeks, the Samaritans, seeing the difficulties of the Judahites somewhat abated, for the time being, renewed their claim of kinship to Judah.

> While the nation of Judah was fiercely defending itself against Greece, the Idumeans were already forming an alliance with Rome, plotting their move against Judah when the inevitable defeat of Greece came at the hands of the Romans. Judah, being fully occupied defending herself against Greece, and not given to making deceptive deals behind the scenes, was not prepared for the Roman juggernaut.

> With the Roman occupation, behind-the-scenes intrigue by both Judahite and non-Judahite candidates increased, and the priesthood fell more and more into corruption. Josephus relates that "Alcimus, who was not of the high priest stock," became High Priest.

> The continuous warfare was taking its toll on Judah's spiritual life. The situation grew worse and worse until, finally, Antipater, an Idumean, gained influence with John Hyrcanus, a Maccabean. Antipater talked Hyrcanus into conquering Idumea and making Judea and Idumea one kingdom, thus tending to mingle the populations.

> It was at this point that the Idumeans became Judeans, for a purely Judahite priesthood would never have accepted Idumeans as fellow citizens.

scribes and Pharisees had already allowed them to accept non-Israelite members, otherwise, Alcimus would never have become high priest. Consequently, Hyrcanus permitted them to stay in the combined new country if they submitted to circumcision and subjected themselves to the religious rules and regulations of the high priests.

This was, of course, a disastrous development in Judahites terms of distinguishing Canaanites.

In a footnote to Josephus, translator Whiston says " This account of the Idumeans admitting circumcision, and the entire Jewish [Pharisaic] law, from this time, or from the days of Hyrcanus, is confirmed by their entire history afterwards—Ammonius, a grammarian, says: The Jews [Judahites] are such by nature, and from the beginning, whilst Idumeans were not Jews [Judahites] from the beginning, but Phoenicians and Syrians; but being afterwards subdued by the Jews [sic] and compelled to be circumcised, and to unite into one nation, and be subject to the same laws, they were called Jews [Judeans -- EJ].'

Dio also says: 'That country is also called Judea, and the people Jews [sic]; and this name is given also to as many as embrace their religion, though of other nations.' " Antiquities, Chap. 9.

The racial confusion bred linguistic confusion, and the rabbis have exploited this linguistic confusion in their historical pretence as Israel and Judah. The above quotes demonstrate why we should always distinguish between Jews and Judahites.

The Jews have done everything possible to influence Christian and secular historians into equating Jews with Judahites; but as can be plainly seen, the history of Jewry and Judaism begins with this edict of John Hyrcanus.

Thus, properly understood, this is an excellent commentary and verification of our main argument: that a non-Israelite people called Jews adopted, by virtue of their half-breed relationship to Israel, some Israelite customs and kept the name for themselves! Also clearly expressed here is how the distinction between Judahites (Israelites) and Judeans became blurred, eventually to be forgotten, with the word 'Jew'

By this time, the Babylonian influence on the substituting for both! Indeed, had these developments not taken place, the prophecy concerning Israel's lost identity would never have been fulfilled. (See Psalm 83:3; Isa. 29:10-12; 42:16,19-20; 49:2; Hos. 1:9,10; 2:6; Matt. 13:44; Romans 11:7,8,25.)

> While the modern Jews, the inheritors of the "Traditions of the Elders", have claimed continuity with Israel from that day forward, true Israel, the Anglo-Saxons plus the remnant of Judah, eventually forgot who they were and lost their identity!

> It is one of the most important marks of Israel that God foretells true Israel's forgetfulness. The Anglo-Saxons have indeed forgotten their true heritage. In contradistinction, the Jews have always claimed to be the Chosen People! So, who is True Israel, those who fulfil the prophecy or those do not?



John Hyrcanus (above) was succeeded by Aristobulus I and then by Alexander Janneus, who was a most cruel and corrupt monarch. He made a habit of killing many of his own people and is reported to have crucified eight hundred Judahites at one time and slit the throats of their wives and children while they watched from their crosses kind of like George W. Bush sending True Israelites out to Iraq to be slaughtered by the Zionist war machine!

Alexander was succeeded by his wife, Alexandra, who made a league with the Pharisees. She did this because Alexander, on his death bed told her that all his troubles were due to having opposed the Pharisees and joining ranks with the Sadducees. He thus advised her to cease hostilities with the Pharisees if she did not wish to fall into the same tragedy.

Alexandra was succeeded by her son, Hyrcanus III. But, Hyrcanus III and his brother, Aristobulus II, fought with each other over the throne, Aristobulus II realizing that the nation was being taken over by non-Israelites. But then the Romans entered the scene and concluded a pact with Hyrcanus III and Antipater, the Idumean, thus defeating Aristobulus II.

Upon Hyrcanus III's death, his sons, in turn, struggled to regain the leadership, but Antipater murdered two of them and finally installed his own son, Herod, as monarch of Judea. Judah was at its ebb. Around 60 B.C., Herod the Great, a half-breed Idumean Jew (and now the word is correctly applied), became petrarch of Judea, a collector of tribute money for the Romans.

Thus ended the valiant struggle of the Judahites to remain a distinct people and culture under their own rule. It is important for us to realize that the struggle to maintain the genealogical purity of Israel continued even down to the time of Christ. In spite of all the corruption and seed-mixing at the upper echelons, there were still numerous pockets of pure-bred Israelites in and around Judea, especially of the tribe of Benjamin in Galilee.

One of these settlements, known as Nazareth, was to be the home of Jesus, the Messiah. In fact, the Galilean Benjamites rarely entered Jerusalem; and, remember, Peter was found out because he had a Galilean accent!

Absolutely crucial to our understanding of this into Greek history is this most salient fact: After the return from captivity, the remnant of the House of Judah had to perform its function of bringing the Messiah into the world. Christ could not have been born except through pure-bred Judahite stock! That is why Matthew, Chapter 1 and Luke Chapter 3 so meticulously record Yahshua's Onias III (genealogy.

(The Ptolemies are the Greek kings of Egypt who reigned after Alexander the Great. Around 260 B.C., they produced what is now called the Septuagint, a translation into Greek of the Torah, the five books of Moses, plus other books).

With the advent of the Herodians and the Pharisees, the time is now ripe for the coming of the Messiah: Mosaism (Hebrewism) in Judea is being replaced by the "traditions of men," the Pharisees. Judaism (Pharisaism), thanks to Herod and his henchmen, is displacing the Levitical priesthood.



The Pharisees (above), although experiencing opposition from the Sadducees, have gained control of religious and civic life. True Judah is struggling for its survival. Jews are usurping Judah's claim to the Covenant. God appears in human form in the person of Jesus Christ.

Jesus, knowing better than any human being the difference between a Judahite and a Jew, declared "I come not but unto the lost sheep of the house of Israel ," (Matt. 15:24) for "He would not walk in Jewry, for the Jews sought to kill Him." (John 7:1.)

It is imperative that we understand our true history in order to determine exactly where and when the Jewish heresy began to displace the Mosaic Law. Consequently, it is an anachronism to refer to any Judahites before 150 B.C. as Jews! They were Judahites who practiced the Mosaic Law. They were not mamzers who practiced Talmudic Judaism!

I cannot stress these distinctions enough. Like the differences between X chromosomes and Y chromosomes, you have to know the religious, cultural and racial differences between Jews and Judahites in order understand true history. It is imperative that we understand these distinctions between Judahites and Jews. Otherwise, Judaism will triumph over True Israel in her ignorance!

I hope this historical analysis has been sufficiently clear so that we can recognize how the Jews have created a false history for themselves so as to confuse even our most erudite scholars, even such scholars as E. Raymond Capt and Howard B. Rand.

Here are the historical facts: The Pharisees are the originators of the religion known as Judaism. As usurpers later empowered by King Herod, who was an Idumean/Edomite put in place by the Roman authorities over the people of Judah, who were **Not His Racial Kin**. the Pharisees began to infiltrate the priesthood of Judah at all levels.

The historian, Josephus (who was not a Jew but a Judahite whose family was of the first of the 24 courses, hereditary families in the service of Israel and Judah!), tells us that, with regard to the ruling priesthood, Herod had all of the racial Judahites murdered and replaced with Edomites!

Now do you see how the transition from Hebrewism to Judaism really took place? It all started shortly before the time of Christ.

The modern parallels are, again, very striking, as the anti-Jewish Christian priesthood was replaced by the Judeo-Christian priesthood during the 1960's, with the advent of Judeotelevangelism and "Christian" Zionism: the scum that go by such names as Jerry Falwell, Pat ("Let's take out Chavez") Robertson, Billy Graham, Tim LaHaye, Jack van Impe and let's not forget Rush Limbaugh and Sun Yung Moon. I feel very secure in declaring that American Israel has a much more accurate view of our true history than British Israel.

The British Empire has been a lackey of Jewish international finance since before the American Revolution. Remember, folks, the Jewish bankers were the ones who instigated King George against the Colonies. It was Jewish debt money imposed upon the Colonies that was a major reason if not the major reason for the revolt of the Colonies. The Americans did not

American Israel is under no illusions about economic reality today. We know that the Federal Reserve System is just another Jewish banking fraud; and we are not going to deny our mistakes, in the interests of nationalism, to make ourselves look good.

Having established the fact that the ancient House of Judah absolutely contaminated itself with Babylonian teaching at the time of John Hyrcanus, the question still remains as to what extent the House of Judah allowed Babylonian teachings to creep in at any time before this during the Second Temple period.

#### Isa. 37:31-35, tells us this:

And the remnant that is escaped of the House of Judah shall again take root downward, and bear fruit upward: For out of Jerusalem shall go forth a remnant [recall Ezra 9:8], and they that escape out of Mount Zion: the zeal of Yahweh will accomplish this.

Therefore, thus saith Yahweh concerning the king of Assyria, He shall not come into this city, nor shoot an arrow there, nor come before it with shields, nor cast a bank against it. By the way that he came, by the same shall he return, and shall not come into this city, saith Yahweh. For I will defend this city to save it for mine own sake, and for my servant David's sake ."

This verse is telling us that Yahweh intends to defend Jerusalem for a future purpose. The expression "take root downward and bear fruit upward" is can only be a reference to the Second Temple Period, for there was no other revival of the Mosaic Law! And it concerns keeping Jerusalem alive for a time, which means keeping want to be the debt-slaves of the Bank of England. His Law and His priesthood alive, until

Jerusalem fulfils its purpose. That purpose is the One of the nine, a maiden by the name of declared in the following verse:

"The sceptre shall not depart from Judah until Shiloh come." (Gen. 49:10)



#### Henry VIII Wants an Heir



Let's start with Henry VIII. The king of England had not been able to conceive a male heir with his wife Catherine. So he wanted a divorce, which he doubted the Pope would allow. Henry VIII sent his secret agent Richard Croke to Venice in 1529 to consult with the Christian Cabalist theologian Georgi, as well as Jewish Rabbis, on the right way to biblically justify divorce and remarriage to the Pope. There was a conflict between Leviticus and Deuteronomy whether a man could marry his brother's widow, the grounds on which Henry VIII was questioning the legality of his own marriage to Catherine.

This represented the beginnings of an alliance between the British Monarchy and various Jewish groups. The divorce arguments, however, went nowhere. No compromise was ever reached with the Pope. (The British historian, Dame Francis Yates, tells the story in her book, *The Occult Philosophy in the Elizabethan Age.*)

So Henry VIII finally solved his dilemma by wresting the Church of England out from under the Pope, and proclaimed himself Head of the Church.

Henry was now supreme leader, both politically and spiritually, and did what he wanted with respect to divorce and remarriage. (As for the heir, we now know that the underlying infertility was Henry VIII's own. But from such trivialities do the major events of world history proceed.)

The Vatican was staggered. And it was furious. Not only had the head of a leading nation defied the Pope's authority in spiritual matters, but this same king had set himself up as a rival Pope, so to speak. King Henry VIII was an Anti-Pope. Or that's how the Vatican saw it. The Vatican and the Monarchy were now at war. The war of spiritual ideas and spiritual concepts quickly became part and parcel of the geopolitical war with the chief Catholic power, Spain.

Henry VIII's seizure of the Church of England had to be justified to English-speaking people in a spiritual sense. And so it was. The British had a spiritual destiny, it was declared.

#### **Information Warfare and John Dee**

John Dee, the son of one of Henry VIII's court officials, grew up surrounded by this controversy and the mystical currents concerning the notion of British Empire. The latter involved a spiritual as well as a geopolitical aspect: the British were to inherit the earth, and in the process foster the spread of True Christianity. That is, not Catholicism. According to Geoffrey Monmouth, the kings of Britain were descended from Brut, of Trojan origin. King Arthur, one of Brut's descendants, was considered the chief exemplar of sacred British Imperial Christianity. John Dee identified with this Arthurian notion of Empire, as he believed himself to be descended from the ancient kings of Britain, and was thus himself a distant cousin of the Tudor Queen Elisabeth I.

The Tudor monarchy of Dee's time was glorified as the culmination of the Arthurian tradition, because Henry VIII's break with the Vatican had eliminated the Pope and made the British Monarch supreme in both church and state.

Another line of thought led to the doctrine of British-Israelism, which held that the British were the descendants of the lost tribes of Israel. The doctrine of British-Israelism and the Lost Ten Tribes was intended to forge a political alliance between the British monarchy and the Jews of Amsterdam, through a merger of the Arthurian imperial tradition with Cabalistic interpretations of the Hebrew scriptures.

What had happened was that after the expulsion of the Jews from Spain in 1492, some of them went East to the Ottoman Empire—the Islamic

world being at the time more religiously tolerant of the Church. The Catholics quickly counter than Christendom. Within Europe itself many of attacked. The Catholic Marlowe wrote Faust in the Jews moved to Italy, particularly Venice, while other Jews and marranos migrated from Spain and Portugal to Amsterdam.

The Jewish merchants and bankers of Amsterdam were seen by the British Monarchy as desirable allies in the financial and political war with Spain, as well as in the spiritual war with the Vatican. Amsterdam thus became the springboard for the return of the Jews to England, from which they had been expelled in 1290.

To forge ties between Jewish merchants and British Imperialists, John Dee created the concept of British-Israel, which gave the British and the Jews a common racial identity, and invoked biblical prophecy to show the inevitable triumph of British Imperialism: the British, as Abraham's seed, were to inherit the earth. Dee also introduced the Jewish Cabala to the British ruling class and its interlocking network of European royal dynasties. All this set the stage for the later absorption of European Jewish merchants and bankers into British society.

In essence, the dissemination of the British-Israel doctrine was an intelligence coup carried out by the British Monarchy. It wasn't the only such propaganda effort, of course. Dee also introduced Rosicrucianism to Germany, and afterward the British Monarchy continued to use secret societies for intelligence gathering and for the spread of propaganda under the guise of Cabalism and occultism.

#### **The Literary War Continues**

By the next century, the British Crown had supplanted the Vatican as the world's pre-eminent manipulator of power, having established British naval supremacy through the defeat of the Spanish Armada in 1588. But the spiritual struggle continued, and British cultural history is strewn with its remnants. Edmund Spenser, for example, wrote The Faerie Queen with the express purpose of making a Napoleonic heroine out of Queen Elisabeth I.

This happened at the same time the Jesuits on the European continent were spearheading an attempt to stamp out Napoleonic influences, which were seen as undermining the authority

order to defame John Dee as a Satanic magician. Marlowe similarly penned The Jew of Malta as a propaganda work intended to generate public rage over the growing encroachment of Jewish merchants. And Marlowe's Tamburlaine was an attempt to discredit British ideals of Empire.



Francis Bacon, by contrast, carried on the traditions of John Dee (above). On the secular front, Bacon emphasized inductive science and proposed the Royal Society. On the religious side, Bacon espoused Masonry and discussed the British-Jewish alliance in his book New Atlantis. Even the Monarchy had a divided loyalty.

Queen Elisabeth's successor James I leaned again toward the Catholics. But his translation and publication of the King James Bible made possible the anti-Catholic practice of individual Bible reading and interpretation. By and large, the British Oligarchy became simultaneously humanist and occultist, pro-Jewish anti-Catholic.

Finally, Mennaseh ben Israel, the Dutch Cabalist Rabbi, petitioned Cromwell for the return of Jews to England. Mennaseh ben Israel argued that the Messiah and the Millennium could not come until the Jews had spread to every corner of the globe, which included England. To be sure, Menasseh ben Israel was not himself a British Israelite.

Instead, he discovered the Lost Ten Tribes of Israel among American Indians, an idea that would later be revived by the Mormons. But Cromwell's Puritan advisors said he should let Jews settle in England (which Cromwell agreed to do), believing they would convert to pure biblical Christianity (which they didn't).

The Jews were actually admitted in 1664, a few years after the deaths of both Cromwell and Catholic strain in the Monarchy was gradually weeded out. When William of Orange took over from the Catholic Stuart King James II in 1688, the domination of the Empire by the Protestant / Anglican branch of the Royal Family became permanent. The Monarchy, along with its allies the Noble and Jewish banking families, then immediately proceeded to consolidate its political control through the establishment of the Bank of England and the National Debt six years later in 1694.

These instruments provided the financial muscle needed to exercise worldwide power: to make loans and to finance enterprises, including the raising of armies and the fostering of revolutions. Manifest Destiny Yields to Balance of Power The manifest destiny of the Anglo-Saxon race continued to be important in Crown-supported propaganda.


But the Monarchy's actual policy evolved into one based on the balance of power. For example, in the 1890's, as Britain began to fear a militarist Germany, Cecil Rhodes and William Stead founded a secret society to revive support for British Imperialism. Members included Alfred (later Lord) Milner and Arthur (Lord) Balfour.

As governor-general of South Africa, Milner recruited a youthful group of administrators from Oxford and elsewhere. These were known as Milner's Kindergarten. To promote their geopolitical ideals, they established Round Table Groups in the British dependencies and the U.S. as well as think tanks like the Royal Institute of International Affairs and the Council on Foreign Relations. The stated intention of the society was to spread British upper class ideals to the world's masses. In practice, however, the Round Table Groups were principally used as an outlet for anti-German propaganda.

In his case—to counter the growing power of Germany—appeal was made to Britain's former colony in the New World: namely, to America. It was the Round Table connections of "Colonel" E. M. House, the principal advisor to President Wilson, that lead in 1913 to the establishment of the Federal Reserve and the graduated Income Tax in the U.S.

You needed both of these, of course, to provide the financial basis to create an American war

Menasseh ben Israel. Following that event, the machine. World War I broke out the following year. But prior to the outbreak, House wrote to Wilson: "Whenever England consents, France and Russia will close in on Germany and Austria." As another example of the balance of power policy, the Balfour Declaration in 1917 of British support for a Jewish homeland in Palestine—served the immediate purpose of increasing Jewish support for the British war effort. But it also followed Crown policy in eventually creating a balance of power in the Middle East.



It is easy to see what was going on if you look at the history of The Protocols of the Learned Elders of Zion. The first edition was published in Russian in 1901. Afterward it was translated into English by George Shanks and issued through the Eyre and Spottiswoode Publishing House, the printer of all official releases by the British Royal Family. Beamish founded "The Britons," a "Society to protect the Birthright of Britons, and to eradicate Alien influence from our politics and industries."



#### The Earth's Electric Envelope **Arthur Firstenberg**



All things by immortal power, Near or far, Hiddenly To each other linked are, That thou canst not stir a flower Without troubling of a star

**HEN I LOOK** at a flower, what I see is not the same as what a honey bee sees, who comes to drink its nectar. She sees beautiful patterns of ultraviolet that are invisible to me, and she is blind to the colour red. A red poppy is ultraviolet to her. A cinquefoil flower, which looks pure yellow to me, is to her purple, with a yellow centre luring her to its nectar. Most white flowers are bluegreen to her eye.

When I look upon the night sky, the stars appear as points of colour twinkling through earth's atmosphere. Everywhere else, except for the moon and a few planets, is blackness. But it is the blackness of illusion.

If you could see all the colours in the world, including the ultraviolet that honeybees can see, the infrareds that snakes can see, the low electric frequencies that catfish and salamanders can see, the radio waves, the X-rays, the gamma rays, the slow galactic pulsations, if you could see everything that is really there in its myriad shapes and hues, in all of its blinding glory, instead of blackness you'd see form and motion everywhere, day and night.

Almost all of the matter in the universe is electrically charged, an endless sea of ionised particles called plasma, named after the contents of living cells because of the unpredictable, life-like behaviour of electrified matter.

The stars we see are made of electrons, protons, bare atomic nuclei, and other charged particles in constant motion. The space between the stars and galaxies, far from being empty, teems with electrically charged subatomic particles, swimming in vast swirling electromagnetic fields, accelerated by those fields to near-light speeds.

Plasma is such a good conductor of electricity, far better than any metals, that filaments of plasma—invisible wires billions of light-years long—transport electromagnetic energy in gigantic circuits from one part of the universe to another, shaping the heavens. Under the influence of electromagnetic forces, over billions of years, cosmic whirlpools of matter collect along these filaments, like beads on a string, evolving into the galaxies that decorate our night sky.

In addition, thin sheaths of electric current called double layers, like the membranes of biological cells, divide intergalactic space into immense compartments, each of which can have different properties. There may even, some speculate, be matter on one side of a double layer and antimatter on the other. Enormous electric fields prevent the different regions of space from mixing, just as the integrity of our own cells is preserved by the electric fields of the membranes surrounding them.

Our own Milky Way, in which we live, a medium-sized spiral galaxy one hundred thousand light-years across, rotates around its centre once every two hundred and fifty million earth years, generating around itself a galactic-size magnetic field. Filaments of plasma five hundred light-years long, generating additional magnetic fields, have been photographed looping out of our galactic centre.

Our sun, also made of plasma, sends out an ocean of electrons, protons, and helium ions in a steady current called the solar wind. Blowing at three hundred miles per second, it bathes the earth and all of the planets before diffusing out into the plasma between the stars.

The earth, with its core of iron, rotates on its axis in the electric fields of the solar system and the galaxy, and as it rotates it generates its own magnetic field that traps and deflects the charged particles of the solar wind. They wrap the earth in an envelope of plasma called the magnetosphere, which stretches out on the night side of the planet into a comet-like tail hundreds of thunderstorms the electric tension in the air millions of miles long.

Some of the particles from the solar wind collect in layers we call the Van Allen belts, where they circulate six hundred to thirty-five thousand miles above our heads. Driven along magnetic lines of force toward the poles, the electrons collide with oxygen and nitrogen atoms in the upper atmosphere.

These fluoresce to produce the northern and southern lights, the aurorae borealis and australis, that dance in the long winter nights of the high latitudes.

The sun also bombards our planet with ultraviolet light and X-rays. These strike the air fifty to two hundred and fifty miles above us, ionising it, freeing the electrons that carry electric currents in the upper atmosphere. This, the earth's own layer of plasma, is called the ionosphere.

physical, chemical, electrical, and magnetic The earth is also showered with charged particles from all directions called cosmic rays. These are atomic nuclei and subatomic particles that travel at velocities approaching the speed of light.


> From within the earth comes radiation emitted by uranium and other radioactive elements. Cosmic rays from space and radiation from the rocks and soil provide the small ions that carry the electric currents that surround us in the lower atmosphere.

> In this electromagnetic environment we evolved. We all live in a fairly constant vertical electric field averaging 130 volts per meter. In fair weather, the ground beneath us has a negative charge, the ionosphere above us has a positive charge, and the potential difference between ground and sky is about 300,000 volts.

> The most spectacular reminder that electricity is always playing around and through us, bringing messages from the sun and stars, is, of course, lightning. Electricity courses through the sky far above us, explodes downward in thunderstorms, rushes through the ground beneath us, and flows gently back up through the air in fair weather, carried by small ions.

> All of this happens continuously, as electricity animates the entire earth; about one hundred bolts of lightning, each delivering a trillion watts of energy, strike the earth every second. During around us can reach 4,000 volts per meter and more.

> When I first learned about the global electrical circuit, twenty-five years ago, I drew the following sketch to help me think about it.



The above drawing indicates, plants are part of the global circuit

Living organisms, as the drawing indicates, are eleven-year cycle of sunspots, the fluctuations part of the global circuit. Each of us generates our own electric fields, which keep us vertically polarized like the atmosphere, with our feet and hands negative with respect to our spine and head. Our negative feet walk on the negative ground, as our positive heads point to the positive sky.

The complex electric circuits that course gently through our bodies are completed by ground and sky, and in this very real way the earth and sun, the Great Yin and the Great Yang of the Yellow Emperor's Classic, are energy sources for life.

It is not widely appreciated that the reverse is also true: not only does life need the earth, but the earth needs life. The atmosphere, for example, exists only because green things have been growing for billions of years. Plants created the oxygen, all of it, and very likely the nitrogen too. Yet we fail to treat our fragile cushion of air as the irreplaceable treasure that it is, more precious than the rarest diamond.

Because for every atom of coal or oil that we burn, for every molecule of carbon dioxide that we produce from them, we destroy forever one molecule of oxygen. The burning of fossil fuels, of ancient plants that once breathed life into the future, is really the undoing of creation.

Electrically, too, life is essential. Living trees rise hundreds of feet into the air from the negatively charged ground. And because most raindrops, except in thunderstorms, carry positive charge down to earth, trees attract rain out of the clouds, and the felling of trees contributes electrically towards a loss of rainfall where forests used to stand.

"As for men," said Loren Eiseley, "those myriad little detached ponds with their own swarming corpuscular life, what were they but a way that water has of going about beyond the reach of rivers?"1 Not only we, but especially trees, are the earth's way of watering the desert. Trees increase evaporation and lower temperatures, and the currents of life speeding through their sap are continuous with the sky and the rain.

We are all part of a living earth, as the earth is a member of a living solar system and a living universe. The play of electricity across the galaxy, the magnetic rhythms of the planets, the

in the solar wind, thunder and lightning upon this earth, biological currents within our bodies—the one depends upon all the others.

We are like tiny cells in the body of the universe. Events on the other side of the galaxy affect all life here on earth. And it is perhaps not too far-fetched to say that any dramatic change in life on earth will have a small but noticeable effect on the sun and stars.

When the City and South London Electric Railway (Above) began operating in 1890, it interfered with delicate instruments at the Royal Observatory at Greenwich four and a half miles away.

Little did the physicists there know that electromagnetic waves from that and every other electric railway were also radiating into space and altering the earth's magnetosphere, a fact that would not be discovered until decades later. To understand its significance for life, let us return first to the story of lightning.

The house we live in, which is the biosphere, the roughly 55-mile-high space filled with air that wraps around the earth, is a resonant cavity that rings like a gong every time a lightning bolt strikes. In addition to maintaining the static electric field of 130 volts per meter in which we all stand and walk, and in which birds fly, lightning sets the biosphere ringing at particular low frequency tones— 8 beats per second (or Hz), 14, 20, 26, 32, and so forth.

These tones are named for Winfried Schumann, the German physicist who predicted their existence, and who, with his student Herbert König, proved their constant presence in the atmosphere in 1953.

It so happens that in a state of awake relaxation, our brains tune in to these precise frequencies. The dominant pattern of a human electroencephalogram, from before birth through adult- that day. König then duplicated these effects in hood—the well-known alpha rhythm, ranging from 8 to 13 Hz, or 7 to 13 Hz in a newborn—is bounded by the first two Schumann resonances. An old part of the brain called the limbic system, which is involved in emotions, and in long-term memory, produces theta waves, of 4 to 7. Hz, which are bounded above by the first Schumann resonance.

The theta rhythm is more prominent in young children, and in adults in meditation. These same frequencies, alpha and theta, with surprisingly little variation, pulsate, so far as is known, in all animals. In a state of relaxation, dogs show an alpha rhythm, identical to ours, of 8 to 12 Hz. In cats the range is slightly wider, from 8. to 15 Hz. Rabbits, guinea pigs, goats and cows, frogs, birds, and reptiles all show nearly the same frequencies.

Schumann's student König was so impressed by the resemblances these atmospheric waves bear to the electrical oscillations of the brain that he conducted a series of experiments with far reaching implications.

The first Schumann resonance, he wrote, is so completely identical to the alpha rhythm that even an expert is hard pressed to tell the difference between the tracings from the brain and the atmosphere.

König did not think this was a coincidence. The first Schumann resonance appears during fair weather, he noted, in calm, balanced conditions, just as the alpha rhythm appears in the brain in a calm, relaxed state. The delta rhythm, on the other hand, which consists of irregular, higher amplitude waves around 3 Hz, appears in the atmosphere under disturbed, unbalanced weather conditions, and in the brain in disturbed or disease states— headaches, spastic conditions, tumours, and so forth.

In an experiment involving nearly fifty thousand people attending a Traffic Exhibition in Munich in 1953, König was able to prove that these latter types of disturbed waves, when present in the atmosphere, significantly slow human reactions the opposite.

the laboratory: an artificial field of 3 Hz (delta range) slowed human reactions, while an artificial field of 10 Hz (alpha range) accelerated them. König also noted that during the 3 Hz exposure some of his subjects complained of headaches, fatigue, tightness in their chest, or sweating from their palms.



In 1965, James R. Hamer published the results of experiments along these same lines that he had conducted for Northrop Space Laboratories, in an article which he titled "Biological Entrainment of the Human Brain by Low Frequency Radiation."

Like König, he showed that frequencies above 8 Hz quickened reaction times, while lower frequencies had the opposite effect. But he went further. He proved that the human brain could distinguish between frequencies that differed only slightly from each other—but only if the signal was weak enough. When he reduced the signal strength to 0.0038 volts per meter, which is close to the value of the earth's own fields, 7 Vi Hz had a significantly different effect than 8 V2 Hz, and 9Vi Hz than 1O V2 Hz.

Lightning is not yet done with its repertoire. In addition to the static field that we walk in and the low frequencies that speak to our brains, lightning also provides us with a steady symphony of higher frequencies called atmospherics, or just "sf erics," which reach thousands of cycles per second. They sound like twigs snapping if you listen to them on a very low frequency (VLF) radio, and usually originate in thundertimes, while the 8 Hz Schumann waves do just storms that may, however, be thousands of miles away.

The larger the Schumann signal in the atmos- Other sounds, called whistlers, resembling the phere, the quicker people's reactions were on descending tones of a slide whistle, often originate in thunderstorms on the opposite end of the Factor. earth. Their falling tones are produced during the long journey these waves have taken as they are guided along magnetic field lines into outer space and back to earth in the opposite hemisphere.

These waves may even bounce back and forth many times from one end of the earth to another, resulting in trains of whistles that seemed so unworldly when they were first discovered in the 1920s that they generated newspaper articles with not-so-inappropriate titles like "Voices From Outer Space."

Among the other sounds one may hear, especially at higher latitudes, originating somewhere in the electrical environment of our planet, are a steady hiss, and a "dawn chorus," so named because of its resemblance to chirping birds. Both of these sounds rise and fall gently every 10 seconds or so with the slow pulsations of the earth's magnetic field.

This VLF symphony bathes our nervous system. Its frequencies, ranging roughly from 200 to 30,000 Hz, span the range of our auditory system and also, as König observed, include the frequencies of the impulses that our brains send to our muscles.


The effect our VLF environment has on our well-being was resoundingly demonstrated by Reinhold Reiter in 1954 when he tabulated the results of a number of population studies that he and his colleagues had conducted in Germany, involving about one million people. Births, deaths, suicides, rapes, work injuries, traffic accidents, human reaction times, amputees' pains, and complaints of people with brain injuries all rose significantly on days with strong VLF sferics.

Our VLF environment regulates biological rhythms in both humans and animals. Golden hamsters, which have been popular pets since the 1930's, live in the wild near Aleppo, Syria where, every winter for about three months, they go in and out of hibernation.

But scientists who have tried to use hamsters as a subject for hibernation studies in the laboratory have been puzzled by their inability to trigger hibernation in these animals by exposing them to prolonged cold, reducing hours of daylight, or controlling any other known environmental

In the mid-1960's, climatologists Wolfgang Ludwig and Reinhard Mecke took a different approach. They kept a hamster during the winter in a Faraday cage, shielded from all natural electro-magnetic waves, and without any alteration of temperature or hours of daylight.

At the beginning of the fourth week they introduced the natural outdoor atmospheric frequencies by means of an antenna, whereupon the hamster promptly fell asleep.



the following two months, researchers were able to put the animal into and out of hibernation by introducing, or removing, either the natural outdoor frequencies, or artificial VLF fields that imitated the natural winter pattern.

Then, at the beginning of the thirteenth week of the experiment, the frequencies in the enclosure were changed so as to imitate the natural summer pattern, and within half an hour, as if panicked by the sudden change in season, the animal woke up and began a "movement storm," running day and night for an entire week until the experiment was terminated.

In repetitions of this experiment on other hamsters, the researchers found that this high level of activity could not be induced unless the state of hibernation had been triggered first. The artificial fields they used were extremely weak as small as 10 millivolts per meter for the electric field and 26.5 micro amperes per meter for the magnetic field.



#### A Short History of The English People - An Interesting Extract – The Transfer of Sovereignty From The **Monarch to The House of Commons** From Our Irish Correspondent



T SEEMS, THE REVOLUTION OF **1688** had only transferred the sovereignty over England from James to William and Mary. In actual fact, it was transferring the sovereignty from the King to the House Commons.

From the moment when its sole right to tax the nation was established by the Bill of Rights, and when its own resolve settled the practice of granting none but annual supplies to the Crown, the House of Commons became the supreme power in the State.

It was impossible permanently to suspend its' sittings, or, in the long run, to oppose it's will, when either course must end in leaving the Government penniless, in breaking up the army and navy, and in rendering the public service impossible. But though the constitutional change was complete, the machinery of government was far from having adapted itself to the new conditions of political life which such a change brought about.

However powerful the will of the House of Commons might be, it had no means of bringing its will directly to bear upon the conduct of

mind than that it should at once have found a simple and effective solution of such a difficulty as this.

The credit of the solution belongs to a man whose political character was of the lowest type. Robert, Earl of Sunderland (centre), had been a Minister in the later days of Charles the Second; and he had remained Minister through almost all the reign of James.

He had held office at last only by compliance with the worst tyranny of his master, and by a

It was common for a King to choose or dismiss a single Minister without communication with the rest;

and so far from aiming at ministerial unity, even William had striven to reproduce in the Cabinet itself the balance of parties which prevailed outside it.

Sunderland's plan aimed at replacing these independent Ministers by a homogeneous Ministry, chosen from the same party, representing the same sentiments, and bound together for common action by a sense of responsibility and loyalty to the party to which it belonged. Not only would such a plan secure a unity of administration which had been



unknown till then, but it gave an organization to the House of Commons which it had never had before. The Ministers who were representatives of the majority of its members became the natural leaders of the House.

Small factions were drawn together into the two great parties which supported or opposed the Ministry of the Crown. Above all it brought about in the simplest possible way the solution of the problem which had so long vexed both King and Commons.

The new Ministers ceased in all but name to be the King's servants. They became simply an Executive Committee representing the will of the majority of the House of Commons, and capable of being easily set aside by it and replaced by a similar Committee whenever the balance of power shifted from one side of the House to the other.

#### All Churches Now Required to Join IRS Super Church



It is now the "procedure" of the IRS to refuse tax exempt status to those churches that will not agree that all religions are equal and who refuse to join through tax exemption, the world church. > again. It doesn't say "exemption," it says, "...churches have a mandatory exception." The exception is from filing a Form 1023 to make application for not for profit status. Here is the kicker. Churches have to abide by the same rules that those that do file for this privilege. And if they do not, the IRS can, and most assuredly will, remove their tax exemption. The only thing missing is the annual Form 990 that other religious organizations have to file. When this is required, the churches will be under total control of the IRS with no wiggle room.



In the Baptist Temple court case, the church learned that a New Testament Church does not legally exist in the US today because there are no longer any First Amendment protections left. The genius of the First Amendment and various religious freedom clauses of the fifty states is that, for the first time in history, a N. T. Church could exist legally without having in the words of the IRS a "distinct legal existence."

Now even a N.T. Church will be assigned by force the legal status of an association and will be expected to meet the same standards that the not for profits have to meet. But, they still won't have their God given right of a non-taxable status. This status is in contrast to an exempt status which is a privilege not a right.

#### IRS Agent Says That Churches Are Trapped

The evidence as to what we are saying, though denied by most preachers, was made clear on January 24 this year in Tampa, Florida. IRS agent Melvin Blough testified in federal court that "once a church obtains the status of 501(c)(3) under the IRC they are trapped. The only way to be removed from a 501(c)(3) status is if the IRS chooses to remove the exemption. So if you dissolve the corporation and continue on as ABC church, an unincorporated church, you're still trapped in their web and under their control." He further testified that a church is automatically exempt under federal law without a 501(c)(3) designation.

He also stated under oath that churches request the status just to get the governments stamp of approval. Even though Blough used the word "exemption" rather than "exception," he is essentially correct in his assessment of the plight of the churches of America. It is obvious that, regardless, the result is the same. 

The only reasonable conclusion I can reach is that this has been deliberately used to justify bogus forecasts intent for political activism-

Which leads us neatly to the second facet of the affair - the actual 'affair' and the politically radical lover.

Professor Ferguson, 51, is said to be estranged from his wife Kim, with whom he has a 17-yearold son.

He is reported to have used the match-finding website OkCupid a year ago to meet Antonia Staats, 38, currently married and living with her husband and two children. Ms Staats is a Leftwing campaigner who works for the US-based online network Avaaz, an organisation that promotes global activism on, among other things, climate change.

The Guardian has called Avaaz the globe's largest and most powerful online activist network, and it has a world-wide following of around 10 million people. It is loosely connected with Bill Gates, through the World Economic Forum, which also lists Al Gore and Christine Lagarde on its board. Staats works as a senior campaigner on climate change for the group, and is said to be sympathetic towards the aims of Extinction Rebellion. Indirectly, on the surface at least, this ties Ferguson to climate change, a cause that the lockdown has served very well by managing to shut down the world economy.

#### **Ancient Mysteries: St Catherine's Hill** and Mizmaze, Winchester From Our Bristol Correspondent



St Catherine's Hill and Mizmaze, just south of Winchester, is a nature reserve offering fine views of the city to those who manage the strenuous climb to the top. It is also steeped in history: here you will find the site of an ancient fort and chapel, and a not-so-ancient turf maze.

Iron Age settlers built a fort on the hill 2,500 years ago. Its circular ramparts ringed the top of the hill, giving ample opportunity to observe the surrounding countryside.

The group of beech trees at the top is known locally as "The Clump". Beneath them lie the remains of St Catherine's Chapel, a Norman structure built 900 years ago. The chapel was destroyed in 1537.

There are differing explanations for the naming of the hill, and of the chapel that was built upon it. According to one source, it derived its name from the circular form of the hill fort, St Catherine having been martyred upon a wheel. Alternatively, it is locally thought that she was the patron saint of hilltops (having supposedly ascended to heaven from Mount Sinai), and the name is in use for hills elsewhere in the region.

#### The Winchester Mizmaze

To the left of The Clump is the Winchester Mizmaze, one of eight historic turf mazes still remaining in England. Cut into the chalk, with no junctions or crossings, this is not a maze in the modern sense but a labyrinth. It is 624m long

Surely it is now time for some genuinely tech- and formed from nine nested squares, in a pattern similar to that used for the traditional game of Nine Men's Morris. Unusually for a turf maze, its form is rectangular rather than circular.

> The origins of the Mizmaze are obscure. Although mediaeval in design, it is thought to date from the 17th century. Local tradition links it with Winchester College, as boys from the school used the hill as a recreational area. The legend is that it was carved one summer by a boy who had been banished to the hill for bad behaviour. With nothing else to do, he drew on his knowledge of classical maze design and set out on the lonely task of measuring out the maze. The story ends with the boy drowning on the last day of the holidays!

> Far fetched though this tale may seem, no other explanation has been found for the creation of the maze. It is equally uncertain what it was intended for. It is thought that some medieval mazes may have been built for penitential rituals but a recreational purpose is more likely by the time of the 17th century. Certainly, walking around the maze (known locally as "tolling of the Labyrinth") became a regular pastime for the College schoolboys.

> The maze fell into disuse for a while, but was recut in the late 19th century. The practice of tolling the Labyrinth was resurrected and has continued to the present day.






