The Enmity, Part 6: The Clash of the Bloodlines (5)

An Analysis of Genesis 3 and 4

THE TWO SEEDLINE TRANSLATION of Genesis 3:15 would read thus: “And I will put enmity between thee and her, between thy offspring and her offspring; her offspring shall bruise your head, and your offspring shall bruise his heel.”

It goes without saying that “seed” cannot do any bruising and that any literal seed cannot have enmity toward each other. I contend that a careful reading of the rest of Chapters 3 and 4 completely validates the bloodline interpretation. Gen. 3:1:

“Now the serpent was more subtle than any beast of the field which Yahweh Elohim had made. And he said unto the woman, Yea, hath Elohim said, Ye shall not eat of every tree of the garden? Now, the Hebrew word ‘Nachash’ has several meanings.

Yes, it can mean a literal snake. But it also means “to hiss, whisper (a magic spell), enchanter, enchantment, incantation, snake (from its hiss), serpent.” Given this range of meanings, by what authority do the sceptics declare that only a literal snake can be meant?

From their literalist position, they are actually saying that the snake raised up and spoke! Now, if little Miss Muffet was scared off her tuffet by a little spider, you can imagine what a talking snake would have done to her! She would have high-tailed it out of there, to use a figure of speech from the Old West.

But no, some anti-seedliners insist that this was a literal snake that spoke to her. And this snake was able to tempt her into eating a piece of fruit! And then this snake disappeared, never to be

heard from again, leaving Eve holding the piece of fruit as evidence. Should this interpretation really be taken seriously?

Gen. 3:1 contains the expression, “beast of the field.” What is a beast of the field? Professor Charles Carroll, in his book, *The Tempter of Eve*, explains, from a comparative study of many verses of the Bible, that the beast of the field is capable of speech, has hands and feet, and can even worship God.

Thus, the “beast of the field” is clearly a humanoid. Professor Carroll claims that it is a reference to Negroes. Whether it means Negroes or some other species is not clear to me because it can mean any or all of the other races that we know existed before Adam was formed.

The fact is that we are dealing with **Another Race**. This proves that there were other races in existence at that time, and, as such, it is clear evidence that Eve was dealing with a humanoid, not a snake.

Now, the verse tells us that the serpent was more subtle than any of these people. Since the “serpent” is being compared to a race of people, should we not consider Genesis 2-4 from the perspective that this nachash was a humanoid? The next few verses describe how nachash smooth talks Eve into defying God’s law.

Verse 5 says this: “For God doth know that in the day ye eat thereof, then your eyes shall be opened, and ye shall be as gods, knowing good and evil.” Now, this enchanter was actually telling Eve the truth. It is true that God does know that, if she does what he, nachash, wants her to do, she will have known good **AND** evil.

What the serpent was doing was piquing her interest, tempting her into an unusual experience. “You’re really gonna love this, Eve. There’s no harm. Try it, you’ll like it.” We hear this same refrain behind nightclubs and dance halls today—also in the back seats of numerous cars. What “gods” is he talking about? The Nephilim (fallen angels), perhaps, of which he was an example?

The Nephilim were known for mixing their seed with humans.

Verse 6: “And when the woman saw that the tree was good for food, and that it was pleasant to the eyes, and a tree to be desired to make one wise, she took the fruit thereof, and did eat, and gave also unto her husband with her; and he did eat.”

Certainly, the serpent had convinced her that the exceptional experience he promised her would be harmless.

Of course, he lied. Are literal snakes capable of lying? Are literal trees capable of lying? How does a literal tree, or its fruit, make one wise?

Now, here is where the anti-seedline position begins to fall apart, because from here on, the context is indisputably sexual. Verse 7 says: “And the eyes of them both were opened, and they knew that they were naked; and they sewed fig leaves together, and made themselves aprons.”

How does eating literal fruit relate to nakedness? Why did they have to cover their genital areas with clothing if their sin was some kind of culinary mistake? – or some kind of unnamed sin? If the sin were related to the mouth, then the punishment should have been to wear face masks!


Surely, the Father does not punish us in unusual ways. And, as we all know from our common law, the punishment must fit the crime! What did Adam and Eve do that required a punishment to be imposed upon their sex organs?

Verse 11: Who told thee that thou wast naked? Hast thou eaten of the tree, whereof I commanded thee that thou shouldest not eat? Again, what does nakedness have to do with the eating of literal fruit?

In Verse 12, Adam tries to pass the buck, blaming his complicity on Eve. In Verse 13, Eve says:

“The serpent beguiled me, and I did eat.” Now, let me remind you that one of the meanings of the word ‘beguiled’ is “seduced.”

Seduction is a sexual act. We want to choose the meaning which best fits the context of the passage(s). Based on the known alternative meanings of these words, it could easily have been translated as “Nachash seduced me and I did lay.”



In Verse 14, Yahweh condemns the Serpent to his lowly status for the rest of his days. If the Serpent were a literal snake, how would crawling on his belly be a curse? The anti-seedliners would have us believe that God is saying, “Hey, you snake, from now on you will crawl on your belly like a snake!”

But, clearly, the Serpent’s status is here being **Lowered to That of a Snake**, if only in figurative language. If nachash was a literal snake, this would be no curse at all, for crawling on his belly is nothing out of the ordinary – for literal snakes!

Verse 16: “I will greatly multiply thy sorrow and thy conception; in sorrow shalt thou bring forth children [Can you hear Eve saying, “*Because I ate a piece of fruit?*”]; and thy desire shall be to thy husband, and he shall rule over you.”

What does childbearing (conception) have to do with literal fruit? But if the “eating” that Eve did was of a sexual nature, then you can understand why Yahweh was so upset with her. And what about the latter clause of this sentence? Was her previous desire **Not Exclusively to Her Husband, Adam?**

Why would Yahweh have to even mention this if she had not desired someone else? And, apparently, she had not yet been subject to his rule...until she “ate” of the “forbidden fruit.” Yahweh had made them for each other. Eve was

even made out of Adam’s side (rib). Would not her desire be automatically for him and him alone? (Kind after kind. Like begets like.)

Think about it. Even today, White women, much more than White men, stupidly intermarry with other races, thinking they are “doing good” while actually contributing to the destruction of their own race. Because nachash **Appeals to Her Emotions of Sympathy for “Those Less Fortunate,”**

Eve loses her perspective and commits racial suicide. It is up to our men folk to rectify this situation because our women apparently cannot or will not do it.

In Verse 17, Yahweh curses the ground of the earth because of the “tree” sin they have committed. The verse concludes with the statement:

“In sorrow shalt thou eat of it all the days of thy life.”

This “eating” is really serious business, isn’t it? If it was just a piece of fruit, or some vague unnamed sin, why would Yahweh heap curse upon curse, sorrow upon sorrow, especially upon her conception and child-bearing?



Could it be because this was “eating” of a sexual nature and not the end of it either? Could it be because this meant the beginning of six thousand years of sorrow? Race-mixing creates forbidden fruit, such as Cain! We are still eating the bitter fruit of race-mixing today, aren’t we?

At the Last Supper, Jesus broke bread and said to the Apostles, “Take, eat; this is my body.” (Matthew 26:26) Was He asking them to literally **EAT** His body? Was Eve **Eating** literal fruit?

Now, before I quote Genesis 4:1, I want you to understand something. Up to this point, with all

of the curses, shame, and nakedness, Adam has not yet “known” Eve!



Yet, her womb was cursed; and her childbearing, and that of future generations of Adamite women, was to be done in pain. We call it “labour.” If she had mated only with her blood-kin husband, would such a curse have been issued by Yahweh?

Genesis 4:1: “And Adam knew Eve his wife; and she conceived, and bare Cain, and said, I have gotten a man from Yahweh.” Evidently, Eve was still under the spell of nachash, because, obviously, Cain was not of Yahweh. We already know from Verse 16 that she was unfaithful to her husband.

Why didn’t she say, “I have gotten a man from my husband, Adam?” Was there something remarkably different about Cain that he didn’t resemble Adam? Or was this just wishful thinking on her part?

Verse 2: “And she again bare his brother, Abel.” Eve does not make any remarks about Abel. You should all know that it is possible for a woman to be pregnant by two different men at the same time.

The offspring are called “twins” but it should properly be called a “dual pregnancy.” It is also possible for a woman to be pregnant at the same time by two men of different races. If you do not believe this, then just look up “hetero-paternal super fecundation” in your encyclopedia or search for it on your browser, and you will find a host of references and examples. Super

fecundity is the ability to conceive by two different men at the same time.

Eve was sexually known by nachash in order for Cain to have been conceived. Cain may have been humanoid, but he was not an Adamite. After murdering Abel, Yahweh drove him out of the land, and put a mark on him so that no one would try to slay him.

Why this mark? My opinion is that Yahweh wanted Cain and his offspring to survive because it is part of His plan to judge the Serpent seed. In order for Genesis 3:15 to be fulfilled, both seedlines had to survive into the future, with the First Advent redeeming the sin of Adam - remember, this was a **Personal Blood Sacrifice**, not a mere field offering - and the Second Advent instituting judgment upon the evil seed.



Again, why a blood sacrifice for the sin of Adam and Eve if only literal fruit or only mental seduction is involved? Jesus Christ shed His own blood so that our blood might be cleansed of its contamination. “For the life of the flesh is in the blood.” (Lev. 17:11)

Adam and Eve fell (and so are we fallen because we are their descendants) because their blood became polluted (mixed) with that of the Serpent (nachash) race. Once Eve’s womb was polluted, there was nothing Adam could do about it. Can you imagine his disappointment?

Incidentally, the name, Abel [#1893], is based on the Hebrew words, ‘habal’ [#1891], meaning “..to lead astray: -- be (become, make) vain,” and ‘hebel’ [#1892], meaning “——emptiness, vanity—transitory—unsatisfactory.”

Adam’s disappointment is reflected in the name, Abel, because he knew that Eve’s womb, and blood, had been contaminated.

This is why Jesus had to shed His own blood, as our Kinsman Redeemer, following the law of cleansing, or atonement for sins. If Adam and Eve’s sin were only mental seduction, **Why Would Literal Blood Have to Be Shed for the Atonement?**

Remember, the Old Covenant was “an eye for an eye, a tooth for a tooth.” Jesus died in order to make an end of these blood sacrifices, but He could only do it with His own Blood, as the scapegoat for our sins.

Does Satan Exist?



The Public Perception of Satan

It seems that part of the anti-seedline argument is that two-seedliners place too much emphasis on the existence of Satan as an evil-doer and that we blame him too much for our mischief.

I agree 100% with the sentiment that no one should use “the devil made me do it” as an excuse for their wrong behaviour; but I know of no two-seedliner who suggests that anyone should use such an excuse.

On the contrary, all of the Two-Seedliners listed earlier are consistent on the subject of moral culpability. They all teach that we are responsible for our own actions. If someone tempts us into doing evil, we are just as responsible as if we thought the whole thing up by ourselves. The involvement of a tempter does not make the crime any less a crime, or any less our own fault. I would say that the two sides are in agreement about this.

All we are saying is that the Serpent of the Garden is the same entity that has plagued our people for centuries. Judaism and Jewry have a spirit which directs them. That spirit is in their blood. But the crimes of the Jews are far worse than tempting us. Their modus operandi is **Deception**. Deception and temptation are two different animals. We often give in to temptation

of our own free wills, usually knowing better. Deception is when someone tricks us into doing evil and we don't even realize that it is evil. That's why it is so insidious.

Yahweh tests us; but He does not deceive us! Satan is a deceiver, not just a tempter! Through deception, completely innocent people are made to bear the brunt of deeds performed with no malicious intent. Christians are constantly being victimized by Jewish scams that involve neither temptation nor consent on the part of the victim.



Communism and the Federal Reserve System are two perfect examples of how the Jews trick us into disobeying God's Law--and we don't even know it! Communism and socialism are soft-peddled in our educational institutions as if they were just systems of politics.

Liberals swear and completely believe that they are doing good! This is indoctrination and brainwashing, pure and simple. People assume that the Fed is part of our government when, in fact, it is a private, profit-making banking conglomerate which robs the entire nation of its wealth. Have the American people been tempted to accept this system or have they been tricked by the Zionists and the government? Law + responsibility = Liberty. Lawlessness + deception = tyranny.

How, in these two examples, have the people yielded to temptation? Temptation is an invitation to do that which you know is wrong. Deception is taking advantage of people's ignorance.

Did the people knowingly create these corrupt institutions? No, they did not. They were created by Satan, or, if you prefer, by his worldly agents, the Jews. Satan is the deceiver in spiritual form.

The Jews are the deceiver in human form. Jesus tells us:


“Be ye therefore wise as serpents, yet gentle as doves.” (Matt. 10:16)

Is Satan a fictitious entity, as the anti-seedliners would have us believe? To quote an anonymous source: “The personification of the devil as the symbol of all evil assumes the living shape of the Jew.” I think it is fair to say the Jewish people, with their enthusiastic acceptance of the justified use of the lie, are led by a **Different Spirit**.


Where does that spirit reside? It is in their blood, because they have a different father. Yahshua told us who their father is:

“You are of your father, the devil, and your will is to do your father's desires. He was a murderer from the beginning Who was the first murderer in the Bible?, and has nothing to do with the truth, because there is no truth in him. When he lies, he speaks according to his own nature, for he is a liar and the father of lies” (John 8:44.)

If this statement does not convince you that the Jews are of a totally different nature from Israelites, then you simply don't understand the Bible.



Since the Jews are Canaanites, Edomites, and Khazars, they cannot be Israelites; and since these people have victimized the guileless Israelites for the last six thousand years, the book of Obadiah pronounces Yahweh's judgment upon these people at the Great Day of Yahweh.



Anti-seedliners have issued many statements in defence of their belief that Satan is a fictitious character invented by the Catholic Church in order to deceive us. But, the fact is that the Bible clearly teaches that Satan is both a spiritual being (in the Book of Job, chapters 1 & 2, and in Revelation) and that he has a worldly empire.

Just because a phony priest uses a concept for his own devious purposes does not mean that the concept is false. Questions: Does Yahweh have an Adversary or does He not? Do we have an Adversary or do we not?

We are not saying that this Adversary is God’s equal. We are merely asserting that Scripture tells us that the Adversary and his earthly children are making war against us. This is not just an inner turmoil.

This is a literal war (in heaven and on earth) and we should not minimize its seriousness by minimizing it as mere temptation. Satan and his followers are the rebellious ones who **Existed before Adam Was Formed!** So, how can they be mere figments of our imaginations? Nor is their biological hatred toward us imaginary.

It doesn’t matter what word you use to designate this deceiver (Lucifer, Sammael, Satan, Adversary, etc.), he and his offspring are very real. Genesis 3:15 is very clear about this. This entity we call Satan is simply the highest ranking spirit of the rebellion.

To deny his existence is to deny that Yahweh has an Adversary. If Yahweh does not have an Adversary, then who is He condemning in Genesis 3:14? Is He condemning Eve’s lust or the deceptions of nachash? The two are not the same. A question for True Israel: Are His enemies your enemies?


The word ‘enmity’ implies an adversarial relationship between two beings. In no way can

Gen. 3:15 be interpreted as Eve versus her own sinful nature!

The fact is that **She Had No Sinful Nature before She Was Deceived!** Gen. 2:25: “And they were both naked, the man and his wife, and were not ashamed.” The word ‘naked’ in this verse and in subsequent verses of Gen. 3 comes from the Hebrew root aram, #6191. The definition is “to be (or make) bare...to be cunning (usually [but not always -- EJ] in a bad sense)—take crafty [counsel], be prudent, deal subtly.”

But, before they sinned, they had nothing to be ashamed of. Wow! Did Adam and Eve learn craftiness from eating an apple, or from one mere instance of mental seduction? How does a tree teach you that you are naked? Can eating one apple impart craftiness even when you are tricked into eating it?

For how many generations must you suffer for this one act of mental deception?



Let us consider the anti-seedliner position that the “tree of knowledge of good and evil” means “mental seduction.” If Yahweh is perfect and without sin, and Adam and Eve are His literal children, as all Identity

teachers say, then how did evil get into us?

Adam and Eve would not be thinking any evil thoughts. We did not know cunning (in the negative sense) and we did not know evil, so how could these mental processes get started in us?

The evil had to be injected into our blood before we could think evil thoughts or commit evil deeds! This is what the Bible is telling us! Also, the word ‘ashamed’ comes from the Hebrew *buwsh*, #954, meaning “to pale—to be ashamed—

—to be disappointed, or delayed confounded, confusion, become dry, delay, be long.” But before the seduction, they were **Not** ashamed, confounded or confused in their nakedness!



How could eating a piece of literal fruit cause us to be ashamed of our nakedness? And how could we become mentally confused when the Bible says we were **Not Confused**? What kind of confusion are we talking about here: mental or genetic? The mental confusion came in as a result of the genetic confusion.

The aim of the Adversary is to get you to follow his program instead of Yahweh’s. When we do his deeds (spiritual, mental, and physical) and when we worship him instead of the Creator, we give him life. The life of the parasite depends upon the blood of the host. This is not about food. This is about **Blood**.

The Adversary is both spiritual and physical; but if those of us in the physical world would reject him and stop entertaining his deceptions, especially the confusion he causes through race-mixing, his food source would dry up. Deception and parasitism go hand in hand.

The problem is not so much that some people, known as Satanists, follow him consciously. These people are a small minority. The real problem is that a great majority of people unknowingly follow him, doing evil while thinking they are doing good. For Satan himself is transformed into an angel of light. (II Cor. 7:14.)

As in this quotation, the Bible repeatedly refers to Satan and the Devil as an individual having his own mind and will.

Ever since the Enmity was declared, Jewry has been on a mission to destroy White Christendom. They have followed us, pestered us, hounded us,

corrupted and deceived us in order to exploit and destroy us.

They are the children of the Devil, given to deception and spite. Like a snake in the grass, they have crawled on their belly, lying in wait for us in order to bite our heels from behind, like the cowards they are, just as Genesis 3:15 describes. Like children of darkness, they prefer the back rooms and the hidden places, where they connive, cheat, steal and plot.

We, on the other hand, deal in the public square, in the sunlight, showing ourselves openly, without malice. In fact, our propensity for honest and open dealing creates an easily bruised “Achilles heel” when interacting with the dishonest.

For as we declare the truth, which is our nature to do, the deceiver then uses this against us to destroy us. Perhaps there exists no better object lesson why Yahweh demands us to remain absolutely separate from the Jews.



To the extent we interact with these deceivers, we are unable to prevent them from subtly parasitising us, precisely because we possess an innate proclivity to tell the truth. Indeed, our worst trait is our gullibility in our dealings with the Jew.

The different nature of these two peoples is so obvious it hardly requires mention. Given this reality, it has been prophesied that the woman’s seed will one day wake up, totally annoyed and frustrated by the conniving of the Jews, and in a fit anger, turn around and crush the head of the Serpent’s seed – with Yahweh’s blessing and assistance. The prophecy of Gen. 3:15 has yet to be fulfilled; and when it is, it will be with a vengeance.

Yes, it is true that we Israelites can be our own worst enemies (our own worst adversary), but it

is not true that we have precipitated history's greatest crimes. These have always been accomplished by the bestial Jew in his war against us.

His dealings with us have always been ruthless and merciless, fomenting wars which have destroyed millions of Israelites. His economic policies (usury) have always sucked out our lifeblood and have ruined marriages, families, homes and nations.

In turn, we have always dealt with the Jew as if he were an equal. This is a courtesy that he never shows us. While the Jew assumes the posture of victimhood, a quick glance at history proves that the Jew has deliberately intended numerous wars and revolutions while we have been the victims of his treacheries.

Therefore, it is plainly untrue and simplistic to say that Eve's problem is her internal struggle with her own carnal nature or moral inadequacies. Let us not blame the victim for the conman's games.

This is not just a morality tale. This is a survival tale; and it is obvious that the Adversary is a flesh and blood creature that lives outside of Eve's conscience or control. Indeed, our efforts

to "Christianise" this Adversary have been met with nothing but scorn, ridicule and bad faith.

From his lofty position of economic and social control, he looks down his crooked nose at us with a hauteur mitigated only by his fear of retribution. Thus he fears exposure as if it were death itself! Like Jacob struggling with the angel through the night, we have had a very long night.

The only hope for us is to fully comprehend our national, racial and religious plight and deal with the Adversary according to our Father's instructions. We are to institute His Law on planet earth by severing all ties with the Jewish menace.

We are to "come out of Babylon." When America severs its slavish ties with the Israeli State, Zionism and Jewry will suffer a drastic cut in their food supply. When the Jew sees that we are about to do this, he will panic; and we will at once gain the upper hand. Yahweh will then fully support us because we will be showing awareness of our mission. 9/11 was a gigantic deception by the Jew against us. "Word for Word" Exodus Part 12

Chapter 16

1. And took they their journey from Eylim 362, and all the congregation of the children of Yis'rael came into the wilderness of *Siy*n 5512, which is between Eylim and Siynay 5514 on the

day fifteenth of the month second after their departing out of the land of Mits'rayim. .

2. Murmured 3885 the whole congregation of the children of Yis'rael against Mosheh and against Aharon in the wilderness:

3. and said the the children of Yis'rael, "Who 4310 will give 5414? Had we died by the hand of Yahweh in the land of Mits'rayim, when we sat by the flesh 1320 pots 5518, and when we ate bread till we were filled? Because, you have brought us forth into this wilderness, to kill this whole assembly with famine 7458!"

4. Said Yahweh to Mosheh, "**Behold, I will rain 4305 for you food 3899 from the sky 8064;**

and the people shall go out and gather a portion 1697 of a day 3117 in its day 3117, so that I may test them, whether they will walk in My law 8451 or not.

5. And it shall be, that on the day six they shall prepare that which they bring in, and it shall be twice what they gather daily."

6. And said Mosheh and Aharon to all the children of Yis'rael, "At sunset 6153, then you shall know that Yahweh has brought you out from the land of Mits'rayim:

7. and in the morning, then shall see you the Glory of Yahweh, because hears He your murmurings 8519 against Yahweh: and what are we, that murmur 3885 you against us?"

8. And said Mosheh, "When Yahweh shall give you flesh to eat in the evening, and in the morning food to the full; because Yahweh hears your murmurings that you murmur against Him: and what are we? Your murmurings are not against us, but against Yahweh!"



9. And spoke Mosheh to Aharon, "Say to all the congregation of the children of Yis'rael, 'Come near 7126 in the presence of Yahweh: because He has heard your murmurings.'"

10. And it came to be, as Aharon spoke to the whole congregation of the children of Yis'rael, that they looked toward the wilderness, and, behold, the Glory of Yahweh appeared in the cloud.

11. And spoke Yahweh to Mosheh, saying,

12. "I have heard the murmurings of the children of Yisrael: speak to them, saying, 'At

sunset you shall eat flesh, and in the morning you shall be filled with food; and you shall know that I am Yahweh Eloheychem."

13. And it came to be, that at sunset 6153 the quails 7958 came up, and covered the camp: and in the morning the dew 2919 lay round about 5439 the camp.

14. And when the dew that lay was gone up, behold, on the surface of the wilderness lay a fine 1851 scale-like thing 2636, as fine as the hoar-frost 3713 on the ground 776.

15. And when saw the children of Yisrael it, said they to one another, "What 4100 is this 1931?": because they knew not what it was. And said Mosheh to them, "This is the food which Yahweh has given you to eat.

16. This is the Word which has commanded Yahweh, 'Gather of it every man according to his eating 398, an omer 6016 for every man 1538, according to the number of persons; every man take what you need for those in your tents.'"

17. And the children of Yisrael did so, and gathered, some more, some less.

18. And when they measured it with an omer, he that gathered much had nothing left over, and he that gathered little had no lack; they gathered every man according to his eating.

19. And said Mosheh, "Let no man leave of it until the morning."

20. They listened not to Mosheh; and some left of it until the morning, and it bred worms, and stank 887: and angry was Mosheh with them.


21. And gathered they of it every morning, every man according to his eating: and when the sun grew hot, it melted 4549.

22. And it came to be, that on the day sixth they gathered twice as much food, two omers for one man: and all the rulers 5387 of the congregation came and told Mosheh.

23. And said he to them, "This is as has said Yahweh, tomorrow is the rest 7677 of the holy Shabbath 7676 unto Yahweh: bake that which you will bake today, and seethe what you will seethe; and that which remains over lay up for you to be kept until morning."

24. And they laid it up until the morning, as Mosheh bid them: and it did not stink, and there were no worms in it.

25. And said Mosheh, "Eat that today; because today is a Shabbath unto Yahweh: today you shall not find it in the field.



26. Six days you shall gather it; but on the seventh day, which is the Shabbath, there shall not be any."

27. And it came to be, that some of the people went out on the seventh day to gather, and they found none.

28. And said Yahweh to Mosheh, "**How long will you refuse 3985 to keep My commandments 4687 and My Torah 8451?**

29. See, because Yahweh has given you the Shabbath, therefore He gives you food for two days on the sixth day; every man abide in his place, let no man go out of his place on the seventh day."

30. So desisted 7673 the people on the seventh day.

31. And the House of Yisrael called it Man 4478: and it was like coriander 1407 seed, white; and the taste of it was like wafers 6838 with honey 1706.

32. And said Mosheh, "This is the thing which Yahweh commands, 'Fill an omer of it to be

kept for your posterity; so that they may see the food with which I have fed you in the wilderness, when I brought you forth from the land of Mitsrayim.'"

33. And said Mosheh to Aharon, "Take a pot, and put an omer full of Man in it, and lay it up before Yahweh, to be kept for posterity."

34. As commanded Yahweh to Mosheh, so Aharon laid it up before the Ark, to be kept.

35. And ate the children of Yisrael Man forty years, until they came to an inhabited land; ate they Man until they came to the borders of the land of Kenaan.

36. Now an omer is the tenth part of an ephah 374.

Chapter 16 Notes

Yahweh gives specific instructions concerning the gathering of Man, after Yisrael whines about being in the wilderness. Yahweh gives them quail to eat first, and then begins the gift of the food they would eat for forty years - Man. It is not spelled manna.

All Scripture can be backed up by science, and Man is no exception. It evidently is the drippings from a tree found in the region, and I will quote directly from my Brown, Driver, Briggs - Gesenius Hebrew Lexicon, Page 577, #4478 "known to Beduin in Sin. Penin.; a juice exuding in heavy drops from twigs (some say also the leaves) of Tarfa(Turfa) tree (tamarix gallica mannifera) in W. Sin. Penin., end of May and in June, sweet, sticky, honey—like".

This is a perfect fit for the substance provided to Yisrael by Yahweh. Yahweh used this entire scenario to again firmly establish His Shabath. It was a cessation from all labor, and of course may be translated as "rest", although this is a weaker form of what is meant than "cessation" in my opinion.

As to the exact measurement of omer, and ephah, these have been lost over time, and we can only guess at an approximate measurement. The spelling in the quote from B. D. B. G. is what is in there, and is old style, which I have left alone. I cannot recommend any Hebrew Lexicon more highly than this one. Others are

good, but for the advanced student B. D. B. G is by far the best out there, in my opinion (again).

Verse 28 - 8451 is torathay, plural of torah. It can also mean "teachings" instead of "law".

Their Place In World Affairs

THE JEWS distribute and merchandise a sizable part of the trade of the world, as they are first to admit. The International Trade Cartel (ITC) could

This avoids the condemnation in the Talmud which teaches, "A Gentile who studies the law deserves death." (Sanhedrin 59a, p. 75.) A Noahide priest is forbidden to proclaim things such as:

"The rapist shall surely be put to death." Deut 22:25-26; "If a man lie with mankind, as he lieth with a woman-- they shall surely be put to death." Lev 20:13; "Whoso killeth any person, the murderer shall be put to death." Num. 35:29-30

Noahides must not shed human blood. The Talmud teaches: "(Noahides are) required to choose martyrdom rather than shed human blood" (Pes. 25b and Rashi). The Jewish Encyclopaedia adds:-

"if he slay a man in self-defence, the Noahide is guilty of murder and must pay the death-penalty, although under the same circumstances an Israelite would not be executed." (Ency Judaica, Vol 12, p 649)

If you have wondered why the great push to confiscate guns - it might not entirely be the fault of "big brother." It might just be the implementation of religious doctrine. Without guns, Noahides could not violate the Talmud prohibition of slaying in "self-defence." How is it possible to pass such laws?



Easy! Look at the country's leaders. Both Clinton and Gingrich are pictured in the media wearing yarmulkas - the sign of submission to the God of the Jews[14].

Tele-Evangelists act as Noahide priests. They follow the rules exactly. Thumping the pulpit, they declare that the Bible is "the infallible word of God;" they use Christian terminology and parables to maintain the Christian facade needed to win the confidence of their audience, and then they preach a whole sermon without once repeating a single law, much less the Whole Law of the Bible[15].

Harold Stough Notes USAID and World Bank Unite Church and State (Part 3) Government Money Silences the Church

The World Bank Another Facilitator of Tyranny



H EADQUARTERED— AMID
O PULENCE IN WASHINGTON
D.C., the World Bank works to project a caring image. While their offices in the nation's capital are undergoing a renovation "at a cost of \$314 million" [6], the Bank urges austerity measures for the world's poorest people.

At the same time, James Wolfensohn, the Bank's president, warns that mal-distribution of income threatens global stability, yet "his 74 senior officers each draw a salary of \$120,000." [7]

On a broader scale, the Bank's policy is responsible for widespread destruction both socially and economically throughout the developing world.

Through its Structural Adjustment Programs (SAPs) the Bank manipulates internal policy within a country. With most Third World nations, the Bank's entering wedge is through its offer of loan money for a price. The cost usually comes in the form of concessions which benefit the Bank and its larger interests - consolidating its gains - drawing the state more firmly into their "**International System.**"

When countries become overburdened, unable to repay loans to the World Bank, the Bank creatively devises a plan to alleviate the problem - - another loan. Catherine Caufield, author of the 1997 book *Masters of Illusion: The World Bank and The Poverty of Nations* writes: "The bank called these 'structural adjustment loans,'

and conditioned them on the borrowing country agreeing to convert to a free-market economy (defined later as "open market" economy) by adopting reforms covering nearly every aspect of life.

"The World Bank uses these adjustment loans to 'roll over' the bad debts of borrowing nations--thereby disguising the poor quality of the bank's own lending practices--and to impose its ideology of economic reform on its borrowers.

"Perversely, under this arrangement in which bad loans are covered up by new ones, the World Bank gains more from failed projects than from successful ones. For as its lending grows, so do its profits, and consequently its power and stature. The more the World Bank lends to a country, the more it can insist on being involved in domestic issues confronting the debt-ridden, supplicant borrower."

Z Magazine stated in its February 98 issue, "World Bank policies have devastated the Third World. Between 1984 and 1990, developing countries under SAPs transferred \$178 billion to Western commercial banks. So enormous was the capital drain from the South that one former Bank director remarked:

'Not since the conquistadors plundered Latin America has the world experienced such a flow in the direction we see today.' By severely restricting government spending...the loan terms of the Bank and the IMF have eviscerated the state--leaving in its wake spiraling poverty and hunger.

"After twelve years of following World Bank and International Monetary Fund (IMF) - imposed policies, Latin America is going through 'its worst period of social and economic deprivation in half a century.'"

A case in point is the experience of Peru in 1991. In exchange for \$100 million from the United States, Peru put in place the World Bank and IMF's "structural adjustment" policy, opening its markets to United States' agricultural products.

"As a result, by 1995 corn cultivation fell tenfold. Under these conditions four million people were pushed into extreme poverty. Consequently, there has been a forced migration of impoverished peasants and urban unemployed." [8]

Many have turned to the lucrative cash crop of coca (cocaine) as an alternative to destitution. Corruption flourishes, drug trafficking has ensnared many including political leaders, leading to the overall destabilization of society.



A large sector of the economy has been criminalized as a result of these self-serving policies required by the Bank and the IMF. The case of Colombia shows a very similar history to that of Peru, the creation of a drug-driven economy, that "requires" the internal intervention of the U.S.

Another "revealing example is Haiti. In 1981 a USAID-World Bank development strategy was initiated based on assembly plants and agro-export, shifting land from food for local consumption. USAID forecast 'an historic change toward deeper market interdependence with the United States.'

The World Bank concurred, offering the usual prescriptions for 'expansion of private enterprises' and minimization of 'social objectives,' thus increasing inequality and poverty and reducing health and educational levels.

It may be noted that these standard prescriptions are offered side-by-side with sermons on the need to reduce inequality and poverty and improve health and educational levels, while World Bank technical studies recognize that

relative equality and high health and educational standards are crucial factors in economic growth.



Haiti

In the Haitian case, the consequences were the usual ones: profits for U.S. manufacturers and the Haitian super-rich, and a decline of 56 percent in Haitian wages through the 1980's.

"

It was the effort of Haiti's first democratic government to alleviate the growing disaster that called forth Washington's hostility and the military coup and terror that followed. With 'democracy restored,' USAID is withholding aid to ensure that cement and flour mills are privatised for the benefit of wealthy Haitians and foreign investors (Haitian civil society), while barring expenditures for health and education [for the poor]." [9]

These internationalist power groups call for strengthened civil society but always for self-serving purposes. It is difficult for these consortiums to work their will on Third World societies where there is no effective corporate structure or state to work through. As in the case of Peru (and a hundred other countries), it is the national government held hostage by these "humanitarians" that enslave and degrade their own people.

In their official capacity these globalist institutions speak in lofty, benevolent terms of reducing social inequity, combating poverty, fighting corruption, improving health and education.—but their destructive record speaks more forcefully than their rhetoric.

At the annual meeting in Hong Kong the Bank displayed its hypocrisy by the use of caring words while at the same time calling Third

World countries to open their capital markets (to exploitation by insatiable multinational corporate profit seeking).

"Many Southern governments made clear their opposition to such liberalization in Hong Kong but the IMF, backed by the Group of Seven leading industrialized nations, is going to push ahead anyway.

The insistence on capital liberalization is revealing of the true agenda of the World Bank and the IMF since 1945: fully integrating the Third World into the global capitalist system in the subordinate position of raw material supplier and open market.

The fulfillment of this agenda has involved the use of U.S. military power in combination with the World Bank - IMF economic programs to crush Third World governments aspiring to independent development. No talk of poverty can hide such a brutal enterprise." [10]

This world-subjugating "enterprise" results from the threefold union of secular government, corporate power and merchandising religious organizations. Each of these entities has an individual agenda yet, by their union, all are benefited.

Church and State -- the Final Corrupt Union



The LA. Times article stresses that ADRA officials maintain they are rigorous in honouring

the division between humanitarian work and proselytising. They say there is no cooperation between ADRA and Global Mission, the church's formal missionary arm, yet "the agency's (ADRA's) 10-year strategic plan, developed in 1996, calls ADRA 'a bona fide ministry of--the Seventh-Day Adventist Church.

The church's mission is incomplete without ADRA's distinctive ministry." [11] The church inseparably identifies itself with ADRA which, in turn, has identified itself with USAID, making the church inescapably responsible for the agenda of both ADRA and USAID.

ADRA's mission is now focused on fulfilling USAID's objectives, something one might expect from a "good, solid partner." But how then can ADRA serve both the government's interest (advancing U.S. political and economic objectives) and the church's interest simultaneously? Have the church's interests merged with those of the government's?

By their own accord, the Adventist church, through ADRA and nearly all other religious denominations, has become a partner with USAID - the U.S. government, the World Bank and the United Nations. In this union they become an accomplice to the crimes against humanity committed by this world-dominating cabal.

In the partnership of ADRA and their fellow religionists with USAID is represented the final union of the fallen religious bodies with the oppressive and corrupted state.

The Invisible Rainbow Irritable Heart (Part 4)

Mandel Ettelson Cohen (1907-2000)

COHEN, WHO DIRECTED THE RESEARCH, brought to it an open mind. Raised in Alabama and educated at Yale, he was then a young professor at Harvard Medical School who was already challenging delivered wisdom and lighting one of the earliest sparks of what would eventually be a revolution in psychiatry. For he had the courage to call

Freudian psychoanalysis a cult back in the 1940's when its practitioners were asserting control in every academic institution, capturing the imagination of Hollywood, and touching every aspect of American culture.

Paul White, one of the two chief investigators—the other was neurologist Stanley Cobb—was already familiar with neuro-circulatory asthenia from his civilian cardiology practice, and thought, contrary to Freud, that it was a genuine physical disease.

Under the leadership of these three individuals, the team confirmed that this was indeed the case. Using the techniques that were available in the 1940's, they accomplished what no one in the nineteenth century, when the epidemic began, had been able to do: they demonstrated conclusively that neurasthenia had a physical and not a psychological cause. And they gave the medical community a list of objective signs by which the illness could be diagnosed.

Most patients had a rapid resting heart rate (over 90 beats per minute) and a rapid respiratory rate (over 20 breaths per minute), as well as a tremor of the fingers and hyperactive knee and ankle reflexes. Most had cold hands, and half the patients had a visibly flushed face and neck.

It has long been known that people with disorders of circulation have abnormal capillaries that can be most easily seen in the nail fold—the fold of skin at the base of the fingernails.

White's team routinely found such abnormal capillaries in their patients with neuro-circulatory asthenia.

They found that these patients were hypersensitive to heat, pain and, significantly, to electricity—they reflexively pulled their hands away from electric shocks of much lower intensity than did normal healthy individuals.



When asked to run on an inclined treadmill for three minutes, the majority of these patients could not do it. On average, they lasted only a minute and a half. Their heart rate after such exercise was excessively fast, their oxygen consumption during the exercise was abnormally low and, most significantly, their ventilatory efficiency was abnormally low.

This means that they used less oxygen, and exhaled less carbon dioxide, than a normal person even when they breathed the same amount of air.

To compensate, they breathed more air more rapidly than a healthy person and were still not able to continue running because their bodies were still not using enough oxygen.

A fifteen-minute walk on the same treadmill gave similar results. All subjects were able to complete this easier task. However, on average, the patients with neuro-circulatory asthenia breathed fifteen percent more air per minute than

healthy volunteers in order to consume the same amount of oxygen.

And although, by breathing faster, the patients with neuro-circulatory asthenia managed to consume the same amount of oxygen as the healthy volunteers, they had twice as much lactic acid in their blood, indicating that their cells were not using that oxygen efficiently.

Compared to healthy individuals, people with this disorder were able to extract less oxygen from the same amount of air, and their cells were able to extract less energy from the same amount of oxygen.

The researchers concluded that these patients suffered from a defect of aerobic metabolism. In other words, something was wrong with their mitochondria—the powerhouses of their cells.

The patients correctly complained that they could not get enough air. This was starving all of their organs of oxygen and causing both their heart symptoms and their other disabling complaints.

Patients with neuro-circulatory asthenia were consequently unable to hold their breath for anything like a normal period of time, even when breathing oxygen.

During the five years of Cohen's team's study, several types of treatment were attempted with different groups of patients: oral testosterone; massive doses of vitamin B complex; thiamine; cytochrome c; psychotherapy; and a course of physical training under a professional trainer. None of these programs produced any improvement in symptoms or endurance.

“We conclude,” wrote the team in June 1946, “that neuro-circulatory asthenia is a condition that actually exists and has not been invented by patients or medical observers.”

It is not malingering or simply a mechanism aroused during war time for purposes of evading military service. The disorder is quite common both as a civilian and as a service problem.”

They objected to Freud's term “anxiety neurosis” because anxiety was obviously a result, and not a cause, of the profound physical effects of not being able to get enough air. In fact, these


researchers virtually disproved the theory that the disease was caused by “stress” or “anxiety.” It was not caused by hyperventilation. Their patients did not have elevated levels of stress hormones— ketosteroids—in their urine.

A twenty-year follow-up study of civilians with neuro-circulatory asthenia revealed that these people typically did not develop any of the diseases that are supposed to be caused by anxiety, such as high blood pressure, peptic ulcer, asthma, or ulcerative colitis.

However, they did have abnormal electro - cardiograms that indicated that the heart muscle was being starved of oxygen, and that were sometimes indistinguishable from the EKGs of people who had actual coronary artery disease or actual structural damage to the heart.

The connection to electricity was provided by the Soviets. Soviet researchers, during the 1950’s, 1960’s, and 1970’s, described physical signs and symptoms and EKG changes, caused by radio waves, that were identical to those that White and others had first reported in the 1930’s and 1940’s. The EKG changes indicated both conduction blocks and oxygen deprivation to the heart.

The Soviet scientists—in agreement with Cohen and White’s team—concluded that these patients were suffering from a defect of aerobic metabolism. Something was wrong with the mitochondria in their cells.

And they discovered what that defect was. Scientists that included Yury Dumanskiy, Mikhail Shandala, and Lyudmila

Tomashevskaya, working in Kiev, and F. A. Kolodub, N. P. Zalyubovskaya and R. I. Kiselev, working in Kharkov, proved that the activity of the electron transport chain.

—the mitochondrial enzymes that extract energy from our food—is diminished not only in animals that are exposed to radio waves, but in animals exposed to magnetic fields from ordinary electric power lines.



Erecting Electric Cable on Posts During The American Civil War

The first war in which the electric telegraph was widely used—the American Civil War—was also the first in which “irritable heart” was a prominent disease. A young physician named Jacob M. Da Costa, visiting physician at a military hospital in Philadelphia, described the typical patient.

“A man who had been for some months or longer in active service,” he wrote, “would be seized with diarrhoea, annoying, yet not severe enough to keep him out of the field; or, attacked with diarrhoea or fever, he rejoined, after a short stay in hospital, his command, and again underwent the exertions of a soldier’s life.

He soon noticed that he could not bear them as formerly; he got out of breath, could not keep up with his comrades, was annoyed with dizziness and palpitation, and with pain in his chest; his accoutrements oppressed him, and all this though he appeared well and healthy.

Seeking advice from the surgeon of the regiment, it was decided that he was unfit for duty, and he was sent to a hospital, where his persistently quick acting heart confirmed his story, though he looked like a man in sound condition.” Exposure to electricity in this war was universal. When the Civil War broke out in 1861, the east

and west coasts had not yet been linked, and most of the country west of the Mississippi was not yet served by any telegraph lines. But in this war, every soldier, at least on the Union side, marched and camped near such lines.

From the attack on Fort Sumter on April 12, 1861, until General Lee's surrender at Appomattux, the United States Military Telegraph Corps rolled out 15,389 miles of telegraph lines on the heels of the marching troops, so that military commanders in Washington could communicate instantly with all of the troops at their encampments.

After the war all of these temporary lines were dismantled and disposed of. "Hardly a day intervened when General Grant did not know the exact state of facts with me, more than 1,500 miles off as the wires ran," wrote General Sherman in 1864.

"On the field a thin insulated wire may be run on improvised stakes, or from tree to tree, for six or more miles in a couple of hours, and I have seen operators so skilful that by cutting the wire they would

receive a message from a distant station with their tongues."

Because the distinctive symptoms of irritable heart were encountered in every army of the United States, and attracted the attention of so many of its medical officers, Da Costa was puzzled that no one had described such a disease in any previous war.

But telegraphic communications were never before used to such an extent in war. In the British Blue Book of the Crimean War, a conflict which lasted from 1853-56, Da Costa found two references to some troops being admitted to hospitals for "palpitations," and he found possible hints of the same problem reported from India during the Indian Rebellion of 1857-58.

These were also the only two conflicts prior to the American Civil War in which some telegraph lines were erected to connect command headquarters with troop units. Da Costa wrote that he searched through medical documents from many previous conflicts and did not find even a hint of such a disease prior to the Crimean War.

The History of The Rothschilds

The Rothschilds Clan

THE ROTHSCHILDS CAN NEVER STOP GETTING CAUGHT with their pants down. The only way they will stop their covert activities is if the authorities start putting them behind bars.

It was reported a few years ago that “Switzerland’s financial regulator has accused Rothschild Bank AG and its trust subsidiary of violating anti-money laundering law in relation to 1MDB, the troubled Malaysian sovereign wealth fund.

“According to the regulator, both Rothschild Bank AG and Rothschild Trust AG failed to check where assets from a client came from. The firms reportedly disregarded signs that the funds could be connected to money-laundering and took the money anyway. The companies run by

the Rothschild family are also accused of reporting on the issue too late.”

Obviously that is not a surprise at all, particularly when we look at the Rothschild family and their covert activities throughout history. Keep in mind that One of the “industrial forces” that controlled the financial world in the eighteenth and nineteenth centuries was none other than the Rothschild family.

This was even admitted by socialist historian Gustavus Myers, who wrote in *The History of the Great American Fortunes* that “under the surface, the Rothschilds long had a powerful influence in dictating American financial laws. The law records show that they were the power in the old Bank of the United States.”

Mooney write that “the Rothschild family stands out in history as the prime example of manipulating the power of international banking, by means of usury on international scale, they were able to consolidate great wealth and power to turn world affairs according to their own fancy.”

The Rothschilds financed wars in England and America, collecting huge interest rates and making a massive profit.

By the middle of the nineteenth century, the Bank of England was dominantly controlled by the Rothschild family.

As Jewish Austrian writer Frederic Morton wrote, by the middle of the nineteenth century, “Rothschild was now banker to empires and continents—to all the principal European countries, to Eurasian Russia, to the Americas, to the Indies...In Paris, in Vienna, in Frankfurt and Naples, the titanic brother branches were just as busy.”



Jewish historian Esther Benbassa has similar views. She states that “the Rothschilds were Scottish Rite Masons,” but saw Freemasonry as a noble and tolerant religious organization that had welcomed Jews.

Yet, far from being a benign organization, Freemasonry was anti-Christian from the start and sought to dethrone Christianity—even through revolution. Starting with its rituals of initiation, Freemasonry finds itself in complete contradiction to the teachings of Christianity. Freemasonry is a secret society and its doctrines are antithetical to the Bible.

Philo-Semitic historian Niall Ferguson declared that Nathan Rothschild “was able to become the principal conduit of money from the British government to the continental battlefields on which the fate of Europe was decided in 1814 and 1815.”

Nathan, according to Ferguson, “became the master of the bond market” and “the master of European politics” during the Napoleonic war. By the nineteenth century, Nathan established “the biggest bank in the world.”[[] An American

magazine complained in the 1830’s that “not a cabinet moves without [the Rothschilds’] advice. They stretch their hand, with equal ease, from Petersburg to Vienna, from Vienna to Paris, from Paris to London, from London to Washington.”

The Rothschilds, in relation with the Rockefeller Foundation, were behind the “fiat money and inflation policy of the early New Deal.” (As of 2012, the Rothschilds again attempted to merge British and French banking operations in order to gain more control.

David de Rothschild declared that the new system would “better meet the requirements of globalizations in general and in our competitive environment in particular, while ensuring my family’s control over the long term.”

Ferguson, of course, does not attribute this to usury but to “sheer good luck,” something that is hardly rational; Sachar does the same thing. While Ferguson documents the fact that a century before the Rothschilds came onto the scene Sephardic Jews in places like Lisbon, Toulouse, Bordeaux, Antwerp, and London were deeply involved in the banking system, and admits that the Rothschilds “dominated the Jewish social and communal pyramid,” he says nothing about usurious contracts.



Sachar only gives us the example of Joseph Suss Oppenheimer, a Jewish financier and banker who “exploited his connections with such imagination and ruthlessness that he obtained almost complete control of the duchy’s financial administration. In that

capacity, Suss did not hesitate to pocket substantial bribes from businessmen in return for government contracts.”

In the end, Sachar attributed it to anti-Semitism. We find similar methodology in Benbassa’s work.


There were other voices, however, who thought the Rothschilds were up to something. In 1828, Thomas Dunscombe declared, “Master of unbounded wealth, [Nathan] boasts that he is the

arbiter of peace and war, and that the credit of nations depends upon his nod; his correspondence are innumerable; his couriers outrun those of sovereign princes, and...ministers of state are in his pay.”

Henry Clews, the American financier who wrote *Twenty-Eight Years in Wall Street* in 1888, declared that the Rothschilds were making a fortune in America through German banker August Schonberg, who changed his name to Belmont when he came to the United States.

Clews states that through his “avariciousness” and “penuriousness,” Nathan Rothschild in particular would “manipulate the market.”

Carroll Quigley claimed that the Rothschilds, among other bankers, were secretly misleading governments and people; he says that Mirabaud and the Rothschilds became the dominant financial system between 1871 and 1900. British economist J. A. Hobson declared in 1902 that nothing could be pursued “by any European state...if the house of Rothschild set their face against it.”



The Rothschilds ended up making a fortune during the Napoleonic Wars. Austrian-born Jewish writer Frederic Morton - **Left** - (born Fritz Mandelbaum) declared that the Rothschilds “conquered the world more thoroughly, more cunningly, and much more lastingly than all the Caesars before or all the Hitlers after them.”

Morton’s assertion is corroborated by biographer Derek Wilson, who declared that the Rothschilds were so financially and politically powerful that even royal governments and political leaders were afraid of them.

Their influence was so covert that Wilson moves on to say that “clandestinity was and remained a feature of Rothschild political activity—Yet all the while they were helping to shape the

major events of the day: by granting or withholding funds; by providing statesmen with an unofficial diplomatic service; by influencing appointments to high office; and by an almost daily intercourse with the great decision makers.”

Wilson later argued that their clandestine ways were justifiable since they feared that they would be misrepresented by the press; whether Wilson is right is hard to justify. But the Rothschilds made an enormous profit from the Napoleonic wars; after the dust settled, the Rothschilds “emerged from the war as millionaires and celebrities.”[[] One of the Rothschilds, Nathan, “was widely believed to have made extortionate profit from official contracts.”





Healing Properties of Pomegranates

WHY NOT ADD POMEGRANATE to your healthy habits to gain benefits from protecting your brain to increasing your immunity and lowering inflammation in your body?

Pomegranate is considered a super food and the best way to benefit from this low in calories, but packed with fibre, vitamins and minerals, nutri-

tion is to cut the pomegranate in half and eat the fresh pink seeds — known as arils — inside the whole fruit. Researchers have found pomegranate to have neuro-protective, antioxidant, anti-inflammatory and antibacterial healing properties that are highly beneficial to your health.

1 Neuro-protective

In a study of 30 multiple sclerosis (MS) patients, half were given a pomegranate seed oil supplement (GranaGard) for the first three months and then placebo pills containing soybean oil for an additional three months.

The other half received placebo pills first and then GranaGard for three months. All patients then received GranaGard for six more months. All patients receiving GranaGard reported a “positive” effect in their activities of daily life

while using the product and had stronger verbal learning test results during the period of treatment. Three cognitive function scores were significantly improved in the three months of GranaGard treatment compared to the placebo treatment.



For the patients receiving GranaGard in the initial three months, verbal learning remained high also at the following three months (while they received placebo), suggesting a longer lasting effect after discontinuation of the treatment. Thus, pomegranate shows the ability to protect the brain — both improvement and stabilization in cognitive decline for MS patients.

In an animal research study, rats were given pomegranate seed extract (PSE) of 200, 400 or 800 milligrams (mg) per kilogram (kg) for three weeks. In the third week, scopolamine — a memory and learning deficit inducer — was administered 30 minutes before the Morris water maze and passive avoidance tests.

PSE significantly reduced the time (maximum 173%) and distance (maximum 332%) required to reach the platform during the maze test and also increased performance in the passive avoidance tests relative to the treatment dosage. Pomegranate treatment successfully alleviated memory loss and learning deficits in rats by impacting cholinergic system function, oxidative stress and inflammatory cytokines in the brain.

Control and induced-MS mice were chronically administered ellagic acid (EA) and pomegranate peel extract (PE) dissolved in drinking water. After inducing MS for 10 days, mice were given a dose 50 mg/kg of both EA and PE daily and displayed a significant amelioration of “in vivo” clinical symptoms.

“Ex vivo” analysis showed that spinal-cord demyelination and inflammation in PE and

EA-treated MS-induced mice were comparable to those in the control animals, while microglia activation and astrocytosis significantly recovered, particularly in the grey matter.

Both PE and EA dietary supplementation in patients suffering from multiple sclerosis would be beneficial for disease treatment and provide brain protection. Pomegranate juice (PJ) is a rich source of ellagitannins, which are tied to pomegranate’s neuro-protective effect.

Olfactory and motor deficits are typical symptoms of Parkinson’s disease (PD). In a rat model of induced PD, rats were treated with pomegranate juice at a dose of 500 mg/kg per day for 35 days. PJ treatment protected against dopamine release in the brain and subsequently improved olfactory function and motor activity in the animals.

The neuro-protective effects of PJ against a neural toxin, lead acetate (LA), were tested in an experiment of 28 male Wistar albino rats, divided into four groups: control, PJ, LA and LA plus PJ.



The LA group had a significant decrease in hippocampal volume compared to the control group, while PJ demonstrated protective effects on the brain when compared with the LA and LA plus PJ groups, showing its ability to fight lead poisoning effects (See above).

Aluminium (Al) is a metal that can create neurobehavioral and biochemical problems. Six groups of male mice were treated for 35 days with 20% PJ, 40% PJ, 400 mg/kg Al, Al and 20% PJ, Al and 40% PJ or tap water as a control.

The exposure of male mice to Al decreased learning and memory retention in the shuttle box, Morris water-maze and T-Maze tests related to significant depletions in neurotransmitters and oxidative proteins. In both low and high doses,

PJ has health benefits and reduces aluminium toxicity while protecting learning and memory.

Aluminium trichloride (AlCl₃) exposure has been shown to encourage some behavioural deficits and eventually induces anxiety and depression in rodents. Six groups of male mice were administered PJ and AlCl₃ orally for 35 days. The control group received tap water while the PJ groups were treated with 20% and 40% PJ, respectively.

The AlCl₃ group was treated with 400 mg/kg/day of AlCl₃, and the last two groups were treated with AlCl₃ and 20% PJ or 40% PJ, respectively. The results illustrated that the anxiety- and depression-like behaviours induced by AlCl₃ exposure in male mice can be ameliorated by PJ treatment, through the inhibition of oxidative damage and minimizing the changes in neurotransmitters and hormonal activity.

Aluminium chloride (AlCl) was used to induce neurobehavioral and biochemical disorders in a mouse study and PJ treatment reversed AlCl-induced neuro-toxicity effects on body weight, neurotransmitters and oxidative stress parameters while improving learning and memory in the AlCl-treated mice even at low concentrations.

2. Antioxidant



Acrylamide is a food processing contaminant and carcinogen found primarily in wheat, rye and potato products such as crackers, breakfast cereals, breads, cakes, pies, French fries, potato chips and other snack products.

In an animal study, acrylamide exposure increased serum levels of aspartate aminotransferase (AST) and alanine aminotransferase (ALT), creatinine, interleukin-1 beta (IL-1 β) and interleukin-6 (IL-6) significantly, increased the lipid peroxidation marker malondialdehyde

(MDA) and lowered antioxidant biomarker activities (glutathione (GSH), superoxide dismutase (SOD), catalase and interleukin-10 (IL-10)).

Pomegranate peel extract significantly reduced MDA levels, inflammatory blood markers such as IL-1 β and IL-6, elevated antioxidant biomarkers (GSH, SOD, IL-10 and catalase) and restored liver damage markers (AST and ALT), showing its powerful antioxidant activity against acrylamide-induced toxicity.

Both peel and aril phenolic extracts (PPPE and PAPE) were shown to significantly inhibit lipid peroxidation and the formation of reactive oxygen species (ROS) in a study of stressed human bladder cancer cells. Therefore, pomegranate may provide protection against the development of metabolic disorders, cancers, athero-sclerosis and cardiovascular diseases due to its antioxidant properties.

3. Anti-inflammatory




Inflammation is commonly characterized as a defensive and protective reaction of the body to various internal and external stimuli, which aims to maintain your body's health. In a comprehensive review of research studies on pomegranate and its component EA, researchers confirmed the presence of important anti-inflammatory, anticancer and antioxidant activities of both pomegranate and EA.

Chronic diseases are responsible for approximately 71% of deaths around the world. These diseases are characterized by chronic low-grade inflammation and metabolic alterations. In a systematic review of 88 human clinical trials, functional fruits that regulate inflammation and metabolic parameters included cranberries, grapes, pomegranate and strawberries.

In a systematic review of 16 studies involving 572 subjects, pomegranate supplementation significantly reduced inflammatory markers of

heart disease — particularly heart attacks and strokes — and autoimmune diseases like rheumatoid arthritis, inflammatory bowel diseases, psoriatic arthritis, psoriasis, noninfectious uveitis, ankylosing spondylitis and Crohn’s disease. Significant reductions in high-sensitivity C-reactive protein (hs-CRP), interleukin-6 (IL-6) and tumour necrosis factor alpha (TNF- α) were found.

4. Antibacterial



Pomegranate — which contains a diverse range of phyto-chemicals including ellagic acid, punicalagin, pedunculagin, quercetin, rutin, tannic acid, polyphenols, anthocyanins and catechins — plays a strong role in the prevention and treatment of gingival and periodontal diseases due to its antibacterial, anti-inflammatory and antioxidant properties.

Pomegranate extract exerted antibacterial activity against periodontal pathogens — *Streptococcus* (S.) *epidermidis*, *S. aureus*, *lactobacillus* (L.) *acidophilus*, *S. mutans*, *S. sanguinis* and *S. salivarius* — and its component punicalagin also prevents the development of antibiotic resistance.

In comparison studies of pomegranate versus a standard chlorhexidine mouthwash, pomegranate had a more inhibitory effect (84% versus 79%) against dental bacteria — *S. sanguis*, *S. sobrinus* and *L. casei* — increased bacterial cell wall breakage, prevented adhesion of bacteria to the tooth surface, inhibited growth of bacterial enzymes and reduced gingival and bleeding scores.

Thrice daily mouth rinsing with pomegranate extract dissolved in water increased the levels of antioxidant activity and decreased activities of aspartate aminotransferase, which is elevated among periodontitis patients.

Probiotic bacteria were found to decrease the periodontal pathogen burden in the oral bio-film and strengthen epithelial barrier function, which enhances resistance to infections. Punicalagin in pomegranate has been shown to increase probiotic bacteria, especially *Bifido-bacterium* species and *Lactobacillus* species.

Not only is pomegranate a great treatment option for gingivitis and periodontal disease, it also has remarkable wound healing properties. In an animal study, a 10% pomegranate extract with 40% ellagic acid ointment had the most accelerated effect for healing of deep second-degree severe burn wounds.

The use of pomegranate seed oil in wound healing was studied in a rat model with results showing pomegranate making a significant difference in levels of inflammation and neo-vascularisation in open wounds within two weeks and the granulation tissue level in the closed wounds was significantly higher within 21 days.

In a rat study of the effects of pomegranate or chamomile on wounds, the combination of the two together in lower concentrations resulted in the most accelerated **wound healing** closure.

In a series of experiments on the effectiveness of pomegranate seed extract oil and curcumin versus ibuprofen as a control, the wound-healing efficacy of curcumin and pomegranate seed oil combined was better than any of the control combinations or each by itself.

Healing Aspects of Pomegranate



Year of Darkness: The Climate Cataclysm of 536 You've Never Heard of By John Black



DURING 536 THE WORLD WAS BESET BY A LONG WINTER. DUBBED “the year of darkness” in the *New Scientist*, temperatures plummeted and the sun was dimmed by a vast fog which blocked its rays from hitting the earth during 24 hours a day over the course of 18 months.

This climate cataclysm affected Europe, the Middle East and even parts of Asia over the course of the following decade. In fact, “this climatic downturn may well have profoundly altered the course of history.” But what caused this global climate cataclysm?

References in Historic Texts to a Global Climatic Cataclysm

Back in 2018, Science reported that the medieval historian Michael McCormick had stated that 536 “was the beginning of one of the worst

periods to be alive, if not the worst year.” In his historical work *Historiae Ecclesiasticae*, translating as “Church Histories”, the 6th century historian and church leader John of Ephesus wrote that “the sun became dark and its darkness lasted for 18 months.”

Between the years 535 and 536, a series of major climatic events took place that could easily be described as a global cataclysm with catastrophic consequences. “Each day, it [the sun] shone for about four hours, and still this light was only a feeble shadow. Everyone declared that the sun would never recover its full light again,” detailed Ephesus.

Ancient Cataclysms: 9 Catastrophes That Rocked the World

1110 AD, The Year Volcanoes Vanished the Moon and Sparked Global Famine.

In fact, according to Brandon Specktor in *LiveScience*, “the fall of the Roman Empire may have been a partial result of the decade of famine and plague that began in A.D. 536.” The fall in temperatures was in fact the beginning of the coldest decade to have been experienced during the last 2,000 years.

These low temperatures, falling as low as 1.5 C in summer time for example, led to crop failures and famine recorded across the world. Just a few

years later, in 541 AD, Justinian's Plague killed as many as 100 million people throughout the Mediterranean, a dire time to be alive indeed.

The Darkness and Severe Winter of 536



John of Ephesus is not the only writer to mention this climate cataclysm. Procopius, who lived between 500 and 565 AD and was a late antiquities Byzantine scholar and historian, also refers to the strange behaviour of the sun during 536 AD.

Believing it to be a bad sign foretelling coming events, Procopius stated “and it came about during this year that a most dread portent took place. For the sun gave forth its light without brightness, like the moon, during this whole year, and it seemed exceedingly like the sun in eclipse, for the beams it shed were not clear.”

Another reference to the climate cataclysm of 536 comes from the 6th century writer Zacharias of Mytilene, who authored a chronicle that contains a section referring to the “Dark Sun” between 535 and 536 AD.

The sun began to be darkened by day and the moon by night, while the ocean was tumultuous with spray from the 24th of March in this year till the 24th of June in the following year... And, as the winter was a severe one, so much so that from the large and unwonted quantity of snow the birds perished... there was distress... among men... from the evil things.” Zacharias of Mytilene (Chronicle, 9.19, 10.1)

These three extracts are just a representative sample of numerous accounts from all over the world, written during the era in question. In all cases, the sun was described as getting dimmer and losing its light. Many also described it as having a bluish colour.

The effects were also observed with the moon. It simply wasn't as bright anymore. The reduction of the light resulted in the reduction of heat on the planet. A lack of rain and a very long winter resulted in crop failures and for birds and other wildlife to perish, as Zacharias of Mytilene writes. Famine and plagues struck many areas and there were a huge number of deaths.

In China and Japan, the event was also recorded in great detail. With scarce water, there were massive droughts and death followed. Hundreds of thousands of square miles became infertile.

The Beishi chronicles, the official history of the Northern Dynasties, mentions that in the province of Xi'an 80% of the population died and the survivors ate corpses to survive. The year was 536.

The catastrophic event also struck Korea, the Americas, Europe, Africa, and Australia. While written records do not exist for all countries, archaeological and geological data revealed evidence of the climatic changes. Studies done on the trunks of trees, for example, showed that 536 AD had been the coldest in 1,500 years.

Trying to Understand What Caused the Darkness

The important question in all of this is why did it happen? While there are no definite answers for the climate cataclysm of 536, one theory put forward for the worst year in history is that there was a large asteroid or comet impact which landed in the sea (if it had hit land there would be evidence of a crater).

Geologist Dallas Abbott is one proponent of this view and bases his view on evidence that he found studying ice cores from Greenland. However, this wouldn't explain the dim light of the sun, and no tsunamis have been recorded for this period, which would have occurred if an asteroid landed in the ocean.

Another theory that has been put forward is a gigantic volcanic eruption, as the dust thrown up into the atmosphere could have caused the dimming of the light.

One candidate is Krakatoa, located between the islands of Java and Sumatra in Indonesia. Indeed, the Pustaka Raja Purwa (meaning “Book of the

Ancient Kings”) written in 1869, describes an ancient volcano.



There was a furious shaking of the earth, total darkness, thunder and lighting... Then came forth a furious gale together with torrential rain and a deadly storm darkened the entire world. When the waters subsided it could be seen that the island of Java had been split into two, this creating the island of Sumatra.

Although this manuscript refers to the year 416 AD and not 535 AD, the fact that it was written in the 19th century could account for inaccuracies in the time reference.

Searching for Answers: Understanding the Climate Cataclysm of 536

Whether or not a definitive answer will ever be found is unknown, but that hasn't stopped scientists from trying to find one. One thing that is quite peculiar about this global climate cataclysm is that it is a virtually unknown event.

Why is it that this climatic event is not taught in schools? Why isn't there a plethora of research examining it? Perhaps it is because it reminds us of our fragility as human beings and the fact that no matter how powerful and "advanced" mankind becomes, we are still at the mercy of nature.

While historians have known about this climate cataclysm for a long time, they have remained puzzled as to its causes. In 2018, the analysis of a 72-meter-long (253 foot) core of ice from a

glacier in the Swiss Alps, which serves as a logbook of naturally occurring and human created events, has concluded that an immense volcanic eruption in Iceland spread ash throughout the Northern Hemisphere in 536. There were two more eruptions in 540 and 547. Their results were published in the journal Antiquity.



But, why does a volcanic eruption affect global temperatures? "When a volcano erupts, it spews sulphur, bismuth, and other substances high into the atmosphere, where they form an aerosol veil that reflects the sun's light back into space, cooling the planet," explains Ann Gibbons in Science.

According to the Antiquity study, by 640 the ice core shows traces of lead, which they concluded is evidence of a so-called "silver-smelting boom." Live Science explains that this silver boom is a sure sign of "an economy rebounding in the darkness of starving, disease-stricken Europe, and the emergence of a new merchant class ready to trade in precious metals." Humanity began to recover from the dire effects of climatic conditions of 536.

The Venetian Conspiracy (Part 7)

THE FIRST VENETIAN PLOY WAS TO ATTEMPT TO DISMEMBER THE CAMBRAI COALITION. They started with Pope Julius II. This pontiff was, as already noted, Genoese. Genoa and Venice had engaged in a series of highly destructive wars up till about the end of the fourteenth century, but after that, Genoa gravitated toward the status of junior partner and close associate of the Venetians. The Venetians had bested the Genoese by virtue of superior connections in the East, but otherwise their was a broad area of agreement.

The symbol of Genoa was St. George the dragon-slayer, in reality no saint at all but a thinly disguised version of Perseus saving Andromeda by slaying the sea monster, a legend that is centred on the coast of Lebanon. The “George” is said to come from the Gorgon Medusa, whose head Perseus was carrying.

Perseus is in turn nothing but a westernised variant of Marduk, the Syrian Apollo, a deity associated with the most evil forces of ancient Assyria and Babylon.

The Venetians had their own Marduk cult, although subordinated to St. Mark, on the island of San Giorgio Maggiore, home of a Dominican monastery and today of the Cini Foundation, one of the highest level think tanks in the world. The modern British preference of Gorgons is too well known to need comment.

What probably accounted more directly for Julius II’s decision to reverse his alliances was a deal mediated with the Venetians by Agostino Chigi, the Siena Black Guelph banker from

whose financial empire the infamous Siena Group of today derives. He proposed that the Venetians stop buying alum, needed in textile and glass manufacture, from the Turks, but contract for a large shipment at higher prices from the alum mines at Tolfa in the Papal States – mines for which he, Chigi, was acting as agent. To sweeten the pot, Chigi offered the Venetians tens of thousands of ducats in much-needed loans.

The Venetians, fearing a rapid French offensive, accepted. Their own state finances were in total shambles. Only the Chigi loan allowed them to hire enough Swiss mercenaries to hold out against the French and the Imperial Landsknechte.

To provide a plausible cover for his move, Julius II suddenly discovered that the real issue was not Venice after all, but the need to expel the barbarians (primarily the French) from Italy. Julius stipulated an alliance with Venice. He then set up the slogan of Fuori Barbari! (Kick the Barbarians out!) which is still recorded by credulous writers of Italian school books as the beginning of the struggle to unify Italy. Even the Venetian mercenaries, mostly Swiss, began using the battle cry of “Italy and Freedom!”

Thus the post-Agnadello crisis was overcome. Some years later the Venetians tried the same tactic in reverse, this time with more lasting success. By 1525 the prevalent barbarians in Italy were the forces of Emperor Charles V, who had defeated the French at Pavia, capturing King Francis I.

The French lost their hold on Naples and Milan. At this point Doge Andrea Gritti, whose portrait by Tiziano speaks volumes about his personality, decided to agitate once again the banner of Italian freedom.

This took the form of the Holy League of Cognac “for the restoration of Italian liberty,” uniting France, Venice, Milan, Florence, and the Papal States under Pope Clement VIII Medici. After having set up this alliance, designed to

play the French against Charles V once again to destroy Medici-controlled Rome, the last intact Renaissance centre, the Venetians retired into defensive positions to await the outcome.

Venetian capacities to manipulate Charles V were formidable indeed. The emperor's bankers and intelligencers were the Fuggers of Augsburg, a banking house and a city that must be regarded as Venetian satellites, within a context of very heavy Venetian control of the cities of the Danube valley.



Jacob Fugger

Virtually every young male member of the Fugger family, and of their colleagues the Welsers as well, was sent to Venice for a period of apprenticeship at the Fondaco dei Tedeschi. This was the case with Jacob Fugger the Rich. Venice was the pivot for Fugger metals trading, especially toward the East.

Thus, the Venetians stayed in their phony war posture against Charles V, while the imperial army of Lutheran Lanzis under Georg Frundsberg devastated Italy. The sack of Rome in 1527 was the direct outcome of this combined Venetian diplomacy and manipulation. To make Charles V's triumph complete, the Genoese Admiral Andrea Doria, commanding the French fleet, defected to the imperial side. A Doria coup in Genoa then established a permanent de facto alliance with Venice.

In 1530, Charles V was crowned as Holy Roman Emperor and King of Italy in a ceremony at Bologna. Garrisons of imperial troops were shortly stationed in every major city. Thanks to the tenacious policy of the Venetians, the main centres of the Renaissance had been subverted or destroyed. Venice was the only major Italian state which had retained real sovereignty. With the end of the Renaissance, Venice could feel

free to start a delphic Renaissance among the throngs of intellectuals seeking asylum in the lagoons.

THE CREATION OF THE JESUITS

The "long autumn of the Italian Renaissance in Venice" during the rest of the sixteenth century was only one deployment among several. Another was the promotion of the Protestant Reformation.

The more immediate controllers of Martin Luther have yet to be identified, but this is something of a secondary matter. Luther's agitation in Wittenberg was merely one more example of protests against the papacy and the Curia that had been chronic and endemic for decades.

What gave Luther and the rest of the Protestant reformers real clout was a publicity and diffusion of their ideas that owed much to the Venetian publishing establishment. The Venetian presses quickly turned out 40,000 copies of the writings of Luther, Calvin, Melancthon, and the heresiarch Juan Valdes, especially popular in Italy.



Pope Leo X publicly denounced the University of Padua as the hotbed of inspiration of the German disease of Lutheranism. Clearly, Venetian interest was well-served by a schismatic movement that would embroil Germany, France, and the rest of Europe in a series of easily profiled conflicts. In addition, a conflict between reformers and counter-reformers, all owing allegiance to Aristotle, would severely undercut the influence of Erasmus and others like him.

Venetian influence on both Reformation and Counter-Reformation can be seen most clearly in the remarkable career of Gasparo Contarini, who did not let the fact that he was a Protestant in theology, well before Luther, prevent him from founding the Society of Jesus.
