## Was Mary A Levite or A Judahite? By Eli James



ANY CHRISTIAN IDENTITY BELIEVERS HAVE WRITTEN TO ME expressing the opinion that Mary, mother of Jesus Christ, was not of the tribe of Judah but was a descendant of the Tribe of Levi.

In this paper, I am going to do my best to counter this opinion and show the Biblical reasons why it is unsound. Although most of those who have expressed this opinion are concerned Christian Identity adherents, there are also those who wish to throw a monkey wrench into the works of Christianity by suggesting the idea that Jesus was **Not** of the House of David, and therefore, not a Judahite.

But if Mary was indeed a Levite, then there would be a problem with the prophecy that the Messiah would be of the House of Judah, seed of David. Let's take a look at what the Good Book tells us in Matthew 1:1:

"A genealogy of Jesus Christ, son of David, son of Abraham..."

Here is listed the statement by Matthew that Jesus is, indeed, the son of David. Christ's genealogy is given in a forward historical direction, starting from Abraham and ending with Jesus. Now, of course, this statement alone does not solve our problem because we need two or three witnesses.

The Gospel of Luke also lists Jesus Christ's genealogy, but in a backwards order, from Jesus all the way back to Yahweh, our Father:

"When he started to teach, Jesus was about thirty years old, being the son, as it was thought, of Joseph, son of Heli, son of Matthat, son of Levi–son of David–son of Judah—son of Adam, son of God." - Chapter 3, Verse 23-38.



Note that in the above quotation, the man, Levi, is mentioned. It is not mentioned whether he is a member of the Levitical priesthood or of the tribe of Levi. He is simply mentioned as Joseph's great-grandfather.)

But since Jesus Christ's true father was the Holy Spirit, not Joseph, then we must concentrate on Mary's lineage in order to show that Jesus was, in fact, a Judahite. If Mary is not a Judahite, then Christianity has a problem. Let's see if we can get to the bottom of this question. Going back to Matthew, we have this list of patriarchs:

"—Eliud was the father of Eleazar, Eleazar the father of Matthan, Matthan the father of Jacob; and Jacob was the father of Joseph the husband of Mary; of her was born Jesus who is called Christ." -- Verse 15 & 16.

Since these lists do not contain the same names, many critics of Scripture have claimed that this is one of the famous instances where the Bible seems to contradict itself; but I do not think so.

I think what the New Testament has recorded for us is the separate genealogies of Joseph and Mary, with Matthew giving us Joseph's descent and Luke giving us Mary's line of descent. The important fact is that **Both** are of the house of David and Judah. In Old Testament times (and the days of the Messiah were not different in this regard), the wife was considered the property of The Bible is not contradicting itself. It is simply the husband. This custom led to certain idiomatic expressions which are very confusing to those who are not aware of the idiomatic nature of much of the Bible's language.

A great example is the story where Noah curses his grandson, Canaan, for a sin committed by his son, Ham. The sin committed by Ham is described as "Ham saw the nakedness of his father."

The reality is that the idiomatic expression, "nakedness of the father," can also be a reference to the nakedness of the wife because she is his property. Therefore, many Bible scholars interpret this story as being a case of incest in which Ham must have had sexual relations with his mother while both Noah and his wife were in a drunken stupor, presumably celebrating the landing of the Ark.

This is why Noah cursed Canaan, not Ham, because Canaan was quite likely the product of incest! Without the knowledge of the idiomatic nature of Biblical Hebrew, this idea is not likely to occur to anyone and the whole incident is a mystery.

The same type of idiomatic interpretation probably applies to Luke 24 which says that Joseph was the son of Heli, but here we have to take the meaning as son-in-law.

The reason for this is that the two genealogies are different and because Matthew expressly identifies Joseph as the husband of Mary, thus giving us the clue that Matthew gives Joseph's side of the family and Luke gives us Mary's side of the family. Since the custom was always to give the genealogy through the father [Jews take note: NOT through the mother!], Joseph is mentioned in both cases.

giving us the two different lines of descent of the two parents. Note, however, that, either way, whichever genealogy you choose, Jesus is of Judah and of David, so the claim that Mary is not a descendant of the tribe of Judah and merely of the tribe of Levi just does not stand.

In addition, it is a matter of historical fact that the Tribe of Levi was set apart and not to be considered a distinct tribe anymore:

"Yahweh then set apart the tribe of Levi to carry the ark of Yahweh's covenant, to stand in the presence of Yahweh, to do him service and in his name to pronounce blessing as they still do today [whenever this verse was written!]. Levi therefore has no share or inheritance with his brothers: Yahweh is his inheritance, as Yahweh your God told him." Deut. 10:8,9:

- The Levitical priests were to get their wives from the other tribes, so that the Tribe of Levi would no longer exist as a distinct tribe.
- Joshua 13:14 repeats this testimony.
- "To the tribe of Levi alone was no inheritance given."
- From this standpoint, it is impossible for Mary to be a Levite because the tribe of Levi ceased to exist as a distinct tribe during the forty years wandering in the desert. Yahweh gave them a special mission and they obeyed that part of the mission, about 1400 years before Mary was born.
- In short, the Tribe of Levi was absorbed into the other tribes and was no longer considered a distinct tribe.
- During the time of Christ, the expression, "the sons of Levi," could only be a reference to the Levitical Priesthood, not the tribe of Levi. By this time, this priesthood had the blood of all twelve tribes in its veins. None of this disqualifies either Joseph or Mary from their claim to being of the House of Judah through

David. All it means is that they might each carry the genetic material of an original Levite in addition to the genetic material of David himself.

• This fact would make Jesus qualify all the more for His role as Priest, King and Kinsman Redeemer.

## Old Testament "Word for Word" Exodus Part 17 Translation by Stephen Howard Anderson



## **Chapter 22**

**1.** If a thief is found breaking in, and smitten so he dies, there shall be no blood shed for him.

2. If the sun has risen upon him, there shall be blood shed for him; for he could make full restitution; if he has nothing, then he shall be sold for his theft.

**3.** If the theft is found in his possession alive, whether it is an ox, or an ass, or a sheep; he shall restore double.

4. If a man causes a field or a vineyard to be eaten, and has let loose his grazing animals, and shall graze in another man's field; then the best of his own field, and of the best of his own vineyard, he shall make restitution.

5. If fire breaks out, and catches in thorns, so that the stacks of corn, or the standing corn, or the field is consumed by the fire, he that kindled the fire shall make restitution.


6. If a man shall give to another person money or stuff for safekeeping, and it is

stolen out of the man's house, if the thief is found, let him pay double.

7. If the thief is not found, then the owner of the house shall be brought to the judges 430, to see whether or not he has put his hand into another person's property 4399.

8. For all manner of trespass 6588, whether it is for ox, for ass, for sheep, for clothing, or for any manner of lost thing that another says is his, the cause 1697 of both parties 8147 shall come before the judges; and whom the judges shall condemn 7561, he shall pay double to the other person.

9. If a man give to another person an ass, or an ox, or a sheep, or any beast, for safekeeping; and it dies, or is harmed, or driven away as captive 7617, and no man sees it:



10. then shall an oath of Yahweh be between them both, that he has not put his hand into

another person's property; and the owner of not be to him a creditor 5383, neither shall it shall accept 3947 it, and he shall not make you lay upon him usury 5392. it good.

11. And if it is stolen from him, he shall make clothing as a pledge, you shall return it to him restitution to the owner of it.

14. But if the owner of it is with it, he shall not your ripe fruits 4395, and of your liquors make it good: if it is a hired thing 7916, it 1831: the firstborn of your sons you shall give came for his hire.

15. And if a man entice 6601 a virgin 1330 29. Likewise shall you do with your oxen, and that is not betrothed 781, and lie 7901 with her, he shall surely give a dowry to her 4117 to be his wife.

16. If her father utterly refuses to give her to him, he shall pay money according to the dowry 4119 of virgins.

17. A sorcerer 3784 you shall not let live 2421.

18. Whosoever lies 7901 with a beast 929 shall surely be put to death. [see notes]

**19.** He that slaughters 2076 to any elohiym except Yahweh only, he shall be utterly destroyed 2763.

20. You shall neither treat violently 3238 nor oppress 3905 a sojourner 1616: because you were sojourners in the land of Mitsrayim.

**21. You shall not afflict** 6031 any widow 490 or fatherless child 3490.

22. If you afflict them in any way, and they cry out at all to Me, I will surely hear their cry;

23. and My wrath shall grow hot 2734, and I will kill you with the sword; and your wives shall be widows, and your children fatherless.

24. If money 3701 you lend 3867 to any of My people that are poor 6041 by you, you shall



This entire chapter is full of common-sense laws of personal responsibility concerning private property. It is clear, without all the "legalese" we have in our current laws today. If these laws were followed today, crime would be rare, and the dealings between people would be far more respectful and polite. Note verse 18, because 929 also refers to two-legged beasts. "Beast" is a derogatory term for non-adamic peoples in Hebrew. This covers race-mixing as well. Race mixers were killed back then. 

7. Distance vourself 7368 from a false 8267 matter; and the innocent 5355 and the righteous 6663 do not slay: because I will not declare righteous 6663 the wicked 7563.

8. And you shall take no bribe 7810: because perverts 5557 the words of the righteous 6662.

9. Also you shall not oppress 3905 a sojourner 1616: because you know the heart of a sojourner, because you were sojourners in the land of Mitsrayim.

10. And six years you shall sow 2232 your land, and shall gather in the fruits of it:

11. but in the seventh year you shall let it rest 8058 and be left alone 5203 so that the poor of your people may eat: and what they leave the beasts of the field shall eat. In a like manner you shall deal with your vineyard, and your olive-yard.

12. Six days shall you do your work, and on the seventh day you shall rest 7673: so that your ox and your ass may rest 5117, and the son of your concubine 519 and the sojourner, may be refreshed 5314.

#### 5 - Kevin Mitnick - Hacker

**EVIN MITNICK** is the renowned computer hacker used as an example of tomorrow's hero. He is the one who played the mischief with American business computers and found no difficulty breaking into government computers.



This top spot no doubt might be occupied today by the 16 year old Austrian hacker (above) who more recently shut down the computers of eastern Europe - and in so doing largely shut down eastern Europe itself.

The government has hired many of the best hackers and has used them to break into the systems of Islamic militants to destroy, change, or plant bugs. However, the number of computer viruses created by the private sector are expanding at an unbelievable rate and can be used against the state and the Cartel by any number of malcontents.

It is the belief of some computer experts that in the future entire finance, manufacturing, or transport of a country will come under computer attack. Entire countries could become immobilized by hackers and their computer viruses. In essence, an individual, or a handful of people, can conceivably hold entire countries, or even groups of countries, for ransom.

#### The Weak's Last Ditch Defence

In the Chinese opinion, America, in the process of conditioning its people for constant war, instilled in them the erroneous belief that its worldwide military escapades would take place without casualties. This, the Chinese believe, is its weak point.

The Vietnamese suffered more than two million casualties while inflicting 58,000 American casualties. As this rate of "wastage" the war could continue indefinitely because Vietnamese births were still greater than their deaths.

The strategy worked and resulted in Vietnam's victory. The casualty ratio in Iraq at this writing is 1,000 American soldiers and 100,000 Iraqi men, women and children. Of course, the later figure includes executed puppet collaborators whom the U.S. has been unable to protect from Iraqi vengeance.

#### **Psychological Warfare - Deception**

No one person was given the hero status for media psychological warfare used by one state against another, against individuals, and against entire populations. Such warfare is pervasive someone who is gay, and at the last a "gay" is and takes place all the time.



"What became of Europe?"



E RECALL FROM THE LAST CHAPTER that exposure to electromagnetic fields interferes with basic metabolism. The power plants of our cells, the mitochondria, become less active, slowing the rate at which our cells can burn glucose, fats, and Protein.

They burn glucose as fast as they can after a meal, and it's no longer fast enough.

Most of the excess goes into our fat cells, is converted to fat, and makes us obese. If your pancreas becomes worn out and stops producing insulin, you have Type 1 diabetes. If your pancreas is producing enough, or too much insulin, but your muscles are unable to use glucose quickly enough, this is interpreted as "insulin resistance" and you have Type 2 diabetes.

this. In fact, before the discovery of insulin in 1922, some doctors, including Elliott Joslin, successfully treated severe cases of diabetes with a near starvation diet. They radically restricted their patients' intake of not just sugar, but all calories, thus ensuring that glucose entered the bloodstream at a rate no faster than the cells could deal with.

After a several days' fast normalized the blood glucose, first carbohydrates, then proteins, then fats were gradually reintroduced into the patient's diet. Sugar was eliminated. This saved many people who would have died within a year or two.



But in Joslin's (left) time the very nature of this underwent disease а mysterious transformation. Insulin resistance-which accounts for the vast majority of diabetes in the world today-did not exist before the late nineteenth century. Neither did obese

diabetic patients.

Almost all people with diabetes were insulindeficient, and they were universally thin: since insulin is needed in order for muscle and fat cells to absorb glucose, people with little or no insulin will waste away.

They pee away their glucose instead of using it for energy, and survive by burning their stores of body fat.

In fact, overweight diabetics were at first so unusual that late-nineteenth century doctors couldn't quite believe the change in the disease—and some of them didn't. One of these, John Milner Fothergill, a prominent London physician, wrote a letter to the Philadelphia Medical Times in 1884, in which he stated:

only a tyro would conjecture that he was the innocent oblivion of its existence, and hence fat victim of classical diabetes, a formidable wasting is often a greater danger to a diabetic than disease."

Dr. Fothergill, as it turned out, was in denial. A corpulent, florid-complexioned man himself, Fothergill died of diabetes five years later.

Today the disease has changed entirely. Even children with Type 1, insulin deficient diabetes tend to be overweight. They are overweight before they become diabetic because of their After a meal, the cells cannot oxidize the cells' reduced ability to metabolise fats.

They are overweight after they become diabetic because the insulin that they take for the rest of their lives makes their fat cells take up lots of glucose and store it as fat.

#### **Diabetes is Also a Disorder of Fat** Metabolism

Nowadays, all blood that is drawn from a patient is sent right off to a laboratory to be analysed. The doctor rarely looks at it. But a hundred years ago the quality and consistency of the blood were valuable guides to diagnosis.

Doctors knew that diabetes involved an inability to metabolise not just sugar but fat, because blood drawn from a diabetic's vein was milky, and when it was allowed to stand, a thick layer of "cream" invariably floated to the top.

In the early years of the twentieth century, when diabetes had become epidemic and was not yet controllable with any medication, it was not unusual for a diabetic's blood to contain 15 to 20 percent fat.

Joslin even found that blood cholesterol was a more reliable measure of the severity of the disease than blood sugar. He disagreed with those of his contemporaries who were treating diabetes with a low-carbohydrate, high-fat diet.

"The importance of the modification of the treatment to include control of the fat of the diet is obvious," he wrote.

He issued a warning, appropriate not only for his contemporaries but for the future: "When fat ceases to be metabolised in a normal manner no striking evidence of it is afforded, and both patient and doctor continue to journey along in

carbohydrate."

The linked failure of both carbohydrate and fat metabolism is a sign of disordered respiration in the mitochondria, and the mitochondria, we have seen, are disturbed by electromagnetic fields. Under the influence of such fields, respiratory enzyme activity is slower.

breakdown products of the proteins, fats, and sugars that we eat as quickly as they are being supplied by the blood. Supply outstrips demand. Recent research has shown exactly how this happens.



Glucose and fatty acids, proposed University of Cambridge biochemist Philip J. Randle (above) in 1963, compete with each other for energy production.

This mutual competition, he said, operates independently of insulin to regulate glucose levels in the blood. In other words, high fatty acid levels in the blood inhibit glucose metabolism, and vice versa. Evidence in support appeared almost immediately.

Jean-Pierre Felber and Alfredo Vannotti at the University of Lausanne gave a glucose tolerance test to five healthy volunteers, and then another one a few days later to the same individuals while they were receiving an intravenous infusion of lipids. Every person responded to the second test as though they were insulin resistant. Although their insulin levels remained the same, are deposited in arteries. These experiments were easy to repeat, and overwhelming evidence confirmed the concept of the "glucose-fatty acid cycle." Some evidence also supported the idea that not only fats, but amino acids as well, competed with glucose for respiration.

Randle had not been thinking in terms of mitochondria, much less what could happen if an environmental factor restricted the ability of the respiratory enzymes to work at all. But during the last decade and a half, finally some diabetes researchers have begun focusing specifically on mitochondrial function.

Remember that our food contains three main types of nutrients—proteins, fats. and carbohydrates-that are broken down into simpler substances before being absorbed into our blood.

Proteins become amino acids. Fats become triglycerides and free fatty acids. Carbohydrates become glucose. Some portion of these is used for growth and repair and becomes part of the structure of our body. The rest is burned by our cells for energy.

Within our cells, inside tiny bodies called mitochondria, amino acids, fatty acids, and glucose are all further transformed into even simpler chemicals that feed into a common cellular laboratory called the Krebs cycle, which breaks them down the rest of the way so that they can combine with the oxygen we breathe to produce carbon dioxide, water, and energy.

The last component in this process of combustion, the electron transport chain, receives electrons from the Krebs cycle and delivers them, one at a time, to molecules of oxygen. If the speed of those electrons is modified by external electromagnetic fields, as suggested by Blank and Goodman, or if the functioning of any of the elements of the electron transport chain is otherwise altered, the final combustion of our food is impaired. Proteins, fats, and carbohydrates begin to compete with metabolism is reduced at all levels. The enzymes each other and back up into the bloodstream. Only recently was it proven that this actually happens in diabetes. For a century, scientists had assumed that because most diabetics were fat, obesity causes diabetes. But in 1994, David E. Kelley (above) at the University of Pittsburgh School of Medicine, in collaboration with Jean-Aimé Simoneau at Laval University in Quebec, decided to find out exactly why diabetics have such high fatty acid levels in their blood. Seventy-two years after insulin was discovered, Kelley and Simoneau were among the first to measure cellular respiration in detail in this disease.

To their surprise, the defect turned out not to be in the cells' ability to absorb lipids but in their ability to burn them for energy. Large amounts of fatty acids were being absorbed by the muscles and not metabolised.

This led to intensive research into all aspects of respiration at the cellular level in diabetes mellitus. Important work continues to be done at the University of Pittsburgh, as well as at the Joslin Diabetes Center, RMIT University in Victoria, Australia, and other research centres.

What has been discovered is that cellular

Krebs cycle are impaired. The enzymes of the In June 2010, Mary-Elizabeth Patti, a professor Krebs cycle itself, which receives the breakdown products of fats, sugars, and proteins, are impaired. The electron transport chain is impaired. The mitochondria are smaller and reduced in number.

Consumption of oxygen by the patient during exercise is reduced. The more severe the insulin resistance-i.e., the more severe the diabetesthe greater the reductions in all these measures of cellular respiratory capacity.

In fact, Clinton Bruce and his colleagues in Australia found that the oxidative capacity of the muscles was a better indicator of insulin resistance than their fat content—which threw into question the traditional wisdom that obesity causes diabetes. Perhaps, they speculated, obesity is not a cause but an effect of the same defect in cellular respiration that causes diabetes.

A study involving lean, active young African-American women in Pittsburgh, published in 2014, seemed to confirm this. Although the women were somewhat insulin resistant, they were not yet diabetic, and the medical team could find no other physiological abnormalities in the group except two: their oxygen consumption during exercise was reduced, and mitochondrial respiration in their muscle cells was reduced.

In 2009, the Pittsburgh team made an extraordinary finding. If the electrons in the electron transport chain are being disturbed by an environmental factor, then one would expect that diet and exercise might improve all components of metabolism except the last, energy-producing step involving oxygen.


That is exactly what the Pittsburgh team found. Placing diabetic patients on calorie restriction and a strict exercise regime was beneficial in many respects. It increased the activity of the Krebs cycle enzymes. It reduced the fat content of muscle cells. It increased the number of mitochondria in the cells.

These benefits improved insulin sensitivity and helped control blood sugar. But although the number of mitochondria increased, their efficiency did not. The electron transport enzymes in dieted, exercised diabetic patients were still only half as active as the same enzymes in healthy individuals.

at Harvard Medical School and researcher at the Joslin Diabetes Center, and Silvia Corvera, a professor at the University of Massachusetts Medical School in Worcester, published a comprehensive review of existing research on the role of mitochondria in diabetes.


They were forced to conclude that a defect of cellular respiration may be the basic problem behind the modern epidemic. Due to "failure of mitochondria to adapt to higher cellular oxidative demands," they wrote, "a vicious cycle of insulin resistance and impaired insulin secretion can be initiated."

But they were not willing to take the next step. No diabetes researchers today are looking for an environmental cause of this "failure to adapt" of so many people's mitochondria. They are still, in the face of evidence refuting it, blaming this disease on faulty diet, lack of exercise, and genetics.



This in spite of the fact that, as Dan Hurley noted in his 2011 book, Diabetes Rising, human genetics has not changed and neither diet, exercise, nor drugs has put a dent in the escalation of this disease during the ninety years since insulin was discovered.



This battle is won with knowledge, with awareness, with consciousness, with courage and faith. It is won with righteousness, with conviction, with determination and with love.


We can no longer afford to hide our heads in the sand, we can no longer pretend others will fight for us and we can no longer assume things will be ok if we don't do our share.

#### His Majesty, the King,

I am truly grateful for the courage and dignity displayed by Queen Elizabeth II during an historic reign and I wish you well in taking up the Monarch's mantle.





## This Blind Age By Willie Martin



**WERY PERIOD OF UPHEAVAL AND DESTRUCTION, RECORDED IN THE BIBLICAL HISTORY**, was preceded by an era of blindness in regard to Divinely-related truth and its inherent obligations. It was so in the days of Noah. It was so in the days of Solomon.

"Now king Solomon was a lover of women; he had seven hundred royal wives, and three hundred mistresses. He married many foreign women:——- Moabites, Ammonites, Edomites, Phoenicians, and Hittites - belonging to nations against whom the Eternal had warned the men of Israel, 'You must not mix with them, nor let them mix with you, for they will be sure to seduce you to follow their gods.' Solomon clung to these women in love." (1 Kings 1-2, Moffatt's Translation)

Next, Solomon is charged with departing from faith in the true God to whom he had prayed with such fervour and devotion at the dedication of the temple. The record of Solomon's defection continues with facts so shocking as to seem almost incredible. The Moffatt version reads:

"When he grew old, he had no undivided mind for the Eternal, his God, as his father David had; his wives seduced him to follow foreign gods. Solomon did what was evil in the eyes of the Eternal; he did not follow the Eternal faithfully, as his father David had done.

For he put up shrines for Astarte, the goddess of the Phoenicians, and for Milkom, the detestable idol of the Ammonites, and for Kemosh, the detestable idol of Moab, on a hill to the east of Jerusalem. He did the same for all his foreign wives, burning incense and offering sacrifice to their gods." (1 Kings 11:4-8)

It is written, furthermore, that the Lord was angry with Solomon for his defiance of the God of Israel, who had twice appeared to him and given him this order, that he was not to follow foreign gods. Nevertheless, Solomon continued his rebellious course and unwittingly sealed the fate of his beloved kingdom; for God said of his evil decision:

"Since this is your mind, since you have not obeyed my compact and the rules I laid down for yon, I will tear the kingdom from you and give it to your servant." (1 Kings 11:11, Moffatt Translation)

What madness possessed the soul of Solomon! What blindness engulfed his mind and heart as he dared to defy God's racial law and build altars for the worship of false gods! Solomon's oneman "united nations" and "fellowship of faiths" led to his own undoing and, eventually, to the break-up of the once glorious Kingdom of Israel.




The Jewish Edomite the Pharisees

'the fury of hell')— Verily I say unto you, All in other lands, the beloved sheep of His pasture. these things shall come upon this generation. For love of them, Jesus said to His disciples: ...Behold, your house is left unto you desolate."

Thus ended the generation that sought to put out the Light of the world by crucifying the Lord of life and glory, sinful man's only Savior and wandering Israel's Redeemer. Fortunately for us, the atrocious deeds of evil men are powerless to stop the onward march of God's plan for His people.

It was customary in the time of the apostles to call any uncircumcised person "a gentile." In that sense the twelve tribes scattered abroad were "gentiles," for they were them, and remain to this day, an uncircumcised people. Paul's Epistle to the Romans cannot be elucidated until one learns that it was written to Israelites who, in the main, had lost their identity and became paganised. Doubtless Paul and Barnabas had this meaning in mind when they said to the Jews at Antioch in Pisidia:

"It was necessary that the word of God should first have been spoken to you (a Judah segment of Israel, he is not talking to the Israelites, but to Jews): but seeing ye put it from you, and judge yourselves unworthy of everlasting life, lo, we turn to the Gentiles." (Acts 13:46)

Why Could Talcum Powder Be Dangerous? From Our Health Correspondent



ALCUM POWDER IS MADE OF FINELY GROUND TALC, a mineral which forms underground as a clay like rock.

Talc is often mined from the same place as asbestos, a mineral known to cause lung disease.

Non-contaminated talc is completely safe. But if tainted with asbestos, there is a risk it could be damaging to health. Tests have in the past found traces of asbestos in talcum powder products.

Asbestos is made up of six minerals that form together as tiny crystallised fibres. The minerals on their own aren't dangerous, but together they are a recognised cause of cancer.

About eight out of 10 people with mesothelioma -a type of lung cancer -have been exposed to asbestos. When asbestos fibres are breathed in, they travel to the ends of small air passages and reach the membranes of the thorax and lungs.

They can cause inflammation and scarring, damage cells' DNA, or cause changes that result in uncontrolled cell growth.

If swallowed, these fibres can reach the abdominal lining, where they can cause mesothelioma.

Ovarian cancer is another cancer asbestos is believed to be linked to.
